# Manipur volatile, HM monitoring state

A mid escalating unrest in Manipur, Union Home Minister Amit Shah on Sunday cancelled all his rallies in poll-bound Maharashtra and returned to Delhi to hold a meeting to review the volatile situation. Irate mobs set fire to the residences of three more Bharatiya Janata Party (BJP) legislators, one of whom is a senior Minister, and also the home of a Congress MLA in various districts of Imphal Valley, even as security forces foiled the attempt of agitators to storm the ancestral residence of Manipur Chief Minister N Biren Singh, officials said.

Later in the evening, the Home Minister held a meeting with senior security and intelligence officials, and reviewed the Manipur situation. Meanwhile, Central Reserve Police Force (CRPF) chief Anish Dayal Singh reached imphal on Sunday, to monitor and coordinate the security operations in the

The fresh incidents of violent protests took place on Saturday night even as an indefinite curfew was clamped after people, agitated by the

#### NPP withdraws support to BJP

 $T_{(\text{NPP})}^{\text{he National People's Party}} \\ \text{on Sunday}$ withdrew support to the BJPled government in violencehit Manipur, claiming that the N Biren Singh dispensation has "completely failed to resolve the crisis and restore normalcy" in the normalcy" in the Northeastern state. The NPP has 7 MLAs in the 60member Manipur assembly. In the last few days, the situation in Manipur further deteriorated and many more

innocent lives have been lost and people in the state are "going through immense suffering", the NPP claimed in a letter to BJP chief J P Nadda. 'We strongly feel that the Manipur state government under the leadership of Shri Biren Singh has completely failed to resolve the crisis and restore normalcy. "Keeping the current situation in mind, the National People's Party has decided to withdraw its support to the Biren Singh government in the state of Manipur, with immediate effect," the letter said.

killing of three women and children each by militants in Jiribam district, attacked the residences of three state Ministers and six MLAs earlier on Saturday.

Meanwhile, the Manipur Government has requested the Centre to review and withdraw AFSPA from areas falling under the jurisdiction of six police stations in the State. The Centre has reimposed the Armed Forces (Special Powers) Act, 1958 in Manipur's six police station areas, including violence-hit Jiribam.

falling under Sekmai PS and Lamsang PS in Imphal West district, Lamlai in Imphal East, Moirang in Bishnupur, Leimakhong in Kangpokpi and Jiribam in Jiribam district. Enraged people torched the houses of PWD Minister Govindas Konthoujam at Ningthoukhong, Hiyanglam's BJP MLA Y Radheshyam at Langmeidong Bazar, Wangjing Tentha's BJP MLA Paonam Brojen in Thoubal district and Khundrakpam's Congress MLA Th Lokeshwar in Imphal East district, the officials said. The legislators

angry mob stormed their residential compounds, vandalised properties and set the houses on fire, police said, adding the houses were partially burnt in the incidents

Fire services rushed to the spots and doused the blaze before the flames engulfed the houses. On Saturday night, protesters also advanced towards Biren Singh's residence ancestral Luwangsangbam in Imphal East but were stopped short of 100-200 metres by security forces. Security personnel, including Assam Rifles, BSF and state forces, fired several rounds of tear gas shells, rubber bullets to disperse the protesters and foiled the attempt to damage Singh's house, officials said.

Later, protesters burnt tyres on the main road leading to Biren Singh's residence and piled iron roads to prevent vehicular movement. Protests continued till around 11 pm in Mantripukhri area, some 3-4 km from the CM's ancestral home. Many of the protesters had come in vehicles from other constituencies, and not from the Heingang Assembly seat, which the CM represented.

### **Embarrassed by 'Sheesh Mahal',** infighting Kailash Gahlot quits AAP

NEW DELHI

Arvind Kejriwal's Aam Aadmi Party (AAP) received a massive setback just months before the Delhi Assembly elections, as senior minister and veteran leader Kailash Gahlot, who had to be Kejriwal's claimed "Hanuman", on resigned from the primary membership of the party and the council of ministers, citing the 'sheesh mahal' controversy, and the party unnecessary fighting with the Centre for setting their own political agenda.

With this, four MLAs, including three ministers, have resigned from the AAP -Rajendra Pal Gautam joined the Congress in September, Patel Nagar and Chattarpur MLAs Raaj Kumar Anand and Kartar Singh Tanwar joined the Bharatiya Janata Party (BJP) during the Lok Sabha polls. Gahlot is the third minister of the AAP led Delhi government who quitted in the past one-and-half years.

In his resignation letter addressed to AAP's National Convener Arvind Kejriwal and Delhi Chief Minister Atishi, Gahlot also cited unfulfilled



promises controversies as reasons for stepping down. Gahlot has held key positions within the Delhi government, including the portfolios of Transport, Law, Information Technology, Administrative Reforms, and Women and Child Development.

Gahlot pointed to the "grave challenges" facing the party Gahlot, a prominent figure in the party, also took a jab at Kejriwal while flagging some "awkward" and "embarrassing" controversies like 'sheesh mahal', saying it makes everyone doubt if "we still believe in being the 'Aam Aadmi". Gahlot's reference to the 'sheesh mahal' controversy comes against the backdrop of BJP leaders' charge that

Kejriwal spent crores on lavish items and modern facilities at his former official residence at 6 Flagstaff Road. The BJP had dubbed Kejriwal's earlier residence as 'sheesh mahal'. Meanwhile, the AAP national convener refused to take a question on Gahlot's shock resignation at a press conference held at the party office hours after Gahlot's resignation and promptly turned the microphone towards MLA Durgesh Pathak, seated next to him. When pressed for his response, Kejriwal said with a smile, 'You want an answer, right?' before Pathak began speaking. In fact, the former Chief Minister spoke soon after, criticised the BJP but did not mention Gahlot's exit.
Holding the BJP responsible, Pathak said Gehlot was being questioned and raided by questioned and raided by Enforcement Directorate (ED) and Income Tax for months. "So he did not have a choice. But this makes it clear that BJP

# **India successfully flight-tests long-range hypersonic missile**



Flight trial of DRDO's long range hypersonic missile being successfully conducted at Dr. APJ Abdul Kalam Island, off-the-coast of Odisha

India has joined the elite league of nations after it successfully flight-tested a long-range hypersonic missile off the coast of Odisha. Russia and China are the two other countries having this capability.

kms while travelling five times more than the speed of sound and evade most air defence Hailing the test systems. conducted late Saturday night, Defence Minister Rajnath Singh on Sunday described it as a "stupendous" achievement and a "historic moment."

The missile, developed by the Defence Research and The missile can strike targets at a range of more than 1,500 (DRDO), is designed to carry various payloads for ranges greater than 1,500 km, an official readout said.

"India has achieved a major milestone by successfully conducting flight trial of long range hypersonic missile from Dr APJ Abdul of Odisha," Rajnath Singh said in a social media post. "This is a historic moment this significant achievement has put our country in the group of having nations select capabilities of such critical and advanced military technologies," he said.

Generally, the hypersonic missiles, capable of carrying conventional explosives or nuclear warheads, can fly in the range of five times the speed of sound (Mach 5 which is roughly 1,220 km) per hour at sea level However, some advanced versions of hypersonic missiles can even fly at the speed of over 15 mach.

At present, Russia and China are way ahead in developing hypersonic missiles while the US is in the process of developing a range of such weapons under an ambitious programme. Several other countries, including France, Germany, Australia, Japan, Iran and Israel, are also pursuing projects to develop hypersonic-missile systems.

s a thick blanket of smog Acontinued to engulf Delhi, the Commission for Air Quality Management (CAQM) sub-committee has decided to implement Stage IV of the Graded Response Action Plan (GRAP) for Delhi-National Capital Region, that will come into effect from Monday at 8 am, owing to 'severe' air quality conditions which include complete halting construction and demolition activities that generate dust and a ban on truck entry.

Additionally, the government can choose to impose Oddrestrictions. Commission issued the order as Delhi's Air Quality Index to disruptions in flights at decision to impose GRAP



(AQI) worsened, reaching 457 Indira Gandhi International at 8 pm. Due to unfavourable Airport (IGIA). The India Meteorological weather conditions and dense Department (IMD) issued an fog, visibility reduced to less than 50 metres in some parts of the National Capital, leading orange alert, warning of dense fog on Monday morning. The

According to the order, no trucks will be allowed into Delhi except for those carrying essential items or using clean fuel (LNG/CNG/BS-VI diesel/electric). Non-essential light commercial vehicles registered outside Delhi will also be prohibited, except for EVs and CNG and BS-VI diesel ones. Delhi-registered BS-IV or older diesel medium and heavy goods vehicles are banned, except for those in essential services, Commission said in its order. The CAQM order will be applicable for the NCR.



#### Water Crisis in Moharda: Saryu questions official negligence

The Moharda drinking water project has been facing a complete halt in water supply for the past three days, sparking concern among residents and public representatives. Jamshedpur East MLA and Jamshedpur West NDA candidate, Saryu Roy, has expressed serious dissatisfaction over the issue, questioning the negligence of officials in maintaining the infrastruc-

"All three motors breaking down simultaneously is beyond comprehension," stated Roy. Highlighting the chain of events, he pointed out that the first motor of the project's intake well had broken down 20 days ago, followed by a second motor shortly after. Despite these issues, no repair work was undertaken, leaving the entire system dependent on a single motor, which also failed three days ago, completely halting the water supply.

"Providing water through tankers is like a

drop in the ocean," remarked Roy, emphasizing the impracticality of such a solution for a vast area. He criticized the lack of readiness by the officials of Jamshedpur Notified Area Committee (JNAC) and Tata Steel UISL, calling their approach to maintenance and crisis management inadequate.

Roy engaged with the Deputy Municipal Commissioner of JNAC, Tata Steel UISL General Manager, and other officials, urging immediate action to restore water supply. The officials assured him that at least one motor would be repaired by Sunday evening, resuming partial water supply.

The MLA questioned why preventive maintenance was ignored and repairs delayed, causing undue hardship to the residents. "The non-stop disruption of water supply for three days reflects poorly on the relevance and management of the project," he concluded.

This incident has raised questions about the sustainability and effectiveness of critical public infrastructure in Jamshedpur, as citizens await prompt resolution.

### Bhramo Samaj, RK Mission clash over property in Shimla, seven injured

Seven people, including three police personnel were injured following a dispute between two Hindu groups here -- theHimalayan Brahmo Samaj and the Ramakrishna Mission Ashram -- in the heart of the state capital, police said on Sunday.

The premises of the Ramakrishna Mission Ashram, located within the Brahmo Samaj property near the Vidhan Sabha was also damaged in the conflict, they said. The clash occurred after over a 100 people, including elderly women associated with the Himalayan Brahmo Samaj, peacefully entered the ashram premises on Saturday evening to perform prayers, Sanjeev Kumar Gandhi Shimla superintendent of police (SP) said.

The group wished to continue their prayers into the night, but the members of the Ramakrishna Mission Ashram, who are in possession of the premises, objected, citing that they wished to close the ashram for

the night, Gandhi said. Anticipating a possible takeover attempt, as there is an ongoing dispute over the ownership of the property reported worth crores, the ashram authorities called the police and administration for assistance, said ashram office

According to the SP, it was a sensitive issue as it involved religious sentiments, hence police and administration were present at the spot, to mediate and resolve the matter. However, when

Trustee, Himalayan Brahmo Samaj, Shimla MR Sagroli said that a two-day Brahmo Samaj conference was held in Shimla and their members from across the country wanted to visit the temple (ashram) and they should be allowed to access.



"The student was rushed to the hospital after he collapsed, and attempts to revive him failed and he was declared dead. His classmates said Methaniya died after being made to stand for three hours and introduce himself before seniors at the college hostel,' Shah informed.

He said the anti-ragging committee of the college has initiated a probe into the matter, and punitive measures will be taken against the senior students if they are found responsible for ragging. The student's body was sent for postmortem and a case of accidental death was registered, an official from Balisana police station said.

A first-year medical student at the college said seven-eight senior students forced a group of juniors to stand for around three hours and introduce themselves one by one.

"They forced us to keep standing and asked us not get agitated. At last, a student, who was also standing with us, fell unconscious. We rushed him to a hospital where he died," he said on condition of anonymity.

### Death toll rises to 11 in Jhansi hospital tragedy

Another rescued infant succumbed to death on Sunday. District Magistrate (DM) Avinash Kumar clarified that the death was not caused by burns.

The aftermath of the devastating fire at the Special Newborn Care Unit (SNCU) of Maharani Laxmibai Government Medical College continues to unfold, with the

Autopsies conducted on the victims revealed that the infants were burned beyond recognition, with over 80% of their bodies affected. Three teams of two doctors each carried out the postmortems. Initially, seven bodies were sent for examination. Identification of three more infants was delayed due to the severity of burns.

By Sunday, the remaining infants were identified, and their bodies were handed over to grieving families. DNA samples were collected from the charred remains to confirm identities and for use in any future disputes. The findings disclosed that the intense heat had exposed bones, and the infants died within minutes of the fire breaking out.

DM Avinash Kumar stated that 49 newborns were in the SNCU at the time of the fire, and 39 were rescued. However, earlier reports suggested 55 children were present, highlighting discrepancies in official

accounts.

critically ill newborns with conditions such as jaundice and pneumonia, was reportedly operating at three and monitoring machines, essential for neonatal care, were running continuously. Experts noted that these devices require periodic breaks to prevent overheating, a safety protocol allegedly overlooked on the night of the incident.

Questions abound over safety lapses and administrative negligence, as the heartwrenching cries of grieving parents such as Rema Devi, whose first baby died, continue to echo through hospital corridors. "Let me see the face of my child," she wailed, encapsulating the anguish of a mother whose hopes were cruelly extinguished.

While the hospital administration attributes the fire to a short circuit, the

exact cause remains under investigation. findings electrical excessive caused a short circuit, which ignited concentrator and escalated the fire. However, officials have yet to provide a definitive explanation for the incident.

Bereaved families have raised serious questions about overcrowding, safety hospital staff. The tragedy has sparked widespread outrage, responsible. with many demanding strict

Chief Minister Deputy Brajesh Pathak has ordered a three-tier investigation to determine accountability for the catastrophic fire. While the investigation initially involved Jhansi Divisional Commissioner Vimal Kumar Dubey, the government later transferred the responsibility to Director General of Medical and Department Kinjal Singh.

The government's decision to alter the investigation committee has not been explained, but the findings from all three investigations are awaited to establish culpability.

With the National Socialist Council of (Isak-Muivah) Nagaland (Isak-Muivah) (NSCN-IM) threatening to go back to jungles due to delay in the resolution of the Naga political dialogue with the Government of India (GoI), the Nagaland cabinet has decided to meet both negotiating parties at the earliest, official sources said on Sunday.

A delegation of Nagaland cabinet led by Chief Minister Neiphiu Rio and his deputies TR Zeliang and Y Patton are scheduled to leave for Delhi on Monday to meet home minister Amit Shah to press for expediting the Naga political negotiations.

In a statement, NSCN-IM general secretary Th Muivah has alleged that the Centre was deliberately refusing to honour the key provisions of

historic agreement, specifically the recognition of the Naga national flag and constitution.

Threatening violent armed conflict, the NSCN-IM on November 7 sought a thirdparty intervention to address the impasse over the Naga political issue. The group, which has

maintained ceasefire since 1997, accused the Union government of betraying the Framework Agreement signed on August 3, 2015. In an interview with a news channel on Saturday, Zeliang had said that a cabinet meeting held during the day

had deliberated on Muivah's

statement and therefore

decided to meet the Union home minister and also the NSCN-IM leadership. On NSCN-IM seeking third-party intervention, Zeliang had said that unless there is an understanding between

them (Centre and NSCM-IM), third-party intervention may not help them. "There should be a meeting point... both sides should reconsider and come to an understanding," he had told the news channel. Sources said that before leaving for Delhi, the state cabinet is approaching the NSCN-IM leadership for deliberation. However, sources said the meeting with both Centre and NSCN-IM leadership has not been scheduled.

Sources also said that the state cabinet would also apprise the Union home minister about the decision of the September 12 consultative meeting of the state government with Naga tribal bodies and civil societies seeking appointment of a proper interlocutor and also to elevate the ongoing Naga political dialogue to

ministerial level. The House appealed to the GoI to elevate the ongoing dialogue and peace process to the highest political level by appointing an interlocutor of, who has the confidence and mandate of the government," the meeting had resolved.

Former Governor of Nagaland, RN Ravi was the last interlocutor for the talks but after being shifted to Tamil Nadu, the Centre appointed AK Mishra only as

a representative. The Centre has been holding negotiations with NSCN-IM since 1997 after the ceasefire agreement and inked the

Framework Agreement on August 3, 2015. It also started parallel talks with the Working Committee of Naga National Political Groups (WC NNPGs) in 2017

and signed the Agreed Position the same year. The then interlocutor Ravi had declared talks have concluded on October 30,

2019. However, the persistent demand of NSCN-IM of a separate flag and constitution for Nagas and integration of

all Naga inhabited areas has

not been accepted by the

Centre, delaying the final solution. On the other hand, WC NNPGs, composed of seven Naga groups, have declared to accept whatever is possible for now and continue further

### Left turn ho!

Anura Kumara Dissanayake's election triumph could prove to be a turning point for Sri Lanka's politics and South Asia

ri Lanka has done it again. After electing Anura Kumara Dissanayake as President his left-leaning party has secured a majority in the parliament, which gives Anura a complete control over Sri Lanka. What is more startling is that his party has decimated the Tamil parties in the northern Sri Lanka, which was the stronghold of Tamil parties. This is indeed a stunning political shift. Anura Kumara Dissanayake, leader of Sri Lanka's National People's Power (NPP), has achieved a resounding victory in the country's parliamentary elections, winning 123 out of 225 seats in Sri Lanka's Parliament. This outcome, which comes barely two months after Dissanayake's election as President on September 21, marks a pivotal moment in the nation's political landscape and could have significant ramifications not only for Sri Lanka but also for the wider South Asian region. Dissanayake's rise to prominence is both unexpected and historic. His party, despite winning only 42 per cent of the presidential vote, has managed to galvanise a



broad cross-section of Sri Lankan society, particularly in regions where other political forces have traditionally held sway. His victory represents a rejection of the traditional political elites that have long governed the island since its independence in 1948, and it signifies the growing appeal of his platform advocating for economic revival and social justice. Notably, the NPP's win in the Jaffna district—a historically Tamilmajority area in the northern part of Sri Lanka—has surprised political pundits. For decades, Tamil ethnic parties have dominated this region, a legacy of the civil war (1983-2009) that left a deep divide between the Tamil minority and the Sinhalese-majority government.

This victory in Jaffna is symbolic of a new approach to ethnic relations in Sri Lanka. Traditionally, the Tamil population has been wary of Sinhalese-majority leaders, given the traumatic history of the civil conflict, where over 100,000 lives were lost according to conservative UN estimates. Dissanayake's success in these areas suggests that many Tamils are willing to embrace a new kind of leadership, one that offers economic promise and a path forward, beyond ethnic divisions. Dissanayake's victory carries significant implications for the future of Sri Lanka. First and foremost, his strong mandate gives him the political capital needed to implement his economic revival agenda, which is urgently needed as Sri Lanka grapples with economic instability and growing debt. Dissanayake has long advocated for Marxist economic policies, including land reforms, wealth redistribution and greater state control over key industries. If successful, his administration could lead to a reshaping of Sri Lanka's economy, potentially benefiting marginalised communities, including Tamils and other ethnic minorities. Dissanayake's popularity, especially among younger voters and ethnic minorities, suggests a growing demand for alternative political solutions. But can he live up to people's expectations, bring about radical changes and maintain ethnic harmony? That is the big question only time can tell!

# The smog capital of India




As Delhi battles a toxic mix of seasonal stubble burning and local pollution sources, its residents are exposed to severe and potentially life-threatening health risks

he National Capital Territory of Delhi, which is home to nearly 30 million people, has been grappling with dangerously high pollution levels for over two weeks. On Wednesday, November 13, 2024, the air quality index (AQI) across Delhi remained in the 'very poor' category, marking the 15th consecutive day when residents faced increased health risks from the polluted air. According to official data (the Air Quality Early Warning System for Delhi, manby the Central Government), this situation will likely persist for at least six days. In parallel, the city is also experiencing an unusually warm spell that defies typical seasonal trends, adding complexity to an already challenging situation for residents. This grim forecast highlights the role of unfavourable meteorological conditions that limit the dispersal of pollutants, essentially trapping them close to the ground. The AQI measures levels of harmful pollutants in the air, with a higher value indicating a greater concentration of pollutants. While an AQI between 300 and 400 is considered "very poor," levels above 400 are classified as "severe," meaning the pollution is severe enough to affect even healthy individuals.

The IMD has reported that the typical winter season may not arrive in Delhi as quickly as expected, thereby disrupting long-established weather patterns that typically bring cooler, less polluted air to the region.

The dense fog mixed with thick smog has created a near-total obscurity, as citizens found themselves enveloped in a hazardous blend of pollutants and moisture resulting in keeping daytime temperatures lower than expected for this time of year – because of fog and smog – although overall temperatures remain warmer than the seasonal norm. This combination of high pollution and unusual weather patterns has compounded the health concerns for residents, particularly the elderly, children and those with respiratory ailments. Delhi's persistent air pollution crisis is fuelled by a combination of local and regional sources.

effects like coughing, throat irritation and chest tightness. In the long term, the risks increase substantially, with studies linking air pollution exposure to chronic respiratory diseases, lung cancer, heart disease, and even impacts on cognitive functions. Air pollution is a severe health crisis in India, causing between 1.2 million and 1.8 million premature deaths each year.

The 7 million annual deaths from air pollution worldwide exceed those from COVID-19, as well as combined fatalities from war, homicide, car and plane accidents. Clean air is essential for human health, yet scientific studies continue to reveal new health risks linked to air pollution, including respiratory diseases, heart issues, stroke, and lung cancer, as well as emerging links to premature births, diabetes, and brain damage.

Poor air quality can also worsen outcomes for COVID-19 by increasing vulnerability to respiratory illnesses. Dr David R Boyd, Institute for Resources, Environment Sustainability, University of British Columbia, CA, Associate Professor in law, policy and Sustainability in his paper "The Human Rights to Breathe Clean Air" published in The National Library of Medicine (2019) necessitates the urgency for treating air pol-

rights to life and health, the rights of the child and the right to live in a safe, clean, healthy and sustainable environment" and that there is an urgent need to voice that the legal support of a human rights issue, since Dr David says that "The human rights perspective changes everything – because governments have clear, legaly enforceable obligations to respect, protect, and fulfil human rights. As Delhi battles yet another season of toxic air, the health and wellbeing of millions are at stake. The situation demands urgent and coordinated action from the government, industry, and residents (read citizens). Sustainable improvement requires systemic changes to reduce pollution at its source. While the road to a cleaner, healthier Delhi may be long, there is hope in ongoing technological and policy developments aimed at reducing pollution. As more people become aware of the critical importance of air quality, public support for environmental initiatives will continue to grow, fostering a collective movement toward cleaner air and a better quality of life for all Delhiites and others who visit to see the grandeur of the Capital City.

# Supreme Court strikes down 'bulldozer injustice'



By reinforcing legal safeguards, the Apex Court seeks to restore public trust in the justice system and ensure that no citizen is denied their constitutional rights

historic Supreme Court verdict against "bulldozer justice" promises broad legal, social, and administrative impacts, addressing concerns around the unchecked, high-handed demolition of properties linked to criminal accusations. Such actions have often violated the fundamental tenets of the Indian Constitution. This ruling holds direct implications for BJP-ruled states like Uttar Pradesh, Rajasthan, Madhya Pradesh, Haryana, Assam and the Delhi Municipal Corporation, which have been accused of misusing administrative powers to punish marginalised sections of society without due legal process.

The concept of "bulldozer justice" was notably invented by Uttar Pradesh Chief Minister, Yogi Adityanath, earning him the nickname "Bulldozer Baba" among sup-porters. The Court's verdict marks a setback to the UP government, though CM may not express regret for actions nullified by the ruling, which had previously jeopardised the constitutional guarantees afforded to all

Social Implications Protection of Marginalised Communities: The ruling acknowledges that bulldozer justice has disproportionately impacted marginalised groups. By mandating due process, the Court aims to prevent biased or retaliatory actions against vulnerable communities, promoting equal treatment under the law. Public Trust in the Rule of Law: By condemning bulldozer justice, the Supreme Court seeks to rebuild public confidence in lawful governance, fostering trust that the state will not bypass legal safeguards to punish alleged offenders.

Awareness and Advocacy: This judg-

ment may empower civil rights groups to challenge arbitrary demolitions, advocating for the rights of those affected by unilateral property destruction. Administrative and Policy Impact

Reduced Arbitrary Actions: Administrative bodies may now face restrictions against immediate demolition practices that bypass judicial processes, holding them accountable to legal frameworks designed to protect against arbitrary punishment. This could encourage a fairer and more equitable application of laws. Policy Revisions at the State Level: States that have regularly employed demolitions as a form of "bulldozer justice" may need to revisit their policies, ensuring alignment with constitutional rights to property and due process. This could result in tighter guidelines and even statutory changes. Limit on Executive Power: The Court's disapproval of unilateral demolition reinforces the separation of powers, signaling that executive decisions must strictly adhere to legal boundaries.

Legal and Judicial Consequences Strengthened Due Process: The ruling reaffirms that demolitions must respect due process, requiring legal scrutiny rather than administrative discretion. This will likely lead to the implementation of judicial approval for demolition orders, protecting citizens' rights against arbitrary state

**Increased Judicial Oversight:** The ruling could result in heightened court involvement in cases where demolitions serve as punitive responses to alleged crimes, particularly in cases involving minority or marginalised groups.

related to criminal cases, which could formalise rules for state authorities to follow, reducing current ambiguities. Supreme Court Guidelines on

Demolitions Justices BR Gavai and KV Viswanathan made impactful assertions, noting that demolitions based solely on accusations violate fundamental rights. The Court emphasised the presumption of innocence and man-dated a 15-day notice period, allowing tenants or owners time to challenge demolition orders or make necessary arrangements. This highlights the right to shelter under Article 21 of the Indian Constitution.

The Court warned that contempt proceedings could follow violations of these guidelines and responsible officials may face compensation liabilities for restitution. I his ruling stemmed from controversial demolitions in Rajasthan and Madhya Pradesh, alongside a Jamiat-Ulama-i-Hind petition challenging demolitions in Delhi's Jahangirpuri in 2022. Data show that state laws on demolitions were often violated in Uttar Pradesh, a state pioneering "bulldozer justice."

The Uttar Pradesh Urban Planning and Development Act, 1973, requires a minimum 15-day notice before unauthorised structures can be removed, with a right to appeal. However, the 2022 demolitions, where structures were razed without due process, led to the Jamiat-Ulama-i-Hind's petition to the Supreme Court.

In another significant instance, former Chief Justice Chandrachud, before his retirement on November 9, and Justices JB Pardiwala and Manoj Misra directed the Uttar Pradesh government

to a man whose home was demolished in 2019 for a road-widening

The Court expressed concern over state actions that could potentially use demolitions as selective reprisals, noting that citizens' voices must not be stifled by the threat of losing their homes. In Rajasthan, demolition laws under Section 245 of the Rajasthan Municipalities Act, 2009, require prior written notice detailing the grounds for eviction. Following communal tensions in

Udaipur, authorities issued a quick notice before demolishing a house on alleged forest land encroachment, contravening local law requirements for a reasonable response period. Section 91 of the Rajasthan Forest Act, 1953, restricts eviction orders to be issued only by a Tehsildar.

maanya Municipalities Act, 1961, stipulates that any unauthorised building alteration or construction may be removed, but only after notice. However, this was ignored when a labourer's home was demolished immediately after his son's arrest, raising rights violation con-

Under the Delhi Municipal Corporation Act, 1957, the commissioner can remove illegal structures but must give reasonable opportunity for owners to dispute

The Jahangirpuri incident in 2022 highlighted the need for due process, intensifying scrutiny on such practices. In Haryana, demolitions are governed by Section 261 of the Haryana Municipal Corporation Act, 1994, which mandates a notice period with an opportunity to contest. However,

in 2023, authorities demolished over 440 structures, mostly affecting Muslim households. Although similar to Delhi's DMC Act, Haryana's compliance period is notably shorter—only three days, leaving owners little time for appeals

Strengthening Accountability: The Supreme Court's new guidelines aim to check arbitrary demolitions and uphold legal protections, particularly for vulnerable tenants. These regulations emphasise that adequate notice, transparency, and due process must be integral to any demolition order. While state laws vary, adherence to these guidelines will be essential in ensuring that demolitions respect both legal and constitutional rights, strengthening administra-

tive accountability.

A Fundamental Shift in the Justice System: The Supreme indias recent ruling against "bulldozer justice" was a response to cases where properties of individuals accused of crimes, especially those involving communal violence, were demolished without legal due process.

The Court underscored that demolitions must be legally justified and cannot bypass established procedures. It criticised this practice for disproportionately impacting marginalised communities, violating human rights, and eroding public trust. In essence, this ruling reaffirms the constitutional right to due process, expected to curb the trend of using demolitions as extrajudicial punitive measures. The ruling marks a shift toward a justice system grounded in fairness, procedure, and accountability.

### Tackling the epidemic of diabetes and hypertension: Urgent action needed Lack of awareness and limited early screening make these two lifestyle diseases rampant

iabetes and hypertension are two interconnected yet distinct chronic diseases that collectively strain public health. Both conditions share underlying risk factors, such as unhealthy diets, physical inactivity and high stress levels. They also frequently co-occur, accelerating the onset of severe complications and amplifying each other's impact.

Diabetes and hypertension significantly increase the risk for cardiovascular diseases, chronic kidney disease, stroke, and eye disorders, forming a "double-edged sword" for health. In particular, hypertension, when combined with diabetes, can increase the likelihood of heart disease and stroke. Management of these conditions in India is challeng-



ing due to lack of awareness, inadequate early screening and inaction, particularly in rural and resource-poor areas. More than half a billion people are living with diabetes globally. This is only expected to more than double in the next 30 years, in almost every country, according to a Lancet study. When it comes to hypertension, over a billion peoplewomen—are living with this condition, which ranks as one of the leading causes of premature death worldwide. In addition to this, WHO states that more than 50 per cent of people with diabetes and about 46 per cent of adults living with hypertension don't even know

about their condition. It is safe to argue that lack of awareness is the biggest problem here. Both conditions have become the largest, silent, dual epidemics currently challenging India. The Cost of Inaction: Tertiary treatment for complications from advanced diabetes and hypertension such as heart disease, kidney failure, or stroke—is exponentially more costly than pri-

mary health interventions. In

that the cost of a kidney transplant in public sector hospitals in India generally goes up to 6

This estimate is significantly lower than in private hospitals, which can go up to INR 15 lakhs or more, due to higher administrative and facility fees. Similarly, cardiac surgery can range anywhere between Rs 1 lakh and Rs 15 lakhs. In contrast, medication for diabetes and hypertension cost potentially up to only Rs 10,000 yearly, which is otherwise completely free of cost if obtained from a Government

Thus, investing in primary care interventions is far more cost-effective and sustainable than managing advanced com-2024, reports from different plications. Reducing the community health services.

¬hina's leader Xi Jinping met for the last time with US President Joe Biden on Saturday but was already looking ahead to President-elect Donald Trump and his "America first" policies, saying Beijing "is ready to work with

administration".During their talks on the sidelines of the annual Asia-Pacific Economic Cooperation summit, Xi cautioned that a stable China-US relationship was critical not only to the two nations but also the "future and destiny of humanity'

"Make the wise choice," he cautioned. "Keep exploring the right way for two major countries to get along well with each

Without mentioning Trump's name, Xi appeared to signal his concern that the incoming president's protectionist rhetoric on the campaign trail could send the US-China relationship into another valley.

"China is ready to work with a new US administration to maintain communication, expand cooperation and manage differences so as to strive for a steady transition of the China-US relationship for the benefit of the two peoples," Xi said through an interpreter.

Xi, who is firmly entrenched atop China's political hierarchy, spoke forcefully in his brief remarks before reporters. Biden, who is winding down more than 50 years of public service, talked in broader

brushstrokes about where the relationship between the two panies, including Nike and eyewear retailer Warby Parker, countries has gone. He reflected not just on the past four vears but the decades the two have known each other.

'We haven't always agreed, but our conversations have always been candid and always been frank. We've never kidded one another," Biden said. "These conversations prevent miscalculations, and they ensure the competition between our two countries will not veer into conflict."

Biden urged Xi to dissuade North Korea from further deepening its support for Russia's war on Ukraine. The leaders, with top aides surrounding them, gathered around a long rectangle of tables in an expansive conference room at Lima's Defines Hotel and Conference Center. China "hosted" the meeting this year, after Xi and Biden met a year ago on the APEC sidelines in northern California, a gathering hosted by the US. They had much to discuss, including China's indi-rect support for Russia, human rights issues, technology and Taiwan, the self-ruled democracy that Beijing claims as its own. On artificial intelligence, the two agreed on the need to maintain human control over the decision to use nuclear

There's much uncertainty about what lies ahead in the US-China relationship under Trump, who campaigned promising to levy 60 per cent tariffs on Chinese imports. Already, many American com-

have been diversifying their sourcing away from China. Shoe brand Steve Madden says it plans to cut imports from China by as much as 45 per cent next year.

In a congratulatory message to Trump after his victory over Vice-President Kamala Harris, Xi called for the US and China to manage their differences and get along in a new era. In front of the cameras Saturday, Xi spoke to Biden — but it was unmistakable that his message was directed at Trump.

"In a major flourishing sci-tech revolution, neither decoupling nor supply chain disruption is a solution," Xi said. "Only mutual, beneficial cooperation can lead to common development. Small yard, high fence is not what a major country should pursue."

Biden administration officials would advise the Trump team that managing the intense competition with Beijing will likebe the most significant foreign policy challenge they will face. White House national security advisor Jake Sullivan

On Saturday, Sullivan said Biden had reinforced to Xi "that these next two months are a time of transition, and the president would like to pass it off "in stable terms" to the new administration.

Biden has viewed his relationship with Xi as among the most consequential on the international stage and put much effort into cultivating it. The two first got to know each other

on travels across the US and China when both were vicepresidents, interactions that both have said left a lasting impression. President-elect Donald Trump has selected Chris Wright, a campaign donor and fossil fuel executive, to serve as energy secretary in his upcoming, second administration. CEO of Denver-based Liberty Energy, Wright is a vocal advocate of oil and gas development, including fracking, a key pillar of Trump's quest to achieve US "energy domi-nance" in the global market. Wright has been one of the industry's loudest voices against efforts to fight climate change and could give fossil fuels a boost, including quick action to end a year-long pause on natural gas export approvals by the Biden administration. Wright also has criticised what he calls a "top-down" approach to climate by liberal and leftwing groups and said the climate movement around the world is "collapsing under its own weight". Wright, who has never served in government, has written that more fossil fuel production is needed around the globe to lift people out of poverty. Consideration of Wright to head the administration's energy department won support from influential conservatives, including oil and

"The Energy Department should be doing all it can to develop and expand the energy sources of the 21st century, not trying to promote the dirty fuels of the last century," Wong said.

"Given the devastating impacts of climate-fueled disasters, DOE's core mission of researching and promoting cleaner energy solutions is more important now than ever." The Energy Department is responsible for advancing energy, environmental and nuclear security of the US. The agency is in charge of maintaining the country's nuclear weapons, oversees 17 national research laboratories and approves natural gas exports, as well as ensuring environmental cleanup of the nation's nuclear weapons complex. It also promotes scientific and technological research. Republican Senator John Barrasso of Wyoming, who is expected to become chair-man of the Senate Energy and Natural Resources Committee, said Trump promised bold choices for his Cabinet, and Wright's nomination delivers.

#### Young woman found murdered in car boot in UK

London (PTI): A 24-year-old woman believed to be of South Asian origin has been found murdered in a car boot in east London after a missing person inquiry was launched for her in the East Midlands region of

England. Northamptonshire Police named the victim as Harshita Brella on Saturday night as the force launched a murder inquiry and appealed for information in the case.

Police said it had received a call

on Wednesday regarding concerns for Harshita's welfare and officers were deployed to her home address at Skegness Walk in Corby, Northamptonshire. police launched a missing person investigation and fast-track enquiries were made which led to the discovery of the victim's body inside the boot of a vehicle on Brisbane Road in the Ilford area of east London in the early hours of Thursday.

A post-mortem was conducted at Leicester Royal Infirmary on Friday which established the murder victim as Harshita Brella, whose name indicates a South Asian heritage, but there is no further confirmation of her family background at this stage of the inquiry.

"First of all, I want to express my heartfelt condolences to everyone who loved Harshita Brella," said Detective Chief Inspector Johnny Campbell Senior Investigating Officer from the East Midlands Special Operations Major Crime Unit (EMSOU). "She was a young woman in her early 20s with her whole life ahead of her and it is absolutely tragic that her life has been cut short in this way Detectives from EMSOU and Northamptonshire Police are working around the clock to establish the circumstances behind her death, including the exact location and timeframe in which it took place," he said.

Tsraeli strikes in the Gaza Strip Lovernight killed 12 people, Palestinian medical officials said on Sunday. stitute genocide, according to excerpts released on Sunday from an upcoming new book ahead of the pontiff's jubilee year.

It's the first time that Francis has openly urged for an investigation of genocide allegations over Israel's actions in the Gaza Strip. In September, he said Israel's attacks in Gaza and Lebanon have been "immoral" and disproportionate, and that its military has gone beyond the rules of war. The book, by Hernán Reves Alcaide and based on interviews with the Pope, is entitled "Hope never disappoints. Pilgrims towards a better world". It will be released on Tuesday ahead of the pope's 2025 jubilee. Francis' yearlong jubilee is expected to ing more than 30 mil celebrate the Holy Year. "According to some experts, what is happening in Gaza has the characteristics of a genocide," the pope said in excerpts published Sunday by the Italian daily La

"We should investigate carefully to determine whether it fits into the technical definition formulated by jurists and international bodies," he added.

Last year, Francis met separately with relatives of Israeli hostages in Gaza and Palestinians living through the war and set off a firestorm by using words that Vatican diplomats usually avoid: "terrorism" and, according to the Palestinians, "geno-

Francis spoke at the time about the suffering of both Israelis and Palestinians after his meetings, which were arranged before the Israeli-Hamas hostage deal and a temporary halt in fighting was announced. ### Trump takes break from making Cabinet picks

President-elect Donald Trump is attending the UFC heavyweight championship clash at Madison Square Garden on Saturday night, combining two things close to his heart — fierce battles inside the octagon and New York City. Trump also spent three hours taping a podcast with Joe Rogan, who himself has spoken about hypermasculinity.

Harris failed to do a similar appearance with Rogan, citing scheduling conflicts.

A return to Madison Square Garden means revisiting the place where a comedian caused an uproar at a Trump rally last month by likening Puerto Rico to a "floating island of garbage". Yet Trump continues to relish visits to New York, where he lived for decades, before moving to his Mar-a-Lago club in Palm Beach, Florida.

Trump boarded his plane for the flight to New York accom-

panied by Robert F Kennedy Jr, his choice to lead the Department of Health and Human Services after his new administration begins on January 20.

Except for a day trip to Washington this week to meet for nearly two hours with President Joe Biden, and separately address House Republicans, Trump has been spending his time since his Election Day victory at Mar-a-Lago. The club has hosted galas and conservative events

throughout the week. Trump has been close to UFC President Dana White for more than two decades.

White hosted a 2001 UFC batmer casino-hotel in Atlantic City, New Jersey, and Trump has frequently attended UFC matches since — including during his 2024 campaign. #### COP29 week one ends in deadlock as divisions stall climate action progress

Baku (Azerbaijan) (PTI): The first week of the COP29 summit concluded in Baku without significant breakthroughs, as deep divisions between developed and developing nations stalled progress on key issues like climate finance, trade measures, and equitable responsibility for climate action.

India, representing the G-77/China and BASIC blocs, demanded accountability from wealthier countries on unmet financial commitments.

The G-77/China bloc reiterated the call for USD 1.3 trillion annually in climate finance, with an emphasis on grants and concessional funding to avoid

vulnerable burdening economies already grappling with the impacts of climate

"Loans make up nearly 70 per cent of climate finance provided so far. This is unacceptable and places undue pressure on developing economies," an Indian negotiator had asserted, urging developed nations to move away from debt-inducing mechanisms.

**UN Executive Secretary Simon** Stiell added to the urgency, urging G20 countries to take bolder action, warning that without it, no economy in the grouping would be spared from climatedriven economic losses.

However, his call for solidarity failed to resolve the dead-

Cosima Castle, of E3G's climate diplomacy team, acknowledged the challenges posed by geopolitical tensions but underscored the potential of the upcoming G20 Leaders' Summit in Rio de

E3G is an engineering and environmental consulting firm. "We're seeing strains everywhere, from the Middle East to Africa to Ukraine, yet there's collective resolve among many nations to work toward a deal,

Castle pointed out that the G20 countries, responsible for 80

per cent of global emissions and 85 per cent of the world economy, hold the key to unlocking ambitious climate agreements.

The contentious issue of the European Union's Carbon Adjustment Border Mechanism (CBÁM) also fuelled sharp exchanges.

India and other developing nations criticised the measure for disproportionately penalising their economies, calling it a violation of equity principles and the United Nations Framework Convention on Climate Change (UNFCCC). "CBAM shifts the responsibility of climate action onto nations with minimal historical emissions, undermining industrial growth in the developing world," warned a negotiator from Bolivia, echoing India's concerns.

Technology transfer emerged as another unresolved issue. Developing nations demanded a robust technology implementation programme supported by dedicated financial backing.

"Without equitable access to climate technologies, the promises of the Paris Agreement will remain unful-filled," an Indian negotiator stated.

India also opposed any

attempts to impose external regulations on its climate targets, emphasising that mitigation efforts should align with Nationally Determined Contributions (NDCs) and national sovereignty.

The BASIC bloc criticised developed nations for attempting to dilute their commitments under the Paris Agreement by shifting additional obligations onto emerging economies.

The BASIC countries include Brazil, South Africa, India, and China

The Alliance of Small Island States (AOSIS) and the Arab Group joined forces with India, highlighting the disproportionate impact of climate change on vulnerable populations and demanding scaled-up financial and technological support.

The negotiations in Baku have also highlighted the urgent need for a comprehensive climate finance package that addresses both mitigation and adaptation.

"The costs of inaction are far greater than the costs of action," Castle warned, adding that countries must come together not only for climate action but

### Russia launches fiercest attack on Ukraine's infrastructure

 $R^{\mathrm{ussia}}$  on Sunday launched a massive drone and missile attack on Ukraine, described by officials as the largest over the past months, targeting energy infrastruc-ture and killing civilians.

The attack came as fears are mounting about Moscow's intentions to devastate Ukraine's power generation capacity ahead of the cold winter.

President Volodymyr Zelenskyy said that Russia had launched a total of 120 missiles and 90 drones in a large-scale attack across Ukraine. Various types of drones were deployed, he said, including Iranian-made Shaheds as well as cruise, ballistic and aircraft-launched ballistic missiles.

Ukrainian defences shot down 140 air targets, Zelenskyy said in a statement on the Telegram messaging

Ukrainian officials have routinely urged

Explosions were heard across Ukraine on Sunday, including in capital Kyiv, the key southern port of Odesa, as well as the country's west and central regions, according to local

### Latest typhoon lashes Philippines

Manila (Philippines) (AP): A powerful typhoon wrecked houses, caused towering tidal surges and forced hundreds of thousands of people to flee to emergency shelters as it cut across the northern Philippines on Sunday in the sixth major storm to hit the country in less than a month.

Typhoon Man-yi slammed into the eastern island province of Catanduanes on Saturday night with sustained winds of up to 195 kilometers (125 miles) per hour and gusts of up to 240 kph (149 mph). The country's weather agency warned of a "potentially catastrophic and life-threatening situation" in provinces along its path.

There were no immediate reports of casualties from the typhoon, which was forecast to blow northwestward on Sunday across northern Luzon, the archipelago's most populous region. The capital region of metropolitan Manila would likely be spared from a direct hit but was placed, along with outlying regions, under storm alerts and warned of dangerous coastal storm surges.

"The rain was minimal, but the wind was very strong and had this eerie howling sound," Roberto Monterola, a disastermitigation officer in Catanduanes, told The Associated Press by telephone. "Along a main boulevard here, the tidal surges went up to more than 7 meters (23 feet) near the seaside houses. It looked really scary."

The entire province of Catanduanes had no power after the typhoon knocked down trees and electricity posts, and disaster-response teams were checking how many more houses were damaged in addition to those impacted by

previous storms, he said. "We need tin roofs and other construction materials, aside from food. Villagers tell us here that they still haven't gotten up from the past storm and were pinned down again by this typhoon," Monterola said. Nearly half of the island province's 80,000 people were sheltering in evacuation centers. Catanduanes officials were so concerned as the typhoon approached that they threatened vulnerable villagers with arrest if they did not follow orders to evacuate to safer grounds. More than 750,000

people took refuge in emergency shelters, including churches and a shopping mall, due to Man-yi and two previous storms mostly in the northern Philippines, Assistant Secretary Cesar Idio of the Official of Civil Defense and other provincial officials said. The rare number of back-toback storms and typhoons that lashed Luzon in just three weeks left more than 160 peo-ple dead, affected 9 million people and caused such extensive damage to residential com-

munities, infrastructure and farmlands that the Philippines may have to import more rice, a staple food for most Filipinos. In an emergency meeting as Man-yi approached, President Ferdinand Marcos Jr. asked his Cabinet and provincial officials to brace for "the worst-case scenario." At least 26 domestic airports and two international airports were briefly shut and inter-island ferry and cargo services were suspended due to rough seas, stranding thousands of passengers and commuters, according to the Civil Aviation Authority of the Philippine and the coast

#### Pak religious body faces backlash over anti-VPN decree

Islamabad (PTI): Pakistan's leading constitutional religious body came under severe criticism after it issued an edict terming the use of Virtual Private Networks (VPNs) to access blocked content on the internet as 'un-Islamic'. The unprecedented pro-clamation by the Council of Islamic Ideology (CII), which advises parliament on aligning legislation with Islamic teachings, enraged digital rights activists as well as some religious scholars. According to the Dawn newspaper, the CII chief Raghib Naeemi said that using VPNs to access "imm-oral or illegal content" was against Sharia. In a social media statement on

Saturday, Maulana Tariq Jameel, a prominent religious scholar, said if watching adult content or blasphemous material was an issue then mobile phones should be declared un-Islamic before labelling VPNs as such. Senator Allama Nasir Abbas,

the chief of Shia organisation Majlis Wahdat Muslimeen (MWM), said the country was being ruled by an "incompetent and corrupt elite" who were not even the true representatives of the people."They make laws in such a way and are using decrees ... as per their whims," Senator Abbas added. Wahaj Siraj, the CEO of telecom company Nayatel, said technology has always been neutral and only its use or misuse made it 'Halal or Haram'. The issue of VPNs came to light after the Interior Ministry asked the Pakistan Telecom Authority, the electronic media watchdog, to take action against their illegal use as they were being used for terrorism. Nighat Dad, the executive director of the Digital Rights Foundation, said the action to block VPNs was "contradictory" to the rights of privacy granted in the

Constitution.

### Gold pocket watch from Titanic rescue sells for record price **London (AP):** A gold pocket watch given to the ship captain Titanic memorabilia. The price year demonstrates the endur-

who rescued 700 survivors from the Titanic sold at auction for nearly \$2 million, setting a record for memorabilia from the ship wreck.

The 18-carat Tiffany & Co. watch was given by three women survivors to Capt. Arthur Rostron for diverting his passenger ship, the RMS Carpathia, to save them and others after the Titanic struck an iceberg and sank in the north Atlantic on its maiden voyage in 1912.

Auctioneers Henry Aldridge and Son, who sold the watch to a private collector in the United States on Saturday for 1.56 million British pounds, said it's includes taxes and fees paid by the buyer.

The watch was given to Rostron by the widow of John Jacob Astor, the richest man to die in the disaster, and the widows of two other wealthy businessmen who went down with

Astor's pocket watch, which was on his body when it was recovered seven days after the ship sank, had previously set the record for the highest price paid for a Titanic keepsake, fetching nearly \$1.5 million (1.17 million pounds) from the same auction house in April. Auctioneer Andrew Aldridge

Rostron was awarded the U.S. Congressional Gold Medal by President William Howard Taft and was later knighted by King George V.

Madeleine Astor, who had been helped into a lifeboat by her husband, presented the watch to Rostron at a luncheon at her mansion on Fifth Avenue in New York.

#### Japanese troops will train with US, Aus forces as concerns over China grow ing talks with his Japanese

Canberra (AP): Japan will send troops for joint training with US Marines and Exercise Orient Shield in Japan for the first time next year. Australian forces in northern Australia, the three defence ministers said on Sunday as they expressed concern about a spate of confrontations with China's increasingly assertive military.

Australia's Acting Prime Minister Richard Marles hosted US Defence Secretary Lloyd Austin and Japanese Defence Minister Nakatani Gen for talks in Darwin.

The ministers announced trilateral amphibious training between Australia, Japan and the US Marine rotational force in northern Australia from 2025, beginning with Exercise Talisman Sabre.

A joint statement reiterated 'serious concern" about destabilising actions in the East and South China seas including "dangerous conduct" by the Chinese military against Philippine and other vessels from the region. China claims the South China Sea almost in its entirety. The ministers also urged the importance of peace and stability across the Taiwan Strait. China claims self-ruled Taiwan as its own territory and has stepped up military harassment with frequent drills around the island.

### Municipal corporations need to impose adequate user charges to provide better facilities: RBI report

Municipal corporations to impose adequate user charges for essential services like water supply and sanitation, to boost non-tax revenues and quality public services, according to a Reserve Bank of India (RBI)

report.
The 'Report on Municipal Finances' delves into the fiscal position of 232 municipal corporations (MCs) from 2019-20 to 2023-24 (Budget Estimates), with a focus on the theme 'Own Sources of Revenue Generation in Municipal Corporations: Opportunities and Challenges'.

"MCs can significantly enhance them (non-tax applying revenues) appropriate and adequate fees and user charges for essential services such as water supply, sanitation, and waste management while also ensuring seamless availability of high-quality public services," it said.

These measures, combined with more transparent and accountable governance practices, can contribute to bolstering the financial health of MCs, setting off a



virtuous cycle of better services for the public, stronger revenues and a continuous upgrade of the urban infrastructure, it said. The major non-tax revenue sources include user charges, licensing layout/building approval fees, development charges, betterment charges, sale and hire charges, market fees, slaughterhouse fees, parking fees, birth and death registration fees.

Sources of tax revenue, include property tax, vacant land tax, water benefit tax, advertisement tax, sewerage benefit tax, tax on animals, and taxes on carriages and municipal services such as supply, management transportation. The report further said own

sources of revenues (tax revenue, non-tax revenue, and other receipts) afford municipalities increased financial autonomy, stability, and enhanced capacity to strategise and execute urban development initiatives more efficiently and effectively.

Municipal corporations need to augment their own revenue sources for greater operational and financial flexibility. "By optimising property and water taxes, increasing non-tax revenues, and adopting transparent governance practices, urban local bodies can improve their finances," it said.

Leveraging technologies Geographic Information System (GIS) digital mapping and payment systems enhance property collections, it said.

Periodic revisions in water and drainage taxes, and fees and user charges, coupled with use of technology for plugging leakages, can also help improve their revenue collections, it added.

#### Enforce odd-even rule to encourage people to shift to natural gas or EV: IBA

PTI ■ NEW DELHI

Indian Biogas Association has suggested enforcement of the odd-even rule for four wheelers in Delhi NCR to check air pollution and encourage people to shift to electric vehicles or those based on compressed biogas (CBG) or natural gas.

Under the Graded Response Action Plan (GRAP) 4 (with air quality index of over 450) measures, odd/even rule for four wheelers is imposed.

The Commission for Air

Quality Management (CAQM) has already imposed GRAP 3 measures with the air quality remaining in the

"severe" category. Taking with PTI in an interaction, Indian Biogas Association (IBA) Chairman Gaurav Kedia said, "We recommend implementing the Odd-Even Rule for Petrol and Diesel Vehicles in the coming months so that a good impact can be seen for the air pollution levels in Delhi, and subsidy on EVs and CNG/CBG vehicles, as this will compel the citizens to shift to greener fuel alternatives.

The air pollution situation in Delhi NCR worsens every winter, with the seasonal air quality index consistently remaining above the 300 mark. Delhi due to its the severely polluted AQI has received worldwide attention



as one of the most polluted cities on earth.

Of all the municipal solid wastes produced, around 40-60 per cent is organic in nature. It represents an untapped resource clean energy generating through biogas production. Kedia stated that there is a sense of urgency that no organic waste finds its way to the landfill sites and rather should be diverted energy-generating

#### **CNG** retailers want price hike, government wants to see cost

City gas companies like Indraprastha Gas Ltd and Adani Total Gas Ltd are mulling an increase in CNG prices after supplies of cheaper input gas was cut for the second time in a month, but the government officials say the retailers must give a cost breakup to justify the

The government, with effect from November 16, cut supplies of low-priced natural gas coming from old fields to city gas retailers by up to 20

per cent. This reduction came on the back of a 21 per cent reduction on October 16. City gas retailers IGL, which

retails CNG in national capital and adjoining cities, Mahanagar Gas Ltd that does the same in Mumbai, and Adani Total Gas Ltd which operates in Gujarat and elsewhere, in regulatory filings flagged profitability concerns due to supply cut and hinted at price hike.

Officials in the ministry of petroleum and natural gas however are unimpressed as they feel the retailers operate on "hefty" margins and can easily absorb the additional cost they may have to incur on replacing the lost volumes with slighted higher priced gas from new wells or imported LNG.

Take for instance IGL. It posted a net profit of Rs 1,748 crore on revenue of close to Rs 16,000 crore in the fiscal year ending March 31, 2024.

That is a margin of 11 per cent. MGL had a profit of about Rs 1,300 crore on a revenue of Rs 7,000 crore. Which retailer earns that kind of margin?" a senior official

Officials said the government is not against companies earning profits but if they want low-priced input (gas from old fields) then they should also declare the cost breakup of the final product

The total area for which the relocation being planned is 927 hectares, including 205.8 hectares of forest land, 572.5 hectares of tenancy/private land, and 149.3 hectares of government land.

The company is planning to ramp up the capacity of Jayant coal mine from 30 million tonnes per annum (MTPA) to 35 MTPA by 2026-27.

The company is expecting a big jump in capex target in the coming fiscal year, the CMD said, adding that a chunk of its over Rs 4,000 crore capex will be spent on land compensation.

NCL's capex for the current fiscal year will be in the range of Rs 2,500-2,600 crore. The PSU company produced

136.2 million tonnes of coal in 2023-24. The miniratna company under the Ministry of Coal is targetting production of 139 MT coal in the current fiscal year.

The company accounts for 14 per cent of the total coal produced in the country, contributing to 10 per cent of the country's total electricity generation.

The Singrauli-headquartered company operates through its 10 mechanised opencast mines across Singrauli and Sonebhadra districts of MP and UP, respectively.

### Hyundai Motor India bets on CNG vehicles, sees accelerated demand

In October this year, HMIL had clocked 8,261 units of CNG models in domestic sales with CNG penetration in its compact car Grandi10 NIOS at 17.4 per cent, 39.7 per cent for mini SUV EXTER and 90.6 per cent for compact sedan AURA.

HMIL said it has also witnessed the penetration of CNG models grow from 8.8 penetration of 14.9 per cent per cent in FY22 to 10.7 per

cent in FY24 in the urban markets, and from 7.1 per cent in FY22 to 12.0 per cent As of October this fiscal,

HMIL's urban penetration of CNG models stood at 12.3 per cent while it was at 14.6 per cent in the rural market. ### Retail tomato prices drop 22.4 per cent on improved supplies: Government

The all-India average retail price of tomatoes stood at Rs 52.35 per kg on November 14, down from Rs 67.50 per kg on October 14, according to an official statement.

During the same period, modal wholesale prices at Delhi's Azadpur mandi witnessed a sharper decline of nearly 50 per cent to Rs 2,969 per quintal from Rs 5,883 per quintal, driven by increased arrivals.

Similar price corrections were reported from key markets Pimpalgaon (Maharashtra), Madanapalle (Andhra Pradesh), and Kolar (Karnataka), the ministry

"Though arrivals have



subsided at major tomato centres in Madanapalle and Kolar, prices have eased due to seasonal supplies from Maharashtra, Madhya Pradesh and Gujarat filling supply gaps nationwide," it added

Favourable weather conditions have supported both crop growth and smooth supply chain movement from fields to consumers, the statement noted.

country's tomato production is projected to increase 4 per cent to 213.20 lakh tonne in 2023-24. While tomatoes are grown

year-round, production varies

seasonally across regions. The ministry said adverse weather and logistics disruptions significantly impact prices due to the crop's susceptibility perishable nature.

The price surge during October 2024 was attributed to excessive and prolonged rains in Andhra Pradesh and Karnataka. October and November are

the main sowing periods in major producing states. Regular market availability is maintained due to the crop's short cultivation duration and multiple harvests, ministry added.

The Australian almonds are your key to a healthier gut microbiome, writes KAVITA DEVGAN

Regardless of whether you're a professional athlete or simply interested in health and fitness, it's easy to integrate almonds into your routine. In fact, a regular 30-gram handful of Australian almonds contribute to heart health. THE GUT BENEFITS OF ALMONDS

#### Interest in gut health has increased

exponentially over recent years. Understanding what drives a healthy gut is still in its infancy, but current knowledge suggests a healthy gut is dependent on an abundant and diverse gut microbiota. Lower gut microbiota diversity is associated with a range of disorders and disease states, including cardiovascular disease, type 2 diabetes and inflammatory bowel disease. The nutrients that we get from food, in particular fibre, *phytochemicals* (particularly flavonoids and polyphenols) and unsaturated fatty acids, can positively impact the gut micro biota. Almonds contain a unique nutrient package that includes all three, but what exactly is the evidence base for nuts and gut health?

#### Key insights you need to know:

• Gut health, and specifically micro biota balance and diversity, can influence overall health.

Almonds are one of the few foods to



contain a unique package of fibre, phytochemicals and unsaturated fat, that can all positively affect the gut microbiota composition.

There is established evidence that eating at least 1 large handful (>42g) of almonds daily has a positive effect on gut microbiotaboth increasing beneficial bacteria

Evidence suggests that long-term nut consumption may also decrease the risk of colorectal (and colon) cancer recurrence and death, and this link may be more apparent in women than men. Almonds contain the highest content of fibre, and one of

highest amounts phytochemicals, of all nuts.

#### Research findings in a snapshot: THE GUT MICROBIOTA

A 2020 SLR and meta-analysis of nine RCTs found strong evidence that both almonds (5 studies) and walnuts (3 studies) can improve the gut microbiota. There was an absence of evidence for other nut types (8). Almonds had a dual effect, increasing the abundance of healthy short chain fatty acids producing bacteria, and decreasing potentially pathogenic bacteria.

In one study, even greater effects were found in children, where 42.5g and 85g of almonds per day over 3 weeks had a more pronounced effect on gut microbiota in four-year-old children compared with their parents.

#### Is the level of processing important?

Research has shown that whole and chopped almonds have a greater positive impact on the gut microbiota than almonds in butter form. This may be because approximately 50% of the fibre

### US Open runner-up Fritz back in another big final and faces Sinner again for ATP Finals crown

Taylor Fritz is starting to make reaching big finals a habit. He feels like he belongs among the very best players in tennis, too. The American followed his runner-up finish at the U.S. Open by beating Alexander Zverev 6-3, 3-6, 7-6 (3) on Saturday to play for the trophy at the ATP Finals. "I have believed that I belong, that I'm one of the best players Fritz said. "It's not results-based. It's more I can feel how I'm

playing. This week is huge." In Sunday's final, Fritz will will face top-ranked Jannik Sinner the player he lost to in the U.S. Open final. Sinner also beat Fritz in straight sets in the group stage this week
