# Marital rape not a crime, **Centre tells Supreme Court**

#### **Government says punitive measures in place**

**¬**he Government Thursday filed an affidavit before the Supreme Court opposing petitions that have called for the criminalisation of marital rape in India.

The affidavit filed by the Union Home Ministry said that in a marriage, there is a continuing expectation to have reasonable sexual access from one's spouse. It clarified that such expectations do not entitle a husband to coerce his wife to have sex against her will. However, it may be excessive

and disproportionate to punish a man under anti-rape laws for such an act, the Centre said. affidavit further highlighted that the parliament has already provided different remedies to protect a married woman's consent within marriage.

In the counter-affidavit filed through advocate AK Sharma, the Union Home Ministry backed the existing Indian rape law that carves out an exception for sexual relations between a husband and wife. The Central Government



which has a direct bearing on society in general. While so, even if 'marital rape' is to be criminalised, it is not up to the Supreme Court to do so, the Centre argued.

"The (issue) cannot be decided without proper consultation with all the stakeholders or taking the views of all the States into consideration ... the act colloquially referred to as 'marital rape' ought to be illegal and criminalised. The Central Government asserts that a woman's consent is not

obliterated by marriage, and its violation should result in penal consequences. However, the consequences of such violations within marriage differ from those outside it, the affidavit stated.

It added that a breach of consent should be punished differently, depending on whether such an act occurs within or outside a marriage. These remedies include laws punishing cruelty to married women (as it was under Section 498A under the Indian Penal Code then), laws punishing acts against the modesty of women, and remedies under the Protection of Women from Domestic Violence Act, 2005. The Bench of Chief Justice of

India DY Chandrachud with Iustices IB Pardiwala and Manoj Misra is currently seized of the matter. Marital rape is excluded from the ambit of "rape" by way of Exception 2 to Section 375 of the Indian Penal Code (IPC). A similar provision is also present in the newly enacted Bharatiya Nyaya Sanhita (BNS) which replaced the IPC on July 1 this year. In 2022, the

Delhi High Court delivered a split verdict on whether marital rape should be a criminal offence. The matter then reached the Supreme Court in September that year. The sexual aspect is but one of many facets of the relationship between husband and wife, on which the bedrock of their marriage rests ... Given the nature of the marital institution in our socio-legal milieu, if the legislature is of the view that, for preservation of the marital institution, the impugned Exception should be retained, it is submitted that it would not be appropriate for this Hon'ble Court to strike down the Exception," the latest affidavit added.

The counter-affidavit was filed in response to a batch of petitions that have called for the criminalisation of marital rape. The Centre criticised the petitioners' approach of treating the institution of marriage as a private institution, terming this view unidimensional. The case of a married woman and her own husband cannot be treated in the exact same manner as other cases, it said.

## **Drug mastermind has Congress link, says BJP**

he Indira Gandhi Rashtriya Manay Sangrahalaya (IGRMS) successfully completed the re-construction of the traditional Hajong House in its open-air

exhibition premises. Seventeen traditional artists from the Hajong community of Joyrampur Village in Dhemaji District, Assam, led by Sri Sanjiv Kumar Hajong, played an instrumental role in reviving this important cultural exhibit. The team arrived at the IGRMS campus on September 5, 2024, and, within a span of 28 days, meticulously completed the reconstruction of the traditional house, which stands as vital of the Hajong community's traditional architecture and cultural heritage in the muse-

um premises. The culmination of this effort was celebrated with an inaugural ritual, marked by the preparation of a Dev Haali, a sacred and symbolic space used for invoking gods and goddesses. #### One-year-old child falls from moving e-rickshaw, dies

# 69.69 per cent turnout: ECI

Voter turnout of 69.69 per cent has been recorded in third phase of the Jammu and Kashmir Assembly polls, with women outnumbering men in casting votes, the Election Commission said Thursday.

Overall, 63.88 per cent turnout has been recorded at polling stations, as against 58.58 per cent in the Lok Sabha polls, the poll panel noted.

In phase-three of the polls on October one, when 40 seats went for voting in the Union Territory, the turnout of male voters was recorded at 69.37 per cent as compared to 70.02 per cent of women, the Election Commission (EC) said. Nearly 44 per cent of voters from the third gender

category came to cast their votes in this phase. Referring to the overall turnout, the

Commission said it stood at 63.88 per cent with male participation recorded at 64.68 per cent. The overall women turnout was recorded at 63.04 per cent and that of the third gender at 38.24 per

The final votes polled will be available post-counting with counting of postal ballots. Postal ballots include postal

ballots given to service voters, absentee voters (those above 85 years of age, persons with disabilities, those part of essential services) and voters on election duty, the EC Daily account of such postal

ballots received, as per established guidelines, are given to all candidates, it said.

## Indian researchers develop road safety sensor prototype

A prototype of a road safety sensor that can be implanted at high-risk turning points where accidents are frequent, has been developed by Indian researchers from a new polymer nanocomposite with pressure sensing and energy harvesting properties.

The prototype may be implanted in the movable ramp and secured to the road just 100 meters before acute and fatal turning points. Thus, any vehicle approaching from the opposite side will see the signal on a screen and be alerted, according to from Department of Science and Technology which has funded the project under INSPIRE

programme.
This prototype works on the principle of piezoelectric effect so it can generate energy that can be stored and used further to power electronic gadgets as well, Developed by the scientists from the Centre for Nano and Soft matter Sciences (CeNS), Bengluru, the novel polymer nanocomposite, from which the prototype has been crafted, has been made of transition dichalcogenide,

Scientists, Ankur Verma, Dr. Arjun Hari Madhu, Dr. Subash Cherumannil Karumuthil synthesised vanadium disulfide (VS2) with a very high surface charge which has the capacity of improving the piezoelectric characteristics of polymers. Polymer nanocomposite films

were prepared by integrating these nanoparticles at various concentrations into a wellknown piezoelectric polymer, poly (vinylidene difluoride)

Further they investigated how

the surface charge of nanoparticles will affect the piezoelectric properties of polymer nanocomposite. In addition, a laboratory-scale

demonstration of a road

This study demonstrates that PVDF-VŚ2 nanocomposites will provide significant value to flexible, long-term energy

generating and pressure sensing applications. This work was recently published in the Journal of Material Chemistry A and an Indian patent application filed.
This study is part of an

ongoing project "Materials for self powered powered energy generating and pressure sensing devices".

Scientists are constantly trying to develop new materials for self-powered energy generating pressure sensing devices and using them for several applications. 

## BJP proposes renaming Sealdah station | Indian Army aims to crack terrorists' after Dr Shyama Prasad Mukherjee

There are credible reports that a section of Bengal BJP has started lobbying for rechristening Sealdah Railway Station as Dr. Shyama Prasad Mukherjee Railway Station a la Deen Dayal Upadhyay Railway

The proposal to change the name of the country's sixth oldest railway station after Mumbai VT, Howrah, Chennai, Kanpur and Vadodara was given by BJP Rajya Sabha MP Samik Bhattacharya before Railway Minister Ashwini Vaishnav during his visit to Kolkata on Wednesday.

"But what is in a name?" asked Trinamool Congress' Kunal Ghosh who wondered why the name of only Mukherjee and why not Swami Vivekananda who lived nearby, barely a mile or two away from the Station at Shimla Street should be considered

"Why the station should not be named after Swami Vivekananda because after returning from his glorious trip to Chicago his ship came to Budge Budge from where he took a train to Sealdah It is from this place where thou-



sands of young people assembled and dragged his cart by hand," Ghosh said.

However according to Bhattacharya, "When lakhs of beaten and uprooted refugees from the erstwhile East Pakistan thronged Sealdah Station post Partition it was Dr Mukherjee who stood by them and their cause I will request the honourable Railway Minister to consider renaming Sealdah Station after Prasad Shyama Mukherjee.

Historically speaking: British architect Walter Glanville in 1869 designed the Sealdah Main Railway Station as it stands today pursuing a Victorian-Gothic form.

Sealdah which has 20 platforms today had only four in 1862 standing out amidst muddy, marshy and potholed

vicinity. It was a part of the East Bengal Railway and then Assam Bengal Railway set up in 1857 for the sake of establishing connectivity with northern and southern Bengal which then comprised a large

province including Bihar,

Odisha and portions of the

present North East. Incidentally there was a tram terminus located just outside Sealdah Station before the year 1978 from where the concept of horse tram carriage started. Historically speaking Sealdah owes its name to Sealdihi or a village infested by jackals.

In fact the station itself was built clearing a huge Pipal tree surrounded with bushes, swamps and marshes and heavily colonized by jackals on two sides of the great Maratha Ditch (a canal) that surrounded the city and where today runs the Upper and Lower Circular Roads more lately called the Acharya Prafulla Chandra (APC) Road and Acharya Jagadish Chandra (AJC) Road. The Maratha Ditch was dug up to prevent Maratha invasions in those days. So historically today's Sealdah Station stands by the Maratha Ditch so to say.

The Maratha Ditch could not however prevent Bengal Nawab Siraj ud Daulah from invading Kolkata in 1756 when he crossed the mighty canal and attacked the British garrison "causing a great loss to the white men's families by bundling about 64 of them including women inside an underground chamber leading to 43 deaths."

Others however, put the figure to 146 captured and 123 dead. Sealdah stood witness to the brief but cruel battle between the Nawab and the British who avenged the cruelty post Battle of Plassey by allowing Siraj to be cut into pieces and ferried about the Murshidabad town on a bullock cart.

# encrypted communication networks

The outgoing General Officer Commanding (GOC) of the Srinagar-based 15 Corps, Lieutenant General Rajiv Ghai on Thursday said that the Indian Army is working hard to crack the highly encrypted communication network of the terrorists to dismantle their ecosystem in the

Briefing media persons in Srinagar Lt Gen Rajiv Ghai said, "We are aware that terrorists operating in the valley are using ultra communication networks, which have layers of encryption. While presently it is affording them the secrecy that they want I assure you that work is happening in this direction and soon we will be able to crack that encryption and I am hoping that will further dent their ecosystem and net-

The senior Army officer also claimed that the active number of terrorists in the region has also come down to 80 and no fresh recruitment has taken place in recent months in the

"There are around 80 active terrorists in Kashmir. The figure has gone down. Their number will be further down by midnext year," he said.

He estimated that between 25 and 30 foreign terrorists remain

active, and the army is determined to neutralize them soon. We foiled infiltration attempts by terrorists from across the border. This summer there were fewer attempts of infiltration," he said.

He further stated that successful infiltration attempts were not mostly made in Kashmir but at other places.

Referring to the frequent attacks in Pir Pranjal range, Rajiv Ghai said that there were chances that the terrorists may attempt to take shelter in Kashmir. "Terrorists keep moving as they cannot survive in one place," he said. Sharing his assessment of the

prevailing security scenario Lt Gen Ghai said Kashmir has

troop cut was possible at this juncture, the GoC said: "We are in a consolidation phase and no dilution of counter insurgency and counter terrorism grid is recommended. Both the grids need to be maintained. I defi-nitely won't advocate any dilu-tion to these grids at this stage," the GoC said the GoC said.

The said interview which was carried in the 30th September edition of the paper had featured the chief minister's allegation that large scale gold smuggling and hawala cash was taking place in Malappuram district. "I did not tell this reporter anything on this issue. The Supreme Court on Thursday stayed the police probe into the alleged illegal confinement of two women at spiritual leader Jaggi Vasudev's Isha Foundation ashram at Coimbatore in Tamil Nadu. Transferring to itself a habeas corpus petition of a man alleging that his two daughters were held captive inside the premises of the Foundation, a bench headed by Chief Justice D Y Chandrachud directed the Tamil Nadu Police to not take any further action in pursuance of the Madras High Court's direction asking it to inquire into the alleged illegal confinement of the

'You can't let in the Army or the police into an establishment like this," the bench observed during the hearing. The bench, also comprising Justices JB Pardiwala and Manoj Misra, said the police shall file the status report, as directed by the high court in its September 30 order, before the top court. The top court passed the order after the Isha Foundation approached it challenging Madras High Court's order directing the Coimbatore Police to collect all case details registered against the Foundation and produce them before the court for further consideration. Senior advocate Mukul Rohatgi, appearing for the Foundation, sought a stay of the high court order, and said around 150 police offic

the Foundation's ashram and are probing every corner. The bench, which interacted with the two women in-chambers through video-conferencing, noted they have stated that both of them are residing at the ashram voluntarily and without any coercion. "As regards the presence of police, in pursuance to the order of the High Court, it has been stated by the two individuals that the police left the premises last night, though they were there... In pursuance of the order of the high court," the bench noted. While taking up the habeas corpus petition, the

bench permitted the father of the two women to appear before it through video-conferencing if he wishes to interact with the court in person or through counsel. The court said text of the high court's order indicated that they are presently 42 and 39 years old respectively. The bench noted the two women have stated that they are free to travel outside the ashram, which they had done from time to time and their parents have also visited there to meet them. The court noted it was submitted before it that a similar petition was filed by the mother of the two individual about eight years ago, in which the father had also appeared. Solicitor General Tushar Mehta, who appeared for the Centre, said the high court should have been "very circumspect". Madras High Court had on September 30 passed an interim order on a habeas corpus petition filed by Dr S Kamaraj.

## Bengal doctors divided over protest strategies

There seems to have developed differences of opinion among the doctors of Bengal agitating in demand of justice for their woman colleague who was on August 9 raped and murdered inside the RG Kar Medical College and Hospital with the seniors opposing the juniors' decision to resume indefinite "cease work" for the second time within a span of ten days following repeated attacks on their colleagues at various medical college hospitals.

According to the senior doctors the protestors who had been getting full support from the general public should not take recourse to actions that could impede people's interest. "About 35,000 patients come to the five medical colleges in Kolkata alone for treatment most of them have supported our cause throughout the movement so we should also take their plight into consideration particularly during the festive season when many private doctors would go vacationing and the poor patients would be left in lurch," said one of the senior doctors while expressing his views in a general convention of doctors called in RGKMCH on Thursday. Another senior doctor said

that "we have been by the side of these junior doctors and will continue to support their cause but without imposing our views on them we will just like to advice them that this is not right time to resume cease work impeding the interests of thousands of common people who have been by us all these days we cannot alienate the common man from this movement," said another senior paediatrician.

The doctors who had gone on an indefinite cease work post the RGKMCH incident had resumed duty breaking their 42-days' cease work after Chief Minister Mamata Banerjee assured foolproof security inside hospital premises besides conceding to their demand of removing Kolkata Police Commissioner Vineet Goyal and two directors of Health.

But the Government which had given us assurance on other demands would not fulfill them forcing us to resume our movement," said Dr Aniket one of the leaders.

Another doctor, a cardiologist suggested alternative mode of movement saying, "we can think about partial cease work or regular rallies and even dharnas or even go to the districts setting special medical care camps so as to make people aware about the plights of the doctors? The junior doctors had not

presented their views when reports last came in. However some of them said that they would take the

advice of the senior doctors and hold general body meeting of joint platform of junior doctors before taking a final decision. It is clear that this

Government is trying to create a rift between the common people who have supported us and the doctors but we will not fall in its trap if we withdraw our cease work then it will not be because of the government pressure but because of the needs of the people but still we will continue to agitate until attacks on doctors stop and until the Government takes some concrete steps to ensure safety and security inside the hospitals," said Dr Kinjal Nanda one of the agitating doctors.

## Bombay HC orders to expedite inquiry into custodial death

fter the BJP-led MahaYuti Agovernment set up a Commission of Inquiry into the "encounter killing" of Badlapur children sexusal assault case Akshay Shinde, the Bombay High Court on Thursday directed the Magistrate looking into Shinde' death to expedite its inquiry and submit the site of the state of th to it at the next hearing on November 18.

Hearing a PIL filed by the father of Shinde on the suspicious circumstances leading to the death of Shinde, a HC bench of Justices Revati Mohite Dere and Prithviraj Chavan asked the Thane Magistrate and the police to collect, preserve and get all the evidence relating to Shinde's death in police custody.

Earlier, Advocate General Birendra Saraf told the court that all relevant documents have been forwarded to the magistrate for inquiry. While asking the Magistrate to

start the inquiry proceedings quickly and submit its report quickly after hearing all parties in the case. "Law requires that when there

is a custodial death, the investigation be conducted by the Magistrate. Let the investigation be conducted. We will wait for the report of the magistrate," the HC bench said. 'The Magistrate should expedite the inquiry and submit its report to the court by

November 18. Akshay Shinde -- key accused in the sensational Badlapur child sexual assault --was shot dead at a point blank range while he was being taken from Badlapur to Thane in a van for investigation in another case. It may be recalled that two nursery girls - aged four and



were sexually abused allegedly by sweeper Shinde when they in the washroom of the kindergarten school run by Adarsh Vidya Prasarak Sanstha (AVPS) on August 13 for using the toilet there. A Special Investigation Team (SIT) of the Thane police that investigated the case has filed a charge-sheet in the case before the special Protection of Children from Sexual Offences (POCSO) Act court in Kalyan.

The firing pin of every gun is different. This can be a conclusive proof which firing arm will have which firing pin," the HC bench aid.

We want to see a report showing this conclusively," the HC bench said, while wanting to know from the police State CID police who are investigating the case if the bullet had pierced through the accused. Advocate General Saraf replied in the affirmative.

Expressing its displeasure over the failure to recover a bottle of water that was given to the accused when he asked for water in the vehicle. "The police's case is that the handcuffs of the accused were removed after he asked for

water after which he forcibly snatched the pistol of one of the police officers and opened fire. "It (bottle) is an important piece of evidence," the bench said. Seeking the medical report of

At a hearing held on September 25, a HC bench of Justice Revati Mohite Dere and Prithviraj Chavan had questioned the version put out by the police Shinde was shot by the police in self defence. Justice Chavan said "it is hard to believe" that a man of slight build as Akshay Shinde could be overpowered by the four policemen when he turned violent and pulled the slide back on a 9 mm pistol for firing which "requires firing which strength".

## The caste contest

Haryana elections will be a tight contest. The BJP-JJP alliance breakup and Congress rebels have added uncertainty to it

s Haryana heads to the polls on October 5, 2024, the political landscape is marked by intense competition and shifting alliances. This election holds importance as the Bharatiya Janata Party (BJP), which had formed a government in 2019 with the support of Dushyant Chautala's Jannayak Janata Party (JJP), is now contesting alone. The breakup of the BJP-JJP alliance has left the BJP in a precarious position, governing as a minority until the upcoming elections. The ruling party, which is contesting without its former ally, the JJP, is focusing on its development agenda, highlighting its work on infrastructure, education and women's safety. However, the party faces challenges, especially in rural areas, where discontent over issues like agricultural reforms remains strong. Another unpredictable player is Aam Aadmi Party which is contesting in Haryana with renewed vigour. AAP is aiming to replicate its success in neighbouring Punjab. The party is focusing on issues such as healthcare, education and anti-corruption measures, appealing primarily to urban voters. A strong contender of yesteryears, Indian National Lok DaL (INLD) led by Abhay Singh Chautala has joined hands with Bahujan Samaj Party. But the agrarian sector remains a pivotal issue in Haryana, especially after the farmers'

protests against the now-repealed agricultural laws. Farmers' resentment towards the government has not entirely subsided, and the opposition parties, particularly Congress and JJP, are using this to mobilise rural voters. Besides, Haryana has one of the highest unemployment rates in India. Both the BJP and Congress have promised to address the issue, with the BJP touting its industrial initiatives and the Congress proposing new employment schemes. But all said and done, it is the caste politics which decides who rules the State. The traditional Jat-non-Jat divide continues to shape Haryana's political landscape. The BJP, which has traditionally garnered support from non-Jat communities, faces the challenge of consolidating this base while the JJP and Congress focus on winning over Jat voters. Caste dynamics have always been a significant factor in Haryana's political landscape, deeply influencing voter behaviour and electoral outcomes. Jats, who make up approximately 25-30 per cent of Haryana's population, are the state's most politically influential caste group. The Congress, under Hooda, is attempting to bridge the gap between Jats and non-Jats by emphasising its rural-urban development plans but is plagued by rebels. The outcome of the elections will be favourable to the party which manages the complex caste matrix of the state well.



Practical enforcerisks are significant. A coordinated effort involving the Ministry of Finance, Information Technology, Home Affairs, and Consumer Affairs is essential, with each department playing a critical role in enforcement and raising public awareness about the legal implications of sup-

porting illegal operations. Without robust enforcement and heightened awareness, illegal gambling platforms will not only make Indian citizens vulnerable to gambling addiction but also siphon their hard-earned money into criminal networks. The profits from illegal gambling often fund organised crime, money laundering, and terrorism, with global examples linking gambling profits to drug trafficking and terrorist financing. This not only destabilises local economies but poses a serious threat to national security. As the government takes strict action against illegal gambling, it must also work closely with the legitimate gaming industry to differentiate between legal online gaming and illegal gambling. Such a partnership would

port the industry's growth. This collaboration could further enhance the crackdown on illegal gambling through combined awareness campaigns and enforcement efforts.Finally, the government and the gaming industry must work together to dévelop a responsible gaming framework.

#### **REBALANCING THE GLOBAL ORDER**

The escalating missile strikes between Israel and Iran threaten regional stability in West Asia

he escalating situation in India's extended neighbourhood is threatening internal security for the region. The recent elimination of several top Hezbollah commanders, especially the killing of its top leader Hassan Nasrallah, by Israel, and Iranian missiles raining on Israeli territory is likely to widen the crisis in West Asia. PM Modi realised the sensitivity of the situation and immediately made a phone call to their Israeli counterpart Benjamin Netanyahu. Indian PM's message to Israel was "the crucial need for preventing regional escalation and the safe release of all hostages, terrorism has no place in any form and manifestation and India stands ready to support early restoration of peace and stability." Last month on the sidelines of the Summit of Future in New York, the PM met the President of Palestine Mahmoud Abbas. A press statement released after the meeting read "The Prime Minister reiterated India's time-tested principled position on the Israel-Palestine issue, and called for ceasefire, release of hostages and return to the path of dialogue and diplomacy. He stressed that only a two State solution will deliver enduring peace and stability in the region. Recalling that India was one of the first countries to recognise Palestine, he conveyed India's continued support to Palestine membership of the UN." Even as the Indian PM was holding bilateral with several global leaders in the US, the newly appointed head of the interim government of Bangladesh Muhammad Yunus was getting a much-needed pat on his back from Western leaders. Yunus during his US trip met the US President Joe Biden, former President Bill Clinton, US Secretary of State, Canadian PM, President of the European Union, heads of the World




Bank and ADB. He topped it up by having an unusually warm meeting with Pakistan's PM, where he expressed the desire to deepen their bilateral ties and revive the regional body SAARC. For India, these ties could potentially lead Pakistan and China to use this newfound bonhomie with Bangladesh to push its subversive agenda against India. Almost on cue External Affairs Minister S Jaishankar in his remarks at the Asia Society Policy Institute in New York spoke on rebalancing the global order. He said "Rebalancing a global order which started with 51 founding members of the United Nations, which has quadrupled in the last eight decades, where you not only have more independent countries in the world, but the economic, political and even demographic weight of individual members of the global order has shifted, shifted to a point where many of us believe that today we are actu-

The minister carefully brought multipolarity and plurilateralism in same address while trying to define the evolving global order. He said "Today, we are looking really at a global landscape which is much more regional, which is, as I said, much more characterised by countries who have their strong interests and which have the ability to pursue that interest. And so a lot of what we see in terms of the world is really how does the politics of convergence of the world is really how does the politics of convergence play out. And a third word which would occur to me is 'plurilateralism'. It's a very ugly word, but it in a sense describes a world beyond bilateral relations but which are short of multilateral. That where countries form combinations based on these convergences and overlaps that I've talked about. And you have really this phenomenon of groups of countries coming together for often a limited agenda, sometimes in an agreed theatre to pursue their interests." The recent global events and India's measured stance on several of these reflect what the EAM spoke about in New York, and a rebalance is underway. ## One Nation, One Ration: Revolutionising food security with 24/7 grain ATMs

These grain ATMs are a major step in India's fight against hunger. Biometric authentication and Aadhaar-linked portability ensures streamlined distribution

ince June 1, 2020, under the Modi administration, the 'One Nation, One Ration Card' system has been implemented across India, marking the beginning of a revolutionary scheme. Its purpose is to provide food grains to the poor, particularly those who migrate from one state to another, through a single

ration card. Initially, the system was launched in two clusters comprising four states (Andhra Pradesh-Telangana and Maharashtra-Gujarat). Even then, work was underway on inter-state ration card portability in other states. The government claimed that the common people would benefit most

this



Previously, ration cards were issued by the government to provide food grains and other rations to the poor at subsidised rates. However, when workers moved to another state, they often lost access to these benefits, particularly in more developed

states like Gujarat. With this new system, that issue is resolved, adding another significant chapter

Union Minister of State for Consumer Affairs, Food, and Public Distribution, Nimuben Bambhaniya, recently inaugurated Gujarat's first grain ATM in Bhavnagar, facilitating 24/7 ration distribution under the Central Government's Public Distribution System (PDS). The grain ATM, called Annapoorti, was the Karchaliapara area of Bhavnagar city to free the poor from India's outdated, bureaucratic ration distribution system. According to Minister Bambhaniya, the grain ATM represents a

The 2011 census reported that about 4.1 crore people had migrated to other states for work. The Aadhaar numbers of family members on over 85 per cent of the country's ration cards are registered, enabling them to use

the ATM system. India runs one of the world's largest food-based safety nets, providing subsidised grains to around 813 million people every month through a network of over 500,000 fair price shops (FPS).

This initiative is key to the partnership with the United Nations World Food Bihar or Uttar Pradesh trav- Programme to enhance food

security. ATMs will be installed across the state, offering 24/7 access to food grains under the National Food Security Act. The Annapurna Yojana allows anyone with a valid PDS ration card, regardless of their state or union territory, to access their entitlements. The ATM can deliver up to 50 kg of grain in just five minutes, reducing wait-

ing time by 70 percent. Once biometric authentication with an Aadhaar card is complete, users will have continuous access to their entire ration. The modular design of the ATM allows for easy assembly based on the available space. Additionally, Annapoorti is energy-efficient and can be connected

to solar panels for automat-

The grain ATM is designed to distribute wheat and rice and includes a tank with a capacity to hold 2,500 kg of grains, according to an offi-

cial release.

Officials explained that individuals covered under the National Food Security Act can visit the grain ATM at any time, punch in their ration card, authenticate their identity using the fingerprint scanner, and collect their monthly ration. However, there is speculation that the grain ATM in Bhavnagar could also be used to attract migrant voters in the upcoming assembly elections.

# at least 50 people: Witnesses

boat carrying scores of pas-Asengers capsized on Lake Kivu in eastern Congo on Thursday, killing at least 50 people, witnesses told The Associated Press.

It was not immediately clear exactly how many people were on board or how many perished but witnesses said they saw rescue services recover at least 50 bodies from the water. They said 10 people survived and were taken to the local hospital

The boat, overloaded with passengers, sank while trying to dock just metres (vards) away from the port of Kituku, the wit nesses said. It was going from Minova in South Kivu province to Goma, in North Kivu province.

Local authorities said that the rescue efforts continued and the death toll remained unknown for the moment. In February, the majority of the 50 passengers aboard a wooden boat were presumed dead after

the vessel capsized on Lake Kivu. "This boat was carrying about a hundred people when it had the capacity for about thirty passengers," the governor of the province of South Kivu Jean-Jacques Purusi told a local radio station following the acci-

It was the latest deadly boat accident in the central African country, where overcrowding on vessels is often to blame. Maritime regulations also are often not followed.

Congolese officials have often warned against overloading and vowed to punish those violating safety measures for water transportation. But in remote areas where most passengers come from, many are unable to afford public transport for the few available roads.

In June, an overloaded boat sank near the capital of Kinshasa and 80 passengers lost their lives. In January, 22 people died on Lake Maî-Ndombe and in April 2023, six were killed and 64 went miss-

Witnesses said the boat that capsized on Thursday was visibly overcrowded.

"I was at the port of Kituku when I saw the boat arriving from Minova, full of passengers," Francine Munyi told the AP. "It started to lose its balance and sank into the lake. Some people threw themselves into the water.

"Many died, and few were saved," she added. "I couldn't help them because I don't know how to swim."

The victims' families and Goma residents gathered at the port of Kituku, accusing authorities of negligence in the face of growing insecurity in the

Since the fighting between the armed forces and the M23 rebels made the road between the cities of Goma and Minova impassable, forcing the closure of the passage to trucks transporting food, many traders have resorted to maritime transport on Lake Kivu. It's an

alternative considered safer than road traffic, which is threatened by insecurity. But according to Elia Asumani, a shipping agent who works on this line, the situation has become dangerous: "We are afraid," he told the AP. "This shipwreck was predictable." Bienfait Sematumba, 27, said he lost four family members.

"They are all dead. I am alone now," he said, sobbing. "If the authorities had ended the war, this shipwreck would never have happened." The survivors, about 10 of

them, were taken to Kyeshero hospital for treatment. One of them, Neema Chimanga, said she was still in shock.
"We saw the boat start to fill

with water halfway," she recounted to the AP. "The door of the boat opened, and we tried to close it. But the water was already coming in, and the boat tilted." "I threw myself into the water and started swimming," she said. "I don't know how I got out of the water.

Rutte expressed confidence that he can work with whomever is elected president of the United States, the alliance's most powerful member, in November. That could be a key moment for Ukraine's effort to ensure continuing Western support.

The Russian military, meanwhile, intercepted Ukrainian drones overnight, according to a statement by the Defense Ministry in Moscow.

The drones were destroyed over four Russian regions on the border with Ukraine -Belgorod, Bryansk, Kursk and Voronezh, it said.

## Votes against party lines can be counted, rules Pak's top court

**PTI** ISLAMABAD

Pakistan's Supreme Court ruled Thursday that the votes cast by lawmakers in parliament against their party directions can be counted, in a major relief to the government seeking support for a constitutional amendment to tweak laws related to the judiciary. The apex court's previous rul ing had stated that the votes of parliamentarians who deviated from their party's directives were to be disregarded and not counted. The Supreme Court Bar Association had filed a review petition against the apex court's verdict related to the defection clause under Article 63-A of the Constitution.

Hearing the plea, a five-member bench led by Chief Justice of Pakistan Qazi Faez Isa announced the unanimous verdict and approved the review petition with the top judge saying the detailed verdict would be issued later.

The bench comprising Chief Justice Isa and justices Naeem Akhtar Afghan, Aminuddin Khan, Jamal Khan Mandokhail and Mazhar Alam Khan Miankhel issued the verdict fter hearing the petition that the bench had started on

Monday. The court in its May 17, 2022 verdict had said that the votes of the lawmakers would not be counted but after granting of review petition, the vote would be counted but the person going against the party line would lose his seat.

The 2022 verdict was given in response to the presidential case filed by then-President Arif Alvi. It was then a 3-2 split decision, with then-chief justice Umar Ata Bandial, Justice Ijazul Ahsan and Justice Munib Akhtar being the majority verdict authors. The development comes as the government is struggling to get support for its planned constitutional amendment to tweak laws related to the top judiciary.

## Singapore court jails Indian-origin ex-minister for 12 months

**PTI** SINGAPORE

Singapore's Indian-origin former transport minister S Iswaran has been sentenced to 12 months jail on Thursday by the High Court for obtaining gifts worth about SGD 403,300 over seven years, from two businessmen he considered his friends. The 62-year-old pleaded guilty to four charges relating to receiving gifts and one blocking justice on September 24, the first day of trial proceedings, cutting short what was set to be a protracted trial with 56 prosecution witnesses.

In sentencing, Justice Vincent Hoong said he had considered submissions on sentence from both prosecution and defence but was "ultimately unable to agree with both the positions taken". In his sentencing remarks, Justice Hoong emphasised that trust and confidence in public institutions are the bedrock of effective governance.

The judge added that the former minister abused the position to accept gifts worth about SGD 403,300 (USD313,200).

He said, "This can all too easily be undermined by a public servant who falls below standards of integrity and accountability." The judge said it was significant that Iswaran had innocent, and believed he would be acquitted. Thus, I have difficulty believing that he was remorseful," The Straits Times quoted the Judge as saying. As Justice Hoong addressed the court, Iswaran looked down and took notes. The judge added, "The higher the office held by the offender as a public servant, the higher his level of culpability." He said such individuals set the tone of public servants in conducting themselves with high

false. "In a letter to the Prime Minister,

Iswaran said he rejected the charges and was

## Prosecutors lay out new evidence | Kamala Harris surveys Hurricane in Trump election case

**AP** WASHINGTON

Donald Trump laid the groundwork to try to overturn the 2020 election even before he lost, knowingly pushed false claims of voter fraud and "resorted to crimes" in his failed bid to cling to power, according to a newly unsealed court filing from prosecutors that lays out fresh details from the landmark criminal case against the former president.

The filing from special counsel Jack Smith's team offers the most comprehensive view to date of what prosecutors intend to prove if the case charging Trump with conspiring to overturn the election reaches trial.

Though a months-long congressional investigation and the indictment itself have chronicled in stark detail Trump's efforts to undo the election, the new filing cites previously unknown accounts offered by Trump's closest aides to paint a portrait of an "increasingly desperate" president who while losing his grip on the White House "used deceit to target every stage of the electoral process'

So what?" the filing quotes Trump as telling an aide after being alerted that his vice-pres-



ident, Mike Pence, was in potential danger after a crowd of violent supporters stormed the US Capitol on January 6, 2021.

"The details don't matter," Trump said, when told by an advisor that a lawyer who was mounting his legal challenges wouldn't be able to prove the false allegations in court, the filing states.

The filing was submitted, initially under seal, following a Supreme Court opinion that conferred broad immunity on former presidents for official acts they take in office, narrowing the scope of the prosecution charging Trump with conspiring to overturn the results of the election he lost to Democrat Joe

The purpose of the brief is to con-

vince US District Judge Tanya Chutkan that the offences charged in the indictment are private, rather than official, acts and can therefore remain part of the indictment as the case moves forward. Chutkan permitted a redacted version to be made pub-

"Although the defendant was the incumbent president during the charged conspiracies, his scheme was fundamentally a private one," Smith's team wrote, adding, "When the defendant lost the 2020 presidential election, he resorted to crimes to try to stay in office.

Trump campaign spokesman Steven Cheung called the brief "falsehood-ridden" and "unconstitutional" and repeated oftstated allegations that Smith and Democrats were "hell-bent on weaponising the Justice Department in an attempt to cling to power."

"The release of the falsehood-ridden, Unconstitutional J6 brief immediately following Tim Walz's disastrous debate performance is another obvious attempt by the Harris-Biden regime to American undermine Democracy and interfere in this

The filing includes details of

conversations between Trump and Pence, including a private lunch the two had on November 12, 2020, in which Pence "reiterated a face-saving option" for Trump, telling him, "don't concede but recognise the process is over," according to prosecutors. In another private lunch days later, Pence urged Trump to accept the results of the election and run again in 2024.

"I don't know, 2024 is so far off," Trump told him, according to the filing.
But Trump "disregarded" Pence

"in the same way he disregarded dozens of court decisions that unanimously rejected his and his allies' legal claims, and that he disregarded officials in the targeted states — including those in his own party - who stated publicly that he had lost and that his specific fraud allegations were false," prosecutors wrote.

Trump's "steady stream of disinformation" in the weeks after the election culminated in his speech at the Ellipse on the morning of January 6, 2021, in which Trump "used these lies to inflame and motivate the large and angry crowd of his supporters to march to the Capitol and disrupt the certification proceeding", prosecutors wrote.

# Helene devastation in Georgia

Augusta (AP): Vice-President Kamala Harris handed out meals, embraced a shaken family and surveyed Hurricane Helene's "extraordinary" path of destruction through Georgia on Wednesday as she left the campaign trail to pledge federal help and personally take in scenes of toppled trees, damaged homes and lives upended.

She visited Augusta, where power lines stretched along the sidewalk and utility poles lay cracked and broken. The vice-president spoke from a lectern erected in front of a house with a fallen tree teetering on its roof, acknowledging those who had died in the disaster while also trying to project a tone of unity and hope for communities now facing long and expensive rebuilds.

Harris and President Joe Biden, who visited the Carolinas on Wednesday, were seeking to demonstrate commitment and competence in helping devastated communities after Republican former president Donald Trump's false claims about their administration's response.

Harris said she wanted to "personally take a look at the devastation, which is extraordinary". She expressed admiration for how "people are coming together. People are helping perfect strangers".

The Democratic presidential nominee said that shows "the vast majority of us have so much more in common than what separates us", an echo of a line she frequently uses on the campaign trail.

Before delivering her remarks, Harris could be seen embracing and huddling with a family of five grappling with the storm's aftermath. "We are here for the long haul," she said. Harris also toured a Red Cross relief centre and received a briefing from local officials, praising those working to "meet the needs of people who must be seen and must be heard". I am now listening," she said.

Brittany Smith, an Augusta resident, walked away from the distribution centre with Styrofoam boxes of food and some fruit cups, beaming that she got a photo with the vicepresident. She said there's a hole in her roof and she had to send her kids elsewhere to live because it wasn't safe.

Harris' visit, she said, "made it better" despite the hardship. Smith said she was encouraged that Harris travelled to the town instead of just appearing on television. "She's a person. She's not just a voice." About 200 miles north in the Carolinas, Biden was also surveying the storm's aftermath. With many of the area's roads inaccessible, he flew by helicopter over toppled trees, twisted metal and towering piles of debris in the normaly tourist-friendly downtown of Asheville. From the air, Biden saw flooded roads, piles of shredded lumber and displaced sandbags, emergency trucks and downed power lines. In one area, homes were partly underwater, and it was hard to distinguish between lake and land. Visits to disaster zones are a familiar responsibility for Biden, who has frequently been called on to survey damage and comfort victims after tornadoes, wildfires and tropical storms. But this was Harris' first visit

to a disaster area as vice-president.

## UK hands over Chagos Islands to Mauritius, holds on to military base

m he}$  UK on Thursday announced a "historic" agreement that will see Britain hand over sovereignty of the remote Chagos Islands in the Indian Ocean to Mauritius while it retains the joint UK-US military base on Diego Garcia. The British Indian Ocean Territory (BIOT) status of the disputed archipelago, made up of around 60 islands, has been in contention for many years and negotiations over its future began under the previous Conservative Party government in 2022. Under the agreement announced this week, the tropical atoll of Diego Garcia which the West says plays a crucial role in the region's stability and international security – will remain under UK and US jurisdiction for at least the next 99 years. "This government inherited a situation where the longterm, secure operation of the Diego Garcia military base was with contested sovereignty and ongoing legal challenges," said UK Foreign Secretary David Lammy.

## Samsung workers protest continues to 4th week | Government launches internship programme for youth

Workers of Samsung India Electronics Ltd on Wednesday observed a token fast near the factory in Chennai on Wednesday, as part of intensifying their ongoing protest w entered the fourth week. which

Communist Party of India (Marxist) led Centre of Indian Trade Unions (CITU) which is spearheading the protest by the employees said they would be meeting the Director of Factories in a day or two, alleging that the Korean electronics giant has roped in temporary workers to work in the shop floors in view of the strike.

About 1,100 employees of Samsung India Électronics Ltd are on strike since September 9 pressing for various demands including wage revision and better conditions. While several rounds of talks held in the presence of the Labour Department and company



officials failed. another tripartite meeting has been planned for next week, said CITU leaders.

We are observing a token fast today. We want the state government to come forward and resolve the issue fast. Our most important demand is to recognise the Samsung India Workers Union by the labour department at the earliest. "The temporary labourers are not trained like regular employees and this attitude by the management is not acceptable. We will file a complaint with the Director of Factories in a day or two, said the trade union leaders. Samsung's Chennai unit produces consumer durables at the factory including airconditioners, refrigerators and television sets. Recently, Labour Minister

the Tamil government urging to resolve the issue amicably. On Tuesday, the CITU members staged a protest in some districts as part of extending their support to the Samsung India workers

They were detained by the police and were released Samsung India recently said

scores of agitating workers have returned to work soon after it issued a show-cause notice. "The management has already indicated that all the issues can be resolved by discussions and has made various harmonious attempts to resolve differences and for your report to duty, Samsung had said. Due to the strike, Šamsung India said the impact on the plant operations was minimal and added that the welfare of the employees is of top priority and would engage with them to address any grievances they may have.

'Trading lot for the purpose of trading of units on the designated stock exchange shall be Rs 25 lakh," Sebi said

in its notification dated September 26. The move came into effect the same day. The move will help increase the liquidity of privately placed InvIT units by permitting a broader base of investors to participate in the market and diversification of investment portfolios.



# Hindus and the Modern Struggles of Religious Persecution

Anand Ranganathan's book, Hindus in Hindu Rashtra, offers a scathing analysis of the plight of Hindus in modern India, drawing parallels to historical persecution and raising crucial questions about religious dynamics in the country.

Sufferance is the badge of our tribe," Shylock, the Jewish money lender, says in the Shakespearean play "The Merchant of Venice," Had Shylock been around now, he would certainly have added Hindus too as the victims of hatred and cruelty perpetrated by the Abrahamic religions. History, as well as modern times, substantiate what Shakespeare made Shylock say in this path-breaking play.

In October 2023, the dreaded Hamas organisation let loose one of the most barbaric attacks ever reported in history on the innocent Jewish residents of the Gaza Strip, kidnapping more than 300 of them and subjecting them to vicious torture. The Hamas terrorists were celebrating in style as their colleagues recounted how they raped young girls in front of their parents and tore them apart, a la Nirbhaya incident that shook India in 2012.

It was only when Israel retaliated (like any other nation would) in a bid to release their brethren from the torturing cells of Hamas, that liberals, secularists pseudo-intellectuals came out extending their open-hearted support to Hamas. The Israeli Defence Force was portrayed as the aggressor while the Hamas terrorists were seen as angels in the eyes of these paid intellectuals.

The history of the Jewish people is packed with stories of persecution faced by them and their struggles for survival. No other community, other than Hindus, has faced the kind of cruelty to which the Jewish were subjected by their tormentors. To lambast Israel and eulogise the Arabs as well as Palestinians became the measure of one's intellectual dexterity.

This is what the Hindus in India face now. Though 80 per cent of the Indian population are Hindus, they face the

same kind of torment and cruelty at the hands of the minorities. In the land of the Sanatana Dharma, the aggressors claim ownership of more than 70 per cent of the land. A cleric was heard claiming the other day that Antilia, the 27-storey personal residence of Mukesh Ambani in Bombay and valued at \$4.6 billion, has been constructed on Waqf land. It is for Mukesh Ambani to give clarification to this claim, while the day is not far off when the same people are likely to come forward claiming that Rashtrapati Bhavan as well as 7 Lok Kalyan Marg belong to them.

Forget about these things. The Hindus have become eighth-class citizens and victims of State-sanctioned apartheid in their own country, according to Dr Anand Ranganathan, scientist, author and political critic who works in the Communist citadel Jawaharlal Nehru University (JNU for short). Dr Ranganathan speaks and writes with conviction and articulation. True to his profession as a genetic engineer and biotechnologist, Dr Ranganathan has found out the basic reasons behind the plight of the Hindus in the country, and he has made it unambiguously clear with his latest book Hindus in Hindu Rashtra, published by BluOne Ink. 

## INDIA NEED TOP GUNS FIRING IN UNISON AGAINST NEW ZEALAND

stellar effort by senior stars would be mandatory when India take on New Zealand in their opening Group A match of the women's T20 World Cup here on Friday, aiming for a strong start in their quest to wipe off the memories of past near-misses.

A victory against them could well be counted as a sign of being in fine shape — tactically and mentally and that's a pre-requisite for India in a group that also has Australia, Sri Lanka and Pakistan.

To start with, India will require heavy contributions from their top guns the 35-year-old Harmanpreet, Smriti Mandhana, Jemimah Rodrigues, Shafali Verma and Deepti Sharma.

them, Shafali Among Mandhana have been in excellent touch, making runs in their last international outing in the Asia Cup in Sri Lanka in July even though India lost to the hosts in the final. In fact, Mandhana's last five T20I innings include three fifties.

But Harmanpreet and Shafali have been a tad underwhelming and the duo finding range is imperative for India's charge at the top and middle

It is critical to India's chances as the pitches in the UAE, going through a harsh heat wave, might not be a treasure trove of runs, particularly deep into the tournament.

However, the expected weariness of the track, in one way, will cater to India's strengths in the bowling department — spin.



They have only three pacers in their squad — Renuka Singh, Pooja Vastrakar and Arundhati Reddy.

#### Weight management is athlete's responsibility: Mary Kom situation demands. If the sports

No stranger to the physical toll of weight management during a competition, six-time world champion boxer M C Mary Kom Thursday waded into the debate surrounding wrestler Vinesh Phogat's Olympic heartbreak for being 100gm over, saying that to be within the prescribed limit is an individual responsibility.

The 42-year-old mother of four, who is only woman bover with Olympic medal (a bronze in London, 2012), was in the city to promote Utkarsh Small Finance Bank, which named her as its brand ambassador. Speaking for the first time on Phogat,

who was disqualified on the day of her 50kg finals in the Paris Games for being marginally over the prescribed Kom said weight limit, Mary management is an athlete's responsibility.

"I felt so disappointed in the sense that I have also done the same (weight management) for the last so many years. Weight is important, that is my responsibility. I cannot blame anyone, she said.

"I do not want to say this in her case. I am saying this in my case only. If I do not cut the weight properly then how will I play? I am there to win a medal and that is what I think," she continued.

Mary Kom, in the past, has spoken about her weight cut routines and how difficult the process can be. The Manipuri started out as a pin-weight (46kg) category boxer before settling for the flyweight (51kg) division in her amateur career.

Phogat, who was being seen as gold medal contender in Paris, skipped meals and fluids, worked out an entire night and also cut her hair to be within the requisite category but the effort fell She challenged her disqualification,

calling the rules inhumane, but her appeal was rejected by the Court of Arbitration for Sport. The wrestler retired to join politics after the heartbreak and is contesting the Haryana assembly elections on a Congress ticket.

WANT TO DISCUSS
BOXING WITH INDIAN

**SPORTS** MINISTER: Mary Kom was also quizzed about India's boxing campaign in Paris and she was still perplexed by how poor the performance was. Refusing to share her exact concerns, Mary Kom said she would rather discuss them in the meeting with Mandaviya and BFI brass.

'The federation has provided all the coaches. But I have a few doubts as well. But what is the point in saying them now, the Olympics are done. Jow there is no point in saving all that. but I want to discuss it with them in the meeting," said the former Rajya Sabha MP.

"(The) sports minister is doing whatever he can do from his side, infrastructure, facilities or whatever (other) needs are there. But how did the federation handle the training? Was it done systematically or not? What happened exactly, I do not know," she wondered.

"If I do not meet them and not discuss, how will I know about them?' Mary reiterated that she wants to

participate in professional boxing I have not retired yet but I want to compete. I am trying to get opportunities, waiting for my chance to fight pro. I just want to come back." "I can continue for another three-four years, that is my will. I have the passion and hunger. I want to continue," she

## Lionel Messi, Inter Miami win MLS Supporters Shield with 3-2 win at Crew

ionel Messi and Inter Miami have Lanother trophy, along with homefield advantage throughout the Major League Soccer playoffs.

Messi scored twice in the final minutes of the first half, goalie Drake Callender stopped a penalty kick in the 84th minute and Inter Miami beat the defending MLS Cup champion Columbus Crew 3-2 on Wednesday, wrapping up the Supporters Shield given annually to the team with the

best regular-season record. It was Messi's 46th major trophy won for club or country, extending his record for the most by any men's soccer player in history. And it is the second he has won with Inter Miami, this Supporters Shield being added to the Leagues Cup trophy the Herons claimed shortly after Messi joined the club in 2023.

"We knew this was a group that could fight for this," Messi said.

Luis Suarez also scored for Inter Miami, which will open a best-ofthree first-round playoff series in the final weekend of October. If the team wins that series, it would have the right to host every match it plays the rest of the season - an Eastern Conference semifinal (scheduled for

Nov. 23 or 24), the East final (Nov. 30 or Dec. 1) and the MLS Cup final on

'We have a nice opportunity to go down in history ... And now we think about what is coming," Messi told Apple TV after the match. "We have a great advantage in that we play all the games at home, which was what we were looking for. I think that we are very, very strong at home?

Also still within reach for Inter Miami: the best MLS regular-season mark ever. Wednesday's win pushed Inter Miami's record to 20-4-8 this season, giving it 68 points. If the club wins its final two matches - Saturday at Toronto and Oct. 19 at home against New England - it would finish with 74

New England has the single-season points record, finishing with 73 in

Messi opened the scoring in the 45th minute, taking a long pass from Jordi Alba - his longtime teammate at Barcelona, the club with which Messi won 35 of his trophies - and splitting two defenders before somehow getting the ball past Columbus goalkeeper Patrick Schulte for a 1-0 lead.

And about five minutes into first-half stoppage time, Messi struck again on a free kick from about 30 yards out.



Schulte seemed fooled, and Messi squeezed the ball between the goalie and the near post for a 2-0 lead.

"Dominant," Inter Miami coach Gerardo "Tata" Martino said. Diego Rossi scored in the first minute

of the second half for Columbus to cut the lead in half, but it didn't take long for Inter Miami to restore the two-goal cushion. Almost immediately after play resumed, Schulte was upended by one of his own defenders and Suarez sent a header into an empty net for a 3-1 edge. Juan "Cucho" Hernández's penalty

kick in the 61st minute got Columbus within 3-2. But once again, the momentum didn't last for long. Rudy Camacho was sent off for his second yellow card in the 63rd minute, meaning the Crew had to play with 10 men the rest of the way.

Didn't matter. Columbus still created some big chances down the stretch. A deflected ball in the 76th minute got

across the box and onto the right foot of Mohamed Farsi - but his shot was blocked by Callender, who was perfectly positioned to protect the

Then came more drama, when Inter Miami was called for its second handball inside the box — an automatic penalty kick - of the second half. Hernández picked the left side of the net, but Callender made the save look almost easy.

That save helped finish what Messi started.

It was the fifth two-goal game of the MLS season for Messi, who now has 17 goals in 17 league matches this season. He's missed 15 of Inter Miami's MLS matches in 2024, either because of commitments to Argentina's national team or the twomonth absence that he needed to recover from a badly injured ankle an injury that happened during his nation's run to the Copa America title in July. Inter Miami, in MLS play this season, is now 10-1-6 with Messi in the lineup.

Throughout the year we had many, many injuries, where we couldn't all be together ... But the group was getting the most out of every tough game, Messi said. The Crew and the LA Galaxy entered Wednesday still with a mathematical

hope of passing Inter Miami in the race for the Supporters Shield, and Cincinnati was nine points back with nine points still possible. But now, they're all playing for second.

"Dec. 7 is what we want," Martino said, referring to the date of the MLS Cup final.
