Delivering a thinly veiled message to Pakistan from its soil, External Affairs Minister S Jaishankar on Wednesday said activities across borders characterised by the "three evils" of terrorism, extremism and separatism are unlikely to encourage trade, energy flows and connectivity.

In his address at a conclave of Shanghai Cooperation Organisation (SCO) chaired by Pakistan Prime Minister Shehbaz Sharif, Jaishankar asserted that trade and connectivity initiatives must recognise territorial integrity and sovereignty and it is essential to have an "honest conversation" on the lack of trust.

Jaishankar spoke immediately after Sharif's inaugural address

Mustard is widely grown in states like Rajasthan, Haryana, and Madhya Pradesh while chana is widely consumed by a larger part of the population.



## Traffic jams on the Ring Road go round and round... Severe congestions on routes along, Ashram, Sarai Kale Khan, Majnu Ka Tila, Hanuman Setu, Rajghat

The traffic on Ring Road is anything but a smooth circle, if anything it resembles a 'jalebi' with two wheelers, autos and even rickshaws crossing lanes in a bid to get ahead in the bumper-tobumper traffic on the circular road. From Majnu Ka Tila to Hanuman Temple these jams are making the drivers sweat in their vehicles. There is a severe traffic jam on both sides of this route from Majnu Ka Tila to Hanuman Setu. This adds to the problems of the drivers coming to Majnu Ka Tila from Rajghat side, and those coming to Hanuman Setu from Majnu Ka Tila side.

On Tuesdays, there is a severe traffic jam on both sides in front of Hanuman temple. All efforts to reduce this jam have failed. Recently, traffic signals have been installed at the end of Hanuman Mandir Setu by Delhi Traffic Police. But this has not resulted in much improvement right now.

After the inauguration of Ashram Flyover, and Ashram Flyover Extension, people were expecting some relief from the jam, but due to the bottleneck near Sarai Kale Khan on the Ring Road, the mess remains.

As soon as one descends from the Ashram flyover to the Ring Road, the traffic jams begin, due to which it takes more than halfan-hour for people to cover the

distance of about half a kilometre to Sarai Kale Khan. This is due to the ongoing construction work of the rapid rail at Sarai Kale Khan.

Meanwhile, traffic jams continue on six roads of outer Delhi. Even emergency vehicles, ambulances and fire engines also get stuck in this jam. At the same time, due to the bottle neck near Haiderpur Badli Mod on Outer Ring Road, the traffic of sixlanes gets reduced to four lanes. The jam here is due to the narrow railway bridge. Vehicles coming without stopping from elevated road from the Pitampura get stuck in traffic as soon as they reach here. Several meetings have also been

held between the Public Works Department (PWD) and Railways. According to PWD sources the width of this bridge can be increased soon if mutual consent is reached.

Due to the construction work of Outer Ring Road Metro, there are traffic jams from Prashant Vihar to Rohini Jail Mod. it takes about 30 to 40 minutes to cover three kilometres in, whereas earlier it used to take five to seven minutes.

Vehicles coming from KN Katju route are stuck in traffic jams as soon as they reach the outer ring road. E-rickshaws and other vehicles parked haphazardly below Rithala metro station, add to the mess.

### **Bobby Panwar demands Vigilance** action against 'corrupt' UPCL MD

The president of Uttarakhand Berojgar Sangh (UBS) Bobby L Panwar accused the managing director of Uttarakhand Power Corporation Limited Anil Kumar Yadav of engaging in corrupt activities while addressing a media conference here on Wednesday. He commended the efforts of the Vigilance department in apprehending individuals on bribery charges. However, in the same breath, he said that the people being caught redhanded for taking bribes are small fries and the amount of bribes ranges from Rs 2,000 to Rs 8,000 while the big sorts, steeped headlong into corrupt practices, mysteriously elude the Vigi-"This discrepancy must be explained," he said. "For lance net. instance, Yadav has been indulging in corruption with impunity for years on end but the government and its agencies choose to look the other way. We suspect they are promoting him. According to our investigation, Yadav's properties are registered in the names of his wife and children. We requested the authorities concerned to probe and take actions, but all our efforts proved futile. We are convinced that these corrupt officers are functioning in cahoots with the corrupt people ruling the roost. They are being given full indulgence in the form of extension, post-retirement," he said. He further said that undaunted by official mollycoddling and apathy, his organisation was again appealing to the Vigilance department and other anti-graft agencies to initiate investigation against UPCL's managing director prior to taking exemplary actions for his involvement in corrupt practices. "In case nothing happens we will move the Uttarakhand High Court," he warned. 

Railway modernisation: Cabinet approves ₹ 2,642 crore for multi tracking project

 $U_{\text{Wednesday approved the}}^{\text{nion Cabinet on}}$ Varanasi-Pt Deen Dayal Upadhyaya (DDU) multitracking project with an estimated cost of Rs 2,642 crore. The proposed project includes a new rail-cum-road bridge across the Ganga river and the addition of third and fourth railway lines between Varanasi and DDU Junction route, among other infrastructural upgrades.

"The proposed multi-tracking project will ease operations and reduce congestion, providing the much-required infrastructural development on the busiest sections across Indian Railways. The project traverses through Varanasi and Chandauli districts in Uttar Pradesh," a government statement said.

It added, "Varanasi Railway Station, a crucial hub in Indian Railways, connects key zones



and serves as a gateway for pilgrims, tourists and the local population." According to the statement, the

Varanasi-DDU Junction route, vital for both passenger and freight traffic, faces heavy congestion due to its role in transporting goods like coal, cement, and food grains, as well as serving growing tourism and industrial demands.

"To address this issue, infrastructure upgrades are needed, including a new rail-cum-road

bridge over the Ganga River and the addition of 3rd and 4th railway lines. These enhancements aim to improve capacity, efficiency and support the region's socio-economic growth," the statement said. Apart from relief in congestion in the stretch, 27.83 MTPA (million tonnes per annum) freight is anticipated on the proposed stretch," it added. Highlighting the enhancement of employment/self-employment opportunities, the official release stated that the project is result of PM-Gati Shakti National Master Plan for multimodal connectivity which has been possible through integrated planning and will pro-vide seamless connectivity for movement of people, goods and services

According to the government, the project, covering two dis-tricts in Uttar Pradesh, will increase the existing network of Indian Railways by about 30 kilometres. "The Railways being an environmentally friendly and energy efficient mode of transportation, will help both in achieving climate goals and minimizing logistics cost of the country and lower CO2 emissions (149 crore kg) which is equivalent to plantation of six crore trees," the state ment said.

The grievance applications, filed in the physical form with the ministry/department, shall be uploaded on the CPEN-GRAMS portal to ensure proper monitoring of these grievances" it added.

Besides Modi and Shah, several Union ministers including Rajnath Singh and J P Nadda, who is also the BJP president, chief ministers of many states, and senior party leaders will attend the oath-taking event. Haryana Governor Bandaru Dattatreya will administer the oath of office and secrecy.

Haryana BJP chief Mohan Lal Badoli on Tuesday said while PM Modi, Union ministers, chief ministers of the BJPruled states and NDA partners will attend the oath-taking function, opposition leaders of various parties, "progressive farmers", 'Lakhpati Didis' and people from various social organisations have also been invited.

Badoli had also said Valmiki Jayanti falls on October 17, the day when the new government would be sworn-in. In the October 5 Haryana polls, the BJP secured an unprecedented third term in the state, winning 48 seats in the 90-member assembly. The Congress won 37 seats.

With the BJP forming the government for a third time in a row in Haryana, Saini will be taking oath as the chief minister for the second time. Around 50,000 people were expected to attend the mega event, party leaders said. A total of 14 LED screens will

be installed at the event venue



so that people could witness the function. Traffic advisory has also been issued ahead of the swearing-in event. In a departure from tradition, the BJP had declared that Saini would remain chief minister if the party returned to power in Haryana after the assembly polls.

Saini had replaced Manohar Lal Khattar as the chief minister of Haryana in March. Saini, an OBC face of the party, had won the Ladwa seat in Kurukshetra district.

Months before the assembly polls, the BJP replaced Khattar with low-profile Saini, a decision that surprised many, but the BJP's gamble paid off with Saini leading the party to victory in the state elections.

Saini's elevation from the Haryana BJP president to chief minister in March came at a time when the party was facing anti-incumbency following Khattar's tenure of nine-and-ahalf years and attacks from a buoyant opposition on farmers' issues, unemployment, Agnipath scheme, inflation, and law and order.

Days after Saini was brought in by the BJP, the Model Code of Conduct came into effect with the announcement of the Lok Sabha elections, and later ahead of the assembly elections, effectively giving him only two months to shift the public perception.

The Supreme Court Collegium headed by Chief Justice DY Chandrachud has recommended to the Centre the names of three advocates for appointment as judges of the Andhra Pradesh High Court. The three-member Collegium, which also comprised Justices Sanjiv Khanna and B R Gavai, held the meeting on Tuesday and also decided to recommend the names of four senior judicial officers as judges of the Kerala High Court.

The Collegium by way of a separate resolution, recommended to the Centre the name of Justice Siddaiah Rachaiah, an additional judge of the Karnataka High Court, as a permanent Judge of the same high court. "The Collegium resolves to recommend that S/Shri (i) Maheswara Rao Kuncheam @ Kuncham, (ii) Thoota Chandra Dhana Sekar @ T C D Sekhar, and (iii) Challa Gunaranjan, advocates, be appointed as Judges of the High Court of Andhra Pradesh. Their inter se seniority be fixed as per the existing practice," the October 15 resolution said. They all are prac-LUCKNOW tising as lawyers in the Andhra

Pradesh High Court. "The Collegium resolves to recommend that S/Shri (i) K V Jayakumar, (ii) Muralee Krishna S, (iii) Jobin Sebastian, and (iv) P V Balakrishnan, Judicial Officers, be appoint-ed as Judges of the High Court of Kerala," it said. Referring to an earlier recommendation on appointment of judges in the Kerala High Court, the apex court on Tuesday said, By recommendation dated 10 October 2023, the Supreme Court Collegium recommended names of five Judicial Officers, including the name of Shri P Krishna Kumar, for elevation as judges of the high

# **Election time**

The elections in the two states, along with by-elections, will provide a clear snapshot of the public sentiment

t is election time once again. The last round of elections in 2024 would be held in November. The Election Commission has announced that Assembly elections in Maharashtra and Jharkhand will begin on November 13. Jharkhand will go to the polls in two phases, on November 13 and 20, while Maharashtra will hold a single-phase election on November 20. The votes for both states will be counted on November 23. Additionally, dates for several Lok Sabha by-elections, including in Wayanad, Kerala, where a bypoll is needed after Rahul Gandhi vacated the seat, have been announced. The Assembly elections in Maharashtra and Jharkhand are critical for both the ruling and the Opposition parties, as they serve as key battlegrounds to gauge their standing. In Maharashtra, the Bharatiya Janata Party (BJP) faces a formidable challenge from the Maha Vikas Aghadi (MVA) coalition, comprising the Shiv Sena (UBT), the Nationalist Congress Party (NCP) and the Congress.



The MVA aims to capitalise on public dissatisfaction over issues like economic distress and governance failures while projecting a united front despite internal tensions.

In Jharkhand, the contest is equally poised, with the incumbent Jharkhand Mukti Morcha (JMM)-Congress alliance seeking to fend off the BJP's challenge. The ruling coalition is banking on Chief Minister Hemant Soren's popularity and social welfare schemes to retain power. However, the BJP is expected to emphasise issues like law and order and tribal rights to swing the vote in its favour. Apart from the Assembly polls, by-elections will be con-

ducted on November 13 for four Assembly seats in Punjab-Dera Baba Nanak, Chabbewal (SC), Gidderbaha, and Barnala. These bypolls are seen as indicators of the prevailing political sentiment in the regions, potentially setting the tone for broader electoral battles. In addition, the by-election for the Wayanad Lok Sabha seat in Kerala presents another crucial contest. Speculation is rife that Priyanka Gandhi Vadra may make her electoral debut from this constituency, adding a significant dimension to the Congress's campaign strategy. Elections in India are not only a period of heightened activity for political parties but also a monumental task for the Election Commission and government machinery. Conducting elections in the country is no small feat, as ensuring a peaceful, free and fair process presents significant challenge. The upcoming assembly elections in Maharashtra and Jharkhand, along with the bypolls, will serve as critical indicators of India's evolving political dynamics. As the states prepare for high-stakes battles, various political scenarios could unfold, influenced by factors like coalition strategies, regional issues and leadership challenges. But ultimately it would be the unpredictable and elusive voters who would decide the fate of the political parties.



# Haryana setback exposes cracks in INDIA Bloc



he Grand Old Congress Party faces criticism from its INDIA coalition partners for mishandling the recent Haryana Assembly polls, allowing the BJP to win for a third time despite ten years of anti-incumbency. Most exit polls had predicted a clear win for the Congress, but the BJP secured 48 out of 90 seats, a victory even the BJP itself was surprised by. A win in Haryana would have boosted the Congress resurgence story. However, Congress lost this fifth Assembly election recently due to internal conflicts, adding to its previous losses in Punjab, Uttarakhand, Madhya Pradesh and Chhattisgarh. It is uncertain whether the partners will be united in fighting against the BJP. Questions like whether an alliance with AAP would have favoured Congress to win in the Haryana polls are being debat-ed. Secondly, the defeat would impact the upcoming elections in Maharashtra and Jharkhand. The immediate impact of the Haryana result is likely in seat sharing in the forthcoming Assembly elections in Delhi, Maharashtra and Jharkhand. Thirdly, it is uncertain whether the Congress and AAP will have an alliance. The AAP has already said it will go solo. The INDIA bloc performed well in the 2004 Lok Sabha polls due to its adaptability and compro-mise. The main aim of the Coalition was to give a one-toone fight with the BJP and not split the anti-BJP votes. The Coalition put irritable issues on the back burner and managed to work well. They functioned with the sole aim of defeating the BJP and, to a certain extent, succeeded. The BJP majority was reduced, and the government had to be formed with the help of JD (U) and TDP.

The Harvana defeat has altered the situation within the Coalition, with the INDIA bloc getting an edge over the Congress. The partners would probably deal with a slightly more restrained and sobered Congress. No one has said so far that the INDIA bloc is finished. the Congress, the Shiv Sena

On the contrary, Samajwadi Party leader Akhilesh Yadav's statement a day after the defeat indicated that the alliance with Congress would continue. Akhilesh said, "I want to say that the INDIA bloc will be there. The UP and Congress alliance will remain intact..." The Aam Admi Party has said it will go solo in the Delhi Assembly poll, while it allied with the Congress in the Lok Sabha polls three months ago. Congress won no seat. The other allies criticise Congress for its overconfidence and rigid attitude

toward seat sharing. The resurgent Congress, which had doubled its tally in the Lok Sabha polls, weakened after its Haryana shocker. Most exit polls suggested an astounding win for Congress in Haryana because the BJP faced a 10-year anti-incumbency and dealt with a section of disgruntled people. However, the BJP sprung a surprise and registered its most impressive victory in

(Uddhav) and the Nationalist Congress Party in Maharashtra. Congress needs to be more responsive to the seat-sharing formula and Sena's demand for Thackeray to be projected as the CM's face even before the polls. The AAP won no seat in the Haryana election but got roughly 1.78 per cent of the votes.

It would have undoubtedly added to the INDIA bloc's kitty if Congress had allied with AAP. According to Shiv Sena leader Sanjay Raut, the Congress ignored the smaller parties and their offers for collaboration. Leaders from the Trinamool Congress, AAP, Shiv Sena (Uddhav), National Conference, RJD, Nationalist Congress Party, and others were critical of the Congress for messing up the Haryana polls. Shiv Sena mouthpiece Saamna said, "No one thought the BJP government would be elected in Haryana again. It seems Congress's overconfidence and arrogance of local

Lok Sabha polls for seat sharing is crucial, at least in the Maharashtra and Jharkhand polls. The subdued Congress will not have the upper hand in seat sharing with most of its allies. The present mood in the INDIA coalition must impact Congress's relations with its partners.

# Why Indian women deserve support, not judgement

We must start questioning the unrealistic expectations placed on women and inculcate a culture that promotes shared responsibilities and duties

ndian women are increasingly taking on obliga-Lions that exceed 55 hours per week. They manage to pursue their professional careers while also managing a household-what one may refer to as the "second job." It reveals an unsettling fact about the intimidating pressure on women to perform above their capabilities. Although this problem between job and private life affects women all over the world, it is especially difficult for Indian women due to cultural expectations, societal standards and the long-held conviction that they "must do it all?

The question arises: why is there so much pressure on Indian women to push themselves beyond their breaking point? The answer lies in deeply ingrained gender roles and societal expectations. While strides have been made in women's empowerment, the onus of managing the household and caring for children continues to largely fall on their shoulders, even as they excel in their careers. As more women enter the workforce and pursue professional goals, the expectation



to continue fulfilling traditional roles has not diminished. Instead, it has expanded, creating an unsustainable juggling act.

Are women taken for granted? In many ways, yes. The concept that women are born to balance this act manifests itself in the belief that they can easily handle a high-demanding profession while also serving as primary carers, homemakers, and support for the rest of the extended family. However, such an assumption ignores the impact on their physical and mental wellbeing. Each woman's drive is influenced by the societally imposed "superwoman" image, which puts undue pressure on them. And when Should she be judged for

they falter, they are unfairly judged.

But why should society judge women for trying to manage the impossible? The expectations placed on women often come with little recognition or appreciation for the sacrifices they make. Instead, when women struggle or choose to prioritise one aspect of their life over another, they are met with criticism rather than compassion. This is especially true for those who lack a strong support system. If a woman does not have family members willing to share the load of child-rearing or household management, she is left to carry an even heavier burden.

this? Absolutely not. Let us not forget that many Indian women are also teachers, a profession that requires nurturing, patience and a relentless dedication to the betterment of future generations.

These women are shaping young minds in the classroom while simultaneously caring for their own families at home. The least society can do is give them the space and freedom they deserve, without the weight of judgement. It's time we, as a society, recognise that women's worth

is not measured by their ability to "do it all." We must start questioning the unrealistic expectations placed on them and, instead, advocate for a culture that promotes shared responsibilities. Supporting women in their endeavorswhether in their careers or at home-by giving them the freedom to make choices without judgment is essential. 

# Stubble burning crisis needs practical solutions

Without swift and sustained efforts, northern India would face yet another year of deteriorating air quality, leaving millions to grapple with bad air quality



he Supreme Court has taken a strong stance against the Commission for Air Quality Management (CAQM) for its failure to control stubble burning, a major contributor to air pollution in Delhi-NCR. The court's rebuke, delivered during a hearing on October 3, emphasised the need for effective ground-level interventions and questioned why the Commission had not implemented any provisions of the rele-vant Act to curb pollution from crop residue burning. Stubble burning, especially in the northern states of Punjab, Haryana and Uttar Pradesh, has been a major environmental challenge for years. Farmers often resort to burning crop residue after harvesting paddy and wheat due to the increasing mechanisation of farming, the use of combined harvesters, a shortage of labour, and rising labour costs. This practice, prevalent in October and November following the paddy harvest, results in the release of lar amounts of particulate matter into the atmosphere, contributing to the hazardous air quality in Delhi-NCR. The Supreme Court's criticism of the CAQM reflects a broader frustration over the Commission's inability to effectivelv tackle this issue. Despite being set up three years ago to address pollution in the National Capital Region and surrounding areas, the CAQM has been criticised for its slow pace and lack of tangible outcomes. The court particularly highlighted that the Commission meets only once every three months, a frequency deemed inadequate for addressing a recurring crisis like stubble burning. Moreover, the Commission has issued only 82 directives since its inception, a number that the court described as insufficient to deal with the scale of the problem. A significant concern raised by the Supreme Court is the lack of adequate staffing within the pollution control boards of Delhi-NCR and other affected states, including Uttar Pradesh. The

court ordered that these vacant posts be filled by April 30, 2025, to improve monitoring and enforcement capabilities. Effective staffing is critical for implementing measures on the ground, particularly when deal-ing with farmers who rely on burning crop residue as a quick and cost-effective way to clear their fields.

Despite repeated interventions from both the National Green Tribunal (NGT) and the Supreme Court, stubble burning incidents continue to surge. Last year alone, more than 33,000 incidents of stubble burning were recorded in Punjab, even after explicit instructions to engage with farmers to explore alternatives. The lack of a coordinated effort between the state governments and the CAQM has only exacer-MECHANISATION bated the pollution crisis during

material for the CBG process. In this way, stubble has shifted from being a burden to becoming a valuable asset in Uttar Pradesh's rural economy. As of last year, Uttar Pradesh led the country in CBG production, with ten oper-ational plants. Currently, 24 CBG units are active, and another 93 are under construction. The state aims to have more than 100 CBG plants operational soon, a goal endorsed by Union Petroleum and Natural Gas Minister Hardeep Singh Puri. During a March 2024 announcement, he highlighted the state's plan to double its bio-coal and biodiesel production by 2025. The success of CBG production in Uttar Pradesh has been bolstered by the Uttar Pradesh State Bio-Energy Policy 2022, which offers various incentives for establishing bio-

a crucial role in the energy sector. By reducing the practice of stubble burning, the state is making strides in environmental protection. The Yogi Adityanath government has expressed confidence that the enhanced produc-tion of bio-coal and biodiesel will help reduce air pollution in the region over the next five years. The Supreme Court's critique of the CAQM underscores the urgency of finding a balanced approach to stubble burning that respects both environmental concerns and the practical chal-lenges faced by farmers. Uttar Pradesh's model of converting stubble into a resource could serve as a blueprint for other states grappling with similar issues. However, the broader challenge remains: implementing such solutions at scale requires

The key to this transformation has been the establishment of Compressed Biogas (CBG) plants that convert crop residue into energy and high-quality compost. This approach has not only addressed environmental concerns but has also created an additional income stream for farmers, who sell stubble as raw

CNG and CBG units using agricultural waste.

The policy aims to set up CBG plants in every district, providing local solutions for managing stubble while promoting energy self-sufficiency. A significant milestone in this journey was the inauguration of a CBG plant in Dhuriyapar, Gorakhpur, on March 8, 2023, by Union Petroleum Minister Hardeep Singh Puri and Chief Minister Yogi Adityanath. The plant, built for Rs 165 crore, processes 200 metric tonnes of straw, 20 metric tonnes of press mud, and 10 metric tonnes of cattle dung daily. It produces 20 metric tonnes of biogas and 125 metric tonnes of organic manure, contributing to higher agricultural yields while reducing dependency on chemical fertilisers. This initiative allows farmers to diversify their income sources and play

consistent policy support, ade quate resources, and a willingness to engage with farmers directly. The court's directive for the CAQM to improve its approach and for state governments to fill vacant posts by 2025 is a step towards accountability.

Yet, the real test will lie in translating these directives into action before another winter brings the familiar, suffocating haze back to the skies of Delhi-NCR. The question remains whether the CAQM, in partnership with state governments, can adapt and adopt innovative solutions like those seen in UP. Without swift and sustained efforts, the region risks facing another year of deteriorating air quality, leaving millions to grapple with the health consequences of inaction.

# **Israel strikes southern suburbs of Beirut** for the first time in nearly a week

sraeli jets struck the southern súburbs of Beirut early Wednesday for the first time in six days, Lebanese state media reported. The casualty count was not yet clear.

The attack comes just one day after caretaker Prime Minister Najib Mikati said the United States government gave him some assurances of Israel easing its strikes in the Lebanese capital.

Israel says it is striking Hezbollah assets in the suburbs, where the militant group has a strong presence, but it is also a busy residential and commercial area. The Israeli military said the Wednesday strike hit a weapons warehouse under a residential building.

The Israeli military posted an evacuation warning on the X platform saying it is target-ing a building in the Haret Hreik neighborhood. An Associated Press photogra-pher who witnessed the strikes said there were three in the area. The first strike was documented less than an hour after the notice.

Hezbollah began firing rockets into Israel on Oct. 8 in solidarity with the Palestinian militant group Hamas, following their surprise attack on southern Israel. A year of low-level fighting escalated



into all-out war last month, and has displaced some 1.2 million people in Lebanon. Elsewhere, Israeli strikes late Tuesday in the southern town of Qana killed at least 15

people, according to Lebanon's Civil Defense. Nuhad Bustanji, a spokesperson for the first responders, said rescue efforts were still underway and the toll could rise. Videos

shared on social media showed the smoking ruins of a building targeted in the strike with surrounding structures damaged as well. Local media said there were several strikes in the southern

town Tuesday night. Qana was the site of an Israeli artillery strike on a United Nations compound that killed dozens of civilians in 1996.

## Zelenskyy's 'victory plan' includes big hurdle for West **'NATO membership for Ukraine'**

Ukrainian President Volodymyr Zelenskyy said Wednesday his plan to win his country's fight against Russia's invasion could bring peace next year, but it contains a step that some crucial Western allies have so far refused to countenance: inviting Ukraine to join NATO before the war ends.

"If we start moving according to this victory plan now, it may be possible to end the war no later than next year," Zelenskyy told his country's parliament.

He has recently been trying to win approval for the plan from Western partners, who so far have stopped short of publicly voicing their support for it. The first point in Zelenskyy's five-

point plan that was presented in a speech to the Verkhovna Rada, Ukraine's parliament, is perhaps the most ambitious and the most likely to make Western allies balk: letting Ukraine into NATO while the fighting continues.

Zelenskyy said granting Ukraine membership in the alliance would be a "testament of (allies') determination" to support Ukraine. It may, however, be too ambitious a step.

NATO's collective security guar-antee — Article 5 of the military alliance's treaty — is the pillar on which its credibility is based. It is a political commitment by all member countries to come to the aid of any member whose sover-

## At least 100 killed as gasoline tanker **explodes in Nigeria**

More than 100 people have been killed and 50 others injured after a gasoline tanker overturned in Nigeria and sparked an explosion as dozens of people rushed to the vehi-cle to scoop up the fuel, police said Wednesday. The explosion occurred past midnight in Jigawa state's Majiya town after the tanker driver lost control of the vehicle while

town after the tanker driver lost control of the vehicle while travelling on a highway close to a university, police spokesper son Lawan Adam said.

Deadly tanker accidents are common in Nigeria, Africa's most populous country, where traffic regulations are not strictly enforced in many places and there is a lack of alternatives such as an efficient railway system to transport cargo.

It is also common for people to salvage fuel after such acci dents, especially with Nigeria's soaring fuel prices.

Residents who heard about the latest accident rushed to the scene and were scooping up fuel, "sparking a massive inferno that killed 94 people on the spot," Adam said.



# Mexican president acknowledges killings of 3 civilians by military

#### AP MEXICO CITY

Mexico's new president acknowledged Tuesday that three civilians including a child died in two shootouts involving the military last week in a violent border city. President Claudia Sheinbaum

said a soldier was killed in one of the shootouts, as well as two adults and an 8-year-old girl. She said the events on Friday and Saturday are under investigation. But Sheinbaum gave no sign of backing away from the outsized role that she and her predecessor have given to the armed forces. The events in Nuevo Laredo, across the border from Laredo, Texas, started Friday when a nurse, her husband and son found themselves on a road where soldiers were pursuing suspects' vehicles. The husband, Víctor Carrillo Martínez, told local media there was a confrontation and his wife died in the crossfire. Sheinbaum said the soldier was

apparently killed in an exchange behavior by any member of the of gunfire "It had to do with criminals who guard or the army, or any official,

she said. "It is very important to say that Nuevo Laredo is where criminal groups have carried out the most attacks on the army and the National Guard." The city has long been in the grip of the Northeast Cartel, an offshoot of the old Zetas gang. The second incident in Nuevo

Laredo happened Saturday, when the 8-year-old and her grandmother were driving to a store and were caught in the middle of a pursuit by soldiers or National Guard officers.

The grandmother told reporters that a military vehicle was pursuing an SUV and her car got stuck between them and the military opened fire.

The Human Rights Commission of Nuevo Laredo said a young man's tortured body was found nearby in a truck that the army and National Guard had been pursuing. Sheinbaum confirmed the two deaths, saying the shoot-ings had involved the militarized National Guard. "In case there has been any mis-

opened fire on an army vehicle," it will be punished," she said. The Defense Department, which controls the National Guard, said it had no immediate com

ment on the shootings. Last week, the army was involved in another shooting that killed six migrants and wounded 10. In the incident near Tapachula, close to the border with Guatemala. sol diers claimed they heard "detonations" and opened fire on a truck carrying migrants from Egypt, Nepal, Cuba, India, Pakistan and El Salvador.

The dead included an 11-yearold Egyptian girl. The area is often used by migrant smugglers, but warring drug cartels also operate in the region.

Former president Andrés Manuel López Öbrador, who left office Sept. 30, gave the military an unprecedentedly wide role in public life and law enforcement. He created the militarized Guard and used the combined forces as the country's main law enforcement agencies, supplanting olice. But critics say the military is not

trained to do civilian law enforce ment work.

Bodies of 5 Russian climbers who died on Nepal peak have been retrieved AP KATHMANDU

The bodies of five Russian mountaineers who died on the world's seventh-highest peak were retrieved from the mountain on Wednesday and flown to Kathmandu.

The bodies were picked up by rescue helicopters from base camp on Wednesday. They were then transported from the airport in Kathmandu to the morgue at Tribhuvan University Teaching Hospital. The Russians were climbing the 8,167-metre (26,788-foot) high Mount Dhaulagiri during Nepal's autumn climbing season

The climbers were reported missing on Oct. 6 and a rescue helicopter spotted their bodies two days later. Bad weather and the location of the bodies made it difficult for rescuers to retrieve the bodies.

Two of the climbers reached the summit, the while other three had turned around with out reaching the top before teammates at base camp lost radio contact with them.

# Hong Kong cuts liquor tax in effort to reignite its nightlife industry

#### AP HONG KONG

Hong Kong's leader announced a cut to liquor tax Wednesday as the Asian financial hub hopes to revive its reputation as a travel destination with a vibrant nightlife and dining scene.

After fulfilling Beijing's longstanding imperative to enact a homegrown national security law, Chief Executive John Lee now faces challenges with economic competitiveness against regional rivals like Singapore, Japan, and mainland Chinese metropolises.

Changes in residents' lifestyles and a wave of middle-class emigration during the COVID-19 pandomic here 1 19 pandemic have dampened local demand. Many residents now prefer to spend their weekends in mainland China, attracted by its lower prices and a wider variety of entertainment options. Visitors from the mainland are also spending less in the city than before.

Vacant shops are commonly seen in the city's most popular shopping districts, and rev-



enue at the city's bars were down about 28% in the first half of 2024 from the same period in 2019, preliminary official data showed.

In his annual policy address, Lee said the duty rate for liquor with an import price of more than 200 Hong Kong dollars (about \$26) would be slashed from 100% to 10% for the portion above that price starting Wednesday. He hoped the policy would foster the logistics, storage, tourism and high-end dining industries. The government previously told lawmakers that after wine duties were abolished in 2008. imports jumped 80% in a year and the city welcomed hundreds of new wine-related businesses.

Lee, a former security chief handpicked by Beijing to lead Hong Kong, pushed through the new security law in March. Critics fear the law will further curtail the civil liberties promised to the former British colony when it returned to Chinese rule in 1997.

That law follows similar nation-al legislation Beijing imposed al legislation beijing imposed in 2020 to quell huge anti-gov-ernment protests. Since that law took effect, many of the city's leading activists have been prosecuted, forced into self-exile or silenced. The Hong Kong government said the security laws are necessary for

the city's stability. But in the wake of these dramatic political changes, many middle-class families and young professionals have emigrated to Britain, Canada, Taiwan and the United States.

To attract more wealthy migrants, Lee also revised a scheme that awards residency to applicants who invest a minimum of 30 million Hong Kong dollars (\$3.9 million) in certain types of assets. Starting Wednesday, purchases of homes valued at 50 million Hong Kong dollars (\$6.4 million) or more can be counted for up to a third of the requirement, he said.



# **Indian-origin candidates in race** for Oxford University Chancellor

The University of Oxford on Wednesday announced the 38 finalists in the race to be elected the new Chancellor of the University of Oxford, which includes Indian-origin candidates but excludes former Pakistani prime minister Imran Khan.

Ankur Shiv Bhandari, the first Indian-origin Mayor of Bracknell Forest in Berkshire; Nirpal Singh Paul Bhangal, a Professor of International Entrepreneurship; and Pratik Tarvadi, a medical profes-sional, will go head-to-head with academics, politicians, philanthropists and entrepre-

neurs. Former Conservative Party leader Lord William Hague and former Labour politician Lord Peter Mandelson are among the senior politicians selected, with Khan deemed to have been disqualified following the selection process.

Earlier on Wednesday, Washington, Seoul and Tokyo announced plans with eight Western governments to launch a new multinational team to monitor the enforcement of sanctions against North Korea. Russia in March vetoed a UN res-

North Korea has also been making increasingly provocative threats against rival South Korea, including accusing the South of infiltrating drones to drop anti-North Korean propaganda leaflets over Pyongyang and threatening to attack the South if it happens again.

North Korea also on Tuesday blew up the northern sections of unused road and rail routes that once linked it with South Korea in a choreographed demolition aimed at demonstrating its growing anger with South Koreas conservative government.

from the Telecom Department and we have initiated consultation process in response to reference that has been received from DoT and it covers issue that have been referred to TRAI by the DoT... The consultation process is on, we will consider all inputs and views that are received during consultation process and we will come out

with considered our recommendations," TRAI Chairman Anil Kumar Lahoti told reporters on the sidelines of IMC.

Asked about the demand by Reliance Jio that the TRAI consultation paper be revised to ensure a level playing field between terrestrial and satellite players, TRAI satellite players, TRAI chairman said, "different stakeholders raise different demands on the consultation process, and we consider all these viewpoints and inputs and take a considered view.

World's richest man Elon Musk has taken on Indian billionaires Mukesh Ambani and Sunil Bharti Mittal over the allocation of spectrum used in wireless communication using satellites, calling their demand for the auction of

such airwaves "unprecedented". While Ambani's Reliance Jio has been vocal about the need

to allocate such spectrum through an auction to give a fastest-growing level-playing field to legacy operators who buy airwaves and set up infrastructure like telecom towers, Mittal on Tuesday articulated the need for satellite companies harboring any urban



ambitions to buy spectrum as not auctioned.

Pointing out that satellite spectrum is shared airwaves, Scindia said, "If the spectrum is shared then how can you price it individually". Musk first termed the

## India reiterates opposition to China's Belt and Road Initiative

#### PTI ISLAMABAD

India on Wednesday once again refused to endorse China's ambitious 'One Belt China's ambitious 'One Belt One Road' initiative, becoming the only country in the Shanghai Cooperation Organisation (SCO) not to support the controversial connectivity project.

joint A joint communique unveiled at the end of the SCO's Council of Heads of Government conclave hosted by Islamabad said Russia, Belarus, Iran, Kazakhstan, Kyrgyzstan, Pakistan, Tajikistan and Uzbekistan reaffirmed their support for the Chinese connectivity initiative.

It said the countries noted ongoing work on the implementation of the project, including efforts to link the Eurasian Economic Union with the One Road One Initiative (OBOR). India has been refusing to endorse OBOR in previous

SCO conclaves as well. India has been severely critical of the OBOR, previously known as the Belt and Road Initiative (BRI), as the project includes the socalled China-Pakistan Economic Corridor (CPEC) that passes through Pakistanoccupied Kashmir.

There has been growing global criticism against the OBOR as a number of countries are reeling under the burden of debt while implementing projects relating to the initiative.



In his address at the SCO conclave, External Affairs Minister S Jaishankar said, "debt is a serious concern" but did not elaborate further. "Collaborative connectivity can create new efficiencies,

he said. The joint communique said the heads of delegations noted the proposal to create a Eurasian 'Greater Partnership' with the participation of the SCO, Eurasian Economic Union, Association of Southeast Asian Nations as well as other states interested and multilateral associations.

"The heads of delegations, reaffirming their desire to ensure stable economic and social development in the SCO region, noted the importance of implementing SCO the Economic Development Strategy for the period up to 2030 and the programme of multilateral trade and economic

cooperation of the SCO member states," it said. "They stressed the need for coordinated efforts through

the mechanisms of relevant cooperation in order to implement the respective action plans," it added. The SCO conclave was chaired by Pakistan Prime



# Thomas Tuchel hired as England head coach ahead of 2026 World Cup

wait for a trophy. The German, who previously managed Paris Saint-Germain, Chelsea and Bayern Munich, will begin his tenure in January ahead of the 2026 World Cup in the United States

English Football The Association said Tuchel had been identified as the "preferred candidate" after what it described as an

extensive search to replace Gareth Southgate, who stepped down after the European Championship in

July. Tuchel won major trophies in Germany, France and England and is England's third foreign coach, after the late Sven-Goran Eriksson and Fabio Capello. He succeeds one of England's most successful coaches in Southgate, who led the country to back-to-back European Championship finals and a World Cup

semifinals. Southgate stepped down after eight years following defeat to Spain in the final of Euro 2024.



The FA said it had interviewed several candidates before deciding on Tuchel. Tuchel won European club soccer's biggest prize when leading Chelsea to the

Champions League title in 2021. He has won league titles with PSG in France and Bayern in Germany. He takes on the England job after leaving Bayern at the end

of last season. The 51-year-old Tuchel fits the FA's remit of hiring a coach who has delivered at the highest level and also knows the English game following his time with Chelsea. The FA said in July that it Premier League club.

wanted someone with "significant experience of English football, with a strong track record delivering results in the Premier League and/or international leading competitions.

It also said the new coach would develop the team to 'win a major tournament and be consistently ranked as one of the top teams in the world." As manager of Chelsea, Tuchel beat Pep Guardiola's Manchester City to win the Guardiola's Champions League within months of taking the job. He also won the UEFA Super Cup and Club World Cup with the

#### this year stronger petition India can lift SAFF trophy: Ashalata

The quality of football has improved immensely in the region but the Indian team is equipped to win the SAFF Women's Championship, senior defender Ashalata Devi said on Wednesday as the side gears up to take on arch-rivals Pakistan in its tournament-opener.

The clash against Pakistan on Thursday assumes significance since Ashalata will become India's first woman footballer to play 100 international matches when she takes field on Thursday at the iconic Dasarath Stadium. Ashalata said the first game always sets the tone, and a strong start will help them play freely in the following matches. The last time the two teams clashed, India had emerged a 3-0 winner.

"It's always exciting to face a team like Pakistan. We have a lot of respect for them. They have grown as a unit. Last time, we won against them, but we are not taking them lightly. They are motivated, prepared well and will surely put up a good fight," said Ashalata.

India head coach Santosh Kashyap is expecting a close contest. "I have watched Pakistan's recent matches, including the one against Singapore, where they put up a tough fight and narrowly lost 1-0. They have strong physicality and play good football. "All the teams are very close in terms of quality, and they fight hard. Whether it's the men's or women's teams, we can't afford to think we are the favourites and will win easily. When asked about Ashalata

Devi's milestone, coach Kashyap said, "It's a great achievement for her as well as for women's football. I always tell young players to look up to her and how she has maintained herself for such a long time."

Pakistan, who have players like Maria Khan and Nadia Khan in the ranks, will not be pushovers. Skipper Maria is an experi-enced midfielder, who plies her trade for Saudi Arabian pro side Eastern Flames. Two other Pakistan players, goalkeeper Rumaysa Khan and striker Isra Khan, play in Canada and the United States, respectively.

"I think it will be an interesting match, India have prepared well. They have a new coach as well, so they have new strategies, we don't know what to expect. It's a good rivalry," Pakistan head coach Adeel Rizki said.

# Messi scores hat-trick as Argentina wins in South American World Cup qualifying

hat trick and two assists: Lionel AMessi came back in style for Argentina in its 6-0 home win in a South American World Cup qualifying match.

Messi, who missed two rounds of the competition in October due to a right ankle injury, played from start to finish on Tuesday in front of raucous fans at the Monumental de Nuñez Stadium, who chanted his name after he opened the scoring in the 19th minute.

Its archrival Brazil, whose coach Dorival Júnior was under pressure earlier this month, got some relief with a convincing performance in a 4-0 home win against Peru.

Argentina remained as leaders of the round-robin competition with 22 points after 10 matches, three points clear of second-place Colombia, who earlier beat Chile 4-0. Uruguay, which earlier had a goalless draw with Ecuador, and Brazil come next with 16 points.

The Uruguayans are in third position on goal difference. Ecuador and Paraguay follow, with

13 points each, but the Ecuadorians have one more win to take the fifth position.

The top six teams in the region will secure automatic berths in the next World Cup. The seventh-place team, currently Bolivia, will play in an international playoff for a spot in the tournament in 2026.

Two more rounds of South American World Cup qualifying will be played in November.

## Neetu David becomes second Indian woman to be inducted into ICC Hall of Fame

 $F^{ormer\ India\ spinner\ Neetu\ David,\ who}_{still\ holds\ the\ record\ for\ the\ best\ figures}$ (8/53) by a woman in an individual Test innings, on Wednesday became only the second female cricketer from the country to be inducted into the ICC Hall of Fame. David, the current chairman of selectors for Indian women's team, enters the ICC Hall of Fame a year after the induction of former captain Diana Edulji.

David made more than 100 appearances (10 Tests and 97 ODIs) for India as a prolific left-arm spinner and was inducted alongside South Africa and England legends AB de Villiers and Alastair Cook,

joining a long list of great cricketers. The 47-year-old David is the secondhighest wicket-taker for India in ODIs cricket with 141 scalps and was also the first female player from the country to claim 100 wickets in the 50-over game.

Topping the wicket-taking list at the World Cup in 2005, to inspire her country to their first-ever final, is also among her standout achievements.

David said in an ICC release: "It is truly an honour to be inducted into the ICC Hall of Fame, something that I consider to be the highest recognition available to anyone who puts on their national team jersey.

'This comes after a lifetime of dedication to this great sport, and it caps a very special journey for me to get to this point. "To be considered a Hall of Famer alongside the greatest players that ever

In late 1995, David truly rose to prominence as she recorded sensational figures of 8/53 — still the best individual bowling spell in a single innings of a women's Test — against England in Jamshedpur as India fell to a narrow tworun loss.

While David excelled at Test cricket with 41 wickets from 10 matches, it was in ODI cricket that she performed best with 141 scalps from 97 matches at a miserly bowling average of 16.34.

David retired from international cricket in 2006, only to reverse that decision two later for a brief return in ODI cricket vears

in international cricket, making his most significant impact in the longest format. He retired from international cricket in 2018 as England's highest Test run-scorer and century-maker, spearheading notable successes both home and away with the bat and as captain.

In his 14-year-long career, de Villiers hit over 20,000 international runs across all three formats.

De Villiers, fondly known as "Mr 360", excelled in Test and T20I cricke while setting South African records for the fastest fifty, century and 150 in ODI cricket to earn a reputation of being one of the most feared, destructive batters in the history of the game.

After all, he is going through a roseate phase in Test cricket for over a vear now.

But that deep caring for his craft and a focused mind will come handy when Jaiswal crosses over to Australia next month for the biggest challenge yet in his fledgling career, feels his childhood

coach Jwala Singh. "At this level, it is more about how you handle pressure. You can always work on technique, but if you don't have the right attitude and mindset then you will end up as a failure. But fortunately, Yashasvi has a mature head on his shoulder," Jwala told PTI when he was informed about skipper Rohit Sharma's high evaluation of his

younger colleague. "It is even more true when you go and play in Australia because they play some hard cricket there and put a lot of pressure on opposition," he added added.

As someone who saw Jaiswal from a very young age, Jwala feels that the 21-year-old has grown as a batsman since making his debut in 2023 against the West Indies.

"I think being around players like Rohit and Virat has helped him a lot. After all, there is nothing like learning from such masters," he said.

Since his baptism in international cricket, Jaiswal has made 1217 runs from 11 Tests at an average of 64.05 and has three daddy knocks - 171, 209 and 214.

So, what are the changes that he has observed in the lefthander in the last one year or so?

"He always has been aggressive as a batsman. Earlier, he had a tendency to attack almost every ball, especially fast bowlers, but now he uses aggression more judiciously. "Yashasvi now has more awareness of his game. He has But once the pacer erred in length, Jaiswal creamed the Lancastrian's next three balls for sixes — a sweep over square leg, a loft over mid-wicket and straight mousse over the bowler's head.

Jaiswal was highly effective against Anderson throughout the series — extracting 98 runs from 150 balls that he faced off the quick and getting out twice. It was not entirely surprising then that he became only the second Indian batter after the legendary Sunil Gavaskar to score over 700 in a series.

But then it is always easy to play down that wonderful run citing home advantage, as Australia offers a vastly different challenge. What are the challenges a sub-continent batter will face

Down Under?

"First thing first, what India did in Australia during their last two visits here has been fantastic. Not many teams have managed that (winning backto-back series). So, the Aussies will go hard at Indians to overturn it.

"I am sure they are going to pepper them with some short stuff and I guess the pitches too could offer some more spice.

"In that sense, I think the batters coming here should be well-prepared to play a few more cuts and pulls," former England pacer Alan Mullaly, who is now settled in Perth, told PTI.

India skipper Rohit Sharma had little doubt about the skill level and adaptability of Jaiswal.

"He has got the game to play in all sorts of conditions. You can bet on him and expect him to do wonders for the team. We've found a great player.

'Now, it is just about how he manages himself in the next couple of years," said Rohit.
