

ARMY IS THE BOSS TERRORISTS ELIMINAT

ll three dreaded foreign terrorists, who were **T**holed up inside a religious place since Monday morning, were eliminated by the joint team of security forces in the Batal area of Akhnoor in the 27-hour-long anti-terrorist operation without suffering any major collateral damage

A group of heavily armed terrorists, dressed in combat fatigue, were spotted by the local villagers in the Batal area early Monday morning after three school-going children came in contact with them in the close vicinity of a religious place. The terrorists, it is believed, were tasked to target an army convoy in the area to disturb peace.

One of the three terrorists who fired at an army ambulance was eliminated by the security forces on Monday afternoon. However, special forces were inducted to flush out the terrorists holed up inside the religious place.

The Indian army had also deployed BMP-II, infantry combat vehicles to ferry troops to the nearest location before launching a final assault on the terrorists holed up inside the religious place.

Disengagement almost complete

Having agreed to disengage from the friction points in Demchok and Depsang at the Line of Actual Control (LAC) in Eastern Ladakh last week, India and China have nearly completed the process. The two sides will now verify the situation and commence patrolling in their respective zones.

Troop disengagement at two friction points at Demchok and Depsang Plains in eastern Ladakh following a key agreement firmed up between India and China is in the "final stages," official sources said on Tuesday. On October 25, sources had said the process was likely to be completed by October 28-29.

The agreement framework was "signed" first at the diplomatic level and then military-level talks took place, the Army sources had said, adding the nitty-gritty of the agreement was worked into the Corps Commander-level talks, which was signed last week.

Adhering to agreements between the two sides, Indian troops then began to pull back equipment to rear locations in these areas. The disengagement at the two friction points is in its "final stages", an official source said on Tuesday.

Sources last week said the agreement was arrived at only for these two friction points, and "talks were still underway" for other areas.

m ore\ than\ 100\ flights}$ operated by various Indian airlines received bomb threats on Tuesday. In 16 days, over 510 domestic and international flights have received threats that later turned out to be hoaxes. The threats were issued mostly through social media. Meanwhile, the Nagpur police arrested a 35-year-old man from Maharashtra's Gondia, who was allegedly behind the spate of hoax bomb threats that triggered panic, caused flight delays, and led to increased security at airports and other establishments. Air India received threats for around 36

flights and IndiGo for about 35 flights. Vistara received the threats for 32 flights. "A number of Air India flights were subject to security threats received on social media on 29 October 2024. "Following the laid down protocols, relevant authorities were immediately alerted, and all security procedures strictly adhered to, as per guidance from the regulatory authorities," an airline spokesperson said in a statement. As many as 14 FIRs in October in connection with the bomb threats to airlines.

In a related development, designated terrorist Gurpatwant Singh Pannun

has also issued a threat specifically named several Air India flights in his recent video message, focusing on routes between New Delhi and Toronto (AI 187, AI 189), Vancouver (AI 185), London (AI 111, AI 161), Frankfurt (AI 121), Sydney (AI 302), and Melbourne (AI 308). Additional threats target Mumbai-London routes (AI 129, AI 131). Meanwhile, the Nagpur police Special Branch has identified him as Jagdish

Uikey, an author of a book on

terrorism, who had been arrested in 2021 in a separate case. Uikey was identified after the hoax emails were traced back to him. So far three persons have been arrested in the hoax bomb threats probe. One was arrested from Indira Gandhi International Airport, and the second arrest was made from Chhattisgarh. The investigation, led by Deputy Commissioner of Police (DCP) Shweta Khedkar uncovered detailed information linking Uikey to the emails. According to Nagpur police,

Uikey sent emails to various government bodies, including the Prime Minister's Office (PMO), Railway Minister, Maharashtra Chief Minister Eknath Shinde and his deputy, airline offices, the Director General of Police (DGP) and the Railway Protection Force (RPF).

On Monday, the Nagpur police stepped up security outside Deputy Chief Minister and Home Minister Devendra Fadnavis's residence in the city after Uikey sent an email threatening to protest unless given a chance to present his information on the secret terror code he claimed to have deciphered. He also requested a meeting with Prime Minister Narendra Modi to discuss his knowledge of terror threats, he added. Uikey's email sent on October 21 to Railway Minister Ashwini Vaishnaw, and also forwarded to the DGP and RPF, led to security measures at railway stations, the official said

Noida man arrested for death Ghaziabad court turns battlefield as lawyers, judge clash threats to Salman, Zeeshan

Mumbai police has arrested a 20-year-old man from Noida in Uttar Pradesh on Tuesday for allegedly giving extortion and death threats to Bollywood super star Salman Khan and MLA Zeeshan Siddique, the Nationalist Congress Party (NCP-AJit Pawar) date and late Raha Ziauddin Siddique's son.

Identifying the arrested accused as one Mohammed Tayab, alias Gufran Khan, the police said that he was being brought from Noida to Mumbai on a transit remand. Acting on a complaint registered by Ziauddin Siddique's office, on Monday, Mumbai's Nehru Nagar police traced Mohammed Tayab to Noida using tech-intel and rushed its team to New Delhi's satellite city. The visiting police team wanted the accused on Tuesday and produced him before a court and sought a transit remand. The police said that Mohammed Tayab, alias Gufran Khan, had on Friday last sent a threat message to Siddique's mobile phone used by the latter for receiving

NCB busts a 'Breaking Bad' plot, Tihar Jail warden among the arrested

The Narcotics Control Bureau **▲** (NCB), in coordination with the Delhi police Special Cell, has busted a methamphetamine manufacturing unit, linked to members of the Mexican drug cartel - Cartel De Jalisco Nueva Generación, in Uttar Pradesh's Gautam Budh Nagar, arrested five persons, and seized about 95 kg of the drugs. Shockingly, the laboratory was allegedly set up by a Delhi-based




businessman along with a Tihar Jail warden, and a Mexican cartel member was also part of the syndicate.

Pentral Delhi is the worst affected by the perennial problem of 'VIP movement' where busy main roads are frequently restricted for the general public to allow various events, politicians and dignitaries to move in a secure manner. Markets in Doon buzz with activity on Dhanteras

The markets in Dehradun were bustling with people as many I thronged to buy utensils and gold apart from other things on the occasion of Dhanteras on Tuesday. The residents of the city celebrated Dhanteras with religious fervour and enthusiasm Major markets in the city including Paltan Bazaar, Raja Road Jhanda Bazaar and others experienced a significant increase in footfall, especially at the utensils and jewellery shops. According to priest Jagmohan Krishna, it is considered auspicious to buy gold, utensils and brooms on Dhanteras as they are believed to attract blessings, peace and prosperity to the household. It is common for individuals to visit the market on this day to purchase these items in hopes of a blessed and peaceful year ahead Additionally, many people also perform Pooja of their jewellery at home on this day. In view of this, the market has seen a surge in activity with many people out and about. A jewellery store owner Charanjeet Singh noted that the price of gold has increased this year compared to last year. As a result, there has been a slight shift in shopping habits on Dhanteras. While there has been a large turnout at his shop on Tuesday, customers seemed to be opting for lighter weight gold jewellery due to the price hike. They still adhere to the tradition of purchasing auspicious items on this occasion, but are making adjustments to accommodate the higher prices, he said. A similar trend has been observed at other jewellery stores across the Dehradun district. In addition to this, individuals were also seen purchasing kitchenware. Local resident Piyush Rawat added that in accordance with his family's annual tradition, he visited the market to buy kitchen utensils on the occasion of Dhanteras as it is considered auspicious. Further, he stated that not only kitchen utensils, but buying anything on Dhanteras is considered auspicious as well. With this in mind, he had planned to purchase several other items for his home. Aside from the kitchenware and jewellery stores, numerous individuals were noticed in the city market shopping for Deepawali.

Gangotri MLA calls for probe into Uttarkashi incident

Gangotri MLA Suresh Singh Chauhan has said that the lathicharge on protesting members of Hindu organisations in Uttarkashi on Thursday and the mosque against which they were protesting should be inquired into. Condemning the violence which took place during the protest, he said that he had directed that the stone pelting on the protesters should also be investigated. Addressing the media here on Tuesday, Chauhan said that Uttarkashi is a very important city in Sanatan Dharm with the Ganga river also originating in this region. Expressing concern at "outsiders" encroaching here, he questioned who is supporting encroachments by such persons, adding that this also needs to be checked. He assured the people of the district that legal action will be taken soon against those who had indulged in stone pelting on the protesters. The MLA said that illegal activities in the name of religion will not be allowed in Uttarkashi, adding that he had talked to the superintendent of police and asked that the severe sections under which the protesting members of the Hindu bodies were booked, should be removed.

Social activist Dinesh Panwar claimed the police had carried out the lathi-charge after a water bottle was tossed, adding that action should be taken against the officials responsible. He demanded that the strict sections under which the protesters were booked should be removed. Roadside vendors, kiosks made on the Ramleela ground and other encroachments on public land should be cleared. Failing this, the public will be called on to protest against such activities, he said.

In the programme the PM inaugurated and laid the foundation stone of various health sector projects worth Rs 12,850 crore. The chief minister of Uttarakhand Pushkar Singh Dhami attended the programme virtually from AIIMS Rishikesh. Speaking on the occasion the CM said that with the start of heli ambulance service in AIIMS Rishikesh, the health services of the State will become strong and modern. The service will work as a lifesaver for the people in times of crisis. The CM expressed his

Health minister JP Nadda and civil aviation minister Ram Mohan Naidu for providing heli ambulance and drone facilities to Uttarakhand. The CM said that Uttarakhand had been waiting for this service for a long time and it is a matter of great pride that the country's first government heli ambulance is starting from AIIMS Rishikesh. He said that the service will function on the lines of 108 -ambulance service through which patients can be brought to AIIMS Rishikesh from every corner of the state free of cost. Dhami said Uttarakhand is a State with difficult geographical conditions and many times difficulties are faced in taking the patient to a major hospital. In such a situation, a heli ambulance equipped with all life-saving facilities will work as a lifesaver gratitude to PM Modi, Union for patients of remote and

mountainous areas. He said the toll-free number of the service will soon be issued and it will be linked to the district disaster management office of all 13 districts. Dhami added that the use of drones will also help in bringing blood samples and delivering medicines in remote areas. He said that the state government is working towards opening a medical college in every district of the State. Work is also progressing rapidly on the satellite center of AIIMS Rishikesh in Kichha. The State government is currently providing the facility of 207 types of free pathology tests. Former CM and Haridwar MP Trivendra Singh Rawat, Finance minister Premchand Agarwal, Health minister Dhan Singh Rawat AIIMS Director Dr Meenu Singh and others attended the programme.

U'khand Govt hikes DA, gives bonus to its employees ahead of Deepawali

PNS DEHRADUN

Tn a Deepawali gift for thousands of State government employ Lees, the Uttarakhand government released Deepawali bonus and ordered a three per cent hike in the Dearness Allowance (DA) of its employees on Tuesday. The orders will benefit more than two lakh government employees and pensioners in the State. The DA allowance of the employees has been increased from the present 50 per cent to 53 per cent of their basic salary. The increased DA will be applicable from July 1, 2024 and the employees will get revised DA from July 1 to September 31, 2024 as arrear while the increased DA will be given regularly from October 1, 2024. It means that the employees will get three months of revised DA as arrear in this month's salary. In another gift to the employees, the State government announced Deepawali bonus to the non-gazetted employees up-to the grade pay of Rs 4,200. The bonus would be interim not linked to the productivity and would be of 30 days not exceeding Rs 6,907.89. The casual/ daily wage earners work ing in different departments for a period of minimum three years would also get a bonus of Rs 1,184. The order of increase of three per cent would be applicable to all employees of the State government, aided teaching institutes, workers of the local bodies and the recipients of the University Grants Commission (UGC) scales. However the order will not be applicable to the judges of High Court, chairman and members of Uttarakhand Public Service Commission (UkPSC) and Public Undertaking Corporations in respect of whom separate orders will have to be issued by respective departments. The increase in the DA would put an additional burden of about Rs 600 crore on the State exchequer. The salaries of the employees would witness an increase of Rs 1,000 to Rs 9,000

after the increase in DA. After the recent increase in the DA of the Central government employees, the State government employees were waiting anxiously for the DA hike by the Uttarakhand government.

Kedarnath bypoll: U'khand Cong accuses governor, BJP leaders of violating MCC

The Pradesh Congress taken by the government in the meeting which is a viodent Karan Mahara has accused the governor lieutenant general (retd) Gurmit Singh, Bharatiya Janata Party State president Mahendra Bhatt and BJP State in-charge Dushyant Kumar Gautam of violating the model code of conduct imposed in Rudraprayag district due to the Kedarnath Assembly by-election. A delegation of Uttarakhand Congress led by the vice president Mathura Dutt Joshi submitted a memorandum of PCC president to the chief electoral officer (CEO) Uttarakhand Purushottam on Tuesday.

The PCC president objected to the Badrinath and Kedarnath Yatra of the governor on October 28 during which he interacted with the Teerth Purohits and officers of administration after paying obeisance at Kedarnath. He said that the governor appreciated the development works being underthe meeting which is a vio-lation of the MCC. BJP leaders' presence at **Kedarnath temple is not** MCC violation: Chauhan

The Bharatiya Janata Party State media in-charge Manveer Singh Chauhan has dismissed Congress' allegations against BJP leaders regarding the violation of the model code of conduct (MCC) in Kedarnath. He said that Congress leaders are becoming increasingly anxious over the presence of BJP leaders in Kedarnath, indicating that they are fearful of the BJP's influence.

He said that, while the MCC is in place for the Kedarnath Assembly by-election, the Kedarnath temple is open to all devotees. He questioned Congress' issue with BJP leaders visiting the temple and speaking with others there, emphasising that anyone can engage in conversation at a public religious site. "Thousands of devotees from across the country are visiting Kedarnath, so Congress' claim that BJP leaders were promoting the government's achievements at the temple is laughable. Even the idea of consultation with the temple priests seems absurd as there is no requirement for Congress' permission to visit a temple or any other religious

Chauhan also stated that interacting with priests at the temple is a common courtesy, not a political maneuver. He expressed disbelief at Congress' agitation over such routine interactions, attributing it to Congress' lack of confidence ahead of the upcoming election. "On the one hand, Congress is making grand claims about the Kedarnath by-election and on the other, it is rattled by the mere presence of BJP leaders at the temple. This clearly reveals their desperation before the election," Chauhan said. He said that the BJP is unaffected by Congress' actions or its presence in Kedarnath, as the BJP relies on its strong organisational base and the support of the people in the Kedarnath. The locals there are content with the development work undertaken by the BJP and hold resentment against Congress for the past neglect of the Kedarnath valley during its rule. Chauhan advised Congress to be wary of internal rivalries within its own ranks rather than focusing on the BJP. He asserted that Congress leaders and candidates appear to be as eager to challenge their own leader-





The police have arrested eight members of the banned United National Liberation Front of Manipur (Pambei) for allegedly threatening residents and obstructprocess in Thoubal district, police said in a statement on

Police recovered a substantial cache of arms and ammunition from the suspects, including five AK-47 assault rifles, one M-16 rifle, and a 9mm pistol, the statement said.

The arrest highlighted growing concerns among security agencies regarding escalating violence linked to the UNLF(P), despite the group having signed a ceasefire agreement with the Union government last November. The UNLF(P), led by Kh Pambei, became the first Meitei armed group in the Imphal Valley to enter into a ceasefire agreement with the government on November 29,

This agreement was aimed at renouncing violence, yet officials have criticised the group for failing to provide a list of its cadres who were expected to surrender their weapons. The arrested individuals have been identified as Laishram Atangba Meitei

Irregularities in conduct of exam for Gujarat HC: Delhi HC asks NTA to file detailed affidavit

The Delhi High Court has directed the National Testing Agency (NTA) to file a detailed affidavit on a plea alleging gross irregularities in the tender process for the conduct of an examination for recruitment of various posts in the Guiarat high court

the Gujarat high court.
The petitioners SKS Visions and its proprietor Sonu Goel, represented by senior advocate Pinaki Misra and assisted by advocates Anurag Chandra, Raj Kamal and Rohit Raman among others challenged the NTA in the recent tendering process for the recruitment in the Gujarat high court.

In the writ petition, it was alleged that there were substantial procedural irregularities in the tender dated October 15 2024 issued for "Hiring of experienced agencies firms" to provide ancillary security services on turnkey basis during Offline examination conducted by the NTA in

Gujarat on pilot basis". The petitioner alleged that the tender was issued with minimal notice, providing inadequate time for bid submissions, and that it favoured a predetermined bidder "Sai Educare Pvt Ltd", compromising transparency and accountability in public procurement.

Noting the gravity of the allegations, the Delhi high court directed the NTA to submit a detailed affidavit justifying its



The petition claimed specific violations by the NTA, including deviation from Central Vigilance Commission guidelines in which the NTA reportedly accepted offline bids in place of the standard online bidding mechanism, thereby undermining transparency.

The NTA also lacked adherence to General Financial Rules (GFR) as it allegedly circumvented essential protocols, such as employing a singlepacket bid system rather than the mandatory two-packet system for complex tenders, thereby bypassing compre-hensive technical evaluation, the plea alleged.

The petition claimed the NTA allegedly caused a loss of over Rs 75 lakh to the public exchequer. The testing agency is also allegedly accused of not conducting a pre-bid conference despite the technical complexities, a key procedural lapse that purportedly affected the tender's integrity, it

The petitioner sought a directive from the court to set aside the tender allocation, citing a violation of Article 14 of the Constitution, which mandates fairness and transparency by the state or its instrumentali-

During the hearing, the NTA counsel admitted that it was the testing agency's decision to release the short tender on October 15. The petitioner, however, stated that relying on NTA Public Notice dated September 27, NTA itself published that the notification by Gujarat High Court to conduct exam was notified in the month of May, which is five months before the October 15 public notice.

Notwithstanding the importance of the examination to be conducted, NTA deliberately chose not to publish the tender in time and chose to publish it online in October giving a 24hour window to submit the bid offline, which can easily be manipulated and lacks transparency, the petitioner alleged. The plea also highlighted that the NTA did not publish the tender online or through mandatory GeM portal just to avoid transparency and accountability in order to

allegedly favour the bidder "Sai Educare Pvt Ltd". After the hearing, the Delhi high court directed the NTA to file a comprehensive affidavit detailing their stand and addressing the allegations.

Delhi water woes

Political blame game erupts as toxic ammonia levels in Yamuna spark crisis and residents are supplied with unpotable water

s images of a frothy Yamuna flooded the media, Delhiites were shocked and alarmed. Pollution levels in the river have soared beyond what anyone could have imag-Ained. This has disrupted the Delhi water supply and Delhiites are forced to consume polluted water. Delhi is in the grips of a severe water crisis as elevated ammonia levels in the Yamuna River disrupt water supply across the capital. With water treatment plants at Sonia Vihar and Bhagirathi struggling to manage the contamination, residents face widespread shortages. The AAP and BJP have engaged in a heated blame game, with the AAP accusing the BJP-led Haryana government of neglecting pollution controls upstream, while the BJP criticizes Delhi's administration for failing to bolster treatment facilities. As political tensions rise, Delhiites are left hoping for swift, actionable solutions to restore their water supply. The ammonia levels in the Yamuna have surged to nearly 0.9 parts per million (ppm), far exceeding the safe limit of 0.5 ppm

required for effective treatment. This spike is severely affecting the functionality of the Sonia Vihar and Bhagirathi water treatment plants (WTPs), which play a pivotal role in providing clean water to the city. When the Upper Ganga Canal—Delhi's primary source of clean water—is closed for annual maintenance, as it was from October 12 to 31, the city becomes increasingly reliant on the Yamuna, compounding the water scarcity problem. Amid mounting public dissatisfaction, the political sparring has escalated. The AAP has blamed the BJP-led Haryana govern-

ment, accusing it of being 'hostile' towards Delhi's

interests by failing to curb the industrial waste entering the Yamuna. AAP officials claim that Haryana's callous attitude has left Delhi residents without a reliable water supply, with no proactive steps being taken to control the pollutants entering the river. On the other hand, the BJP's Delhi unit responded by holding AAP accountable for the water crisis, criticising the Kejriwal administration for what they call "mismanagement." They say that the AAP government has failed in two major areas: maintaining operational sewage treatment plants and equipping existing WTPs, such as those at Sonia Vihar and Dwarka, with the capacity to handle ammonia contamination. Indeed it is a classic case of passing the buck and Delhi has had enough of it. Rather than blaming each other both Delhi and Haryana government would do well to mitigate this disaster. The Yamuna water is coming from Haryana so no two opinions about where the source of contamination is but AAP should have managed the situaiton well as it new well in advance that Uppar Ganga Canal would be closed for the maintenance till October 31. Right now water remains the biggest concern for Delhi. Yamuna is no better than a drain. Apart from being visually appalling it is a health

A mirage of progress on the LAC

The path to restoring the status quo appears fraught, with divergent interpretations between the two countries clouding any clear progress

he 21st October Agreement to disengage from Demchok and Depsang and resume patrolling as in April 2020, is being hailed as a breakthrough. It's not quite that: now Indian soldiers have to inform the Chinese of the timetable for patrolling and grazing. The government has called this disengagement as a pathway to return to conditions on the ground that existed in April 2020. It is also hoped this will lead to the disengagement of troops deployed in buffer zones, de-escalation, de-induction and return to status quo ante(RSQA) in April 2020. This is wishful thinking. COAS, Gen Dwivedi has expressed fear that the Chinese may encroach into buffer zones, so low is the trust factor.

He has called the latest disengagement a 'low hanging fruit'. But the government has given the impression as if RSQA is around the corner. Far from it.From day one after the intrusions had taken place government has covered LAC in a smokescreen: making unilateral statements and blocking debate in parliament as it would undermine troop morale. But PM Modi's famous statement after Galwan that no one came in and no one is in, took the cake. The government has banned former COAS Gen Naravane's book Four Stars of Destiny as it removes some of the smoke screen. India has its interpretation of the 21st October Agreement and China its own. There were no joint statements after the Agreement and Modi-Xi Jinping bilateral on 24 October. The Chinese readout of the 21st

October Agreement and the bilateral are different from India's like chalk from cheese. In the Agreement, the Chinese say: "two sides have reached a solution to relevant issues which has been evaluated positively. In the next step China will work with India to implement above solution". There is no mention of RSQA April 2020, and no details of "the solution" and "relevant issues". Similarly, on the bilateral which was scheduled for 45 minutes made forms had been obliter-(more than half the time is taken up in translation) Indian readout mentions "complete disengage-

ment"; "properly handling dif-ferences and disputes"; "Special Representatives would meet to resolve border dispute". China's readout: "two sides agreed on holding talks between Foreign Ministers and officials to bring relationship back to sound and steady development at early date"; "it notes progress and development on both sides and in border areas and recommends more communication and cooperation" ...in short China has shown a vague inclination to implement border agreement.

For China border talks and bilateral relations are separate issues. For India normalcy on the border is linked to bilateral relations. Positions are poles apart. As there is no road map to RSQA with timelines, one will never know the progress the three Disengagement, De-escalation and De-induction. Chinese will engage in endless military and diplomatic talks, making India the supplicant. We will continue to grope in the dark as we have for the last five years about the situation along the

ITBP officer mentioned losing 26 of 65 patrolling sites. The government has said frequently Chinese had amassed troops in violation of border protocols and "attempted to alter status quo". The forgotten legacy of Odisha's unsung iron lady



Pallavi Rebbapragada unveils Nandini Satpathy's profound journey of resilience and lasting impact in her book 'Nandini Satpathy, The Iron Lady of Orissa'

romen have played a critical and active role in shaping the political future of India. But unless they have risen to positions of power, most of them have remained unsung and forgotten. It is then a paradox that Nandini Satpathy, one such spunky politician who governed her state of Odisha as its first woman chief minister and never lost an election as a member of the legislative assembly, faded out of not just public memory but also found little or no mention in many official records of her

time in office. Why is so little known about Satpathy, the astute politician who legislated several groundbreaking state land reforms and was a passionate conservationist, poet and author? Despite being a Rajya Sabha member and minister of Information and Broadcasting in former Prime Minister Indira Gandhi's cabinet, why was her legacy largely confined to her family and friends? Was she deliberately isolated because she dared to oppose the imposition of the Emergency despite being a trusted friend and



close aide of Indira Gandhi? Did this step sound the death knell for Satpathy's association

with Indira Gandhi? Answers to these questions can be found in Pallavi Rebbapragada's researched book on the second woman to become chief minister of a state in India. Titled 'Nandini Satpathy, The Iron Lady of Orissa, Rebbapragada, a journalist and public policy consultant, chronicles the story of a girl who first defied odds to be born and then, went on to show not just Cuttack, the city where she was born, but also her state and the country that her birth would one day herald new beginnings. The first time she made her presence publicly known was when she did the unthinkable by pulling down the Union Jack flag atop her Ravenshaw college and hoisting the national flag. Satpathy, then just 15, showed no remorse even though she was imprisoned by the British police for this act of defiance. It was also to be a turning point in her personal life.

It was in jail that she met activist Devendra Satpathy whom she later married. While she accomplished several milestones during her stint in office including the setting up of the Free Bangla Radio as I&B minister in Indira Gandhi's first government during Bangladesh's struggle for independence, her contribution when out of power is no significant.Except perhaps for students of law, not many

know about her case. Dani, Superintendent of Police, Vigilance, led to a historic 1978 Supreme Court judgment that expanded the scope of the right against selfincrimination and provided guidelines for police interrogation, ensuring individuals could not be compelled to provide evidence against themselves at any stage.

This came about when Satpathy, then former Chief

Minister of Odisha, refused to answer certain questions invoking her right against self-incrimination under Article 20(3) of the Constitution when she was called for police interrogation in connection with a corruption case. The police contended that her refusal to answer questions constituted an offence under Section 179 of the Indian Penal Code.

The case reached the Supreme Court and paved the way for reaffirmation of the Right to Silence as a fundamental right, protecting individuals from being compelled to answer incriminating questions during police interroga-tion and the Right to Legal Assistance allowing individuals to consult with a legal practitioner before answering any questions during police interrogation, promoting fair treatment and safeguarding against coercive practices. Importantly, the judgment continues to remain a key reference today for ensuring the protection of individual rights during the investigative

The web of conspiracy theories and the US election



Conspiracy theories have captivated society for centuries, spinning intriguing narratives that challenge our sense of truth—and the recent US elections are no exception



n every era, conspiracy theories have captivated the public imagination, creating a whirlwind of suspicions, accusations, and intrigue. Today, with the American presidential election in the rearview mirror, the air is thick with conspiracy theories, some rooted in historical patterns and others fueled by recent global events.

From ancient prophesies to modern speculations, these narratives show how deeply conspiratorial thinking is woven into society, even influencing one of the most powerful democracies in the world. During the COVID-19 pandemic, a wave of theories dominated headlines, each offering a different perspective on the virus's origin and spread. For example, when former U.S. President Donald Trump labelled COVID-19 the "Wuhan virus," he fanned the flames of speculation that the virus was the result of Chinese bioengineering. Simultaneously, however, a counter-narrative gained traction, suggesting that the virus was an American creation, designed and disseminated as part of an alleged biological warfare

Even within the conspiracy community, viewpoints diverged: was COVID-19 a lab-born pathogen or a conse-quence of environmental manipulation? A particularly unique theory even claimed the virus spread through the electromagnetic signals of 5G towers, resulting in people burning down cell towers in the United Kingdom. The COVID-19 narrative was far from alone in raising eyebrows. Conspiracy theorists link current fears to past events-from the HIV/AIDS epidemic to natural disasters. Some hold that HIV was an engineered product of the U.S. military's biological weapons division, first tested on prisoners in the 1970s before it spread outside government control.

Others go back further in history, believing that HIV stemmed from scientific mutations, a theory allegedly supported by Russian virologists who argue that HIV was a modified form of the VISNA virus, created in a laboratory setting. Nobel laureate Wangari Maathai also claimed in 2004 that

AIDS was no accident, attributing its origin to American laborato-

Natural disasters, too, have not escaped the lens of conspiratorial imagination. In the wake of the catastrophic 2004 Indian Ocean tsunami, rumours spread that U.S. military tests were to blame. The claim was that sophisticated nuclear weapons testing off the coast of Indonesia could manipulate the weather and disrupt seisulate the weather and disrupt seismic activity. Alongside such theories, another narrative has taken shape, labelled the "Thucydides Trap"—a concept rooted in the belief that rising powers, such as China, often seek to destabilize dominant powers, exemplified dominant powers, exemplified by the release of COVID-19 as an alleged bio-weapon against the United States. Conversely, some assert that COVID-19 was a means for the U.S. to undermine China, spurring a dramatic escalation of mutual suspicion. Even the 9/11 attacks are rich ground for conspiracy theories. There are over four million articles online dissecting and speculating on every aspect of the attack, includ-ing claims of prior U.S. knowledge and deliberate inaction. Such theories propose that the tragedy served as a pretext for increased American military involvement in the Middle East, bolstering the economic interests of defence industries.

In such an environment, it is hardly surprising that suspicion surrounds recent American presidential elections. Election season in the United States has always been a prime opportunity for conspiracy theories, with the latest election being no exception. In this context, Nostradamus, the French astrologer and reputed seer of the 16th century reappears in the collective imagination. Nostradamus is often cited as having "predicted" world events, from the rise of Hitler to the terror of 9/11. As American political dynamics shift, believers inter-

pret Nostradamus' cryptic prophecies to suit contemporary issues, citing his supposed fore-sight about Trump's ascension and even a second term. Such theories proliferate because they tap into pre-existing beliefs, adding layers of mystery to the already intricate political landscape. One particularly respected figure in the American election-prediction community is historian Allan Lichtman. Dubbed the "Election Nostradamus," Lichtman has accurately forecasted the outcomes of multiple presidential elections over the past few decades.

Although Lichtman's predictions are based on a well-formulated system, his track record and the nickname he's acquired seem to lend credence to the idea that prophecy and foresight have a place even in the most rational domains. Lichtman's projections of a Democratic victory fueled hope among Biden and Harris supporters, while some conspiracy theorists proposed that the "powers that be" were covertly steering the election outcome to align with Lichtman's track record. Despite NASA's documentation

and evidence, sceptics argue that the moon landing was an elaborate hoax staged to one-up the Soviet Union in the Cold War space race. Believers insist that the televised moonwalks were filmed on Earth, attributing the iconic image of Neil Armstrong to American propaganda efforts. The moon landing controversy

may be one of the most persistent conspiracy theories, as it continues to captivate audiences more than 50 years later. As much as conspiracy theories

focus on the United States, they are not exclusive to any single nation. Still, America's global influence and extensive media presence make it especially susceptible to scrutiny. Government mistrust underpins many of these theories, exemplified by the Roman historian Tacitus, who posited that the actions of untrustworthy rulers breed public suspicion.

According to Tacitus, regimes that lose the faith of their citizens tend to fuel the fires of conspiracy, using public confusion as a tool to maintain control. In the current political climate, where truth is elusive and media narratives frequently conflict, conspiracy theories are likely to thrive. They emerge not only from a need to question authority but also from an inherent fascination with the unknown.

For every piece of verified information, there is a counter-theory that rejects it, and conspiracy theories transform historical and current events into captivating narratives for believers and scep-

As American democracy continues to face these claims, it's clear that conspiracy theories are not going away any time soon. Rather, they will evolve, adapting to each new event and generation with the same intensity that has fueled them for centuries.

the startup brings out creativity and resourcefulness in problem-solving. Combined with lean operations and focus on revenue generation, the founder manages to survive and thrive which leads to high founder satisfaction, selfreliance and long-term sustainable growth. Although it is difficult to

dampen the spirit of entrepreneurship, the statistics sure us disheartened. According to an article in Harvard Business Review by Prof. Tom Eisenmann, nearly 63 per cent of startups never end up with a positive return. By another metric, only 15 per cent of startups ever see through their first round of funding. So, in situations where the survival of startups

So, are bootstrapped companies less valuable than funded companies? This is a quintes-

sential question. Well, to answer this, let's try to see what is value. For starters, a company is valuable if, irrespective of its size, can develop a product or service and generate rev-

By doing so, over some time, the revenue base starts helping the company to grow organically and lo behold, it manages to cross the 'valley of death'. By focusing on customer acquisition and revenue generation, bootstrapped startups demonstrate their qualities of innovation, resourcefulness, flexibility and agility, in navigating the uncertain world of entrepreneurship. By keeping themselves lean and using costeffective strategies, bootstrapped startups facilitate higher profit margins that in turn lead to long-term sustainable growth. In a startup world that is fix-

ated with high growth fancy ideas and flamboyant entrepreneurs, bootstrapped startups stand out as beacons of efficiency, proving that some-times slow and steady truly does win the race.

Israel passes laws to restrict work of UN agency that is lifeline for Gaza

sraeli lawmakers passed two laws on Monday that could **⊥** threaten the work of the main UN agency providing aid to people in Gaza by barring it from operating on Israeli soil, severing ties with it and labelling it a terror organisa-

The laws, which do not immediately take effect, signal a new low for a long-troubled relationship between Israel and the UN Israel's international allies said they were deeply worried about their potential impact on Palestinians as the Gaza war's humanitarian toll worsens. Under the first law, the UN

agency for Palestinian refugees, or UNRWA, would be banned from conducting "any activity" or providing any service inside Israel. The second law would sever Israel's diplomatic ties with the agency.

The laws risk collapsing the already fragile process for distributing aid in Gaza at a moment when Israel is under increased US pressure to ramp up aid. UNRWA's chief called them "a dangerous precedent".

Israel has alleged that some of UNRWA's thousands of staff members participated in the Hamas attacks last year that sparked the war in Gaza. It also has said hundreds of UNRWA staff have militant ties and that it has found Hamas military assets in or under the agency's facilities.

The agency fired nine employees after an investigation but denied it knowingly aids armed groups and said it acts quickly to purge any suspected militants from its ranks. Some of Israel's allegations prompted major international donors to cut funding to the agency, although some of it has been

Israel has at times during the war raided or attacked UNRWA schools or other facilities, saying militants were operating there. UNRWA says more than 200 of its employees have been killed during the war.

"The law that we passed now is not just another bill. It is a call for justice and a wake up call," said lawmaker Boaz Bismuth, who co-sponsored one of the bills. "UNRWA is not an aid agency for refugees. It is an aid

The head of UNRWA, Philippe Lazzarini, said the new laws were part of an "ongoing campaign to discredit UNRWA".

These bills will only deepen the suffering of Palestinians, especially in Gaza," he said on the social platform X.

The first vote passed 92-10 and followed a fiery debate between supporters of the law and its opponents, mostly members of Arab parliamentary parties. The second law was approved

An English language account on X for Israeli Prime Minister Benjamin Netanyahu said Israel was ready to work with international partners to ensure it "continues to facilitate humanitarian aid to civilians in Gaza".

The post did not say how, and it was not clear how the flow of aid would be affected once these bills take effect.

Together, the laws would effectively sever ties with the UN agency, strip it of legal immunities and restrict its ability to support Palestinians in east Jerusalem and the West Bank. The legislation does not provide for alternative organizations to oversee its work.

UN Secretary-General Antonio Guterres said UNRWA would be prevented from doing UN General Assembly-mandated work if the laws are implemented. "There is no alternative to UNRWA," he said in a statement issued Monday night.

Guterres called on Israel "to act consistently with its obligations" under the UN Charter and international law, as well as the privileges and immunities of the United Nations. "National legislation cannot alter those obligations," Guterres stressed in a state-

International allies of Israel's have opposed the move: The changes could be a serious blow to Palestinians in Gaza. More than 1.9 million Palestinians are displaced from their homes, and Gaza faces widespread shortages of food, water and medicine.

International aid groups and a handful of Israel's Western allies, including the US, have voiced strong opposition.

Petition seeking ban on Awami League withdrawn

Acourt in Bangladesh seeking a ban on ousted Prime Minister Sheikh Hasina's Awami League and several other parties was withdrawn on Tuesday.

Leaders of the anti-discrimina tion students' movement, which led to the ouster of Hasina's 15year regime on August 5, on Monday in a petition in Dhaka High Court sought the court's directions to prevent the Awami League and 10 other parties from conducting political activities in the country

Court officials and lawyers said three top leaders or coordinators of the movement — Sarjis Alam, Hasnat Abdullah and Hasibul Islam — decided not to proceed with the petition that also questioned the past three general elections in 2014, 2018 and 2024 which installed Hasina-led

Awami League to power. The elections were staged amid allegations of massive vote manipulation or boycott by the

Nationalist Party (BNP) led by ers. Khaleda Zia and several other parties. The movement leaders, however, preferred not to proceed with the second writ either that questioned the legitimacy of these three parliamentary elections. The two writs, listed by a two-member high court bench for hearing on Tuesday, were withdrawn as the proceedings began in the morning. The petitioners' lawyers informed the bench that their clients would not proceed with the writs.

Alongside Awami League, the writ petition was filed against Jatiya Party (Ershad), Jatiya Party (Manju), Ganatantri Party, Jatiya Samajtantrik Dal, Bikalpa Dhara Bangladesh, Bangladesh Tarikat Federation, Communist Party of Bangladesh (CPB), Liberal Democratic Party (LDP), Communist Party of Bangladesh (Marxist-Leninist) (Barua), and Workers Party of Bangladesh. n a major setback to China's In a major servace to Carlotte BRI, Brazil has decided against joining Beijing's multibillion-dollar initiative becoming the second country after India in the BRICS bloc not to

endorse the mega project. Brazil, headed by President Lula da Silva, will not join the Belt and Road Initiative (BRI) and instead seek alternative ways to collaborate with Chinese investors, Celso Amorim, special presidential adviser for international affairs, said on Monday.

Brazil wants to "take the relationship with China to a new level, without having to sign an accession contract", he told Brazilian newspaper O Globo. "We are not entering into a treaty," Amorim said, explaining that Brazil does not want to take Chinese infrastructure and trade projects as "an insurance policy".

According to Amorim, the aim is to use some of the Belt and Road framework to find "synergy" between Brazilian infrastructure projects and the investment funds associated with the initiative, without necessarily formally joining the group, the Hong Kong-based South China Morning Post quoted him as saying. The Chinese "call it the belt

[and road] ... and they can give whatever names they want, but what matters is that there are projects that Brazil has defined as a priority and that may or may not be accepted [by Beijing]", Amorim said.

The decision contradicts China's plans to make Brazil's joining of the initiative a centrepiece of Chinese President Xi Jinping's state visit to Brasilia on November 20, the Post reported.

Officials from Brazil's economy and foreign affairs ministries recently voiced opposition to Ethiopia, Iran, Saudi Arabia,

Duterte's jarring testimony into drug killings relives nightmare for many

The cockiness, expletives and threats unleashed by former President Rodrigo Duterte in a Senate inquiry brought back the nightmare of the bloody "war on drugs" for many families of the thousands of victims who were gunned down under his rule. Speaking under oath in Monday's

televised hearing into the killings, a defiantly combative Duterte $returned \ \dot{to} \ the \ national \ spotlight$ for the first time since leaving office in 2022 with little show of remorse. He got away with it again, critics say.

"If I'm given another chance, I'll wipe all of you," Duterte, 79, who is seeking a new term as mayor of his southern home city of Davao next year, said of drug dealers and criminals.

Duterte again denied that he authorized extrajudicial killings of drug suspects, saying there were no "state-sponsored killings". But he acknowledged that as mayor of Davao, before becoming president, he kept a small "death squad" of gangsters whom he had ordered to eliminate other criminals.

Duterte's profanity-laced out-bursts scared Randy delos Santos, who was invited by the Senate to speak about the killing of his nephew, Kian, by police under Duterte's "war on drugs". It felt, he said, like a nightmare had returned.

'I had this frightening feeling that thousands of innocent people may be gunned down again," delos Santos told The Associated Press on Tuesday. "I was wondering why he was allowed to speak with disrespect and given a stage to vent his past excuses.

The thousands of killings which human rights groups estimate could exceed 20,000 under Duterte were unprecedented in recent Philippine history and triggered an International Criminal Court investigation as a possible crime against human-

Philadelphia DA sues Elon Musk's America PAC over its \$1m giveaway

The district attorney of Philadelphia has filed a lawsuit to halt $\bar{\text{Elon}}$ Musk 's USD 1 million giveaways as part of his political organisation's effort boosting Donald Trump's presidential campaign.

The suit by Democratic District Attorney Larry Krasner is the first legal action to be brought over the America PAC's sweepstakes offering USD 1 million every day until November 5 to a person in a battleground state who has signed a petition supporting the Constitution.

Krasner's office said the lawsuit, coming just over a week before Election Day, doesn't preclude potential criminal action.

The Philadelphia District Attorney is charged with protecting the public from public nuisances and unfair trade practices, including illegal lotteries. The DA is also charged with protecting the public from interference with the integrity of elections," Krasner's office said in a statement published on its website.

A spokesperson for the billionaire tech mogul's America PAC, emailed for comment on the lawsuit and asked if the cash awards would continue, responded with a link to an X post, which showed the latest USD 1 million winner holding an oversize

I-T department notifies range for transfer pricing cases

 $T^{\text{he income tax department}}_{\text{has notified the tolerance}}$ range for variation between arm's length price and transfer pricing for international and specified domestic transactions for Assessment Year 2024-25.

The range has been retained at the same level as last year's -- one per cent for "wholesale trading" and three per cent for all other taxpayers, the Central Board of Direct Taxes (CBDT) said.

The term 'wholesale trading' will be defined as an international transaction or specified domestic transaction of trading in goods subject to certain conditions.

The notification of tolerance range shall provide certainty to taxpayers and reduce the risk perception associated with the pricing of a transaction in transfer pricing," the CBDT said in a transaction statement.


