INDIA AND CHINA TO THAW FROST ALONG LAC

Signalling a thaw in strained ties between the two countries for the last four years, Foreign Secretary Vikram Misri on Monday announced that India and China have reached an agreement on patrolling arrangements along the Line of Actual Control (LAC) in eastern Ladakh. This leads to eventual disengagement of troops from both sides, Misri

External Affairs Minister S Jaishankar later said, "...We can say that the disengagement process with China has been completed... We will be able to do the patrolling which we were doing in 2020. I think it's a good development..."
This significant development

came a day ahead of the Brazil, Russia, India, China and South Africa (BRICS) summit in Kazan, Russia. The two-day summit starts on Tuesday. Prime Minister Narendra Modi may have a bilateral meeting with Chinese President XI Jinping on the sidelines of the meet, though there is, so far, no official word

regards the latest development, Misri said here the countries have reached an agreement on patrolling arrangements along the LAC following recent negotiations between officials from both countries.

"Over the last several weeks, Indian and Chinese diplomatic and military



contact with each other in a variety of forums. As a result these discussions, agreement has been arrived at patrolling arrangements along the line of actual control in the India China border areas, leading to disengagement and a resolution of the issues that had arisen in these areas in 2020. We will be taking the next steps on this," he said.

The foreign secretary said the Chinese and negotiators were in touch over the last few weeks to resolve the remaining issues. It is understood that agreement agreement pertains to patrolling in Depsang and Demchok areas.

It is not immediately clear whether the agreement facilitates the restoration of patrolling rights that were in place prior to the standoff. Tensions flared up at the LAC in Eastern Ladakh in May 2020 when China unilaterally tried to change the status quo on the border. It led to a major clash between the troops of the two armies on June 15 that

year in Galwan. Indian army personnel including the commanding officer died in the clash while more than 40 Chinese troops were also killed. Both the sides then amassed

troops and weaponry on their respective sides of the LAC. In fact, India, not willing to take any chances, also deployed its troops even during the winter months at the LAC. Earlier, the troops used to withdraw to their bases during the winters. At one point of time, more than 50,000 troops from each side were facing each other on friction points at the LAC. Given the situation, India and China, since 2020, held

Delhi bomb investigation exploring multiple angles

Khalistani link, a male Asuspect wearing a white tshirt and an Improvised Explosive Device (IED), are the angles that the multiagency probe is focusing a day after a 'bomb' blast near the Central Reserve Police Force (CRPF) public school sent shockwaves across the national Capital.

According to police sources, it is suspected that an IED, wrapped in a plastic bag, was hidden in a one-foot-deep pit near the CRPF school wall. A CRPF team visited the spot on Monday morning while its officials from the Institute of IED Management conducted a ground assessment. The National Security Guard's (NSG) Bomb Disposal Squad (BDS) is preparing to submit its final report to the Delhi Police.

The CRPF, with its expertise in ground assessment, and the IED Institute Management's involvement, suggest a focus on understanding the blast's mechanics and origin. The Delhi Police, in turn, is

expected to submit its initial report to the Ministry of Affairs (MHA). Home Additionally, the National Investigation Agency (NIA) and the Forensic Science Laboratory (FSL) of the Delhi Police have been assisting in the investigation.

Meanwhile, shops remained shut and a usually bustling market of the Prashant area remained deserted due to fear, with businessmen left in distress who are incurring losses ahead of the festival of Diwali, which is usually a peak time for sales of items including jewellery. Moreover, the two schools near the spot, including CRPF school and Lancer's Convent, saw a low turnout of students due to the parents who are concerned

for their safety. Linking the blast to a possible Khalistan angle, a purported Telegram post was being circulated on social media which claimed that the blast was carried out in retaliation to the "targeting" of pro-Khalistan separatists allegedly by Indian agents

Hoax threat callers to have a rough landing ahead

fter unabated After unavaced bonne threat messages to multiple Indian airlines in the past one week, lead to diversions, cancellations and passenger inconvenience, the Union government planning to make hoax threat calls to Indian airlines a cognisable offence. The government is also planning to put hoax callers on a 'no fly

Union Civil Aviation Minister Kinjarapu Ram Mohan Naidu announced this on Monday, in the National Capital. Currently, this stringent law is invoked against people who make hoax calls and endanger the safety of an aircraft when it is in the air, not on the ground. Meanwhile, two top aviation security officers met Union Home Secretary Govind Mohan and discussed the unabated incidents of bomb threats to Indian airlines, leading to diversions, cancellations and passenger inconvenience.

Naidu said amendments are being planned to aviation security rules as well as the Suppression of Unlawful Acts Against Safety of Civil Aviation Act, 1982. "We have come to the conclusion that there are two areas that we can explore - 1) Amendment Aircraft Security Rules...one of the ideas that we want to propagate by changing these rules is that once we catch hold of the perpetrator who is behind this, we want to put them in no-flying list... 2) Suppression of Unlawful Acts Against Safety of Civil Aviation Act...", he said.



"While it (SUASCA) takes care of the offences when the aircraft is in travel, in flight, if we want to address these kinds of threats that have been happening. We want to take strict action against people who are behind this when there is a fake or hoax threat that they are trying to do, we have to cover the act on the ground and the airport also. So we are trying to make an amendment. Our legal team has worked very thoroughly on this and we are coming up with amendment," Naidu said.

"We want to make it a cognisable offence. Even though these are hoax threats we cannot take it lightly.. we have a set protocol," he said. The Union Minister said that the aviation ministry is in consultation with ministries such as the Home Ministry. "We are trying to use intelligence, IB and all the other important people who are there in this, especially home affairs and all, everyone is cooperating together. We are taking it very seriously and we want to ensure that these kinds of incidents do not happen."

The minister said multiple meetings have been held with stakeholders since the spate of calls began so that the people making such threats can be put on the no-fly list after they are identified. He added that the National

Democratic Alliance (NDA) government at the Centre would not compromise the safety and security of passengers. The minister added that around 10 per cent security has been enhanced at airports across the country in the wake of bomb threats. In a related development, a key high-level meeting was also held in the Ministry of Home Affairs on Monday in which updates were taken from

aviation security body Bureau of Civil Aviation Security (BCAS) and the Central Industrial Security Force, which is responsible for security at airports. Bureau of Aviation Security (BCAS) Director General (DG) Zulfiquar Hasan and Director General of Central Industrial Security Force (CISF) Rajwinder Singh Bhatti met Mohan at the latter's office at North Block here. The three officers remained

closeted for about half an hour. However, details of the meeting are not known immediately. The CISF guards 68 civilian airports in the country.

GRAP Stage-II invoked, NCR AQI 'very poor'

As Delhi's air quality continues to remain in the very poor' category, with an average Air Quality Index of 310, the Commission for Air Quality (CAQM)'s Management committee has now invoked the 11point action plan as per Stage-II of Graded Response Action Plan (GRAP) from Tuesday, with the forecast indicating that the air quality is likely to deteriorate in the coming days.

To discourage private vehicles, the authorities can hike parking fees under the stage II GRAP. The CAQM has appealed to people to use public transport and minimise use of personal vehicles and take less congested routes even if slightly longer. It is also advised to regularly replace air filters at recommended intervals in your automobiles, avoid dust generating construction activities during months of October to January and open burning of solid waste and biomass. Data from CPCB shows that several parts of Delhi are currently grappling with "Unhealthy" levels of pollution. Anand Vihar, for example, registered an Air Quality Index (AQI) of 226, while other monitoring stations including Rohini, Sonia Vihar, Dilshad Garden, Vivek Vihar, Ashok Vihar have reported similarly hazardous levels, categorised as either "Unhealthy" or "Very Unhealthy."

The AQI also recorded 210 (poor category) in Gurugram, 165 (moderate) in Faridabad, 252 (poor) in Noida, 183 (moderate) in Greater Noida, 257 (poor) in Ghaziabad. The CAQM's or read, "In an order

prevent further deterioration of the air quality, the Sub-Committee decided that all actions as envisaged under Stage II of the GRAP - 'Very Poor' Air Quality (DELHI AQI ranging between 301-400) - be implemented by all the agencies concerned in the NCR, in addition to the Stage-I actions already in force, from 8 am of 22.10.2024 in the National Capital Region (NCR).

The decision was taken after the subcommittee took stock of the air quality scenario and air quality forecasts for Delhi made by the India Meteorological Department and the Institute of Indian Tropical Meteorology.

11-action plan meant to be implemented by various agencies including Pollution Control Boards of NCR States and the Delhi Pollution Control Committee (DPCC). These include carrying out mechanical or vacuum sweeping and water sprinkling of the identified roads on a daily basis; Ensuring water sprinkling along with use of dust suppressants (at least every alternate day, during nonpeak hours) on roads to arrest road dust especially at hotspots, heavy traffic corridors, vulnerable areas and proper disposal of dust collected in designated sites/landfills; Intensifying inspections for strict enforcement of dust control measures at C&D sites; Focussed and targeted action for abatement of air pollution in all identified hotspots in NCR and intensifying remedial measures for the predominant sector(s) contributing to adverse air quality in each of such hotspots; Ensuring uninterrupted power supply to discourage use of alternate power Generating sets/ equipment (DG sets etc.) and Strict implementation of the schedule for regulated operations of DG sets across all sectors in the NCR including Industrial, Commercial, Residential and offices etc.



There is enough pollution, no firecrackers to be sold: Delhi HC

The Delhi High Court said on Monday that it cannot allow the sale of firecrackers when there is already "enough" pollution in the national capital.

The court's oral observation came while dealing with a petition by the Fireworks Shopkeepers Association, a group of traders with a "permanent" licence to possess and sell crackers.

The petitioner's counsel said the grievance of the traders was with respect to the ban on the storage of firecrackers as it was allegedly resulting in harassment.

During the hearing, the court said it would ask authorities to seal the traders' premises being used for storage of firecrackers to ensure that there is no pilferage.

The State must be involved in the sealing process so that there is no pilferage," said Justice Sanjeev Narula. We are not going to allow you to sell. There is enough pollution in this city,"

the judge orally added.

The petitioner's counsel said that even though no crackers were being sold by its members, soon after the ban order, the police started visiting the permanent licensees questioning why they were storing the firecrackers.

The court observed that in one of the instances cited by the petitioner, there was an allegation of someone selling the crackers and said whoever acted in contravention of the law would be prosecuted.

We can't make an exception for you. If you store them, there is a possibility of (misuse). We will put a seal. It will be videographed," the court said

orally.

The Delhi government on September 14 imposed an immediate ban on the production, storage, sale, and use of all kinds of firecrackers across the city, effective from January 1.

While making the announcement, Delhi Environment Minister Gopal Rai urged the city residents to support the government's efforts to curb air pollution.

New nuclear reactors coming up

The Parliamentary Standing Committee on I Science and Technology said on Monday here that at least 10 nuclear reactors are being installed in the country while two reactors in Gujarat's Kakrapar have started generating power commercially.

According to sources, the new nuclear ors con states like Gujarat, Rajasthan Haryana are of 700 MW capacity and will start operating in the next few years The details of the new nuclear reactors were

provided to members of Standing Committee

of Parliament on Science and Technology, Environment, Forests and Climate Change during a meeting here. Congress leader Jairam Ramesh, who is a

member of the committee as well as its former chairman, said members of the panel were informed during the meeting that the Kakrapar-3 and Kakrapar-4 nuclear reactors in Gujarat have been fully synchronised with the grid and are generating power commercially. "This is a major accomplishment since these

are indigenously designed 700 MW reactors that were approved in 2007. Construction had begun in 2010. More such reactors are being installed at different locations," he said in a post on X. Another example of how much continuity

there is in our development — which is never acknowledged by 'El Supremo," Ramesh said, stressing that it was during the Congress rule when the two nuclear reactors in Kakrapar were approved.

Vehicles spew 18 per cent PM 2.5 in the peak evening hours

According to the Decision Support System (DSS) of Indian Institute of Tropical Meteorology, for Air Quality Management in Delhi, emission from transportation accounts contributed to around 11.2 percent air pollution on Monday.

According to a study by IIT Kanpur, the contribution from the local on-road transport sector to diurnal mean PM 2.5 is largest (18%) during the evening traffic peak. It is dominated

three-wheelers (50%) followed by heavy-duty vehicles (30%), which also collectively represent 60-70% of the total on-road transport sector at any hour of the day. Breakdown of vehicles and ongoing construction works by agencies like Delhi Metro, Delhi

Jal Board and National Highway Authority of India (NHAI) added woes to the congestion, causing inconvenience to daily office goers in the morning and deteriorating air pollution. Mehrauli-Badarpur Road, Mehrauli-Gurugram Road, Netaji Subhash Marg, Wazirabad Road,

Raja Garden Road, Kashmere

Gate ISBT, Sadar Bazar, Chirag Dilli, roads surroundings major markets including Sarojini Nagar, Chandni Chowk, Lajpat Nagar, Kamla Nagar were among those areas witnessed heavy traffic on Monday.

These stretches are the busiest roads known for heavy traffic flow during the week. Lakhs of people commute in and from Delhi to Gurugram, Noida, Faridabad and Ghaziabad daily. Neighbouring Noida has been consistently contributing between 10 and 11 percent to Delhi's pollution, while Ghaziabad's share ranges from 5 to 10 percent, as per the DSS -

Jugsalai heads for a heated contest as JMM's Mangal Kalindi files nomination



The Jugsalai (SC) Assembly seat is heading for a closely watched electoral battle, with sitting JMM MLA Mangal Kalindi officially filing his nomination papers on Monday. Kalindi, a well-known grassroots leader from the SC community, is expected to face a tough fight Ramchandra Sahis, who represents the All Jharkhand Students Union (AJSU).

Kalindi, a stalwart in Jugsalai politics, is contesting for a second term backed by his strong control over the local electorate. A member of the Scheduled Caste (SC) community, Kalindi has built

caste rights. He enjoys close ties with senior Jharkhand Mukti Morcha (JMM) leaders, including party patriarch Shibu Soren and current Chief Minister Hemant Soren. His base in Kalindi Basti gives him a foothold in the SC and tribal-dominated regions of Jugsalai, which remain his core support base.

However, Kalindi faces challenges in upper-caste dominated localities where JMM has historically struggled. Despite this, he is banking on his grassroots connections and his image as a leader who has worked tirelessly for the marginalized.

Ramchandra Sahis, the AJSU candidate, enters the fray with a different appeal.

Singhbhum district, Sahis's life has been marked by struggle and perseverance. Having completed his education from Singhbhum College in Seraikela-Kharswan district, Sahis is known for championing OBC (Other Backward Classes) issues, which have garnered him significant support in rural and **OBC-dominated** areas AJSU's focus on regional issues and grassroots development has strengthened his standing, particularly in regions where the party has traditionally performed well.

Sahis, however, faces a disadvantage in urban and Muslim-dominated regions, where the JMM and BJP have a stronger presence. With

10% of the electorate, Sahis will need to extend his appeal beyond AJSU's usual base to secure a victory.

The Jugsalai constituency

presents a complex and diverse electorate. Leading the community representa-tion are the Mahtos, who make up 14.7% of the electorate with 48,019 voters. Close behind are the Singh comprising community, 12.8% with 41,812 voters, followed by the Muslim population at 9.9% (32,339 voters). Smaller but significant communities such Das, Sharma, Murmu, Prasad, and Karmakar hold sway in various pockets, while indigenous groups like the Manjhis (Mushars), Gope,

and others like Hambram, Tudu, and Soren also have notable voter bases.

As the JMM and AJSU candidates prepare for what promises to be an intense Jugsalai Assembly seat's outcome will largely depend on how well Kalindi can solidify his existing support base while Sahis tries to expand his reach into urban and minority areas. With caste dynamics playing a key role, both candidates will need to navigate the complex social fabric of Jugsalai to emerge victorious.

The next few weeks will see a battle of grassroots leaders with contrasting appeals, making the Jugsalai seat one to watch in the upcoming elections.

11,000 paramilitary personnel to be deployed during polls



SC grants two-week extention to expert panel of NEET-UG reforms

The Supreme Court on The Supreme Court
Monday extended by two weeks the time granted to the Centre-appointed seven-member expert panel to file its report on exam reforms after reviewing the National Testing Agency's functioning in holding the NEET-UG. The SC on August 2 had passed its formal order and expanded the remit of the seven-member expert panel, headed by former Indian Space Research Organisation (ÎSRO) chief K Radhakrishnan, to review the functioning of the National Testing Agency (NTA) and recommend exam reforms to make the controversy-ridden NEET-UG (National Eligibility cum Entrance Test Undergraduate), transparent and free from mal-



The NEET-UG is conducted by the NTA for admission in undergraduate medical programs. The top court had also refused to annul the NEET-UG of 2024, saying there was no sufficient material on record at present to indicate a systemic leak or malpractice compromising

examination. On Monday, Solicitor General Tushar Mehta, appearing for the Centre, told a bench headed by Chief Justice DY Ćhandrachud that deadline for filing the report of the expert committee was ending and sought two-week extension. The bench, also comprising

Manoj Misra, took note of the fact that the report of the panel was almost complete and granted two more weeks for filing the same. While expanding the scope of the expert panel, the top court had flagged multiple lapses on the part of NTA like the security breach at an examination centre Iharkhand's Hazaribagh where the rear door of the strongroom was opened and unauthorised people were permitted to access question papers, transportation of question papers by e-rickshaws and distribution of wrong set of question papers

among the candidates. Besides Radhakrishnan, other members of the expert Ranđeep committee are Guleria, B J Ramamurthy K,

Govind Jaiswal. The bench said the remit of the committee, in addition to the tasks that it has been entrusted with by the union government and the NTA, shall encompass examination security and administration, security technological enhancements. Its responsibilities will also stakeholder collabo engagement, international cooperation, and recommendations for providing mental health support to students and training of NTA staff, it had said. Over 23 lakh students took up the NEET-UG in 2024 for admissions to MBBS, BDS, AYUSH and other related courses, which marred series of controversies of

'I am Congressman till my last breath': Ajay Singh Yadav

Yadav, whose son Chiranjeev Rao lost from Rewari in the recently concluded Haryana Assembly polls, said the party could not effectively micro manage the polls

"(AICC Harayana in-charge) Babaria ji was in the hospital. Now he is offering resignation, why didn't he do it earlier. If he was unwell, he should have resigned. Our PCC chief was himself busy fighting an election," the chairman of the Congress OBC department said.

SC stays NCPCR directive against madrassas

The Supreme Court on Monday stayed the operation of the communications issued by child rights body NCPCR urging States to shift students of unrecognised Madrassas to Government schools. A bench comprising Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoj Misra took note of the submissions of senior advocate, appearing for Muslim organisation Jamiat Ulema-i-Hind, that the communications of the National Commission for Protection of Child Rights (NCPCR) and consequential actions of some of States needed to be stayed. The Muslim organisation



has challenged the action of Uttar Pradesh and Tripura governments directing that students of unrecognised madrassas should be shifted to Government schools. The top court ordered the communications of the NCPCR issued on June 7 and June 25 this year should not be acted upon. The Court also said the consequential orders of the states shall also remain stayed. It also permitted the Muslim body to make states, other than Uttar Pradesh and Tripura as parties to its petition.

The National Commission for Protection of Child Rights (NCPCR) last week wrote to chief secretaries of States and Union Territories, recommending that Madrasa boards be "closed down", State funding to Madrasas and Madrasa boards be stopped, and children attending Madrasas be enrolled in "formal schools." President Droupadi Murmu will present the National Water Awards 2023 on Tuesday, recognising outstanding contributions to water management and conservation across India.

Department Resources, Development, and Ganga Rejuvenation under the Union Ministry of Jal Shakti, honour efforts in nine categories, ranging from best state to best civil society, according to an official statement.

In the category of Best State, the first prize has been conferred upon Odisha, with Uttar Pradesh securing the second position, and Gujarat and Puducherry jointly securing the third position. Each award winner will be conferred with a citation and a trophy as well as cash prizes in certain categories.

Odisha has been gaining recognition for its extensive water conservation initiatives such as establishment of approximately 53,000 water



harvesting structures, along with 10,800 reuse and recharge systems. Additionally, the renovation of 11,000 traditional water bodies, development of 68,700 watersheds, and completion of 21,000 wastewater treatment plants have been achieved.

The renovation of around 1,800 km of drainage channels has reclaimed approximately hectares of agricultural land previously affected by waterlogging. Also, over 90,900 hectares of irrigated land have transitioned from conventional irrigation methods to micro-irrigation

drip irrigation, benefiting about 87,000 farmers.

Second slot in the award category has been acquired by Uttar Pradesh. It has built or rejuvenated 14,679 'Amrit Sarovars' and undertaken extensive rainwater harvesting initiatives in recent years. Pakistani terrorist handlers target one of India's most strategic road projects in J and K

Terrorist handlers sitting ▲ across Pakistan have once again attempted to derail the peace process close on the heels of a successful Shanghai Cooperation Organisation (SCO) summit in Islamabad by targeting construction workers of India's one of the strategic road construction projects in Jammu and Kashmir.

A doctor from the Nadigam area of Central Kashmir's Budgam district along with six employees of APCO Infratech, a private construction agency constructing the Z-Morh tunnel on the Srinagar-Sonamarg highway was killed in one of the most provocative strikes in recent years in the Kashmir valley. The Resistance Front (TRF), an affiliate of Pakistan-based Lashkar-e-Taiba (LeT), has claimed responsibility for the

Reacting strongly to the provocative terror strike, Union Home Minister Amit Shah said the dastardly terror attack on civilians in Gagangir, J&K, is a despicable act of cowardice. Those involved in this heinous act will not be spared and will face the harshest response from our security forces. "At this moment of immense grief, I extend my sincerest condolences to the families of the deceased. Praying for the speedy recovery of those injured" Amit Shah said in a post on X(earlier Twitter).

The gruesome terror strike inside the campsite has also exposed the vulnerability of migrant construction workers engaged by private agencies without caring for their adequate safety and security.

The attack also signals a shift in the strategy of Pakistanbased terrorist handlers. After launching a series of strikes on the security forces convoys



in the Jammu region this time they targeted the civilians working on ground zero to earn their livelihood.

Following the strike, several workers have decided to shift safer locations in Ganderbal and Srinagar to prevent any fresh strikes.

A large-scale search operation is also underway, with the Assam Rifles, CRPF, and the Jammu and Kashmir Police's Special Operations Group (SOG) involved. Senior police officers, including the Director General of Police (DGP) Nalin Prabhat and the Inspector General of Police (IGP), Kashmir range VK Birdi are overseeing the efforts. A team from the National Investigation Agency (NIA) also visited the campsite ahead of launching detailed investigations into the case.

Meanwhile, the mortal remains of victims of a gruesome terror attack near Sonamarg in the Ganderbal district were sent home for the last journey on a day when newly elected members of the Jammu and Kashmir legislative assembly were administered oath by the pro-term speaker Mubarak Gul in Srinagar.

According to ground reports victims as he blamed Pakistan

around 8,00 p.m. on Sunday the heavily armed terrorists barged inside the campsite without facing any resistance and started indiscriminate firing on the construction workers. As chaos prevailed the terrorists also targeted some employees present inside the staff mess killing a local doctor, a Jammu-based designer Shashi Abrol, Safety Manager from Bihar Mohd Faheem Nasir and Mechanical Manager Anil Shukla from Madhya Pradesh. The other dead included Gurmeet Singh son of Dharm Singh of Gurdaspur Punjab; Mohammad Hanif and

Kaleem from Bihar. At least five critically injured workers have been admitted to the Sher-e-Kashmir Institute of Medical Sciences (SKIMS) for advanced treatment. Before fleeing the terrorists also torched two vehicles stationed in the campsite. Jammu and Kashmir Lieutenant Governor Manoj Sinha on Monday said security forces will avenge the construction workers' death in the brutal attack in Ganderbal, and "exact a price" that the terrorists will remem-

ber for the time to come.

Wife of slain designer was observing Karva Chauth fast, entire family in shock

The wife of Shashi Abrol, one of the Jammu-based employees of Apco Infratech, was observing fast on the occasion of karva Chauth on Sunday when he was killed by terrorists inside the staff mess of a makeshift campsite in the Sonamarg area of Ganderbal district.

The incident has left the entire family in a state of shock

Shashi, who has been working with Apco Infratech as a designer for over seven years now, leaves behind his wife and two kids. His elder son recently joined an engineering college in Bhopal and his daughter is currently studying in class 4. Shashi Abrol spoke to his wife for the last time via video call around 6.30 p.m. on

His sister, who was consoling her sister-in-law informed visiting media persons, "My bhabi, dressed in her traditional attire and sporting 'Heena' on her palms, spoke to my brother on Sunday evening as she wanted to inform him that she was going to join special prayers on the occasion and would again call him past 8.00 p.m. at the time of breaking her fast.

The couple agreed to close the call after seeing each other for the last time. On her return when she started contacting her husband she received no response. "We told her that he may be busy at work but when there was no response from his side till late night we were worried for his well-

being". "Till late at night no one from the Apco Infratech or the government informed us about the terror strike in their camp where he along with six others were killed. We came to know through the media in the morning when we read the newspapers that our loved one is one among those victims of the gruesome terror strike", Shashi Abrol's sister said. The family spent the whole day waiting to receive the mortal remains. LG Manoj Sinha met the family at their residence in Talab

Tillo area. In Kashmir, the family of Dr Shahnawaz Ahmad Dar wept inconsolably after learning about his death in the terror strike. Dr Shahnawaz was killed by terrorists while he was having dinner with other colleagues. He solemnized the marriage of his elder daughter last Wednesday and had promised the family to return home to welcome his newly married daughter as per their rituals on Tuesday. Unfortunately, Dr Shahnawaz

Tej Pratap files nomination, accompanied by Yadav family

The political scene in Uttar Pradesh has intensified as on Monday Samajwadi Party (SP) candidate Tej Pratap Yadav filed his nomination from the Karhal assembly constituency in Mainpuri where bye-elections are due on November 13. SP chief Akhilesh Yadav, accompanied by Dimple Yadav, Professor Ram Gopal Yadav, Shivpal Yadav, Dharmendra Yadav, was present during the nomination process.

Addressing the media after Tej Pratap's nomination, Akhilesh Yadav took a dig at the Bharatiya Janata Party (BJP), accusing it of orchestrating riots in Bahraich to gain political mileage. "BJP deliberately caused riots so that they could benefit politically. When questions are asked of the government, they remain silent," he

Dastardly strike

As terrorists kill seven people in Central Kashmir, concerns grow over the effectiveness of security measures

disturbing pattern of targeted violence has resurfaced in Jammu and Kashmir, with seven killed in a cowardly terrorist attack. The people killed were part of the con-Seven Killed in a cowaruly terrorist attack. The people struction team working on the Z-Morh tunnel, which connects Gagangir to Sonamarg in Central Kashmir's Ganderbal district. Yet another bomb blast occurred in the capital though no one was injured, which raises concerns about potential coordination between terrorist groups and the spread of violence beyond the Valley. While there is no direct evidence linking the incidents, the possibility of a broader security threat cannot be ignored. This latest attack is part of a troubling trend of escalating violence against migrant workers in the region, marking the fifth such incident this year. The recent killings underscore a persistent threat to life in Kashmir. This latest tragedy follows a series of deadly incidents in the Valley. The recent wave of terrorist attacks exposes critical vulnerability of security apparatus. While authorities, including J and K Chief Minister Omar Abdullah



and Lieutenant Governor Manoj Sinha, have condemned these acts and pledged to bring the perpetrators to justice, the recurrent nature of these attacks reveals deeper challenges in counter-terrorism measures and security protocols. The targeted nature of these attacks suggests a deliberate strategy to instill fear among migrant workers and disrupt ongoing development projects. By targeting migrant labourers involved in infrastructure work, terrorists aim to deter economic activities that could stabilise the region. These incidents not only hamper development but also erode the confidence of workers who play a crucial role in key infrastructure projects. Moreover, the attacks signify a broader

attempt to undermine the relative peace that has been maintained in recent years. Despite heightened security measures and the presence of the military in sensitive areas, the perpetrators have managed to carry out attacks on civilians, highlighting significant intelligence gaps and the ability of militants to exploit weaknesses in the security grid to target rather easy groups. A comprehensive review of security measures in Jammu and Kashmir is urgently needed. While military action remains essential, it needs to be complemented by robust intelligence gathering, better coordination between different security agencies and community-based approaches to countering extremist elements. The current situation also points to the need for upgrading the security apparatus around camps housing migrant workers and ensuring that projects with a high number of migrant labourers receive adequate protection. Another pressing issue is the socio-political narrative surrounding such incidents. There is a need for a unified political strategy that addresses not only the immediate security concerns but also the long-term socio-economic challenges that contribute to unrest. Investing in local economic opportunities, countering extremist ideologies through educational initiatives and strengthening intelligence network can make a lot of difference.

Global Hunger Index: Misleading metrics




The accuracy and intent behind GHI rankings are suspect. Does the GHI truly reflect India's reality, or is it a motivated attempt to malign India's image?

he recent Global Hunger Index (GHI) report, which places India at a dismal 105th position out of 127 countries, has raised eyebrows and sparked considerable debate. While hunger and malnutrition remain pressing global issues, the methodology and conclusions of the GHI, co-authored by two non-governmental organisations-Irish-based Concern Worldwide and German Welthungerhilfe—have drawn criticism, particularly from the Indian government and sections of society.

There is a growing concern that such reports may not just reflect statistics but also carry political and geopolitical undertones aimed at tarnishing India's image on the world stage. The GHI is based on four key indicators: the prevalence of undernourishment, child wasting, child stunting, and child mortality. The scores from these factors are compiled to place countries on a scale from zero (no hunger) to 100 (extreme hunger), with countries scoring closer to zero seen as having little or no hunger issues. India's score of 27.3 puts it in the "serious" hunger category, alongside 42 other countries. Critics of the GHI have raised several concerns about the methodology used in calculating India's score

Firstly, the reliance on child mortality and child stunting indicators as primary components of the hunger index is problematic. India is a country with a large population, and while child malnutrition is a valid concern, this issue is not unique to India but rather shared by other develop-ing countries. By focusing heavily on this aspect, the report seems to disproportionately penalise India. Additionally, the GHI report uses outdated data from global sources such as the World Health Organisation and the Food and Agriculture Organisation (FAO). India, like many countries, has been undergoing significant improvements in food security through government initiatives such as the National Food Security Act, the Midday Meal Scheme, and public distribution system reforms.



By positioning India in such a negative light, the report seems to overshadow the country's genuine achievements. India's economy is among the fastestgrowing in the world, and its agricultural output has been consistently high. The country's food production is more than sufficient to meet the needs of its population. India has become a net exporter of food grains and has successfully launched programs to improve access to food for its vast population. Given this backdrop, how can India be ranked lower than countries facing severe internal strife, economic collapse and war, such as Afghanistan or even smaller nations like Bangladesh and Nepal?

It's essential to question the intentions behind these rankings. Are they an honest reflection of hunger, or do they serve other interests? Reports like the Global Hunger Index can have far-reaching consequences, not just for the countries they assess but also for

global perceptions.
The fact that the organisations behind the GHI-Concern woriawiae Welthungerhilfe (German) hail from Western countries has not gone unnoticed. It rais-However, these efforts do not es the question of whether the

index is truly impartial or if it subtly reflects geopolitical biases. India has made significant strides in addressing hunger and malnutrition, but it seems that these efforts are often ignored or underplayed by such indices. For instance, the Pradhan Mantri Garib Kalyan Anna Yojana, which provided free food grains to over 80 crore people during the COVID-19 pandemic, is one of the world's largest food security initiatives. The fact that India could provide this level of support during a global crisis contradicts the narrative of widespread hunger and undernourishment. To deny that hunger exists in India would be dishonest, but the situation is far more complex than a single ranking can capture. Hunger is not a static issue; it is deeply intertwined with poverty, access to education, healthcare, and infrastructure.

The Indian government has been tackling these root causes of hunger through a multipronged approach that includes social welfare schemes, employment generation programmes like MGN-REGA, and nutrition programs targeted at women and

Programmes such as the Integrated Child Development Services (ICDS) aim to provide supplementary nutrition to millions of pregnant and lactating women, along with children under six years of age.

Meanwhile, the Midday Meal Scheme, which serves nutritious meals to school children, has had a significant impact on reducing malnutrition. Despite these efforts, it is undeniable that India still

faces challenges. The legacy of poverty, the vast size and population of the country, and regional disparities make it difficult to eliminate hunger overnight. The concerns raised by the Indian government about the Global Hunger Index are not without merit. The index, while claiming to provide an objective measure of hunger, fails to capture the ground realities of individual nations. India, being the second-most populous country in the world, is bound to face issues that smaller nations with more homogeneous populations do not.

By painting India as a country where hunger is rampant, the GHI risks creating a false narrative that undermines the substantial progress made by the country. It also risks discouraging the efforts of those working tirelessly on the ground to ensure that no one goes to bed hungry.

What is needed is not biased rankings or politically motivated reports but genuine collaboration between nations to tackle the global hunger crisis. As we reflect on the GHI, one thing is clear: statistics alone do not tell the whole story.

Unlocking the full potential of GatiShakti



The PM GatiShakti initiative is revolutionising India's infrastructure by integrating digital planning tools to expedite project completion and improve multimodal connectivity

ccording to the Secretary of the Department for Promotion of Industry and Internal Trade (DPIIT), Amardeep Singh Bhatia, as many as 208 big-ticket infrastructure projects including roads (101), railways (73), urban development (12) and oil and gas (4) worth Rs 1539,000 crore have been recommended for approval under the PM GatiShakti initiative so far. These projects have been recommended by an inter-ministerial group known as the Network Planning Group (NPG) constituted under the PM GatiShakti National Master Plan (NMP). Launched in October 2021, the PM Gati Shakti NMP is a transformative Rs 100 lakh crore initiative aimed at revolutionising the infrastructure in India over the next five years.

Its vision is to create a world-class integrated infrastructure that improves the ease of living, boosts economic growth and makes Indian businesses more competitive. It does so by expediting project completion, reducing timelines, enhancing multimodal connectivity, boosting efficiency across sectors, benefiting logistics (a jargon for handling, storage and transportation) creating jobs and fostering innovation. How does it work? The PM GatiShakti NMP has been developed as a Digital Master Planning tool. It works on a dynamic Geographic Information System (GIS) platform wherein data on specific action plans of all the 16 Ministries/Departments dealing with infrastructure sectors as well as of the States have been incorporated within a comprehensive database.

The NMP portal has over 1,600 layers of geospatial data, showing all physical and social infrastructure of an area viz land, ports, forests, and highways and so on. The NMP revolves around seven primary sectors that are fundamental to economic growth and ensuring seamless connectivity. These sectors are roads, railways, ports, airports, mass transport, waterways and logistics infrastructure.

These are further supported and complemented by sectors like energy (all fuels such as petrol, diesel, ATF, natural gas and power etc) transmission, IT communication, bulk water and sev erage, and social infrastructure. The inter-ministerial NPG has representations from the connectivity infrastructure ministries/departments, involving their heads of network planning division to ensure unified planning and integration of the proposals.

The NPG meets every fortnight and appraises infra projects to ensure multi-modality (a term used to connote several different modes of transportation to get cargo from the factory/port/warehouse to a client's front door), synchronisation of efforts, and comprehensive development in and around the project location. All logistics and connectivity infrastructure projects worth over Rs 500 crore are routed through the NPG. The NPG's approval is required even before making a DPR (Detailed Project Report) at the planning stage. Thereafter, the project follows the normal procedure of approval by the Public Investment Board (PIB) or Department of

Put simply, NMP provides on a centralised portal, a 360-degree view of all the existing projects/initiatives, those under implementation as well as projects under planning stage across all ministries and departments and offers visibility into all critical data relevant to efficient planning and execution. It helps in the identification of critical gaps in infrastructure, helping to select the most efficient routes for transportation, reducing costs, and minimising delays.
As many as 156 gaps in infra-

structure to ports and for movement of bulk commodities like coal, cement, fertilisers and food grains, have been identified for intervention under the PM GatiShakti initiative.

The plan also helps in prioritising projects more effectively by leveraging cross-sector interactions, ensuring that the ministries work in harmony to align the projects and allocate resources optimally - based on national priorities – avoiding duplication and redundancies. The upfront approval by the NPG even before the ministry prepares the DPR can help it in making the RIGHT choices, prevent delays and avoid colossal wastage of resources that were germane to the earlier dispensations when the ministries and departments were working in silos - in an uncoordinated manner - unaware of the happenings and work in progress in other departments and bereft of the crucial data on KEY parameters. The PM GatiShakti is a robust system working on real realtime basis in a dynamic framework to guide project planning and execution (monitoring through satellite imagery ensures that the ministries can track progress and make necessary

adjustments to keep projects on schedule).

The phenomenal increase in the capacity in all crucial areas such as ports, airports, railways, highways, roads and so on is a testament to the success of efforts made under PM GatiShakti. But, we have a long way to go

The target of Rs 100 lakh crore investment for building the infrastructure over five years was set by Finance Minister Nirmala Sitharaman in her maiden Budget for 2019-20 (out of this, 39 per cent or Rs 3900,000 crore was to come from the Centre and an equal amount from States and the balance Rs 2200,000 crore from the private sector).

Against this, the investment covered under PM GatiShakti is Rs 1539,000 crore which is just about 15 percent. Even when we take this as a proportion of the investment commitment by the Centre (presumably all projects under PM GatiShakti are centrally sponsored), this works out to 40 per cent. As for the States, they are far behind in meeting their overall investment target of Rs 3900,000 crore.

And, very few of them such as Uttar Pradesh, and Gujarat have boarded the PM GatiShakti plat-

The platform by ensuring visibility, identification of bottlenecks and better coordination can help expedite approvals but it can't be a substitute. The approvals have to be given by the concerned authorities at the central and State levels. Here, projects face long delays especially when it comes to getting environmental and land clearances.

Local protests exacerbate the delays. 'Working in silos' syndrome doesn't go away just because Modi has given a platform to the bureaucrats in various Ministries to sit together and thrash out issues.

Sticking to their stance, especial-

ly when it comes to staking their claim to resources (such conflicts are seen more in major projects like roads and railways) often leads to delays. Further, a lack of coordination with the states, as seen in the Sagarmala and Bharatmala projects, has led to slower progress.

Outdated or incomplete data is a major bottleneck. For instance, while land records are digitised in 13 states, the rest lag. This hampers the implementa-

tion of projects in states where land records are not digitised as well as roads/highways projects, power transmission lines, and oil and gas pipelines passing through these states.

Even as the PM GatiShakti platform allows for real-time tracking, the authorities don't always make project updates regular, which delays completion. This is particularly true of rural road projects in many districts leading to slow progress.

The investment by the private sector is nowhere near the target of Rs 2200,000 crore set b Sitharaman. In the roads/highways sector, even as the government has asked private players to come under public-private partnerships (PPPs) mode, the latter's response isn't encouraging leaving it to the former to take on the load.

The bottlenecks lead to continuing project delays and cost overruns which cause high tariff/service charges across all sectors highways, railways, ports, airports, power transmission, fuel transportation etc.

These come in the way of making Indian businesses more competitive and ease of living for the common man. All Stakeholders particularly the States should work to surmount the bottlenecks to enable PM GatiShakti to deliver its full potential.

institution within the country, but it is not powerful enough to impose its will on Hezbollah or defend Lebanon from Israel's invasion. The army has largely kept to the sidelines as Israel and Hezbollah have traded blows over the past year.

Pak limits Chief Justice's term to 3 years

Following an overnight $oldsymbol{\Gamma}$ debate, Pakistan's National Assembly passed the controversial judicial amendment bill early on Monday, capping the chief justice's tenure to three years. The National Assembly passed the 26th Constitution Amendment Bill, which the opposition alleges is aimed at watering down the powers of the independent judiciary, at 5 am with 225 members in the 336-member house supporting

The Pakistan Tehreek-e-Insaf (PTI) and the Sunni-Ittehad Council (SIC) opposed the amendment, but six independent members who held their seats with the support of the PTI supported the bill.

The government needed 224 votes to pass the amendment. The Senate on Sunday night voted 65-4 to approve the amendment with the required two-thirds majority. The ruling coalition needed the support of 64 members in the upper house of the parliament.

Following its passage in both Houses of Parliament, the

Constitution (Twenty-Sixth Amendment) Act, 2024 will now be sent to the president for assent under Article 75 of Pakistan's Constitution and become law after his signatures. The bill, comprising a set of constitutional amendments, including a special commission to appoint a chief justice out of three senior-most judges of the Supreme Court, was approved by the cabinet on Sunday with a consensus among the ruling coalition partners.

Law Minister Azam Nazeer Tarar who presented the bill in the Senate said the 'new-face' commission would consist of the Chief Justice, four seniormost Supreme Court judges, two senators and two national assembly members — one of each from the opposition.

He said the changes would help expedite the dispensation of justice by the apex court.

The amendment blocked the automatic rise of the seniormost Supreme Court judge to the post of chief justice after the incumbent CIP retired. Speaker Ayaz Sadiq presided over the proceedings in the National Assembly According to a statement from

the Prime Minister's Office (PMO), Prime Minister Shehbaz Sharif has signed the advice for President Asif Ali Zardari to ratify the 26th constitutional amendment.

Following the bill's passage, Shehbaz said in the parlia-ment: "Today's amendment, the 26th, is not just an amendment, but an example of national solidarity and consensus. A new sun will rise, emanating across the nation."

The opposition alleged the entire exercise was aimed at blocking Justice Mansoor Ali Shah's appointment from becoming the chief justice on the retirement of current CJP Qazi Faez Isa on October 25. PTI leader Hammad Azhar termed the amendment "a death blow to the indepen-dence of the judiciary", and explained how giving the power to appoint judges to the apex court and high courts to the government would politicise the judiciary.

Seoul wants N Korean troops to leave Russia

South Korea on Monday demanded the immediate pullout of North Korean troops allegedly deployed in Russia as it summoned the Russian ambassador to protest deepening military cooperation between Pyongyang and Moscow

South Korea's spy agency said Friday it had confirmed that North Korea sent 1,500 special operation forces to Russia earlier this month to support Moscow's war against Ukraine. Ukrainian President Volodymyr Zelenskyy earlier said his government had intelligence that 10,000 North Korea soldiers were being prepared to join invading Russian forces.

During a meeting with Russian Ambassador Georgy Zinoviev, Vice South Korean Foreign Minister Kim Hong Kyun "condemned in the strongest terms' North Korea's troop dispatch that he said poses "a grave secu-

rity threat" to South Korea and programs in return for the the South Korean Foreign Ministry said in a statement.

Kim said that South Korea in collaboration with the international community will mobilise all available means to deal with an act that threatens its vital national security interests. Zinoviev replied he would relay South Korea's position to his home government, according to the South Korean statement.

The Russian Embassy quote Zinoviev as saying that the Russian-North Korean cooperation is conducted in accordance with international laws and is not aimed against the security interests of South Korea.

The US and NATO haven't confirmed that North Korean troops were sent to Russia. But the reports of their presence have already stoked concerns in South Korea that Russia might provide North Korea with sophisticated technologies that can sharply enhance its nuclear and missile

North Korea's advancing nuclear arsenal is a major security threat to South Korea, North Korean leader Kim Jong Un recently took steps to permanently terminate all relations with South Korea and threatened to use nuclear weapons preemptively Some observers say South Korea will likely consider supplying weapons to Ukraine if Russian transfers of high-tech nuclear and missile technologies to North Korea are verified South Korea has joined US-led

sanctions against Moscow over its invasion of Ukraine in February 2022. But it hasn't directly provided arms to Kyiv, citing a longstanding policy of not supplying weapons to countries actively engaged in con-

Russia has earlier denied using North Korean troops in its war with Ukraine. North Korea's state media hasn't commented on the matter.

Temple being reconstructed after 64 years in Pak's Punjab

re-construct a Hindu temple in the Punjab province of Pakistan marking the first phase of restoration 64 years after it was rendered dysfunctional, a media report said on Monday.

The Evacuee Trust Property Board (ETPB), the federal body overseeing minority worship places in Pakistan, has started the construction of the Baoli Sahib temple in Zafarwal town of Narowal, a city on the western bank of river Ravi in Punjab, after the place of worship was rendered dysfunctional in 1960,

Dawn News reported. Currently, there is no Hindu temple in Narowal district, forcing the Hindu community to perform their religious rituals at home or travel to temples in

Sialkot and Lahore. Ratan Lal Arya, former president of the Pak Dharamsthan Committee, said the ETPB's control over the Baoli Sahib temple rendered it non-functional

and the Hindu community, A budget of Pakistani Rs 10 which numbers over 1,453 in

place for worship. After the establishment of Pakistan, the Narowal district had 45 Hindu temples but all of them have over time fallen into disrepair.

For the past 20 years, the Pak Dharamsthan Committee has advocated for the restoration of Baoli Sahib temple, Arya said. The government has taken steps to restore the temple to address Hindu community demands, he said.

The ETPB is overseeing the construction at the four kanals of land where the boundary wall is the priority. Once completed, the temple will be handed over to the Pak Dharamsthan

Committee. Shoaib Siddal, chairman of the One Man Commission of the Supreme Court, and Manzoor Masih, member of the National Commission of Human Rights, have played pivotal roles in this restoration effort.

President Muizzu introduces UPI payment service to boost economy

Mohamed Muizzu has taken "necessary steps" to introduce India's Unified Payments Interface (UPI) in the archipelago nation, slated to benefit the Maldivian economy substantially.

Developed by the National Payments Corporation of India (NPCI), UPI is an instant realtime payment system for facilitating inter-bank transactions through mobile phones. Muizzu on Sunday set up a consortium to introduce UPI in

the country and appointed Maldives TradeNet Corporation Limited as its leading agency, according to a press release by the President's Office. The president also suggested the participation of the country's banks, telecom companies, state-owned companies and fintech companies in the consortium.

He "decided to take the necessary steps" on the recommen-

"This move is expected to bring significant benefits to the Maldivian economy, including increased financial inclusion, improved efficiency in financial transactions, and enhanced digital infrastruc-

ture," it said.

Muizzu also constituted an inter-agency coordination team comprising the Ministry of Finance, the Ministry of Homeland Security and Technology and the country's Monetary Authority to lead the Ministry of Economic Development and Trade in overseeing the establishment of the UPI in the Maldives.

The agreement to introduce UPI in Maldives was signed during External Affairs Minister S Jaishankar's threeday official visit to the country in August.

Earlier this month, dollarstarved Maldives floated a new foreign currency regulation,

Subianto swears in Indonesia's largest Cabinet since 1966, with 109

Newly President inaugurated Prabowo Subianto swore in Indonesia's largest Cabinet since 1966 on Monday, with 109 members representing his pledge for a

strong government. He announced the lineup late Sunday and named his Cabinet of ministers, vice ministers and head of national agencies the "Red and White Cabinet," referring to the colours of Indonesia's flag.

Subianto became the eighth president of Southeast Asia's largest economy on Sunday. The Cabinet of Subjanto's predecessor, Joko Widodo, had 34 ministers and head of government agencies. Subianto's Cabinet is the largest since 1966 when Indonesia's first President Sukarno formed a lineup of 132 ministers in an extremely tense political situ-

ation after a failed 1965 coup.

The so-called Dwikora Cabinet 2 was dismissed a month later. Subianto has said earlier that he needs a strong administration, even though analysts said that his "fat" Cabinet would bloat

the bureaucracy. "I want to create a strong government that would unite our multicultural society and diverse political interests," Subianto said before inviting more than 100 people for interviews at his residence last week. "It must be a big coalition, and

some will say my Cabinet is fat." The Cabinet features politicians from a coalition of seven parties who supported his victory in the February election, and figures allied with Widodo's Cabinet, who were reappointed to continue their jobs under Subianto's presidency. Analysts said the move was a political reward to Widodo for the latter's tacit support in the election.

Subianto was sworn in with his

new vice president, 37-year-old Surakarta ex-Mayor Gibran Rakabuming Raka. He chose Raka, who is Widodo's son, as his running mate, with Widodo favouring Subianto over the candidate of his own former party. The former rivals oecame tacit allies, even though Indonesian presidents don't typically endorse candidates. Subianto was a longtime rival of the Widodo, who ran against him for the presidency twice and refused to accept his defeat on both occasions, in 2014 and 2019. But Widodo appointed Subianto as defence chief after his reelection, paving the way for an alliance despite their rival political parties. During the campaign, Subianto ran as the popular outgoing president's heir, vowing to continue signature policies like the con-

struction of a multibillion-dol-

lar new capital city and limits

on exporting raw materials

intended to boost domestic

industry

Backed by Widodo, Subianto swept to a landslide victory in February's direct presidential election on promises of policy continuity.

Subianto reappointed nearly half of Widodo's Cabinet members, including Finance Minister Sri Mulyani Indrawati, making her the first person to hold the ministry under three different presidents.

Indrawati, 62, who has served as the executive director of the International Monetary Fund and managing director of the World Bank, is one of Indonesia's longest-serving finance ministers, having held the post for long stretches under Presidents Susilo Bambang Yudhoyono and Joko

Widodo. She has earned considerable respect in international circles, particularly for her reforms of the chaotic Indonesian taxation system and her role in steering

Indonesia through the global financial crisis and the COVID-19 pandemic. "We regularly consulted with

each other to discuss strategies for strengthening the Finance Ministry and the state finances to support his programmes," Indrawati told reporters after meeting with Subianto last Other ministers from Widodo's

Cabinet include Interior Minister Tito Karnavian, Trade Minister Zulkifli Hasan, Energy Minister Bahlil Lahadalia and State-Owned Enterprises Minister Erick Thohir. Subianto has announced an

ambitious goal of increasing annual economic growth to 8% by the end of his five-year term, and embarking on an ambitious spending programme, including an increase in defence spending, hikes in civil servants' salaries, and a programme to give 83 million children free meals.

'Gives us what you stole from us,' Australian senator yells at King Charles

An Indigenous senator told King Charles III that Australia is not his land and Prime Minister Anthony Albanese said the monarch is not needed as the country's head of state as the British royal visited Australia's parliament on Monday.

Indigenous independent Senator Lidia Thorpe was escorted out of a parliamentary reception for the royal couple after shouting that British colonisers have taken Indigenous land and bones.

'You committed genocide against our people," she shouted. "Give us what you stole from us — our bones, our skulls, our babies, our people.

You destroyed our land. Give us a treaty. We want a treaty." King Charles spoke quietly with Prime Minister Anthony Albanese while security officials stopped Senator Thorpe

from approaching.
"This is not your land. You are not my king," Thorpe yelled as she was ushered from the hall. Albanese, who wants the country to become a republic with an Australian head of state, also told the king it was time for his role to end

'You have shown great respect for Australians, even during times when we have debated the future of our own constitutional arrangements and the nature of our relationship with the Crown," Albanese said. But, he said, "nothing stands

Opposition leader Peter Dutton, who wants to keep the British king as Australia's monarch, noted that even supporters of a republic were honoured to attend a reception for the Charles and Queen Camilla at Parliament House in the capital Canberra.

People have had haircuts, people have shined shoes, suits have been pressed and that's just the republicans," Dutton quipped.

Australia's six state government leaders underscored the political divide on the country's constitutional relationship with Britain by declining invitations to attend the reception. All six would prefer an Australian citizen was

Australia's head of state. They each said they had more

pressing engagements on Monday, but monarchists agreed the royals had been snubbed.

Charles used the start of his

speech to thank Canberra Indigenous elder Auntie Violet Sheridan for her traditional welcome to the king and queen. "Let me also say how deeply I appreciated this morning's moving Welcome to Country ceremony, which offers me the opportunity to pay my respects to the traditional owners of the lands on which we meet, the Ngunnawal people, and all First Nations peoples who have loved and cared for this continent for 65,000 years," Charles "Throughout my life, Australia's centre-left Labour Party is re-First Nations peoples have done me the great honour of next year. sharing so generously their stories and cultures. I can only say how much my own experience has been shaped and strengthened by such traditional wisdom," Charles added.

Australians decided in a referendum in 1999 to retain Queen Elizabeth II as head of state. That result is widely regarded to have been the consequence of disagreement about how a president would be chosen rather than majority support for a monarch. Albanese has ruled out holding

another referendum on the subject during his current three-year term in govern-ment. But it is a possibility if his

Charles was drawn into Australia's republic debate months before his visit.

The Australian Republic Movement, which wants Australia to sever its constitutional ties with Britain, wrote to Charles in December last year requesting a meeting in Australia and for the king to advocate their cause.

Buckingham Palace politely wrote back in March to say the king's meetings would be decided upon by the Australian government. A meeting with the ARM does not appear on the official itinerary. "Whether Australia becomes a

republic is ... a matter for the

Australian public to decide," the Buckingham Palace letter said. Earlier Monday, Charles and Camilla laid wreaths at the Australian War Memorial then shook hands with well-wishers

Attack on Trump was preventable, finds House panel report

AP WASHINGTON

The assassination attempt against former President Donald Trump at a Pennsylvania rally in July was "preventable and should not have happened," according to a bipartisan House panel that is investigating the shooting and what it calls the "stunning security failures" at the event The report from a House task force, released Monday, is just the latest look at the cascading and wide-ranging law enforcement failings that preceded the July 13 shooting at the Butler, Pennsylvania, rally where Trump was struck in the ear by gunfire. One rallygoer was killed in the shooting and two others were wounded.

Members of both the House and Senate have repeatedly questioned why the Secret Service, an agency tasked with protecting the country's top leaders, didn't do a better job communicating with local authorities during the campaign rally, particularly when it came to securing the building that was widely agreed to be a security threat but that ultimately was left so unprotected that gunman Thomas Matthew Crooks was able to climb up and shoot.

Lawmakers in their report focus on "the fragmented lines of communication and unclear chains of command' between Secret Service and Pennsylvania state and local police but place the majority of the blame on the Secret

Service for the security break-

"Federal, state, and local law enforcement officers could have engaged Thomas Matthew Crooks at several pivotal moments," the report stated.

Lawmakers added that throughout the afternoon, "as Crooks's behaviour became increasingly suspicious, fragmented lines of communication allowed Crooks to evade law enforcement" and climb onto the unsecured roof where he would eventually open fire. "Put simply, the evidence obtained by the Task Force to date shows the tragic and shocking events of July 13 were preventable and should not have happened," the report

Moldovans secure country's path toward EU membership

m oldovans}$ voted by a razorthin majority in favour of securing the country's path toward European Union membership, electoral data showed Monday, following a ballot that nearly caused a major setback for the pro-Western president, who accused "criminal groups" of trying to undermine the vote. With 99.41% of the 1.4 million votes counted in the EU referendum held Sunday, the "Yes" vote stood at 50.39%, to 49.61% who voted "No," according to the Central Electoral Commission. The "No" vote had looked to be ahead right until the last few thousand votes were counted from the country's large diaspora. A loss would have been a political disaster for the pro-Western government, which strongly supported the pro-EU

"Criminal groups, working

together with foreign forces hostile to our national interests, have attacked our country with tens of millions of euros, lies and propaganda, using the most disgraceful means to keep our citizens and our nation trapped in uncertainty and instability," said President Maia Sandu after about 90% of the votes were counted. "We have clear evidence that these criminal groups aimed to buy 300,000 votes — a fraud of unprecedented scale," Sandu added. "Their objective was to undermine a democratic

The vote was held amid ongoing claims by Moldovan authorities that Moscow has intensified a "hybrid war" campaign to destabilise the country and derail its EU path. The allegations include funding pro-Moscow opposi-tion groups, spreading disinfor-mation, meddling in local elections and backing a major votebuying scheme.

In Brussels, the European Union's executive branch, the European Commission, said that its services had also noted Russian interference in Moldova, and it underlined its continued support for Moldova on its EU accession This vote took place under

unprecedented interference and intimidation by Russia and its proxies, aiming to destabilize the democratic processes in the Republic of Moldova," spokesperson Peter Stano said. Stano told reporters that allega-

tions of vote buying, the bussing of voters and disinformation are only the most recent forms of Russian interference, and that attempts to undermine Moldova and its support for the EU have been going on for months.

In the presidential race that was held at the same time, Sandu won the first round with 42% of the vote in a field of 11, but failed to win an outright majority. She will

face Alexandr Stoianoglo, a Russia-friendly former prosecutor general who outperformed polls with around 26% of the vote, in a runoff on Nov 3. By the time polls closed at 9 pm

Sunday, more than 1.5 million voters - about 51% of eligible voters - had cast ballots, according to the Central Electoral Commission. Cristian Cantir, a Moldovan

associate professor of international relations at Oakland University, told The Associated Press that polls might have "overestimated the pro-EU feeling" inside Moldova, which would have failed to pass without votes from outside the country. "It's going to be particularly

problematic because ... it's going to feed into narratives that are pushed by the Kremlin and pro-Russian forces," he said.

US national security spokesman John Kirby echoed Russian interference concerns this week, say-

ing in a statement that "Russia is working actively to undermine Moldova's election and its European integration." Moscow has repeatedly denied it is inter-

fering in Moldova. In early October, Moldovan law enforcement said it had uncovered a massive vote-buying scheme orchestrated by Ilan Shor, an exiled pro-Russia oligarch who currently resides in Russia, which paid 15 million euros (\$16.2 million) to 130,000 individuals to undermine the two ballots.

Shor was convicted in absentia last year of fraud and money laundering and sentenced to 15 years in prison in the case of \$1 billion that went missing from Moldovan banks in 2014. He denied the allegations, saying the payments were legal and citing a right to freedom of expression. Shor's populist Russia-friendly Shor Party was declared unconstitutional last year and banned.

Indian apparel exporters to post 9-11 per cent revenue growth

▼ndian apparel exporters are Lexpected to register a 9-11 per cent revenue expansion in FY25 aided primarily by gradual liquidation of retail inventory in key end markets and a shift in global sourcing to India, ratings agency ICRA on Monday.

The long-term prospects for Indian apparel exports are favourable, aided by product enhanced acceptance in end markets, evolving consumer trends and a boost from the government in the form of the production-linked incentive (PLI) scheme, export incentives, the proposed free trade agreement with the UK and

said in a statement. The expected growth this fiscal follows a tepid performance in FY24 when exports were affected because of high retail inventory, sluggish demand from the key end markets, supply chain issues, including the Red Sea crisis and heightened competition from neighbouring countries, it added.

the EU, among others, ICRA

With the revival in demand, ICRA said it expects the capex spending to increase in FY2025 and FY2026 and may stay in the range of 5-8 per

cent of the turnover. After a marginal decline (down 2 per cent) in FY24, Indian apparel exporters are estimated to report a 9-11 per cent revenue growth in FY25, benefitting from derisking strategy adopted by customers and replenishment of retail inventory in key end markets, especially the US and the EU regions," ICRA Senior Vice President & CoGroup Head Corporate Ratings Krishnamurthy said.

Nevertheless, challenges around demand uncertainty persist in a few key markets amid a subdued m a c r o e c o n o m i c environment and geopolitical

"Despite the revenue growth, associated operating leverage benefits and softer raw material prices, the industry's operating margins are expected to contract by 30-50 bps on a YoY basis in FY25 with increasing labour costs, freight costs and rise in

Krishnamurthy added. ICRA said the recent geopolitical tensions in Bangladesh could result in capacity additions outside the country, including India. Yet, availability of labour at competitive costs and preferential duty access given its least developed country status for another two years on exports to the US and the EU help Bangladesh to remain competitive against most other developing countries, it added.

'Apart from the benefits to be derived from the fresh capacity additions under the PLI scheme.

PM Mega Integrated Textile Region and Apparel scheme is expected to strengthen India's presence in the global apparel trade by providing scale benefits and strengthening the country's presence in the man-made fibre value chain," Srikumar

ICRA anticipates the culmination of these schemes to enable Indian apparel exporters to increase their share of the pie in the global apparel trade, he added.

Insurance regulator Irdai has directed two insurers to carry out audits of their IT systems following concerns over the recent instances of policyholders' data leaks.

The regulator is also in touch with their management to address the vulnerabilities. Without naming the insurers,

the Insurance Regulatory and Development Authority of India (Irdai) said it takes data breaches very seriously and asserted that it will continue to engage with the companies to ensure that the policyholders' interests are that the

fully protected. Star Health Insurance had recently admitted data breach. The name of the

second insurer could not be immediately ascertained. "There have been reports of data leaks from two Insurers

recently," the regulator said. closely monitoring the situation in the case of the concerned insurers and has been in touch with their management.

Regular updates are being obtained to ensure that the policyholders' data and interests are fully protected and the company is taking all steps to arrest the threat posed by this breach, the regulator said.

Irdai said it will continue to engage with the insurance companies to ensure that the policyholders' interests are fully protected.

"The concerned insurers have been instructed to appoint an independent auditor to undertake a comprehensive audit of the company's IT landscape with the aim that there are no vulnerabilities and the IT system are adequate to meet the scale and complexities of their operations," the release said. NCLAT upholds order to allow govt to takeover Delhi Gymkhana Club's management

A ppellate tribunal NCLAT has upheld an order to allow the central government to take over the management of the prestigious Delhi Gymkhana Club.

The National Company Law Appellate Tribunal (NCLAT) set aside the petition filed by the erstwhile management members against the order passed by the Principal Bench of the NCLT.

On April 1, 2024, the NCLT allowed the plea filed by the Ministry of Corporate Affairs for taking over the Delhi Gymkhana management citing

'violations" of the Company Law and said there was "sufficient material" for holding that, as it is a case of mismanagement.

In its 149-page order, the NCLT had also allowed the persons as directors on the club's general committee as well as manage the affairs of the club.

The said order challenged before appellate tribunal, which has been now upheld on Monday by a two-member bench, comprising Chairperson Ashok Bhushan and Member Arun Baroka.

However, the NCLAT bench also also directed the government to carry out all remedial measures as mandated by the NCLT, by March 31, 2025.



The committee has further been directed to conduct an election at the club three months after March 31, 2025. The order was pronounced in the open court on Monday morning and a detailed order is still awaited. "The NCLAT upheld the

holding that Union of India's intervention in the affairs of the Delhi Gymkhana Club was Gymkhana necessitated in view of the mismanagement by the erstwhile general committee. The current committee has been asked to take necessary remedial measures by 31st March and conduct elections thereafter," said Advocate Raunak Dhillon, who appeared for the Central government.

Institutional investments in the Indian real estate sector increased 31 per cent year-onyear to USD 4.61 billion in January-September strong consumer amid demand, according Vestian.

Real estate consultant Vestian on Monday released its report on 'Investment in Indian Real Estate', observing that funds' inflow from institutional investors in the first nine months of 2024 surpassed the total for 2023. "Investors have shown confidence in India's growth

story on the back of robust GDP growth. As a result, the real estate sector witnessed increased participation from foreign investors which led to institutional investments touching a billion mark in Q3 2024," Shrinivas Rao, CEO of Vestian said.

He noted that domestic investors are also actively participating, supported by the rapid infrastructure development across country.

During the latest July-September institutional investments in real estate rose 41 per cent to USD 960.8 million from USD 679.9 million in the year-ago period. The inflow however fell

sharply from June quarter that saw an investment of USD 3,116.3 million.

'Amid prevailing geopolitical challenges, India's robust economic growth continues to attract both foreign and domestic investors. Rising prominence of wo office policies and growing office markets are expected to boost investor confidence, setting a positive tone for coming quarters," Vestian said.

Despite this significant quarterly decline of 69 per cent, the consultant said that the outlook remains positive. Chennai received the highest investments during Q3 2024 with 48 per cent share. According to Romer, India needs to decide.

Does it wants to be on the side of the empire or wants to stand up for the importance of the sovereign state as the organising principle going forward in the world.
"India should be able to say we

don't like empires. India's stand could decisively tip the balance," he said.

Emaar India to invest ₹ 2,000 cr in Mumbai region

UAE-based developer realty Emaar planning to invest up to Rs 2,000 crore in Mumbai and its surrounding areas in the next six-seven years, a top official said on Monday.

The group, known for projects like Burj Khalifa, has stayed away from the Mumbai Metropolitan Region (MMR) despite being present in India for nearly two decades. Emaar India's Chief Executive

Kalyan Chakrabarti said there is no specific reason to stay away from Mumbai for so long. He added that the group is attracted to the megapolis because it considers it as the deepest and strongest realty market which will be vibrant for decades to come.

The company is aware about the market realities in the space-crunched city, and is open for looking at both societies and redevelopments along with any fresh development proposals, he said. The company plans to invest



15,500 crore) in realty developments across the country in the same time period, he said, adding that capital is not a constraint for it given the backing of a parent company willing to invest. Therefore, it is not keen to

aggressively pursue opportunities on the capital markets, including an initial public offering or sponsoring a Real Estate Investment Trust (REIT).

Elaborating on strengths of Mumbai, Chakrabarti said Mumbai is home to one of the best talent bases in the country, neatly linked to the global trade and offers a great opportunity for realtors when infrastructure being created in the megapolis. The company will continue to

serve the mid-market to luxury opportunity in the financial capital as well, wherein an apartment unit will typically cost upwards of over Rs 4 crore, he said.

The Gurugramheadquartered company already has a presence across various other Indian cities including Hyderabad, Indore and Mohali.

Around 85 per cent of its revenues come from the residential segment while the commercial segment accounts for the rest at present, he said, adding that

the company will have over 8 million square feet of space under construction December, which will have to be delivered in four years. The company announced its

maiden venture into the Mumbai market, with a 84villa community in nearby Alibag, which is a weekend getaway for Mumbaikars. . Chakrabarti said

company will be investing Rs 400 crore for constructing the villas, which will be spread over 25 acres of land. He, however, did not disclose the cost of buying the land. Over three-fourths of the land

Time running out for Norris to catch Verstappen in F1 title chase as series heads to Mexico City

Time is running out on Lando Norris' Formula 1 title chase of Max Verstappen.

The Red Bull driver won the sprint race, then took the final podium spot in the Sunday main event when Norris was ed for leaving the track him in the final laps.

Verstappen is chasing a fourth consecutive season championship. Norris is trying to win his first, and Texas gave him another taste of just how hard, if not impossible, it can be to take the title from the Dutch driver.

Norris had the faster car in the late stages Sunday. He got stuck behind a stubborn Verstappen who refused to yield the place as the drivers battled over every inch of the track

When Norris finally made his move to third with about four laps to go, race stewards determined he improperly left the track to gain the position. He was given a five-second penalty. Norris crossed the finish line in third.

Officially, he was fourth and Verstappen took the final podium spot. The penalty and the head-to-head battle with Verstappen, left Norris

clearly frustrated. "He defends by going off-track, he overtakes by going off-track. But I'm not going to complain. Max drove well



and he defended well, we had a good race together. But the rules are the rules." Norris said.

At least he finished the race this time. When those two tangled in Austria, a late-race collision knocked Norris out of the race and dropped Verstappen from first to fifth

That tussle proved to be a taste of things to come.

Norris has been in a months-long charge after Verstappen, who hasn't won a grand prix since June after a dominant start to the season. Norris and Verstappen finished 1-2 in Singapore, but Norris won the race by 21 seconds just before the four-week autumn break. Red Bull and Verstappen appear to have

at least closed that gap.

Verstappen won the Texas sprint race for his first victory of any kind since the sprint race in Austria. And even if Sunday's finish had been reversed, Norris would have have come out of the weekend just a single point closer in the

championship. Yet Verstappen's weekend wasn't as good as he had hoped it would be. Red Bull brought a trove of upgrades to a car that Verstappen has alternately called "undrivable" and "a monster" this season.

The car looked good in the sprint and again in qualifying when Verstappen barely missed out on pole position, which Norris won.

But the sprint race victory proved a bit of a mirage. The Red Bull had nowhere near the pace of the Ferraris over a regular race distance, and was passed by Norris at the end.

It was still good enough to squeeze the title chase just a bit tighter. And Verstappen had no sympathy for McLaren's complaints Sunday about losing the podium.

"They complain about a lot recently." Verstappen said. "The battle with Lando at the end was cool as we were racing hard and it was actually a lot of fun. You cannot overtake outside the white line and I have lost a podium here for overtaking outside the track?

And he'll take any result that stretches his lead in the championship. "We are going in the right direction. It is still not enough," Verstappen said. "Ultimately the fact that we have extended the gap is the biggest thing for us.

Shami, who has not played since the ODI World Cup final last November, bowled full tilt in the nets after India's opening Test against New Zealand in Bengaluru on Sunday.

This was a few days after skipper Rohit Sharma revealed that he had swelling in his knees which has affected his rehabilitation from an ankle injury sustained last year.

"I am very happy with how I bowled yesterday. I was bowling from half run-up before that because I didn't want to take too much load. But yesterday, I decided to go full tilt, and I bowled at a 100 per cent," the 34-year-old told reporters on the sidelines of an event organised by Eugenix Hair Sciences.

"The result was good. I am 100 per cent pain-free. Everyone has been wondering for a long time about whether I will make it for the Australia series but it is still some time away." India are expected to leave for

Australia two weeks before the series opener in Perth beginning November 22, leaving Shami just about enough time to feature in two Ranji games for Bengal. Bengal take on Kerala at home

from October 26 before travelling to Bengaluru to face Karnataka from November 6. Is he ready for Bengal's next game?

I don't know if I can play the next match. But the day I feel I can bowl 20 to 30 overs, doctors give me the clearance, $\hat{\mathbf{I}}$ will go. I want to spend maximum time on ground

"I don't want that I clear fitness here in India and something happens there (in Australia). Ĭ want to be totally sure about my fitness before going there," said Shami, who was only part of the Adelaide Test on the previous Australia tour in 2020-21.
