WB Government passes anti-rape Aparajita Bill

n the backdrop of a Statewide agitation for justice for the Kolkata lady doctor who was raped and murdered early this month while on duty turning fast into a movement for "change of the a movement for "change of the system that harbours rapists and the corrupt," the Mamata Banerjee Government of Bengal on Tuesday got an anti-rape "Aparajita" Bill passed unanimously. This makes West Bengal first State to bring in amendments to Central laws dealing with such offences. such offences.

The Opposition parties, however, called it а diversionary tactics in order to contain the Statewide unrest and assuage peoples' anit-Government feelings. Notwithstanding stringent remarks from the Opposition Chief Minister Bench. Banerjee asked Mamata Opposition leader Suvendu Adhikari to help get the Bill signed by Governor CV Ananda Bose and President Droupadi Murmu. Apart from prescribing life imprisonment until death, the Bill, christened 'Aparajita

offender in cases of rape and sexual offences that lead to a victim's death or leave her in a vegetative state.

The Bill was passed at a time when citizens including medical staff of Kolkata formed a 17-km long human chain from Patuli in South Kolkata to Ultadanga in the North. The Bill was also passed when a separate detachment of junior doctors and members of the civil society staged a joint rally in front of the Lal Bazar police headquarters demanding the resignation of Police Commissioner

Vineet Goyal for failing to act in an impartial manner. Saying that rape was a "curse on the human society and that there was a need for social reforms to stop such crimes, the Chief Minister said that "the Bill seeks to plug the loopholes in the central legislation."

She also appealed to the Opposition BJP to get the Governor's assent "instead of politicising the issue," Leader of even as Opposition attacked the Government for supporting a system where rapes and murders had become the

order of the day. "It is your Government and the police that had investigated the infamous Kamduni rape case in such a manner that all the accused save one got acquitted and even the one who was not got his death sentence commuted to life sentence if this was not the result of the Government's apathy to such cases then what is ...

In Kamduni rape case the Government changed 16 Public Prosecutors to ensure that the rapists who were the members of the TMC get acquitted," Adhikari said.

Former president of Atlas Cycles Salil Kapoor allegedly committed suicide at his Lutyen's Delhi home on APJ Abdul Kalam Marg on Tuesday afternoon.

The 70-year-old man allegedly shot himself with his licensed pistol and was found dead on the ground floor of his three-storey house at around 1 pm. According to a senior police officer, his manager found his body lying in a pool of blood near the puja room of his home. A suicide note was recovered in which Kapoor mentioned the name of about four to five people accusing them of harassing him.

A¹⁹-year-old boy, studying in Class 12 in Haryana's Faridabad, was allegedly chased in a car and shot dead by a group of five cow vigilantes who mistook him for a cattle smuggler.

The victim was identified as Aryan Mishra. The members of vigilante group have been identified as Anil Kaushik, Varun, Krishna, Adesh, and Saurabh.

A Duster car in which the boy, Aryan, and his friends Harshit and Shanky as well as two other women seated in the back of the vehicle, was chased by the members of cow vigilante group on the night of August 23 for about 30 kilometres near Haryana's Gadhpuri on the Delhi-Agra National Highway.

During interrogation, the accused revealed that on the night of August 23, they had received information that some suspected cattle smugglers driving two SUVs were doing recce in the city. They mistook the victim and his friends, Shanky and Harshit, for those cattle smugglers and followed their or a conice poly of the state of the state. car, a senior police officer said.

According to sources, in its Central Election Committee (CEC) meeting on Monday evening, party leader Rahul Gandhi expressed interest in exploring the possibility of alliance with AAP for Assembly elections in Haryana.

Ironically, the State Congress leaders in Haryana have rejected the possibility of any alliance with AAP in the State. Recently, senior

Leader of Opposition in Lok Sabha and Congress MP Rahul Gandhi with party president Mallikarjun Kharge and party MP KC Venugopal during meeting with party secretaries and joint secretaries, in New Delhi, on Tuesday

Congress leader in Haryana, Kumari Selja ruled out the possibility of an alliance with AAP for the Assembly polls, saying her party is strong in the State and will fight the elections on its own.

Asked about the possibility of an alliance with AAP, AICC general secretary in-charge of Haryana Deepak Babaria said, "We are in talks with the AAP, but nothing has been finalised yet. As soon as something concrete emerges, we will inform you." Responding to another question, Babaria said, We have to defeat the BJP, and therefore are against allowing anti-BJP votes to be divided."

Meanwhile, AAP leader and Rajya

Sabha MP Sanjay Singh has

welcomed reports claiming Rahul has shown interest in an alliance with Arvind Kejriwal-led party in poll-bound Harvana.

Polling for 90 Assembly seats in Haryana will be held on October 5 and counting of votes will be undertaken on October 8.

The Congress's Central Election Committee had met on Monday and cleared the names of 34 candidates for the Assembly polls in Haryana. "Today, a meeting was held for Haryana by the CEC. A list of 49 names was presented by the State's screening committee, out of which 34 have been approved and decision on 15 is pending," Babaria had said last evening.

Asserts CM Majhi PNS BHUBANESWAR

In a significant shift from his earlier stance, Chief Minister Mohan Charan Majhi on Tuesday stated that the proposal for establishing a High Court Bench in western Odisha is "under consideration" by his government. This statement came a day

after he had informed the State Assembly that there was "no justification" for setting up a

High Court Bench in the State. Majhi asserted, "The issue of setting up a High Court Bench in western Odisha is under consideration of the government." His administration is dedicated to delivering speedy justice to the people, he added.

Opposition Biju Janata Dal (BJD) and Congress criticised Majhi for his conflicting statements.

BJP leader Jayanarayan Mishra, a veteran lawmaker from the western region, reiterated his party's demand for



a High Court Bench in western Odisha. "We (BJP) have not withdrawn the demand for a HC Bench in western Odisha. The CM referred to the Supreme Court judgment, but with the State's population and High Court cases increasing, why can't Odisha have a HC

Bench when a State like Uttar Pradesh has three?" Mishra questioned.

Balangir BJD MLA Kalikesh Singh Deo, who had raised the written question, expressed dissatisfaction with Majhi's response. "Today, the CM clarified that the matter is under consideration. He should provide an assurance on whether a Circuit or a Permanent Bench of the High Court will be set up in Balangir and specify a timeline," Singh Deo said.

that the Supreme Court had observed that the demand for a HC Circuit Bench had become obsolete with technological advancements, urging lawyers in Sambalpur to end their agitation, which turned violent in November 2022. "There was no verdict from the apex court against setting up a HC Bench. Technology is not a substitute for a second or Circuit Bench. Balangir has the first right for a Permanent Bench since it had one in the pre-Independence era," he

Singh Deo further noted added.

Locals on looting spree as 2 containers float near S'bhaya coast

For, two containers that they came across floating ashore had a huge stock of food and stationery items, which they looted to their heart's content

While two or three persons first saw the containers, soon there was a mad rush of locals as the news spread about the containers and the bounties they carried. The Baunsagadi river ghat witnessed a huge crowd of people falling upon one another to ferry the Patasala river to reach the Satabhaya coast to lay their hands on the goods from the containers.

First they were scared but later, on opening them they saw huge quantities of daily use items, including food stuffs, medicines, torch lights, umbrellas, cup plate sets, sarees, pants, shirts, chappals, mustard oil, biscuits, air bags, water bottles and several other items

Locals stated that while one container was floating near the coast, the other was located

fearing police action hid the goods they collected at a

nearby forest so as to collect them back at night.

It was known that the containers belong to ITT Lines Private Limited as the name of the company was written in them. ITT Lines Private Limited is a shipping company of Kolkota.

Kendrapada SP Siddharth Kataria said as Satabhaya comes under Rajnagar Police

station, he had directed the IIC of Rajnagar to rush to the spot to take stock of the situation.

The containers that drifted in Bay of Bengal and came ashore near Satabhaya might belong to a Mumbai-registered sunken cargo ship MV ITT Puma which was en route Port Blair from Kolkata with a carrying capacity of 75 metric tons. It sank around 80 km from Kolkata (70 nautical miles) south of Sagar Island due to inclement weather on August 25.

The Coast Guard personnel rescued 11 persons in a sea-air coordinated operation but three crew members were missing.

Rajnagar DFO Sudarshan Gopinath Jadav said, "We got information on Monday about the containers floating near Satabhaya coast. When the forest personnel reached the spot, the containers had

been broken open and many daily use items and food stuffs were looted by the locals residing near the Satabhaya coast. The Forest personnel seized the remaining items from the containers."

"I have written a letter to the Coast Guard and the SP, Kendrapada requesting to conduct an inquiry in this regard," said Jagdev.

Meanwhile, the forest personnel have been directed to conduct patrolling at the coast to ensure whether some other containers were floating ashore. Strict patrolling has been going on at the Baunsagadi ferry ghat to restrict the entry of public as it comes under Bhitarkanika





WHO issues first ever guidelines Centre in process of framing policy to balance salt intake on managing antibiotic pollution

World Health The ▲ Organization (WHO) has issued its first-ever guidelines on managing antibiotic pollution to address the global health threat posed by pharmaceutical waste from antibiotic manufacturing companies that has added the risk of antimicrobial resistance (AMR) or superbugs.

The guidance sets targets to mitigate risks of AMR and protect aquatic life from antibiotic contamination, addressing a largely unregulated issue where environmental emissions from pharmaceutical production often go unchecked.

The framing of guidelines is crucial in the context of India too, where active pharmaceutical ingredient (ÅPI) manufacturing poses significant environmental challenges. Wastewater from these plants frequently contains harmful byproducts that contaminate local water sources.

This pollution not only affects ecosystems but also public health by potentially spreading antibiotic resistance, which as per the WHO is a top 10 global public health threat. A study last year found that, in 2019, it was responsible for 1.27 million deaths.

Studies reveal that the most common antibiotics found in water sources include Sulfamethoxazole which has



been detected in 96 per cent of samples; analyzed Trimethoprim, frequently found in water sources and often present alongside sulfametĥoxazole while Ciprofloxacin is another commonly detected antibiotic. Additionally, various other antibiotics have been identified

in water sources, including tetracyclines, macrolides, fluoroquinolones, and beta-lactams.

This action comes in response to concerns that no



State in India is completely free from Iodine Deficiency Disorders (IDD), as reported by the Ministry in Parliament in 2022. Iodine is an essential micronutrient, needed daily in amounts of 100-150 micrograms for normal growth and development.

Experts noted that current WHO guidelines recommend limiting salt intake to less than 5 grams per day, but in India, people consume nearly twice this amount, leaving them majorly vulnerable to hypertension. Currently, an estimated 220 million people in India are suffering from hyperten-

sion. Dr Alka Rao of FSSAI high-lighted ongoing efforts like the Eat Right campaign to support healthier choices. The meeting called for more nationally representative data on sodium and iodine intake

that could aid in making informed policy decisions and tailoring interventions effectively.

Under the National Iodine Deficiency Disorders Control Programme (NIDDCP), the goal is to bring the prevalence of IDD to below 5 percent in the country and to ensure 100 percent consumption of adequately iodated salt (15ppm) at the household level.

The experts at the meet also suggested that in addition to mass awareness campaigns, innovative strategies that promote the use of low sodium salt substitutes that have proven to be effective should be explored. Policies should be implemented to reduce salt intake from all sources, including restaurant meals, public procurement, packaged foods, and to reinforce mandatory iodization, said the experts.

Road crashes leading cause of deaths from unintentional injuries in India: Report

Road crashes remain the Relading cause of deaths from unintentional injuries in India, accounting for over 43 per cent of such fatalities, with overspeeding being the primary factor, according to a new report released by the Union Ministry of Health here. The "National Strategy for Prevention of Unintentional Injury," report which was released at the "Safety 2024" World Conference on Injury Prevention and Safety Promotion, highlights that while drowning, falls, poison-ing, and burns also contribute to unintentional injury deaths, road traffic crashes (RTCs) are the most significant concern.

The report reveals that in 2022, there were 430,504 deaths from unintentional injuries and 170,924 from intentional injuries, with RTCs making up 43.7 per cent of unintentional injury deaths. It also noted that despite efforts to improve road safety, India continues to grapple with a high number of fatalities due to road traffic injuries (RTIs). The mortality ratio remains constant at approximately 86 per cent for males and 14 per cent for females.

ing for a staggering 75.2 per cent of fatalities. Other major contributing factors include driving on the wrong side of the road (5.8 per cent) and dri-ving under the influence of alcohol or drugs (2.5 per cent). "Analysis of RTIs reveals a significant disparity in mortality rates based on location. Rural areas bear the brunt of RTI fatalities, with a staggering 67.8 per cent of deaths occurring there compared to 32.2 per cent in urban areas. Furthermore, the data suggests that open areas and residential zones might be particularly dangerous, with potentially higher fatality rates compared to other locations," it said. National highways, which have

a share of only 2.1 per cent of the total road length in the country, account for the maximum number of road fatalities and were responsible for 45 lives per 100 km in 2022.

The three-day conference, hosted by IIT Delhi and cosponsored by WHO, aims to address these issues through a comprehensive approach that includes safer infrastructure and protection for vulnerable road users. International experts are focusing on improving coordination, strengthening research, and integrating injury prevention with global health strategies to build a safer future for all.

Wild animal attacks claim 68 lives in Odisha this year, says Minister

At least 68 people were killed in attacks by elephants and other wild animals in Odisha during the current year, state Forest Minister Ganesh Ram Singkhuntia told the Assembly on Tuesday.

While replying to a written question of BJD legislator Arun Kumar Sahoo, the minister said besides human casualties, 1,087 houses and crops over 2315.79 acres were also damaged in incidents of the human-wildlife conflict in different forest divisions of the state during the current year.

To prevent human habitations located near forest areas from elephant and other wild animal attacks, the government has been taking steps for the roll-out of an artificial intelligence (AI) e-surveillance supported ct at Bharatour area in



officials can monitor the movement of wild animals accordingly, human and habitations can be put on alert in advance, the minister said. A maximum of 14 people were killed in such wild animal attacks in the Dhenkanal forest division, while eight such deaths were reported from the Keonjhar forest division, the minister said.

Similarly, wild animal attacks claimed six human lives each of the Bonai and Rourkela forest divisions, five people were killed in such attacks in the Angul forest division.

The Athagarh and Baripada reported divisions four human deaths each. Singkhuntia has informed that the government has so far received 9,168 complaints seeking compensation for the loss incurred due to elephants

"Reviewing the (status of the implementation of) literacy mission, the chief minister instructed directors of panchayats and municipal administration to direct secretaries and chief officers to provide a list of illiterates in their respective areas or to issue a certificate confirming that the ward, locality, village, or city is literate," he said.

The chief minister also reviewed the implementation of NEP in the school education system, the spokesperson said.

the current status of NEP 2020 implementation," he said, adding that the state curriculum framework for foundational the and secondary stages has been officially notified.

A strategic pivot

Amid rising regional tensions, Indo-US defence ties are strengthening, marking a significant strategic shift in South Asia

| ndia has solidified its defence partnership with the United States through two pivotal agreements, signaling a deepening American commitment to South Asia at a time when China's military influence is expanding across the region. The agreements, secured during Indian Defence Minister Rajnath Singh's recent four-day visit to the United States, include a Security of Supply Arrangement (SOSA) and a Memorandum of Agreement on the Assignment of Liaison Officers. These developments underscore a significant shift in the dynamics of Indo-US relations, with both nations moving closer in their defence cooperation. The SOSA, a non-binding bilateral pact, is designed to prioritise support for defence-related goods and services between the two countries. This agreement is particularly crucial in addressing supply chain vulnerabilities that are critical to national security. Under the SOSA, India will receive assurances from Washington's Defence Priorities and Allocations System,



while Indian companies will provide priority support to the United States. India's inclusion in the elite group of 18 SOSA partners, which includes nations like Australia, Canada, and Britain, marks a significant step in defence cooperation.

In effect it means if either of two nations ended up in combat with an adversary, the SOSA could help accelerate the delivery of crucial weapons and materials required for defence, thereby ensuring robust supply chains in times of crisis. India and the United States have already established several key strategic agreements, including the Logistics Exchange Memorandum of Agreement (LEMOA) signed in 2016

and real-time intelligence sharing since 2018 under the Communications Compatibility and Security Agreement (COMCASA). These agreements, alongside the new SOSA, create a framework for expedited deliveries of contracted goods and services, potentially streamlining defence commerce between the two nations. In 2019, the signing of the Industrial Security Annex marked another significant step, allowing the sharing of classified US information with private Indian defence firms-a departure from previous restrictions. The Reciprocal Defence Procurement Agreement could further streamline defence commerce, enabling private companies in both countries to bid on each other's contracts. Indeed, a technologically advanced Indian military aligns with American interests. The recent Indo-US defence agreements mark a significant milestone in the evolving relationship between the two nations. As China's influence continues to grow across South Asia, particularly in Islamabad and the Maldives, these agreements provide a foundation for enhanced collaboration and a shared commitment to regional stability. With these developments, India and the United States are poised to further deepen their defence ties, building a partnership that could play a crucial role in shaping the future of the region.

Tibet festival started on 3 September at India International Centre New Delhi ■to celebrate its rich Buddhist heritage, culture and identity. The Sikyong (head) of Central Tibet Administration, Penpa Tshering, will preside over various activities to highlight Tibet's geo-strategic, spiritual and cultural importance for India.

His Holiness Dalai Lama at 89, is in a New York hospital for medical treatment but is considered in good health. US Special Coordinator on Tibet, Uzra Jeya met him which elicited "immediate (solemn) protest from China". Foreign Affairs spokesperson Mao Ning said: we don't allow Dalai Lama to engage in political activities in the US". Backchannel talks between the Dalai Lama envoy and China have been going on for an undisclosed period though Beijing does not confirm them. Talks are being pushed by the US House Resolution Resolve Tibet Act July 2024 which calls for restoration of its full autonomy.India needs to add its voice for Tibet's autonomy both internally and externally as part of a broader coalition. India's recognition of full Chinese sovereignty over Tibet was based on Beijing granting and implementing Tibet's autonomy. Instead, China has quashed Tibet's autonomy and trade treaties opening for India to take a more nuanced position.

In the latest NIRF 2024 rankings, serious concerns were raised regarding the dropping ranking of many prestigious national institutions. Many mediocre institutions climbed to a higher level than institutions of national repute. Though the purpose of accreditations and rankings is to improve the quality of each institution through a competitive spirit, one major point of concern is that many institutions climbed the ladder through a single parameter, the publication metrics. The over-emphasis on publication spoils our country's academic and research environment

Even people who don't know how to write a paper properly publish one paper per month. There was a time when a researcher used to publish one or two papers per year. Even at the international level, people have expressed reservations about citation metrics. In a recent issue of Nature (published on non is especially widespread



20th August), a team of researchers led by Yasir Zaki explicitly shows that a citation black market is operating in our society. The citation black market is the unscrupulous act of exchanging citations to enhance research articles' perceived influence unduly. The citation black market functions through the following mechanisms.

1. Citation Cartels: Citation cartels are groups of researchers who agree to quote each other's work a lot, even if it has nothing to do with the current topic. These cartels can change citation metrics in a big way, giving the wrong impression of how important and influential the study is.

2. Paid Citations: Citations may sometimes be available for purchase by researchers or publications. This phenome-

Unified Pension Scheme promises a guaranteed pension for long-serving employees, but at a significant fiscal cost to the exchequer



he old pension scheme (OPS) has been a big burden on the union and states' budget of the country. In one of the economic reforms, it was shelved for employees joining government services in 2004 and later. The new scheme was called the National Pension Scheme (NPS), where the employee had to con-tribute 10% of the salary during the entire period of service. Initially, the government too was to make a matching contribution of 10%, which was later increased to 14%. The corpus generated THE NEW SCHEME for pension this way was invested in government securities, shares and corporate WAS CALLED THE bonds, which had daily net asset value like mutual funds. At the time of retirement, at least 40% of the corpus is to be PENSION SCHEME used for purchasing an annuity. The NPS scheme does not guarantee a monthly pension equivalent to 50% of the last salary drawn.

This led to resentment among the government employees and opposition parnity to keep the BJP-led central govern-ment in the dock. Among several free-bies, Congress also promised in the election manifesto to revert to OPS in states they came to power. Montek Singh Ahluwalia has gone on record to bring home the point that the economy of the country will be ruined if OPS is revived for employees who joined service in and after 2004. Many experts have also concurred with the views. Congress won the Himachal Pradesh Assembly election on the promise to revert to OPS but did not implement it. Subsequently in the Telangana election and also in the Lok Sabha 2024 election, the revival of OPS was not again brought up in the manifesto. BJP having disappointed with the Lok Sabha results in Maharashtra, Rajasthan, Haryana and Uttar Pradesh had to make a tightrope walk and find a middle ground between OPS and NPS. The central government now proposes a United Pension Scheme (UPS) for employees whose service lasts for 25 years

or more to get a pension of 50% of the average of the preceding twelve months' salary before the super annulation. The pension amount will be inflation-adjusted in dearness allowance twice a year. It has also a provision for a 60% family pension, for all dis-eased employees. The scheme does not benefit those who served for less than ten years. However, a monthly pension of Rs 10,000 has been guaranteed for employees who retired after serving for at least ten years. An additional sweetener has also been brought in the provision for the payment NATIONAL of a lump sum amount linking it with the duration of service in the government.

(NPS), WHERE The scheme will come into effect from 1st April 2025 and will THE EMPLOYEE benefit 23 lakh employees of the central Government if they opt for it. Policy rollbacks: The unseen cost of ignoring stakeholder consultation

There have been a number of high-profile policy rollbacks, underscoring the need for consultation and consensus-building before implementing major reforms

Since the Modi Government 1.0, India has witnessed a series of high-profile policy rollbacks that highlight a critical issue in governance: the need for broader consultation and consensus-building before introducing significant reforms. The latest example is the rollback of the lateral entry scheme, which sought to bring professionals from outside the traditional civil services into government roles

While the merits and demerits of such a policy can be debated, the rapid reversal following its announcement points to a deeper, more systemic issue-the lack of comprehensive stakeholder engagement. This pattern is not new. The government's



Putin challenges arrest warrant during Mongolia visit 11 killed,

Ahead of his visit, Ukraine called on Mongolia to hand Putin over to the court in The Hague, and the European Union expressed concern that Mongolia might not execute the warrant.

A spokesperson for Putin said last week that the Kremlin wasn't worried.

A provisional assessment showed that 24 inmates were fatally shot by "warning" shots fired by guards as they tried to escape from the Makala Central Prison in the capital of Kinshasa early on Monday, Congolese Interior Minister Jacquemin Shabani said on the social plat form X.

"There are also 59 injured people taken into care by the government, as well as some cases of women raped," he said, adding that order has now been restored at the prison, part of which was burned in the attempted jailbreak. n the inci

Videos posted online show bodies lying on the ground inside the prison, many of them with visible injuries. Another video shows

inmates carrying bodies that appeared to be lifeless onto a vehicle. There were no signs of forced entry into the prison, which is located in the city center, 5 kilometers from the presidential

palace. The attempted escape was plotted from inside the prison by inmates in one of the wings, Mbemba Kabuya, the deputy jus-tice minister, told the local Top Congo FM radio.

In the hours following the attack, officials visited the prison as authorities convened a panel to investigate the incident. Congolese President Felix Tshisekedi, who is in China on an official visit, has not publicly commented on the incident.

China-linked network mimics Americans to influence US politics

Washington (AP): When he first social media users designed to mimic emerged on social media, the user known as Harlan claimed to be a New Yorker and an Army veteran who supported Donald Trump for president. Harlan said he was 29, and his profile picture showed a smiling, handsome young man. A few months later, Harlan underwent a transformation. Now, he claimed to be 31 and from Florida. New research into Chinese disinformation networks targeting American voters shows Harlan's claims were as fictitious as his profile picture, which analysts think was created using artificial intelligence.

As voters prepare to cast their ballots this fall, China has been making its own plans, cultivating networks of fake

Americans. Whoever or wherever he really is, Harlan is a small part of a larger effort by US adversaries to use social media to influence and upend America's political debate.

The account was traced back to Spamouflage, a Chinese disinformation group, by analysts at Graphika, a New York-based firm that tracks online networks. Known to online researchers for several years, Spamouflage earned its moniker through its habit of spreading large amounts of seemingly unrelated content alongside disinformation.

"One of the world's largest covert online influence operations — an operation run by Chinese state actors — has become more aggressive in its efforts to infiltrate and to sway US political conversations ahead of the election," Jack Stubbs, Graphika's chief intelligence officer, told The Associated Press.Intelligence and national security officials have said that Russia, China and Iran have all mounted online influence operations targeting US voters ahead of the November election. Russia remains the top threat, intelligence officials say, even as Iran has become more aggressive in recent months, covertly supporting US protests against the war in Gaza and attempting to hack into the email systems of the two presidential candidates.

China, however, has taken a more cautious, nuanced approach. Beijing sees little advantage in supporting one presi-

dential candidate over the other, intelligence analysts say. Instead, China's disinformation efforts focus on campaign issues particularly important to Beijing such as American policy toward Taiwan — while seeking to undermine confidence in elections, voting and the US in general. Officials have said it's a longer-term effort that will continue well past Election Day as China and other authoritarian nations try to use the internet to erode support for democracy. A message left with the Chinese Embassy in Washington was not immediately returned. Compared with armed conflict or economic sanctions, online influence operations can be a low-cost low-risk means of flexing geopolitical power.

Fierce storm blows out of northern Philippines after leaving 14 dead

Caracas (AP): A Venezuelan judge on Monday issued an tion results. arrest warrant for the opposition's former presidential candidate Edmundo González as part of a criminal investigation into the results of a disputed

election. The warrant was issued at the request of authorities who accuse González, a former diplomat, of various crimes including conspiracy, falsifying documents and usurpation of powers. The warrant comes just over a month after election officials declared President Nicolás Maduro the winner of an election that his opponents

say he lost. Authorities sought the warrant after González failed to appear three times to answer questions from prosecutors in a criminal investigation stemming from the disputed elec-

Ruling party-loyal electoral authorities declared Maduro the victor of the July 28 election, hours after polls closed. They did not show any detailed results to back up their claim as they had offered in previous

presidential elections. The lack of transparency has drawn international condemnation against Maduro and his allies.

The opposition, however, managed to obtain more than 80% of vote tally sheets, which are printed by every electronic voting machine, and said they show Maduro lost by a wide margin against González.

González was summoned to the prosecutor's office as recently as Friday. Attorney General Tarek William Saab opened the investigation against González after he and opposition leader María Corina Machado revealed what they said were the results shown in the tally sheets and

published them online. Maduro's ruling party and the National Electoral Council have refused to publish their copies of tally sheets that the electronic voting machines printed after polls closed.

Instead, as international pressure mounts to release a breakdown of results, Maduro asked the country's high court to audit the electoral process. The Supreme Tribunal of Justice, stacked with Maduro loyalists, concluded on Aug. 22 that the vote counts published by the opposition were false and certified Maduro's victory. González, 75, has not made any public appearances since the day after the election. His campaign did not immediately respond to a request for comment from The Associated Press. González has questioned the

prosecutors' actions for lack of due process guarantees and accused Saab, a longtime Maduro ally, of being a "polit-ical accuser" who "condemns in advance." He rejected the interview summons arguing, among other issues, that they did not specify the condition under which he was expected to appear.

Russian missile strike kills 41, wounds 180 in Poltava city

wo Russian ballistic missiles struck an educational facility and nearby hospital in a central-eastern region of Ukraine, killing at least 41 people and wounding 180 others, Ukrainian President Volodymyr Zelenskyy said Tuesday.

The strike occurred in the city of Poltava, the capital of the region of the same name, officials said. Poltava is located about 110 kilometres (70 miles) from the border with Russia and about 350 kilometres (200 miles) southeast of Kyiv.

The strike appeared to be one of the deadliest carried out by Russian forces since the war began more than 900 days ago on February 24, 2022.

Kishida to visit S Korea for summit on improving ties

Seoul (AP): Japan's prime minister will arrive on Friday in South Korea for what will likely be the last summit between the two leaders, South Korean President Yoon Suk Yeol's office said on Tuesday.It said outgoing Minister Fumio Prime Kishida's two-day visit was arranged after he "actively expressed hope" to end his term on a high note in bilateral relations. In what would be their 12th summit talks, the leaders will discuss further developing two-way ties and strengthening the countries' cooperation in regional and global issues, the office said. A series of local election losses earlier in the year sparked calls for change within Japan's governing party, which was also dealing with a fundraising scandal. Kishida announced in August that he'll step down after the Liberal Democratic Party picks a new leader on

September 27. "Prime Minister Kishida is expected to continue to provide constructive advice to his successor on foreign policies and the future development of South Korea-Japan relations based on his experience," Yoon's office said in a statement

Jailed former prime minister Imran Khan's PTI dominates the TTAP, the alliance for the protection of the constitu-

tion of Pakistan. The PTI opposes talks with Prime Minister Shehbaz Sharif-led government but is keen upon holding a dialogue with the army to end its polit-ical plight. Khan, who on Monday said he was ready to hold talks with the army, had earlier mandated Achakzai to hold talks with anyone. "We

Pope begins Asia tour, celebrating religious freedom

Jakarta (AP): Pope Francis arrived in Indonesia on Tuesday at the start of the longest trip of his pontificate, hoping to encourage its Catholic community and celebrate the tradition of interfaith harmony in a country with the world's largest Muslim population.

After an overnight flight from Rome, Francis was wheeled off the plane in his wheelchair and onto the tarmac for a welcoming ceremony under Jakarta's perennial hazy, humid and

polluted skies Two children wearing traditional clothes handed him a bouquet of vegetables, fruits, spices and flowers

Francis planned to rest for the remainder of the day, given the rigors of an 11-day voyage zigzagging across time zones that will also take him to Papua New Guinea, East Timor and Singapore.

However, the Vatican said the 87-year-old pope met with a group of refugees, migrants and sick people at the Vatican residence in Jakarta.

Outside the residence, he was greeted by well-wishers eager to catch sight of the first pope to visit since St. John Paul II in 1989.

"When I saw him in the car I was so touched, goosebumps," said Fanfan, a 49-year-old housewife from West Jakarta who uses only one name. "I hope he will hopefully appear in front of me to wave his hand

again. Francis' first full day of activities begins Wednesday with visits to the country's political leaders and meetings with Indonesian clergy who are helping to fuel the growth of the Catholic Church in Asia. Indonesian President Joko Widodo welcomed the pope, saying in a broadcast statement

Their proximity is not coincidental, but strongly willed as a symbol of religious freedom and tolerance that is enshrined in Indonesia's Constitution. The buildings are also linked by an underground "Tunnel of Friendship" which Francis will visit with the grand imam, Nasaruddin Umar, before they sign a joint declaration. While Francis will want to

highlight Indonesia's tradition of religious tolerance, the country's image as a moderate Muslim nation has been undermined by flare-ups of intolerance. In 2021, a militant Islamic couple blew themselves up outside a packed Catholic cathedral on Indonesia's Sulawesi island during a Palm Sunday Mass, injuring at least 20 people. 73,700 per 10 grams. On the global front, Comex gold is trading at USD 2,531.40 per ounce, up by USD 3.80 per ounce or 0.15 per cent. "Gold fluctuated in a narrow

range on Tuesday as traders remained sidelined ahead of US job market data that may

influence the US Federal Reserve's (Fed) interest rate-cutting path," Saumil Gandhi, Senior Analyst of HDFC Commodities at Securities, said.

However, silver was quoted 1.81 per cent lower at USD 28.62 per ounce in the international markets.

During the week, traders will focus on various job reports, including Jolts job openings, ADP Non-farm employment change, non-farm payrolls and unemployment data, which will impact the Fed's policy decision and could provide direction for gold prices, Gandhi added.

arrying a back injury for more than a year, history-making Indian javelin thrower Sumit Antil's path to Paralympic glory was paved with a 'sweet sacrifice'

and several sleepless nights. The 26-year-old faced a tough choice in the build-up to the Paralympics - give up his favourite sweets or put his career at risk due to rapid weight gain and a back injury that troubled him before the Para Games in Asian Hangzhou last year where he won a gold.

On the advice of his physio, Antil grudgingly gave up sweets, followed a strict training regimen and shed around 12 kilograms in just two months. His sacrifice paid off on

Monday when the Sonepat-lad became the first Indian man and only the second Indian overall to defend a Paralympic title, clinching gold in the F64 category with a record throw of 70.59m.

This new mark bettered his previous Paralympic best of Tokyo 68.55m set in Paralympics three years ago. "I've reduced around 10-12

kilos. My physio, Vipin Bhai, told me that the weight was putting pressure on my spine. So, I cut out sweets, which are my favourite, and focused on eating right," he revealed in a media interaction here.

Fixing his back by taking adequate rest is the first thing Antil will do after his return to India

India. "I was not at 100 per cent. I had to take a painkiller before my throw, and even during training, I haven't been at my best. The first priority is to fix my back after we return to India because rest is crucial with the time of injury. I have with the type of injury I have. "With competitions so close, I haven't been able to rest properly and have constantly taken precautions to protect my back. I've been careful with every movement to avoid aggravating it further," he

added. He also thanked his coach (Arun Kumar) for always knowing what he needed, staying up nights to plan his exbedulo and mutting in schedule, and putting in tremendous effort. He said his coach had worked even harder than him.

"I also started doing CrossFit workouts, sprints, and trained hard. It's been two years with my coach, and he's like an elder brother to me. He knows exactly what I need and when I need it. "I've seen him stay up nights to plan my schedule. My team has put in a tremendous effort for me, and I feel truly blessed to have them," he said. "Once you reach a certain level, the responsibility on you increases, and all eyes are on you. Hopefully, after this, I'll finally get some rest. I've been continuously on the field for



He said he sustained the injury in 2023 ahead of the Asian Para Games and kept competing in back-to-back tournaments.

Antil dreamed of becoming a wrestler and was inspired by Olympic bronze-medallist

Vogeshwar Dutt. However, in 2015, his life changed when a tractor accident led to the amputation of his left leg below the knee. Undeterred, Sumit was introduced to para-sports in 2017 by a fellow athlete from

his village. Despite the pain and challenges of training with a prosthetic leg, he found his new passion in javelin. Under coach Naval Singh's guidance, Sumit's relentless dedication transformed him his village.

IT'S TIME TO MAKE AMENDS: PAT CUMMINS ON TEST SERIES AGAINST INDIA

ustralian captain Pat Cummins is looking at the Lupcoming five-match rubber against India as a chance to "make amends" for the successive Test series defeats at home against their fierce rivals.

He said the next Border-Gavaskar Trophy, which will start on November 22 in Perth, promises to be a 50-50 affair.

India retained the trophy in the last four series, from 2016-17 to 2022-23. India had defeated Australia in their own backyard in the last two series in 2018-19 and 2020-21.

Cummins said Australia are hoping to draw confidence from their win over India in the World Test Championships Final at London last

year. "The last two series here in Australia, we haven't been successful, so it's been a long time. Hopefully, it's time to make amends," Cummins told Star Sports

You know, we've played them (India) plenty of times where they've beaten us, but we've also had plenty of wins against them as well, which we'll draw confidence from. The most recent Test match was, of course, the World Test Championship in neutral conditions, and we came out on top in that match.

"It's always fiercely competitive, and it always feels like it's 50-50. I'm 10 out of 10 excited for the Border-Gavaskar Trophy," he added.



Senior batter Steve Smith agreed with the skipper and said it will a "big summer" for Australia against a "well-balanced" Indian team. "...You know, it's going to be a great series. You know, India have been

been playing really good cricket the last couple of years. You know, we haven't beaten India in the last two times they've come out here," he said. "Obviously got a terrific side, very well-balanced team, all bases playing outstanding cricket. We've covered. So, you know, they've played

really good cricket out here. They've played good cricket when we've been over in India as well, where we know they're very, very difficult to beat. So it's going to be a big summer. It's going to be an exciting one." Pacer Mitchell Starc highlighted the

importance of the rivalry by keeping it at par with the Ashes.

"For Australian cricket, you've got the Ashes and then you've got the Border Gavaskar Trophy in there. I mean there's a long history in the Ashes but that Border Gavaskar rivalry, if you like, has just grown from strength to strength over each series.

"And now we see it as a five Test match series which is fantastic for not only the rivalry but for the Test series as well. Whether it's the calibre of player, the calibre of matches that we see as fans and as cricketers just continues to grow strength on strength each series," he said.

"Now (with) India obviously winning a number of series in a row, it's created even a bigger rivalry between the two countries. I mean both teams are well known to one another, we play each other very often across the formats, so I'm sure it'll be another exciting series," Starc added. All-rounder Glenn Maxwell said an

India-Australia contest in any format has become a must-watch affair now. "I think over the last few years, definitely, it feels like the two teams sort of swap places in the rankings quite a bit. Whichever format it is, you will always see these two teams at number one at some stage around the world," Maxwell said.

The different contests we've had in both countries across all formats certainly provide a lot of highlights for the rest of the world. It's always must-watch cricket whenever these two teams are playing."

Kylian Mbappé joined Real Madrid without a transfer fee being paid because the France star was a free agent after

letting his contract expire at Saint-Germain. Still, Paris Madrid had to pay Mbappé a signing bonus variously reported as between USD 110 million and USD 165 million. The biggest transfer fees in cross-border deals were Julián Alvarez's move from Manchester City to Atletico Madrid, reported to be about 75 million euros (USD 83 million) and Leny Yoro from Lille to Manchester United for a reported 62 million euros (USD 69 million).



Tearful Luis Suárez announces Uruguay retirement

AP MONTEVIDEO (URUGUAY)

Striker Luis Suárez will play his last game for Uruguay on Friday. Suárez was emotional as he announced he was ending a 17-year international career after the World Cup qualifier against Paraguay at Centenario Stadium.

"It hurts to say it, but Friday will be my last match with my country's national team, Suárez said late Monday, unable to hold back tears at a press conference.

"I am retiring because I want to step aside. I am 37 years old, there are a lot of talented players, and I know it would be difficult to get to the next World Cup.

"It is comforting to know I can retire on my terms and not have to retire due to injuries, or to not being called up. I want to say goodbye here, with my people. This is the ideal moment?

Suárez debuted in 2007 and is Uruguay's all-time leading scorer with 69 goals in 142 matches. He played in four World Cups and five Copa

America. He helped to lead the team to the title at the 2011 Copa, where he scored twice in the semifinals and the matchwinner in the final and was named player of the

tournament. "It's very difficult, but I want to be relaxed when I play my last game with the national team," he said. "I will be just as excited as I was for my first national team appearance in 2007 when I was a 19-yearold kid.

"Now, I am a veteran, an older player, whatever you want to call it, with an incredible history with the national team and I will give my life for the team on Friday.

In the 2010 World Cup quarter-finals, Suárez
