India has scripted history with its remarkable remarkable performance and determination to achieve glory at the 2024 Paris Paralympic Games, bringing home a record-breaking tally of medals and elevating the nation's stature on the global stage of para-sports. With a mix of grit, determination, and incredible athleticism, Para-Athletes shattered personal and national records, creating an inspiring narrative for the country's sporting future and inspiring millions like them. India, this year secured an unprecedented total number of 29 medals on the board just one short of the 30 mark after Pooja Ojha fell short in the

Doval lands in Moscow

Advisor (NSA) Ajit Doval will visit Moscow for two days starting September 10 to hold discussions focused on resolving the Russia-Ukraine conflict. This comes after Prime Minister Narendra Modi's visits to Ukraine and Russia in the past few weeks. Favouring dialogue to end the conflict, the Prime Minister during his talks with Ukraine President Volodymyr Zelenskyy on August 23 said both Ukraine and Russia should sit together without wasting time to end the ongoing war and that India was ready to play an "active role" to restore peace in the region. Prime Minister Modi also said he would even like to contribute personally for a peaceful resolution of the

Moreover, Russian President Vladimir Putin on September 5 named India among the three countries he is constantly in touch over the conflict. He also said these countries are sincerely making efforts to resolve it. Other world leaders, too, are of the view that India can play a key role in finding a resolution to the Ukraine conflict. Italian Prime Minister Giorgia Meloni on Saturday held talks with Zelenskyy.

"China and India have a role

As regards Doval's upcoming visit, shortly after his trip to Ukraine, Prime Minister Modi spoke to President Putin over the phone on August 27. "We respect our friends and partners, who, I believe, sincerely seek to resolve all issues surrounding this conflict, primarily China, Brazil and India. I constantly keep in touch with our colleagues on this issue," Putin said.

The Russia-Ukraine conflict and most global powers have taken sides. New Delhi, however, has constantly called for peace, with Prime Minister Modi stressing that "this is not an era of war". When Prime Minister Modi

travelled to Russia in July and hugged President Putin, President Zelenskyy had referred to a Russian missile strike that killed 37 people, three of them children. He had said it is "a devastating

In a move to decongest, and maximum utilisation of its capacity, private as well as Government interstate buses will have to pay the same amount of parking fee for using the bus bays at inter-state bus terminals in the national capital. Buses will be provided with a parking time slot of 25 minutes at a fixed rate of Rs 500 (excluding Good and Services tax). After that, charges will be applied for every five-minute extra. It was also decided that only buses with Fastag be allowed to enter the terminals to ensure tracking. The new norms and rates will be soon notified at interstate terminals. Delhi has three operational inter-state bus terminals (ISBTs) at Kashmere Gate, Anand Vihar and Sarai Kale Khan having their optimum capacity of 3,000 per day against 1,700

Dynastic politics carries a negative connotation, but it is unfair to solely attribute its promotion to any single party in Harvana Assembly election. The allocation of tickets by the national and regional political parties - Bharatiya Janata Party (BJP), Congress, Indian National Lok Dal (INLD) and Jannayak Janata Party (JJP) for the Assembly election in the State has demonstrated the influence of dynastic ties in furthering careers across the polit-

In its first list of 67 out of 90 Assembly seats, BJP has tried to play all cards including giving tickets to kin of prominent party leaders in order to score a hat-trick in the State despite strong anti-incumbency sentiment.

Jannayak Janta Party has declared its first list of candidates on 15 Assembly seats. Senior JJP leader and former Deputy Chief Minister Dushvant Chautala has been fielded from Uchana Kalan, from where he is a sitting MLA. JJP has fielded Dushyant's brother and senior leader Digvijay Singh Chautala from Dabwali seat.

JJP is headed by Dushyant and Digvijay's father and former MP Ajay Singh Chautala. The party has yet not named its candidate from Badhra where Dushyant's mother Naina Chautala is the sitting MLA.

On the remaining seats in which BJP, Congress, INLD and JJP are yet to announce their candidates, their leaders including Ministers, several legislators, office-bearers and senior leaders too have presented the names of their children as eligible candidates.

Political observer opined that now, without exception, dynasty politics is well entrenched and parties are not keeping up the morale of ordinary cadres by fielding grassroots workers. The list of candidates for Assembly seats announced by these parties in Haryana showed that there was no hesitation in fielding father-son and father-daughter

"If dynasties are the flavour of Indian politics, Haryana could well be its capital. From the Hoodas of Rohtak, the Chautalas of Sirsa to the Bishnois of Hisar, Harvana is home to at least five prominent political dynasties, which date back at least three generations, all of which are in the fray for the Assembly elections in the State on October 5. The families have also managed to have a stake in power by either en masse switching of loyalties from one national party to another or forming breakaway factions from within," said a political expert.

Another political observer opined that Prime Minister Narendra Modi's aggressive narrative against dynasty politics in Congress and regional parties has no relevance in . Haryana as all the three leading political parties, including BJP, are saddled with political dynasties. It has been a longheld convention that if a sitting member passes away, his or her family member is given the ticket in the by-election. Dynasty politics is for self-protection and it is not a good sign, they added.

The decision to strike

Punjab Governor Gulab Chand Kataria is set to embark on a crucial tour of the state's border districts in the last week of September — a move that comes against the backdrop of Chief Minister Bhagwant Mann's attempts to foster better relations with Kataria after bitter clashes with his predecessor Banwari Lal Purohit.

The visit has raised curiosity, as Mann had previously locked horns with Purohit over similar tours, particularly regarding border security and drug trafficking. It will be interesting to observe how Mann responds to Kataria's tour, given the sensitive history surrounding such vis-

It has been learnt that Kataria will spend three days, from September 25 to 28, visiting key districts along the border, including Amritsar, Gurdaspur, Fazilka, Ferozepur, Tarn Taran, and Pathankot. Though the Governor's office is yet to confirm the exact details, officials in these districts have already been put on high alert.

Kataria's visit marks his first official tour of the border districts and follows in the footsteps of Purohit, who had made seven trips to the region during his tenure. Purohit had frequently criticized the AAP Government, raising serious concerns about illegal mining and drug trafficking, and had pointed out that drug addiction had infiltrated even the younger population, with school children becoming victims.

Purohit's stance on these issues often put him at odds with Mann, leading to a strained relationship. The former Governor's criticism included not just local governance but also the agencies operating in these sensitive areas. During his last visits to border areas in July

this year, Purohit had drawn attention to the growing use of drones by Pakistan to smuggle

sures to counter these tactics, large portions of the State remained vulnerable. Purohit emphasized that local villagers often knew about these illegal activities but were too afraid to report them. He noted a lack of coordination between Central and State security agencies, which further hampered efforts to tackle drug smuggling.

To combat this, Purohit had launched several initiatives, including the formation of Village Defence Committees and the incentivization of residents to report suspicious activities. He had announced that villages ridding themselves of drugs would receive a reward of Rs three lakhs from the Governor's Fund.

With Kataria now stepping into the spot-light, it remains to be seen whether he will continue these measures or introduce new strategies to address the ongoing issues of drug trafficking and illegal activities in the border dis-

Intensify Crackdown on Power Theft: Punjab Power Minister Directs PSPCL

Punjab Power Minister Harbhajan Singh ETO on Sunday issued stringent directives to the state power utility — Punjab State Power Corporation Limited (PSPCL) — to combat power theft aggressively. Emphasizing a zerotolerance policy against corruption, the Minister called for comprehensive special checks across the state to detect and prevent power thefts.

The Minister stressed the Punjab Government's commitment to energy conservation and curbing revenue losses due to power theft. He underscored the necessity of regular inspections to safeguard the interests of lawabiding consumers and to ensure efficient ser-

2014, after which he continued He instructed the PSPCL officials to conas the honourary member of duct thorough inspections of all types of power

connections, including domestic, commercial, agricultural, and industrial. Reports from these inspections are to be submitted to him daily. He warned that any PSPCL or PSTCL official involved in power theft would face immediate termination and legal action.

The Minister also directed the imposition of penalties and registration of FIRs against those caught stealing electricity. The PSPCL's recent efforts have been notable. A total of 81,262 connections have been checked statewide, resulting in the detection of theft in numerous cases. Penalties amounting to approximately Rs 13.30 crore have been imposed on defaulters. Zonewise, the Border Zone in Amritsar reported 27,285 checks with 989 theft cases and a penalty of Rs 3.01 crore. The West Zone in Bathinda saw 6,079 checks, detecting 872 thefts with Rs 3.03 crore in penalties.

Heavy Rains Paralyze HP: Over 60 Roads Blocked; Power, Water Supplies Disrupted schemes and one water supply liminary damage report proand one critically injured on

Himachal Pradesh has been severely impacted by relentless rains, leading to the blockage of over 60 roads across the State. The downpour has caused extensive disruptions in transportation and essential services, with significant effects on various districts. As per the information shared by the State Emergency Operation Centre (SEOC) on Sunday, the situation is critical with 31 roads closed in Mandi, 13 in Shimla, 10 in Kangra, four in Kinnaur, and two in Kullu. Additionally, roads in Una, Sirmaur, and Lahaul and Spiti districts are also obstruct-A major concern is the

blockage of National Highway 5 near Negulsari in Kinnaur district. This key route, which connects the region with Tibet, is crucial for trade and travel. The closure is exacerbating the situation, further isolating the affected areas. Besides the road closures, the state is facing significant disruptions in essential services. The SEOC reported that 11 power

scheme have been affected, adding to the hardships faced by residents.

The heavy rains that began on Saturday evening have led to widespread damage. Una recorded the highest rainfall with 48 mm, followed by Kufri with 19.8 mm, and Sangla with 17.2 mm. Other areas affected include Jubbarhatti and Mandi, each receiving 15.6 mm of rain, and Nichar with 14.8 mm.

Despite the recent heavy rainfall, the state is still grappling with a 21 percent rainfall deficit since the monsoon season began on June 27. The state has received 522.2 mm of rain, whereas the average expected is 657.9 mm. The ongoing monsoon sea-

son has been devastating, with 158 fatalities reported due to rain-related incidents from June 27 to September 7. Additionally, 30 people remain missing. The overall damage to the state has been estimated at Rs 1,305 crore, with substantial losses due to landslides, flooding, and infrastructure damage.

The State Disaster Management Authority's pre-

vided a grim picture. It highlighted deaths caused by cloudbursts, floods, landslides, and lightning strikes. The report also noted fatalities due to snake bites, electric shocks, and accidents caused by the severe weather conditions. The state has witnessed 51 incidents of cloudbursts and floods, along with 40 major land-

Looking ahead, the weather forecast predicted continued light to moderate rainfall in Shimla, Solan, Mandi, Kullu, and Sirmaur, with isolated showers in other districts.

In response to the extensive damage, the State Government has requested a special relief package from the central government. To date, Rs 10 crore in financial aid has been allocated to assist affected communities. Efforts are ongoing to restore normalcy and support the residents as the state continues to cope with the aftermath of this severe weath-

Parliament breach sought to discredit India's democracy: Delhi Police chargesheet

Accused aimed to gain global fame, usurp power, planned attack for two years before executing gas attacks

The December 13, 2023 Parliament security breach accused wanted to discredit India's democracy, gain instant global fame, usurp power and achieve "richness and glory" by targeting the "very symbol of democracy", according to the chargesheet filed in the court by Delhi Police.

The accused first met on social media and planned their move for nearly two years before executing it last year on the anniversary of the 2001 Parliament athtack. According to the chargesheet, a source said, their first in-person meeting was held in February, 2022 at Mysuru.

Citing from the chargesheet, sources told PTI, that in total they held five meetings in Mysuru, Gurugram and Delhi to decided finalise their plan and arrive at a modus operan-

The chargesheet, spread over 1,000 pages, was filed before the Patiala House Court in June and the court took its cognisance last month. A supple mentary was filed in July.

The chargesheet mentioned that the group of young people, led by Manoranjan D, a resident of Karnataka, met on social media.

Manoranjan is among the six accused arrested by the Delhi

Police Special Cell, sources

Manoranjan, according to the chargesheet, is suspected to be among the main conspirators of the parliament breach, who allegedly "instigated and motivated" the young people by promising them "richness, glory and wealth" and by targeting the "very symbol of democracy".

While citing the chargesheet, a source said that driven by his "ultra Maoist-inspired thinking" Manoranjan decided to target the Parliament building to gain immediate and lasting attention.

The source said the accused wanted to send out a wider message that the "Indian Democracy is ineffective and

needs to be replaced".

The major security breach took place on the anniversary of the 2001 Parliament terror attack. The accused launched coordinated gas attack both inside and outside the parliament house during the Zero Hour on December 13, 2023. Two persons — Sagar Sharma and Manoranjan D — jumped into the Lok Sabha chamber from the public gallery and opened canisters that released yellow gas in the House. They also shouted slogans before parliamentarians overpowered

premises around the same time, two other accused --Amol Shinde and Neelam Azad -- also sprayed coloured gases from canisters while shouting "tanashahi nahi chalegi (dictatorship won't be allowed)

Manoranjan, Sagar Sharma, Amol Shinde and Neelam

Azad were arrested on the same day as they were caught soon after their acts. Lalit Iha and Mahesh Kumawat were arrested on December 15 and 16, respectively. All the accused are lodged in the Tihar iail.

They have been booked under sections 16 and 18 of the

Unlawful Activities Prevention Act (UAPA) and other sections of the Indian Penal Code by the Delhi Police's anti-terror unit, Special Cell.

Kosovo", the source added. Their second meeting was held at a hotel in Gurugram in August, 2022, which was attended by seven people as some of the members had already "backed out" knowing their "nefarious" plan, anoth-er source said. He said that in this meeting, they decided to include a woman in their plan and that is how they inducted Neelam into their group. In their third meeting held at

a hotel in Paharganj in central Delhi in August 2023, they decided to use the smoke canisters for their act in the Parliament. This meeting was attended by all the six accused arrested in the case, the source

They met again at the same Paharganj hotel in September, 2023 and discussed getting entry passes and the use smoke canisters inside Parliament. They also decided to enter into the Parliament during the winter session, the source said. Their last meeting was held at Gurugram and subsequently, near the Delhi's India Gate on December 13, 2023, the final day of the execution of their plan.

The four accused -Manoranjan D, Sagar Sharma, Amol Shinde and Neelam Azad -- broke their SIM cards and handed them over to Lalit Jha, who was tasked to destroy them all, the source said. Jha was also given the task of recording Shinde and Neelam as they executed their plan at the Parliament gate and

upload the video on social media. The police also said in the chargesheet that the accused were members of a social media page "Bhagat Singh Fan Club", and they mostly used the signal app to communicate, according to



Security heightened in Manipur, anti-drone systems deployed

The bypolls, the schedule for which is yet to be announced, were necessitated by the election of the incumbent MLAs to the Lok Sabha and the disqualification of one legislator. Leaders of the two parties, which contested the Lok Sabha elections in an alliance in Uttar Pradesh, have confirmed that they would contest the bypolls "unitedly".

Samajwadi Party chief spokesperson Rajendra Chaudhary told PTI, "The Government has failed on this front (stopping wolf attacks). It has made people of the entire State insecure. We The Government's style of working is not democratic. They have not done any development and they want to remain in Government," he

Echoing the Samajwadi Party leader, Ajay Rai -- the Congress' State unit chief -told PTI that the Government failed to control the wolf-attack situation and the "terror" was moving towards the

"The other issues plaguing the State are the collapse of law and order, fake encounters, rising inflation and unemployment," he said.

The BJP, on the other hand, said the State Government was making every effort to resolve the wolf-attack prob-lem. Eight people, seven of them children, were killed and about three dozen injured in alleged wolf attacks in Bahraich district in the last two months, official figures

The district's Mahsi tehsil has recorded a series of wolf attacks since March. The frequency of attacks rose during the monsoon from July.

Four wolves have been captured but the attacks still continue, leading to experts sug-gesting that the real "man eaters" had not been caught. There were also reports of suspected animal attacks in neighbouring Sitapur district. On September 2, three women in a village were injured in mals. While locals claimed that the women were attacked by wolves, officials of the forest department, which collected animal samples and footprints, suspected that jackals were behind the attacks.

On Saturday, two children and five men were injured in alleged jackal attacks in two villages in the Jehanabad area of Pilibhit district.

erous in this issue (seat share). Wherever they (Congress) think they can win, those seats will be given to them," he

The seat-share formula is yet to be finalised but there is still time for the bypolls, he added.

The seats that will go to the bypolls are Karhal, Milkipur, Katehari. Kundarki, Ghaziabad, Khair, Meerapur, Phulpur, Majhawan and

The Sisamau seat fell vacant following the disqualification of Samajwadi Party MLA Irfan Solanki after he was sentenced to jail in a criminal case. Liquor shops near national highways to be relocated: Tripura CM

Saha said law enforcement agencies must prepare a list of liquor shops functioning within 100 metres of the outer edge of national highways as drunken driving also contributes to

fatal road accidents.

Vijayawada flood damage assessment to begin from Monday: Andhra Home Minister

Andhra Pradesh Home Minister Vangalapudi Anitha said here on Sunday that the procedure of estimating flood losses in Vijayawada will begin from Monday.

Addressing a press conference at the NTR district collectorate, the Home Minister said flood relief work is going on for the eighth day since the floods in the centrally located city.

"From tomorrow (Monday), the procedure to start estimating flood losses will

begin," said Anitha. Earlier, Chief Minister N Chandrababu Naidu said the state government sent its first report regarding the floods to the Centre and sought a

relief of Rs 6,880 crore, and that enumerators are being roped in, who will be provided with

training on Sunday. In flood-hit areas, the CM observed that out of 2 lakh houses, 1.4 lakh were singlefloor residences, which suffered extensive damage due to the floods.

Naidu said houses, shops and all others will be assessed for damage.

Meanwhile, the number of deaths due to floods rose to 45 on Sunday morning, said an official press release.

Mohammed Ilyas (50) from Ajit Singh Nagar mini stadium area, one of the worst-affected places, who is currently taking refuge at a relative's house in Tadigadapa told PTI that it



has been raining continuously in Vijayawada since Saturday night. Though the 100-metre Budameru breach has been plugged, Ilyas said water is seeping through it and flowing towards Vijayawada, parts of which are still waterlogged. He said the sand and mud between the boulders used between the boulders used to plug the breach got washed away, leading to

seepage. Moreover, Budameru is also receiving inflows from swollen Pulivagu rivulet, along with inflows from Munneru rivulet in

Telangana. "Waterlogging has reduced. Now there is about 2 ft water on the road and it is not reducing further due to continuous rain. Once it

stops raining it could reduce," said Ilyas. Home Minister Anitha said that three lakh food packets, milk, and biscuits would be distributed today while vegetables, whose prices have been regulated, also recorded brisk sales. The Home Minister noted that 5 lakh kg vegetables were sold through 163

stores.

Further, 20,000 houses were cleaned using fire engines and 42 drones are also deployed for sanitation work. Meanwhile, the Chief Minister met Governor S Abdul Nazeer on Sunday and briefed him on the flood situation and the damage caused to Vijayawada city and other places in the state.

Admission of guilt

After being in a state of denial for 25-odd years, Pakistan admits its army's role in the Kargil war for the first time

akistan has, for the first time, officially acknowledged the role of its army in the Kargil War of 1999. Speaking at an event to commemorate Defence Day, Pakistan Army Chief General Asim Munir said several Pak soldiers died in the 1999 Kargil War against India. This is the first time that Pakistan acknowledged active role in the war in a surprising departure from its elusive stance. Previously, Pakistan had maintained that the Kargil operation was carried out by mujahedeen or "freedom fighters" and local insurgents, distancing its military establishment from the war. However, this newfound candor could potentially reshape not only the country's internal discourse but also its relations with India and the broader international community. Indeed, India and the world knew it all along and there was not an iota of doubt about the role the Pakistan army under General Musharraf played in the Kargil war. It was orchestrated by the then Pakistan army chief General Musharaff who went ahead with his machi-

nations without even taking the then Prime Minister

of Pakistan Nawaz Sharif.

The Kargil War, fought between India and Pakistan from May to July 1999, erupted after Pakistani soldiers and militants infiltrated the Indian side of the Line of Control (LoC) in the Kargil district of Jammu and Kashmir. Their goal was to seize strategic heights, from where they could disrupt supply routes to India's northern military outposts, including the Siachen Glacier. India was initially caught by surprise but responded with full-scale military operations to reclaim the territory. Indian forces mounted a determined counter-offensive, which eventually forced Pakistan

to retreat. Multiple independent sources, including captured Pakistani soldiers and intelligence reports, indicated that regular units of the Pakistani Army were deeply involved. But the big question is why now? This change is likely driven by internal and external factors, including evolving political dynamics, growing transparency within the military establishment, and changing geopolitical realities. By acknowledging its role, Pakistan may be seeking to rewrite its narrative, demonstrating a willingness to confront uncomfortable truths in its military history. This admission could have several important implications for Pakistan, India, and the region as a whole. The official acknowledgement could prompt a deeper examination of the internal decision-making processes that led to the Kargil War. By owning up to its role, Pakistan could potentially build trust in future diplomatic engagements. This admission could further influence Pakistan's military strategy, possibly encouraging more caution and restraint in future operations. Pakistan's recognition of its army's involvement could alter its approach to the Kashmir dispute, leading to more diplomatic, rather than military, efforts to resolve the issue. While the scars of Kargil will not heal overnight, this acknowledgement opens up the possibility for greater introspection and, potentially, reconciliation in the future.

Bihar's special land survey: A step towards resolving land disputes



This ambitious project aims to digitise and map land records, addressing longstanding issues of land disputes and enhancing transparency in land dealings

Bihar is undergoing a significant transition with the commencement of a Special Land Survey covering 45,000 villages across the state. To expedite this process, the government has deployed 10,000 officials, aiming to complete the survey by August 2025.

The Department of Revenue and Land Reforms has already digitized 64 million revenue documents. The digitisation of an additional 160 to 200 million documents is expected to be completed within the next year. These documents will be available to the public for a nominal fee.

The primary goal of the survey is to digitize and map the state's land data to enhance transparency in land dealings and address the persistent land disputes that overwhelm Bihar's courts. "Our main focus is to prepare accurate land records, including Kistwar (Plotting) and Khanapuri, to ensure legitimate land ownership," states Vinod Kumar Singh, Additional District Magistrate of Vaishali dis-

Singh emphasizes the importance of this initiative, noting that 60% of land-related crimes in Bihar arise from missing or inaccessible Record of Rights (RoR) documents. Fraudulent claims on land titles have also contributed to the problem. Regarding the Vanshavali

(Pedigree) Form, Singh clarifies that approval is not required from the Sarpanch (Panchayat Head). Individuals can certify and submit the form themselves

along with Self-Declaration Form-2 (Prapatra 2). This form is particularly crucial for ancestral properties, regardless of the type of ownership, such as Khatiyan

Settlement (Bandobust Adhikari) of Vaishali, adds that if land is in the father's name and agricultural rent is being paid, a Vanshavali form is not necessary. However, if the father wishes to distribute the property among his children, the form must be completed along with Self-Declaration Form-2.

Khatiyan is a legal document that records rights related to Khata (Account) number, Kheasara (Plot) number, Mouza (area), tenant's name, and land area. It specifically pertains to ancestral immovable property.

The digitization and mapping efforts through the Special Land Survey are or Property Sale Deed. Special Land Survey are Vipin Kumar Yadav, commendable. By reducing

land disputes, these measures will enable farmers to focus on enhancing agricultural productivity instead of engaging in protracted legal battles. Given that agriculture contributes 18% to India's GDP, improving land record management is crucial for the sector's growth. In conclusion, Bihar's Special Land Survey represents a crucial step towards modernizing land management and resolving persistent land disputes.

By digitizing and mapping extensive land records, the initiative aims to enhance transparency, reduce legal conflicts, and empower farmers to focus on agricultural productivity.

With the goal of completing the survey by August 2025, this project underscores the state's commitment to improving land administration and supporting the agricultural sector, which is vital for Bihar's economy. As digitization progresses, stakeholders can look forward to a more efficient and equitable land management sys-

GANESHA: THE MASTER OF RIDDHI AND SIDDHI

As the first deity, Ganesha guides the soul toward deeper spiritual experiences

ord Ganesh is the swami of Riddhi and Siddhi. Riddhi is the force responsible for prosperity and abundance - material riches and luxury pertaining to the five senses. Siddhi refers to spiritual powers, like extra-sensory perception, clairvoyance, clairaudience, premonition, thought manifestation etc. Ganesh was born of the dirt of Mata Adi Shakti, as she took a bath indicating that all the riddhi and siddhi in creation are nothing but a spec of dirt of the phenomenal force of the Mother. Ganesha is the deity closest to physical creation, the swami of ridhhi and siddhi, which are nothing but Maya, unreality.

They are temporary and bound to leave. The majority spend their life chasing these forgetting the temporary nature of these forces and oblivious to what lies beyond...Ganesha is the first deity, pratham pujya, just the first step to the phenomenal experiences of the world of spirit. Ganesha manifested at a time when impurities started creeping into the society. In due course of time as worldly desires took precedence over spiritual pursuits in ordinary men, different mantras and sadhnas wereprescribed to invoke different aspects of Ganesha, to fulfil specific desires in the realm of the physical, the grossest layer of creation.

Uchchhishta Ganapati is invoked through specific mantras as a giver of boons, as a protector of the motherland or to develop mastery over the five senses. Heramba is the five-headed form of Ganapati, golden in colour and riding a lion. This ten-armed deity is invoked for fearlessness and to defeat one's enemies. Mahaganapati form corresponds to wealth and pleasures, the bestower of bliss. The red-golden Balaganapati is called upon for good health and a bright future. Haridra Ganapati with his turmeric complexion and yellow vestments is theharbinger of prosperity and



Shwetark Ganpati is white and is said to exist in the root of the madar plant, a rare variety of madar that bears white flowers instead of the common purple flowers of Madar. Shwetark Ganpati brings vitality, vigour, strength when kept in the bedroom, intelligence, and concentration in the study room, spiritual powers when worshippedin the puja room, bring luck and prosperity and free the house from evil influences all the time. These sadhnas are extremely potent. They are given according to one's requirement and capacity by the Guru, who is himself a Siddha and does not charge you a fee.

They are a personal relationship between the guru and shisha, not to be discussed and never taught en masse. When the Guru gives the mantra, blessings follow but then it's imperative to balance out that karma, since every action has an equal and opposite reaction, every pleasure has a pain attached to it, for which the Guru shows the way. Guru guides the practitioner on which mantra to practise, for how long, the correct charan and bhava and practices to complement the sauna. After the mantra sadhna, a yagya is performed for the siddhi of the mantra. One of the safest mantras to practice for the manifestation of the shakti of Ganesha is 'gama ganpataye namah' but this too has to be channelized by the Guru for the desired effects.

The success of the sadhna is indicated by the manifestation of the deity in the yagya agni. Sadhaks at Dhyan Ashram who havebeen seriously practising the various mantra siddhis have had physical manifestations of the multiple gods (see image). Ganesh Chaturthi is the night of Siddhi mantra and mantra diksha under the sandhya of a Guru. To experience the power of mantra sadhana and Vedic yagya for the manifestation of thought on Ganesh Chaturthi.

Soviet moves on the Afghan Chessboard



The Soviet Union's botched attempt to poison Afghan leader Hafizullah Amin in 1979 set off a chain of events that reshaped the geopolitical landscape of Afghanistan

he failure of the poisoning attempt to kill Hafizullah Amin led Soviet officials to reconsider their strategy. Soviet doctors, unaware of the assassination plot, treated Hafizullah Amin for food poisoning at his palace. The KGB did not report this failed attempt in their confidential records, deeming it an ineffective method for removing Amin. Consequently, Soviet authorities concluded that a military operation was the only viable option. Karmal and his allies were forced to return to the Soviet Union as the plan was re-evaluated. Ultimately, a decision was made to execute Amin through a carefully planned military assault. The operation on December 25, 1979, saw Soviet special forces, disguised as Afghan soldiers, storm Darul Aman Palace, resulting in significant Soviet casualties, including over 100 special forces personnel and their commanding officer, Colonel Grigory Boyarinov.

The KGB concealed the death toll to protect its reputation, but Vasili Mitrokhin, a senior KGB archivist who defected to the UK in 1992, later exposed the grim details of the operation. His defection, revealing extensive Soviet espionage activities, marked a pivotal moment in the Cold War. The interplay of internal espionage and foreign intervention in Afghanistan, with ineffective Afghan intelligence and CIA-supported Mujahideen, highlighted the geopolitical manoeuvring that exacerbated Afghanistan's instability, including the assassination of Hafizullah Amin and the rise of Babrak Karmal, setting the stage for prolonged conflict.Karmal's rise to power after Amin's assassination marked period of intensified Soviet control in Afghanistan. He sought to justify his regime by denouncing Amin as a CIA agent and framing himself as the rightful defender of the Soviet-backed revolution. Karmal's administration, supported by Soviet intelligence and military aid, aimed to stabilize the country but instead deepened its social and economic problems.

This period underscored the broader geopolitical struggle and the impact of external powers on Afghanistan's turbulent history Taraki's Stalinist purge of the Afghan political party led to widespread imprisonment and execution, with some members exiled or appointed to distant posts. Karmal, who had been made the Afghan ambassador to Czechoslovakia, used his position to plot against Taraki. Faced with the threat of arrest or death if he returned to Afghanistan, Karmal sought asylum from the Czechoslovakian government. The Czechoslovak authorities, concerned about the diplomatic repercussions, consulted with the Soviet Union, which advised granting Karmal asylum and preventing his return to Afghanistan. This marked the start of Karmal's complex political manoeuvring.After being granted asylum, Karmal and his family were relocated to a secret location near Kreislice, under constant surveillance by Czechoslovakia's StB.

Despite a confirmed assassination plot against him, Karmal evaded capture by frequently relocating and maintaining Soviet contact. By December 1979, following Amin's assassination, Karmal became Afghanistan's leader with Soviet backing. His tenure, marked by increased instability and Soviet manipulation, saw him misinterpret domestic unrest as foreign interference and downplay Soviet military presence. Committed to Marxist ideologies, Karmal's conflicts with parliament over religious issues highlighted his dedication to communism. The Soviet intervention starting December

28, 1979, under Karmal's regime, worsened Afghanistan's turmoil, leading to widespread devastation and secretive reporting of casualties, revealing internal KGB struggles.Karmal's leadership, heavily reliant on Soviet military support, ultimately proved ineffective in sta-bilising Afghanistan. The continu-ous conflict led to the rise of the Mujahideen, supported by the US and Pakistan, further destabilising the country. Karmal was replaced by Mohammad Najibullah in 1986, who continued to rule until 1992 when the Mujahideen took control of Kabul, marking the beginning of the first phase of Taliban rule. Karmal's life ended in 1996 in Moscow, and his tenure is remembered as a period of profound strife and political manipulation in

Afghan history.
This power struggle continues to harm Afghanistan. Mahmud Tarzi (1865-1933) noted that 'the and embrace knowledge and reform.' He observed that while Europe advanced through education and modernization, the Muslim world remained entrenched in outdated traditions. Tarzi emphasized that intellectuals should guide their societies from darkness to moder-

This transition from enlightenment to darkness accentuates a deeper issue rooted in Afghanistan's turbulent political history. The events following the 1973 coup, which brought the foreign intelligence agencies of the KGB, CIA, and ISI into Afghanistan's political sphere, illustrate how external powers have long manipulated the country's fate, contributing to its ongoing strife. The overthrow of Mohammad Zahir Shah in 1973 marked the beginning of a period of significant destabilisation in Zahir Shah, who had a nuanced

Afghanistan.

understanding of Afghanistan's needs and implemented substantial social reforms, was succeeded by Mohammad Daoud Khan. Despite Daoud Khan's attempts to seek American assistance, the refusal of support set the stage for Soviet intervention, exacerbating the country's instability. Zahir Shah's return to Afghanistan after the collapse of the Taliban in 2001 symbolised a nostalgic yearning for stability and unity. However, his exclusion from significant political decisions by Hamid Karzai highlights the challenges of integrating historical fig-ures into contemporary politics without disrupting the prevailing power dynamics. The failure of both the Soviet Union's intervention and the subsequent U.S. involvement in Afghanistan underscores a profound lesson about the limitations of foreign military power in achieving lasting political stability. The Soviet Union's reliance on sheer military might and neglect of social and political trust is mirrored by the U.S. and its allies' inability to implement meaningful reforms.

The eventual resurgence of the Taliban and the disgraceful withdrawal of foreign forces, leaving behind modern weapons, epitomises the failure to address Afghanistan's underlying issues. This pattern of short-term military solutions and inadequate attention to genuine structural reforms has led to repeated cycles of conflict and instability, reflecting a broader failure to understand and address the complex socio-political realities of Afghanistan.

External influences, notably from China and powerful Arab states, crucially affected Afghan politics during the Soviet-Afghan War. Amid the China-Soviet ideological rift, Mujahideen groups led by

Ahmad Shah Massoud fiercely resisted both Soviet forces and the Pakistan-backed Taliban. Massoud's declaration, "We will not be pawns in someone else's game, we will always be Afghanistan," underlined his commitment to Afghan sovereignty. Henry Kissinger's covert 1971 visit to China, aimed at under-mining Soviet influence, marked a significant Cold War strategy shift. Despite massive Soviet and U.S. investments, Afghanistan's political instability persisted due to the lack of a coherent strategy to address its complex social and administrative issues. Ultimately, the failure of both superpowers to grasp Afghanistan's intricate social fabric and implement effective governance solutions led to prolonged instability. The U.S. and its allies' focus on aligning with extremist fac-tions, coupled with the Soviet Union's pursuit of a monolithic socialist state, failed to address the real needs of the Afghan people. The resulting chaos not only perpetuated a cycle of conflict but also laid the groundwork for the rise of the Taliban. This historical narrative accentuates the profound consequences of using small nations as pawns in geopolitical games, raising pressing questions about the future of Afghanistan's over fortyone million people under continued turmoil and social repression. The Taliban, ultimately, are not the sole symptom of the decades that Afghanistan plunged into an abyss. As a South Asian nation, Afghanistan's future depends on proactive collaboration with neighbouring countries and strategic efforts to establish strong people-topeople connections, rather than succumbing to isolationism. WHO declares the outbreak of monkeypox as a public health emergency of global proportions, underscoring need for preparedness

ndia is enhancing its preparedness to tackle **▲**Monkeypox (Mpox) by raising awareness, strengthening surveillance, setting up isolated wards, and expanding diagnostic testing capacity. Although a pandemic-like situation has not emerged, all mechanisms are being put in place to curtail the spread of Mpox and its menace. Since January 2023, the Democratic Republic of the Congo (DRC) has reported more than 27,000 suspect Mpox cases and more than 1,300 deaths. Clade I Mpox occurs regularly, or is

endemic, in DRC The current outbreak is more widespread than any previous DRC outbreak, and Clade I Mpox has spread to some neighbouring countries, including Burundi, the Central


African Republic, the Republic of the Congo, Rwanda, and Uganda, and a travel-associated case in Kenya. On August 14, 2024, the World Health Organization (WHO) declared the outbreak a Public Health Emergency of International Concern (PHEIC). This is the WHO's highest level of global alert, and the decision recognizes the potential threat this virus poses to countries around the world.

The declaration focuses international attention on acute public health risks that require the coordinated mobilization of extraordinary resources by the international community for prevention and response. Monkeypox is a virus that transmits from animals to humans. Technically, it is known as a 'viral zoonosis'. Its symptoms are similar to smallpox and cowpox, but fortunately, Monkeypox is less

Cases have been emanated from Central Africa and are reported to be spreading fast across the globe. Common symptoms of Mpox are a skin rash or mucosal lesions which can last 2-4 weeks accompanied by fever, headache, muscle aches, back pain, low enerSo far, no cases have been reported from India.

The Monkeypox virus was discovered in Denmark (1958) among monkeys kept for research. The first reported human case of Mpox was in a nine-month-old boy in the DRC in 1970. Following the eradication of smallpox in 1980, Mpox steadily emerged in central, east and west Africa. In 2003, an outbreak in the United States of America was linked to imported wild animals (Clade II). Since 2005, thousands of suspected cases have been reported in the DRC every year.

In 2017, Mpox re-emerged in Nigeria and continues to spread among people across the country and travellers to other destinations. The naturgy, and swollen lymph nodes. al reservoir of the virus is



unknown - various small mammals such as squirrels and monkeys are susceptible. In May 2022, an outbreak of Mpox appeared suddenly and rapidly spread across Europe, the Americas and then all six WHO regions, with 110 countries reporting about 87 thousand cases and 112 deaths.

Monkeypox virus (MPXV) outbreak that began in 2022 demonstrated the pandemic potential of Mpox. Clade I MPXV is endemic in several Central African countries, including the Democratic Republic of the Congo (DRC). Clade I is generally associated with higher case fatality rates (CFRs) (1.4% to >10%) compared with Clade II MPXV 0.1% to 3.6%).

MPXV can spread to persons from contact with infected wildlife, or through close, prolonged contact with persons infected with MPXV. During 2023-2024, DRC has reported an unprecedented number of suspected Clade I MPXV infections. Clade I MPXV transmission in DRC is more commonly reported among mission is reported because of zoonotic reservoirs, household occupants, and unhygienic resources.

Diagnosis and reporting of Clade I MPXV infections to health officials are important for limiting onward transmission by aiding early containment measures, including contact tracing, isolating patients, offering the JYNNEOS vaccine to contacts, and strictly adhering to recommended infection prevention and control practices in health care settings. Shooting at West Bank-Jordan border kills 3 Israelis

Three Israelis were shot and killed Sunday at the border crossing between the West Bank and Jordan, Israeli officials said, in what appeared to be an attack linked to the 11-month-old war in Gaza. The military said the gunman approached the Allenby Bridge Crossing from the Jordanian side in a truck and opened fire at Israeli security forces, who killed the assailant in a shootout. It said the three people killed were Israeli civilians. Israel's Magen David Adom rescue service said they were all men in their 50s. Jordan is investigating the shooting, its state-run Petra News Agency reported. The Western-allied Arab country made peace with Israel in 1994, but is deeply critical of its policies toward the Palestinians. Jordan has a large Palestinian population and has seen mass protests against Israel over the war in Gaza. The Allenby crossing over the Jordan River, also known as the King Hussein Bridge, is mainly used by Palestinians and internation al tourists, as well as for cargo shipments. The crossing has seen very few security inci-

Authorities search for shooter on I-75 in Kentucky; 7 hurt

A manhunt was under-way early Sunday as police searched for a gun-man in a rural area. man in a rural area of southeastern Kentucky near Interstate 75, according to authorities who said up to seven people were hurt in the shooting and a vehicle accident that accompanied the violence.

The shooting began just after 6:30 pm Saturday and was followed by an Deputy Gilbert Acciardo, public information officer The Laurel County London. Sheriff's Office said in a

post on Facebook that it was an "active shooter situation" and "numerous persons" were shot near the highway. In a video statement, London Mayor Randall Weddle said he was told seven people were hurt, but not all of those were wounded by gunfire. Some of the victims were injured in an accident when the shooting

London, a small city of about 8,000, is located about 75 miles (120 km) south of Lexington. "There are no deceased at this time. No one was killed from this, thankfully, but we ask that you continue to pray," Weddle

started, he said.

Hospital officials at Saint Joseph London said in a state-ment that the facility was treating multiple patients, LEX 18 reported. The hospital added that the people it received had minor injuries. Jay Blanton, a spokesperson for the University of Kentucky Albert B. Chandler Hospital, said two victims were admitted but he did not have any information on their conditions. The sheriff's office also announced that a "Person of Interest" has been identified in connection with the shooting, saving he should be considered armed and dangerous and people should not approach him. The man's name was given as Joseph A Couch, a 32-year-old white male, and anyone with information about his location was urged to call the county 911 centre.

González flees Venezuela for asylum in Spain Experts from the United

Former Venezuelan opposition presidential candidate Edmundo González has fled into exile after being granted asylum in Spain, delivering a major blow to millions who placed their hopes in his upstart campaign to end two decades of single-party rule.

The surprise departure of the man considered by Venezuela's opposition and several foreign governments to be the legitimate winner of July's presidential race was announced late Saturday night by Venezuelan Vice President Delcy Rodríguez. She said the government decided to grant González safe pas-

sage out of the country, just days after ordering his arrest, to help restore "the country's political peace and tranquilli-

Neither González nor opposition leader Maria Corina Machado has commented.

government said the decision to abandon Venezuela was González's alone and he departed on a plane sent by the

country's air force. Foreign Minister José Manuel Albares told Spanish national broadcaster RTVE that his government will grant González political asylum as he has requested. Albares spoke while en route to China with Spanish Prime Minister Pedro Sánchez on a state visit."I have been able to speak to (González) and once he was aboard the airplane he expressed his gratitude toward the Spanish government and Spain," Albares said. "Of course I told him we were pleased that he is well and on his way to Spain, and I reiterated the commitment of our government to the political rights of all Venezuelans.

Sánchez said in a speech Friday, before González's departure was announced, that the opposition leader was "a hero whom Meanwhile, Spain's centre-left Spain is not going to abandon."

Albares said that González had spent an unspecified number of days at the Spanish Embassy in Caracas before his departure. A Spanish official with knowledge of details on González's departure said that his government did not discuss González's exit with Maduro's administration. The official spoke on condition of anonymity in line with ministry protocols.

González, a 75-year-old former diplomat, was a last minute stand in when Machado was banned from running. Previously unknown to most Venezuelans, his campaign nonetheless rapidly ignited the hopes of millions of Venezuelans desperate for change after a decade-long economic freefall.While President Nicolás Maduro was declared the winner of the July vote, most Western governments have yet to recognise his victory and are instead demanding that authorities publish a breakdown of votes.

Meanwhile, tally sheets collected by opposition volunteers from over two-thirds of the electronic voting machines indicate that González won by a more than 2-to-1 margin. The tally sheets have long been considered the ultimate proof of election results in Venezuela. In previous presidential elections, the National Electoral Council published online the results of each of the more than 30,000 voting machines but the Maduro-controlled panel did not release any data this time, blaming an alleged cyberattack mounted by its opponents from North Macedonia. Attorney General Tarek William Saab, a staunch Maduro ally, sought González's arrest after he failed to appear three times in connection with a criminal investigation into what it considers an act of electoral sabotage. Saab told reporters the voting records the opposition shared online were forged and an attempt to undermine the National Electoral Council.

Nations and the Carter Centre, which at the invitation of Maduro's government observed the election, determined the results announced by electoral authorities lacked credibility. In a statement critical of the election, the UN experts stopped short of validating the opposition's claim to victory, but they said the voting records it pub lished online appear to exhibit all of the original security features. Spain has been a major of exodus Venezuelans, particularly of those leading opposition to Maduro's regime. They include Leopoldo López, who fled to Spain to reunite with his family in 2020, and Antonio Ledezma, who left for the European country in 2017. Boeing and union face final talks & possible strike

Dallas (AP) Boeing and its largest union are entering the last week of contract negotiations before a threatened strike by more than 30,000 workers who build the planes that carry millions of airline passengers every year.

A walkout would add to the headwinds facing Boeing, which is hurtling toward a sixth straight money-losing year and just hired a new CEO to turn things around. The regional branch of the International Association of Machinists and Aerospace Workers says the two sides are far apart on wages, health care and job security. The union of started out seeking pay raises of more than 40% over three years, although "that's probably not where we're going to end up," IAM District 751 President Jon

Holden said last week.

The union has scheduled a two-part election for Thursday, with voting at more than a half-dozen locations in Washington state and one in Southern California. Workers will vote on Boeing's last contract offer and whether to authorize a strike if the offer is rejected. A walkout could begin by Friday morning.

A straw vote in July to gauge support for a strike passed with 99.99% support, according to the union. "What we are asking for is reasonable," Holden said in an interview. 'We need to get more wages to address the very low increases over the last 10 years, massive inflation, massive costshift on health care. We are trying to reach an agreement,

isn't afraid to tap it. Boeing declined to make an executive available to discuss the labour negotiations. A spokesperson provided a onesentence statement.

'We're confident we can reach a deal that balances the needs of our employees and the business realities we face as a company," the statement said. Boeing's new chief executive, Kelly Ortberg, has tried to take a conciliatory posture toward labour. He is working in Seattle, to be near the factories where the company builds most of its commercial airplanes, instead of at headquarters in Arlington, Virginia. He walked the floor of the 737 Max plant during his first day ready to take action if we on the job.

"He understands that they are basically contentious relationships with the union, and he wants to make those relationships better," TD Cowen aerospace analyst Cai von Rumohr

Ortberg already has a long to-do list. The new CEO will try to fix Boeing's aircraft-manufacturing process, gain regula-tory approval for the longdelayed 777X jumbo jet, limit damage from over-budget government contracts, pay down \$45 billion in net debt, and absorb Spirit AeroSystems, the money-losing key supplier that Boeing just bought for \$4.7 billion.

Ortberg's toughest job will be restoring Boeing's reputation for quality, which was crushed after two 737 Max jets crashed less than five months apart in 2018 and 2019, killing 346 people, and took another big hit when a door plug blew off a Max during an Alaska Airlines flight in January. Unlike strikes at airlines, which are very rare, a walkout at Boeing would not have an immediate effect on consumers. It would not result in any canceled flights. It would, however, shut down production and leave Boeing with no jets to deliver to the airlines that ordered them.

"During a strike, they don't work on planes, they don't deliver planes," von Rumohr said. Aircraft makers typically get about 60% of the purchase price on delivery, "so not delivering planes has a massive impact on your cash in-flow, and your costs probably continue on?

An eight-week strike in 2008, the longest at Boeing since a 10-week walkout in 1995, cost the company about \$100 million a day in deferred revenue.

Meeting the union's wage demand would cost Boeing \$1.5 billion in cash, which is "a small price to pay versus a strike," Jefferies aerospace analyst Sheila Kahyaoglu said. In a note to clients, she estimated a strike would cost the company about \$3 billion, a calculation based on the impact of the 2008 strike plus inflation and current airplaneproduction rates.

Boeing is in far worse financial shape than it was in 2008. The company has lost \$27 billion since the start of 2019, around the time that its best selling plane, the 737 Max, was grounded worldwide after the rashes in Indonesia and Ethiopia. Revenue is down, debt is up.

Typhoon Yagi kills 14 people in Vietnam

Hanoi (AP): At least 14 people have died and 176 others injured in Vietnam after Typhoon Yagi slammed the country's north, state media said Sunday, as officials warned of heavy downpours despite its waning power. Described by Vietnamese officials as one of the most powerful typhoons to hit the region over the last decade, Yagi left more than 3 million people without electricity in northern Vietnam. It also damaged vital agricultural land, nearly 116,192 hectares where rice and fruits are mostly grown. Hundreds of flights were cancelled after four airports were closed. The typhoon made landfall in Vietnam's northern coastal provinces of Quang Ninh

and Haiphong with wind speeds of up to 149 kilometres per hour (92 miles per hour) on Saturday afternoon. It raged for roughly 15 hours before gradually weakening into a tropical depression early Sunday morning. Vietnam's meteorological department predicted heavy rain in northern and central provinces and warned of floods in low-lying areas, flash floods in streams and landslides on steep slopes. Municipal workers along with army and police forces were busy in the capital, Hanoi, clearing uprooted trees, fallen billboards, toppled electricity poles and rooftops that were swept away, while assessing damaged buildings.

Evidence against Imran Khan points towards military trial'

Pakistan's Defence Minister Khawaja Asif has said that the evidence against jailed former prime minister Imran Khan points towards a military trial in the cases concerning the violence on May 9 last year, a media report said on Sunday. Speaking to a private news channel on Saturday, Asif said that military trials had taken place before and will continue to do so in future as well, Geo News reported.

"Evidence against founder Pakistan Tehreek-e-Insaf party founder (Imran Khan) points towards military trial," Asif

His remarks come after 71year-old Khan - fearing a military trial over his alleged involvement in the May 9 riots - filed a petition in the Islamabad High Court (IHC) to stop his potential trial in military courts.

However, the IHC registrar's office raised objections over Khan's plea, saying that neither it mentioned any specific first information report (FIR) nor any documentation or order was attached to the petition and how a petition be filed in a high court while the matter of military trials is sub judice in the

Supreme Court. It is not the first time that the ruling Pakistan Muslim League-Nawaz (PML-N) expressed such a possibility. Several leaders of the party have accused Khan of orchestrating the May 9, 2023 vio-

Russian drone violated A Romania's airspace during nighttime attacks on neighbouring Ukraine, the NATO member reported Sunday, urging Moscow to stop what it described as an escalation.

The incident occurred as Russia carried out attacks on "civilian targets and port infrastructure" across the Danube River in Ukraine, Romania's Ministry of National Defence said.Romania deployed F-16 warplanes to monitor its airspace, and NATO allies were kept informed, the ministry said. Romanian emergency authorities also issued text alerts to residents of two eastern regions.

Preliminary data indicates there may be an "impact zone" in an uninhabited area near the Romanian village of Periprava, the ministry said. It added that an investigation is under-

Since Russia invaded Ukraine in February 2022, Romania has confirmed drone fragments on its territory on sev eral occasions and as recently as July this year.

The Romanian Defence Ministry strongly condemned the Russian attacks on Ukraine, calling them "unjustified and in serious contradiction with the norms of international law." Mircea Geoana, NATO's outgoing deputy secretary-general and Romania's former top diplomat, said the military alliance also condemned Russia's violation of Romanian airspace. "While we have no information indicating an intentional attack by Russia against Allies, these acts are irresponsible and potentially dangerous," he wrote on X. Civilians reported killed in

UN official says Sudan war Moon had surprisingly recent volcanic activity has killed 20,000 people

Cairo (AP): More than 16 months of war in Sudan has killed more than 20,000 people, a senior United Nations official said on Sunday, a grim figure amid a devastating conflict that has wrecked the northeastern African country

Ghebreyesus, director general of the World Health Organisation, gave the tally at a news conference in Sudan's Red Sea city of Port Sudan, which serves as the seat of the internationally recognised, military-backed government.

He said the death toll could be much higher. "Sudan is suffering through a perfect storm of crisis," Tedros said as he wrapped up his two-day visit to Sudan. "The scale of the emergency is shocking, as is the insufficient action being taken to curtail the conflict."

Sudan was plunged into chaos in April last year when simmering tensions between the military and a powerful paramilitary group, the Rapid Support Forces, exploded into open warfare across the country. The conflict has turned the capital, Khartoum, and other urban areas into battlefields, wrecking civilian infrastructure and an already battered health care system. Without the basics, many hospitals and medical facilities have closed their doors.

The conflict has created the world's largest displacement crisis. More than 13 million people have been forced to flee their homes since fighting began, according to the International Organisation for Migration. They include over 2.3 million who have fled to neighbouring countries as

Lancaster (The Conversation): Volcanoes were erupting on the Moon as recently as 120 million years ago, evidence collected by a Chinese spacecraft suggests. Until the last few years,

scientists had thought volcanic activity ended on the Moon around 2 billion years ago. The findings, published in Science, come from analysis of lunar rock and soil delivered to Earth by China's Chang'e 5 spacecraft in 2020. While these results are difficult to reconcile with the accepted history of lunar volcanism, it's possible some areas of the Moon's interior were more enriched in radioactive elements that generate the heat that drives volcanic activity. The region where Change 5 landed, called Oceanus Procellarum, may be one such area where rocks were enriched

Volcanism is a major way in which all rocky planetary bod-

in these heat-producing ele-

ies lose their heat. The rocky bodies in our Solar System are Earth, Venus, Mars, Mercury, Jupiter's satellite Io, and Earth's satellite, the Moon. All available evidence suggests that Venus is currently volcanically active. On Mars, we can date the ages of formation of large lava flows by counting the numbers of impact craters on these flows.

This crater-counting technique relies on the fact that craters form randomly and uniformly across planetary surfaces, so highly cratered terrains are considered older. The results suggest that Mars, which is half the size of Earth, is volcanically active every few million years.

This is expected, because larger bodies conserve heat better than smaller ones. On this basis Mercury, which is a third of Earth's size, and our Moon, a quarter the size of Earth, should have been volcanically dead for

about 2 billion years. The same should be true of Io, Moon. However, tidal forces generated by gravitational interactions with Jupiter give Io an additional, strong heat source. Io is very volcanically active as

Most eruptions on the Moon took place near the edges of giant depressions formed early in the Moon's history by asteroid impacts. Lava flooded the interiors of these basins to form the dark areas on the Moon's near side. These areas are call maria (singular mare), the Latin for seas, because the flat sheets of lava were mistaken for expanses of water by early observers.

Analyses of the composition and age of samples returned from these mare areas by the six Apollo missions and three Soviet robotic probes were consistent with the belief there had been no geologically recent vol-

canic activity on the Moon. This understanding persisted

which is similar in size to our until very high-resolution images of the lunar surface the US Lunar Reconnaissance Orbiter mission became available following the mission's launch in 2009. Counts of the numbers of very small impact craters revealed a lack of craters in some volcanic areas with unusual surface textures, named irregular mare patches (IMPs). The simplest explanation for this was that these IMPs were young, typically about 100 million years old. This is 20 times younger than the 2 billion-year youngest age that had been expected. In an attempt to reconcile

> these observations with the accepted history of lunar volcanism, it was pointed out that the lack of any atmosphere on the Moon would make eruptions there significantly different from those on Earth. The lack of confining pressure would have allowed erupting lavas to release almost all of the gaseous

compounds dissolved in them. allowing some lava flows to contain very large numbers of gas bubbles - to the extent of being a foam. Meteoroid impacts into this soft foam would produce much smaller craters than in solid rock, thus causing the crater-counting method to give ages that were too young.

This issue has seen much debate, and the best way to resolve it is the return of samples to Earth for detailed laboratory analysis. Chang'e 5 brought back samples from a very large lava flow which was already known, from cratercounting, to be relatively young in geological terms.

The three "volcanic droplets" identified in the Change 5 sample were probably not erupted from the same vent as the bulk of the rock and soil delivered to Earth. This would explain why these droplets are much younger than the lava flow at Change 5's landing site.

GST Council to deliberate on insurance premium, online gaming taxation

The GST Council on Monday is expected to deliberate on a host of issues, including taxation insurance premium, GoM's suggestions on rate rationalisation, and a status report on online gaming, sources said.

Sources said the fitment committee, comprising Centre and state tax officials, will present a report on GST levied on life, health and reinsurance premiums and the revenue implications.

The GST Council, chaired by Finance Minister Nirmala Sitharaman and comprising state ministers, will decide on whether to reduce the tax burden on health insurance from the current 18 per cent or exempt certain categories of individuals, like senior

The deliberations will also happen with regard to the goods and services tax (GST) life insurance

In 2023-24, the Centre and states collected Rs 8,262.94 crore through GST on health insurance premium, while Rs 1,484.36 crore was collected on account of GST on health reinsurance premium.

The issue of taxation on insurance premium figured in Parliament discussions with opposition members demanding that health and life insurance premiums be exempt from GST. Even Transport Minister Nitin Gadkari wrote to Sitharaman on the issue.

Finance Minister Nirmala Sitharaman in her reply to discussion on the Finance Bill had said 75 per cent of the GST collected goes to states and opposition members should ask their state finance ministers to bring the proposal at the GST Council. West Bengal Finance Minister Chandrima Bhattacharya had raised the issue in the meeting of the Group of Ministers (GoM) on rate rationalisation

last month and the matter was referred to the fitment committee for further data

analysis.

The GoM had opined against any tinkering of four-tier GST slab of 5, 12, 18, and 28 per cent for the time being. The panel, however, had asked the fitment committee to look into any scope for into any scope for rationalisation of rates of goods and services. With regard to online gaming,

Centre and state tax officers will present a "status report" before the GST Council. The report would include GST revenue collection from the online gaming sector before and after October 1, 2023. From October 1, 2023, entry

level bets placed on online gaming platforms and casinos were subject to 28 per cent GST. Prior to that, many online gaming companies were not paying 28 per cent GST, arguing that there were differential tax rates for games of skill and games of chance. The GST Council in its



meeting in August 2023 had clarified that online gaming platforms were required to pay 28 per cent tax and subsequently Central GST law was amended to make the taxation provision clear.



WE DESERVE SAME RESPECT, SAYS NAVDEEP AFTER TURNING TAUNTS INTO TRIUMPH

avdeep Singh, who suffered from dwarfism, endured not just the usual rigours of training but cruel taunts while from onlookers growing up in his village in Haryana's Panipat district. On Saturday, having turned

those taunts into his biggest triumph on sport's grandest stage, the four feet four inches tall para athlete expressed his concerns with the indignities visited upon people whose bodies don't fit the usual moulds, and demanded "same respect" for them.

The 23-year-old Indian javelin thrower won an unparalleled gold in the F41 classification at the Paris Paralympic Games.

"Humein bhi utna darja milna chahiye, maine bhi desh ka naam roshan kiya hai (We deserve the same respect, I too have brought glory to the country," Navdeep said, flashing his gold medal in a video shared Paralympic Committee of India (PCI).

"My aim is to educate society that we also exist in this world and nobody should make fun of us, which is often the case. We also can make our country proud.

"There were a lot of hurdles initially but I kept at it and strengthened myself, which led to good results. This is the biggest moment of my life, I feel proud to sign off with a gold medal," he added.

As the track and field competitions concluded at the Paris Games, Navdeep's golden throw in the final ensured the hallowed Stade de France echoed with the Indian national anthem.

His personal best effort of 47.32m initially placed him in second position but it was upgraded to gold after the top finisher, Iran's Sadegh Beit Sayah, was disqualified for repeatedly displaying an objectionable flag. It was a defining moment for Navdeep who silenced all his

doubters.

Born prematurely in 2000, Navdeep's struggles began from the start.

It wasn't until he was two years old that his parents realised their son had

dwarfism, setting the stage for a life filled with both struggles and triumphs. His father, Dalbir Singh, a

national-level wrestler, kept motivating him and saw his son as an extension of his

own aspirations. Navdeep started his athletic journey at the age of 10, dabbling in wrestling and sprinting before finding his true calling in javelin throw after being inspired by national icon Neeraj Chopra. "The first thing that comes

to my mind is my dad (Dalbir Singh). I really miss my family now. Initially, it felt like a burden. wondered why I couldn't enjoy life like others -- go to school and have fun.
"But he (dad) kept me

motivated and on track. In this journey, I can't credit just one person. Champions are made with support, so my coach, my family, the government contributed to our success, taking our medal tally beyond the expectation of

25, reaching 29 already."

Navdeep made his international debut at the Asian Youth Para Games, clinching his first gold medal and setting the stage for a remarkable career.

He continued to train tirelessly at the Sports Authority of India (SAI) centres in Gandhinagar and Bangalore, honing his skills

At the Fazza International Championship in Dubai in 2021, he secured another gold medal.

Amid high expectations, Navdeep also faced setbacks, finishing fourth at the Tokyo Paralympics three years ago and Asian Para Games last year. He finished with a bronze at the World Para Athletics Championship in 2024, and faced criticism.

2024, and faced criticism.
"I suffered a lot, so I wanted to achieve something for my country. My event was on the last day, but I came on the August 31, so I kept preserving myself.
"I heard things like, 'He can't do this, he only performs well in India, but fails in competition.' I heard these from several quarters, but I just had to ignore all this. I just needed guidance and the right path. right path.

carried all my past baggage, the training, the hard work, the criticisms. I knew I had to unleash all of this on the September 7, and I did that and won."

He also spent years away home, training relentlessly with limited resources, often making do with basic meals and cooking alongside his roommate and friend Sumit Antil, who smashed his own record to win javelin gold in F64 category.

"It has been a struggle for six years (2017-2024). I stayed away from my home, eating whatever was available. Sumit and I used to stay together; we are good friends and roommates.

"Initially, we would eat outside but ended up with upset stomachs, so we started cooking ourselves," Navdeep recalled. "I started with (a throw of) 11 metres initially and now reached 47; I never thought of it. The performance was better than what I expected. I will work harder from now on and will try to win more gold medals for India," he



France wins gold in blind football at Paralympics under Eiffel Tower lights

 $F^{\text{rance defeated Argentina 3-}}_{\text{2 on penalties under the lights of the Eiffel Tower for}}$ the gold medal in blind football on the penultimate day of the Paralympic Games. Frederic Villeroux scored the decisive spot kick to get the partisan home fans' party underway after the teams drew 1-1 in normal time on

Saturday. Saturday.
"It felt like the script of a film," said Villeroux, who also made the breakthrough in the 12th minute when he rifled a shot inside the left post.

Argentine star forward Maximiliano Espinillo replied from close range straight away after the French defenders

failed to clear the ball.

"You have to take the good and accept the bad, but we are still very proud," Espinillo said.

France is the first team other than Brazil to win blind football at a Paralympics. Brazil won all five previous golds since it was first played at the 2004 Athens Games.

The five-time defending champion, which had never lost a match before Thursday's penalty loss to Argentina in the semifinals, was consoled by the bronze medal after a 1-0 win over Colombia thanks to a fierce strike from Jefinho in the 24th minute.

Known as the "Paralympic Pelé" because of speed and skill, Jefinho scored in off the left post despite facing two defenders, setting off a roar of appreciation around the Eiffel Tower Stadium.

"Today we left all disappointments behind and were able to win," Jefinho said. Blind football is an adaptation of soccer for teams of five players with an audible ball of rattles. The four outfield players must be classified as completely blind, while the goalkeeper is sighted and instructs his teammates where to go. A guide behind the opposition goal also instructs the attacking players.

Though the four outfield Argentine players couldn't have seen the sea of French flags around the stadium, they would have heard the fevered rendition of the French anthem around them, and chants of "Allez les Bleus" from the home crowd. The fans were quiet when the ball was in play so the players could hear their guides' instructions.

As fulltime approached, the supporters started a boisterous

Mexican wave during a break in play. It continued silently when play resumed - so the players would not be disturbed.

More golds for the US

On another solid day for United States athletes, Jake Williams scored 26 points as the men won the wheelchair basketball gold by beating Britain 73-69.

That made it three from three for the U.S. In Games basketball after the men and women won thrilling finals against France at the Olympics last month, also at Bercy Arena.

Fans at Bercy are used to hearing "The Star-Spangled Banner" and they will listen to it again if the women's team wins its final against the Netherlands on Sunday.

Earlier, Germany's men won the bronze-medal match against Canada 75-62.

Meanwhile, the U.S. Sitting volleyball team made it three golds straight by defeating China 3-1 in the women's final. The Americans have won every title since 2016 in Rio de Janeiro.

The U.S. Equestrian team won three more medals in Paralympics dressage, and Fiona Howard and Rebecca Hart clinched their third gold medals of the Paris Games.

The Paralympic debutant Howard won the Grade II individual freestyle and the veteran Hart won it in Grade III. Earlier, teammate Kate Shoemaker claimed bronze in Grade IV.

Riders compete in five grades, with Grade I for the most severely impaired riders. Howard

won individual golds this week and helped the U.S. Win the team event on Friday.

Long may it continue

American swimmer Jessica Long extended her mammoth Paralympics medal collection to 31 with gold in the S8 100-

meter butterfly. She won in 1 minute, 10.59 seconds at La Défense Arena, finishing one second clear of Viktoriia Ishchiulova. Britain's Alice Tai was third.

The 32-year-old Long also won the women's 400 freestyle

on Wednesday. Her Paralympic career started

when she was 12 and won three golds at the 2004 Athens Games. S8 is for swimmers with the absence of limbs. Long is a double amputee.

NEW ZEALAND SEEKS TO EXPLOIT AFGHANISTAN'S RED-BALL INEXPERIENCE IN TEST

New Zealand will aim to exploit Afghanistan's relative inexperience in red-ball cricket, in the one-off Test starting here from Monday, and gather momentum ahead of their upcoming World Test Championship challenges in the sub continent.

New Zealand's first-ever Test against Afghanistan will kick off a challenging couple of months for the Black Caps who play six long-format matches on the bounce in the subcontinent, something they haven't done in 40 years.

With their underwhelming subcontinent record in mind (40 losses in 90 matches), New Zealand would want to hit the straps straightaway.

Senior batter Kane Williamson has emphasised on the need to adapt to conditions and with three games under their belt, they would be well prepared for the marquee series against India next month.

Spin is expected to dominate proceedings and New Zealand have come well prepared with five slow bowling options.

Left-arm spinner Ajaz Patel, who returns to India for the first time since his 10-wicket haul in Mumbai in 2021, is expected to make the playing

Rachin Ravindra, who has been sweating it out in CSK High Performance Centre in Chennai, is expected to be handy with bat and ball while all-rounders Glenn Phillips, Mitchell Santner and Michael Bracewell are vying to fill the

remaining spinners' spots.
Matt Henry is New Zealand's best seamer at the moment but captain Tim Southee's dip in Test form will be a concern. Will O'Rourke, or express pacer Ben Sears may be given

"In six years, nine games is not more. We are new in this format. We need more experience. If we get more chances on a regular basis, we will

improve a lot.
"It's in the hands of the ACB and ICC. When it comes to Test cricket, some players are different from those who play

in the leagues." Shahidi, who has a Test double century, feels a longer run of red ball fixtures will help the Afghans hone their skills


"If we get three-four match series at a stretch, it will be helpful for us as a side. If you look at our past, we would prepare only 10 days ahead of a Test match.

"It's not easy to come to red-ball cricket, by just playing in the nets. Only if you play matches, will you get better at judging the ball."

The game against New Zealand is historic as it will be the first time these two side clash in the longest format.

Indian cricket powerful, talent comes from everywhere says Rahul Dravid

The legendary Rahul Dravid on Sunday said that Indian cricket has evolved into an "extremely powerful" force, thanks to the growing talent pool that now extends to even the remotest corners of the country.

Dravid, who masterminded India's triumph in the T20 World Cup, said a strong club cricket culture has a lot to do with bucking the old trend of city cricketers dominating the passage to the national team. "If you look at Indian cricket today, Indian cricket is extremely strong, it's extremely powerful. One of the big reasons for that is that talent comes from everywhere, from all over the country," said Dravid during the 50th year celebration of Mount Joy Cricket Club.

"I think if you go back to the time of say GR Vishwanath or even when I was starting out my career, most of the talent came from the big cities or from few other states.

"Even if they were talented boys in smaller places, they to play cricket. But today I think you see in Indian cricket that boys are coming from everywhere," he added. Dravid said it's getting reflect-

ed in the standards of domestic cricket in India.

You just look at the standard of the Ranji Trophy.

In the old days when you played in the South Zone, other than playing Hyderabad or Tamil Nadu, I think it is fair to say, without being disrespectful, that a lot of other



teams you could take it not for granted but you could certainly take it a little bit more light-

I don't think there is any

team in the South Zone today that you can walk in and say that you will comfortably beat," he added. 'Hailing the club cricket struc-

ly in Karnataka, Dravid said the system has allowed the sport to remain accessible to

'We need clubs to be strong. We need cricket not to be concentrated in the hands of a few people. We need cricket to be egalitarian, we need it to be all over the place.

"You cannot have talent or you cannot have facilities concentrated only in one or two

places.
To get the best out of talent,

we need to ensure that young boys and girls are getting access to good infrastructure in every part," he noted.

The 51-year-old former Indian captain then briefly revisited his club career when he was young to underscore the need for that system to thrive.
