# **SC** directs protesting doctors in West Bengal to return to work immediately

Protest cannot be at the cost of duty," the Supreme Court observed on Monday as it directed the West Bengal doctors protesting over the rape and killing of a postgraduate medic at the State-run RG Kar Medical College and Hospital in Kolkata to return to work immediately.

A bench headed by Chief Justice DY Chandrachud directed the protesting doctors to get back to work by 5 pm on Tuesday and assured them that there will be no adverse action if they resume

"The State of West Bengal must take steps to create confidence in the minds of the doctors that their concerns regarding their safety and security are being duly attended to. In order to ensure this, all the district collectors and SPs (superintendents of police) shall take stock of the situation in all Government medical colleges and public hospitals and provide adequate safety.

"We also direct that in the event the doctors return to duty on or before 5 pm (on Tuesday), adverse disciplinary action should be taken against them. If there is continued abstention of work, there may be a likelihood of

adverse action," the bench, also comprising Justices JB as doctors are on strike Pardiwala and Manoj Misra, protesting against the rape

The court said the protesting doctors cannot be oblivious to the needs of the general community. "Any protest cannot be at the cost of duty. The young doctors must now return and attend to the patients. We know what is happening on the ground. First, return to work. The district collectors and superintendents of police will ensure (your) safety. You have to now return to work," the bench said.

Appearing in the court on behalf of the West Bengal Government, senior advocate Kapil Sibal submitted that 23

people have died in the State and killing that has triggered nationwide protests.

The Supreme Court also voiced concern over the absence of a key document that was needed for the postmortem of the medic raped and murdered at the RG Kar Medical College in Kolkata, and asked the ČBI to investigate into it. The court also flagged that

there was at least a 14-hour delay by Kolkata Police in registering FIR in rape and murder incident. The top court directed the CBI to submit a fresh report by September 17 on the probe in the case. The apex court also directed immediate removal of photographs of the victim all social media platforms to protect the dignity and privacy of the deceased.

On the issue of security of medical institutions in the State, the Supreme Court said "All DMs, SPs in West Bengal to take stock of situation to ensure safety, security of Government medical colleges".

The apex court also directed a senior officer of the West Bengal Government's Home department and a senior CISF officer to ensure all three companies of the CISF, which are deputed for security at the RG Kar Hospital, are given

# Little hopes of alliance in Haryana as AAP declares first list

#### What could be the first indication of the failure of a poll alliance or pressure tactics on the Congress for an alliance, the Aam Aadmi

Party (AAP) on Monday decided to go solo in the Haryana Assembly polls as it released its first list of 20 candidates. This comes amid days of hectic parleys between the two parties over seat-sharing arrangements that dragged on looking at the nomination window for the polls closing on September 12. This decision could complicate the potential alliance between the AAP and the Congress in Haryana and might impact the possibility of the two major INDIA bloc allies coming together for the Delhi Assembly polls next year. Interestingly, the AAP has

fielded candidates from at least 12 seats including Naraingarh, Assandh, Samalkha, Uchana Kalan, Dabwali, Meham, Rohtak, Bahadurgarh, Badli, Beri, Mahendragarh and Badshahpur where the Congress has already announced its candidates. Interestingly, AAP has fielded its party's vice president of Harvana unit, Anurag Dhanda from Kalayat, which is considered to be a stronghold of former chief minister and veteran

Official sources said the aeroengines will be manufactured by the Koraput division of HAL and are expected to fulfil the need of the Indian Air sustain the operational capability of the

Su-30 fleet. The deal for the engines comes amid concerns over the depleting fleet of the IAF's fighter squadrons and delays in the supply of Tejas jets by HAL. The number of the IAF's fighter squadrons has come down to around 30 as against the authorised strength of at

The contract agreement was inked by senior officials of the ministry and the HAL in the presence of Defence Secretary Giridhar Aramane and Chief of Air Staff Air Chief Marshal VR Chaudhari. The HAL would supply 30 aero-engines annually as per the contractual delivery schedule. The supply of all 240 engines would be completed over the next eight years, according to the defence ministry.

"During manufacturing, HAL plans to take support from the defence country's manufacturing ecosystem, involving MSMEs and public and private industries," said the official.

"By the end of the delivery programme, HAL would enhance the indigenisation content up to 63 per cent to achieve an average of over 54 per cent," the defence ministry said. It said this would also help increase the indigenous content of repair and overhaul tasks of the aero-engines.

February 2022 and a Local Currency Settlement (LCS) System in July 2023 to promote the use of Indian Rupee and AED (United Arab Emirates Dirham) for cross-

border transactions. The two countries are among each other's top trading partners with a bilateral trade of about USD 85 billion in according to official data. The UAE is also among the top four investors in India in terms of foreign direct investments in 2022-23.

About 3.5 million strong and vibrant Indian community forms the largest expatriate group in the UAE. The UAE was invited as special invitee for G20 during India's Presidency of the grouping. In Feb 2023, the India-UAE-France (UFI) trilateral was formally launched. With India's active support, the UAE joined SCO as dialogue partner in May 2023. The UAE also joined BRICS as a member on January 1 with India's support. The India-UAE defence cooperation has also witnessed a renewed momentum in the last few years. In January 2024, the first India-UAE bilateral army exercise 'Desert Cyclone' was held in Rajasthan.

Nahyan also called on the President Draupadi Murmu at the Rashtrapati Bhavan during which she praised the UAE leadership for ensuring the welfare, particularly the special care taken during the difficult times of the Covid pandemic, of more than 35 lakh Indian citizens in the West Asian country.

# Kalindi Express train accident averted, sabotage not ruled out

KANPUR /NEW DELHI

¬or the second consecutive day yet another major train accident was averted as the Bhiwani-Prayagraj Kalindi Express was brought to a screeching halt after hitting an LPG cylinder placed on the tracks. In what appears to be a sabotage, a bottle of petrol and matchboxes were recovered from the site. Police said the incident occurred around 8.20 pm on Sunday when the train was running at a high speed.

An FIR has been registered in the matter and multiple teams have been formed to probe the Commissioner of Police (West) Rajesh Kumar Singh said the Uttar Pradesh Anti Terrorist

Squad (ATS) has launched an

investigation separately.

"An attempt was made to derail the Kalindi Express by placing the LPG cylinder on the tracks. after receiving information about the incident around 8.20 pm on Sunday, senior officials rushed to the site and launched investigation," police said.

A forensics team was also called in and the Railway Protection Force (RPF) is also investigating the matter, they

Additional Commissioner of Police (Law and Order) Harish Chandra said the loco pilot saw that the LPG cylinder was placed on the tracks and applied emergency brakes. However, before it came to a halt, the train hit the cylinder, throwing it away from the tracks, Chandra said, adding the loco pilot informed the guard and the gateman about

The train remained at the incident site for about 20 minutes and was again stopped at the Bilhaur station for a check, the ACP said. The damaged cylinder has been recovered. A bottle of petrol and matchboxes were also recovered from the spot, Chandra said.

On Sunday coupling of the Magadh Express from New Delhi to Islampur broke, splitting the train into two

between Raghunathpur railway stations in Bihar's Buxar district near Patna. However, no one was injured in the incident. An inquiry has been ordered to probe the exact cause of the incident.

Railways is also probing several incidents of surfacing of big boulders placed on the railway tracks in last few resulting months many derailments in recent times.

## Man killed, daughter injured after MCD truck hits motorcycle

According to a senior police officer, police received a call regarding a motorcycle being hit by a MCD truck near Shiv Mandir red light on Mehrauli Badarpur road near Pul Prahladpur area at 1.06 pm. The police teams rushed to

the spot and took Kuldeep and his daughter Anshika to All India Institute of Medical Sciences (AIIMS) Trauma Centre. "Second PCR call was received at 03:36 pm regarding Medico Legal Case (MLC) from AIIMS Trauma centre of the two patients.

Kuldeep was declared brought dead by the doctor and injured Anshika is under treatment," another senior officer stated.

Moreover, the truck driver fled from the spot after the incident. The father and daughter were residents of Pul Prahladpur area. "The inspection of the spot was conducted by the Crime Team and the offending vehicle i.e. truck and accidental motorcycle have been taken in police possession," he said.

#### MCD conducts special drive to check mosquito breeding

The Municipal Corporation of Delhi (MCD) on Monday conducted a special drive to check for mosquito breeding at 290 construction sites across all of its 12 zones with mosquito breeding was found in 148 of them

A senior official from the civic body said that this drive was conducted in an ongoing effort to combat the spread of Vector Borne Diseases such as Dengue, Malaria, and Chikungunya. "During the drive, 290 construction sites were inspected, and mosquito breeding was found in 148 of them. The breeding were destroyed then and there, and 83 legal notices and 60 prosecutions were issued to the responsible

owners/builders," he added. He further said that the drive conducted construction sites because of their propensity for water stagnation which are potential breeding grounds for Aedes and Anopheles mosquitoes, which are the sole vectors for transmitting these diseases. "However, mosquito breeding can be easily prevented by taking simple measures such as channelizing water or treating stagnant water with diesel/kerosene oil," the officer stated.

MCD officials emphasized the importance cooperation construction site owners and builders in mosquito breeding and ensuring a safe and healthy

#### Rajasthan: Bodies of four girls Delhi Police arrests 24 year old man for extortion recovered from Parbati river

The bodies of four girls who drowned while taking a dip in the Parbati river in Rajasthan's ?Dholpur district were recovered on Monday, police said.

On Sunday, Mohini (14), Priya (12), Anjali (14) and Tanu (10) went to take a dip in the river on the occasion of Rishi Panchami festival. While one of the girls was taking a dip in the river, her

feet slipped and she drowned in the 20 feet deep water, Dholpur Superintendent of Sumit Meharda

While trying to save her, three more girls drowned in the deep water, he said.

On Monday morning, the SDRF and police team recovered the bodies of all four about 1.5 km away from the accident spot and handed them over to the family after post-mortem.

# 500 sniper rifle bullets seized in Moti Nagar, West Delhi

Aroutine traffic check in West Delhi's Moti Nagar area has led to the seizure of 500 sniper rifle bullets while According to police

Monday, the traffic police were checking vehicles on Saturday night when they signalled a motorcycle rider to stop. Instead, the rider picked up speed and tried to flee, leading to a chase, said a senior police officer privy to the probe into the matter.

"While being chased, the man abandoned the motorcycle near a traffic stop and fled,"



the officer said, adding that when they searched the motorcycle they saw a bag in which they found 10 boxes containing 500 live cartridges of 7.62 calibre.

"The Moti Nagar police station was informed about the matter and the cartridges were seized," the police officer said. An FIR under the Arms Act has been registered and multiple teams have been formed to identify the accused. "We are checking CCTV footage and the route taken by the accused," the officer said.

Another senior police officer, who requested anonymity, in AK-47 rifles, self-loading rifles (SLRs), light machine guns and also for sniper rifles. These bullets are very pointed. When fired at someone, it leaves a small entry wound but causes maximum damage while exiting," said the officer. He said, "Recovery of such

"There is no indication of any

widespread risk to the public at this time," the Health Ministry stated even as it urged states and Union territories to stay vigilant and avoid unnecessary panic. Authorities are advised to

enhance surveillance, including screening, testing, and contact tracing, to manage the effectively and situation effectively and prevent further spread, said Union Health Secretary Apurva Chandra in a letter to States and Union Territories(UTs).

The Centre has also advised them to ramp up surveillance including screening, testing and tracing contact of all suspect Mpox cases and identify isolation facilities in hospitals for both suspect and confirmed patients. Presently, three Centre-led hospitals in the national capitals have been designated for treatment of the Mpox cases if needed.

Chandra asked the States and UTs to review public health instructed preparedness, particularly at health screening of incoming the health facility level, travellers to detect any identify isolation facilities in suspected case, the Union hospitals, and ensure the Health Secretary said, adding availability of required the laboratory network under logistics and trained human Indian Council of Medical resources at such facilities. The Secretary also called for

stakeholders with a focus on surveillance units under the Integrated Disease Surveillance Programme (IDSP) at state and district levels to re-orient them on definitions of suspect, probable, confirmed cases, contact tracing and other

Emergency of International Concern (PHEIC). Health units at points of entry

to strengthen instructed health screening of incoming Indian Council of Medical Research (ICMR) has also been strengthened.

Dr. Jugal Kishore, Director Professor and Head of Community Medicine at Vardhman Mahavir Medical College and Safdarjung Hospital, described Mpox symptoms as resembling those of chickenpox or smallpox, including sores, blisters, rashes, or pimples on the face or body, sometimes with yellow pus. Additional symptoms may include itching, vomiting, fever, headache, muscle stiffness, and lethargy.

He said there was no need to panic but precautionary measures need to be taken such as avoiding crowded places, maintaining distance, washing hands frequently, and avoiding contact with immunocompromised individuals. He stressed the importance of consulting a doctor if Mpox symptoms appear, given the potential confusion with chickenpox.

# Delhi LG orders ACB probe into PWD corruption allegations

Delhi Lieutenant Governor Vinai Kumar Saxena has ordered a probe by the Anti-Corruption Branch (ACB) into serious allegations of corruption and misuse of public funds to the tune of nearly Rs 80 Cr. against the officials of the Public Works Department (PWD) in connection with the de-silting work carried out in Southwest Road-I and Southwest Road-II Divisions in Palam area. The Principal Secretary to Lieutenant Governor has written to the Chief Secretary conveying the

In a complaint to LG's office secretariat on August 11, 2024, advocate and ward number 127 (Najafgarh) councillor Amit Kharkhari alleged that the officials involved in the project are engaged in serious irregularities, including misuse of public funds, blatant disregard for established ten-

Keeping in view the severity, scale of the alleged irregularities supported with substantial proof of corruption in the complaint, Hon'ble Lt. Governor has desired that Governor has desired that this matter may kindly be referred to Anti-Corruption Branch (ACB) for in depth investigation, so that further course of action be initiated, as per rules. It is also requested that an action taken report in the matter may be forwarded to this Secretariat, at the earliest", said the comthe earliest", said the communication to the Chief Secretary from LG Secretariat. The complaint alleged that one single contractor namely Surender Singh was unduly favoured and given the con-tracts for de-silting of drains in violation of the laid norms and thus caused financial losses to the government. In his complaint, Kharkhari

has alleged the irregularities which include corruption in de-silting of drains during

The complainant further alleged irregularities including fraudulent billing for consecutive four years; Obstruction of RTI requests and cover-up attempts; Corruption and

Financial misconduct and overbilling; Misappropriation and fraudulent payments; Favouritism, corruption and misuse of power in awarding contracts to Contractor Surender Singh. In his com-Executive Engineer, Ashish Gupta, Junior Engineer, Assistant Engineer, Dharam Singh Meena along with the contractor Surgador Singh and tractor, Surender Singh, and other PWD employees for being directly involved in the wrongdoings.

Kharkhari also pointed out that, since both the divisions fell under the supervision of high-ranking PWD officials, including Superintending Engineers,RajpalShivrain and Shailander Mishra, as well as Chief Engineer, South (M), Manoj Kumar Aggarwal, it is likely that they were aware of such corrupt activities and may have even colluded with the above-mentioned Ex. Engineer and Assistant

Engineer to shield them from scrutiny.

The complaint further added that there are several instances where the measures recorded by the above officials have been deliberately inflated to process higher payments to the contractor.

These allegations, supported by various documents, suggest that the exchequer suffered significant financial losses due to the misconduct.

#### AAP Government banned production of firecrackers: Rai

Delhi Environment Minister Gopal Rai on Monday announced that the AAP government has banned the production, sale and use of firecrackers in the national capital till January 1, 2025 to control air pollution in the coming winter season.

Rai, in a press conference, said that the ban is necessary to mitigate the seasonal surge in air pollution, which is worsened by firecrackers.

"In view of such a situation, like last year, this time also a complete ban is being imposed on the production, storage, sale and use of all types of firecrackers so that people can be saved from the pollution. There will also be a complete ban on online delivery or sale of any kind of firecrackers," he said. He added that there is a risk of increased air pollution in Delhi during the winter season. Burning firecrackers during this time further exacerbates pollution.

The senior AAP leader stated that to avoid any confusion, this ban applies to all types of firecrackers. "The ban will

remain in effect in Delhi until January 1, 2025, to provide relief to Delhiites from the pollution caused by burning firecrackers," he said.

The minister announced that a joint action plan involving Delhi Police, the Delhi Pollution Control Committee (DPCC), and the Revenue Department will ensure strict enforcement of the ban, as the city ramps up efforts to protect public health.

Highlighting the government's commitment to addressing air pollution, Rai stated that a Winter Action Plan' focusing on 21 key areas is being developed. This plan will include various campaigns aimed at controlling pollution, and the government will work closely with citizens to ensure its suc-

"We urge all residents of Delhi to celebrate festivals by lighting lamps and sharing sweets instead of using firecrackers. Together, we can take responsibility for reducing pollution and protecting the environment. If every citizen becomes a 'Pollution Warrior,' we can prevent the health risks caused by air pollution," said Rai.

## St Stephen's challenges single judge's order

St. Stephen's College on Monday approached the Delhi High Court challenging a single judge's order for granting admission to seven stu-dents on the basis of the seats allocated by the Delhi University.

The appeal is listed for hearing on Tuesday before a bench of Acting Chief Justice Manmohan and Justice Tushar Rao Gedela.

On September 6, the single judge had granted the relief to the seven students, saying the candidates were not at fault but had to face undue hardship due to an ongoing dispute between the institution and the

The court said the indecision on the part of the college part had left the petitioners in a state of uncertainty, preventing them from taking any further action at that stage.

"On one hand, the petitioners faced the challenge of uncertainty over securing admission to their preferred college, St Stephen's, and on the other hand, they were also deprived of the opportunity to select and



The prolonged 'under-process' status effectively blocked their participation in subsequent allocation rounds, causing them to miss out on other potential options for securing a seat," the single judge had

The seven students had sought a direction to the college to provide them seats for the courses for which they have qualified.

They had sought admission under the "single girl child quota" fixed by the DU. According to the university's

bulletin for admission information, one seat in each programme in every college is reserved under the "supernumerary quota for a single girl

The petitioners had submitted

that despite being allotted seats by the university in the college for the BA Economics (Honours) and BA programme courses, their admissions were not completed within the stipulated time.

While the university had supported the petitions, they were opposed by the college. The college opposed the DU's stand that it was obliged to students only within the sanctioned limit. The single judge, in the verdict, noted that the seat matrix for the current academic session was prepared and forwarded by the college itself to the DU. It said the seat matrix offered by the college clearly indi-

# **NGT** slams delayed response

National Green Tribunal (NGT) has directed authorities to take "expeditious action" to complete the desilting of drains, including Barapullah, Kushak and Sunehri Pul, in Delhi.

Observing that silt removed from a drain is kept by its side and flows back into it when it rains, the tribunal directed the authorities to take steps to remove it.

The green body, which was hearing a matter related to the discharge of effluent via drains into the Yamuna river and issues related to it, including establishment of sewage treatment plants (STPs) and desilting and dredging of drains, also imposed a Rs 20,000 fine on the Delhi Jal Board (DJB) for filing a late reply on the

On August 13, the tribunal

while considering the desilting of drains, had sought a response from the DJB within two weeks. In its order passed on September 4,

a bench of NGT Chairperson Justice Prakash Shrivastava, Justice Arun Kumar Tyagi and expert member A Senthil Vel noted that the DJB had filed its report belatedly and this obstructed proceedings.

"It will be open to the competent authority of the DJB to find out the official responsible for causing the delay in filing the report and recover the cost from him," the bench said.Regarding the desilting of drains, the tribunal said, ' Expeditious action is required to be taken to complete the process of desilting. Undisputedly, the silt removed from the drain is kept by the side of the drain at some locations which on account of rains flows back to the drain.

#### High Court orders termination of pregnancy for minor rape victim

The Delhi High Court has **1** allowed a minor rape victim to undergo termination of her over 26 weeks pregnancy, observing that unwanted pregnancy constitutes a grave injury to the mental health of


the survivor. The court also directed the Safdarjung Hospital to preserve samples from the foetus for DNA testing which may be required for the pending crim-

inal proceedings The high court said the victim has the ultimate right whether to give birth to the conceived child or to terminate the pregnancy, and her opinion has to be given primacy.

"This court is of the considered opinion that the suffering of the victim who is aged about 16 years would be compounded if she is forced to continue the pregnancy at a tender age. Apart from above, the victim is bound to face social stigma which may not permit the scars left by defilement of her body to heal," Justice Anoop Kumar Mendiratta said.

The court said it was cautious that though the pregnancy is of over 26 weeks of gestation but the risks associated with termination of pregnancy is not higher than the risk of delivery at full term of pregnancy.

"Merely because there is no foetal abnormality, it cannot be held that the reproductive

Despite India's ambitious goal to eliminate Tuberculosis (TB) by 2025 five years ahead of the global target— intriguingly there are no national guidelines for routine TB screening and surveillance healthcare workers deeply involved in treatment, placing medical staff at a significantly higher risk of contracting multidrugresistant TB strains than in the general population, flags a study

It reached this disturbing conclusion after analysing data from ten separate studies conducted between 2004 and 2024. It found an average prevalence 2,391.6 cases per 100,000 healthcare workers in India, starkly contrasting with the 300 cases per 100,000 in the general population. The study "Prevalence of

Tuberculosis Among Healthcare Workers in India: A Systematic Review and Meta-Analysis." also noted that inadequate ventilation, insufficient personal

equipment, and frequent exposure to MDR among others are severely affecting the well-being of medical staff with the infection. Given that TB remains a

critical public challenge globally, particularly in high-burden countries like India accounting approximately one-fourth of the global TB cases— the authors emphasised the for guidelines specifically targeting highrisk group's such as medical trainees and those in highexposure departments.

Dr. Jugal Kishore, Director Professor in the and Department of Community Medicine at Safdarjung Hospital highlighted the alarming incidence of TB among healthcare workers (HCWs) as indicative of broader vulnerabilities healthcare infrastructure.

'Shruti Choudhry is the daughter of BJP leader Kiran Choudhry and Bansi Lal's son late Surender Singh while Anirudh Chaudhry is the son of Ranbir Singh Mahendra. Mahendra, a former BCCI president, and Surender Singh were brothers.

'Tosham assembly segment was represented by Kiran Choudhry, but she quit as MLA last month after which the BJP nominated her for the Rajya Sabha bypoll from Haryana, which she won unopposed.

'Not just Tosham, the contest has become keen from Dabwali seat in Sirsa district the Congress.

# The onion price and poll dynamics



Soaring onion prices are causing concern for both consumers and politicians alike, with historical evidence showing that onion price can sway electoral outcomes

ya pyaj rulayega – Would the onion bring tears? - is the common refrain in ■poll-bound states of Haryana, Jammu and Kashmir and Maharashtra. and many a time it has hit not only the common man but even the political

The rise in Indian onion prices is feared to spurt international prices and food bills. Could the prices come down to wipe off tears? Maybe not. Its support prices have increased manifold. The Centre is procuring onion at a price 74 per cent higher than last year in Maharashtra, the highest onion-growing state.

Last year, onion was procured at Rs 16.93 per kg. This year it is being procured at Rs 29.5 per kg through direct benefit transfer (DBT) to eliminate middlemen. The centre is not taking any chances. It is selling through NAFED outlets, mobile vans and others at Rs 35. For how long it could be sustained? Even at Rs 16.93 per kg procurement, national prices rarely came down below Rs 30 a kg. Onion prices hover around Rs 60 and 70 a kg. The overall national prices are unlikely to come down as the Maharashtra government is investing Rs 1500 crore to buy onion from the state to keep its farmers and traders happy to secure a political future. The government imposed a ban on onion exports in December 2023 to curb rising retail onion prices, ahead of the Lok Sabha election. It led to a fall in onion prices by approximately 40 per cent from Rs. 42.2 a kg in December 2023 to Rs. 24.5 kg in March 2024. On 23rd March 2024, the ban was extended indefinitely Lok Sabha

The declining onion prices continued to create uproar among the farmers and traders. The government lifted the ban with the third phase of polling on May 4 to six countries - Bangladesh, the United Arab Emirates (UAE), Bhutan, Bahrain, Mauritius, and sri Lanka. Historically, nigh onion prices have led to discontent among consumers, whereas lower onion prices have upset a Lok Sabha 2024 elections, the large voting bloc of farmers, BJP has significant losses in

India is one of the largest producers and consumers of onions and fluctuations in onion prices have large-scale socio-economic impacts on the domestic and international markets.

In 2023-24 yield came down by 15 percent to around 25.47 million tonnes (MT), compared to the previous year's production of about 30.21 MT, according to an official release. The production may further fall this year.Traders fear that despite the lifting of the ban with 40 per cent export duties Indian onion remains highly-priced at \$ 770 per MT (Rs 64 a kg). The Egyptian onion is sold at \$ 387 per MT, almost half of the Indian price making it uncompetitive. Countries such as Egypt, Pakistan and China compete with India in the Asian onion export market. The onion has been a political game-changer since the 1980 general elections when rising onion prices contributed to the return of Indira Gandhi to power wiping out the Janata

Again because of high onion prices in 1998, the BJP lost to the Congress despite naving changed its chief minister a few months before.In the 2024

Maharashtra's onion-growing belt. Except for one seat, the National Democratic Alliance (NDA) has been completely trounced in this crucial agricultural region. Out of the 13 Lok Sabha constituencies where the majority of onion farmers are concentrated, 12 have been won by the opposing INDIA bloc.

This is a stark contrast to the 2019 parliamentary elections, where NDA — comprising BJP and formerly united Shiv Sena — won 11 out of these 13 seats, with BJP alone securing seven.Since the extension of the export ban, there has been simmering anger among onion cultivators of Nasik, which has the largest Asian onion market at Lasangaon. The export ban led to significant financial losses for farmers, who struggled to recover their cultivation costs as wholesale prices nosedived. Other major constituencies with significant onion grower populations, such as Dhule, Ahmednagar, Nandurbar, Baramati, Beed, Latur, Maval, Shirur, Solapur, Shirdi and Osmanabad, also saw NDA's influence wane. The government has also decided to fill in the state emergency reserves with 500,000 tonnes of onions for the 2024-25 period. inis initiative aims to miti-

gate future price volatility and protect farmers from sudden market fluctuations.



The onion is a staple vegetable for the poor, indispensable to many Indian cuisines and recipes, from spicy curries to tangy relishes. "In Maharashtra, if there are no vegetables or you can't afford to buy vegetables, people eat 'kanda bhakari' (onion with bread)," says a food historian

It is more than butter for politicians, whose success depends on how they can handle the onion. The cheers and tears of impending state elections are closely linked with onion.

# Freedom for all: Breaking gender stereotypes



For decades, Indian households have upheld certain gender roles—men return to a home-cooked meal while women cook after returning home from work

wife came across a feed on her social . media, "Men come back home to a cooked meal; women come home to cook a meal. It is not the women who need freedom; it is the men who should have the freedom." The first half of the statement is something that we observe in almost all Indian households. It was the second part that I could not comprehend till I introspected. Ī was born in 1959, a few years after India gained independence. I was the firstborn in my generation. During those days, and even now in many parts of the country, young couples are blessed by family and friends to have a male firstborn. My mother told me that my paternal aunt went to the terrace to announce my birth to the locality by banging a steel plate with a spoon, "A son is born." I was a cherished and muchloved child, and then an

I would not say that I was unduly pampered due to my gender, though my wife and daughters disagree. One thing was certain. I



was not expected to enter the kitchen except to fetch a glass of water, and certainly not for cooking. My mother would insist on reheating the cooked food in case my wife had to go out for some work, till she could not do it any longer due to her medical condition.I was not alone in my generation to receive special treatment.

A friend would be served freshly made bread by his wife, however late he returned from the office, or however tired the lady was after a hectic day spent in the kitchen or running after the children. Almost all my friends from that era were

mothers, aunts, sisters, and even females from the extended family, and then by their wives and daughters. Many of us, from relatively better social milieu, have raised our children to question the age-old cus-

More women are going out for work. Men are also raised to help with household chores. Young couples make efforts to take care of each other. There is no gender bias. A friend's sonin-law loves cooking, especially preparing masala tea. It is almost a ritual for him to prepare tea whenever he and the daughter visit the parents. The maid and a few others were scandalized at this blatant display of deviation from the traditional, till they had tasted the special tea

The change is slow, and only in certain sections of society. Women in many families are still expected to learn the art of looking after the household, husbands, and children, even after a tiring day at work. They are made to feel guilty for leaving their newborn pampered first by their child at home to resume

Men still do not enter the kitchen, and more often are not permitted to enter the kitchen, even if they have an interest or an inherent desire to help the wife. Men need the freedom to make their choices without being judged by people. They also need the freedom to break the shackles of gender biases. Certain gender-specific roles and responsibilities were assigned based on the requirements of the times.

Many of these may no longer be relevant. It is for us to adapt to changing times, and we can. We have reached where we are because of the ability of humans to change. Welsh writer and critic Stephen Bayley expresses it well, "The assumption must be that those who can see value only in tradition, or versions of it, deny man's ability to adapt to changing



# A roadmap for boosting India's agri-export



By incorporating cutting-edge food processing technologies and establishing globally recognised quality standards India can push its agri-exports substantially



n a bid to give impetus to strengthen the supply chain from farm to fork, foster collaboration among global and Indian food sector stakeholders, and support food processing units near farm gates to ensure better profits for farmers and reduce postharvest losses, The Ministry of Food Processing Industries is taking the lead by hosting 'World Food India' from September 19-22 in New Delhi. In addition, the Union Budget for 2024-25 has allocated Rs 1.52 lakh crore to prioritise agricultural sector development. This funding will focus on climate resilience, productivity, innovation, and processed food exports.

This is crucial as agricultural product exports saw an 8% decline to \$48.9 billion in 2023-24 from \$53.2 billion in 2022-23. The average annual growth rate of agri-exports was just 2% during 2014-23. Notably, five products — rice, wheat, meat, spices, sugar and tea/coffee account for over 50 per cent of total agri-cultural exports and sometimes face restrictions to match the domestic demands and supplies to control inflation. Only 25 per cent of our agro-exports are processed or value-added, a figure that has remained virtually unchanged over the

This is significant due to a need for more tech-based operational size and production capacity and for meeting international standards to tap the global market. However, the success of global giants like Nestle (Switzerland), with an annual turnover of \$111 billion in the processed food and beverages sector, shows us what is possible with technology and research. Notable Indian firms in domestic processed agriculture, such as AMUL, with a turnover of \$9 billion, are far behind in operational size, production capacity, and meeting international standards. Still, they can achieve similar success with the proper support and approach.

The Global exports of processed agricultural products are nearing \$1 trillion, with Germany(\$63 billion) at the top, the US (\$58 billion), the Netherlands (\$57 bil-

lion), China (\$53 billion), and France (\$50 billion). Southeast Asian nations like Indonesia, Malaysia, and Thailand are also major exporters of processed agricultural products. While, India's value-added exports increased by \$6.5 billion over the last five years since the agro-export policy was introduced to boost value-added agriculture exports, taking the total to \$15 billion, it only marginally improved our global rank from 21 to 17.

This can be surely improved. The Economic Survey 2023-24, reveals that the annual output of fruits and vegetables in India is the world's second-largest at a substantial 300 million tonnes after China, yet the processing levels at 4.5 per cent for FUND OF INR 1

This deficiency in processing capacity leads to a substantial amount of produce going to waste in India. Estimates of post-harvest losses in the country vary from 18% to 25% across the entire supply chain, though they are thought to be much higher, at up to 45%, for fruit and vegetables. To improve this situation, it is suggested to focus on proper sorting and grading near the farm gate and enhance processing capacity. Punjab has yet to make a similar move, despite the success of neighbouring states like Haryana with their dedicated Agribusiness and Food Processing Policy.Revisit the PLI Scheme: The Production Linked Incentive Scheme for the Food Processing Industry (PLISF-PI) will be Rs 10,900 crore (\$1.25 billion) from 2021-22 to 2026-27, precisely to attract large globally competitive firms to produce in and export from India. This anchor global firms will help scheme aims to expand processing capacity, grow strong Indian brands, increase global market presence, create jobs, and boost farmer incomes. As of May 2024, 90% of the PLISFPI funds still need to be utilised. The government has disbursed only Rs 1,073 crore among 158 SME beneficiaries, using only 10% of the funds over

half of the timeline expired. This underutilisation highlights the need for more focused policy intervention. To achieve the twin objectives of the PLI schemeglobal competitiveness and increased exports—these SMEs must form joint ventures with globally established 'anchor' firms. Over the past decade, India has attracted Foreign Direct Investment (FDI) worth Rs 500 billion, with 100% FDI being permissible. The Way Forward: Food processing is considered India's sunefit farmers effectively, a multipronged approach combining MSP, value addition and industry integration is essential for agricultural development due to its strategic importance in providing food

As the world's most populous

country, we exert significant environmental pressure on Earth, resulting in ecological issues such as soil degradation, loss of biodiversity, and water depletion. Within the broader food systems, waste reduction stands out as one of the leading climate change mitigation solutions, contributing to reduced emissions throughout the food supply chain from farm to fork. By incorporating cutting-edge food processing technologies, establishing globally recognized quality standards, and opening up access to international markets, this focused strategy to attract achieve our goals. Apple serves as a prime example of the success of this targeted approach in the electronics sector; it manufactures 14 per cent of the world's i-Phones in India. Electronics exports, mainly intelligent mobile phones, have surged from under \$3 billion in 2020 to \$15.6 billion in 2023 and have led to the creation of over one lakh jobs. This same model should be replicated across various industries. The Ministry of Food Processing Industries should roll out a time-bound outreach program to attract anchor global firms and facilitate their partnerships with Farmer's Producers Organisations (FPOs) and SMEs.

The renaming is part of a wider effort to challenge the enduring influence of British-established institutions and the colonial educational framework that has shaped the country for over a century. Colonial Legacy in India's **Education:** India's education system continues to carry the imprint of its colonial past. # Israeli strikes in Syria leave 14 dead, more than 40 hurt

The number of people killed in overnight Israeli strikes in Syria has risen to 14 with more than 40 wounded, Syrian state media said Monday morning. Israeli strikes hit several areas in central Syria late Sunday, damaging a highway in Hama province and sparking fires, Syrian state news agency SANA said. The initial death count reported by the Masyaf National Hospital in western province four.SANA, citing hospital head Faysal Haydar, said 14 were killed and 43 wounded. The Syrian Observatory for Human Rights, a UK-based war monitor, said at least four of those killed were civilians. One of the strikes targeted a scientific research centre in Maysaf and others struck sites where "Iranian militias and experts are stationed to develop weapons in Syria," the Syrian Observatory for Human Rights said. Local media also reported strikes around the coastal

Israel has vowed to stop Iranian entrenchment in Syria, particularly since Syria is a key route for Iran to send weapons to the Lebanese militant group Hezbollah.

Hezbollah has been clashing with Israeli forces for the past 11 months against the backdrop of Israel's war against Hamas — an ally of Hezbollah – in Gaza. Méanwhile three Israelis were shot and killed at the border crossing between the West Bank and Jordan, Israeli officials said, in what appeared to be an attack linked to the 11-month-old war in Israel's military said the gun-

man approached the Allenby Bridge Crossing from the Jordanian side in a truck on Sunday and opened fire at Israeli security forces, who killed him in a shootout. Israel's Magen David Adom rescue service said the three Israelis were men in their 50s and the military said they were civil-

Relatives identified the gunman as Maher al-Jazi, a retired Iordanian soldier from Athroh, a town in the impoverished Maan area. Jordan's state-run



Petra News Agency said he was transporting goods to the West Bank. The interior ministry said that, based on initial investigation results, the incident was an individual act.

Jordan was investigating. The Western-allied Arab country made peace with Israel in 1994 but is deeply critical of its toward policies Palestinians. Jordan has a large Palestinian population and has seen mass protests against Israel over the war in Gaza. Hundreds of Jordanians marched in Amman to celebrate the attack, chanting slogans in support of al-Jazi and burning the Israeli flag. "We bless this heroic operation carried out by this noble Jordanian hero," said Murad Adaileh, head of the local Muslim Brotherhood Party.

The Allenby crossing over the Jordan River, also known as the King Hussein Bridge, is mainly used by Palestinians and tourists. The crossing has seen few security incidents, but in 2014 Israeli security guards shot and killed a Jordanian judge who they said had

The crossing was closed, and Israel announced the closure of its land crossings with Jordan. It later said all would reopen on Monday

Prime Minister Benjamin Netanyahu con-demned the attack and linked it to Israel's larger conflict with Iran and allied militant groups, including Hamas in Gaza and Hezbollah in Lebanon. The Israeli-occupied West

Bank has seen a surge of violence since Hamas' October 7 attack out of Gaza triggered the war there. Israel has launched near-daily military arrest raids into dense Palestinian residential areas, and there has been a rise in Israeli settler violence and Palestinian attacks on

Loved ones mourned Aysenur Ezgi Eygi, an American-Turkish woman shot dead on Friday in the West Bank. She had been demonstrating against Israeli settlements. The White House has said it was "deeply disturbed", while her family seeks an independent investigation. Her body remained at a hospital in Nablus.

In Gaza, an Israeli airstrike killed five people, including two women, two children and a senior official in the Civil

Defense — first responders who operate under the Hamasrun government. The Civil Defence said the strike targeted the home of its deputy director for northern Gaza, Mohammed Morsi, in the urban Jabaliya refugee camp. There was no immediate comment from the Israeli military. The army says it tries to avoid harming civilians and only targets militants.

Another Israeli strike hit the Eid family home in the Nuseirat refugee camp and killed at least two girls, according to an Associated Press journalist who counted the oodies and witnesses. Paltel, one of the territory's

main telecom providers, said all household internet in central and southern Gaza was down because of ongoing attacks. Gaza's Health Ministry says over 40,000 Palestinians have been killed in Gaza since the war began. It does not differentiate between fighters and civilians in its count. The war has caused vast destruction and displaced around 90 per cent of Gaza's population of 2.3 million, often multiple times. Hamas-led militants killed some 1,200 people, mostly civilians, in their October 7 attack. They abducted another 250 and are still holding around 100 after releasing most of the rest in exchange for Palestinians imprisoned by Israel during a weeklong cease fire last November. Around a third of the remaining hostages

are believed to be dead. The United States, Qatar and Egypt have spent months trying to broker a cease-fire and the return of the hostages, but the negotiations have repeated-

ly bogged down. Also on Sunday, Netanyahu said government ministers may no longer visit Jerusalem's most sensitive holy site — revered by Jews as the Temple Mount and by Muslims as Haram al-Sharif

without his permission. Israel's far-right national security minister, Itamar Ben-Gvir visited it again in July and has called for allowing Jewish prayer there. Tensions over the compound have fuelled past violence.

Israel captured the West Bank, Gaza and east Jerusalem — territories the Palestinians want for a future state — in the 1967 Mideast war. Israel withdrew soldiers and settlers from Gaza in 2005 but maintained control over its airspace, coastline and most of its land crossings. Along with Egypt, it imposed a blockade on Gaza after Hamas seized power from rival Palestinian forces in 2007.

#### Af's London embassy to be closed

Afghanistan's embassy in London is being shut down after it was disowned by the country's Taliban rulers, the UK government said Monday. The Foreign Office said "the

embassy is being closed following the dismissal of its staff by the Taliban." Britain does not recognise the Taliban govern-

Ambassador Zalmai Rassoul wrote on the social network X that the embassy would shut its doors on Sept. 27 "at the official request of the host country." Neither the UK government nor the ambassador said what would happen to the embassy's staff.Diplomats who served under Afghanistan's for-mer Western-backed govern-ment were left in limbo when the Taliban seized Kabul and returned to power in August 2021. Many embassies in Europe and beyond have continued to operate, but have been accused by Kabul of failing to cooperate with the government. Afghanistan has sent Talibanapproved diplomats to some countries, including Pakistan

# President Abdelmadjid re-elected in Algeria

President Abdelmadjid Tebboune has been named the victor in Algeria's presidential election, winning re-election in a landslide marred by low turnout and claims of irregularities and discrepancies in how results were reported.

The country's independent election authority on Sunday announced that Tebboune had won 94.7 per cent of Saturday's vote, far outpacing his challengers Islamist Abdelali Hassani Cherif, who received only 3.2 per cent and socialist Youcef Aouchiche, who got just 2.2 per cent. After both of Tebboune's oppo-

nents questioned the results after they were reported on Sunday, the three campaigns jointly issued a statement accusing the country's election chairman of announcing results that contradicted earlier turnout figures and local tallies. In a country where elections have historically been carefully choreographed affairs, such



astonishing questions about irregularities shocked Algerians who expected Tebboune to win in a relatively uneventful fashion. It's unclear what will follow all three candidates casting doubt on irregularities and whether they will prompt legal challenges or delay the final certification of the result.

The tally reported on Sunday gave Tebboune's a total vote share that was far more than the 87 per cent that Vladimir Putin won in Russia's March elections and the 92 per cent that Ilham Aliyev got in Azerbaijan's February contest. But efforts from Tebboune and members of his government to encourage voter turnout to project legiti-macy appeared to have fallen short, with less than one out of participating.Election officials on Sunday reported 5.6 million of the country's roughly 24 million voters had turned out to vote. Such high abstention rates,

surpass the 2019 presidential election when 39.9 per cent of the electorate participated. Officials did not explain why they had earlier announced 48 per cent voter turnout at the time of polls closing. Before the three candidates joined in guestioning the discrepancy, both of Tebboune's challengers raised

He also said there had been a failure to deliver vote-sorting records to the candidates' representatives and that said the party had recorded instances of proxy group voting and pressure put on poll workers to inflate certain figures. Claims of irregularities cap off

an election season that outraged activists and civil society groups. Human rights advocates railed against the campaign season's repressive atmosphere and the harassment and prosecutions of those involved in opposition parties, media organisations and civil society groups.Some denounced this election as a rubber stamp exercise that can only entrench the status quo. Amnesty International last week condemned Algeria's "brutal crackdown on human rights including the rights to freedom of expression, peaceful assembly and association in the run up to

the country's presidential elections".

Before the candidates questioned the results, Tebboune's supporters and detractors each had drawn conclusions from the results.

Pro-Tebboune university pro-fessor Abdellaoui Djazouli said on public television that the result was a resounding endorsement of Tebboune's program."The President has more legitimacy to continue his action to better establish his project for the new Algeria," he said on public television.

But his runaway victory fueled criticism from pro-democracy activists who have long seen elections as tools that the country's political elites have used to give off an appearance of popular support.Many said the loudest message to come out of the election came from those who chose to abstain out of fear that the election would only entrench and legitimise "le pouvoir" - a term used to describe the military-backed elites who run the country.

Peace Prize-winning hero. Timorese jammed Francis' motorcade route into town from the airport, waving Vatican and Timorese flags and toting yellow and white umbrellas — the colours of the Holy See — to shade themselves from the scorching midday sun.

"Viva el Papa!" they shouted as he passed by. The 87-year-old Francis seemed to relish the greeting, smiling broadly from the open-backed pickup truck and waving as he passed by billboard after billboard featuring

his image and words of welcome. The overwhelmingly Catholic East Timor, one of the world's poorest countries, had eagerly awaited Francis' arrival, which came on the heels of the 25th anniversary of the UNbacked referendum that paved the way for independence from

Indonesia. It was a far different atmosphere than when the last pope visited. St. John Paul II came in 1989, when Timor was still an occupied part of Indonesia and fighting for its freedom. After Timorese voted overwhelmingly for independence a decade later, Indonesia's military responded with a scorched-earth campaign that destroyed 80 per cent of the country's infrastructure and shocked the world. Overall, as many as 200,000 people were killed during the 24 years of Indonesian rule.

John Paul's visit, which culminated with a massive Mass on the seaside near Dili, helped draw international attention to the plight of the Timorese people and shine a spotlight on the oppressiveness of Indonesia's occupation.Francis arrived in Dili from Papua New Guinea to follow in John Paul's footsteps and open the third leg of his trip through Southeast Asia and Oceania. President Jose Ramos-Horta and Prime Minister Xanana Gusmao, two of East Timor's most revered independence heroes, greeted Francis at the airport and were meeting with him privately.In remarks to them and other dignitaries Monday, Francis applauded the Timorese people for having recovered from their "greatest suffering and trial" to put East Timor on the path of peaceful development. And he praised

them for having reconciled with Indonesia.

But he said new challenges and problems were now confronting the country, Asia's newest, including emigration and poverty, as well as alcohol abuse and violence involving martial arts gangs

'Let us also not forget that these children and adolescents have their dignity violated," Francis said. "In response, we are all called to do everything possible to prevent every kind of abuse and guarantee a healthy and peaceful childhood for all young people." It was a generic and indirect reference to "abuse." But it nevertheless recalled the scandal involving Timorese Bishop Carlos Ximenes Belo who along with Gusmao and Ramos-Horta, is regarded as a hero for their efforts to support Timor's independence.

#### Third INDUS-X summit to boost | UN rights US-India defence relations

The third edition of the two-day INDUS-X summit will begin on Monday, during which India and the US will explore ways to strengthen partnerships in defence innovation, according to an official release.The India-US Defence Acceleration Ecosystem (INDUS-X) Summit, themed: "Harnessing Investment Opportunities to Enhance Cross-Border Defence Innovation Ecosystems," will be held at Stanford University in Palo Alto, California from September 9-10, said a press release by the US-India Strategic Partnership Forum (USISPF). It will focus on the critical role of private capital in advancing the defence innovation sector, bringing together leading defence policymakers from Washington and New Delhi. "The event will facilitate interactions between

American and Indian leaders in defence innovation, including startups, venture capitalists academia, accelerators, and industry professionals, to foster co-production and investment opportunities," according to the press release. It will include sessions with leaders from the private and the public sectors touching on themes of "strengthening defence and advanced technology partnerships, funding defence innovation, and resilient supply chains". The summit will be co-hosted by the US-India Strategic Partnership Forum (USISPF) and Stanford

University.
INDUS-X, which stands for enhanced strategic and defence partnership between India and the US, was launched on June 21 last year by the US Department of Defence and the Indian Ministry of Defence during Prime Minister Narendra Modi's

state visit to Washington, DC. The India-US defence and strategic ties have been on an upswing in the last few years. The two countries have inked key defence and security pacts over the past few years, including the Logistics Exchange Memorandum of Agreement (LEMOA) in 2016 that allows their militaries to use each other's bases for repair and replenishment of supplies. #### Google faces new antitrust trial AP ALEXANDRIA

One month after a judge declared Google's search engine an illegal monopoly, the tech giant faces another antitrust lawsuit that threatens to break up the company, this time over its advertising technology. The Justice Department and a coalition of states contend that Google built and maintains a monopoly over the technology that matches online publishers to advertisers. Dominance over the software on both the buy side and the sell side of the transaction enables Google to keep as much as 36 cents on the dollar when it brokers sales between publishers and advertisers, the government contends in court papers.

Google says the government's case is based on an internet of yesteryear, when desktop computers ruled and internet users carefully typed precise World Wide Web addresses into URL

fields. Advertisers now are more likely to turn to social media companies like TikTok or streaming TV services like Peacock to

reach audiences. In recent years, Google Networks, the division of the Mountain View, California-based tech giant that includes such services as AdSense and Google Ad Manager that are at the heart of the case, actually have seen declining revenue, from USD 31.7 billion in 2021 to USD 31.3 billion in 2023, according to the compa-

ny's annual reports.

The trial over the alleged ad tech monopoly begins Monday in Alexandria, Virginia. It initially was going to be a jury trial, but Google maneuvered to force a bench trial, writing a check to the federal government for more than USD 2 million to moot the only claim brought by the government that required a

# Death toll in Vietnam storm rises to 59

bridge collapsed and a Abus was swept away by flooding Monday as more rain fell following a typhoon in Vietnam that has caused at least 59 deaths in the Southeast Asian country and disrupted businesses and factories in the export-focused northern industrial hubs, state media reported.

Nine people died when Typhoon Yagi made landfall in Vietnam on Saturday before weakening to a tropical depression, and at least 50 others have died in the consequent floods and landslides, state media VN Express reported. The water levels of several rivers in northern Vietnam were dangerously

A passenger bus carrying 20 people was swept into a flooded stream by a landslide in mountainous Cao Bang province Monday morning. Rescuers were deployed but landslides blocked their



path.In Phu Tho province, rescue operations were continuing after a steel bridge over the engorged Red River collapsed Monday morning. Reports said 10 cars and trucks along with two motorbikes fell into the river. Three people were pulled out of the river and taken to the hospital, but 13 others were missing. Pham Truong Son, 50, told

VNExpress that he was driving on the bridge on his motorcy cle when he heard a loud noise. Before he knew what was happening, he was falling into the river. "I felt like I was drowned to the bottom of the river," Son told the newspaper, adding that he managed to swim and hold on to a drifting banana tree to stay afloat before he was rescued.Dozens

On Sunday, a landslide killed six people including an infant and injured nine others in Sa Pa town, a popular trekking base known for its terraced rice fields and mountains. Overall, state media reported 21 deaths and at least 299 people injured from the weekend.Skies were overcast in the capital, Hanoi, with occasional rain Monday morning as workers cleared the uprooted trees, fallen billboards and toppled electricity poles. Heavy rain continued in

northwestern Vietnam and forecasters said it could exceed 40 centimetres (15 inches) in places. Yagi also damaged agricultural land where rice is mostly grown. Before hitting Vietnam, Yagi caused at least 20 deaths in the Philippines last week and four deaths in southern China. Chinese authorities said infrastructure losses across the Hainan island province amounted to USD 102 million with 57,000 houses collapsed or damaged, power and water outages and roads damaged or impassable due to fallen trees. Yagi made second landfall in Guangdong, a mainland province neighbouring Hainan, Friday night.Storms like Typhoon Yagi are "getting stronger due to climate change, primarily because warmer ocean waters provide more energy to fuel the storms, leading to increased wind speeds and heavier rainfall," said Benjamin Horton, director of the Earth Observatory of Singapore.

# Spanish PM visits China

Spanish Prime Minister Pedro Sánchez met with Chinese President Xi Jinping and other top officials Monday during his second trip to China in a year and a half that comes during a spat over electric cars. The official Xinhua News Agency reported the meeting at Beijing's Diaoyutai State Guest House but gave no details about what they discussed.

The centre-left Socialist leader also attended a business forum in Beijing for Spanish and Chinese companies before travelling to Shanghai later Monday. On Tuesday he is attending more business events and

the inauguration of a Cervantes Institute, a centre that promotes Spanish language and culture.

Prior to holding talks and dining with Xi, Sánchez held talks with Chinese Prime Minister Li Qiang and the head of the ceremonial legislature, Zhao Leji. Sánchez arrived late Sunday and departs Wednesday. Sánchez visited China in

March 2023 when Spain held the rotating European Union presidency. Spain was among the EU members that expressed support earlier this year for a 36.7 per cent tariff on Chinese electric vehi-cles. The Chinese govern-ment responded by launching an investigation into imports of EU pork.

EU exports of pork products to China hit a peak of 7.4 billion euros (USD 7.9 billion) in 2020 when Beijing had to turn abroad to satisfy domes tic demand after its pig farms were decimated by a swine disease. EU pork exports to China have dropped since then, hitting 2.5 billion euros (USD 2.6 billion) last year. Almost half of that total came from Spain. The tension over pork has not stopped Spain from welcoming the plans of Chinese carmaker Chery to open a plant for electric vehicles in

#### Congress tackles China with bills on drones and drugs

**AP** WASHINGTON ow to curb and counter HChina's influence and power through its biotech companies, drones and electric vehicles will dominate the US House's first week back from summer break, with lawmakers taking up a series of measures targeting Beijing. Washington views Beijing as its biggest geopolitical rival, and the legislation is touted as ensuring the US prevails in the competition. Many of the bills scheduled for a vote this week appear to have both Republican and Democratic support, reflecting strong consensus that congressional actions are needed to counter China. The legislation "will take meaningful steps to counter the military, economic and ideological threat of the Chinese Communist Party," said Rep. John Moolenaar, chair of the House Select Committee on the Chinese Communist Party and a Michigan Republican. "There's a bipartisan goal to win this competition." Advocacy groups worry about the impact, warning against rhetoric that hurts Asian Americans and could create "an atmosphere of guilt by association or fuel divisiveness," said Christine Chen, executive director of Asian & Pacific Islander American Vote.The Chinese Embassy in Washington called legislation tensions in an election year. If passed, the bills "will cause serious interference to China-US relations and mutually beneficial cooperation, and will inevitably damage the US's own interests, image and credibility," spokesman Liu Pengyu said in a statement. He called it "the first step" in protecting Americans' genetic data.BGI, one of the Chinese companies named in the bill, called it "a false flag targeting companies under the premise of national security." The company, which offers genetic sequencing for research purposes in the US, said it follows the law and has no access to Americans' personal

Another bill would dub drones made by the Chinese company DJI, which dominates the global drone market, "an unacceptable risk to US national security" and cut its products from US communications networks over data security concerns. The bill would protect Americans' data and critical infrastructure, said New York, who introduced it. "Congress must use every tool at our disposal to stop" China's "monopolistic control over the

drone market," she said. DJI argues that users have to "opt in" to share data such as flight logs, photos and videos with the company. If users don't do so, the company said it won't have data to share with any government when compelled. It also has rejected allegations that it is a Chinese military company and has aided the persecution of members of ethnic Muslim minorities. Adam Bry, co-founder and CEO of major US drone maker Skydio, told a congressional committee in June about losing business to China, where "the Chinese government has tried to control the drone industry, pouring resources into national champions and taking aim at competitors in the US and the West, tilting the playing field in China's

A challenge is likely against an attempt to revive a Trump-era programme described as a way to stop Chinese efforts to steal intellectual property and spy on industry and research

The bill would direct the Justice Department to curb spying by Beijing on US intellectual property and academic institutions and go after people engaged in theft of trade secrets, hacking and economic espionage

The Trump-era programme, called the China Initiative, ended in 2022 after multiple unsuccess ful prosecutions of researchers and concerns that it had prompt ed racial and ethnic profiling. Critics also say it chilled cooper ation between the US and China in science and technology meant to benefit the greater good.

"Our colleagues in the Republican Party sought to reinstate this failed program because they wanted to look like they were solving problems. But in reality, they were only stoking fear and hatred," several Democratic lawmakers said in a statement in March, when they fought off another effort to restart the program. Another bill, which says it will protect US farmland from foreign adversaries, has raised concerns about discrimination. It would add the agriculture secretary to the US Committee on Foreign Investment, which reviews the national security tions. The bill also flags as "reportable" land sales involving citizens from China, North Korea, Russia and Iran.

"Food security is national security, and for too long, the federal government has allowed the Chinese Communist Party to put our security at risk by turning a blind eve to their steadily increasing purchases of American farmland," said Rep. Dan Newhouse, a Republican from Washington state, who introduced the bill. The National Agricultural Law Centre estimates 24 states ban or limit foreigners without residency and foreign businesses or governments from owning private farmland. The interest emerged after a Chinese billionaire bought more than 130,000 acres near a US Air Force base in Texas and another Chinese company sought to build a corn plant near an Air Force base in North

# 'Decision on Imran's military trial will be based on merit'

Pakistan Information Minister Atta Tarar on Monday said that any decision about the military trial of jailed former premier Imran Khan would be made considering the merit of the case. Tarar said this at a press conference a day after the Pakistan Tehreek-e-Insaf leaders while addressing a public rally in Islamabad demanded the government to release Khan, who has been imprisoned in Rawalpindi's Adiala Jail for more than a year. "The decision of the military trial of Khan will be made on merit based on evidence," the minister said in response to a question. Top government officials have been indicating holding a military trial of Khan for his alleged involvement in the May 9, 2023, violence when alleged PTI supporters had attacked military buildings in reaction to his arrest. However, the issue of holding military trials of civilians is pending with the Supreme Court for final adjudication and the cases of more than a hundred civilians. who were handed over to military authorities after violence, have also lingered on. In the first public rally in Islamabad



after the February 8 elections, the PTI leaders asked the government to release Khan. Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur, belonging to PTI, went a step ahead and warned the government to set Khan free within two weeks or the party would forcibly get him released. "If the founder of PTI is not legally released within one to two weeks, we will have him freed ourselves," the chief minister said, declaring that he would take the lead and take the first bullet to get Khan out of jail. Khan's party on Sunday held a

power show, demanding his immediate release while slamming the government for its crackdown on the party as police fired tear gas to disperse

the crowd. The rally — postponed twice in the last two months — was held near Sangjani Cattle Market in the suburbs of Islamabad after the capital administration issued a noobjection certificate (NOC). Thousands of PTI supporters attended the rally, proving that the party's power base was intact despite several hurdles it faced, including the incarceration of its 71-year-old founder. Khan was arrested on August 5 last year after his conviction in the Toshakhana corruption case filed by the Election Commission of Pakistan. Since then, he has been in jail in different cases. On Sunday, Khan completed 400 days in prison.

#### INJURED IN CLASH

At least 13 policemen were injured in Pakistan after they clashed with a mob protesting against the disappearance of a youth in the Badin district of the Sindh province, according to the police. The incident took place in the Allah Khan Magsi

village on Saturday. "The policemen were injured after they tried to disperse a mob of angry tribesmen from the Magsi clan who were protesting the disappearance of one of their youth," a senior police official said. The youth was picked up by the police in connection with a motorcycle theft and disappeared from the lockup on Saturday. The mob got violent when the police claimed the youth was freed by a group of armed men, who took him with them.

"The mob attacked the police with bricks and sticks, and they also damaged the police station and vehicles parked at station," Superintendent of Police Zubair Ahmed said.

As the police tried to disperse the crowd of people, 13 policemen were injured and sent to hospital, he said.

#### AT LEAST 6 INJURED IN EXPLOSION

At least six people, including three policemen, were injured in a bomb explosion that targeted a vehicle carrying workers associated with the Pakistan Polio Programme in the country's restive northwestern

province, authorities said on Monday. The explosion resulted in injuries to three frontline polio workers and three police men in South Waziristan district's Wana town. The injured were immediately shifted to a hospital and their condition is stated to be stable. Police contingents rushed to

the explosion site and launched a combing operation to arrest the accused. Authorities in Pakistan last week reported its first polio case in the capital Islamabad in the last 16 years, a setback to the national efforts aimed at eradicating the crippling virus from the country. The country came close to achieving zero poliovirus cases in 2021 when only one infection was reported. So far this year, 12 cases have been reported from Balochistan, three from Sindh, and one from Punjab and Islamabad each. Separately in Peshawar, the capital of the Khyber Pakhtunkhwa province, a suicide vest was thrown by two motorcyclists when they were signalled to stop by police at Jameel Chowk, Ring Road. A bomb disposal squad has been called to defuse the jacket that has seven kilograms of explo-

### 8 Afghan Taliban soldiers killed in border clash with Pakistani forces

A South Korean commission found evidence that women were pressured into giving away their infants for foreign adoptions after giving birth at government-funded facilities where thousands of people were confined and enslaved from the 1960s to the 1980s. The report by the Truth Reconciliation Commission on Monday came years after The Associated Press revealed adoptions from the biggest facility for so-called vagrants, Brothers Home,

Its latest report is focused on four similar facilities in the cities of Seoul and Daegu and the provinces of South Chungcheong and Gyeonggi. Like Brothers, these facilities were operated to accommodate government roundups aimed at beautifying the streets.

Ha Kum Chul, one of the commission's investigators, said inmate records show at least 20 adoptions occurred from Daegu's Huimangwon and South Chungcheong province's Cheonseongwon in 1985 and 1986. South Korea

Officials later note that she eventually did."It's difficult to accurately determine how many more adopted children there might have been in other years," Ha said, citing the commission's limitations in staff. For Huimangwon, Ha said, the commission was only able to look through its inmate records from 1985 and 1986 and still found 14 adoptions. A further six adoptions were linked to inmates at Cheonseongwon.At their peak, Huimangwon had about 1,400 inmates and Cheonseongwon 1,200. That was still smaller than the population at Brothers, which exceeded 3,000. Holt and Eastern did not immediately respond to requests for comment on the commission's findings.

# FPI disclosure deadline approaches amid legal tussle with SEBI

Some FPIs have sought legal avenue to avoid complying rules requiring ultimate beneficial ownership (BO) to the markets regulator Sebi as the deadline expires on Monday. Two Mauritiusbased foreign portfolio investors -- LTS Investment portfolio Fund and Lotus Global Investment -- have reportedly approached the Securities Appellate Tribunal (SAT) to seek urgent relief from adhering to Sebi's new norms for foreign investors.

These two FPIs were named in the January 2023 report on Adani Group by the US-based short-seller Hindenburg Research.

They have asked SAT to direct Securities and Exchange Board of India (Sebi) to give more time to meet these rules. Sebi set a deadline of 9 for noncompliant FPIs that fail to provide detailed ownership their violations.

On Friday, there were rumours that some overseas funds were rushing to sell their holdings ahead of Monday's deadline.

"Even though Sebi's deadline for disclosure of beneficial owners in FPI holdings ends on Monday, September 9, it is learnt that two FPIs have moved the appellate tribunal SAT seeking time till March 2025 to meet these norms. Therefore, the verdict from SAT is awaited.

"If the verdict comes in their favour, that will not impact the market. Otherwise there may be some selling pressure from these FPIs which might impact the market marginally. Sebi enforcing these norms is a healthy and desirable trend that will make FPI investment completely transparent," V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said. 

# Jannik Sinner beats Taylor Fritz in the US Open men's final weeks after doping exoneration

Tannik Sinner started slowly at the US Open, dropping the first set he played

after being exonerated in a doping case no one knew about until shortly before play began at Flushing Meadows. If that episode initially hung over him during the tournament, Sinner was able to put it aside while on court. Was he ever. The No. 1-ranked Sinner beat Taylor Eritz 6.3 6.4 7.5 with his typical Taylor Fritz 6-3, 6-4, 7-5 with his typical relentless baseline game to win the men's championship at Arthur Ashe Stadium on Sunday, less than three weeks after word emerged of his two positive drug tests. positive drug tests.

"This title, for me, means so much," said Sinner, a 23-year-old from Italy, "because the last period of my career was really not easy

He won the second Grand Slam trophy the Australian Open in January - and prevented No. 12 Fritz from ending a major title drought for American men that has lasted 21 years.

Andy Roddick's triumph at Flushing Meadows in 2003 was the last Slam title for a man from the United States. The last before Fritz, a 26-year-old from California, to even contest a final at one of the four biggest tournaments in tennis also was Roddick, who lost to Roger Federer at Wimbledon in 2009.

"Being an American at the US Open is just incredible. Feeling the love all week. So thank you so much," Fritz said during the trophy ceremony. "I know we've been waiting for a champion for a long time, so I'm sorry I couldn't get it done this time. But I'm going to keep working and, hopefully, I'll get it at the

Still, this tournament was a success in many ways for US tennis, with two women and two men from the country all reaching the semifinals for the first



time at a major since the 2003 US Open. Jessica Pegula reached the women's final before losing Saturday to Arvna Sabalenka of Belarus.

Sinner improved to 55-5 with a tourhigh six titles in 2024. That includes a 35-2 mark on hard courts, the surface used at both the Australian Open and US Open. He's the first man since Guillermo Vilas in 1977 to win his first two Grand Slam trophies in the same

"So many big wins for me this season," said Sinner, who took full advantage of Week 1 exits by Novak Djokovic and Carlos Alcaraz. "But the work never

The world found out on August 20 that Sinner had tested positive twice in an eight-day span for trace amounts of an anabolic steroid in March but was cleared because his use was ruled unintentional - the banned substance entered his system via a massage from a team member he later fired.

While some players wondered whether he was accorded special treatment, most believed he wasn't trying to dope. And the US Open's fans never gave him a hard time.

Sinner then double-faulted, putting Fritz in front 4-3.

But when he tried to serve out the set at 5-4, Fritz buckled enough to let Sinner pull even by breaking. Sinner used a drop shot to lure Fritz to the front court, then slid a passing shot that Fritz volleyed into the net. Fritz bounced his racket off the court. Sinner loped to the towel box, not even smiling.

About 10 minutes later, the victory was run. When it was over, Sinner raised his arms, threw his head back and closed his eyes.

He generally asserts himself during matches in what perhaps is best described as a rather casual way. His style is less spectacular than solid, less magical than metronomic. Either way, it was masterful, using his long limbs and squeaking, sliding sneakers to get to everything before aiming high-speed shot after shot right near lines - and

usually succeeding. Neither player seemed all that interested in venturing forward Sunday unless forced to, instead content to ply their forehands and backhands from the back of the court.

That's decidedly Sinner's territory.

By the end, Sinner, the second Italian to win a singles title at the US Open, joining 2015 women's champion Flavia Pennetta, had an impressive ledger: just 21 unforced errors, 13 fewer than Fritz, and 23 winners.

# Will Los Angeles 2028 be the moment when Paralympics conquer America?

**AP** ■ LOS ANGELES

Paris raised the game for the Paralympics, with more than 4.000 athletes as well as 2.4 million tickets sold, which was second only to the London Games of 2012. Now the challenge for US organisers is to top it with another breakout moment for para sports.

We want to conquer America," said Craig Spence, a spokesman International Paralympic Committee.

Retired Army Lt. Gen. Reynold Hoover, CEO of the organizing committee for the 2028 Los Angeles Olympics and Paralympics, is confident the Paralympics can do just that.

We don't have the Eiffel Tower, we don't have the Grand Palais, but we've got the Coliseum and we've got the Rose Bowl and we've got SoFi (Stadium), and all these tremendous state-of-the-art venues," he said in an interview Friday as the Paris Games wound down.

The Paralympic venues for Los Angeles haven't been announced yet - ideally, they'll be finalized by the end of 2024. Since LA received the bid in 2017, several venues such as Crypto.Com Arena and Sofi Stadium have either been reenvisioned or built.

With five new sports coming to the Olympics, and the addition of para climbing in the Paralympics, a record combined total of up to 15,000 athletes are expected to compete.

"We try to figure out what is the sport that is kind of new, engaging, emerging and can offer the Paralympians another avenue in which to show their intensity and commitment to sport," Hoover said.

If the Paralympics are to take a


their last two tours of Australia (2018-19 and 2020-21) with an identical 2-1 margin.

## Pant on course to become all-time great in Tests Needs to improve in shorter formats: Ganguly

Former India captain Sourav Ganguly believes Rishabh Pant is on course to become an all-time great in Test cricket but at the same time, the southpaw needs to raise his game in the shorter formats. Pant on Sunday returned to the

Test side for the first time since his life-threatening car accident in December 2022. He is expected to the start the first Test against Bangladesh beginning in Chennai on

September 19. Since his return earlier this year following the accident, Pant has played T20s and ODIs and has done well.

"I consider Rishabh Pant one of India's best Test batsmen. I'm not surprised that he's back in the side, and he will continue to play for India in Tests," Ganguly said at a

promotional event here.
"He will be an all-time great in Tests if he keeps performing like this. For me, he needs to get better in the shorter formats. With the talent he has, I'm sure with time, he will become one of the best."

Indian selectors have opted to give Mohammed Shami more time to recover from an ankle surgery and have named uncapped left-arm pacer Yash Dayal and Akash Deep in the squad. Jasprit Bumrah and Mohammed Siraj are the two frontline pacers.

"I know Mohammed Shami is missing because of injury, but he will be back very soon since India is going to Australia. It's still a very good attack," Ganguly said.

"In India, you will see a lot more spin. In Chennai, you will see a lot more bounce. Ashwin, Jadeja, Axar, and Kuldeep are the four best spinners in the world at the moment — it won't be easy. When you play in India, spinners have a lot more say in the game. But India are a very good team."

I am looking forward to their tour to Australia; that, for me, will be the real test for the squad. Then, when they tour England in July, these are the two most important tours, to be honest. I think the pace bowling department, with Bumrah and Siraj, and once Shami comes back, will be

strong." He also hailed Bengal pacer Akash Deep and said he's one to watch out for.

"Akash Deep is an outstanding young fast bowler. He runs in, bowls quick, and will bowl for long periods. I've seen him play for Bengal, taking wickets. "He will be as quick as Siraj and Shami, hitting high 140s. He is one to watch out for," he added.

**TOUGH CHALLENGE** BANGLADESH: **VERSUS** Having conquered Pakistan, Bangladesh's next assignment will be a two-Test series in India.

Going to Pakistan and beating them is never easy, so congratulations to the (Bangladesh) players. But India will be a different kettle of fish: India, whether at home or away, are a fantastic side

with a very strong batting unit. "I don't see Bangladesh winning; India will win the series. But India must expect good and tough cricket from Bangladesh because they are coming into the series with a lot of confidence after beating Pakistan in Pakistan," he added.

GENUINE DEARTH OF TALENT IN PAKISTAN: With Pakistan hitting a new low with a Test series loss to Bangladesh, Ganguly feels there is a "genuine dearth of talent" in the country and they are far from the glory days when players like Javed Miandad, Wasim Akram, Waqar Younis, formed the backbone of the team.

"I see a genuine dearth of talent in the country. Every time we think of Pakistan, we remember Miandad, Wasim, Waqar, Saeed Anwar, Mohammad Yousuf, and Younis Khan.

That's the memory of Pakistan for us, but that doesn't win matches in the modern generation of cricket. Every generation has to produce outstanding players to win, and when I look at Pakistan in world cricket — I saw them in the West Indies World Cup, in India during the World Cup, and now after the Bangladesh series loss -there is a dearth of talent in that country.

'The people connected with the sport in Pakistan will have to look into it. I'm not saying this with disrespect. Pakistan of the old had some great cricketers, which I don't see in this squad," Ganguly said.

## 'Health of Indian motorsport has improved significantly over past five years'

The health of Indian motorsport has improved significantly over the past five years but a lot more can be done in terms of infrastructural support, says JK Tyre motorsport head Saniay Sharma

Sharma's organisation has supporting Indian motorsport for close to three decades. The tyre maker is running its national racing championship for the 27th consecutive season but seeing the bigger picture, this year the company has partnered with RPPL for the Indian Racing Festival (IRF).

RPPL is the promoter of the FIA-sanctioned Formula 4 championship in India and could bring Formula 3 to the country as soon as next year. "The health of motorsport is improving considerably. If you just compare how things have changed in the last 8 to 10 years, everything is crystal clear. It's very unfortunate that in terms of infrastructure, we do lack a lot of support," said Sharma following round two of IRF. MotoGP hosted its inaugural

Buddh race the International Circuit last year but the round was dropped for the 2024 season and is expected to return in March next year. The premier two-wheel race

needed changes to the track

that hosted Formula 1 for

three editions and now it

needs to be homologated again for four wheel racing. Sharma lamented the state of affairs in this context. The only big F1 track which

hosted MotoGP last year now even doesn't have a homologation to do car events. And they have their own set of little problems, but whatever they are, they are not available for the sport. "So this is one of the very major kind of setback,

because even to our championship, because one of the reasons that we got together (RPPL and JKTyre) two like-minded people, was that we will come back with a package that was worth BIC standard with fast cars and good turnout.

"However, having said so, if you see there are more promoters, more sponsors, more patronage for drivers, things are looking really good. In terms government, I would say from the era where they didn't recognize us as a sport, we have come a long way. They are very receptive.

"And the live example of that is street races in Hyderabad and now Chennai (held earlier this month)," said Sharma. The tyre major had brought Formula BMW to India back in 2011 but a decade and more later, Sharma feels the current Formula 4 championship in the IRF is a better package. "On paper, the Formula 4

does look a little better. But safety-wise, there is a whole lot of difference. These new generation cars are far ahead. carrying all the latest safety norms. Then coming to the program of the FIA, if you follow it also helps you later for the super license.

"The structure is more formalised by the FIA (the world body). Unlike in the past, we don't need to race outside India anymore. Now everything is available in your own backyard, in your own

pocket size. "With the kind of vigour and vision that our partner RPPL has, I think the story which now will unfold will be the best that India can ask for," Sharma added.
