# KEJRIWAL OFFERS TO QUIT AS DELHI CM

In an unexpected move that shook the political circles here, AAP convener and Delhi Chief Minister Arvind Kejriwal on Sunday announced that he would resign after two days and would demand early polls in Delhi while vowing not to sit in Chief Minister's chair till people give him a "certificate of honesty".

According to Kejriwal, he will hold a meeting of AAP MLAs in the next couple of days, and a party Leader will take over as the Chief Minister. The AAP convener also ruled out the possibility of former Deputy Chief Minister Manish Sisodia being named Chief Minister. The announcement came two days after the Supreme Court granted him bail in the corruption case linked to Delhi's now-scrapped liquor policy. The BJP hit back at the AAP supremo, terming his move a "PR exercise" and a "drama".

The AAP national convener, who reached the party headquarters here on Sunday along with his wife Sunita to address party workers, demanded that the Delhi elections be held in November 2024 with Maharashtra, instead of February 2025. I will only sit on Chief Minister's chair after people give me a certificate of honesty. Want to give 'agnipariksha' after coming out of jail," he said. He also requested all the non-BJP State CMs to "not resign in any situation. And run the Government from jail".

Insiders say his resignation caught many by surprise, but the decision may not be as unexpected as it

seems because the Supreme Court granted him bail on Friday, but with several conditions which gives more powers to the Lieutenant Governor. The most significant of these is a restriction barring him from entering the Chief Minister's office or signing official documents "unless absolutely necessary to obtain the Lieutenant Governor's sanctions." He has also been barred

from entering the Delhi secretariat. The surprising decision has left everyone wondering who will be the next Chief Minister of Delhi. Party insiders say Sunita Kejriwal, Rakhi Birlan, Atishi, Gopal Rai and Sandeep Pathak are among the top contenders for the CM post if he resigns. The shock announcement may reap poll benefits for the AAP as

Kejriwal framed his recent announcement as a moral stand, suggesting that he will not occupy the CM chair until he receives a "certificate of honesty" from the electorate. Experts said the move is likely aimed at addressing corruption and governance under Kejriwal's leadership and also serves to rally AAP and its supporters around a

narrative of integrity and accountability. Meanwhile, choosing a CM for just a few months has often led to a power tussle and big exits later, as was witnessed in Jharkhand recently between JMM's Hemant Soren and Champai Soren, and in Bihar in 2014 after JD(U) chief Nitish Kumar reclaimed the top seat from Jitan Ram Manjhi.

Terming it as PR stunt, BJP national spokesperson Pradeep Bhandari claimed that Kejriwal has understood that his image among the people of Delhi is not of an honest leader. BJP leader Manjinder Singh Sirsa said that Kejriwal has no option but to resign because of the bail conditions on him by the Supreme Court. Sirsa claimed that Kejriwal sought two days' time to resign from CM's post to convince the party MLAs to make his wife, Sunita Kejriwal the Chief Minister of Delhi. BJP leader Kapil Mishra termed Kejriwal's announcement as the "victory for the people" of Delhi. "In the end, the corrupt Kejriwal will have to resign. This resignation is being forced due to the Supreme Court's strict action. The man who was adamant about running the Government from jail had to announce his resignation today. This is a major victory for the people of Delhi against corruption," he said. BJP's Harish Khurana questioned why the AAP Leader is creating a drama. "Why after 48 hours? He should resign today. In the past too, he has done this. People of Delhi are asking, he can't go to the secretariat, can't sign documents? What is the point then?"

This is not the first time he resigned. The last time Kejriwal resigned, his Government had worked only for 49 days and the decision was hailed as a masterstroke as the AAP returned with mammoth numbers nearly sweeping the polls by winning 67 of the 70 assembly seats in 2015. The BJP won only 3.

"You people might be thinking I have just come out of jail, why is he going to resign. They have raised allegations against me... They are saying that SC has put conditions on bail. After I resign, AAP will hold a high level meeting and decide a name for CM post," Kejriwal said while addressing party workers at his new headquarters. He said, "Despite the court giving us bail, the case will continue. I spoke to my lawyers. Till the case does not end, I will not sit on the CMs seat. After two days, I am going to resign from the post of CM. I will not sit on the CM's seat till the people elect me and send me to the seat again." Kejriwal alleged that the probe agencies sent him to jail to break his spirits, and the party. "Why did they send me to jail? It was not like I had committed any crime. They also know this. They just want to break my spirit, break my party, poach our Leaders, Ministers... send ED, CBI to torture our Leaders. But our Leaders and workers did not break. But I want to tell you today that they strengthened me by sending me to jail," he said. AAP convener added, "Both Sisodia and I were also stressing about this. He will also not hold any charge. We both will assume our seats when people will reelect us." The AAP national convener said, "I will become Chief Minister and Manish Sisodia deputy CM only when people say we are honest. Kejriwal said he would hold a meeting of AAP MLAs in the next couple of days and a party Leader would take over as Chief Minister.

## Vande Bharat on Voters' Platter

With Assembly polls in few States round the corner, fresh spice of Vande Bharat train series are back on the platter of the voters as Prime Minister Narendra Modi on Sunday flagged off six Vande Bharat Trains and also launched various projects worth Rs 660 crore. The PM's schedule to flag off the trains and other projects from the Tatanagar Railway Station had to be modified in the morning due to inclement weather which was not feasible for helicopter service from

Ranchi to Tata. Modi landed at Ranchi and the programme had to be scheduled virtually. PM apologised to the people for not being able to reach Tatanagar as "my chopper could not take off from Ranchi due to bad weather". Later during the day PM reached Jamshedpur by road to attend the political programmes and a Parivartan Maha Rally as per schedule. Modi is on a three-day visit to Jharkhand, Gujarat and Odisha where he will flag off several trains, lay the foundation stones and launch projects worth more than Rs

12,460 crore. Jharkhand goes to polls this November. He flagged off six Vande Bharat trains for Jharkhand, Odisha, Bihar and UP at Ranchi. Union Ministers Shivraj Singh Chouhan, Annappurna Devi and Sanjay Seth and Jharkhand Governor Santosh Kumar Gangwar were present at Tatanagar station. Sources said some of the rail projects for poll bound Maharashtra and Jammu and Kashmir are also in pipeline. "The work of laying railway lines, doubling of these and developing modern facilities at railway stations are

underway at a fast pace in Jharkhand," Modi said. Jharkhand, which was lagging in development, will also see rapid growth with the launch of these projects, he said. "The Centre has increased its investment for the development of Jharkhand. This year, Jharkhand has been given an allocation of Rs 7,000 crore for the development of railway infrastructure. If we compare the budget of the past 10 years, it is 16 times higher. Jharkhand has joined the list of States where 100 per cent electrification of the railway network has been achieved," he said.

## Road to justice in Kolkata

The Central Bureau of Investigation on Sunday alleged a "larger conspiracy" and "deep nexus" between the hospital authorities and a section of the police in the RG Kar Medical College and Hospital rape and murder case.

A day after arresting Abhijit Mondal the officer-in-charge of the Tala Police Station and re-arresting former RG Kar principal Sandip Ghosh — who is already in jail in custody on charges of corruption — the CBI advocates told the Sealdah Court that the two sides had conspired to destroy evidence and hush up the case. Both Mondal and Ghosh were given three-day CBI remand by the designated court.

Terming the incident an "institutional murder" the CBI pointed out in point 8 of the remand letter how the officer-in-charge showed extra hurry in allowing the cremation of the victim's body. The police "allowed cremation in a hurried manner when the family members demanded second autopsy," the remand letter said questioning the gap of more than 14 hours between the timing when the report

of the incident was first received by the police (at 10.03 am) and lodging of the FIR (at 11.30 pm). Not only this the officer-in-charge of the police station came a "full one hour late," the CBI told the court adding how a general diary number 542 was registered describing unconscious state of the victim when the "doctors of the medical college had already examined the body in a dead condition." The CBI was trying to understand the reason behind the "intentional

mistake" left by the police, the lawyer said. The lawyer also told the court that "the way the hospital authorities insisted in conducting the postmortem inside the same hospital where the incident took place and that too after sunset," was highly suspicious. Besides, when one of the autopsy surgeons asked for the requisite police permission for the postmortem to be done post sunset a sub-inspector of the Tala Police Station was allegedly asked to write the letter of permission which

was beyond his authority, sources quoting the CBI lawyer said. A postgraduate lady doctor of the RGKMCH was raped and murdered in the wee hours of August 8 explaining the "deep nexus" between a section of the police and the hospital authorities, the CBI said. CBI added that there was evidence to show that on the day of the incident Ghosh and Mondal had multiple telephonic conversations. Besides, "Mondal allowed the entire crime scene to be crowded by hospital people and outsiders for hours... people came and went and evidence was allowed to be tampered," lawyers said, adding this took place in front of some of the topmost officers of Kolkata Police. The CBI sources also said that apart from Mondal there were four more police officers who were under their scanner. Among them, there was an Indian Police Services officer. "Notices would soon be served to some of these officers for interrogation," sources in the central agency said adding however, that there was "nothing between the CBI and the police" and that "all the steps that are being taken are taken in the interest of the investigation."

## Nature's fury engulfs India

Heavy rains have wreaked havoc across India, flooding streets, widespread destruction, disrupting traffic, triggering landslides and chaos in multiple states. From north to south and east to west, the monsoon's relentless downpour has left cities grappling with submerged roads, rescue operations, and widespread chaos.

Gangetic West Bengal. The India Meteorological Department (IMD) data showed India, this monsoon has received 857.5 mm rainfall as against the normal of 795.9 mm so far. Notably, Arunachal Pradesh, Nagaland, Punjab and Chandigarh are among the rain deficit States and two weeks left for departure of monsoon this year. Data showed East and North-East sub division has received 1047 mm rainfall as against the normal of 1233.9 mm, a deficit of 15 per cent so far; North-West India including Jammu and Kashmir, Ladakh, has received rainfall of 590.9 mm as against the normal of 552.5 mm, around 7 per cent more this season.



Central India received 1068.5 mm as against normal of 906.8 mm rainfall, which is 18 per cent more so far. South Peninsula received 759.8 mm

rainfall as against the normal of 631.5 mm, around 20 per cent more this year. The torrential downpour across Delhi for the past few

days has surpassed both annual and seasonal average rainfall in September in the national Capital. According to the India

Meteorological Department (IMD) data, the city has already exceeded the 1,000 mm rainfall mark this month, the highest since 2021 and the second highest in at least the last decade, as against the usual 650 mm of rainfall that it receives during the monsoon season. The month has recorded 125.8 mm of rainfall, which is also 55 per cent higher than normal. Moreover, this continuous spell has brought the city to a halt as rain results in severe waterlogging, closure of underpasses, and traffic snarls, along with occasional reductions in visibility in the city. It has also led to the loss of lives due to drowning and electrocution with reportedly about 40 people dying in

Delhi so far. South Peninsula received 759.8 mm rainfall as against the normal of 631.5 mm, around 20 per cent more this year. The IMD has also issued a fishermen warning, advising against venturing into the northern Bay of Bengal and the coasts of Bangladesh, West Bengal, and Odisha until the morning of September 16 due to expected rough sea conditions. Squally winds with speeds of 45-55 km/h, gusting up to 50 km/h, are anticipated over Gangetic West Bengal (including Kolkata) and nearby areas in North Odisha and Jharkhand. Residents and travelers in the affected areas are advised to stay updated on weather

alerts and take necessary precautions to ensure safety during the severe weather conditions. As many as 200 people died this monsoon so far. Water leakage has been reported at the Taj Mahal after incessant rain in Agra. The death toll in the collapse of a three-storey house in Zakir Nagar in Meerut has risen to 10 while the rescue work at the site is still underway. The local meteorological department issued a "yellow" alert for thunderstorm and lightning at isolated places in six districts of Himachal Pradesh on Sunday and Wednesday. It also predicted a wet spell in the State till September 21. Over 40 roads were closed in the State and 53 power supply schemes were disrupted on Saturday evening as per the State Emergency Operation Centre (SEOC).

# Mehbooba has only brought destruction to J and K, claims Omar

National Conference (NC) vice president Omar Abdullah Sunday hit out at People's Democratic Party (PDP) chief Mehbooba Mufti, saying she has brought nothing but destruction to Jammu and Kashmir.

On Delhi chief minister Arvind Kejriwal's announcement of resignation, the NC leader said it remains to be seen what will be his next steps.

"Mehbooba Mufti has brought nothing but destruction to Jammu and Kashmir. If anyone has played the biggest role in bringing BJP (in J&K) then it is PDP and its leadership," Abdullah told reporters in Anantnag district of south Kashmir.

Referring to the violent street protests after the killing of Hizbul Mujahideen commander Burhan Wani in 2016 that left over 90 civilians dead, Abdullah said Mufti should give an account of 2016 before pointing fingers at him.

"She talked about milk and toffee... She has not yet apologised for that. She has not yet apologised for bringing



the BJP here. She has not apologised for pushing Jammu and Kashmir towards this destruction. Why is she targeting me? Let her clear her own record first," the NC leader added.

The former chief minister asked what compulsion did the PDP have to form an alliance with the BJP in 2015? "We were ready to give them the government at that time. The NC and the Congress first sent a message of their support to Mufti Sahab and after his death, to Mehbooba Mufti. Why did they reject it? What was their weakness that

they had to go with the BJP?" he asked.

He said Mufti used to say that time that they would bring more confidence building measures (CBMs) from Delhi because of the alliance with the BJP, but "one after the other, all our CBMs were stopped".

Asked about Kejriwal's announcement, Abdullah said, "I have just heard about it. Why is he resigning, will there be elections after his resignation or is he making someone else the chief minister. Let the information come, then we will talk about it."

# RG Kar: Rains, rallies inundate Kolkata

Kolkata on Sunday returned to its usual life with protest rallies demanding "justice" for the victim doctor of the RG Kar Medical College being taken out from all parts of the city a day after the much talked about talks between Chief Minister Mamata Banerjee and agitating junior doctors failed to take off following three hours of negotiations over the live streaming of the dialogue.

Two large rallies of the junior doctors started from two points and met at the Central Park in Salt Lake before marching towards the sit-in site and Swasthya Bhavan whereas the ex-students, mostly women from a number of schools in central and North Kolkata took out rallies demanding "justice for RG Kar." Most pertinently the ex-service men to the ranks of Army Brigadiers and Admirals of Indian Navy too took part in the procession demanding justice for the victim and a safe environment for women.

"If a doctor is not safe in her hospital which is her second home then who is safe and where," asked Major Samanta (retired) adding how he too was worried about his own



daughter who was presently pursuing management course. "Consider this inclement weather ... there is deep depression not only in the skies but also in our minds ... the issue is far bigger than what we all think ... if we cannot give justice to our Abhya (the victim lady doctor) then we will be a failed society ... then where is the need for the police force to be paid from our tax-payers money," said Dr Debashis Pramanik one of the agitating doctors. A lady doctor said, "the Government is asking us to return to festivities ... but what can be a bigger festival than to get soaked in rains for

the sake of justice and to secure the society for women in future."

Meanwhile in a related development Bengal State Minister for Health Chandrima Bhattacharya rejected the claims made by the junior doctors that she had turned them out of the Chief Minister's residence. "The Chief Minister had called them for talks and how can I ask them to go ... but the way the things were delayed talks fizzled out," she said adding "the Chief Minister has already said that she has no problem to talk so that the doctors can go back to their work."

# Massive crackdown against hiding foreign terrorists in Jammu

A joint team of security forces Sunday launched a massive crackdown at two separate locations after picking up the movement of a group of foreign terrorists in the Mendhar tehsil of Poonch and Bani area of Kathua district. Initially, a brief exchange of firing took place at both places, and reinforcements were also rushed to pin down the terrorists. Intermittent firing was reported at different intervals during the day. According to a police spokesman, acting on a tip-

off, a joint search operation was launched by the police and Army in the Pathanater area near Gursai top in Mendhar sub-division on Saturday evening.

He said the search party came under fire from the hiding terrorists, triggering a gunfight. In the second anti-terrorist operation, the search operation was launched by the security forces in the general area of Bani in Kathua. Till the time of filing the report, the security forces were maintaining a tight cordon and carrying out searches in the thickly forested areas to hunt down the terrorists hiding in the area.

# Two arrested for robbing woman by impersonating police, army personnel

Delhi Police has arrested two men for allegedly robbing a woman by impersonating police and Army personnel. According to the police on Sunday, the accused have been identified as 28 year old Mohammad Shahrukh and 38 year old Satish Jaishwal. The police also recovered one gold mangalsutra, Rs. 10,900, and one white coloured Wagon-R Car used during commission of crime.

On September 6, a woman filed a complaint of cheating at the Kamla Market police station. "An incident of cheating with a lady was reported at Kamla Market police station. During enquiry, it came to know that while waiting for Bus at Bus Stop, Minto Road, one of the accused approached her



in a car and asked directions for Kapashera," DCP Central M. Harsha Vadhani said. Meanwhile, another accused standing at the bus stop replied that he knew the route and he was also going towards Kapashera Border and boarded the car. "The accused persons impersonating themselves as police and Army personnel lured the complainant to get into the car for a free ride till Kapashera border," said the officer, adding that they allegedly robbed her of man-

galsutra and ATM card. According to police, they checked the CCTV footage and tracked the car's owner. "During investigation, local enquiry was made, CCTV footage of the place of occurrence and place where the victim was dropped were checked in which one Wagon R Car used during commission of offence was identified," the DCP added.

Accordingly the owner of the car was tracked but it was found out that the car was handed over to some other person. "The team put more effort into the case and after several enquiries the team got the clue about one accused namely Mohd. Shahrukh. The team immediately rushed to his residence and apprehended accused Mohd Shahrukh from his residence," he said.

# Police bust counterfeit visa operation in West Delhi

Delhi Police arrested seven people and claimed to have busted a gang of counterfeit visas operating in west Delhi's Tilak Nagar area.

According to officials on Sunday, a substantial quantity of equipment used in manufacturing fake visas along with 14 Nepalese and two Indian passports have been seized from the house of the main accused.

The accused have been identified as 51 year old Manoj Monga, the main accused from Tilak Nagar. The others have been identified as 42 year old Shiva Gautam, 25 year old Naveen Rana, 65 year old Balbir Singh, 55 year old Jaswinder Singh, 27 year old Ashif Ali and a passenger named Sandeep. While elaborating on the case,



DCP (IGI Airport) Usha Rangnani said, "On the night of September 2, Sandeep from Haryana went to the departure immigration counter at Indira Gandhi International Airport here with an Indian passport." She added that he intended to

depart for Rome in Italy, but during scrutiny of his documents a fake Swedish visa was found affixed on his passport and he was arrested, Rangnani said. Later, an investigation was launched after registering an FIR. "Sandeep, who was looking to

move abroad, had contacted Ashif Ali, a travel agent. Ali agreed to send Sandeep to a European country in lieu of Rs 10 lakh. Sandeep paid Rs seven lakh in two bank accounts of the agent and paid Rs 50,000 in cash," Rangnani said.

Further, Ali and his associates -- Naveen Rana and Shiva Gautam -- arranged tickets and a Swedish visa for Sandeep's journey to Rome. "Ali, Rana and Gautam were arrested which led to the arrest of Balbir Singh and Jaswinder Singh," she said. Police said that Jaswinder Singh disclosed the name of Manoj Monga, who is an expert in design and preparation of fake stickers. Monga was arrested from his house in Tilak Nagar where he was running his fake visa business. According to police, five years

ago, Monga came in contact with Jaideep Singh and they established an illegal factory for manufacturing fake visas at Monga's house. Later, Monga also started providing fake appointment letters to his customers so that their visas look legitimate.

Police said that 30 fake stickers were issued in the names of different persons, 23 rubber stamps of various countries, three fake Permanent Residency (PR) cards of Italy, three wooden dyes of different embassies, four metal dyes of different countries, 14 original Nepalese passports, two original Indian passports and many other items were recovered from Monga's house. Further investigation in the case is underway and efforts are underway to nab the other associates, police added.

# Bahraich wolf attacks: Yogi conducts aerial survey of Mahasi, meets affected families

Uttar Pradesh Chief Minister Yogi Adityanath on Sunday assured the residents of Mahasi tehsil that the forest department, district administration and police will continue working until the wolf threat ends.

He also conducted an aerial survey of the region and met families of those who lost their lives in the recent wolf attacks during the human-wildlife conflict. The priority is to capture the remaining wolf safely and shooting it will be the last resort, said Adityanath who also met the injured and inquired about their well-being. According to an official statement, the chief minister assessed the relief efforts, including the compensation provided and medical assis-

tance given to the injured.

While addressing the media, Adityanath emphasised that the safety of the public is the government's top priority and said that the forest department, district administration and police, will continue working in the area until the threat is fully eliminated.

"The government has classified human-wildlife conflict as a disaster. In the event of loss of life, an immediate compensation of Rs 5 lakh is provided to the victim's family. Anti-rabies treatment has also been made available for those injured in wild animal attacks," he said.

The chief minister further said 25 teams, comprising 165 personnel from the forest department, have been deployed to ensure public safety. Four thermal drones have

also been deployed for monitoring.

"The primary objective is to capture the wolf safely. However, if the animal's aggressive behaviour escalates or poses a threat to human life, orders have been issued to shoot it as a last resort, with other measures being prioritised first," he said.

"There have been casualties in the Mahasi assembly constituency, located near the river, due to wolf attacks over the past two months. Several children have also been injured. Upon receiving the first reports from public representatives, the administration was directed to launch a comprehensive campaign, after which the Forest Minister and department officials were dispatched with a response team," he said.

Within a 20-25 km radius, eight people have lost their lives in the last two months, and five wolves have been successfully captured so far, though one remains elusive, he said.

Adityanath said that the area is prone to wild animal incidents, particularly during this season when the floods force animals to migrate closer to human settlements in search of prey, leading to attacks where vulnerable targets are found.

The first incident occurred on July 17, when a wolf attacked a one-year-old child, and the attacks continued intermittently every four to five days, he said. The most recent fatality was reported on September 1, and while an attack on a child was reported on September 2-3, no further incidents have occurred since then.

Alleging the BJP tried to prove him corrupt, Kejriwal said the saffron party cannot provide good schools and free electricity to people because they are corrupt. "We are honest," he asserted.

"They slap false cases against non-BJP Chief Ministers. If they are arrested, I urge them not to resign but run the Government from jail," the Delhi Chief Minister said. "I didn't resign (after arrest in excise policy case) because I respect democracy and the Constitution is supreme for me," Kejriwal said and asserted that it is only the AAP that can stand up to the BJP's "conspiracies". Referring to him quitting the Chief Minister's post in 2014 over the Jan Lokpal Bill, just 49 days after assuming power, Kejriwal said, "I resigned then for my ideals. I do not have a

lust for power."

Saying that the excise policy case would go on for long, the Chief Minister said he wanted to ask the people of Delhi whether he is honest or guilty. He asked people to vote in his favour only if they considered him honest. "For me, the BJP is not important, people are important," he said.

"Our Leaders Satyendra Jain and Amanatullah Khan are still in jail. I hope they come out soon," the Chief Minister told AAP workers here as he thanked God "who was with us through difficulties." About his time in jail, Kejriwal referred to letters written by freedom fighter Bhagat Singh while in British captivity and said, "I wrote only one letter to the Lieutenant Governor from Tihar and was issued a warning." "Our freedom fighters were allowed meetings with colleagues but

my party colleague Sandeep Pathak was not allowed to meet me in jail," he said.

Addressing AAP workers, Kejriwal said, "I had a lot of time in jail. I read a lot of books when I was inside jail like Bhagavad Gita... Today, I bought one book written by Bhagat Singh. When he was in jail, he wrote several letters to his comrades, family, sister, his childhood friends... and the Britishers sent those letters. I also went to jail and I wrote only one letter to LG Sahab. It was August 15."

"I wrote a letter to LG Sahab three days before the Independence Day and asked him to permit Atishi to host the Independence Day. I was given warning that if you write another letter, we will stop your meeting with family. I was thinking not even Britishers did such things," Kejriwal said.

He said he did not resign as Chief Minister despite being arrested because he wanted to save democracy. "They have registered cases against (Karnataka Chief Minister) Siddaramaiah, (Kerala Chief Minister) Pinarayi Vijayan, (Bengal Chief Minister) Mamata didi (Banerjee). I want to appeal to non-BJP CMs, do not resign if they register cases against you. This is their new game," he said.

AAP had returned to power in the national Capital by sweeping Assembly elections held in February 2020. AAP won 62 of the 70 assembly seats. The BJP won 8 seats and Congress won none. AAP won a landslide victory in the 2015 elections, securing 67 of 70 seats and Kejriwal was re-elected as Chief Minister for second time. He became the CM for the third time in 2020.

# Kejriwal to resign in two days: Decision raises pressing questions

After AAP convener and Chief Minister Arvind Kejriwal's announcement that he will resign as Chief Minister after 48 hours, the decision has raised two pressing questions: First, who will serve as the temporary Chief Minister of the national capital until the elections? Second, will the Election Commission allow early elections as requested by the AAP leader?

Another critical factor was the looming threat of President's Rule. The central government, led by the BJP, could have cited policy paralysis to justify imposing President's Rule, which could delay elections by up to six months. As Delhi is a National Capital Territory, the Lt Governor

will forward the Delhi Chief Minister's recommendation to the President through the Ministry of Home Affairs. The Lt Governor has the power to dissolve the Assembly on the advice of the chief minister. Currently, there is no proposal to dissolve the Delhi Assembly, which could reduce the possibility of President's rule being imposed.

First, choosing a CM for just a few months has often led to a power tussle and big exits later, as was witnessed in Jharkhand recently between JMM's Hemant Soren and Champai Soren, and in Bihar in 2014 after JD(U) chief Nitish Kumar reclaimed the top seat from Jitan Ram Manjhi. Now the question is also being raised will Delhi Chief Minister Arvind Kejriwal hand over the

responsibility to a family member? However, his wife Sunita Kejriwal's name has been in the news since the Lok Sabha elections when CM Kejriwal came out on interim bail for some time for an election campaign. Since then, there has been a constant discussion about Sunita Kejriwal's claim for the post of CM. Now that the CM has announced his resignation, discussions again intensified about who will replace him as the Chief Minister.

The CM's wife, who is on the second position of star campaigners for Haryana elections, has been actively participating in election campaigns along with the state unit leaders these days. Meanwhile, analysts also say that Kejriwal may not be portrayed that he is promoting dynastic politics because as he



and his party have always advocated a clean public image where there is no room for such politics. But internal dynamics within the AAP could create turbulence. Finding a suitable interim chief minister who commands the respect and loyalty

of party members, while also appealing to voters, could be challenging. Kejriwal's successor could either come from the current Cabinet or be strategically selected to leverage caste dynamics, with an eye of assembly polls in Haryana and Delhi.

Many names are doing the rounds including senior AAP leaders Gopal Rai, Sandeep Pathak, Rakhi Birlan, Raghav Chadha and Atishi for the coveted post. Analysts also are also giving Atishi an edge as she has risen rapidly since Sisodia's arrest and is currently holding more than 10 portfolios, the highest in the AAP dispensation.

The AAP leader holds several important portfolios in the Kejriwal-led government namely Finance, Planning, PWD, Water, Power, Education, Higher Education, TTE, Services, Public Relation and Vigilance. Atishi now oversees 11 portfolios, which is the highest number of departments a minister holds in the Delhi government right now. Atishi's importance can be gauged from the fact that Kejriwal in a letter to the

Delhi LG VK Saxena, suggested that cabinet minister Atishi will hoist the national flag in his place during the Delhi government's Independence Day programme.

Possibility of elevation of Delhi Assembly Speaker Ram Niwas Goel and Deputy Speaker Rakhi Bidlan cannot be denied as they both the close aides of the Delhi CM. Another thing, despite Kejriwal's demand for early polls, Election Commission has the authority to call for early elections if it deems it necessary due to extraordinary circumstances. However, the EC has historically preferred to adhere to established electoral timelines unless there is a compelling reason to intervene.

Experts say the city government may have to write to the

Election Commission giving reasons behind the demand. "Legally, the EC has the power to hold the assembly elections in Delhi alongside Maharashtra. But on previous occasions, the polls in Delhi were held separately. The EC should have a reason to club Maharashtra and Delhi polls," said an expert refusing to be named.

He also pointed out that the electoral rolls in Delhi would be updated in January with January 1 as the qualifying date. When the rolls are updated, the newly-registered voters are able to cast their votes. "Therefore, the EC may prefer holding the polls in Delhi as planned," he said.

The exit — likely to be formalised on Tuesday — will not be the first time that Kejriwal has stepped down as Delhi CM.

## Kejriwal conduct, image and character all under suspicion: BJP

Amid the sudden announcement of resignation by Chief Minister Arvind Kejriwal, Delhi BJP President Virendra Sachdeva on Monday raised questions regarding the resignation two days later and said that the AAP supremo's 'conduct, image, and character' are all under suspicion.

Addressing a joint press conference, Sachdeva said, "Arvind Kejriwal stated that he would leave his resignation to the public, but the public had already given its verdict long ago when they sent him to jail and didn't respond to the 'Jail ka Jawab Vote Se' campaign."

He claimed that the announcement for resigning from the post in two days' time is probably to settle some remaining issues and gather more money. "Given the deep-rooted corruption in the Kejriwal government, the entire cabinet should resign because there is no department untouched by corrup-

tion," Sachdeva stated. The Delhi BJP chief alleged that Kejriwal should have resigned following the incident of AAP Rajya Sabha MP Swati Maliwal accusing his aide Bibhav Kumar assaulting her. "Arvind Kejriwal is not only the first Chief Minister of Delhi but also the first in the country who called a woman MP to his house and got her mistreated and assaulted. If he had any decency, he would have resigned long ago," Sachdeva said.

He also asserted that Delhiites doubt whether Kejriwal will resign, and added that his past actions and changes in statements cast doubt on his announcement. The BJP leader added that the corruption of Kejriwal, who claims to speak of honesty, has hollowed out Delhi like a termite. "Every year, 40 to 45 people lose their lives due to waterlogging," he said.

South Delhi BJP MP Ramvir Singh Bidhuri expressed apprehension that Kejriwal's resignation announcement could be just a drama because



AAP is an expert in doing drama. "A drama of not resigning can also be done by calling a meeting of the legislative party. Therefore, it is not necessary that he resigns as per his announcement. If he submits his resignation to the Lieutenant Governor, only then it will be considered that he has resigned," Bidhuri stated.

Referring to the conditions applied on Kejriwal's bail, Bidhuri said, "The Supreme Court had made it clear while granting bail to Kejriwal that

he cannot work as the Chief Minister. He was barred from entering the Secretariat and was also barred from signing any file and his arrest was also declared valid." He added that a situation of constitutional crisis had arisen in Delhi and Kejriwal has no option left except to resign. "The festive atmosphere created by the AAP after Kejriwal's bail and calling it his victory has also gone. The Supreme Court has granted him bail but now the Chief Minister's chair is slipping out of his hands," the Delhi BJP MP alleged.

Chandni Chowk BJP MP Praveen Khandelwal described Arvind Kejriwal as a person who has outdone even chameleons in changing colours and said, "The demand for Kejriwal's resignation amid controversies has raised serious questions on the administrative capability and accountability of Delhi." "Kejriwal has described himself as a leader fighting for the interests of the common man, but his resignation is being seen as an attempt to divert attention from the recent allegations and controversies surrounding him and his government. He has proved himself to be a 'fugitive' as it contradicts the principles he espoused earlier," he stated, adding that this is not a voluntary declaration but a result of pressure from the Supreme Court which granted him bail but did not allow him to function as Chief Minister. Further, Sachdeva added that people in Delhi are devoid of drinking water and despite

the talk of free electricity, bills are coming with a 45 per cent surcharge. "Kejriwal, who talks about free and world-class healthcare services, should explain why more than half of the ICU centers in government hospitals are still non-operational," he questioned. "Kejriwal, who spied on opposition leaders and officials, seems to have forgotten about his espionage scandal, and now he is appealing to opposition parties," he said. Further, he added that Kejriwal is showing Bhagat Singh's diary, but he should read his own written 'Swaraj', in which alcohol was called a curse, and now, by engaging in the liquor trade, he has landed in jail.

"The Kejriwal government should explain why, if there was no scam in the liquor policy, they withdrew it when the investigation began. The court had sent him to jail, and legal proceedings are still ongoing. Instead of making noise, Kejriwal should focus on these issues," Sachdeva alleged.

## Resignation should have happened six months ago: Congress

Delhi Congress President Devender Yadav on Sunday welcomed the decision of Chief Minister Arvind Kejriwal to resign from his post, but claimed that this decision should have happened six months ago.

"He should have tendered his resignation six months ago then the public of Delhi would not have gone through a lot of crisis," Yadav said, adding that this looks like a "political drama" as the Supreme Court has already imposed restrictions on him.

"A new Chief Minister should be appointed as soon as possible," the Delhi Congress chief demanded. He said that the public of Delhi is "aware and they will surely give an answer" to the AAP's misgovernance in the Delhi Assembly elections. Responding to the announcement of Kejriwal resigning two days later, Yadav said, "Kejriwal

should have resigned as soon as he came out of jail, as there was no point clinging to the post of Chief Minister with the apex court putting a lot of restrictions on him. Why is he waiting for two days?" He added that Kejriwal had lost his moral right to continue as Chief Minister. "He has no right to continue on the post after he was sent to jail in connection with the liquor scam, following his arrest by the ED for money laundering and CBI for corruption, as governance took a back in the past six months, with people going through untold suffering due to waterlogging, water shortage, garbage pile up and deaths due to drowning in flood waters and electrocution, as nearly 40 people had lost their lives in the past two months in rain related mishaps," he said.

He accused the AAP supremo of not resigning so that his family could live in the palatial official residence.

## Will only hold portfolio with Delhi Government if people vote for me: Sisodia

Senior AAP leader and former Deputy Chief Minister Manish Sisodia on Sunday announced that he will only hold any portfolio in the Delhi government after the people vote for him stating that 'he did not come into politics here for the greed of chairs and posts' following the footsteps of AAP supremo Arvind Kejriwal who also announced his resignation

from the post of Chief Minister. "Along with Arvind Kejriwal, I will also go to the people's court, if people approve my honesty in elections, only then will I sit in the chair," he said. Taking to his 'X' handle, Manish Sisodia emphasized he didn't enter politics for power who recently came out of jail on bail after 17-month imprisonment in the alleged excise policy linked money laundering scam.

"I came into politics to work honestly for education. I worked honestly as Delhi's education minister for 10 years. I built schools. I built new universities. As the Education Minister of Delhi, I worked with the mantra that India cannot become a developed nation without providing the best education in government schools. The result of ten years of hard work is visible that today even in the gov-



ernment schools of Delhi, children are studying brilliantly and topping exams like IIT, JEE, and NEET," he said.

He further stated, "I worked honestly but attempts were made to prove me dishonest by making false allegations against me under petty politics - I was kept in jail for 17 months on false charges. After two years of legal process, now even the country's top court has told me to go and

do my work. But I will not sit on the chair of Deputy Chief Minister-Education Minister right now. I did not come into politics here for the greed of chairs and posts."

Sisodia added that he has come to work honestly on education and have also decided that he will go to the public court along with Arvind Kejriwal and ask whether the public considers him honest or not. "Elections are to be held in three-four

months. Only if the public approves my honesty, I will sit on the chair of Deputy Chief Minister-Education Minister and work for education. Jai Hind!" he said in a post.

Earlier, he addressed the party workers and public at AAP's headquarters and said, "Arvind Kejriwal kept the AAP united in such a big crisis, so today people expect that Arvind Kejriwal is the only person who can keep the whole country united."

## CM resignation defining moment in political history: AAP

AAP on Sunday lauded its party supremo and Chief Minister Arvind Kejriwal's decision to resign from his post while calling it a rare display of morality and a defining moment in the country's political history.

Senior AAP leader and Delhi Minister Saurabh Bharadwaj accusing the BJP for mudslinging against Kejriwal and said, "For the last two years, the BJP has been mudslinging at Arvind Kejriwal and all the big leaders of the AAP that these people are thieves, they have committed corruption and earned crores of rupees." "But even after two years of investigation, the ED-CBI do not have the courage to even start the trial. These people (BJP) are not even able to

start the case, the Supreme Court of the country itself is saying this," he said.

He claimed that while granting bail to Kejriwal, the Supreme Court that even today CBI is acting like a 'caged parrot'. Bharadwaj further added that in the history of the entire world, Arvind Kejriwal is the only Chief Minister who, after resigning from the post, is saying, "If I am honest, then vote for me, otherwise don't vote for me." The Delhi minister claimed, "Kejriwal is jeopardizing his entire career and saying that despite so much mudslinging and such adverse conditions, when the party has been thrown out of its office, many party leaders have been arrested, and the party has no money, even in such a situation, he is going among the



people and saying, "If I am honest, then put me back in the Chief Minister's seat, otherwise don't." The senior AAP leader said that in a time when Indian politics has become like a mud bath, such morality and purity are rarely seen. "This is unique to Arvind Kejriwal," he affirmed.

Delhi Minister Atishi hailed the decision and said, "He

built a party from zero against corruption and when that new party won, Kejriwal became the Chief Minister. Then, he resigned from his post only because he could not bring a law against corruption, which he had promised to the people of Delhi."

She said that the AAP supremo cannot tolerate corruption, dishonesty and pocketing public money. "Today, the decision of Arvind Kejriwal's resignation has come from the same pain that maybe there is a Delhiite who thinks that Arvind Kejriwal has committed corruption," she said.

"We have demanded early elections in Delhi. Elections are going to be held in Maharashtra in November, Delhi elections should be

held simultaneously and in this election, the people of Delhi will give their mandate to their brother-son Arvind Kejriwal. The people of Delhi have full faith in Arvind Kejriwal," Atishi asserted.

AAP Rajya Sabha MP Sanjay Singh said that the BJP has failed in trying to stop AAP and Arvind Kejriwal. "Chief Minister Arvind Kejriwal was arrested with the intention of ending AAP, but BJP failed in this. Now He is going among the public, we will take certificates from the public. The people of Delhi will decide whether they are honest or guilty. I have full faith that Arvind Kejriwal will bring the certificate of the people with a huge majority and win the upcoming elections with full majority," he said.

## Cops launch system allowing women to be in touch in real time

Haryana Police has launched an initiative under its Emergency Response System, allowing women travelling alone to be in touch with them in real time in a bid to ensure their safety, especially at night.

Women can now dial '112' and share their live location on Whatsapp with the police control room to avail the service, a senior police officer said. They will also have the option to stay on a call with cops until they reach their destination, the officer said.

To register, women can call '112' and share their travel

details, including name, mobile number, departure and arrival locations and expected travel times. The Haryana dial '112' team will then track the woman's location and stay in contact with her until she reaches her destination, he said.

The system is also connected to existing emergency response systems, including police, fire and health departments, which allows it to track the location of all services in real time and direct the nearest vehicle to the person in need, police said. Additionally, users can activate a panic call by pressing the power button on their phone three times quickly or long-press '5' or '9' key on a feature

phone. They can also email an SOS alert to the State Emergency Response Centre or use the 112 India Mobile App, the officer said.

Haryana Director General of Police, Shatrughan Kapur recently held a review meeting with senior police officials in Chandigarh to enhance women's safety system. Kaur also released a video message, especially for the working women, talking about the new services in the system. The meeting focused on the trip-monitoring service, creation of databases for auto-rickshaws and working women as well as the operational review of Haryana '112'.

## Kejriwal at crucial juncture in career after completing more than decade in politics

At 56 and with a surprise announcement of resignation from his post on Sunday, Chief Minister and AAP convener Arvind Kejriwal is at a crucial juncture in his political career while completing more than a decade in politics.

A man who has now made his name in the political landscape of the nation, Kejriwal's journey in politics began with his role in the India Against Corruption movement in 2011. The movement, led by activist Anna Hazare, aimed to

push for the passage of the Jan Lokpal Bill, which sought to establish an independent body to investigate corruption cases. During this period, Kejriwal emerged as a key figure advocating for clean governance and transparency. His involvement in the movement and his stand against corruption garnered significant public support, setting the stage for his political career. Inspired by the movement and the public's call for clean governance, Kejriwal founded the AAP in 2012.

The party's foundation was built on the principles of anti-corruption and transparency,

and it quickly captured the public's imagination, especially in urban areas tired of traditional politics. In its political debut during the Delhi assembly elections in 2013, AAP stunned established political parties by winning 28 out of 70 seats.

This victory propelled Kejriwal to the Chief Minister's office, but his first term was short-lived. After just 49 days in power, Kejriwal resigned, citing difficulties in passing the Jan Lokpal Bill. This abrupt resignation was a controversial move, sparking both criticism for its perceived



impulsiveness and praise for his commitment to anti-corruption principles.

Kejriwal and AAP made a remarkable comeback in the 2015 Delhi assembly elections. The party won a landslide victory, securing 67 of the 70 seats. Kejriwal was re-elected as Chief Minister, and his administration set out to focus on key public welfare areas such as education, healthcare, water, electricity, and infrastructure. Kejriwal's third consecutive term came after the 2020 Delhi assembly elections, where AAP once again dominated the polls. Representing

the New Delhi constituency, Kejriwal continued to focus on the issues of education, healthcare, and infrastructure. However, his political career has also been marked by frequent clashes with the central government.

In 2014, he contested the Lok Sabha elections against Narendra Modi in Varanasi but lost. Despite this setback, he remained a vocal critic of the Modi government, often confronting Delhi's Lieutenant Governor Vinai Kumar Saxena. Before entering the political arena, Kejriwal was an officer in the Indian Revenue

Service (IRS). He was actively involved in advocating for governance reforms and the Right to Information (RTI) movement, emphasizing transparency in public offices. He also received the Ramon Magsaysay Award for emergent leadership in 2006.

In recent times, however, Kejriwal found himself embroiled in a legal battle related to the Delhi excise policy. The Supreme Court's decision to grant him bail offered a temporary respite, yet the legal turmoil has cast a shadow over his administration.

# PM Modi flags off Vande Metro, inaugurates four Vande Bharat trains in Bihar

India's first Vande Metro, which will be virtually flagged off by Prime Minister Narendra Modi today in Gujarat is poised to transform inter-city travel with its advanced medium-distance capabilities. According to Railway Ministry, PM Modi will be in Ahmedabad, the train will start from Bhuj and reach Ahmedabad covering 359 km of distance in 5.45 hours.

For passengers, its regular service will start from September 17 from Ahmedabad and the total journey will cost Rs 455. "While the other metros cover only short distances, Vande Metro trains will connect cities from the heart of the city to the peripheral cities," the ministry said. It added that the word 'metro' gives an impression of urban landscape, however, Vande



Metro was conceptualised by incorporating numerous advancements. Giving a comprehensive overview of the Vande Metro and other Metros being operated in the country, the ministry said, "Vande Metro operates at a maximum speed of 110 km/h, offering faster acceleration and deceleration to passengers. This speed

advantage ensures quicker commutes and improved efficiency." It added, "With ergonomically designed seats, fully air-conditioned cabins and modular interiors, Vande Metro definitely proves to be superior than the other metros." Highlighting its safety aspects, the Railway Ministry

said that Vande Metro is equipped with advanced safety systems like KAVACH for collision avoidance, fire detection, and aerosol-based fire suppression, along with emergency lights. So far it's accessibility is concerned, according to the Ministry, it has been designed with inclusivity in features such as Divyangian-friendly

toilets, a fully sealed flexible gangway and meal service among others. Emphasising its superior technology, the Ministry said that Vande Metro incorporates cutting-edge technology, including under slung propulsion and advanced braking systems, offering a smoother ride. "Featuring 12 coaches with seating for 1,150 passengers, the Vande Metro offers a host of innovative features. It boasts double-leaf automatic sliding doors, similar to those in urban metro trains, and a fully sealed flexible gangway that ensures a dust-free, quiet, and rain-proof interior," the ministry said. A significant upgrade, according to the ministry, from traditional suburban trains and metro coaches is the Vande Metro's modular design that includes ejector-based vacuum evacuation toilets. ## Amit Shah releases expanded Hindi Kahavat Kosh on Hindi Diwas

"The main objective of this was to preserve these proverbs for the coming generation. I believe that increased awareness of these sayings will further enrich the Hindi language and the vocabulary of the people," he said. In addition to his literary con-

tributions, Agrawal runs the website 'healthhindi.in', which provides valuable information about common diseases and their prevention in simple Hindi, promoting health awareness. Looking ahead, Agrawal said he plans to include folk songs in future editions of the book, continuing his efforts to preserve India's cultural and linguistic heritage. "In Hindi literature, apart from the work done by well known writers, there is a vast area of folk literature contributed by unknown people of society through ages. This was transferred verbally and has accumulated through the generations. This includes proverbs, idioms folklores, folk music and puzzles etc. Due to massive impact of social media, people are forgetting all this legacy of Hindi literature. These invaluable creations are now on the verge of being extinct," Agrawal said. He said to preserve Hindi proverbs and to make them available for the common people, he has authored this book. This book also includes pictures of many things which are mentioned in proverbs but are unknown to the new generations. "This definitely is the largest collection of Hindi proverbs and the stories related to them," he said. The writer said to preserve other precious creations of folk literature, he has also collected a large number of lyrics of folk music, proverbs recited by children, Sanskrit proverbs, common proverbs written on transport vehicles and so many good old puzzles told to "us by our grandparents".

## BJP-led NDA to implement one nation, one election

The BJP-led NDA Government will implement 'one nation, one election' within its current tenure, sources said, exuding confidence that the reform measure would receive support across party lines. As the third term of the NDA government led by Prime Minister Narendra Modi completes 100 days in office, the sources said the cohesion within the ruling alliance will continue for the rest of the tenure. "Definitely, it will be implemented in this tenure itself. It will be a reality," one source said, speaking on condition of anonymity. In his Independence Day address last month, the prime minister made a strong pitch for 'one nation, one election', contending that frequent polls were creating hurdles in the country's progress. "The nation has to come forward for 'one nation, one elec-



tion," Modi had said in his address from the ramparts of the Red Fort. The prime minister urged the political parties "from the Red Fort and with the national tricolour as a witness to ensure the nation's progress". He also asked the parties to ensure that national resources are used for the common person and said, "We have to come forward to realise the dream of 'one nation, one election'." "One nation, one election' is one of the key promises made by the BJP in its manifesto for the Lok Sabha elections. A high-level panel headed by

former president Ram Nath Kovind in March this year recommended simultaneous elections for the Lok Sabha and state assemblies as the first step followed by synchronised local body polls within 100 days. Separately, the Law Commission is likely to recommend holding simultaneous polls for all three tiers of government -- Lok Sabha, state assemblies and local bodies like municipalities and panchayats -- starting with 2029 and a provision for unity government in cases like hung house or no-confidence motion.

## Panchayati Raj Ministry to hold national conference on PESA Act implementation

The Panchayati Raj Ministry has come up with specialized training modules for effective implementation of the Panchayat (Extension to Scheduled Areas) Act and is likely to hold a national conference later this month to discuss and advance the implementation of the law. The PESA Act of 1996 gives special powers to gram sabhas in a state's scheduled areas, especially for the management of natural resources. It is aimed at recognising, empowering and promoting the social, economic, cultural and political way of life of the Scheduled Tribes. The ministry is likely to hold a national conference in Delhi on September 26 that will bring together policymakers, senior officers, panchayat representatives and other key stakeholders from the 10 PESA states to discuss and advance the implementation of the Act, an official said. The 10 states under the PESA



Act are Andhra Pradesh, Chhattisgarh, Gujarat, Himachal Pradesh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Rajasthan and Telangana. The fundamental spirit of the legislation for tribal areas under the Fifth Schedule of the Constitution is to devolve rather than delegate power and authority to gram sabhas and panchayats, paving the way for participatory democracy. To strengthen the ground-level institutions in these areas, the Ministry of Panchayati Raj, in partnership with the PESA States and various NGOs, has

developed seven specialized training modules for the Fifth Schedule areas, an official said. With land alienation being one of the major issues faced by tribals living in these areas, the training programme provides a special focus on the matter, the official said. Land disputes and inadequate implementation of land reform policies are persistent issues in scheduled areas. Due to the lack of awareness about land rights, communities often struggle to assert their rights, thus being deprived of their traditional means of livelihood.

## Government begins decadal census preparations

The government has started preparations for conducting the decadal census, but a decision is yet to be taken on including a column on caste as part of the exercise, sources said on Sunday. Speaking on condition of anonymity, one source said that the decadal census will be conducted soon. India has conducted the census every 10 years since 1881. The first phase of this decade's census was expected to begin on April 1, 2020 but had to be postponed due to the Covid-19 pandemic. The implementation of the Women's Reservation Act, enacted by Parliament last year, too is linked to the conduct of the decadal census. The law reserving one-third of seats for women in the Lok Sabha and state assemblies shall come into effect after an exercise of delimitation is undertaken based on the relevant figures of the first census recorded after the Act has come into force. "This is yet to be decided," the source said when asked about inclusion of a column on caste in the decadal census.

The political parties have been making vociferous demands for conducting a caste census. In the absence of fresh data, the government agencies are still formulating policies and allocating subsidies based on the data of the 2011 census. The house listing phase of the census and the exercise to update the National Population Register (NPR) were scheduled to be carried out across the country from April 1 to September 30, 2020 but it was postponed due to the Covid-19 outbreak. ## SC expresses displeasure over false statements in convict release petitions

During the last three weeks, this is the 6th or 7th case which we have come across where blatantly false statements have been made in the pleadings," the bench said in its September 10 order uploaded recently. It pointed out that on a miscellaneous cases hearing day in the apex court, there are 60 to 80 matters listed before every bench and it is not possible for the judges to go through each and every page of each and every case listed before the court, though an endeavour to go through every case very meticulously.



## Two Navy women officers to embark on global voyage

# Will stake claim for CM post if BJP returns to power in Haryana: Anil Vij

Senior BJP leader and former Minister Anil Vij on Sunday said he will stake claim for the chief minister's post if the party returns to power in Haryana after the October 5 Assembly polls.

The six-time MLA's remarks come at a time when the party has already made it clear that Nayab Singh Saini will be the chief minister if the BJP returns to power.

Saini is also the party's chief ministerial face in the polls.

"I never sought anything from the party till today... People from Haryana are coming to meet me. Even in Ambala, people tell me that I am senior-most why I did not become CM. On demand of the people, and on the basis of seniority, this time I will stake claim to become chief minister," Vij

said.

Whether the party makes me or not, it is up to them. But if they make me CM, I will take Haryana's 'takdeer and tasveer' (destiny and face of Haryana), the Ambala Cantt MLA said.

When asked to clarify the remarks he made while interacting with reporters in Ambala, Vij later told PTI over phone, "I am the party's senior-most MLA and have won six elections and am contesting my seventh one. I have never sought anything from my party so far."

"But people from across Haryana and people of my own constituency have been meeting me... I will stake claim for the chief minister's post," the 71-year-old Vij said.

"It is up to the party high command to take a call," he said.

When pointed out the Saini has already been declared chief



ministerial candidate, Vij said, "There is no bar on staking the claim. I will make my claim, let the party take a call."

Asked about the timing of his decision with polls only a couple of weeks away, Vij said he took the decision after people came to meet him.

"People have been regularly meeting me and asking me about this (that he is senior most and yet not become CM)," Vij said.

Notably, in March, Manohar Lal Khattar was replaced by Saini as chief minister. Polling for the 90 assembly seats in Haryana will be held on October 5 and the votes will be counted on October 8.

When BJP came to power in Haryana for the first time on its own strength in 2014, Vij along with few other BJP leaders including Ram Bilas Sharma, was frontrunner for the CM's post, but the party

went with Manohar Lal Khattar, a first-time MLA then, as its choice.

Recently, BJP has faced resentment from some of its leaders who were denied tickets.

BJP leaders including Ranjit Singh Chautala, Laxman Napa, Karan Dev Kamboj and few others quit the party.

Former Minister Ram Bilas Sharma was also denied ticket from Mahendragarh this time. In March, Vij was said to be upset with the BJP for not keeping him in the loop when the party decided to replace Manohar Lal Khattar as the chief minister and bring Nayab Singh Saini in his place.

He had then said he came to know about it only in the BJP MLAs' meeting here in which Saini's name was announced. Vij later also did not find a place in the cabinet led by Saini. The senior BJP leader had also kept away from Saini's

swearing-in ceremony in March.

In April, while addressing a public gathering in Ambala, Vij, without taking any names, had said, some people have made him a stranger in his party.

"Mana kuch logo ne mujhe meri party mein he begana bana diya hai, parantu kayee baar begane apno say bhi zyada kaam kar jaate hai, (It may be true that some people have made me a stranger in my party, but sometimes strangers do more work than own people)," Vij had then said.

Vij, who held the home portfolio in the Manohar Lal Khattar government, was often at loggerheads with Khattar when he was the CM.

Vij, has in the past maintained, that he is a dedicated worker of the Bharatiya Janata Party, but whatever he has to say he says it clearly.

## PM Modi accuses JMM-led coalition of patronising Bangladeshi, Rohingya infiltration

Modi termed the JMM, RJD and the Congress as the "biggest enemies of Jharkhand", asserting that these parties were "power-hungry" and "indulged in vote bank politics".

The PM also alleged, "The JMM-led government has been trained by Congress' school of corruption. It is time to bid farewell to the JMM that looted mines, minerals and Army land."

Modi, who was scheduled to reach Jamshedpur via a chopper, had to travel to the steel city on the road as his heli-

copter could not take off due to inclement weather conditions.

"No obstacles, including heavy rain, could prevent me from reaching you, I am touched by your affection," he said.

He also asserted that the BJP is set to come to power in the state after the assembly polls due later this year.

"If the BJP comes to power, it will launch a probe into deaths of aspirants during excise constable recruitment drive," he said.

Modi accused the JMM-led coalition of targeting BJP leaders and framing false cases against them.

## 62 candidates in fray for four Assembly seats in Gurugram

The District Election Officer called upon all the candidates to ensure that they follow the instructions issued by the Election Commission.

It is mandatory for the candidate to take permission from the administration for rallies, road shows and other programs. If any candidate violates norms, then necessary action will be taken against them under the rules laid down by the Election Commission.

He informed that voting for the assembly elections will be held on October 5 and counting will be held on October 8, the result will be declared along with the counting.

Meanwhile, Haryana, is known for its politically charged environment, is expected to see intense competition, with various regional and national parties fielding strong candidates.

The two major national parties BJP and the Congress are leaving no stone unturned in its quest to win the elections and cement its influence in the state.

The Me Too controversy plaguing Malayalam film industry with the disclosures made by a report prepared by the K Hema Committee that probed the professional difficulties of women artists and technicians had its roots in the turf war between various power groups in the Kerala Motion Picture Academy (Kerala Chalachitra Academy), a State Government undertaking.

A war of nerves was brewing up in the Academy between the groups led by Ranjit and Bina Paul, the director of International Film Festival of Kerala (IFFK), according to sources in the Academy. Ranjit, who was appointed by the Pinarayi Vijayan dispensation quit as chairman following an allegation made by Sreelekha Mitra, Bengali film actress that the former had misbehaved with her in 2009.

The grapevine is that Ranjit, a graduate of the School of Drama in Calicut University tried to usher in changes in the film festivals which was not liked by the cartel controlling the Academy. Ranjit was appointed immediately after the resignation of Kamaluddeen, a controversial character who allegedly molested and abused wannabe artists. But till date no action has been taken against Kamaluddeen, known by his screen name Kamal.

Irked by their sidelining from important positions, the group opposed to Ranjit devised a strategy to oust him from the Academy. It all began during the last IFFK held at Thiruvananthapuram when Ranjit, a hardcore SFI and CPI(M) activist despite his roots in a feudal Nair zamindar family, was booed down by a



section of the audience. Interestingly most of them were CPI(M) activists.

"A thorough probe into the phone calls made by two persons (including a documentary film maker) to Mitra in the recent past. There were no justification behind the telephone contacts between these persons and Mitra at this juncture," said a film professional with Doordarshan Kendra, Thiruvananthapuram. He is of the view that the unprecedented increase in the number of calls between the actress and Chalachitra Academy officials has no other justification.

He also pointed out that though Ranjit was in the industry since 1985 and had his first directorial venture in 2001, this is the first time an accusation of this kind has been made against him. Though Ranjit is known for his arrogance, this scion of a feudal zamindar Nair family despite working with some of the divas have remained aloof from casting couch controversies till Mitra made her allegations. Mitra's allegations prompted many junior artists to come out with "Me Too" charges against many senior artists and they all quit their elected positions in AMMA, an industry body.

The Investigation Team probing the a la Mitra issue has been left clueless over the timing of Mitra's charges.

## HM Shah to wrap up first round of high voltage campaign in Jammu

To wrap up the first round of the high-voltage election campaign Union Home Minister Amit Shah will be arriving in Jammu on Monday to address three back-to-back election rallies in Ramban and Kishtwar districts on the last day of the campaigning.

This will be Amit Shah's second visit. Earlier, he made a two-day visit to Jammu, where he not only released the party's

manifesto but also addressed a large convention of party workers in Jammu city on the second day. Out of eight Assembly segments, the BJP is aiming to win the maximum seats and retain at least all four seats it won during the 2014 Assembly polls. On the other hand alliance partners Congress and National Conference are also working hard on the ground to improve their tally and give a tough fight to the BJP in Doda and Ramban.

## Rashid springs surprise by allying with banned Jel

He added both parties underscored the importance of unity in resolving the Kashmir issue and promoting a lasting and dignified peace in the region. They highlighted the rapidly evolving political landscape, both regionally and internationally, and stressed that neither the banned JeI nor AIP can afford to remain passive observers.

## IAF provides aid to Cambodia, Vietnam

## India inundated

The unprecedented rains have wreaked havoc across the country, serving as a stark wake-up call for urban planning

India's major cities, including Mumbai, Delhi, and Bengaluru, are reeling from the aftermath of unprecedented rainfall, leading to widespread flooding, loss of life, property damage, and severe disruptions to daily life. As heavy monsoon showers continue to batter these urban hubs, residents are grappling with submerged streets, gridlocked traffic, and power outages, exposing critical flaws in the country's urban infrastructure. This year's torrential downpour has been particularly devastating. In Mumbai, water levels have risen to waist height in low-lying areas, while Bengaluru's once-bustling tech corridors resemble rivers. Over 100 lives have been lost in flood-related incidents across the country, with thousands displaced from their homes. Many families have seen their life savings washed away in a matter of hours as homes and vehicles succumb to rising waters. Besides, the northern cities like Meerut, which hardly ever reported water-logging, have been partially submerged. The economic toll is equally staggering. Shops, offices, and industries have faced forced shutdowns. Public infrastructure has borne the brunt of the floods.



Urban centres in India are no strangers to traffic congestion, but the flooding has exacerbated an already dire situation. In Delhi, where rainwater has clogged major arterial roads, commute times has increased manifold.

The inconvenience is compounded for those who rely on daily wages for their livelihood, as the disruptions prevent them from working. The scale and intensity of these floods underscore the urgent need for India to rethink its urban planning. Many problems are rooted in poor drainage systems, encroachment on natural water bodies, and unregulated urban sprawl. In cities like Mumbai and Chennai, where floods have become an annual menace, experts have long warned of the consequences of unchecked development in flood-prone areas. Indeed the rains have been unprecedented but they have exposed the slackness of urban planning which is ill-equipped to deal with heavy downpours in the monsoon season. Drainage are clogged, necessary equipment is either unavailable or non-functional, and poor planning in executing operations only exacerbates the situation. City drainage across the country are either outdated or inadequate to handle the massive volumes of rainwater. Local governments must invest in upgrading this critical infrastructure, ensuring that water can be efficiently channelled away from residential and commercial areas. Besides the builder-bureaucrat nexus has stolen away the water bodies. Many lakes, rivers, and wetlands that once absorbed rainwater have been lost to unplanned illegal development. It goes without saying that urban planning should incorporate green spaces, permeable surfaces, and sustainable construction practices that allow water to seep into the ground rather than accumulate on the surface. This includes promoting rainwater harvesting and stormwater management solutions. Cities must build climate resilience into their long-term plans.

## The art of problem solving

Those in decision-making roles must be equipped with the necessary skills, attitudes, and awareness to meet the demands of their tasks

Problem-solving is more than an art. It is a matter of resources, teamwork, and timing. Behavioral interventions in problem-solving need to keep this in mind. This applies equally to training programs on problem-solving. Many training programs tend to believe that if their techniques are right the results will surely follow. This is a palpably comforting approach but with limited truth in reality. Amongst the foremost requirements of problem-solving is the need for all the people involved in the process to have the necessary skills to handle the job. The job itself has to be neatly reduced to manageable levels of skill clusters, and the persons allotted the responsibility for it must have the necessary attitude, skills, and approaches to handle the job. Unfortunately, not all in key decision-making situations have the competence to embrace this simple truth.

They seem to have arrived in that position either through regular promotion, seniority, hierarchy, or indeed, simply by chance. While the logic that brought them there is understandable, it does not meet the requirements for getting the tasks done. The result is therefore all to see. Not only do accidents take place, but delays and ineptness also become the hallmarks of a situation. It is important to remember this while planning an activity. It is important to build this into training programs, and above all, it is important to remind those who control the resources to be conscious of this requirement. Even when all the skill columns and more are regularly accounted for, it stands to reason that the resources of the supply chain must be intact and in position. As it happens in organizational setups, the supply chain side and the engineering side need effective dialogue, communication, or exchanges with the human resources side, the skill formation side, and control and monitoring methodologies.

Thus, it is that ineptness becomes an inevitable part of the scene in organizations not so well linked together on these dimensions. It



is therefore necessary to create a culture of effectiveness and an appreciation of the requirements to deliver. To deliver requires, to the extent possible, objective and manageable resource mobilization, skill availability, sensitive monitoring, and linking up with the results in the time set. If this is not done, effectiveness is impaired, and others who can organize themselves will surge forward, and then the institutional returns of the defaulting group will continue to diminish. It may ultimately reach a point where there may be no surpluses to distribute even for salaries or to administer. This is a point of view to which no exceptions can be made. Considering this in the current and growing crescendo on reservations is something that can be avoided only at the grave risk of creating further problems for oneself.

Struggle for the decision-making process is often termed as 'politics' and political processes in a country like India are often determined by numbers. Hence, the push to enhance the numbers of one's following and pander to political rising waves, even though it may not be sustainable in the long run. This is such an obvious warning and caution that it cannot be over-emphasized. The tragedy is, not only that so many people seem to

overlook this point. It appears, at times, that many otherwise knowledgeable people do it purposefully to gain political advantage.

Little do they realize that what they gain on the swing, they will lose on the round. In this context, two observations need to be made, one concerning the constitution and the other concerning the practices of reservation for social equity in other parts of the world. The constitution in its initial draft was very clear and forthright on the reservation as a policy only for a limited period, even the period for which was indicated.

Gradually, through political compulsions and otherwise, the focus of reservation-affected communities was expanded till the Supreme Court had to step in and say that not more than 50% of positions could be made in the reserved category. Pressure has been on for a while, in political terms, to loosen this limit. Should this happen, it could have implications, not just politically but also in terms of perhaps affecting the results of performance. This could jeopardize the total volume of resources, then, available for distribution.

To consider the issue of social equity in other communities and countries beyond India may be worthwhile. Limited examples may be found across

the world where the total availability of jobs is parcelled off in reserved blocks. Some nations have a parallel stream for reserved categories and a definite stream where only talent could be a criterion for selection. This amalgam seems to have worked for both productivity and distributive justice. There is a clear case of streaming of jobs in India, being examined from this point of view also. Not to look at this option would be limiting the possibilities of growth with equity.

That may be risky and unwise. The logic of preferential treatment has many caveats, and one of them is that preferential treatment could become a matter of habit and expectations, and when not granted, it could be seen as akin to 'rights' being violated.

The time has come to seriously ask whether the slogan-mongering of several political groups may not be tantamount to throwing the baby out with the water. Every approach can be considered for and against, but the ultimate solution should preferably incorporate requirements of universal equity, and sustainability amongst various criteria of performance and results.

In the complex structure of Indian governance, where the judiciary and the executive function as distinct but interdependent pillars, such gestures are appropriate and reflective of the harmony essential for the nation's progress. To criticise this act would be to adopt a narrow-minded approach, ignoring the more profound significance of the occasion. The judiciary and the executive are two of the most important pillars of Indian democracy. While they are distinct in their functions, they share a common purpose: the preservation of the Constitution and the welfare of the people. The Prime Minister, as the head of the executive, and the Chief Justice of India, as the head of the judiciary, embody the leadership of two vital branches of government.

Their personal or religious event participation reflects mutual respect and understanding of their respective roles in the country's governance. The Ganesh Pooja, a significant religious event in India, represents the invocation of wisdom, prosperity, and the removal of obstacles. By attending such an event together, the two leaders are sending a message that they are united in their goals for the nation, seeking divine blessings for the common good. To view this act as inappropriate would be to overlook the fact that it is not merely a personal gathering but a reflection of shared responsibility in upholding the constitutional fabric of India. Critics of the Prime Minister's participation in the Ganesh Pooja at the Chief Justice of India's residence should remember that performing the Ganapati Pooja is not a crime, but a deeply ingrained part of India's cultural and historical heritage. The significance of Ganesh Pooja, especially when viewed through the lens of its revival by the great freedom fighter Bal Gangadhar Tilak, is a reminder of its deeper objectives—unity, nationalism, and collective strength. In this context, the Ganesh Pooja is not just a religious ceremony but a powerful cultural symbol that has historically promoted social

cohesion, unity, and nationalism. By criticizing such an event, the critics undermine the values that Tilak sought to instil through this festival. In Indian tradition, the term "Karta" refers to the head or manager of a family, responsible for the well-being of the entire household. Similarly, the Prime Minister and the Chief Justice act as the 'Kartas' of their respective domains: the executive and the judiciary. While their roles are different, their objectives often align, especially concerning matters of national interest, law, and justice.

By coming together at a religious event, they demonstrate that despite their institutional separation, they work towards the same larger and greater goal—the welfare of the people and the strengthening of Indian democracy. As the Karta of the executive, the Prime Minister is responsible for running the government, implementing laws, and ensuring the country's development. The Chief Justice, as the Karta of the judiciary, ensures that justice is upheld and that the laws are interpreted and applied in a fair and just manner. These roles complement each other, and public gestures of respect and unity, such as attending a religious event together, only strengthen the understanding and coordination between these two pillars of governance. Only a narrow-minded perspective would find fault in the Prime Minister's attendance at the Ganesh Pooja. Such criticism is often rooted in a limited understanding of the executive and judiciary's roles in the country's broader governance. Criticizing such gestures of goodwill and unity overlooks the significance of collaboration between these branches, which is essential for a well-functioning democracy. By attending the Ganesh Pooja, the Prime Minister and the CJI are reinforcing their commitment to work together for

the nation's greater good. It is well-known that Congress, during its tenure in power, had multiple instances where it was accused of attempting to influence or interfere with the independence of the judiciary. One such example that comes to the mind of every informed citizen is when Chief Justice S.M. Sikri retired on April 25, 1973, the day after the Supreme Court's landmark Kesavananda Bharati judgment, which ruled that Parliament could not alter the "basic structure" of the Constitution. Displeased by this limitation on her plans for constitutional amendments, Indira Gandhi swiftly responded by superseding three senior judges—Justices K.S. Hegde, J.M. Shelat, and A.N. Grover—on April 26.

Justice A.N. Ray, who was less critical of the government's stance, was appointed Chief Justice. This supersession sent a clear message, influencing the Supreme Court's subsequent ruling in the ADM Jabalpur case (also known as the Habeas Corpus case). During the Emergency declared on June 25, 1975, which suspended fundamental rights including the right to life and personal liberty, a Constitution Bench of the Supreme Court heard challenges to the presidential order. Attorney General Niren De argued that no judicial remedy could be sought during the Emergency. Justice Khanna questioned the Attorney General about remedies for severe abuses, like police killings, during the Emergency. The Attorney General admitted there would be no judicial recourse during this period. Despite this troubling admission, the majority ruled that citizens had no right to life or personal liberty during the Emergency. Justice Khanna dissented but was later superseded by Justice M.H. Beg as Chief Justice in January 1977. In November 1976, Congress passed the 42nd

Amendment, aiming to undermine judicial independence and establish a more authoritarian regime. The Prime Minister's participation in Ganesh Pooja at the Chief Justice of India's residence underscores mutual respect and recognition of each other's roles and powers.

Unlike Congress, which historically attempted to undermine judicial independence, this gesture reflects a healthy relationship between the executive and judiciary. It demonstrates that both leaders acknowledge and uphold the boundaries of their respective roles, ensuring a collaborative rather than confrontational dynamic in governance and judicial matters. The Prime Minister's attendance at a religious function does not imply interference in the judiciary's functioning or decision-making. There is a significant difference between engaging in respectful cultural or religious participation and attempting to subvert judicial independence for political gains, as seen during the Congress era. To equate the two is to distort history and misrepresent the present.

The Prime Minister performing Ganesh Pooja at the Chief Justice's residence is an act that reflects India's values of cultural unity, mutual respect, and inclusiveness. Only those with a narrow-minded view or divisive political motives would criticize such a gesture. This event represents the healthy relationship between the judiciary and executive, reaffirming their shared commitment to upholding the Constitution and promoting the welfare of the nation. Rather than being a cause for criticism, it should be seen as a celebration of the harmony and unity at the heart of India's democratic and cultural ethos.

## The hidden toll of climate change: India's struggle with eco-anxiety and mental health

Rising temperatures and erratic weather patterns are not only threatening the nation's economy but also fueling anxiety, depression and trauma

India's diverse landscape is one of its greatest assets, but it also makes the country highly vulnerable to the adverse effects of climate change. The consequences are increasingly evident in events like wildfires, violent storms, unseasonal rainfall, melting glaciers, air pollution, and heatwaves. These phenomena not only damage the environment but also have serious implications for public health. Heatwaves, for instance, have led to a 53.7% increase in heat-related deaths among people aged 65 and above between 2000 and 2017. Additionally, the growing heat stress could result in an estimated 34 million job losses, while air pollution is expected to cause 6.6 million premature deaths by 2050.

Climate change poses a significant threat to India's economic stability as well. Implementing adaptation strategies will come at a staggering cost of ₹85.6 lakh crore (approximately \$1.065 trillion). While these economic challenges are daunting, the mental health implications of climate change are often overlooked. According to the Intergovernmental Panel on Climate Change (IPCC) Sixth

Assessment Report, shifts in economic, social, and food systems triggered by climate change will lead to long-term mental health impacts, including rising levels of anxiety, depression, and stress.

One of the most alarming consequences of climate change on mental health is the rise of "eco-anxiety." Defined as a persistent worry about the current environmental crisis and the bleak future it suggests, eco-anxiety is affecting millions globally, especially the younger generation. A study by The Lancet across ten countries, including India, surveyed 10,000 young adults aged 16-25 years. The results were sobering: over half of the participants reported feeling 'sad', 'anxious', 'angry', 'powerless', 'helpless', 'insecure', and

'guilty' about climate change. Furthermore, 45% admitted that these emotions disrupted their daily lives, while 75% expressed serious concerns about their future. Most disturbingly, 83% believed that humanity had failed to take adequate steps to protect the planet. The Lancet Countdown report of 2022 further highlighted the mental health consequences for younger people, including increased levels of phobias, drug dependency, sleep disturbances, emotional dysregulation, and cognitive impairment. Children and adolescents are particularly vulnerable to eco-anxiety, as they are growing up in an era where the effects of climate change are becoming more apparent with each pass-



ing year. India has already witnessed numerous climate-induced disasters that have exacerbated mental health issues. According to the National Institute of Disaster Management, India experienced 1,058 climate-related events, including floods, cyclones, droughts, cold waves, and heatwaves between 1995 and 2020. These disasters often

result in severe psychological consequences. For example, the prevalence of post-traumatic stress disorder (PTSD) in flood-affected populations is estimated to be around 50%. Frequent droughts, for instance, have been linked to high suicide rates among farmers. The National Crime Records Bureau (NCRB) reported over 10,000 farmer suicides in 2019. A study also found that when temperatures rise above 20°C, a 1°C increase in a single day's temperature is linked to approximately 70 additional suicides. Over the past three decades, rising temperatures and droughts have contributed to the suicides of around 59,000 farmers in India, accounting for 6.8% of the overall upward trend in suicides.

The future also appears bleak in terms of water security. A 2018 report by Niti Aayog predicts that 21 Indian cities will run out of water by 2030, affecting 100 million people. By that time, 40% of India's population may lack access to clean drinking water, leaving communities stressed and insecure. The mental health impact of such crises is particularly severe for indigenous communities, whose lives and livelihoods are closely tied to their natural surroundings. Sadly, these communities and their experiences remain underrepresented in mainstream discussions about climate change, calling for more focused research to understand their specific vulnerabilities. Addressing these challenges

will require coordinated efforts across sectors. Communities, climate activists, organizations, policymakers, and mental health professionals must collaborate to develop solutions. Initiatives like planting trees, reforestation, and recycling can empower communities and provide a sense of agency, helping alleviate the psychological burden of eco-anxiety.

Policymakers must prioritise the environment by enforcing carbon emission reductions and investing in renewable energy. Mental health surveillance should be integrated into climate policies at every level of governance.

# Yemen missile hits Israel, triggers airport sirens

A missile fired by Yemen's Iran-backed rebels landed in an open area in central Israel early Sunday and triggered air raid sirens at its international airport, in the latest reverberation from the nearly yearlong war in Gaza. There were no reports of casualties or major damage, but Israeli media aired footage showing people racing to shelters in Ben Gurion International Airport. The airport authority said it resumed normal operations shortly thereafter. A fire could be seen in a rural area of central Israel, and local media showed images of what appeared to be a fragment from an interceptor that landed on an escalator in a train station in the central town of Modiin. The Israeli military said it made several attempts to intercept the missile using its multitiered air defences but had not yet determined whether any had been successful. It said the missile appeared to have fragmented midair, and that the incident is still under review. The military said the sound of explosions in the area came from interceptors.



The Yemeni rebels, known as Houthis, have repeatedly fired drones and missiles toward Israel since the start of the war in Gaza between Israel and the Palestinian militant group Hamas, but nearly all of them have been intercepted over the Red Sea. In July, an Iranian-made drone launched by the Houthis struck Tel Aviv, killing one person and wounding 10 others. Israel responded with a wave of airstrikes on Houthi-held areas of Yemen, including the port

## '3 hostages recovered months ago were likely killed in Nov airstrike'

Jerusalem (AP): The Israeli military says there is a "high probability" that three hostages found dead months ago were killed in an Israeli airstrike. The army on Sunday announced the conclusions of its investigation into the deaths of Cpl. Nik Beizer, Sgt. Ron Sherman and Elia Toledano. It said investigations had determined that the three were likely killed in a November airstrike that also killed a senior Hamas militant, Ahmed Ghandour. All three of the hostages were kidnapped in Hamas' October 7 attack. Their bodies were

recovered in December, but the cause of death was only recently determined. In its report, the army said there was a "high probability" they were killed in the strike, based on where the bodies were recovered, pathological reports and other intelligence. But it said, "it is not possible to definitely determine the circumstances of their deaths." The conclusions could add pressure on the government to strike a deal to bring home the remaining hostages held by Hamas. Critics say it is too difficult and dangerous to try to rescue them.

the rebels portray as a blockade on Israel in support of the Palestinians. Most of the targeted ships have no connection to Israel. The war in Gaza, which began with Hamas' October 7 attack into southern Israel, has rippled across the region, with Iran and allied militant groups attacking Israeli and US targets and drawing retaliatory strikes from Israel and its Western allies. On several occasions, the strikes and counterstrikes have threatened to trigger a wider conflict. International carriers have cancelled flights into and out of Israel on a number of occasions since the start of the war, adding to the war's economic toll on the country. Iran supports militant groups across the region, including Hamas, the Houthis and Lebanon's Hezbollah, its most powerful ally, which has traded fire with Israel on a near-daily basis since the war in Gaza began. Iran and its allies say they are acting in solidarity with the Palestinians. The military said around 40 projectiles were fired from Lebanon early Sunday, with most intercepted or falling in open areas. The strikes along

the Israel-Lebanon border have displaced tens of thousands of people on both sides. Israel has repeatedly threatened to launch a wider military operation against Hezbollah to ensure its citizens can return to their homes. "The status quo will not continue," Netanyahu said at the Cabinet meeting. "This requires a change in the balance of power on our northern border. We will do everything necessary to return our residents safely to their homes." Hezbollah has said it would halt its attacks if there is a cease-fire in Gaza. The United States and Arab mediators Egypt and Qatar have spent much of this year trying to broker a truce and the release of scores of hostages held by Hamas, but the talks have repeatedly bogged down. In recent weeks, Prime Minister Benjamin Netanyahu has insisted on lasting Israeli control over the Gaza side of the border with Egypt, which Israeli forces captured in May. He has said Hamas used a network of tunnels beneath the border to import arms, allegations denied by Egypt, which along with Hamas is opposed to any lasting Israeli presence there.

## US-China military leaders discuss SCS tensions

Bangkok (AP): Military leaders from the US and China met in Beijing for routine talks that only resumed in January after being suspended for two years as ties between the two countries soured. The meetings ended on Sunday and officials discussed ongoing issues such as Taiwan, the Russia-Ukraine war and clashes in the South China Sea. Michael Chase, deputy assistant secretary of defence for China, Taiwan and Mongolia led a delegation to engage in the bilateral Defence Policy Coordination Talks, which were last held in January. While the talks weren't expected to resolve long-standing differences in stances over issues ranging from South China Sea claims to Taiwan, the US has continued to push for the discussions as a way to avoid conflict. The meetings were held after Chase attended the Xiangshan forum in Beijing, a defence forum that is China's answer to the Shangri-La Dialogue. Communication between the two militaries broke off in 2021, as US-China tensions ratcheted up over widening differences on issues such as Taiwan's sovereignty, the origin of COVID-19 and economic issues. Beijing has ignored US requests to engage in the past, especially over intercepts between US and Chinese aircraft and ships. While communications resumed after US President Joe Biden and Chinese President Xi Jinping met in San Francisco last November, it is unclear whether the talks could continue as the US is poised for a presidential election. In the bilateral talks, the two sides discussed China's support for Russia during the ongoing Ukraine war, as well as China's actions in the South China Sea, said a US senior defence official briefing reporters on the meetings. On Sunday, the Philippine ship at a disputed shoal, BRP Teresa Magbanua, had left in order to resupply and provide medical care to its crew members. The defence official said that they were "watching further developments there very closely."

## A least 8 die trying to cross English Channel, French authorities say

At least eight people died during a failed attempt to cross the English Channel from northern France, French maritime authorities said on Sunday. The incident occurred Saturday just before midnight when authorities spotted a boat, carrying dozens, in distress near a beach in the northern town of Ambleteuse. A French rescue ship was deployed to the area and rescue services offered medical assistance to 53 migrants on the beach, a statement from the French maritime authorities in charge of the Channel and the North Sea said. "Despite the emergency care provided, eight people have died," the statement said. No people were discovered during the search at sea, it added. Six people were taken to hospital

"in relative emergency," including a 10-month-old baby with hypothermia, Jacques Billant, the Pas-de-Calais prefect, told French media on Sunday. He said survivors of the accident come from Eritrea, Sudan, Syria, Afghanistan, Egypt and Iran. Survivors of the tragedy have been taken to the sports hall in Ambleteuse, according to a statement from the prefecture of Pas-de-Calais region. Prosecutor's office in Boulogne-sur-mer has opened an investigation into the accident. The incident Saturday occurred nearly two weeks after a boat carrying migrants ripped apart in the English Channel as they attempted to reach Britain from northern France, plunging dozens into the treacherous waterway and leaving 13 dead, officials said. British officials were quick to

express sadness over another English Channel incident. "It's awful," Foreign Secretary David Lammy told the BBC. "It's a further loss of life." The new Labour Party government has pledged to crack down on criminal gangs plying the channel trade and had discussed with European partners "how we go after those gangs, in co-operation upstream." UK Prime Minister Keir Starmer will be in Italy on Monday for talks with counterpart Giorgia Meloni about her efforts to tackle the problem "and the work they have done, particularly, with Albania." Starmer is interested in the policy, under which Tirana will accept asylum seekers on Italy's behalf while their claims are processed. On Saturday, French coast guard and navy vessels rescued 200 people from the

treacherous waters in the Pas-de-Calais area, according to a report sent by French maritime authorities in charge of the Channel and the North Sea. They said they observed 18 attempts of boat departures from France to Britain on Saturday. Before Saturday's accident, at least 43 migrants had died or gone missing while trying to cross to the UK this year, according to the International Organisation for Migration. In July, four migrants died while attempting the crossing on an inflatable boat that capsized and punctured. Five others, including a child, died in another attempt in April. Five dead were recovered from the sea or found washed up along a beach after a migrant boat ran into difficulties in the dark and winter cold of January.

## Venezuela arrests 6 in alleged Maduro assassination plot

Three Americans, two Spaniards and a Czech citizen were arrested Saturday after Venezuelan officials accused them of coming to the South American country to assassinate President Nicolas Maduro. The arrests were announced on state television by Diosdado Cabello, the nation's powerful interior minister. Cabello said the foreign citizens were part of a CIA-led plot to overthrow the Venezuelan government and kill several members of its leadership. In the television program, Cabello showed images of rifles that he said were confiscated from some of the plotters of the alleged plan. The arrest of the American citizens included a member of the Navy, who Cabello identified as Wilbert Joseph Castañeda Gomez. Cabello said that Gomez

was a navy seal who had served in Afghanistan, Iraq and Colombia. Spain's embassy in Venezuela did not reply to a request for comment on the arrests of its citizens. The US State Department late Saturday confirmed the detention of a US military member and said it was aware of "unconfirmed reports of two additional US citizens detained in Venezuela." Any claims of US involvement in a plot to overthrow Maduro are categorically false. The United States continues to support a democratic solution to the political crisis in Venezuela," the statement said. The announcement of the arrests comes just two days after the US Treasury imposed sanctions on 16 allies of Maduro who were accused by the U.S. government of obstructing voting during the disputed July 28 Venezuelan presidential election, and carrying out

human rights abuses. Earlier this week, Spain's parliament recognized opposition candidate Edmundo Gonzalez as the winner of the election, angering Maduro allies who called on the Venezuelan government to suspend commercial and diplomatic relations with Spain. Tensions between Venezuela's government and the US have increased as well following the election, whose result sparked protests within Venezuela in which hundreds of opposition activists were arrested. Venezuela's Electoral Council, which is closely aligned with the Maduro administration, said Maduro won the election with 52 per cent of the vote, but did not provide a detailed breakdown of the results. Opposition activists, however, surprised the government by collecting tally sheets from 80 per cent of the nation's voting

machines. The tally sheets collected by the opposition were published online, and they indicate that Gonzalez won the election with twice as many votes as Maduro. Despite international condemnation over the election's lack of transparency, Venezuela's supreme court, which has long backed Maduro, confirmed his victory in August. Venezuela's attorney general then filed conspiracy charges against Gonzalez, who fled to Spain last week after it became clear he would be arrested. Maduro has dismissed requests from several countries, including the leftist governments of Colombia and Brazil, to provide tally sheets that prove he won the election. Maduro, who has been in power since 2013, has long claimed the US is trying to overthrow him through sanctions and covert operations.

## Rising floodwaters trigger evacuations in Czech Republic and Poland

Another night of torrential rains pounded Central Europe forced massive evacuations in the hardest hit areas in the Czech Republic, where floods reached extreme levels on Sunday. Meteorologists have warned the situation still might get worse as waters in most rivers are rising, the flood wave made its way through the country and more heavy rains could return overnight. Authorities declared the highest flood warnings in almost 90 places across the country and in two northeastern regions that recorded the biggest rainfall in recent days, including the Jeseniky mountains near the Polish border. In the city of Opava, up to 10,000 people out of a population of some 56,000 have been asked to leave their homes for higher ground. Rescuers used boats to transport people to safety in a neighbourhood flooded by the raging Opava River. "There's no reason to wait," Mayor Tomas Navratil told the Czech public radio. He said the situation was worse than during

the last devastating floods in 1997, known as the "flood of the century." "We have to focus on saving lives," Prime Minister Petr Fiala told the Czech public television Sunday. His government was to possibly meet Monday to assess the damages. Thousands of others also were evacuated in the towns of Krnov and Cesky Tesin. The Oder River that flows to Poland was expected to reach extreme levels in the city of Ostrava and later in Bohumín. Towns and villages in the Jeseniky mountains, including the local center of Jesenik, were inundated and isolated by raging waters that turned roads into rivers. The military sent a helicopter to help with evacuations. Four people who were swept away by waters were missing, police said. About 260,000 households were without power Sunday morning in the entire country while traffic was halted on many roads, including the major D1 highway. A firefighter dies as Lower Austria declared a disaster zone A firefighter died after "slipping on stairs" while pumping out a flooded basement in the town of

Tulln, the head of the fire department of Lower Austria Dietmar Fahrafellner told reporters on Sunday. Authorities declared the entire state of Lower Austria a disaster zone. The situation remains tense, especially at the water reservoir of Ottenstein, which is expected to reach its maximum capacity on Sunday. Romanian reports another flooding victim Romanian authorities said Sunday that another person had died in the hard-hit eastern county of Galati after four were reported dead there a day before following unprecedented rain. In Poland, one person was presumed dead in floods in the southwest, Prime Minister Donald Tusk said Sunday. Tusk said the situation was "dramatic" around the town of Klodzko, with some 25,000 residents, located in a valley in the Sudetes mountains near the border with the Czech Republic. In Glucholazy, rising waters overflowed a river embankment and flooded streets and houses. Mayor Pawel Szymkowicz said, "we are drowning" and appealed to residents to evacuate to high ground.

## Air Canada and pilots union reach tentative pact to avoid shutdown

Air Canada and the union representing its pilots have come to terms on a labor agreement that is likely to prevent a shutdown of Canada's largest airline. Talks between the company and the Air Line Pilots Association produced a tentative, four-year collective agreement, the airline announced in a statement early Sunday. The prospective deal recognises the contributions of the pilots flying for Air Canada and Air Canada Rouge while setting a new framework for company growth. The terms will remain confidential until ratification by union members and approval by the airline's board of directors over the next month, the airline said. The pilots association said

its Air Canada Master Executive Council voted to approve the tentative agreement on behalf of more than 5,400 Air Canada pilots. After review and ratification by a majority of members, the deal is expected to generate an additional \$1.9 billion for the pilots over the period of the agreement, the union said in a statement. "While it has been an exceptionally long road to this agreement, the consistent engagement and unified determination of our pilots have been the catalyst for achieving this contract," Charlene Hudry, the executive council's chair, said in the statement. "After several consecutive weeks of intense round-the-clock negotiations, progress was made on several key issues including compensation, retirement, and work rules." Federal Labor

Minister Steven MacKinnon confirmed the agreement on Sunday and lauded the company and the union. "Thanks to the hard work of the parties and federal mediators, disruptions have been prevented for Canadians," MacKinnon said in a statement. "Negotiated agreements are always the best way forward and yield positive results for companies and workers." The airline and its pilots have been in contract talks for more than a year. The pilots have sought wages competitive with their U.S. counterparts, but Air Canada continues to post record profits while expecting pilots to accept below-market compensation, the union said. The two sides could have issued a 72-hour notice of a strike or lockout beginning Sunday.

## UK royal social media accounts offer b'day wishes to Prince Harry

London (AP): Britain's royal social media accounts posted 40th birthday wishes Sunday for Prince Harry, marking the milestone celebration despite longstanding strains following the publication of his explosive memoir, "Spare." The Royal Family site shared an image of a beaming Harry with a birthday cake emoji and the caption "Wishing The Duke of Sussex a very happy 40th birthday today! The Prince and Princess of Wales shared the image, adding their own birthday wishes. The post from the royal family account marked the first public birthday message for Harry since 2021. The Duke and Duchess of Sussex



announced they were giving up royal duties in January, 2020. They moved to America and said they hoped to become financially independent, signing lucrative deals with Netflix and Spotify. Harry famously shared his story in the memoir, "Spare."

## Tech billionaire back on Earth after first private spacewalk

Cape Canaveral (AP): A billionaire spacewalker returned to Earth with his crew on Sunday, ending a five-day trip that lifted them higher than anyone has travelled since NASA's moonwalkers. SpaceX's capsule splashed down in the Gulf of Mexico near Florida's Dry Tortugas in the pre-dawn darkness, carrying tech entrepreneur Jared Isaacman, two SpaceX engineers and a former Air Force Thunderbird pilot. They pulled off the first private spacewalk while orbiting nearly 460 miles (740 kilometres) above Earth, higher than the International Space Station and Hubble Space Telescope. Their spacecraft hit a peak altitude of 875 miles (1,408 kilometres) following Tuesday's liftoff. Isaacman became only the 264th person to perform a spacewalk

since the former Soviet Union scored the first in 1965, and SpaceX's Sarah Gillis the 265th. Until now, all spacewalks were done by professional astronauts. During Thursday's commercial spacewalk, the Dragon capsule's hatch was open barely a half-hour. Isaacman emerged only up to his waist to briefly test SpaceX's brand new spacesuit followed by Gillis, who was knee high as she flexed her arms and legs for several minutes. Gillis, a classically trained violinist, also held a performance in orbit earlier in the week. The spacewalk lasted less than two hours, considerably shorter than those at the International Space Station. Most of that time was needed to depressurise the entire capsule and then restore the cabin air. Even SpaceX's Anna Menon and Scott "Kid"

Poteet, who remained strapped in, wore spacesuits. SpaceX considers the brief exercise a starting point to test spacesuit technology for future, longer missions to Mars. This was Isaacman's second chartered flight with SpaceX, with two more still ahead under his personally financed space exploration program named Polaris after the North Star. He paid an undisclosed sum for his first spaceflight in 2021, taking along contest winners and a pediatric cancer survivor while raising more than USD 250 million for St. Jude Children's Research Hospital. For the just completed so-called Polaris Dawn mission, the founder and CEO of the Shift4 credit card-processing company shared the cost with SpaceX.



# US to give \$202.25 mn in aid to B'desh

The United States will provide USD 202.25 million in aid to Bangladesh to advance development, empower youth, strengthen democracy, improve health and expand trade and economic opportunities to people in the South Asian country, authorities said on Sunday. AKM Shahabuddin, additional secretary of the Economic Relations Division, and Reed J Aeschliman, mission director of USAID, signed the 6th amendment of "The Development Objective Grant Agreement (DOAG)" in Dhaka on behalf of their respective governments, according to a press release from the Ministry of Finance. Under the agreement, USAID will provide a USD 202.25 million grant to Bangladesh for its three sectors namely good governance, social, human and economic opportunity and resilience, the state-owned BSS news agency reported. "Driving greater prosperity: @USAID signed an agreement worth over \$200 million with the Bangladesh interim government to advance development, empower youth, strengthen democracy & governance, improve health and expand trade & economic opportunities to people across the country," the US Agency for International Development (USAID)-Bangladesh said in a post on X. On September 27, 2021, a new DOAG was signed between Bangladesh and USAID for the period of 2021-2026. By implementing the DOAG, USAID is committed to contributing a total of \$954 million. So far up to the 5th amendment, USAID has provided USD 425 million to Bangladesh, the BSS news agency reported. The US provides most of its development assistance through USAID, the United States Department of Agriculture and some other government and non-government organizations, it added. On Sunday, the interim government's Chief Adviser Muhammad Yunus met a high-powered American delegation and sought support from the US to rebuild Bangladesh, carry out vital reforms and bring back stolen assets. He described the challenges that the interim government is facing and said his administration has moved quickly to "reset, reform, and

restart" the economy, initiate reforms in financial sectors, and fix institutions such as the judiciary and police. The US delegation assured him of expanding economic and political ties to create a more equitable and inclusive future for its citizens. The multi-agency US delegation was led by Assistant Secretary for International Finance at the US Department of the Treasury Brent Neiman. Assistant Secretary of State for the Bureau of South and Central Asian Affairs, Donald Lu, who arrived in Dhaka on Saturday from India, also joined the delegation. The meeting came over a month after Yunus, known for his deep relations with Washington, was installed Bangladesh's Chief Advisor following the resignation of Sheikh Hasina who fled the country on August 5 amidst student-led mass protests. # Attempt to murder case filed against Hasina, 58 others

**Dhaka (PTI):** A fresh case has been filed against Bangladesh's ousted prime minister Sheikh Hasina and 58 others on the charges of attempting to murder a student during the violent clashes that led to the fall of her government last month, a media report said on Sunday. It was the latest in the slew of cases filed against the 76-year-old former premier, who resigned and fled to India on August 5 following a massive protest by students against a controversial quota system in government jobs. The case was filed on Friday by 22-year-old Fahim Faisal, who claimed he was shot and injured during an anti-government protest in Dinajpur on August 4, a day before the fall of the Hasina-led



Awami League government, The Daily Star newspaper reported. With this, the tally of cases against Hasina has reached 155, including 136 for murder, seven for crimes against humanity and genocide, three for abduction, eight for attempted murder and one for

the attack on a Bangladesh Nationalist Party procession, the report said. According to the case statement, protesters were assaulted with firearms and local weapons, resulting in multiple injuries to Faisal, who was treated at Dinajpur Medical College Hospital and recovered partially. The case accuses 59 people, including Hasina, former whip Iqbalur Rahim and Dinajpur Sadar Upazila Chairman Imdad Sarkar. Over 230 people were killed in the incidents of violence that erupted across the country following the fall of the Hasina-led government, taking the death toll to more than 600 since the massive protest by students first started in mid-July.

# US pledges support for equitable future

**Dhaka5 (PTI):** The US on Sunday assured Bangladesh of expanding economic and political ties to create a more equitable and inclusive future for its citizens, as the head of the interim government Muhammad Yunus sought support from Washington to rebuild the country and implement key reforms. The multi-agency US delegation was led by Assistant Secretary for International Finance at the US Department of the Treasury Brent Neiman. Assistant Secretary of State for the Bureau of South and Central Asian Affairs, Donald Lu, who arrived in Dhaka on Saturday from India, also joined the delegation. The meeting came over a month after Yunus, known for his deep relations with Washington, was installed Bangladesh's Chief Advisor following the resignation of Sheikh Hasina who fled the country on August 5 amidst student-led mass protests. "Our (US) delegation met with the Chief Adviser, Professor Muhammad Yunus, affirming our dedication to fostering inclusive growth, institution building and development to benefit the people of Bangladesh," the US embassy in Dhaka said in a statement after the meeting. The statement added that the United States stood ready to support Dhaka's efforts as "Bangladesh looks to chart a more equitable and inclusive future". Yunus outlined the urgent challenges his interim government faces, stressing the need to "reset, reform, and restart" the economy, The Daily Star newspaper reported. "This is a very important time for us and a significant moment in our history," Yunus said, referring to the student-led revolution that culminated in the toppling of the Awami League government. He said his government was committed to getting back

the stolen assets siphoned off by corrupt individuals linked with the previous autocratic regime. He described ongoing reforms in the financial sector, judiciary, and police, which have been initiated to strengthen national institutions and address systemic corruption. Officials familiar with the meeting said the chief adviser's special envoy on International Affairs Lutefy Siddique also joined the talks. Earlier in the day, the US delegation met Foreign Adviser Md Touhid Hossain at the state guest house Padma. "We are committed to helping expand economic opportunities, build institutional capacity, uphold human rights, and mitigate climate risks with our partner, Bangladesh," the US Embassy in Dhaka posted on X after the meeting. "Great to meet the foreign affairs adviser at Padma House," said the embassy. Neiman also met Finance Adviser Salehuddin Ahmed. After the meeting, the embassy said: "We support Bangladesh's path towards renewed dynamism and growth. Our engagement with top economic policymakers centred on the authorities' efforts to propel economic growth, job creation, and sustainability, including through engaging with international financial institutions." The six-member delegation reached Dhaka on Saturday. The US was one of the first countries to welcome Yunus's installation while this is the first delegation from Washington to visit Bangladesh following the formation of his interim government on August 8. The US-Bangladesh ties deteriorated and saw its lowest ebb in recent months when Hasina in public alleged that the US was out to see her ouster as she declined to serve its strategic interest compromising Bangladesh's sovereignty.

# Iran launches satellite amid western fears

**Tehran (AP):** Iran launched a satellite into space Saturday with a rocket built by the country's paramilitary Revolutionary Guard, state-run media reported, the latest for a program the West fears helps Tehran advance its ballistic missile program. Iran described the launch as the second such launch to put a satellite into orbit with the rocket. Independent scientists later confirmed the launch and that the satellite reached orbit. Footage later released by Iranian media showed the rocket blast off from a mobile launcher. An Associated Press analysis of the video and other imagery later released suggested the launch happened at the Guard's launch pad on the outskirts of the city of Shahroud, some 350 kilometres (215 miles) east of the capital, Tehran. The launch comes amid heightened tensions gripping the wider Middle East over the ongoing Israel-Hamas war in the Gaza Strip, during which Tehran launched an unprecedented direct missile-and-drone attack on Israel. Meanwhile, Iran continues to enrich uranium to nearly weapons-grade levels, raising concerns among nonproliferation experts about Tehran's programme. Iran identified the satellite-carrying rocket as the Qaem-100, which the Guard used in January for another suc-

cessful launch. Qaem means "upright" in Iran's Farsi language. The solid-fuel, three-stage rocket put the Chamran-1 satellite, weighing 60 kilograms (132 pounds), into a 550-kilometer (340-mile) orbit, state media reported. The rocket bore a Quranic verse: "That which is left by Allah is better for you, if you are believers." A state-owned subsidiary of Iran's Defense Ministry and experts at the Aerospace Research Institute built the satellite with others to "test hardware and software systems for orbital maneuver technology validation," state media said, without elaborating. Gen. Hossein Salami, the head of the Guard, praised the launch in a statement and said scientists successfully overcame "the atmosphere of extensive and oppressive international sanctions." Responding to questions from The Associated Press, the US State Department said it has "long made clear our concern that Iran's space launch vehicle programmes provide a pathway to expand its longer-range missile systems." "We continue to use a variety of nonproliferation tools, in coordination with our allies and partners, to counter the further advancement of Iran's ballistic missile programme and its ability to proliferate missiles and related technology," it added.

# Shanghai cancels flights as Typhoon Bebinca draws near

**Bangkok (AP):** Shanghai's airports are cancelling hundreds of flights Sunday as they brace for impact from Typhoon Bebinca, which is due to make landfall in the early hours of Monday morning, the authorities said. Flights past 8 pm local time will be cancelled at Hongqiao and Pudong airports in the city, the airport officials said in a statement, affecting more than six hundred flights. The city also announced that it was suspending travel on some bridges while restricting that on other highways. Typhoon Bebinca is currently a few hundred kilometers away from the coast. The typhoon's winds are expected to reach 151 km per hour by Sunday night, according to the China Meteorological Administration, which has categorised it as a strong typhoon. State media reported that 9,318 people had been evacuated from one district in Shanghai. Meanwhile, in the nearby city of Zhoushan, restaurants, supermarkets and shops shut down early for the day, and public transportation services were halted.

# ADB asks Pakistan to adopt Indian plan on education

**Islamabad (PTI):** The Asian Development Bank (ADB) has advised Pakistan to adopt India's scheme ULLAS to fix its dysfunctional education system and impart quality training to its citizens, according to a media report. The Manila-based lender's recommendation came in response to Pakistan's request for financial support to improve its education system and impart education to all out-of-school children, The Express Tribune newspaper said. The Understanding of Lifelong Learning for All in Society (ULLAS) was launched by the Government of India in July last year to help non-literates and adults who missed out on formal schooling. The ADB recommends that the government adopt a strategic and multi-stakeholder consultative approach, drawing on international best practices, such as the government of India's new centrally sponsored scheme "ULLAS", according to the lender. The ADB emphasised that the ULLAS scheme emphasises the need for both federal and provincial governments to collaborate urgently to enhance access to quality

education and can offer insightful lessons of success and challenges when considering a similar vertical scheme in Pakistan. Prime Minister Narendra Modi approved the new centrally-sponsored scheme ULLAS for the five-year period to cover all the aspects of "Education for All". The objective of the Indian scheme is to impart not only foundational literacy and numeracy but also to cover other components which are necessary for a citizen of the 21st century such as critical life skills including financial literacy, digital literacy, commercial skills, health care and awareness, child care and education and family welfare. The ADB's recommendation came just days before a scheduled visit of ADB President Masatsugu Asakawa to Pakistan. The ADB president will meet with Pakistani stakeholders on Monday. A Planning Commission's report revealed that Pakistan's education delivery system had become dysfunctional and all the 134 districts, barring Islamabad, were lagging on indicators ranging from learning outcomes to public financing.

# Two die in Ukraine's Odesa after drone, missile attacks

**Kyiv (AP):** Two people died in a missile attack on the Ukrainian Black Sea port city of Odesa, local officials said, as Moscow and Kyiv exchanged drone and missile attacks. The Ukrainian air force said Sunday it shot down 10 of the 14 drones and one of the three missiles Russia launched overnight, while the rest hit the suburbs of Odesa. Oleh Kiper, Odesa's regional governor, said the two who died Saturday night were a married couple, and that another person was wounded in the attack. Meanwhile, the Russian Defence Ministry said it downed 29 Ukrainian drones overnight into Sunday over western and southwestern regions, with no damage caused by the falling debris. It also said another Ukrainian drone was shot down Sunday morning over the western Ryzan region. While Ukraine and Russia regularly launch



overnight drone raids on each other's territory, Ukrainian officials generally do not confirm or deny attacks within Russia's borders. The latest attacks came after Ukraine made a new call Saturday on the West to allow it to use the long-range missiles they have provided to strike targets deep inside Russia, as Ukrainian forces

struggle to hold back Russian advances in eastern Ukraine. So far, the US has allowed Kyiv to use American-provided weapons only in a limited area inside Russia's border with Ukraine. Kyiv officials argue the weapons are vital to weaken Russia's ability to strike Ukraine and force it to move its strike capabilities further from the border.

# Lebanese novelist Elias Khoury dies at 76

**Beirut (AP):** Lebanese novelist Elias Khoury who dedicated much of his writings to the Palestinian cause and taught at universities around the world, making him one of Lebanon's most prominent intellectuals, has died. He was 76. Khoury, a leading voice of Arab literature, had been ill for months and admitted and discharged from hospital several times over the past year until his death early Sunday, Al-Quds Al-Arabi daily that he worked for said. The Lebanese writer, born and raised in Beirut, was outspoken in defense of freedom of speech and harsh criticism of dictatorships in the Middle East. In addition to his novels, Khoury wrote articles in different Arab media outlets over the past five decades making him well known throughout the Arab world. Two days after the Israel-Hamas war broke out on October 7, Khoury wrote an article in Al-Quds A-Arab daily titled "It's Palestine." Khoury wrote then that "the biggest open-air prison, the besieged Ghetto of Gaza, has launched a war against Israel, occupied settlements and forced settlers to flee." Born in Beirut on July 12, 1948, Khoury had been known for his political stances from his support of Palestinians to his harsh criticism of Israel and what he called its "brutal" settling policy in Palestinian territories. He studied at the Lebanese University and later at the University of Paris, where he received a PhD in social history. "The Catastrophe began in 1948 and it is still going on," he once wrote referring to Israel's settlement policies in occupied Palestinian territories. The "nakba," or "catastrophe" is a term used by many Arabs to describe the displacement of hundreds of thousands of Palestinians when Israel was created in 1948.

# Imran Khan criticises opponents day after his questioning in jail

A day after he was grilled for a provocative social media post, Pakistan's jailed former prime minister Imran Khan on Sunday launched a scathing attack on his opponents, including the chief justice, the establishment and his rival politicians. The 71-year-old Pakistan Tehreek-e-Insaf (PTI) founder in a message from Rawalpindi's Adiala Jail posted on his X account that the government was reportedly going to introduce a constitutional amendment to rewrite the rules about the top judiciary. The former cricketer-turned-politician lashed out at the government for trying to tweak the laws in order to allegedly control the judiciary. "The occupying mafia and its handlers are fighting only for their survival, regardless of the national interest. The attack on the independence of the judiciary is also a link in this chain. All institutions in the country have been destroyed. There remains a Supreme Court which is the last hope and support of the nation," he said. Khan alleged that an "attempt is being made to destroy this last hope of the nation through constitutional amendment and once again the whole institution and system of the country is being put at stake to grant extension to the person of choice." He said "efforts are being made to bring (Chief Justice) Qazi Faiz Isa through the new constitutional amendments to avoid a transparent investigation into human rights violations and electoral fraud." Khan alleged that the ruling Pakistan Muslim League-Nawaz (PML-N) won less than 20 seats but it was preparing to attack the judiciary in exactly the same way the PML-N government attacked the Supreme Court with batons in 1997. "The only difference is that this time the attack is being carried out by removing the powers of the judiciary. But I want to make one thing clear today that the entire nation stands behind the judiciary," he said. "If they



think that we will sit quietly, then it is their mistake, we will not accept it under any circumstances. Let me make it clear that the Pakistan Tehreek-e-Insaf will stand with the country's judiciary in any case. We will call for massive protests across the country," he said. Khan also talked about the case registered by the Federal Investigation Agency against him for targeting the judiciary and the army in a tweet on Friday. He said that a case was registered against him for highlighting the Hamud-ur-Rehman Commission report, which probed the debacle of 1971. "If the Hamud-ur-Rehman Commission report had been implemented, there would have been no martial laws in the country," he said and then added that even now, undeclared martial law is in force in the country. PML-N and its coalition partner Bilawal Bhutto Zardari's Pakistan Peoples Party (PPP) are not parliamentary parties, but like puppets, they are dancing on the cues of a few individuals. "The boot is being respected by saying that the vote should be respected," he said in a taunt to Nawaz Sharif who had demanded respect for vote after being thrown out of government in 2017. He said that the government and its backers were going to completely

enslave the nation and asked how can people be arrested from Parliament without the will of the speaker. The PTI leader said, "What is happening to us today can happen to them tomorrow. No one has been forcibly removed from Parliament till date." Khan also said that Prime Minister Shabbaz Sharif was going to be punished in the money laundering case during his government and alleged that the then army chief Qamar Javed Bajwa saved him. He said apart from the money laundering case, all the cases against Shabbaz Sharif, Nawaz Sharif and Ishaq Dar were old. Khan also talked about the case of possession of drugs registered against PML-N leader Rana Sanaullah during his government by the Anti-Narcotics Force (ANF), which is controlled by the army. "The head of ANF was a Major General. I called the head of ANF and asked him about the case. He had come and briefed the cabinet and presented the evidence related to the case of Rana Sanaullah. He told us that drugs have been seized from Sanaullah. Before us, no one had the courage to call him and ask the question about his own opponents in front of the cabinet. Why did you make this drug case against them," he asked. Khan also said that

when journalist Matiullah Jan was picked up, he got him released. The former premier also spoke about the planned rally by his party at Lahore on September 21. "Political gathering is our democratic and constitutional right. Whether we get permission or not, we will hold a rally in Lahore on September 21," he said. Khan said barricades were erected in Islamabad for the September 8 rally but his supporters came to attend it. "Has Punjab become a police state that we will not be allowed to hold a rally? We are preparing the party for street movement. I am telling my nation and party to prepare. Whatever happens, the present regime will be responsible," he said. He concluded the message by saying: "When there is a war of freedom, sacrifices have to be made. I have been unjustly imprisoned for one and a quarter year. Is this not a sacrifice? I believe in 'La ilaha illa Allah'. I am ready to sacrifice my life but I will not accept anyone's slavery. I also tell the nation not to accept their slavery." The contents of Khan's statement are not much different from the previous social media posts, as he targeted the head of judiciary, the army and his political opponents, mainly from the PML-N.

# China testing stealth fighter jet for its 3rd aircraft carrier: Report

**Beijing (PTI):** China is testing a new stealth fighter jet called J-35 to be deployed on its third aircraft carrier, the Fujian, which is equipped with an electromagnetic catapult unlike the other two fitted with ski-jump take-off ramps, official media reported on Sunday. A new type of warplane was tested earlier this year on the Chinese People's Liberation Army (PLA) Navy's first aircraft carrier, the Liaoning, state-run Global Times quoted official broadcaster CCTV as saying. It added that the new aircraft could be the long-expected J-35 - China's next-generation carrier-borne stealth fighter jet. China currently has two aircraft carriers, Liaoning, a refit of the Soviet-era ship, and Shandong, an indigenously built 2nd aircraft carrier commissioned in 2019. China's third aircraft carrier, Fujian, is larger than the two carriers, with a displacement of 80,000, and is currently undergo-

ing trials. It is the "first fully domestically developed and constructed" aircraft carrier with an electromagnetic aircraft launch system (EMALS) similar to that of the American aircraft carrier, USS Gerald R. Ford, official media reports said. China's other two aircraft carriers are equipped with ski-jump take-off ramps, while the Fujian features a flat-top flight deck. China operates its indigenously built J-15 aircraft for its carriers. Global Times quoted experts as saying that the CCTV report is an official confirmation that China now has a new-type carrier-borne aircraft ready for service. The report also confirmed that the new warplane is operational not only on China's third aircraft carrier, the Fujian, which is equipped with electromagnetic catapults but also on the previous two carriers, the ramp-

equipped Liaoning and Shandong, experts said, noting that this will significantly boost the capabilities of Chinese aircraft carriers. Hong Kong-based South China Morning Post newspaper reported that the J-35 is being developed by Shenyang Aircraft Corporation as China's second fifth-generation fighter jet, following the J-20. The jet is designed for use on aircraft carriers and is still in the development and prototype phase, but it is touted as the Chinese equivalent of Lockheed Martin's fifth-generation fighter jet, the F-35. Collin Koh, a senior fellow at the S. Rajaratnam School of International Studies in Singapore, told the Post that "one most straightforward assessment is that the Liaoning, which has long been designated as a test bed for PLA carrier capabilities, is conducting experiments on the J-35 as a viable carrier-borne fighter jet."

# Bharti Airtel leads the market rally

Nine of the top-10 most valued firms together added Rs 2,01,552.69 crore in market valuation last week, with Bharti Airtel stealing the show, amid bullish investors' sentiment in equities.

Last week, the BSE benchmark jumped 1,707.01 points or 2.10 per cent. The 30-share BSE Sensex hit its lifetime high of 83,116.19 on Thursday.

Bharti Airtel's valuation jumped Rs 54,282.62 crore to Rs 9,30,490.20 crore, becoming the biggest gainer among the top-10 firms. The market capitalisation (mcap) of ICICI Bank surged Rs 29,662.44 crore to Rs 8,80,867.09 crore.

Tata Consultancy Services (TCS) added Rs 23,427.12 crore taking its valuation to Rs 16,36,189.63 crore. The mcap of Hindustan



Unilever soared Rs 22,438.6 crore to Rs 6,89,358.33 crore and that of HDFC Bank zoomed Rs 22,093.99 crore to Rs 12,70,035.77 crore.

The market valuation of Infosys climbed Rs 17,480.49 crore to Rs 8,07,299.55 crore and that of ITC rallied Rs 15,194.17 crore to Rs

6,42,531.82 crore. The valuation of Reliance Industries jumped Rs 9,878.19 crore to Rs 19,92,160.61 crore and that of State Bank of India went up by Rs 7,095.07 crore to Rs 7,05,535.20 crore. However, the mcap of Life Insurance Corporation of India (LIC)

declined by Rs 3,004.38 crore to Rs 6,54,004.76 crore. Reliance Industries was leading the chart of the top-10 most valued firms followed by TCS, HDFC Bank, Bharti Airtel, ICICI Bank, Infosys, State Bank of India, Hindustan Unilever, LIC and ITC.

# 90 per cent of financial firms embrace AI, GenAI: Report

Ninety per cent of Indian financial institutions are focusing on artificial intelligence (AI) and GenAI (Generative Artificial Intelligence) as the primary technology enablers of innovation, according to a PwC India report.

As per the PwC India report titled, 'Mapping the FinTech innovation landscape in India' data analytics also continues to emerge prominently across nearly 74 per cent responses, underscoring its integral role in driving insights and decision-making within the financial services (FS) sector. It said that 31 financial institutions consisting of banks, insurance firms and fintechs participated in the



survey. "Artificial Intelligence (AI) and GenAI (Generative Artificial Intelligence) emerged as the focus area for innovation for Indian financial institutions, with 90 per cent of the respondents citing them as the primary technology enablers of innovation," it said.

"Fintech companies need to navigate an ever-changing regulatory landscape while building compliant partnerships to ensure sustainable success.

# HDFC Bank to double income of marginal farmers as CSR initiative

As per the Companies Act 2013, every company for which the CSR provisions apply must ensure that the firm spends in every financial year at least 2 per cent of its average net profits made during the immediately preceding three financial years as per its CSR policy.

The bank's net profit increased by 38 per cent to Rs 60,812 crore on FY'24 from Rs 44,109 crore in the previous fiscal. Average net profit of the company for the CSR calculation comes out to Rs 47,294 crore taking into account net profit of Rs 36,961 crore for FY'22. So, the bank should be spending around Rs 950 crore during

the current fiscal. "With over 65 per cent of India's population residing in rural areas, we strongly believe that inclusive development can only be attained when the prosperity and livelihood in villages keeps pace with the growth. We prioritise rural areas for our programme and currently 70 per cent of our programmes are being implemented in such areas," said Nusrat Pathan, Head CSR, HDFC Bank.

Bharucha further said that the bank is working towards becoming carbon neutral by 2031-32. As part of this initiative, he said, the bank is looking at reducing its emissions, energy, and water consumption. The bank will continue to incorporate and scale up the use of renewable energy in its operations. As part of the green initiative, he said, the bank has raised USD 300 million through its first ever sustainable finance bond issue in February this year.

# Tata Power Solar installs rooftop solar systems in Chhattisgarh

The initiative intends to make



clean energy available to all households in the state, building on the commitment to promoting sustainable energy solutions throughout India, he said. Chhattisgarh has become a significant hub for TPSSL's activities and initiatives, with a catered portfolio of over 600 installations, equivalent to more than 250 MW capacity across residential, commercial, industrial, and direct projects. The initiative

will cover all 33 districts of the state, he said. In line with the PM Surya Ghar Yojana, residents can receive a central government subsidy of Rs 30,000 for 1kW, Rs 60,000 for 2kW, and Rs 78,000 for a 3-10kW system, he said. These subsidies aimed at making solar energy installations more accessible and affordable, enabling every household to shift to renewable energy without financial burden, he said.

# India seeks investments from South Korea, Japan for shipbuilding, repair clusters

India is seeking investments and technology transfer from South Korea and Japan to establish shipbuilding and ship repair clusters to promote the domestic shipping supply chain in the country, according to a senior government official.

Currently, India holds less than 1 per cent of the global shipbuilding market, dominated by China, South Korea, and Japan. "We are looking at South Korea and Japan for investments and technology transfer for establishing shipbuilding and ship repair clusters in India," TK Ramachandran, Secretary in



Ministry of Ports, Shipping and Waterways (MoPSW), told a group of journalists here. Ramachandran was in Goa to participate in the 20th Maritime State Development Council (MSDC), where plans for a mega shipbuilding park, spanning multiple

states, were discussed. "We have communicated to them (South Korea and Japan) that you come with your technology and investments, we will provide you land for setting up shipbuilding and ship repair clusters," he said. Ramachandran also said that

Union Minister of Ports, Shipping and Waterways Sarbananda Sonowal has written to chief ministers of all states to provide land immediately if Japanese or Korean companies express interest in setting up shipbuilding and ship repair clusters in their states. "At least three states have expressed interest in providing land for establishing shipbuilding and ship repair clusters," he said, without naming the states. According to him, this ambitious initiative aims to consolidate shipbuilding capabilities across regions, fostering greater efficiency and innovation. Ramachandran said India's

proposed Rs 25,000 crore Maritime Development Fund (MDF) which looks at providing long-term, low-cost financial support and push towards indigenous shipbuilding will be basically equity funding. "The equity funding will come from the Centre, PSUs, pension funds and private sector," he noted. While pointing out that currently, 95 per cent of India's foreign trade happens through foreign-owned and foreign-flagged vessels, which results in an outgo of USD 110 billion annually from India, Ramachandran said almost 60 per cent of the country's ship repair work happens outside the country.

The Ministry of Home Affairs introduced the Rajbhasha Kirti Puraskar award scheme to encourage the implementation of the official language policy among ministries, departments, public sector undertakings, nationalised banks, among others.

# Inter-departmental panel to combat online gaming tax evasion

An inter-departmental committee with representatives from ED, RBI, tax and consumer affairs departments may be set up to combat the proliferation of online gaming platforms and ensure regulatory compliance, a DGGI report said. The GST intelligence wing of the Central Board of Indirect Taxes and Customs (CBIC) has initiated action against 118 domestic online gaming entities, and Show Cause Notices have been issued to 34 taxpayers involving tax amount of Rs 1,10,531.91 crore. The notices were issued to these gaming companies as they were not paying GST at 28 per cent rate. Furthermore, 658 offshore entities have been identified as non-registered/non-compliant entities and are being investigated by the DGGI. Also, 167 URL/websites have been recommended for blocking.

The Directorate General of GST Intelligence (DGGI) annual report 2023-24 flagged that online money gaming is a "high-risk" industry for tax evasion, money laundering, cyber frauds, juvenile delinquency and various socio-economic evils. Despite the legal clarity with effect from October 1, 2023, bringing the gaming entities under the tax net continues to be an uphill task. Many such firms are set up in offshore tax havens (i.e. Malta, Curacao Islands, British Virgin Islands, Cyprus etc.) known for their opacity, thus making it difficult to ascertain their ultimate ownership. There are online gaming platforms which keep on changing their URL/website/apps to avoid tax compliance. Use of dark web or VPN based platforms for such supply further accentuates the difficulties in tax law enforcement, the DGGI said. "Therefore, a multi-



prolonged approach to deal with this sector is need of the hour. An Inter-department committee comprising CBIC, CBDT, ED, MeITY, MCA, MIB, RBI, Department of Consumer Affairs, and the like along with industry bodies may be

set up to develop comprehensive strategies and regulations to combat the proliferation of such platforms, ensuring regulatory compliance, consumer protection and national security," the DGGI said in its report released on

Saturday. In October 2023, the government clarified in the GST law that online gaming attracts a 28 per cent tax on the total sum deposited by the players with the entity. The online gaming industry has grown exponentially in the last few years, at a CAGR of 28 per cent, reaching Rs 16,428 crore in FY23-24 as per an estimate. This boost is largely attributed to factors like widespread smartphone penetration, improved internet connectivity, a growing youth population and the development of local gaming content. Several of show cause notice recipients have approached the court filing Writ Petition against the notices, and the matter is sub-judice before the Hon'ble Supreme Court of India. The notices have essentially contended that games like rummy, poker and others are games of skill and, therefore, cannot be classified as betting/gambling. The terms

'betting' and 'gambling' are not defined in GST law. "Sir William Raynell Anson, a renowned British jurist, has defined a wager or bet as 'a promise to give money or money's worth upon the determination or ascertainment of an uncertain event'. The Hon'ble Supreme Court's verdict on the matter shall have a significant impact on how the concept of online money gaming is understood," the DGGI said. Creating awareness and education among digital nagriks about safe and responsible gaming practices, promoting the use of legitimate platforms registered with MeITY or verified as permissible Real Money Gaming Platforms under the IT Rules, 2021, and entering into reciprocal arrangements with foreign governments for information sharing and tax enforcement may go a long way in effecting regulatory compliance in this industry, the DGGI said.

# Chopra finishes second in DL final, misses crown by 1cm

Star Indian javelin thrower Neeraj Chopra agonisingly missed the Diamond League crown by just one centimeter as he finished second for the second consecutive year with a throw of 87.86m in the season finale here on Saturday.

The 26-year-old Chopra, who had won the DL trophy in 2022 before finishing second last year, achieved his best throw of the day in his third attempt but that was 1cm short of eventual winner Anderson Peters' 87.87m effort.

Grenada's Peters, a two-time world champion, produced his best throw of the day in his opening attempt. Julian Weber of Germany was third with 85.97m.

Chopra, who added a silver to his Olympic medal tally in Paris following a historic gold at the Tokyo Games, thus ended his season on a high. The Indian javelin throw superstar, who has a personal



best of 89.94m and season's best of 89.49m, had a series of 86.82m, 83.49m, 87.86m, 82.04m, 83.30m and 86.46m. The top three led the seven-

man field in the same order for the whole competition. Peters will collect a Diamond League trophy and USD 30,000 for emerging as the DL

champion this season. Chopra will pocket USD 12,000 for his second-place finish in the grand finale which marked the end of the

prestigious Diamond League series after 14 legs, as well as the end of international athletics season. The Haryana lad remained

consistent throughout the season, though he won just one international event this season -- Paavo Nurmi Games in Turku, Finland on June 18.

He had made the Diamond League final cut after finishing fourth in the overall standings with 14 points from his two second-place finishes in DL one-day meets in Doha and Lausanne on May 10 and August 22.

Chopra has been struggling with his fitness this season and is expected to meet a doctor to rectify a groin injury that has affected him all season and came in the way of his quest to hit the 90m mark.

On Friday, national record-holding 3000m steeplechaser Sable had finished ninth in a 10-man field in his maiden DL final with a mediocre time of 8 minute and 17.09 seconds to end a largely disappointing season. He had finished 11th in the Olympic Games.

It was for the first time that a DL finale featured two Indians.



## In-form India clear favourites against Korea in ACT hockey semifinal

Maintaining a clean slate, favourites India will fancy their chances when they take on a below-par but unpredictable Korea in the semifinals of the Asian Champions Trophy hockey tournament here on Monday.

Paris Olympics bronze medalist India have been in rollicking form in the tournament so far, registering five wins out of five league matches. The Harmanpreet Singh-led side started their campaign with a 3-0 win over hosts China and then trounced Japan and Malaysia 5-1 and 8-1 respectively.

India then beat Korea 3-1 before eking out a narrow 2-1 win over arch-rivals Pakistan.

It has been a commanding performance from the Indians as they excelled in every department be it forwardline, midfield or defence.

The most promising part of India's performance in the league stages has been the form of the strikers.

Scoring field goals was a major concern in Paris but here the young forwardline comprising Sukhjeet Singh, Abhishek, Uttam Singh, Gurjot Singh, Arajjeet Singh Hundal and others have exceeded expectations.

Young midfielder Raj Kumar Pal, too, has shone bright, scoring some fine field goals. Besides, veteran Manpreet Singh, vice-captain Vivek Sagar Prasad and Nilakanta Sharma has excelled in the midfield.

The Indian defence too has performed stoutly, conceding just four goals with goalkeepers Krishan Bahadur Pathak and Suraj Karkera not letting the team feel the void left the retirement of the talismanic PR Sreejesh.

Harmanpreet, one of the best dragflickers in the world currently, has led from the front and has continued his good form of Paris, converting as many as five penalty corners. When India struggled for

field goals, Harmanpreet stood up with his penalty corner conversions.

Harmanpreet also has an able understudy in young Jugraj Singh, who is right now the fastest dragflicker in the world.

But a knockout game is a new beginning for any side and the Indians can ill afford to take Korea lightly as they can spring a surprise on their day, evidence of which was their last-gasp equaliser to draw 3-3 against Malaysia and keep their semifinal hopes alive.

The Indian defence will also have to be cautious about not conceding too many penalty corners as in Jihun Yang, the tournament's leading scorer with seven goals, Korea possesses a potent dragflicker.

In the other semifinal of the day, Pakistan will take on hosts China.

FIFA coach capacity building workshop to be held at AIFF NCE in Kolkata

New Delhi, (PTI) The FIFA coach capacity building workshop, a vital component of the world football governing body's Women's League Development, which falls under the broader FIFA Women's Development Programme, will be held at the AIFF National Centre of Excellence (NCE) in Kolkata from September 16 to 18. The workshop will be conducted by FIFA experts Simon Toselli and Stéphanie Spielmann.

Toselli, a FIFA women's football technical expert, had previously conducted the women's football strategy workshop in New Delhi in June this year. He has been collaborating with 25 countries on different projects and implementation of strategies (AFC, OFC, CAF and UEFA).

Spielmann, a former player, is a UEFA A-License coach and a FIFA and OFC instructor. She has been part of the FIFA coach mentorship programme with the Belgium women's national team.

## Argentina reaches Davis Cup Final after tense win over Finland

Argentina clinched a berth in the eight-team Davis Cup Final with a tense 3-0 win over Finland.

The Argentines have reached the quarterfinals in Malaga, Spain, in November for the first time in five years.

They had to battle in Group D in Manchester after an opening loss to 2022 champion Canada. They beat host Britain on Friday and overcame a gritty Finland, a semifinalist last year but without its best player on Saturday.

Tomas Martin Etcheverry beat 703rd-ranked Ero Vasa 7-6(5) 6-3, then Francisco Cerundolo outlasted Otto Virtanen 6-7(4) 6-1 6-0. Argentina needed the doubles, and Maximo Gonzalez and Andres Molteni delivered against Patrick Kaukovalta and Harri Heliövaara 6-7(3) 6-4 6-3.

The result forces Britain to have to beat Canada 3-0 on Sunday to advance at Canada's expense. In Bologna, Brazil beat Belgium 2-1 after losses to Italy and the Netherlands in Group A.

Three-set wins by Joao Fonseca and Thiago Monteiro followed by a doubles loss took more than six hours to complete on the indoor hard-court. Brazil has a shot at advancing; the Netherlands must lose to unbeaten defending champion Italy 3-0 on Sunday. In Zhuhai, the United States earned a seeding in the Final by beating Germany 2-1 and topping



Group C unbeaten. Both teams were already qualified for the Final but the US grabbed a seeding awarded to the group winners.

Reilly Opelka saved two match points to beat Henri Squire 6-7(4) 7-6(9) 6-3 and Brandon Nakashima eased past Maximilian Marterer 6-4 6-2. The Americans dropped their first point in nine matches when Austin Krajicek and Rajeev Ram lost to Kevin Krawietz and Tim Puetz 6-1 7-6(4).

"We have a good chance against any team there (in Malaga)," Nakashima said. "There's a bunch of talented Americans playing really well right now."

In Group B in Spain, a tie between teams already out of contention saw 10-time champion France beat three-time champion the Czech Republic 2-1 sealed by a doubles win.

## Messi returns and scores twice as Inter Miami defeats Union 3-1

Lionel Messi made a successful return after a lengthy absence, scoring two goals and assisting on the third to lead Inter Miami to a 3-1 victory over the Philadelphia Union.

The Argentine star winger and eight-time Ballon d'Or winner had not played with Inter Miami since June 1 because of national team commitments and a right ankle injury sustained in a 1-0 victory over Colombia in the Copa America final on July 14.

"A little bit tired because of the heat and humidity of Miami but I wanted to return so much after such a long time away," Messi said in Spanish on the Apple TV broadcast after the game.

"I started training with the group and began to feel better," Messi, who resumed practicing three weeks ago, showed no rust or ill-effects from the injury with his performance. He scored twice in a four-minute span midway through the first half that negated an early goal by Philadelphia.

"What he did was more typical than other things that happened tonight," Inter Miami coach Gerardo "Tata" Martino said in Spanish. "I am happy that he finished the game and completed the 90 minutes. He felt fine."

Without Messi, Miami went



8-2 and clinched an MLS playoff spot. Miami (19-4-5) also took the lead in the Supporters Shield table with 62 points.

"It's nice to see that his injury has healed and that he's as effective as he was before," Inter Miami midfielder Julian Gressel said.

Luis Suárez had one assist and clinched Miami's win with a strike on Messi's assist during second half stoppage time. It was Suárez's 17th goal of the season.

Messi's first goal in the 26th minute evened it at 1-1. Suárez sent a short pass near the large area, where Messi retrieved it, outmaneuvered Union defender Kai Wagner into the box and converted a

shot that landed inside the left post. Four minutes later, Messi received a crossing pass inside the box and beat Philadelphia goalkeeper Andrew Rick with a 15-yard shot.

Suárez had a goal in the 44th minute overturned after a video review ruled an offside infraction.

"As the game progressed we ran the risk of not controlling the ball," Martino said. "From the last 30 minutes of the first half we managed to handle the ball better."

Messi's mended ankle absorbed a kick by Philadelphia midfielder Quinn Sullivan in the 67th minute as both battled for a loose ball. Messi fell to the

ground and favored the ankle but quickly stood and continued playing. Match referee Sergii Boiko assessed yellow cards to Sullivan and Martino, who argued for a stiffer infraction against Sullivan.

Seeking the equalizer, Philadelphia (7-12-9) pressed repeatedly throughout the second half before Messi centered a pass to Suárez and he converted from 18 yards.

Before his absence, the 37-year-old Messi had 12 goals and 13 assists in 12 league matches this season.

Fans barely settled in when Union forward Mikael Uhre stunned the home crowd with a goal two minutes into the match.

Messi had his first scoring opportunity in the seventh minute with a free kick near the half circle that was cleared by a wall of Philadelphia defenders. For Inter Miami, the victory came with a price. Defender David Martinez left early in the first half because of a groin injury and his replacement Noah Allen was removed after what Martino said was a blow to the head.

"We have to take it day by day and see how they recover and how they feel," Martino said. Both clubs continue league play with road matches on Wednesday. Inter Miami will visit Atlanta on Tuesday while the Union visit New York City FC on Tuesday.

## Champions League starts bigger new era with Mbappe at Madrid and rematches of past finals

The new Champions League format kicks off Tuesday after more than six years of planning, one failed proposal and one Super League launch fiasco.

In the end, storied clubs who pushed for change from UEFA and created turmoil in European soccer got most of what they wanted: More teams, more games and more of them against strong opponents, more money.

Now there are 36 teams instead of 32, each playing eight games instead of six, against eight different opponents instead of three.

Kylian Mbappe starts his quest for a first title with his third club, the record 15-time European champion Real Madrid that hosts Stuttgart. Mbappe reached the semifinals in 2017 with Monaco and was a beaten finalist in 2020 with Paris Saint-Germain.

Ultimately, all 36 teams will be ranked from top to bottom in a single league standings that finishes in January instead of traditional four-team groups that would end in December.

UEFA has cleared its midweek schedule to relaunch the marquee club event over back-to-back-to-back nights - six games each through Thursday.

The league phase through January

is quite simple. Each team plays a balanced schedule of eight games - four at home, four on the road - earning three points for a win and one for a draw.

Eight different opponents were allocated in the draw last month by a software program picking two teams from each of four seeding pots. Seeding was based on a team's UEFA ranking over five years of results in European competitions.

Recent champions Madrid, Manchester City and Bayern Munich were among the top seeds. Low-ranked pot four included debutants Girona and Brest, and long-time absentees Aston Villa, Bologna and Stuttgart. Advancing to the knockout phase is more complex, and UEFA suggested teams will need eight points from eight games to stay involved.

The top eight in the standings on January 29 go direct to the round of 16 in March seeded Nos. 1-8. Teams placed ninth to 24th in the standings enter a knockout playoffs round in February. Teams 9-16 will be seeded in the draw and play second legs at home against teams who placed from 17-24. The bottom 12 teams in the standings are eliminated.

The eight playoff winners advance as unseeded teams in the round of 16, which will be drawn into a set



bracket like a tennis tournament. That replaces the old system of separate draws for the quarterfinals and semifinals.

The new era starts with two early kickoffs featuring three European Cup winners from the 1980s - Juventus (1985) hosts PSV Eindhoven (1988) and Aston Villa (1982) travels to Young Boys. Both are first-time fixtures between the teams.

Also playing are the four teams with the most European Cup and Champions League titles in their 70-season history.

While Madrid plays Stuttgart, six-time winner Bayern hosts Dinamo Zagreb.

The standout pairing is AC Milan against Liverpool at San Siro. Milan won the last of its seven European titles in the 2007 final against Liverpool.

**Man City-Inter meet**

A more recent rematch of another Istanbul final features the current champions of England and Italy. Manchester City, riding Erling Haaland's hot start to the season, hosts an Inter Milan it beat 1-0 in the 2023 final and is unbeaten in Champions League home games for six years. It is also a night for fresh faces. Girona, which is in the same Abu

Dhabi-backed ownership group as Man City, will make its European debut at Paris Saint-Germain.

Bologna hosts Shakhtar Donetsk in its first game in the competition since a preliminary round exit 60 years ago. Bologna still plays in the Stadio Renato Dall'Ara that has been its home since 1927 and staged games at the 1934 World Cup.

Leverkusen and Atalanta, the Europa League finalists last season, now rise together to the bigger stage.

Bayer Leverkusen's only loss in a remarkable first full season under coach Xabi Alonso was that Europa final against Atalanta. Now Leverkusen returns to the Champions League at Feyenoord, whose coach last season Arne Slot took the job at Liverpool that was first offered to Alonso.

Atalanta hosts Arsenal which has lost captain Martin Odegaard to an ankle injury suffered playing for Norway on Monday.

La Liga leader Barcelona with 17-year-old star Lamine Yamal goes to Monaco and the most unlikely fixture of all 18 this week is Brest vs. Sturm Graz.

Brest, founded 121 years ago, has never played a European game and Sturm last played in the

Champions League 23 years ago. The game is being played at Guingamp, 110 kilometers east of Atlantic port city Brest, whose home stadium is not modern enough.

UEFA has put at least 2.5 billion euros (\$2.8 billion) into the prize money fund for the 36 clubs, a 25% raise on last season. The title winner in Munich on May 31 can expect to get more than 160 million euros (\$177 million).

Each team gets a basic 18.6 million euros (\$20.6 million), then 2.1 million euros (\$2.3 million) for each league-phase game won and 700,000 euros (\$780,000) per draw.

Each place in the standings is worth more money with shares of 275,000 euros (\$305,000) per place: 36 shares, or 9.9 million euros (\$11 million), goes to the team finishing top in January and a single share to the last-place team.

Bonuses escalate from 11 million euros (\$12.3 million) per team for advancing to each knockout round.

Another prize fund of 853 million euros (\$950 million) is allocated based on teams' historical record in UEFA competitions and the value of national and global broadcast deals.

# Khawaja relishes his on-field battles with Ashwin

Australian opener Usman Khawaja has over the years relished his on-field battles with star Indian spinner Ravichandran Ashwin, who according to the southpaw is a man who always has a plan up his sleeve.  
Ashwin (39 wickets) is the third-highest wicket-taker among Indian bowlers in Test matches in Australia, only behind Anil Kumble (49) and Kapil Dev (51) apart from topping the charts across all bilateral series (home and away) with 114 scalps which also includes seven five-for.  
"Ravi is a very good bowler. He is very strategic. He always has a plan," Khawaja told Star Sports.  
"He tries to figure it out and stay ahead of the game, which I respect. I respect his cricketing brain. It's always cool to play against him, and I look forward to the challenge," he was all praise for Ashwin's tactical nous.  
This will be Ashwin's fifth Test tour of Australia, having been part of the sides that



played in 2011-12, 2014-15, 2018-19 and 2020-21 although on last two tours, he had injury issues.  
Don't think India are favourites: Travis Head  
Meanwhile, India's current nemesis Travis Head had asserted that despite visiting team's dominance during last two Test series, he does not feel the visitors will be the 'favourites' this time around. "I don't feel like they're my favourite. I just feel like we play them enough, play them

(a) lot," he told Star Sports. "And, I guess the last couple of years I've been in nice form. So yeah, being able to play well, it's always nice. "It's not hard to get up for the contest. It's hugely competitive. Yeah, it's easier to get up for the game. So, I wouldn't say they're my favourite."  
However, the 30-year-old warned that Rohit Sharma and Co. Will be a difficult lot to compete against and the Aussies need to be at their best, especially 'in a couple of games'.  
"They're extremely difficult but it's been nice to play well in a couple of games and looking forward to preparing well and being ready to go. And hopefully, I can contribute to what's a successful summer for us," he added.  
The two teams will lock horns in the upcoming five-Test series in Australia starting November 22, as India defends the Border-Gavaskar Trophy it has won over past four bilateral engagements (home and away).



## Ramkumar-Balaji pair loses must win doubles

Ramkumar Ramanathan and N Sriram Balaji could play well only in patches to lose the do-or-die doubles against Andre Goransson and Filip Bergevi as India succumbed to Sweden in the Davis Cup World Group I tie after conceding an unassailable 0-3 lead, here Sunday.  
After losing both the singles on Saturday, India needed to win the third rubber to stay alive in the tie but Ramkumar and Balaji went down 3-6 4-6 in one hour and 19 minutes.  
India's dismal record against Sweden in the Davis Cup continued as it was the team's sixth defeat in as many ties. The reverse singles have been rendered inconsequential.  
India will now compete next year in Play-offs to keep place in World Group I.  
The Indian pair had its first chance in game three in the opening set on Goransson's serve. Balaji and Ramkumar pocketed four straight points to earn a breakpoint but the home team averted the danger.  
Ramkumar was, however, broken in the next game and Bergevi held his own to zoom to a commanding 5-2 lead. Balaji served to stay in the set and managed to hold. The home team comfortably sealed the opening set with Bergevi holding at love.  
In the second set, Ramkumar had a fiery start, holding at love.  
Bergevi though surprisingly struggled with his first serve as he committed two double faults to be at 30-all.  
Sensing a chance, Ramkumar attacked Bergevi's second serve but could respond only with a feeble shot on the Swede's wishidish cross court return. Standing at the net, it was an easy put away for Goransson.  
Balaji was under pressure in the next game.  
Serving at deuce, he fired an ace but Goransson hit a backhand volley winner on the next point to again make it deuce. The Indians soaked the pressure and eventually saved the game.  
Balaji faced the heat again in the seventh game with both Swedish players finding service return winners with attacking shots.  
Goransson earned a break chance with a volley winner from the net. Ramkumar hit a powerful forehand return following an exciting rally on that break point and later the Indians saved one more but on the third breakpoint Balaji netted a return. The lead stayed with the home team that served out the match in the 10th game. Ramkumar's causal forehand return landed outside the lines on the match point.

## Duleep Trophy: Bhui makes hundred in defeat against India A

Ricky Bhui delayed the inevitable with a stubborn hundred, but spinners Shams Mulani and Tanush Kotian eventually brought India D to their knees as India A walked away with a 186-run win in the Duleep Trophy match here on Sunday.  
Bhui, starting from overnight 44, made 113 (195b, 14x4, 3x6) but India D, overnight 62, were bundled out for 301, chasing 488.  
The victory enabled India A to stay in contention for the title with 6 points. But they will have to get a favourable result against table-toppers India C (9 points) in their next match here from September 19.  
India D, out of title race after two successive defeats, will be up against second-placed India B, who have 7 points.  
On a pitch that gave copious assistance to the spinners, the 'D' batters needed to show tremendous application to hang around. But apart from Bhui none really showed the stomach for a fight.  
Bhui's second-wicket stand with Yash Dubey (37) was worth 100 runs but Dubey got run out, and in his next over Mulani castled Devdutt Padikkal to push India D to 105 for three.  
They managed to stitch two useful stands for two subsequent wickets - a 53 between Bhui and skipper Shreyas Iyer (41, 55b, 8x4) and a 62 between Bhui and Sanju Samson (40, 45b, 3x4, 3x6).  
But their stands were more about aggression, and the approach was fraught with danger on a pitch where spinners called the shots.  
Both Shreyas and Samson were cleaned up by Mulani, who was later adjudged player of the match. A sharply turned one accounted for Shreyas while Samson failed to connect a pull as the ball disturbed the timber.  
While wickets were tumbling at constantly at the other end, Bhui was a picture of confidence and brought up his century in 170 balls.  
Then off-spinner Tanush Kotian got into act, and started his demolition job by removing Saransh Jain (5), and six overs later he ousted Bhui, who holed out to Riyan Parag in the deep.  
It ended the fight of India D even as Kotian went on to add two more wickets - Saurabh Kumar (22) and Harshit Rana (24).  
Brief scores: India A: 290 and 380/3 declared beat India D: 183 and 301 all out in 82.2 overs (Ricky Bhui 113, Shreyas Iyer 41, Sanju Samson 40; Shams Mulani 3/117, Tanush Kotian 4/73) by 186 runs.

## Bangladesh arrive in Chennai, Shanto confident of good show

A confident Bangladesh team arrived in India on Sunday for two Test matches and three T20s with visiting skipper Najmul Hossain Shanto hoping that their historic 2-0 series win in Pakistan recently would hold them in good stead against the formidable hosts in the coming weeks.  
The Bangladesh squad landed in Chennai, the venue for the opening Test beginning on September 19, on Sunday afternoon.  
"It's definitely going to be a very challenging series for us," Shanto was quoted as saying at the pre-departure press briefing at the Dhaka airport.  
"After a good series (vs Pakistan) there is definitely an extra confidence in the team, in the people of the country. Every series is an opportunity."  
"We will play to win both matches. The things that matter to win, the process matters... Our aim will be to do the work properly. Good results are possible if we do our job properly," the Bangladesh captain added.  
While India is on top of the World Test Championship (WTC) table, the Bangladesh



skipper believed that it will all boil down to how they perform during those five days and the result can come even in the last session.  
"If you see the ranking, they are much ahead of us," Shanto noted. "We have been playing well lately. We have had a good series. Our aim will be to play well for five days."  
"The result comes in the last session on the last day. If we play good cricket for five days, there is a chance for either team to win in the last session," the skipper said just before boarding the flight to Chennai.  
Adequate security cover for the visitors in Chennai  
Usual security protocol was in place for Bangladesh team like it happens for all international teams with two police vans accompanying the team bus to the hotel.  
Upon arrival at the hotel, the players were given a warm welcome as staff showered them with rose petals.  
The entire team will be put on one of the floors, while armed security personnel will be present on the floor, which is a regular protocol.  
The Tigers are visiting India after the tiny neighbours witnessed civil unrest for over a month. Following the students' protests last month that led to the ouster of former Prime Minister Sheikh Hasina, there have been reports of communal clashes, with attacks on minorities, especially Hindus.



## Haryana, Karnataka, Punjab win in men National Junior Hockey Championship

## Lahiri slips to tied 12th at LIV Golf Individual Championship

Lahiri carded two birdies but he also had three bogeys on the second day, and now he has a total of 2-under for 36 holes.  
Lahiri began the tournament with a fine 3-under 67 that placed him inside the top-5. He had four birdies against one bogey in the opening round.  
Jon Rahm entered this week's regular-season finale with a slim points margin over Joaquin Niemann.  
The Legion XIII captain increased that advantage with a brilliant bogey-free 6-under 64 that now has him in position to claim two trophies after Sunday's final round at Bolingbrook Golf Club.  
Rahm is at 7 under and owns a one-shot lead over Fireballs GC Captain Sergio Garcia on the leaderboard and a three-shot lead over Niemann, the Torque GC captain.  
Rahm can still become Individual Champion even if he doesn't win the tournament.



Bryson DeChambeau's Crushers GC, winners last year in Chicago, have already clinched one of the three available seeds along with Rahm's Legion XIII.  
The Crushers entered the final round tied for the tournament lead with Cleeks GC at 10 under and would clinch the No. 1 overall seed with a victory.  
Niemann's one-shot advantage entering the day was erased in their first eight holes.  
Playing in the same group for the second consecutive day, Rahm was 3 under while Niemann was 2 over.  
At one point late in the round, Rahm was five strokes ahead of Niemann. But Niemann fought back down the stretch with birdies GC in three of the final four holes to shoot a 2-under 68 and stay within striking distance.  
Hatton was on the verge of falling out of contention, opening with a 3-over 73 and then playing the first 11 holes on Saturday at even par. But then he found his game, playing the last seven holes in 5 under - a stretch that included a hole-in-one at the island green sixth hole.  
First-round leader Brooks Koepka followed his opening bogey-free 8-under 62 with a 73 that included five bogeys in his first 12 holes.  
But he made two late birdies and finished at 5-under and solo third. Team Cleeks are in the lead.
