NO PANACEA FOR COMMONERS AT AIIMS, DELHI

2018: A four-month-old infant whose parents brought her to the All India Institute of Medical Sciences (AIIMS), Delhi, for urgent surgery for a hole in her heart was given a slot for the corrective surgery operation in 2023, resulting in a five-year wait.

Fast forward to June, 2024: A sixyear-old from Begusarai, Bihar, has been left waiting for a heart operation at the premier health institute for the past six years due to "dates changed thrice."

Despite the best efforts of his father, Ankit Kumar, who had been running from pillar to post gathering funds and blood, it was a long wait for treatment. However, it was only after the issue was highlighted in the media and the NHRC took suo motu cognisance that the hospital formed a panel to investigate the delays.

These are likely some of the longest waiting periods for patients at AIIMS Delhi and have been reported as such.

Welcome to India's most prestigious medical institution, established as the country's foremost centre of medical excellence. The bustling scene outside the hospital, with relatives of the patients lying by the roadside waiting for their turn outside the emergency wards, is a telling example of the stark disparity in healthcare access in the country.



While this flagship hospital draws thousands daily, it also highlights a critical shortage of specialist doctors and medical facilities both at the hospital and in rural areas, where the majority of India's 1.4 billion people struggle with the challenge of reaching distant healthcare facilities.

On Thursday, The Pioneer visited AIIMS Delhi and spoke with the relatives of ailing patients, most of whom were suffering from serious

conditions like blood cancer, some of them admitted in the emergency departments while a few were waiting for their turn. The hospital is visited by around 20,000 patients daily from across various states, particularly populous ones like Bihar, Uttar Pradesh and Odisha, and even faroff States of North-East.

Jagan Ram who lost his 18-yearold son to blood cancer a few years ago has a better understanding of the condition. 'The doctors back home in Kanpur did not disclose the disease my son was suffering from. But now I have learned a lot about this health condition and what may come, I will ensure that this girl (Radha) does not meet the same fate."

The reputation of AIIMS for its high-quality healthcare services, cutting-edge research, and a wide range of specialties contribute to its status as a go-to destination for many seeking comprehensive medical care.

But for Mammu, a 20-year-old youth from Jaganpura Kauch, Jalon in Uttar Pradesh, it has been a restless day as he silently writhe in pain on a stretcher in the open with the weather behaving nastily. His attendant said he's having thick blood problem.

The doctor concerned is not here. So we have been asked to wait outside," said 40-year-old Jagat Singh, attending to the patient. The medical report showed that Mammu's hemoglobin level has shot up to 25, contrary to the normal 14-15 hb. He might be suffering from a disorder that causes the body to produce too many red blood cells. Yet another relative of a patient with co-morbidity such as TB and diabetes outside the emergency ward said he is trying for a 'recommendation' so that his ward could get a bed. This hospital has its own reputation, with doctors dedicated to their profession. This is what makes patients flock to this hospital, he said matter-of-factly. Outside the hospital, one can see the adjacent streets are crowded with patients and their families from distant places, all seeking remedies for their or their loved ones' health issues. "We've been

to the hospital for the last five years for my son's treatment," rued Ramwati from Rajasthan's Alwar district.

Her son suffers from chronic asthma, a condition marked by inflammation that restricts airflow from the lungs. As securing a hospital bed is a significant challenge, they are doing everything they can to ensure the little boy receives the necessary treatment. In fact, this is the travail of almost every other patient and their relatives on the roadside.

Conceding that the six new AIIMS like hospitals at States underserved Bhubaneswar, Ranchi, Patna, Raipur, Bhopal, Jodhpur and Rishikesh have failed to ease the pressure on AIIMS Delhi, a senior official in the Union Health Ministry blamed faculty shortages, resource crunch, and infrastructural deficiencies. Besides these six States, more AIIMS like institutes are coming up in other States too.

Public health specialists believe that this state of affairs is largely due to flawed health policies adopted by successive Governments. Anant Bhan, a successive researcher in global health, said merely naming an institute 'AIIMS' does not guarantee it will be held in the same esteem as the one in Delhi. "AIIMS Delhi has earned a reputation for quality and affordability, but the new centres face challenges that need

to be overcome," he stressed.



SC reserves order on Arvind Kejriwal

The Supreme Court on Thursday Treserved order on Delhi Chief Minister Arvind Kejriwal's separate pleas seeking bail and challenging arrest by Central Bureau of Investigation (CBI) in the excise policy "scam". After concluding arguments from both sides, a bench of Justices Surya Kant and Ujjal Bhuyan said, "Thank you for the

assistance. Judgment reserved."
Additional Solicitor General SV Raju represented the CBI and Senior Advocate Abhishek Singhvi appeared for the AAP chief. The apex court was hearing two separate petitions challenging his arrest by the CBI and the denial of bail in the corruption case

filed by the agency.
The AAP convenor has challenged the August 5 order of the Delhi High Court dismissing his plea against his arrest by the agency. He has also filed a Special Leave Petition against the High Court's refusal to consider his bail plea. The CBI had arrested Kejriwal on June 26.

Questioning the maintainability of Kejriwal's pleas seeking bail and challenging his arrest, the CBI told the Supreme Court that he should have first approached the trial court for bail in the corruption case linked to the alleged excise policy scam. "He has approached Delhi High Court directly without going to sessions court. Under Section 439 of the Code of Criminal Procedure (CrPC), both have concurrent jurisdiction. My preliminary objection is he must first go to trial court," ASJ Raiu said.

The CBI did not issue a notice to Kejriwal under section Section 41A of the CrPC as he was already in judicial custody, he said. Raju said if the Supreme Court which grants bail to Kejriwal, it will demoralise the Delhi High Court, which had upheld his arrest."Don't say that. Whatever order we pass, we will ensure nothing like that happens," the bench assured Raju.

day after the BJP released its first Alist of 67 candidates for the October 5 Haryana Assembly elections, discontent among party leaders, including Ministers Nayab Saini Cabinet, flared up. Several leaders expressed their dissatisfaction, with several resigning from their posts

on Thursday.

Among them were Haryana Energy
Minister Ranjit Singh Chautala, Minister of State Bishamber Singh Balmiki, Ratia MLA Laxman Napa, former Ministers Karan Dev Kamboj, Kavita Jain, MP Savitri Jindal, MLA Lakshman Napa who had raised the banner of revolt. The rebel trouble for BJP started shortly after it came out with the first list of candidates as it left

many sulking.
Interestingly, the BJP has named former prison official Sunil Sangwan
— who recommended parole for Dera Sacha Sauda chief and rape convict Ram Rahim six times — on its list of candidates for next month's Haryana Assembly election.

Sangwan will contest the Dadri seat which former BIP leader Somveer Sangwan won as an Independent in 2019 that was after the party favoured wrestler Babita Phogat over him. Energy and Jail Minister Ranjit Singh Chautala (79), son of former Deputy

Prime Minister Devi Lal said he took a

decision after a meeting with his supporters and will now enter the fray as an Independent, Ranjit Chautala called a meeting of his supporters after the party ignored his candidature from Rania segment in Sirsa district."I had good relations with them (BJP). Rajnath Singh calls for evolving joint military vision at commanders' meet

cations. He also called upon the Commanders to identify and include the right mix of traditional and modern warfare equipment in the Armed Forces arsenal. He stressed on capability development in space and electronic warfare, describing them as integral to tackle mod-

ern-day challenges. "Referring to the ongoing Russia-Ukraine and Israel-Hamas conflicts and the current situation in Bangladesh, the Defence Minister exhorted the Commanders to analyse these episodes, predict the problems that the country may face in the

"In line with the theme of the conference, 'Sashakt aur

Surakshit Bharat: Transforming the Armed Forces, the Defe Minister stated that India is a peace loving nation and the Armed Forces need to be prepared for war in order to preserve peace.

"He emphasised on the need of a broader and deeper analysis by the top military leadership in view of the situation along the Northern border and the happenings in neighbouring countries, which are posing a challenge to peace and stability in the region.

"Despite global volatility, India is enjoying a rare peace dividend and it is developing peacefully. However, due to the increasing number of challenges, we need to remain alert. It is important that we keep our peace intact during Amrit Kaal. We need to focus on our present, keep an eye on the activities happening around us at present, and focus on being future-oriented. For this, we should have a strong and robust national security component.

Dhaka issues warning of discomfort with Delhi

Muhammad Yunus, the head of Bangladesh's interim Government, has said former Prime Minister Sheikh Hasina making political remarks from India is an "unfriendly gesture", asserting that she must remain silent to prevent the discomfort to both countries until Dhaka requests her extradition.

"If India wants to keep her until the time Bangladesh (Government) wants her back, the condition would be that she has to keep quiet," he said.

In an interview with PTI at his official residence in Dhaka, Yunus, who was appointed the country's Chief Adviser after Hasina's ouster, stressed that while Bangladesh values strong ties with India, New Delhi must move "beyond the narrative that portrays every other political party except Awami League as Islamist and



that the country will turn into Afghanistan without Sheikh Hasina.

No one is comfortable with her stance there in India because we want her back to try her. She is there in India and at times she is talking, which is problematic. Had she been quiet, we would have forgotten it; people would have also forgotten it as she would have been in her own world. But sitting in India, she is speaking and giving

instructions. No one likes it, he said.

'It is not good for us or for India. There is discomfort regarding it," he told PTI. Yunus was apparently referring to Hasina's statement on August 13 in which she demanded "justice", saying those involved in recent "terror acts", killings and vandalism must be investigated, identified and punished. This has been the

only statement made by

Hasina after she fled. It was posted on her US-based son Sajeeb Wazed Joy's X handle. Following unprecedented anti-Government protests that peaked on August 5, Hasina resigned as Prime Minister and fled to India. Her presence in India for nearly four weeks has fuelled speculation in Bangladesh. When asked wheth whether Bangladesh

communicated its stance to India, Yunus said it has been conveyed verbally and quite firmly that she should keep

Days after Prime Minister Narendra Modi urged Russia and Ukraine to talk to each other to end the ongoing conflict and said India is ready to play an "active role," President Vladimir Putin on Thursday named India among the three countries he is constantly in touch over the issue. He also said these countries are sincerely making efforts to resolve it.

Modi made these assertions during his talks with Ukraine President Volodymyr Zelenskyy during his historic visit there on August 23. He conveyed to Zelenskyy that both Ukraine and Russia should sit together without wasting time to end the ongoing war and that India was ready to play an "active role" to restore peace in the region. Dolice have filed an FIR for Pabetment to suicide against three individuals, including two policemen, following the suicide by an e-rickshaw driver who was allegedly humiliated by the accused.

The victim, Amit Kumar from Babu Kheda, was an e-rickshaw driver. He faced severe humiliation and abuse from the accused, who included two policemen and a contractual worker from Apex Trauma Centre-II. The incident occurred when Amit refused to fetch cigarettes for them.

The denial led to an altercation where the contractor and police-men verbally abused and physically assaulted him for not complying with their demands. The incident took place when Amit was waiting for passengers at the gate of the trauma centre. Following the abuse, Amit's family alleged that he took his own life as a result of the humiliation and beating he endured. DCP (East) Shashank Singh assigned the investigation to the ACP (Cantt). After reviewing the case, an FIR was filed on Wednesday against two constables and a contractual worker for allegedly inciting the suicide. The investigation is ongoing. According to a written complaint filed by the deceased's father Raj Kumar, Amit was driving his e-rickshaw around 1:30 pm on Sunday when he was

MAN ATTACKS NEIGHBOUR OVER SPITTING PAAN

A man attacked his neighbour with a brick in the PGI police station area after a dispute over spitting etiquette, on Thursday. The victim, a woman named Shanti Yadav, sustained serious head injuries in the attack.

According to reports, Shanti Yadav, who lives with her husband and daughters at Raksha Khand Eldeco-II on Rae Bareli Road in Lucknow, had been in ongoing disputes with her neighbours, Sandhya and Sandeep. The conflicts were fuelled by an old rivalry, with frequent arguments escalating into violent incidents.

On August 29, Shanti had filed a complaint with the police regarding these ongoing issues, but no action was reportedly taken. On Wednesday, Sandeep spat paan on Shanti's door. When she protested, an argument ensued. During the confrontation, Sandeep and Sandhya began abusing Shanti. In the heat of the argument,

Sandeep attacked Shanti with a

brick, hitting her on the head and causing severe injuries. The assailant fled the scene after the attack, threatening Shanti and her family. According to Shanti, the attacker also threatened her four daughters, leaving the family scared. The police arrived at the scene, took Shanti to SGPGI's Apex Trauma Centre for treatment, and then sent her home. Based on Shanti's complaint, a case has been registered and the investigation is ongoing. The police are searching for the accused and working to ensure the safety of the victim and her family.

3 booked for driving One held for bakery businessman murder

Police claimed to have arrested an accused in connection with the murder of a bakery businessman whose body was found in the Gomti river a week ago. The victim, whose body was found floating in the river on August 31, was identified as Shahabuddin Mansoori (35) from Huzurpur Katka Marautha in Bahraich. The murder stemmed from a dispute over a business partnership. The primary suspect, Abu Usman, had worked in Shahabuddin's factory and had been pressuring him to make him a partner-an offer Shahabuddin never agreed to. In a violent altercation, Abu Usman allegedly slit Shahabuddin's throat and smashed his face to conceal his identity.

The conflict reportedly escalated over a debt of Rs 40,000. Abu Usman had lent this money to Shahabuddin to help run the factory.

When Shahabuddin refused to make Abu Usman a partner, the situation turned deadly. The police have registered a case and are actively searching for Abu Usman, who is currently on the run.

According to reports, Shahabuddin ran a factory near Ramlila Maidan in Khadra and was staying at a rented place in Madehganj. Around midnight on August 31, Abu Usman took Shahabuddin out of the house

under the pretext of discussing something urgent. It is suspected that Abu Usman, possibly with one or two accomplices, killed Shahabuddin and disposed of his body near Pakka Pul. Shahabuddin's brother Sultan Sheikh Mansoori accused Abu Usman of the murder. An employee of Shahabuddin, Israr Ahmed,

STF nabs 3 for duping SGPGI assistant prof

The Special Task Force (STF) of Uttar Pradesh has arrested three members of a gang involved in defrauding an asso-ciate professor at SGPGI of over Rs 2 crore in Lucknow, police said. The suspects have been identified as Haripriya Pradhan from Odisha, Jitendra Kumar Yadav from Prayagraj, and Hitesh aka Gyanchandra from Ghazipur.

According to a spokesperson, the STF had been receiving reports about organised gangs operating through social media, impersonating senior police officers from agencies such as the police, ED, and CBI to intimidate and defraud individuals.

"In response, various teams within UP STF were instructed to take necessary actions. A team led by Deputy Superintendent of Police Deepak Kumar Singh began gathering information and activating the intelligence system," the spokesperson said.

During interrogation, the suspects revealed that their gang would contact people, posing as police or CBI officers, and threaten them under various pretexts.

They collected personal information from their victims, used it to open accounts, and then transferred the stolen money through these accounts. This money was subsequently used in online trading. Instead of using their own accounts, the gang lured individuals to open accounts in their names, retaining the ATM cards, passbooks, chequebooks, and registered mobile numbers to facilitate transactions and avoid detection.

The STF is now working to trace the bank accounts and digital wallets mentioned by the accused and to apprehend additional gang members. Forensic analysis of the electronic devices recovered from the suspects will also be con-

Female advocate found murdered in Kasganj

In a sensational killing in Kasganj, the body of a female advocate was found in a canal. The victim has been identified as Mohini Tomar. She was missing from the gate of the Kotwali Sadar area of the district court since Tuesday afternoon and her body was recovered in the Sahawar area of the district on Wednesday night. The face of the victim was brutally mutilated in an attempt to conceal her identity. It is suspected that the body was thrown into the canal after the

Senior police officials reached the spot after receiving information. The police recovered the body from the canal and sent it for post-mortem. A panel of doctors will conduct the autopsy which will be recorded on video. The murder of the female

advocate caused a sensation in the area. A fellow advocate alleged that she was kidnapped and murdered from the district court's gate. Mohini Singh Tomar, wife of

BS Tomar of Madhavpuri Nadarai Gate in Kasganj, was a criminal advocate in the district court. On Tuesday morning, she went to the court from home on a scooty as usual. At 11:30 am, she called her husband and asked him to bring the car. After this, she went to the district magistrate's court with her husband. At 2 pm, BS Tomar dropped Mohini at the gate of the civil court and left. When Mohini did not reach home till evening, her husband tried to contact her on mobile phone but it was switched off. He reached the Civil Court searching for her and found her scooty parked there. At 6 pm, information about the disappearance of Mohini was registered in the police station. On Wednesday, the District Bar

Association announced a strike. At 9 pm, the police received information that the body of a woman was found in the canal of village Rempur in Sahawar police station area. Superintendent of Police Aparna Rajat Kaushik went to the spot with a police force. The advocate's husband identified

Mohini's body. Meanwhile in Sitapur, a 12year-old boy was allegedly kid-napped and killed by four people, including a juvenile, all of whom were nabbed, police said on Thursday.

The boy's body was thrown into Sharda canal of neighbouring Lakhimpur district, police

The search for the body is underway, according to a senior officer. The boy, Shivansh, had gone missing on Tuesday from the Sirkida village in Sakran area, the officer

After the family members were informed about the death they created a ruckus at the local police station and blocked the Sakran-Sitapur road, accusing the Sakran police of negli-

Shubham Mishra, an uncle of the victim, said they had filed a complaint about his nephew's disappearance on Tuesday and expressed suspicion on two individuals, one from the same village. He said they also informed police about a car used in the crime.

"However, the Sakran police paid no attention and only informed the family about the murder on Thursday. When we visited the police station on Wednesday, we were rebuked by the police officers and the station house officer of Sakran. If the Sakran police had acted promptly, our child could have been saved," Mishra claimed. Additional Sitapur's Superintendent of Police Prakash Kumar said Mishra

had reported on Tuesday that his nephew, son of late Vikas Mishra, had gone missing. The ASP said after investigation Rinku Mishra, 22, Sirkida village, Ankur Trivedi, 25, Puneet Shukla, 20, of Laharpur Kotwali area and a 17-year-old juvenile of Gularia village, Lakhimpur Kheri district, were taken into custody. ""During interrogation, the suspects admitted to kidnapping Shivansh for ran-som. After failing to receive the money, they murdered him and disposed of the body in Sharda canal," he added.

The car used in the kidnapping has been recovered and the search for the body is on with the help of divers and local police, Kumar added.

MAN HELD FOR RAPING MINOR IN BUDAUN

Police on Thursday arrested a man for allegedly raping a minor girl in a car in Zarifnagar police station area of Budaun district in UP. The accused who knew the girl reached her school on Wednesday and asked the principal that her parents have called her. The accused took the class sixth student in his car, stopped it at a secluded spot and raped her. The accused threatened the girl of dire consequences and dropped her home. The girl, however, told her parents about the incident on Thursday.

Additional Superintendent of Police (ASP) K K Saroj said, "On the basis of the complaint filed by the family members, we have lodged a case under section of rape of BNS (Bhartiya Nyay Sanhita) and relevant sections of POCSO (Protection of Children From Sexual Offences) Act. Wolves keep forest officials on toes

fter two days of relative A fter two days of calm, the wolves once again kept the Forest department on high alert as officials worked to track their movements on Thursday. Despite the efforts of 26 active teams, with ten additional teams on standby, locating the wolves proved challeng-

District Forest Officer (DFO), Bahraich, Ajit Singh, reported that a wolf was sighted on Thursday morning at Pachdeoria in Mahsi tehsil, Bahraich district. Singh personally inspected the pug marks. However, he acknowledged that rising temperatures were diminishing the effectiveness of thermal drones used for tracking. "As temperatures rise, thermal drones struggle to pinpoint the exact locations of the wolves because they begin to identify multiple spots," Singh

explained. A forest staff member elaborated on the issue, noting that thermal drones detect the body heat of wolves to locate them. "When the land's temperature increases, the drones have difficulty distinguishing the wolves' heat signatures. They work better in cooler conditions, such as during cloudy weather or in the evening," he

The DFO also mentioned that three shooters from the Forest department had arrived in Bahraich for the potential elimination of the wolves. This measure follows orders

issued by the department due to the wolves posing a threat to human safety.

Mudit Gupta, a carnivore expert from the World Wide Fund for Nature (WWF), provided insights into the situation. He suggested that the recent incidents in Bahraich might be caused by a specific group of wolves targeting of "Small wolf populations have existed in the Terai region of Uttar Pradesh and typically inhabit semi-open spaces. Factors such as a reduction in their prey base or flooding of their natural habitats could drive them into human areas. Wolves live in packs, feed on smaller mammals and birds, and prefer semi-forested areas," Gupta explained.

Gupta commended the Forest department for its efforts but emphasised the need for community education.

"Local residents should be sensitised about safety measures to take in such situations. Communities living close to wildlife should be aware of their behaviours and implement safety precautions," he said. He suggested that community sensitisation programmes be organised to educate residents

about living near wildlife. "Homes near forests should be secured with proper doors and netted windows. Additionally, allowing smaller mammals like rats and rabbits to thrive can help prevent wolves and other carnivores from encroaching into human habitats," Gupta

advised.

in robbery gunned down Lucknow (PNS): A wanted

criminal and prime accused in the daylight robbery at a jewellery shop in Sultanpur district was killed in an encounter with the Uttar Pradesh Special Task Force in the early hours of Thursday, officials said.

Mangesh Yadav, who carried a reward of Rs 1 lakh, sustained serious injuries during the encounter and was admitte the community health centre in Bhadhaiya where he succumbed to his injuries.

The police recovered a 32bore pistol, cartridges, 315-bore pistol, a motorcycle and looted jewellery from the spot. Mangesh, a native of Jaunpur, had several criminal cases registered against him.

The encounter, with the members of the gang which committed daylight robbery at Bharat Jewelers in Sultanpur town on August 28, took place in the Misirpur Puraina area of Kotwali Dehat, Sultanpur at around 3:25 am.

The operation was led by STF Deputy Superintendent of Police DK Shahi and Deputy Superintendent of Police Vimál Singh. On August 28, five armed men

had looted valuables worth over Rs 2 crore at gunpoint from a jewellery shop in broad daylight in Majorganj area in Sultanpur. The CCTV footage of the incident has surfaced online. According to eyewitnesses, the incident took place at around 12 noon when five men, who came on two motorcycles, entered the showroom of jeweller Bharatji Soni. Three of them wore helmets and two had their faces covered with scarves. The police and UP STF were investigating the case. Mangesh Yadav was also involved in this robbery.

Earlier, the police had arrested three other criminals after an encounter. On Thursday, the police received information about the location of three criminals from an informer. The police surrounded the area, leading to the shootout. During the exchange of fire, the police shot the three criminals in the legs. All three were arrested and admitted to the

criminals were involved in the robbery. Three of them have been arrested, one has been killed by the STF, and another is still being searched for. Earlier, ADG Lucknow Zone announced a reward of ₹1 lakh each on 11 dacoits involved in the jewellery robbery case.

MP flags off train for Mata | Minister inspects hospital, police station

Uttar Pradesh Minister of Tourism and Culture and in charge of the district Jaiveer Singh conducted a surprise inspection of Kasturba Gandhi Residential Girls School Shivpur, Pt Deendayal Upadhyaya (DDU) District Hospital and Cantt police station and gave necessary instructions to the officers present on the spot while reviewing the works and arrangements. He first reached the Shivpur-located school and tested the general knowledge of girls asking names of the President, Prime Minister, CM etc. He also inquired from the girls about the time of waking up in the morning and the day's routine, breakfast, lunch, dinner time etc. After this, he inspected the computer room operated for online coaching of higher education for girls. He instructed all the teachers present to give quality education

During the inspection of Pt Deendayal Upadhyay District Hospital, the minister went to the medicine store room and checked the availability register of medicines from the storekeeper/pharmacist. Apart from this, he took information about the demand and supply of medicines. He instructed the CMS to maintain the stock register of medicines and put up stock charts of medicines outside the medicine room. During the inspection, the

minister has taken the CMS to task for finding medicines with MRP print and on the instruction of Singh, District Magistrate S Rajalingam asked a senior officer to investigate all the shortcomings of the hospital. Some attendants said the medicines are available in the hospital, while others complained that the doctors prescribe medicines from outside. On this the minister instructed the CMS to improve the hospital system. Apart from this, he went to the OPD room, paediatrics, dermatology and other departments and talked to the doctors and instructed them to provide better services to the patients.

Later, Singh reached Cantt police station and inquired from the police officers/employees posted at the women help desk, IGRS, cyber crime cell, CCTNS office and FIR rooms and gave necessary instructions. The minister asked the women police personnel posted at the women help desk how many women and children have been rescued in the last three/six months and how many cases came and how many were resolved. In reply, the cops informed that no case is pending right now. After this, the minister went to the cyber crime cell and inquired about the complaints received in two months. It was told that a total of 25 cases came, out of

this, Singh said that the personnel deployed in the cyber crime cell should do better work and ensure disposal of complaints within the stipulated time limit. He also went to the IGRS cell and checked the complaint register and gave instructions for timely disposal.
Later, at a review meeting of

India's move to build toilets has saved up to 70,000 infant lives annually: Study

India's initiative focused on **⊥** building toilets has potentially saved up to 70,000 infant lives annually, a recent study published in the British journal 'Nature' has revealed, in a testament to the impact of the Prime Minister Narendra Modi's pet project, the Swachh Bharat Mission (SBM). Lauding the observations, the

report was shared by the Prime Minister on Thursday stating that access to proper toilets plays a crucial role in reducing infant and child mortality. The Mission is a country-wide campaign initiated by the Central Government on October 2, 2014, to eliminate open defecation and improve

solid waste management. In a social media X, the Prime Minister posted saying that improved sanitation has



become a "game-changer" for public health in India. "Happy to see research highlighting the impact of efforts like the Swachh Bharat Mission. Access to proper toilets plays a crucial role in reducing infant and child mortality," Modi said. "Clean, safe sanitation has become a game-changer for public health. And, I am glad

India has taken the lead in this," he added. The report "Toilet construction under the Swachh Bharat

Mission and infant mortality in

India", said toilet construction increased dramatically across India following the implementation of the SBM in 2014 adding that the post-mission period in India exhibited accelerated reductions in infant and child mortality compared to the pre-SBM years.

Researchers had analysed infant and under-5 mortality data from 35 states in 640 districts and came to the conclusion that "based on regression estimates, the provision of toilets at scale may have contributed to averting approximately 60,000 to 70,000 infant deaths annually." It added that the implementation of transformative sanitation programmes can deliver population health benefits in low and middle-income countries. This significant impact underscores the crucial role of improved sanitation in reducing infant and child mortality rates, highlighting the success of the program. The research delves into data

spanning two decades, uncovering a significant link between improved sanitation and reduced child mortality. By examining changes in toilet

access across the states, the study demonstrates how each 10-percentage-point increase in district-level sanitation correlates with marked declines in both infant and under-5 death rates, highlighting the mission's crucial role in advancing public health and saving lives. | information.

1 has informed the Supreme Court that it has prohibited the 'two-finger test' which was conducted to determine whether a survivor of rape or sexual assault was habituated to sexual intercourse.

The State Government told the apex court that a circular dated June 27, 2024, was issued by the Health and Family Welfare Department of Meghalaya prohibiting the test and disciplinary action will be

taken for non-compliance.
A bench of Justices J B Pardiwala and Sanjay Karol, which referred to a top court's order passed on May 7, noted that the apex court had strongly deprecated the practice of conducting a 'two-finger test'. "Amit Kumar, the Advocate General appearing for Meghalaya, has tendered a circular dated June 27, 2024, issued by the Government of Meghalaya, Health and Family Welfare Department. This circular has been issued prohibiting the 'two-finger test and also disciplinary action for its non-compliance," the bench said in its September 3 order. The bench passed the order while dismissing a petition filed by a convict who had challenged the Meghalaya High Court's verdict delivered on

March 23 last year. The high court had affirmed his conviction for the offences punishable under the provision of the Protection of Children from Sexual Offences Act. The bench noted that the convict was sentenced to 10 years

for the offence. In a judgement delivered in October 2022, the apex court deprecated the "regressive" and "invasive" practice of the 'twofinger test' on rape survivors and said it has no scientific basis and instead re-victimises



women who may have been sexually assaulted, and was an affront to their dignity. In its order passed on

September 3, the top court referred to the circular issued by the Meghalaya Government. The Supreme Court of India and the Ministry of Health and Family Welfare have prohibited the practice of conducting the two-finger test (TFT) on survivors of sexual assault. This practice is scientifically baseless, traumatising, and violates the survivor's dignity and rights," the circular said.

"All Government doctors and medical practitioners in the State of Meghalaya are hereby directed not to conduct the two-finger test on survivors of sexual assault. Adherence to this directive is mandatory for all Government medical per-

The circular further said any doctor found conducting the test will be held guilty of misconduct and strict disciplinary action will be initiated in accordance with the Meghalaya Discipline and Appeal Rules, 2019. It said the survivors of sexual assault must receive compassionate, respectful and sensitive care, including psychological support and counselling services.

"We hope and trust that the circular referred to above issued by the State of Meghalaya is implemented and abided in its letter and spirit. We hope that in future we may not have to once again condemn the State of Meghalaya for such a serious lapse," the bench said.

Frequent mobile phone use linked to increased risk of cardiovascular diseases: Study

For, a new study published in Canadian Journal of Cardiology has suggested that frequent mobile phone use is linked to an increased risk of cardiovascular diseases (CVD), particularly among current smokers and individuals with

The study is particularly relevant for India, where, as of January 2024, there were 1.12 billion mobile connections, encompassing 78 per cent of the country's population.

Study author Dr Yanjun Zhang from Nanfang Hospital, who use their phones less fre-

Southern Medical University China, warned that, "Given the pervasive nature of mobile phone use, understanding its health impacts is crucial. Radio-frequency electromagnetic fields (RF-EMF) from these devices can disrupt the hypothalamic-pituitary-adrenal axis, cause inflammation, and induce oxidative stress. This can affect heart health and blood vessels. However, the precise connection between mobile phone use and CVD

remains uncertain." His colleague and co-investi-gator Dr. Ziliang Ye echoed similar views. "We found that regular users face a significantly higher risk of developing these conditions compared to those failure, while also exploring the

Over a median follow-up period of 12.3 years, the study assessed incidences of stroke, coronary heart disease,

MD, emphasised that poor sleep patterns and mental health issues could exacerbate the risk of cardiovascular diseases through disrupted circadian rhythms, endocrine and metabolic disturbances, and increased inflammation. "Chronic RF-EMF exposure from mobile phones, combined with smoking and diabetes, may further amplify this risk." Dr Vivek Shama, Associate consultant cardiology, Fortis Greater Noida who though not connected with

the study, agreed. "Yes, we do agree that mobile phone usage can adversely

affect heart health. Excessive use of mobile phones, particularly during long conversations, exposes the body to high-frequency magnetic field waves. These waves can interfere with the heart's function, leading to symptoms such as palpitations, dizziness, headaches, and even heart arrhythmias in some cases. We've particularly observed this in individuals who frequently use devices like EarPods. Although companies claim that these devices are safe, excessive usage can still result in complications for both the heart and brain," he said. Additionally, sleeping with your phone nearby can lead to headaches, migraines, and potentially other health issues. It is essential to minimize screen time, especially before bed, Sama warned and cautioned that excessive phone use, especially among the younger generation, can lead to insomnia, anxiety, and stress.

"This is largely due to the constant engagement with virtual platforms, which can result in unhealthy comparisons with others, leading to mental health issues. Prolonged screen time also reduces physical activity, contributing to obesity, particularly in children who are often given phones as distractions," he said.

"Phones should be kept away while sleeping, and screen time should be minimized, particularly first thing in the morning,"

eb series IC-184: The Kandahar Hijack, has triggered debate on the complexities and 'greys' that accompany such incidents. Beyond obvious things like the lack of coordination, responsiveness or even allowing the flight to take off from Amritsar – one important query is if India did wrong in negotiating with terrorists. Given the handiwork of these released terrorists in the subsequent terror attacks, the question acquires even gravity. However, beyond the simplistic and binary 'yes' or 'no' position that is often postulated in the argument, lies the necessity of nuance in attempting to answer the same. It is universally agreed that negotiations with terrorists are a bad idea, however, sometimes, the consequences of not negotiating can have far more debilitating and costly consequences.

Sifting the wheat from the chaff of the supposed 'no-negotiation' stance of some countries (as often bandied) is important. It is frequently argued that countries like Israel or the United States of America do not negotiate with terrorists. It is further claimed that because of such an unbending posture, the Israelis and Americans avoided being taken as hostages. But such beliefs are untrue, misplaced, and belie the wheels-within-wheels of the American or Israeli reality, beyond the publicly stated position of 'no-negotiation'.

It is the worst-kept secret that such countries have funnelled money through proxies, 'friendly countries, or even masked the same as 'aid' to secure their citizens, whilst maintaining the official stance.The Iran-Contra affair (1981-86) during the Reagan era wherein American hostages held by the Lebanese group, Hezbollah, were exchanged for weapons for Hezbollah itself, xemplifying the deals cut beyond the public gaze. As recently as 2014, the Americans had released five Taliban prisoners from Guantanamo, to secure an American hostage. Last August, the United States is

believed to have unfrozen \$6 bil-

lion of Iranian funds in South Korean banks to secure the release of five US citizens. It is now argued that the same money could have been invaluable for the cashstrapped Iranians (widely believed benefactors of Hamas) in launching the subsequent '7th Oct' attack on Israel. Israelis themselves are the masters of the backdoor negotiations, irrespective of the belligerent stand adopted for public consumption. In the Gilat Shalit (Israeli prisoner) exchange of 2011, it is believed that Israelis released 1027 prisoners who were held in jails. Even now as the bludgeoning of the Gaza Strip continues, the Israelis in parallel (and in sup-port of the Biden administration) are still negotiating with Hamas for the release of their citizens held hostage. Often, the aggrieved government can end up losing a lot of leverage and lives when they refuse to engage with bad actors. Negotiations help immediate outcomes, buy crucial time for alternate reactions, and most importantly, help establish critical information and 'leads' about the captors that could be invoked, productively.

Lastly, a well-managed ransom payoff (with 'marked' bills and telltale trails) can also lead to discovering broader networks and bases to take down the terror infrastructure, subsequent-

ly. Negotiations or engagement does not have to be tantamount to surrender or even a 'bad deal', necessarily. From the post-released activities of the three terrorists in the IC-814 case, it was a costly 'deal' but was there an alternative? The hijacked plane was parked in the backyard of Pakistani ISI's supported Afghan base (at least then) with 158 precious lives (not including the 5 terrorists). The terrorists in this case (under the direct supervision of the ISI and Taliban) were not exactly known to be reasonable, and if anything, had given a glimpse of their intent with the brutal and fatal stabbing of passenger, Rupin Katyal. Even an Entebbe-like commando operation using Indian Special Forces was impractical and fraught with additional risks. With the clear intention of harming Indian interests without an iota of any fear of getting caught (given the location) the risk to the lives of all passengers and crew of IC-814 was not possible, but imminent. The calculation and opportunities would have been far ordeal necessitated negotiamore creative with possible tions in that specific case, as solutions, had IC-814 been held up in Amritsar, as opposed to Kandahar. Could India have forsaken the lives of its citizens? Has any other country ever for-

authorities when its Embassy staff was held hostage or did it steadfastly hold to the 'nonegotiation' posture? The 'nonegotiation' is more of an ideal, but a fuzzy line, practically. It is a deterring policy but has never been an ironclad law, anywhere in the world. INDIA BOLSTERS 'ACT EAST' POLICY

PM Modi's Brunei visit highlights India's commitment to strengthening ties in Southeast Asia

rime Minister Modi is wasting no time in walking the talk as far as his foreign policy goals are concerned. This week, with a clear focus on Look East policy the Indian PM was in Brunei and Singapore. The Brunei visit was the first state visit by an Indian PM, after establishing diplomatic relations in 1984. The Indian Mission in Brunei came nearly a decade later in 1993. PM Manmohan Singh had visited Brunei Darussalam in 2013 to attend multilateral meetings of ASEAN and East Asia Summit. Highlighting the importance of the first bilateral visit to Brunei, India's High Commissioner Alok Amitabh Dimri, told news agency ANI " In our four decades of diplomatic relationship, this is the first bilateral official visit by the Prime Minister of India to Brunei Darussalam.

It is a historic moment in our bilateral relationship and also for the Indian community in Brunei Darussalam that high-level bilateral engagement between Prime Minister Shri Modi and His Majesty the King is going to take place. This visit is historic in many ways that Brunei and India have been civilizational neighbours as you know that India shares deep historical roots and bonds with Southeast Asia. The Malayan tradition of this geography which is located in the Borneo Island of Southeast Asian Seas derives deep linkages be it, linguistic, anthropological, ethnic, architectural, religious motives, customs and traditions, norms from India, South India." Defence relations between the two countries have been on an upward trajectory since the establishment of formal diplomatic



There have been several official-level defence exchanges and visits of navy, coast guard ships and joint exercises. India has MoU in in defence sector with Brunei till 2026. Several Indian Navy ships and coast guard ships such as INS Rana, INS Airavat, INS Shivalik & INS Kadmatt, and Samudra Pahereda to name a few, have been in Brunei waters, given the maritime security concerns. The trade relations between the two countries are not what one can boast of, however, it is of strategic impor-

The recently concluded Brunei trip by the Indian PM has enhanced and deepened the partnership between the two countries. The joint statement issued after the leader's meeting stated "Both leaders held discussions for enhancing cooperation on a wide range of issues including defence, connectivity, trade and investment, energy including renewables, space, ICT, health and pharmaceuticals, education and capacity building, culture, tourism, youth and people-to-people exchanges, as well as regional and international issues of mutual interest." However, the real area of cooperation would be in maintaining international rules of law deep in the Indian Ocean. Brunei is located in the South China Sea region, where China has a significant presence and has been increasingly threatening the bordering countries with its coercive tactics. These issues were raised by the Indian PM in his meeting with his Counterpart on Darussalam. The joint statement read, "Both leaders reiterated their commitment to work closely together in mutually beneficial areas to further strengthen the ASEAN – India Comprehensive Strategic Partnership. Both leaders reiterated their commitment to maintaining and promoting peace, stability, maritime safety and security, as well as respecting freedom of navigation and overflight and unimpeded lawful commerce, consistent with international law, notably the United Nations Convention on the Law of the Sea (UNCLOS) 1982. The leaders also urged all parties to resolve disputes through peaceful means in accordance with international law, particularly UNCLOS 1982."

The first state visit by an Indian PM to Brunei just months after taking charge for a third time is a long-term strategic move to secure India's interests for the future.

Unified pension scheme: Balancing the old and new UTTAM GUPTA



Modi Government unveils unified pension scheme to bridge old and new, aiming to satisfy Central and State employees



n August 24, 2024, the Union government announced the new Unified Pension Scheme (UPS) for central govern-ment employees. In fact, what looked like a well-orchestrated action plan, on the following day the BJP-led government in Maharashtra approved the implementation of the Scheme for its employees. Madhya Pradesh government is likely to implement the UPS soon. The above announcements are in response to the earlier decisions of Opposition-ruled States, including Rajasthan, Chhattisgarh (before the November 2023 elections), Jharkhand, Himachal Pradesh (HP) and Punjab to revert to the old pension system (OPS) which it felt tilted the electoral pendulum towards those parties, particularly in HP. Fearing a repeat during the upcoming elections and Congress having already announced its intent to revert to OPS in Maharashtra, Modi seems to have gone for a preemptory move. employees of both the central and State governments who joined service after January 1, 2004, and are covered under the national pension scheme (NPS) have been uncomfortable with it. They have been demanding the restoration of the OPS which opposition-ruled states promised. Now, the Centre and BJP-ruled states have come up with the UPS hoping this will satisfy them. Will it? Under the OPS, retired employees

received 50 per cent of their last drawn salary as a monthly pension. Just as the government offers its employees an adjustment in dearness allowance or DA to offset the increase in the cost of living, the monthly payouts of pensioners also increase to provide for DA. A government employee under OPS could not have got anything better. He was entitled to a decent 'pre-determined' monthly amount; the pension was fully protected against inflation and got it as long as he lived. After death, his wife gets the same amount for seven years and thereafter the family pension is around 60 per cent of this amount till she is alive. However, from the perspective of the government, the arrangement could not have been worse.Under OPS, there was an inherent tendency for pension liabilities to balloon

due to the addition to the pensioners' club every year, higher salaries of those joining, inflation indexation, increased longevity and so on. In 1990-91, the Centre's pension bill was Rs 3,272 crore. By 2020-21, it had jumped 58 times to Rs 190,886 crore. For all states, it shot up from Rs 3,131 crore in 1990-91 to Rs 386,001 crore in 2020-21 or 125 times.

Financial prudence requires that every year, the government set aside capital which together with return accruing thereon would create a growing corpus sufficient to pay for the pension liabilities on a sustainable basis thus avoiding any stress on the budget. But, that was never done. Instead, both the Centre and states have followed what in jargon is known as 'pay-as-you-go'. This has made the present generation of taxpayers bear the continuously rising burden of pensioners.

To deal with these pitfalls, the then UPA dispensation introduced the NPS for government employees joining service from January 1, 2004. Unlike OPS where the employee doesn't contribute anything, NPS is a contributory pension scheme under which employees contribute 10 per cent of their salary (Basic + DA). The government also contributes 14 per cent towards the employees' NPS accounts. The money is invested in multiple investment avenues i.e. equity, government bonds etc where it grows into a sizeable corpus by the time an employee reaches retirement age.On retirement, she is allowed to withdraw 60 per cent of the corpus (this is tax-free), and buy an annuity from the remaining 40 per cent. NPS offers a selffinancing and fully funded arrangement for discharging pension liabilities in which the state knows 'how much it has to contribute'.

There won't be any major stress on the budget even as the employ-

ee gets a good pension depending on the contribution made, the age of joining, the type of investment, and the income accruing from that investment. The NPS is good for the fiscal health of the government. However, from the pensioner's angle, it doesn't match the OPS. Modi has brought a new UPS to bridge the gap between the two. Does it?Under UPS, which kicks in from April 1, 2025, employees who joined the service after January 1, 2004, and have worked for 25 years or more, after retirement, will be given 50 per cent of their basic average salary of the last 12 months as pension every month. However, employees who have served less than 25 years will get proportionately less or Rs. 10,000 per month minimum pension to employees who have served for a minimum of 10 years.If an employee dies on or before retirement, then the husband or wife will be given a pension, but the pension amount wil be 60 per cent of the pension received by the employee immediately before her or his demise. Employees who have already retired or retiring on or before 31 March 2025, with arrears, will be eligible under UPS. The Scheme offers an adjustment in DA on assured pension, assured family pension and assured minimum pension. The DA will be calculated based on the All India Consumer Price Index for Industrial Workers (AICPI-IW) as in the case of service employees. How will the government fund it?It will build a pension corpus out of the employee contribution of 10 per cent (of basic pay plus DA) and the government's contribution of 18.5 per cent. The pension corpus will be divided into two portions: an individual pension fund (IPF) to which the employee's contribution of 10 per cent and matching government contribution will be credited; and

remaining 8.5 per cent contribution of the government.

The employee can exercise an investment choice for the IPF alone. The employees looking for higher pensions will have the option to get their pension monies (from IPF alone) invested in high-risk instruments for better returns. However, they will have to forego the UPS guarantees viz. monthly pension payouts of 50 per cent of the final service year's monthly pay, with full inflation adjustment.UPS guarantees will only be for those who opt for the "default investment option" which means an employee should leave it entirely to the government to manage the IPF besides the 'pool corpus. the former has anyway no claim. Needless to say, the 'pool corpus' will be used to make up for the shortfall in the returns generated from the investment of the IPF to ensure a 50 per cent pension.

Inder UPS, there is no provision for the return of capital to the heirs of the pensioner in the event of her death. This makes perfect sense as one can't have the cake and eat it too. The shift to UPS is a good move. It gives what the OPS gave even while preserving the good features of NPS like self-financing for discharging pension liabilities. It puts a little extra burden on the taxpayers being the extra 4.5 per cent of the government's contribution (18.5 per cent under UPS against 14 per cent under NPS). One wonders whether this will fully satisfy the employees. The answer is 'Yes' if they see reason. It will be 'No' if they don't. For instance, they could still argue under OPS, they were getting a 50 per cent pension without having to contribute even a Rupee whereas under UPS, an employee has to contribute 10 per cent of basic pay plus DA every month.

DCP tried to purchase my silence: RG Kar horror victim's father

There was more fuel to the leaping flames of protests against the rape and murder of a lady doctor of RG Kar Medical College and Hospital with the father of the victim alleging that Kolkata Police had tried to stuff his mouth with cash to keep it shut. In what could embarrass the

powers that be more than ever before the father of the victim doctor told a rally of protesting doctors how a senior IPS officer drew him aside and offered him a packet which he refused.

"It was on the evening of my daughter's death ... her body was kept inside her room ... and we the old parents were sitting on the sofa ... blank ... about the source of the money

me aside and offered me a packet stuffed with money ... It was clearly to keep my mouth shut ... I was not prepared for such a situation ... Îmagine the mental state of a father who had just lost her only daughter," said old man in his late sixties adding "I refused the offer and pointed at his 'IPS' insignia and said 'the way you earned your police service through hard labour my daughter too had earned her degree."

The father of the victim broke down and said how, "they were trying to purchase the honour of my dead daughter . it was the last thing expected from a senior police officer." On whether he asked Deputy or whether he was asked by

Commissioner of Police drew his superior officers to do so the parent of the victim replied in the negative.

The ordeal of the family did not end there. "Sometime later a couple of police personnel came back and asked us to tell before a video camera that no money had been offered to us and we had no other way but follow their instructions as there was intense pressure ... our whole house was surrounded by 300-400 policemen."

The victim's body was found in a semi nude state inside the seminar hall of the RGKMCH in the early morning of August 9.

Prime Minister Narendra Modi, in his Independence Day address from the ramparts of the Red Fort on August 15, expressed hope that the situation in violence-hit Bangladesh would return to normal soon and stated that 1.4 billion Indians are concerned about the safety of Hindus and minorities in the neighbouring country. The 84-year-old Nobel laureate

emphasised the need for India and Bangladesh to work together to improve their currently strained relationship. When asked about ways to improve the Indo-Bangla relations, Yunus said both the countries need to work together and it is on a downhill presently.

"We need to work together to improve this relationship, which is now at a low," he said.

Speaking about the future of bilateral treaties with India, Yunus said there are demands for a relook at certain treaties such as transit and the Adani electricity deal. "Everybody is saying it is needed. We will see what is on paper and, second, what is actually happening on the ground. I can't answer it specifically. If there is any need to review, we will then raise

questions about it," he said. The BNP has said if voted to power, it will review and reevaluate the "questionable" Adani electricity deal signed during the Awami League regime, as it is putting "tremendous pressure" on the people of Bangladesh.

The appointment of the 73vear-old Barnier follows weeks of intense efforts by Macron and his aides to find a candidate who might be able to build loose groupings of backers in parliament and survive possi-ble attempts by Macron's opponents to quickly topple the new government that Barnier will now put together and lead. A statement from Macron's office announcing Barnier's appointment said he'd been tasked "with forming a unifying government to serve the country and the French peo-

This appointment comes after an unprecedented cycle of consultations during which, in accordance with his constitutional duty, the president



ensured that the prime minister and the future government would meet the conditions to be as stable as possible and give themselves the chances of uniting as broadly as possible," the statement said.

Barnier, a career politician proud of his humble roots in France's Alpine region of Haute-Savoie, is no stranger to complex and difficult tasks: He was the European Union's chief negotiator in the difficult talks with Britain over its Brexit departure from the bloc.

Netanyahu sticks to open-ended control of Gaza border with Egypt

Tsraeli Prime Minister Benjamin Netanyahu said Wednesday that Israel must keep open-ended control of Gaza's border with Egypt, digging in on his stance on an issue that has threatened to derail cease-fire efforts.

Netanyahu's comments came as the United States is developing a new proposal for a cease-fire and hostage release, hoping to break a long deadlock and bring an end to the nearly 11month-old war.

The question of Israeli control of the Philadelphi corridor -a narrow strip of land along Gaza's border with Egypt, seized by troops in May -- has become a central obstacle in the talks. Hamas has demanded an eventual full Israeli withdrawal from Gaza in the multi-phase truce deal.

Egypt, a mediator in the talks along with the U.S. and Qatar, has also demanded a concrete רצועת עזה

leave the Philadelphi corridor. And on Wednesday, the United Arab Emirates, which established formal ties with Israel in the 2020 Abraham Accords, also criticized the Israeli stance.

Speaking to foreign journalists, Netanyahu repeated his stance that Israel must maintain its Hamas from rearming by smuggling weapons into Gaza. He said it was a vital part of the war goal of ensuring Hamas cannot repeat its Oct. 7 attack on Israel.

Gaza must be demilitarized, and this can only happen if the Philadelphi corridor remains under firm control," he said, timeline for Israeli troops to hold on the border to prevent claiming Israeli troops had dis-

covered dozens of tunnels under the border. He said Israel would only consider withdrawing from the corridor when presented with an alternative force to police it.

"Bring me anyone who will actually show us ... that they can actually prevent the recurrence" of smuggling, he said. "I don't see that happening right now. And until that happens, we're there." Ukraine gets new foreign minister as Zelenskyy reshuffles cabinet for 'new energy'

Ukraine's parliament approved the appointment of a new foreign minister Thursday, two lawmakers said, as President Volodymyr Zelenskyy sought to breathe fresh life into his administration with the war against Russia poised for what could be a pivotal phase.

Andrii Sybiha, a former ambassador to Turkey, is the country's new chief diplomat. He replaced Dmytro Kuleba, who became one of Ukraine's most recognizable faces on the international stage as he petitioned and pleaded with Western countries to support Ukraine's war effort.

Sybiha, 49, has been working as Kuleba's deputy since April. Zelenskyy wants to replace almost a dozen top officials in his biggest government shakeup since Russia's full-scale invasion started on Feb 24, 2022. Other changes included the heads of strategic industries, justice, natural resources and



farming.

Parliament's approval is required for the changes. Ukrainian lawmakers Yaroslav Zhelezniak and Oleksii Honcharenko confirmed the vote to The Associated Press. Zelenskyy said Wednesday of the reshuffle that Ukraine needs "new energy". The war, more than 900 days

long, is on the cusp of what could be a key period.

Will not stop oil exploration in **South China Sea: Malaysia**

Prime Minister Anwar Ibrahim said Thursday that Malaysia will not bow to demands by China to stop its oil and gas exploration in the South China Sea as the activities are within the country's waters.

Anwar said Malaysia would continue to explain its stance following China's accusations in a protest note in February to the Malaysian Embassy in Beijing that Kuala Lumpur had infringed on its territory. Malaysia's Foreign Ministry said Wednesday it was investigating the leak of the diplomatic protest note that was published by a Filipino media outlet on Aug. 29.

"We have never intended in any way to be intentionally provocative, unnecessarily hostile. China is a great friend, but of course we have to operate in our waters and secure economic advantage, including drilling

for oil in our territory," Anwar said in a televised news conference from Russia, where he is on an official visit.

The Philippine Daily Inquirer

published the diplomatic note in which Beijing reportedly demanded that Malaysia immediately halt all activities in an oil-rich maritime area off Sarawak state on Borneo island. The report said China had accused Malaysia of encroaching on areas covered by its 10dash line, Beijing's controversial map showing its claims to sovereignty in the South China Sea. The diplomatic note also expressed Beijing's displeasure over Malaysia's oil and gas exploration activities near the Luconia Shoals, which is near to Sarawak, it said.

Anwar said it wasn't the first time China had sent a protest note over the South China Sea dispute but stressed it shouldn't mar a strong relationship. Anwar had called China a "true friend" during a visit to trading partner since 2009.

The Chinese government is no longer allowing foreign adoptions of the country's children, a spokesperson said Thursday. The only exception will be for blood relatives adopting a child or a stepchild, Foreign Ministry Spokesperson Mao Ning said. She didn't explain the decision other than to say that it was in line with the spirit of rele-

vant international conventions.

Many foreigners have adopted children from China over the decades, visiting the country to pick them up and then bringing them to a new home overseas. China suspended international adoptions during the COVID-19 pandemic. The government later resumed adoptions for children who had received travel authorization before the suspension in 2020, the US State Department said in its latest annual report on adoptions. A US consulate issued 16 visas for adoptions from China in the 12 months from October 2022 through September 2023, the first in more than two years, the State Department report said. It wasn't clear if any more visas had been issued since then.

In January, Denmark's only overseas adoption agency said it was winding down operations after concerns were raised about fabricated documents and procedures, and Norway's top regulatory body recommended stopping overseas adoptions for two years pending an investigation into several cases.

China intends to build nuclear power out an "action for a mine-free Africa,"

plants in Africa, similar to its cooperation with Pakistan. The collaboration on nuclear and

space technologies will help modernise African countries, Xi said. He also spoke of elevating China-Africa relations to an all-weather partnership, a term typically used to describe China's close ties with Pakistan.

Teenager charged with murder of 80-year-old Indian in UK

14-year-old boy arrested A 14-year-old boy arrested following the fatal assault on 80-year-old Bhim Kohli while he was out walking his dog in a park near the eastern England city of Leicester appeared in court on Thursday charged with his murder.

The boy, who cannot be named for legal reasons as he is a minor, appeared at Leicester Youth Court sitting at Leicester Magistrates' Court. He was among five children aged 12-14 years arrested following the death of Kohli in hospital on Monday night by Leicestershire Police, with the other four released earlier with no further action.

Meanwhile, Kohli's family released a statement via the police to say they were heartbroken and struggling to cope with the loss of a loving and caring person.

"Bhim was a loving husband, dad and granddad. He was also a son, brother and uncle. He adored his grandkids with all his heart and loved spending time with them. He really was such a loving, caring person whose life was centred around his family," the statement reads. "He has always been a very hardworking man and even at the age of 80 he was still very active. One of his great passions was his allotment, he would go everyday to tend to his plots

and was so proud of them. He also enjoyed walking the fam-ily dog Rocky in the park many times a day," it goes on. The family shared how Kohli 'loved to laugh" and was always very happy and talkative, the "joker of the family" who always loved to outsmart us with a smile. "Our family have lived in the same house in Braunstone for 40 years, so he was very well known in the community – we have been overwhelmed by the messages and support from many who knew him. Our hearts have been completely broken. We are now pulling together as a family to try and support each other through the most difficult

time imaginable and would ask for privacy while we do this," the statement concludes. A post-mortem examination carried out after his death in hospital following the attack at Franklin Park in Braunstone Town on Sunday evening confirmed the cause of death as a neck injury, while further tests were to be carried out. "The circumstances surround-



Wicketkeeper-batter Rishabh Pant warned against taking Bangladesh lightly in the upcoming two-Test series, and stressed on the need for India to keep improving themselves to stay ahead of the competition.

Bangladesh, who recently blanked Pakistan 2-0 at Rawalpindi, will face Rohit Sharma's side in the first Test at Chennai from September 19 before moving to Kanpur.

India will play a total of 10 Tests within the next five months as the series against Bangladesh will be followed by three Tests against New Zealand at home in October-November before moving to Australia for the five-Test Border-Gavaskar Trophy. "Asian countries like Pakistan, Bangladesh, and Sri Lanka perform well in Asian conditions because they are accustomed to the wickets," Pant told Jio Cinema.

"As the Indian cricket team, we focus solely on our own standards and how we can improve. Regardless of the opposition, we strive to play with the same intensity and give our 100 percent every sin-

gle day," he said.
Pant said no series can be taken lightly with the margins between the teams decreasing in international cricket. "Pressure will always be there because in international cricket, you can't take any series lightly. The margin between winning and losing is very small, and nowadays, the gap between international teams isn't much either," he said. Pant said playing in the

Duleep Trophy ahead of a long season of Test cricket will give the players quality match practice while young cricketers at domestic level will benefit from the presence of international stars. The opening round Duleep matches got underway here at the M Chinnaswamy Stadium and at Anantapur on Thursday.

"It is very important for us to play domestic cricket because as a cricketer, match practice is always very important," he said.

"Especially coming back to domestic cricket, the youngsters also learn a lot of things from us - they see you playing here even after playing international cricket. There is a lot to give back to domestic crick

"It also gives us the opportunity to share all the learning and experiences from international cricket with our colleagues, especially with the young players and newcomers; it gives them a huge boost since we all have reached here from playing domestic crick-

et," Pant added. Pant, who is playing for Team B in Duleep Trophy, said he was looking forward to getting back into domestic cricket as this is his first red-ball game after December 2022.
