Delhi deluged as incessant rains bring Delhi-NCR to a grinding halt

Incessant rain on Thursday brought the national Capital and adjoining areas including Noida, Ghaziabad and Gurugram to a screeching halt with severe water logging, potholes and breakdown of buses witnessed in several parts of the city amid the India Meteorological Department issuing an orange alert for the

An orange alert denotes heavy rainfall and also potential disruptions to rail, road and air transport. This is the second consecutive day when the commuters and daily office goers were stuck traffic jams and waterlogging in the Capital city. Besides torrential downpours since late night, the breakdown of buses on

major roads led to traffic jams during the morning and evening peak hours.

The ongoing metro construction works have also worsened the situation including disruptions in the Khanpur area. Traffic around Lutyens' Delhi was affected due to Prime Minister Narendra Modi's visit to the Asia-Pacific second Ministerial Conference on Civil Aviation in Pragati Maidan.

Some of the Resident Welfare Associations (RWAs) had to issue caution to the locals to be alert while moving out from the colonies. With the traffic situation becoming a regular menace, the Sainik Farms Welfare Association in south Delhi took to its social media groups to issue alerts and updates particularly the disruption due to metro work and rains in the area that has

Inappropriate to call UP Police trigger-happy, says DGP Kumar

Lucknow: Uttar Pradesh Director General of Police (DGP) Prashant Kumar on Thursday dismissed the allegations about the state police being "trigger-happy", asserting it adheres to strict guidelines and has not faced criticism constitutional bodies.

Kumar's remarks come in response to the recent encounter of Mangesh Yadav, an accused in the Rs 1.5-crore jewellery heist case of Sultanpur district. The has sparked encounter controversy with former chief minister Akhilesh Yadav accusing the BIP of staging fake encounters to target individuals on the basis of caste and religion.

The Samajwadi president had on Tuesday slammed the Uttar Pradesh government, saying statistics of encounters during the BJP rule are also statistics of the "injustice of illegal killings" and "injustice done against the PDA".

SC verdict on **Kejriwal bail** plea today

PNS NEW DELHI

The Supreme Court will deliver its verdict today on the plea filed by Aam Aadmi Party (AAP) convener and Delhi Chief Minister Arvind Kejriwal seeking bail and quashing of arrest by the Central Bureau of Investigation (CBI) in the Delhi Excise Policy case. As per the cause list of September 13 uploaded on the apex court website, a bench headed by Justice Surya Kant is slated to pronounce the verdict.

The bench, also comprising Justice Ujjal Bhuyan, had on September 5 reserved its verdict on the pleas. Kejriwal has filed two separate petitions challenging the denial of bail and against his arrest by the CBI in the corruption case filed by the central agency. Kejriwal was arrested by the CBI on June 26. Manish Sisodia, K Kavitha, Vijay Nair and several other accused in the excise policy scam case have been given bail by the courts.

AAP Rajya Sabha MP Raghav Chadha said they are "hopeful" and are waiting for the Supreme Court's decision on Delhi Chief Minister Arvind Kejriwal's bail. "We are very hopeful. We are waiting for tomorrow," Chadha told reporters.

PM at CJI's residence; **BJP** plays defensive

rime Minister Narendra D'ime Minister That I Modi's visit to the residence of Chief Justice of India (CJI) DY Chandrachud on Wednesday to attend 'Ganpati Puja' celebration has sparked a controversy with senior Supreme Court judges and some opposition leaders expressing concern over the event, the BJP and its ally hit out at the opposition parties on Thursday, calling their reactions "reckless" and said casting "baseless aspersions" on the highest court sets a dangerous precedent. The BIP reminded the Congress of the time when in 2009, former Prime Minister Manmohan Singh invited then CII, KG Balakrishnan, to attend an Iftaar party.

The video of Narendra Modi attending the Puja celebration alongside the CJI and his wife Kalpana Das has gone viral. In a video, Chandrachud and his wife Kalpana Das were seen welcoming Modi at their house. In a post on X, PM Modi shared his experience stating, "May Bhagwan Shri Ganesh bless us all with happiness, prosperity, and wonderful health".

Addressing a press conference at the BJP headquarters here, Lok Sabha MP and national spokesperson Sambit Patra hit back at the opposition and asked if the then Chief Justice of India (CJI) did not attend the Iftar party hosted by then Prime Minister Manmohan Singh.

They do not have any objection to the prime minister meeting the chief justice of India but Ganpati

Puja," he said and accused the Opposition leaders of indulging in politics. "I am surprised that if the prime minister meets the chief justice of India, you raise an objection. But when he (Rahul Gandhi) meets (US lawmaker) Illhan Omar, who is with Pok, in America, you have no objection," Patra added.

Sharing pictures of Singh in a candid laugh with Balakrishnan, BJP leader Shehzad Poonawalla, in an X post, wrote, "Judiciary is safe".
"PM Modi attends Ganesh Puja at current CJI House oh God Judiciary compromised," Ponawalla mocked the Congress in his post.

Ganpati Utsav is being celebrated and people visit each other's house... I don't have information whether the Prime Minister has visited

anyone's house," Shiv Sena (UBT) leader Sanjay Raut

Ganpati Utsav is being celebrated at several locations in Delhi and Maharashtra Sadan, he said. "However, the Prime Minister visited the CJI's residence. They performed 'aarti' together. We think that people will have doubts if guardians of the Constitution meet political leaders," Raut added.

In a post on X, senior lawyer Indira Jaising said the Chief Justice of India has compromised the separation of powers between the utive and the judi "Lost all confidence in the independence of the CJI. The SCBA (Supreme Court Bar Association) must condemn this publicly displayed compromise of Independence of the CJI from the executive," she said in her post. Shiv Sena Rajya Sabha MP Milind Deora also flayed the critics and said it's unfortunate to see "reckless commentary" on Prime Minister Modi's visit to the CJI's residence for

Ganapati Aarti. "When verdicts favour them, the opposition praises the Supreme Court's credibility, but when things don't go their way, they conveniently claim the judiciary is compromised," he charged in

a post on X. Casting such baseless aspersions on the highest court sets a dangerous precedent, he added. "This reckless attempt to undermine the credibility of the CJI by the opposition is not only irresponsible but also damaging to the institution's integrity. India's politics is taking an ugly turn," Deora said.

Militarisation of frontier a big issue with China, says EAM

PNS NEW DELHI

External Affairs Minister S Jaishankar has said roughly 75 per cent of the "disengagement problems" with China are sorted out but the bigger issue has been the increasing militarisation of the frontier. His remarks came in the backdrop of China trying to alter the LAC in May 2020 in Ladakh leading to a violent clash between the two armies in Galwan valley on June 15. Twenty Indian army personnel including the commanding officer were killed in the fight and more than 40 Chinese soldiers also

Elaborating upon the current situation regarding the lingering border row, Jaishankar also said the Galwan Valley clashes affected the "entirety" of India-China ties, asserting that one cannot have violence at the border and then say the rest of the relationship is insulated from it. He made these assertions during an interactive session at a think-tank in Geneva. The external affairs minister said negotiations between the two sides to find a

solution to the problem are underway. "Now those negotiations are going on. With tension persisting at the Line of Actual Control (LAC) in eastern would say roughly you can Ladakh for the last four say about 75 per cent of the disengagement problems are sorted out," he said at the Geneva Centre for Security Policy. "We still have some things to do," Jaishankar said, responding to a question. But there is a bigger issue that both of us have brought forces close up and in that sense, there is a militarisation of the border, he said.

The external affairs minister indicated that the relationship can improve if there is a resolution to the row. "We hope that if there is a solution to the disengagement and there is a return to peace and tranquility, then we can look at other possibilities," Jaishankar said.

The Indian and Chinese troops are locked in a standoff in certain friction points in eastern Ladakh even as the two sides completed disengagement from several areas following extensive diplomatic and military talks. India has been maintaining that its ties with China cannot be normal unless there is peace in the border areas. **Continued on Page 8**

Israeli soldier

killed near **West Bank**

24-year-old Indian-origin Alsraeli soldier from the Bnei Menashe community was killed in a vehicle-ramming attack close to the West Bank's Beit El settlement, community members said on Thursday. Staff Sergeant Geri Gideon Hanghal was a resident of Nof HaGalil and a soldier in the Kfir Brigade's Nahshon Battalion, the Israeli Army



Community members told PTI that they were "in shock at the news of the loss of a young life" on Wednesday near Asaf Junction. Footage from the scene of the attack showed a truck with a Palestinian licence plate veering off a busy highway and barrel full speed into an Israel Defence Forces (IDF) guard post adjacent to a bus stop before coming to a halt. The suspect was named by Israeli security sources as 58-year-old Hayil Dhaifallah, from the central West Bank town of Rafat. Sergeant Hanghal's funeral will be held on Thursday, they said.

Hanghal immigrated to Israel from the northeastern part of India in 2020. Some 300 Bnei Menashe youngsters are said to be doing Army duty during the current war, most of them serving in combat units. The Bnei Menashe, hailing from India's north-eastern states of Manipur and Mizoram, are believed to have descended from the Israelite tribe of Menasseh, one of the "lost tribes" of ancient times.

Veteran CPI(M) leader Sitaram Yechury breathes his last at AIIMS

The CPI (M) finds itself I orphaned by the unexpected demise of 72-year-old Sitaram Yechury, the general secretary of the party. It is not going to be an easy task for the comrades to find suitable replacement for Yechury, considered to be suave and quite accommodative in the Left parties. Even his rivals held him in esteem for his soft manners accessibility approachability.
The first time he was seen in an

embarrassing situation was during the Press meeting convened by the CPI(M) immediately after the 2016 Assembly Election in Kerala. Yechury, with an anguished look, announced that Pinarayi Vijayan would be the Chief Minister of the State. Though it was widely

believed that V S Achuthanandan would be appointed as chief minister, the bigwigs in the party including the proprietor of a publishing house in Chennai had other ideas and they ensured the coronation of Vijayan.

Yechury, who was highly critical of Vijayan's crony capitalist friends, wanted the mantle to be given to VS while others chose Vijayan. As a disciplined comrade, Yechury had no other option and he never forgot his crestfallen face during the presser.
Though highly critical of the NDA

Government at the Center, Yechury was open in private conversations about the good things done by the Vajpayee government (1998-2004).

When India conducted a nuclear explosion at Pokhran in May 1998 there was an uproar in the USA,



Pakistan and China. The US even blacklisted India from dual technology deals and Indian scientists were denied permission to attend any international conferences on science and

Yechury, who was then a politburo member visited Chennai to address a Press meeting. "Pakistan assembled and exploded a nuclear bomb in such a short time only

because of India. There was no

need for India to conduct an

experiment at this juncture," said Yechury. He was adamant in his stance that India was responsible for Pakistan going nuclear soon after India did it.

After the Press meeting, this writer got the opportunity for a tete-a-tete with Yechury when he was asked how a country (Pakistan) could assemble a nuclear bomb within 10 days. A smiling Yechury quipped: "Yaar, these are all to score some brownie points. You just report what I told in the press meet."

During his younger days, Yechury was the superstar of the CPI(M). He was at ease while dealing with political leaders including rivals which had earned him the reputation that "Sitaram is always

at a different level". Even RSS leaders, the only pronounced enemies of the

CPI(M) held Sitaram Yechury in high regard. Yechury, hailing from Telangana remained a popular politician in Tamil Nadu.

Yechury's major achievement is the research paper "Oil Pool Deficit or Cesspool of Deceit" published in 1997 in which he questioned the propriety of the government hiking petroleum prices regularly citing the oil pool deficit account.

With his demise, what the CPI(M) has lost is the best bridge between the party and the intellectuals as well as the common man. Yechury surpassed all his predecessors in his dealings with the public through his man next door image. He was tasked with selling an outdated ideology to the new generation which was impossible in this era.

Youth killed for 'family honour'

 $T^{\text{ension prevailed in Pasin}}_{\text{Dhakwa village in Sushant}}$ Golf City police station area after a vouth was beaten to death over a row over a girl on Wednesday night.

The slain youth was accused of eloping with the girl and was jailed for it. He had come out of jail on bail four days ago. The girl had been recovered four days after she was reported missing.

A heavy police force is camping in the village and the cops are keeping a close watch on every minute detail. The situation is said to be tense but under control.

Deputy Commissioner of Police (South) Keshav Kumar said the police force was deployed in the village around 8 pm immediately after the news of the youth's murder reached them. He said the situation was under control.

As per reports, Amit Kumar of Pasin Dhakwa, a Pasi community dominated village in Sushant Golf City police area, was attacked with an axe and sticks around 7-8 pm on Wednesday and he was fatally injured. Ámit was attacked, allegedly by the family members of a girl whom he loved and for whose love he had served a jail term following a brawl over the issue.

On the fateful day he had gone to meet the girl. The girl's brothers are suspected to have murdered him.

After the incident, all four brothers of the girl absconded. The police have taken the girl into custody and she is being

Retired S-I's son shot at in fight for supremacy

Lucknow (PNS): In a daring incident, the son of a retired police sub-inspector was shot at in a fight for supremacy in Gomti Nagar on Wednesday night, exposing the tall claims of police over night patrolling. The injured youth is said to have a criminal past and is a historysheeter in Lucknow.

Identified as Dhananjay Singh,

the youth sustained gunshot injuries in his leg and is admitted in the SPM (Čivil) Hospital. His arch rival, Avinash Singh alias Sinku, has been named as the main assailant and the police have launched a search for him. Dhananjay was shot at when he was sitting in a car outside his house in Gomti Nagar late Wednesday night. The bullet hit his right leg. Dhananjay's friend was also present with him at the time of the attack. The victim's father is a retired sub-inspector. According to the police, retired sub-inspector Ram Sahodar lives with his family in Vipul Khand of Gomti Nagar. On Wednesday night, his son Dhananjay was sitting in the car outside the house with his friend Rahul when five unknown youths suddenly attacked him. The assailants opened fire at

It surfaced that Rahul had gone to meet Dhananjay at the latter's house and both were talking while sitting in Rahul's luxury car. Suddenly, 4-5 people came with sticks and country-made pistols and fired three shots at Rahul and Dhananjay. While Dhananjay Singh was hit by a bullet, Rahul had a narrow escape. However, when Rahul tried to run away, the assailants caught him and attacked him with the butt of the gun, injuring him also. The injured youth's family alleged that 2-3 days ago, one Avinash Singh alias Sinku had threatened to kill Rahul and Dhananjay.

Amit reached there, her brothers Shatruhan, Man Bharan, Ravi and Ramashankar also reached there, all armed with an axe and sticks. Amit's grandfather Chhotelal

alleged that in the presence of the girl, her four brothers attacked Amit, causing a deep cut in his neck with an axe. When he was injured, they beat him brutally with sticks. When he fell down bleeding, the assailants took him for dead and fled the scene.

After getting information from the villagers, the victim's family members rushed to the spot and took the injured Amit to a nearby private hospital, where the doctors pronounced him dead.

As the news of Amit's death reached the village, the locals split into rival camps, ready to attack each other. On getting information, a police force from Sushant Golf City police station rushed to the village and prevented a clash. The police also sent the body for postmortem.

Amit's grandfather alleged that the girl had conspired with her brothers to get Amit killed. The police have registered a murder case against the girl and her brothers on Chhotelal's complaint and are looking for the absconding brothers.

The girl reportedly told the police that she killed Amit and not her brothers. The police suspect she has owned up the murder to save her brothers.

The girl told the police that Amit used to harass her so she called him and killed him by hitting him with an axe.

50-year-old woman attacked by wild animal in Bahraich Forest dept asserts not a wolf attack

PNS LUCKNOW

50-year-old woman was Aattacked, allegedly by a wolf, at Kureanpurwa in Bahraich district on Wednesday night. Forest officials however maintained that it was not a wolf attack.

The woman was sleeping outside when she was attacked by the animal and she bore injury marks on her neck. She was taken to hospital where she was given necessary treatment and is now out of dan-

ger. Divisional Forest Officer (Bahraich) Ajeet Singh said that it could be an attack by any other animal but not a wolf. The DFO said that he personally visited the area after receiving the information about the attack but found no pug marks of the wolf. "The land was wet because of the rains but we still could not find

any pug mark of the wolf. Parallel to the attacks of the wolves there have been attacks by the jackals, causing injuries to the villagers. Experts also pointed out that the injury was not caused by a wolf but by some other animal," he said. The DFO said that the presence of pug marks were the only conclusive evidence of attack by wolf but they were

not found in this case. He said one wolf was left to be captured and all efforts were being made to catch it by the Forest department.

The DFO said that the wolf was sighted at Sissaya village on Thursday but it became difficult to capture it as it was raining. "It ran through the sugarcane fields which were filled with water. Because of the rains we had to stop flying the drones and we followed its pug marks till they were visible. These are the problems the situation after days," he added.

With nine killed and more

than 40 injured, the Forest department has launched Operation Bhediya in Bahraich district and has been successful in capturing five wolves.

Pathak said that the teams were monitoring the crucial areas. "We are using camera traps, thermal drones and traditional methods of tracking. The public is also being made aware. We will again review the situation after four to five

Experts debunk myths around wolves

Bahraich: Wolves are "shy" pack animals showing empathy towards their kind, say wildlife experts while stressing the need for conserving the species on the brink of extinction amid a spate of attacks in Bahraich and the Uttar Pradesh government ordering to shoot the animals, if necessary. In Bahraich's Mahsi tehsil, 10 people, including nine children, have been killed in these attacks since March and around three dozen people have been left injured in human-wildlife conflicts in the area with the government declaring it as a "wildlife disaster".

Sanjai Pathak, an Indian Forest Service officer leading Operation Bhediya in Bahraich and former Field Director of Dudhwa National Park, addressed common misconceptions about wolves and their behaviour. He criticised the negative portrayal of wolves, saying, "Humans view wolves with great prejudice. For instance, the main accused in the Kolkata rape case is referred to as a 'hungry wolf'. However, wolves are generally shy and social creatures."

He points out that wolves are monogamous, mating exclusively with the same partner and

respecting older pack members.
Pathak further stresses the significance of

wolves' communication through pheromones which are chemical messengers released into the air by animals. "Wolves have a more acute sense of smell and perception compared to other animals and humans," he says, as most modern dogs have ancestry from wolves. Wolves also hold cultural significance in parts

of India, for instance in Bihar people worship wolf dens and it is a tradition for newlyweds to visit and offer prayers near these dens, he said.

A senior scientist and wolf expert from the Wildlife Institute of India (WII) in Dehradun, Dr. Shaheer Khan says wolves are "group-living social animals." He detailed the two types of wolves found in India: 'Canis lupus chanko' in the mountainous regions and 'Canis lupus pallipes' in the Terai regions like Bahraich. "These animals live in packs led by an alpha pair that raises offspring and cares for older wolves who can no longer hunt," Khan said, adding that the alpha pair hunts for the pack, feeding the elders first before eating with the young ones. "Once the pups mature, they leave the pack to form new pairs in different territories. Siblings do not mate pairs in different territories. Sionings are with each other," Khan said highlighting the PTI

Thyroid cancer cases are also rising in Lucknow, she added. "This troubling statistic points to a growing need for awareness. early detection, and effective treatment strategies. Thyroid cancer is more prevalent among females, who account for a larger proportion of the cases. The high incidence of thyroid cancer could be attributed to the widespread prevalence of goitre in many parts of the country,"

Dr Rana said. Goitre, an enlargement of the thyroid gland, often results from iodine deficiency. In some cases, this condition may progress to thyroid cancer, particularly in regions where goitre is endemic.

This correlation suggests that inadequate iodine intake and thyroid dysfunction could be contributing factors to the rising number of thyroid cancer cases. Many a time people neglect it thinking it to be a simple goitre and start taking medicines of Ayurveda and it keeps on increasing and thus the cancer is missed. This is something which can only be treate through surgery, she added. Dr Rana said that because of fine

radiological techniques available more cases were being detected which also accounted for the increase in the number of cases. Notably, she said that a significant proportion of Indian patients had advanced-stage disease or aggressive forms of thyroid cancer, such as anaplastic thyroid carcinoma.

'This is in stark contrast to the western world, where early detection and intervention have improved outcomes. The higher stage at diagnosis and prevalence of poor prognosis types of thyroid cancer in India may be linked to limited access to healthcare facilities, lack of awareness, and delayed diagnosis. Whenever a person has

swelling in the neck they should approach a pathologist to know whether the swelling is cancerous or non-cancerous," she added. Dr Rana said that she was cur-

rently conducting a study on the role of molecular mutations and the immune landscape in thyroid cancer. "Our research has identified

several common mutations associated with thyroid cancer in India, including BRAF, TERT, P53, and RAS. These mutations play a crucial role in the development and progression of the disease," she said.

Interestingly, thyroid cancers harbouring more than one of these mutations tend to have a poorer prognosis and outcome. She said that with the advent of immunotherapy, there was new hope for patients with advanced cancer.

thvroid "Immunotherapy, which harnesses the body's immune system to fight cancer cells, has shown promising results in other cancers and is now being explored as a potential treatment for thyroid cancer," she said. Dr Rana said that she and her research team were actively analysing various immune markers that could help surgeons and oncologists tailor treatment plans to individual patients. "Our goal is to identify mark-

ers that can predict a patient's response to immunotherapy, which will allow for more personalised and effective treatment strategies," Dr. Rana

"By understanding the molec-ular and immune landscape of thyroid cancer in Indian patients, we hope to improve prognosis and survival rates." Dr Rana is currently a part of the Asian thyroid working group and is actively involved in international collaboration with many renowned researchers across the world," she added. The ongoing research in India is crucial for developing targeted therapies that address the specific genetic and molecular profiles of thyroid cancer patients in the country. With increased awareness, better diagnostic tools, and advancements in treatment options, there is hope for improved outcomes for those affected by

Heritage corridor work under Smart City to be finished by December

Lucknow (PNS): The development of Heritage corridor, under Smart City projects, which extends from the Kaiserbagh rotary to Chotta Imambara will be completed by December this

A senior official said the project aimed to develop the route in one pattern and design so that it could be highlighted as a heritage part of the state capital.

The Rs 25-crore project is being implemented by the Lucknow Development Authority.

He said that the corridor will extend from Kaiserbagh rotary to Amir-ud-daula Library, Raja Rampal Park, Bhatkhande University, Parivartan Chowk, Globe Park, Tikona Park, Bada Imambara and Chhota Imambara. "The corridor has several components under which work is being carried out and approximately 70-80 per cent of the work has been completed," he added.

The Globe Park, which forms a part of the corridor, will be redesigned and lighting and fountains will be restored with a walkway through the park.

Sale of 'sub-standard' namkeens: HC seeks govt's response

Prayagraj (PTI(): The Allahabad High Court has directed the principal secretary, food and civil supplies department of Uttar Pradesh, to file an affidavit on the steps taken to check the sale of "sub-standard" 'namkeens' (savoury snacks) for the consumption of human beings. The high court also directed its registry to implead the central gov-

Rare surgery performed at Lohia Institute organs complicates the tradi-

Lucknow (PNS): The doctors of the Surgery Department of Dr Ram Manohar Lohia Institute of Medical Sciences performed an unprecedented surgery.

A 36-year-old woman, Kiran Yaday, a resident of Hardoi, was suffering from pain in the left side of her abdomen for a long time and despite seeking treat-ment at many places she did not get any relief.

"She ultimately consulted Professor Vikas Singh in the Surgery Department of Dr. Ram Manohar Lohia Institute of Medical Sciences. After examining the patient it was found that the patient had her gall bladder on the left side of the stomach in which stones were formed. Normally, the gallbladder is located below the liver on the right side of the stomach. In the patient, all organs normally found on the left were found on the right side and all the organs found on the right were found on the left side. This was confirmed by getting a CT scan done. This condition, known as 'Situs Inversus Totalis', occurs in one out of 10,000 people globally. "This changed position of

tional established surgical methods," said a senior doctor. Considering the age of the patient, Dr Vikas Singh performed the surgery through the navel using traditional telescope instruments. "It was decided to operate through only one incision, as a result of which no scars remain on the patient's stomach," said the doctor.

Professor Singh displayed special skills in operating through a single hole using traditional telescope instruments. After the operation, which lasted about an hour, the patient was completely healthy.

'Till now in the world of medical science, only 3-4 cases of gall bladder operations have been done through a single incision by telescope method in situs inversus totalis condition which have been reported. This in itself gives a special place to this surgery," said the senior doctor.

This operation was done by Dr Harendra Pankaj, Dr Samaya Bajpai, Dr Priyanshi Swaroop and Dr Paval Chaudhary under the leadership of Dr Vikas

CM announces phase-wise **expansion of Atal schools**

Chief Minister Yogi Adityanath, on Thursday, inaugurated the 2024-25 academic session of all 18 Atal Residential Schools in the state at a ceremony held at the Atal Residential School in Mohanlalganj.

During the event, Chief Minister Yogi announced a phase-wise plan to expand the schools, aiming to increase their number to 2,000.

According to him, in the second phase, 57 similar schools will be established as composite schools across various districts, while the third phase will extend this initiative to all 350 tehsils of Uttar Pradesh. In the fourth phase, such schools will be set up in 825 development blocks, and by the fifth phase, they will reach the nyaya panchayat level.

Ultimately, 2,000 such schools will be run across the state, providing quality education to children. In addition, Chief Minister Yogi announced that the 57 new schools would cater to students from classes 1 to 12 and include Bal Vatikas.

During the ceremony, Chief Minister Yogi distributed school bags and textbooks to students entering classes 6 and 9. He also awarded prizes and certificates to the top three students from class 6 in the 2023-24 academic session. The chief minister also gave awards to Vigyan Ratna and students leading in sports and other activities. The students impressed Chief Minister Yogi with their welcome performances, including dance routines. In his address, Chief Minister Yogi stated: "Respected Atalji often said that no force in the world could prevent a society that successfully combats illiteracy and deprivation from becoming secure and prosperous. He considered illiteracy and scarcity to be society's greatest enemies."

Yogi added: "Scarcity arises from poverty, idleness, anarchy, corruption and division. Where there is corruption and anarchy. there will also be disorder, lawlessness, an unsafe environment

and a lack of respect for anyone. Moreover, when society lacks proper leadership, illiteracy spreads rapidly and a significant portion of the population falls victim to it. This leads to widespread poverty, hunger and deprivation. With his vast life experience, revered Atalii expressed these insights through his words and poetry. When he had the opportunity to lead the

government, he implemented a comprehensive action plan to tackle these deep-rooted issues at their core." Maya tries to regain lost ground through 'booklet' Blames Akhilesh for failure of SP-BSP alliance

Bahujan Samaj Party chief Mayawati alleged that the 2019 alliance with the Samajwadi Party failed because Akhilesh Yadav stopped receiving her phone calls following the alliance's dismal result in the general elections.

She made this remark in a booklet of the party that was distributed amongst the cadre. Samajwadi Party chief Akhilesh Yadav hit back on Thursday, saying no one had any clue that the alliance was coming apart and that he had dialed the BSP chief to know why the tie-up ended. In the 2019 Lok Sabha polls, the Bharatiya Janata Party and its allies won 64 out of 80 Lok Sabha seats in Uttar Pradesh while the BSP-SP combine could manage just 15 seats. The Congress won only one seat. However, in 2024, the SP ioined hands with the Congress and the combine won 43 Lok Sabha seats in UP. The BJP won 33 seats while the BSP drew a

blank. The BSP's initiative to connect with the party cadre by distributing the 59-page booklet is seen as an effort to regain its lost political ground in UP after a series of electoral setbacks. In the booklet, Mayawati says, "The SP-BSP pact in the 2019 Lok Sabha polls was aimed at checking the BJP from coming to power at the Centre."

However, SP chief Akhilesh Yadav was so dejected with the results of the elections in which



BSP won 10 seats and the SP five that he stopped taking calls from BSP chief and other senior leaders. Thus a decision was made to sever ties with the SP without compromising one's self-respect," the booklet states. The claim, however, was met with an instant rebuttal from At a press conference in

Lucknow on Thursday, the Samajwadi Party chief said, "When the alliance was called off, I was addressing a rally in Azamgarh and both SP and BSP cadres were present there. None had a clue that the alliance was coming apart." "I had myself dialed (BSP chief) to ask why the alliance was coming unstuck. I needed a response to prepare myself for media queries after the rally," he said. Akhilesh Yadav added that at times some things are said to divert people's attention. Yadav was Samajwadi Party's

top leader. "After surviving the murder attempt, the BSP went on to form its first government with the help of anti-Samajwadi Parties. The BSP continued to maintain distance from the SP after that. But when Akhilesh Yadav approached with an alliance offer, the two parties entered into a pre-poll pact," Mayawati said in the booklet. BSP's state chief Vishwanath Pal said the idea behind distributing the booklet among the cadre was to make them and the supporters understand the

party's line and policy. In the 59-page booklet, Mayawati has also targeted Rahul Gandhi by calling his stay at a shoe repair shop as politics. She told her Dalit community about this entire incident and why should only people of a particular caste do the work of shoe making and repairing on the basis of their birth. She has also said big things for Brahmins in this booklet and tried to connect them through her social engineering. Through this booklet, Mayawati has said

that there is no uplift of Brahmins in any way in SP, Congress and BJP. BSP has once again taken the help of the booklet to bet strongly on Brahmins as per its political strategy. Through this booklet, Mayawati has also polished her strict image very well. People have also been made to realise through the booklet that Mayawati will uplift the society by following the path shown by Baba Saheb Bhimrao Ambedkar. Mayawati has been addressed as 'Iron Lady' in this booklet. And there is mention of the uplift of bahujan samaj from getting the master key of power under the leadership of the 'Iron Lady'.



SC displeased with Punjab, Haryana HC inaction on judicial officer's reinstatement

m he}$ Supreme Court has expressed displeasure over the Punjab and Haryana High Court's decision of not reinstating a judicial officer, sacked for an alleged affair with a lady judicial officer, despite the top court setting aside his termination letter in 2022 nation letter in 2022.

The issue has been between the high court and the apex court since 2009.

A bench of Justice Vikram Nath and Justice P B Varale, in its recent order, noted that the apex court on April 20, 2022, set aside the high court's October 25, 2018, order dismissing the male judicial officer's plea against his termination from service.

It had directed the full court of the high court to reconsider its decision of sacking the judicial officer.

The Supreme Court had also noted that on October 26, 2018, the same division bench of the high court allowed the petition of the lady judicial officer and set aside the termination order, after disbelieving the allegations of an illicit relationship.

"Once the termination order is set aside (by SC in 2022) and the judgement of the high court dismissing the writ petition challenging the said ter-mination order has also been



set aside, the natural consequence is that the employee should be taken back in service and thereafter proceeded with as per the directions," the top court bench said recently. The apex court bench said

that once the termination order is set aside then the employee is deemed to be in service. "We find no justification in the inaction of the high court and also the state in not taking back the appellant (judicial officer) into service after the order

dated April 20, 2022. "No decision was taken either by the high court or by the state of taking back the appellant into service and no decision was made regarding the back wages from the date the termination order had been passed till the date of reinstatement which should be the

Niti Aayog suggests Public Health Emergency **Management Act for future pandemics**

With Covid-19 pandemic exposing significant gaps in global health preparedness, a report by Niti Aayog expert group has underscored the need for responding in the first 100 days of an outbreak and suggested enacting separate legislation to handle public health crises if any in future. The report, "Future Pandemic Preparedness and Emergency Response - A Framework for Action," proposes the creation of a Public Health Emergency Management Act (PHEMA), which would facilitate a holistic approach to health management, covering prevention, control, and disaster response. The report which provides a blueprint for the country to prepare for any future public health emergency or pandem-



ic and have a rapid response system comes amid WHO warning to tackle the unknown deadly Disease X, which could be 20 times deadlier than COVID-19'.

Led by Dr. Renu Swarup, with members including Dr. Soumya Swaminathan and Dr. Sujeet Singh, the expert group's proposals aim to better equip India and the global community for future pandemics and

health emergencies. "It will allow a holistic approach to health management, covering prevention, control, and disaster response, the report added. "The Act would also provide for the creation of skilled public health cadres at national and state levels," said the report which also outlines recommendations for establishing a dedicated Pandemic Preparedness and

Emergency Response (PPER) fund and creating institutionalised and empowered governance mechanisms.

'The report highlights the need for a well-structured scorecard mechanism to regularly monitor progress on key preparedness targets, especially in light of WHO warnings about potential new zoonotic outbreaks. As countries and international organizations work to enhance their readiness for novel pathogens, the WHO has identified approximately 30 viral and bacterial families with potential epidemic or pandemic risk.

These targets necessitate focused research, development of advanced diagnostic techniques, and effective countermeasures. The report's recommendations align with global efforts to bolster pandemic preparedness and response

Entod Pharmaceuticals to challenge suspension of PresVu

product through media. Nikkhil K Masurkar, CEO of the pharma firm, in a press statement said that this action is against a pharma company in the MSME sector, which is purely research and innovation driven and attempts to bring new therapeutic options to the Indian market.



"As a result, we have decided to challenge this suspension in the court of law to get justice," said Masurkar.

'Our fight will not only allow innovative medicines to be available in India but also encourage other pharmaceutical entrepreneurs and companies in the MSME sector to continue the research drive in India without facing similar obstacles," he said.

The company also said that it has not made any unethical or false presentation of facts to the media or public when it comes to PresVu eye drops. All facts disclosed to the media were strictly on the basis of the recent approval by the Drugs Controller General (India) for

treatment of presbyopia in adults and the results of the phase 3 clinical trial conducted by us in India.

"Announcing the new product launch to the media is a routine industry practice followed by all pharma companies in India and in the recent past, many such announcements have been made. In our case, media reports went viral and public imagination led to an unusual escalation for which Entod Pharmaceuticals is not responsible," he said.

The Union Cabinet extends Ayushman Bharat to senior citizens Above 70; a move that would benefit six crore people

n a significant move the Union Cabinet has approved the extension of the Ayushman Bharat health insurance scheme to all citizens above 70 years of age, regardless of their income or social standing. The Cabinet's decision fulfils a key promise made by Prime Minister Narendra Modi during the 2024 Lok Sabha election campaign. This move is expected to transform healthcare for senior citizens, providing much-needed relief to millions who have been struggling with rising medical costs and insufficient insurance coverage. Since its launch over five years ago, Ayushman Bharat has provided healthcare access to millions across India, covering hospitalisations and treatments for families that otherwise couldn't afford medical care. However, data has shown that nearly every fourth person admitted to hospitals under this scheme has been a senior citizen, highlighting their disproportionate need for medical support. Out of over one crore admissions, 24% were of citizens aged 60 and above, demonstrating how



essential this safety net is for the elderly. The latest decision to extend coverage to all citizens over 70 is particularly significant as this age group is often neglected by private insurers. Most health insurance companies either refuse to offer policies to those above 70 or charge prohibitively high premiums. Even when insurance is available, pre-existing conditions are often excluded for the first two to three years, leaving many senior citizens without immediate access to treatment for serious ailments like heart disease, kidney issues, and diabetes. With the new policy, six crore people over 70 years of age are expected to benefit, receiving health insurance coverage up

to Rs 5 lakh per year. This applies on a family basis, ensuring that elderly individuals, even those abandoned by families or facing financial hardships, can now access free or affordable medical care. The extension of Ayushman Bharat to all citizens above 70 comes at a critical time. Procedures like dialysis, heart surgeries, and cancer treatments are not only expensive but also frequent among senior citizens. The new policy provides a safety net for seniors who have, until now, been forced to bear these expenses themselves or rely on insufficient public health programs. Rs 5 lakh coverage under Ayushman Bharat will lift much of this financial burden, enabling families to access quality healthcare without worrying about their savings. Apart from the direct medical benefits, this policy could have far-reaching social implications. India's senior citizens, especially those in rural or economically disadvantaged areas, often face neglect and abandonment when they become ill. This policy not only promises improved healthcare outcomes but also offers dignity and security to millions of older Indians at a time when they need it most. As this initiative rolls out, its impact on families, communities, and the healthcare system at large will likely be profound, marking a significant leap toward inclusive and accessible healthcare for all.

Resignation shakes Trinamool Congress SIDHARTH MISHRA

rinamool Congress Member of Rajya Sabha and former Chairman of Prasar Bharati Jawahar Sircar has resigned both from parliament and the party. Sircar tendered resignation to protest the 'mishandling' of the traineedoctor rape-cum-murder case at RG Kar Medical in Kolkata. The resignation is significant as Sircar is part of 'Kolkata Bhahdralok' which has so far remained steadfast in its support of West Bengal chief minister Mamata Banerjee. The move also indicates that the West Bengal assembly passing a 'very stringent anti-rape law' bill has not cut much ice with the people, who so far have resisted condoning the errors committed by the Mamata government in the mat-

The West Bengal bill, which has now been referred by the Governor to the President, has also not found much echo outside the state. The Aparajita Woman and Child (West Bengal Criminal Laws Amendment) Bill, 2024, passed by the West Bengal Assembly is not the first of its kind. In the past five years, Andhra Pradesh (Disha) and Maharashtra (Shakti) passed similar bills with a death penalty clause against the rapists but they are still to bring any change in the matter. All these bills were preceded by Criminal Law (Amendment) Act, 2013 through which Capital Punishment for rape made its entry into the Indian Penal

This followed the public outrage after the brutal gang rape and murder of a woman on a moving bus in Delhi on December 16, 2012, which shook the collective conscience of the nation. Parliament passed the Criminal Law (Amendment) Act, 2013 to allow the death penalty in rape cases where the accompanying orutality leads to death or leaves the victim in a persistent vegetative state. Whatever name you may give Aparajita, Disha or Shakti, these bills are meaningless as long as cases about rape remain pending in the courts for years together. In 2022, com-



bined with those brought in the previous years, courts had around 2 lakh cases for trial. However, trials could be completed in only a little over 18,000 cases, which was less than the number of incidents as well as police charge sheets filed that year. Finally, the conviction rate of 27.4% in rape cases means seven out of every 10 accused persons were acquitted. So just making the laws doesn't help. Speaking at a function some months back, Chief Justice of India DY Chandrachud had quoted BR Ambedkar saying, "However bad a Constitution may be, it may turn out to be good if those responsible for its functioning happen to be a good lot."Maker of the Constitution in the concluding speech before the Constituent Assembly had said, "However good a Constitution may be, it is sure to turn out bad because those who are called to work it, happen to be a bad lot. The rules have been there but not much work has been done beyond the customary launching of the programme with much fanfare. However,

decided to implement the programme in mission mode. and 20 Pink Booths exclusively manned by female police personnel were established in September 2023.

A year later the results were for all to see. The mere presence of a force for women's safety had its impact. According to the data released by Crime and Criminal Tracking Network & Systems of Uttar Pradesh Police, crime against women which included dowry deaths, dowry-related cases, molestation, rape and kidnapping came down by approximately 24 per cent. The biggest fall of over 36 per cent was in dowry deaths thus at least securing women inside their homes. If such an initiative by Ghaziabad Police can achieve such results one is sure at the state government level such steps can be taken more effectively. One is not sure how effectively have these pink police outposts been functioning in West Bengal, where the government has just brought a more stringent anti-rape law. (Sidharth Mishra is the author

DIPLOMATIC BOOST TO SEMICONDUCTORS

India and Singapore are building a resilient semiconductor supply chain

omestic politics may be a key issue for the ruling NDA alliance, however, it has not taken away Prime Minister Narendra Modi's focus on constantly working on fine-tuning India's foreign policy. PM Modi recently was in Brunei a first for any Indian Prime Minister on a bilateral state visit, to a country located strategically in the South China Sea.Brunei's visit was topped by the PM's visit to Singapore, an important technology ally for India in the region. India and Singapore will be entering into the 60th year of diplomatic relationship next year and both countries have decided to upgrade their existing bilateral partnership to a Comprehensive strategic partnership, which would in turn expand the areas of cooperation.

One of the key focus, during PM Modi's visit to Singapore was expanding the digital cooperation between the countries. The joint statement released read "Both Prime Ministers welcomed the signing of the MoU on cooperation in the field of Digital Technologies and affirmed common interests in data, Al and cybersecurity. Building on this, both Prime Ministers agreed to deepen collaboration in the digital space, including in facilitating trusted cross-border data flows, cybersecurity, and the interoperability of digital systems." A crucial element of the partnership was a demonstration under the trade trust framework. Singapore is home to many large Technology companies, many of whom have regional headquarters in the island state, with the business geography, spread all across Asia primarily India



Advance technology manufacturing and semiconductors formed another crucial element of the PM's visit. The statement read "Both Prime Ministers agreed to explore cooperation in the area of critical and emerging technologies. Both Prime Ministers agreed that advanced manufacturing, particularly in developing resilient semiconductor supply chains, can be a new pillar of bilateral cooperation.

Both Prime Ministers welcomed the signing of the MoU on the India-Singapore Semiconductor Ecosystem Partnership. Immediately after the PIVI visited Singapore the US government also announced a new partnership with India to explore supply chain opportunities in India. Funded under the International Technology Security and Innovation (ITSI) Fund, created by the CHIPS Act of 2022 (CHIPS Act) of the US, it allows the department to spend some money on developing a trusted supply chain ecosystem with partners and allies. A US State Department press release read, "The initial phase includes a comprehensive assessment of India's existing semiconductor ecosystem and regulatory framework, as well as workforce and infrastructure needs. The state anticipates that key Indian stakeholders, such as state governments, educational institutions, research centres, and private companies, will participate in this analysis steered by the India Semiconductor Mission. The insights gained from the assessment will serve as the basis for potential future joint initiatives to strengthen and grow this critical sector. The United States and India are key partners in ensuring the global semiconductor supply chain keeps pace with the global digital transformation currently underway. Manufacturing of essential products ranging from vehicles to medical devices relies on the strength and resilience of the semiconductor supply chain."

This week India also hosted SEMICON a global conference that attracts investments in the Indian semiconductor ecosystem. India is trying to attract investments for a crucial component of most modern equipment and machinery called chips. The recent visits by the PM to Singapore and the Memorandum of Understanding with the US may provide the much-needed kickstart for India's semiconductor ecosystem.

India's Paralympic journey of resilience and triumph



Through sheer determination and perseverance, para athletes have steadily overcome the odds, earning global recognition and bringing glory to the nation



he Paris Paralympics unfolded as a captivating display of athletic excellence, particularly for the Indian contingent. It was a spectacle, with each athlete embodying a harmonious blend of strength, determination, and skill – almost like poetry in motion. As an avid follower, I found myself engrossed in nearly every performance, regardless of the challenging (IST) time difference that saw events commence under the glowing silhouette of the Eiffel Tower. On the rare occasions when I could not watch live, social media provided timely updates, fuelling my enthusiasm and admiration for these remarkable ath-

Their tenacity and commitment to realizing their dreams on the global stage were evident as they competed and excelled across multiple disciplines, leaving an indelible mark on the world of sports. India delivered its best-ever performance at the Paris 2024 Paralympic Games, achieving a historic 29-medal haul that included seven gold, nine silver, and 13 bronze medals. This outstanding achievement surpassed the 19medal tally from Tokyo 2020, where India had won five golds, and marked a significant milestone as the country crossed the 50-medal mark in its Paralympic history. A record 84 para-athletes represented India across 12 disciplines, including the debut participation in para-cycling, para-rowing, and blind judo. Among the shining stars, Avani Lekhara became the first Indian woman to win two golds at the Paralympic Games, defending her title in the women's 10m air rifle standing SH1 shooting event with a world-record score. Meanwhile, India saw its first-ever one-two finish in athletics, with Dharambir and Parnav Soorma clinching gold and silver in the men's club throw F51 event. Dharambir also set a new Asian record of 34.92m.In athletics, several Indian para-athletes etched their names in the record books.

Praveen Kumar set an Asian record en route to winning the high jump T64 title, securing India's sixth gold medal — their highest total at the Paralympics. Javelin thrower Sumit Antil made history as the first Indian man to defend his Paralympic title, winning gold in the men's javelin throw F64 with a stunning throw of 70.59m, breaking his record from Tokyo 2020 not once but

times. Mariyappan Thangavelu, with a bronze in the high jump T42 class, became the first Indian to win medals at three consecutive Paralympic Games, having previously won gold at Rio 2016 and silver at Tokyo 2020. Preethi Pal secured India's first-ever medal in a track event at the Paralympics with a bronze in the women's 100m T35 race and won another bronze in the 200m, becoming India's most successful athlete at the Games with two medals. The track events also saw Deepthi Jeevanji become the first intellectually impaired Indian athlete to win a Paralympic medal with a bronze in the women's 400m T20 class.India's achievements extended beyond the track and field to other disciplines. In archery, armless archer Sheetal Devi briefly set a world record in the ranking round and later teamed up with Rakesh Kumar to achieve a world record score in the compound mixed team qualification event. It was a perfect example of poetry in

At just 17, Sheetal made history as India's youngest Paralympic medallist by winning a bronze in the mixed team event. Moreover, India's dominance in archery was further confirmed when Harvinder Singh became the country's first-ever Paralympic archery champion. The outstanding performances by Indian para-athletes at the Paris 2024 Paralympic Games underscored India's emergence as a formidable contender on the global stage. Originating in 1948 with a sports event for World War II veterans with spinal injuries, organized by Sir Ludwig Guttmann in Stoke Mandeville, England, the Paralympics evolved into an international event in 1960 in Rome with 400 athletes from 23 countries. Since then, the Games have grown significantly, challenging stereotypes and promoting inclusivity, while celebrating the exceptional talents and resilience of athletes

with disabilities. India began its Paralympic journey in 1968, overcoming numerous challenges such as limited resources, inadequate facilities, and low public awareness. Despite these hurdles, Indian para-athletes gradually rose to prominence on the global stage. A pivotal moment came in 2004 when Devendra Jhajharia won India's first Paralympic gold, setting a world record in the F46 javelin throw. This achievement heralded a new era for Indian para-sports, culminating in 35 medals across 12 Paralympic Games. The Paralympics exemplify India's commitment to inclusiveness, reflecting a broader national strategy to promote equity in sports. Government initiatives such as the 'Target Olympic Podium Scheme' (TOPS), 'Khelo India,' and increased funding for para-sports provide athletes with special abilities access to advanced training facilities, coaching, and financial support. To foster a more inclusive sports ecosystem, India regularly hosts events like the National Para Games and Para Athletics Championships, enhancing visibility and opportunities for para-athletes. What is needed is corporate sponsorships and media coverage which are crucial in transforming societal perceptions of disability, empowering athletes and promoting social inclusion and awareness. Globally, several countries have successfully promoted inclusiveness

through sports. The United Kingdom, for example, has been a pioneer in fostering an inclusive sports culture. Looking back at the success of Team GB at the London 2012 Paralympics, where they ranked third with 120 medals, which stemmed from years of investment in para-sports proves

The UK government, along with organizations like the British Paralympic Association, provided substantial funding, advanced training facilities, and comprehensive support for athletes.

The extensive broadcasting and marketing of the London 2012 Paralympics also helped transform public perceptions of disability, inspiring a new generation of paraathletes. Similarly, Australia has excelled in promoting inclusivity in sports through the Australian Paralympic Committee, which focuses on talent identification, athlete development, and grassroots

inclusivity.
Further, Japan's efforts during the
Tokyo 2020 Paralympics highlight ed its commitment to accessibility, with significant investments in inclusive infrastructure, such as accessible public transport, venues, and accommodations, demonstrating a strong commitment to parasports.

Moreover, the Paralympic Committee's 'I'mPOSSIBLE' program, an educational initiative by the Agitos Foundation, was introduced in schools across Japan to educate children about the Paralympic values of courage, determination, inspiration, and equality, fostering a culture of inclusivity from a young age.In India, the road to achieving inclusiveness in sports has been long and challenging, but progress is evident.

The success of para-athletes at the Paralympics 2024 has helped break down barriers and challenge stereotypes, paving the way for a more inclusive society. However, there is still much work to be done to ensure that people with special abilities have equal access to sports and the opportunity to compete at the highest level.

The future of Indian para-sports looks promising, as it is a powerful reminder that success in sports is not limited by physical ability but defined by determination, skill, and the spirit to overcome adversity. WE CAN is the catchword.

Mamata offers to quit as talks with docs fizzle out

m amata}$ Banerjee on Thursday offered to resign as the Bengal Chief Minister asking for people's exoneration for failing to resolve the logiam arising out of the statewide junior doctors' "cease work" that entered its 34th day on Thursday.

The junior doctors had been agitating in demand of justice for the post graduate lady doctor of RG Kar Medical College and Hospital who was last month brutally raped and murdered inside the seminar hall of the Chest

Medicine Department. Banerjee's offer to quit came after two-and-a-half-hour high drama over whether the Government would allow the meeting with a 32-0member delegation of the doctors to be live-streamed.

"It seems that there are some people who are not interested in a solution to the problem ... they want my Chair ... then so be it ... I am ready to resign as I don't have a yen for the Chair ... if my quitting solves brings relief to the people then so be it ... let the doctors join work and serve the poor people," Banerjee said leading to a prompt inter-pretation from critics who read her statement as "a last effort to emotionally blackmail the masses.'

While the doctors who had bus-rode to State secretariat Nabanna to meet the Chief Minister following a Government invite to end the impasse pressed for a live-streaming of the event the Government (read the Chief Minister) would reject the demand outright. This, even top officials including Chief

Secretary Chakravorty and DGP Rajeev Kumar shuttled with messages between the Chief Minister and the doctors waiting outside the Nabanna Sabha Ghar.

Banerjee told the camera with folding hands, "I beg your forgiveness as I could not bring the doctors to the talking table ... I apologise to the people of Bengal who expected an end to the RG Kar impasse today. They (junior doctors) came to Nabanna but did not sit for the meeting. Though there was no meeting still request them to go back to work ... We have been waiting for two-and-a-half hours as we did two previous days but there was no response ... my doctor brothers and sisters brought 34 member delegation against



the Government stipulation of 15 ... we agreed ... but they were demanding live-streaming of the proceedings which is not possible in formal meetings ... they are giving example of Supreme Court

proceedings being telecast but what the Supreme Court can do we cannot ... besides this matter is subjudice and if during the meeting any derogatory statement is made against the judiciary as is

media then who will take that responsibility ... but they would not take our suggestion and would not enter the meeting hall despite coming to Nabanna ... where as I was waiting with my team of offi-

Alleging that about 27 people had died due to the doctors' cease work and about 1,500 cardiac operations had been postponed, the Chief Minister said she was not taking any action despite Supreme Court clearance.

The Court has given a deadline to them to join work. but the doctors have defied that even," Banerjee said in what the junior doctors called a "bid to instigate the judiciary against the medical staff" adding, "I have ESMA with me but will not use against the doctors ... as I want good conscience to prevail and I want them to return to work so that common people do not suffer.'

Government had been under a popular pressure --- unprecedented in the 13 years of Trinamool Congress rule --- that tended to mount by the day with thousands of people, mostly women coming out on the streets, taking control of the nights on more than one

Air taxis to soon become reality: PM Modi

Prime Minister Narendra Modi on Thursday announced that air taxis will soon become a reality as the government prepares the country for advanced air mobility. The Prime Minister was addressing the Second Asia Pacific Ministerial Conference on Civil Aviation in the national capital, where he also suggested the idea of having an international Buddhist circuit.

The prime minister said the government is preparing the country for advanced air mobility and the day is not far when travel by air taxi will be a reality, amid rising travel demand, initiatives are also being taken to promote advanced air mobility.

Under the regional air connectivity scheme UDAN, which has made air travel more accessible for lower middle-class individuals, 14 million people have flown with many of them seeing the inside of an aircraft for the first time, he said.

Mpox patient under treatment recovering well: LNJP hospital

Lok Nayak Jai Prakash (LNJP) hospital's Medical Director Suresh Kumar on Thursday shared that the mpox patient undergoing treatment at the hospital is recovering well.

Elaborating on mpox, Kumar said, "Mpox is a DNA virus and its rashes typically appear on the palms, soles and skin as maculopapular lesions, which are larger and more pronounced. These can also develop into ulcerated rashes and large skin lesions.'

He shared that the patient with mpox at LNJP is recovering well and there is no need to panic. The Union Home Ministry had on Monday confirmed the mpox case, saying, The individual, a young male, who recently travelled from a country experiencing ongoing mpox transmission, is currently isolated at a designated tertiary care isolation facility. The patient remains clinically stable and is without any systemic illness or comorbidi-



The ministry had stated that it was an isolated case, similar to the 30 cases reported in India from July 2022 onwards. "It is not part of the current public health emergency reported by WHO, which pertains to clade 1 of Mpox," it said.

The 26-year-old patient, a resident of Haryana's Hisar, was admitted to the Delhi government-run LNJP Hospital on September 7. The case aligns with earlier risk assessments and continues to be managed according to established protocols, the home ministry had said, adding that public health measures, including contact tracing and monitoring, are actively in place to ensure the situation is contained.

Political Parties to recalibrate strategy to nullify impact of AIP on vote bank

We want to tell (Prime Minister Narendra) Modi that no one needs peace more than we do. But that peace will come at our conditions, not yours.

Expressing gratitude to his supporters who had assembled outside the airport to welcome him, the Baramulla MP said he wants to convey to the people of Kashmir that they are not weak at all.

'The people of Kashmir will win as the people of Jammu and Kashmir are on the path of truth.

Blinken to discuss Ukraine request for greater arms use with other leaders

US Secretary of State Antony Blinken is wrapping up a three-nation, Ukraine-focused European tour in Poland after hearing repeated appeals from Ukrainian officials to use Western-supplied weaponry for long-range strikes inside Russia.

Blinken traveled to Warsaw on Thursday after spending a day in Kyiv with British Foreign Secretary David Lammy during which they pledged to bring the Ukrainian requests to their leaders. President Joe Biden and British Prime Minister Keir Starmer are to meet in the United States on Friday amid signs both Washington and London are growing more receptive to allowing the Ukrainians to use their arms to hit targets farther inside Russia than previously okayed. NATO member Poland, which shares a border with Ukraine, has been supportive of the Ukrainians and Blinken is likely to hear further requests for easing weapons-use restrictions from Polish President Andrzej Duda, Prime Minister Donald Tusk and Foreign Minister Radoslaw Sikorski. On Wednesday, Blinken and Lammy announced that the



Polish President Andrzej Duda, right, welcomes U.S. Secretary of State Antony Blinken, left, for a meeting in Warsaw, Poland,

pledged nearly \$1.5 billion in additional aid to Ukraine during their visit to Kyiv. During the hearing, Justice Miangul Hassan Aurangzeb asked Assistant Attorney General Azmat Bashir Tarar to seek directions from the Attorney General's office over the issue and provide a clear response to the court. "You are saying there is no case now, but could there be one later?" the judge asked, highlighting the Pak province to hold talks with Taliban

Peshawar (PTI): Khyber Pakhtunkhwa Chief Minister Amin Gandapur on Thursday said that he will send a delegation to Afghanistan for direct talks with the Taliban to address his government's concerns over terrorism, nearly a week after he sought permission from the Centre to engage in peace negotiations. Gandapur's remarks came amid a series of military operations by the Pakistan Army targeting the Tehreek-e-Taliban Pakistan (TTP) in Khyber Pakhtunkhwa and Balochistan. Starmer plans 'major surgery' to reform country's health service

British Prime Minister Keir Starmer on Thursday announced plans for "major surgery" that is needed to reform the National Health Service (NHS) after a damning new review warned that the country's state-funding health service is in "serious trouble". Starmer pledged the "biggest reimagining of our NHS since its birth" in a speech after for-mer surgeon Lord Ara Darzi's probe concluded the service is in a "critical condition" amidst surging waiting lists and a deterioration in the nation's underlying health, identifying serious and widespread problems for people accessing ser-

Based on Darzi's diagnosis of the challenges facing the NHS, Starmer outlined greater digitisation, reducing care burden on the hospitals and a greater prevention rather than cure as the fundamental areas of reform.

What we need is the courage to deliver long-term reform major surgery not sticking plaster solutions," Starmer said in his major speech at the healthcare charity King's Fund in London.

UK waives settlement fees, unveils new visas for bereaved partners

London (PTI): Eligible foreign nationals dealing with the death of a partner and facing financial hardship will soon be able to apply to have the appli-cation fee for settlement in the UK waived, under new rules laid out in Parliament this

Currently, people who wish to apply for settlement in the UK following the death of their British citizen partner are required to pay a GBP 2,885 fee, irrespective of a change in financial circumstances following a loss. Indian-origin migration and citizenship minister Seema Malhotra told Parliament on Tuesday that this fee will now be waived from October 9 as part of a "fairer and more compassionate approach" to those wishing to stay in the UK and facing acute financial vulnerabilit during times of grief. "Losing a loved one is a deep and unimaginable pain, all too often compounded by the immense financial strain faced by those left behind," said Malhotra. "Widows, widowers, and their

dependent children who had become integral parts of our communities can now apply for a fee waiver if facing destitution, in order to settle and keep the life they have built. This marks a fairer and more compassionate approach to those unable to afford the settlement fees, but who have often worked, paid their taxes and contributed to life here in the UK, including the partners of our military veterans," she said. Those who qualify include partners on a family visa who meet the criteria for destitution,

if their partner had either been a British citizen, had indefinite leave to remain in the UK, or was from the European Union (EU), Switzerland, Norway, Iceland or Liechtenstein and had pre-settled status. Bereaved partners of members of the Armed Forces, Gurkhas or Hong Kong military unit veterans - discharged before July 1997, may also benefit from In her written statement in the House of Commons, Malhotra

North Korea fired multiple short-range ballistic mis-siles toward the sea on Thursday, South Korea's military said, days after North Korean leader Kim Jong Un vowed to put his nuclear force fully ready for battle with its rivals.

South Korea's Joint Chiefs of Staff said it detected the missiles launched from North Korea's capital flying 360 kilometers (about 220 miles) before landing in the waters between the Korean Peninsula and Japan. Japanese Prime Minister Fumio Kishida instructed officials to ensure the safety of ships and aircraft, but there were no immediate reports of

The reported fight distances suggest the missiles were designed to attack South Korea. The South Korean Joint Chiefs of Staff condemned the launches as a provocation that poses a serious threat to peace on the Korean Peninsula.

The launches were North Korea's first public weapons firing activities in more than two months. On July 1, North Korea claimed to have tested a new tactical weapon capable of delivering a "super-large" 4.5 ton-class warhead.

In a Monday speech marking his government's 76th foundation anniversary, Kim said he would redouble efforts to make his nuclear force fully ready for combat with the United States and its allies. Kim made such a pledge saying North Korea faces "a grave threat" because of what he called "the reckless expansion" of a U.S.-led regional military bloc that is now developing into a nuclear-based

Kim has made similar vows numerous times, but his latest threat came as outside experts believe North Korea could carry out a nuclear test explosion or long-range missile test-launches ahead of the U.S. presidential election in November to boost its leverage in future dealings with the On Sunday, North Korea's state media published a photo of Kim inspecting a 12-axel vehicle that would be the the country's biggest missile launch platform. That sparked speculation that the North could be developing a more powerful intercontinental ballistic missile designed to strike the U.S.

mainland. Recent commercial satellite images indicate that North Korea's northeastern nuclear test site incurred minor damage from heavy summer rains in recent weeks and that no notable recent work was detected at its tunnels, 38 North, a North Korea-focused website. said an analytical piece published Wednesday.

Thursday's launches after North Korea flew hundreds of huge balloons carrying rubbish toward South Korea for five straight days through Sunday.

Since 2022, North Korea has sharply ramped up its weapons testing activities in part of its efforts to perfect its capabilities to launch strikes on the U.S. and South Korea. The U.S. and South Korea have responded by expanding military drills that North Korea calls invasion rehearsals.

Last month, Kim had still held off from missile tests or other provocative military demonstrations as the United States and South Korea conducted large-scale summertime military exercises. North Korea has previously reacted with other major U.S.-South Korean military training with its own weapons tests.

But prior to the U.S.-South Korean exercises, Kim staged a big ceremony in Pyongyang to mark the delivery of 250 nuclear-capable missile launchers to frontline military units and called for a ceaseless expansion of his country's nuclear program.

The Aug. 4 event added to concerns about Kim's pushes to deploy battlefield nuclear weapons along the tense border with South Korea.

in his post. On Wednesday, the Spanish Parliament approved a proposal from the conservative Popular Party urging Sánchez's left-wing coalition government to recognise the opposition leader as the elected president of Venezuela. The motion is for "the immediate rupture of all diplomatic relations, of all commercial relations".

Soyabean oil imports surge amid price drop

Tndia's crude soyabean oil Imports reached a seasonal high of 4,54,639 tonnes in August, even as local soyabean prices have dropped below the minimum support price (MSP), industry body Extractors Solvent Association (SEA) said on Thursday.

According to SEA, crude soyabean oil imports in August 2023 stood at 3,57,890 tonnes.

The share of non-palm oils, including soyabean oil, made up 48 per cent of the total vegetable oil imports.

The surge in imports comes as local soyabean prices dropped below the MSP, raising concerns about farmers' income with the new crop's arrival expected in the coming weeks. SEA praised the government's

efforts to procure soyabean at MSP in Madhya Pradesh, Maharashtra and Karnataka, but suggested increasing import duties on crude and refined edible oils by 20 to 25 per cent across the board as a more effective solution. "This



translate remunerative price to the farmers for his produce and the market forces will be able to pay above MSP price to the farmers and at the same time the government does not have to procure at MSP," SEA said in a statement.

The industry body noted that in the last two months, soyabean ex-mandi prices were Rs 550-600 per quintal below the MSP of Rs 4,892 per quintal causing unrest among farmers.

However, total vegetable oil imports declined to 15.63 lakh tonnes in August from 18.66 lakh tonnes a year ago. In the non-palm oils segment, crude sunflower oil imports fell 22.34 per cent to 2.84 lakh tonnes in August.

NANDINI SATPATHY, former union minister and chief minister of Orissa was one who lived during the days of titans of Indian politics. Though not a leader in the true sense of the word, she too had her successes and failures. Nandini's life sketch is introduced to the readers 18 years after her demise but she had disappeared from public life much earlier. → he art of writing a book, whether it is novel, essays, short stories, poetry or history is a job of creativity. It is the writer's hands-on experiences or tough realities he/she faced in life that come out as literary works. A biography of Nandini Satpathy, the

former chief minister of Orissa has been published by Simon and Schuster and authored by Pallavi Rebbapragada, a journalist and public policy consultant based in New Delhi. It is a good mission as nothing much has been heard about Nandini Satpathy since 1980 as she withdrew from active politics and faded out since her rejoining the Congress. Nandini had an uneventful career at the

Center as deputy minister for information and broadcasting. Those were the days when Akashwani was described as Indirawani because the babus in Mandi House preferred to pay obeisance to the Prime Minister than their profession as broadcasters.

Nandini returned to Orissa in 1972 and was crowned as chief minister at the instance of Indira Gandhi. Her tenure saw hundreds getting imprisoned for questioning the declaration of internal emergency. By December 1976, towards the fag end of emergency, Nandini quit the Congress along with Jagjivan Ram, Chandra Sekhr, Mohan Dharia and Hemavati Nandan Bahuguna to form Congress For Democracy. The slogan coined by the opponents of Indira Gandhi at that period read like this: "Jagjivan Poyi, Jivan Poyi, Bahuguna Poyi, Gunavum Poyi, Nandini Poyi, Malayalam for "With Jagjivan's exit, the party lost its life, With Bahuguna's exit, the party lost quality and with Nandini gone, the party lost the last vestige of whatever reputation". To be candid, Nandini Satpathy's name hogged the national limelight when she left the

Congress party.
Had she been effective as chief minister of Orissa, the State should have made giant strides in development and progress. But Orissa remains one of the least developed regions in India. A thorough probe should be held on how the politicians managed to make Orissa remain as a poverty stricken State despite its vast natural resources and sufficient assistance from the Center.

The author has used theatrics in the narration to sell Satpathy to the readers. Her claim that Nandini Satpathy was the Iron Lady of Orissa is far-fetched. The designation Iron Lady was used by international experts to describe Gold Meir, the fourth Prime Minister of the State of Israel (1969-1974). Perhaps, the over dependence on TV anchorpersons might have put the author in a minefield of wrong information.

Biju Patnaik would have been an ideal topic for her to write about since not much has been written about the titan from Eastern India.







Mbappé rejects mediation offer in Chopra, Sable spearhead Indian challenge in Diamond League season finale

Kylian Mbappé is not ready to compromise with Paris Saint-Germain.

The France superstar rejected a mediation offer by the French soccer leagues legal commission on Wednesday in his dispute with his former club over wages and bonuses.

PSG officials and Mbappés representatives met in Paris after Mbappé asked the commission to get involved. Mbappé, who joined Real Madrid this summer on a free transfer, says PSG owes him 55 million euros (\$60 million).

In a statement to The Associated Press,

Mbappés representatives said the player asked the commission to take note of the nonpayment of three months salary and the last third of a loyalty bonus.
"The eventuality of a mediation was mentioned this morning," the statement read. "This

possibility was rejected during the meeting by the players representative. A mediation would be useless to record a lack of payment that would be seen from a simple analysis of the players payslip."
PSG, which said it was pleased with the two-

hour hearing at the commission on Wednesday, said in a statement it recalled that Mbappé had formerly made "clear, repeated public and private commitments that must be respected, having been afforded unprecedented benefits by the club over seven fantastic years in Paris." PSG has argued that it does not owe money to

the World Cup winner under an agreement when Mbappé was sidelined ahead of the 2023-24 season - following his decision not to prolong his contract with the club - with the player allegedly stipulating that he would relinquish bonuses over his reintegration into the team. "To avoid its payment obligation, the club seeks

to demonstrate the existence of a secret agreement that would justify it. But the club fails to demonstrate the existence of such an agreement," Mbappés representatives said. PSG said that the leagues legal commission recommended "mediation between the parties,"

which the club said it had been seeking for The French league did not respond to a request for comments from the AP.

The players representatives did not say what action they will now take. In light of the current

deadlock, its likely the case will ultimately be

settled by an employment court. Mbappés relationship with PSG ended amid deep tensions during his final season at the club. PSG felt let down by Mbappé after offering him the most lucrative contract in the clubs history

when he signed a new contract in 2022. But Mbappé was frustrated because he felt promises to sign key players were not kept.
When he signed the new deal, he was paraded in front of fans holding up a jersey with 2025 on it.
Mbappé was reportedly annoyed about this because the contract was until 2024 with the

option for an extra year.

Mbappé stunned PSG in June last year by informing the club he would not take the option for an extra year. With his contract effectively into its final year, it put PSG in the position of needing to sell Mbappé to avoid losing him for free when the contract expired.

His PSG career could have ended in the summer of 2023 amid a tense transfer standoff. After telling the club he would not extend his contract for an extra year, Mbappe was left off a preseason tour to Japan and South Korea and forced to train with fringe players. PSG said it would rather sell him than let the player leave for free in 2024, but he rejected a 300 million euro move to Saudi team Al-Hilal.

PSG left Mbappé out of the teams opening league game of that season as the standoff continued but eventually let him return to the lineup after "constructive and positive talks" between the two parties, PSG said at the time.
