NO PANACEA FOR COMMONERS AT AIIMS, DELHI

2018: A four-month-old infant whose parents brought her to the All India Institute of Medical Sciences (AIIMS), Delhi, for urgent surgery for a hole in her heart was given a slot for the corrective surgery operation in 2023, resulting in a five-year

Fast forward to June, 2024: A sixyear-old from Begusarai, Bihar, has been left waiting for a heart operation at the premier health institute for the past six years due to "dates changed thrice."

Despite the best efforts of his

father, Ankit Kumar, who had been running from pillar to post gathering funds and blood, it was long wait for treatment. However, it was only after the issue was highlighted in the media and the NHRC took suo motu cognisance that the hospital formed a panel to investigate the

These are likely some of the longest waiting periods for patients at AIIMS Delhi and have been reported as such.

Welcome to India's most prestigious medical institution, established as the country's foremost centre of medical excellence. The bustling scene outside the hospital, with relatives of the patients lying by the roadside waiting for their turn outside the emergency wards, is a telling example of the stark disparity in healthcare access in the country.



While this flagship hospital draws thousands daily, it also highlights a critical shortage of specialist doctors and medical facilities both at the hospital and in rural areas, where the majority of India's 1.4 billion people struggle with the challenge of reaching distant healthcare facilities.

On Thursday, The Pioneer visited AIIMS Delhi and spoke with the

conditions like blood cancer, some of them admitted in the emergency departments while a few were waiting for their turn. The hospital is visited by around 20,000 patients daily from across various states, particularly populous ones like Bihar, Uttar Pradesh and Odisha, and even faroff States of North-East.

The doctors said they have arranged one unit of blood, and since she will need blood transfusions whenever it is low, we are now arranging donors."

ago understanding of the condition. The doctors back home in Kanpur did not disclose the disease my son was suffering from. But now I have learned a lot about this health condition and what may come, I will ensure that this girl (Radha) does not meet the same fate."

People come here seeking care, advanced medical specialised treatment, and expert available in their local hospitals. The reputation of AIIMS for its high-quality healthcare services, cutting-edge research, and a wide range of specialties contribute to its status as a go-to destination for many seeking comprehensive medical care.

But for Mammu, a 20-year-old youth from Jaganpura Kauch, Jalon in Uttar Pradesh, it has been a restless day as he silently writhe in pain on a stretcher in the open with the weather behaving nastily. His attendant said he's having thick blood problem.

The concerned doctor is not here. So we have been asked to wait outside," said 40-year-old Jagat Singh, attending to the patient. The medical report showed that Mammu's hemoglobin level has shot up to 25, contrary to the normal 14-15 hb. He might be suffering from a disorder that causes the body to produce too many red blood cells. Yet another relative of a patient with co-morbidity such as TB and diabetes outside the emergency ward said he is trying for a 'recommendation' so that his ward could get a bed. This hospital has its own reputation, with doctors dedicated to their profession. This is what makes patients flock to this hospital, he said matter-of-factly. Outside the hospital, one can see the adjacent streets are crowded with patients and their families from distant places, all seeking remedies for their or their loved ones' health issues. "We've been living on the footpath for the past to the hospital for the last five years for my son's treatment," rued Ramwati from Rajasthan's Alwar district.

Her son suffers from chronic asthma, a condition marked by inflammation that restricts airflow from the lungs. As securing a hospital bed is a significant challenge, they are doing everything they can to ensure the little boy receives the necessary treatment. In fact, this is the travail of almost every other patient and their relatives on the roadside.

Conceding that the six new AIIMS like hospitals at underserved States Bhubaneswar, Ranchi, Patna, Raipur, Bhopal, Jodhpur and Rishikesh have failed to ease the pressure on AIIMS Delhi, a senior official in the Union Health Ministry blamed faculty shortages, resource crunch, and infrastructural deficiencies. Besides these six States, more AIIMS like institutes are coming up in other States too.

Public health specialists believe that this state of affairs is largely due to flawed health policies adopted by successive Governments. Anant Bhan, a researcher in global health, said merely naming an institute 'AIIMS' does not guarantee it will be held in the same esteem as the one in Delhi. "AIIMS Delhi has earned a reputation for quality and affordability, but the new centres face challenges that need



SC reserves order on Arvind Kejriwal

The Supreme Court on Thursday reserved order on Delhi Chief Minister Arvind Kejriwal's separate pleas seeking bail and challenging arrest by Central Bureau of Investigation (CBI) in the excise policy "scam". After concluding arguments from both sides, a bench of Justices Surya Kant and Ujjal Bhuyan said, "Thank you for the assistance. Judgment reserved.

Additional Solicitor General SV Raju represented the CBI and Senior Advocate Abhishek Singhvi appeared for the AAP chief. The apex court was hearing two separate petitions challenging his arrest by the CBI and the denial of bail in the corruption case filed by the agency. The AAP convenor has challenged the

August 5 order of the Delhi High Court dismissing his plea against his arrest by the agency. He has also filed a Special Leave Petition against the High Court's refusal to consider his bail plea. The CBI had arrested Kejriwal on June 26. Questioning the maintainability of

Kejriwal's pleas seeking bail and challenging his arrest, the CBI told the Supreme Court that he should have first approached the trial court for bail in the corruption case linked to the alleged excise policy scam. "He has approached Delhi High Court directly without going to sessions court. Under Section 439 of the Code of Criminal Procedure (CrPC), both have jurisdiction. concurrent preliminary objection is he must first

go to trial court," ASJ Raju said.

Dhaka issues warning of discomfort with Delhi, if Sheikh Hasina speaks

Muhammad Yunus, the head of Bangladesh's interim Government, has said former Prime Minister Sheikh political Hasina making from "unfriendly gesture", asserting that she must remain silent to prevent the discomfort to both countries until Dhaka requests her extradition.

"If India wants to keep her until the time Bangladesh (Government) wants her back, the condition would be that she has to keep quiet," he said. In an interview with PTI at his official residence in Dhaka, Yunus, who was appointed the country's Chief Adviser after Hasina's ouster, stressed that while Bangladesh values strong ties with India, New Delhi must move "beyond the narrative that portrays every other political party except Awami League as Islamist and that the country will turn into Afghanistan without Sheikh Hasina."

"No one is comfortable with her stance there in India because we want her back to



try her. She is there in India and at times she is talking, which is problematic. Had she been quiet, we would have forgotten it; people would have also forgotten it as she would have been in her own world. But sitting in India, she is speaking and giving instructions. No one likes it," he said.

"It is not good for us or for India. There is discomfort regarding it," he told PTI.

Yunus was apparently referring to Hasina's statement on August 13 in which she demanded "justice", saying those involved in recent "terror acts", killings and vandalism must investigated, identified and punished. This has been the only statement made by Hasina after she fled. It was posted on her US-based son Sajeeb Wazed Joy's X handle. Following unprecedented anti-Government protests that peaked on August 5, Hasina resigned as Prime Minister and fled to India. Her presence in India for nearly four weeks has fuelled speculation in Bangladesh.

asked whether When Bangladesh has communicated its stance to India, Yunus said it has been conveyed verbally and quite

firmly that she should keep Everyone understands it. We

have said quite firmly that she should keep quiet. This is an unfriendly gesture towards us; she has been given shelter from there. It is not that she has gone there on a normal course. She has fled following a people's uprising and public anger," he said.

Yunus stated that the interim Government is committed to ensuring justice for the people of Bangladesh against the atrocities, and justice requires that she be brought back to the country. "Yes, she has to be brought back or else the people of Bangladesh won't be at peace. The kind of atrocities she has committed, she has to be tried in front of everyone

here," he emphasised. Discussing the future of the India-Bangladesh relationship, Yunus expressed a desire for good ties with India but insisted that New Delhi must abandon the narrative that only Hasina's leadership ensures country's stability.

Rural collides with urban Delhi over Lal Dora

The Delhi High Court has taken suo motu I taken suo motu cognisance of the challenges faced by residents of Delhi's urbanised villages when it comes to the mutation (entry in revenue records) of their land.

This development comes after Supreme Court judge, Justice Sanjiv Khanna, along with Acting Chief Justice, Manmohan, visited Jaunti village in North-West Delhi pursuant to an event organised by Delhi State Legal Services Authority (DSLSA) on August 10 focused upon addressing the multifaceted challenges faced by the remote and underdeveloped areas of

During interaction with the judges, the villagers voiced concerns regarding the difficulties faced by them pertaining to mutation in the land records.

They said they wished to get their immovable properties inherited from ancestors mutated in their names in the land records as per law, but mutation applications with all the necessary documents attached gather dust endlessly concerned

departments despite persistent efforts over the years, the aggrieved villagers complained. Mutation is the process of

changing the title of a property in the records of the local authorities. A Division Bench of Acting

Make flat possesion hassle-free: LG to DDA

In an effort to make process of buying and taking possession of a Delhi Delhi Development Authority (DDA) flat a hassle free experience, it has started providing a plush folder con-taining all relevant papers print-ed out in a thicker bond. Farlier ed out in a thicker bond. Earlier, the flat buyers would only get a piece of loose paper as 'possession letter' upon buying their flats, a statement officials said here on said.

It also said this initiative was taken by Delhi Lt Governor(LG)V K Saxena. The Lt. Governor, in his varied interactions, found the lack of 'papers' - their non-availability, them being disputed, them having got lost, etc. as one of the prime woes afflicting various individuals, groups and processes of DDA. He had accordingly



directed DDA to prepare a folder containing not only possession letter but all relevant documents to be handed over to the buyers. While directly supervising the roll out of the DDA Housing Schemes since last year, Saxena had directed DDA to address this issue in a suitable manner. He has underlined that buying a house or property was an important, once in a life time occasion for most of the buyers and the same should be dealt as a special and memorable occasion for the buyer by the DDA. He had

to the practice being followed by renowned builders in this regard. Accordingly, DDA has now decided to hand over the flat documents in a customized folder. The folder will contain all relevant documents that include demand-cum-allotment letter (DAL), payment receipt, possession letter (PL), NOC for water and electricity, possession Slip, RERA registration certificate and layout plan. This will facilitate getting all documents at one place rather than approaching various departments of DDA.

On directions of the Lt. Governor, the DDA has also introduced a new format of Possession Slip that has the picture of the flat buyer / allottee being handed over the possession letter at the site, print-

Heavy rain lashes city, commuters face knee-deep water

Heavy rains battered parts of Delhi and adjoining areas of Noida and Gurugram leading to waterlogging and traffic congestion in the city even as commuters struggled to wade through knee deep

The incessant downpour led The incessant downpour led to waterlogging in the arterial junctions of the city. Areas including Mundka, Dhaula Kuan, Moti Bagh, Mehrauli-Badarpur road, Lajpat Nagar, Karol Bagh, Punjabi Bagh, Khanpur, ITO, Jahangirpuri, Safdarjung, Kashmere, Gate Safdarjung, Kashmere Gate ISBT and Okhla Estate were left indudated after the showers causing slow traffic move-

According to the India Meteorological Department, city's primary weather station Safdarjung recorded 11 mm of rainfall, Ayanagar 53 mm of rainfall, Delhi University 23.5 mm of rainfall, Lodi road 7.8 mm of rainfall,





Palam 8 mm of rainfall, Ridge 17 mm of rainfall, Pitampura 6.5 mm of rainfall, Pragati Maidan 15.9 mm of rainfall, Pusa 0.5 mm of rainfall, Rajghat 15.9 mm of rainfall and Mayur Vihar's Salwan public school 6.5 mm of rainfall in the last 24 hours till 8 am on Thursday.

While commuters appreciated relief from humid weather relief from humid weather and better air quality due to rains, they complained about huge traffic jams witnessed in different parts of the city. Delhittes travelling in the evening from their office back home said that they were left

He made the remarks while addressing a 'Shikshak Samman Samaroh,' organised by the Municipal Corporation of Delhi (MCD) on the occasion of Teachers' Day where 90 teachers were honored at Auditorium in Civic Center

"Today, there is a lot of talk about India of 2047. The teachers who are sitting here today, the children you have with you are very important for 2047. The India of 2047 depends on these children. But even policy makers have to do something for them," Sisodia said.

Citing examples of Germany, Switzerland and a few other countries, he said, "In most developed countries, the



salary of teachers is more than the bureaucrats there. A teacher with five years of experience draws more salary than an IAS officer with five

years of posting."
Talking about his incarceration in Tihar jail for 17 months in an excise policy-linked money laundering case, Sisodia said he spent eight to 10 hours every day reading books and learning about the education system of

"The last 1.5 years I was in difficult circumstances of my life. When we are in difficult circumstances, the lessons learnt by teachers are most useful. I studied a lot during this time. I used to read books for eight to 10 hours. Most of all, I read about education, India's education system, the

bring an education revolution in corporation schools on the lines of the Delhi government. The dream of former

Education Minister of Delhi Manish Sisodia was that corporation schools should also be on the lines of Delhi government schools. We sent the principals of corporation schools to prestigious insti-tutes like IIM for training. Now we will send principals and teachers abroad for training, for which we have also passed a resolution from the House," she said.

The Education Minister said that when Arvind Kejriwal became the Chief Minister of Delhi in 2015, he took a pledge that whether a child is from a rich family or a poor family, every child of Delhi will get world class edu-

"The result of this is that the Delhi government became the first government in the



country to double the education budget in the first year itself. The budget of Rs 5000 crore was increased to Rs 10,000 crore. Delhi became the first government in the country to consistently spend the largest part of its budget, almost a quarter, on education. Delhi Environment Minister Gopal Rai on Thursday said that the Government will focus on the 21-point Winter Action Plan, as pollution levels in the city peak during the cold

In a press conference, Rai said, "Like last year, the government is committed to addressing pollution, especially during the winter months when it peaks. This time, we will focus on new measures as part of the 21point Winter Action Plan." The 2024 Winter Action Plan

will focus on different issues including hotspots, vehicle and dust pollution, work from home, stubble and garbage burning, industrial pollution, upgrading the war room and green app, dialogue with the central government and neighboring states, and preparation for odd-even and artificial rain as emergency measures.

cerned have been instructed to submit their action plan on the winter action plan by September 12," Rai said.

hhattisgarh Chief Minister Vishnu Deo Sai on Thursday said the "double engine government in Chhattisgarh has pushed Naxalites on the backfoot and the Red menace is expected to end by March 2026.

He told reporters here that the recent visits of Union Home Minister Amit Shah have boosted the morale of security forces and a decisive battle against the Maoists was on in Chhattisgarh.

"Only eight months have passed since we have formed government



Chhattisgarh and there has been a considerable decline in Maoist activities in the state," the Chief Minister said.

So far this year, at least 153 Naxalites have been killed, 669 arrested and 656

surrendered. This was achieved due to better coordination and strategy among district and Central forces, said Sai.

Citing the Home Department, he said there Naxalite incidents in 2014-24 as compared to 2004-14.

The number of Naxalite incidents fell from 14,862 in 2004-14 to 7,128 in 2014-23,

The number of deaths of security personnel due to Maoists dipped by 72 percent, from 1,750 in 2004-14 to 485 in 2014-23.

The number of civilian deaths was down by 68 percent, from 4,285 to 1,383, in the same period. "It is now crucial time to

deal the final blow to the problem of Left Wing Extremism with a strong strategy," Sai said.

Phishing fraud mimics

Indian cyber-security agencies have detected a phishing fraud that "mimics" the official website of the Ministry of Defence to "harvest" the log-in credentials of officials to "steal" sensitive Government documents. An advisory issued this week by the National Informatics Centre (NIC) has identified two phishing links mod.Gov.In.Aboutcase.Nl/publ ications.Html mod.Gov.In.Army.Aboutcase. Nl/publications.H́tml.

'The communication says both the URLs seek NIC-provided log-in credentials of Government officials through a fake e-mail that comes attached with a "fake" document titled "Hackers Targeted Defence Personnel in Mass Cyber Attack".

"Ónce individual credentials like log-in IDs and passwords are punched, the links re-direct the users to a "loginerror.Html" page.
""Both the phishing URLs have

mirrored the original MoD website (www.Mod.Gov.In) to lure end users into believing they are legitimate MoD websites," the communication says. 'The two links are "mimicking' the Department of Defence under the Ministry of Defence and the phishing campaign is primarily aimed at harvesting the NIC credentials of Government officials to steal sensitive documents pertaining to the Indian Government, the

communication says. The NIC serves as the backbone of Internet-based Government communication. "A phishing attack is defined as the fraudulent practice of impersonating reputed and official names and identities through e-mails, text messages or phone calls to trick the victims into sharing sensitive personal information like banking and credit card details and login or identity

India's move to build toilets has saved up to 70,000 infant lives annually: Study

ndia's initiative focused on $oldsymbol{1}$ building toilets has potentially saved up to 70,000 infant lives annually, a recent study published in the British journal 'Nature' has revealed, in a testament to the impact of the Prime Minister Narendra Modi's pet project, the Swachh Bharat Mission (SBM).

Lauding the observations, the report was shared by the Prime Minister on Thursday stating that access to proper toilets plays a crucial role in reducing infant and child mortality. The Mission is a country-wide

campaign initiated by the Central Government on October 2, 2014, to eliminate open defecation and improve solid waste management. In a social media X, the Prime

Minister posted saying that

improved sanitation has

become a "game-changer" for public health in India. "Happy to see research highlighting the impact of efforts like the Swachh Bharat Mission. Access to proper toilets plays a crucial role in reducing infant and child mortality," Modi said.

'Clean, safe sanitation has become a game-changer for public health. And, I am glad India has taken the lead in this." he added

The report "Toilet construction under the Swachh Bharat Mission and infant mortality in India", said toilet construction increased dramatically across India following the implementation of the SBM in 2014 adding that the post-mission period in India exhibited accelerated reductions in infant and child mortality compared to the

Researchers had analysed infant and under-5 mortality data from 35 states in 640 districts and came to the conclusion that "based on regression estimates, the provision of toilets at scale may have contributed to avert-

pre-SBM years.

ing approximately 60,000 to 70,000 infant deaths annually." It added that the implementation of transformative sanitation programmes can deliver population health benefits in low and middle-income countries. This significant impact underscores the crucial role of improved sanitation in reducing infant and child mortality rates, highlighting the success of the program. The research delves into data

spanning two decades, uncovering a significant link between improved sanitation and reduced child mortality. By examining changes in toilet

access across the states, the study demonstrates how each 10-percentage-point increase in district-level sanitation correlates with marked declines in both infant and under-5 death rates, highlighting the mission's crucial role in advancing public health and saving lives.

Meghalaya bans two-finger test to confirm rape

 $T^{\text{he Meghalaya Government}}_{\text{has informed the Supreme}}$ Court that it has prohibited the 'two-finger test which was conducted to determine whether a survivor of rape or sexual assault was habituated to sexual intercourse.

The State Government told the apex court that a circular dated June 27, 2024, was issued by the Health and Family Welfare Department of Meghalaya prohibiting the test and disciplinary action will be taken for non-compliance.

A bench of Justices J B Pardiwala and Sanjay Karol, which referred to a top court's order passed on May 7, noted that the apex court had strongly deprecated the practice of conducting a 'two-finger test'. "Amit Kumar, the Advocate General appearing for Meghalaya, has tendered a circular dated June 27, 2024, issued by the Government of Meghalaya, Health and Family Welfare Department. This circular has been issued prohibiting the 'two-finger test' and also disciplinary action for its non-compliance," the bench said in its September 3 order. The bench passed the order while dismissing a petition filed by a convict who had challenged the Meghalaya High Court's verdict delivered on

The high court had affirmed his conviction for the offences punishable under the provision of the Protection of Children from Sexual Offences Act.

March 23 last year.

The bench noted that the convict was sentenced to 10 years for the offence.

In a judgement delivered in October 2022, the apex court deprecated the "regressive" and "invasive" practice of the 'twofinger test' on rape survivors and said it has no scientific basis and instead re-victimises

sexually assaulted, and was an affront to their dignity. In its order passed on September 3, the top court

referred to the circular issued by the Meghalaya Government. The Supreme Court of India and the Ministry of Health and Family Welfare have prohibited the practice of conducting the two-finger test (TFT) on survivors of sexual assault. This practice is scientifically baseless, traumatising, and violates the survivor's dignity and

rights," the circular said. "All Government doctors and medical practitioners in the State of Meghalaya are hereby directed not to conduct the two-finger test on survivors of sexual assault. Adherence to this directive is mandatory for all Government medical personnel," it said.

The circular further said any doctor found conducting the test will be held guilty of misconduct and strict disciplinary action will be initiated in accordance with the Meghalaya Discipline and Appeal Rules, 2019. It said the survivors of sexual assault must receive compassionate, respectful and sensitive care, including psychological support and coun-

selling services. "We hope and trust that the circular referred to above issued by the State of Meghalaya is implemented and abided in its letter and spirit. We hope that in future we may not have to once again condemn the State of Meghalaya for such a serious lapse," the bench said.

Frequent mobile phone use linked to increased risk of cardiovascular diseases: Study

Do you spend hours glued to your smartphone, whether for social media or work? It's better if you reassess your habits. For, a new study published in Canadian Journal of Cardiology has suggested that frequent mobile phone use is linked to an increased risk of cardiovascular diseases (CVD), particularly among current smokers and individuals with diabetes. The study is particularly rele-

vant for India, where, as of January 2024, there were 1.12 billion mobile connections, encompassing 78 per cent of the country's population. Study author Dr Yanjun Zhang from Nanfang Hospital,

China, warned that, "Given the pervasive nature of mobile phone use, understanding its health impacts is crucial. Radio-frequency electromagnetic fields (RF-EMF) from these devices can disrupt the hypothalamic-pituitary-adrenal axis, cause inflammation, and induce oxidative stress. This can affect heart health and blood vessels. However, the precise connection between mobile phone use and CVD

remains uncertain." His colleague and co-investigator Dr. Ziliang Ye echoed similar views. "We found that regular users face a significantly higher risk of developing these conditions compared to those who use their phones less fre-



data from 444,027 individuals in the UK Biobank with reported mobile phone use from 2006 to 2010, defined regular use as making at least one call per week. Over a median follow-up period of 12.3 years, the study assessed incidences of stroke, coronary heart disease, atrial fibrillation, and heart failure, while also exploring the logical distress, and neuroti-Co-investigator Xianhui Qin,



Ensure leave applications of prisoners processed scrupulously as per rules: HC to TN DGP

The Madras High Court has directed the Director General of Prisons to issue consolidated instructions to all the subordinate prison authorities to ensure that the leave applications filed by or on behalf of the prisoners were processed scrupulously in accordance with the rules and decisions were taken within a period of 28 days as contemplated under Rule 24(5) of the Tamil Nadu Suspension of Sentence Rules,

In a recent order, a division bench comprising Justices S M Subramaniam and N Senthil Kumar said failure in complying with the Tamil Nadu Suspension of Sentence Rules, 1982 regarding adherence of time limit contemplated was to be construed as lapse, dereliction of duty or negligence, as the case may be and appropriate disciplinary actions were to be initiated against the who all officials were for responsible such misconduct.

The bench said the writ petitions filed prematurely before expiry of the statutory time limit of 28 days as contemplated under the Tamil Nadu Suspension of Sentence Rules, 1982 were not entertainable for grant of ordinary leave. Applications for emergency leave were to be considered forthwith by the competent authority without causing any delay. An

order of rejection of leave application would provide a cause for instituting the writ petition challenging the same, the bench added.

The bench gave the above directives while disposing of a petition filed by Usha, wife of Karthi, a convict prisoner confined in Vellore Prison, seeking a direction to the authorities to grant 28 days ordinary leave to her husband The bench said in the present

case, the petitioner filed an application seeking leave on June 27, 2024. The writ petition was filed on July 15, 2024, even before the date of expiry of the statutory period as per the rules to dispose of the leave petition by the competent authority under the Tamil Nadu Suspension of Sentence Rules, 1982.

the present writ petition was premature on the date of filing. "However, we are inclined to take an exception in the present case, since during the pendency of the present writ petition, the statutory period expired and again remanding the matter became unnecessary", the bench added.

IC-814: Lessons beyond the binary-

eb series IC-184: The Kandahar Hijack, has triggered debate on the complexities and 'greys' that accompany such incidents. Beyond obvious things like the lack of coordination, responsiveness or even allowing the flight to take off from Amritsar – one important query is if India did wrong in negotiating with terrorists. Given the handiwork of these released terrorists in the subsequent terror attacks, the question acquires even gravity. However, beyond the simplistic and binary 'yes' or 'no' position that is often postulated in the argument, lies the necessity of nuance in attempting to answer the same. It is universally agreed that negotiations with terrorists are a bad idea, however, sometimes, the consequences of not negotiating can have far more debilitating and costly consequences.

Sifting the wheat from the chaff of the supposed 'no-negotiation' stance of some countries (as often bandied) is important. It is frequently argued that countries like Israel or the United States of America do not negotiate with terrorists. It is further claimed that because of such an unbending posture, the Israelis and Americans avoided being taken as hostages. But such beliefs are untrue, misplaced, and belie the wheels-within-wheels of the American or Israeli reality, beyond the publicly stated position of 'no-negotiation'. It is the worst-kept secret that

such countries have funnelled money through proxies, 'friendly countries, or even masked the same as 'aid' to secure their citizens, whilst maintaining the official stance. The Iran-Contra affair (1981-86) during the Reagan era wherein American hostages held by the Lebanese group, Hezbollah, were exchanged for weapons for Hezbollah itself, exemplifying the deals cut beyond the public gaze. As recently as 2014, the Americans had released five failban prisoners from Guantanamo, to secure an

Korean banks to secure the release of five US citizens. It is now argued that the same money could have been invaluable for the cashstrapped Iranians (widely believed benefactors of Hamas) in launching the subsequent '7th Oct' attack on Israel. Israelis themselves are the masters of the backdoor negotiations, irrespective of the belligerent stand adopted for public consumption. In the Gilat Shalit (Israeli prisoner) exchange of 2011, it is believed that Israelis released 1027 prisoners who were held in jails. Even now as the bludgeoning of the Gaza Strip continues, the Israelis in parallel (and in support of the Biden administration) are still negotiating with Hamas for the release of their citizens held hostage. Often, the aggrieved government can end up losing a lot of leverage and lives when they refuse to engage with bad actors. Negotiations help immediate outcomes, buy crucial time for alternate reactions, and most importantly, help establish critical information and 'leads' about the captors that could be invoked, productively.

INDIA BOLSTERS 'ACT EAST' POLICY

PM Modi's Brunei visit highlights India's commitment to strengthening ties in Southeast Asia

rime Minister Modi is wasting no time in walking the talk as far as his foreign policy goals are concerned. This week, with a clear focus on Look East policy the Indian PM was in Brunei and Singapore. The Brunei visit was the first state visit by an Indian PM, after establishing diplomatic relations in 1984. The Indian Mission in Brunei came nearly a decade later in 1993. PM Manmohan Singh had visited Brunei Darussalam in 2013 to attend multilateral meetings of ASEAN and East Asia Summit. Highlighting the importance of the first bilateral visit to Brunei, India's High Commissioner Alok Amitabh Dimri, told news agency ANI " In our four decades of diplomatic relationship, this is the first bilateral official visit by the Prime Minister of India to Brunei Darussalam.

It is a historic moment in our bilateral relationship and also for the Indian community in Brunei Darussalam that high-level bilateral engagement between Prime Minister Shri Modi and His Majesty the King is going to take place. This visit is historic in many ways that Brunei and India have been civilizational neighbours as you know that India shares deep historical roots and bonds with Southeast Asia. The Malayan tradition of this geography which is located in the Borneo Island of Southeast Asian Seas derives deep linkages be it, linguistic, anthropological, ethnic, architectural, religious motives, customs and traditions, norms from India, South India." Defence relations between the two countries have been on an upward trajectory since the establishment of formal diplomatic



There have been several official-level defence exchanges and visits of navy, coast guard ships and joint exercises. India has MoU in in defence sector with Brunei till 2026. Several Indian Navy ships and coast guard ships such as INS Rana, INS Airavat, INS Shivalik & INS Kadmatt, and Samudra Pahereda to name a few, have been in Brunei waters, given the maritime security concerns. The trade relations between the two countries are not what one can boast of, however, it is of strategic impor-

The recently concluded Brunei trip by the Indian PM has enhanced and deepened the partnership between the two countries. The joint statement issued after the leader's meeting stated "Both leaders held discussions for enhancing cooperation on a wide range of issues including defence, connectivity, trade and investment, energy including renewables, space, ICT, health and pharmaceuticals, education and capacity building, culture, tourism, youth and people-to-people exchanges, as well as regional and international issues of mutual interest." However, the real area of cooperation would be in maintaining international rules of law deep in the Indian Ocean. Brunei is located in the South China Sea region, where China has a significant presence and has been increasingly threatening the bordering countries with its coercive tactics. These issues were raised by the Indian PM in his meeting with his Counterpart on Darussalam. The joint statement read, "Both leaders reiterated their commitment to work closely together in mutually beneficial areas to further strengthen the ASEAN – India Comprehensive Strategic Partnership. Both leaders reiterated their commitment to maintaining and promoting peace, stability, maritime safety and security, as well as respecting freedom of navigation and overflight and unimpeded lawful commerce, consistent with international law, notably the United Nations Convention on the Law of the Sea (UNCLOS) 1982. The leaders also urged all parties to resolve disputes through peaceful means in accordance with international law. particularly UNCLOS 1982."

The first state visit by an Indian PM to Brunei just months after taking charge for a third time is a long-term strategic move to secure India's interests for the future.

Unified pension scheme: Balancing the old and new-



Modi Government unveils unified pension scheme to bridge old and new, aiming to satisfy Central and State employees



n August 24, 2024, the Union government announced the new Unified Pension Scheme (UPS) for central government employees. In fact, what looked like a well-orchestrated action plan, on the following day the BJPled government in Maharashtra approved the implementation of the Scheme for its employees. Madhya Pradesh government is likely to implement the UPS soon. The above announcements are in response to the earlier decisions of Opposition-ruled States, including Rajasthan, Chhattisgarh (before the November 2023 elections), Jharkhand, Himachal Pradesh (HP) and Punjab to revert to the old pension system (OPS) which it felt tilted the electoral pendulum towards those parties, particularly in HP. Fearing a repeat during the upcoming elections and Congress having already announced its intent to revert to OPS in Maharashtra, Modi seems to have gone for a preemptory move. Generally, employees of both the central and State governments who joined service after January 1, 2004, and are covered under the national pension scheme (NPS) have been uncomfortable with it. They have een demanding the restoration of the OPS which opposition-ruled states promised. Now, the Centre and BJP-ruled states have come up with the UPS hoping this will satisfy them. Will it? Under the OPS, retired employees received 50 per cent of their last drawn salary as a monthly pension. Just as the government offers its employees an adjustment in dearness allowance or DA to offset the increase in the cost of living, the monthly payouts of pensioners also increase to provide for DA. A government employee under OPS could not have got anything better. He was entitled to a decent 'pre-determined' monthly amount; the pension was fully protected against inflation and got it as long as he lived. After death, his wife gets the same amount for seven years and thereafter the family pension is around 60 per cent of

this amount till she is alive. However,

due to the addition to the pensioners' club every year, higher salaries of those joining, inflation indexation, increased longevity and so on. In 1990-91, the Centre's pension bill was Rs 3,272 crore. By 2020-21, it had jumped 58 times to Rs 190,886 crore. For all states, it shot up from Rs 3,131 crore in 1990-91 to Rs 386,001 crore in 2020-21 or 125 times.

Financial prudence requires that every year, the government set aside capital which together with return accruing thereon would create a growing corpus sufficient to pay for the pension liabilities on a sustainable basis thus avoid-ing any stress on the budget. But, that was never done. Instead, both the Centre and states have followed what in jargon is known as 'pay-as-you-go'. This has made the present generation of taxpayers bear the continuously rising burden of pensioners.

To deal with these pitfalls, the then UPA dispensation introduced the NPS for government employees joining service from January 1, 2004. Unlike OPS where the employee doesn't contribute anything, NPS is a contributory pension scheme under which employees contribute 10 per cent of their salary (Basic + DA). The government also contributes 14 per cent towards the employees' NPS accounts. The money is invested in multiple investment avenues i.e. equity, government bonds etc where it grows into a sizeable corpus by the time an employee reaches retirement age.On retirement, she is allowed to withdraw 60 per cent of the corpus (this is tax-free), and buy an annuity from the remaining 40 per cent. NPS offers a selffinancing and fully funded arrangement for discharging pension liabilities in which the state knows 'how much it has to con-

There won't be any major stress

on the contribution made, the age of joining, the type of investment, and the income accruing from that investment. The NPS is good for the fiscal health of the government. However, from the pensioner's angle, it doesn't match the OPS. Modi has brought a new UPS to bridge the gap between the two. Does it?Under UPS, which kicks in from April 1, 2025, employees who joined the service after January 1, 2004, and have worked for 25 years or more, after retirement, will be given 50 per cent of their basic average salary of the last 12 months as pension every month. However, employees who have served less than 25 years will get proportionately less or Rs. 10,000 per month minimum pension to employees who have served for a minimum of 10 years.If an employee dies on or pefore retirement, then the husband or wife will be given a pension, but the pension amount will be 60 per cent of the pension for the return of capital to the received by the employee imme- heirs of the pensioner in the diately before her or his demise. Employees who have already retired or retiring on or before 31 March 2025, with arrears, will be eligible under UPS.The Scheme offers an adjustment in DA on assured pension, assured family pension and assured minimum pension. The DA will be calculated based on the All India Consumer Price Index for Industrial Workers (AICPI-IW) as in the case of service employees. How will the government fund it? It will build a pension corpus out of the employee contribution of 10 per cent (of basic pay plus DA) and the government's contribution of 18.5 per cent. The pension corpus will be divided into two portions: an individual pension fund (IPF) to which the employee's contribution of 10 per

remaining 8.5 per cent contribution of the government.

The employee can exercise an investment choice for the IPF alone. The employees looking for higher pensions will have the option to get their pension monies (from IPF alone) invested in high-risk instruments for better returns. However, they will have to forego the UPS guarantees viz. monthly pension payouts of 50 per cent of the final service year's monthly pay, with full inflation adjustment.UPS guarantees will only be for those who opt for the "default investment option" which means an employee should leave it entirely to the government to manage the IPF besides the 'pool corpus. the former has anyway no claim. Needless to say, the 'pool corpus' will be used to make up for the shortfall in the returns generated from the investment of the IPF to ensure a 50 per cent pension.

Under UPS, there is no provision event of her death. This makes perfect sense as one can't have the cake and eat it too. to UPS is a good move. It gives what the OPS gave even while preserving the good features of NPS like self-financing for dis-charging pension liabilities. It puts a little extra burden on the taxpayers being the extra 4.5 per cent of the government's contribution (18.5 per cent under UPS against 14 per cent under NPS). One wonders whether this will fully satisfy the employees. The answer is 'Yes' if they see reason. It will be 'No' if they don't. For instance, they could still argue under OPS, they were getting a 50 per cent pension without having to contribute even a Rupee whereas under UPS, an employee has to contribute 10 per cent of basic pay plus DA every month. Macron names Barnier Netanyahu demands control of Gaza's border with Egypt

AP JERUSALEM

Tsraeli Prime Minister Benjamin Netanyahu said Wednesday that Israel must keep open-ended control of Gazas border with Egypt, digging in on his stance on an issue that has threatened to derail cease-fire efforts.

Netanyahu's comments came as the United States is developing a new proposal for a cease-fire and hostage release, hoping to break a long deadlock and bring an end to the nearly 11-monthold war. The question of Israeli control of the Philadelphi corridor -- a narrow strip of land along Gaza's border with Egypt, seized by troops in May -- has become a central obstacle in the talks. Hamas has demanded an eventual full Israeli withdrawal from Gaza in the multi-phase Oatar, has also demanded a concrete timeline for Israeli troops to leave the Philadelphi corridor. And on Wednesday, the United Arab Emirates, which established formal ties with Israel in the 2020 Abraham Accords, also criticized the Israeli stance. Speaking to foreign journalists, Netanyahu repeated his stance that Israel must maintain its hold on the border to prevent Hamas from rearming by smuggling weapons into Gaza. He said it was a vital part of the war goal of ensuring Hamas cannot repeat its Oct. 7 attack on Israel.

"Gaza must be demilitarized, and this can only happen if the Philadelphi corridor remains under firm control," he said, claiming Israeli troops had dis-

Hasina must stay silent in India till B'desh seeks her extradition: Yunus

Muhammad Yunus, the head of Bangladesh's interim government, has said that former prime minister Sheikh Hasina making political remarks from India is an "unfriendly gesture", asserting that she must remain silent to prevent the discomfort to both countries until Dhaka requests her extradition.

"If India wants to keep her until the time Bangladesh (government) wants her back, the condition would be that she has to keep quiet," he said. In an interview with PTI at his official residence in Dhaka, Yunus, who was appointed the country's Chief Advisor after Hasina's ouster, stressed that while Bangladesh values strong ties with India, New Delhi must move "beyond the narrative that portrays every other political party except Awami League as Islamist and that the counwithout Sheikh Hasina?

"No one is comfortable with her stance there in India because we want her back to try her. She is there in India and at times she is talking, which is problematic. Had she been quiet, we would have forgotten it; people would have also forgotten it as she would have been in her own world. But sitting in India, she is speaking and giving instructions. No one likes it," he said. Yunus was apparently referring to Hasina's statement on August 13 in which she demanded "justice", saying those involved in recent "terror acts", killings and vandalism must be investigated, identified and punished."It is not good for us or for India. There is discomfort regarding it," he told PTI. Following unprecedented antigovernment protests that peaked on August 5, Hasina resigned as prime minister and fled to India. Her presence in India for nearly four weeks has fuelled speculation in

Bangladesh. When asked whether Bangladesh has communicated its stance to India, Yunus said it has been conveyed verbally and quite firmly that she should keep quiet."Everyone understands it. We have said quite firmly that she should keep quiet. This is an unfriendly gesture towards us; she has been given shelter there and she is campaigning from there. It is not that she has gone there on a normal course. She has fled following a people's uprising and public anger," he said. Yunus stated that the interim government is committed to ensuring justice for the people of Bangladesh against the atrocities, and justice requires that she be brought back to the country "Yes, she has to be brought back or else the people of Bangladesh won't be at peace. The kind of atrocities she has committed

Top poll officials resign amid political transition

Dhaka (PTI): Bangladesh's entire five-member election commission, headed by Chief Election Commissioner Kazi Habibul Awal, resigned on Thursday, amid a massive political transition, marking the first time the country's Election Commission has stepped down before the completion of its

Awal was appointed as CEC for a five-year term in February 2022. Army troops were guarding inside and at the election commission office premises as a large number of protestors rallied in front of the building at Agargaon area in the capital, chanting slogans against Awal and other commission members. The commission came under outrage, particularly for conducting the January 7 general election boycotted by most parties, including the main opposition Bangladesh Nationalist Party (BNP), which resulted in the re-election of Sheikh Hasina's Awami League for the fourth consecutive term. Addressing reporters at a press conference in his office, Awal said in the 53-year history of Bangladesh, there is no instance that any election commission voluntarily resigned without completing its term. The CEC and the other commissioners - Brig Gen Md Ahsan Habib Khan (Retd), Rashida Sultana, Md Alamgir and Md Anisur Rahman – resigned exactly one month after the fall of Sheikh Hasina's government on August 5.

Prime Minister Narendra Modi, in his Independence Day address from the ramparts of the Red Fort on August 15, expressed hope that the situation in violence-hit Bangladesh would return to normal soon and stated that 1.4 billion Indians are concerned about the safety of Hindus and minorities in the neighbouring country. The 84-year-old Nobel laureate emphasised the need for India and Bangladesh to work together to improve their currently strained relationship.

The suspect was fatally wounded in an area near the consulate and a museum on the city's Nazi-era history after officers were alerted to man carrying a "long gun." There was no indication that anyone else was hurt. According to a police spokesperson, officers were alerted to a person carrying a "long gun" in the Karolinenplatz area, near downtown Munich, at around 9 am. There was then an exchange of shots in which the suspect sustained fatal injuries, but there no was no indication that anyone



The artisans of Pratap Bagh, like Mohini, Rekha, Sonu and Kamla, bring a unique blend of dedication, skill and devotion to their craft. Despite facing challenges such as rising costs of materials, intricate designs and financial uncertainties, they continue to pour their hearts into creating beautiful idols of Lord Ganesha. Their passion is truly inspiring, driven by both their love for their work and their deep devotion to

Mohini's approach to her work is remarkable. She sources plain murtis from Kolkata and transforms them with her own hands, turning them into vibrant, beautifully decorated idols. "I personally select the pearl necklaces from Chandni Chowk," she explains, and her years of experience allow her to complete each one in just 15 minutes. The transformation from a plain clay figure to a colourful deity, embellished with pearls and intricate designs, is a tribute to her expertise and devotion. Mohini's work reflects not just artistic skill but also a deep spiritual connection, infusing each idol with a unique sense of reverence and love. The prices of her creations range from as little as ₹300 to as much as ₹30,000 with most people opting for smaller idols for their homes, while larger ones are chosen for

community pandals. Rekha, an artisan from Pratap Bagh, has been dedicated to idol-making for many years, a tradition she proudly continues. She explains that it takes them about "4 to 5 months" to prepare these beautiful idols, highlighting the dedication and effort involved in each piece. "Everything is done by hand," she emphasises. From moulding the clay to carefully painting and decorating each idol, the entire process is meticulous and labourintensive.

Walking through the lanes of Pratap Bagh, one cannot help but feel a deep sense of admiration seeing women like Mohini and Rekha leading their stalls. Every stall is filled with the bustling energy of women hard at work, their hands moving with practiced precision as they shape and paint the idols. It is a powerful sight, reflecting not just the artistry involved but also the empowerment of these women who bring beauty and devotion to life through their craft.

The dedication of these artisans stands out as a remarkable example of resilience. They face many hardships, yet their pride and joy in their work remain evident. Their craft is more than just a job; it is a calling, a deeprooted part of their identity that connects them to the community and the divine. harambir shattered the Asian record to win the gold medal while compatriot Pranav Soorma clinched the silver as Indian club throwers dominated the men's F51 event at the Paralympics here

After four fouled attempts, the 35-year-old world championships bronze medallist from Sonepat, Dharambir hurled the club to a distance of 34.92m in his fifth attempt to claim the top spot on the podium on Wednesday.

Soorma, who injured his spinal chord at 16 when a cement sheet fell on his head, then produced a throw of 34.59m in his first attempt but the 29-year-old from Faridabad couldn't better and get past Dharambir as India completed a one-two.

The third Indian in the fray, 2017 world championship silver medallist, trailblazing Indian para-athlete and Dharmbir's menton Amit Kumar Saroha, however, fin-ished last with a best effort of

Serbia's Filip Graovac bagged the bronze, courtesy a 34.18m throw in his second attempt. The F51 club throw event is for athletes who have movement affected to a high degree in the trunk, legs and hands.

Dharambir faced a life-altering accident when a misjudged



dive into a canal left him paralyzed from the waist down. Para-sports gave him a new direction in life when he was introduced to it by fellow para-athlete Amit Kumar Saroha. Within two years, Dharambir

He has since earned multiple medals for India, including a silver at the 2022 Asian Para Games.

 $D_{\text{pected, whether in}}^{\text{ealing with the unex-}}$ archery or life in general, is no big deal for Harvinder Singh. He has aced the anticipation game thanks to the hard lessons that came his

The 33-year-old from Haryana, who scripted history by becoming the first Indian archer to win a Paralympic gold, has impaired legs owing to a dengue treatment gone wrong when he was just one year old but instead of lamenting his fate, he chose to become bigger than his circumstances. Harvinder's journey to Paralympic glory began with a bronze three years back in Tokyo, which made him the first Indian to finish on the Games podium.

On Wednesday, he showed neither fatigue nor nerves to



secure five back-to-back wins in a day to bag his second successive Paralympic medal in recurve open category, bettering the previous performance by quite a margin. All his achievements are a first in Indian archery. And when he is not shooting down medals, Harvinder is busy pursuing a
