Conducts aerial survey of flood-hit areas in Eluru dist

"I have personally experienced all the problems that you are facing and I will do justice for each and everythe Chief Minister, Chandrababu Naidu, on Wednesday assured all the flood victims.

Chandrababu conducted an aerial survey of all the flood-affected areas in Éluru district aboard a helicopter and later held a review meeting with the officials at the Sir CR Reddy Degree College auditorium. They particularly discussed the prevailing situation of Kolleru Lake, Upputeru and Tammileru.

Later, interacting with the flood victims, the Chief Minister said the whole

Seven people were killed and two injured when a mini-truck they were travelling in overturned at Chilakavari Pakala of Chinnayagudem on the highway connecting East and West Godavari districts. The mini-truck, laden with cashew nuts, was on its way from Borrampalem of Eluru district to Tadimalla in East Godavari dis-

Police said the accident occurred when the driver lost control and the vehicle skid off the road and overturned in the adjoining agricultural field.

Nine labourers, who were travelling on the mini-truck, got trapped under the sacks of cashew nuts. While seven of them died on the spot, the police rescued two others and shifted them to a nearby hospital. The police, with the help of locals, pulled out the bodies from beneath the sacks and shifted them to Kovvuru Government Hospital

PNS NEW DELHI The Union Cabinet on Wednesday approved an outlay of Rs 12,461

crore to support the development of 31,350 MW hydropower projects to

The Union Cabinet, chaired by Prime Minister Narendra Modi, has approved the proposal of the Ministry of Power for modification of the scheme of budgetary support for the cost of enabling infrastructure for Hydro Electric Projects (HEP) with a total outlay of Rs 12,461 crore, an official statement said. According to the statement, the scheme will be implemented from FY2024-25 to FY2031-32.

The limit of the budgetary support for the cost of enabling infrastructure has been rationalised to Rs 1 crore per MW for projects up to 200 MW capacity and Rs 200 crore plus Rs 0.75 crore per MW for projects above 200 MW capacity.

For exceptional cases the limit of budgetary support may go up to Rs 1.5 crore/MW provided sufficient iustification exists.

The scheme has a total outlay of Rs 12,461 crore for cumulative generation capacity of about 31,350 MW to be implemented from FY 2024-25 to FY 2031-32, the statement said. The scheme will be applicable to all hydro power projects of more than 25 MW capacity, including the private sector projects which have been allotted on a



applicable to all hydro power projects of more than 25 MW capacity, including the private sector projects which have been allotted on a transparent basis.

transparent basis.

This scheme will also be applicable to all pumped storage projects (PSPs) including captive/merchant PSPs, provided the project has been allotted on a transparent basis.

A cumulative PSP capacity of about 15,000 MW would be supported under the scheme. The projects whose Letter of Award of first major package is issued up to June 30, 2028 would be considered under this scheme. The statement said that the move

would widen the ambit of the budgetary support for cost of enabling infrastructure by including four more items apart from construction of roads and bridges.

MP Sivanath vows to drain out floodwater in 24 hrs PNS VIJAYAWADA

In a determined response to the rising concerns of flood-affected residents, Vijayawada MP Kesineni Sivanath assured that stagnant floodwaters in Jakkampudi and Ambapuram within the Mylavaram constituency will be drained within 24 hours. On Wednesday, Minister P Narayana, MLA Kolikapudi Srinivasa Rao, and MP Sivanath visited the flood-affected regions to assess the situation firsthand.

During the visit, MP Sivanath emphasised that under Minister Narayana's leadership, measures have already begun to tackle the floodwater accumulation in critical areas such as Jakkampudi Colony-Pipula Road and Inner Ring Road. 

AP shines once again in EoDB Rankings

concerning the Telugu states worth discussing in relation to the latest Ease of Doing Business (EoDB) rankings. First, despite former AP chief minister Y.S. Jagan Mohan Reddy's apparent disregard for the efforts made under Chandrababu Naidu's leadership, Andhra Pradesh continues to secure top positions. Second, Telangana's former minister K.T. Rama Rao attempted to shift blame for Telangana's poor performance in the EoDB rankings onto the current Congress government, sidestepping his own administration's role in the decline.

The EoDB rankings were introduced by the Union government in 2014, with the main objective of fostering competition among the states in India by encouraging reforms to make business operations smoother. The Centre assess which states were making it easier to do business. Based on this framework, the rankings were released four times: in 2015, 2017, 2019, and most recently.

The key point is that, ever since the rankings started, the Telugu states have been highly competitive. In 2015, Andhra Pradesh (AP) secured the second spot, while Telangana ranked 13th. Determined to improve, then minister KTR placed significant focus on the rankings, and by 2017, Telangana had made substantial progress, with AP securing first position and Telangana coming second.

The new Telugu states' competitive rise in the business rankings even gained national recognition. By 2019, AP once again secured the top spot, with Telangana ranking third. In the latest EoDB rank-

government, AP once again claimed second place. This means that, since the EoDB rankings began, Andhra Pradesh has consistently been in the top ranks, achieving first or second place every time.

The first rankings were released under then chief minister Chandrababu Naidu, with then-IT Minister Nara Lokesh making considerable efforts to improve AP's business environment. It was widely acknowledged, even by renowned business journalists like Swaminathan Anklesaria Aiyar, that Naidu's leadership enabled AP to compete with more industrially advanced states like Tamil Nadu, Karnataka and Maharashtra. Telangana also advanced in the rankings, with KTR's efforts playing a crucial role in moving from 13th to second place.

But in the latest rankings, two key observations emerge.

Let's first examine AP's ranking. As mentioned earlier, AP has consistently remained in the top two positions. The third set of rankings was released for the year 2020, when YS Jagan Mohan Reddy served as the chief minister. Despite that, AP still managed to top the rankings, and the YSRCP government proudly

claimed credit. However, it is interesting to note that when Jagan was in the Opposition, he had ridiculed the EoDB rankings, dismissing them as a media fabrication.

Despite becoming chief minister in 2019, Jagan continued to make dismissive remarks about the rankings. His attempts to defame the rankings failed to acknowledge their value, even as AP was recognised again in the 2020 rankings (for the year 2019) clearly not due to his administration, but due to the groundwork laid by the previous TDP government.

In the latest EoDB rankings for 2022 (announced on September 5 by the Centre); A P once again secured second place. So, should Jagan's government receive credit? Given Jagan's earlier disdain for these rankings, it seems unlikely that his administration actively pursued this recognition. Thus, it is more plausible that the foundations laid during the 2014-2019 period contributed to AP's continued success in

these rankings.
Now, let's look at Telangana. As noted earlier, Telangana had previously secured 13th, second, and third positions in past rankings. However, in the most recent EoDB rankings, Telangana's name is conspicuously absent. KTR responded to this by tweeting, blaming the Congress government under Revanth Reddy for the decline. "The latest Ease of Doing Business (EoDB) reformers rankings reflect the misrule of the Revanth government in Telangana," he observed.

However, there's a catch. The rankings KTR referred to were for 2022 -- a period when the BRS government, led by KCR, was in power. Therefore, the responsibility for this failure lies with KTR's own admin-

KTR's hasty criticism of the Congress government overlooks this critical point. While he had worked hard during BRS' tenure to compete with the TDP government, Telangana's decline in the rankings highlights a lack of consistency and follow-up Interestingly, KTR blamed the Naidu government in 2016 for 'stealing' its ease of doing business data. His government even lodged a complaint alleging theft of website information and template copyrights with its cybercrime police. But it seems AP continued to blaze a trail in securing top rankings, while Telangana lagged due to its political leaders.

Ultimately, both Jagan and KTR have shown that their political priorities often overshadow their commitment to improving their states.

Sealyan team begins operation to remove sand boats

PNS VISAKHAPATNAM

A challenging operation is currently underway at the Prakasam Barrage to remove heavy sand boats, each weighing 40 tonnes, that are stuck at the barrage gates. Initial efforts to lift the boats using cranes proved unsuccessful, leading Water Resources Department (WRD) authorities to decide on cutting the boats into smaller parts for easier removal.

On Tuesday, Beckham Infra, Hyderabad engineers attempted to remove the boats but were unsuccessful. Recognising the complexity of the task, the State government entrusted the operation to Sealyan, an experienced Visakhapatnam-based diving team known for handling similar operations, including work at the Pulichintala dam. On Wednesday,

Sealyan's team arrived at Prakasam Barrage and commenced the challenging task of breaking the boats.

The diving team, equipped with modern gear and gas cutters, began the process by scuba diving 12 feet underwater with

oxygen cylinders to cut the boats into manageable pieces. Working in rotations, two divers spent an hour at a time

cutting through the boats. Despite their efforts, none of the boats were fully removed on the second day of operations. Water Resources Minister

Nimmala Ramanaidu visited the Prakasam Barrage to inspect the progress and enquired about the ongoing work with WRD officials. He urged the team to expedite the process, emphasising the need for quick action to resolve the issue. Meanwhile, a large number of journalists from both print and electronic media, along with photographers and videographers, gathered at the Prakasam Barrage to cover the removal operation of the sand boats stuck in River Krishna.

However, as the process

faced significant delays, the journalists were left waiting for extended periods. Many of them eventually sat

on the footpath of the barrage, awaiting updates and the chance to document the operation once it progressed.

'Fish Andhra' initiative fails, outlets closed

Scheme aimed to benefit unemployed individuals from SC, ST, BC, and minority communities

The ambitious Fish Andhra initiative, introduced three years ago by the YSRCP government to create employment through fish-related businesses, has failed to live up to its expectations. Despite its initial promise, none of the outlets in the district are operational today.

Under the Pradhana Mantri Mathsya Sampadha Yojana (PMMSY) in collaboration with the Central and State governments, the Fisheries Department established Fish Andhra units in villages across

the district. These units were designed to sell fish, prawns, and crabs and were targeted at unemployed individuals from SC, ST, BC, and minority communities. With each unit valued at Rs 2.5 lakh, the government promised substantial subsidies 60 per cent for SCs and STs, 40 per cent for BCs, and 50 per cent for minorities. To further ease participation, offi-cials assured that only 10 per anonymity. cent of the amount needed to be invested by the beneficiaries, while the remaining funds

In Chodavaram and Madugula constituencies, a total of 19 outlets were opened under the scheme. Today, none of them are functional. "This scheme had the potential to provide a livelihood for many unemployed youth, but due to poor planning and execution, it has failed miserably," said a local official on condition of

Beneficiaries are now calling on the government to address the issues plaguing the scheme and provide the necessary support to revive the Fish Andhra

'Med colleges only on paper under BRS'

Vijayawada Municipal Corporation Commissioner Dhyanachandra is actively addressing the aftermath of flooding in various parts of the city, by touring the affected areas and providing guidance to residents. ITDA introduces Mauritius pineapple to farmers

Mauritius pineapple variety to be cultivated over 90 acres in Seethampeta, Bhamini mandals

The Integrated Tribal Development Agency (ITDA) is set to revolutionise the fortunes of local pineapple farmers in Seethampeta by introducing the Mauritius pineapple variety. This move addresses the long-standing challenges faced by farmers growing the local Simhachalam variety, which has struggled with poor returns due to subpar quality and limited storage

Mauritius pineapple variety cultivated over 90 acres in Seethampeta and Bhamini mandals, marking a significant shift from the less lucrative Simhachalam variety. "The Simhachalam variety has proven to be a poor performer," said SV Ganesh, Project/Horticulture Officer (PHO) at ITDA, Seethampeta. "It's slightly sour, of low quality, and has a limited storage life, forcing farmers to sell at reduced prices. In contrast, the Mauritius pineap-

The pilot project will see the ple variety offers a promising alter-



native. "It is a game-changer," Ganesh explained. "It boasts a longer storage life and yields heavier fruit, selling at approximately Rs 50 per kg, providing a much-needed boost in market value." Despite past setbacks, ITDA remains optimistic. "We're adopting the Mauritius variety on an experimental basis. The input costs are similar, but the potential for higher

returns is substantial," Ganesh noted. The initiative is a strategic effort to improve the economic conditions of local farmers. By enhancing the

profitability and sustainability of pineapple farming, ITDA aims to provide farmers with a viable path to financial stability and success. The call for tenders to procure Mauritius pineapple suckers marks the beginning of a new chapter in the region's agricultural landscape. "The introduction of the Mauritius variety is a crucial step towards transforming the local pineapple industry," said a local farmer. "We're hopeful that this new variety will bring better returns and improve our livelihoods.

Army conducts emergency relief operations at Kandrakota



Presidential debate showdown

In a heated TV debate, Harris and Trump present sharply contrasting visions on issues like healthcare and economy

he 2024 presidential race is shaping up to be one of the most intense and polarised" in US history. At the forefront of this political battle is a head-to-head TV debate between two defining figures—Vice President Kamala Harris and former President Donald Trump. Their exchange, filled with sharp contrasts in policy, tone, and vision for America, laid bare the deep ideological divide within the nation. Vice President Kamala Harris took the stage emphasising unity, justice, and inclusivity. Known for her dynamic speaking style and sharp prosecutorial background, she framed her narrative as one that focuses on healing America's divisions while pushing for progressive reforms. However, in most of the debate, he looked less confident and defensive, unlike his debate with Joe Biden where he was more aggressive. Besides, he was floored by Kamala's facts that he was criticised by his staff and even Republicans including Dick Chenny were rooting for her. His handling of key issues like the COVID-19 pandemic and the January 6 Capitol riot also came up in the debate which further receded his confidence and put him on the backfoot. The big question is who resonates more with the people and who would eventually win. Right now, it looks like a fair competition but with Kamala having a slight edge, though it would be folly to disregard Trump's fanbase and constituency which is proactive and loud. Many of the cherished goals of Kamala like climate action, Israel policy, and Gun policy do not go down well with many Americans who would be looking up to Trump as their representative. Trump, continues to resonate with a significant portion of the American population—particularly white, rural, and working-class—who feel disconnected from the progressive direction the country has taken in recent years. His simplistic ideas may not work but they do sway people.

The statement outlined several concerns, including misinformation given to the victim's parents, alleged tampering of the crime scene, delays in filing the FIR, and the hasty disposal of the body despite the parents' request for more time. Furthermore, it noted that the transfer and reappointment of the Principal of the hospital raised suspicions about the state's intentions, as did the Kolkata Police's alleged attempts to cover up the crime scene tampering. The making of Kerala's catastrophe



Despite warnings from experts about the perils of unchecked quarrying and deforestation in the Western Ghats, successive governments failed to act, leading to Wayanad disaster



K Pottekkat, who could be rated as India's best travelogue writer has elaborated on his 1955 visit to Finland. "The country's area is 1,30,119 sq miles out of which 71 per cent is forests. Finland's main source of income is the pine trees grown in its forests. But to get permission from the government to cut down a single pine tree, one has to furnish proof that he has planted six pine saplings," writes Pottekkat in his memoirs.

He was a delegate to the World Peace Council meeting held in Helsinki, the capital city. In 2024, despite a massive industrialisation drive, the country has the tenth highest percentage of forest cover in the world. Pottekkat hailed from Kozhikode, the neighbouring district of Wayanad.

Once the region was full of evergreen forests filled with exotic trees, plants and flowers. Folklore is that the tribal youth who led a team of Englishmen to Wavanad was shot dead by the visitors to ensure that no more outsiders entered the

But Wayanad has become a teardrop since 30 July 2024 as landslides and flash floods struck the district in quick succession swallowing hundreds of people and their houses. Pinarayi Vijayan, the chief minister, has asked the Centre to release Rs 2,000 crore as the first instalment towards the rescue, rehabilitation and reconstruction mission to be undertaken by the Government of Kerala.

He also blamed the Centre for its failure to provide the exact date, time and place of the natural disaster and has vowed to establish the State's early warning system for floods, landslides and heavy rainfalls. Vijayan will outclass the best of the entrepreneurs in the skill of mobilization of resources for the Chief Minister's

Disaster Relief Fund. All media briefings by Vijayan end with him announcing the details of persons who have contributed to the CMDRF in the aftermath of landslides and deluge that devastated Wayanad. But what stands out is the generous offer made by High Range Rural Development Society,

a non-governmental organisation, which came forward to build houses for all those who lost their dwelling places in the flash floods. According to the Kerala Government's estimate, 500 homes were washed away by the gushing waters. The HRDS told the Government that it would rebuild/construct 500 safe and secured houses each of 700 sq ft and costing Rs 10 lakh free of

The NGO also told the government that it would help the landslide victims to set up group farming so that they could earn a reasonably fair monthly income. All the 500 houses to be constructed by the HRDS will feature self-contained guest rooms which could be rented out as part of the homestay programme. But Vijayan and his comrades are cold o the offer The Centre has asked Vijayan to submit details of the losses suffered in nature's fury and how the State would go ahead with the rehabilitation and reconstruction. Though the disaster struck nearly a month ago, the Government has yet to come out with the details of the losses. In the aftermath of the 2018 floods, Vijayan had demanded Rs 40,000 crore as flood relief which included Rs 20,000 crore to rebuild the roads washed away in the deluge.

But senior officials who took stock of the situation once the flood water receded had told that roads could be rebuilt with Rs5,800 crore. Microsoft acquires 16.4 acre land in Pune for Rs 520 cr

lobal tech giant Microsoft has bought 16.4 acres of land in Pune for Rs 520 crore, according to real estate consultant Square Yards. "As per the registration document reviewed by Square Yards, Microsoft's Indian arm, Microsoft Corporation (India) Pvt Ltd, acquired 66,414.5 square meters (around 16.4 acres) of prime land in Pune's Hinjewadi. The transaction, registered in August 2024, involved the purchase of land from Indo Global Infotech City LLP," the consultant said in a statement. The deal incurred a stamp duty of Rs 31.18 crore and a registration fee of Rs 30,000, it added. Microsoft did not share any comment on this deal. In 2022, the company also acquired a 25-acre plot in Pimpri-Chinchwad for Rs 328 crore. Earlier this year, Microsoft secured 48 acres of land in Hyderabad for Rs 267 crore. Both deals are part of Microsoft's broader strategy to expand its presence in India, particularly within its data centre

The January-June period saw private credit transactions of over \$ 6 billion in 96 deals, and the last two-and-a-half years have seen over \$ 20 billion being deployed in the emerging alternative serving the credit needs of Indian companies. Major deals were witnessed across real estate, infrastructure, and healthcare sectors in the first half of the year, the report by EY said. Domestic funds are gaining traction and market share in the private credit space leveraging local expertise and the influence of lower-cost domestic money, it said. The first half of the year saw Reliance Logistics and Warehousing, Vedanta Semiconductors, and Matrix Pharma collectively raising approximately \$ 1.3 billion.



Labour unrest at Sriperumbudur industrial belt

abour unrest in the industrial belt of neighbouring Sriperumbudur emerged as a section of employees belonging to Korean electronics giant Samsung have resorted to a strike, pressing for various demands including wage revision, sources said on Wednesday. The facility located about 40 km from here in Sriperumbudur produces various consumer durable products across categories. It employs about 1,750 people who work in various shifts, round-the-clock. Since Monday, a section of workers went on strike demanding wage revision, recognising their union among others, sources said. "We have been informing the management but they did not heed to our demands. We need a better pay package, and demand recognition for the union," they said. According to the agitating employees, Samsung has formed a union in July comprising about 100 of them which was not agreed upon by the workers who are on strike. "Already there is a union backed by the CITU (Centre for Indian Trade Unions).

Eyeing 10 per cent share of patents in 6G services for India: Scindia

After the fastest 5G rollout, India is targeting a tenth of all worldwide patents in sixth generation mobile services, Union Telecom Minister Jyotiraditya M Scindia said on Wednesday.

He was delivering a keynote address at the 51st edition of the AIMA National Management Convention

"Whilst we have the fastest growing 5G network in the world, in 22 months building out 4.5 lakh 4G towers, building out our own 4G technology for BSNL, we are also embarking on our path towards 6G by setting up the Bharat 6G Alliance.

"Our target is to ensure 10 per cent of international worldwide patents for India in 6G through this Bharat 6G alliance in the days to come,"

India has emerged as a beacon of hope and stability amid tremendous amount of global economic and social turbulence, the minister said.





Uniting Kerala diaspora in Hyderabad

he season of festivals has already begun and now lately, we've been celebrating the annual harvest and cultural festival celebrated mostly by the people of Kerala, Onam. Wednesday marked the main festive day of Onam, which was *Thiruvonam*.

Making the celebrations more eventful, *The Pioneer* brings to you a community in Hyderabad, specially dedicated for the Malayalis.

It was in 2005, far from the lush landscapes of Kerala, that a group of passionate individuals gathered to form a hope of tradition and community in the bustling city of Hyderabad. The Nair Service Society (NSS) had existed in the hearts and history of Kerala since 1914, founded by the visionary Mannathu Padmanabhan, but its roots were about to spread into the Deccan plateau, creating a bridge between two regions that shared a bond of culture and heritage.

Suresh Kumar, the society's general secretary and one of its founding members in Hyderabad, recalls those early days vividly. In this world of OTT, there's Keshav Sadhna, who is slowly but surely turning into an OTT star. His latest release, *Loop 11:47*, streaming on Zee5, is a not-so-regular concept that proves his versatility and prowess to the fullest.

Loop 11:47 centers on three roommates who embark on a spontaneous trip to break free from their boring routine and setbacks. As one person risks it all for a girl, another person leads a double life for their social media audience. The third person is struggling in his professional role with an overly authoritative boss. Their holiday turns for the worst when they find themselves stuck in a never-ending loop of the same day resetting every night, lasting for more than a year! The sci-fi show also stars Akashdeep Arora and Qabeer Singh.

Well, we have Keshav onboard for an exclusive chat with *The Pioneer*. Looking back at his journey, it's been no less than a roller coaster ride, just like many. Coming from a non-filmy background, "There's always a roller coaster of emotions. You never know what might happen next. However, having been in this field, you are emotionally and mentally prepared to take up the challenges."

College Romance or Couple Goals, Code M or 4 Thieves, Keshav has always been on the forefront to try out something new, every time a project comes his way. "Hailing from Ghaziabad and coming to Mumbai was a whole lot of a decision in itself. Choosing a field that not many parents would allow! Back then, in Ghaziabad, not many people knew that you could make a full-fledged career in this field. However, my dad had supported me a lot. Eventually, when you try out something new or learn, it takes time. For the first 4-5 years, I used to only and only give auditions, but eventually, as I did theater, things started to work."

Not that Keshav began his work with just theaters. He, like many others, got into corporate but continued doing theaters side-by-side. Then, as soon as his good acting worked, it was then that he shifted to Mumbai and rest his history!

one-fourth of the cigarette industry in India.
As per the recent reports, throughout 2023-2024, law enforcement agencies have seized illegal cigarettes across many Indian cities. In Guwahati, customs officials and railway authorities confiscated over 11 lakh sticks on

multiple

occasions, with the Assam Rifles also making seizures. Visakhapatnam saw the police and customs seize over 21 lakh sticks, while in Vijayawada, the tally reached over 103 lakh sticks, including 75 boxes. Hyderabad's police force seized 267 cartons and 4.5 lakh sticks. Additionally, Lucknow's customs officials seized over 2.12 lakh sticks and a substantial number of packs and boxes. Furthermore, Calicut Airport, Faridabad, Amritsar and Indore experienced various seizures by customs, the police and the DRI. Pune and Silchar, Raipur, Surat and Ahmedabad saw the DRI seize over 85 lakh sticks. According to Euromonitor International's 2023 report, illicit cigarette volumes in India reached 30.2 billion sticks in 2022, trailing only behind China

2023 ODI World Cup in India generated economic impact of USD 1.39 billion: ICC

The 2023 ODI World Cup in India created an "economic impact" of USD 1.39 billion with tourism among the biggest beneficiaries, according to a report released by the International Cricket Council (ICC) on Wednesday.

The Economic Impact Assessment conducted by Nielsen for the ICC, claimed that the mega-event held in October-November last year was the

biggest ever ODI World Cup.
"The ICC Men's Cricket World Cup
2023 has demonstrated the significant economic power of cricket, generating economic benefit of USD 1.39 billion (Rs 11,637 crore) for India," ICC Chief Executive, Geoff Allardice said in a statement. Australia ended India's unbeaten run in the tournament to win the trophy for a record-extending sixth time.

"The impact of tourism across the "The impact of tourism across the host cities amounted to USD 861.4 million of revenue generation, through accommodation, travel, transportation and food and beverage because of a massive influx of domestic and foreign tourists attending the matches," read an ICC statement. statement.

'The secondary and incremental spends within the economy was a key driver, generating USD 515.7 million, which was approximately 37 per cent of the total impact." However, the ICC did not specify



whether the massive figure cited in the report is actual revenue.

A record-breaking 1.25 million spectators attended the mega event, of which nearly 75 per cent were attending an ICC 50-over match for the first time ever, the report

"Nearly 55 per cent of the international respondents had previously visited India regularly, whilst an injection of new visitors thanks to the World Cup saw 19% of

thanks to the World Cup saw 19% of international attendees making their first ever visit to the country. "International travellers visited multiple tourist destinations during their stay which amounted to an economic impact of USD281.2 million and nearly 68 per cent of international attendees said that they would recommend India as a they would recommend India as a tourist destination to friends and family in the future further enhancing India's global image," read the statement from the

governing body. Over 48,000 full and part time jobs were created by the event through direct involvement in delivering the tournament, as well as other organisations across the hospitality sector, added the report.

The event created thousands of jobs and showcased India as a premier tourist destination, proving that ICC events not only engage fans passionately but also contribute significantly to the economies of our host nations," Allardice said.

ed the film in July and later in August, I flew to the US for my studies. Several people had approached my parents. However, they informed them that I wasn't interested in doing any films back then. So that's how I took a break," she said.

Talking about her film career, she says, "It's been like a joyous twist of fate for me. I am lucky and grateful that this is my profession and I like it," said Abhirami.

Her criteria for choosing a project is pretty simple; the story and her role. "The story is my driving force. I am not bothered about whether the production house is big or small, the director is new or old; I am not doing this for money; I am doing it for love," she said. Talking about her comeback,

After her re-entry, she shared, "In the last two years, I finished nearly ten films." Now, she is busy with many projects. "But I am not in a rush to do quantity of films, as I want to take it in a slow manner. I want a long career, so I am looking for interesting roles," she said. "Now I am in a very exciting part of cinema, as I am getting different roles. The new generation is coming up with incredible stories, so I am looking for different kinds of roles in the future," she said.
