RAHUL DISSENTS POLL PANEL, BJP DEFENDS

eader of Opposition (LoP) in Lok Sabha, Rahul Gandhi on Tuesday attacked Prime Minister (PM) Narendra Modi and Home Minister (HM) Amit Shah for the midnight decision to select the new Chief Election Commissioner (CEC), when the process of selection is being challenged in the Supreme Court (SC).

While Rahul who said it was "disrespectful" and "discourteous" on part of the Centre to ignore his dissent note to the CEC selection panel comprising of PM and HM, the BJP dismissed the Congress leader's criticism and accused the LoP of undermining an elected malicious" judicial activism.

The government late on Monday night appointed Gyanesh Kumar as the new CEC hours after the meeting of the PM-led selection committee in which the Leader of Opposition in Lok Sabha asked the government to defer the meeting in view of the SC hearing in the matter.

Meanwhile the SC on Tuesday said it would take up on February 19 on "priority basis" the pleas against the appointments of the CEC and election commissioners (EC) under the 2023

"During the meeting of the committee to select the next Election Commissioner, I presented a dissent note to the PM and HM, that stated: The most fundamental aspect of an independent Election Commission, free from executive interference, is the process of choosing the Election Commissioner and Chief Election Commissioner," Rahul said in a social media post.

"By violating the Supreme Court order and removing the Chief Justice of India from the committee, the Modi Government has exacerbated the concerns of hundreds of millions of voters over the integrity of our electoral process," he also said in his post while sharing his dissent note.

Rahul said as the LoP, it is his duty to uphold the ideals of Babasaheb Ambedkar and the founding leaders of the nation while holding the government to account.

In his dissent note presented before the panel, the Congress leader cited a speech of BR Ambedkar in the Constituent Assembly in June 1949 to discuss the setting up of an independent Election Commission, where he had warned about executive interference in India's democracy and the affairs of the Election Commission.

Rahul said in a judgement on March 2, 2023, the Constitutional Bench of the Supreme Court ordered the appointment of the CEC and election commissioners should be undertaken by a committee comprising the PM, the LoP and the Chief Justice of India.

SC comes to rescue of 'pervert' Allahabadia

The Supreme Court (SC) on Tuesday protected influencer Ranveer Allahbadia from arrest over his distasteful comments during a YouTube show while severely castigating him for the remarks it described as "showing a perverted mind". Several FIRs have been filed against Allahbadia, popularly known as BeerBiceps, for the comment on parents and sex on comedian Samay Raina's YouTube show "India's Got Latent". A furious court at the outset Allahbadia berated for his "unacceptable comments" on the

vomited on the YouTube show.

'The words you have used will make daughters, sisters, parents and even the society feel ashamed. It shows a perverted mind. If this is not obscenity, what is it? Why should we quash or club the FIRs against you?" asked Justice Surya Kant, who was on the bench along with Justice N Kotiswar Singh.

However, the bench agreed to the submissions of senior advocate Abhinav Chandrachud, representing the influencer, that Allahbadia be protected from arrest keeping in

show and said, "... There is something dirty in his mind which has been the same issue as well as the death threats against him.

"Are you defending the kind of language he has used?" Justice Surya Kant asked Chandrachud, who conceded that he himself was "disgusted". The senior lawyer, however, said the question was whether the remarks constituted a criminal offence as profanity per se would not amount to obscenity. "If you can try to attain cheap publicity by saying these kinds of things, there might be others also who might want to get cheap publicity by making threats," the bench said

The bench directed that no further FIRs shall be lodged against him for his comments during the YouTube show, "India's Got Latent". The top court also restrained Allahbadia and his associate influencers on the controversial YouTube show from airing any other episode till further orders. It directed Allahbadia to deposit his passport at the Thane police station and said he shall not leave the country without the prior permission of the court.

The bench directed Allahbadia to cooperate in the probe of the FIRs lodged at Maharashtra and Assam.



President approves Jain's prosecution

The case falls under the provisions of the Prevention of Money laundering Act (PMLA), The Ministry of Home Affairs (MHA) on Friday sought the President of India's approval

to prosecute former Delhi minister and AAP leader Satyendar Jain under Section 218 of the Bharatiya Nyaya Suraksha Sanhita (BNS), 2023 the alleged disproportionate assets were to the tune of Rs 1.47 crore, about 217 per cent more than Jain's known sources of income during 2015-17. The MHA has claimed that there is adequate evidence against the AAP leader to implicate him on charges of laundering money through four shell companies allegedly linked to him. Based on material received from Enforcement Directorate, he

President found sufficient evidence to grant the request, officials said Currently, out on bail, Jain has been chargesheeted by the ED. The money-laundering case stems from an August

2017 FIR filed by the Central Bureau of Investigation (CBI) against Jain and others, alleging possession of disproportionate assets. Jain had recently lost Shakur Basti seat to BJP's Karnail Singh by a margin of 20,998 votes.

Prosecution seeks death penalty for Sajjan Kumar


The prosecution has sought the death penalty for former Congress MP Sajjan Kumar who was convicted by a Delhi court last week over the killings of two Sikhs in the national capital during the 1984 anti-Sikh was committe "brutal and diabolical manner". The prosecution said the case was "graver than the Nirbhaya case" of 2012 in a written submission filed before special judge Kaveri Baweja. "The present case is graver than the Nirbhaya case as in the Nirbhaya case, a young woman was targeted but in the present case, people of a particular community were targeted," it said.

Arguments on the quantum of sentencing will take place on February 20 as the lawyers were on strike on Tuesday.

While describing the case as rare of the rarest, Additional Public prosecutor (APP) Manish Rawat in his written submissions has pressed for death penalty for the convict in view of the guidelines issued in Nirbhaya and other

Asking the convict and the victims to file their written submissions, Special judge Kaveri Baweja has listed the matter for hearing arguments on sentence on February 21. The minimum punishment for murder is life imprisonment.

Senior advocate H S Phoolka, appearing for the complainant, supported the prosecution's demand of death penalty and sought time to

GIS grand, well-organized, and result-driven. CM Yadav emphasized that the Global Investors Summit being organized to and foreign



IT department preparing to question Saurabh Sharma

Income Department is preparing to question former RTÖ constable Saurabh Sharma, his associate Chetan Singh Gaur, and Sharad Jaiswal in connection with the recovery of 52 kg of gold and Rs 11 crore in cash from a car in Mendori forest. However, the department will have to wait until their Enforcement Directorate (ED)

remand ends. The department had initially planned to summon the three for questioning post-bail, but the court has sent them to judicial custody for 14 days. As a result, the Income Tax Department has now sought a complete investigation report from both the Lokayukta Police and the ED to advance its probe into the case. Officials have indicated that if the agencies do not provide

this information voluntarily, they may approach the court to obtain it.

Key Interrogation Reports Awaited

Following the seizure of gold and cash, the Income Tax Department has already recorded the statement of Chetan Singh Gaur, the owner of the Innova car in which the valuables were found. Gaur's statement is crucial as it could provide key details about the source of the wealth. The department had been waiting for over two months to question Saurabh Sharma, but with his recent arrest, their focus has now shifted to obtaining existing interrogation reports from the inves-

tigating agencies. Since both the Lokayukta and the ED have interrogated Saurabh and his associates during remand, the Income Tax Department has requested full

ED's Findings and Income Tax

BMC puts meandering metropolitan mammals on notice

Bhopal Municipal Corporation (BMC) on Tuesday stated that notices have been issued to cattle owners and dairy operators who allow their bovines to roam freely on city roads. This action aims to prevent road accidents and the spread of filth in public areas.

Animals caught roaming by the BMC will require an identity card for their first release. For subsequent releases, both the identity card and a sworn affidavit will be necessary. Failure to comply will result in legal

The civic body had previously instructed dairy operators to keep livestock outside Bhopal's municipal limits. Animal owners violating this directive will face fines, and their animals will be sent to the pound.

response, Commissioner Harendra Narayan has directed the Deputy Commissioner of the Govardhan Branch to take action against offenders. Notices will warn animal owners against allowing their live-stock to roam freely in public spaces, on roads, or at intersections.

If animals are found causing accidents, pollution, or traffic obstructions, the corporation will impound them. If the animals are caught more than twice, they will be relocated to cow shelters. Separately, the BMC on Tuesday apprehended 36 animals roaming in various locations. These animals were sent to cattle shelters for proper care and safety.

He also stated that grand celebrations are being planned for the Gudi Padwa festival on March 30. Chief Minister Yadav said that Vikramotsav will commence from Mahashivratri, and the Jal Ganga Abhiyan will continue this year along with the Watershed programme for an extended period. Cabinet approves policies in the interest of State, investors

hief Minister Mohan Yadav chaired a cabinet meeting held at the secretriat on Tuesday. During the meeting, the cabinet approved the implementation of the Integrated Township Policy 2025 to promote private investment in real estate within urban areas. This initiative aims to boost economic activities, generate employment opportunities, and contribute to the state's GDP growth. The policy is designed to facilitate land development through land pooling, ensuring planned urban expansion. Its implementation will lead to the development of large-scale townships while allowing the continued growth of residential colonies under the existing

framework.

As per the decision, the inte- In the township policy, the state grated township policy will be implemented in development areas where adequate infrastructure facilities are available. Under this policy, the minimum land requirement for cities with a population of less than five lakh will be 10 hectares, while for cities with a population exceeding five lakh, the requirement will range between 20 to 40 hectares. Developers will be required to register with the competent authority before proceeding under this policy.

To oversee township proposals, an authoritative committee will be formed, chaired by the Principal Secretary at the state level and the Collector at the district level. The Directorate of Urban and Rural Investment will serve as the nodal agency for the implementation of the township policy.

government has authorized the authorised committee at the department level for land acquisition, external development work, timely provision of all permissions, benefit of TDR, exemption in maximum limit of agricultural land, concession on stamp duty, exemption in colony rules, ease in process for amendment in development plan, green FAR, FAR for nonconventional use of energy, FAR for additional EWS/LIG/affordable housing units and modification in land use proposed in the adopted development plan under section 23 of the Act 1973. The MSME department has been authorized to provide customized packages to mega units of MSME category classified under Industry Promotion Policy-2025.

be given for investment promotion, renewable energy will be encouraged in new industries, 48 percent assistance will be given to SC/ST and women entrepreneur units and 1.3 times assistance will be given in backward development blocks. Petrol pump employee's robbery claim was fake ing off the area, but found no leads.

Bhopal: A reported robbery involving a petrol pump employee in the Gautam Nagar area turned out to be a staged conspiracy, orchestrated by the employee himself along with two accomplices. The police uncovered the truth during a rigorous interrogation and arrested all three individuals involved in the scheme.

The incident came to light when Piyush, an employee at the Indian Oil Petrol Pump near DIG Bungalow Square, lodged a complaint on the night of February 16. HC allows 'trial run' of Carbide waste

Bhopal: Madhya Pradesh High Court on Tuesday approved a trial run for the disposal of Union Carbide's toxic waste in Pithampur. Three trial phases will be conducted, burning a total of 30 metric tonnes of waste. In the first phase, 135 kg per hour will be incinerated; 180 kg per hour in the second phase, and 270 kg per hour in the third

The court directed the state government to carry out the first phase of the trial run on February 27, with the subsequent phase scheduled for March 4 and March 10. The results of all three phases will be submitted to the Central Pollution Control Board, and a final report is due before the High Court on March 27.

The Madhya Pradesh government had initially requested a sixweek extension to dispose of 337 tonnes of Union Carbide waste, with the original deadline expiring on Tuesday. However, the sealed containers of waste have not yet been emptied.

Advocate General Prashant Singh confirmed that the state government had submitted a compliance report to the High Court regarding the disposal process. In response, the court approved the trial run, allowing the disposal to proceed.

Sandeep Raghuvanshi, who has petitioned against the toxic waste disposal, expressed concerns: "Pithampur is already severely contaminated. The groundwater is undrinkable, and air pollution is dangerously high. We have filed a petition in both the High Court and the Supreme Court, where we hope to secure a stay

Is city anti-encroachment action also anti-poor?

day after the District Collector sought the **A**immediate removal of encroachments from public spaces in the state capital, a key service lane right opposite his office remained lost to haphazard parking, illegal extensions, and municipal apathy.

The entire stretch of the lane, which starts opposite the Tehsil office and ends at the Fitness Centre run by the Bhopal Municipal Corporation (BMC), is used as a private parking space by commercial establishments.

At one point, hundreds of twowheelers stand on a part of the lane outside an automobile dealership. An electricity transformer, placed across the lane, blocks traffic and even forces pedestrians to risk their lives by walking on the main road. Accidents are not uncommon.

Home to several eateries and other business establishments,



neglect towards civic spaces in stretch is bad, the intrusions on the state capital, which continues to cause tremendous traffic woes due to these violations, suggestive of a nexus between encroachers and municipal officials.

As per norms, neighbourhood traffic can only access highways at designated spots, and vehicles—both two-wheelers and four-wheelers—are supposed to use service lanes to reach these highway entry points.

public spaces on Hoshangabad Road are even worse, with entire stretches of the service lane, on either side of the busy highway, lost to encroachments.

If a majority of encroachments in the city are pan shops, tea stalls, or other makeshift shacks built by the poor for their livelihoods, the violations of building norms and other civic misdemeanours on service lanes are caused by the

well-off in the city, who seem to have become the darlings of the civic administration.

Over the last few months, the BMC has been running a campaign to rid the city of encroachments. However, most of this campaign focuses on roadside shacks and shanties, making residents question the propriety of the drive. Many in the state capital believe

that the municipal drive is selective and only targets the poor, while the relatively wealthier folks in the city are allowed unrestrained access to public spaces, which they blatantly turn into personal or exclusive utilities. Though District Collector Kaushalendra Vikram Singh's observations on encroachments in the city on Monday are worth welcoming, it remains to be seen if his directives are heeded by the anti-encroachment squad bosses at BMC, whose behaviour, until now, has failed to reflect the pro-poor policies of the state gov-

India, Qatar to double trade to USD 28 Billion Gyanesh Kumar to take over

India and Qatar on Tuesday here agreed to double bilateral trade to USD 28 Billion over the next five years and announced elevation of their relationship to the level of strategic partnership as Prime Minster Narendra Modi held talks with Amir Sheikh Tamim Bin Hamad Al-Thani.

The two sides also signed two agreements - one on establishing strategic partnership and another on Revised Double Taxation Avoidance Agreement and signed five memoranda of understanding to strengthen economic partnership, step up ties in areas such as management of archives, and cooperation in youth affairs and sports.

The strategic partnership agreement actually elevates the present state of bilateral relationship to a strategic level. What we are looking at is deepening cooperation in fields of trade, energy security, as well as in regional and international fora," Arun Kumar Chatterjee, Secretary, Ministry of External Affairs, told reporters here.

He said Modi and the Qatari

ing. We are inclined to grant to his six-year long incarcerbail on such terms and conation. ditions as determined by the trial court. The CBI will make appropriate request to the trial court for imposing necessary conditions," said the

The top court said James would be released on bail, subject to terms and conditions decided by the trial court. The counsel for the CBI sought time saying the additional Solicitor General was unavailable for arguments. When the bench showed its inclination to grant bail, the CBI's lawyer said the plea was filed only in terms of seeking bail on medical grounds.

The report further found that development benefits often bypass vulnerable groups, with intersecting factors like age, gender, education, location and wealth exacerbating inequali-

"Poverty and education level are the two most significant factors contributing to inequality of opportunity. Poorer households in rural areas with lower levels of education are the most disadvantaged in accessing basic services such as water, sanitation and clean energy, the report said.

To bridge these gaps, ESCAP called for innovative and inclusive data collection and analysis. Nuanced and granular data will provide policymakers a clearer understanding of the realities of specific population groups especially those most at risk of being left behind.

Prayagraj airport handles over 100 flights daily amid Mahakumbh surge

Prayagraj Airport has undergone a remarkable transformation, handling over 100 flights daily-a sevenfold increase from its previous 16 flights per day before Mahakumbh-2025.

This surge in air traffic has resulted in new records for the airport, with February 16 marking the highest singleday footfall in its history, as it managed 20,297 passengers. This broke the previous record set on February 15, when the airport handled the same number of flights but with 19,822 passengers, according to airport officials.

The spike in air traffic is attributed to the massive influx of pilgrims arriving for the grand religious gathering. Official data reveals that on February 16, 10,152 passengers arrived on 60 flights, while 10,145 departed on another 60 flights. On February 15, 10,300 passengers landed, and 9,522 passengers took off.



Minister Narendra Modi on December 16, 2018, and the launch of flight operations in January 2019, the airport has rapidly expanded its capacity.

Between February 1 and 16,

2025, the airport handled 214,593 passengers across 1,288

Since its inauguration by Prime flights, averaging 13,412 passengers daily and 81 flights per day. On February 13, the airport set a record of 16,310 passengers on 96 flights, before surpassing it with 20,297 passengers on February 16. On January 13, the opening day of Mahakumbh-2025, the airport

UP Budget session starts amid Opposition uproar

The Uttar Pradesh Assembly's budget session commenced on Monday with high drama as the Samajwadi Party (SP) launched a scathing attack on the ruling Bharatiya Janata Party (BJP) over alleged financial irregularities related to Mahakumbh-2025. New CEC takes over

Gyanesh Kumar has been appointed as the next Chief Election Commissioner by the PM-led selection committee amid criticism

he senior Election Commissioner Gyanesh Kumar has been appointed as the next Chief Election Commissioner (CEC). The decision was made by the Prime Ministerled selection committee, which also named Haryana Chief Secretary Vivek Joshi as an Election Commissioner. However, the appointment has sparked controversy, with the Congress party questioning the process and alleging a lack of transparency. For decades, the Government held the power to appoint the Chief Election Commissioner and Election Commissioners. However, in 2023, the Supreme Court ruled that appointments should be made by a panel comprising the Prime Minister, the Chief Justice of India (CJI) and the Leader of the Opposition (LoP). Despite this ruling, the new CEC and Other ECs (Appointment, Conditions of Service and Term of Office) Act, 2023, replaced the CJI with a cabinet minister, a change that has been challenged in court. Gyanesh Kumar, is a seasoned bureaucrat and was appointed as an Election Commissioner in



March 2023. He has a tenure extending until January 26, 2029, meaning he will oversee critical elections, including the 2029 general elections. His selection follows the convention of appointing the senior-most Election Commissioner to the role of CEC. Gyanesh Kumar replaces Rajiv Kumar, whose term concluded recently.

The Congress party, led by Leader of Opposition Rahul Gandhi, has strongly opposed the appointment process. Gandhi submitted a dissent note during the selection committee meeting, urging the Government to defer the decision until the Supreme Court rules on the validity of the selection panel's composition.

Congress leaders Abhishek Manu Singhvi and Ajay Maken have argued that proceeding with the appointment while the court is hearing a challenge to the new selection law undermines democratic principles. The government's decision to exclude the CJI from the selection panel and desperation to elect the CEC before the judgement indeed creates an impression that the Government wants to have its way in the election of Chief Election Commissioner. Ensuring transparency and balance in selecting election officials is crucial to maintaining a fair democratic process. Meanwhile, Vivek Joshi, a 1989 batch IAS officer, is set to serve as an Election Commissioner until February 2030. The Supreme Court has yet to issue a final verdict on the legality of the new selection process. The outcome of this legal battle could shape the future of India's electoral governance for years to come. To put things in perspective, the Election Commission plays a crucial role in the government machinery during elections and can significantly impact their outcomes. However, it is often influenced by the government through the appointment of favorable officials. It was, in fact, TN Seshan who, as Chief Election Commissioner, challenged government control and brought a sense of independence to the Commission.



Bangladesh wipes out history,

shuns India at its own peril



With opposition forces emboldened, Bangladesh appears to be at a turning point, grappling with a shifting political landscape and growing internal discord

that the tremors were so strong that it felt like a bridge was collapsing.

However, the quake itself was not of a high-intensity magnitude. The gravity of the situation soon gave way to humour as social media users began sharing their reactions to the unexpected jolt. Memes and jokes flooded various platforms, with many poking fun at the situation while still conveying their fear and disbelief. While the suddenness of the earthquake understandably caused concern among residents, the quick wit and resilience of the people of Delhi-NCR were on full display as they found ways to cope with the unexpected turn of events. Like Mumbai rains, the Delhi tremor gave a tough time to people there, but it was business as usual once the tremor settled.

THE SELECTIVE NARRATIVES THAT SHAPE OUR LEGACY

History is often told from the perspective of the victors, shaping

collective memory in ways that serve those in power



t is a well-established fact that History, often, is written from the perspective of the victor, making it a one-dimensional testimony of what transpired. Thus, while for the British Imperial power, the tumultuous events of 1857 were an unsuccessful mutiny by sepoys from across the subcontinent, for us, it is the celebrated 1st War of Independence. Before being put down with unprecedented vengeance and ferocity, it ignited a spark of 'freedom' which continued to inspire generations to come, although, in the process, they sowed venomous seeds of communal discord, deftly using their devious policy of divide and rule, which continue to rile us

Not surprisingly, the events instilled such fear in the minds of our forefathers that it was several decades before any credible stirrings for a fight to overthrow the yoke of imperialism were felt. To take this forward, while Bhagat Singh & his young comrades might have been treated as terrorists/ militants/ extremists by the British, their cohorts and courts, we extoll them as valiant freedom fighters and martyrs, so much so, that more than a century after Bhagat Singh sacrificed his life for the liberation of the motherland, we are witnessing a massive surge in his following, especially in the

It is not difficult to gauge this- there is a proliferation of his photographs - on the rear of cabs and auto-rickshaws, trucks and buses, emblazoned on T-shirts, and so on. Given all this, what startled me, and raised my hackles was Rajmohan Gandhi's book, Punjab: A History from Aurangzeb to Mountbatten.

Otherwise, a well-researched and thoughtfully written book, his treat-



ment of the life and times of Bhagat Singh is rather disappointing- in a tome of more than 400 pages, there are just a few linesa cursory mention of Bhagat Singh and his comrades. Sadly, even in these lines, they are not feted as freedom fighters, but rather disparagingly, as delinquent and misguided youth, militant in their approach, hellbent on derailing the course of the freedom struggle. Well, while all of us have the liberty or freedom to form our opinion, in a broader sense, it needs to be noted that sensitivities of a significant mass of our population don't get hurt. Because, if the Butcher of Amritsar became a celebrated hero among a section of his countrymen, hailed as "the man who saved India" and a beneficiary of a fund of over £26,000, then, we need serious introspection as to how we portray our martyrs for the generations to come, because, as I repeatedly quote the words of George Santayana- "Those who cannot remember the past are condemned

The way history is written shapes how future generations perceive their past. The events of 1857 and Bhagat Singh's sacrifices remain crucial in our national consciousness, inspiring countless individuals. Yet, the selective representation of these figures in historical narratives raises concerns. When colonial figures like Dyer are glorified, while our martyrs are downplayed or misrepresented, it calls for reflection. As a society, we must ensure that our heroes are remembered with the respect they deserve. After all, history is not just about the past—it is a guide for the future, reminding us never to forget our hard-fought struggles.

Balancing growth with fiscal discipline



Key measures, including tax reliefs and incentives for private sector, reflect a balanced approach to making India a developed economy by 2047



theme that reverberates in the Union Budget for FY 2025-26 presented by Finance Minister Nirmala Sitharaman on February 1, 2025, is 'sustaining the momentum of high economic growth alongside sticking to fiscal consolidation. During FY 2024-25, the GDP growth (gross domestic product) is estimated at 6.4 per cent which is more or less close to the 6.5 per cent - 7 per cent projected in the Economic Survey (ES) for 2023-24 presented by Sitharaman in the Parliament on February 1, 2024. For FY 2025-26, according to the Economic Survey presented by her on February 1, 2025, the GDP is projected to expand between 6.3 per cent - 6.8 per cent. On top of a growth of 8 per cent plus for three consecutive years beginning FY 2021-22 and 6.4 per cent during FY 2024-25, this is a fairly impressive number in sync with the overarching goal of making India a 'developed economy' by 2047. As for fiscal deficit or FD (excess of total expenditure over total receipts), in her interim budget presented on February 1, 2024, she had set a target of 5.1 per cent of the nominal GDP (NGDP). Subsequently, in the full budget for FY 2024-25 presented on July 23, 2024, she revised it downward to 4.9 per cent of the GDP taking into account the extra cushion of Rs 130,000 crore in the dividend transferred by the Reserve Bank of India (RBI) to the Central Government from its operations during the FY 2023-24 (the actual dividend transfer was Rs 210,000 crore against a provision of Rs 80,000 crore made in the interim buded by the FM on February 1, 2025, the FD

Going by the revised estimate (RE) presentfor FY 2024-25 has turned out to be even lower at 4.8 per cent of the NGDP. Even as the total revenue expenditure at Rs 3698,000 crore is only marginally lower than the budget estimate (BE) of Rs 3709,401 crore, the RE for capital expenditure is about Rs 1018,000 crore - a significant Rs 93,000 crore less than the BE of Rs 1111,111 crore. Indeed, this is a major reason behind a reduction of one percentage point in the FD over the BE. In the budget for FY 2025-26, the FM has provided for a total expendi-

ture of Rs 5065,000 crore which is a significant increase of 7.4 per cent over the RE for FY 2024-25 at Rs 4716,000 crore.

This includes capital expenditure of Rs 1121,000 crore, the remaining Rs 3944,000 crore being the provision for revenue expenditure. Sitharaman has received flak for going slow on investment. This is unjustified and out of sync with the underlying facts. We need to compare the budget provision with RE for FY 2024-25. On this basis, the provision of Rs 1121,000 crore is 10.1 per cent higher than the actual capital expenditure during That apart, the position about the

government's capital spending has to be viewed in totality. In her Budget for FY 2019-20, Sitharaman had laid a roadmap for catapulting the Indian economy to US \$5 trillion by 2024-25. In sync with this target, she had projected an investment requirement of over KS 100,00,000 crore to build the infrastructure over five years. Of this, 39 per cent or Rs 39,00,000 crore was to come from the Centre and states each and the balance was Rs 22,00,000 crore from the private sector. The Centre's actual capital expenditure was for 2020-21: Rs 439,000 crore; 2021-22: Rs 554,000 crore; 2022-23: Rs 750,000 crore; 2023-24: Rs 1000,961 crore and Rs 1018,000 crore for 2024-25.

Over five years, the total comes to Rs 3761,000 crore which is more or less close to the amount the Centre intended to contribute. Continuing with the above trend, a substantial allocation of Rs 1121,000 crore for 2025-26 shows the determination of the government to maintain the momentum of investment in building roads, highways, expressways, waterways, ports, airports, railways, irrigation projects, hospitals, schools, tech-

But, investment by the central government alone won't be enough to give the intended boost to the economy. The States and private sector also need to do their bit. The Centre has been helping the former to boost their capital spend. During 2022-23, it provided them with 50-year Rs 100,000 crore interest-free loans. During 2023-24, such transfers were Rs 130,000 crore. For FY 2024-25, the transfers were kept at Rs 150,000 crore though the states didn't fully uti-

lize the amount.
For FY 2025-26 also, the budget allocation is kept at Rs 150,000 crore. To promote investment in the private sector, the Centre has given a host of incentives to industries and businesses. Amongst others, these included a reduction in the corporate tax rate to 15 per cent for new manufacturing enterprises. In 2024-25, the tax rate on foreign firms was reduced from 40 percent to 35 percent. But, the private sector has complained of demand constraint'. Team Modi has addressed this as well.

In the budget for FY 2024-25, Sitharaman altered tax slabs under the New Income Tax (IT) regime besides increasing the standard deduction by Rs 25,000.

This resulted in a relief of around Rs 17,500 in personal income tax or PIT. In the budget for FY 2025-26, she has given a bonanza by announcing that a person earning Rs 1200,000 per annum need not pay any tax (taking into account the standard deduction of Rs 75,000/- now, the threshold comes to Rs 1275,000). Besides, she has altered the tax slabs to give relief even to persons earning more. Thus, a person earning Rs 2400,000 per annum will pay Rs

so on in symphony with strength- 110,000 less. Consequent to these changes, the taxpayers will gain Rs 100,000 crore annually.

These savings will be distributed amongst a total of 7 crore persons who won't have to pay any tax. This will give a big boost to demand. However, this by itself won't give the required fillip. The government's efforts need to be complemented by the owners of businesses. They should go for better distribution of income through measures such as keeping prices low, increasing salaries at the lower rungs, reinvesting profits for growth etc.

Coming to FD, apart from lower capital expenditure (than BE), the contribution of buoyant tax collections in containing it at 4.8 per cent of the NGDP during FY 2024-25, can't be brushed aside. The RE of gross tax revenue (GTR) during the year at Rs 3850,000 crore is higher than the BE of Rs 3840,000 crore which itself was 14.6 per cent higher than GTR of Rs 3350,000 crore during 2023-24. For 2025-26, FM has kept the FD target at 4.4 per cent. To achieve it, she has set the GTR collections at still higher Rs 4270,000 crore.

This despite lower tax rates shows that the government's efforts at broadening the tax base and ensuring tax compliance are working. In an interview, Sitharaman cited capital expenditure of 4.3 per cent as being more or less close to FD of 4.4 per cent. From a fiscal consolidation angle, this is a good sign as borrowings are used only for building assets. However, the government needs to go beyond by generating a 'revenue surplus' so that borrowings even for building capital assets can be cut. This is necessary as 'interest payments' alone account for over 25 per cent of total spending by the Centre.

Bihar, too, is set to witness an intense electoral showdown. With recent victories boosting the party's confidence, BJP and its allies plan to enter the battle with renewed aggression to retain power. The frag



mented INDIA alliance, which was evident in Haryana and Delhi, provides the BJP with an additional advantage. The Rashtriya Swayamsevak Sangh (RSS), which has maintained a strong presence in West Bengal for decades, is expected to play a pivotal role in BJP's bid to oust Mamata in the upcoming assembly elections. CardPrime Minister Narendra Modi remains the BJP's strongest electoral force. His leadership, credibility, and mass appeal, especially among the middle and lower-income groups, were decisive in Delhi's outcome. Delta jet flips upside down on snowy Toronto runway

All 80 passengers aboard survive

A Delta Air Lines jet flipped On its roof while landing Monday at Toronto's Pearson Airport, but all 80 people on board survived and those hurt had relatively minor injuries, the airport's chief executive

Snow blown by winds gusting to 40 mph (65 kph) swirled when the flight from Minneapolis carrying 76 passengers and four crew attempted to land at 2:15 around

Communications between the tower and pilot were normal on approach and it's not clear what went so drastically wrong when the plane touched down.

Peter Carlson, a passenger travelling to Toronto for a paramedics conference, said the landing was "very forceful."

"All the sudden everything just kind of went sideways and then next thing I know it's kind of a blink and I'm upside down still strapped in," he told CBC News. Canadian authorities held two brief news conferences but provided no details on the crash. Video posted to social media showed the aftermath with the

turned, the fuselage seemingly intact and firefighters dousing what was left of the fire as pas-sengers climbed out and walked across the tarmac.
"We are very grateful there was

no loss of life and relatively minor injuries," Deborah Flint, CEO of Greater Toronto Airports Authority, told reporters.

Delta CEO Ed Bastian said in a statement that "the hearts of the entire global Delta family are with those affected.

Toronto Pearson Fire Chief Todd Aitken said 18 passengers were taken to the hospital. Earlier in the day, Ornge air ambulance said it was transporting one pediatric patient to Toronto's SickKids hospital and two injured adults to other hospitals in the city.

Emergency personnel reached the plane within a few minutes and Aitken said the response "went as planned." He said "the runway was dry and there was no cross-wind conditions." The crash was the fourth major

aviation accident in North America in the past three weeks. A commercial jetliner and an Army helicopter collided near Reagan National Airport in Washington, DC, on January 29, killing 67 people.

A medical transportation plane crashed in Philadelphia on January 31, killing the six people on board and another person on the ground. And on February 6, 10 people were killed in a plane crash in Alaska. The last major crash at Pearson was on August 2, 2005, when an Airbus A340 landing from Paris skidded off the runway and burst into flames amid stormy weather. All 309 passengers and crew aboard Air France Flight 358 survived the crash. On Monday, Pearson was experiencing blowing snow and winds of 32 mph (51 kph) gusting to 40 mph (65 kph), according to the Meteorological Service of Canada. The temperature was about 16.5 degrees Fahrenheit (minus 8.6 degrees Celsius). The Delta flight was cleared to land at about 2:10 pm. Audio recordings show the control tower warned the pilots of

the approach. "It sounds to me like a controller trying to be helpful, meaning

the wind is going to give you a bumpy ride coming down, that you're going to be up and down through the glide path," said John Cox, CEO of aviation safety consulting firm Safety Operating Systems in St. Petersburg, Florida.

Top Russian, US officials meet for talks on Ukraine war without Kyiv

m the\ US\ met\ in\ Saudi\ Arabia}$ on Tuesday to begin talks on improving ties and negotiating an end to the war in Ukraine.

Delegations led by US Secretary of State Marco Rubio and Russian Foreign Minister Sergey Lavrov met at the Diriyah Palace in Riyadh. The meeting marks another pivotal step by the Trump administration to reverse US policy on isolating Russia and is meant to pave the way for a meeting between US President Donald Trump and Russian President Vladimir Putin.

Trump earlier this month upended US policy toward Ukraine and Russia by saying he and Putin had agreed to begin negotiations on end-

ing the war. Ukrainian officials aren't taking part in the meeting, and Ukrainian

accept the outcome if Kyiv doesn't take part.

Rubio was accompanied by US national security adviser Mike Waltz and Special Envoy Steve Witkoff, while Lavrov sat next to the Kremlin's foreign affairs adviser, Yuri Ushakov. Saudi Foreign Minister Faisal bin Farhan and national security adviser Musaed al Alban joined Rubio, Lavrov and others for the start of the meeting but were expected to leave early in the talks. Ushakov said Monday the talks would be "purely bilateral" and would not include Ukrainian offi-

The talks mark a significant expansion of US-Russian contacts nearly three years into a war that has seen ties fall to the lowest level in decades. Lavrov and then-US Secretary of State Antony Blinken talked briefly part in the meeting, and Ukrainian on the sidelines of a G-20 meeting President Volodymyr Zelenskyy in India nearly two years ago, and

said Monday that his country won't in the fall of 2022, US and Russian spymasters met in Turkiye amid Washington's concerns that Moscow could resort to nuclear weapons amid battlefield setbacks.

The recent US diplomatic blitz on the war has sent Kyiv and key allies scrambling to ensure a seat at the table amid concerns that Washington and Moscow could press ahead with a deal that won't be favourable to them.

France called an emergency meeting of European Union countries and the UK on Monday to decide how to respond. French President Emmanuel

Macron on Tuesday said he spoke by phone to Donald Trump and Volodymyr Zelenskyy following the meeting.
"We seek a strong and lasting peace

in Ukraine," Macron wrote on X. "To achieve this, Russia must end its aggression, and this must be accompanied by strong and credible security guarantees for the Ukrainians," he said and vowed to "work on this together with all Europeans, Americans, and Ukrainians.

Ahead of the talks, Kirill Dmitriev, the head of the Russian Direct Investment Fund who the Kremlin said might join the talks, underscored the importance of the meeting in comments to The Associated Press. "Good US-Russia relations are very important for the whole world. Only jointly can Russia and the US address lots of world problems, resolve for global conflicts and offer solutions," Dmitriev, who said he and his team would focus on economic issues at the talks, told AP. The Saudi-owned satellite channel Al Arabiya, citing the Russian delegation, described Moscow's priority as "real normalisation with Washington".

Hosting the summit also balances the harsh criticism recently levied by the kingdom's tightly controlled media at President Donald Trump over his repeated comments that he wants the US to "own" the Gaza Strip, which has been devastated by the Israeli military offensive there since the October 7, 2023, Hamas attack. The Palestinians want Gaza and the West Bank for a future state, something backed by the wider Arab world and nearly all of the international community.

Meanwhile, Russia continued to pummel Ukraine with drones, according to Kyiv's military. The Ukrainian air force said Russian troops launched a barrage of 176 drones at Ukraine overnight, most of which were destroyed or disabled by jamming. One Russian drone struck a residen-

tial building in Dolynska in Kirovohrad region, injuring a mother and her two children and prompting an evacuation of 38 apartments, the regional administration reported. Four more residential buildings were damaged by drone debris in the Cherkasy region of Ukraine, according to local officials.

Egypt's state-run Al-Ahram newspaper said the proposal calls for establishing "secure areas" within Gaza where Palestinians can live initially while Egyptian and international construction firms remove and rehabilitate the

strip's infrastructure. Egyptian officials have been discussing the plan with European diplomats as well as with Saudi Arabia, Qatar and the UAE, according to two Egyptian officials and Arab and Western diplomats. They are also discussing ways to fund the reconstruction, including an international conference on Gaza reconstruction, said one of the Egyptian officials and an Arab diplomat. The officials and diplomats

spoke on condition of anonymity because the propos-

al is still being negotiated. The proposal comes after an international uproar over Trump's call for the removal of Gaza's population of some two million Palestinians. Trump said the US would take over the Gaza Strip and rebuild it into a "Riviera of the Middle East", though Palestinians would not be allowed back.

Palestinians have widely said they will not leave their homeland, while Egypt, Jordan backed by Saudi Arabia – have refused Trump's calls for them to take in Gaza's population. Rights groups have widely said the plan amounts to forced expulsion, a potential war crime. European countries have also largely denounced Trump's plan. Israeli Prime Minister Benjamin Netanyahu has praised the idea and says Israel is preparing to implement it. US Secretary of State Marco Rubio, who was in Saudi Arabia on Monday in a tour of the region, has said the US was up to hearing alternative propos-

Egypt's Al-Ahram newspaper said the proposal is designed to "refute American President Trump's logic" and counter "any other visions or plans that aim to change the geographic and demographic structure of Gaza Strip

Gaza is nearing a critical juncture with the first phase of a ceasefire due to run out in early March. Israel and Hamas must still negotiate a second phase meant to bring a release of all remaining hostages held by the militants, a full Israeli withdrawal from Gaza and a longterm halt to the war.

Any reconstruction plan will be impossible to implement without a deal on the second phase, including an agreement on who will govern Gaza in the long term.

Israel demands the elimination of Hamas as a political or military force in the territory, and

international donors are unlikely to contribute to any rebuilding if Hamas is in charge

Central in Egypt's proposal is the establishment of a Palestinian administration that is not aligned with either Hamas or the Palestinian Authority to run the strip and oversee the reconstruction efforts, according to the two Egyptian officials involved in the efforts.

It also calls for a Palestinian police force mainly made up of former Palestinian Authority policemen who remained in Gaza after Hamas took over the enclave in 2007, with reinforcement from Egyptian- and Western-trained forces.

Asked about the possibility of deploying an Arab force in Gaza, one Egyptian official and the Arab diplomat said Arab countries would only agree if there were a "clear path" for the establishment of an independent Palestinian state. Israeli Prime Minister Benjamin Netanvahu has rejected any Palestinian state as well as any role for Hamas or the Western-backed Palestinian Authority in governing Gaza, though he has not put forward

any clear alternative. Hamas has said it is willing to give up power in Gaza. Hamas spokesman Abdul Latif al-Qanou told AP on Sunday that the group has accepted either a Palestinian unity government without Hamas' participation or a committee of technocrats to run the territory. The Palestinian Authority, which governs pockets of the West Bank, has so far opposed any plans for Gaza that exclude

The Western diplomat said France and Germany have backed the idea of Arab countries developing a counterproposal to Trump's plan, and that Egyptian President Abdel Fattah el-Sissi discussed his government's efforts with the French president in a phone call earlier this month.

Elon Musk's Department of Government Efficiency is seeking access to troves of sensitive taxpayer data at the IRS, two people familiar with the inner workings of the plan who were not authorised to discuss the matter publicly told AP on Monday.

If successful, Musk and his group would have access to millions of tightly controlled files that include taxpayer information, bank records and other sensitive records. The people who spoke to the AP and requested anonymity said DOGE is specifically seeking to access the IRS' Integrated Data Retrieval System, which enables employees "to have instantaneous visual access to certain taxpayer accounts", according to the IRS website.

Advocates fear that the potential unlawful release of taxpayer records could be used to maliciously target Americans, ramifications.

Harrison Fields, a White House spokesman, said in an emailed statement that "waste, fraud, and abuse have been deeply entrenched in our broken system for far too long. It takes direct access to the system to identify and fix

"DOGE will continue to shine a light on the fraud they uncover as the American people deserve to know what their government has been spending their hardearned tax dollars on," he said.

Democratic lawmakers are trying to fight against DOGE plans to access IRS data. Senators Ron Wyden, D-Ore, and Elizabeth Warren, D-Mass, sent a letter to acting IRS Commissioner Douglas O'Donnell, demanding copies of any memos that would grant IRS system access to Musk or DOGE. The senators are also seeking justifications for DOGE efforts to inspect tax returns and

Along with fears that DOGE access to taxpayer data may not be legal, "we are also extremely concerned that DOGE personnel meddling with IRS systems in the middle of tax filing season could, inadvertently or otherwise, cause breakdowns that may delay the issuance of tax refunds indefinitely", the letter

"Any delay in refunds could be financially devastating to millions of Americans who plan their budgets around timely refunds every spring." January 27 was the official start date of the 2025 tax season, and the IRS expects more than 140 million tax returns to be filed by the April 15 dead-

m F}$ our paramilitary personnel were killed and five others injured when unknown militants attacked their squad in Pakistan's violence-hit Kurram, where an aid convoy was also targeted.

According to security officials, the militants ambushed the paramilitary Kurram Militia squad in Lower Kurram's Ochit area late on Monday, where an aid convoy carrying essential supplies was ambushed earlier in the day.

The injured and dead were shifted to a hospital, where the condition of one injured was stated to be critical. The military, which typically issues statements in such situations, has yet to comment. The attack on the aid convoy in sectarian violence-hit Kurram district in the Khyber Pakhtunkhwa province killed a truck driver and injured 15 others. Late last night, another injured succumbed to injuries, taking the toll to two, according to officials. The convoy, which was travel ling from Thall to Kurram, was attacked at multiple locations along the route, prompting officials to turn the convoy of 64 vehicles back to Hangu as a

precautionary measure. It is the latest in a series of violent incidents in Kurram which has been a hotbed of violence for decades, with deepseated tribal and sectarian conflicts often resulting in bloodshed and prolonged blockades. The latest wave of violence erupted in November 2023, when two police-escorted convoys were ambushed, killing at least 40 people.

Senior Afghan Taliban officials in Japan for talks

The Taliban officials were invited to help them better understand the need "to have a broad perspective toward their future nation building and to widely accept humanitarian assistance from the international community for vulnerable people Nippon Zaidan said in a statement. It declined to give details of the visitors and their schedule. Japan does not formally recognize the Taliban as Afghanistan's official govern-

Hayashi noted the visit was initiated by a private organization but complements the Japanese

government's effort to work with the international commu-

nity to call on the Taliban to make policy changes that protect human rights. Restrictions the Taliban impose on women and girls are a major hurdle to the Taliban

Olympic medal-winning javelin L throw star Neerai Chopra has revealed that his new coach Jan Zelezny has figured out mistakes in his technique and would now make some adjustments to his throwing routine to achieve the 90m mark that the Indian star is pursuing for a while.

The 26-year-old, while speaking to India Today, also opened up about his hushhush wedding to former tennis player Himani Mor last month, saying that their relationship was a casual friendship at first "but slowly we fell in love".

Chopra has been trying hard to hit the 90m mark. His personal best stands at 89.94m which was achieved in 2022. His season begins in May with the Diamond League and would mark the competitive start of his partnership with Zelezny, a former Olympic and world champion who also holds the

world record (98.48m). "I believe a 90+ throw is happening soon. He (Jan Zelezny) has made some technical adjustments in my

game," said Chopra.
"He (Zelezny) feels that his tweaks would help me. I've been able to understand what he expects from me. One of the mistakes that he told me about was how I was throwing very low even in Paris and that I was leaning towards the left.

"If I am able to incorporate those changes, I think I will get a lot better," he added. But the Panipat-lad insisted that the milestone is still not as important as winning medals for the country.

'I want to do it myself. But, going to a competition and winning a medal against people who have previously thrown 90 meters is even more important. There's no point in throwing 90 meters and not winning.

I have not resigned, will complete tenure, says Mary Kom

The Indian Association's Olympic athletes commission chairperson and boxing legend M C Mary Kom on Tuesday denied reports that she has resigned from her position, insisting that she has been misunderstood and will complete her tenure in the panel.

The 42-year-old Manipuri, who is also a 2012 Olympics bronze-winner, had travelled to Haldwani for the National Games closing ceremony last week where she expressed her displeasure over being lodged at an "inferior hotel'

Speaking to PTI, Mary Kom said her outburst has been misconstrued as resignation. "I have not resigned, I will complete my tenure (which ends in 2026)," she asserted. "I was merely telling my fellow (athletes commission) members that if this kind of treatment happens again, I will consider resigning. I never said that I am

resigning. IOA is my family and if I am unhappy over something, I have every right to express it. "This does not mean that I

am resigning," she went on. Mary Kom was elected to the panel in 2022 with table tennis stalwart A Sharath Kamal as vice-chairperson. The commission also features

two-time Olympic medal-winning shuttler PV Sindhu, former shot putter Om Prakash Karhana, Winter Olympian Shiva Keshavan, London Olympics bronze-winning shooter Gagan Narang, rower Bajrang Lal, fencer Bhavani Devi, former women's hockey captain Rani Rampal, and Tokyo Olympics silver-winning weightlifter Mirabai Chanu.

"I don't know why is it that every time I raise my voice for something, it is misunderstood like this? Lot of my fellow athletes speak their mind on so many issues but nobody gets misunderstood," Mary Kom

said.
"I was put up in a bad hotel when I went for the National Games closing ceremony despite the fact that a better hotel was available. If others could be accommodated, why not me? That was the only question I asked," she

"Next thing I know, people are saying I have resigned. Where is the resignation? Has anyone seen it?" she asked.

Asked if she has had a word with IOA President P T Usha on this matter, Mary Kom said. "I haven't been able to connect with her because my phone was misplaced. But I will speak to her, I have good communication with her."

India will feel Bumrah's absence very strongly: Dhawan

India will feel Jasprit Bumrah's absence "very strongly" in the Champions Trophy but they still have a great chance to win the tournament considering their recent form and a host of match-winners at their disposal, reckons former opener Shikhar Dhawan.

While the event starts in Pakistan on Wednesday, India start their campaign a day later with a match against neighbours Bangladesh at the Dubai International Cricket

Pace spearhead Bumrah was ruled out of the tournament due to a lower back injury, having taken the maximum load during India's five-

match Test series against Australia. "My concern is they are going to miss Jasprit Bumrah, there is no doubt he will be a big absence and I think they will feel it very strongly," Dhawan wrote in an ICC column published on Tuesday.

"For me, he is the best bowler in the world, and his accuracy is hard to replicate. He is also a very calm character and that is crucial in a huge ICC event like this."

Dhawan is, however, backing Shubman Gill and Harshit Rana to sizzle in the tournament.

"At the same time, Harshit Rana has



come into the side and I think that is really exciting - keep an eye on him, I think he could have a breakout

"I like his attitude, he is a go-getter and he is not afraid of anything. He accepts challenges and we have seen in the England series that he is in form. I am sure he will look to seize this opportunity and, if he does, he could provide a real X-factor for

look beyond India when the discussion turned to title contenders.

"There are a lot of reasons to be optimistic for India. They have a very balanced side, especially with the bat – there is a nice blend of experience Going by recent form and team and youth. Shubman Gill, in strength, Dhawan found it hard to particular, is so consistent and he has a big role to play. I think he will have

"Rohit Sharma has found form, Virat Kohli is there; they are a top side and will take some stopping."

Dhawan is also not ruling out teams

such as South Africa, New Zealand, Australia and hosts Pakistan, to whom India lost in the title clash in the last edition in the UK.

"I really like South Africa in this tournament as well. They have played consistent cricket and have everything you need to win such a huge tournament – experience, strength-in-depth and X-factor players like Kagiso Rabada. "I also like Pakistan, they will be hard

to beat in home conditions, and also New Zealand – who are just always there or there abouts.

Champions Trophy set to start amid debate on relevance of 50-over cricket

Intrigue, uncertainty, backstage drama. The ICC Champions Trophy has seen it all even before the curtains go up on the tournament and it would only get more stirring over the next three weeks, starting with the opening clash between Pakistan and New Zealand in Karachi.

Eight teams will vie for a trophy, often talked up as tougher to win than the World Cup, and also to script a new chapter in their own cricketing story. While India will fight it out in Dubai, others will be primarily based in Pakistan, which would get to host its first ICC event

since the 1996 World Cup. Several barriers had to be hurdled over to cobble this tournament together after eight years. The tournament is also crucial amid the raging debate on the relevance of ODI cricket, which is

amid the rage for T20 cricket and the devotion for Test format.

Perhaps, no other cricketing event in the recent past has been harried so much by long-standing geopolitical tensions, stubbornness by administrative boards of two important participants, and the nail-biting anxiety over the readiness of venues in the main hosting nation. The chaos has been an

endearing throwback to the 90s when cricket in the subcontinent resembled a hastily organised party. But all these pre-tournament

jitters will be forgotten once the teams enter the field, and the first of them will be Pakistan and New Zealand. If anyone needs a reminder, then Pakistan had won the last edition of the Champions

Trophy in 2017. The opening match in itself is a curious clash -- a talentedvet-volatile Pakistan unsure of struggling to find its space its own destiny against a team lap of a long race, and would

South Africa too will have a similar goal. They had won ICC Knockouts Trophy in 1998, but not bagged anything in recent times and the Temba Bavuma-led side will be hoping for a reversal of fortune. But for that to happen, the Proteas should coat their minds with steel in crunch situations. It's applicable to Pakistan as

well. If they can stop obsessing over the match against India and not treat it as the 'final frontier', then the home side is a dangerous opposition. Their pace attack is top-notch

and they have some batters like Fakhar Zaman and Salman Ali Agha who can turn on the heat on the rivals. Afghanistan, who have transformed into formidable white-ball outfit, also can put other teams under immense pressure through a squad that has Rashid Khan and Rahmanullah Gurbaz.

Bangladesh now has receded to the periphery of cricketing consciousness, but can they pull of a stunner as they had done in the 2007 50-over World Cup?
