## BJP, Congress battle over USAID

At the backdrop of BJP and Congress engaged in a fierce battle of words over certain revelations about USAID funding for certain activities in the country, the Ministry of External Affairs on Friday said they are "deeply troubling" and have led to concerns about foreign interference in its internal affairs.

BJP sharpened its attack on the Congress on the USAID funding issue and called Rahul Gandhi a "traitor", accusing him of colluding with foreign forces in his bid to weaken India as it dismissed as "cover up" media reports that claimed USD 21 million was sanctioned in 2022 for Bangladesh, not India.

Congress on their part, following reports that an amount of USD 21 million approved by the USAID was meant for Bangladesh and not India, the party demanded an apology from the BJP alleging that the ruling party's narrative was aimed at diverting attention from its own use of foreign funds to destabilise past governments led by the grand old party. Congress also reiterated its demand from the government for a white paper on the USAID funding as well as funding by other such agencies in

Since the Trump administration's Department of Government Efficiency (DOGE) announced on February 16 that it had "cancelled", among a string of projects, the USAID funding of "USD 21 million for voter turnout in India", the ruling BJP has accused the Congress of using external influence in India's election process

In a speech in Miami on Wednesday, US President Donald Trump said: "Why do we need to spend USD 21 million for voter turnout in India? Wow, USD 21 million! I guess they were trying to get somebody else elected."

Vice President Jagdeep Dhankhar too voiced concern over the alleged USAID funding for raising voter turnout in India, saying people who allowed such an attack on the country's democratic values should be exposed. He also said



that it was the "national duty" of people to strike at such forces.

Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said relevant departments and authorities are looking into the information put out by United States administration regarding certain US activities and funding. "We have seen information that has been put out by the US administration regarding certain US activities and funding. These are obviously very deeply troubling," Jaiswal

"This has led to concerns about foreign interference in India's internal affairs. Relevant departments and agencies are looking into this matter. It would be premature to make a public comment at this stage, so relevant authorities are looking into it and hopefully, we can come up with an update on that subsequently," Jaiswal said.

Addressing a Press conference at the BJP headquarters, party national spokesperson Gaurav Bhatia claimed the USAID funding came to India to meddle with internal politics and disrupt electoral process in India.

"More than USD 2000 million funding came to the government in India from 2004-13 during the erstwhile Congress led UPA rule. And, just USD 1.5 million came during Modi ji's term. It's because they know that Narendra Modi will not sell India and India's interests to any

foreign power," he said. A larger share of the USAID fund came into India during the UPA regime because the Congress can broker the country's sovereignty and its interests, Bhatia alleged.

"While funding for the government (in India) stopped, there was an increase in funding for the NGOs during Rahul Gandhi's Bharat Jodo Yatra to strengthen Rahul Gandhi ahead of the polls in an attempt to defeat Narendra Modi (in the Lok Sabha elections)," he claimed. Congress general secretary in-charge

communications Jairam Ramesh said, "Lies first mouthed in Washington. Lies then amplified by BJP's Jhoot Sena. Lies made to be debated on Godi media.' "Lies now thoroughly exposed. Will the liars apologise?" he asked in a social media post.

Addressing a press conference Congress's media and publicity department head Pawan Khera alleged that the entire "USD-21 million USAID funds narrative" perpetrated by the BJP, Modi government's ministers, its economic advisor, the party's IT department head, the RSS-BJP ecosystem and a section of the "BJPfriendly media" was done to divert attention from their "own sins" of using foreign funds to destabilise Congress governments of the past

### New Delhi Assembly to begin with CAG reports

The newly constituted BJP led Delhi Assembly is set to begin its first session on Monday. The session will be held on February 24, 25, and 27, with 14 pending Comptroller and Auditor General of India (CAG) reports on the previous Aam Aadmi Party (AAP) government's performance will be tabled. According to Rohini MLA Vijendra Gupta, 14 pending CAG reports will be tabled on February 25. ### **Opposition walks out of Assembly over KIIT issue**

Express dissatisfaction over minister's response

Opposition BJD and Congress members staged a noisy walkout in the Odisha Assembly on Friday voicing their dissatisfaction over Higher Education Minister Suryabanshi Suraj's response regarding the unrest at the KIIT University following the suicide of a Nepali girl student.

Earlier, while participating in an adjournment motion debate on the issue, they had demanded a judicial inquiry into the matter, but the government did not respond to their plea. The minister stated that law would take its course and that anyone found guilty would be punished.

During an adjournment motion moved by Congress members, Minister Suraj explained that tensions escalated at KIIT following the girl's suicide, and on February 17, the university administration declared a sine die for Nepalese students, instructing them to vacate the campus. These students were later escorted to railway stations in Bhubaneswar and Cuttack.

# Govt to expand urban planning scheme to 3 new cities

Puri-Konark, Cuttack, Brahmapur to benefit

would expand its urban planning scheme to three additional cities, aiming to emulate the transformative development witnessed in the capital city of Bhubaneswar. The government has announced the extension of its successful Town Planning (TP) scheme to the cities of PK (Puri-Konark), Cuttack and Brahmapur.

This decision was finalised in a meeting presided over by Housing and Urban Development Minister Krushna Chandra Mohapatra on Fri-

The 'Triple City' initiative aims to enhance land management and develop essential infrastructure across the holy city of Puri, the historical town of Konark, the industrial hub of Cuttack, and the silk city Brahmapur. As part of the scheme, 40% of land from common people in these cities will be acquired for building roads, drainage systems, electricity networks, markets and parks, with landowners retaining the remaining 60%.

The minister called for prompt execution of the revised scheme, stressing the importance of safeguarding residents against exploitation by intermediaries. He advised government officials and relevant stakeholders to be vigilant in ensuring fair and transparent processes.

The expansion is expected to bring about significant improvements in urban planning and infrastructure. The minister said, "We are committed to implementing this scheme effectively and ensuring that the benefits reach the rightful owners without any undue in-

"I had invited development authorities of PKDA (Puri Konark), Berhampur, Cuttack, and Bhubaneswar. Our government wants as much development as possible in these cities. Usually, people who have houses close to the main road are the benefiters while those have houses a bit interior face lot of problems due to lack of space, road and connectivity. So, we are planning to take 40% of their lands and build all the facilities including drainage, sewerage, light system and proper road," he

### Drones used to curb liquor smuggling

Drone footage enabled the department to locate numerous liquor production sites nestled within these protected reserve forest areas. The initiative marks a breakthrough in addressing the challenges posed by liquor mafias who often take advantage of the inaccessible and dense forests

In a collaborative move involving the Cuttack Flying Squad and local Excise Department officials, the authorities seized 5,355 litres of fermented brew and 595 litres of country liquor on Friday. Despite the significant haul, there have been no arrests made as of yet. The country liquor makers gave the excise officials a slip during the raid.

## Bhubaneswar to be IT hub like Hyderabad

Rs 408 crore allocated

The Odisha Government has allocated Rs 408 crore to transform Bhubaneswar into an IT hub akin to Hyderabad. A new satellite city spanning 322 hectares is planned, alongside a Rs 1,100-crore investment in urban corridors.

The ambitious plan aims construction of a new Bhubaneswar to foster economic growth and urban development, inspired by Hyderabad's success as a major IT hub.

Further enhancing this vision, the government also plans to transform 15 cities into five tri-city clusters.

A strategic initiative is underway to develop a new sat-

ellite city within Bhubaneswar. Spanning 322 hectares, the project is expected to bolster the region's infrastructure across multiple sectors with a particular focus on IT like in the Hyderabad model.

This move is anticipated to attract significant investments and foster a plethora of employment opportunities.

Besides, the government is also prioritising an expeditious completion of the Bhubaneswar Metro system. This metropolitan expansion will also include a new ring road to streamline the traffic

Additionally, with a budget allocation of Rs 1,100 crore, this initiative aims to transform several city regions into economic powerhouses. The plan includes enhancement of urban

Sambalpur-Jharsuguda-Baragarh, Jeypore-Sunabeda-Koraput, Chhatrapur-Brahmapur-Gopalpur and Keonjhar-Badbil-Joda. These regions are envisioned as future economic hubs, critical to boosting local economies and infrastructure.

Under the scheme, the government will focus on the development of creation centres and tourism circuits. There will also be significant advancements in logistics, higher education facilities and medical services.

Chief Minister Mohan Charan Majhi said, "We are planning to construct a new city within Bhubaneswar and land for the purpose has already been identified. Our plan is to transform Bhubaneswar in the parallels of Hyderabad.

Now, ring roads are also currently in works to avoid traffic congestion. This development is expected to boost local employment opportuniand promote infrastructural advancements.'

"This apart, we will transform Bhubaneswar-Cuttack-Puri into an economic hub," he

he Odisha Government is striving for global recognition of the historic Bali Yatra festival held annually in Cuttack.

While replying to a question by MLA Debi Ranjan Tripathy in the State Assembly on Friday, Culture Minister Suryabanshi Suraj clarified that there is no current mechanism for national recognition of Bali Yatra as such status is conferred by the United Nations Educational, Scientific and Cultural Organisation (UNESCO).

"There is no provision for according national status tag. UNESCO only grants recognition for intangible heritage as far as fairs and festivals are



concerned. Be it Bali Yatra or Dhanu Yatra, we are trying to ensure that they get included in the UNESCO recognition and heritage map. Provision for funds has also been made in the budget as well," said

In pursuit of international recognition, the Odisha Government is working closely with UNESCO and has established an experts' team to maintain a consistent dialogue. The minister said, "We are hopeful that UNESCO's

recognition will be realised soon." The Bali Yatra witnessed a record turnout this year. A total of 2,438 stalls were established.

Recently, the Central Government accorded 'National Fair' tag to the Bali Yatra.

In a move to transform south Odisha's connectivity and economic prospects, the Ministry of Railways sanctioned several railway infrastructure projects on Friday.

Among the major projects is the doubling of the Naupada-Gunupur-Theruvali Rail Line alongside the 250-km-long Gopalpur-Rayagada New Rail Line. Rs 9.65 crore has been sanctioned for the Final Location Survey (FLS) for the two projects. The Rs 1,326-crore Gunupur-Theruvali New Line (73.62 km) will link Gunupur and Theruvali in Rayagada district. The project is set to be completed in five years with a land acquisition of 473.78 hect-

The Gopalpur-Rayagada New Rail Line and Gunupur-Theruvali Rail Line projects will bring immense economic benefits by improving transportation efficiency and reducing logistical costs in the southern part of the state.

Development of seven new stations in the Gunupur-Theruvali New Rail Line Project will improve access to key areas, including the aspirational Rayagada district. The Gunupur-Theruvali New Rail Line Project is an essential part of the Energy, Mineral and Cement Corridors under Indian Railways.

### Odia language: Legacy of struggle, identity, pride Ashram, established in 1903,

**A**s the world observes the International Mother Language Day on February 21, it is a moment of reflection on the rich legacy of Odia, a language that has shaped the identity and cultural consciousness of millions.

Recognised as one of the six classical languages of India, Odia has played a decisive role in the linguistic and political history of the country. Odisha holds the unique distinction of being the first State in India to be formed on the basis of language, marking a significant milestone in the nation's

tinct language. The Utkal

linguistic reorganization. Brahmapur played a his-

was the first epicenter of the Odia language movement. Under the leadership of Krishna Chandra Panigrahi, the ashram became a hub for intellectuals, writers and activists who campaigned for Odia's preservation.

During the British rule, Bengali, Hindi and Telugu were being imposed in different parts of Odisha, leading to concerns that Odia might be erased. Utkal Ashram spearheaded protests, debates, and literary movements that demanded the reinstatement of Odia in administration and education. The influence of the institution later spread to Paralakhemundi, Cuttack, Puri and Sambalpur, strengthening the call for a separate Odia-speaking State.

separate province in 1936, Odia-speaking regions were fragmented under the control of different administrative units such as Bengal Presidency, Central Provinces and Madras Presidency. This led to the marginalization of Odia language and culture, as Bengali and Telugu were being imposed in various regions.

A major struggle for Odia language recognition took place in southern Odisha, particularly in Paralakhemundi, Brahmapur and Koraput, which were then part of the Madras Presidency. Despite the dominance of Telugu and Tamil in administration and education, the people of these regions fought persistently to be reunited with Odisha, citing their linguistic and cul-

was instrumental in the eventual merger of southern Odisha into the State when it was carved out from Madras

Paralakhemundi, under the rule of the Gajapati kings, played a crucial role in the Odia language movement. Maharaja Krushna Chandra Gajapati, a key figure in Odisha's formation, strongly advocated for the recognition of Odia as the administrative language in Odia-speaking areas. Likewise, Brahmapur, with its intellectual and literary contributions, remained a major center for the linguistic struggle.

Odisha was officially declared a separate province on April 1, 1936. The province also had the rare distinction (equivalent to today's Chief Minister) in 1936. Maharaja Krushna Chandra Gajapati became the first Prime Minister of Odisha, leading the State's first government under British rule. His efforts were crucial in shaping modern Odisha and preserving Odia

Odia has a rich literary tradition that dates back over a thousand years. Mahabharata of Sarala Das (15th century) is one of the earliest and most significant literary contributions in Odia. The Bhakti movement, led by Jagannath Das, Balaram Das and Achyutananda, infused Odia literature with deep spiritual and philosophical

insights. With literary figures like

Fakir Mohan Senapati Gangadhar Meher and Gopabandhu Das, modern Odia literature flourished, shaping the linguistic and cultural identity of Odisha. Today, the language continues to thrive through literature, digital platforms, and academic research, securing its place as a classical language of India

### NHAI violates court orders during road widening

2K vendors from Chandikhole to Paradip lose livelihoods RAJESH BEHERA

KENDRAPADA

The National Highway Authority of India(NHAI) has been carrying out a 77 km-long NH -53 road widening work from Chandikhole to Paradip. This has led to eviction of thousands of locals who eke out their living by opening shops on both sides of NH-53. Consequently, they have lost

their livelihood as their shops

were evicted The Odisha Soochan Adhikar Abhijan (OSAA) alleged that the NHAI by violating the norms of the Orissa High Court and Supreme Court allegedly evicted the shops from both sides of NH-53. Neither did the NHAI authority organised public hearing (Jana Sunani) nor it carried out survey work for the purpose, OSAA complained.

Even, the grievances of the locals and shopkeepers were not addressed, it added.

An RTI query exposed the NHAI's violation on eviction of shops on both side of National Highway-53 for road widening work. The matter came to the light following the authority failed to give details in this regard.

Notably, one Pratap Kumar Mohanty of Talasanga earlier sought information from NHAI through RTI. But the NHAI failed to give information on as the information. The NHAI authority alleg-

edly failed to discuss for rehabilitating the shopkeepers and providing compensation. The most important thing is as per official data received from RTI from the concerned authority, the NHAI does not have any information related to number of shops evicted for widening of NH road, eviction date and number of persons who received compensation from NHAI, alleged district convenor of OSSA Pratap Mohanty. He lated the human rights of 2,000 small businessmen as it forced them to lose their livelihood.



### ' ship faces uncertain future at Paradip



After seizure of Rs 220-crore cocaine

PNS BHUBANESWAR

he MV Devi ship remains stranded at the Paradip Port after the seizure of Rs 220 crore worth of cocaine from it. Despite an Orissa High Court order resolving financial disputes, Customs' ongoing probe raises uncertainty over its release.

There is a possibility that the investigation into the cocaine smuggling could be obstructed if the ship is released.

The person responsible for smuggling the cocaine on the ship has not been identified yet. Hence, it is believed that the ship is unlikely to leave Paradip for now.

Recently, the High Court rescinded an arrest order on the ship, originally issued due to unpaid berth charges owed

to the port authority, PICT (Paradip Internatonal Cargo Terminal Private Limited). Despite resolving the finan-

cial dispute between the ship's owners and PICT, the cocainerelated investigation remains unresolved.

Legal experts are skeptic regarding the ship's imminent departure as the primary investigation still unfolding.

"The Honourable High Court's order is for the issue between PICT and the ship. Because they have reached an amicable resolution, the High Court has ordered its release. However, the involvement of the Customs Department after the seizure of cocaine is a different case altogether. It is a high-profile case with a large quantity of cocaine seized. Maybe, the Customs department will file a review petition," informed lawyer Gatikrushna Satapathy.

The MGNREGS has the potential to serve as a significant source of income and a means of sustainable livelihood for the poor if implemented with innovation and careful planning.

A remarkable example of such innovative utilisation of the MGNREGA funds can be seen in Arada village of Khariar block. Raja Sabar, a tribal migrant

worker from the village, now finds himself in a much better position as a beneficiary of the iob scheme. Once compelled to migrate to cities in Andhra Pradesh and Tamil Nadu for work in brick kilns, he is now the proud owner of a oneand-a-half-hectare mango or-

"I have a total of eight acres of cultivable land, but finding steady income from farming here was a challenge. My job card not only provided me with work but also opened up an alternative source of livelihood. This is the fifth year of my mango plantation, which I established with the support of the Watershed Department, and it has now started bearing fruits," he shared.

Raja had cultivated cotton, and groundnut as intercrops among the mango plants when they were still small, enabling him to earn approximately Rs 40,000 over the past three years. He now plans to sow arhar and groundnut again in the upcoming season.

trees like aanla, jamun, gambhari, and neem along the boundary of his field, which will provide additional earnings in the coming years. Rajeswar Sabar of this village has planted 200 mango

plants in one acre of land. The intercrops are beans, tomato, radish, and watermelon. He got Rs 8,000 from tomato. He hopes to earn fifty thousand rupees from watermelon. The mango plantation

project was initiated in Arada village in 2020. It began with Raja, who agreed to the idea immediately when it was proposed to him. "The land had been fallow for a long time. When we sug-

gested the project to Raja, he agreed," said Biswambar Gauda, the field official of the Watershed Mission in Raja's wife, Bhagya Sabar,

who dedicates her time to the

mango plantation, shared their motivation: "We had seen mango farmers in our neighbouring village selling their produce in truckloads; so we decided to take up mango cultivation." Raja was not the only one

to embrace mango farming in Arada village that year; three others also agreed to convert their fallow land into mango orchards. The initiative was implemented under the MGNREGS scheme with an estimated budget of Rs 12.92 lakh, out of which Rs 9.35 lakh was allocated for wages, according to Gauda. "The project generated around 2,500 per-

son-days of employment over

four years from the year of planting, averaging about 650 days per year," he added.

It was enough to generate more than 150 days of employment per family who took up the venture, because most of the work was carried out by the family members of the beneficiaries.

Bhagya explained, "We handled everything-from digging pits and manuring to planting and regular watering, often carrying water on our heads from the nearby river."

Additional employment opportunities were also created for the beneficiaries through a field bunding programme under the

MGNREGS.

The effort in 2020 led to the engagement of additional households in developing mango orchards on their uplands, which were previously used occasionally for cultivating cotton or gurji.

"Four more households approached the Watershed Mission for support under the project, and they were subsequently included in 2021-22 and 2023-24," informed

The mango orchard in Arada now covers 8 hectares with 3,200 thriving plants, backed by an investment of approximately Rs 26 lakh, of which Rs 22.42 lakh has been allocated to wages. After ensuring three/four years of dedicated care and supervision, the mission has successfully handed over the plantations from the first and second phases to the beneficiaries.

Over the past five years, the projects have generated 6,500 person-days of employment, providing stable livelihoods for 12 households actively engaged in the initiative. These farmers have also participated in other MGNREGS projects, such as field bunding and land development, further enhanc-

ing their earnings. Beneficiaries report that

their income from the scheme alone has ranged between Rs 30,000 to Rs 40,000 per year, helping them meet their livelihood needs, healthcare expenses, and children's educa-

Additionally, they have earned extra income by cultivating vegetables as intercrops. 'We haven't calculated the

exact income our efforts will yield, but we are deeply grateful to the officials who guided us out of distress migration (dadan) and the hardships we faced while working in kilns," shared the farmers.

These beneficiaries have now become role models within the community, inspiring more farmers to take up plantation activities. Encouraged by their success, three more farmers have expressed interest in joining the initiative next year, and officials are planning to include them in the scheme.

"The district administration has been striving hard to reach out to people in distress and indigent condition by way of providing employment through MGNREGA. We are also sanguine in arresting migration in coming days," said Nuapada DM Madhusudan

Many reporters asked him if Panamian authorities had approached India on this issue. We have seen some reports about deportation flights to Panama and Costa Rica. Now it is our understanding that these have been undertaken as per a bridge arrangement between the US and the respective governments. Both Costa Rica and Panama have agreed

to serve as transit countries for deportees while the US bears all the costs of the operation," Jaiswal said.

### Mahakumbh 2025 to end with a cosmic spectacle

As the Mahakumbh enters its final week before concluding on February 26, skywatchers and spiritual seekers alike are in for a rare celestial treat. All seven planets of the solar system-Mercury, Venus, Mars, Jupiter, Saturn, Uranus, and Neptune, will be visible in the night sky from India, creating a once-in-alifetime astronomical spectacle. The phenomenon, which began in January with the visibility of Venus, Mars, Jupiter, Saturn, Uranus, and Neptune, will reach its climax in February as Mercury joins the formation. The alignment will peak on February 28, when all seven planets gather on one side of the Sun, forming a breathtaking planetary parade. Astronomers explain that while the term 'planetary alignment' lacks a strict scientific definition, it generally refers to multiple planets appearing along the ecliptic-the Sun's apparent path across the sky. "These celestial bodies will align along the ecliptic since their orbits lie nearly within the same plane," said Dr Rajeev Sharma, an astrophysicist.

### Mamata clarifies her 'Mrityu Kumbh' remarks | Hathras stampede: Judicial inquiry clears Bhole Baba

BISWAJEET BANERJEE LUCKNOW

The judicial commission I investigating the tragic stampede at a religious gathering in Hathras has given a clean chit to Bhole Baba, also known as Narayan Sakar, according to the sources. The commission submitted its report to the Uttar Pradesh government, which discussed it in a cabinet meeting ahead of the state budget presentation.

While the report confirms that the police investigation was conducted properly, it remains inconclusive on whether any conspiracy was involved. The government has approved a proposal to table the report in the legislature, but it has not yet publicly disclosed its key findings. The incident occurred on July 2 in Hathras, Uttar Pradesh,

during a religious congregation attended by tens of thousands of devotees.

According to eyewitnesses, as Bhole Baba concluded his sermon and began leaving, a sudden rush ensued.

Many followers tried to move closer to him, hoping for his blessings. In the overcrowded space, people began pushing and shoving, leading to panic. Authorities reported that the venue lacked adequate emergency exits, and many attendees were unable to escape in time. While some blame poor crowd management, others argue that the organisers did not anticipate the sheer number of devotees who would attend the event.

The judicial inquiry commission, set up to investigate the tragedy, has made several key recommendations to prevent

similar incidents in the future. The report suggests enforcing strict crowd management protocols, including a cap on the number of attendees at religious events and mandatory security drills before such gatherings. It recommends that all large public events be required to

have designated emergency exits, medical teams, and police presence. It also proposes stricter licensing rules for religious congre-

gations and large public gatherings to ensure better accountability of event organisers. Grieving families of the victims have expressed frustration over the report's findings, saying justice remains elusive. Anita

Priyanshu Diwan, Assistant Commissioner of Police (cybercrime), said that the arrested accused has been identified as Avinash Sharma and Aditya Chaturvedi both resident of Delhi.

According to the police, a man filed a complaint at the Cyber Crime Police Station East in November 2024, that he was duped of ₹4.97 Crore in the name of investing in the stock market.

During the probe, the police of the said police station arrested the suspects from different parts of Delhi for the alleged involvement in the ing in the stock market, reduc-crime from Delhi on ing electricity bills, in the Wednesday.

During interrogation, the accused disclosed that Aditya Chaturvedi was currently working as business development manager at gujranwala town-2 of Idsusand bank in Delhi since 2023.

"The bank account used in the fraud was opened by Aditya Chaturvedi and sell it to Avinash in ₹25,000 to commit fraud. Chaturvedi took ₹10,000 to open saving account and ₹50,000 for current account," Sandeep Kumar, a spokesperson of the Gurugram police said.

Senior police officers of the Gurugram claimed that the police are closely working with other agencies and organisations to counter these frauds. "The cyber fraudsters commit fraud by luring people with good profits, invest-

ing electricity bills, in the name of buying or selling cheap goods online, sextortion through video calls on WhatsApp, morphing, sending links through various means, posing as a customs officer or police officer in the name of implicating false case, in the name of issuing a No-Objection Certificate, digitally arresting people by showing the fear of implicating them in a criminal case, etc, Priyanshu Diwan, ACP (cybercrime), said.

'We appealed to the public to steer clear of such dubious callers and advised caution in sharing personal details to strangers stalking them online," he added.

"So far the Gurugram police have arrested 27 bank officials from different banks till now who were allegedly involved in cyber fraud," Diwan added.

After Babaria, the Congress leaders who remained in charge of Madhya Pradesh unit of Congress were- Mukul Wasnik, JP Agarwal, Randeep Singh Surjewala and Bhanwar Jitendra Singh.

The recent departure of AICC general secretary Bhanwar Jitendra Singh reportedly stemmed from his strained relations with Madhya Pradesh Congress president Jitu Patwari. Patwari, known for his assertive

stance, was believed to have actively sought Singh's replacement.

Harish Choudhary is new in-charge of MP Congress unit

This episode is indicative of the larger issue of factionalism within the state unit, where power struggles between senior leaders continue to weaken the party's organisational framework.

While Patwari has made efforts to project a unified front with Leader of the Opposition in the State Assembly, Umang Singhar, their underlying differences remain an open secret in political circles.

The discord within the leadership ranks is no longer just an internal matter but has become a talking point in Madhya Pradesh's political landscape.

Patwari himself recently likened intra-party groupism to a 'cancer' eating away at the Congress's prospects in the state, vowing to eliminate such divisions. However, his own conflicts with Singhar and other senior leaders contradict this call for unity, raising questions about the feasibility of his mission.

The fissures within the Congress were further underscored during Harish Choudhary's formal induction at the PCC headquar-

Addressing the party workers on the occasion, Patwari's remark that leaders who attain positions within the party begin to behave as though they own it was a thinly veiled critique of the prevailing culture of entitlement and power struggles.

His statement underscores the deep-rooted leadership crisis within the party, where personal ambitions often supersede collective goals.

For the Congress to regain its lost ground in Madhya Pradesh, addressing these internal conflicts is imperative.

Harish Choudhary's appoint-

bly elections loom on the horizon, the Madhya Pradesh Congress must introspect and realign its strategies if it hopes to mount a serious challenge against the ruling dispensation. Madhya Pradesh BJP spokesper son Narendra Saluja, who joined the saffron party after quitting Congress a couple of years ago, told The Pioneer that Choudhary

faces tough challenges ahead. The absence of senior Congress leaders Kamal Nath, Digvijay Singh, and Arun Yadav from the induction programme suggests they did not take Choudhary's appointment seriously, he added.

### **Trump's peace offensive**

Though US President Trump is attempting to resolve the prolonged war in Ukraine, the effectiveness of his methods remains uncertain

s the war in Ukraine enters its third year, US President Donald Trump is trying to broker peace. However, his approach has sparked controversy, as it appears to Sideline Ukraine in key negotiations. With Russia still holding a significant portion of Ukrainian territory, the implications of this initiative could reshape the geopolitical landscape of Europe and beyond. The critical questions remain: What would a Trump-led peace deal entail? How would it affect Ukraine's sovereignty? And what choices do Ukraine and Europe have in response? If Ukraine is sidelined in these negotiations, it could be pressured into accepting a deal that legitimises Russia's territorial gains, effectively rewarding aggression. For Russia, such an outcome would be a strategic victory, allowing it to retain control over nearly a fifth of Ukraine's land, including areas it currently does not fully control. A peace deal without Ukraine's full participation and interests at its core would have profound consequences. The Ukrainian government has consistently main-



tained that any agreement must include the restoration of its 1991 borders and accountability for war crimes committed during the invasion. However, a Trump-negotiated settlement could pressure Kyiv into compromising its sovereignty in exchange for an end

For Europe, such a scenario would be equally troubling. If Russia emerges from the conflict with territorial gains, it could embolden further aggression against NATO's eastern flank. The Kremlin's broader objective has always been to reverse the strategic impact of the Soviet Union's collapse and limit the sovereignty of Eastern European nations. A weakened

Ukraine would shift the burden of deterrence squarely onto NATO's shoulders, requiring significant military investments and commitments to prevent further Russian expansion. The effectiveness of Trump's initiative is highly uncertain. While a ceasefire might reduce immediate bloodshed, it would not necessarily lead to lasting stability. If Ukraine is forced into a compromised peace, resistance movements could emerge, leading to prolonged low-intensity conflict. Additionally, the global implications of a weakened Ukraine extend beyond Europe. A victorious Russia could inspire China to take a more aggressive stance on Taiwan, believing that the West lacks the resolve to uphold international law. Trump's initiative to end the Ukraine war could mark a turning point in the conflict, but the manner in which it is pursued will determine its impact. If Ukraine is sidelined and forced into territorial concessions, the consequences could be dire—not just for Kyiv but for the entire European security framework. While a peace deal might bring temporary relief, a settlement that fails to address Ukraine's sovereignty could embolden Russia and reshape the global balance of power in ways that will be felt for decades to come. The choices made in the coming months will define the future of Ukraine, Europe, and world security.

## A reminder of Delhi's seismic vulnerability



The 4.0 magnitude earthquake that shook Delhi-NCR recently underscores Delhi's alarming seismic risks, given its location on active fault lines

n the early morning of February 17, 2025, the residents of Delhi-NCR awakened by a sudden unexpected jolt awakening due to a tremor. A 4.0-magnitude earthquake struck the region, with its epicentre located near Dhaula Kuan, Delhi, sending shockwaves throughout the city along with neighbouring NCR. Although the quake was relatively minor, its impact felt stronger because it originated from a shallow depth and was intensified by widespread fear of bigger earthquakes. People hurriedly evacuated their homes, buildings swayed and social media was abuzz with concern.

This event served as yet another reminder that Delhi remains dangerously vulnerable to seismic shock vulnerability to seismic activity. Delhi hazardously sits on several active fault lines, including the Delhi-Haridwar Ridge and the Mahendragarh-Dehradun fault. The city falls in Seismic Zone IV and is recognised as being at high risk for earthquakes. Its closeness to the Himalayas, one of the most seismically active areas globally, further increases its risk. According to geoscientists, the Indian plate is continually pushing beneath the Eurasian plate at a rate of about 47 mm per year, generating significant underground stress. When this stress is released, it

results in earthquakes—ranging from minor to devastating. History has shown us the potential destruction of earthquakes. The 2001 Bhuj earthquake in Gujarat, which registered 7.7 on the Richter scale, resulted in over 20,000 fatalities and left entire towns in rubble. If a similar earthquake event were to strike Delhi-NCR, the aftermath could be even more disastrous. Simulations from global seismic studies, including the USGS PAGER system and the GEM Global Seismic Risk Map, indicate that a 7.7-magnitude earthquake in Delhi could result in between 150,000 to 250,000 deaths. The combination of a dense population, ageing infrastructure, and unpianned urbanisation makes the capital particularly vulnerable to widespread devastation. One major concern facing the city is the quality of construction.

safe areas in homes, and having emergency kits ready, can greatly improve safety. The government also needs to take necessary actions in this

regard. A comprehensive structural audit of buildings, particularly those constructed before modern seismic standards were established, is urgently required. Buildings that fail to meet safety criteria should be reinforced and retrofitted. It is essential to enforce the use of earthquake-resistant construction methods in new projects. Retrofitting at-risk buildings may be expensive, but it is a crucial investment for protect-

ing lives. Additionally, public infrastructure needs to be reassessed. Bridges, flyovers, and metro stations need to be evaluated for their ability to withstand seismic activity. Several cities like Tokyo and San Francisco have successfully implemented advanced technology to make buildings more earth-quake-proof. Delhi should look to these global examples to reduce the risk of widespread casualties.

A city that is well-prepared for disasters always invests in the education and awareness of its residents. Creating an Earthquake Awareness Museum in Delhi, akin to the one in Bhuj, Gujarat, could make a significant impact on

people's awareness, not only from Delhi NCR but from all

over the country. This museum could highlight Delhi's seismic history, delve

into the science behind earthquakes, and inform the public about safety protocols. Additionally, a dedicated "Earthquake Clinic" within the museum could provide free consultations with engineers on how to house earthquake resistance at a reasonable price. Moreover, implementing an efficient early warning system could significantly minimise the risk of casualties. For instance, Japan's earthquake early warning system alerts people just seconds before a quake, allowing people to take cover. Establishing a similar system in Delhi should be a national priority. Despite scientific advancements, earthquakes remain unpredictable. However, we can control the level of preparedness when a disaster strikes. The recent tremor in Delhi is more than just a fleeting event- it serves as a warning. Ignoring it could be disastrous. The time to take action is now before nature

### The road to change: A story of hope in Uttarakhand's remote Villages



As government initiatives push forward rural road development, the hope remains that these villages will soon find themselves linked to a future of greater possibilities

n the mountains, roads are more than just paths from Lone place to another they are lifelines. They connect people to schools, hospitals, and markets, making daily life easier and opportunities more accessible. For many remote villages in Uttarakhand, however, the wait for a proper road continues, shaping everyday realities in ways that outsiders rarely

In Surag and Bhagdhanu villages of Garud Block, Bageshwar District, the absence of a proper road is a challenge that residents navigate every day. The people here have adapted—carrying essentials on foot, finding their ways to reach schools and markets, and supporting each other through difficult

Yet, the dream of a well-built road remains. Kedar Singh, 70, has spent a lifetime in Surag. He describes how unpaved, uneven roads make even the simplest tasks difficult, especially during the monsoon. "When it rains, the paths become slippery, making it hard for both people and animals to move. We take our cattle to graze on the

mountains, but during the rains, they often slip on the muddy paths and fall down the slopes. It's heartbreaking to see, and it makes our work much harder." For many, the challenge is not just about movement but about access to essential services. Nandi Devi, 45, explains how women and elderly residents face particular difficulties: "When someone falls ill, finding transport is nearly impossible. Vehicles don't come here because of the poor road conditions. We have to rely on each other and make do with what we

A Journey to Education

For students, an incomplete road is more than an inconvenience—it shapes their future. Bhavana Rawal, a 10th-grade student, walks 5 km every day on an unpaved road to reach her school in Sailani, 9 km away. "Most of the time, we manage, but during the rains, we arrive at school covered in mud. On some days, we can't go at all," she says. Kavita, 18, has similar concerns. "During the monsoon and winter, getting to school is incredibly difficult. The steep paths become dangerous, and there is always the fear of slipping. Sometimes, we miss school for days, which affects our studies."

The Road Ahead

Efforts have been made over the years to bring road connectivity to Surag and Bhagdhanu. A survey for the road's construction was conducted, and discussions continued resolving land-related concerns. Local leaders, like village head Champa Devi,

have been advocating for progress, and there is optimism that change will come. In Uttarakhand, over 33,500 km of roads have already been built, with 171 km of new roads planned for 2024-25 under the Pradhan Mantri Gram Sadak Yojana. Across the state, better road connectivity has opened doors to education, healthcare, and employment. There is hope that the Rs 70,000 crore allocated in the Union Budget for rural roads will also reach villages like Surag and Bhagdhanu, ensuring that they, too, become part of this expanding network.

For now, the people of these villages continue their journeys-on foot, through difficult terrain, with patience and resilience. But with consistent efforts from local communities, government agencies, and policymakers, the day is not far when these paths will finally be paved, bringing with them new possibilities for those who have waited the longest.

#### **MAKE THE RIGHT CHOICES IN LIFE**

Those who exhibit positive behaviour and make righteous choices excel and live a meaningful life

Jes, there are five choices; by making them we can excel in life. These are to become good people. We know whom we call good. They are good in their behaviour, choices, etc. The next level is of those, who are not only good but they mostly follow dharma also, which pleases God. The next level is that of welfare workers, who dedicate their lives to the service of humanity without any selfish motive. Out of the followers of dharma, God appoints some as His (nimitta) instrument to carry out activities for God to uphold dharma. The topmost level of course is of bhaktas (devotees) of God. I will now give details regarding how one can become these five and what benefits one will derive by doing so.

To be good in spiritual parlance means to have the highest percentage of the mode of goodness. There are three modes, which are: goodness, passion and darkness. They are always competing with us. (The Bhagavad-Geeta 14.10) The mode of goodness is illuminating and free from diseases on account of purity. (14.6) The mode of passion suffers from the fault of attachment. (14.7) One is too attached to certain acts and their results. Unfortunately, the results are not in our hands. (2.47) One, therefore, suffers from anxiety, fear, depression,



The mode of darkness deludes, which gives rise to many faults like carelessness. (14.8) Lord Krishna has set out in great detail about activities in goodness in the Bhagavad-Geeta. If we imbibe them, the percentage of the mode of goodness will gradually increase in us. There are many benefits in doing so and the best is goodness being the stepping stone to devotional life - the highest, and good karmaphalas of course. The next level is of persons, who strictly follow dharma besides being good.

This sets them apart from the masses. One is aligned with the plan of God for us, who is for upholding dharma. God even incarnates to do so. (6.7) We know what dharma is; it is the highest moral and religious principle. Benefits are many including accumulating pious karmas. The third higher level is that of welfare workers. God promises no 'durgati' (bad end) for such persons. (6.40) This is a big achievement because old age and bad ends are very scary prospects for human beings. Lord Krishna has singled out King Janaka as the role model in the Bhagavad-Geeta (3.20) in this connection.

The next higher level is that of 'nimittas' (instruments) of God; He chooses them from those who are habitually followers of dharma and are inclined to serve God as Arjuna did. God does everything as a karta for them and they get credit for the acts done. (11.33) The topmost category is those of devotees of God. Their rise is from being good people to strict followers of dharma. Then, they do spiritual practices like praying, darshan of God's Deities, offering obeisance to God, chanting of God's names and mantras, dhyan of God, thanking God for favours done, etc.

They become very dear to God, who is everything. (7.19) The topmost benefit of being a devotee of God is liberation in a few lives. (6.45)I am going to describe the benefits in greater detail because these are the highest. God guides, and He, being omniscient, knows what will work every time. I have made a habit of praying for guidance anytime I have some doubts about something. I have been surprised by God's response. They are no longer intuitions because they work. The same happens in the case of help. God helps His devotees like one cannot even dream of.

## Beyond the boundary: The passion, intelligence and legacy of cricket



Cricket, the game of glorious uncertainties, is almost a religion in our country. It often gets more attention than other sports but then you have to play it to experience its magic



here are people who frown upon what they view as the obsessive interest that many Indians have in cricket and, to a lesser extent, soccer. One wonders how many of them are familiar with Rudyard Kipling's reference to the "flannelled fools at the wicket or the muddied oafs at the goal" in his poem, The Islander, first published in The Times, London, on January 4, 1902. One also wonders whether even those who are familiar are aware that any attempt to cite the quote in vindication of their position, can run into a squall.

He wrote the poem in anger, as he felt that the English cricket team that was on an ashes tour of Australia in 1901-02, was getting more attention from the public than the British soldiers who were dying in the Boer War in South Africa, which was then limping towards an end. People paid lip service to their valour and "Then ye returned to our trinkets; then ve contented your souls With the flannelled fools at the wicket or the muddied oafs at the goals."
It is clear from the lines that follow that

Kipling's rebuke was addressed not primarily at Britishers who played cricket and soccer but his countrymen in general for not doing enough to cope with the challenges that were going to confront the British empire—of which he was an unabashed apologist. These read, "Given to strong delusion, wholly believing a lie, / Ye saw that the land lay fenceless, and ye let the months go by/Waiting some easy wonder, hoping some saving sign/Idle—openly idle—in the lee of the forespent Line. / Idle—except for your boasting—and what is your boasting worth/If ye grudge a year of service to the lordliest life on earth?'

The reference in the last line was to conscription for military service that many in Britain abhorred. Let us, however, not digress, especially when it not even caused by "perfume from a dress"—as TS Eliot puts it in The Love Song of J. Alfred Prufrock. Our original concerns were cricket and soc-

cer, to which we must now revert. I have never played much soccer. I played cricket for my College (Presidency) and clubs (Union Sporting and Dakshin Kolikata Sangsad), in Kolkata in the 1950s. Even at those levels—by no means lofty—I realised that playing required a lot of intelligence and application of mind, intense concentration, reflection, enormous will power and determination, courage, considerable physical fitness and huge reserves of stamina.

INTELLIGENCE Intelligence was needed to tailor one's batting and/or bowling to meet the demands of the pitch and the nature of the outfield, The mind had to be set to work to find out the vul-BOWLING TO nerabilities of the players of the opposing side, and devise the strategy to win a match. Determination was needed to continue fighting DEMANDS OF THE even when the odds were heavily loaded against one, will power to PITCH AND THE calm the butterflies that began in fluttering in one's stomach as one walked out to bat and took guard, and courage not to run away from fast bowling on a wicket with uneven bounce where one could get hurt any moment.

The matches we played were mostly for a day. As an opening batsman, I could be at the wicket for a maximum period of three hours. As a first-change medium pacer, I bowled a maximum of eight overs in two spells. As the skipper of my college team, I fielded mostly at first slip or short square leg, which meant I did not have to do much running around. Yet I was pretty much drained out at the end of it all. Cricket matches are war by other means among well-established rivals, and particularly so when it England and Australia for the ashes. It, however, also has other dimensions. If history, to quote TS Eliot again—this time from Gerontion— "has many cunning passages, contrived corridors," cricket has its tantalising moments and amusing Several of the latter relate to Dr WG

Grace, a legend of English cricket who had an MRCS and LRCP against his name. In one of these, he had gone to a village to play in a charity match, and a massive crowd had turned out to watch. A huge cheer rent the sky as he walked to the wicket and took guard. Then the unthinkable happened. A village lad who was bowling shattered his stumps with the devil of a delivery. The umpire signalled "out." A deadly hush fell on the ground. Grace did and said, "All of these people have come to see WG Grace bat and not your monkey tricks. So go back and start bowling."

There are stories relating to India as well. One of these is about Ganesh Bose who, along with his brother, Kartik Bose-both my maternal grand-uncles—constituted the bedrock of Bengal's batting from the late 1920s to late 1940s. A dashing batsman, he was once out to a rank bad shot in a critical match.

One of his maternal uncles, who was among the spectators, rushed to him as he returned to the pavilion, and unleashed a mouthful of colourful abuses. Ganesh Bose glared at him for a moment and then said between his teeth, "I would have buried you here had you not been my maternal uncle (mama na hole tomake eikhane punte pheltam in Bengali). There are many stories about Kartik

There was a good spinner who played college and club cricket and kept long hair, which fell on his eyes every time he bowled. Watching him at the Cricket Association of Bengal's nets at the Eden Gardens, which he conducted, Bose had asked him several times to cut his hair. As the spinner showed no sign of complying, he summoned one of Kolkata's many roadside barbers who sat in the Kolkata Maidan, and, as the nets concluded, had a crewcut administered to him.

I had to give up cricket shortly after 21. Those days, cricket offered neither money nor the kind of career I wanted. The crunch came when I saw some of those who played with me join the railways at subordinate levels, while my friends at college joined the Indian Railways Traffic Service and the Indian Railways Accounts Service, both central services of the Government of India,

## Netanyahu decries release of wrong body as ceasefire violation

### HAMAS PLEDGES TO INVESTIGATE

Israeli Prime Minister Benjamin Netanyahu vowed revenge Friday for what he described as a "cruel and malicious violation" of the ceasefire agreement after a body that Hamas released as part of the deal was found to not be that of an Israeli mother of two young boys, as the militants had promised.

The incident has thrown the future of the fragile ceasefire into question. Six more living hostages are scheduled to be released Saturday as part of the tenuous ceasefire that has paused over 15 months of war. În a statement on Friday, Hamas said it would "conduct a thorough review" of the information regarding the body, and suggested a possible mixup of remains might have occurred due to Israeli bombing of the area where the Israeli hostages were being held, where other Palestinians were also

present. Hamas turned over four bodies Thursday as part of the ceasefire. They were supposed to have been those of Shiri Bibas and her two young sons, Kfir and Ariel Bibas, and of Oded Lifshitz, who was 83 when he was abducted during the Hamas attack that started the

war on October 7, 2023. Israeli authorities said that while the remains of the two boys and of Lifshitz were positively identified, the fourth body was found to not be that of Shiri Bibas, but that of an unidentified woman from

"We will work with determination to bring Shiri home together with all our hostages — both living and dead — and ensure that Hamas pays the full price for this cruel and malicious violation of the agreement," Netanyahu said.

'The sacred memory of Oded Lifshitz and Ariel and Kfir Bibas will be forever enshrined in the heart of the nation. May God avenge their blood. And so we will avenge.

Hamas said it had "no interest in retaining any bodies", adding that it had "demonstrated full compliance with the agreement in recent days and remain committed to all its terms".

'We reject Netanyahu's threats, which serve only to manipulate Israeli public opinion," Hamas said, calling on mediators to ensure the continued implementation of the ceasefire. The group also called for the return of the unidentified remains, which Israel has said are those

## Ukrainians rally around Zelenskyy

Days before the third anniversary of Russia's full-scale invasion, Ukrainians are as sombre and tense as they were right before Moscow launched the war. Only now, they aren't just worried about their longtime

Ukraine's stunning new threat comes from its once staunchest ally, the United States, whose support appears to be fading as President Donald Trump echoes the narrative of Russian President Vladimir Putin while pledging to stop the fighting between the two countries.

After their initial shock at Trump's false claims this week that Ukraine is led by a "dictator" who started the war with Russia, the Ukrainian people are rallying around a defiant President Volodymyr Zelenskyy, who publicly criticized Trump for promot-

ing Russian "disinformation." Yes, he's not a perfect president, but he's not a dictator," said Kateryna Karaush, a 25-year-old tech worker from Kyiv who like some Republicans in Congress is struggling to wrap her head around Trump's embrace of Russia, which represents a major about-face in US foreign policy. "It feels like the whole world is against us," Karaush said.

Against long odds, Ukrainians – with massive military support from the US - have prevented



country, even if roughly one fifth of it is now under Russia control.

But after three years of war, both civilians and soldiers are exhausted. Hundreds of thousands have been killed or wounded, tens of thousands are missing, and millions have fled the country. The mood only became gloomier in recent days as Trump signaled his desire to rapidly bring the fighting to a close on terms that Zelenskyy and many in the West say are too favorable to Russia. After Trump called ly postponing an election last year and as reports emerged of US and Russian officials meeting in Saudi Arabia to discuss a possible ceasefire without input from Ukraine, even some of Zelenskyy's harshest domestic critics have begun defending

"We may have different opinions

about Zelenskyy, but only Ukrainian citizens have the right to judge his support," said Yaroslav Zhelezniak, a lawmaker from the opposition party Holos. "And to publicly criticize him too, because, in the end, he

is our elected leader." Trump's harsh words for Zelenskyy have drawn criticism from Democrats and even some Republicans in the US Congress, where defending Ukraine from Russia — with tens of billions of dollars in military aid — has had bipartisan support. But Vice President JD Vance admonished Zelenskyv for publicly warning Trump about falling for Russian disinformation. On Thursday, the deepening

tensions led to the cancelation of a news conference that had been planned to follow talks between Zelenskyy and Trump's Ukraine envoy over how to end the war. A poll released Wednesday by the Kyiv International Institute of

Sociology put public trust in Zelenskyy at 57%. The survey was conducted Feb 4 to Feb 9 among 1,000 people living across Ukraine in regions and territories controlled by the Ukrainian gov-"We have a president whom we

### Macron's message to Trump: 'You can't be weak in face of Putin

 $F^{\mathrm{rench}}$  President Emmanuel Macron said he intends to tell Donald Trump that it's in the joint interest of Americans and Europeans not to "be weak" in the face of Russia's Vladimir Putin amid US-led negotiations to end the almost three-year war in Ukraine.

Macron is to travel to Washington to meet with Trump on Monday, the White House said.

In a one-hour question and answer session on his social media Thursday, Macron said he'll tell Trump: "You can't be weak in the face of President Putin. It's not you, it's not your trademark, it's not in your interest. How can you then be credible in the face of China if you're weak in the face of Putin?'

Trump's recent statements that echo Putin's narrative and plans to have direct negotiations with Moscow have left European allies and Ukrainian officials worried. But Macron suggested Trump's strategy to create "uncertainty" in talks with Russia could actually make Western allies stronger in these talks

Putin "doesn't know what he (Trump) is going to do, he thinks (Trump) is capable of anything," Macron said. "This uncertainty is good for us and for Ukraine." Macron added he would seek to persuade Trump that US interests and Europeans' interests are the same, telling him: "If you let Russia take over Ukraine, it would be unstoppable." That means any peace deal must be negotiated with Ukrainians and Europeans around the table, Macron reaffirmed.

"We want peace, but we don't want a ceasefire that means Ukraine surrendering, because that's dangerous. And we know that would lead to Russia going further. We've already experienced it," he said.

Macron also appeared ready to answer Trump's call to boost defence spending. "Us, Europeans, we must increase our war effort," he said.

### Trump admin flouting order to temporarily lift freeze on foreign aid, judge says

**PTI** ■ WASHINGTON

The Trump administration has kept withholding foreign aid despite a court order and must at least temporarily restore the funding to programmes worldwide, a federal judge has said. Judge Amir H. Ali on Thursday declined a request by nonprofit groups doing business with the US Agency for International Development to find Trump administration officials in contempt of his order, however.

The Washington, D.C., district court judge said administration officials had used his February 13 order to temporarily lift the freeze on foreign aid to instead "come up with a new, post-hoc rationalisation for the en masse suspension" of funding.

Despite the judge's order to the con-

trary, USAID Deputy Secretary Pete Marocco, a Trump appointee, and other top officials had "continued their blanket suspension of funds", Ali

The ruling comes in a lawsuit by the nonprofit groups challenging the Trump administration's month-old cutoff of foreign assistance through USAID and the State Department, which shut down USD 60 billion in annual aid and development programmes overseas almost overnight. Even after Ali's order, USAID staffers and contractors say the State Department and USAID still have not restored payments even on hundreds of millions of dollars already owed by the government.

Marocco and other administration officials defended the nonpayment in writ-

ten arguments to the judge this week. They contended that they could lawfully stop or terminate payments under thousands of contracts without violating the judge's order.

The Trump administration says it is now doing a programme-by-programme review of all State Department and USAID foreign assistance programmes to see which ones meet the Trump administration's agenda.

Aid organisations, and current and former USAID staffers in interviews and court affidavits, say the funding freeze and deep Trump administration purges of USAID staffers have brought US foreign assistance globally to a halt, forced thousands of lavoffs and is driving government partners to financial

### Xi passes orders to transform China's military into world-class armed force

Thinese President Xi Jinping issued fresh orders on Friday revising rules to transform the country's military into world-class armed forces, focusing on combat readiness and war preparation amid growing rivalry with the US and tensions over Taiwan and neighbours. Xi, 71, who heads the military besides the pow erful ruling Communist Party of China (CPC)

and the Presidency, signed orders to publish

three regulations on the military's interior order, code of conduct and military formation. state-run Xinhua news agency reported. The revisions to the regulations prioritise combat readiness as the foremost duty, with a fundamental orientation of preparing for and

engaging in warfare. Fully applying the strategy of running the armed forces by law, the revised rules aim to promote a more standardised order in war preparation,

training, operations and daily life, the report said. The revision to the military code of conduct refines the rules to award the excellent, punish violators and streamline relevant procedures, it said. The revised rules, which will take effect April 1, are designed to fully transform the country's military into world-class armed forces. The regulations on the military's interior order were revised to improve the management of mil-

itary personnel in matters such as soldiers'

appearance and conduct, leave-taking and military training. The revised regulations on military formation were added with detailed codes of practice concerning military parades on the land, in the sea, at the dock and in the air. These rules were promulgated as China gears up for increased frictions with the US after the return of President Donald Trump, who vowed to follow a firm policy to contain Beijing's rise with tariffs as well

### Canada designates 7 Latin American criminal groups as terrorist entities

Canada is designating seven Latin American criminal organisations as terrorist entities under the country's Criminal Code, giving Canadian law enforcement another tool in the fight against fentanyl trafficking, Public Safety Minister David McGuinty has said.

The list includes Mexico's Sinaloa Cartel, Jalisco New Generation Cartel and La Nueva Familia Michoacana, and was announced a day after the US government formally designated eight Latin American organized crime groups

as "foreign terrorist organisa-"The measures will help keep fen-

tanyl off Canadian streets and from entering the United States," McGuinty told a news conference. The announcement was Canada's latest response to US President Donald Trump 's claim that the flow of fentanyl and illegal immigration into the US were behind his threats of imposing a 25 per cent tariff on all Canadian goods with the exception of 10 per cent

on energy Trump has paused the implementation of those tariffs until at least

US border patrol statistics show that less than 1 per cent of all fentanyl seized is found at the northern border. But Canadian officials have expressed a willingness to do more to combat the deadly synthetic opioid

The other organisations designated as terrorist groups are Cartel del Golfo and Carteles Unidos, also from Mexico; Tren de Aragua, in Venezuela, and the Mara Salvatrucha, or MS-13, which started in California but became a dominant criminal force in El Salvador.

The designation effectively freezes a group's assets and property.

Banks and brokerages will freeze these entities' assets, which can then be the subject of seizure, restraint or forfeiture," said McGuinty.

It is also an offence to knowingly participate in, or contribute to, any activity of a listed terrorist

group.
The listing process begins with intelligence reports that indicate whether an organisation has knowingly carried out, attempted to carry out, participated in or facilitated a terrorist activi-

McGuinty said listing a group as a terrorist entity follows a rigorous process that "must meet a legal threshold".

If the public safety minister believes that threshold has been met, the minister may recommend to the federal cabinet that the organization be added to the

RCMP Commissioner Mike Duheme said the RCMP has intelligence indicating that crime

in the meeting room when it was Lammy's turn to speak. No details of Lavrov's speech were released.

The two-day G20 gathering on Thursday and Friday comes days after landmark bilateral

"Kash is a brilliant lawyer, investigator, and 'America First' fighter who has spent his career exposing corruption, defending justice, and protecting the American people," Trump said. Meanwhile, Democrats say Patel is a far-right conspiracy theorist with little experience in law enforcement, and someone who would put fealty to Trump above his oath to lead a department that is meant to operate independently. "(Patel's) poor judgment and lack of experience make him wholly unqualified to keep Americans safe as our FBI Director. I voted no, Senator Martin Heinrich said on

#### Brazil's top court justice orders X to pay **USD 1.4** million fine for non-compliance certain accounts from the months over free speech, far-

Brazil's Supreme Court Alexandre de Moraes ordered X to pay 8.1 million Brazilian reais (USD 1.4 million) in fines for failing to comply with judicial orders, according to a judicial ruling. The ruling, signed on Wednesday and made public by the court on Thursday, said the social media platform refused to provide registration data for a profile attributed to Allan dos Santos, an ally of former president Jair Bolsonaro accused of spread-

ing falsehoods. In July 2024, De Moraes ordered both X and Meta to block and ban the account and provide the data. X said it had blocked the account but could not deliver the requested information, arguing that its operators didn't collect it and that the user had "no technical connection point with Brazil".

De Moraes rejected the argument and, in early August, imposed a daily fine of 17,500) if the social media platform failed to provide the data. By October, the total fine for noncompliance had reached 8.1 million Brazilian reais. X appealed but later notified the court that it would pay the fine. In Wednesday's ruling, the justice ordered the company to pay the full amount immediately. It is unclear from the decision reviewed by The Associated Press whether X provided the requested registration data. The company didn't immediately reply to AP's request for comment. Last year, De Moraes ordered X's nationwide shutdown after the company said it was removing all remaining Brazil staff in the country, saying de Moraes

"Given the macroeconomic outlook when inflation is expected to align with the target, and recognising that monetary policy is forwardlooking, I view a lower policy rate to be more appropriate at current juncture, Malhotra said, according to the minutes.

Chairing his first MPC meeting, he had also pointed out that rising uncertainties on global financial markets

coupled with continuing risk of adverse weather events pose risks to the inflation and growth outlook.

While the central bank had reduced the rate, it continued with the neutral stance of monetary policy.

'This will provide the flexibility to respond to the evolving macroeconomic environment. By taking this logical course, monetary policy will be able to fulfil its mandate and play its part in the sustainable development of the Indian economy," Malhotra said.

Headline inflation, after moving above the upper tolerance band in October, has moderated and was at a five-month low of 4.3 per cent in January. MPC member and RBI

Governor Rajeshwar Rao said that at the current juncture, with a alignment of headline inflation towards the 4 per cent target, there is greater space to address concerns regarding growth by way of reduction in the

policy repo rate.


The rupee pared initial gains and (provisional) against the US dollar on Friday, weighed down by sustained foreign fund outflows and a recovery in the American currency index.





## Gill gives India confidence against Pakistan

hubman Gill has an invincibility cloak hung around his shoulder in ODIs these days. Conditions and oppositions do not feature in his

After taking a dominant avatar against England recently at home, Gill faced a different challenge against Banglades (FI) India's Champions Trophy (CT) opener in Dubai on Thursday

The pitch was sluggish and the bowlers consistently probed for

But Gill beat both to notch up his eighth ODI hundred that led India to a six-wicket victory. The 125-ball century was the slowest he has made so far, but was perhaps the most important in his career.

That uncharacteristically sedate outing carried a deeper meaning as it validated Gill's growing stature as India's all-weather batter in white-ball formats.

His form is a good omen when legends like Virat Kohli and Rohit Sharma, who have been performing that role for several years, are in the twilight zone of their careers. And with important matches against Pakistan and New Zealand linedup, India would need him to

There were a couple of signature shots last night — a cracking short-arm pull off pacer Tanzim Hasan and a spearing, lofted cover drive off the same bowler for a four.

continue in the same vein.

Those hits in the ninth over were breathtaking, showcasing Gill's otherworldly timing, but even more mesmerising was his transformation to a batter full of self-restraint after that.

When Rohit Sharma (41) got out in the 10th over, Gill was batting on 26 off 23 balls, and a lift-off looked imminent.

But it wasn't there. His next boundary came in the 33rd over when pacer Taskin Ahmed returned to attack.



Till then, Gill was milking the spinners and pacer Mustafizur Rahman, a lethal slower ball, for singles and twos, ensuring that the quick start given by Rohit would not go in vain.

In that phase, the 25-year-old scored just 30 runs off 52 balls, showing admirable situational

awareness. It was of little surprise when Gill termed it as a

"Satisfying" effort.
"Definitely one of my most satisfying innings that I have played. The message was sent from outside that I have to try to bat till the end and that's what I tried to do." (sill would say later. tried to do," Gill would say later to the host broadcaster.

Rohit was also chuffed to see the Punjab cricketer adhering to the team order.

"He's been batting brilliantly of late and what he showed us (against Bangladesh), it shouldn't surprise anyone. What was good to see was he was there till the end," said Rohit.

Along with carrying his bat through, Gill also tweaked his tactics as per the game's evolving needs.

A feature of Gill's batting was him coming down the track even against pacers, something he does not usually do.

Generally, he stays at the crease to drive, flick or pull the quicker bowlers, a minimalistic approach

that reduces the risk quotient. Gill explained that change in his

approach.
"Cutting the ball wasn't easy because the balls which were outside the off-stump weren't coming onto the bat that nicely.

"So, I thought of using my feet to

even the fast bowlers and tried to go over the circle," he added. The strategic fluidity apart, Gil's willingness to look beyond easy-on-the-eye but fleeting knocks will stand India in good stead in

this tournament. If the early signs are anything to go by, then the pitches in Dubai could remain slow-burners.

## Kerala enter Ranji Trophy final

A resilient Kerala on Friday Sealed their maiden Ranji Trophy final by taking a dramatic two-run first-innings lead over Gujarat, 68 years after making their debut in Indian cricket's premier

domestic competition.
Going into the final day at 429/7, the home side, who won the Ranji title in 2016-17, needed just 29 runs to take a first imping lead. first innings lead.

However, left-arm spinner Aditya Sarwate delivered under pressure, taking all three wickets to bowl Gujarat out for 455 in 174.4 overs to leave them two runs short of the mark.

Making only their second semifinal appearance, the visitors had been left frustrated by a dogged 72-run eighth-wicket stand between Jaymeet Patel (74 overnight) and Siddharth Desai (24 overnight). They started the day needing three wickets with just 28 runs to defend.

Kerala, who last made the semifinals in 2018-19 after making their Ranji debut back in 1957, will face Vidarbha in the summit clash after the latter defeat heavyweights



Mumbai by 80 runs in the other semifinal.

Sarwate's breakthroughs came amid high drama, including a dropped catch, a tight stumping decision, and a successful DRS review that overturned a caught-out call to an LBW dismissal.

First it was Kerala skipper Sachin Baby, who dropped the well-set Jaymeet with Gujarat 23 runs shy of a lead. But Jaymeet could not make it

count and perished for 79 (177 balls; 2x4) in the same over when he dragged his foot outside the crease while the ball passed his outside edge for Mohammed Azharuddeen to complete an excellent stumping.

After multiple replays, umpire finally ruled him out as his

foot was found to be on the line when the bail was knocked off as Kerala camp went up in celebration.

But there was more to the contest as Gujarat left-arm quick Arzan Nagwaswalla, batting at No 10, counter-attacked and smashed Akshay Chandran for a cover boundary to take them within 14 runs of the lead.
