Fisrt-time MLA Rekha to be new Delhi CM

First-time MLA Rekha Gupta will be the new chief minister of Delhi, the BJP announced on Wednesday.

Gupta was chosen as the Leader of the House in the Delhi Assembly at the BJP legislature party meeting. The party has returned to power in Delhi after over 26 years, ending the 10-year rule of the Arvind Kejriwal-led AAP.

Gupta and her Cabinet ministers will take the oath of office at the Ramlila Ground on Thursday. She will be Delhi's fourth woman chief minister after Sushma Swaraj, Sheila Dikshit and Atishi. She will be the only woman chief

minister among the states being ruled by the BJP at present.

The 50-year-old leader won from Shalimar Bagh, defeating AAP candidate Bandana Kumari by over 29,000 votes in the February 5 Assembly polls.

All 48 newly-elected BJP MLAs attended the legislature party meeting in the presence of Central observers Ravi Shankar Prasad and O P Dhankar.





Rajalingamurthi who filed case against **KCR** murdered

Unidentified persons killed one Nagavelli Rajalingamurthi on Wednesday using swords. Nagavelli had filed cases against KCR, former BRS Ministers and the companies who executed the Kaleshwaram Project.

The murderers killed Nagavelli near the TBGKS office in the Reddy Colony in Bhupalpally district headquarters when Nagavelli was riding his two-wheeler. Nagavelli died on the spot.

The police shifted the body of Nagavelli Rajalingamurthi to the mortuary and launched an investigation.

Ganga water at Sangam unsafe for bathing

The Ganga water at Triveni Sangam, where lakhs of people are taking a holy dip every day during the ongoing Maha Kumbh, is currently unsafe for bathing as it exceeds the prescribed limit for biological oxygen demand (BOD), a key parameter to determine water quality, according to government data.

BOD refers to the amount of oxygen required by aerobic microorganisms to break down organic material in a water body. A higher BOD level indicates more organic content in the water. River water is considered fit for bathing if the BOD level is less than 3 milligrams per litre.

Government data shows that the river water at Sangam is currently exceeding this limit. The BOD level at Sangam was 5.09 milligrams per litre at 5 am on January 16. It was record-

ed at 4.6 milligrams per litre at 5 pm on January 18 and 5.29 milligrams per litre at 8 am on January 19 (Wednesday).

According to Central Pollution Control Board (CPCB) data, the BOD level at Sangam was 3.94 milligrams per litre on January 13 when the Maha Kumbh started.

It improved to 2.28 milligrams per litre on Makar Sankranti (January 14) and further dropped to 1 milligram per litre on January 15.

However, it rose to 4.08 milligrams per litre on January 24 and was recorded at 3.26 milligrams per litre on

Mauni Amavasya (January 29). In a report submitted to the National Green Tribunal on February 3, the CPCB said the river water quality did not meet bathing standards during



monitoring on January 12-13 at most locations in Prayagraj. "However, after that, organic pollution (in terms of BOD) started to

decrease due to freshwater intrusion at upstream locations. After January 13, 2025, river water quality (is) conforming (to) the bathing criteria w.r.t. bathing.

BOD except (at) Lord Curzon bridge on river Ganga on January 19, 2025, the CPCB report read.

According to Uttar Pradesh government officials, 10,000 to 11,000 cusecs of water is being released into the Ganga to ensure it meets bathing standards. The Maha Kumbh, which started on January 13, will conclude on February 26, Maha Shivaratri day. Over 54 crore people have taken a dip in the sacred waters of Triveni Sangam so far.

Draft UGC regulations make V-Cs very vulnerable

The dratt University Grants Commission (Minimum for **⊣**he draft University Qualifications for Appointment and Promotion of Teachers and Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education) Regulations, 2025, makes Vice-Chancellors vulnerable and dependent on the Minister and the subordinate entity named UGC. Although called the University Grants Commission, it is neither a university nor a commission. Grants for any university depend on the Centre's sweet will.

A significant issue of this 'regulation' is the proposal to revise the selection process for Vice-Chancellors. This draft has given powers to Chancellors or Visitors to constitute a three-member search-cum-selection committee to appoint ViceChancellors. The guidelines also warn that non-implementation of it may result in debarring an institution from participating in UGC schemes or from offering degrees. The UGC has given 30 days to stakeholders and the public to comment on the draft. A Vice-Chancellor is gener-



Uttam requested the installation of telemetry systems at both Srisailam and Nagarjuna Sagar dams and at 35 points on the Krishna River to ensure transparency and prevent disputes. These systems would provide real-time data on water usage, ensuring adherence to allocated quotas. The Union Minister agreed, recognising the importance of accurate monitoring mechanisms.

Stressing the need for accelerated approvals and funding, Uttam urged the Centre to sanction key irrigation projects, including the Palamuru-Rangareddy Lift Irrigation Scheme (PRLIS), the Sitarama Sagar Project and the Sammakka Sagar Project. He also demanded that PRLIS should be granted the national project tag and full Central funding. Jal Shakti Secretary Mukherjee said the Centre would explore the possibility of providing infrastructure funds for Telangana's irrigation projects at zero per cent interest with a 50-year repayment period. She also committed to granting all necessary approvals for the Sitarama Sagar Project within a month. 

Pen cap stuck in man's lungs for 21 years removed

A 25-year-old IT employee from Karimnagar had unknowingly lived with a pen cap lodged in his lungs for 21 years before doctors at KIMS Hospital, Kondapur successfully removed it.

The man had accidentally swallowed the pen cap at the age of four or five but never experienced significant symptoms until a month ago when he developed a persistent cough and unexplained weight loss. Over the last 10 days, his condition worsened, making it difficult for him to sleep

lower left lung. Consultant Clinical and Interventional Pulmonologist, Dr Shubhakar Nadella, explained the case, "We conducted a CT scan that showed a suspicious obstruction in his

lungs. Initially, we thought it was just an infection. However, during the proce-

actually a pen cap stuck deep inside. Midway through the procedure, we called in his elder brother, who then recalled that the patient had accidentally swallowed a pen cap as a child. At that time, a doctor had assumed it had naturally passed through his system.

The three-hour-long proce-dure involved the use of a flex-

ible bronchoscopy to careful-ly remove tissue buildup and muscle formations around the pen cap before extracting it. Prolonged exposure had caused lung damage, but doctors were able to restore the affected area with antibiotic treatment. The patient has since made a full recovery.

5,660 students suffer from eye defects in Khammam

A total of 5,660 students have been identified with vision defects out of the 1,89,784 students from govern-ment schools and colleges who were screened for eye ailments.

Last year, between April and October, students from government schools and junior colleges were screened twice for vision problems as part of the Rashtriya Bala Swasthya Karyakram. Expert doctors conducted diagnostic tests

to assess students' eye health. The second round of screening for the 5,660 affected students began on February 17, with daily checks of 200 students. The screening is expected to be completed by March 15. Based on the results, students suffering from severe issues will be referred for surgical treatment at the Sarojini Devi Government Eye Hospital in Hyderabad. Meanwhile, students with less serious conditions will be treated with medication and prescribed glasses.

Over the past three days, the second phase of the screening has been underway in government hospitals Sathupalli, Nelakondapalli, and Khammam in Khammam district. A total of 1.11 lakh students from ,332 government schools and colleges have been tested for eye problems, revealing that 3,557 students are experiencing vision issues. These students are unable to read properand often suffer from headaches. In Bhadradri-Kothagudem district, 78,227 students were screened,

and 2,103 students have been identified as needing a second round of testing. The screenings are being

conducted daily, with 250 students being examined at hospitals in Bhadrachalam and Kothagudem starting from February 17.

Dr Ramakrishna from Khammam attributed the high inci-dence of vision problems to poor nutrition, prolonged screen time, and excessive use of smartphones and TVs. He pointed out that many hostel students have developed the habit of using smartphones during their vacation periods. He advised parents to limit their children's creen time and encourage outdoor play to promote better eye health.

Dr Kalavati Bai, the District Medical and Health Officer, visited the special eye camp at the district headquarters hospital on Tuesday. She stated that ophthalmic officers from the Rashtriya Bala Swasthya Karyakram had identified 3,500 students with vision-related issues after two rounds of screenings in government schools.

If needed, these students will be referred to Hyderabad for further surgical treatment.

Chaos as farmer attempts self-immolation

Finally, the police allowed the farmers to hold a rally, during which they demanded that the state government provide the full compensation they were entitled to while continuing their procession with begging bowls in their hands.

Aadhaar server glitch: Cotton procurement grinds to a halt

Komuram Bheem Asifabad district cotton farmers are facing severe difficulties with the Aadhaar server malfunctioning. Since February 10, the cotton procurement has come to a grinding halt. The Cotton Corporation of India (CCI) has stopped procuring cotton due to glitch in Aadhaar authentication. As a result, around 350 cotton vehicles are waiting in front of ginning mills.

Authorities have announced that procurement has been stopped due to disruptions in Aadhaar authentication. However, there has been no clarity as to when procurement of cotton would be resumed, leading to concerns among farmers. Procurement is expected to resume only after the Aadhaar server is restored.

To facilitate procurement, a total of 18 CCI centres have been set up in the district. Farmers have been lining up at these centres to sell their cotton, and they rented vehicles to transport their produce. However, due to the disruption in

the Aadhaar server since February 10, the rented vehicles have been waiting for 15 days in front of the mills, increasing the burden of vehicle rental costs.

The support price for cotton, if the moisture content is within the acceptable range, should be Rs 7,521 per quintal. However, private traders are paying only Rs 6,500 per quin-tal or even less, citing quality issues. As a result, farmers have been waiting in long queues at CCI procure-ment centres for over a week. Private vehicle rentals have

and some farmers are finding it difficult to pay the higher rental fees. They are selling to private traders at a loss who are exploiting the situa a loss, who are exploiting the situation by offering lower prices, even below the support price.

Farmers are urging for an immediate resolution of this issue and the resumption of CCI cotton procurement without further delay.





Three Rohingyas from Myanmar were identified and arrested by the police at a farmhouse in Narsing Thanda under Rajapur mandal. They were produced before the court and remanded in judicial custody

Mahbubnagar Deputy Superintendent of Police Venkateswarlu at a media conference at the Jadcherla police station revealed the arrest of Rohingyas. Noor Mohammad, a Myanmar national, who was residing at Balapur in Hyderabad, had created a fake passport a visa for Saudi Arabia. After going to Saudi Arabia, he returned to Hyderabad in 2022. In October 2022, he obtained another visa and went to Dubai, returning within a month. He married a Rohingya girl, Rizwana, from Balapur.

With the help of an agent, he crossed into Bangladesh via the Tripura border, where he stayed for a year in Cox's Bazaar. During this time, he met a couple, Sumayya Mohammed and Aroob Ahmed, who informed him that he could earn more money in India. He took a large sum of money from them.

In March 2024, the couple illegally entered India through the Tripura border at Charma Nagar at night. The next morning, they reached Agartala, the capital of Tripura, and from there traveled by train to Secunderabad. To avoid the police, they worked at a farmhouse at Narsing Thanda in Jadcherla constituency, owned by a person from Hyderabad named Ayog. They had been staying at the farmhouse for eight months. Ten days ago, the main accused sent his wife to Bangladesh with the help of an agent. Acting on information, sub-inspector Shivananth Goud conducted an investigation after a complaint was filed. The police arrested three illegal immigrants—Noor Mohammad, Muhammad Aru Ahmed, and Sumayya.

Man sells infant son for Rs 1 lakh, booked

CBI arrests 5 railway officials for graft in exam

he CBI has arrested five railway officers, including two of the Indian Railway Personnel Service posted at the Vadodara Division, for alleged bribery in favouring candidates in departmental examination, officials said Wednesday. The federal probe agency seized 650 grams of gold and Rs 5 lakh cash during its searches at 11 locations, including in Gujarat's Vadodara, a CBI spokesperson said. The CBI has arrested 2008batch IRPS officer Sunil Bishnoi posted as a senior divisional personnel officer in Vadodara, 2018-batch IRPS officer Ankush Wasan, posted as divisional personnel officer there, Deputy Chief Commercial Manager Sanjay Kumar Tiwari posted at Mumbai's Churchgate, Deputy Station Superintendent Neeraj Sinha and Nursing Superintendent Dinesh Kumar posted at Divisional Railway Hospital in Ahmedabad, officials said. The agency has also arrested Mukesh Meena in the case, they said. The refugee crisis is a perplexing issue for governments, requiring a delicate balance between maintaining national security and extending compassion to those in need

he paradoxes of rapid global changes are proving to be a contemporary reality, one that sheds light on the philosophical aphorism proposed by Samuel P. Huntington, that of "Political Decay." This concept is becoming increasingly evident in highly developed societies, particularly in the face of numerous challenges concerning security. The issue of illegal migration, human trafficking, and the plight of refugees has become a significant concern, with its implications stretching across borders, creating tension among nations, and fueling rising anxieties about national security.

A few years ago, the discovery of fifty refugees dead near eastern Austria, along the Slovakia-Hungarian border, prompted videspread discussion on the issue of illegal migration and related crimes. This tragic event highlighted a larger issue facing European countries-illegal migration and the security risks that come with it. Many individuals from underdeveloped regions, in their search for survival and opportunities, attempt to migrate o European countries, often taking illegal routes. The tragic drowning of more than 80 illegal migrants in a boat off the coast of Libya is just one example of the deadly risks faced by those desperate for a better life. In light of these challenges, it is imperative that European nations develop more sophisticated mechanisms to address this issue, one that has already caused significant tension between countries.

The broader problem of migration and refugees, particularly in regions such as Afghanistan and Central Asia, has created a complicated and often violent dynamic. As refugees flee war and persecution, they find themselves subject to not only economic exploitation but also social discrimination. According to reports, over 70 per cent of the 26

n the predawn darkness, millions of pilgrims converge at the sacred confluence of the Ganges, their faith burning brighter than the stars above. The Mahakumbh, humanity's largest gathering of spiritual seekers, presents a profound paradox of our times - the sublime beauty of collective devotion juxtaposed against the perils of unquestioning faith. His remarks stirred debate on India's response to terrorist incidents and the appropriate diplomatic approach to such crises. Despite all controversies, he continued to be Indian Overseas President. The brutal truth is that the displacement of the Chagossians, the abduction of their homes, their lands, and their futures, was merely a strategic calculation by the British government, sanctioned and enabled by the United States. These islands have been stripped of their rightful inhabitants, and instead of facing international condemnation, they remain a linchpin in the projection of military power. Lord Dannatt's proposal that the UK should relinquish control of the islands not to Mauritius, but directly to the US, serves as a blunt reminder that this military realpolitik is not just a policy but an ideology one that continues to shape decisions about sovereignty, justice and human lives in ways that are both morally

bankrupt and legally indefensible. The truth is that the Chagossians were forcibly displaced, their lives uprooted, their families scattered across the world, and their right to return externatical their right to return systematically denied. The UK government's refusal to comply with ICJ rulings, while continuing to enjoy a special relationship with the US, sends a clear message to the world: law and justice are subordinate to power and strategy. The international legal community can issue as many judgments as it likes, but it is all for naught when the major powers choose to ignore or bypass those rulings in favour of military interests. The declassified documents from the 1960s and 1970s reveal the collusion between the US and the UK to create a military enclave on Diego Garcia, with the forcible removal of the Chagossians merely an administrative detail to be swept under the carpet. In those documents, we see the foundations of a dirty deal that placed

geopolitical strategy above the basic human rights of a people. It is colonialism dressed as military necessity, and those who challenge this narrative are dismissed as idealists, outliers, or irrelevant. This is not just a matter of the Chagossians' rights; it is a fundamental crisis of the global legal and moral order. It is a scandal that has gone largely ignored, an injustice that has been swept under the rug of strategic necessity, and an entire people's history erased in the name of military convenience. How can anyone with even a hint of conscience ignore these flagrant breaches of international law, perpetrated by those who claim to champion human rights while posing as defenders of democracy? Our complicity, fuelled by willful indifference, contributes to the erosion of international law and the degradation of fundamental human dignity.


Hyundai aims to be production hub for exports

Irdai: Provide ASBA facility for premium payments

PNS NEW DELHI

Insurance regulator Irdai has asked life and health insurers to provide Bima-ASBA, a facility wherein a policyholder blocks the amount towards premium in his or her bank account which gets debited only when the policy is issued.

According to Insurance Regulatory and Development Authority of India (Iradi) norms, premium is required to be paid only after the insurer communicates the decision of acceptance of the proposal to the customer.

Peres emphasises that the program's long-term vision is to expand further, ensuring that more children receive the essential nutrients they need. "We are committed to scaling our impact year on year. By 2030, we aim to reach a significantly larger number of children, tackling morning hunger on a much broader scale."

Targeting the most vul-nerable communities has been central to Bright Start's mission. The programme prioritises underprivileged areas where access to balanced nutrition is limited. "We've focused on regions across Maharashtra, Gujarat, across Andhra Pradesh and Karnataka," Peres explains. "Working closely with NGO partners like Shri

Satya Sai Annapoorna and The Breakfast Revolution, we ensure that nutritious breakfasts reach children in both urban and rural areas."

One of the key reasons these regions were selected is the high prevalence of mal-nutrition and food insecurity among children. Through strategic local partnerships, they have been able to distribute fortified, multigrain cereals with milk, ensuring chil-dren receive a consistent, balanced meal.

For any large-scale nutrition programme to be sustainable, collaboration is key. He credits Bright Start's success to a well-structured partnership model. "We work closely with NGOs, local communities and government bodies," he says. "For instance, in ernment bodies, he says. For instance, in Karnataka, the state government pro-vides milk, while Kellanova supplies Kellogg's cereals and sponsors SaiSure Fortified Ragi in collaboration with Annapoorna Trust, enhancing the nutri-tional value of school meals."

Similarly, in Andhra Pradesh, the state government has granted permissions for the initiative, allowing Kellanova and Annapoorna Trust to jointly implement the Morning Feeding Programme in rural schools. 
around 32 cases have been filed against him and his wife from various places, including Delhi, Tirupati, and other regions. He continued, "There's only one version of the truth, and numer-

Shubman Gill becomes No 1 ODI batsman

ndia vice-captain Shubman Gill on Wednesday dethroned Babar Azam of Pakistan from the Number one spot in the ICC ODI Rankings for batters on the back of his strong show against England in the recent home series.

The ICC issued the latest rankings just ahead of the start of the eightteam Champions Trophy (CT) in Karachi with the match between Pakistan and New Zealand.

"India right-hander Shubman Gill overtakes former Pakistan captain Babar Azam to become the top ranked ODI batter in the world," the ICC said.

Gill, who scored two fifties and a century in the recent three-match ODI series against England at home which India won 3-0, jumped one place to the No. 1 spot. He now has 796 rating points compared to Babar's 773.

Babars 773. India skipper Rohit Sharma is placed at the third spot with 761 points followed by South Africa's Henrich Klaasen and New Zealand's Daryl Mitchell at fourth

and fifth respectively. "It's a major shake-up at the top of the rankings just prior to the start of the Champions Trophy and leaves an interesting sub-plot to what will transpire over the coming



weeks during the eight-team tournament in Pakistan and Dubai," the ICC said.

"This is the second time Gill has held the No.1 ranking in ODI cricket, with the India batter having also gone past Babar to claim top

Gill has been in excellent form of late, with his century against England in Ahmedabad during the third ODI of the recently concluded series enough to

spot midway through the ICC catapult the 25-year-old to the top Men's Cricket World Cup in 2023. of the rankings," the global of the rankings," the global governing body added. Sri Lanka's Maheesh Theekshana,

meanwhile, has taken the first position in the ODI rankings for bowlers as he replaced Afghanistan captain Rashid Khan.

"While Sri Lanka won't be featuring at the Champions Trophy, Theekshana earned the top spot following his exploits against the Aussies that included an excellent four-wicket haul in the opening match of that series in Colombo," the ICC said.

Sri Lanka had recently handed a 2-0 whitewash to Australia with Theekshana taking four wickets. The Sri Lankan spinner has 680 rating points, followed by Rashid at second, Namibia's Bernard Scholtz at third, India's Kuldeep Yadav at fourth and Pakistan's Shaheen Shah Afridi at fifth.

"Meanwhile, Afghan spin wizard Rashid drops to second and will be keen to regain the No.1 spot as he trails his Sri Lankan counterpart by just 11 rating points," the ICC said. "While a trio of spinners in India's squad Kuldeep Yadav (up one place to fourth), South Africa's Keshav Maharaj (re-enters the rankings in sixth) and New Zealand's Mitchell Santner (up four rungs to seventh) are all inside the top 10 after making ground this week." Afghanistan veteran Mohammad

Nabi remains the top ranked all-rounder in ODIs, followed by Raza, Azmatullaĥ Sikandar Omarzai, Mehidy Hasan Miraz and Rashid.

Former Mumbai captain and selector Milind Rege, a highly respected figure in domestic cricket, died after suffering a heart attack on Wednesday, just days after

turning 76. Rege, who turned 76 last Sunday, was admitted in the intensive care unit of the Breach Candy Hospital here and passed away around 6am on Wednesday morning. He is survived by his wife and admiration across the cricketing fraternity," it said. two sons.

The all-rounder had suffered a heart attack at the age of 26 but returned to the cricket but returned to the cricket field and even captained Mumbai in the Ranji Trophy. Bangladesh can beat any team in Champions Trophy: Shanto

Heading into their Champions Trophy (CT) opener against formidable neighbours India, Bangladesh skipper Najmul Hossain Shanto was filled with optimism. He was particularly emboldened by the rise of pace sensation Nahid Rana, who has added a new dimension to their bowling attack.

The 22-year-old Rana holds the record for the fastest ball (152kph) bowled by a Bangladesh cricketer, hits 150kph on occasion, and averages 145kph for most of his

Besides the presence of Rana and experienced pace colleague like Taskin Ahmed, the team also has few useful all-rounders and spinners, and some good batters. "Obviously, all-rounders always balance the rounders always balance the team and we have got some good all-rounders. I hope they will perform tomorrow," Shanto said in the pre-match press conference here on Wednesday. "If you look in this format, our

team is quite balanced and we believe we can beat any team in this tournament. All teams are capable of winning this trophy but I am someone who is not thinking about the opponents much. If we execute our plan properly we can beat any team in any day," Shanto said.

After years of struggle, Bangladesh are now in a position to boast a good pace-bowling attack, feels Shanto.

"Yes, obviously. I think we always struggle with our seam attack, but last couple of years we have got some quality fast bowlers. Now we have got Nahid Rana, Taskin the way they are bowling. I think it helps

a lot. "As a captain, we love to see As a captain, we love to see them bowling fast. So, I'm really happy that we have got a good fast bowling unit and under lights the ball might swing. So, if they bowl in the good areas, it will beln our team? will help our team." Rana has done well in his

nascent career, having taken 20 wickets in six Tests and four scalps in three ODIs. Bangladesh are in a group in quality teams. And against

"We have to play well in all departments - batting, bowling, fielding - because I think the way we played the last few years in this format, I think we have a good side and as you mentioned the conditions are quite similar. I'm really confident that we will prepare ourselves well."

When asked about Rana, Shanto said he was looking to leading the pace attack on Thursday and that his emergence has motivated the

whole bowling unit. "I think last few matches he bowled really well and bowled fast. And when we see in the ground bowling like this, it helps our whole bowling unit. And it's motivated us.

"He needs to be fit and he can continue his bowling form. We have got another two-three fast bowlers as well," he said.

After their opener in Dubai, Bangladesh will be playing their last two group games in Pakistan, and the conditions there are going to be different. "Yes, here I think we need to adjust, because if you look at this wicket, probably it's not that high scoring if you compare to Pakistan. So, we have to adjust. "Recently we played against Pakistan in a Test match in Rawalpindi. We have that experience how the wicket will behave. But as a cricketer, I think we all understand when

we need to adjust and how to play the game. I don't think it will be difficult."

Talks around fast-bowling unit Talks around fast-bowling unit With Rana linking up with the likes of Taskin, a lot of people have started talking about Bangladesh's fast bowling department, and Shanto said factors such as switching to Duke balls and arrival of experts from overseas have contributed the to improvement in the country's

pace attack. I think the important thing is the wicket and the ball has been

changed in first class cricket. We play with the Duke ball, so the fast bowlers wanted to bowl a lot of overs and we get a little bit charged.

"And obviously there is a lot of local coaches and obviously overseas coaches there, so they helped and they motivated the fast bowlers, how they can compete in the international arena."

"So that is one thing... The ball has changed and the wicket, and thanks to BCB the way they think about our fast bowlers," he said.

Shanto is also expecting a lot of crowd support for his team in Dubai. The Bangladesh skipper added that he is not solely relying on his pacers to power their bowing attack, but they also have experienced spinners in their ranks.

"I am not just depending on our pace bowling attack, to be very honest. What I mentioned is that we did not have a lot of pace bowlers now unlike earlier times. We have always had spinners, so we now have good balance of pace, and spin."
