## TG inks power banking deals with UP & MP

Telangana has entered into power banking agreements with the Uttar Pradesh Power Corporation Limited (UPPCL) and the Madhya Pradesh Power Management Company Limited (MPPMCL) to ensure uninterrupted power supply during peak

The power swap agreements will help Telangana balance electricity supply and demand efficiently, particularly from February to April when energy consumption is at its

As per the agreement, UPPCL will supply power to TGPCC/TGDISCOMs between February and March 2025, ranging from 1,000 MW to 3,000 MW. Telangana will return the power to UPPCL between May and July, with an additional 5% of the availed

power as a returnable quantum. Similarly, MPPMCL will provide 150 MW of power from March to April, while Telangana has the flexibility to draw up to 500 MW between February and April based



on availability and needs. In return, Telangana will bank power with MPPMCL from December 2025 to January 2026, ensuring 105% returnable quantum of availed energy. These strategic agreements will help the state manage demand fluctuations and mitigate any shortages during peak

summer months. Official sources said the power banking agreements will complement these efforts, ensuring grid sta-bility and a reliable electricity sup-

ply to industries and households. With Telangana's energy demand continuing to rise, agreements like this have a crucial role in maintaining a sustainable and efficient power distribution system.



### TG govt slashes LRS fees by 25% Amends regularisation rules

PNS HYDERABAD

In a major relief to property owners, the Telangana government has announced a 25% reduction in Layout Regularisation Scheme (LRS) fees, alongside key amendments aimed at simplifying the regularisation process for unauthorised layouts. The decision, issued through a Government Order (GO), is expected to benefit thousands of applicants who had raised concerns over the high financial burden and procedural delays.

According to officials, the fee reduction is aimed at making regularisation more accessible while ensuring compliance with urban planning norms. Additionally, the new amendments streamline approval mechanisms, clarify penalty structures and introduce a faster verification process

to address long-standing grievances The government has also simplified

documentation requirements, reducing ambiguities that previously delayed approvals. With thousands of applications pending under the existing system, the revised guidelines are expected to accelerate approvals and provide a transparent framework for ayout regularisation.

Urban development authorities have welcomed the move, stating that the amendments will not only benefit individual plot owners but also enhance planned urban expansion. Further details on the implementation of the revised LRS rules are likely to be released in the coming days, with officials urging applicants to review the updated guidelines and comply with necessary regulations.

### CMO probing **Rajalingamurthy** murder case

"Since the last three months, Andhra Pradesh has been removing 10,000 cusecs daily from the Nagarjuna Sagar. What are the Chief Minister and Irrigation Minister doing?" he asked.

He said that Andhra Pradesh has already exceeded its temporary allocation of 512 TMC by utilizing 657 TMC from Krishna waters, yet the Congress government remains

He criticised the government's failure to take control of the Nagarjuna Sagar, despite the Assembly passing a resolution demanding the withdrawal of the CRPF and asserting Telangana's authority over the project. Harish Rao presented alarming statistics, revealing that in the last 25 days alone, 60 TMCs had been diverted by Andhra Pradesh, averaging 2 TMC per day. He said that as per the agreed water-sharing ratio, Telangana should receive 343 TMC, but it has only used 220 TMC so far, meaning 123 TMC is still pending. Andhra Pradesh, on the other hand, should have received only 666 TMC but has already taken 657 TMC, leaving only 9 TMC as per the agreement.

He accused the Congress government of failing to prevent water theft, questioning why it had not pressured the Centre or confronted Andhra Pradesh Chief Minister Chandrababu Naidu. "They lack the guts to challenge Chandrababu or question the Centre. The same leaders who shout at the opposition in the Telangana Assembly are silent when it comes to Andhra Pradesh," he

Harish warned that the existing 100 TMC of water in Srisailam and Nagarjuna Sagar is at risk of being diverted, leading to severe shortages for drinking water in Hyderabad, Khammam, Mahbubabad, Nalgonda, and Suryapet.

He pointed out that nearly 6.38 lakh acres of farmland under the Sagar left canal and AMR SLBC project need urgent irrigation, requiring at least 30 to 35 TMCs.



On January 23, when Shashidhar visited the accused's office at Devender Nagar, Jagadgiri gutta, he found it closed, and several other victims were present with similar complaints. It was later discovered that the accused had absconded with multiple vehicles.

The police have registered multiple cases under various sections of the Bharatiya Nyaya Sanhita (BNS). Three of the accused, identified as Chivakala Ramana, Jakkamsetty Satyanarayana, and Reddy Venkatesh, are absconding.

### Woman drug peddler held, 60 grams of MDMA seized

PNS HYDERABAD

In a significant crackdown on synthetic drug trafficking, the Cyberabad Police, in collab oration with the Telangana Anti-Narcotics Bureau (TGANB), arrested a woman drug peddler and seized 60 grams of MDMA, a commercial quantity valued at Rs 6 lakh. The accused, identified as Shatabdi Manna, a resident of Sola Devanahalli in Bengaluru and a native of Jamsherpur village, Jharkhand, was intercepted at Miyapur bus stop while attempting to deliver the contraband.

Investigations revealed that Manna was part of an inter-state drug network operating under the direction of a foreign supplier, identified as Warren Kokarango, an African national who is currently absconding. She allegedly came in contact with him in 2024 and, facing financial difficulties, agreed to store and distribute MDMA on his

She is suspected of having handled multiple consignments ranging between 100 to 200 grams and supplying drugs over 10 times in Bengaluru before being caught in Hyderabad.

Earlier on February 11, two Rajasthanbased peddlers were arrested in Cyberabad with 40 grams of MDMA, while on December 25 last year, three local peddlers were apprehended in Film Nagar with 17.38 grams of the drug. In October, a Rajasthanbased gang was busted in Hyderabad, leading to the seizure of 350 grams of MDMA, with cases registered at Abids, Afzalgunj and Choutuppal police stations.

### TG ACB nabs two govt officials in bribery cases

The Anti-Corruption Bureau (ACB) of Telangana arrested two government officials on bribery charges in separate incidents on February 20. The accused were caught red-handed while accepting bribes for granting official favours.

In the first case, ACB officials apprehended Boppuri Anand Kumar, Executive Director and FAC General Manager of the Telangana Scheduled Castes Co-Operative Development Corporation, Hyderabad.

He was caught at his office by the ACB City Range-2 unit while accepting a bribe of Rs 1 lakh from a complainant. He had initially demanded Rs 1.33 lakh as a reward for processing a sanctioned bill of Rs 33.32 lakh and for ensuring further payments.

The tainted cash was seized from him, and chemical tests confirmed traces of the bribe on his hands and office items. He was taken into custody and produced before the Special Judge for SPE and ACB Cases at Nampally.

In another case, the ACB Khammam unit arrested Shanthan Kumar, Mandal Agricultural Officer of Ashwapuram, Bhadradri Kothagudem district. He was caught red-handed at his office while accepting a Rs 30,000 bribe to issue coupons for a complainant to sell his cotton crop cultivat-

The bribe money was recovered, and chemical tests confirmed positive results. He was presented before the Additional Special Judge for SPE and ACB Cases at Warangal.

The Telangana ACB has urged the public to report any demands for bribes through its toll-free helpline 1064 or via WhatsApp (9440446106) and social media platforms. The bureau assured that complainants' details would be kept confidential.

### **Collector asks residential school** to constitute mess committee

Traders in the district are facing a growing issue with the shortage of small coins, which are not being reintroduced into circulation. While business owners have no trouble attracting customers or boosting sales, small change has

become a challenge.
As customers make purchases, they often receive coins as change, but these coins are not finding their way back into the market. Many people are not carrying coins anymore and instead give the small change they receive to their children or drop them in piggy banks. This practice has contributed to the ongoing shortage.

# Mango growers cautioned against indiscriminate use of pesticides

PNS ■ KHAMMAM

Mango, which is known as the king of fruits, is cultivated in over 32,105 acres In Khammam district. Primarily, the mango orchards are concentrated in areas such as Sathupally, Vemsoor, Penuballi, Kalluru, Tallada,

Errupalem, and a few other mandals. The main varieties cultivated Banganapalli, Dasheri, Himayat and Totapuri, Rasalu.

Currently, the mangoes are in the fruit development stage. District Horticulture Madhusudhan has advised the

following precautions to be taken during this stage. In the fruit-setting stage, water management is crucial. Water should be given in smaller amounts, as over-irrigation can lead to issues like stem borers pest attack, honeydew pests, and powdery mildew dis-

The dropping of fruit is a significant problem, which can occur due to water shortage, hormonal imbalances, or nutri-

tional deficiencies. During the fruit-setting stage and in the 15-20 days after that, giving 2-3 irrigations to the trees in areas where water is available can significantly improve the fruit set, preventing fruit drop and helping the mangoes

grow larger and of better quality. Even if water is not available in the area, tankers can be used to irrigate

the trees, which will be a worthwhile investment as it leads to better revenue than the irrigation cost.

During the fruitsetting stage, applying 500-1000 grams of Potash and 500-1000

2 kilograms of neem powder to each tree will promote large, high-quality mangoes and improve vield, the horticulture.

To achieve the best results in pest control, it is advised not to apply the same pesticide more than once. This could lead to pests developing resistance to the chemicals. Therefore, for each problem, more than one pesticide is recommended. The growers were cautioned against

# Inter-state drug syndicate busted, 300 kg marijuana seized PNS RANGAREDDY

The Special Operations Team (SOT) of Maheshwaram Zone, in collaboration with Abdullapurmet Police, busted an interstate drug syndicate and arrested a drug ped-dler. The police seized 300 kg of Marijuana, along with a container vehicle, with the total value of the seized property estimated at Rs 1.05

The arrested accused has been identified as Ahmed Gulab Shaik (56), a resident of Nigidi in Pune. He was reportedly working as a transporter in the illegal drug trade. Another accused, identified as Bujji Babu from Visakhapatnam in Andhra Pradesh, who supplied the contraband, is absconding.

According to police reports, Ahmed Gulab Shaik, originally from Pune, was working as a driver but turned to drug trafficking due to financial difficulties. He allegedly collaborated with two drug peddlers, Vaibhav and Deva

from Pune, who offered him Rs 3 lakh per consignment to transport ganja from Visakhapatnam to Maharashtra. Having successfully transported two consignments earlier, he was on his third delivery when he was caught.

Following instructions from Vaibhav and Deva, Ahmed collected 300 kg of marijuana (packed in 138 packets) from Bujji Babu in Visakhapatnam. To avoid police detection, he concealed the contraband within plastic scrap inside a container and proceeded towards Pune via Hyderabad.

Acting on a tip-off, the SOT Maheshwaram team, along with Abdullapurmet Police, intercepted the vehicle near the Film City on Hyderabad-Vijayawada highway in the early hours of Thursday. The police apprehended Ahmed Gulab Shaik and seized the contraband under a formal panchanama.

A special team has been formed to track down the absconding accused, including Vaibhav, Deva, and Bujji Babu.

### **Harbouring terrorists** endangers safety: Delhi HC

he Delhi High Court has said harbouring terrorists led to creation of "safe havens" for them and endangered the safety of citizens by providing them with a "veil of secrecy" A bench of Justices Prathiba M Singh and Amit Sharma made the observations on February 18 and denied bail to Zahoor Ahmad Peer, a resident of Wahama in Jammu and Kashmir's Kupwara district. Peer was arrested in 2017 for allegedly providing logistical and material support to terrorists infiltrating from Pakistan into Kashmir for carrying out subversive activities. The high court said providing food and a safe shelter to persons associated with terror organisations, encouraged terrorism over a long period and harbouring of terrorists was a serious offence under the Unlawful Activities (Prevention) Act, attracting the maximum penalty of life imprisonment. "Harbouring of terrorists may not be seen to be a serious offence, especially when it is claimed that the same is under duress or coercion. However, a deeper analysis would reveal that harbouring is not an innocent act," the bench said.

# SC stays Lokpal order on hearing complaints against HC judges

The Supreme Court on Thursday stayed the Lokpal order on entertaining complaints against sitting high court judges saying it was "something very, very disturbing" and concerned the

independence of the judiciary.
A bench of Justices B R Gavai, Surya Kant and Abhay S Oka issued notice and sought responses from the Centre, the Lokpal registrar and the person who filed complaints against a sitting high court judge.

Issue notice to the Union of India, Registrar, Lokpal of India and the complainant, returnable on March 18 at 10.30 am," the bench said.

Solicitor general Tushar Mehta, appearing for the Centre, said a high court judge

would never fall within the ambit of the Lokpal and Lokayuktas Act, 2013.

Dealing with Lokpal's order on two specific complaints against the sitting high court judge, the bench, issued an injunction to prevent the complainant from disclosing the name of the judge and directed him to keep the complaint confidential.

The apex court was dealing with a suo motu case initiated after the Lokpal passed the order on January 27.

The bench directed the registrar concerned to mask the identity of the complainant and serve notice upon him at his residence through the registrar (judicial) of the high court. "In the meantime there shall be stay of the order dated January 27, 2025 passed by the Lokpal of India...," it added.

### 'Haryana launches witness protection scheme'

Taking a big stride towards implementing the three new criminal laws, the Haryana government has rolled out a new programme -- the Haryana Witness Protection Scheme, 2025 -- to ensure the protection of witnesses in the state.

A notification to this effect has been issued by the home department, an official statement said on Thursday.
The scheme will be

applicable to witnesses of those offences which are punishable with death or life imprisonment or a jail term of seven years and above.

"It will also cover punishments under Sections 74, 75, 76, 77, 78 and 79 of the Bharatiya Nyaya Sanhita (BNS), as well as under Sections 8, 10, 12, 14 and 15 of the Protection of Children from Sexual Offences Act (POCSO), 2012," it said.



### 71% of newly-sworn in Delhi ministers face criminal cases: ADR

Five, including the chief minister, out of seven newly swornin ministers in Delhi have declared criminal cases against themselves, while two are billionaires, according to poll rights body Association for Democratic Reforms.

The findings are based on the

self-sworn affidavits submitted by the ministers ahead of the 2025 Delhi Assembly Elections. According to the analysis by the ADR, five out of seven ministers (71 per cent) have declared criminal cases against themselves, while two ministers (29 per cent) are billionaires. The highlighted that five ministers, including Chief Minister Rekha Gupta, have declared criminal cases against themselves. Among them, one minister, Ashish Sood, faces serious criminal charges.

On the financial front, two ministers, accounting for 29 per cent of the cabinet, are billionaires. The minister with the highest declared total assets is Manjinder Singh Sirsa from Rajouri Garden constituency with assets worth Rs. 248.85 crores and the minister with the lowest declared total assets is Kapil Mishra from Karawal Nagar constituency with assets worth Rs 1.06 crores.

The average assets of the seven ministers analysed stand at Rs 56.03 crores. All seven ministers have declared liabilof the New Delhi constituency having the highest liabilities at

and research innovation. "Encephalitis is an increasing global threat. Without urgent

will see more needless deaths and disabilities from the condition," said Dr Ava Easton, the chief executive of Encephalitis International.

Encephalitis, caused by infectious and autoimmune factors, is an often-deadly brain inflammation that can affect anyone regardless of age, sex or ethnicity. It can lead to severe neurological consequences, including permanent brain injury.

It arises either from an infection invading the brain, such as Japanese Encephalitis and Scrub Typhus which are more prevalent in India or from the immune system mistakenly attacking the brain.

Japanese Encephalitis cases were reported from 24 states and Union Territories in the WHO

According to a survey in Encephalitis International 2024, as many as 1,548 urged policymakers, public urged policymakers, public health professionals, healthcare providers, and researchers to implement its recommendations to save lives and reduce

disability associated with encephalitis.



of our life is enacted. We play, rewind and rerun an enormous number of movies. These are based on our idiosyncrasies and quality of thoughts. Thoughts are impacted by the kind of food we partake in (Tamasik, Rajasik, Sattvik), the company we keep and the amount of rest we take. The quality (guna) of food has a bearing on our disposition and approach to life. Tamasik food makes us sluggish, Rajasik food makes us feverish or anxious in disposition and Sattvik food makes

The first two lead us to fearful situations. If we are closeted to individuals who have a negative thought process, we impide such attributes and evince such a behavioural pattern. "Man is known by the company he keeps" is a very old adage and so is "man is born free but always is in chains". Suppose we have inspirational friends and achievers in our orbit, we will tread such a path. It is cardinal to have adequate physical and mental rest. If we are rested, then we are at peace and do not complain or quibble. Then we are physically and mentally alert and high-yielding. In our minds, we need to keep space to just dump the garbage that disappears into the recycle bin, never to appear again.

We need to pursue passions, hobbies, indulge in sports, participate in extracurricular activities, avoid negative company, take up initiatives, practice meditation, keep the mind occupied, footslog on the treadmill, go for long walks, go for treks, and read autobiographies of entrepreneurs and achievers. ### **Govt extends tenure of CEA** till March 2027

he government on Thursday extended the tenure of Chief Economic Adviser (CEA) V Anantha Nageswaran for two years till March 2027. Appointments Committee of the Cabinet (ACC) headed by Prime Minister Narendra Modi approved the tenure of Nageswaran on a contract basis up to March 31, 2027. With the approval of ACC, the tenure of V Anantha Nageswaran as Chief Economic Adviser on contract basis is extended up to March 31, 2027, or until further order whichever is earlier, an office order said. Nageswaran assumed charge of the CEA on January 28, 2022, for a three-year term. The office of CEA is responsible for giving advice to the government on various economic policies and drafting the Economic Survey which is tabled in Parliament a day ahead of the Union Budget. Nageswaran, an academic and former executive with Credit Suisse Group AG and Julius Baer Group, succeeded K V Subramanian. His extension comes weeks after the Economic Survey 2024-25 projected a growth of 6.3-6.8 per cent for the next financial year amid Asia's third-largest economy showing signs of moderation.

Asked about the nature of the proposed pact, one of the sources said it will be decided after bilateral meetings.

The idea to reach out to all

departments is to inform them about the US circulars, "what will be there in BTA? What is the meaning of reciprocal tariffs? Any agreement we do, we involve all the ministries also,"

they added. Commerce and Industry Minister Piyush Goyal recently stated that the two countries can offer concessions and duty reductions, as their economies complement each other.

Normally in a free trade agreement, two trading partners either eliminate or significantly reduce customs duties on the maximum number of goods traded between them.

### India's GDP growth to slow to 6.4 pc: Moody's **Analytics**

Moody's Analytics on Thursday said India's growth will slow to 6.4 per cent in 2025, from 6.6 per cent in 2024, as new US tariffs and softening global demand weigh on

In its report titled 'Asia-Pacific Outlook: Chaos Ahead', Moody's Analytics said growth across the Asia-Pacific economy will slow in 2025 as trade tensions, policy shifts, and uneven recoveries knock the region's fortunes.

"Growth across the region will slow as new tariffs and softening global demand weigh on exports,"

It projected Chinese GDP growth slowing to 4.2 per cent in 2025 and 3.9 per cent in 2026 from 5 per cent in 2024. Growth in India will creep into the low-6 per cent range in the coming years from 6.6 per cent in 2024. As per its APAC forecast, İndia's GDP is expected to grow 6.4 per cent both in 2025 and 2026 fiscal years.

### **NSDL** aims to launch Rs 3,000-cr **IPO** by next month: Official

Depository firm NSDL is targeting to launch its much awaited Rs 3,000crore initial public offering (IPO) by next month, a senior official said on Thursday.

As a market infrastructure institution (MII), National Securities Depository Ltd (NSDL) also needs other approvals apart from the draft red herring prospectus, the official said, adding that it is this approval which has a looming deadline.

"Our dates are expiring next month. We are rushing against time to get things done fast. We will try (to launch the IPO before that),' the official said, replying to a specific query on the timeline for the IPO.

The 12-month deadline for the DRHP expires in

September, but it is the MII approval given by Sebi which is prompting the depository handling a bulk of India's dematerialised accounts to expedite the share sales process.

Asked if the choppy market conditions are leading to a delay, the official said even in this situation there are some offerings hitting the market. Responding to a question on the reasons behind the delay in share sale, the official pointed towards challenges on the manpower front, saying the amount of work to be done is very large.

NSDL had received a goahead from Sebi for the IPO in September last year.

As per reports, NSE, State Bank of India (SBI) and HDFC Bank plan to offload 5.72 crore equity shares in the issuance which will be a complete offer for sale (OFS).



Raised in a traditional household with her mother, Paakhi (Sonali Kulkarni) and grandmother (Apara Mehta), Roohi finds herself navigating a whirlwind of emotions, societal expectations and romantic complications.

As she processes her pregnancy, Roohi's world becomes even more chaotic due to the people surrounding her. Her long-term boyfriend Omkar (Abhay Mahajan), an Intelligence Bureau officer, is caught up in an undercover investigation, while Samar (Aashim Gulati), the owner of the Madh Island hotel where Roohi works, unknowingly turns out to be the biological father of her child. Meanwhile, the hotel itself becomes a backdrop for a web of crime, hidden identities, and unresolved past relationships—including a rekindled romance between Paakhi and Vanrai (Jaaved Jaaferi).

The series juggles multiple storylines—family drama, romance, crime and comedy—delivering a fast-paced narrative packed with twists and turns, all while exploring the changing dynamics of love, tradition and modern womanhood.

### **ANALYSIS**

Oops! Ab Kya? attempts to bring the charm of Jane the Virgin into an Indian setting, blending humour, drama and chaos. The series shines in its depiction of generational conflicts, with Roohi, Paakhi, and her grandmother forming a compelling trio whose interactions provide some of the most heartfelt moments. However, the show's biggest

challenge is its pacing—by condensing a long-format telenovela into just seven episodes, it rushes through crucial plot points, often sacrificing depth for speed.

While the concept of a virgin protagonist dealing with an accidental pregnancy is intriguing, the emotional weight of Roohi's journey feels underexplored. The story frequently shifts focus to external subplots—crime investigations, business rivalries and love triangles—sometimes at the cost of its central theme. The Madh Island hotel, though an interesting setting, becomes overused, with almost every major event unfolding within its premises.

Despite these drawbacks, the show delivers plenty of laughs and entertaining twists. Shweta Basu Prasad leads with confidence, and the ensemble cast adds charm to the storytelling. However, the hurried execution leaves viewers craving more depth, making *Oops! Ab Kya?* an enjoyable but uneven adaptation.

### **HIGHLIGHTS**

The core strength of *Oops! Ab Kya?* lies in its lead performances and its fresh take on unconventional motherhood. Shweta Basu Prasad brings a natural charm and emotional depth to Roohi, portraying her confusion, resilience and wit with great ease. The show also excels in its lighthearted, self-aware humour, particularly in the way it references the original series. One notable meta moment is when a character jokes about Samar (Aashim Gulati) resembling Justin Baldoni, a clear nod to his Jane the Virgin counterpart.

Another highlight is the unexpected romance between Paakhi and Vanraj (Jaaved Jaaferi), whose past love story resurfaces after decades. Their chemistry adds a nostalgic and heartwarming touch, proving that love stories don't always have to be limited to the younger generation. The show's approach to breaking societal taboos, particularly

around surrogacy and single motherhood, is also commendable. Instead of heavy-handed messaging, it weaves these themes naturally into the story, showing how love and support can triumph over judgment and criticism.

Despite its entertaining premise, *Oops! Ab Kya?* struggles with pacing issues. By compressing a 22-episode telenovela season into just seven episodes, the show ends up cramming in too many plotlines, leaving some underdeveloped. The series introduces multiple subplots—drug rackets, undercover investigations, infidelity, hidden identities and even a murder mystery—within the confined space of the Madh Island hotel. While this adds layers of intrigue, it also overwhelms the central narrative, making it difficult to fully connect with Roohi's personal journey.

Moreover, the characters' reactions to major revelations sometimes feel oddly muted. Roohi's unexpected pregnancy, which should have led to intense emotional conflicts, is treated with surprising nonchalance by those around her. This lack of high-stakes drama reduces the impact of what should have been pivotal moments.

### PERFORMANC

Shweta Basu Prasad delivers a strong performance, balancing comedy and emotion effortlessly. Having previously taken on more intense roles, this lighthearted portrayal is a refreshing change for her. Aashim Gulati steps into the role of Samar with ease, though his character's development feels somewhat rushed.

Sonali Kulkarni and Apara Mehta shine as Roohi's mother and grandmother, respectively, bringing warmth and depth to their roles. Jaaved Jaaferi, in his limited screen time, adds charm to the narrative with his old-school romance. Abhay Mahajan, as Roohi's boyfriend Omkar, has an interesting role as an Intelligence Bureau officer, but his subplot often feels like a separate storyline rather than an organic part of the main plot.

### TECHNICAL ASPECTS

Visually, *Oops! Ab Kya?* maintains a vibrant, glossy appeal, capturing the charm of its beachside hotel setting. However, the overuse of a single location for almost all key events can make the show feel somewhat repetitive. The cinematography effectively complements the show's playful and dramatic tones, while the background score helps

heighten the comedic and emotional beats. One of the standout elements of *Jane the Virgin* was its clever use of narration and editing techniques, which added to its satirical edge. In *Oops! Ab Kya?*, while the transitions and exaggerated reactions attempt to recreate a similar energy, they sometimes feel overdone, making certain scenes appear more chaotic than engaging.

### /FRDICT

Oops! Ab Kya? is a fun, breezy watch that successfully blends humor, drama, and romance but struggles to maintain a steady pace. Shweta Basu Prasad anchors the show with her compelling performance, while the supporting cast adds charm and depth. However, the series' attempt to juggle multiple storylines in a limited timeframe leaves some moments feeling rushed and underdeveloped. While it may not capture the satirical brilliance of Jane the Virgin, it does offer an enjoyable, light-hearted take on an unconventional story. If you're looking for a quick, entertaining binge with doses of chaos and comedy, Oops! Ab Kya? is worth a watch. Just be prepared for a whirlwind ride that packs in more than it can fully explore.

wicketkeeper-batter, considered one of the game's greatest for captaining India to two World Cup titles in a storied international career, set a high benchmark for a leader with his calm and focused approach on the field.
He is now gearing up for what most believe is his final IPL

season as a player with Chennai Super Kings and at an event here, he turned philosophical when asked to give advice to fans and followers.

"I think, keep life simple. Be honest to yourself, have gratitude towards people for whatever they have been doing for you. Don't always think, 'this is my birthright' and ask for more," the enigmatic big-



hitter said here on Wednesday evening during the launch of his app 'DHONI' powered by Single. Id where injured India keeper-batter Sanju Samson was also present.

"I know the whole app (DHONI) says 'thoda aur' (a little more), but the whole thing is to have that gratitude, to say thank you, to respect the elders (and) to give love to the younger ones," he added. He then went on to stress on

the need to have a forgiving attitude, which he feels is in short-supply right now.
"I always felt having a smile on your face solves half the problem. Even if you're not in a comfortable position, even if it's tough to do, have the power to forgive. That is one thing that not many of us have," said the cricketer who has never responded to the personal attacks on him by anyone, including former teammates or critics, some of whom have even accused him of hurting

We have become a very revengeful people. Isne mujhe aisa bola, main aisa bola (He said something to me, I said something back)... Just forgive, move on, be happy in life, because whatever we do... When we're growing up, we always wanted to be happy in life," he further stated.

Dhoni said being careless towards a few things helps in balancing the pressure of day-

to-day life. "We all feel the pressure. We always say the grass is greener on the other side. We always feel that his or her life is better, but what is important is how you manage that stress, how prepared you are," he said.

"I keep it very simple. Growing up, we were told 'you cannot be careless'. But I feel in today's environment, it is important to be a bit careless because you can't worry about each and everything that is happening around you. You cannot do things that are not in your control," he added.

Dhoni said those who are obsessed with perception are not particularly constructive. He felt not every opinion merits a response or even consideration.

"If you get carried away with what others are feeling, then that important thing of what needs to be done, often you are not really giving utmost attention to that," he said.

"I am a bit careless in life. I don't give everything my 100 per cent attention because I feel this is important, (or) that's not important," he explained.

February 19.
