

Rescue team races against time to save eight trapped workers

Rescue operations at the Srisailam Left Bank Canal (SLBC) tunnel collapse site near Domalapenta have intensified, with efforts underway to locate and extract the trapped workers. A multi-agency team, including personnel from the Army, Navy, Singareni Collieries, the central government's roadways department, Jaypee, and Navayuga, has so far conducted seven rounds of tunnel inspections. The team comprises 584 expert personnel who have previously been involved in successful rescue missions in Uttarakhand. Additionally, 14 specialized rat-hole miners have been deployed to aid in the search.

TG's tourism industry lost ground last decade

Telangana, once among India's top 10 domestic tourism destinations, slipped into obscurity in the last decade. The latest India Tourism Data Compendium 2024 reveals that Telangana, which ranked seventh in domestic tourist visits in 2013, is not in the top 10 rankings in 2023.

Foreign tourist arrivals at Hyderabad's Rajiv Gandhi International Airport saw a slight increase from 3.41 lakh in 2019 to 3.56 lakh in 2023.

In 2013, Telangana reported 54.08 million domestic tourist visits, securing the seventh rank among Indian states. By 2019, its ranking went to eighth with 83.04 million visits. However, by 2022, Telangana had dropped to ninth place with 60.75



million visits.

The situation worsened in 2023 as Telangana was completely absent from the list of top 10 states in domestic tourism, marking a signif- istered 254.71 million visits.

This downturn contrasts with the national trend, where domestic tourism saw a sharp rebound in 2023, reaching 2.5 billion visits, a 44.98% increase from 2022. Uttar

Pradesh topped the list with 478.53 million visits, followed by Tamil Nadu (286.01 million) and Karnataka (284.12 million)

Despite the state's overall decline in tourist footfall, Hyderabad's iconic sites recorded an increase in visitors. Charminar attracted 12.90 lakh domestic visitors in 2023-24, compared to 9.29 lakh in 2022-23. Golconda Fort also saw a rise, welcoming 16.08 lakh visitors in 2023-24, up from 15.27 lakh in the previ-

ous year Hyderabad MP Asaduddin Owaisi has urged the state government to take immediate steps to enhance visitor facilities at Charminar and Golkonda Fort. He has called for the construction of a parking lot at the Old Charminar Bus Stand space to accommodate tourist buses and private vehicles.

Despite relentless efforts by the Indian Army, Navy, NDRF, SDRF and other agencies, no breakthrough has been achieved so far in the rescue operations as the teams had to navigate through thick muck, tangled iron rods, and cement blocks to reach the accident spot in the tunnel to extricate the persons who have remained trapped for over two day inside the tunnel after a section of it collapsed in the SLBC project in Telangana's Nagarkurnool district on Saturday morning.



TG reports over 6.25 M malware incidents in 2024

Telangana has emerged as one of India's most targeted states for cyber attacks, accounting for 23 per cent of all malware detections nation-wide in 2024. A staggering 6.25 million malware incidents were recorded across the State, with critical government and educational institutions among the worst affected, according to the Telangana Cyber Threat Report 2025 by Seqrite, the enterprise arm of Quick Heal Technologies.

The report paints a grim picture of the state's cybersecurity landscape, revealing an average of 47 ransomware attacks daily, amounting to 17,505 incidents last year. Notable victims included the Telangana government portal (data.telan-gana.gov.in), Jawaharlal Nehru Architecture and Fine Arts University and the Deputy Chief Minister's website, all of which suffered significant breaches.

Beyond malware, identity theft emerged as Telangana's most common cybercrime, with nearly 30,000 cases reported. It includes 11,125 cases of unauthorised transactions, 5,369 cases of KYC update fraud, 18,647 impersonation scams, including



courier fraud, police impersonation, and digital arrest scams 26,000 cases of business and investment fraud, 17,669 advertisement fraud cases and 12,589 loan fraud incidents.

Ransomware attacks have also intensified, particularly in the IT, manufacturing and education sectors, causing widespread disruptions. Among the most severe incidents, a ransomware attack on Narayana Group hospitals and educational services crippled electronic medical records (EMR) and billing systems,

affecting critical patient care. Similarly, Sivaraj Medical Colleges faced a devastating breach that exposed student records, financial transactions and payroll data.

The Telangana government portal and educational institutions were among the primary targets, with website defacements and data leaks causing significant reputational damage. The Deputy Chief Minister's website was also compromised, exposing internal documents and raising serious privacy concerns.

Commenting on the findings, Vishal Salvi, CEO of Quick Heal Technologies, emphasised the need for a proactive cybersecurity strategy. "Telangana is becoming a key IT hub, driving India's digital economy through robust infrastructure and innovationdriven policies. As the State develops, cyber threats will continue to rise. Our report underscores the urgent need for stronger security frameworks to protect businesses, government institutions and individuals.

ECI to hold two-day conference of CEOs

Minister for Forest, Environment and Endowments Konda Surekha reiterated the government's commitment to wildlife conservation while chairing the eighth meeting of the State Board for Wildlife (SBWL) at the Secretariat. The meeting reviewed the implementation of decisions taken in the previous session and discussed key developmental initiatives concerning wildlife protection, forestry and environmental con-

tion of the SBWL is mandatory. He informed that the Telangana Board was officially constituted through GO Ms. No. 52, issued on December 2, 2024.

During the discussions, the expansion of the Medak-Yellareddy road passing through Pocharam Wildlife Sanctuary was approved. Proposals for laying OFC lines in forest areas were deliberated. Permission was granted for the construction of an 11 KV power substation in Mulugu and the Peddagattu lift irrigation scheme in the Nagarjunasagar division.

Eighteen proposals regarding modifications to animal passages and 13 proposals for mobile towers were reviewed before being sent to the NBWL. The board also discussed setting up a corpus fund to compensate victims of human-wildlife conflicts through the Mee-Seva

The resettlement of 1,088 families from Amrabad Tiger Reserve was reviewed, with officials providing updates on the process. Progress on community-based eco-tourism projects was assessed, and the lifting of restrictions on heavy vehicles in Kawal Tiger Reserve was considered. The Minister suggested forming special committees to oversee the development of zoos, national parks and urban parks across the State. She emphasized the need to prioritize indigenous trees and take measures to protect natural forest ecosystems.

The meeting was attended by legislators Payam Venkateswarlu and Ramdas Naik, Chief Secretary Nadeem, PCCF Dobriyal, senior officials Elu Singh, MSS Somaraju and OSD N Sumanth Kumar, along with other senior officials.

Four Sangareddy pilgrims killed in ghastly accident

The tragedy happened when pilgrims from Sangareddy were returning from Maha Kumb in Prayagraj

In a horrific road accident near Varanasi in Uttar Pradesh on Sunday night, four people from Sangareddy district lost their lives when a truck collided with their car, while two others were seriously injured.

The deceased were identified as Irrigation Deputy Engineer Venkat Rami Reddy (46), a resident of Mamidigi village under the Nyalkal mandal, his wife Vilasini (40), and Mall Reddy (40) from Maki village along with the Malgi village, along with the car driver. Two others are reported to be in critical con-

The accident took place around 10:40 pm on Sunday night, while they were heading to visit Lord Kashi Vishwanath after taking a holy dip at the Triveni Sangam in Prayagraj.

According to reports reaching here, the car in which the pilgrims from Sangareddy district were travelling, met with an accident while trying to avoid hitting a two-wheeler coming from the opposite direction, the driver swerved the car and collided head-on with the tipper. Three people in the car died instantly

As soon as the incident happened, Varanasi police reached the accident site and shifted the injured to the local hospital. They also informed the families of the deceased. The incident happened while they were returning from the

Area under horticulture declines in Nalgonda dist

The cultivation of horticultural crops in Nalgonda district is experiencing a decline as more farmers are shifting towards paddy farming. The area dedicated to horticulture has significantly reduced, now covering only a few thousand acres, compared to the extensive cultivation seen in

A key factor contributing to this downturn is the lack of ade-quate staffing in the Horticultural Department. The number of Horticultural officers in the district is insufficient, with each officer responsible for 8-9 mandals, which leaves little room for providing guidance to farmers on cultivating horticultural crops.

Historically, Nalgonda district supported a thriving horticultural sector, with crops such as sweet lemon, lemon, oil palm, papaya, vegetables, fruits, and flowers. However, this area has now dwindled to approximately 70,000-80,000 acres, a far cry from the expansive acreage in earlier times.

Despite the decrease in horti-cultural cultivation, the state government has focused on promoting oil palm and vegetable farming. Oil palm is now cultivated on 17,000 acres, with 12,000 acres in Nalgonda, where farmers receive subsidies for its cultivation. Additionally, veg-



etables are grown across 6,000 acres, and recent government funds have been allocated for vegetable cultivation in 90 units.

Sweet lemon cultivation in Nalgonda has fallen to 43,000 acres, while lemon gardens occupy 9,000 acres. Chili farming spans 12,000 acres, and ivy gourd is cultivated in around 800 acres. The market prices for sweet lemons and lemons have become

unpredictable, leading many farmers to reconsider these crops. Both are vulnerable to pest attacks, further discouraging their cultivation.

While lemons have a dedicated market at Nakrekal, sweet lemons lack a local market, forcing farmers to rely on traders and middlemen who purchase the fruit for export to Delhi and West

A BOLT OUT OF THE BLUE

TG border districts witness sharp decline in liquor sales

In recent months, the liquor sales in Telangana's border districts, especially Khammam, have drastically dropped. Previously, Telangana saw a surge in alcohol demand, particularly in its border areas, as people from Andhra Pradesh (AP) crossed over to purchase liquor due to the unavailability of pre-mium liquor brands and high prices in AP. However, this trend has now reversed, resulting in a sharp decline in

reversed, resulting in a sharp decline in revenue for Telangana.

Khamman, a key district in this context, has seen a sharp drop in liquor sales, especially in the past three months. Compared to last year, the figures have plummeted, and officials are finding it increasingly difficult to meet sales targets. This month, for instance, sales have gets. This month, for instance, sales have dropped by approximately Rs 10 crore compared to February last year.

The shift is largely attributed to a new liquor policy implemented in AP in October. Liquor prices were reduced, and popular liquor brands became widely available. As a result, those who used to drink alcohol often in AP relied on Telangana for their alcohol purchases and are now buying liquor from their state, severely impacting sales in Telangana's border areas.

The excise circles in Sathupally, Madhira, Vyra, Khammam-1, and Ashwaravupet, all near the AP border, are particularly affected.

The situation is further complicated by the MLC elections, which will keep liquor shops closed for two days this month, making it even harder to meet



suggest that liquor prices in Telangana might go up by another 15 per cent, which could further depress sales and potentially lead to an influx of AP liquor into Telangana.

As things stand, the once-thriving liquor trade in Telangana's border districts is having a rough time.

Meanwhile, Khammam District Prohibition and Excise Officer G Nagender Reddy denied, in an interview, that the liquor is being smuggled from that the liquor is being smuggled from AP into Telangana. Right now, the smuggling of alcohol from Telangana to AP has come to an end. Since the prices are the same in both AP and Telangana, people are purchasing alcohol locally.

In the past, alcohol was smuggled from Telangana to Andhra Pradesh. Brands like Mansion House and OAB were not available in AP in AP. Now, these brands are also available there. As a result, sales in Telangana border districts have decreased. Earlier, there was only one government shop in the mandal headquarters in AP. Now, the number of private shops in mandals of AP has increased. It led to people from AP stopping from buying alcohol from Telangana he said.

Tenant farmer commits suicide due to debt burden



Centre, State focus on expansion, construction of roads

The Central and State governments are placing a special focus on the expansion of roads and the construction of new roads in Telangana. New roads have already been approved in several areas, and green signals have been given for the expansion of existing roads. The Central government has released funds for the construction of a national highway through Medak and Kamareddy districts, and work is currently

progressing rapidly.
The National Highway, which is being built for a distance of 95 kilometers at an estimated cost of Rs 526 crore, is being executed on a war footing. The construc-



tion of National Highway 765 D from Medak to Rudrur via Yellareddy and Banswada

is underway. In the first phase, Rs 213 crore have been allocated by the Centre for the work Medak and Yellareddy, covering a distance of 43.91 kilometers. In the second phase, the road will be constructed from Yellareddy to Rudrur via Banswada, with Rs 313 crores allocated for the 51.66-kilometer stretch. The work on both the first and second

packages is progressing

As part of the road construction, trees on both sides of the road for the double road have already been removed. The widening work has also been completed, and the areas have been filled with gravel, while service roads and drains are being constructed for the villages. The work from Yellareddy to Rudrur under the second package is already 50 per cent complete.

However, the road stretches through a forest area for 18 kilometers. Approval from the Forest Department is required for the construction, and authorities say that once these permissions are obtained, the work can progress even faster.

Poisoned by mother, girl dies

Merz has emerged as the frontrunner to become Germany's next chancellor, advocating for economic stability, stricter immigration policies, and a reassertion of Germany's leadership in Europe. The far-right Alternative for Germany (AfD) is poised to make historic gains, emerging as the second-largest political force. This comes at the expense of Chancellor Olaf Scholz's Social Democratic Party (SPD), which has suffered due to economic stagnation and dissatisfaction with the previous coalition government. The Green Party and the Free Democrats (FDP), both

part of the fallen coalition, have also struggled to maintain voter confidence. Meanwhile, the Left Party is fighting to remain relevant amid internal divisions and the broader shift in political sentiment.

This election is taking place at a critical juncture for Germany, with pressing domestic and international challenges shaping the national narrative. Germany, the EU's largest economy, is grappling with slow growth, rising inflation, and concerns about industrial competitiveness. Many voters are looking for a leader who can restore economic stability and drive innovation. Besides, the country has faced growing debates over migration policies, with many Germans expressing con-

cerns about integration and border security. The AfD has capitalised on this sentiment, calling for stricter immigration controls. With growing geopolitical tensions, including relations with China, Russia, and the United States, Germany's next leader will need to navigate foreign policy challenges carefully. But the biggest factor that is being analysed is why the AfD is gaining ground? Indeed, the rise of the AfD can be attributed to several factors. Firstly, economic dissatisfaction has pushed voters towards populist rhetoric, with the AfD portraying itself as the party of change. Secondly, frustration with the previous coalition's handling of immigration and energy policy has bolstered nationalist sentiments. An interesting aspect of this election has been the role played by social media, particularly TikTok. The AfD has effectively leveraged TikTok to reach younger audiences, spreading populist messages through short, engaging videos, often laced with negative content. Meanwhile, mainstream parties have struggled to counteract misinformation and viral narratives that favor the far-right. This election underscores the growing influence of digital platforms in modern politics, raising questions about regulation and the impact of algorithm-driven content on democratic processes. Whatever the outcome, it will have far-reaching implications for Germany, the EU and beyond.

New VC appointment rules


he University Grants Commission's (UGC) guidelines proposing a shift in the appointment of Vice-Chancellors (VCs) have ignited a political storm. By granting Chancellors—predominantly Governors—the authority to constitute search-cum-selection committees for appointing VCs, the UGC has stirred concerns about federalism, state autonomy, and academic independence.

Adding to the controversy, noncompliance with these guidelines could disqualify state universities from UGC funding schemes, creating a direct clash between the Centre and opposition-ruled states such as Tamil Nadu, Kerala, West Bengal, Punjab, and Himachal Pradesh. This move, seen as a veiled attempt to centralise power over state universities, places the spotlight on India's federal structure and the simmering tension between state governments and Governors, especially in opposition-led states. At the core of the debate is the growing role of Governors, often viewed as proxies of the Centre, in state gover-

Historically, state governments have played a central role in appointing VCs by constituting independent search committees. However, the UGC's draft proposes a shift, granting Governors—functioning as Chancellors of state universities—control over these committees.

Governors, constitutionally expected to act as neutral figures, have increasingly been accused of serving partisan interests, particularly in states like Tamil Nadu, Kerala, and West Bengal. By formalizing the Governor's role in academic appointments, the UGC guidelines risk politicising the process, potentially undermining academic independence and turning universities into ideological battlegrounds. The fears of state governments are not

In Tamil Nadu, for example, the DMK has accused the Governor of deliberately delaying VC appointments to push candidates aligned with the ruling party at the Centre. Similarly, Kerala has witnessed repeated stand-offs between the Governor and the state government over academic



The new guidelines, by empowering Governors to dominate the VC appointment process, are being viewed as an encroachment on states' jurisdiction. Several states may challenge these guidelines in court, arguing that they violate the federal structure enshrined in the Constitution. States like Tamil Nadu have already passed laws to curtail the Governor's powers in academic governance, reflecting a broader pushback against what they see as an overreach by the

For opposition-ruled states,

where educational institutions are often viewed as bastions of intellectual and political autonomy, the UGC's guidelines have deepened fears of central overreach. The ruling dispensations in states like Tamil Nadu, Kerala, and West Bengal have expressed strong apprehensions about Governors using this newfound authority as an extension of the Centre's political influence. In West Bengal, Chief Minister Mamata Banerjee's government has long accused the Governor of interfering in the state's affairs, particularly in

the educational domain. The UGC guidelines could exacerbate this friction, allowing the Governor to influence appointments to academic institutions. Such moves, critics argue, undermine the intellectual independence that universities in the state have historically enjoyed.

In Kerala, where the Left Democratic Front (LDF) government has vociferously defended educational autonomy, the guidelines are being seen as an outright encroachment on the state's constitutional rights. The state government fears that politicised appointments could compromise the ideological neutrality and academic standards of its universities.

The DMK-led Tamil Nadu government has also repeatedly opposed the Governor's increasing interference in educational appointments. The state has even passed legislation to reduce the Governor's control over the VC selection process, only to have it stalled by the Governor. For Tamil Nadu, these new guidelines are a direct challenge to the state's efforts to safeguard its educational institutions from external political influence.

Universities, as centres of higher learning, thrive on autonomy and academic freedom. The UGC's intervention lines risk becoming another threatens to compromise these principles by potentially turning VCs into political appointees. Critics argue that such appointments could erode academic independence, with VCs prioritising political allegiance over edu-

cational excellence. In opposition-led states, this concern is particularly acute.

The fear is that such interference could stifle intellectual diversity, with universities becoming vehicles for propagating the central government's political agenda. This interference also undermines the confidence of academicians and researchers.

Scholars worry that political considerations will outweigh merit in appointments, leading to a decline in the quality of higher education. The resulting chilling effect could discourage free thought and innovation in academic insti-

The controversy over VC appointments is emblematic of a larger tussle between the Centre and states over federalism. For states like Tamil Nadu, Kerala, and West Bengal, the guidelines represent an erosion of their autonomy in managing critical domains such as education. This growing centralisation also poses questions about the role of Governors in a federal structure.

A balanced approach, one that respects state autonomy while ensuring accountability in academic governance, is the need of the hour. THE HANDWRITING BLUES: **A STORY OF DECLINE**

Some see handwriting as a reflection of character, but it shifts, evolves and often declines beyond recognition

ome conjecture that a person's handwriting can give a glimpse , into that person's character. But I am a sceptic in this regard, because, in my opinion, the handwriting of an individual is not a constant, but keeps on morphing as time goes by. A case in point is your humble friend, who has seen his handwriting deteriorate over the past few decades, till now, in my fifth decade, it is nothing more than a painstaking, almost illegible scrawl- although, with the advent of the now ubiquitous personal computer and other sundry devices, the negative impact of this deterioration has been minimised, especially in official work. Because today, when I write a note on any file with my hand, others find it rather difficult to 'decrypt'.

Even filling simple financial documents like a cheque is a nightmare now, a stiff challenge, that is increasingly being left to my better half to handle, as bank people, on a few occasions, have raised doubts about the authenticity of my signature. But before the readers start commiserating about the sad and agonising state of my handwriting, I will share with them that this was not always the case. In the early years of school, I was the darling of my teachers because of my neat and clean handwriting, which made me the cynosure of my peers. Writing on four-line copies, I would get full marks in English handwriting.

The slide commenced from middle school onwards, when I shifted from writing with a pencil to writing with a ball pen, and the copy changed from one with four lines to that with two lines. But the hand was still steady, and teachers did not have any problem reading my answer sheets, as was evident from the good grades I continued to get in my exams. But I am sure, that as I entered college and the university in the mid-eighties, the good professors would have become



increasingly impatient in poring over my messy answer sheets, with scribbles galore. Throughout, my father, a diligent and thorough gentleman, with very precise and beautiful handwriting, kept counselling me to stem the rot, even as I secured a job in the public sector in 1991. He gently warned that it would adversely impact my prospects of growth in the corporate world, especially when this was the period when all office work was conducted on well-defined sheets of paper- which, in my case, were to be yellow pages.

Before leaving for Bombay (as Mumbai was then called), I scoffed at Dad's gentle, but consistent reprimands. It was only when I took my first, tentative steps in the company did I realise that what Dad had been emphasising over the years was not an iota away from the truth. I faced a mild, personal nudge from some bosses on this account, but others were not so kind, and their reaction bordered on outright contempt, reprimand and disapproval. But Dad was an eternal optimist. He still harboured a strong wish to get my handwriting back on track, even at this stage, for which he purchased a book- 'Techniques to improve your handwriting'. I was back in kindergarten.

So, whenever I came home to Delhi for a break, he would insist that I sit with him, at least for some time, and practice on ways to improve my, by now abominable handwriting. But by this point, my mind, like that of all young men, was engrossed in finer things of life than improving my writing ability, which, I realised, was destined to be an exercise in futility. This cat-and-mouse game continued even after I got married in 1993. It was only after I became a father in 1995 did Dad finally buried his desire to improve my handwriting to a decent

RBI should go for an 'accommodative' stance



While inflation has been steadily declining, the RBI opted to retain its 'neutral' stance, signaling a measured approach rather than give push to boost liquidity and demand



n February 7, 2025, the Reserve Bank of India (RBI) Governor Sanjay Malhotra announced the decisions taken by the six-member Monetary Policy Committee (MPC) in its sixth bi-monthly meeting of the current financial year (FY). It has reduced the policy rate or the repo rate (the interest rate at which the RBI lends to banks) by 25 basis points to 6.25 per cent. This marks the first repo rate cut in nearly five years. Moreover, it has continued with a neutral stance which it shifted in its fourth bimonthly review/announcement on October 10, 2024, from its earlier stance of "withdrawal of accommodation". In 2016, the Union Government put in place an institutionalized framework to enable the MPC to formulate monetary policy and determine the key interest rates including the policy rate for inflation targeting. It mandated the RBI to fix the policy rate in such a manner as to maintain the Consumer Price Index or CPI (it corresponds to a basket that includes food, fuel, manufactured goods, and select services) within the target range of 4 per cent (+/-2 per cent). The RBI decides the policy rates once in

two months during each FY. The mandate initially given for five years ending March 31, 2021, has since been extended for a further period of five years. The current mandate will continue till March 31, 2026. The other crucial policy instrument the RBI uses for targeting inflation is Liquidity - jargon for the quantum of credit available in the banking system. Pumping more liquidity along with a reduction in the policy rate represents a scenario which in jargon is described as an 'accommodative' policy stance. The terminology was coined by the outgoing governor Shaktikanta Das in June 2019 when he started going for aggressive cuts in the policy rate and an increase in cred-

Since June 2022 the RBI changed its stance to "withdrawal of accommodation" and had stuck to it till October 9, 2024, when in the fourth bi-monthly review, the MPC decided to go for a "neutral" stance. A

Put simply, he meant there was no need to start reducing interest rates until inflation reached the target of 4 per cent and stayed at that level. The incumbent DISINFLATION IS Governor has continued with this mindset. In February 2023, the policy rate was at a peak of 6.5 per cent. During FY 2022-23, the CPI inflation was hovering around 8 percent.

In the following year, it started decreasing from 7.4 per cent in July 2023 to 5 per cent in September 2023 to 5 per cent in September 2023, 4.8 per cent in October 2023 and 5.1 per cent during January/February 2024. For FY 2023-24, it was 5.4 percent. During the current FY also, it has kept low; 5.08 percent in June 2024 and 3.54 percent in July of 2024. After a brief spurt of 6.2 per cent in October 2024, in January 2025, it declined to 4.3 per cent.

declined to 4.3 per cent.
During FY 2024-25, the RBI has estimated it at 4.8 percent. Given the above, from the third quarter of FY 2023-24, the CPI inflation has remained well within the target range of 4 per cent (+/- 2 per cent). This position continues during the current FY. For FY 2025-26, the RBI expects it to be 4.2 per cent. Thus, there was a strong case for a significant reduction in the repo rate of vegetables caused by seasonal facbesides the injection of sufficient liauidity. This would have helped in stimulating demand thereby giving a boost to economic growth besides helping millions of borrowers reduce their EMIs and helping industries, especially MSMEs reduce the cost of servicing their loans. But, this was not to be.

The problem is RBI's obsession with inflation. Malhotra recognizes that inflation is on a downward trajectory. Yet, he doesn't want to relinquish his neutral stance citing global economic challenges "progress in global disinflation is stalling."

Put simply, he fears imported inflation impacting CPI hence, a "neutral stance will provide MPC flexibility to respond to evolving macroeconomic environment." A major factor contributing to wide variations in CPI inflation is food inflation which has a weight of around 40 per cent and is impacted predominantly by supply side/seasonal factors whereas monetary policy instruments work on the demand side. Invariably, food inflation maintains an upward trend even as a small disruption in supply caused by seasonal factors can lead to spiralling prices.

As long as food remains a part of the CPI basket, inflation targeting will always remain a problem. There is an urgent need to exclude it while setting benchmark interest rates, an idea that was mooted by the Chief Economic Advisor in the Economic Survey (ES) for 2023-24. The CEA argued that monetary policy has no bearing on the prices of food items, which are dictated by supply-side pressures.

For instance, during 2021-22, wheat output was affected by unusually high temperatures. During 2022-23, rains accompanied by hailstorms acted as a spoiler. During the first half of FY 2023-24, food inflation went up due to a spike in the prices tors. The spurt in food prices during October 2024 also had to do with supply-side pressures only. The RBI can achieve little to con-

trol them by keeping the policy rate high. The RBI should take the idea mooted in the ES - 2023-24 on board. Meanwhile, it should consider reducing the weight of food inflation in CPI to reflect the contemporary reality. The current 40 per cent weight is based on the Consumption Expenditure Survey (CES) of 2011-12 whereas Summary Statistics from the 2022-23 CES point towards a significant reduction.

While formulating its monetary policy, the RBI's prime responsibility is to ensure macro-economic stabilitv its pivotal focus being on keeping inflation within reasonable bounds. However, it can't be oblivious of the dire need to support economic growth which could be adversely impacted if it doesn't relax the credit environment.

he recent escalation of violence in the eastern L Democratic Republic of the Congo (DRC) is a stark reminder of the region's deeprooted instability. The resurgence of the M23 rebellion, which led to the seizure of Goma and further advances into South Kivu, is not merely an internal Congolese crisis—it is a conflict with significant regional and international implications. Rwanda's involvement, whether direct or indirect, remains contentious, as accusations of its support for

M23 persist. While Kigali denies these allegations, the sophistication of M23's operations raises serious questions about its backing. At complex mix of ethnic tensions, political grievances, and Democratic Forces for the

The conflict's economic dimension cannot be ignored, with Rwanda being accused of profiting from the illicit exploitation of Congolese minerals, particularly coltan, a key component in electronic devices.

The capture of Rubaya, a coltan-rich area, by M23 last year suggests that economic interests play a crucial role in shaping the rebellion's trajectory. M23 claims to be fighting for the rights of ethnic Tutsis in eastern DRC, arguing that the Congolese government has failed to protect them from persecution. While

there is historical evidence of ethnic violence against Tutsis in the region, M23's actions undermine its credibility. Rather than advocating for political rights through diplomatic means, the group has engaged in violence, forced displacement, and human rights violations. Its strategy of seizing key cities and resourcerich territories suggests an agenda extending far beyond self-defence.

The DRC, backed by the international community, has dismissed M23's claims, arguing that the group is acting as a proxy for Rwanda's regional ambitions. The latest attempt by regional leaders to broker peace, with the Southern Development African



(EAC) calling for an immediate ceasefire, reflects a growing recognition that the crisis cannot be resolved through military means alone. However, the reality on the ground tells a different story. Unless regional actors commit to genuine peace efforts and the international community enforces stricter measures against illegal mineral trade, the conflict will persist.

Without meaningful action, eastern DRC will remain trapped in a cycle of violence, with its people bearing the brunt of a war that serves the interests of powerful actors far beyond its borders.

DBS to 'shrink workforce' by 4,000 due to Al adoption

C lobal banking major DBS Group expects a 10 per cent reduction in its workforce over the next three years as artificial intelligence adoption goes deeper into the operations, its chief executive Piyush Gupta said on Monday. Gupta said AI is different and unlike any other technologies adopted in the past, and added that he is struggling to create new jobs for the first time in his over 15-year stint at the helm of the Singaporean bank. "This year, my current projection is that in the next three years, we are going to shrink our workforce by 4,000 or 10 per cent," Gupta said, speaking at the Indian IT industry lobby group Nasscom event here. Attributing his outlook to the advent of AI, Gupta said, "AI is very powerful. It can self-create and also mimick" Pointing out that AI is "different", Gupta said in the last ten years, there have not been any job cuts in the group. He reminisced that in 2016-17, the bank embarked on a digital transformation which was seen impacting 1,600 people but added that almost all of them were repurposed in consultation with unions and other representatives.



Rupee declines 4 paise to close at 86.72 against USD

he rupee dropped 4 paise to 86.72 (provisional) against the US dollar on Monday amid a steep fall in the domestic equity markets and a rise in Brent crude prices. However, a flat greenback against major currencies prevented further decline in the domestic unit, according to forex traders. At the interbank foreign exchange, the local unit opened at 86.58, went up 10 paise from Friday's close of 86.68, but gave way through the session. It eventually settled at 86.72 (provisional), 4 paise lower than the previous day's close. "The RBI is all set to do a 3-year buy/sell swap of USD 10 billion on February 28 to ease the tightening liquidity position, thus bringing premiums further down. Exporters may sell the cash dollars requirement on all upticks while importers may buy good dips," Anil Kumar Bhansali, Head of Treasury and Executive Director, Finrex Treasury Advisors LLP, said. Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading flat at 106 61 "The dollar has slid more than 3 per cent from January peak on tariff issues leaving little appetite for traders to load up on fresh dollar holdings



LG Corp chief visits India ahead of IPO

G Corporation Chairman and CEO Kwang Mo Koo is on a twoday visit to India ahead of the proposed initial public offering of its Indian unit, according to industry insiders. Koo is meeting with the senior leadership of LG Electronics India, including its Managing Director, to review the performance and take stock of the preparations for the local subsidiary's upcoming IPO, they added. He is also expected to discuss investment proposals for the Indian market, one of the largest markets for the South Korean Chaebol. It is unclear whether he is scheduled to meet with any top policymakers here. He is likely to visit the Greater Noida plant of LG Electronics India. An e-mail sent to LG Electronics India remained unanswered. Last week, LG Electronics started roadshows for the upcoming initial public offering of its Indian units, where the South Korean chaebol will sell over 10.18 crore shares amounting to a 15 per cent stake, which, according to some reports, may raise up to USD 1.5 billion.



filmmaker Sridhar Rangayan once again delivers a deeply person-al yet universally reso-nant story. The Indo-Swedish co-production, set to release on February 21, explores the complexities of love, trust, and acceptance—not just in queer relationships but in all human connections. Featuring acclaimed actors Shishir Sharma (*Raazi*, *The Family Man*) and Mona Ambegaonkar (Godmother, Evening Shadows), the film navigates themes of resilience, societal norms and personal aspirations.

Rangayan explains that the film's international collaboration came about through the NFDC Film Bazaar Co-Production Market in 2023. While scouting for a location out side India to align with the script's demand— where the lead character Kartik has a fleeting romance abroad—Sweden emerged as the ideal choice. "We had many friends there who generously supported us-offering their homes, offices and even a motorboat for shooting," Rangayan shares, emphasising the warm and collaborative spirit that

helped bring the film to life. Known for crafting narratives that are both intimate and globally relevant, he believes in starting with a personal story and blending it with experiences from the world around him. "For mass audiences to enjoy a film, it has to be both personal and universal," he says. His films have

resonated not only in India but across the globe, from Serbia to Jamaica.

With Kuch Sapney Apne, which won the highest award at the Mysuru International Film Festival - the Best Indian Feature Film Award, the filmmaker wanted to move beyond conventional queer narratives. "It is 2025 and we are beyond stories of coming out and identity angst. It is time to delve into real issues headon," he asserts. At its core, the film conveys the message that love is love and that every relationship—regardless of gender or identity—comes with its own set of challenges.

Rarity and seasonality of lichen planus

ichen Planus is a chronic inflammatory skin condition that can impact the mouth, nails and genitalia. Although the precise reason is unknown, potential causes include immunological or allergic reactions, exposure to specific medications, dyes, and other chemicals, as well as illnesses like Hepatitis C.

One out of every 100 persons will eventually get lichen planus. It cannot spread to other people and it is not brought on by an infection. Middle-aged men and women are typically affected by lichen planus. Lichen planus on the skin affects men and women equally, but oral (within the mouth) lichen planus is twice as common in women. In very young or very old people, the sickness is uncommon. Although lichen planus isn't strictly "seasonal" in the sense that it only manifests during specific seasons, some research indicates that its symptoms may intensify or worsen with the changing of the seasons. This is especially true for actinic lichen planus, which is exacerbated by sun exposure and may be more obvious in the summer.

Symptoms of Lichen Planus

Typical symptoms of Lichen Planus include lacy-white lesions in the mouth that can hurt or cause burning, thin white lines over the rash, purplish coloured bumps or lesions with flat tops on the skin or genitals that develop and spread over the body for several weeks or a few months or itching at the site of the rash, which typically appears on the wrists, lower back, and ankles.



didn't meet expectations. What went wrong? "I think the execu-tion didn't work," he admitted. However, he is confident about Mazaka. "We screened the film for many of my friends, distributors and others, and everyone liked it. They all said that the entertainment and emotional quotient would definitely work for this film," he said.

The film was initially set for a Sankranthi release in January but is now releasing on February 26 for Shivaratri. Was the lastminute rush a concern? "In the industry, many films are made with the release date in mind and my film was no different," Razesh explained. "Sundeep Kishan was busy with three projects and coordinating dates for multiple actors caused delays in shooting."
The trailer was released only

"Generally, for any film, the budget increases by around 10% beyond the estimated cost," he stated.


Razesh is already planning a sequel to *Mazaka*. "Yes, we are planning it with the same director, and it's going to be titled Double Mazaka," he confirmed.

"Because when I hit that kind of shots, then I feel in control when I bat out there. So, it was a good innings for me personally and it was a great team win,"

An India-Pakistan game is always a blockbuster, but Kohli felt Sunday's



clash was even more electrifying, with Dubai's stands packed with passionate fans from both nations.

'The occasion is a bit more lively when you play against Pakistan, especially in this region because you have an equal number of fans from both countries, yeah, it was a great day for us as a team and for me personally as well."

Delighted to contribute to India's victory once again, Kohli, who became the fastest batter to complete 14,000 ODI runs, said his role at number three has remained unchanged over the years - minimising risk, stabilising the innings, and, when possible, finishing the chase.

"One thing that I've always thought of batting at three is to minimise risk and make sure that I put my team in a winning position and if you have a chance to finish off the game in a chase, obviously, that's much better and I always preferred that kind of a situation. "My role over the years has remained the same, whatever the demand of the game, I put my head down and try to do that," he added.

And that is my mindset. If we take charge, if we gain the momentum towards us, then it is easy to steady the ship," Iver said in the post-match
