# **CM REVANTH MEETS PM MODI Seeks Centre's nod for Metro** Phase-II, RRR & Musi revamp

PM gives a to-do list to Revanth

#### PNS NEW DELHI

Chief Minister A Revanth Reddy met Prime Minister Narendra Modi in New Delhi on Wednesday and urged the Centre to approve key infrastructure projects for Telangana, including the Hyderabad Metro Rail Phase-II, Regional Ring Road (RRR) South, and the Musi Rejuvenation project. The meeting, held at the Prime Minister's official residence, also focused on the need for a Regional Ring Rail, dry ports, and the India Semiconductor Mission. Interestingly even PM made suggestions to the state gov-ernment regarding PMAY, rail and road project clearances, irrigation project DPRs.

The Chief Minister highlighted that the previous BRS government had not prioritized the expansion of Hyderabad Metro during its 10-year tenure. He explained that the Phase-II project proposes five corridors covering 76.4 km at an estimated cost of Rs. 24,269 crore and sought immediate approval for its implementation. He also pressed for the sanction of the Southern part of the RRR, argu-

ing that with 90 percent of land acquisition completed for the Northern part, both sections must progress

simultaneously for full utilization. The CM informed the Prime Minister that the Telangana government was ready to bear 50 percent of the cost of land acquisition for the Southern RRR. Additionally, he proposed the devel-

The Chief Minister highlighted that the previous BRS government had not prioritized the expansion of Hyderabad Metro during its 10-year tenure. He explained that the Phase-II project proposes five corridors covering 76.4 km at an estimated cost of Rs. 24,269 crore and sought immediate approval for its implementation

RRR to boost exports and imports along with a Greenfield road and rail line linking the dry port to a sea port. He emphasized that such projects would be vital for Telangana, a landlocked state.

The CM also pushed for central support for the Musi Rejuvenation project, citing its cultural and spiritual significance to Hyderabad. He requested Rs. 20,000 crore in financial assistance for the project, which includes Continued on Page 2

# **SLBC TUNNEL COLLAPSE Rescue ops in final stages** Will be completed in two days, says Uttam

#### **PNS** NAGARKURNOOL

The rescue operation at the SLBC tunnel in Nagarkurnool district has entered its final stages, with elite forces like the Indian Marine Commando Force (MARCOS) and the Border Roads Organisation (BRO) joining the mission. Irrigation and Civil Supplies Minister N Uttam Kumar Reddy stated that the Telangana government has escalated efforts, deploying advanced technology and national agencies to ensure the safe evacuation of eight trapped workers. After an extensive field assess-

ment, Uttam Kumar Reddy confirmed that a concrete action plan

had been finalized, prioritizing both the safety of the rescuers and the trapped workers. He acknowl-edged that the operation posed significant risks, but after thorough reviews over the past two days, strategic measures had been put in place to minimize dangers and accelerate the mission.

He asserted that the rescue would be completed within two days and that multiple approaches were being explored, including alternative access routes from the side and main exit, to expedite efforts. He emphasized that every possible avenue was being considered to reach the trapped workers as quickly as possible. Continued on Page 2

#### AP deliberately avoiding: Irrig Secy

A crucial meeting of the Krishna River Management Board (KRMB) was held at Jala Soudha in Hyderabad under the chairmanship of Atul Jain. The meeting saw participation from Telangana Irrigation Department Secretary Rahul Bojja and the Engineer-in-Chief (ENC). However, officials from Andhra Pradesh were notably absent, prompting Telangana representatives to express dissatisfaction.

Due to the absence of AP officials, the board decided to reconvene on

Thursday for further discussions. Rahul Bojja, voicing Telangana's concerns, accused AP of deliberately avoiding the meeting despite its importance. He urged that the state's arguments be recorded and forwarded to the Centre for further action.

The water allocation issue remains contentious, with Andhra Pradesh requesting 55 TMC from Srisailam and Nagarjuna Sagar reservoirs until May, while Telangana has sought 63 TMC for the same period. The meeting's postponement underscores the ongoing disputes over Krishna watersharing between the two states.

# US citizenship for \$5 million Trump plays a 'gold card'

President Donald Trump said Tuesday that he plans to offer a "gold card" visa with a path to citizenship for USD5 million, replacing a 35year-old visa for investors.

"They'll be wealthy and they'll be successful, and they'll be spending a lot of money and paying a lot of taxes and employing a lot of people, and we think it's going to be extremely successful," Trump said in the Oval Office.

Commerce Secretary Howard Lutnick said the "Trump Gold Card" would replace EB-5 visas in two weeks. EB-5s were created by Congress in 1990 to generate foreign investment and are available to people who spend about USD1 legally.



He highlighted Telangana's rise as a top pharma investment hub. To support sustainable growth, new pharma hubs will be set up in Tier-2 and Tier-3 cities with minimal environmental impact. # Alakananda kidney racket worsens recipient's health

The illegal kidney transplantation racket exposed at Alakananda Hospital, Saroornagar, has had severe consequences for a recipient, leading to critical health complications.

Bhat Prabha, also known as Krupalatha, a nurse from Mangalore, had travelled to Hyderabad for a kidney transplant However foll bust of the illegal racket, she experienced kidney rejection and required specialised treatment at Nizam's Institute of Medical Sciences (NIMS) before being discharged. Prabha had been undergoing dialysis and was advised by doctors in Mangalore to undergo a kidney transplant. According to sources, adherence to prescribed medications is crucial for organ transplant recipients, as the body may reject a transplanted organ, considering it a foreign entity, much like the need for blood type compatibility in transfusions. Even kidneys donated by family members can sometimes face

around the transplanted kidney, leading to its rejection. At NIMS, specialised procedures such as a kidney biopsy and nuclear scan were conducted to assess the organ's condition. Through intensive medical intervention, the transplanted kidney was gradually sta-bilised, and within 15 days, her body began to accept it. She was later discharged.

Despite spending Rs 50 lakh on the transplant, the family had to bear additional of approximately Rs

Additionally, she was reportedly made to wait at a police station for hours, during which she missed critical medication and treatment. Given her financial constraints, she sought treatment at a government hospital and was eventually transferred to NIMS.

Upon admission, her husband was in distress, and doctors discovered an infection

1 lakh at NIMS for further treatment. They expressed gratitude to NIMS for providing advanced medicare, which would have been costlier at private hospitals. Without immediate intervention, Prabha could have lost her transplanted kidney entirely. This case highlights the critical importance of posttransplant monitoring, adherence to prescribed medication, and timely medical intervention. NIMS, recognising the need for dedicated care, has reserved 10 specialised beds for transplant recipients, ensuring a mandatory 15-day observation before discharge

to monitor their condition.

# 'Low-quality data a challenge for Al implementation in startups'

Low-quality data and limited financial resources is one of the main challenges for implementing Artificial Intelligence (AI) in startups, said Rahul Paith, CEO of DST, Machine Learning and AI Tech Hub (MATH), an innovation and ecosystem enabler at T-Hub.

Rahul Paith shared that AI is transforming industries, offering startups enhanced efficiency, automation and innovation. However, AI adoption presents significant challenges, including high costs, data security concerns, talent shortages and regulatory complexities. He noted that addressing these challenges strategically is essential for startups to unlock AI's full potential.

The CEO mentioned that AI development requires substantial investments in infrastructure, research and skilled professionals. Expenses include cloud computing, AI platforms and data storage, with ongoing maintenance and upgrades further escalating costs. He noted that startups often operate on

constrained budgets, making it difficult to afford high-end AI solutions. To mitigate expenses, Rahul mentioned that AIas-a-Service (AIaaS) platforms can be explored and opensource solutions that reduce initial investment requirements

ing mechanisms. Concluding, Rahul shared that evolving AI regulations present another challenge for startups. Ensuring compliance with laws related to data privacy, algorithmic fairness and ethical AI practices is crucial.

This has made a huge difference in their lives, and tribal people from both sides of the border are celebrating after bus service has been introduced. For just Rs 250 one can travel from Pamed to Bijapur.

In addition, another bus service will be launched in the first week of March, connecting Charla in Bhadradri Kothagudem district in Telangana. This has brought satisfaction to small business owners in both states, as well as those who had settled in Bijapur from Telangana or migrated to Charla for work. They are now able to visit their families more fre-

quently, and can now complete their work and return in a single day. However, passengers have expressed concerns about a bridge that is yet to be completed near Kondapalle. # **Disparities rising**

One billion Indians have minimal purchasing power despite rapid growth says a Blume Ventures and Marcellus report

n a startling revelation about the state of the Indian economy, recent findings of a study highlight that nearly one billion Indians possess little to no spending power. According to a report by Blume Ventures— supported by insights from Marcellus Investment Managers—India's consumer market is undergoing profound structural changes, marked by deepening disparities and a shifting focus towards premium products for the wealthy. At the heart of the report is the disconcerting revelation that India's true "consuming class" is far smaller than what many might assume. The report identifies only about 130-140 million people as part of this active consumer base-roughly equivalent to the entire market of a country like Mexico. In addition, an extra 300 million Indians are categorised as 'emerging' or 'aspirant' consumers. The report underscores that India's consumer market is not broadening by adding new entrants into the wealthy segment; instead, it is deepening. In practical terms, while the overall size of the affluent popula-



tion remains relatively stagnant, the existing wealthy are growing even wealthier.

This trend of 'premiumisation' has seen brands pivot towards offering high-end, upgraded products that cater specifically to the rich. For example, ultra-luxury housing and premium smartphones are experiencing surging sales. In contrast, lower-priced alternatives are struggling. Affordable homes now represent a mere 18 per cent of the overall market. Moreover, the booming 'experience economy'-evident in the rapid sellout of high-priced concert tickets for international artists like Coldplay ---further illustrates the evolving consumption pattern that favours upscale offerings over mass-

market products. A critical dimension of the report is its analysis of income inequality in India. The long-term trend of widening disparities has been stark. The top 10 per cent of Indians now control 57.7 per cent of the national income-a dramatic increase from 34 per cent in 1990. Conversely, the bottom 50 per cent have seen their share decline from 22.2 per cent to just 15 per cent. The affluent continue to prosper, while the majority of the population grapples with stagnant incomes, diminished savings, and mounting debt. The situation is particularly alarming for India's middle class. The report reveals that the middle 50 per cent of India's tax-paying population has experienced income stagnation over the past decade. The situation is alarming as financial savings are nearing a 50-year low. The insights from the report paint a sobering picture of the Indian economy. While the nation boasts rapid growth in certain sectors and an expanding base of emerging consumers, the benefits of this growth are unevenly distributed. The government must focus on strategies that not only promote growth but also ensure that economic gains are more broadly shared. Investments in education, upskilling and initiatives to revive the middle class's purchasing power will be crucial in steering India towards a more balanced and inclusive economic future.

Social media swiftly linked the question to Truth or Drink, a comedy show from Australia hosted by Sammy Walsh. In the original episode, Walsh presented the same bizarre hypothetical to comedian Alan Fang.

The controversy surrounding Ranveer Allahbadia, also brings to the forefront, a critical constitutional debate - where do we draw the line between freedom of speech and responsibility in content creation? Article 19(1)(a) of the Indian Constitution guarantees the Fundamental Right to Freedom of Speech and Expression, but it comes with reasonable restrictions under Article 19(2), including public decency and morality. The focus must shift from merely advocating Fundamental Rights to instilling deeper commitment to Fundamental Duties.



# How antibiotic-free poultry empowered a mother and her community

By raising chickens with natural remedies instead of antibiotics, women in Uttar Pradesh are safeguarding their health and boosting their incomes

Singh is a post-term baby. Having been born after a ten-month pregnancy, many of her family members were afraid she would be weak and sickly. But Pinky always knew her child would be healthy despite being born a month after what is considered a normal nine-month pregnancy period.

Angel's weight and other health indicators at birth proved her mother right. Much of Pinky's confidence stemmed from the fact that she was regular with her antenatal checkups (ANC). She also focussed on a nutritious diet of leafy greens which she sourced from her small vegetable patch Uttar Pradesh's Samsa Tarhar village in Bahraich, the second

most backward district in India. As her pregnancy progressed, Pinky, a small poultry farmer, diversified her diet to include antibiotic-free eggs and poultry. This was to be a smart move.

Not only because it helped her stay healthy and increase her weight and haemoglobin levels, but more importantly, thanks to her poultry training, she was able to ensure whatev-

er she ate was free of antibiotics. By using natural feed and herbal remedies while raising her chickens, she was able to cut the risk of developing antimicrobial resistance (AMR), a condition arising from the consumption of meat and eggs of poultry fed with at the back of her house in antibiotics to promote quick growth and prevent diseases. Just how critical this practice

was can be gauged from the worrying fact that, in 2019, over 297, 000 deaths in India were directly attributed to AMR. Moreover, the poultry environment has been a reservoir of multi-drug resistant bacteria according to the most recent study of four poultry farms in Uttar Pradesh by the Centre for Science and Environment which found rampant use of antibiotics for

growth promotion and disease prevention. The WHO recognizes the non-therapeutic use of antibiotics in feed and water in food-producing animals to contribute to the development of AMR in humans. Pinky realised this was possible only after she joined the backyard poultry (BYP) farming initiative to empower women and enhance food security and incomes implemented by the Aga Khan Foundation (ÁKF) under their aspirational district programme. After being trained by them in poultry farming techniques, biosecu-rity, and disease management using proven herbal and natural formulations to prevent the development of antibiotic resistance, Pinky, then in her second trimester of pregnancy, understood that the bene-



fits of being a poultry entrepreneur were more than just being economically empowered. "It was an opportunity to take charge of my own health and destiny and that of my unborn child," says Pinky. It is not just Pinky who is bringing change. Like her, 60 women from

marginalised communities in 120 villages in four blocks in Bahraich trained as poultry farmers by AKF are making a team. Yet, many died.

difference in their lives and communities through sustainable and ethical poultry farming practices after each was given 50 pre-vaccinated 21day-old Sonali breed chicks free along with support for feeding and constructing chicken coups. It was the AKF strategy to

impart rigorous, yet easy-tounderstand hands-on demonstration and training on using commonly found medicinal plants and herbs as alternatives to antibiotics that helped the women, mostly uneducated; understand the importance of adopting ethnoveterinary methods or traditional practices for treating animal health and illness. "I used to give antibiotics to keep my poultry healthy before I met the AKF

After joining their programme, I gave a health tonic of turmeric water mixed with jaggery, chirata for deworming and azola, a protein rich fern, to boost their immunity. None of my chicken fell ill," shares a Rambha Devi, a poultry farmer in village Samroha. Raghvendra Singh, AKF district coordinator, skill development, who is closely associated with the BYP programme, contends the 10 per cent mortality rate normally associated with chicks has come down to 4.5 per cent among the 3000 chicks given to AKF poultry farmers because of their use of natural feed and traditional herbal remedies. Consequently, almost 90 per cent of their chicken was sold

and the remaining was used

for home consumption. The

health of families, especially children, consuming these antibiotic-free poultry and eggs, has improved say frontline health workers working in these villages. Further, an AKF evaluation shows that each poultry farmer made a profit ranging between Rs 10,000-14,000. This success has prompted the women to invest in another 50 chicks even if it means taking a loan from their self-help group as it will no longer be given free.

But this isn't stopping them, especially Pinky, who is buy-ing 100 chicks. "The benefits I have gained from being a poultry farmer cannot be measured only in monetary terms. It has changed my life."

# Worst over on India's growth trajectory: Report

The worst seems to be over for the Indian economy's growth trajectory, a German brokerage said on Thursday. GDP growth, which had slipped to a seven-quarter-low

of 5.4 per cent in the September quarter leading to a lot of concerns over the economy's strength, is likely to rise to 6.2 per cent in

the December quarter, the report by Deutsche Bank said. "We think the

worst is over as far as India's growth trajectory is concerned but, even with the improvement of momentum, overall GDP growth is likely to remain below the

potential growth rate of 7 per cent in FY26," the

bank's analysts said. In the report which comes a day ahead of the release of official data on economic performance, the analysts also said that we have to be cautious about the forecasts as there can also be a revision in

previous years' data. The brokerage added that its leading indicator derived from 65 high-frequency indicators

is also pointing towards a 6.2 per cent growth. The Reserve Bank is likely to deliver another rate cut of 25 basis points at the upcom-

ing review of the monetary policy in April to help growth. Minutes of the last policy reveal that all the members on the six-member monetary policy panel feel that rates remained at restrictive levels,



it said. After the April rate cut, RBI will focus more on the liquidity measures to ensure transmission of the 0.50 per cent repo rate cut to the real economy, it said, adding that more cuts are unlikely in the current cycle.

The central bank is already cognizant about the liquidity needs, and the recent USD 10 billion swap announcement is "encouraging", it said.

The Nifty tumbled 3,729.8 points or 14.19 per cent from its all-time high level. The BSE bellwether index Sensex is



down 11,376.13 points or 13.23 per cent from its record peak.

Equity markets came under bear attack from last October onwards after smashing many record high levels.

A correction of this magnitude is usually triggered by a combination of factors. Investor sentiment was tempered when a number of large corporations reported lower-than-expected Q3 results. Furthermore, the Indian stock market faced a difficult environment due to Trump's tariff threats and worries about India's slowing economic growth, which caused international investors to keep selling.

"The Sensex witnessed a sharp decline of over 13 per cent from its peak, driven by heavy FII outflows, negative technical indicators, weak corporate earnings and lobal economic concerns," Puneet Singhania, Director of Master Trust Group, said.

'Additionally, weak US economic data and inflation risks, fuelled by President Donald Trump's tariffs, added to market uncertainties.

WARNS CGMS COULD HARM HEALTH ING BLOOD SUGAR MAL

hile continuous glucose monitors (CGMs) may be of significant help to people living with diabetes, they may harm healthy adults by showing inaccurate results that can lead to unnecessary food restrictions, according to a study on Wednesday. CGMs were originally designed to help diabetics manage their blood sugar. It helps by tracking glycaemic index (GI) -- a measure of how quickly a food can make your blood sugar. However, these devices are now increasingly being used by healthconscious adults to track how different foods affect their glucose levels.

The peer-reviewed research, published in The American Journal of Clinical Nutrition, warns that CGMs could be overestimating blood sugar levels in healthy adults, leading to unnecessary dietary changes. "CGMs are fantastic tools for people with diabetes because even if a measurement isn't perfectly accurate, it's still better than not having a measurement at all. However, for

someone with good glucose control they can be misleading based on their current performance. For healthy individuals, relying on CGMs could lead to unnecessary food restrictions or poor dietary choices. If you want to assess your blood sugar accurately, traditional methods are still the way to go. We want to better identify the sources of the error in CGMs so that we can improve their performance in the future and have active research on this topic,"said Professor Javier Gonzalez from the Department for Health, from the University of Bath. Researchers measured blood sugar responses in healthy volunteers (non-diabetic, within a healthy BMI range) using two methods -- a CGM and the gold standard finger-prick test -- to assess the accuracy of CGMs in fruit-based products, ranging from whole fruit to smoothies. The CGM consistently reported higher blood sugar levels compared to finger-prick tests. When participants consumed a smoothie, the device

overestimated the GI by 30 per cent, reporting a GI of 69 (medium) compared to the traditional test result of 53 (low). Whole fruit was misclassified as medium or high-GI foods by CGMs, while the finger-prick test showed they were low-GI. This could lead users to mistakenly believe that fruit could cause harmful spikes in blood sugar.

The research also debunked the common myth that blending fruits into a smoothie raises their GI. Whether eaten whole or blended, fruits like apples, bananas. mangoes, and oranges remained low on the GI. CGMs are unlikely to be a valid method to determine whether a food has high or low GI, said the researchers. Gonzalez said the CGMs may be inaccurate because they measure alucose in the fluid surrounding your cells, not directly in your blood. "This can lead to discrepancies due to factors like time delays, blood flow, and how glucose moves between different parts of the body."







# tollywood **MAZAKA DOESN'T REALLY BRING MUCH OF ITS 'MAZA', BUT RAO RAMESH NAILS THROUGHOUT**

irector Nakkina Thrinadha Rao and writer Prasanna Kumar Bezawada, known for delivering hits like Nenu Local and Dhamaka, have joined forces once again for Mazaka, which was released on the occasion of Maha Shivratri. The film stars Sundeep Kishan and Rao Ramesh in lead roles, marking Sundeep Kishan's 30th film. Ritu Varma plays the female lead, while Manmadhudu fame Anshu makes her comeback after many years. Here's a look at the film's story and how it fares.

#### STORY

Venkata Ramana (Rao Ramesh) and his son Krishna (Sundeep Kishan) belong to a middle-class family. Venkata Ramana is searching for a bride for Krishna, but no one is willing to marry him because there is no woman in the household. A marriage broker advises Venkata Ramana to remarry first, as it would make it easier to find a match for his son.

One day, Venkata Ramana sees Yashodha (Anshu) and falls in love with her at first sight. He wants to marry her, but Yashodha has plans to move to the USA. Meanwhile, Krishna also falls in love with a college girl, Meera (Ritu Varma). Both father and son try their best to win over their respective love interests, but a major twist occurs when Bhargav Varma (Murali Sharma) enters the picture. Bhargav Varma sets a condition that both father

and son must fulfill if they want to marry the women they love. What is this condition? How is Bhargav Varma related to Yashodha and Meera? Will Venkata Ramana and Krishna finally get the family photo they dream of with the women they love? The film unravels these questions in an entertaining manner.

#### **ANALYSIS**

Director Nakkina Thrinadha Rao has a track record of delivering successful entertainers like Cinema Choopista Mava, Nenu Local and Dhamaka. Writer Prasanna Kumar Bezawada has collaborated with him on multiple projects and their combination has generated curiosity about Mazaka. Several films in the entertainment genre have late-

ly prioritised comedy over logic, aiming purely to



amuse the audience. Mazaka follows the same formula-it focuses on entertainment but lacks logic. Unfortunately, Prasanna Kumar seems to have lost his touch with the screenplay. Interestingly, this story was in circulation for years before finally landing in Rao Ramesh's hands. Prasanna initially wrote the script with Rao Ramesh in mind and later, Sundeep Kishan was added as the lead actor.

The core plot is simple—a father and son both

fall in love and want to marry their respective partners, but an obstacle stands in their way. The first half is engaging, with Rao Ramesh's love story adding freshness to the narrative. Typically, films focus on a young hero trying to impress a girl, but here, a middle-aged man pursuing romance brings novelty. The chemistry between Sundeep Kishan and Ritu Varma is also well-developed in the initial half.

However, the film falls apart in the second half. The conflict between Anshu and Ritu Varma's characters lacks depth and is based on an unconvincing, almost silly, premise. Several scenes feel unnecessarily dragged, making the second half sluggish. One standout moment is the emotional kitchen scene between Rao Ramesh and Ritu Varma, which adds some weight to the narrative.

On the downside, certain comedy scenes, espe-

cially those involving Jabardasth Rohini, Anshu and Rao Ramesh, are poorly executed. The interactions between Rao Ramesh and Anshu in the latter half feel artificial, failing to evoke the intended impact. While the climax has some redeeming moments-Kishan and Hyper Aadhi, which, despite being rem-iniscent of Atharintiki Daredi, manages to entertain-the overall storytelling falls short.

#### PERFORMANCES

Rao Ramesh steals the show. Though some might find his performance over-the-top, his role demands a loud and energetic portrayal, which he delivers effectively. His comedic timing, especially in the first half where he tries to impress Anshu, adds to the film's charm. However, his chemistry with Anshu lacks conviction. Sundeep Kishan plays a role that suits him well,

delivering a solid performance. Ritu Varma is ade-quate, while Anshu looks beautiful but fails to impress with her expressions. Murali Sharma gets a meaty role after a long time and does justice to it. Hyper Aadhi and Srinivas Reddy manage to generate a few laughs. Ajay, who plays a police officer, starts off well but becomes loud and irritating in the latter half.

#### **TECHNICAL ASPECTS**

Technically, the film is average. The cinematography by Nizar Shafi is decent, but Leon James' music is a major letdown. The last two songs, along with their choreography, fail to leave an impression and are a significant drawback. The dialogues, however, provide some comic relief, with well-placed punchlines aimed at mass audiences.

#### VERDICT

Mazaka offers entertainment but only in bits and pieces. The Nakkina-Prasanna duo seems to have lost their magic touch, especially in the second half, which drags down the film. While the story has potential, weak execution and lack of a strong conflict dilute the impact. The film redeems itself slightly with its ending, but overall, it fails to be a consistent entertainer.

Rao Ramesh is the film's biggest asset, and his per-formance alone makes *Mazaka* a watchable, timepass entertainer. However, the film could have been much better had the makers paid more attention to strengthening the second half.

But it is only an idea under consideration as of now," a source in the sports ministry had said. "The implementation can greatly improve transparency and performance of the NSFs," he had insisted.

# Subhman Gill consolidates top spot in ICC ODI rankings

India opener Shubman Gill Wednesdav Wednesday consolidated his position atop the ICC ODI batting rankings after playing a big role in his team's qualification for the semifinals of the Champions Trophy.

Gill, who scored a matchwinning 101 not out against Bangladesh and 46 against Pakistan in Group A matches played in Dubai this past week, has gained 21 rating points and moved up to 817 rating points, increasing the gap with second-placed Babar Azam from 23 to 47

Virat Kohli's unbeaten 100 against Pakistan has helped him overtake Daryl Mitchell of New Zealand to fifth position while KL Rahul has moved up two places to 15th position after notching an unbeaten 41 against Bangladesh.

New Zealand batters Will Young (up eight places to 14th) and Tom Latham (up 11 places to 30th) have moved up after scoring centuries against Pakistan while Rachin Ravindra's ton against Bangladesh has lifted him 18 places to 24th. Glenn Phillips is another Kiwi batter to gain, up 12 places to 28th position.

# **ICC clears bowling action of Matthew Kuhnemann**

Australia's left-arm spinner Matthew Kuhnemann, who was reported for an illegal bowling action during the second test against Sri Lanka last month, has been cleared by the ICC after undergoing extensive testing in Brisbane. The development means Kuhnemann will be able to

resume playing for Australia in the test tour of the Caribbean scheduled later this year. "Kuhnemann's action has now been deemed to be legal and the left-arm spinner will continue to bowl in international cricket," the ICC said in a statement.

The 28-year-old Kuhnemann had undergone an independent bowling assessment at the National Cricket Centre in

Brisbane, where it was revealed that the amount of elbow extension for all his deliveries was within the 15-degree level of tolerance permitted under the ICC Illegal Bowling Regulations, the apex body said.

Despite being called for his general manager national action, Kuhnemann played a pivotal role in Australias 2-0 teams, said: "We are pleased for Matt that this matter is now

resolved. It has been a challenging period for Matt however he has carried himself exceptionally well.

"He has had the full support of Australian cricket and he can now move forward to the next phase of his international career with great confidence."

After the test series in Sri Lanka, match officials asked for an independent assessment of Kuhnemann's bowling action. The ICC allows bowlers a maximum of 15 degrees of flex in their bowling arm, and anything beyond that is deemed illegal. The spinner, who made his Test debut for Australia in 2023, has 25 wickets to his name so far from five matches. Kuhnemann will be available for selection for the three-Test series in the West Indies across June and July.

# **Champions Trophy: Pakistan to play for pride against Bangladesh**

 $T_{\rm the}^{\rm heir\ dreams\ of\ defending}$  the Champions Trophy (CT) title at home shattered, an under-fire Pakistan team will seek to play for pride when it faces an equally insipid Bangladesh in a dead rubber here on Thursday.

With the tournament offering very little margin for error, Pakistan crumbled to suffer heavy defeats to New Zealand and arch-rivals India, which left them on the brink of elimination before the Kiwis confirmed it with their win over Bangladesh.
