# Rekha Gupta is Delhi Chief Minister

**¬**he suspense over Delhi's new chief minister ended on Wednesday as the BJP on Wednesday named first-time MLA Rekha Gupta, 50, as the new chief minister of Delhi, marking the BJP's comeback in the national capital after 27 years

She will be the fourth chief minister of Delhi after Sushma Swaraj, Sheila Dikshit and Atishi and the only woman chief minister among the states being ruled by the BJP at present. Gupta is an old Rashtriya Swayamsevak

Sangh (RSS), hand who was part of the Sangh's students' wing Akhil Bharatiya Vidyarthi Parishad.

The decision was taken at a meeting of the party's legislature party on Wednesday evening in the presence of Central observers Ravi Shankar Prasad and O P Dhankar where she was chosen as the Leader of the House in the Delhi Assembly

The new BJP government, led by Gupta, will be sworn in at a grand ceremony at the Ramlila Maidan on Thursday afternoon in the presence of Prime

Minister Narendra Modi , Union Home Minister Amit Shah, Union Defence Minister Rajnath Singh, chief ministers from the party-ruled states and many celebrities

"Hearty congratulations and best wishes to Mrs. Rekha Gupta ji on being elected the leader of the Delhi BJP Legislative Party. After appointed as the Leader of the House of the BJP's legislative party, Chief Minister designate Gupta alongwith six ministers went to Raj Niwas to stake claim to form the government. She was accompanied by state BJP observers Ravi Shankar Prasad and OP Dhankar along with city BJP president Virendra Sachdeva, and Delhi MPs including Bansuri Swaraj, Praveen Khandelwal and Kamaljeet Sehrawat. BJP national vice-president Baijayant Jay Panda was also present at the Raj Niwas.

## Trump bellows at India

US President Donald Trump has said that he made it clear to Prime Minister Narendra Modi that India will not be spared from Washington's reciprocal tariffs, emphasising that "nobody can argue with me" on tariff structure.

Trump made these remarks during an interview with Fox News' Sean Hannity recently. Fox News aired a joint television interview with President Trump and billionaire Elon Musk on Tuesday night.

On February 13, hours before Prime Minister Modi's bilateral meeting with Trump in the White House, the US President announced reciprocal tariffs. Under the plan, the Trump administration "will work strenuously to counter non-reciprocal trading arrangements with trading partners by determining the equivalent of a reciprocal tariff with respect to each

foreign trading partner." During the interview with Hannity,

Trump reiterated his stance on existing tariff structures between the US and its partners, including India I told Prime Minister Modi yesterday -

Musk said, "It's 100 per cent - auto imports are 100 per cent."

"Yeah, that's peanuts. So, much higher. And - and others too. I said, "Here's what we're going to do: reciprocal. Whatever you charge, I'm charging," Trump said.

Under the reciprocal tariff system, the US would impose the same level of tariffs on Indian imports as India does on American goods.

"Nobody can argue with me," President Trump insisted. "If I said 25 per cent, they'd say, 'Oh, that's terrible.' I don't say that anymore... Because I say, 'Whatever they charge, we'll charge.' And you know

what? They stop."
During Modi's visit to the US, while responding to a question on reciprocal tariffs on India, Trump said, "India has been, to us, just about the highest tariffed nation anywhere in the world. They've been very strong on tariffs, and I don't blame them, necessarily, but it's a different way of doing business. It's very hard to sell to India because they have

'We are right now a reciprocal nation. We are going to - if it's India or if it's somebody else with low tariffs, we're going to have the same. We're going to have whatever India charges, we're charging them. Whatever another country charges we're charging them country charges, we're charging them. So, it's called reciprocal, which I think is a very fair way. We didn't have that.

trade barriers and very strong tariffs."

During his first term as the US president, Trump described India as a "tariff king" and in May 2019, terminated India's preferential market access — Generalised System of Preferences (GSP) — to the US, alleging India has not given the United States "equitable and reasonable access to its markets.

Also, during the interview, Musk claimed that two NASA astronauts, including Indian-origin astronaut Sunita Williams, currently stuck in space, had been left there by the Biden administration "for political purposes." SpaceX, also founded and owned by Musk, has been contracted to bring Williams and Butch Wilmore home. Musk said the rescue attempts would be being made in less than a month.

### Yogi counters pollution board claims of Ganga water unsafe

mid claims by Central Agovernment pollution body that the present condition of Ganga water in ensuing Maha faecal bacteria, Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday countered by assuring the Sangam water in Prayagraj if safe for bathing and other rituals. A sort of controversy erupted over the claims by Central government pollution body which reported the Ganga water at Triveni Sangam, where lakhs of people are taking a holy dip every day during the ongoing Maha Kumbh, is currently

unsafe for bathing. Central Pollution Control Board (CPCB) data informed the National Green Tribunal that Sangam water at Maha Kumbh exceeds the prescribed limit for biological oxygen demand (BOD), a key parameter to determine water quality. BOD refers to the amount of oxygen required by aerobic microorganisms to break down organic material in a water body. A higher BOD level indicates more organic content in the water. River water is considered fit for bathing if the BOD level is less

than 3 milligrams per litre. In a report submitted to the NGT the CPCB said the river water quality did not meet bathing standards during monitoring on January 12-13 at most locations in Prayagraj. According to Uttar

#### **CBI** arrests five rail officers in job bribery case

The CBI has arrested five railway officers, including two of the Indian Railway Personnel Service posted at the Vadodara Division, for candidates in departmental examination, officials said Wednesday.

The federal probe agency seized 650 grams of gold and Rs 5 lakh cash during its searches at 11 locations, including in Gujarat's Vadodara. spokesperson said.

The CBI has arrested 2008-batch IRPS officer Sunil Bishnoi posted as a senior divisional personnel officer in Vadodara, 2018-batch IRPS officer Ankush Wasan, posted as divisional personnel officer Deputy there, Commercial Manager Sanjay Kumar Tiwari posted at Mumbai's Churchgate, Deputy Station Superintendent Neeraj Sinha and Nursing Superintendent Dinesh Kumar posted at Divisional Railway Hospital in Ahmedabad, officials said. The agency has also arrested Mukesh Meena in the case, they said.

# **HC slams railways over ticket sales**

Questioning the rationale of selling excess tickets, the Delhi High Court on Wednesday sought the response of Indian Railways on a Public Interest Litigation (PIL) seeking safety measures to prevent stampedes similar to the one which happened recently Railway Station. During the hearing of the PIL, the Bench of Chief Justice DK Upadhyay and Justice Tushar Rao Gedela questioned the Railways for selling tickets in excess of the number of passengers that can be accommodated in a coach.

"If you fix the number of passengers to be accommodated in a coach then why do you sell, why the number of tickets sold exceed that number? That is a problem," the Court said. The Judges also referred to Section 57 of the Railways Act which mandates that the administration shall fix the maximum number of passengers which may be carried in a compartment.

"If you implement a simple thing in a positive manner in letter and spirit, such situation can be avoided. On rush days you may increase that number accommodate the rush depending on exigencies which keep on arriving from time to time. But not fixing the strength to be accommodated in a coach, this provision appears to have been neglected all along," Observed the

The Court was hearing a petition moved by Arth Vidhi, an organisation of a group of lawyers, entrepreneurs and others professionals, in the backdrop of

Aditya Trivedi said that various legal provisions and rules under the Railways Act should be implemented properly to prevent such incidents in future. "This highlights petition mismanagement, gross negligence and complete failure of administration that caused the

stampede that occurred on February 15 at New Delhi Railway Station," the counsel told the Court. Justice Gedela pointed out that measures have been taken

subsequently. "Are you aware of how many lakhs of people were at station that day? Infrastructurally it may not be possible to control that kind of crowd. The subsequent measures

were taken. It is not something like a railway accident to claim negligence."

The petitioner's counsel insisted on the seriousness of the issue and highlighted the failures of Railways. "We highlight Section 57 and 157 of Railways Act. Airports have mechanisms to know how many people are there. Indian Railways has no such mechanism. There is no notification or circular for unreserved class. If Railways is not following its own rules, then how can we expect security," he said. "If we go to station right now, we will see a lot of crowd without platform ticket and train ticket. We don't see any compliance with the Railways Circular requiring platform ticket. If Railways had complied with its own rules, a lot of things could have been prevented. We have come in larger

Three land revenue officials of the Nilamber namely Circle Officer (CO) Sunil Kumar Singh, Circle Inspector (CI) Mahender and Karamchari (HK) have been penalised under the Jharkhand Rajya Sewa Dene Ki Guarantee Act

These three officials have been fined 65,000 rupees each under section of 7(1) and section 7(2) of Jharkhand Rajya Sewa Dene Ki Guarantee Act by the Deputy Commissioner of Palamu Shashi Ranjan. An order to impose penalty to the tune of rupees 65,000 each of all the three was issued by the DC on February 18.

Sources said this is the first action of its kind in the annals of the land revenue matter in Palamu in the past two decades. These three land revenue officials have been found guilty on two counts.

First and foremost they 'sat over' the mutation cases. These three left a huge number of mutation cases undisposed of. Second, they performed too poor in the collection of Lagaan. These three are far behind the target of the collection of Lagaan.

### Punjab CM opposes US deportee flights, Karge pulls up Congress socks government defends move amid row

With Punjab Chief Minister Bhagwant Mann taking exception to US flights carrying Indian deportees landing in Amritsar, government sources Wednesday defended the move, saying the state makes up for the biggest share of these illegal immigrants.

Sharing figures of the three flights that have arrived in India since February five, they said Puniab residents total 126 of the 333 people deported in US military aircraft, followed by 110 from neighbouring Haryana and 74 from Gujarat.

Eight of them were from Uttar Pradesh, five from Maharashtra, two each from Himachal Pradesh, Chandigarh, Rajasthan and Goa, and one each from Jammu and Kashmir, and Uttarakhand. Each of the three flights on February 5, 15 and 16 carried over 100 Indians and 333 of them have been deported so far, they added. The total includes 262 men, 42 women and 29 minors, the sources added.

As many as 23 flights carrying Indian deportees have arrived in the country since May 2020 and all of them landed in Amritsar, they said.

Since Donald Trump's inauguration as US President, whose

campaign promises included a crackdown on illegal immigrants, three military aircraft have arrived in India carrying the

Opposition parties protested the treatment meted out to the deportees, including them being shackled, and asked the Indian government to take up the issue

After the first flight landed on February 5, Mann accused the Centre of trying to defame Punjab and said a holy city like Amritsar should not be made a "deport centre". This flight had 30 deportees from Punjab and 33 each from Haryana and Gujarat. He kept up his attack and said on Tuesday that if another US plane carrying deportees arrives in

India, it may not land in the state following strong objections raised Γ'he second flight had 65 deportees from Punjab, 33 from Haryana and eight from Gujarat. The corresponding numbers for the third flight were 31, 44 and 33. Following the opposition's protest, External Affairs Minister

Jaishankar told Parliament on

February 6 that the government

was engaging with the US to ensure that deported Indians

are not mistreated.

The minister, however, added that the process of deportation is not a new one, and the standard operating procedure for deportation by aircraft provides for the use of restraints. Women and children were not restrained, he

Government sources said the rules of the US' Immigration and Customs Enforcement (ICE), the agency tasked with such deportations, stipulate that the "detainees transported by ICE aircraft" will be fully restrained by the use of handcuffs, waist chains and leg irons".

The Lokpal directs the chief vigilance officers (CVOs) who act as a distant arm of the Central Vigilance Commission (CVC) - to conduct preliminary inquiry and submit reports in respect of certain

complaints received by it. "An instance has been noted by the Lokpal where the preliminary inquiry entrusted by it specifically to a CVO was submitted to the Lokpal under the signature of an authority other

"The CVOs are advised that any preliminary inquiry directed by the Lokpal should be submitted to it by the respective CVO concerned under his signature," the order issued on Tuesday by the probity

watchdog said. The Lokpal has the mandate to inquire into allegations of corruption against certain public functionaries.

As per the provisions contained under Section 20 (1) (b) of the Lokpal and Lokayuktas Act, 2013, complaints in respect of public servants belonging to Group A, B, C or D are referred by the Lokpal to the CVC for preliminary inquiry. The CVC forwards such references to the CVOs concerned for preliminary inquiry and report.

Some of the important suggestions that emanated from the discussion include simplifying user agreements and policy frameworks to enhance consumer understanding and control over personal data; estab-lishing "clear accountability" structures for data breaches, especially for research institutions and third-party data processors; and strengthening user consent frameworks for greater transparency and informed decision-making. Having "explicit penal provisions for non-compliance"; need for bilateral agreements to address cross-border security and datasharing concerns; addressing the challenges arising from strict data localisation mandates; and having clear guidelines for

obtaining verifiable parental

consent for minors, were also suggested. Addressing the participants, the NHRC chairperson "emphasised that safeguarding privacy as a human right in the digital world is necessary", the statement said. The technological advancements

should "align with fundamental human rights and privacy protection". The responsibility must begin with the individual user,

Justice Ramasubramanian high-lighted that "maintaining digi-tal hygiene is crucial". He also pointed out the "significant decline in value systems, cautioning that one must bear the consequences of this shift", it

The Lokayukta police said that further investigation will be conducted into the allegations of Mysore Urban Development Authority (MUDA) providing compensatory plots in the ratio of 50:50 from 2016 to 2024 and an additional final report will be submitted to the High Court under Section 173 (8) CrPC. In the MUDA site allotment case, it is alleged that compensatory sites were allotted to Siddaramaiah's wife in an upmarket area in Mysuru, which had higher property value as compared to the location of her land which had been "acquired" by the

With over 55 Crore devotees already taken a dip during two months long congregation of extraordinary proportions at Mahakumbh, the Uttar Pradesh government has taken care of all efforts to ensure the cleanliness of the Sangam in Mahakumbh Nagar. Each day, an average of 10-15 Tonnes of floating waste is collected from the river and sent for recycling, demonstrating a strong commitment to maintaining environmental sustainability during this sacred event.

But since this poses a complex array of logistical challenges, especially in managing the immense waste generated by such a gathering, deployment of trash skimmers at Prayagraj by the Urban Development Department as part of Swachh Bharat Mission is being executed by Cleantec Infra, and



focuses on the removal of floating debris.

The trash skimmers patrol the Sangam 24 hours, collecting floral offerings, coconuts, discarded materials, and other debris left by pilgrims. While these offerings hold spiritual significance, their accumulation can pose an environmental burden on the sacred

Amrit Abhijat, Principal Secretary, Urban Development Department, Government of Uttar Pradesh, in a social media post highlighted the significance of the large-scale cleaning efforts underway at the Maha Kumbh. "Guided by the vision of Chief Minister Yogi Adityanath, the department was working towards giving best experience to devotees with a fine blend of technology and human resources," said He added that these skimmers

were critical to ensure that all leftovers and offerings by devotees are captured in real-time the waste is despatched to the recycle plant at Baswar.

He also highlighted the recycling of 600 MT of waste so far, construction of 1.5 lakh toilets and deployment of 16,000 sanitation workers to ensure cleanliness

and hygiene. Managing waste at the Maha Kumbh requires a multi-faceted approach," notes Gaurav Chopra, managing director and cofounder of Cleantec Infra. "The UP Government has demonstrated foresight in implementing this initiative, and we are pleased to provide the technology and operational support. The priority is to maintain the sanctity of the Ganga while ensuring responsible waste management practices. The trash skimmers are designed

for efficient collection and removal of floating trash. Each machine has a 13 cubic meter capacity and a 3,600-kilogram holding capacity. The daily collection of 10-15

tonnes, and up to 20-25 tonnes on peak days such as Maaghi Paurnima, highlights the scale of the waste management challenge and the importance of this peration.

The collected waste is deposited near Naini and subsequently transported to a recycling facility at Baswar, ensuring responsible disposal and minimising environmental impact.



he paradoxes of rapid global changes are proving to be a contemporary reality, one that sheds light on the philosophical aphorism proposed by Samuel P. Huntington, that of "Political Decay." A few years ago, the discovery of fifty refugees dead near eastern Austria, along the Slovakia-Hungarian border, prompted widespread discussion on the issue of illegal migration and related crimes. This tragic event highlighted a larger issue facing European countries-illegal migration and the security risks that come with it. Many individuals from underdeveloped regions, in their search for survival and opportunities, attempt to migrate to European countries, often taking illegal routes. The tragic drowning of more than 80 illegal migrants in a boat off the coast of Libya is just one example of the deadly risks faced by those desperate for a better life. In light of these challenges, it is imperative that European nations develop more sophisticated mechanisms to address this issue, one that has already caused significant tension between countries.

The broader problem of migration and refugees, particularly in regions such as Afghanistan and Central Asia, has created a complicated and often violent dynamic. As refugees flee war and persecution, they find themselves subject to not only economic exploitation but also social discrimination. According to reports, over 70 per cent of the 26 million refugees worldwide are women and children. n the predawn darkness, millions of pilgrims con-■verge at the sacred confluence of the Ganges, their faith burning brighter than the stars above. # Lord Dannatt's Chagos proposal: A testament to imperial arrogance



In a stunning display of imperial indifference, a former British Army chief has urged Keir Starmer to abandon plans to return the Chagos Islands to Mauritius and instead hand them over to the US



he call made by Lord Dannatt, former British Army chief, as reported by The Independent (UK), urging Prime Minister Sir Keir Starmer to abandon plans to cede control of the Chagos Islands to Mauritius and instead consider handing the islands to the United States under the leadership of Donald Trump, is a moment of brutal clarity in the ongoing saga of colonial legacy, imperial arrogance and military hegemony. It is, perhaps, the most unambiguous and openly cynical articulation of an attitude that has plagued British foreign policy for decades: indifference to justice when the imperial or military agenda is at stake. In this shocking proposal, Lord Dannatt not only trivialises the long-standing historical injustice suffered by the Chagossian people but also reveals a chilling truth about the global order — one in which the rights of dispossessed peoples are inconsequential when the might of military power

The Chagos Islands, particularly Diego Garcia, remain a crucial outpost for both British and American military operations in the Indian Ocean, a key region for global military and economic dominance. The brutal truth is that the displacement of the Chagossians, the abduction of their homes, their lands, and their futures, was merely a strategic calculation by the British government, sanctioned and enabled by the United States.

These islands have been stripped of their rightful inhabitants, and instead of facing international condemnation, they remain a linchpin in the projection of military power. bankrupt and legally indefensible. The truth is that the Chagossians were forcibly displaced, their lives uprooted, their families scattered across the world, and their right to return systematically denied. These are not mere footnotes in a distant history; this is an ongoing systematic injustice that has been buried beneath the murky layers of military necessity and imperial prerogative.

The United Nations and the International Court of Justice (ICJ) have ruled unequivocally that the separation of the Chagos Islands from Mauritius was illegal, that the Chagossians' forced expulsion violated fundamental human rights and that their right to return to their homeland must be respected. These rulings are binding principles of interna-tional law, upheld by the court of global conscience. Yet the British United States, has continued to flout these legal rulings, with a callousness that is matched only by the complicity of global institutions that have failed to hold them to account.

The UK and its allies continue to demonstrate a dissonance between the legal obligation to return the islands to Mauritius and the military significance of Diego Garcia. The £18 billion (approximately \$22.52 billion USD) leaseback deal designed to ensure that the UK retains control of the islands is a financial burden, a sum that could instead be better spent on bolstering Britain's own defence capacity. But here's the crux: the Chagos Islands, specifically Diego Garcia, are not just a military base. They are a symbol of the power dynamics that have defined the post-war world order — a world

human dignity or sovereignty, govern the actions of nations. It is worth noting that Lord Dannatt's rhetoric is not an anomaly.

He is merely the latest in a long line of British military and political figures who have justified colonial dispossession in the name of military expediency. Diego Garcia, a military outpost of unparalleled strategic importance, is where American bombers take off for strikes in the West Asia, where naval forces project power across the Indian Ocean, and where the surveillance apparatus of the global superpowers monitors and con-trols vast swathes of the world. In short, Diego Garcia is a symbol of global military dominance a fortress built upon the foundation of historical dispossession, suffering, and legal nullification. government, in collusion with the The fact that the Chagossians' right to return to their nomeiand is still not respected is a contemptuous affront to international law. The UK government's refusal to comply with ICJ rulings, while continuing to enjoy a special relationship with the US, sends a clear message to the world: law and justice are subordinate to

power and strategy. The international legal community can issue as many judgments as it likes, but it is all for naught when the major powers choose to ignore or bypass those rulings in favour of military interests. The declassified documents from the 1960s and 1970s reveal the collusion between the US and the UK to create a military enclave on Diego Garcia, with the forcible removal of the Chagossians merely an administrative detail to be swept under the carpet. In those documents, we see the foundawhere military interests, not tions of a dirty deal that placed

geopolitical strategy above the basic human rights of a people. It is colonialism dressed as military necessity, and those who challenge this narrative are dismissed as idealists, outliers, or irrelevant.This is not just a matter of the Chagossians' rights; it is a fundamental crisis of the global legal and moral order. It is a scandal that has gone large-

ly ignored, an injustice that has been swept under the rug of strategic necessity, and an entire people's history erased in the name of military convenience. How can anyone with even a hint of conscience ignore these flagrant breaches of international law, perpetrated by those who claim to champion human rights while posing as defenders of democracy? Our complicity, fuelled by willful indifference, contributes to the erosion of international law and the degradignity.

The truth is this: the Chagos Islands are not just a stretch of land — they symbolise everything that is corrupt in the global order. A system where power eclipses justice, and human lives are sacrificed for the sake of geopolitical dominance. The silence that surrounds this injustice is as damning as the apathy

that sustains it. The Chagossians have been denied their homeland for over half a century. It is high time that the world demands the return of their land, not just out of legal obligation, but out of a moral imperative to right the wrongs of the past and give these forgotten people the future they have been

# Russia, US agree to work for ending Ukraine war in major diplomatic shift

 $R^{ussia} \ {\rm and} \ {\rm the} \ {\rm US} \ {\rm agreed} \ {\rm on}$   $Tuesday \ to \ start \ working$ toward ending the war in Ukraine and improving their diplomatic and economic ties. the two countries' top diplomats said after talks that reflected an extraordinary about-face in US foreign policy under President Donald Trump.

In an interview with AP after the meeting, US Secretary of State Marco Rubio said the two sides agreed broadly to pursue three goals — restore staffing at their respective embassies in Washington and Moscow, create a high-level team to support Ukraine peace talks and explore closer relations and economic cooperation.

He stressed, however, that the talks — attended by his Russian counterpart Sergey Lavrov and other senior Russian and US officials — marked the beginning of a conversation, and more work needs to be done. Lavrov echoed Rubio's remarks and told reporters that "the conversation was very useful". Trump's national security advisor Michael Waltz and special Mideast envoy Steven Witkoff joined Rubio at the table, along with Layrov and Russian President Vladimir Putin's foreign affairs advisor Yuri

No Ukrainian officials were present at the meeting, which came as the beleaguered country is slowly but steadily losing ground against more numerous Russian troops in a grinding war that began nearly three years

Ukrainian President Volodymyr Zelenskyy said his country would not accept any outcome from the talks since Kviv didn't take part, and postponed his own trip to the kingdom scheduled for Wednesday

European allies have also expressed concerns that they are being sidelined

Trump showed little patience for Ukraine's objections to being excluded from the talks. Today I heard, 'Oh, well, we

weren't invited.' Well, you been there for three years. You should have ended it three years ago," Trump said during a news conference at his Florida residence. 'You should have never started it. You could have made a deal."

Ties between Russia and the US have fallen to their lowest level in decades in recent years — a rift that has been widening ever since Russia illegally annexed Crimea from Ukraine in 2014 and only worsened after Moscow's full-scale inva-

nations, imposed a raft of sanctions on Russia in an effort to damage its economy. And embassies in Washington and Moscow have been hit hard by expulsions of large numbers of diplomats, as well as other

restrictions.

Rubio said on Tuesday that ending the war in Ukraine could "unlock the door" for "incredible opportunities" to partner with the Russians on issues of common interest "that hopefully will be good for the world and also improve our relations in the long term".

His comments were further evidence of the remarkable US reversal on Russia after years in which Trump's predecessor, Joe Biden, led international efforts to isolate Moscow.

Tuesday's meeting was meant to pave the way for a summit between Trump and Putin. After the talks, Ushakov and Waltz said no date has been set vet for that summit

Speaking to reporters after the meeting, Lavrov mentioned the same three goals as Rubio and said that Washington and Moscow agreed to appoint representatives to carry out "regu lar consultations" on Ukraine. The meeting marked the most extensive contact between the two countries since Moscow's The US, along with European February 24, 2022, invasion.

The recent US diplomatic blitz on the war has sent Ukraine and key allies scrambling to ensure a seat at the table amid concerns that Washington and Moscow could press ahead with a deal that won't be favourable to

Kyiv's absence at Tuesday's talks rankled many Ukrainians, and France called an emergency meeting of European Union countries and the UK on Monday to discuss the war. Kyiv's participation in such talks was a bedrock of US policy under Biden.

US State Department spokeswoman Tammy Bruce said the talks were aimed at determining how serious the Russians are about achieving peace and whether detailed negotiations can start.

Rubio said Tuesday that there would be "engagement and consultation with Ukraine, with our partners in Europe and others. But ultimately, the Russian side will be indispensable to this effort".

US Defense Secretary Pete Hegseth said last week that NATO membership for Ukraine was unrealistic and suggested Kyiv should abandon hopes of winning all its territory back from Russia — two key items on Putin's wish list. French President Emmanuel Macron on Tuesday said he spoke by phone to Trump and Zelenskyy following Monday's

European meeting.
The meeting at the Diriyah
Palace in the Saudi capital of Riyadh also highlighted de facto Crown Prince Mohammed bin Salman's efforts to be a major diplomatic play-

Saudi state media described the talks as happening at the prince's direction. Like the neighbouring UAE, the prince has maintained close relations to Russia throughout its war on Ukraine, both through the OPEC+ oil cartel and diplomatically as well.

Saudi Arabia has also helped in prisoner negotiations and hosted Zelenskyy for an Arab League summit in 2023.

But Zelenskyy postponed his own trip to Saudi Arabia scheduled for this week, suggesting that he wanted to avoid his visit being linked to the talks since Ukrainian officials weren't invit

Meanwhile, Russia continued to pummel Ukraine with drones, according to Kyiv's military. The Ukrainian air force said Russian troops launched a barrage of 176 drones at Ukraine overnight, most of which were destroyed or disabled by jam-

Kellogg will meet Zelenskyy and military commanders as

Trump told reporters at his Florida residence Tuesday that Ukraine "should have never started" the war and "could have made a deal" to prevent it. Kellogg said his visit was "a chance to have some good, substantial talks." Zelenskyy cancelled his planned Wednesday trip to Saudi Arabia in what some analysts saw as an attempt to deny legitimacy to the US-Russia talks about the future of his country.

American officials have signaled that Ukraine's hopes of joining NATO in order to ward off Russian aggression after reaching a possible peace agreement won't happen. Zelenskyy says any settlement will require US security commitments to keep Russia at bay. ### Federal judge won't immediately block Musk or DOGE from federal data or worker layoffs

A federal judge refused on Tuesday to Immediately block billionaire Elon Musk and the Department of Government Efficiency from accessing government data systems or participating in worker layoffs. US District Judge Tanya Chutkan found that there are legitimate questions about Musk's authority but said there isn't evidence of the kind of grave legal harm that would justify a temporary restraining

The decision came in a lawsuit filed by 14 Democratic states challenging DOGE's authority to access sensitive government data. The attorneys general argued that Musk is wielding the kind of power that the Constitution says can only be held by those who are elected or confirmed by the

The Trump administration, for its part, has maintained that layoffs are coming from agency heads, and asserted that despite his public cheering of the effort Musk isn't directly running DOGE's day-to-day operations himself.

DOGE has tapped into computer systems across multiple agencies with the blessing of President Donald Trump, digging into budgets and searching for what he calls waste, fraud and abuse, even as a growing number of lawsuits allege DOGE is violating the law.

Chutkan recognised the concerns of the group of states, which include New Mexico and Arizona

"DOGE's unpredictable actions have resulted in considerable uncertainty and confusion," she wrote. Their questions about Musk's apparent "unchecked authority" and lack of Congressional oversight for DOGE are legitimate and they may be able to successfully argue them later.

Still, at this point, it remains unclear exact ly how DOGE's work will affect the states, and judges can only issue court only issue orders to block specific, immediate harms, she found.

Chutkan, who was nominated by Democratic President Barack Obama previously oversaw the now-dismissed criminal election interference case against Trump in Washington, DC.

Washington (PTI): The Trump administration on Tuesday stopped support for legal representation in immigration court for children who enter the US alone, a setback for those fighting deportation who can't afford a lawyer.

The Acacia Center for Justice says it serves 26,000 migrant children under its federal contract. The Interior Department gave no explanation for the stop-work order, telling the group only that it was done for "causes outside of your control" and should not be interpreted as a judgment of poor perfor-

The halt remains in effect until further notice.

# White House says Elon Musk not in charge at DOGE but advising president

The White House says billionaire Elon Musk is not technically part of the Department of Government Efficiency team that is sweeping through federal agencies but is rather a senior advisor to President Donald Trump.

Musk's exact role could be key in the legal fight over DOGE's access to government data as the Trump administration moves to lay off thousands of federal workers. Defining him as an advisor rather than the administrator in charge of dayto-day operations at DOGE could help the administration as it pushes back against a lawsuit arguing Musk has too much power for someone who isn't elected or Senate-con-

The declaration was filed on

Monday as the Trump administration fends off the lawsuit from several Democratic states that want to block Musk and the DOGE team from accessing government systems. The litigants say Musk is wielding 'virtually unchecked power" in violation of the Constitution. The Trump administration, on the other hand, says Musk is not a DOGE employee and has "no actual authority to make government decisions himself", Joshua Fisher, director of the White House Office of Administration, said in court papers. The documents do not name the administrator of DOGE, whose work Musk has championed in posts on his social-media platform X and in a public appearance at the White House. White House press secretary

# Trump administration gives schools deadline to end DEI programmes or risk losing funds

The Trump administration is giving America's schools and universities two weeks to eliminate diversity initiatives or risk losing federal money, raising the stakes in the president's fight against "wokeness".

In a memo on Friday, the Education Department gave an ultimatum to stop using "racial preferences" as a factor in admissions, financial aid, hiring or other areas. Schools are being given 14 days to end any practice that treats students or workers differently because of their race.

Educators at colleges nationwide were rushing to evaluate their risk and decide whether to stand up for practices they believe are legal. The sweeping demand threatens to upend all aspects of campus operations, from essays on college applica-

tions to classroom lessons and campus clubs. It's meant to correct what the memo described as rampant discrimination in education, often against white and Asian students.

"Schools have been operating on the pretext that selecting students for diversity or similar euphemisms is not selecting them based on race," said Craig Trainor, acting assistant secretary for civil rights. "No longer. Students should be assessed according to merit, accomplishment and character."

The guidance drew sharp backlash from civil rights groups and university groups. Some believe its vague language is meant to have a chilling effect, pressuring schools to eliminate anything touching on the topic of race even if it may be defensible in court.

"Creating a sense of risk around doing work that might promote


diverse and welcoming campuses is much more of the goal than a clear statement of existing law," said Jonathan Fansmith, senior vice-president of government relations at the American Council on Education, an association of

college presidents. The memo is an extension of President Donald Trump's executive order banning diversity, equity and inclusion programmes. As legal justification, it cites the 2023 Supreme Court decision barring race as a fac-

tor in college admissions. "Put simply, educational institutions may neither separate or segregate students based on race, nor distribute benefits or burdens based on race," it said. On Monday, the Education Department announced it also cut USD 600 million in grants for organisations that train teachers. The programmes promoted "divisive" concepts like DEI, critical race theory and social justice activism, the

department said. Confusion around the implications of Trump's anti-DEI order was apparent at last week's confirmation hearing for education secretary nominee Linda McMahon. Ásked whether classes on African American history would run afoul of the president's order, McMahon said she wasn't certain.

The California School Boards Association is awaiting legal guidance so it can advise schools on the Trump administration's deadline, spokesman Troy Flint said. "At this point there is not enough informa tion for a step-by-step playbook that tells school districts if you were doing A then now you should do B, or perhaps eliminate the whole programme entirely," he said.



### Man who attacked Japan's ex-PM sentenced to 10 years

A Japanese court on Wednesday convicted a man who threw a homemade pipe bomb at Japan's former Prime Minister Fumio Kishida at a 2023 campaign event, sentencing him to 10 years in prison, according to local media reports. Ryuji Kimura, 25, was charged

with attempted murder for the April 15, 2023 attack on Kishida at a small fishing port in the western city of Wakayama, as well as four other charges including violations of laws on explosives and other weapons. In the ruling, the Wakayama

District Court sentenced

Kimura to 10 years in prison, according to Japan's public television and other media, without specifying which of the five charges he was found guilty of. The court did not immediately confirm the ruling by phone. Kimura, at an opening session of the trial in early February, pleaded not guilty to attempt ed murder, saying he didn't intend to kill Kishida. The then-prime minister was unhurt, but two people sus-

tained minor injuries. Kimura was arrested on the spot. The attack came about a year after the assassination of former

# **Nearly 300 deportees from US held in Panama hotel**

PTI ■ PANAMA CITY (PANAMA)

Panama is detaining in a hotel nearly 300 people from various countries deport-ed under US President Donald Trump, not allowing them to leave while waiting for international authorities to organise a return to their countries.

More than 40 per cent of the migrants, authorities say, won't voluntarily return to their homeland. Migrants in the hotel rooms held messages to the windows reading "Help" and "We are not save (sic) in our country.

The migrants hailed from 10 mostly Asian countries, including Iran, India, Nepal, Sri Lanka, Pakistan, Afghanistan, China and others. The US has

difficulty deporting directly to some of those countries so Panama is being used as a stopover. Costa Rica was expected to receive a similar flight of third-country depor-

tees on Wednesday. Panama's Security Minister Frank Abrego said Tuesday the migrants are receiving medical attention and food as part of a migration agreement between Panama and the US. The Panamanian government has now agreed to serve as a "bridge" or transit country for deportees, while the US bears all the costs of the operation. The agreement was announced earlier this month after US

Secretary of State Marco Rubio's visit. Panamanian President Jose

threats of retaking control of the Panama Canal, announced the arrival of the first of the deportation flights last Thursday. The confinement and legal limbo the deportees face has raised alarm in the Central American country, especially as images spread of migrants peaking through the windows of their rooms on high floors of the hotel and displaying the notes pleading for help. Abrego denied the foreigners are being detained even though they cannot leave the

The Border Patrol made 21,593 arrests during the month, down from 47,316 in December and the lowest mark since May 2020 near the peak of the COVID-19 epidemic, according to US Customs and Border Protection. "Call it the Trump effect," the White House said in a statement. Border arrests fell sharply well before Trump took office from an all-time high of 2,50,000 in December 2023 Mexican authorities increased enforcement within their own borders and then-president Joe Biden introduced severe asylum restrictions in June. Arrests sank even further after Trump was sworn in on January 20 and issued a slew of orders on immi gration, including one to suspend asylum on grounds that the US is under "invasion" at the southern border

Sahibzada Hamid Raza, the chief of Sunni Ittehad Council (SIC), made the claim during Geo News' programme "Capital Talk" on Tuesday, according to The News.

"The PTI founder did not demand the release of any [party] leader during the talks [with the government]. But in fact, an offer is being made to set aside his disqualification within three months," Raza said. The politician's remarks came after a well-placed source told The News that the PTI was once again seeking backchannel talks with the establishwith Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur reportedly playing a key role in the effort. The source insisted that PTI was eager to restart the

process and views Gandapur as the central figure who could make it happen. So far, there is no indication that the other side is willing to engage.

It is pertinent to know that the Election Commission of Pakistan (ECP) disqualified Khan in August 2023 or five years from holding any public office following a trial court's verdict in the first Toshakhana The electoral body had said

that the former premier was guilty of corrupt practices under Section 167 of the Elections Act, 2017.

The PTI founder was again disqualified for 10 years in July 2024 after an accountability court sentenced him to 14 years in the New Toshakhana case — which is not to be mixed with the previous case. The SIC chief's remarks about a deal aren't the first time such claims have come to the fore relating to a deal offered to the incarcerated former prime minister.

Gandapur, earlier this month, claimed that a proposal was made to transfer Khan Bani Gala, Nathia Gali, or the CM

# Imran offered deal to overturn Migrant groups say racist attacks dismuslification. claims ally

When Haben Gebregergish first immigrated to the German city of Magdeburg seven years ago, the Eritrean immigrant was walking to the supermarket with her child when an intoxicated woman approached her on the street. At the time, Gebregergish did not speak German well enough to comprehend what the woman was saying. But Gebregergish says that when the woman threw a beer bottle at her head, she immediately understood.

It was one of her first encounters with racism, but certainly not the last. In the aftermath of a deadly attack at a Christmas market in Magdeburg late last year, Gebregergish and other migrants who have settled in the city say they have experienced a sharp increase in racism and anti-immigration

"We are the same as you," Gebregergish said earlier this month. "We are not different. Just like you, we have feelings. Sometimes we are sad, sometimes we are happy, just like everyone else."

The Christmas market violence was one of five high-profile attacks committed by immigrants in the past nine months that have made migration a key issue as the country heads toward an early election on Sunday. The suspect, a Saudi doctor, drove into the holiday market teeming with shoppers and left five women and a 9-year-old boy dead and 200 people injured.

The suspect arrived in Germany in 2006 and had received permanent residency, and authorities say the suspect does not fit the usual profile of perpetrators of extremist attacks. He is being held in cus-

"Racism already exists here and everywhere. But it has increased enormously since the attack. Ketevan Asatiani-Hermann, newly elected chair of the board for the Advisory Council for Integration and Migration in Magdeburg, said victims of racist attacks in the city often do not feel support from politicians or police

The hatred has always been there, people just didn't dare to say it so clearly before," said Asatiani-Hermann, who came to Magdeburg in 2011 from Georgia. Officers sometimes target or search the victims first before the perpetrator, she alleged, and they also worry reporting an attack could have a negative impact on their residence status

The Magdeburg Police Department did not respond to multiple requests for comment. Mayor Simone Borris, in a statement, said: "Cohesion and community are fundamental values of a city that are inviolable." The mayor also referred media to online services for migrants, and said the city's Cooperation with the Advisory Council for Integration and Migration will be expanded.

# Seven passengers killed in Pakistan's Balochistan

Unidentified gunmen killed at least seven passengers of a bus on Wednesday after checking their identity cards in Pakistan's troubled Balochistan province, officials said. The gunmen targeted the pas-

senger bus in the Barkhan area of the province when it was moving from the provincial capital, Quetta, to Punjab province. Police said that the assailants stopped the bus on a national highway by setting up a blockade. The attackers boarded the bus, checked the passengers' identity cards, and forcibly took seven individuals to a nearby mountain. Shortly after, gunshots were heard.

Barkhan Deputy Commissioner Waqar Khurshid Alam confirmed the incident and the death toll. "All seven who were travelling in the coach belonged to Punjab, and were on their way to Lahore," he said.

India will be less impacted by **⊥**the proposed United States (US) reciprocal tariff as the country's economy is mainly driven by domestic demand, and has substantial services exports, which is not going to be targeted by the Trump Administration, S and P Global Ratings said on Wednesday. US President Donald Trump

has announced he will impose reciprocal tariffs on its trading partners, including India. S&P Global Ratings

Asia-Pacific, Economist Vishrut Rana said the reciprocal tariff will hurt countries like Vietnam, South Korea, Taiwan more as they have high trade surplus with the US.

The Indian economy has two mitigating factors - greater reliance on domestic economy and larger services trade with

the US, which is not likely to be tariffed.

In Japan also, there are similar mitigating factors - greater reliance on services trade, and domestically-driven economy. 'Which means (US) trade measures might be less impactful there (India and Japan)," Rana said at the S&P Asia-Pacific Credit Focus webinar.

He also said that reciprocal tariffs may fuel inflationary expectations, thus leading to higher interest rates globally.
S and P Global Ratings,
Director, Sovereigns (Asia-Pacific) YeeFarn Phua also said India's economy is largely still domestic-oriented and the nature of the exports to the US

is more on the services side,

which is less prone to tariffs. "India's dependence on exports for growth is not that great. So, therefore, I think the impact (of US tariffs) will be more or less limited," he said, adding on the goods side the

exposed to higher tariffs are pharmaceutical, jewellery, textiles and chemicals.

Phua said the US may not impose higher tariffs on pharmaceuticals, which are basically generic drugs, from India as it would drive up healthcare costs in its own country.

However, textiles and to some extent chemicals are most at risk of higher tariffs.

"If we were to reimagine that scenario for the first Trump administration to unfold again, I think overall, the impact on India should be quite minimal," Phua added. Ēarlier in 2018 under the Presidency of Donald Trump, Washington had imposed an additional 25 per cent import duty on steel products and 10 per cent on certain aluminium products. In retaliation, India June 2019, imposed additional customs duties on

28 American products.

The SEC update, submitted by Counsel Christopher Colorado, cited a case which notes that service via the Hague Service Convention is one permissible means of serving defendants located in India. "Since the filing of its Complaint, SEC staff has been

Besides, they ease norms to promote trade in services and boost investments. Given the trade structure

between the two nations, a trade agreement "must be approached with caution," the Global Trade Research Initiative (GTRI) Founder Ajay Srivastava said.

India has a well-developed domestic petrochemical industry that could face challenges if tariff reductions lead to an influx of cheaper Qatari imports, he said, adding that India already has a significant trade deficit with Qatar, which could widen further post-trade pact if market access benefits are

not balanced. 'A careful evaluation of sectoral impacts, particularly energy manufacturing, will be essential before proceeding with such an agreement," he

India's trade with Qatar is marked by a significant imbalance. In 2023-24, the country's imports from Qatar stood at

\$12.34 Billion, while its exports were only \$1.7 Billion. A large portion (85 per cent) of India's imports from Qatar comprises LNG (\$6.3 Billion), butane, propane mostly for LPG production

(\$3.1 Billion), and petroleum crude (\$1.1 Billion). Meanwhile, India's primary exports to Qatar include Basmati rice (\$124 Million), articles of iron and steel (\$200 Million), and machinery (\$106 Million).

According to the GTRI, as of 2024, Qatar has a gross domestic product (GDP) of \$221.4 Billion, and a population of about 3.1 Million. India has a GDP of \$4 Trillion and a population \$4 Trillion and a population of 1400 Million. The bilateral trade has declined to \$14 Billion in 2023-24 from \$18.77 Billion in 2022-23.

India received \$1.5 Billion of foreign direct investments from that country between April 2000 and September

the top? ago, this "Many years question wouldn't have come up because sport was not big enough. The mass of people



overtakes former Pakistan captain Babar Azam to become the top ranked ODI batter in the world," the ICC said.

Gill, who scored two fifties and a century in the recent three-match ODI series against England at home which India won 3-0, jumped one place to the No. 1 spot. He now has 796 rating points compared to Babar's 773.

India skipper Rohit Sharma is placed at the third spot with 761 points followed by South Africa's Henrich Klaasen and New Zealand's Daryl Mitchell at fourth

and fifth respectively.
"It's a major shake-up at the top of the rankings just prior to the start of the Champions Trophy and leaves an interesting sub-plot to what will transpire over the coming



weeks during the eight-team tournament in Pakistan and Dubai," the ICC said.

This is the second time Gill has held the No.1 ranking in ODI cricket, with the India batter having also gone past Babar to claim top

"While Sri Lanka won't be featuring at the Champions Trophy, Theekshana earned the top spot following his exploits against the Aussies that included an excellent four-wicket haul in the opening match of that series in Colombo," the ICC said the ICC said.

Sri Lanka had recently handed a 2-0 whitewash to Australia with Theekshana taking four wickets. The Sri Lankan spinner has 680 rating points, followed by Rashid at second, Namibia's Bernard Scholtz at third, India's Kuldeep Yadav at fourth and Pakistan's Shaheen Shah Afridi at fifth.

### Ex-Mumbai captain, selector Milind Rege passes away at 76

 $F^{ormer\ Mumbai\ captain}_{and\ selector\ Milind\ Rege,}$  a highly respected figure in domestic cricket, died after suffering a heart attack on Wednesday, just days after turning 76.

Rege, who turned 76 last Sunday, was admitted in the intensive care unit of the Breach Candy Hospital here and passed away around 6am on Wednesday morning. He is survived by his wife and two sons.

The all-rounder had suffered a heart attack at the age of 26 but returned to the cricket but returned to the cricket field and even captained Mumbai in the Ranji Trophy. He played 52 First-Class matches between 1966-67 and 1977-78, taking 126 wickets with his right-arm off-break bowling. He also contributed with the bat, scoring 1,532 runs at an average of 23.56. Legendary batter Sachin Tendulkar recalled Rege's contribution in the early days of his career. "Sad to hear about Milind Rege Sir's passing. He was a true Mumbai cricketer with immense contributions to the city's cricket. He and other city's cricket. He and other CCI members saw potential in me and asked me to play for CCI, which, as I look back now, was a landmark moment in my career," Tendulkar wrote on 'X' in a tribute. "He could pick out a talented

player from a sea of hardworking hopefuls. He had a special sixth sense to pick talent at all levels, but especially at junior levels.
"He leaves behind a void, one

that's tough to fill. He may not be around, but his imprint on people's lives will always live on. He made a difference to so many lives and definitely made a difference to mine. Thank

you, Sir, for everything. Heartfelt condolences to his friends and Tendulkar added.

The Indian cricket board also conveyed its condolence

message.
"The BCCI mourns the passing of Milind Rege, former Mumbai captain and selector. A pillar of Mumbai cricket, he played a key role in its growth and legacy. His in its growth and legacy. His keen eye for talent and

soul," he said. A childhood friend of former India captain Sunil Gavaskar, Rege attended the same school and college as Gavaskar and played alongside him at the Dadar Union Sporting Club.

As one of the most revered figures in Mumbai as well as domestic cricket, Rege held several roles through his career and was also associated with with the Mumbai Cricket Association as a cricket advisor.

### Bangladesh can beat any team in Champions Trophy: Shanto

Heading into their Champions Trophy (CT) opener against formidable neighbours India, Bangladesh skipper Najmul Hossain Shanto was filled with optimism. He was particularly emboldened by the rise of pace sensation Nahid Rana, who has added a new dimension to their bowling attack.

The 22-year-old Rana holds the record for the fastest ball (152kph) bowled by a Bangladesh cricketer, hits 150kph on occasion, and averages 145kph for most of his

Besides the presence of Rana and experienced pace colleague like Taskin Ahmed, the team also has few useful all-rounders and spinners, and some good

batters. "Obviously, all-rounders always balance the team and we have got some good all-rounders. I hope they will perform tomorrow," Shanto said

in the pre-match press conference here on Wednesday. "If you look in this format, our team is quite balanced and we believe we can beat any team in this tournament. All teams are capable of winning this trophy but I am someone who is not thinking about the opponents much. If we execute our plan properly we can beat any team in any day," Shanto said.

After years of struggle, Bangladesh are now in a position to boast a good pacebowling attack, feels Shanto.

"Yes, obviously. I think we always struggle with our seam attack, but last couple of years we have got some quality fast

bowlers. Now we have got Nahid Rana, Taskin the way they are bowling. I think it helps

"As a captain, we love to see them bowling fast. So, I'm really happy that we have got a good fast bowling unit and under lights the ball might swing. So, if they bowl in the good areas, it will help our team." Rana has done well in his

nascent career, having taken 20

wickets in six Tests and four scalps in three ODIs. Bangladesh are in a group in which the spotlight is on traditional rivals India and Pakistan, and Shanto was asked

if this is a favourable position to be in before a big tournament. 'Yeah, obviously. I think if you look at all eight teams - they are quality teams. And against India, Pakistan, New Zealand,



we have good memories. We won a couple of matches in recent times.

"Last year, when we played India in Bangladesh, we have some good memories from then. But that is past, I think if we play well tomorrow and execute our plan, we will have a good match tomorrow," he said. Shanto refused to read much into the absence of India's pace spearhead Jasprit Bumrah and

Shakib al Hasan. The conditions in the UAE are familiar to both the teams but for Bangladesh to have any chance against India, Shanto knows that they will have to have one of the best days in all departments.

"We have to play well in all departments - batting, bowling, fielding - because I think the way we played the last few years in this format, I think we have a good side and as you mentioned the conditions are quite similar. I'm really confident that we will prepare ourselves well."

When asked about Rana, Shanto said he was looking to leading the pace attack on Thursday and that his emergence has motivated the whole bowling unit.

"I think last few matches he bowled really well and bowled Bangladesh's star all-rounder fast. And when we see in the ground bowling like this, it

helps our whole bowling unit. And it's motivated us.

"He needs to be fit and he can continue his bowling form. We have got another two-three fast bowlers as well," he said. After their opener in Dubai, Bangladesh will be playing their

last two group games in Pakistan, and the conditions there are going to be different. "Yes, here I think we need to adjust, because if you look at this wicket, probably it's not that high scoring if you compare to Pakistan. So, we have to adjust. "Recently we played against Pakistan in a Test match in Rawalpindi. We have that experience how the wicket will behave. But as a cricketer, I think we all understand when we need to adjust and how to

play the game. I don't think it

will be difficult."

Talks around fast-bowling unit With Rana linking up with the likes of Taskin, a lot of people have started talking about Bangladesh's fast bowling department, and Shanto said factors such as switching to Duke balls and arrival of experts from overseas have contributed to the improvement in the

country's pace attack. "I think the important thing is the wicket and the ball has been changed in first class cricket. We play with the Duke ball, so the fast bowlers wanted to bowl a lot of overs and we get a little bit charged.

"And obviously there is a lot of local coaches and obviously overseas coaches there, so they helped and they motivated the fast bowlers, how they can compete in the international
