
STATE GOVT MOVING AHEAD WITH THE GOAL OF SWARNANDHRA VISION-2047 IT'S NOT THE RULING DISPENSATION THAT ACCORDS OPPOSITION STATUS FOR YSRCP

Chief Minister N Chandrababu Naidu, on Tuesday, made it clear that all the promises made in the election manifesto will be fulfilled despite having heavy constraints.

"The TDP-led NDA government is committed to fulfil all the promises made to the people before elections," the Chief Minister said, and released on the floor of the Assembly the schedule on the implementation of the Super-Six schemes. Responding to the debate on the Motion of Thanks to the Governor's address to the joint session of legislature, Chandrababu asked whether the demand of the YSRCP to sanction Special Category Status for the State against the norms is justifiable.

Making it clear that it is not the ruling dispensation that accords Opposition party status for the YSRCP, but the decision has to be taken by the people, the Chief Minister said that the alliance partners did not contest the polls for any selfish ends. They did it to rebuild the State thinking that it is possible only with the double-engine government. The Chief Minister said that the State government is moving ahead with the objective of Swarnandhra Vision-2047, and that the Central assistance for the development of the State is commendable.



"We will work for 365 days and 24 hours a day with the solid commitment to implement the promises made to the people," Chandrababu said, and pointed out the promises already implemented like revision of pension from Rs 3,000 to Rs 4,000 and the assistance being extended to the differently abled.

Stating that the State is passing through various constraints due to the inefficient rule of the previous government, the Chief Minister said that on record from the floor of the House, he is appreciating the efforts of the Deputy Chief Minister, Pawan Kalyan. "Also, I appreciate the Prime Minister, Narendra Modi, in extending all kinds of cooperation for the progress of the State," Chandrababu said.

Referring to the poor condition of roads when he became the MLA for the first time, Chandrababu Naidu regretted that the proceedings of the House in the past five years were very unpleasant. "In my 40 years of political life for the first time I have experienced the demand that the MLAs of a party will attend the House only if Opposition status is accorded," he added.

SLBC TUNNEL COLLAPSE Water, silt impede rescue operations

PNS HYDERABAD

The rescue operation inside the collapsed SLBC (Srisailam Left Bank Canal) tunnel entered its fourth day, with the situation inside the tunnel growing increasingly dangerous.

Despite continuous efforts by 11 national and state agencies, including the Indian Army, Navy MAR-COS, NDRF, SDRF, the Geological Survey of India (GSI), SCCL rescue teams and experts from the L&T, the rising water levels, thick silt and unstable debris continue to impede progress.

Nagarkurnool Collector B. Santhosh, who has been closely monitoring rescue operations, described the conditions inside the tunnel as "extremely treacherous."

Rescuers are moving through waistdeep sludge with visibility reduced to near-zero due to the murky water and dust from the collapse. "We are facing a major challenge in reaching the last 50 meters where the eight workers are trapped. The tunnel is completely blocked by four to five meters of accumulated silt and debris, making entry almost impossible at present," the Collector said.

The tunnel, which has only a single entry and exit point, presents a very difficult problem for rescue teams. With no other escape route any movement inside the structure is dangerous. The Tunnel Boring Machine (TBM) used for excavation remains stuck in the collapsed section complicating access. Experts are currently assessing the feasibility of drilling from the top or sides of the tunnel to create

But the party had a nightmarish experience in the case of a Council seat (graduates) in the Rayalaseema districts where its chief YS Jagan Mohan Reddy hails from. It lost that seat despite being the ruling party. The fear of a pos-sible repetition of that might have made the party's leader-ship skip Council elections. The chances of a win may be bleak for the party if there is a direct fight like last year's general elections. The YSRCP might have thought that avoiding the polls was better than getting defeated.

Streamline data integration for efficient governance: RTG Secretary Stress on creating a centralised data lake

Bhaskar Katamneni, Secretary of the Real Time Governance (RTG) Department, has issued an urgent directive to all government departments, emphasising the need for complete data submission to enhance governance through data integration. In a recent review meeting at the Secretariat, Katamneni highlighted the importance of creating a centralised data lake, and expressed concerns over several departments providing only partial data, which he deemed unacceptable.

During the meeting, attended by officials from various departments, Katamneni underscored the critical necessity of accurate data sharing to facilitate the integration process essential to RTGS's initiatives. One of the primary action items discussed was the appointment of Chief Data Technical Officers (CDTO) across all departments and their sections.

Despite previous instructions, only 202 of the 338 sections have completed these appointments, leaving 136 sections without a designated officer. Katamneni called for immediate action to finalise these appointments, stressing their importance for seamless

coordination with RTGS. Furthermore, he pointed out the issue of incomplete data submissions, urging departments to provide comprehensive datasets, particularly concerning government assets. The integration process aims to enhance operational efficiency and improve service delivery across all sectors. In line with Chief Minister N Chandrababu Naidu's vision, Katamneni stressed that effective data integration will accelerate public service delivery by eliminating delays. By consolidating data from various departments, the government aims to streamline processes that typically take months, enabling tasks to be

completed with a single click and enhancing departmental efficiency through technology.

In addition to data integration efforts, Katamneni encouraged departments to communicate any specific challenges they encounter in improving performance. RTGS plans to use this feedback to develop tailored solutions that address these challenges, further optimising daily operations.

Katamneni also addressed the need to accelerate GPS implementation in RTC buses. He urged RTC officials to expedite discussions and finalise an agreement with Google. If successful by the end of the month, the GPS system can be rolled out in RTC buses, marking a significant advancement in service delivery. Srikanth, Technical Service from the Home Department, and M Madhuri, Deputy CEO of RTGS, also attended the meeting.

All set for MLC polls

6,62,100 graduate voters, 22,493 teacher voters expected to cast votes

PNS VIJAYAWADA

The Election Commission of India (ECI) is prepared to oversee the polling for two Graduates Constituencies and one Teacher Constituency MLC elections scheduled for February 27 in the State. Following the ECI's directives, Chief Electoral Officer (CEO) Vivek Yadav has made all the necessary arrange-ments for the polling of the three MLC elections across the combined districts of Krishna, Guntur, East Godavari, West Godavari, Visakhapatnam, Srikakulam, and Vizianagaram.

As per the final publications of the nominations filed before the respective election officers, a total of 70 candidates are in the contest in the two Graduates' and one Teacher's MLC election. For the East Godavari-West Graduates' Godavari Constituency, 54 candidates filed nominations, however, 11 were rejected and eight candidates withdrew their nominations. Finally, 35 candidates are contesting in this segment.

Also, in the Krishna-Guntur Graduates' Constituency, 40 nominations were filed, of which 10 were rejected, five candidates withdrew their nominations, and currently, 25 are in the fray. Whereas, in the Srikakulam-Vizianagarm-Visakhapatnam Teachers' Constituency, 10 candidates filed nominations and all are in the election contest.

In view of the three MLC election polling, the Election Commission arranged a Control Room at the Chief Electoral Officer Office in two shifts for monitoring the election on February 27 and counting on March 3. For the polling process,



supervision of the District Medical and Health Officer (DMOH) for private hospital management, specifically addressing the registration and issuance of birth and death certificates.

"It is imperative that we ensure citizens receive these documents promptly," Judge Seshamma stated. "These certificates are fundamental for accessing various government services and entitlements."

She further advised officials to thoroughly review govern-ment guidelines (GOs) and exercise due diligence in all certificate issuance processes. In particular, she highlighted the importance of verifying the age of brides and grooms using Aadhaar cards, 10th class certificates, school leaving certificates, and municipal bar certificates before registering marriages. processing applications. After a year inauguration, Vizag food lab remains idle

State-of-the-art facility, inaugurated by PM, remains non-operational delaying crucial testing

PNS VISAKHAPATNAM

A state-of-the-art food laboratory, virtually inaugurated by Prime Minister Narendra Modi over a year ago in Visakhapatnam, remains non-operational, sparking widespread concern over food safety enforcement in Andhra Pradesh. The facility, intended to bolster public health and ensure the quality of food products, stands empty despite substantial financial investment and the installation of advanced equipment.

Constructed within the Peda Waltair Regional Public Health Laboratory premises, the project received approximately Rs 30 crore in funding from both the Central and State governments following the oifurcation of Andhra



Pradesh. The building was Opposition leaders, who completed two years ago, and Rs 10 crore worth of sophisticated equipment was installed prior to the virtual inauguration on February 25 last year. Yet, the laboratory has remained inactive since. The delay has drawn

accuse the State government of neglecting crucial food safety regulations. They argue that the non-function-al facility is a significant waste of public resources, including high-end instruments and costly chemicals, and demand immediate

action to activate the labora-

tory. Prior to the State's bifurcation, food samples were sent to Hyderabad for testing. Now, with no operational facility in Visakhapatnam, food safety officers continue to rely on the Hyderabad laboratory, resulting in processing delays of up to a month. This extended timeframe significantly undermines the timely detection of food adulteration and hinders effective regulatory action against offenders. The laboratory, designed to conduct tests across 17 categories, including oils, food grains, dairy products, and soft drinks, boasts 30 types of advanced instruments. However, full installation remains incomplete, and the

facility requires approxi-

mately 80 staff members for effective operation. The crucial recruitment process has yet to commence. The inaction of State

authorities has fuelled public outrage, with concerns mounting over wasted resources and potential risks to consumer safety. Experts are calling for the government to urgently expedite the installation of remaining equipment, recruit qualified personnel, and streamline administrative processes. "The prolonged delay in making this vital laboratory operational is a serious dereliction of duty," said one local food safety advocate, who requested anonymity. "Consumers deserve to have confidence in the safety of the food they consume. This inaction puts public health at risk.

TG govt plans radial road linking ORR to RRR

PNS HYDERABAD

The Telangana Government has launched the construction of a Greenfield Radial Road (Ratan Tata Road), a key project which improves connectivity between the Outer Ring Road (ORR) and the Regional Ring Road (RRR). This major corridor will pass through critical development zones like Skill City and Future City facilitating seamless transportation

for businesses and the public. The Hyderabad Metro politan Development Authority (HMDA) and the Hyderabad Growth Corridor Limited (HGCL) have been entrusted with the project, which will span 41.50 km across six mandals and 14 villages in Ranga Reddy district.

The construction will be carried out in two phases:

Phase I: ORR at Raviryal (Tata Interchange) to Meerkhanpet (19.2 km)-Estimated cost: Rs 1,665 crore Phase II: Meerkhanpet to RRR at Amangal (22.3 km) -Estimated cost: Rs2,365 crore.

Curbing of ganja, drugs menace emphasized



'73 pc waste pickers lost income during COVID'

ore than 73 per cent of Delhi's waste pickers suffered severe income loss during the COVID-19 pandemic, forcing many into debt and extreme financial distress, said a report released on Tuesday. The report, 'A Governance Landfill: The Tragic Story of Capital's Waste-Picking Community During the Pandemic', was published by the People's Commission and Public Inquiry Committee (PC-PIC). The report also found that 56.5 per cent of waste pickers faced harassment from municipal authorities, while 52 per cent had to borrow money for basic healthcare, an official statement of PC-PIC said. According to the statement, the findings based on field research, public hearings and testimonies, paints a stark picture of how the pandemic's economic fallout, coupled with government neglect and increasing privatization of waste management, pushed waste pickers further into precarity. At the report's release event, waste pickers shared firsthand accounts of their struggles.



DRDO recruitment scam: CBI registers FIR

he CBI has registered an FIR to probe a fraudulent recruitment racket, which allegedly cheated unemployed youths by making fake promises of ensuring employment in the Defence Research and Development Organization (DRDO), officials said on Tuesday. The case registered against unidentified suspects alleged that racketeers offered jobs on various posts like Peon, Cleaner, Multi-Tasking Staff (MTS) and Lower Division Clerk (LDC) in the DRDO, they said. The gang charged Rs 5-10 lakh from the candidates promising the jobs, the officials said. The racketeers even conducted medical examination at a purported DRDO-affiliated facility located in New Delhi after extracting payments from the aspirants, they said. "Subsequently, the job aspirants were issued fake appointment letters and were directed to report for a threemonth training session in a fake DRDO office at Jaipur.

NEW RULES FOR KOTA HOSTELS Security fee waiver, installation of anti-suicide ceiling fans

Ahead of the upcoming acade-mic secession 2025-26, the district administration has released new guidelines for coaching centres and hostels under the Kota Cares Campaign, officials said on Tuesday.

The aim of the campaign is to reduce the cost of living for the students coming to Kota to pre-pare for the competitive exams.

The key features of the new guidelines include the elimination of security and caution money in all the 4,000 hostels in the city. Earlier, the hostels

would charge the amount and refund it by the end of the year. Following a meeting with the stakeholders of the coaching industry, Kota District Collector Dr Ŕavindra Goswami announced that hostels can charge of maintenance fee of Rs 2,000. They will also be provided with anti-suicide ceiling fans and mandatory gatekeeper training for hostel staff, the statement said.

The students will be provided free entry to Chambal Riverfront and Oxygen Zone Park on a one-time pass basis. A Kota Cares helpdesk will be set up at the railway station and bus stand, and functional CCTV and biometric systems will be installed in the hostels, the statement read.

The hostel staff will be required to maintain manual

attendance at night. The accommodation will have recreation areas and parents will be provided with receipts of all payments.

Dr. Goswami said, "Under the Kota Cares campaign, efforts are being made to provide students with better facilities and an improved environment. With the growing number of students in Kota, excellent infrastructure has been developed. Better accommodations and care facilities can now be offered to students in different areas of the city, and issues that previously existed have been resolved. We are confident that students in Kota will receive the best coaching along with excellent housing and an ideal environ-

ment. This comes as the number of students coming to Kota for the preparation of competitive exams saw a sharp decline from over 2 lakh to over 1.24 lakh in 2024-25. This caused a revenue loss of around 50 per cent, leaving many hostels with less than 40 per cent occupancy.

Liberty is sacrosanct

The Supreme Court's directive affirming bail as the norm and emphasising liberty is a welcome step

he Supreme Court in a recent ruling and observation made a very pertinent precedence that could have far-reaching implications in the functioning of the democracy. The Supreme Court in the case of Kailash Kumar vs State of Himachal Pradesh wherein it set aside a High Court order cancelling the bail of an accused has rooted for individual's liberty. This ruling underscore the judiciary's commitment to protect personal liberty and ensuring that courts do not meddle with individual's right to freedom. Liberty is a cornerstone of the Indian Constitution, protected under Article 21, which states that no person shall be deprived of life or personal liberty except according to the procedure established by law. Bail, in this context, serves as a safeguard against arbitrary detention and ensures that an accused remains free unless proven guilty. The Supreme Court has consistently held that bail should be the norm and jail the exception, especially when the accused does not pose a threat to the legal



process. The Supreme Court, while overturning the High Court's decision, made critical observations regarding the protection of personal liberty. The Supreme Court's ruling aligns with a broader judicial philosophy that bail is a right and should not be

treated as a privilege granted at the discretion of the courts. The idea is that pre-trial detention should not be punitive but rather a measure to ensure the accused's presence at trial. In numerous judgements, the Court has clarified that unless there is compelling evidence of misconduct, denying bail would violate an individual's fundamental rights. However, courts must balance the rights of the accused with the inter-

ests of justice and the safety of society. The Supreme Court's reaffirmation that bail is a fundamental right serves as a significant reminder to lower courts to uphold personal liberty. The judiciary must ensure that bail decisions are guided by legal principles rather than subjective interpretations of the accused's culpability. This observation is likely to have far-reaching implications and may pave the way for several undertrials, especially political activist who are languishing in the jails. For instance as of February 2025, several individuals accused in connection with the 2020 Delhi riots continue to await bail, leading to prolonged incarceration without trial. Notable among them are activists Umar Khalid and Sharjeel Imam, as well as a politician Tahir Hussain. Despite multiple bail applications, courts have consistently denied them relief. As of October 2024, Khalid had spent over four years in jail without trial, highlighting concerns about prolonged pre-trial detention. The prolonged detention of these individuals have sparked debates about the use of stringent laws like the UAPA and the rights of undertrials in India. These cases exemplify the challenges within the Indian judicial system regarding prolonged pre-trial detention and the balance between ensuring justice and upholding individual rights.

The rise of extremist ideologies among Central Asian youth has become a critical security concern, exacerbated by economic hardship and geopolitical conflicts

n recent years, the increasing attraction of Central Asian youth to extremist and Takfiri groups has become a significant security concern for regional governments and international experts. The ongoing Russia-Ukraine conflict has only intensified these concerns, with reports indicating that young migrant workers are being recruited for extremist activities, a pattern reminiscent of the recruitment seen during the conflicts in Syria and Iraq. The emergence of the Turan

Battalion, a group of Turkicspeaking Central Asians fighting alongside Ukrainian forces against Russia, highlights the pressing need to address radicalisation among young people. At the same time, extremist propaganda spread by figures such as Idas Sadeghov has contributed to the rising tide of radicalism, further complicating the region's ecurity landscape.

The radicalisation of Central Asian youth stems from a combination of social, economic and political factors that make them ulnerable to extremist narratives. Economic hardship is one of the most significant drivers, particularly in countries like Kyrgyzstan and Tajikistan, where persistent poverty, high unemployment, and limited socio-economic opportunities push young people toward alternative ideologies. Over three decades of independence, Kyrgyzstan has experienced multiple coups, widespread corruption, and growing dissat-isfaction with the secular governance model.

Many young people, disillusioned with their governments, seek a sense of purpose and community in extremist ideologies that not only provide identity but often come with financial incentives. Migration also plays a critical role in this radicalisation process. Millions of Central Asians migrate to Russia for work, where they frequently face exploitation, legal difficulties and social alienation. The absence of integration programs and social support

leaves them vulnerable to extrem-

ist recruiters who exploit their

grievances and isolation. These

ology as a means of empower-

ment and justice, a dangerous

proposition that finds traction



among individuals struggling to navigate foreign environments with little institutional support. Religious education, or the lack thereof, is another crucial factor in the rise of extremism. In countries like Tajikistan, where Islamic teachings are heavily restricted and even prohibited for individuals under 18, a signif-icant knowledge vacuum has

emerged. This vacuum is quickly filled by extremist propaganda, often disseminated via social media. Many young Tajik migrant workers in Russia rely on online content to shape their religious understanding, unknowingly consuming distorted interpretations of Islam that align with extremist beliefs. This unchecked exposure to radical ideologies fuels the rapid spread of extremist sentiment within vulnerable communities. Kazakhstan presents a unique case where extremist ideologies have infiltrated even the highest levels of power.

Salafi groups, for instance, gained traction with backing from influential figures such as General Kairat Satybaldy, making the fight against radicalisation more challenging.



The gold of 99.5 per cent purity rose by Rs 250 to Rs 88,950 per 10 grams from the previous close of Rs 88,700 per 10 grams. On February 20, gold of 99.9 per cent and 99.5 per cent purity hit all-time highs of Rs 89,450 and Rs 89,050 per 10 grams, respectively. However, silver prices slipped below the Rs 1 lakh mark, falling by Rs 500 to Rs 99,500 per kg. "Silver fell due to weakness in the industrial metals and rebound in the dollar index. Global equity markets are also struggling due to Trump's tariff fears and pressure on industrial metals but reversal in the US Treasury yields could support silver prices at lower levels," Rahul Kalantri, VP Commodities at Mehta Equities Ltd, said. On Tuesday, the rupee fell sharply by 51 paise to settle at 87.23 (provisional) against the US dollar due to month-end dollar demand by importers amid uncertainty over US trade tariffs



ucts. "India has a lower overall exposure relative to most others in the region, although certain sectors such as food and textiles as well as pharmaceutical products face risks," Moody's Ratings said.

Given a more restrictive trading environment, currencies of targeted APAC economies could face continued downward pressure given potentially higher capital outflows and a likely stronger US dollar, with regional central banks having a much narrower window for easing domestic monetary policies to support economic growth.

'India, UK trade agreement 'genuinely beneficial' for both'

The proposed free trade agree-ment (FTA) between India and the United Kingdom is "genuinely beneficial" to both countries as it would help boost bilateral trade and investments, UK Secretary of State for Business and Trade Jonathan Reynolds said on Tuesday.

India and the UK on Monday announced resumption of negotiations for the FTA, which is expected to double or even triple bilateral trade from the current USD 20 billion in the next 10 years.

Reynolds met Commerce and Industry Minister Piyush Goyal to discuss about the

agreement. After concluding the twoday talks with the Indian minister, Reynolds said: "This is about an agreement which is genuinely beneficial to both countries. That is possible. That's the prize. Getting it right is what we are here to do, and that's what we are working

The days of England's white ball supremacy are far behind now, as the former world champions' creaking unit even failed to defend a 350-plus total against Australia in their tournament opener.

While England may take some comfort in posting a massive total, the reality is that it came against an Australian side missing their premier pacers - Pat Cummins, Mitchell Starc, and Josh Hazlewood.

The English bowlers then failed to stop an Australian line-up that did not have lead batters such as injured Mitchell Marsh and now-retired Marcus Stoinis.

So, England will need to show massive improvement against Afghanistan on both those counts. Afghanistan's three-pronged spin attack, consisting Rashid Khan, Noor Ahmad and Mohammad Nabi, has

WITH FUN, I WANT VALUES IN MY FILMS: THRINADHA RAO

irector Nakkina Thrinadha Rao delivered a massive hit with *Dhamaka*, starring Ravi Teja, which grossed more than Rs 100 crores. Now, the director is working on a smaller film, *Mazaka*, starring Sundeep Kishan and Rao Ramesh in lead roles. "I am comfortable with the story that I like, and I go with it," says Thrinadha Rao.

Many directors wait for years to work with a big star, but Thrinadha Rao takes a different approach. "I don't blame them for wanting to build their careers, but I follow my own methods. If I like a story, I go with it, even if it means working with new faces," he shares. Thrinadha Rao reveals that when he was making *Dhamaka*, writer

After I finished *Dhamaka*, Prasanna completed the story and dialogues. There wasn't much for me to change, except for a few improvisations when we went to the sets," says the director.

He further explains that the story was initially pitched to several people before finally being brought back to Rao Ramesh. "Prasanna had written the story with Rao Ramesh in mind. When we were looking for the lead actor, Sundeep Kishan agreed to take on the role, which was a great decision," Thrinadha Rao adds.

"Our film is about a father and son, which may lead people to compare it to the Malayalam film. However, both stories are completely different, and there is no connection between them," he clarifies.

Thrinadha Rao is optimistic about the film's prospects, noting that, much like the Sankranthi festival, Sivaratri also draws people to the theatres.
