Govt suppressing Opposition's voice: Appi Reddy **Denial of principal Opposition status is** blatant disregard for democratic norms

YSRCP MLC Lella Appi Reddy has criticised the coalition government for its authoritarian stance in denying YSRCP principal Opposition status in the Andhra Pradesh Assembly. Speaking to the media, he accused the government of suppressing the Opposition's voice and undermining democracy by refusing to recognise the YSRCP as the principal Opposition, calling it a blatant disregard for democratic norms.

He stressed that principal Opposition status is a responsibility, not a privilege, ensuring time to address public issues in the Assembly. Condemning the coalition's "venomous propaganda" for misrepresenting this role, he cited the Parliament Act of 1977, which mandates recognising the principal Opposition regardless of seat count. With three of four Assembly parties in the ruling coalition, he argued that the YSRCP, as the

sole remaining party, deserves the status.

Appi Reddy accused the government of lying in the Assembly and blocking discussion on public grievances, fearing YSRCP's scrutiny amid rising discontent over unfulfilled promises, Group-2 unemployment issues, chili farmers' struggles, and electricity charge hikes. He linked the denial of status to the coalition's inability to answer questions and hide governance failures.

Noting the YSRCP's effective Opposition role in the Legislative Council -- raising issues like vicechancellors' forced resignations and falsehoods in the Governor's address -- he said the government is rattled. He emphasised the Opposition's vital democratic role, warning that unilateral governance without accountability is dictatorial. Challenging the coalition's numerical excuse, he suggested that the Jana Sena Party exit the coalition if numbers were the criterion.

The already difficult path to Donkada becomes treacherous during the monsoon. "Travelling becomes extremely difficult," they said. "The path is full of pits and sharp rocks which we cannot see when it rains. Still, we have no but to continue commut.

Despite these hardships, there is a glimmer of hope. In 2023, the Department of Panchayat Raj and Rural Development approved Government Order Route Number 726, sanctioning a 1.5kilometre road from Karaka to Donkada at an estimated cost of Rs 1.35 crore.

"We hope the road work starts soon," a villager commented. "Road work for other villages like Chalisingam has already begun, so we remain hopeful that ours will commence as well. Once the road is built, many of our problems will be resolved automatically." The villagers are relying on this long-awaited infrastructure project to improve their lives and provide their children with access to education, breaking the cycle of poverty.

Despite intensified police surveillance, traffickers continue to employ covert strategies for transporting narcotics. Drugs are frequently smuggled via buses and trains, cleverly concealed in luggage and personal belongings. Furthermore, traffickers utilise encrypted communication and coded idenn methods, making it increasingly dif ficult for law enforcement to track and dismantle their networks.

"Smugglers employ coded systems, ensuring anonymity between importers and local suppliers," stated a senior police official.

Intermediaries remain unaware of recipients until transactions occur. Couriers follow specific instructions, meeting buyers at designated locations identified through dress codes or other markers. Buyers also adhere to these covert identification process-

Specific coded phrases, such as 'K' for cocaine and 'B' for brown sugar, further complicate efforts to trace suppliers. The drugs are frequently smuggled via buses and trains, cleverly concealed in luggage and per-

sonal belongings. Recent law enforcement actions underscore the severity of the issue. In one instance, a youth named Ranki was apprehended at Rama Talkies with 24.5 grams of cocaine, allegedly sourced from Goa and Bengaluru. Another arrest involved a Chennai-based

individual caught in Rushikonda selling MDMA powder and LSD chips. Similarly, an native was appr Sagarnagar attempting to deliver two grams of brown sugar. "A recent arrest of an Odisha-based indi-

vidual dealing in brown sugar highlights the severity of the issue," a police spokesperson said. Despite these successes, officials acknowledge that numerous traffickers remain active, operating within intricate networks that require continuous monitoring.

To combat this escalating crisis, law enforcement has enhanced anti-drug operations, implementing specialised intelligence systems in all police stations to swiftact on drug-related leads. Confusion, controversy cloud AU's TDR Hub admissions

Conflicting government directives leave students and faculty in a spot

PNS VISAKHAPATNAM

A cloud of confusion continues to loom over the admissions process at Andhra University's Transdisciplinary Research (TDR) Hub, following conflicting irectives from 1 Education Department. What began as an inquiry into alleged irregularities has now left students, faculty, and university officials in a state of uncertainty.

The TDR Hub, intended to foster interdisciplinary research, has become a hotbed of controversy amid allegations of hundreds of PhD candidates being admitted outside standard procedures. Initially, the university was ordered to proceed with pre-PhD exams and viva. However, a sudden intervention by government officials last month halted the process, demanding an inves-



tigation into alleged admission irregularities.

Many anticipated that the inquiry would reveal significant discrepancies, especially given reports linking a former senior official's associate to the controversial admissions. Yet, in a surprising turn, the university received verbal instructions just four days ago to resume the halted admissions. This abrupt reversal, within a mere four weeks, has deepened uncertainty and fuelled concerns about transparency.

"The situation is incredibly perplexing," a professor stated.
"We were asked to investigate, and now we're being told to proceed as if nothing happened. It undermines the entire process." The TDR Hub has faced more However, uncertainty persists any other department, with claims that standard procedures were bypassed for numerous admissions. Many believed the investigation should have concluded before further action.

Following the latest directives, university officials are now preparing to move forward with the admissions process for 685 candidates admitted through the Andhra Pradesh Research Common Entrance Test (APRSET). These candidates will be allocated to their respective departments, where the eligibility of their research guides

will be reviewed. Any ineligible guides will be replaced before pre-PhD exams and viva proceed. University officials confirm

that this process is underway. regarding those through the Research Common Entrance Test (RCET). Speaking to The Pioneer, Registrar Prof. EN Dhanamjaya Rao assured that all future actions will be in strict accordance with the Higher Education Department's instructions, once the new Vice-Chancellor takes office. The university now awaits the new leader to provide clarity.

The sudden shifts in policy have raised questions about the oversight of higher education in the region, and whether external pressures are influencing academic decisions.

EB-5s were created by Congress in 1990 to generate foreign investment and are available to people who spend about USD1 million on a company that employs at least 10 people.

Lutnick said the gold card — actually a green card, or permanent legal residency would raise the price of admission for investors and do away with fraud and "nonsense" that he said characterize the EB-5 program. Like other green cards, it would include a path to citizenship.

About 8,000 people obtained investor visas in the 12-month period ending Sept. 30, 2022, according to the Homeland Security Department's most recent Yearbook of Immigration Statistics. The Congressional Research Service reported in 2021 that EB-5 visas pose risks of fraud, including verification that funds were obtained legally. Investors' visas are common around the world. TDP chief rejects Jagan's demand for Opposition Leader status

Urges focus on legislative duties over procedural disputes

Telugu Desam Party (TDP) State president Palla Srinivasa Rao has strongly opposed former Chief Minister Y.S. Jagan Mohan Reddy's insistence on being officially recognised as the Leader of the Opposition. Addressing the media on Wednesday, Rao dismissed Jagan's demands, stating that the distinction between an Opposition Leader and a regular party leader is largely symbolic—offering little more than certain travel privileges, while all other allowances remain the

Rao highlighted a recent Assembly session where Jagan refused to participate unless his demand was met. The former Chief Minister's brief protest, lasting just 10 minutes before he exited the Assembly, was

ridiculed by the TDP leader. "If the people have already rejected his claim to this position, he should address those who denied him, not seek validation within the Assembly," Rao asserted.

Reaffirming democratic principles, Rao insisted that the Assembly's primary function is to represent the people's voice, regardless of formal Opposition status. He urged political leaders to focus on their legislative duties instead of engaging in procedural disputes. Drawing a historical comparison, Rao referenced the early years of the Bharatiya Janata Party (BJP), when it held just two seats in Parliament. He praised former Prime Minister Atal Bihari Vajpayee for effectively voicing the party's concerns without demanding official Opposition

The TDP leader further emphasised that the role of the Opposition is not dependent on formal recognition, but rather on a politician's ability to challenge and scrutinise government policies. Suggesting that Jagan's insistence may be driven more by a desire for flight ticket privileges than genuine concerns about opposition rights, Rao questioned whether the YSR Congress Party (YSRCP) chief would continue boycotting the Assembly if his demand

remained unmet. Rao urged Jagan to move beyond procedural disputes and focus on meaningful legislative engagement. "Rather than fixating on titles, he should participate in the Assembly, oppose policies that harm the people, and fulfil his responsibilities as a leader," he said.

Pass resolution opposing UGC proposal: **SFI**

SFI writes to CM that move could compromise autonomy of State universities

Student Federation of India (SFI) State president K Prasanna Kumar and general secretary A Ashok have written to Chief Minister N Chandrababu Naidu, urging him to pass a resolution in the Legislative Assembly opposing the University Grants Commission's (UGC) draft proposal concerning the appointment of vice-chancellors in uni-

The leaders articulated that the UGC's draft proposal seeks to standardise the selection process for VCs across Indian universities by introducing specific eligibility criteria and a uniform appointment procedure. However, they raised concerns that this initiative could compromise the autonomy of State universities and centralise authority, thereby restricting the involvement of State governments in the administration of higher education.

In their correspondence, Kumar and Ashok highlighted the necessity of safeguarding the independence of educational institutions. They called upon the Chief Minister to take a decisive stance against the proposal by enacting a formal resolution in the State legislature. They

believe that such a resolution would convey a robust message to the UGC and the Central government regarding the State's dedication to maintaining oversight of its educational matters.

Additionally, they criticised the UGC for neglecting the principle of reservation in the new proposal. They pointed out that the proposal permits candidates who have completed a Master's Degree with a minimum of 55 per cent but have not qualified for the UGC NET to be appointed as Assistant Professors in their respective

They expressed apprehension that the teaching standards might decline as a result of this proposal. The draft is perceived as a move towards the centralisation and privatisation of universities, which they argue would undermine the educational and decision-making systems currently under the jurisdiction of the State govern-

Additionally, it was stated that States including Telangana, Kerala, Tamil Nadu, and others are expressing their opposition to the draft proposal and have adopted resolutions in their respective legislative assemblies

Illicit liquor is believed to be intended for distribution during MLC elections

In a pre-election operation, authorities have dismantled an illegal liquor racket in Narsapuram, resulting in the seizure of a substantial quantity of illicit liquor believed to be intended for distribution during the MLC elections.

The operation, led by local law enforcement, culminated in the arrest of two individuals, Gollamandala Rajababu (35) from Kopparru village and Barre Jayaraju (42) from Narsapuram Town. The investigation began when officers seized two bottles of liquor (180ml) during a routine check, leading to the discovery of approximately 4,500 bottles of suspected spurious liquor hidden in an aqua farm nearby. Authorities suspect that the

liquor was part of a scheme to sway voters and investigations have linked the operation to

Venkataramana, Barre Chairperson of Narsapur municipality. It is alleged that Venkataramana, through her husband Jayaraju, procured substantial quantities of liquor for election purposes, with leftover stock being sold illegally.

Dr Kumareswaran, the West Godavari District Prohibition and Excise Officer, stressed that no one will be above the law, regardless of their influence. The raid was conducted under the supervision of SHO Rambabu, with support from Assistant Commissioner Prabhu Kumar and Assistant Excise Superintendent Prasad Reddy. Alakananda kidney racket worsens recipient's health

The illegal kidney transplantation racket exposed at Alakananda Hospital, Saroornagar, has had severe consequences for a recipient, leading to critical health complications.

Bhat Prabha, also known as Krupalatha, a nurse from Mangalore, had travelled to Hyderabad for a kidney transplant. However, following the bust of the illegal racket, she experienced kidney rejection and required specialised treatment at Nizam's Institute of Medical Sciences (NIMS) before being dis-

Prabha had been undergoing dialysis and was advised by doctors in Mangalore to undergo a kidney transplant. According to sources, adherence to prescribed medications is crucial for organ transplant recipients, as the body may reject a transplanted organ, considering it a foreign entity, much like the need for blood type compatibility in transfusions. Even kidneys donated by family members can sometimes face rejection.

Following the exposure of the racket, Prabha was taken to Gandhi Hospital.

However, due to the hospital's limited experience with high-risk transplants, she sought better medicare. Additionally, she was reportedly made to wait at a police station for hours, during which she missed critical medication and treatment. Given her financial constraints, she sought treatment at a government hospital and was eventually transferred to

Upon admission, her husband was in distress, and doctors discovered an infection around the transplanted kidney, leading to its rejection. At NIMS, specialised procedures such as a kidney biopsy and nuclear scan were conducted to assess the organ's condition. Through intensive medical intervention, the transplanted kidney was gradually stabilised, and within 15 days, her body began to accept

it. She was later discharged.

Despite spending Rs 50 lakh on the transplant, the family had to bear additional expenses of approximately Rs 1 lakh at NIMS for further treatment. They expressed gratitude to NIMS for providing advanced medicare, which would have been costlier at private hospitals. Without immediate intervention, Prabha could have lost her transplanted kidney

'Gross injustice to the Southern States'

KTR supports Stalin's statements on delimitation

BRS working president K T Rama Rao has raised serious concerns over the proposed delimitation of constituencies, calling it a major injustice to southern states. He warned that the Centre's plan to redraw constituencies based purely on population figures would be a curse for states like Telangana, Andhra Pradesh, Tamil Nadu, Karnataka, and Kerala. Supporting Tamil Nadu Chief Minister M K Stalin's objections, K T Rama Rao questioned whether the Modi government was punishing southern states for their success in population control.

He criticized the move, stating that redrawing constituencies without factoring in the contributions of southern states was against the principles of democracy and federalism.

He pointed out that in 1951, southern states accounted for 26.2 percent of India's population, which declined to 19.8 percent by 2022, while northern states like Uttar Pradesh, Bihar, Madhya Pradesh, and Rajasthan saw their population share increase from 39.1 percent to 43.2 percent. If Lok Sabha seats are allocated based on the latest census, he explained, Uttar Pradesh and Bihar alone would have 222 seats, while all five southern states together would get only

Emphasizing that southern states have consistently outperformed northern states in economic growth, human development, and population control, K T Rama Rao said it was ed.

unfair to penalize performing states while rewarding those lagging.

Instead of using population as the sole criterion, he suggested that economic contribution should be a major factor in the delimitation process. Telangana, he said, accounts for only 2.8 percent of the country's population but contributes over 5.2 percent to India's GDP. The same is true for other southern states, and this should be taken into account before redrawing constituencies.

Rio bats for Naga tribal court for timely justice

agaland Chief Minister Neiphiu Rio on Wednesday stressed the need for the promotion of traditional laws and the establishment of an apex tribal court for timely delivery of justice. Rio made the remarks during an address at the 'Sekrenyi festival-cum-Mini Hornbill' of the Angami Naga tribe in Kisama. He said the special protection and privileges accorded to Naga traditions and customs should be safeguarded and preserved. The chief minister said resolving internal disputes among the Nagas through tribal courts would prevent the need to approach the modern judiciary system and be economical, too. Expressing optimism that upholding customary practices would foster unity and harmony among people, Rio called on tribal bodies to cooperate with the state government in creating an apex court in the state. Rio said the Nagaland government intends to promote customary laws. The Nagaland government has already enacted the Village and Tribal Council Act, replacing the erstwhile Act, which will be implemented soon, he said.



ONOE will bring economic efficiency: Tripura CM

Tripura Chief Minister Manik Saha on Wednesday said 'one nation, one election' (ONOE) is the need of the hour for improving the country's administrative and economic efficiency. Speaking at an event here, Saha said, "Prime Minister Narendra Modi made efforts to implement ONOE in 2019, but was unsuccessful. However, last year the PM was able to get the Bills tabled in the Lok Sabha. If passed, it will strengthen administrative efficiency." Saha said holding elections for Lok Sabha, assemblies and civic bodies have become increasingly expensive. "More than Rs 60,000 crore was spent on the 2019 general elections. This rose to around Rs 1.35 lakh crore in 2024. Political parties also huge amounts to win elections. If this money is saved through simultaneous elections, the country's GDP will grow," he said. Saha asserted that the BJP had promised to implement ONOE in its 1984 election manifesto.



KVS suspends teacher for derogatory remarks

Disparities rising

One billion Indians have minimal purchasing power despite rapid growth says a Blume Ventures and Marcellus report

n a startling revelation about the state of the Indian economy, recent findings of a study highlight that nearly one billion Indians possess little to no spending power. According to a report by Blume Ventures— supported by insights from Marcellus Investment Managers—India's consumer market is undergoing profound structural changes, marked by deepening disparities and a shifting focus towards premium products for the wealthy. At the heart of the report is the disconcerting revelation that India's true "consuming class" is far smaller than what many might assume. The report identifies only about 130-140 million people as part of this active consumer base—roughly equivalent to the entire market of a country like Mexico. In addition, an extra 300 million Indians are categorised as 'emerging' or 'aspirant' consumers. The report underscores that India's consumer market is not broadening by adding new entrants into the wealthy segment; instead, it is deepening. In practical terms, while the overall size of the affluent popula-

tion remains relatively stagnant, the existing wealthy are growing even wealthier.

This trend of 'premiumisation' has seen brands pivot towards offering high-end, upgraded products that cater specifically to the rich. For example, ultra-luxury housing and premium smartphones are experiencing surging sales. In contrast, lower-priced alternatives are struggling. Affordable homes now represent a mere 18 per cent of the overall market. Moreover, the booming 'experience economy'-evident in the rapid sellout of high-priced concert tickets for international artists like Coldplay —further illustrates the evolving consumption pattern that favours upscale offerings over mass-

market products. A critical dimension of the report is its analysis of income inequality in India. The long-term trend of widening disparities has been stark. The top 10 per cent of Indians now control 57.7 per cent of the national income—a dramatic increase from 34 per cent in 1990. Conversely, the bottom 50 per cent have seen their share decline from 22.2 per cent to just 15 per cent. The affluent continue to prosper, while the majority of the population grapples with stagnant incomes, diminished savings, and mounting debt. The situation is particularly alarming for India's middle class. The report reveals that the middle 50 per cent of India's tax-paying population has experienced income stagnation over the past decade. The situation is alarming as financial savings are nearing a 50-year low. The insights from the report paint a sobering picture of the Indian economy. While the nation boasts rapid growth in certain sectors and an expanding base of emerging consumers, the benefits of this growth are unevenly distributed. The government must focus on strategies that not only promote growth but also ensure that economic gains are more broadly shared. Investments in education, upskilling and initiatives to revive the middle class's purchasing power will be crucial in steering India towards a more balanced and inclusive economic future.

The controversy surrounding Ranveer Allahbadia, also brings to the forefront, a critical constitutional debate - where do we draw the line between freedom of speech and responsibility in content creation? Article 19(1)(a) of the Indian Constitution guarantees the Fundamental Right to 'Freedom of Speech and Expression, but it comes with reasonable restrictions under Article 19(2), including public decency and morality. The focus must shift from merely advocating Fundamental Rights to instilling a deeper commitment to Fundamental Duties.

Article 51A of the Indian Constitution enshrines these duties, urging citizens to uphold the dignity of women, respect India's rich cultural heritage and and humanism. In today's digital age, where content creation holds immense power, social media influencers must be more aware of these responsibilities.

The recent incident - among many others in the past, though none as brazen - reflects a troubling cultural decline. The Changing Nature of Work

The rise of automation, AI, and robotics is shifting job requirements. The McKinsey Global Institute highlights that social, emotional, and higher cognitive bilities are becoming more critical while manual and basic cognitive skills are declining.

How antibiotic-free poultry empowered a mother and her community

By raising chickens with natural remedies instead of antibiotics, women in Uttar Pradesh are safeguarding their health and boosting their incomes

our-month-old Angel Singh is a post-term baby. Having been born after a ten-month pregnancy, many of her family members were afraid she would be weak and sickly. But Pinky always knew her child would be healthy despite being born a month after what is considered a normal nine-month pregnancy

Angel's weight and other health indicators at birth proved her mother right. Much of Pinky's confidence stemmed from the fact that she was regular with her antenatal checkups (ANC). She also focussed on a nutritious diet of leafy greens which she sourced from her small vegetable patch Uttar Pradesh's Samsa Tarhar village in Bahraich, the second

most backward district in India. As her pregnancy progressed, Pinky, a small poultry farmer, diversified her diet to include antibiotic-free eggs and poultry. This was to be a smart move.

Not only because it helped her stay healthy and increase her weight and haemoglobin levels, but more importantly, thanks to her poultry training, she was able to ensure whatever she ate was free of antibiotics. By using natural feed and herbal remedies while raising her chickens, she was able to cut the risk of developing antimicrobial resistance (AMR), a condition arising from the consumption of meat and eggs of poultry fed with at the back of her house in antibiotics to promote quick growth and prevent diseases. Just how critical this practice



SWAPNA MAJUMDAR was can be gauged from the worrying fact that, in 2019, over 297, 000 deaths in India were directly attributed to AMR. Moreover, the poultry environment has been a reservoir of multi-drug resistant bacteria according to the most recent study of four poultry farms in Uttar Pradesh by the Centre for Science and Environment which found rampant use of antibiotics for

growth promotion and disease prevention. The WHO recognizes the non-therapeutic use of antibiotics in feed and water in food-producing animals to contribute to the development of AMR in humans. Pinky realised this was possible only after she joined the backyard poultry (BYP) farming initiative to empower women and enhance food security and incomes implemented by the Aga Khan Foundation (ÁKF) under their aspirational district programme. After being trained by them in poultry farming techniques, biosecurity, and disease management using proven herbal and natural formulations to prevent the development of antibiotic resistance, Pinky, then in her second trimester of pregnancy, understood that the bene-



fits of being a poultry entrepreneur were more than just being economically empowered. "It was an opportunity to take charge of my own health and destiny and that of my unborn child," says Pinky. It is not just Pinky who is bringing

Like her, 60 women from marginalised communities in 120 villages in four blocks in Bahraich trained as poultry farmers by AKF are making a team. Yet, many died.

difference in their lives and communities through sustainable and ethical poultry farming practices after each was given 50 pre-vaccinated 21day-old Sonali breed chicks free along with support for feeding and constructing chicken coups. It was the AKF strategy to

impart rigorous, yet easy-tounderstand hands-on demonstration and training on using commonly found medicinal plants and herbs as alternatives to antibiotics that helped the women, mostly uneducated; understand the importance of adopting ethnoveterinary methods or traditional practices for treating animal health and illness. "I used to give antibiotics to keep my poultry healthy before I met the AKF

After joining their programme, I gave a health tonic of turmeric water mixed with jaggery, chirata for deworming and azola, a protein rich fern, to boost their immunity. None of my chicken fell ill," shares a Rambha Devi, a poultry farmer in village Samroha. Raghvendra Singh, AKF district coordinator, skill development, who is closely associated with the BYP programme, contends the 10 per cent mortality rate normally associated with chicks has come down to 4.5 per cent among the 3000 chicks given to AKF poultry farmers because of their use of natural feed and traditional herbal remedies.

Consequently, almost 90 per cent of their chicken was sold and the remaining was used for home consumption. The

health of families, especially children, consuming these antibiotic-free poultry and eggs, has improved say frontline health workers working in these villages. Further, an AKF evaluation shows that each poultry farmer made a profit ranging between Rs 10,000-14,000. This success has prompted the women to invest in another 50 chicks even if it means taking a loan from their self-help group as it will no longer be given free.

But this isn't stopping them, especially Pinky, who is buying 100 chicks. "The benefits I have gained from being a poultry farmer cannot be measured only in monetary terms. It has changed my life."

Worst over on India's growth trajectory: Report

The worst seems to be over for the Indian economy's growth trajectory, a German broker-

age said on Thursday.

GDP growth, which had slipped to a seven-quarter-low of 5.4 per cent in the September quarter leading to a lot of concerns over the economy's strength, is likely to

rise to 6.2 per cent in the December quarter, the report by Deutsche Bank said.

"We think the worst is over as far as India's growth trajectory is concerned but, even with the improvement of momentum, overall GDP growth is likely to remain below the potential growth rate of 7 per cent in FY26," the

bank's analysts said.

In the report which comes a day ahead of the release of official data on economic performance, the analysts also said that we have to be cautious about the forecasts as there can also be a revision in previous years' data.

The brokerage added that its leading indicator derived from 65 high-frequency indicators is also pointing towards a 6.2 per cent growth.

The Reserve Bank is likely to deliver another rate cut of 25 basis points at the upcoming review of the monetary policy in April to help growth.

Minutes of the last policy

reveal that all the members on the six-member monetary policy panel feel that rates remained at restrictive levels,



it said. After the April rate cut, RBI will focus more on the liquidity measures to ensure transmission of the 0.50 per cent repo rate cut to the real economy, it said, adding that more cuts are unlikely in the current cycle.

The central bank is already cognizant about the liquidity needs, and the recent USD 10 billion swap announcement is "encouraging", it said.

readout noted. It said the recent Indian investments in the UK valued at over 100 million pounds in total are expected to create hundreds of new jobs over the next three years in a range of sectors including AI, profes-

sional services and textiles. These investments are proof of global investor confidence of doing business in the UK, it said.

The trend of strong Indian investment into the UK in recent years is evident, with the last year-on-year change showing the value of inward FDI stock from India having increased 28 per cent at the end of 2023, the readout said.

India has remained the second largest investor in terms of number of projects into the UK for five consecutive years.

Minister for Investment Gustafsson said: "The new Indian investment proves that the government's Plan for Change is giving Indian businesses the confidence they need to continue investing in Britain."

"Now the UK will strive to be more ambitious and collaborative than ever before as we show the world why the UK is the best place to invest.'

On Monday, Reynolds and Commerce Minister Piyush Goyal announced the relaunch of talks on a free trade agreement between the UK and India that can support jobs and bring more growth across economies.

Gustafsson is visiting Mumbai and Bengaluru to bang the drum for Britain, champion free trade and promote exciting investment opportunities in the UK for Indian companies, the readout said.

Australia unveils roadmap to boost trade ties with India

Australia on Wednesday unveiled an ambitious roadmap to deepen its trade and investment ties with India, with Australian Prime Minister Anthony Albanese describing it as an attempt to find paths towards a better future for both sides.

There is no greater time to engage economically with India than now, Albanese said while launching the 'Roadman for Australia's Economic Engagement with India' at an event at Deakin University in Melbourne

Describing India as a "giant" on the world stage, he said the country continues to grow in stature. India is on track to be the third largest economy by the end of this decade and it is growing in ways that are complementary to Australia's own economy, he said.

Albanese called the



roadmap a "guide to seizing the enormous trade and investment opportunities of India's economic rise, one that is shaped and informed by the knowledge and experience gathered from 400 consultations in every state and territory, as well as in India.

That the roadman d give us detailed directions to the greater realisation of the potential of the Australia-India relationship. Successfully tapping that potential will be good for Australian business and Australian consumers," he said.

"It will help secure our supply chains in an uncertain world. And it will create jobs and growth," he noted.

The roadmap comes over two years after India and Australia firmed up the Economic Cooperation and Trade Agreement (ECTA). Both sides are now working towards a mutually beneficial Comprehensive Economic Cooperation Agreement

The roadmap also identifies ties to focus and accelerate Australia's engagement with India in several areas such as defence industries, sports, culture, space, and technology.

Kickstarting the implementation of the roadmap, Canberra announced investing USD 16 million in an Australia-India Trade and Investment Accelerator Fund, which will help Australian businesses unlock new commercial opportunities in India.

Equity markets came under bear attack from last October onwards after smashing many record high levels.

A correction of this magnitude is usually triggered by a combination of factors. Investor sentiment was tempered when a number of large corporations reported lower-than-expected Q3 results. Furthermore, the Indian stock market faced a difficult environment due to Trump's tariff threats and worries about India's slowing economic growth, which caused international investors to keep







Researchers measured blood sugar responses in healthy volunteers (non-diabetic, within a healthy BMI range) using two methods -- a CGM and the gold standard finger-prick test -- to assess the accuracy of CGMs in fruit-based products. ranging from whole fruit to smoothies. The CGM consistently reported higher blood sugar levels compared to finger-prick tests. When participants consumed a smoothie, the device

overestimated the GI by 30 per cent, reporting a GI of 69 (medium) compared to the traditional test result of 53 (low). Whole fruit was misclassified as medium or high-GI foods by CGMs, while the finger-prick test showed they were low-GI. This could lead users to mistakenly believe that fruit could cause harmful spikes in blood sugar.

The research also debunked the common myth that blending fruits into a smoothie raises their Gl. Whether eaten whole or blended, fruits like apples, bananas. mangoes, and oranges remained low on the GI. CGMs are unlikely to be a valid method to determine whether a food has high or low GI, said the researchers. Gonzalez said the CGMs may be inaccurate because they measure alucose in the fluid surrounding your cells, not directly in your blood. "This can lead to discrepancies due to factors like time delays, blood flow, and how glucose moves between different parts of the body."

Last November, submitted a 'Letter of Intent' to host the 2036 Olympic and Paralympic Games, to the International Olympic Committee's (IOC) Future Host Commission, taking the first concrete step in an ambitious plan after months of informal dialogue with the

Under the Scheme of Assistance to NSFs, the national sports federations are assisted for several purposes such as organising tournaments inside the country, participation in international tournaments organised abroad, purchase of equipment, organising coaching etc.

Among other things, the NSFs also take care of the requirements for customised training of top level and promising sportspersons.

In the latest annual budget, the NSF's will be entitled to a ₹400 Crore assistance from the ministry, which is a marginal increase from the ₹340 Crore allocated last year. The specifics of the committee's mandate are not mentioned in the ministry circular.

But its formation comes a few weeks after a top ministry source told PTI that a graded system of funding was being mulled. Under this system only those NSFs which comply with the good governance norms of the draft national sports bill will be entitled to their full share of the ministry grant.

"If you are fully compliant with the good governance provisions than you get your entire share but if it is not the case then there could be cuts when such a system comes into effect. But it is only an idea under consideration as of now," a source in the sports ministry had said.

"The implementation can greatly improve transparency performance of the NSFs," he had insisted.

ICC clears bowling action of Matthew Kuhnemann

Australia's left-arm spinner Matthew Kuhnemann, who was reported for an illegal bowling action during the second test against Sri Lanka last month, has been cleared by the ICC after undergoing extensive testing in Brisbane. The development means Kuhnemann will be able to resume playing for Australia in the test tour of the Caribbean New Zealand batters Will Young (up eight places to 14th) and Tom Latham (up 11 places to 30th) have scheduled later this year.

"Kuhnemann's action has now been deemed to be legal and the left-arm spinner will continue to bowl in international cricket," the ICC said in a statement.

The 28-year-old Kuhnemann had undergone an independent bowling assessment at the National Cricket Centre in



Brisbane, where it was revealed that the amount of elbow extension for all his deliveries was within the 15-degree level of tolerance permitted under the ICC Illegal Bowling Regulations, the apex body

Despite being called for his action, Kuhnemann played a pivotal role in Australia's 2-0 series victory in Sri Lanka, bagging 16 wickets at an

average of 17.18. Cricket Australia (CA), on its part, too said Kuhnemann is now free to continue playing international cricket.

Ben Oliver, CA executive general manager national teams, said: "We are pleased for Matt that this matter is now resolved. It has been a challenging period for Matt however he has carried himself exceptionally well. "He has had the full support of

Australian cricket and he can now move forward to the next phase of his international career with great confidence." After the test series in Sri

Lanka, match officials asked for an independent assessment of Kuhnemann's bowling action. The ICC allows bowlers a maximum of 15 degrees of flex in their bowling arm, and anything beyond that is deemed illegal. The spinner, who made his Test debut for Australia in 2023, has 25 wickets to his name so far from five matches. Kuhnemann will be available for selection for the three-Test series in the West Indies across June and July.

MAZAKA DOESN'T REALLY BRING MUCH OF ITS

'MAZA', BUT RAO RAMESH NAILS THROUGHOUT

irector Nakkina Thrinadha Rao and writer Prasanna Kumar Bezawada, known for delivering hits like Nenu Local and Dhamaka, have joined forces once again for Mazaka, which was released on the occasion of Maha Shivratri. The film stars Sundeep Kishan and Rao Ramesh in lead roles, marking Sundeep Kishan's 30th film. Ritu Varma plays the female lead, while Manmadhudu fame Anshu makes her comeback after many years. Here's a look at the film's story and how it fares.

Venkata Ramana (Rao Ramesh) and his son Krishna (Sundeep Kishan) belong to a middle-class family. Venkata Ramana is searching for a bride for Krishna, but no one is willing to marry him because there is no woman in the household. A marriage broker advises Venkata Ramana to remarry first, as it would make it easier to find a match for his son.

One day, Venkata Ramana sees Yashodha (Anshu) and falls in love with her at first sight. He wants to marry her, but Yashodha has plans to move to the USA. Meanwhile, Krishna also falls in love with a college girl, Meera (Ritu Varma). Both father and son try their best to win over their respective love interests, but a major twist occurs when Bhargav Varma (Murali Sharma)

enters the picture.

Bhargav Varma sets a condition that both father and son must fulfill if they want to marry the women they love. What is this condition? How is Bhargav Varma related to Yashodha and Meera? Will Venkata Ramana and Krishna finally get the family photo they dream of with the women they love? The film unravels these questions in an entertaining manner.

Director Nakkina Thrinadha Rao has a track record of delivering successful entertainers like Cinema Choopista Mava, Nenu Local and Dhamaka. Writer Prasanna Kumar Bezawada has collaborated with him on multiple projects and their com-

bination has generated curiosity about *Mazaka*. Several films in the entertainment genre have lately prioritised comedy over logic, aiming purely to



amuse the audience. Mazaka follows the same formula—it focuses on entertainment but lacks logic. Unfortunately, Prasanna Kumar seems to have lost his touch with the screenplay. Interestingly, this story was in circulation for years before finally landing in Rao Ramesh's hands. Prasanna initially wrote the script with Rao Ramesh in mind and later, Sundeep

Kishan was added as the lead actor. The core plot is simple—a father and son both

fall in love and want to marry their respective partners, but an obstacle stands in their way. The first half is engaging, with Rao Ramesh's love story adding freshness to the narrative. Typically, films focus on a young hero trying to impress a girl, but here, a middle-aged man pursuing romance brings novelty. The chemistry between Sundeep Kishan and Ritu Varma is also well-developed in

However, the film falls apart in the second half. The conflict between Anshu and Ritu Varma's characters lacks depth and is based on an unconvincing, almost silly, premise. Several scenes feel unnecessarily dragged, making the second half sluggish. One standout moment is the emotional kitchen scene between Rao Ramesh and Ritu Varma, which adds some weight to the narrative.

On the downside, certain comedy scenes, espe-

cially those involving Jabardasth Rohini, Anshu and Rao Ramesh, are poorly executed. The interactions between Rao Ramesh and Anshu in the latter half feel artificial, failing to evoke the intended impact. While the climax has some redeeming moments particularly the wedding scene featuring Sundeep Kishan and Hyper Aadhi, which, despite being rem-iniscent of Atharintiki Daredi, manages to entertain—the overall storytelling falls short.

PERFORMANCES

Rao Ramesh steals the show. Though some might find his performance over-the-top, his role demands a loud and energetic portrayal, which he delivers effectively. His comedic timing, especially in the first half where he tries to impress Anshu, adds to the film's charm. However, his chemistry with Anshu lacks conviction.
Sundeep Kishan plays a role that suits him well,

delivering a solid performance. Ritu Varma is adequate, while Anshu looks beautiful but fails to impress with her expressions. Murali Sharma gets a meaty role after a long time and does justice to it. Hyper Aadhi and Srinivas Reddy manage to generate a few laughs. Ajay, who plays a police officer, starts off well but becomes loud and irritating in the latter half.

TECHNICAL ASPECTS

Technically, the film is average. The cinematography by Nizar Shafi is decent, but Leon James' music is a major letdown. The last two songs, along with their choreography, fail to leave an impression and are a significant drawback. The dialogues, however, provide some comic relief, with well-placed punchlines aimed at mass audiences.

Mazaka offers entertainment but only in bits and pieces. The Nakkina-Prasanna duo seems to have lost their magic touch, especially in the second half, which drags down the film. While the story has potential, weak execution and lack of a strong conflict dilute the impact. The film redeems itself slightly with its ending, but overall, it fails to be a consistent entertainer.

Rao Ramesh is the film's biggest asset, and his performance alone makes *Mazaka* a watchable, timepass entertainer. However, the film could have been much better had the makers paid more attention to strengthening the second half.
