Congress promises ₹8,500 to educated unemployed youth

n the run to lure the voters by offering 'monetary' benefits, LCongress on Sunday unveiled the 'Yuva Udaan Yojana,' a scheme promising a highest ever monthly allowance of Rs 8,500 to educated but unemployed youth for one year if they come to power in the national

The move, designed to address the growing issue of unemployment among educated youth, comes as a big announcement with Congress likely being the first political party in the country to offer such substantial financial support as part of their employment strategy.

Leader of Opposition in Lok Sabha Rahul Gandhi is also making his first appearance for campaigning for the party at Seelampur on Monday, ending speculations that there is a rift between the national and state leadership. He will address a 'Jai Bhim-Jai Samvidhan' public meeting in East Delhi

Congress is vying to come back to power since 2013 when AAP rose to power. This is the third scheme launched by the party ahead of the Delhi Assembly polls. AICC general secretary and former Deputy Chief Minister of Rajasthan Sachin Pilot, at a press conference, said, "It is the government's responsibility to support our young and educated friends living in Delhi. If the youth gets discouraged, then it is not a good thing for the country. Therefore, we have decided that after the formation of Congress government in Delhi, educated and unemployed youth will be given one year apprenticeship and financial assistance of Rs 8,500. 'We will provide financial assistance

to youths who can show their skills in a company, factory or organisation. They will get money through these companies. This is not a scheme under which one will get money while sitting at home," Pilot said.

Dhaka opposes India's border fencing

m Sunday}$ Secretary Md. Jashim Uddin on Sunday expressed Bangladesh's "deep concern" over the recent border tensions during a meeting with Indian High Commissioner Pranay Verma at the Foreign Ministry here. The state-run BSS news agency earlier reported that Verma was "summoned" by the foreign ministry to discuss escalating tensions along the border. However, a press statement issued by the foreign ministry did not use that term.

Foreign Secretary Ambassador Md. Jashim Uddin today expressed deep concern of Government of Bangladesh to the High Commissioner of India Pranay Verma at his office at the Ministry of Foreign Affairs over the recent activities of the Border Security Force (BSF) of India along the Bangladesh-India Border," the foreign ministry said in the statement. Verma entered the foreign ministry around 3:00 pm (local time). His meeting with the foreign secretary lasted about 45 minutes, BSS reported.

"I just met Foreign Secretary to discuss India's commitment to ensuring a crime-free border, effectively addressing challenges of smuggling, movement of criminals and trafficking," Verma told the media after emerging from the



"We have an understanding with regard to fencing the border for security. BSF and BGB (Border Security Force and Border Guard Bangladesh) have been in communication in this regard. We expect that understandings will be implemented and there will be cooperative approach to combatting crime," he added.

The development came hours after Dhaka alleged that India was trying to construct fences at five locations along the Indo-Bangla border, violating a bilateral agreement.

The foreign secretary "stressed that such activities particularly the unauthorised attempt to construct barbed wire fencing and the related operational actions by BSF, have caused tensions and disturbances along the border," the

Foreign Investors sell ₹22,194 Cr in Indian stocks

Foreign investors have withdrawn Rs 22,194 crore from Indian equities this month, driven by expectations of a weak earnings season, a steady rise in the US dollar, Donald Trump's presidency.

This came following an investment of Rs 15,446 crore in the month of December, data with the depositories showed.

Foreign investors have scaled back their investments in Indian equities significantly amid global and domestic headwinds.

"This exodus of foreign money from the Indian markets could be attributed to multitude of factors, such as expectation of yet another weak earning season, concerns over the tariff war under Trump's presidency, slowdown in GDP growth, still high inflation numbers and uncertainty over commencement of the interest



cut in India," Himanshu Srivastava, Associate Director Manager Research Investment Morningstar

Research India, said.

Additionally, record low level of Indian rupee, surge in US bond yields coupled with rich valuation of Indian markets also makes Indian equities relatively unattractive for foreign investors. According to the data, Foreign Portfolio Investors (FPIs) offloaded shares worth Rs 22,194 crore from Indian equities so far this month (till January 10).

FPIs have been sellers on all trading days except January 2. 'The single major reason for the relentless selling by the FPIs is the steady rise in the dollar index which is above 109 now. The surge in the 10year bond yield to above 4.6 per cent is ensuring capital flows from emerging markets like India," V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said.

KOLKATA: West Bengal government has notified new speed limits for vehicles, ranging from 10 km to 50 km per hour depending on school and market areas, across the state to reduce road accidents. The speed limit on all urban and non-urban roads passing through market and residential areas with significant interactions between motor vehicles and people has been restricted to 30 km/hour to keep the risk of fatality within 10 per cent

This policy might save others from similar pain." The initiative is not new; it was tried in Gautam Buddh Nagar in 2019 but wasn't strictly enforced. This time, officials are determined to ensure compliance across all 75 districts. Regular reviews will be conducted, and

Kolkata, Bengaluru, Pune slowest in traffic globally

Three of the works to cities in terms of traffic speeds Three of the world's 10 slowest are in India. The 2024 TomTom Traffic Index has put Kolkata, Bengaluru and Pune among the top five slowest cities in the world. After Barranquilla in Colombia,

Kolkata was the second most congested city in the world in 2024, and the most congested in Asia, followed by Garden City Bengaluru slipped to the second spot, Pune rounded up the top three. Last year, Bengaluru was India's most congested city.

Surprisingly Delhi was ranked much lower this time. It ranked 122 in the list. Last year, Delhi was ranked 44th in the world. According to the latest survey by

the Netherlands-based location

technology firm TomTom on traffic and congestion on roads, drivers in the city spent an average of 34 minutes and 33 seconds to travel a distance of 10 km. The percentage of congestion is 32. Kolkata was followed closely by Bengaluru, where drivers spent 34 minutes and 10 seconds to cover 10 km. The level of congestion is 38 percent Pune finished third with a travel

time of 33 minutes and 22 seconds for the same distance, leaving India with three cities in the global top five. The level of congestion here is The report says drivers wasted 117

hours in a year in traffic in Kolkata, 110 hours in Bengaluru and 108 hours in Pune due to traffic congestion. The TomTom, annually evaluates



traffic conditions in major cities worldwide, and this year's report has placed Kolkata, Bengaluru and Pune among the worst for traffic flow. The differences in travel times (or average speeds) across cities much lower, with an average travel

European city retained its spot at 5th position as the most congested city, with an average speed of 14 km/h. Other major cities like Dublin (16 km/h), Milan (17 km/h), Lima (17 km/h), and Toronto (18 km/h) were also reported to have slower average speeds than three cities Kolkata Bengaluru and Pune underscoring the widespread issue of urban traffic congestion.

Clouds are expected to persist in Bhopal throughout the day. According to Meteorologist VS Yadav, a rain alert has been issued due to the Western Disturbance, which will temporarily raise both day and night

temperatures.

temperatures are expected to drop again in the next two days. In Narmadapuram, intermittent rain has been observed since early morning, and Tikamgarh also experienced light drizzle starting at 6 am. On Saturday, many districts remained cloudy, including Betul, Harda, Khandwa, Shivpuri, Gwalior, Datia, Bhind, Morena, Sheopur, Chhindwara, Seoni, Chhatarpur, Tikamgarh, Niwari, Katni, and Damoh, leading to a drop in day-

time temperatures. After several days of icy winds which caused a severe cold spell during the past four nights, the cold wave temporarily eased on Saturday, resulting in higher day and night temperatures. The Meteorological Department predicts that the cold will increase again due to melting snow from

Jammu and Kashmir, Himachal Pradesh, Uttarakhand, and Ladakh, and stronger winds are expected, with the jet stream reaching speeds of up to 240

Rain and fog blanket MP amid fluctuating temperatures and cloudy skies

While the weather is forecast to be clear today with no rain expected, on January 14, Bhopal, Rajgarh, Agar-Malwa, Mandsaur, Neemuch, Sheopur, Gwalior, Morena, Bhind, Datia, and Shivpuri will remain cloudy, and drizzle may occur in some areas. The day temperatures in various regions were recorded as follows: Gwalior (21.2°C), Pachmarhi (22.7°C), Raisen (24.2°C), Narsinghpur (23°C), Rewa (24°C), Naugaon (24.8°C), Satna (25°C), Sidhi (24.2°C), and Malajkhand (24.8°C). Many other areas, including Umaria, Seoni, Jabalpur, Damoh, Bhopal, Narmadapuram, Indore, Khandwa, Khargone, and Ujjain, saw temperatures above

On Friday-Saturday night, the lowest temperatures were recorded as 4.5°C in Kalyanpur (Shahdol), 5°C in Rewa, 5.4°C in Mandla, and 5.6°C in Amarkantak. Among major cities, Jabalpur had the lowest temperature at 7.5°C, followed by Bhopal (8.5°C), Gwalior (9.5°C), Ujjain (11.8°C), and Indore (14.2°C). The cold has been particularly intense this year, breaking records in both November and December. highest increases. Bhopal, for instance, saw its cold-

est November in 36 years, and cities like Indore, Ujjain, Jabalpur, and Gwalior experienced temperatures 7°C below normal. December was even colder than January across the state, with a cold wave lasting nine days and breaking a 58-year record in Bhopal. As a result, school timings were adjusted in several districts, and heaters were installed in Bhopal's Van Vihar National Park to protect animals from the cold.

In the last 24 hours, rainfall was recorded at isolated locations in Bhopal, Indore, and Jabalpur divisions, with a few areas in Narmadapuram, Gwalior, and Sagar divisions also receiving rain. Chambal division saw the heaviest rainfall, while other divisions remained dry. The day temperatures in most divisions remained above normal, with Shahdol and Sagar divisions recording the

Night temperatures rose appreciably in several districts, including Bhopal, Narmadapuram, Rewa, Jabalpur, Shahdol, and Sagar. Moderate fog was reported in Bhind, Morena, Gwalior, Sheopur Kalan, Mandsaur, Neemuch, Ratlam, and Agar districts, while shallow fog was observed in areas like West Shivpuri, Ujjain, Shajapur, Rajgarh, Bhopal, Guna, Chhatarpur, Panna, Mauganj, North Satna, Sagar, and Vidisha.

A video showing him falling from the building has surfaced, and the ATS claims he jumped from the third floor of an OYO hotel, which led to his death. However, a magisterial inquiry has raised significant doubts, revealing that Himanshu was illegally detained in the hotel room. The magistrate has criticized the illegal detention, deeming it a serious act of negligence. Additionally, the injuries on his body have been

Based on the inquiry's findings, Sohna City Police Station has filed a murder case against nine Madhya Pradesh ATS officers. Himanshu's family maintains that he was murdered, and his body was thrown from the building. Himanshu was arrested by the

MP ATS on January 6 on charges of terror funding. After his arrest, he was taken to a hotel in Sohna City, Gurugram, where three other accused individuals were already being held. The following day, during interrogation, Himanshu allegedly jumped from the third-floor gallery, claiming he needed to go to the bathroom.

Typically, detainees are kept under strict surveillance, but Himanshu was able to open the balcony gate and jump. The key question remains: why did the ATS team not intervene to stop him?

ardiac arrest cases have recorded a spurt since the ✓arrival of cold weather this year, prompting medical practitioners and district administrations to release advisories for high-risk groups. A young man who arrived at the

Sevashram Old Age Home in Gwalior in search of his missing father, suffered a sudden heart attack. The staff present at the facility immediately performed CPR and saved his life. A medical student from Bhopal, visiting Pachmarhi with her friends, died of a heart attack on December 30.

On November 18, Shanu, a resident of Nishatpura, died of a heart attack while drinking alcohol.

An engineer from Sarvadharma Colony died of a heart attack while taking a morning walk on October 30.

Medical research suggests that the oxygen demand of the body remains high during the winter season. The metabolic activity of the cells increases to keep the body warm, which in turn increases the oxygen demand. In such a situation, the heart has to work twice as hard to pump blood. This causes fluctuations in blood pressure, with the arteries constricting and dilating according to the body's needs. If there is a cholesterol blockage in any artery, the oxygen supply is affected, and cardiac function decreases, which can lead to cardiac arrest and

Experts say special care for the heart is required in the winter, as it brings many potential risks for heart patients, along with

cold and cough. Heart patients should avoid strenuous activities in the winter, as running or brisk walking in harsh, cold weather can

cause exertion, thereby increasing the oxygen demand on the heart. People with arterial blockages may not be suited for such strenuous outdoor activi-Furthermore, stepping out into

the cold is also dangerous because it can cause the blood vessels to constrict, blocking blood flow and causing the skin to turn blue due to a sharp drop in oxygen levels. This situation is known as a vasospastic attack.

Wearing excessive clothing to avoid the cold can also be harmful, as your body will need to release heat when it becomes overheated. Too much warm clothing can prevent that from happening and cause the blood vessels to dilate. This may cause a significant drop in blood pressure, triggering a heart

Influenza may be seen as a minor issue lasting only two to

four days, but it can actually be dangerous for heart patients. Due to the cold, fever may occur, which increases the oxygen demand of the body. Your blood pressure may also drop below normal due to dehydration, which reduces the oxygen supply to the heart muscle. The lack of oxygenated blood can cause a heart attack during

winter. Hypothermia and angina can also be factors contributing to heart attacks in cold weather. Symptoms of hypothermia include shivering, fatigue, exhaustion, drowsiness, and slurred speech.

Hypothermia occurs when the body loses heat faster than it can generate it, causing the body temperature to fall below the normal range of 98.6°F (37°C). In hypothermia patients, the body temperature can drop below 95°F (35°C). Angina, on the other hand, can

that lasts several minutes, a squeezing pressure in the chest, tightness or heaviness in the chest, sweating, and shortness of breath. Angina itself is a symptom of coronary artery disease, which occurs when the heart does not receive enough oxygenated blood. New book reveals inside story of G20 negotiations

An hour before the start of the G20 Summit here on September 9, 2023, Prime Minister Narendra Modi asked Sherpa Amitabh Kant the status of the leaders' declaration and when told there were some issues, he asserted he just wanted to see the result - a "consensus" - very soon.

Kant immediately went into a huddle with fellow Sherpas and managed to secure the final agreement.

These behind-the-scene happenings find mention in Kant's new book "How India Scaled Mt G20: The Inside Story of the

G20 Presidency". India had pulled off a big diplomatic win after the G20 summit adopted a consensus declaration overcoming major differences on the Russia-

Ukraine war. Modi made the announcement about a consensus on the 37page declaration and its subsequent adoption at the start of the second session on the opening day of the two-day summit of the grouping of major developed and developing countries.

Kant says the journey from the principles to the final draft of the NDLD (New Delhi G20 Leaders' Declaration) was, however, far from smooth.

'The text continued to face constant revisions and objections after 300 hours of negotiations over 250 bilateral meetings. The weight and seriousness of the negotiations were felt by all participants, but the pursuit of a mutually agreeable outcome still seemed far from reach," he writes in the book, published by Rupa.

The government wants to establish a permanent framework to continue the work of district agrometeoro-logical units (DAMUs), which had been operating in an adhoc manner until their closure last year, Ministry of Earth

PTI had reported in August last year that the government intended to revive DAMUs, which provided block-level weather-related information to lakhs of farmers, before their closure last year following recommendations from Niti

Ravichandran has said.

"As part of the pilot project, the Earth Sciences Ministry and the Agriculture Ministry provided weather information to farmers. Agricultural meteorologists in DAMUs analyze how weather conditions will affect crops. Their primary role is to offer advice to farmers. The system functioned well, but it should not remain ad-hoc; it needs to be made permanent," Ravichandran told

He said the government wants to establish a solid framework to carry out this vital work.

An official source told PTI that the Earth Sciences Ministry has also written to the Prime Minister's Office about the importance of reviving DAMUs and also voiced concerns related to their closure. Asked whether financial constraints were the main reason for winding up the project, the

source dismissed it as a "misunderstanding".

It was earlier reported that the Ministry of Earth Sciences wanted the Agriculture Ministry to bear the expenditure for DAMUs.

A total of 1,176 CCTV cameras have been installed at nine stations in the Prayagraj region to provide live feeds for realtime monitoring viz monitoring structures like platforms, stations. The War Room will facilitate effective coordina-

tion between district authorities and railway officials, ensur-

ing immediate assistance and operational efficiency. Further a multilingual

Bangladeshi migrants obtaining documents illegally in Maharashtra is 'vote jihad part 2', says CM Fadnavis

Maharashtra Chief Minister Devendra Fadnavis on Sunday said Bangladeshi migrants seeking birth certificates illegally in the state to obtain voting rights was "vote jihad part 2". Fadnavis, during the November assembly poll campaign, had cited instances of a community voting en masse against the BJP in the Lok Sabha elections held earlier in 2024, and had termed this as "vote jihad" Speaking at the State BJP's

convention in Shirdi in Ahilyanagar, Fadnavis said, "Bangladeshi infiltrators are seeking birth certificates in Maharashtra as part of vote jihad part 2. Nearly 100 such cases have been reported in Amravati and Malegaon tehsil in Nashik. These people, many aged around 50 years, are obtaining documents illegally. Not a single infiltrator will be allowed to stay in Maharashtra,



He said his Government is committed to combating anarchist forces attempting to create caste-based and communal divisions and urged people to stay vigilant and ensure this resolve is strengthened. Reflecting on the BJP's stellar performance in the November assembly polls, he hailed Prime Minister Narendra Modi and Union Home Minister Amit Shah for guiding and instilling confidence among party workers after the setbacks faced in

the Lok Sabha polls. "In the last 30 years in Maharashtra, the BJP is the only party which crossed the 100-seat mark in three consecutive polls (2014, 2019 and 2024). PM Modi's leadership gave us confidence and BJP got 132 seats with strike rate of 89 per cent," he said. Only Sanatani shopkeepers in Kumbh please: Sadhus check shopkeepers' Aadhaar Cards

n a significant move to ensure that only Sanatani Hindus could set up shops in Kumbh Mela, sadhus have taken it upon themselves to scrutinize the ating within the fairgrounds. Under the leadership of Mahamandaleshwar Computer Baba of Digambar Ani Akhara, a dedicated task force of saints is actively checking Aadhaar cards to verify the identity of vendors. Over the past three days, this initiative has led to the expulsion of 32 shopkeepers who failed to provide valid identification.

The Sant Task Force, comprising 1,500 saints, is conducting daily inspections across camps and shops in the Mela area. Shops selling food items, puja materials, fruits, blankets, and tea are being monitored. Saints patrol from 10 a.m. to noon and again from 4 p.m. to 5 p.m., ensuring compliance with their directive. "We want to keep the Kumbh free from individuals who may disrespect or defile its sanctity," said Computer Baba. The Akhil Bharatiya Akhara Parishad, the apex body of Hindu saints, has been vocal about barring non-Sanatani individuals from setting up shops in the fair area. Their demand stems from concerns about incidents where food items were reportedly defiled by



sellers spitting on them. Saints have reiterated their stance that only Hindus, Sikhs, Buddhists, and Jains should be allowed to operate within the premises.

This is not about exclusion; it is about preserving the sacredness of the Maha Kumbh," said Acharya Maheshwaranand Giri, a prominent leader of the Akhara Parishad. "We cannot allow actions that could tarnish the spiritual experience of millions of devotees."

Shopkeepers found without Aadhaar cards are immediately asked to leave, with their details handed over to local police for further action. "This initiative is not just about identity verification but also about ensuring that the ethos of the Kumbh is upheld," said Mahant Swami Gyananand of Juna Akhara.

The Mela area, which hosts stalls for millions of pilgrims, is a bustling marketplace with vendors offering everything from hot tea to devotional items. However, the saints have expressed concerns over potential misuse of this sacred space by individuals who may not respect its spiritual essence. The task force has been work-

ing in coordination with local law enforcement to prevent any disturbances. Police officials have acknowledged the saints' efforts as a means of maintaining order and safeguarding the sanctity of the event.

A Safer and Cleaner Kumbh As preparations for the Maha Kumbh 2025 move into full swing, authorities have also ramped up measures to ensure the safety and convenience of devotees. Saints and organizers alike believe that such initiatives will contribute to a more spiritually enriching and harmonious experience for pilgrims.

NDA to boycott **Feb 5 Tamil Nadu** bypoll: BJP chief

"The coming 2026 Assembly polls is one meant to remove the DMK (from the ruling saddle) and the NDA is moving towards that target and does not want to allow the DMK to confine people like



cattle once again," he said in a statement.

'All the leaders of NDA who desire people's welfare, after detailed consultation, have decided to boycott the Erode East bypoll. Our target is to remove the DMK in the 2026 elections and give the NDA's good governance to people, Annamalai said.

The state has been pushed to a "dark period" with no safety for various sections of society and the DMK government was an "anti-people" one where law and order has also failed, the former IPS officer alleged. NDA constituents in the state include Pattali Makkal Katchi (PMK).

reeling of deprivation dominates life, one should not be surprised by this statement and this applies to all of us with some exceptions. You have guessed it. These fortunate souls are devotees of God. Let me substantiate what I have stated.

Do you agree that we have many unfilled desires; all of us have? Some of these are deep desires; those remain unfulfilled throughout our lives. The first one is to have plenty of money. What is plenty? Yes, it varies from person to person, but don't we change the quantum? I have done it throughout my life. What I had hoped for when I was a child has been exceeded many times over, but I still feel that more is what will really please me. By the way, I am one of those fortunate souls, whose needs have always been fulfilled, barring a few short spans. An extreme example is that of having a cycle and desiring a scooter. Once that is obtained, a car will be nice to have. This goes on till one gets to desire a private jet.

Then, come sexual feelings. From childhood, these feelings are never far away from our thoughts. And these are fanned by what we are exposed to by ads and what we choose to associate with like going on internet. Even children do so and giggle with friends. One may question why this feeling is so widespread. Because the creation can only be sustained by procreation. Even Lord Krishna has allowed this activity when He stated in the Bhagavad-Geeta, "I am passion in beings, according to religious principles," (7.11) But what human beings do not even animals do, i.e. make sex an overpowering urge. Even marriage does not satisfy it, though one feels in childhood that it would. Because sexual acts have a purpose, and cannot be made a burning



The third enemy of us human beings are fearful thoughts. The underlying reason is our being small, very small in the overall context. We are also mostly ignorant, i.e., do not know what is good for us. Our intelligence is mostly flawed. There is spiritual intelligence, which is what the Bhagavad-Geeta is all about. Don't we avoid reading it? Because it will expose how little we know. This feeling of safety can only come from God, because only He can ensure it. Unfortunately, most of us avoid taking shelter of God, even though we know about

Why don't we? Whatever we may say we really don't have much faith in God. Most of us feel that God is superior to us but not someone we must take shelter of, though God is everything. (7.19) Then, spiritual practices are considered utterly boring. Do we feel that they should be enjoyable like watching television? They are 'tapa' (austerities), as they should be. Our deeply embedded emotions like greed, lust and enviousness would not let us take shelter of God. The feeling that we can manage on our own also defeats us, even though we keep failing repeatedly in whatever we wish to achieve.


But everyone is not unintelligent. Many do take shelter of God and would never have second thoughts. Isn't this proof enough that they must be getting rewarded. Yes, God begins to guide and help them. One would know what is really desirable like peace, not unlimited sense enjoyment. God is so kind that He provides what we really need and He protects what is worth protecting. (9.22) God only can extricate us from our suffering caused by our past impious acts. been known as the ¬or centuries, India has 'Land of Spices,' producing and exporting a wide variety of products, renowned for their distinctive flavour, aroma and health benefits. One such spice is turmeric, known as the 'Golden Spice of India, which has spread through trade beyond South Asia to different parts of the world. Today, turmeric is cultivated in many South Asian countries, China, Africa and the Caribbean and has multiple end-uses spanning industries such as food, condiment, dye, nutraceuticals, cosmetics and medi-

With global demand rising and growing demand for high-quality curcumin for



al countries, such as Myanmar, Fiji, and Indonesia, are among the top five producers. India continues to be the largest exporter with close to 67 per cent of global exports in the year 2023. While the export value has increased from USD 182.53 million in 2017 to USD 212.65 million in 2023, the

slow decline, with new exporting countries like Fiji

Global demand is also shifting towards turmeric, which has high curcumin content and organic varieties.
Developed markets like the EU and the USA are emerging as key centres for the consumption of high-quality turmeric that meets stringent sanitary and phytosanitary (SPS) and quality standards. The share of the USA in the imports of turmeric increased from 13.80 per cent in 2017 to 18.98 per cent in 2023, making it the first largest importer followed by India. We continue to import significant amounts of turmeric (especially dry), mainly from Vietnam, Indonesia, and preventive healthcare, sever- share in exports is showing a Myanmar. Much of our

exports are in raw and powder format, where processing and further product developments are done in markets like the European Union

Within the EU, countries like Netherlands and the Germany have become key exporters along with other countries like the USA. Some reasons for lower value addition in India include the inability to supply more than 10 per cent of the global requirement of turmeric with higher than 5 per cent curcumin, high use of pesticides and insecticides, lack of market knowledge and limited R&D and innovative prod-

The country must evolve from just a raw turmeric supplier by innovating, ensur-



ing quality, and adopting sustainable and good agricultural practices to maintain India's global dominance and move up the global value chain.

Several companies have made strides in this direction by producing curcumin extracts for pharmaceuticals and nutraceuticals. Products like Vicco Turmeric Cream combine turmeric with modern

traditions with contempo-

rary personal care. High-curcumin variants, such as Lakadong turmeric, are gaining international recognition for their medicinal benefits. The number of Geographical Indication (GI) turmeric has increased to six as of December 31, 2024. However, to achieve the Indian Government's objective of making India the global hub for turmeric production and to meet the Ministry of Commerce and Industry's projected target of turmeric exports of USD1 billion by 2030, further action is

required. Establishing a National Turmeric Board, announced by the Prime Minister, is one such step towards consolidatcosmetics, linking Ayurvedic ing and implementing com- organic products signed

prehensive regulations governing the entire turmeric value chain, imperative to enhance the sector's global competitiveness.

Additionally, although the standards of domestically produced turmeric align with international regulations, such as the CODEX, global turmeric users require higher curcumin content, with sustainable farming practices and for that targeted R&D is needed to improve the curcumin content of the produce.

Export processes and compliance requirements need to be streamlined and simplified. Signing mutual recognition agreements (MRAs) for standards and organic may help. For example, the MRA for 2024, is a step in the right direction. Similar MRAs need to be signed between India and its key turmeric export destinations Like the EU and the USA, which will reduce the cost and time of certifications and testing.

Rising drug menace

Amit Shah's contention that seven per cent of Indians are into substance abuse is an eye-opener; the Govt must act now

■ ndia is grappling with an escalating threat that cuts across social and economic lines: the increasing prevalence of drug abuse. With seven per cent of the population reportedly engaged in narcotics use, the issue has become a pressing concern for policymakers, law enforcement agencies and society at large. Union Home Minister Amit Shah recently underscored the severity of the problem, describing it as a "cancer" that could destroy the nation's future generations. Speaking at the 'Drug Trafficking and National Security' conference, Shah highlighted the government's intensified efforts against the drug menace. In 2024 alone, narcotics worth Rs16,914 crore were seized, a recordbreaking figure. Comparing the past two decades, Shah noted that from 2004 to 2014, 3.63 lakh kilograms of drugs were seized, whereas from 2014 to 2024, the figure had risen seven-fold to 24 lakh kilograms. Despite this, the drug menace has only increased with even school going children also becoming drug addicts. The discovery of at least



50 illegal labs across the country underscores this issue. With stringent actions against traditional narcotics, there is a worrying shift towards the production and consumption of synthetic drugs, a trend that demands immediate intervention.

India's geographical location plays a significant role in its vulnerability to drug trafficking. Positioned near the Golden Crescent (Afghanistan, Pakistan and Iran) and the Golden Triangle (Myanmar, Laos, and Thailand), the country serves as both a transit and a destination hub for narcotics. Social factors such as unemployment, poverty, and peer pressure further exacerbate the issue, especially among the youth, cre-

Enhanced enforcement efforts have led to record-breaking seizures, reflecting improved coordination and action against traffickers. However, the drug menace has only increased. India needs to focus on strengthening its law enforcement framework, ensuring that agencies have access to advanced training, technology and resources to dismantle drug networks. The regulation of precursor chemicals must be tightened to prevent their misuse in synthetic drug production. Rehabilitation facilities must be expanded to provide holistic support to those battling addiction, while nationwide public awareness campaigns should be intensified to foster a culture of prevention. The fight against drugs also requires regional and global cooperation. Neighbouring countries must work together to address cross-border trafficking, share intelligence and coordinate enforcement actions. At the domestic level, fostering collaboration between governments, non-profits and local communities is essential to sustain long-term efforts. The drug menace in India is not merely a law enforcement challenge but a societal crisis that demands collective action. The government must step up the efforts before it becomes a full-blown crisis.

Pioneering meteorology and AQ management

IMD has evolved from focusing on weather forecasting to becoming a key player in climate research, disaster management and air quality monitoring

he completion of 150 years of establishment the India Meteorological Department (IMD) is a matter of great pride for every Indian. The India Meteorological Department (IMD), established in 1875, has played a pioneering role in meteorological and atmospheric studies in India. Initially focused on weather forecasting and seismology, the Department gradually expanded its scope to include climate research, disaster management, and environmental monitoring. IMD was perhaps the first institution in India to start systematic long-term measurement of solar radiation, precipitation chemistry, ozone, and aerosol optical and physical properties.

Recognising the importance of atmospheric composition, IMD became an active partner in global atmospheric environment monitoring and research programs and contributed significantly towards ozone hole, air quality, precipitation chemistry, climate change, solar dimming and brightening research. The Earth's climate system has demonstrably changed since the pre-industrial era. IMD has a key responsibility in understanding the science of climate change and variability as well as adaptation and mitigation strategies. It plays a prominent role in facilitating a broader use of climate information, products and services. IMD has been mandated to operate the national meteorological observing systems; develop and maintain data archives; undertake climate monitoring; and carry out climate diagnostics, climate analysis and climate assessment.

All this reliable and authentic data and information collected over 150 years has provided a proper assessment of climate change in India and has also helped in developing policy formulation for adaptation and mitigation measures. The air quality forecast and assessment system helps CAQM and other pollution control authorities in the country to make decisions for air quality management including the implementation of GRAP.

The problem associated with air pollution is very complex as



changes in concentrations of the main pollutants. The major factors are anthropogenic emissions, urbanisation, specific topography, emissions sources, environmental factors and meteorology. The advances in computational resources allowed the use of advanced deterministic chemical transport models, leading to more accurate air quality forecasts, replacing the previous empirical and statistical approach which has some limitations.

The scientists at India Meteorological Department and Indian Institute of Tropical Meteorology (IITM), Pune, Ministry of Earth Science jointly developed the advanced Air Quality Early Warning System (AQEWS). The advanced modelling framework consists of a high-resolution fully coupled state-ofthe-science Weather Research and Forecasting model coupled with chemistry (commonly known as WRF-Chem), and ingest data from satellites on aerosol optical depth, surface data from air quality monitoring stations across India and high-resolution emissions from various anthropogenic and natural sources including dust and stubble burning, to create more accurate initial conditions using state-of-the-art data assimilation techniques,

Gas station blast kills 15 in Yemen

An explosion at a gas station triggered a massive fire in central Yemen, killing at least 15 people, health officials said on Sunday. The explosion occurred Saturday at the Zaher district in the province of Bayda, the Houthi rebel-run Health Ministry said in a statement. At least 67 others were injured, including 40 in critical condition

The ministry said rescue teams were searching for those reported missing. It wasn't immediately clear what caused the explosion. Footage circulated online showing a massive fire that sent columns of smoke into the sky and left vehicles charred and burning.

A preliminary estimate by AccuWeather put the damage and economic losses so far between \$135 billion and \$150

Long wait for those whose homes destroyed in Lebanese war

Six weeks into a ceasefire that halted the war between Israel and Hezbollah, many displaced Lebanese whose homes were destroyed in the fighting want to rebuild — but reconstruction and compensation are slow in coming.

Large swaths of southern and eastern Lebanon, as well as Beirut's southern suburbs, lie in ruins, tens of thousands of houses reduced to rubble in Israeli airstrikes

The World Bank estimated in a report in November — before the ceasefire later that month - that losses to Lebanon's infrastructure amount to some USD 3.4 billion.

In the south, residents of dozens of villages along the Lebanon-Israel border can't go back because Israeli soldiers are still there. Under the US-negotiated ceasefire deal, Israeli forces are supposed to withare doubts they will.

Other terms of the deal are also uncertain — after Hezbollah's withdrawal, the Lebanese army is to step in and dismantle the militants' combat positions in the south. Israeli officials have complained the Lebanese troops are not moving in fast enough — to which they say the Israeli troops need to get out first. Reconstruction prospects — and who will foot the bill — remain unclear.

In 2006, after the monthlong Israel-Hezbollah Hezbollah financed much of the USD 2.8 billion reconstruction with ally Iran's sup-

The Lebanese militant group has said it would do so again and has begun making some payments. But Hezbollah, which is also a powerful political party, has suffered significant losses in this latest war and for its part, Iran is now mired

draw by January 26 but there in a crippling economic crisis. The cash-strapped and long paralysed Lebanese government is in little position to help and international donors may be stretched by the post-war needs in the Gaza Strip and neighbouring Syria.

Many Lebanese say they are waiting for Hezbollah's promised compensation. Others say they received some money from the group much less than the cost of the damage to their homes.

Manal, a 53-year-old mother of four from the southern village of Marjayoun has been displaced with her family for over a year, since Hezbollah began firing rockets into Israel on October 8, 2023, in support of

its ally Hamas in Gaza. Israel responded with shelling and airstrikes in southern Lebanon. In July, Manal's family heard that their home was destroyed. The family has now sought compensation from Hezbollah.

"We haven't received any money yet," said Manal, giving only her first name for fear of reprisals. "Maybe our turn hasn't arrived." On a recent day in southern Beirut, where airstrikes had hit just 100 metres (vards) away from his home, Mohammad watched as an excavator cleared debris, dust swirling in the air.

He said his father went to Hezbollah officials and got USD 2,500 — not enough to cover USD 4,000 worth of damage to their home. "Dad took the money and left,

thinking it was pointless to argue," said Mohammad, who also gave only his first name for fear of repercussions. He said his uncle was offered only USD 194 for a similarly damaged home.

When the uncle complained Mohammad said, Hezbollah asked him, "We sacrificed our blood, what did you do in the

war?" Others, however, say Hezbollah has compensated them fairly Abdallah Skaiki, whose home

also in southern Beirut was completely destroyed, said he received USD 14,000 from Qard Al-Hasan, a Hezbollahlinked microfinance institution. Hussein Khaireddine, director of Jihad Binaa, the construction arm of Hezbollah, said the group is doing as much as it can. Its teams have surveyed over 80 per cent of damaged houses across Lebanon, he said.

"We have begun compensating families," he said. "We have also started providing payments for a year's rent and compensations for furniture.

Khaireddin said their payments include USD 8,000 for furniture and USD 6,000 for a year's rent for those living in , Beirut. Those who are staying elsewhere get USD 4,000 in money for rent.

Blueprints for each house are being prepared, he said, declining to elaborate on reconstruction plans. "We are not waiting for the government," he added. "But of course, we urge the state to act." There is little the government can do.

The World Bank's report from mid-November said Lebanon's infrastructure and economic losses from the war amount to USD 8.5 billion. And that estimate doesn't take into account the last month of the war, Deputy Prime Minister Saadi Chami told The Associated Press. "The government does not have the financial resources for reconstruction," he said bluntly. The World Bank said 99,209 housing units were damaged — and 18 per cent of them were completely destroyed. In southern Beirut suburbs alone, satellite analysis by Lebanon's National Centre for Natural Hazards and Early Warning identified 353 build-

ings completely destroyed and over 6,000 homes damaged. Lebanese officials have appealed to the international community for funding. The government is working with the World Bank to get an updated damage assessment and hopes to set up a multidonor trust fund.

The World Bank is also exploring an "emergency project for Lebanon", focused on targeted assistance for areas most in need, Chami said, though no concrete plan has yet emerged. "If the World Bank gets involved, it will hopefully encourage the international community to donate money, Chami said. Ali Daamoush, a Hezbollah official, said earlier this month that the group has mobilized 145 reconstruction teams, which include 1,250 engineers, 300 data analysts and hundreds of auditors many apparently volunteers. The compensations paid so far have come from "the Iranian people", Daamoush said, without specifying if the money was from Iran's government or private donors.

Jana, a 29-year-old architect, is volunteering with Hezbollah teams to survey the damage to her hometown of Nabatiyeh in southern Lebanon. Much of the city is destroyed, including an Ottoman-era market. Her father's warehouse was hit by airstrikes, and all the medical supplies stored there were consumed by a fire. Hezbollah officials "told us

not to promise people or discuss reconstruction because there is no clear plan or funding for it yet", she told the AP. She did not give her last name because she wasn't authorised to talk about Hezbollah's actions. "They advised us to offer support and show the people that someone genuinecares about their situation, she added.

North Korean troops in Ukraine gain battlefield experience

Por weeks, Ukrainian troops braced for an unfa-miliar enemy: North Korean soldiers sent to bolster Moscow's forces after Ukraine launched a lightning-fast incursion and seized territory in Russia's Kursk region over the summer.

Their arrival marked a new and alarming phase in the war. And while initially inexperienced on the battlefield, North Korean troops have adapted quickly — a development that could have far-reaching consequences as they gain combat knowledge in the war against Ukraine. Unlike the Russian troops Ukraine has been battling for nearly three years, Kyiv's forces were uncertain about what to expect from this new adversary, drawn into the war after Moscow and Pyongyang signed an agreement pledging military assistance using "all means" if either were attacked.

One Ukrainian soldier who has witnessed North Koreans in battle described them as disciplined and highly methodical, saying they were more professional than their Russian counterparts. The soldier spoke to The Associated Press on condition of anonymity because he was not authorized to discuss the sensitive military issue.

However, other soldiers, including Ukrainian special forces, have shared battlefield drone footage on the Telegram messaging app mocking their tactics as outdated.

Nevertheless, there is consensus among Ukrainian soldiers, military intelligence and others monitoring developments on the ground: While Pyongyang's troops lacked battlefield experience when they arrived, that has been changing quickly. With 1.2 million troops, North Korea's military ranks among the largest standing armies

globally. But its post-Korean War foreign engagements have been limited, leaving them inexperienced with modern warfare technologies like "For the first time in decades,

the North Korean army is gaining real military experience," said Andrii Yusov, spokesperson for Ukraine's military intelligence agency. "This is a global challenge — not just for Ukraine and Europe, but for the entire world.

Identifying the presence of North Korean troops: Despite Ukrainian, US and South Korean assertions that Pyongyang has sent 10,000-12,000 troops to fight alongside Russia in the Kursk border region, Moscow has never publicly acknowledged the North Korean forces.

While reports of their presence first emerged in October, Ukrainian troops only confirmed engagement on the ground in December. Analysts say that without the

influx of North Korean troops, Russia would have struggled to pursue its strategy of over-whelming Ukraine by throwing large numbers of soldiers into the battle for Kursk.

While Moscow's counterattack in Kursk has inflicted thousands of Ukrainian casualties, Kviv's overstretched forces have managed to hold on to about half of the 984 square kilometers (380 square miles) seized in August, though the situation remains dynamic. Besides the symbolic impact of Ukraine's success capturing Russian territory, control of Kursk could

also be a bargaining chip in any ceasefire negotiations.

According to Ukraine's intelligence agency, the North Korean soldiers are operating alongside Russian units, with the latter providing reconnaissance and electronic warfare

The North Koreans wear Russian military uniforms with fake military IDs in their pockets, according to a report by a Ukrainian military unit that has observed them on the battlefield, and they could easily be mistaken for Russian soldiers. The subterfuge means Moscow and "its representatives at the UN can deny the facts," said Yusov, the Ukrainian military

intelligence spokesperson. Among the things proving their presence is that they have been heard speaking Korean with North Korean accents in intercepted communications, Yusov said. He said the North Korean troops are using their own weapons and equipment and have learned to cope with the improvised explosivesladen drones that have become emblematic of the war, firsthand experience even some NATO-member countries don't

threat," Yusov said. "Regional countries must prepare for what this means in the future." North Koreans gain invaluable experience on the battlefield: The North Koreans' early missteps were largely caused by inexperience, such as moving in large groups in open terrain, making them easy targets for drones and artillery strikes.

According to the Ukrainian military unit's report, the North Korean soldiers were spotted easily as they moved in singlefile columns through forest in groups of three, with 3 to 5 metres (yards) between soldiers. On open terrain, they moved in dispersed formations of five to 15 soldiers, making them vulnerable and leading to heavy losses.

However, during night operations, their movements were swift and units oriented themselves using red flashlights along routes, the report said. "They're fast, physically well-prepared, and act strictly according to their algorithms, said the Ukrainian soldier who spoke to the AP. "If you drill the same routines for years, to the point where they can be executed blindfolded, it will yield

Despite their discipline, their lack of combat experience hindered their effectiveness. The Ukrainian military reported that North Korean troops often

trine and training is based on strategies and experiences from over half a century ago," said Glib Voloskyi, a military analyst with the Ukrainian think tank CBA Initiatives Centre. The large-group formations date to when artillery accuracy was significantly lower, and observing troop movements much more difficult. Today, reconnaissance and so-called first-person view drones, or FPVs, that transmit video allowing soldiers to strike targets in real time have made the battlefield highly transparent, and anyone stepping onto it without cover, let alone moving

in groups, is immediately spot-

"But it is only a matter of time before they acquire the necessary skills to improve their combat effectiveness, which, combined with their discipline and training, could make them a significant military force," Voloskyi said.

No surrender policy means few North Korean POWs: After weeks of fighting, Ukrainian soldiers have taken only two prisoners of war. In announcing the capture Saturday, Zelenskyy said taking them alive "was not easy" because of efforts to conceal the North Koreans' presence and avoid their interrogation by Ukraine. North Korean soldiers avoid surrendering at all costs, Zelenskyy said.

This may stem from North Korean internal propaganda that portrays capture as the ultimate disgrace, analysts said.

"To be captured alive is considered a betrayal of the country, the leader and everything they stand for," said Seongmin Lee of the New York-based Human Rights Foundation, who defected from North Korea in 2009. This belief is instilled from a

throughout military training, he said. "Because of the disgrace associated with the capitulation, heroic soldiers are supposed to save the last of their bullets to kill themselves," Lee

Lee said he shared photos of dead North Korean soldiers with contacts back home.

"Most North Koreans don't even know what is going on," Dorothy Camille Shea, the deputy US ambassador to the

UN warned of the dangers posed by the rapidly improving battlefield skills the North Korean troops are gaining fighting in Kursk. North Korea "is significantly benefiting from receiving

Russian military equipment, technology and experience, rendering it more capable of waging war against its neighbours". Shea told the 15-member UN Security Council on Wednesday.

As an added potential benefit, she said, North Korea "will likely be eager to leverage these improvements to promote weapons sales and military training contracts globally".

Croatia's President Milanovic overwhelming favourite to win re-election in runoff vote

The left-leaning Milanovic comfortably won the first round of voting on Dec 29, leaving his main challenger, Dragan Primorac, a forensic scientist who had unsuccessfully run for presidency previously, and six other candidates far behind.

The runoff between the top two contenders was necessary because Milanovic fell short of securing 50% of the vote by just 5,000 votes, while Primorac trailed far behind with 19%.

The election comes as the European Union and NATO member country of 3.8 million people struggles with biting inflation, corruption scandals and a labor shortage.

Milanovic, 58, is an outspoken critic of Western military support for Ukraine in its war against Russia. He is the most

ical tensions in the country. While violent protests took place in many cities of the country on May 9 following Khan's arrest, clashes took place between PTI protesters and the police in Islamabad in November last year.

Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur, Asad Qaiser, Omar Ayub Khan, Allama Nasir Abbas and Hamid Raza were the key party leaders who met Khan at Adiala Jail for consultation ahead of the third round of meetings with the government. Khan suggested an impartial

Speaking to reporters after the meeting, Raza said it was a "detailed meeting in a con-trolled environment" where the committee members presented their points of view before Khan, who has been in prison since August 2023.

We have a detailed meeting with founder PTI who once again demanded a judicial commission on May 9, 2023, and November 26, 2024, events to unearth the facts so that those responsible can be determined," he said, adding that judge should head the commission. Raza said the PTI team would also inform the government that they were ready for the third session of the talks. He admitted that even after so many weeks, no progress has been made in the talks.

Raza added that Khan gave a deadline of January 31 for the conclusion of talks, which only he can extend in case of any progress.

Talking about the party's demands, he said they would also ask for the release of PTI workers and leaders.

CII suggests 10-point agenda on ease of biz reforms ahead of Budget

Ahead of the upcoming Budget, industry body CII on Sunday suggested a 10point agenda to drive ease of business reforms, aimed at reducing compliance simplifying burden, regulatory frameworks, and

improving transparency.
Among the "urgent policy interventions", the industry body has recommended that all regulatory approvals -- central, state and local levels -

must mandatorily be provided only through the National Single Window System.

It has also pitched for expediting the process of resolution dispute improving the capacity of courts and placing greater reliance on alternative dispute resolution (ADR) mechanism.



Industry (CII) said, a unified framework could which introduced, consolidates all requirements

into a single document. Emphasising that easy access to land is important to facilitate new or expanding businesses, it said that states may be incentivised to develop an online integrated

land authority with an objective to streamline land banks, digitise and integrate records, provide information on disputed land

Compliances for industry related to various areas such as land, labour, dispute resolution, paying taxes and environment offer vast scope for reduction, vital for boosting competitiveness driving economic growth and employment generation."

To ensure timely processing of industry applications and delivery of services from the central ministries, an Act, imposing statutory obligation on all public authorities for time-bound delivery of services and redressal of grievances, could be passed, with provision of deemed approval beyond the prescribed timeline, CII suggested.

India's coal import rises two per cent to 182 MT in April-November period

m two}$ per cent to 182.02 million tonnes (MT) in the April-November period of the current fiscal year The country's coal import was

at 178.17 MT in the year-ago period, according to data compiled by business-toe-commerce company mjunction services

However, the country's coal import dropped to 19.57 MT in the month of November, over 22.30 MT in the corresponding month of the previous fiscal.

There was a drop in volumes, which was in line with market expectation. Ample availability in the domestic reduced import demand from consuming sectors such as sponge iron and steel. Also, the



comfortable stock position at plants resulted in muted demand for imports," mjunction MD and CEO Vinava Varma said.

This trend is likely to continue in the coming months, he said. During April-November 2024, non-coking coal import was at 117.73 MT, lower than 118 MT imported during the same period last year. Coking coal import was at 36.93 MT April-November period, down against 37.97 MT recorded in the year-ago earlier stressed on augmenting coal production and reducing the imports of dry-fuel.

As per the present import policy, coal can be freely imported by the consumers themselves considering their needs, based on commercial prudence.

Coking Coal is being imported by Steel Authority of India Ltd (SAIL) and other steel manufacturing units mainly to bridge the gap between the requirement and indigenous availability and to improve the quality. Coal-based power plants, cement plants, captive power plants, sponge iron plants, industrial consumers and coal traders are importing non-coking coal. Coke is imported mainly by

Amnesty Scheme for customs may be announced in Budget 2025-26 to reduce litigation: Experts

In a bid to reduce litigation, Finance Minister Nirmala Sitharaman in the upcoming Budget may announce an Amnesty Scheme for customs to foster ease of doing business.

'The main asks of the industry would certainly be aligned with the objectives of the government and one objective of the government has been litigation reduction. On that front, having an amnesty scheme for customs especially covering pre-GST legacy taxes like additional duty, special additional duty has been one of the asks of the industry," Price Waterhouse & Co LLP managing director Anurag Sehgal said.

The government had in the past announced amnesty



service tax and even for the income tax but not for customs. There are estimates that over 40,000 cases were pending in various courts and tribunals pertaining to customs duty alone.

Another consultancy firm EY India said customs litigations are pending at various forums for a very long time and the same require time and effort to be spent by both taxpayer and the government in resolving

EY India also suggested that a one-time dispute/litigation resolution/settlement scheme should be introduced under the Customs Law to settle and resolve pending disputes. According to Deloitte India

partner Mahesh Jaising, the government should end longdrawn litigation to resolve long-standing alleviate the disputes,

judicial pipeline and upgrade the law to keep pace with technological advancements international practices.

"An amnesty scheme, along the lines of Sab ka Vishwas, will be a welcome decision.
The industry has been waiting for such a scheme for years to address pending litigation matters under customs. This will especially help small businesses avoid past disputes and move ahead with a clean slate," Jaising said.

Another important wishlist of the industry on customs would be rate rationalization to support the Make in India initiative, Sehgal said. "You have PLI, Phased

Manufacturing Programme coming up in many sectors. So rate rationalization would help promote investment in India," he said.

Investors will take cues from the December quarter chips like Infosys, Reliance Industries scheduled to report their results this week, in addition, inflation data and trading activity of foreign investors will also be crucial in dictating market trends, analysts said.

Movement of crude oil prices and the dollar index will also be tracked by investors. The strengthening of the US dollar, along with rising US bond yields, impacted investors' confidence last week.

"The Indian equity markets are poised for a volatile week ahead, as investors eagerly await the release of Q3 earning reports from major companies. "Prominent names such as Infosys, Reliance Industries, HCL Technologies, HDFC AMC, HDFC Life Insurance Company, and Axis Bank are set to unveil their financial performance, which is likely to



significantly impact market sentiment," Pravesh Gour, Technical Analyst, Swastika Investmart Ltd, said. Adding to the market's dynamic, a tug-of-war between Foreign Institutional Investors and Domestic Institutional Investors (DIIs) continues to unfold, he said. Falling rupee puts pressure on Air India's cost structure, says company official

Talling rupee puts pressure on Air but the airline has some natural hedge as it can charge more for international flights where tickets are priced in foreign currencies, according to a senior company official.

In recent weeks, Indian rupee has been on a decline and touched a record low of 86.04 against the US dollar on January 10. A weak rupee results in higher operational expenses for airlines as most

of their costs are in dollars. Air India's Chief Commercial Officer Nipun Aggarwal said the declining rupee definitely poses a challenge to the industry and to Air India, and the situation has to be dealt with by improving productivity and taking other initiatives

"Falling rupee does put pressure on our cost structure because most of our cost is dollarised barring the manpower cost which is in local currency. The more the rupee falls, the more the pressure it puts on our cost structure, on our profitability," he said at a media briefing



flights, including 313 services to international destinations. Of those overseas flights, 244 are short haul and 69 are long haul. The group comprises Air India and low-cost carrier Air India Express.

Increasing airfares is not easy as the industry is very competitive and the demand is sensitive to pricing, Aggarwal said, seeking to highlight the low profitability of the airline industry. "We do have to fill the aircraft and if we

had so much pricing power, the airline industry's profitability would not be what it is today. This makes it very challenging for us to operate... It (falling rupee) will put pressure on our cost structure, impact profitability and demand," he noted.

In December, the International Air Transport Association (IATA) projected global airline industry's net profit at USD 36.6 billion this year for a 3.6 per cent net profit margin.

"Average net profit per passenger is expected to be USD 7 (below the USD 7.9 high in 2023 but an improvement from USD 6.4 in 2024)," IATA said in its financial outlook for 2025.

Government partially restores gas supply to IGL, Adani-Total

The government has increased cheaper gas supply to city gas retailers IGL, Adani-Total, and and Mahanagar Gas, restoring a major part of the allocation that was cut in 2024, according to regulatory filings by the companies.

The government, in October and November last year, had cut supplies of the so-called APM Gas (low-priced natural gas coming from old fields such as Mumbai High and Bassein fields in the Bay of Bengal) to city gas retailers by as much as 40 per cent in view of limited output.

This led to city gas retailers hiking CNG prices by Rs 2-3 per kg and planning more increases as they replaced lost volumes with higher-priced input fuel.

The price hike made CNG less attractive when compared to alternate fuels like diesel.

Following this, the Ministry of Petroleum and Natural Gas in a December 31, 2024 order rejigged some allocations of gas produced from below ground and undersea. The ministry ordered a cut in

gas supplied to state-owned GAIL and Oil and Natural Gas Corporation (ONGC) for production of LPG and diverting those volumes to city gas entities. Out of a total 2.55 million

standard cubic meters per day of gas usage for LPG production, 1.27 mmscmd mmscmd each for GAIL and ONGC) was ordered to be diverted for consumption in CNG/piped cooking gas segment in January-March quarter, according to the order reviewed by PTI.

City gas retailers in regulatory filings said increased volumes of APM gas will start from January 16.

"As per the communication

Ltd (the nodal agency for domestic gas allocation), this is to inform that the domestic gas allocations to IGL have been revised upwards by 31 per cent with effect from January 16, 2025, increasing the share of domestic gas in the CNG segment from 37 per cent to 51 per cent," Indraprastha Gas Ltd (IGL) said in a filing.

The LPG they make is supplied to fuel retailers like Indian Oil Corporation (IOC) for sale to households as domestic cooking gas LPG in cylinders.

The government subsidises domestic cooking gas LPG and hence the higher cost of production is likely to be borne by it.

In two allocation cuts, the government had reduced supplies of domestically produced gas to city gas retailers by 5-5.25 mmscmd. Half of this is being immediately restored and more will come once the gas from Ramnad field and new wells flows.

Natural gas pumped from below the ground and from under the seabed from sites ranging from the Arabian Sea to the Bay of Bengal within India is the raw material that is turned into CNG for sale to automobiles and piped cooking gas to households.






