President-elect Donald Trump is spending the eve of his inauguration in a series of Washington events that celebrate his return to power and his "Make America Great Again" movement as he prepares to move back into the White House at a time of deep national political divisions.

Washington has prepared in unprecedented ways to keep the unfolding events save and secure. But unlike when Trump helped spark a mob of his supporters to attack the Capitol and tried to retain power in 2021 after his loss to Democrat Joe Biden, officials are not expecting massive protests, unrest and violence

this time. Instead, the city is braced for crowds celebrating Trump's second term and MAGA's total control of the Republican

Yet even with that comfortable victory and his party in full, albeit narrow, control of Congress, the incoming president remains one of the most polarising figures in US history, with nearly as many fierce detractors as ardent supporters.

# Gaza ceasefire begins, handover of hostages started

ceasefire between Israel Aand Hamas initiated in the Gaza Strip on Sunday, ushering in an initial six-week period of calm and raising hopes for the release of dozens of militant-held hostages and an end to the devastating 15month war. A last-minute delay by Hamas put off the truce's start by nearly three hours and highlighted its fragility.

First Red Cross convoy picked up three women Israeli hostages in Gaza. Even before the ceasefire took effect, celebrations erupted across the territory and some Palestinians

began returning to their homes. Israel, meanwhile, announced the names of the first three hostages expected to return home later Sunday, in exchange for the planned release of 90 Palestinian prisoners. The truce, which started at

11.15 am local time, is the first

step toward ultimately ending

In the interim between 8.30 am and when the ceasefire took hold, Israeli fire killed at least 26 people, according to Gaza's Health Ministry. It did not say whether they were civilians or fighters. The military has warned people to stay away from Israeli forces as they retreat to a buffer zone inside Gaza.

## **Valmiki Basti key to elite New Delhi seat | Sky clear, city air still poor**

New Delhi's Valmiki Basti is set to play a pivotal role in deciding the fate for Aam Aadmi Party (AAP) chief Arvind Kejriwal, as well as BJP candidate Parvesh Sahib Singh Verma and Congress candidate Sandeep Dikshit in the upcoming Delhi elections. Residents of the Basti have expressed concerns over their sitting MLA's limited presence in the area and the negative impact of the excise policy on the rising problem of

alcoholism. However, remains a notable sympathy among the populace for the former Chief Minister Kejriwal who has faced jail time, alongside an appreciation for the ruling party's initiative that offers free bus rides to women.
The area holds significant importance

# **Police claims Saif attacker nabbed**

The 72-hour-long drama involving the elusive accused in the murderous attack on Bollywood actor Saif Ali Khan finally ended on Sunday, as the Mumbai police finally arrested the real culprit -a Bangladeshi national - behind the sensational crime from

the neighbouring Thane city.

A day after the Railway Protection Force (RPF) personnel detained a 31-year-old suspect in connection with Thursday's attack on Saif, the Mumbai police zeroed in on the real accused - identified as Shariful Islam Shahzad (30) - from Hiranandani Estate at Thane (west).

Shariful, who hails from Rajabariya village in Nalchity sub-region of Jhalokati district in southern Bangladesh, had illegally crossed over to India some six months and been living in Mumbai under the false name of Bijoy Das.

The police said that during the questioning after his arrest, Shariful admitted to having committed the crime

After his arrest, Shariful was produced before a holiday court in Mumbai, which remanded him in police custody for five days. The police had sought Shariful's custody for

14 days to establish the motive behind his breaking into Saif's house, to ascertain where he had hidden the cloths that he wore at the time of crime, what was the motive behind his entry to Saif's house, where did he procure the on, how did he enter India an he break into Saif's house and why did he assume a false name after coming to India. During the knife attack carried out on him

allegedly by Shariful in the small hours of January 16, Saif had sustained six stab wounds, including the one in his spine while he was grappling an intruder in the actor's 12th floor apartment in posh "Satguru Sharan" building at Bandra (W) in north-west Mumbai. The knife attack on the actor had taken place between 2 am and 2.30 am on Thursday, after a failed attempt of a burglary. After his admission to the Lilavati Hospital, the actor had undergone a surgery for removal of a knife stuck in his spine and also plugging the leakage of spinal fluid. During a surgery carried out on him immediately afterwards, the doctors attending on Saif removed a 2.5-inch piece of knife from Saif's

During the preliminary interrogation. Shariful admitted to have sneaked into the actor's building on the night of January 15. Earlier, while seeking the custody of the accused for 14 days, the police cited several grounds for his custody. "The robbery was the motive behind the crime was robbery," a senior police officer said.

The theft attempt failed after a house maid saw and raised an alarm, prompting Saif to come out of his bedroom. The actor resisted Shariful's attempt, resulting in a scuffle between the two-in which the latter stabbed him six times before fleeing the building empty handed.

Later he started telling something else. The sister had told us several times in the past that her brother-in-law had pressurised her to bring goods and money in dowry. **¬**aking up cudgels on behalf of outsourced employees, the Junior Doctors Association (JDA) at Hamidia Hospital has written to the Dean of the government-run college hospital and sought a reconsideration of the decision to lay off scores of employees.

According to sources, the JDA has said in the letter that the removal of 400 outsourced employees will impact hospital services and have a detrimental effect on the financial health of the junior workers.

Since October 2024, outsourced employees have repeatedly protested against the Hamidia Hospital management for failing to pay their salaries on time. Protest leaders said that the Hamidia management, and a private firm responsible for

sourcing human resources for the hospital, continue to owe months of wages.

After placatory moves failed to calm employee anger, the hospital management had said that the issue was rooted in overstaffing during the COVID pandemic. Stopping short of enumerating the employees facing job losses, the management had initially said it was looking into the overstaffing issue, which was causing financial distress for the health facility. Though hospital authorities are yet to confirm or deny, rumours suggest that the hospital plans to lay off 400 workers and has already put 50 individ-uals on notice, with their services ending on Monday.

Quiet since the protests erupted some three months ago, the letter from the JUDA is suggestive of an escalation in the ongoing employee layoff controversy.

## Design issues may drive delays for GG flyover

iddled by years of delay, the GG flyover project in the state capital is highly unlikely to be opened to vehicular traffic any time soon due to inherent flaws in the planning of the multi-crore project.

Experts say stakeholders still need to work on the traffic management aspect of the route, which must be designed with the city's vehicular culture in mind.

They flag the height of the parapet walls on the elevated stretch and the incline leading to the Bhopal Haat intersection as the primary causes of concern.

Indian Road Congress benchmarks require parapet walls on flyovers to be of a certain height to ensure that drivers are not distracted by the periphery and maintain a keen focus on the road, besides discouraging

selfie-taking stops by motorists. Though the elevated route was meant to decongest vehicular traffic in the busy MP Nagar area, the creation of large stretches of negative space beneath the flyover may require motorists to drive past a maze of metro and flyover pillars to reach the business district.

A visit to the project site points to several hurdles that district authorities will need to navigate before the flyover is cleared by the traffic management committee.

In conversation with The Pioneer, the Head of the Civil Engineering Department at the prestigious Maulana Azad National Institute of Technology (MANIT), Prof Sudhakar Rokde, admits that there are lapses in the design of the route that still need to be

addressed. Part of a two-member MANIT team responsible for making transport management recom-

mendations for the flyover, Rokde says that though recommendations have been forwarded to the administration, the traffic management plan for the flyover will require several rounds of fine-tuning before a free and safe flow of traffic returns to the area.

Traffic disruptions have remained an everyday affair in the area since the construction project began in 2020. While the administration blames delays in the completion of the project on Covid protocols, business owners in the glitzy shopping and office area say they have suffered immeasurable losses due to the slowpaced construction.

Even if business owners seek a speedy completion of the project, experts warn against hurriedness in opening the flyover to vehicular traffic without addressing traffic management issues, as it will involve huge They point out that the most grim piece of the GG flyover jigsaw lies in managing the traffic melee that the opening of the flyover will cause at the Bhopal Haat traffic intersec-Though the administration is

mulling ways and methods to get itself out of the traffic tangle, an expert suggests that the fault may lie in the design of the project, as the flyover ends too close to the traffic junction. In the current scenario, the administration expects motorists coming down the flyover at the Bhopal Haat intersection to navigate an immediate left turn, as well as the traffic coming towards them from the side lane beneath the

flvover Even if imagining the situation is scary, the administration is sending out signals of an impending opening of the flyover, despite huge risks to the safety of those taking the route.

## India, Italy decide to expand counter-terror cooperation

## Pipa bridges: Vital links between Sangam and Akhada areas at Mahakumbh

Rigorous Dedication

The temporary pipa bridges are playing key role in the grand arrangements of the Mahakumbh. These bridges are serving as vital links between the Sangam area and the Akhada area during the massive event.

The administration has divided the sprawling 40-square-kilometer Mela area into 25 sectors. These pipa bridges are an integral part of the Mahakumbh, offering a low-maintenance solution for the vast crowds. However, their operation requires constant monitoring, ensuring the safety and movement of smooth devotees 24/7.

Engineer Alok Kumar from According the Public Works entrusted Public bridges temporary structures built with large hollow iron containers (pontoon) floating on the water's surface. These are commonly known as 'pipe ka pul' in Prayagraj.

These bridges have been built to facilitate movement not only for the public but also for the grand entry of 13

To construct 30 pipa bridges for the Mahakumbh, 2,213 pontoons were used, the largest number ever. Over 1,000 workers, engineers, and officials worked tirelessly, often for 14 hours a day. The construction of these bridges was completed by October 2024 and subsequently

The construction of 30 pipa bridges over the Ganga River for the Mahakumbh is the this largest such project to date. fair, these bridges will be dismantled and stored for future use at other locations. The hollow pontoons, made of strong iron sheets, are lowered into the river with the help of cranes. Girder beams are then placed on these pontoons and secured with nuts and bolts. Hydraulic machines are used

planks, sandy soil, and iron angles are added to further stabilize the bridges. Finally, checker plates are laid on the bridge surface to ensure it remains strong for the movement of pilgrims and vehicles.

Each pontoon weighs about 5 tons, yet it floats on water. The secret lies in Archimedes' principle. PWD engineer Alok Kumar explained, "When an object is submerged in water, it experiences an upward force equal to the weight of the water displaced by it. This principle helps the heavy pontoons float?

The construction of the 30 pipa bridges has cost Rs 17.31 crore. The bridge from Nagwasuki Temple to Jhoosi is the most expensive, costing Rs 1.13 crore, while the cost

of the Gangeshwar and Bharadwaj bridges ranged between Rs 50 lakh and Rs 89

The technology of pipa bridges is over 2,500 years old. They were first used in 480 BC by Persian King Xerxes I during his invasion of Greece. These types of of Greece. These types of bridges were also used during the Zhou Dynasty (11th century BC) in China.

In India, the first pipa bridge was built in October 1874 over the Hooghly River between Howrah Kolkata. It was designed by British engineer Sir Bradford Leslie. The bridge was supported by pontoons but was damaged due to a cyclone. Eventually, it was dismantled in 1943. and the famous Howrah

After the Mahakumbh 2025, these bridges will be disassembled and stored in safe locations. According to officials, some of the bridges will be stored in Sarainayat (Kenihar), Trivenipuram, and Parade Ground in Prayagraj. Others may be repurposed as temporary bridges in various

reminded Chaudhary Gandhi that "his party had been supporting the caste survey all through. The government has also been willing to set right anomalies if these were pointed out with tangible evidence. In such a backdrop, the comment by Gandhi is just



another example of his propensity to speak things that sound ridiculous"

Senior BJP leader and former minister Syed Shahnawaz Hussain expressed similar sentiments and pointed out "till recently, Rahul Gandhi used to claim credit for Bihar's caste survey. It is bewildering on his part to call the survey fake".

State minister Dilip Jaiswal, who is also the Bihar BJP chief, mockingly said, "Before holding forth on caste census, Rahul Gandhi should tell us to which caste does he belong". Incidentally, made public in October 2023.

## When elephants roamed beyond: A remarkable journey through China



A historic event captivated the world as a herd of 15 wild elephants embarked on a 500-km journey from Xishuangbanna to the bustling city of Kunming

ome time back an extraordinary event unfold-Oed in China: for the first time in recorded history, a herd of 15 wild elephants embarked on an unprecedented journey. Leaving their natural habitat in Xishuangbanna (commonly referred to as Banna), the elephants traveled over 500 kilometers to Kunming, the capital of Yunnan Province. Xishuangbanna, an autonomous prefecture for the ethnic Dai people, lies in the southernmost part of Yunnan, bordering Myanmar and Laos

This remarkable migration captured the attention of the world, with live 24/7 broadcasts and drones following their every move. The Chinese authorities, committed to the conservation of these majestic creatures, responded with care rather than confrontation. However, their journey caused panic among local residents, who abandoned their homes in fear. Despite trampling crops and cornfields along the way, the elephants did not harm any humans. In some instances, curious jumbos ventured



into deserted homes, with one even slipping under a bed. Yet, they remained peaceful throughout their expedition. During their long journey, the elephants maintained their routines, munching on leaves, bathing in mud, and sleeping. In a touching moment, a calf

was born mid-journey. Eventually, after weeks of gentle coaxing and careful management, the herd returned to their home in Xishuangbanna.

The reasons behind this unusual migration remain unclear. Experts speculate that an inexperienced leader might have led the herd astray, or that they were seeking a new habitat due to environmental changes. While conservation efforts in China have resulted in a gradual increase in the elephant population, these human activity. Large-scale commercial rubber cultivation, introduced to Banna, has significantly disrupted the region's rainforest ecosys-These plantations, consisting

of monocultures of Brazilian rubber trees, replace diverse habitats, further encroaching on the elephants' range. Asian elephants, an endangered species, number only about 300 in the wild in China, primarily in Banna. Protecting these animals is a national priority. Emergency workers and volunteers were mobilised during the migration, providing tonnes of corn, pineapples and other food to ensure both the safety of the elephants and the local population. Trucks and drones were deployed to guide the animals along safe paths, offering them a feast akin to a celebratory banquet. Xishuangbanna is a biodiversity hotspot, home to a wide variety of flora and

The region's tropical climate and historical isolation have preserved its rich ecosystems. In addition to Asian elephants, the area supports efforts are complicated by other endangered species

such as green peacocks, wild oxen, and monkeys. The Wild Elephant Valley Forest Park, located 47 kilometers north of Jinghong city, serves as a key conservation site. Spanning 369 hectares, this park provides a haven for wildlife and a unique opportunity for visitors to observe elephants.

The reserve features observation towers, allowing visitors to watch wild elephants bathing, playing, and strolling. A cableway pro-vides breathtaking views of the valley, while the park's elephant-domestication school entertains visitors with performances by trained elephants, including dancing, headstands, and football tricks. Looking ahead, the Chinese government plans to establish an Asian Elephant Breeding Centre in Banna to further conservation efforts. These initiatives aim to protect not only the elephants but also the rich biodiversity of this unique region, ensuring a harmonious coexistence between humans and

# LPG subsidies: Give it to the poor and needy

As state-owned oil companies grapple with massive losses from selling LPG below cost, the Govt is set to allocate Rs 35,000 crore in subsidies to mitigate the financial burden



uring the current financial year (FY) 2024-25, the stateowned Indian Oil Corporation Ltd (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) are expected to incur an underrecovery of Rs 19,550 crore, Rs 10,400 crore and Rs 10,570 crore respectively on sales of LPG to household consumers. To make up for this loss totalling Rs 40,500 crore, the Union Government is likely to provide a subsidy of Rs 35,000 crore. In the Budget for 2025-26, to be presented on February 2025, Finance Minister Nirmala Sitharaman will make a provision of Rs 10,000 crore in the revised estimate (RE) for the current FY and the remaining Rs 25,000 crore in the budget estimate (BE) for 2025-26.

The under-recovery arose because these corporations sold LPG for Rs 803 per 14.2kg cylinder against the cost of supplying at the retail point being higher. The cost is calculated as the refinery-gate price or RGP (taken as import parity price or IPP and export parity price or EPP in the ratio of 80:20) plus freight, marketing costs, marketing margin, dealers' commission, and taxes and duties. During the current FY, the cost is Rs 1043 per cylinder, and the loss is Rs 240 per cylinder which on total sales of 169 crore cylinders would be Rs 40,500 crore. Modi - government had stopped giving subsidies on LPG during FY 2021-22. Then, how come, it continues to make huge payments from the budget? LPG is an environment and human-friendly fuel that meets the needs of millions of house-

Subsidy on LPG ought to be given only to those HHs who are poor. The government also needs to track the income status of the beneficiaries and withdraw support from those who become better off and can pay cost-based prices. Ignoring these cardinal principles, the subsidy was given to anyone who had an LPG connection. It went to all and sundry including the rich. The poor who alone should have got it sat at the OFF AND CAN PAY bottom. According to the Economic Survey (2015-16), only 0.07 per cent of LPG subsidies in rural areas went to a fifth of the

A lot of subsidies went to fake beneficiaries or the diversion of stocks (albeit subsidised) of LPG cylinders to hotels, restaurants, and other commercial users. Despite lacking sound justification, sheer populism drove politicians to give subsidies to all and sundry. They found ways to give it without taking the burden on the Centre's balance sheet. Initially, the subsidy on LPG (besides petrol and diesel) was cross-funded/subsidised by charging more on the sale of other products such as fuel oil, naphtha, ATF, etc. hence, no burden on the budget. In 2002-03, the Vajpayee-led NDA government ended the above system and decided to give subsidies on these products directly from the budget with the intent to eventually disband them. But, that was not to be.

OUGHT TO BE was not to be.
The UPA government which took charge in 2004, even while continuing with subsidised sales, used disingenuous methods such as the issue of oil bonds to IOCL/BPCL/HPCL (instead of losses incurred by them due to selling these products at below-cost prices), and sale of domestic crude oil by stated owned upstream oil and gas companies viz. Oil and Natural Gas Corporation (ONGC) and Oil India Limited (OIL), etc. at a discounted price to these fuel refiners-cum-retailers.

In June 2010, petrol was decontrolled followed by diesel in November 2014. As for LPG, the Kelkar Committee recommended the removal of 25 per cent of the subsidy in 2012-13 and 75 per cent in the following two years. Modi Government which took charge in May 2014, started acting on it but in a calibrated manner. On January 1, 2015, it launched a direct benUnder DBT, oil PSUs deliver the cylinder to the beneficiaries at a full cost-based price and follow it up by depositing a subsidy in the beneficiary's account.

In turn, they claim reimbursement of the subsidy amount from the Centre. This helped in eliminating fake beneficiaries and curbing misuse that was inherent in the erstwhile system wherein subsidy was embedded in the price. But, the government couldn't muster the courage to trim the number of beneficiary HHs sans Modi requesting the rich to give up on their own. The FY 2020-21 was a boon,

viewed from a subsidy angle. In that year, there was a steep decline in international prices (due to the COVID-19 pandemic) leading to a fall in the cost of supplying an LPG cylinder to a low of Rs 600; hence, it could be given to all HHs at Rs 600 requiring no subsidy support. The BE of Rs 36,000 crore for that year was used largely to clear past dues of oil PSUs and provide free gas connections under the Pradhan Mantri Ujiwala Yojana (PMUY).During 2021-22 when the international price rose due to waning COVID and demand revival, the cost of LPG zoomed to over Rs 900 per cylinder.

This prompted the government to give subsidies but only to the PMUY beneficiaries. They were 9.6 crore out of a total of 33 crore HHs. It spent Rs 14,000 crore during that year. During 2022-23, it spent Rs 9,170 crore. But, this doesn't tell the full story. From June 2020 to June 2022, the government had From June 2020 to asked the three fuel retailers namely IOCL/BPCL/HPCL to sell LPG at a price below cost and gave them a one-time grant of Rs 22,000 crore to compensate for the losses incurred in 2021-22 and 2022-23 (against under-recovery of Rs

This was nothing but subsidy (albeit 'hidden') given to all and sundry, and not just PMUY beneficiaries. In the Budget for 2023-24, it kept the BE for LPG subsidy at Rs 2,257 crore. As in the previous two years, that allocation was meant to cover subsidy to PMUY beneficiary HHs @ Rs 200 per cylinder for up to 12 refills per year. However, to benefit all the 33 crore HHs, on August 29, 2023, the Union Cabinet approved a reduction in the price by Rs 200 per cylinder effective from August 30, 2023, thereby enabling the PSU retailers to sell it at Rs 903 per cylinder (Delhi). Taking 4 fills per HH, @Rs 200 per cylinder, the annual burden comes to Rs 26,400 crore (200x4x33).

Since the decision was effective from August 30, 2023, for the remaining seven months of FY 2023-24, the outgo would be around Rs 15,300 crore. On March 9, 2024, the fuel retailers namely IOCL/BPCL/HPCL were asked to cut the price by another Rs 100 per cylinder (courtesy, of general elections) to Rs 803.

During the current FY 2024-25, the price has remained unchanged despite the cost remaining at an elevated level. The under-recovery for 2023-24 and 2024-25 thus comes to over Rs 40,000 crore of which the Centre now wants to reimburse Rs 35,000 crore. This and the earlier payment of Rs 22,000 crore for loss incurred by IOCL/BPCL/HPCL during 2021-22 and 2022-23 could have been avoided if only it had stuck to its earlier stance of restricting LPG subsidy only to the poor HHs and keeping it transparent. But, this is unthinkable in the current political climate wherein all decisions based on sound economic logic are hamstrung by populism.

## The silent epidemic: The untold story of gender inequality against men in India

Indian society, long entrenched in patriarchy and gender inequality against women, is now grappling with an overlooked dimension of the issue-gender inequality against men

 ndian society has always been dominated by patri-Larchy and gender inequality against women. However, the two recent suicides of a techie and a head constable, both alleging extortion and harassment by their estranged wives and families, point to a highly skewed, female-oriented and obsolete legal framework. Gender inequality largely remains a half-told story, deprived of the male coun-

The legal system in India favours women with the dowry laws in India being specifically highly discriminatory. As per section 113B of the Indian Evidence Act, Bhartiya 1872 (now Saksham Adhiyam, 2023) if



suicide within 7 years of marriage, it is assumed that the husband or his family abetted suicide, while the same does not apply to women. Marriage litigation experts claim that when women file complaints against their husbands and families, the dynamics of abuse and unclear docuthese cases highly complex and a woman's statement is usually considered at face value, creating a significant imbalance in the legal

Additionally, females also get a preference in the custody of children especially in younger ages below 5 years, in most divorce cases, as per the Hindu Minority and Guardianship Act, 1956. According to the National Crime Records Bureau (NCRB) 2022 data, men accounted for 1,22,724 suicides out of a total of

This is 71.81 per cent of all suicides. The data also highlights that a man commits suicide every 4.45 minutes while a woman every 9 minsuicide among married men is three times that of married women. In 2021 as many as 81,063 married men committed suicide while the women's figure stood at 28,660.

Family problems and marriage-related issues were the leading causes of suicide in metropolitan cities, accounting for 32.5 per cent of the cases. Gender inequality towards men finds limited discussions both culturally and in academic research, not just in India but globally. However, a closer look at the facts reveals a biased feminist societal structure

# 'Trump wants to visit China, talked about possible trip to India'

President-elect Donald Trump wants to travel to China after he takes office as part of his effort to deepen relations with Beijing, and also has talked to advisors about visit to India, a media report said

Trump, who arrived at the Dulles International Airport aboard a special plane along with First Lady Melania and son Barron, had during his election campaign threatened to impose additional tariffs on

"President-elect Donald Trump has told advisors he wants to travel to China after he takes office, according to people familiar with the discussions, seeking to deepen a relationship with Xi Jinping strained by the president-elect's threat to impose steeper tariffs on Chinese imports," The Wall Street Journal reported.

"Trump has also talked to advisers about a possible trip to India, according to people close to him," the financial daily said. According to familiar sources, a preliminary level of talks were initiated when External Affairs Minister S

India is all set to host the QUAD Summit composed of leaders from Australia, Japan and the United States. The visit could happen as early as April or in the fall later this year. It is also being considered as a possibility that Prime Minister Narendra Modi might be invited by Trump for a White House meeting this

spring.

A day earlier, Trump had spoken with Chinese President Xi Jinping. Xi has deputed Vice-President Han Zheng to attend Trump's swearing-in ceremony, the first time a senior Chinese official will be present at a US presidential inauguration. External Affairs Minister S Jaishankar would represent India at the inaugur-

Trump invited Xi to his inauguration, however, the Chinese leader never attends the swearing-in of foreign leaders. After the talks, Trump said he held a "very good" phone call with

"I just spoke to Chairman Xi Jinping of China," Trump wrote on Truth Social. "It is my

According to The Wall Street Journal, a Beijing meeting would come at a fraught moment in the relationship between the world's leading superpowers. Along with potential new tariffs on Chinese imports, Trump has also pushed Beijing to crack down on Chinese chemical producers that supply the ingredients for fentanyl to Mexican cartels, it said.

#### TRUMP LIKELY TO SIGN 100 EXECUTIVE ORDERS

When Donald Trump walks into the White House Monday afternoon soon after his swearing-in, 100 plus executive orders would be waiting for him on his Oval Office Desk, which his team has prepared for him to kickoff his second term without wasting any

These executive orders are mainly aimed at fulfilling his poll promises. In an interview to NBC news, Trump said he is planning to sign a "record-setting" number of executive actions on day one. "Well, at least in that category," Trump said when asked if these executive orders would be more than 100. An executive order is an order issued unilaterally by the president who carries the force of law. Unlike legislation, executive orders do not require Congressional approval. Though Congress cannot overturn them, they can be challenged in the court of law.

## Who is Itamar, Isarel minister who resigned from Netanyahu cabinet?

Israel's far-right national security minister resigned Prime Minister Benjamin Netanyahu's Cabinet on Sunday to express his disapproval of the Gaza ceasefire

The resignation of Itamar Ben-Gvir does not threaten the ceasefire, but it does weaken Netanyahu's governing coalition. If other far-right lawmakers leave the government — as Ben-Gvir has encouraged them to do — the prime minister could lose his parliamentary majority, potentially forcing early elections.

It was the latest act of defiance by the 48-year-old ultranationalist settler leader who transformed himself over the decades from an outlaw and provocateur into one of Israel's most influential politicians.

The ceasefire will pause the top compound that houses Gaza. Ben-Gvir opposed the deal because it requires Israel to free hundreds of Palestinian prisoners and to withdraw troops from Gaza's southern border with Egypt — and because it leaves open the possibility of Hamas staying in power in Gaza

Ahead of the resignation, he said the ceasefire was "reckless" and would "destroy all of Israel's achievements." In his Cabinet post, Ben-Gvir oversaw the country's police force. He used his influence to encourage Netanyahu to press ahead with the war in Gaza and recently boasted that he had blocked past efforts to reach a ceasefire.

He also has paid multiple visits to Jerusalem's most sensitive holy site — the contested hill-

war and free dozens of the Al-Aqsa Mosque — hostages held by militants in including last month. In one such visit in July, he said he came to pray for the return of the hostages "but without a reckless deal, without surrendering."

The move, while legal, was seen as a provocation, violated a longstanding ban on Jewish prayer there, and threatened to disrupt months of sensitive negotiations. The site is revered by Jews as the Temple Mount. Ben-Gvir has been convicted eight times for offences that include racism and supporting a terrorist organisation. As a teen, his views were so extreme that the army banned him from compulsory military service. Ben-Gvir gained notoriety in his youth as a follower of the late racist rabbi Meir Kahane. He first became a national figure when he broke a hood ornament off then-Prime Minister Yitzhak Rabin's car in 1995

"We got to his car, and we'll get to him too," he said, just weeks before Rabin was assassinated by a Jewish extremist opposed to his peace efforts with the Palestinians.

Two years later, Ben-Gvir took responsibility for orchestrating a campaign of protests, including death threats, that forced Irish singer Sinead O'Connor to cancel a concert for peace in Jerusalem. The political rise of Ben-Gvir was the culmination of years of efforts by the media-savvy lawmaker to gain legitimacy. But it also reflected a rightward shift in the Israeli electorate that brought his religious, ultranationalist ideology into the mainstream and diminished hopes for Palestinian independence.

## TikTok shuts down as US ban takes effect

TikTok's app effectively shut down in the US, just hours before a law banning the pop-ular video-sharing platform was set to go into effect.

"A law banning TikTok has been enacted in the US Unfortunately, that means you can't use TikTok for now," a message reads when American users open the app.

'We are fortunate that President Trump has indicated that he will work with us on a solution to reinstate TikTok once he takes office. Please stay

While the Biden administration dismissed TikTok's shutdown threat as a "stunt" and handed enforcement to the Trump administration, TikTok maintained that without clear assurances, it had no choice but to suspend its services in the

An internal email to employees stated that President Trump has expressed his intention to work



on a solution to restore TikTok once he assumes office on January 20th. TikTok assured teams are working to resume services as soon as possible. On Saturday evening, a warning appeared in both TikTok and CapCut apps at 9 PM

Easten time: "We regret that a US law banning TikTok will take effect on January 19th, forcing us to temporarily suspend our services. We're working to restore our service in the US as soon as possible. Thank you for your support. Stay tuned." By 10:30 PM ET, users were message that the app "isn't available right now," but expects resolution under Presidentelect Trump. It comes after days of speculation and confusion over the

platform's future. The Supreme Court on Friday unanimously upheld the divestor-ban law, which gave TikTok's

China-based parent company ByteDance until Sunday to divest from the app. The law directed Apple and Google to remove the service from app stores.

It also required web-hosting firms, including TikTok's back-end cloud provider, Oracle, to stop supporting the app or face penalties that could reach into the billions of

dollars, NPR reported. Trump said Saturday that he would most likely give TikTok a 90-day extension.

"The 90-day extension is something that will be most likely done, because it's approblocked from accessing both priate. You know, it's appropri-

fully," Trump said in a call with "Meet the Press" moderator Kristen Welker. "It's a very big situation."The law, which passed Congress with wide bipartisan majorities and was signed by President Biden in April, allows the president to provide a 90-day extension, as long as progress is being made toward a divestiture. Following Friday's Supreme

Court decision, TikTok CEO Shou Zi Chew thanked the president-elect for his commitment to finding a solution to keep the app accessible in the US Chew, who met with Trump at Mar-a-Lago last month, is set to attend Monday's inauguration, the Hill reported.

## Biden spending final full day in office in South Carolina which helped him become president

Joe Biden is spending his final full day in office Sunday in South Carolina, a state that holds special meaning after a commanding win in the 2020 Democratic primary there set him up to achieve his life's goal of being elected president of the United States.On the eve of Monday's inauguration of Republican President-elect Donald Trump, Biden planned to deliver a final farewell from the state that brought him to the dance, as he likes to say.Biden, accompanied by his wife, first lady Jill Biden, was scheduled to visit Royal Missionary Baptist Church in North Charleston to worship and speak on the legacy of the Rev. Martin Luther King Jr., the White House said. Monday is the federal holiday honouring the slain civil rights leader.Afterward, the Bidens will tour the International African American Museum. It was built on a waterfront site where tens of thousands of enslaved Africans were brought to the US from the late 1760s through 1808, according to the museum's website. Rep. Jim Clyburn, D-SC, a key Biden ally, said the trip was Biden's way of saying 'thank you" to the state Joe Biden is showing once again who he is by coming back to the state that really launched him to the presidency," Clyburn told The Associated Press in an interview.

The president delivered a televised farewell address to the nation on Wednesday.Back in 2020, Biden saw his campaign flounder after he lost the opening contests in New Hampshire, Iowa and Nevada. But at the fourth stop, South Carolina — where Black voters make up a majority of the Democratic electorate - he was lifted to victory after Clyburn's endorsement. "I know Joe.

We know Joe. But most importantly, Joe knows us, the congressman said at the time.After winning election and taking office, Biden pushed for South Carolina to move to the head of the line and be the state that opened the Democratic Party's nominating process for 2024, instead of New Hampshire. He easily won the state's primary that year."In 2020, it was the voters of South Carolina who

proved the pundits wrong breathed new life into our campaign, and set us on the path to winning the presidency," Biden said in a statement after winning the primary for the second time.

"Now in 2024, the people of South Carolina have spoken again and I have no doubt that you have set us on the path to winning the Presidency again - and making Donald Trump a loser — again."It didn't turn

out that way. After faltering in a debate against Trump, Biden dropped out of the race under pressure from many Democrats, though Clyburn notably was not among them. Biden endorsed Vice President Kamala Harris, who replaced him as the Democrats' nom-

inee. She lost to Trump.

## Nearly 60 people killed in Colombia

San Juan (PTI ): Officials in Colombia say about 60 people have been killed in the country's northeast region following failed attempts to hold peace talks with the National Liberation Army. Among those killed are seven people who sought to sign a peace deal, as well as community leader Carmelo Guerrero, according to a report that a government ombudsman agency released late Saturday. Officials said the attacks occurred in several towns located in the Catatumbo region, with at least three people who were part of the peace talks being kidnapped. Hundreds of people are fleeing the area, with some hiding in the nearby lush mountains. Colombia's government has demanded that the National Liberation Army, known as ELN, cease all attacks and allow authorities to enter the region and provide humanitarian aid.

## Families of wildfire victims mired in grief

The house was burning with her brother-in-law and nephew inside when Jackie McDaniels flagged down a firetruck and begged for help. "Whoever is in there is no longer alive," she recalled one of the firemen telling her before urging her to flee her Altadena neighbourhood. "I pray to God that they were. But it was horrible to have to leave them there." Now McDaniels, like so many, is facing the gripping realities of grief and questions about what more could have been done. Experts say these survivors are victims themselves; the fires that swept through the Los Angeles area this month were fast-moving and fierce. "It's really just a different beast of a fire when it's this propagating entity of just total mayhem," said Benjamin Hatchett, a fire meteorologist with the Cooperative Institute for Research in the Atmosphere

at Colorado State University. But that doesn't ease the pain or the questions for the families of the more than two dozen killed, some unable to escape, others unaware of what was coming, having survived other blazes unscathed. Among the dead is Dalyce Curry, who rubbed shoulders with some of the elites of old Hollywood in her youth. To family, she went by a different name. "Momma Dee, that's the fire," her granddaughter and namesake, Dalyce Kelley, recalls saying as she drove the 95-year-old to her Altadena home on January 7 after a day of medical tests. But the flames they saw seemed

so far away and power was still on. Now Kelley wishes she would have asked more questions, wishes she would have returned earlier.

'I will live with that regret for the rest of my life," she said. That saddens Jennifer Marlon, a wildfire and climate research scientist at Yale's School of the

Environment. She said larger factors were at play, the summer the warmest on record in California, drying out the vegetation that fuelled the flames. 'These are, by and large, not situations that people could have really anticipated," she said. "It's incredibly tragic that people are blaming themselves and wracked with guilt." # Khyber-Pakhtunkhwa government US rejects Maduro's re-election, but launches op in Kurram district

Pakistan's Khyber-Pakhtunkhwa provincial government on Sunday launched an operation in trou bled areas of Kurram district after armed men attacked an aid convoy transporting goods to Parachinar and killed several people, officials said.

The operation started in four village councils of Lower Kurram district, including Bagan, Mandori, Chapri and Chapripao, to secure the roads and establish lasting peace in the region, where sectarian clashes have left dozens dead since November, they said. The KPK government spokesperson has officially announced the initiation of the operation in troubled areas of the restive Kurram district. The decision was taken at a high-level meeting attended by Chief Secretary KPK, IG Police, and other civil and police officials.

The meeting decided to take strict action against terrorists without any discrimination. The state supports peaceful elements, and oppressors would be brought to justice, officials

## Security forces kill 5 terrorists

Karachi (PTI): Pakistani outs in the neighbouring security forces on Sunday country which shares its borsecurity forces on Sunday killed five suspected terrorists attempting to cross into the Balochistan province of Pakistan from Afghanistan, the ISPR said. According to the military's media wing, the terrorists belonging to the banned Tehreek-e-Taliban Pakistan (TTP) group were killed while trying to infiltrate the Zhob district of the restive province early Sunday. Things seemed to be looking up for Venezuela in 2022. Following years of authoritarian rule and withering economic sanctions, President Nicolás Maduro had agreed to work toward a democratic presidential election. The White House, in return, granted him a financial lifeline: a permit for US energy giant Chevron to pump and export Venezuelan oil.

Oil wells roared back to life and massive tanker ships returned to Venezuela's coast to be filled with heavy, hard-torefine crude destined for the US. Maduro's promised election was neither fair nor free, and the longtime president was sworn in this month for a third six-year term despite credible evidence that his opponent got more votes. Yet, the sanctions reprieve the US offered "to support the restora-tion of democracy" is still helping fill state coffers.

Venezuela's opposition says Maduro's government has earned billions of dollars from exports allowed by the permit. The White House has ignored calls from the main opposition coalition, as well as Republicans and Democrats in the US Congress, to cancel a permit that now accounts for around a quarter of the South American country's oil pro-

Senior administration officials have struggled to explain why the permit has been left in

place under questioning by reporters, saying only that sanctions policy toward Venezuela is frequently reviewed. President Joe Biden told reporters last week he "didn't have enough data" to adjust oil-related sanctions before he leaves office Monday. Venezuela sits atop the world's largest proven oil reserves and once used them to power Latin America's strongest economy. But corruption, mismanage ment and eventual U.S. economic sanctions saw production steadily decline from the 3.5 million barrels per day pumped in 1999, when the fiery Hugo Chávez took power and began his self-described

California-based Chevron Corp., which first invested in Venezuela in the 1920s, does business in the country through joint ventures with the state-owned company Petroleos de Venezuela S.A., commonly known as PDVSA. The joint ventures produced about 200,000 barrels a day in 2019, but the following year, US sanctions imposed by then-President Donald Trump forced Chevron to wind down production.

În 2020, when the COVID-19 pandemic contributed to a 30% decline in the country's economic activity, Venezuela's Central Bank reported yearover-year inflation of over 1,800%. For many, rummaging through garbage in search of food scraps or valuable items became a common activity. Locked out of world oil markets by US sanctions, Venezuela sold its remaining oil output at a discount – about 40% below market prices

to buyers like China and other Asian markets. It even started accepting payments in Russian rubles, bartered goods or cryptocurrency.

Once Chevron got a license to export oil to the US, its joint ventures quickly began producing 80,000 barrels a day, and by 2024, they topped their daily output from 2019. That oil is sold at world market prices. The terms of the license bar Chevron from directly paying taxes or royalties to Venezuela's government. But the company sends money to the joint ventures, which are majority-owned by PDVSA.

"What Chevron is doing is buying oil from joint ven-tures," Venezuelan economist Francisco Rodriguez said. "This purchase of oil is what generates the revenue of the joint ventures," and that revenue pays taxes and royalties to Venezuela's government.

It is not clear exactly how Venezuela's government, which stopped publishing almost all financial data several years ago, uses this revenue. Neither the government nor Chevron have made public the terms of the agreement allowing the company's return to Venezuela. Chevron did not answer questions from The Associated Press regarding the joint ventures, including payments made to Venezuela's treasury.

## S Korea's impeached president arrested

Hours after South Korea's impeached President Yoon Suk Yeol was formally arrested, triggering rioting by his supporters, his lawyers said Sunday that he remains defiant in his refusal to answer questions over the probe into his declaration of martial law last month.

Yoon was formally arrested early on Sunday, days after being apprehended at his presidential compound in Seoul He faces possible imprisonment over his short-lived authoritarian push, which set off the country's most serious political crisis since its democratization in the late 1980s. Yoon's arrest could mark the beginning of an extended peri-

The decision to arrest Yoon Western District Court, where dozens of his supporters broke in and rioted, destroying the main door and windows. They used plastic chairs, metal beams and police shields that they managed to wrestle away from officers. Some were seen throwing objects and using

fire extinguishers, destroying furniture and office machines, smashing glass doors and spraying water on computer servers. They shouted demands to see the judge who had issued the warrant, but she had already left.

Hundreds of police officers were deployed and nearly 90 protesters were arrested. Some injured police officers were seen being treated at ambulance vans. The court said it was trying to confirm whether any staff members were injured and assess the damage to its facilities. In granting law enforcement's request for an arrest warrant for Yoon, the court said he was a threat to destroy evidence. Yoon and his lawyers on Saturday appeared before the court and argued for his release.

The country's acting leader, Deputy Prime Minister Choi Sang-mok, expressed "strong regret" about the riot, saying it "directly undermines democracy and the rule of law." He asked for heightened security at the sites related to Yoon's case, including sures to ensure order during protests.

## 'No excuse for education bans on Af women, girls

Kabul (PTI): A senior Taliban figure has urged the group's leader to scrap education bans on Afghan women and girls, saying there is no excuse for them, in a rare public rebuke of government policy.

Sher Abbas Stanikzai, political deputy at the Foreign Ministry, made the remarks in a speech on Saturday in southeastern Khost province.

He told an audience at a religious school ceremony there was no reason to deny education to women and girls, "just as there was no justification for it in the past and there should n't be one at all." The government has barred females from education after sixth grade. Last September, there were reports authorities had also stopped medical training and courses for women. In Afghanistan, women and girls can only be treated by female doctors and health professionals. Authorities have yet to confirm the medical training

"We call on the leadership again to open the doors of education," said Stanikzai in a video shared by his official account on the social platform X. "We are committing an injustice against 20 million people out of a population of 40 million, depriving them of all their rights.

# **Budget FY26: Government could cut customs** duty on raw materials to boost manufacturing

The government could reduce customs duty on used manufacturing medical electronic equipment, and footwear industries forthcoming Budget to boost local manufacturing, according to tax experts. Deloitte India Partner,

## FPIs take out ₹44,396 Crore from equities in January amid weak earnings outlook, rising dollar

 $F_{\text{out Rs}}^{\text{oreign investors have pulled}}$ Indian equities this month, driven by strength of the dollar, rising bond yields in the US, and expectations of a weak earnings season.

This came following an investment of Rs 15,446 crore in the month of December, data with the depositories showed. The shift in sentiment comes amid global and domestic headwinds. The continued depreciation in

Indian rupee is exerting significant pressure on foreign investors leading them to pull the money out of the Indian equity markets," Himanshu Srivastava, Associate Director -Manager Research, Morningstar Investment Advisers India, said. In addition to that, higher valuation of Indian equities, despite recent corrections, expectation of a rather weak earning season and uncertainty over the pace of economic growth are making investors wary, he added.

According to the data, Foreign Portfolio Investors (FPIs) offloaded shares worth Rs 44,396 crore from Indian equities so far this month (till



January 17)

days this month except January 2. "The principal reasons for the sustained FPIs selling are the strength of the dollar and the rising bond yields in the US. With the dollar index above 109 and the 10-year US bond yield above 4.6 per cent, it is logical for FPIs to sell in emerging markets, particularly in the most expensive emerging market India," Vijayakumar, Chief Investment

Strategist, Geojit Financial Services, said.

Since US bond yields are attractive, FPIs have been sellers in the debt market, too. They withdrew Rs 4,848 crore from debt general limit and Rs 6,176 crore debt voluntary retention route. Vipul Bhowar, Senior Director - Listed Investments

Waterfield Advisors, said that a cyclical improvement in corporate earnings, along with stronger GDP growth driven by resilient domestic consumption and increased government spending on infrastructure projects, could lead to a potential turnaround in FPI flows into India.

The overall trend indicates a cautious approach by foreign investors, who scaled back investments in Indian equities significantly in 2024, with net inflows of just Rs 427 crore.

This contrasts sharply with the extraordinary Rs 1.71 lakh crore net inflows in 2023, driven by optimism over India's strong economic fundamentals In comparison, 2022 saw a net outflow of Rs 1.21 lakh crore amid aggressive rate hikes by

India is not seeking customs duty concessions on over 100 product categories such as liquor, and cigarette in the proposed free trade agreement (FTA), which is under negotiations between the two countries, sources They also said that though the

negotiations were concluded, Oman has sought revision of its market access offers on some products. The two sides have discussed

three to four issues flagged by Oman, and any potential changes would be minimal, they said.

India is expected to gain greater market access for about 98 per cent of its goods in Oman, along with significant access to the services sector.

'There could be about 125-130 tariff lines (or product



categories), where we have not asked for duty concessions and that included goods like liquor, and cigarettes," they added. On January 14, India and Oman held the fifth round of talks for the agreement, which is aimed at boosting bilateral economic ties. The negotiations for the agreement, officially dubbed as Comprehensive Economic Partnership Agreement (CEPA), formally began in Partnership November 2023.

Oman's import duty ranges from 0 to 100 per cent along with the existence of specific

duties. On specific meats, the industry sources said. wines and tobacco products They added that Oman h 100 per cent duty is applicable. According to industry sources, India should not extend duty concessions on petrochemical products, a key demand of Oman.

Indian petrochemical industry which comprises both large public sector units and private players have raised their serious concerns and requested the government not to accede to this demand of Oman, they said. "In petrochemical sector,

feedstock constitutes a significant portion (about 65per cent) of the total product cost such as Polyethylene Polypropylene (PP), Polyvinyl Chloride (PVC), Polyethylene Terephthalate (PET) etc. Therefore, feedstock pricing makes a critical determinant of overall competitiveness in the petrochemical industry,"



and support populations. Without the insurance industry's support, the scheme would not be in place or effective in states adopting an insurance or underpins critical sectors, mitigating financial risks in agriculture, motor, and disaster recovery, économic ensuring resilience," said Singhel.

Notably, Singhel mentioned the industry boasts an impressively low grievance ratio of 0.003 percent against 2.96 billion policies and actively combats fraud, detecting Rs 1.73 lakh crore in fraudulent claims over five years.

"Contrary to the belief that insurers generate massive profits, the industry operates at a loss, with a combined ratio of 115 percent, paying Rs 115 for every Rs 100 earned in premiums. Employing over 6 million people, insurance is a cornerstone of economic growth. 



These issues are not limited to adults. Children and teenagers, too, are increasingly falling victim to inactivity, with screen time often replacing outdoor play. This highlights the urgent need for interventions that promote across all age groups.

High-quality active physiotherapy programs focus on personalised care. A thorough assessment identifies specific issues, such as tight hamstrings, weak





movement and physical well-being core muscles, or joint misalignment, and targets them with tailored exercises. This individualised approach ensures faster recovery and long-term benefits. Moreover, active physiotherapy can improve cardiovascular health, enhance muscle tone, and boost mental wellbeing. Regular movement releases endorphins, reducing stress and anxiety—common side effects of sedentary lifestyles.

> **ACCESSIBILITY: BRIDGING THE GAP:** Active physiotherapy, despite its effectiveness, often remains inaccessible due to factors like cost, geographic constraints, and a lack of awareness. Bridging these gaps requires targeted strategies to make this essential service more widely available. Expanding telephysiotherapy platforms can allow

A PATH TO HEALTHIER LIVES: The challenges posed by sedentary lifestyles are undeniable, but they are not insurmountable. Active physiotherapy provides an evidence-based, patientcentered approach to restoring health and preventing future issues. By making high-quality physiotherapy accessible to all, society can take a significant step toward combating the epidemic of inactivity and fostering a culture of movement and vitality.






