midst surge in the u m a n Metapneumovirus (HMPV) in neighbouring China, India on Monday confirmed three cases of pathogen — two in Karnataka and one in Gujarat. However, the Government and health officials have assured that there is no need to panic as it is not a new pathogen, adding that regular flu shots or even the three Covid vaccine doses makes one immune to this infection.

In Bengaluru, a threemonth-old baby, who has been discharged, and an eight-month-old, who is recovering at a hospital, were the two cases. A two-monthold was also found infected in Ahmedabad in Gujarat with respiratory symptoms and subsequently tested positive for HMPV. All the cases have been detected in children, the Indian Council of Medical Research (ICMR)

said, adding that they were identified during routine surveillance for multiple respiratory viral pathogens. They had no international travel history, added the ICMR, ruling out exposure from other regions or countries.

Even as the number of reported cases climbed to three in the country, health experts and government officials have emphasised that there is no need for alarm, as HMPV has been circulating globally and in India for years where most the population are immune to it. It recently gained attention after its outbreak was reported in

Union Health Minister JP Nadda on Monday said in a video message, that there is no need to panic as health experts have clarified that HMPV is not a new virus and it was first identified in and has circulating in the entire

world since many years.

States dismiss HMPV Naxals blow up DRG vehicle, eight dead

In their biggest strike on **L**security forces Chhattisgarh in two years, Naxals blew up a vehicle using an improvised explosive device weighing 60 to 70kg, killing eight District Reserve Guard (DRG) jawans and their civilian driver in Bijapur district on Monday. Police suspect the powerful IED was planted long back along the route used by DRG, a state police unit involved in antiinsurgency operations.

The explosive device went off near Ambeli village under the Kutru police station area at around 2.15 pm when DRG

personnel from Dantewada district were returning in their Scorpio vehicle after an anti-Naxalite operation, Inspector General of Police (Bastar Range) Sundarraj P said. Eight DRG jawans travelling in the SUV and the driver of the vehicle were killed on the spot, located around 70km from district headquarters Bijapur, the official added.

tified as Ratnakar Bhoi, had cultivated paddy on his twoacre farmland with a hope to repay Rs 70,000 borrowed from a private lender and Rs 35,000 taken from a bank for a

Reports said Dhal had cultivated paddy on eight acres,

but the crop was largely destroyed by the unseasonal and incessant rains. Facing mounting financial pressure from a loan of around Rs 2.5 to Rs 3 lakh, Dhal suffered severe mental distress, leading to his tragic decision.

Preceding the above ordeals, on January 3, two farmers from Ranpur block of Nayagarh died of shock after witnessing the destruction of their harvests.

Meanwhile, the Mohan Majhi-led State Government has declared last month's spell of rains as a state calamity and announced a compensation package of Rs 291 crore to all affected farmers, including those who grew crops other than paddy.



Cops suspect planned murder of BJP leaders Dense fog engulfs many parts of State

Police on Monday assigned a possible planned and premeditated murder angle to the death of the two BJP leaders in a suspicious car accident in Bargarh district on

BIP Goshala Mandal president Debendra Nayak and former sarpanch Muralidhar Chhuria lost their lives on Sunday after their vehicle overturned and skidded off the road on Kantapali over-bridge on Sambalpur-Bargarh National Highway.

Along with the two deceased, a driver and three elling in the car.

The injured, currently undergoing treatment after sustaining severe injuries, alleged that their vehicle was hit intentionally multiple times by a trailer truck that was on their tail. The victims' families alleged a planned murder and lodged an FIR, following which police initiated a probe.

According to the injured BJP workers, their car was first hit by the truck at Kantapali Square. When their car tried to speed away, the truck allegedly rammed them a second

Realising that something

verted towards a village road. Shockingly, the truck continued to chase them and struck the car a third time after following it for some distance.

The repeated hits and the manner of the accident have raised suspicions, and the police investigation is expected to shed light on whether it was an accident or a deliber-

Meanwhile, authorities took the driver of the truck involved in the accident into custody and are analysing CCTV footage from the scene to obtain crucial clues and unearth the truth.

Dense fog engulfed several parts of the State on Monday morning as temperatures remained chilly owing to the cold wave.

The twin cities of Bhubaneswar and Cuttack remained shrouded in intense fog and mist since early morning with visibility limited to nearly 50 meters, causing significant problems for vehicular movement.

6 'priests' held on witchcraft suspicion

Six persons were arrested for allegedly practising witchcraft on the pretext of performing puja to drive out an elderly woman in Chitapari-4 village of Patrel panchayat under Korukonda block in Malkangiri district on Mon-

The arrests occurred in response to allegations centred on the supposed actions of priests who allegedly branded the 67-year-old woman, Bati Khila, a witch, following a series of unexplained deaths of locals and animals. The arrestees are alleged to have collaborated with counterparts from the

neighbouring Chhattisgarh. They conducted rituals on the pretext of a sanctioned religious ceremony, raising suspicions amongst residents.

Upon receiving a tip from villagers, police intervened and halted the ceremony, leading to the arrest of six persons. Police seized various items and a vehicle used during the incident.

"The arrested were forwarded to court following the rejection of their bail pleas. nection and a probe is underway," a police official said.

The farmer suicides are a very sensitive issue. But the State Government has failed to provide assurance to the farmers. The government has failed in achieving zero-casualty. It should immediately provide compensation to the

sharecroppers by amending the Relief Code. There is no coordination in the statements of different ministers. If the farmers' interest are not protected, the Congress would take to the streets, said a Congress delegation which visited the village of a deceased farmer, Krittibash Swain under Balikuda block in Jagatsinghpur district.

The delegation led by Kissan Congress president Amiya Patnaik and also consisting of former MLA Mohhamed Moquim and Congress Legislature Party Leader Ram Chandra Kadma gave an assistance of Rs 1 lakh to the deceased Swain's family.

Organ donor cremated with state honours



Prahlad Raut's pledge has saved many lives

 Γ ollowing his sudden death, a 38-year-old man from Khuntakata village in Athagarh block of Cuttack district was cremated with full state honours on Sunday for his selfless act of pledging to donate his organs.

Prahlad Raut tragically passed away while working at a private event the day before. His decision to donate his organs in case of death became a symbol of his immortality. His organs helped give new life to several individuals in need of a transplant across various hospitals.

Prahlad had married two

years ago and has now left behind a six-month-old daugh-

In similar cases from across Odisha, last year, 18-year-old Om Shibu of Kendrapada district had achieved heights of selflessness after his death due to a brain tumour. After his passing, family members respected his wish and donated his kidneys to the SCB Medical College Hospital, where it then saved two lives.

In another such act, a woman from Brahmapur, who died of brain haemorrhage in 2023, donated all her organs as per her pledge. The organ harvesting, conducted at the Hospital **AMRI** Bhubaneswar, was the largest of its kind and had helped six lives across Odisha, West Bengal and Tamil Nadu.

BJD hits streets over soaring prices Holds BJP govt responsible

Biju Janata Dal (BJD) leaders and workers on Monday hit the streets in Bhubaneswar protesting the skyrocketing prices of essential commodities. They alleged that the BJP government has totally failed to check the price rise.

Holding placards and banners, the protesters gathered at Lower PMG and raised slogans and accused the Mohan Majhi government of crippling the lives of the poor and middle class.

"In New Year 2025, the BJD has descended on the battleground with new motivation, new role and new determination. The battle will go on; the voices of people should be heard. This government is only crippling the citizens with high prices and heavy taxation," BJD leader Arun Sahoo

said. "People have already started boycotting the BJP government in Odisha. Everyone is sad as Naveen Patnaik is not the CM anymore. Everyone is equally angry that this government has come by mistake; forget about the upliftment of people, they are

only looting the people,"

Sahoo alleged.

"This rise in prices is because of the Central government under PM Modi. They are double engine for double taxation and double loot," he further added. However, the BJP claimed that the BJD is doing all the dramas only to gain public sympathy.

"When BJD was in power, Odisha stood No. 1 for high prices in India. Now that they are out of power, they are doing all these dramas. However, people of Odisha clearly know the prices soared under which government," claimed BJP State vice-president Biranchi Narayan Tripathy.

However, he was allegedly abducted near Kota Junction late at night on a deserted stretch of the road.

Spotting the abandoned car, locals grew suspicious and informed the police. Satya's family members also lodged a missing complaint with the police after he failed to answer their calls.

Later, Satya managed to call his family members in the morning and informed them that he was being held hostage at a place in Motu of Malkangiri district.

The businessman's family said that the kidnappers had not made any attempts to contact them nor had there been any demands for ransom. Moreover, after that one call, they failed to establish further contact with Satya.

The Boipariguda police began an investigation into the incident and said the motive of the crime would only be revealed after investigations.

District Election Officer expresses concern over senior AAP leaders exerting pressure

The District Election Officer 1 of New Delhi has raised concerns about senior AAP leaders including Rajya Sabha MPs Raghav Chadha and Sanjay Singh exerting pressure on him to share the personal details of objectors. In a letter to the Chief Election

Officer, Delhi dated January 4, he said, "I am writing to bring to your notice a matter of concern pertaining to the independent functioning of the institution of District Election Officer, New Delhi district. Representatives of the Aam Aadmi Party have been frequently visiting my office and are asking for personal details of objectors which are not mandated to be shared as per

He added that the AAP dele-

December 21, 28, 29 last year and on January 3, 2025 and there have been attempts on their part to exert pressure on me by asking for personal details of the objector and other such information which falls outside the purview of routine operations. He requested the CEO to provide insight and guidance in this matter on whether he is allowed to attend meetings called by the ruling government, without any prior meeting agenda or any other appropriate action as deemed fit by authority

He also mentioned that Chief Minister Atishi has been calling me for a meeting on December 4 without a specified agenda and in the past also, has called me for a meeting without any agenda, wherein discussion regarding electoral rolls

He also wrote to the OSD of the Chief Minister to convey the agenda of the upcoming meeting in advance so that he may come prepared for the meeting as well the timing may be rescheduled to allow me to reach the Office of CM, GNCTD in prescribed time. "In light of this, I respectfully request that the agenda for our

upcoming meeting be shared with me in advance. This would enable me to come prepared and ensure that the meeting is productive," he added. Further, the Additional District Magistrate wrote to the Deputy Commissioner of Police (New Delhi) Devesh Mahla to provide security cover in the office of DEO for ensuring law and order in order to prevent any mishappening.
"I am writing to bring to your



attention the frequent presence of representatives of political parties in the office of District Election Office in light of Delhi Vidhan Sabha elections, 2025. It is imperative to mention that

under such circumstances, there is possibility of breach of peace and pressures being imposed on the office functionaries including DEO in order to disturb the process of conduct of election," the officer

He added, "In light of the above, I kindly request your intervention in deploying adequate police personnel at the location of our office i.e. 12/1 Jam Nagar House, for ensuring law and order in order to prevent any mishappening. The presence of security forces will deter any attempts to sabotage the ongoing election process and help the staff and officers involved in the election process to discharge their duties without fear or coerduties without fear or coer-

Meanwhile, Atishi on Monday alleged a 'voters scam' in the New Delhi constituency from where AAP supremo Arvind Kejriwal is contesting the upcoming assembly elections. She claimed that in the past few

days, 10 percent of new voters had been added to the New Delhi constituency electoral roll, and 5.5 per cent of voters had been deleted.

"In the New Delhi Assembly constituency, which has approximately one lakh voters, between December 15 and January 2, applications for adding 10,500 new voters were submitted. Adding 10,000 new voters in a constituency with one lakh voters could completely alter the election outcome," she said.
"When the

Election Commission summoned these 84 objectors for a hearing, the scam was exposed. The objectors denied filing any applications," she claimed.

The CM also questioned the role of the election commission in the matter and said that the commission's role is 'suspi-

investigated the matter. "I have written a letter to the Chief Election Commissioner regarding this scam in the New Delhi assembly and have asked for time to address our concerns,"

Responding to the AAP accusations, Delhi BJP president Virendra Sachdeva said, "Team Kejriwal must understand that the civil society of Delhi wants to make Delhi free of fake and fraudulent voters. Any political party opposing the removal of fake votes will be ousted by the people of Delhi."

Notification of 'The Delhi Banning of Unregulated | Bidhuri challenges Kejriwal for debate Deposit Schemes Rules, 2024' approved by LG

ieutenant Governor Vinai L'Kumar Saxena on Monday approved the notification of 'The Delhi Banning of Unregulated Deposit Schemes Rules, 2024' by the Finance Department of the Government of the National Capital Territory of Delhi (GNCTD) in a bid to ensure that fraudulent schemes are not used by criminals to dupe hapless residents of their

This initiative is in accordance with Section 38 of "The Banning of Unregulated Deposit Schemes Act, 2019." The rules have special provisions for Self Help Groups as advised by the Ministry of Finance, Government of India (GoI) and Reserve Bank of

The Government of India had enacted the Banning of Unregulated Deposit Schemes Act, 2019, through a gazette notification dated July 31, 2019, to establish a comprehensive framework aimed at prohibiting unregulated deposit schemes,

except those conducted in the ordinary course of business, thereby protecting the interests

As per Section 38(1) of the Act, the State or Union Territory Government, in consultation with the Central Government, is required to issue rules to implement the provisions of the Act. "On October 29, 2020, the GoI forwarded copies of the Banning of Unregulated Deposit Schemes Rules, 2020, and the Karnataka Banning of Unregulated Deposit Schemes Rules, 2020, noting that the Karnataka Government had

developed these rules in consultation with the Ministry of Finance, incorporating sugges tions from the GoI. The GoI urged the GNCTD to expedite the formulation of its own rules under Section 38 of the Act," a statement by the Raj Niwas

It added that in response, the Chit Fund Department drafted the Delhi Banning of Unregulated Deposit Schemes Rules, 2021, based on the rules established by the Karnataka Government. The statement said, "This draft was reviewed by the Law Department, which

advised obtaining the opinion of the then Hon'ble Lieutenant Governor, as required by Clause (4) of Article 239AA of the Constitution. Approval from the Lieutenant Governor was secured before forwarding the file to the Central Government." The draft rules were subsequently submitted to the Ministry of Finance, GoI, under Section 38(1) of the Act. Nine Bangladeshi nationals deported since New Year from central district

Speeding up its crackdown on illegal immigrants in the national Capital even as a between AAP and BJP over the issue, the Delhi Police on Monday claimed that it has deported nine Bangladeshi nationals since the New Year who were staying illegally in the central district of the national Capital.

Iman Hossain, 43 years old Md Sharmin Parvez, 24 years old Rakib Khan, 29 years old Mafujul Islam, 24 years old Shakil Sarker, 38 years old Md Monju Sarker, 36 years old Shahin Danish, 26 years old Taizul Islam and 19 years old Moin "Among the nine Bangladeshi

They include Mohammad Iman Hossain, who entered India illegally after paying an agent, and Mohammad expired in October 2024. Others overstayed their visas and were attempting to acquire Indian identity documents," the DCP said.

PM2.5 pollution up in city for second year on a trot: Report

Delhi's annual PM2.5 levels rose in 2024 for the second consecutive year, despite a 37 per cent drop in stubble burning in Punjab, Haryana and the national capital. The report by the Centre for Science and Environment (CSE) said Delhi's annual PM2.5 concentration increased to 104.7 microgrammes per cubic metre in 2024 -- a 3.4 per cent rise from the 2023 levels. This is also more than twice the national ambient air quality standard of 40 microgrammes per cubic metre. Delhi recorded two major smog episodes this winter: from November 13-20 (about eight days) and

four days). According to the report, the 2024 average is still 9.6 per cent lower than the 2018 peak of 115.8 microgrammes per cubic metre, it is 3 per cent higher

from December 16-20 (about

than the three-year average of 2021-2023, indicating a gradual reversal of earlier gains made between 2018 and 2022. The report highlighted that the total annual fire counts (on account of stubble burning) dropped by 37.5 per cent in 2024 in Delhi, Punjab, and Haryana. Punjab recorded a 75 per cent decline, and Haryana, a 37 per cent decline. "In 2024, the city's annual

PM2.5 levels rose to 104.7 μg/m , marking a 3.4 per cent increase compared to 2023 and standing at 2.6 times higher than the national annual standard of 40 $\mu g/m$. While the 2024 average is still 9.6 per cent lower than the 2018 peak of 115.8 μ g/m , it is 3 per cent higher than the three-year average of 2021-2023, indicating a gradual reversal of earlier gains. Delhi's city-wide win-PM2.5 average for the October-December 2024 stood at 178.3 µg/m , a level consis-

tent with the average since large-scale monitoring began in 2018-19. This season's average was 0.2 per cent lower than the 2019 winter average, but 4.6 per cent higher than the three-year winter average (2021-2023), based on data from 37 monitoring stations across the city". "However, a troubling trend emerges in peak pollution levels. The citywide winter peak for 2024 so ared to 732 μ g/m , marking a 26 per cent jump compared to last year's peak of 580 µg/m. The city-wide peak this year stood at 602 µg/m, recorded on November 18, 2024. The worst station-level peak this season was 9 per cent lower than the highest ever recorded -- at 806 μg/m during the 2018 winter," it added. According to the report, in 2024, approximately 121 days met the National Ambient Air Quality Standards, a trend similar to 2019, when the secondworst annual average was



recorded at 109.1 $\mu g/m$. However, there has been a noticeable decline in the number of good air quality days, dropping from 152 days in 2023 to 121 this year. Annually, while the number of "good" air quality days increased slightly from 25 in 2023 to 29 in 2024,

this improvement was over-

shadowed by a marginal rise in the combined numbers of overall "very poor" or worse category days including "severe" and "severe-plus" categories, which climbed from 107 in 2023 to 111 days this year.

During the winter months (October to December), there were five days of "satisfactory"

air quality -- up from three days recorded in the previous two years; but there were no "good" air quality days. Meanwhile, the number of days categorised as "poor" and "very poor" remained unchanged at 57, reflecting no progress in air quality during this critical peri-

"This winter, only eight out of 37 CAAQMS (stations) showed improvement in their seasonal averages compared to the last three years. The most notable improvements were observed at DTU and NSIT Dwarka, which recorded 26 per cent and 22 per cent lower seasonal averages, respectively, compared to the mean of the previous three winters. On the other hand, three stations --North Campus, Okhla Phase 2 and Jahangirpuri -- showed no change in their seasonal aver-

"CRRI Mathura Road (22 per cent), Aya Nagar (17 per

cent), Ashok Vihar and Vivek Vihar (each 15 per cent) and Pusa IMD (14 per cent) were the top five stations that recorded an increase in seasonal PM2.5 levels compared to previous winters. The seasonal averages ranged from 97 μg/m at DTU to 226 μg/m at Wazirpur, with Anand Vihar emerging as the second

SC orders foreigners to stay in India for criminal proceedings

he Supreme Court on Monday said a foreigner should not be allowed to leave India if required to answer a criminal charge. A bench of Iustices Abhay S Oka and Ujjal Bhyuan said while granting bail to a foreign national, the court should issue a direction to the state or the prosecuting agency, to immediately inform about its order to the registration officer concerned under the Registration of Foreigners Rules, 1992.

"When a foreigner's presence is required in India to answer a criminal charge, permission to leave India must be refused. Under the Order (1948 order), the civil authority can impose restrictions on the movements of a foreigner," the bench said. The bench said the registration officer should then communicate the bail order to all relevant agencies, including the civil authority.

SC's order came in a case where it had decided two main issues concerning bail conditions imposed on a Nigerian national in a drugs case in July,

The top court had held the bail conditions, which allowed an investigating agency to continuously track the movements of an accused, violated the right to privacy guaranteed under Article 21 of the Constitution. In its order passed on Monday,

the bench referred to the provisions of the Foreigners Act, 1946, and said according to clause 5(1)(b) of the Foreigners Order, 1948, no foreigner should leave India without the leave of the civil authority having the relevant jurisdiction. Once a foreigner was released on bail, the top court said, they couldn't leave India without the permission of the civil authority under clause 5 of the 1948

It said if such information was furnished, it would enable the authorities under the Act, the rules and the order, to take

appropriate legal steps. The bench directed a copy of its order to be forwarded to registrar generals of all the high courts, who in turn would forward it to all the criminal courts in the respective states.

The top court was dealing with the question whether it was necessary to implead a foreign registration officer appointed under rule 3 of the Registration of Foreigners Rules, 1992, in the bail application filed by a foreigner within the meaning of the 1946 Act.

The bench said the authorities under the law and the 1948 order have no locus to oppose the bail application filed by a foreigner unless the bail was sought where the allegation was of the offence punishable under Section 14 of the Act. Section 14 deals with penalty

for contravention of the law's provisions, etc.

CJI Sanjeev Khanna recuses from sports constitution cases

A bench of Justices Surya Kant and N Kotiswar Singh said at present AFT, Chandigarh, was burdened by a huge backlog from these states and setting up circuit benches at Jammu and Shimla and Kashmir, Dharamshala, would help in speedy disposal of cases.

Refusing to blame the Centre alone for delay in filling of the vacancies in the AFTs, the bench told attorney general R Venkataramani to explore the possibilities of having circuit benches.

"There are sitting judges of this court who head committees. Even I head some of the committees which look after the appointment of members of the tribunals. Sometimes the workload is so much that the process gets delayed. We have to devise a mechanism so that a process

SC quashes cheating case against Goa MLA

The Supreme Court on Monday quashed a cheating case against a Goa MLA accused of land grabbing and fraudulent sale of property. A bench comprising Justices

Abhay S Oka and Ujjal Bhuyan allowed the appeal of MLA Jit Vinayak Arolkar challenging a March 2023 Bombay High Court verdict dismissing his plea to quash the FIR. The case involved allegations

under Section 420 (cheating) of the IPC, registered on October 26, 2020, at the Pernem Police Station, and then transferred to the special investigation team of the economic offences wing. Gandhi's arrest: A turning point

in the global fight for freedom




His arrest, far from quelling resistance, galvanised the nation, showcasing the power of non-violence as a tool for liberation and freedom

n January 4, 1932, Mahatma Gandhi was arrested after the Congress Party had decided to resume a civil disobedience movement in the wake of emergency measures imposed by the British government. The arrest marked a pivotal juncture in India's struggle for independence and left an indelible impact on global movements for justice and equality. Mahatma Gandhi's philosophy of non-violence and civil disobedience not only reshaped India's freedom struggle but also served as a blueprint for resistance movements worldwide.

The Civil Disobedience Movement, initiated by Mahatma Gandhi in 1930, was a landmark moment in the Indian nationalist struggle. It was launched with the historic Salt March (Dandi Yatra) - where Gandhi defied British-imposed salt taxes, a symbol of colonial exploitation foot-marching from Sabarmati Ashram in Gujarat to the river Dandi, a journey of 241 miles. This movement aimed to undermine British authority through non-violent means such as boycotting British goods, refusing to pay taxes, and disobeying oppressive laws.

By the early 1930s, the movement had gained mass participation but faced severe repression from the British administration. Lord Willingdon, the Viceroy of India, adopted a policy of suppression, seeing Gandhi's leadership as a threat to the stability of British rule in India. On January 4, 1932, Gandhi was arrested under the 'Defense of India Act' for his role in perpetuating 'civil disobedience' - after it was decided by the Congress Party to resume a 'civil disobedience' movement in the wake of emergency measures imposed by the British government in the form of a series of Viceroy's ordinances. The arrest of Gandhi had immediate repercussions in India, sparking a wave of protests and acts of defiance. Historian Bipan Chandra in his book 'India's Struggle for Independence'; (Penguin Books, 1989), writes that Gandhis detention was a "turning point that Orwell criticized the represrevitalized the waning momen-tum of the movement" The arrest



such as the refusal to pay land revenue and the boycott of British institutions, intensified across the country. The arrest also amplified the moral and symbolic power of Gandhi's leadership. His willingness to endure imprisonment demonstrated his steadfast commitment to non-violence and truth. The Indian masses responded with unprecedented solidarity, reinforcing the idea that freedom could be achieved through peaceful resistance.

Gandhi's arrest in 1932 was widely reported in the global press, drawing attention to the Indian struggle for independence.

In Britain, the arrest sparked wide debate. While the colonial government justified the move as a necessary measure to maintain law and order. prominent intellectuals like Bertrand Russell and Georg sion. Orwell in his book 'As I Please: Essays' (1943); Tribune was perceived as an attack on Publishing remarked, "The

paradox of Gandhi's imprisonment lay in the fact that a man advocating peace was treated as a threat to the empire". The arrest also resonated with leaders of other anti-colonial and 'civil rights movements'.

Years later, Martin Luther King Jr. would cite Gandhi's arrest as an example of how moral authority could triumph over systemic oppression. King said, "Gandhi's life and sacrifices teach us that non-violence is not only a method but a philosophy of life,", adding, "The non-violent resistance of Gandhi was the guiding light of our struggle for justice in America".

Gandhi's arrest became a beacon for oppressed peoples worldwide, inspiring movements for freedom and justice. Nelson Mandela, who would later lead the anti-apartheid struggle in South Africa, credited Mahatma Gandhi as the pioneer of non-violent resistance. In his autobiography "Long Walk to Freedom", Mandela wrote, "The spirit of defiance Gandhi embodied in India was equally relevant in South Africa's fight against apartheid".

Historians and political theorists have studied Gandhi's detention in 1932 as a case study in the dynamics of resistance and power. British historian Judith M. Brown, in her seminal work "Gandhi: Prisoner of Hope" (1989) also

points out that Gandhi's imprisonment highlighted the moral contradictions of British colonialism. "By incarcerating Gandhi, the British sought to delegitimize him, but instead they exposed their own vulnerability to ethical critique". International British historian Erik Hobsbawm situates Gandhi's arrest within the broader context of anti-colonial movements. In "The Age of Extremes: The Short Twentieth Century, (1914-1991), Hobsbawm notes that "The imprisonment of Gandhi was not merely an Indian event; it marked the erosion of imperial authority on a glob-

Today, as the world grapples with challenges like systemic injustice, racial inequality, and climate change, Gandhi's principles of civil disobedience remain a guiding light. Some movements such as 'Extinction Rebellion' (a UK-founded global environmental movement and 'Black Lives Matter' draw on the strategies of nonviolent protest that Gandhi exemplified. Mahatma Gandhi's example serves as a reminder that moral courage and non-violent resistance are humanity's most potent tools for building a just and equi-

al scale".

esilience is often mis-understood as an unshakeable strength, but its true essence lies in flexibility and growth. It is not about avoiding pain or adversity but learning to navigate them with courage and purpose. Resilience is the whisper within us that says, "You can rebuild."

S Korean anti-corruption agency, police debate measures to detain impeached president

South Korea's anti-corruption agency and police debated on Monday more forceful measures to detain impeached President Yoon Suk Yeol after their previous attempt was blocked by the presidential security service

The discussions highlighted the obstacles facing the criminal investigation into Yoon's Dec. 3 martial law decree. which led to his impeachment on Dec. 14. The one-week detention warrant was set to expire at midnight, but the agency requested a new court warrant to extend the timeframe for taking Yoon into cus-

The Seoul Western District Court last week issued a warrant to detain Yoon and a separate warrant to search his residence after he defied authorities by refusing to appear for questioning over his brief power grab. Executing those warrants is complicated as long as Yoon remains in his official residence. Yoon has described his power

grab as a necessary act of governance against a liberal opposition bogging down his agen-da with its legislative majority and has vowed to "fight to the end" against efforts to oust him. While martial law lasted only several hours, it set off turmoil that has shaken the country's politics, diplomacy and financial markets for weeks and exposed the fragility of South Korea's democracy while society is deeply polarized.

The Corruption Investigation Office for High-Ranking Officials, which leads a joint investigation with police and military investigators, revealed Monday it had asked police to take over efforts to detain Yoon, following its prominent role in Friday's failure.

However, the anti-corruption agency backtracked hours later after the police stated it could be legally problematic for them

warrants had been obtained by the agency.

The agency, which has faced questions about its competence after failing to detain Yoon, said the efforts to execute the warrants would be carried out under the authority of the joint investigation team but did not clarify whether its approach would change.

When asked about the possibility of deploying police special task forces, the official said "all has vet to publicly comment on the issue. Yoon's lawyers argued the detention and search warrants against the president cannot be enforced at his residence due to a law that protects locations potentially linked to military secrets from search without the consent of the person in charge — which would be Yoon. They also argue the anticorruption office lacks the legal authority to investigate rebellion charges and delegate police

Bangladesh's International Crimes Tribunal issues second arrest warrant against ex-PM Hasina

 $B^{\text{angladesh's International}}_{\text{Criminal Tribunal (ICT)}}$ on Monday issued arrest warrants against deposed prime minister Sheikh Hasina and 11 others, including former military generals and an ex-police chief, for their alleged role in incidents of enforced disappearances.

This was the second arrest warrant by the ICT against Hasina, who fled to India after her Awami League regime's toppling following unprece-dented anti-government protests in August last year. The tribunal has so far recorded three cases against her. 'Justice Md Golam Mortuza

Mojumdar, chairman of the tribunal, issued the arrest warrant after hearing a prosecution plea," an ICT official said.

The Inspector General of Police was ordered to arrest the twelve people, including Hasina, and produce them before the tribunal on February 12 in the case filed over complaints of enforced disappearances of several hundred people.

The deposed premier's thendefence adviser Major General (retd) Tarique Ahmed Siddique and former IGP Benazir Ahmed are among those named in the case. While Siddique is currently under custody, Ahmed is believed to be on the run. ICT Chief Prosecutor Mohammad Tajul Islam did not disclose the names of most of the accused "in the interest of investigations and their arrest".

'The next hearing for this case is also scheduled for February 12. The tribunal has instructed that the investigation report be submitted on that day if completed," Islam later told reporters. He, however, said if the investigation report could not be submitted by then, the law enforcement agencies would have to provide a progress report on the arrests. Islam told the tribunal that the ousted regime had established a culture of enforced disappearances under state sponsorship.



The chief prosecutor alleged that those involved in carrying out these disappearances were rewarded. He added that agencies like the elite anti-crime Rapid Action Battalion (RAB). the police's Detective Branch (DB), the Counter Terrorism and Transnational Crime (CTTC) unit, and the Directorate General of Forces Intelligence (DGFI) were most frequently used for the purpose. "Over the past 15 years,

a culture of fear was established in Bangladesh through enforced disappearances and crossfires. Thousands of people were abducted by various forces, either in plainclothes or in uniform. Most of them never returned," Islam told journalists.

Last month, Dhaka officially sought Hasina's extradition from India. While New Delhi acknowledged the receipt of the letter, it refrained from com-

menting on it. The ICT issued the first arrest warrant against the ex-premier on October 17 on charges of genocide and crimes against humanity committed during the July-August protests and

uprising.
After the fall of the Awami League government, at least 60 cases or complaints of enforced disappearances, killings, genocide, and crimes against humanity were lodged at the ICT, accusing Hasina, leaders of her party and its allies, and senior officials of different law enforcement agencies.

Trudeau likely to resign as Liberal Party leader this week: Report

anadian Prime Minister Justin Trudeau is expected to resign as the leader of the Liberal Party this week amid internal party dissent and low public opinion ratings, according to a media report.

The Globe and Mail newspaper citing sources said it is unclear when exactly Trudeau, who has been Canada's prime minister since 2015, will step down, but a resignation is expected to come before a national caucus meeting on Wednesday.

One of the sources, who spoke recently to the Prime Minister, said Trudeau, 53, realises he needs to make a statement before he meets the Liberal caucus so it doesn't look like he was forced out by his own MPs. The sources said they are unsure about what the Liberal Party's national executive plans to do to replace Trudeau as leader. They said it remains unclear whether he will leave immediately or stay on as

Prime Minister until a new leader is selected. The Liberal Party national

executive, which decides on leadership issues, plans to meet this week, likely after the caucus session, the report said. On Friday, The Globe reported that Trudeau's advisers are looking at how he can remain Prime Minister while a new Liberal leader is selected.

A source said on Sunday they believed that Trudeau would stay in his position until a new leader was chosen.

The party has two options: appoint an interim leader on the recommendation of the national caucus or hold a shortened leadership contest. A leadership contest would require the Prime Minister to request that Governor-General Mary Simon prorogue Parliament, which constitutional experts say is not guaranteed, the paper said.

Another source said it makes sense for Trudeau to remain as Prime Minister until a leader is chosen so he can deal with the incoming US administration of Donald Trump and his threat of 25-per-cent tariffs. A Liberal Party source said a

leadership race would take at least three months, although the party constitution requests at least four months. The news of resignation comes

as Trudeau's popularity continues to dwindle in Canada, which should hold an election by late October.

Public opinion polls show that his party will likely be swept out of power by Pierre Poilievre's Conservatives According to Canadian pollster

Angus Reid, Trudeau has a disapproval rate of around 68 per cent as of December 24. Trudeau faced a difficult few

months in politics. His own party members are calling for his resignation. In September, he faced a no confidence vote in parliament that later failed, despite efforts from the Conservative Party to remove him from office.



On December 16, Finance Minister Chrystia Freeland announced that she was stepping down from Trudeau's cabinet, dealing a significant blow to the prime minister.

Later in December, one of Trudeau's key allies, New Democratic Party leader Jagmeet Singh, said that he planned to present a formal motion of no-confidence

S Korea's military says North Korea fired missile into eastern sea

North Korea on Monday fired a ballistic missile that flew 1,100 kilometers (685 miles) before landing in waters and Japan, South Korea's military said, extending its heightened weapons testing activities into 2025 weeks before Donald Trump returns as US president. The South's Joint Chiefs of

Staff said the midrange missile was fired from an area near the North Korean capital of Pyongyang and that the launch preparations were detected in advance by the US and South Korean militaries. It denounced the launch as a provocation that poses a serious threat to peace and stability on the Korean Peninsula

The joint chiefs said the military was strengthening its surveillance and defense posture in preparation for possible additional launches and sharing information on the missile with the United States and

Japan's Defence Ministry said the missile landed outside its exclusive economic zone and that there were no reports of



damage to vessels or aircraft. The launch came as US Secretary of State Antony Blinken was visiting Seoul for talks with South Korean allies over the North Korean nuclear threat and other issues.

Blinken's visit comes amid political turmoil in South Korea following President Yoon Suk Yeol's short-lived martial law decree and subsequent impeachment by parliament last month, which experts say puts the country at a disadvantage in getting a steady footing with Trump ahead of his return to the White House.

In a news conference with South Korean Foreign Minister Cho Tae-yul, Blinken said they condemn North Korea's latest launch, which violates UN Security Council resolutions against the North, and reiterated concerns about the growing alignment between Pyongyang and Moscow over Russian President Vladimir Putin's war on Ukraine.

According to US, Ukrainian and South Korean assessments, North Korea has sent more than 10,000 troops and conventional weapons systems to support Moscow's war concerns that Russia could transfer North Korea advanced weapons technology in return, which could potentially enhance the threat posed by leader Kim Jong Un's nucleararmed military.

Blinken described the military cooperation between Russia and North Korea as a "two-way street," saying Russia has been providing military equipment and training to the North and "intends to share space and satellite technology.

Blinken and Cho both dismissed concerns about damage to the US-South Korea alliance in the aftermath of the political turmoil in Seoul.

Experts had warned that Yoon's martial law decree which lasted only hours but has rattled politics, high-level diplomacy and financial markets for weeks — exposed the fragility of South Korea's democratic system in a divided soci-

Biden, in 11th hour action, bans new offshore oil, gas drilling in most federal waters

PTI WASHINGTON

President Joe Biden is moving to ban new offshore oil and gas drilling in most US coastal waters, a last-minute effort to block possible action by the incoming Trump administration to expand offshore drilling.

Biden, whose term expires in two weeks, said he is using authority under the federal Outer Continental Shelf Lands Act to protect offshore areas along the East and West coasts, the eastern Gulf of Mexico and portions of Alaska's Northern Bering Sea from future oil and natural gas leasing

"My decision reflects what coastal communities, businesses and beachgoers have known for a long time: that drilling off these coasts could cause irre-

versible damage to places we hold dear and is unnecessary to meet our nation's energy needs," Biden said in a state

"As the climate crisis continues to threaten communities across the country and we are transitioning to a clean energy economy, now is the time to protect these coasts for our children and grandchildren," he said. Biden's orders would not affect large swaths of the Gulf of Mexico, where most U.S. offshore drilling occurs, but it would protect coastlines along California, Florida and other states from future drilling. more than 625 million acres of

Biden's actions, which protect federal waters, could be difficult for President-elect Donald Trump to unwind, since they would likely require an act of

Congress to repeal. Trump himself has a complicated history on offshore drilling. He signed a memorandum in 2020 directing the Interior secretary to prohibit drilling in the waters off both Florida coasts, and off the coasts of Georgia and South

Carolina until 2032 The action came after Trump initially moved to vastly expand offshore drilling, before retreating amid widespread opposition in Florida and other coastal states. Trump has vowed to establish what he calls American "energy dominance" around the world as he seeks to boost U.S. oil and gas drilling and move away from Biden's focus on climate change.

Environmental advocates hailed Biden's action, saying new oil and gas drilling must be sharply curtailed to reduce greenhouse gas emissions that contribute to global warming. 2024 was the ottest in recorded history. 'This is an epic ocean victory!' said Joseph Gordon, campaign director for the environmental

group Oceana. Gordon thanked Biden "for listening to the voices from coastal communities" that oppose drilling and "contributing to the bipartisan tradition of protect-

ing our coasts. Biden's actions build on the legaof Democratic?and Republican?presidents to protect coastal water from offshore drilling, Gordon said, adding that U.S. coastlines are home to tens of millions of Americans and support billions of dollars of economic activity that depend on a clean environment, abundant wildlife

and thriving fisheries.

Pope Francis names first woman to head major Vatican office

Pope Francis on Monday named the first woman to head a major Vatican office, appointing an Italian nun, Sister Simona Brambilla, to become prefect of the department responsible for all the Catholic Church's religious

The appointment marks a major step in Francis' aim to give women more leadership roles in governing the church. While women have been named to No. 2 spots in some Vatican offices, never before has a woman been named prefect of a dicastery or congregation of the Holy See Curia, the central governing organ of the Catholic Church.

The historic nature of Brambilla's appointment was confirmed by Vatican Media, which headlined its report "Sister Simona Brambilla is the first woman prefect in the

The office is one of the most important in the Vatican. Known officially as the Dicastery for the Institutes of Consecrated Life and Societies of Apostolic Life, it is responsible for every religious order, from the Jesuits and Franciscans to smaller newer movements.

In an indication of the novelty of the appointment, and the theological implications involved, Francis simultaneously named as a co-leader, or 'pro-prefect," a cardinal: Ángel Fernández Artime, a Salesian. But the appointment, announced in the Vatican daily bulletin, lists Brambilla first as 'prefect" and Fernández second as her co-leader, which theologically is necessary since the prefect must be able to celebrate

Mass and perform other sacra-

mental functions that current-

ly can only be done by men. Brambilla, 59, is a member of the Consolata Missionaries religious order and had served as the No. 2 in the religious orders department since last year. She takes over from the retiring Cardinal Joao Braz de Aviz, 77

Francis made Brambilla's appointment possible with his 2022 reform of the Holy See's founding constitution, which allowed laypeople, including women, to head a dicastery and become prefects.

Brambilla, a nurse, worked as a missionary in Mozambique and led her Consolata order as superior from 2011-2023, when Francis made her secretary of the religious orders depart-

Her appointment is the latest move by Francis to show by example how women can take leadership roles within the Catholic hierarchy, albeit with-



out allowing them to be ordained as priests.

Catholic women do much of the church's work in schools, hospitals and passing down the faith to future generations. But they have long complained of second-class status in an institution that reserves the priesthood for men

Francis has upheld the ban on

down hopes that women could be ordained as deacons. But there has been a marked

increase in the percentage of women working in the Vatican during his papacy, including in leadership positions, from 19.3% in 2013 to 23.4% today, according to statistics reported by Vatican News. In the Curia alone, the percentage of women

Congo will execute over 170 people convicted of armed robbery

More than 170 inmates on death row were flown from Congo's capital to a high-security prison in the north where they will be executed, Congolese authorities

Seventy of the convicts were transported on Sunday, Congolese Minister of Justice Constant Mutamba said, adding to 102 other prisoners who have already been sent to Angenga prison in the northern Mongala province.

The men have been convicted of armed robbery and are locally known as "Kulunas" or "urban bandits". They're aged between 18 and 35, Mutamba said in a statement. He did not say when the executions would take place.

Some have welcomed the measure as a means of restoring order and security in the cities, while others are concerned about the risks of abuse and human rights violations. "We welcome this decision by the minister because it will help put an end to urban crime. From 8 pm onwards, you can't move around freely because you're afraid of running into a Kuluna," said Fiston Kakule, a resident of the eastern city of Goma. Espoir Muhinuka, a human rights activist, warned of the possibility of extrajudicial executions and called for a strict respect for judicial procedures and fundamental guarantees. He fears that political pressure could lead to unjust convictions and

arbitrary executions.

China protests US sanctions for its alleged role in hacking, complains of foreign hacker attacks

hina has slammed a deci-Usion by the US Treasury to sanction a Beijing-based cybersecurity company for its alleged role in multiple hacking incidents targeting critical US infrastructure, while the Chinese cyber security agency complained Monday of attacks on Chinese networks.

Asked about the sanctions against Beijing-based Integrity Technology Group, Chinese Foreign Ministry spokesperson Guo Jiakun said the country has cracked down on cyber attacks and that Washington was using the issue to "defame and smear China.

"For some time now, the US side has been playing up socalled Chinese cyber attacks and has even initiated illegal unilateral sanctions against China," Guo said. "China firmly opposes this and will take necessary measures to safeguard its legitimate rights and interests?

Integrity Technology Group said the move by Washington had "no factual basis."

"The company firmly opposes the US Treasury Department's unwarranted accusations and Illegal unilateral sanctions on the company," the company, also known as Yongxin

Zhicheng Technology Group, said in a statement Monday to the Shanghai Stock Exchange. The China National Cyber Security Information Center said it had discovered attacks from various malicious websites and foreign IP addresses, including some in California and Florida. It also reported attacks from the Netherlands, Singapore, Mexico, Turkey and Vietnam using Trojan programs, botnets, phishing, theft of intellectual property and

violations of privacy. 'They pose a major threat to China's domestic networked units and internet users and some activities have been suspected of criminal offenses," the center said in a notice on its WeChat social media site.

On Friday, the Treasury's Office of Foreign Assets Control hit Integrity Technology with sanctions that block access to US property and bank accounts and prevent the targeted people and companies from doing business with Americans. It cited alleged multiple hacks against US victims, including incidents attributed to Flax Typhoon, a Chinese state-sponsored campaign that targets US critical infrastructure.

The sanctions did not appear to be related to an incident in Department reported that Chinese hackers had remotely accessed several of its worksta tions and unclassified documents in a major breach of cybersecurity.

The Treasury Department said it learned of that problem on Dec. 8, when a third-party software service provider, BeyondTrust, flagged that hackers had stolen a key "used by the vendor to secure a cloud-based service used to remotely provide technical support" to workers.

US officials are grappling with the fallout from a massive Chinese cyberespionage blitz known as Salt Typhoon that they say gave officials in Beijing access to private texts and phone conversations of an unknown number of Americans.

Late last month, officials said at least eight telecommunications companies, as well as dozens of nations, had been affected by

Salt Typhoon. Integrity Technology said the sanctions would not adversely affect its business since it does not operate in the US and has no assets there. It added that it abides by all laws and regulations and that it "has always adhered to the corporate vision and mission of bringing a sense of security to the world."

Austrian far right gets mandate to try to lead govt for first time since World War II

The leader of Austria's Freedom Party received a mandate Monday to form a new government, which would be the first headed by the far right since World War II if he succeeds.

The Freedom Party, led by Herbert Kickl, won Austria's parliamentary election in September, taking 28.8% of the vote and beating outgoing Chancellor Karl Nehammer's conservative Austrian People's Party into second place.

But in October, President Alexander Van der Bellen gave Nehammer the first chance to form a new government after Nehammer's party said it wouldn't go into government with the Freedom Party under Kickl and others refused to work with the Freedom Party

at all. Those efforts to form a governing alliance without the far right collapsed in the first few days of the new year and Nehammer said Saturday that

he would resign. The People's Party then signaled that it might be open to working under Kickl. Van der Bellen said after meeting Kickl for about an hour at the presidential palace Monday that he had tasked the Freedom Party leader with holding talks with the People's Party to form a new government.

I did not take this step lightly," the president told reporters. I will continue to take care that the principles and rules of our constitution are correctly respected and adhered to."

The far right and the conservatives have governed together before, but on previous occasions with the Freedom Party



WGC further noted that the Reserve Bank of India (RBI) continued with its 2024 buying streak, adding a further 8 tonnes to its gold reserves in

India's services sector growth hits four-month high in Dec on new biz orders



India's services sector growth touched a four-month high in December, supported by new business inflows on strong demand conditions and easing inflationary pressures, a monthly survey said on Monday.

The seasonally adjusted HSBC India Services Business Activity Index, rose from 58.4 in November to 59.3 in December, highlighting the strongest rate of expansion in four months.

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

According to the survey, demand buoyancy continued to drive new business inflows higher, which in turn supported output growth and prompted firms to recruit additional workers.

"India's services companies expressed strong optimism in December as business activity growth surged to a four-month high. Forward-looking indicators such as new business and future activity suggested that the strong performance will likely continue in the near future," Ines Lam, Economist at HSBC, said.

On the price front, there was a softer increase in cost burdens, though panellists continued to report greater outlays on food, labour and materials. Selling price inflation also eased in December.

"The easing of input price inflation in the month also sup-

growth fell to a 12-month low in December, as new business orders and production expanded at softer rates.

Service providers remained confident that output would increase over the course of the coming 12 months. The overall level of positive sentiment fell from November's sixmonth high but remained

The combination of new business growth, upbeat forecasts and rising capacity pressures supported another round of job creation across the service

The rate of employment growth softened from November, but was sharp and among the strongest seen since data collection began in December 2005," the survey

Meanwhile, private sector companies in India posted a faster increase in output at the end of the calendar year. At 59.2 in December, up from 58.6 in November, the HSBC India Composite Output Index signalled the strongest rise for four months.

Composite PMI indices are weighted averages of comparable manufacturing and services PMI indices. Weights reflect the relative size of the manufacturing and service sectors, according to official GDP

Strength in the services PMI stands in contrast with the growing signs of a slowdown in the manufacturing industry," Lam noted.

Trade Unions on Monday pressed for increasing minimum EPFO pension 5 times to Rs 5,000 per month, immediate constitution of the 8th Pay Commission and higher taxes on super rich in the upcoming 2025-26 Budget.

In their customary pre-budget meeting with Finance Minister Nirmala Sitharaman, trade union leaders also demanded an increase in income tax exemption limit to Rs 10 lakh per annum, social security scheme for gig workers, and restoration of old pension scheme (OPS) for government employees.

The Budget for 2025-26 will be presented by Finance Minister Nirmala Sitharaman on February 1.

Talking to reporters after the meeting TUCC National General Secretary S P Tiwari said the government should stop all privatisation and corporatisation of PSUs and impose an additional 2 per cent tax on super rich to fund social security for informal



Tiwari also demanded that agriculture workers be extended social security and their minimum wages should also be fixed.

Bharatiya Mazdoor Sangh Organising Secretary (Northern Zone) Pawan Kumar said that the minimum pension under EPS-95 should be increased from Rs 1,000 per month to Rs 5,000 monthly as a first step and subsequently linked to the VDA Dearness (Variable Allowance).

Harbhajan Singh urges BCCI to end 'superstar culture' in team

India spinner Harbhajan Singh has urged the BCCI to end the "superstar culture" in the team and pick players for future assignments solely on the basis of performance and not on reputation.

Harbhajan's stinging remarks came after India's 1-3 Test series defeat to Australia for the Border-Gavaskar Trophy for the first time in a decade.

"There is a superstar culture which has developed. We don't need superstars, we need performers. If the team has them (performers), it will move forward. Whoever wants to become a superstar should stay at home and play cricket there," the spin great said on his Youtube channel

"There is a tour of England coming up. Now everyone has started talking about what will happen in England, who will go, who will not go. For me, it is a simple matter. Only players who

can't keep picking players on their reputation

'If you do that, then you should take Kapil Dev sir and Anil bhai also. Here, the BCCI and the selectors will have to be firm and act tough. I don't think that the superstar attitude is taking the team forward."

Captain Rohit Sharma and star batter Virat Kohli were woefully out of form during the justconcluded Test series against Australia. The series defeat resulted in the team losing out on qualifying for the World Test Championship final.

Kohli could manage only 190 runs in his nine innings in the series Down Under, repeatedly offering edges to the slip cordon or keeper. Harbhajan said the struggling players should play some form of cricket and prove themselves if they wish to be picked for the England Test tour.

"Virat has played 11 Tests in 2024 and scored 440 runs. The average is 23.15, with one hundred and one fifty. Such an average may be unheard of because he is a very big name. This stat is obviously very low. When I saw it, it was a






