he sacred banks of the Ganga, Yamuna, and the mystical Saraswati came alive with a

sea of humanity as the Maha Kumbh commenced on the auspicious day of Paush Purnima with over 1.65 crore people took a dip at the holy river.

Pilgrims from every corner of the country, carrying faith in their hearts and offerings in their hands, gathered to take the first holy dip. The air was filled with reverberating chants of "Har Har Gange" and "Jai Shri Ram," creating an atmosphere of divine fervor.

The banks of the Sangam turned into a kaleidoscope of colors as people dressed in traditional attire thronged the ghats. Children played in the shallow waters, their laughter mingling with the chants of mantras, while elders sat in prayer, their lips murmuring sacred hymns. The youthful enthusiasm was especially striking, with many capturing the moments on their phones and sharing them instantly. "It's a proud moment for us to be here and celebrate our culture with the world," said 22-year-old Aniket Mishra from Allahabad, holding a selfie stick as he stood at the edge of the waters.

The spiritual energy was matched by nature's grace, with a light drizzle the previous night followed



by a cool breeze enhancing the sanctity of the occasion. Pilgrims The were seen lighting diyas, offering flowers, and performing rituals on the ghats. "The cold water feels like the blessings of the goddess herself. This is not just a bath; it's a spiritual rebirth," said Ramesh Gupta, a trader from Delhi who had traveled

with his family for the occasion. elaborate security arrangements ensured a smooth flow of devotees. Police personnel stood alert at every corner, guiding the crowds and maintaining order. Drones hovered overhead, providing real-time monitoring from the Integrated Command and Control Center. "We feel safe and cared for. The arrangements this year are truly commendable," said Kavita Joshi, a teacher from Uttarakhand.

overcharging anyone, and everything is running smoothly." Similarly, Sunil from Bhadohi, who is serving tea at the event, expressed gratitude for the opportunity. "I've come here for 45 days to earn a livelihood. On this chilly first day, tea is being served to the devotees without any extra charge," he added.

Mahakumbh 2025 is turning into a unique confluence of commerce and charity, as the first day witnessed both thriving business and widespread acts of generosity. Various organisations set up Bhandaras across the fairgrounds, distributing food and tea in abundance to the countless devotees present.

From piping hot Khichdi to Puri Sabzi, devotees were treated to a variety of meals, while tea was served at numerous stalls throughout the day.

Renowned saints, including Satua Baba, have also extended hospitality by organizing Bhandaras and making arrangements for devotees to stay in their camps, ensuring that no one leaves without being cared for. This seamless blend of spiritual service and economic activity highlights the inclusive spirit of Mahakumbh.

MUMBAI

The equity benchmark Sensex cracked over 1,000 points to dive below the 77,000 level on Monday, tracking heavy selling in global equities and a spike in international crude prices. A strong US jobs data, which dampened early rate cut expectations, the rupee logging its steepest single-day fall in nearly two years and unabated foreign fund outflows also dampened investors' sentiment.

Falling for the fourth straight the session, 30-share BSE benchmark Sensex tanked 1,048.90 points or 1.36 er cent to finally settle at 76,330.01. During the day, it plunged 1,129.19 points or 1.45 per cent to 76,249.72.

The NSE Nifty dropped 345.55 points or 1.47 per cent to close at 23,085.95.

From the 30-share blue-chip pack, Zomato cracked nearly 7 per cent. Power Grid, Adani Ports, Tata Steel, NTPC, Tata Motors, Tech Mahindra, Mahindra & Mahindra, Asian Paints, Sun Pharma and UltraTech Cement were the other major laggards.

In contrast, Axis Bank, Hindustan Unilever, Tata Consultancy Services and IndusInd Bank were the gainers.

The Uttarakhand High Court has ordered that the private Ayurvedic medical colleges in the State cannot charge the hiked fee ordered by them in 2019 for students who secured admission during the 2017-18 and 2018-19 academic sessions. The court quashed the order of the appellate authority which had granted permission for hike in tuition fee from the 2017-18 academic session. A provision has been made to implement the fee decided by the regulatory commission in its meeting on April 4, 2019 from the 2019-20 academic session.

not submitted the hiked fee, they had not been issued NOCs by the colleges and as a result, the university had not issued them certificates. Due to this, the students were unable to even undergo internships, the petitioners had stated.

## clip of man cleaning potatoes with feet for samosas goes viral

The Food Safety and Drug Administration (FDA) took legal action against an eatery in Haldwani after a video clip showing a man cleaning potatoes with his feet went viral on social media. The same potatoes were allegedly used to make samosas in the shop. The video sparked outrage on social media after which the FDA raided the premises on Monday. The Haldwani food safety officer Sanjay Kumar confirmed the authenticity of the video during the inspection. He, along with his team, questioned the shop owner and the employee featured in the footage. Following their investigation, the

department decided to suspend the shop's license and file a case in the ADM court. The team also collected samples of the food prepared at the shop and sealed the establishment

until further notice. Kumar said that the shop owner reportedly admitted that the video indeed originated from her establishment. "She ac-knowledged the incident, attributing it to an employee's misconduct during her absence. Despite her explanation, the authorities are proceeding with legal action to ensure food safety and hygiene standards are

maintained," Kumar said. He also added that this action serves as a warning to businesses to adhere to hygiene standards or face strict consequences

## **Human error behind Pauri bus accident** that claimed six lives

 $T_{\rm has\ dismissed\ allegations}^{\rm he\ Transport\ department}$ that the Garhwal Motor Owners Union Limited (GMOU) bus which fell into a gorge about 100 metre deep in Pauri on Sunday was old or technically unfit. The accident of the bus carrying 28 passengers of whom six died, was caused primarily by human error on the part of the driver, as claimed by the department. Considering the increasing rate of frequent accidents in mountainous areas of Uttarakhand, many have been speculating that operation of unfit buses is the main reason behind these accidents.

This is the second accident within a month in which a bus fell into a gorge and claimed several lives. On December 25, an Uttarakhand Transport Corporation (UTC) bus claiming five lives. It was speculated at that time that too the bus was not suitable for operation. The bus had also reportedly exceeded its operational age limit in 2023 and should have been decommissioned as running on the mountainous human error," the Pauri RTO enforcement.







## The calculus behind global invitations

The guest list of Republic day, over the years has reflected India's growing global aspirations, balancing diplomacy with pragmatism

eyond the obvious suggestions of bilateral bonhomie and relationship, there is an invisible calculus of cold strategy in inviting foreign Heads of State to events like the Republic Day, in the Indian context. This year, the President of Indonesia, Prabowo Subianto, graces the occasion. Last year it was the French President, Emmanuel Macron, who heads what the Hudson Institute has described as "India's new best friend". This is unsurprising, given that France was one of the rare countries to avoid condemning India's nuclear test (later emerged as amongst the foremost nuclear fuel and reactor suppliers), supports Delhi's bid to become a permanent member of the United Nations, besides offering strategic defence platforms like Rafale fighters, Scorpène submarines etc.

Before Macron it was the Egyptian President Abdel Fattah el-Sisi (reviving memories of Nehru-Nasser era) whose visit signified India's increased leverage within Ummah (Islamic world), negating Pakistan's ageold rhetoric. Still earlier were stal-warts from BRICS comity i.e., Brazil and South Africa, which was reflective of India's expanded outreach and ambition to assert its strategic independence, beyond superpower-led 'Blocs'. But one region that has increasingly concerned India in terms of the duality of opportunities and threats, is from the East feeding its 'Act East' (evolved from prior 'Look East') policy.

Part of the opportunities is to stitch alliances and further the latent opportunities of the prosperous ASEAN region, and part of its security concern is the shared fear of China's expansionism which makes these Eastern countries, natural allies with India. Therefore the 2018 guest list for the Republic Day parade was a virtual who's who of Heads of State under the commemorative theme 'Shared Values, Common Destiny' from Brunei, Cambodia, Indonesia, Laos,



between the two Asian countries, Indonesia as the world's largest Muslim population country with institutionalised tenets of religious tolerance and diversities, has much in common with India. But perhaps the most significant commonality is the wounded history with China as the purge unleashed by Indonesian dictator and strongman, Suharto (killing between 0.5 to 1 million communists, also banning Chinese literature, culture and diplomatic relations) took HEADS OF STATE decades for the Sino-Indonesian diplomatic rela-

tions to reopen in 1990. But it is the brazen Chinese claims of territorial usurpation in the South China Seas that affect Indonesia the most, especially with its sovereignty over the Natuna Islands getting repeatedly punctured by Chinese transgressions. China's infamous nine-dash line formulation has consumed the waters of the Natuna Islands from a cartographical sense, even though the Permanent Court of Arbitration Kuling validated Indonesian claims. But it is an issue that remains testy with Indonesian President Prabowo Subianto

recently signing a memorandum of understanding with the Chinese for "joint maritime development" whilst acknowledging an "overlapping claim" – it was a move of acknowledgement that was slammed by many international commentators who believe it gave credence and support to Chinese claims.

That said, the usually unconcerned Indonesians who had warmed up to the Chinese with its Belt & Road Initiative (BRI) largesse and other investments are gradually becoming more Sino-wary and concerned. The visit of the Indonesian President to India will be carefully watched in Beijing for what is said or suggested during the visit. Besides the Chinese angularity, there are enough commercial and diplomatic stakes to be tapped bilaterally, which chooses the Indonesian Head of State, very apt and strategic.

ohn and Hazel are a couple in their eighties. They were our neighbours at a mountain resort in Germany and were on a two-week holiday. They had come from the UK, driving nonstop for hours. ### **DECODING ANCIENT LANGUAGES**

Madam — The Chief Minister of Tamil Nadu MK Stalin has announced a prize of \$1 million for deciphering the script of the Indus Valley Civilisation (IVC), or Harappan Civilisation, aka Dravidian Civilisation, the Bronze Age culture that originated in the Indus River valley around 6000 BCE. For over a century, "the pictographic and logo-syllabic script, probably standing for one or two languages, has been the most vexing problem for epigraphists and archaeologists. However, "Indus script scholars John Marshall, Yuri Knorozov, Nikita Gurov, Kamil Zvelebil, Asko Parpola, Iravatham Mahadevan and Bryan Wells agree that the language underlying the Indus script is Dravidian." A science paper pointed out that the Indus Valley people spoke a Dravidian language, while the Vedic people spoke an Indo-European language, Sanskrit.

The paper argues, "A possible scenario combining genetic data with archaeology and linguistics is that proto-Dravidian was spread by people of the Indus Valley Civilisation." At an event in Chennai to mark the centenary of the IVC, Stalin said that the discovery of Sir John Marshall, the then Director General of the Archaeological Survey of India, completely changed the understanding of India's past. Stalin added that the discovery debunked the claim that Aryans and Sanskrit originated in India. Marshall's argument that the IVC predated Aryan (Vedic) civilisation and that the language in the Indus Valley could be Dravidian was a turning point in history. Ironically, his statue is being installed in Tamil Nadu, though he is credited with discovering IVC through excavations in Harappa and Mohenjodaro, now in Pakistan.

A woman of immense strength and boundless compassion, she dedicated her life to healing

lways be associated with people who are good at heart, said Swami Vivekananda. My mother shared her birthday with Swami Vivekananda (12th January). She nurtured strong bonding with spiritually inclined stalwarts. I recall her association with Sathya Sai Baba, Ganapathi Sachchidanda Swamiji, Raghavendra Swami Mutt, Swami Chinmayananda, Jiddu Krishnamurti, Mahesh Yogi and Gurudev Sri Sri Ravi Shankar. She wanted to pursue medicine but life did not take that trajectory. So, she upended the pyramid and became a gualified medical social worker and worked diligently at the Rajan Babu TB (RBTB) Hospital, in Delhi.

Gurudev says, "Open your hands and sky is in your hands." To combat and challenge the disease of tuberculosis she initiated several rehabilitation projects. This included a creche for the children of those afflicted with this malady, a Stitching Centre, candle and match-making units.She used to tell patients and their children that "Fear is only as deep as the mind allows." Thus, patients afflicted with TB, but not bedridden participated in the projects. This was what she called "Diversionary Therapy". Climate changes, civilisations collapse, governments change, political affiliations alter and even the best possible model collapses

This is inevitable. It was extremely traumatic for my mother and she became a patient of Paroxysmal Atrial Tachycardia (PAT). This is a type of arrhythmia (irregular heartbeat). Paroxysmal means that the episode of arrhythmia originates and terminates abruptly. Atrial implies the arrhythmia starts with atria or in the upper chambers of the heart. The tachycardia results in a significant increase in the heartbeat per minute. It is accompanied by severe sweating, dizziness, palpitations, angina, and



acute breathlessness. Normally a patient suffers from such a condition owing to emotional upheavals, physical exhaustion, deep anxiety, and consumption of caffeine or alcohol. She was administered medication but it worked only to an extent. The real help came in the form of a pentagon-shaped talisman. That is through Siddha Healing, Pranic Healing, the 10-day Vipassana Course and the Part 1 and Part 2 Art of Living courses

Indisputably it is the infinitesimal and scientific power of breath. Breathing techniques, meditation, medication and proper diet changed the trajectory of the life of the patient and brought back the mojo in her life. The year 2020 A virulent virus that is assumed to have originated in the dragon land of China assumed monstrous proportions and spread like a pandemic across the swathes of the globe. The robust lady, a woman of substance contracted the disease on the 23rd of December that year, a day after I was detected positive with the pestilence. Six days before when she would have celebrated her eighty-fourth birthday, and despite testing negative for COVID, life was snuffed out and she entered the empyrean. She was on the ventilator, something my mother would have abhorred as the lethal virus had entered her lungs. Strangely at 7:30 a.m. that morning, though enfeebled by the pernicious disease, I was performing Sudarshan Kriya and had a premonition that my mother had entered Vaikuntha. A few minutes later my wife knocked on the door and with misty eyes and a choked voice conveyed the news. We are yet to recover from the body blow. My mother used to get up at twelve in the night and followed a strict regimen that included Vipassana meditation, Pranic Healing, Siddha Healing, Mudra Pranayama and then Sudarshan Kriva. This lasted for almost six hours. She was also religious in taking her short walks... how did she contract the disease and leave for her heavenly abode? Destiny or Karma?

## Deciphering the concerns in State of Forests Report 2023

While the total forest and tree cover rose by 1,445.81 sq km since 2021, the findings reveal deeper concerns about the health and sustainability of India's natural forests



he Forest Survey of India (FSI) has a few weeks ago released its 2023 state of Forest report which shows an increasing trend in forest and tree cover in the country. The current assessment has shown a very meagre increase in forest cover by 156.41 sq km compared to the past assessment of 2021. However, the total forest and tree cover of the country has increased by 1445.81 sq km compared to the last assessment of 2021.

The results are good to show to the nation that its forest machinery is doing a good job in maintaining and also increasing the resources it is managing and controlling. This also is a good political tool in the hands of the Central government to show its success in conserving the forest resources and the overall environment. However, as the saying goes 'the proof of the pudding is in the eating. The benchmark of any such professionally well-prepared report can be judged only if it shows the correct picture

overall scenario demand a serious rethink on the way we manage our forest bio-diversity, even though India is ranked 3rd in top ten countries for an average net gain in the forest area. Let us discuss some of the points for action by the professionals/ administrators as well as the political leaders.

Before I flag the issues let us accept the fact that Trees outside the recorded forests are to the tune of 30.7 million ha which is 37.11 per cent of the total forest and tree cover of the country. All kinds of plantations like rubber, coconut, palm, areca nut etc are also included in it have saved the foresters from criticism with around 1289.40 sq km increase in tree cover between 2021 and 2023 and 20,286.57 sq km almost a 20 per cent increase since 2013. On Paris's commitment to carbon stock India had compared to 2005 had already reached 2.29 billion tonnes of carbon capture. One of the issues of serious concern is the fact that the canopy density of over 40,709.28 sq km has shifted from high-density (70 per cent) and medium (40 per cent and above) density forests to open-category forests (10 per cent or less canopy density). A major portion of this must be in recorded forests and catchments of major rivers and the habitat of Tigers. Apart from this 5573 sq km of good or open forest forests have become scrub and refractive wastelands. Thus almost 46707 sq km of forests have become nonforest inside the recorded forests as per page 73 of the report. Apart from this glaring forest /tree cover losses are in major forested states like Madhya Pradesh, Karnataka, Andhra

Pradesh, Assam, Gujarat, Tripura, Telangana, Ladakh and Nagaland, North-eastern states and Himalayas.

However, some states reported an increase also and among them are Chhattisgarh, Rajasthan and Uttar Pradesh but the question today is how healthy is our forests. Now let us take the condition of regeneration. Only 48 per cent of the recorded forests have adequate natural regeneration 24 per cent have inadequate regeneration and another 9 per cent have no regeneration at all and for the last 10 years, there has been a severe loss of regeneration.

The condition of forests should not be assessed by carbon growth or tree numbers but by the condition of reserve and protected forests Prime Minister Manmohan Singh which are the source of more than when he asked him to make 450 rivers and rivulets of our country and source of recharging the aquifers, binding the soil and controlling the hydrology so vital for sustaining the food, nutritional, climate, livelihoods and water security of millions of people of the country. So in a nutshell, we may feel happy to have a figure of 82 million ha of forest and tree cover (25.17 per cent of geographic area) which covers 71 million ha of forest cover (21.76 per cent) and 3.4 per cent Tree cover. But the fact is we have only 9 million ha of very dense forests with 70 per cent canopy density and 24. 35 million ha of forest with 40 per cent and above density. Another 18.5 million ha is with 10 per cent density or above and this includes the Green Wash area outside the recorded forests on private lands adjacent to recorded forests. Thus only 33 million ha of forest

cover is worth good density in the recorded forests compared to 30 million ha of trees outside the forests. Thus the real good forest is only around 10 to 11 per cent of the geographic area and it must give a wakeup call to foresters and political leaders. One of the reasons is the poor implementation of the Forest Right Act 2006 which has become an apolitical tool in the hands of competitive politics.

The Director General of Forests who is the Chief Technical Advisor of the government of India must tell the Prime Minister and Forest minister of the real situation in natural forest management as a professional like the then Army Chief Gen Vij told adjustments in Siachin area and do not be hawkish. He told him firmly that being a professional he would never agree and after his presentation the Prime Minister supported him. The IFS lobby should propose immediate remedial measures and one of the measures should be to change the format of the future State of Forest Report of FSI. The first part should only deal with the assessment of forests in recorded forests, the second part should deal with Trees outside forests and the third part should deal with fire management, carbon and change matrix etc. Hope the powers that be will notice the suggestion given here and stop the hotchpotch reporting. ## Los Angeles wildfire death toll surges to 24

fter a weekend spent block-A fifer a weekend spent block-ing the explosive growth of fires that destroyed thousands of homes and killed at least 24 people in the Los Angeles area, firefighters got a slight break with calmer weather but cast a wary eye on a forecast for yet more wind.

Should that happen, already burned homes and valleys could flare anew, sending embers to unburned territory miles downwind. New fires could add to the complication. The death toll surged late Sunday with an update from the Los Angeles County medical examiner. At least 16 people were missing, a number authorities said was also likely to rise.

The relative calm Sunday allowed some people to return to previously evacuated areas, however.

The National Weather Service issued red flag warnings for severe fire conditions through Wednesday, with sustained winds of 50 mph and gusts in the mountains reaching 70

Meanwhile, the death toll rose to 24 over the weekend. Eight deaths were attributed to the Palisades Fire and 16 to the Eaton Fire, according to the Los Angeles County coroner's office.

The toll could rise still more as cadaver dogs conducted systematic searches in levelled neighbourhoods. Authorities established a centre where people could report the missing. Officials also were building an online database to allow evacuated residents to see if their homes were damaged or destroyed. In the meantime, LA city Fire Chief Kristin Crowley urged people to stay away from scorched neighbourhoods.

'There are still active fires that are burning within the Palisades area, making it extremely, extremely dangerous for the public," Crowley said at Sunday morning briefing. 'There's no power, there's no water, there's broken gas lines, and we have unstable struc-

## Gaza ceasefire talks press on in Qatar

srael and Hamas appear to be Linching closer to a phased ceasfire agreement, officials said Monday.

But a deal hasn't been reached yet, and there are a number of obstacles that could still scupper the talks in Oatar. The war in Gaza has ground on for more than 15 months, starting on Oct 7, 2023, when Hamas militants stormed into southern Israel and killed about 1,200 people, and abducted around 250. A third of the 100 hostages still held in Gaza are believed to be dead.

More than 46,000 Palestinians have been killed in Israel's offensive, according to Gaza health authorities, which don't distinguish between fighters and civilians.

Israel and Hamas have been holding indirect talks for more than a year aimed at ending the war in Gaza and returning scores of militant-held hostages in exchange for Palestinians imprisoned by Israel.

There has been intensive mediation by the United States, Qatar and Egypt. But the talks have repeatedly stalled over several key issues. They include details of the exchange, whether the ceasefire would be permanent and the withdrawal of Israeli forces. The war has ground on as each side has accused the other of backtracking. US and Arab mediators made significant progress overnight toward brokering a ceasefire in the Israel-Hamas war and the release of scores of hostages held in the Gaza Strip, but a deal hasn't been reached

European Union foreign ministers will meet in late January to discuss easing sanctions imposed on Syria, the bloc's foreign policy chief said on Sunday. However, she said the move would depend on Syria's new rulers carrying out an inclusive political transition after last month's overthrow of

president Bashar Assad. Kaja Kallas' comments came at a gathering of top European and Middle Eastern diplomats in the Saudi capital of Riyadh to discuss Syria's future.

Saudi Arabia called for the lifting of sanctions, which threaten to undermine Syria's recovery from nearly 14 years of civil war that killed an estimated 5,00,000 people and displaced half the country's prewar population of 23 million. European countries and the US have been wary over the Islamist roots of the former insurgents who drove Assad out of power and who now lead an interim government. The former rebels have promised to hold a national dialogue summit that includes different groups across Syria to agree upon a new political road map leading to a new constitution and an election. Kallas said EU foreign ministers will look at how to ease sanctions during a January 27 meeting in Brussels.

'But this must follow tangible progress in a political transition that reflects Syria in all its diversity," she said in a post on the social media platform X. She also posted a photo of herself meeting the new Syrian foreign minister, Asaad al-Shibani at Sunday's gathering. The US, the EU and some Arab nations began imposing sanctions on Syria after Assad's brutal crackdown on the 2011 uprising against his rule and tightened them as the conflict spiralled into war.

Some of the measures are against individuals in Assad's government, including freezing of assets. But many target the government in general, including bans on many financial and banking dealings, on oil purchases and on invest-

ment or trade in some sectors, crippling the wider Syrian economy

German Foreign Minister Annalena Baerbock said sanctions against "Assad's henchmen who committed serious crimes" must remain in place. But she called for "a smart approach to sanctions, providing rapid relief for the Syrian population.

Vancouver (PTI): Canada's out going Prime Minister Justin Trudeau on Sunday suggested that US President-elect Donald Trump's remarks about Canada becoming America's "51st state" has distracted attention from the harm that steep tariffs would inflict on US consumers.

Trump has threatened to impose 25 per cent tariffs on all Canadian imports.

'The 51st state, that's not going to happen," Trudeau said in an interview with MSNBC. "But people are talking about that, as opposed to talking about what impact 25 per cent tariffs (has) on steel and aluminium coming

into the United States." Trudeau told MSNBC, "No American wants to pay 25 per cent more for electricity or oil and gas coming in from Canada. That's something I think people need to pay a little more attention to?

Trump has also said that if Canada merged with the US, taxes would decrease and there would be no tariffs.

"I know that as a successful negotiator he likes to keep people off balance," Trudeau said of Trump's threats to use econom ic force to turn Canada into the 51st state. Trump has also erro-neously cast the US trade deficit with Canada - a natural resource-rich nation that provides the US with commodities

like oil — as a subsidy. Canadian officials say that if Trump follows through with his threat of punishing tariffs, Canada would consider slapping retaliatory tariffs on American orange juice, toilets and some steel products. Already during Trump's first term in the White House, Canada responded to Trump's tariffs on Canadian steel and aluminium with its own on American products like bourbon, Harley Davidson motorcycles and playing cards. "He got elected to try and make life easier for all Americans, to support American workers," Trudeau said of Trump.

Afghanistan with his family at the time of the 2021 collapse of the US-backed government, was abducted by the Taliban in

August 2022 while on a business trip and Glezmann, an airline mechanic from Atlanta, was taken by the Taliban's intelligence services in December 2022 while travelling through the country. Officials believe the Taliban is

Dakar (Senegal) (PTI): At least 40 farmers were killed in an attack by Islamic militants in northeast Nigeria's Borno state, a government official said Monday. The attack Sunday was suspect ed to have been carried out by extremists from the Boko Haram group and its breakaway faction that is loyal to the Islamic State group in Borno's Dumba community, said Borno state Gov

Babagana Umara Zulum. He warned civilians to stay within designated "safe zones" that have been cleared by the army of both extremists and munitions. Zulum also called for an investigation into the attack by the armed forces.

"Let me assure the citizens of Borno that this matter will be thoroughly investigated for further necessary action.

Let me use this opportunity to call on the armed forces to track and deal decisively with the perpetrators of this heinous act of violence against our innocent citizens," he said.

Boko Haram, Nigeria's homegrown jihadis, took up arms in 2009 to fight Western education and impose their radical version of Islamic law.

The conflict, now Africa's longest struggle with militancy, has spilled into Nigeria's northern neighbors. Some 35,000 civilians have

been killed and more than 2 million have been displaced in the northeastern region, according to the UN.

The 2014 kidnapping of 276 schoolgirls by Boko Haram in the village of Chibok in Borno state - the epicentre of the conflict - captured the attention of the world.

rowing complexity in the Gcyber landscape is further exacerbating cyber inequity, deepening the divide between developed and emerging economies, and widening the gap between large and small organisations, the World Economic Forum said on Monday. In its Global Cybersecurity

Outlook 2025, the WEF said nearly 54 per cent of large organisations have identified supply chain interdependencies as the greatest barrier to achieving cyber resilience.

About 45 per cent of cyber leaders were also found to be concerned about disruption of operations and business processes. It further found

that geopolitical turmoil has or intellectual property theft affected the perception of as their top concern. risks, with one in three CEOs The WEF report said that the citing cyber espionage and rising complexity in cyber loss of sensitive information space arises from the rapid

growth of emerging technologies, prevailing geopolitical uncertainty, the evolution of threats, challenges, regulatory

vulnerabilities in supply chain interdependencies and the growing cyber skills gap. Cyberspace is more complex and challenging than ever due to rapid technological advancements, growing cybercriminal sophistication and deeply interconnected supply chains," WEF Managing Director Jeremy Jurgens said calling for Jurgens said, calling for collaborations between public private and sector stakeholders to secure the benefits of digitalisation for all. The study found that 66 per

cent of organisations expect AI to have a major impact on cybersecurity in 2025, but only 37 per cent reported having processes in place to assess the security of AI tools before deployment.

fter wasting a set point in the second tiebreaker with **L** an ill-conceived drop shot, Jannik Sinner quickly reverted to what's been working for him and finished off a straight-set win over Nicolas Jarry to begin his

Australian Open title defense. The 7-6 (2), 7-6 (5), 6-1 victory on Rod Laver Arena extended Sinner's winning streaks to 15 on both the tour and on hard courts in Grand Slams.

After all the pre-tournament attention on the 2024 doping cases of Sinner and long-time women's No. 1 Iga Swiatek, both started the year's first Grand Slam tournament about the same time on nearby courts on Day 2. "Yeah, I was curious to see how it was," Sinner said of the reception at Rod Laver, where he became a fan favorite last year. "You never know what's happening. I was happy about the crowd. It was a nice atmosphere.

Top-ranked Sinner had to grind

for two long, tiebreak sets against No. 35-ranked Jarry, a 29-year-old from Chile, before finding his touch.

"It was a very close one because the first sets, they can go both ways," Sinner said. "In the third set when I broke it the first time, that gave me a little bit of room to breathe.

## Regularly peeping into past glory keeps Sindhu hungry for more success

When the going gets tough for P V Sindhu, the star badminton player dives into her highly successful past to seek inspiration to keep going in her quest for more glory. The 29-year-old has in her

cabinet every trophy and medal that is there to be won. She is one of the only three Indians to win two Olympic medals, and is also a world champion besides claiming medals at Asian Games and

Commonwealth Games. But Sindhu struggled to repeat her international success last season, the medal-less show at the Paris Olympics raising doubts about her future in the sport she dominated for so long.

Sindhu however, For speculations don't not matter. She still steps on the court with the same passion that has catapulted her to the zenith of world badminton.

"Of course yes," Sindhu told were days where I was injured PTI in an interview when asked if she still has the hunger to keep going. "I am saying this because when

you see those wins, how happy it makes you and how much confidence it gives you, that itself will take you to another level. Seeing wins again and again keeps that hunger going, so definitely yes.

There are some clips when you are really young when you look at it, it feels like wow, you know, you have done so much and you know why can't I do it more? You question yourself, and that's when it all starts, so yes," Sindhu said during an interaction facilitated by sports brand PUMA, which has signed her as an ambassador.

Sindhu understands that she will have to endure plenty of struggles but she can't afford to lose hope.

"I have seen a lot through sport, it was important for me to believe in myself when there

and I didn't know if I can come back and I can be my 100 per cent, which happened in 2015, when I had an injury, but then I bounced back, and I got a silver at Rio.

\*My life has changed a lot since the time I started and till now I have had a lot of awards, rewards which has given me a lot of confidence. I am very grateful for whatever I have achieved and when I look back, I can tell that yes I have done whatever I could

Wins and losses are part of the learning curves. So what has been the biggest learning for Sindhu?

"Being patient. That has taught me a lot in life, being patient and wait for the right time because sometimes game teaches you to be patient no matter what.

You have to keep waiting till you get whether it is success or whether it is the right time or whether it is the right shot... you are actually at your lows.



You have to wait for the right time to do the right thing." Sindhu said self-belief

"I am very lucky to say that I have parents who are sports persons and they know what it is and what it takes because they have experienced so much that they tell me that this is what happens and you need to be stronger and you need to come back stronger."

Sindhu was candid in admitting that digesting defeats is still difficult for her despite so much success in her career.

"It does hurt, it does hurt at any point of time even though let's say if you don't have to prove anything, or if you have achieved everything and what is left you might ask me what else is left?

"For me I feel that there is a lot of time left and I can win a lot of tournaments and I can play

because if you are fit and if you are injury free I think passion towards the sport itself will take you much more longer."

She also emphasised that the relationship between a coach and an athlete needs to be very clear in terms of what is going in your head on and off court. "A coach needs to understand even if I am not able to say what is happening in the court. As a coach you know he understands what you feel. So it is very important to also have that trust between a coach and

an athlete? Sindhu has a clear plan for the 2025 season when she will compete in select tournaments to avoid injuries.

"There are a lot of tournaments every month. We are out for like 15 days, 20 days. Definitely I will pick and choose a tournament because as you said I need to stay injury free. That is very important. If you stay injury free that's when you go and give your 100 per cent.

"There are some tournaments where BWF says that you have to play, but apart from that, the players are also smart enough to pick and tournaments." choose

Sindhu said she is still evolving as a player, working on her skills because "the game has been changing so much."

'People have become really strong in their defense so to break that, you have to work on that. You have to also work on defense. Not everyone gives you chance to attack. Because I'm a tall player and I have a good reach, so not everyone will give you a chance to attack, so accordingly you have to make changes

Sindhu also hoped that the gulf between her and the next generation will be bridged sooner than later.

"I am hoping that the gap closes soon. There are a lot of youngsters I have seen in the Sved Modi (recent tournament she won) doing really well.

## **Barcelona thrashes Real Madrid 5-2 to win Spanish Super Cup final**

Real Madrid came out looking for some "clasico" against Barcelona but ended up being embarrassed again. Madrid lost 5-2 to Barcelona

in the Spanish Super Cup final at Jeddah, Saudi Arabia, on Sunday. That followed a 4-0 loss at home to Barcelona in the Spanish league in October.

Kylian Mbappé put Madrid ahead early in his second clasico, but Barcelona then ran away with goals by Lamine Yamal, Robert Lewandowski, Raphinha – who scored twice - and Alejandro Balde.

Rodrygo scored for Madrid on the hour mark after goalkeeper Barcelona Wojciech Szczesny was sent off early in the second half. It was the third straight win for Barcelona in 2025 after it lost two games in a row to

end last year. "The Christmas break helped us reflect on what we had done wrong," Lewandowski said. "Now we can look forward to the run of games that we have until the end of

the season." Madrid lost for the first time after a run of five consecutive victories.

"It was a bad night," Madrid coach Carlo Ancelotti said. "It's a disappointment, we won't hide it, but it's soccer ... You have to try to learn from the losses. We have to look forward to what's ahead." Mbappé had been contained when the rivals met in October but scored a superb goal five minutes into the



The contingent is the biggest ever but focus would be on a handful of tried-andtested names, especially the men's doubles team of Satwiksairaj Rankireddy and Chirag Shetty, when Indian shuttlers go up against a world-class field in the India Open Super 750 tournament beginning here on Tuesday

Despite the name, Indian success at the tournament hasn't been particularly regular with none from the host nation winning any title in the past two editions.

The 21-strong group that will take the court this week would be desperate to change that statistic and make some amends after an ordinary Olympic campaign six months ago.

The expectations would be especially high from Satwik and Chirag, who claimed the doubles title in 2022, the same year in which the currently erratic Lakshya Sen notched the men's singles top honour.

The tournament will feature 18 of the world's top-20 men's singles players and 14 of the top-20 women's singles shuttlers.

Chirag and Satwik, who are former world number ones, have made a good start to the season by reaching the semifinals of the Malaysia Super 1000 last week. Despite the Paris Games disappointment, they have emerged as India's most reliable performers over the last two years by regularly making the deep end of the draws.

They would be expected to do the same in the USD 950,000 event to be held at the KD Jadhav Indoor Stadium here.

Satwik and Chirag, semifinalists at the 2024 China Masters, will face Malaysia's Wei Chong Man and Kai Wun Tee in their opening round

While the Indians have shown impressive form, they will be seeking improvement in quick rallies and service variations in a bid to better their runners-up position in the tournament last vear.

However, the Indian pair will face stiff competition from top names such as China's Olympic silvermedallists Liang Weikeng and Wang Chang.

Also there in the field are Paris bronze-medallists Aaron Chia and Soh Wooi Yik of Malaysia,
