

# 12 runover by train in Jalgaon

At least 12 passengers were killed on Wednesday evening when they jumped from their train in panic due to a 'fire incident', only to be run over by another train on the adjacent tracks in North Maharashtra's Jalgaon district, officials said. Twelve bodies were sent to the nearby civil hospital while six to seven persons were injured, special Inspector General of Police Dattatraya Karale said. The accident took place between Maheji and Pardhade stations near Pachora, more than 400 km from Mumbai, where the 12533 Lucknow-Mumbai Pushpak Express had halted after someone pulled the chain around 5 pm, Central Railway officials said, without confirming the death toll. Some passengers of the Pushpak Express jumped off, and were hit by the oncoming Karnataka Express heading from Bengaluru to Delhi, said Central Railway's chief spokesperson Swapnil Nila. IG Karale said that a "fire incident" occurred on Pushpak Express, at km 372/07 between Maheji and Pardhade stations. The train stopped at the location, and some passengers disembarked. Train No. 12627, Bengaluru-New Delhi Karnataka Express hit people standing on the railway tracks, he added. "Six to seven people have been injured. All injured passengers are being treated at the hospital, none of their injuries are serious. Both trains have reached their respective next stations and the accident site has been cleared," the senior police official added. Pushpak Express departed from the spot in just 15 minutes, while the Karnataka Express was removed within 20 minutes after the accident.

## 14 killed in Karnataka road mishaps

As many as 14 people were killed and 24 sustained injuries in two separate road accidents occurred in Uttara Kannada and Raichur districts on Wednesday. In the Yellapura incident, a truck carrying 29 fruit sellers fell into a 50-metre-deep valley in the wee hours of Wednesday, police said.

The victims from Savanur in Haveri district, were heading towards the Yellapura fair to sell fruits. The accident occurred in a forested section, the Uttara Kannada Superintendent of Police M Narayana said. He added that there was no protection wall in the road there. "Eight persons were killed on the spot and two got critical injuries. The injured have been shifted to the KIMS Hospital in Hubballi," the officer said. Two critically wounded persons too died, failing to respond to treatment, sources said.

Prime Minister Narendra Modi, Union Home Minister Amit Shah and Karnataka Chief Minister Siddaramaiah condoled the tragic incident. "An ex-gratia of Rs 2 lakh from PMNRF would be given to the next of kin of each deceased. The injured would be given Rs 50,000," the Prime Minister Office said in a social media post. In the Raichur incident, at least four persons including three students were killed and nine others injured when the vehicle they were travelling in overturned due to a tyre burst on Wednesday morning, police said.



# BJP-AAP WOO MIDDLE CLASS

## Modi targets AAP



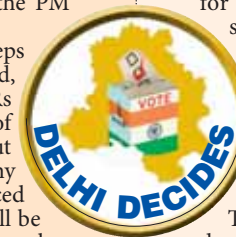

Turning the heat up ahead of the Delhi Assembly elections, Prime Minister Narendra Modi on Wednesday slammed the ruling Aam Aadmi Party (AAP) for failing to provide basic needs such as water to the people of the national Capital while taking a jibe at the party on the money laundering linked excise policy scam, stating that 'liquor is available but water is not'. Prime Minister made these remarks during his interaction with the booth level workers in the 'Mera booth, sabse mazboot' programme while urging the members of the Bharatiya Janata Party (BJP) in the Capital to target winning over 50 per cent booths in the Assembly polls. Assuring a landslide victory in the Assembly polls, he asked booth workers to set two goals- breaking all voting records and ensure that the BJP gets more than 50 per cent at each booth. He said that the AAP is making new announcements daily because they are getting the new news of defeat every day. "These AAP-da people are now making a new announcement every day. This means that they are getting new news of defeat every day.

They are so scared that they have to make a new announcement every morning but now the people of Delhi have understood their game," he said.

"These days these AAP people are raising slogans that 'fir aayege, fir aayege (we will come again)'. But the public is replying to them that 'ye fir khayege, fir khayege (they will eat again, they will eat again)," Modi said, attacking the AAP on corruption charges. Claiming that there is a lot of anger against the AAP government in public, Modi asserted that the common man is saying that 'We will remove AAP and bring BJP to power'. He also said that the AAP leaders have turned away from their ideology. "This party was formed in the name of Jan Lokpal. But today it is neither in Delhi nor in Punjab nor do they speak in its name. They make excuses in Delhi, but they have a government in Punjab and they are not doing it there either," he said. "BJP kept Ram Mandir, Article 370, UCC at the core of its ideology and worked on them with complete honesty. There is only one focal point of our ideology - Nation First," he added.

He also slammed both the AAP and Congress for not fulfilling their promises to the women. "Lakhs of sisters of Himachal are still waiting for the fulfillment of Congress' promise. First the sisters of Haryana and then those of Maharashtra too were misled by Congress by making false announcements," the PM said. Stating that the AAP is two steps ahead of the Congress, he said, "AAP-da had promised to give Rs 1,000 every month to the sisters of Punjab. It's been three years but they haven't given a single penny yet. In Delhi too, it was announced a long time ago that Rs 1,000 will be given to every woman; that money has not been received yet. But now they are announcing an increase in it. This is the first such AAP-da model in the world, which only makes announcements in the air, lies, and deceives."

## Kejriwal bats for salary class

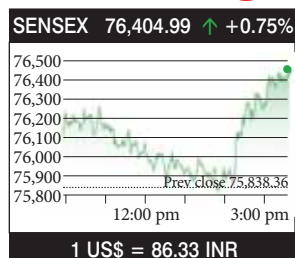
Terming the middle class a victim of tax terrorism and has been reduced to the government's ATM, Aam Aadmi Party (AAP) national convener Arvind Kejriwal on Wednesday unveiled his party's manifesto for the upcoming Delhi elections and Union Budget-2025, listing seven Budget demands from the Centre that AAP MPs will raise in Parliament for the interests of the middle class. Kejriwal accused other political parties of treating the middle class as "just an ATM for the government" saying the middle class is the real superpower of the Indian economy but has long been ignored and exploited solely for tax collection. The party's key demands from the Centre include increasing the education budget from 2% to 10%, providing scholarships for higher studies, enhancing the health budget, removing essential

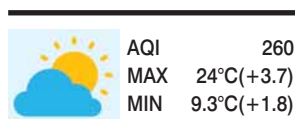

commodities, introducing a pension scheme for senior citizens, and offering a 50% concession on railway tickets for senior citizens. This is the first time that a political party in Delhi has tried to address issues of middle class. Delhi's middle class, which comprises a significant 45 percent of its population and could provide to be a key deciding factor in the upcoming polls. The poor account for 35 per cent, the middle class 45 per cent, and the upper class around 20 per cent of Delhi's population.

## Saif Ali's family properties marked as enemy property

In a setback to actor Saif Ali Khan, recuperating from attack, Madhya Pradesh High Court has asked him to approach the appellate authority against an order of the Central Government that declared historical properties of the Pataudi family in Bhopal, estimated to be worth Rs 15,000 crore, as "enemy property".

Among the properties in question are the Flag Staff House, where Saif spent his childhood, the luxury hotel Nour-U-Sabah Palace, Dar-U-Salam, Bungalow of Habibi, Ahmedabad Palace, and Kohefiza Property. The court had been hearing Khan's challenge since 2015. On December 13 last year, after the Government apprised the court that an "appellate authority has been constituted for adjudication of disputes in regard to enemy property", Justice Vivek Agarwal said the parties could file a representation within 30 days.

## Tahir Hussain denied bail for Delhi Assembly poll campaign

Former Councillor and accused Tahir Hussain on Wednesday failed to secure an interim bail to campaign for Delhi assembly polls after a Supreme Court bench gave a split verdict. While Justice Pankaj Mithal dismissed Hussain's plea saying no case was made out, Justice Ahsanuddin Amanullah opined he could be released on interim bail. The matter would be placed before Chief Justice Sanjiv Khanna for the constitution of a new bigger bench to decide the issue. Observing the right to contest elections was not a fundamental right, Justice Mithal said allowing interim bail could open a Pandora's box as every undertrial would invoke the same ground. "In the event interim bails are to be allowed for purposes of contesting elections, it will open a Pandora's box. Since elections are all year round, every undertrial would come with the plea that he wants to participate in elections and



therefore be granted interim bail. This would open floodgates, which in our opinion can't be permitted," he said. The judge added, "Once such right is recognised, as a sequel, the petitioner would ask for right to vote, which is circumscribed by Section 62 of the Representation of Peoples Act." Releasing such a person on interim bail would amount to permitting the accused to go for door-to-door canvassing and hold meetings in the

locality where the crime took place and witnesses reside, he said.

"Hence, there is a high possibility of the accused meeting the witnesses. The chargesheet reveals serious allegations against the accused and that the rooftop of his house/office was used as the "epicentre" for the offences," said Justice Mithal. He said it was worth mentioning that canvassing for 10-15 days would not suffice the purpose in as much as a constituency has to be nurtured for years, for contesting. "If petitioner had not nurtured it for the past few years sitting in jail, there is no reason why he should be released," he said. While acknowledging the allegations against Hussain were grave and serious, Justice Amanullah said they were only allegations at the present moment. He said the petitioner was in custody since March, 2020, and had secured bail in most cases and the Delhi High Court allowed him to file nomination.

## Five sentenced to death for gangrape-murder of minor

A court in Chhattisgarh has sentenced five men to death for the gangrape-murder of a 16-year-old girl and the killing of her two family members in 2021, holding that the crime has shocked the collective conscience of society. The Fast Track Special Court in Korba district sentenced to death Santram Manjhwra (49), Abdul Jabbar (34), Anil Kumar Sarthi (24), Pardeshi Ram (39) and Anand Ram Panika (29) and handed a life sentence to the six accused, Umashanakar Yadav (26). While delivering the judgement on January 15, Additional Sessions Judge Mamta Bhojwani held that this inhuman and cruel act of the accused is extremely perverted, heinous, brutal and cowardly, said special public prosecutor Sunil Kumar Mishra on Wednesday. A copy of the order was made available on Monday. Those given the death penalty were convicted under sections 302 (murder), 376 (2)G (gangrape) and other sections of the Indian Penal Code (IPC) and provisions of the Scheduled Caste and Scheduled Tribe (Prevention



of Atrocities) Act and Protection of Children from Sexual Offences (POCSO) Act. The lawyer said he had sought the death penalty for all six accused but Yadav was sentenced to life imprisonment on medical grounds. Yadav's medical examination had shown that he underwent a surgery following an accident that damaged his private parts. His involvement in the rape was not established but his role in the conspiracy and murder was found and he was sentenced accordingly, Mishra added. In 2021, the teenage girl was allegedly gang-raped and bludgeoned with stones before she was dumped in a forest leading to her death

near Gadhpurda village under Lemru police station area of Korba district. The accused also killed the girl's father, aged around 60, and his four-year-old granddaughter who were with her. According to police, the deceased man, a resident of Barpani village, had been working as a cattle grazer at the house of prime accused Manjhwra since July 2020. On January 29, 2021, Manjhwra offered lift to the man, his 16-year-old daughter and four-year-old granddaughter to their village on his motorcycle. On the way, they stopped at Korai village and Manjhwra consumed liquor following which the other men also joined him, they said.

The men took the trio to the foot of a hill surrounded by forest near Gadhpurda where the 16-year-old girl was gang-raped in front of her father. After thrashing all the victims with stones and sticks, they dumped them in the forest before fleeing from the scene, police said. Four days after the crime, when the deceased man's son approached the Lemru police station saying three members of their family were missing, cops swung into action and rounded up the six men on February 2, they said. After questioning them, police reached the crime site the same day and found the injured teenager alive and two others dead. The rape victim died while being rushed to a local hospital, police said. The victims belonged to the Pahadi Korwa tribal community, a Particularly Vulnerable Tribal Group (PVTG). Citing police investigation, Mishra said that Manjhwra was pressuring the teenage girl to become his second wife. When she and her family objected to this, Manjhwra and his five associates raped and killed her and also murdered her two family members.

## PM Modi to visit Kumbh on February 5

## Jammu village sealed amid mysterious deaths

Raising a 'red flag,' the District Magistrate Rajouri has declared Badhaal village, which has so far witnessed 17 deaths due to 'mysterious illness' since December 7, 2024, a 'containment zone' under section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS) with immediate effect. Section 163 of the BNSS gives magistrates the power to issue written orders in urgent situations. According to the order issued by the office of the District Magistrate, Rajouri on January 21, 2025, "In view of the recent health situation in the Badhaal area and to curb the spread of infection the following orders are issued under section 163 of BNSS". Meanwhile, four villagers including three sisters have been admitted to the hospital in the last 24 hours.

On Tuesday, Aijaz Ahmad a 25-year-old youth had some symptoms of the mysterious disease, he was later taken to GMC Jammu from where he was shifted to PGI Chandigarh under special arrangements. Three sisters were rushed to the GMC, Rajouri on Wednesday morning. The doctors are monitoring their health

condition; if required, the trio will be shifted to GMC, Jammu. According to the order issued by additional district magistrate (Rajouri) Rajeev Kumar Khajuria, the village has been divided into three containment zones - the first covering all families where deaths have occurred.





# U'khand tableau artistes clinch second prize in Delhi

The folk artists who will perform in Uttarakhand's Republic Day tableau clinched the second prize at a cultural programme organised at the National Stadium Camp in New Delhi on Wednesday. Tableau artists from various States showcased their cultural programmes and dances representative of their respective States. Uttarakhand secured the second-best position in the competition, achieving recognition for the second time since the State's formation in 2000. Earlier in 2018, Uttarakhand's tableau artists had received the third-place award.

Informing this, the joint director and team leader of

the Information department, K S Chauhan said that a 16-member team which would perform at the R-Day parade for Uttarakhand participated. "Each team will be given 30 minutes to present their performance, focusing on their folk culture. The Uttarakhand team presented the Jagar singing and folk dance Chhapeli which was selected for the award by a committee formed by the Central government. The committee appreciated the reflection of Uttarakhand's rich folk culture in their performance and this is what led to the State's achievement," he added.

Chauhan noted that the tableau artistes had prepared diligently since Janu-

ary 14 to achieve this accomplishment. "It is a matter of pride for Uttarakhand to secure the second position nationally. Following this, the tableau artists will present cultural performances at esteemed venues, including Rashtrapati Bhawan and Prime Minister's residence. Besides, events will be hosted to be attended by the Vice President, Defense minister and the Union minister of Tribal Affairs after January 26," he said.

Notably, Uttarakhand will present a tableau based on the theme of cultural heritage and adventure sports at this year's Republic Day parade.

# Police arrest absconding accused in cow slaughter case in Dehradun

The Police arrested the absconding accused Anees Ahmed involved in the recent cow slaughter incidents in the Patel Nagar and Basant Vihar areas of Dehradun on Wednesday. The police also recovered beef which had been hidden by the accused, the Dehradun senior superintendent of police Ajai Singh said. The incidents took place late on January 18 in the Patel Nagar area near Sukha Talab and Alka Dairy as well as at Tea Estate in the Vasant Vihar area. Following these incidents, separate cases were registered under relevant sections of the law. Following an encounter at Harbhajwala Tea Estate on January 20, police arrested two individuals, identified as Waqel alias Chhota and Arish, along with their accomplice, Nadeem. The SSP

said that during interrogation, they revealed the involvement of two other individuals, Farman and Anees Ahmed. Ahmed was identified as the buyer of the beef from the incidents. The police started conducting raids at their possible hideouts to nab them. Singh said that acting on a tip-off on Wednesday, the police arrested Ahmed, a resident of Haridwar but had been residing in Mehuwala of Patel Nagar. Ahmed reportedly confessed to purchasing beef from the other four accused. Fearing repercussions due to protests by Hindu organisations, he admitted to hiding the remaining beef in a black plastic bag near Tea Estate, the SSP said. Based on his disclosure, the police recovered the concealed beef, he added.

# Rs 10 Cr approved for government college construction at Bahadarpur Jat

The State Education minister Dhan Singh Rawat announced that the State government has approved a sum of Rs 10 crore for the construction of a new building for Government College at Bahadarpur Jat in Haridwar. He said that the State government is committed to improving the infrastructure of government colleges, including providing new buildings for those lacking them. While the State government has approved Rs 997.78 lakh for the construction of the new building the first installment of Rs 5 crore has already been released for this purpose, he said. He further said that this funding is part of the scheme for special assistance to States for capital investment for the year 2024-25 and a government order has been issued confirming this allocation. "The construction work will begin soon to be overseen by the designated executing agency. The new building will include essential facilities such as a library, laboratory, rest-

rooms, classrooms and a principal's office," he said. Rawat further stated that instructions have been given to the officials concerned and the executing agency to incorporate modern fire-fighting technology in the college campus. "They have also been advised to focus on appropriate electrification provisions and to conduct preliminary laboratory testing of construction materials. Further, officers have been instructed to ensure full utilisation of the funds by March 31 and to provide a utility certificate to the government to facilitate the

timely completion of the building. We are serious on preventing disruptions to the student's education at the upcoming college," he said.

# 141 teams to provide top-notch health facilities for National Games

To provide health facilities for the players and guests during the 38th National Games, the State Health department has constituted 141 teams. These teams will be on the alert- mode from January 28 on which the national mega sport event starts to February 14-the day it will end.

Informing this, the Health secretary R Rajesh Kumar said that State nodal officers, deputy nodal officers and co-nodal officers have been deployed at the State level. At the district level, the chief medical officer (CMO) will be the district nodal officer while the additional CMO will be the co-nodal officer. He further said that a 10-bed hospital would operate for players in the Maharana Pratap Stadium, Dehradun, and a two-bed hospital would function at IGI Sports Stadium, Gaularpar, Haldwani. Moreover, sufficient quantities of medicines and equipment are being procured for the players. Kumar said that the chief superintendent of the district hospital, Nainital Dr Tarun Tamta has been made the nodal officer for the Kumaon division while Dr K S Negi has been appointed the nodal officer for the Garhwal division. The Health secretary noted that the nodal officers and co-nodal officers have been appointed for primary, secondary and tertiary health care. In secondary health care, medical specialists in neurology, cardiology, head injuries and spine injuries will be on-call 24/7. Additionally, on-call

(24/7) ambulances will be deployed at each district hospital along with necessary medicines. On-call teams will be stationed at the medical units nearest to the players' residences, he said.

"There will be a designated team for each sport and shift, comprising one doctor, two nursing staff, two physiotherapists (male and female) and one ward boy. One team will remain on standby mode. Four ambulances will accompany the medical teams at all sports venues," he said. The Health secretary informed that three on-call (24/7) ambulances equipped with essential medicines- will be available at each district hospital. In total, 150 doctors, 300 nursing staff, 25 physiotherapists, 30 pharmacists and 50 ward boys will be deployed. During the National Games, 115 ambulances-both departmental and those from the 108 service-will be in operation. Five beds will remain reserved in the trauma department of AIIMS Rishikesh from January 28 to February 14. If necessary, airlift facilities will be provided through a heli ambulance, he said.

# Truecaller announces spam blocking on iPhone

Chauhan informed that the virtual meeting, held at the party headquarters, was attended by key leaders, including State General Secretary (Organisation) Ajay Kumar, State General Secretary Aditya Kothari, MPs, MLAs, municipal organisation heads, district presidents and party officials. During the session, Bhatt asked attendees to ensure that every voter is marked at the household level with the assistance of Panna Pramukhs to maximise public participation in electing city governments. Bhatt reiterated the need to secure a significant victory for BJP candidates across maximum municipal bodies, aiming to establish a triple-engine government that will enhance developmental efforts. In the meeting the party

leadership shared the detailed strategy for voting day, calling for the formation of teams responsible for ensuring maximum voter turnout. Instructions were given to identify supporters, party workers and members of affiliated groups in the voter list and ensure that their votes are cast as early as possible. Booth presidents have been tasked with completing all formalities related to the identification and appointment of polling agents. The party workers have been trained on how to raise objections against suspicious voters and educate the public on correctly marking ballot papers to avoid errors, Chauhan said.

# BJP accuses Congress of blatant appeasement in ULB elections

The Bharatiya Janata Party State president Mahendra Bhatt accused Congress of resorting to appeasement politics out of desperation, claiming their true anti-Sanatana face has been exposed ahead of their anticipated electoral defeat in urban local body (ULB) elections in Uttarakhand. Responding to media queries at the party headquarters, Bhatt stated that the BJP is poised to secure a historic victory in all 11 municipal corporations of the State. He attributed this to the party's focus on development and its commitment to preserving cultural heritage, which have resonated strongly with the public. Bhatt said that the BJP conducted a positive election campaign which was focussed on the achievements of the double-engine government and the party's development manifesto for municipal bodies. Criticising the Congress, Bhatt said their leaders are resorting to divisive and controversial statements due to their growing frustration. He alleged that Congress, which once

claimed to be a pro-Hindu party, has now returned to its appeasement tactics. Bhatt pointed out past instances of Congress leaders allegedly supporting practices like cow slaughter, promising minority focused institutions and campaigning in religious places to seek votes. He said that such actions reveal the party's true priorities, which he claimed are against the interests of the Sanatana community. Bhatt stated that these statements will result in the Congress facing rejection in the municipal elections, just as they did in the State and parliamentary polls. Besides this, Bhatt also extended his greetings to the people of Uttarakhand on the first anniversary of the consecration of the Shri Ram Janmabhoomi Temple in Ayodhya.

# Prepare Uttarakhand centric disaster management plan- CS to officers

Chief Secretary Radha Raturi has directed the department of Disaster Management to prepare an Uttarakhand centric disaster management model keeping in mind the special conditions of the State instead of adopting the models of other countries and States. She said that the department should include the suggestions of NGOs, civil society, social organizations and private experts while preparing the framework to deal with the disasters.

Expressing concern over the use of heavy construction works in the State the CS said that relatively light construction works are given priority in disaster sensitive areas.

Calling for a report on villages identified in the State in view of high disaster risk, the CS asked the officers to clarify the status of the action plan for rehabilitation of such villages.

She said that the district magistrates should conduct disaster risk assessment of all the villages.

The CS was reviewing the implementation of Sendai (Japan) framework on disaster risk reduction in the State at the secretariat on Wednesday.

Expressing strong displeasure over the laxity in making an action plan of an insurance scheme in disaster risk reduction, CS said that people of a disaster sensitive State such as Uttarakhand can get help from the scheme.

Taking cognizance of the lack of trained officers for disaster risk assessment, the CS directed that innovative efforts like installing bamboo crash barriers should be adopted in this regard. Secretary Vinod Kumar Suman and officers of Disaster Management, Home, Irrigation, Forest, Drinking water, Education and PWD attended the meeting.

In the meeting she instructed the officers to collect the data of ex-servicemen living in all the districts and train them in disaster management.

# Assam detention centres: SC slams Government, summons Chief Secretary

Calling it a "defective" affidavit, the Supreme Court on Wednesday slammed the Assam government for not giving in its reply reasons for detaining 270 foreigners at the Matia transit camp. A bench of Justices Abhay S Oka and Nongmeikapam Kotiswar Singh directed the Assam chief secretary to remain present through video-conferencing on the next date of hearing.

The top court said it granted six weeks time to the state government on December 9 to file the affidavit and expected it to give reasons for detaining 270 foreign nationals in the transit camp besides details on the steps taken for their deportation. "The affidavit does not give any justification for detaining...Steps taken to deport are not set out. This is gross violation of orders of this court. We direct the chief secretary to remain present through video-conferencing



and explain the non-compliance," the bench said.

The counsel appearing for the state government submitted that persons were detained only after they were declared foreigners by the foreigners tribunals and explained the mechanism of deportation of illegal migrants.

The top court sought to know why detentions were continuing without the deportation process even being initiated.

The court expressed displeasure after the Assam govern-

ment counsel said the affidavit was confidential and should remain sealed.

"This shows that the state does not want to come clean. Tell us what is confidential in the affidavit?" asked the bench.

The lawyer said the affidavit contained the addresses of foreigners and the details could go to the media.

"Assam counsel states that affidavit filed should be kept in sealed envelope, as contents thereof are confidential. Though we are directing that

it be kept in sealed envelope, prima facie we disagree with the counsel that there is something confidential about the contents," the bench said.

The top court had directed Assam State Legal Services Authority to conduct surprise visits at the Matia transit camp for foreigners to check the facility's hygiene and food quality.

The bench was hearing a plea concerning the deportation of persons declared foreigners and facilities at the detention centres in Assam.

While hearing the matter on May 16 last year, the apex court observed that the Centre must take immediate steps for deporting 17 foreigners at the detention centre in Matia. It said priority should be given to deport four, who had spent more than two years in the detention centre.

The plea also sought a direction to the Assam government not to detain any person declared a foreigner by the tribunal until it could show proof of a possible deportation in near future.

# Kolkata rape-murder case: CBI seeks death sentence for Roy

The CBI will file an appeal before the Calcutta High Court, seeking death sentence for Sanjay Roy, who was sentenced to "life imprisonment until death" by a Sealdah court in the rape-cum-murder case of an on-duty doctor at RG Kar Medical College and Hospital, officials said Wednesday.

The agency received a legal advice suggesting that the case may be categorised as the "rarest of rare", deserving capital punishment, they said. The agency is likely to file the appeal against the Sealdah court order as soon as possible with detailed arguments in favour of capital punishment, they said.

The agency's plea seeking death penalty for Roy was turned down by the trial court, where Additional District and Sessions Judge Anirban Das said that the crime did not fall under the "rarest of the rare" category.

"The CBI prayed for the death penalty. The defence lawyer



prayed that a jail term be given instead of the death penalty. This crime does not fall under the 'rarest of the rare' category," the judge said on Monday while sentencing Roy.

"I am sentencing you to life imprisonment, meaning till the last day of your life, for causing injury during the act of committing rape on the victim that led to her death...", he told Roy.

The West Bengal government has already approached the

high court, challenging the verdict and seeking death penalty for Roy.

The CBI has opposed the state's right to file an appeal in the case, claiming that as it was the prosecuting agency, it had the right to appeal on the grounds of inadequacy of the sentence.

Appearing for the CBI, Deputy Solicitor General Rajdeep Majumdar on Wednesday opposed the state's submission, maintaining that the West Bengal government does

not have the right to appeal against the trial court's order on the ground of inadequacy. He submitted that the CBI had prayed for awarding capital punishment to Roy before the trial court.

The high court said it would hear the CBI, the victim's family and the convict before deciding on the admission of the state government's appeal. The high court said it will hear the matter on January 27.

The trainee doctor was raped and killed in the early hours of August 9 in the seminar hall of RG Kar Medical College and Hospital when she had gone to have rest during her graveyard shift.

Her body with severe injury marks was found inside the hall by a doctor next morning. Civic volunteer Sanjay Roy was arrested the next day based on CCTV footage in which he was seen entering the seminar hall at 4.03 am on the day of the incident.

On August 13, the Calcutta High Court ordered the transfer of the probe from Kolkata Police to the CBI, which took over the case on August 14.

# A Raja writes to Waqf panel chief to defer proposed JPC meeting

DMK MP A Raja on Wednesday wrote to Waqf panel chief Jagdambika Pal on behalf of the opposition to postpone the proposed sittings of the joint parliamentary committee proposed on January 24 and 25.

In a letter to the waqf parliamentary panel chief, Raja said it is practically not possible for the members to recollect the evidence and materials essentially needed for the moving of the amendments and discussion on the waqf bill at such a short notice. He said during the tour programme to meet various stakeholders in Lucknow on Tuesday, the members had requested Pal to postpone the meeting of JPC proposed on January 24 and 25 for taking up the bill clause by clause. The panel is examining the waqf bill after it was introduced in Lok Sabha during the monsoon session of Parliament in August last year.

"Hence, it was requested by most of the members at the



Lucknow sitting (21.01.2025) that the proposed sittings of JPC on 24th and 25th have to be necessarily postponed on 30th (full day) and 31st of this month after the presidential address in the Parliament," Raja said in his letter to Pal. He said unless the sittings of the JPC are postponed, the purpose of constituting the committee itself will be defeated as it raises doubts in the minds of the people of India that the secular fabric of the Constitution embodied in the Preamble is endangered and due process in conduct-

ing the JPC is also not followed.

"It is, therefore, prayed on behalf of the members of the opposition parties that the sittings of the JPC proposed on 24th and 25th may kindly be postponed to 30th and 31st of this month as already discussed with you at Lucknow," Raja said.

The Congress also shared Raja's letter in a post on X and said, "Lok Sabha MP and member of the Joint Parliamentary Committee on the Waqf (Amendment) Bill, 2024, Shri A Raja writes to the

Chairman of the joint panel, Shri Jagdambika Pal, on behalf of the members of the Opposition parties, requesting the sittings of the JPC be postponed from 24th and 25th Jan to 30th and 31st Jan 2025."

In his letter to the chairman of the JPC on waqf, Raja said the Lok Sabha Secretariat (JCWAP Cell) through a letter dated January 20 has requested the members of the panel to send their amendments to the proposed bill by 4 pm on Wednesday.

Also, the next sitting of JPC has also been convened on January 24 and 25 for clause-by-clause consideration of the bill, he also said.

"It is needless to say that the tour programmes of the JPC to meet the stakeholders at Patna, Kolkata and Lucknow were completed only yesterday ie 21.01.2025; And the members were dispersed from the tour programme to their constituency/states to continue their scheduled programmes earlier.

"It is very strange that the next dates for a sitting of JPC were hurriedly announced with-

out any formal discussion when the JPC was already on tour. Even during the sitting of JPC at Lucknow itself, it was requested by the members that the proposed sittings of 24th and 25th of this month are practically not possible as the members are expected to discharge their duties/programmes in the locality.

"Moreover, the members are not in a position to recollect the evidence/materials at such a short notice which are essentially needed for the moving of the Amendments and discussion thereon," he said.

The DMK MP also said Pal has directed the stake holders who participated in the tour programme at Patna, Kolkata and Lucknow to submit their views and submission in writing within seven days and the committee is waiting for the same for circulation.

"I sincerely recall that you have reacted to the request that it will be considered positively after consultation with the government realising the justification offered by us for the postponement," he said.

Concerns over "skyrocketing" airfare and "little action" by government agencies and regulator dominated the Parliament's Public Accounts Committee (PAC) meeting on Wednesday as several MPs sought accountability from private airport operators and airlines to provide relief to passengers.

PAC Chairperson K C Venugopal described the meeting of the panel, which has witnessed fiery and at times acrimonious discussion along party lines in the past, as "one of the best" sittings. Members, he said, expressed concerns that the Airports Economic Regulatory Authority (AERA) "is not acting properly as a regulator". "We need clear cut answers," he told PTI after the meeting. He said the regulatory body could not answer adequately the questions raised by members.

The senior Congress MP said, "Concerns were raised by members that airfare is skyrocketing, and there is no action from the Directorate

General of Civil Aviation (DGCA) or the Civil Aviation Department."

Sources said some MPs called for an amendment in the AERA Act to make it more effective in regulating fare amid general unhappiness over issues like "arbitrary" rise in user development fees and price surge, as they alleged that the existing system fell short of fixing accountability and transparency in the functioning of private operators.

"A few MPs were upset over the manner in which both aeronautical tariff and non-aeronautical tariff are decided and flagged the need for having a mechanism in place for prior consultation," a source said. An MP said there should be a quasi-judicial body to hear such issues.

Civil aviation secretary and AERA chairperson were among those who appeared before the panel in the meeting in which presentations were made on related issues. While AERA is tasked with regulating tariff for services covering major airports, the DGCA is primarily concerned with safety issues.

Sources said the PAC members, in general, were unsatisfied with the replies of officials, and the panel has asked them to submit a detailed response. Several members, sources said, gave examples of a few airports where the user development fee (UDF), which is included in the airfare, has gone up many times since they were handed over to private operators.

Some of them sought details from officials about the revenue collected under different heads and to what use they were put to. An MP, sources said, spoke about the real estate development and subsequent rentals collected by private operators at airports, and called for transparency and accountability for the revenue's appropriate use.

An MP lauded the government's UDAN scheme, which envisages air connectivity for smaller cities, but noted that many of its routes are either not served or not served adequately by private airlines as they focus on more profitable routes. It strikes a blow to the vision of having the common man to fly, he added.

# Railway Board extends some facilities to BRMS amidst protests

The Railway Board has extended some facilities to an unrecognised federation, the Bhartiya Railway Mazdoor Sangh, amid strong protest from other unrecognised unions and their alliances.

The Board recently held a Secret Ballot Elections in which the Bhartiya Railway Mazdoor Sangh (BRMS) failed to secure 15 per cent vote, a mandatory requirement to get recognition. Only two federations, All India Railwaymen's Federation (AIRF) and National Federation for Indian Railwaymen (NFIR) got the required percentage of votes and recognition of the Board.

"Bhartiya Railway Mazdoor Sangh (BRMS), an unrecognised Federation, who secured 10.12% of the total votes on all Zonal Railways and Production Units (Chittaranjan Locomotive Works and Rail Coach Factory, Kapurthala) in the last Secret Ballot Elections (SBE) - 2024, had represented and requested that keeping in view of their performance in the SBE-2024, they may be granted some facilities for raising the grievances of railway employees," a Railway Board's letter dated January 16, 2025, addressed to all zones, said.

The letter further said the Board considered the representation of BRMS and the fact that it registered its presence in all the Zonal Railways and PUs (CLW & RCF) in the last SBE - 2024 and secured third largest vote share after AIRF and NFIR.

According to the Board, it decided to extend the union facilities such as 'Informal meeting with senior officers' and 'Office Accommodation' in Railway premises.

"Representatives of BRMS will be permitted to meet officials at Railway Board level as special invitees. However, no Special Casual Leave or Passes will be provided to BRMS officials for the same," the Board in its letter said. "Accommodation, if any, may be provided to BRMS in any Railway office/premise located at New Delhi," it added.

# LPG safety guidelines issued for Maha Kumbh to protect devotees and Kalpvasis

The Food and Logistics Department convened a crucial meeting to address LPG safety during the ongoing Maha Kumbh Mela. The meeting was attended by officials from the department, LPG distributors, gas company representatives, and officers from the Fire Department, all working towards ensuring the safety of devotees and Kalpvasis. During the session, detailed guidelines were issued to prevent accidents caused by LPG leakage. Among the key directives, cylinder testing was made mandatory, and strict restrictions were imposed on the sale of unauthorized cylinders. Officials emphasized that ensuring safety would be a top priority throughout the event. To ensure safe handling of LPG, technical assistants will inspect all cylinders before distribution, and any found to be leaking will not be supplied. Additionally, consumer equipment such as gas pipes and regulators will be scrutinized, with faulty or unsafe equipment being



replaced immediately. Special technical teams have been deployed in the fair area to respond to emergencies promptly. In a bid to further strengthen

safety measures, the storage of gas within the fair area has been limited to 100 kilograms, and complete details of each supply vehicle must be submitted to the

designated office. This measure aims to maintain tight control over the supply and prevent misuse. The meeting also addressed the rampant misuse of

domestic LPG cylinders. It was resolved that strict action would be taken against those found using domestic gas cylinders for unauthorized purposes or selling unapproved cylinders. Violators will face punitive action to ensure compliance with the safety protocols. Pramod Sharma, Chief Fire Officer of Kumbh, said, "The safety of devotees is of utmost importance. We are committed to implementing these guidelines effectively to ensure a secure environment for all."

Sunil Kumar, the Food and Logistics Officer, urged distributors to conduct regular checks and remain vigilant. "We aim to make this Maha Kumbh a 'Surakshit Mahakumbh'. Any violation of the rules will be dealt with strictly," he stated. These measures reflect the administration's commitment to ensuring the safety and well-being of the millions attending the Maha Kumbh. ## Life and challenges of female Naga sadhus at Maha Kumbh

The Maha Kumbh Mela not only showcases the spiritual depth of Sanatan Dharma but also highlights the enigmatic lives of its sadhus and saints. Among them, the Naga Sadhus are a prominent attraction, embodying detachment and spirituality. While much is known about male Naga Sadhus, the lives of female Naga Sadhus remain shrouded in mystery and intrigue.

Female Naga Sadhus dedicate their lives entirely to God, leaving behind domestic ties

and worldly attachments. Their daily routine revolves around rigorous worship, starting with prayers at Brahmamuhurta and culminating in evening rituals dedicated to Lord Dattatreya. Despite the reverence they receive in their Akharas, their lives are fraught with challenges and sacrifices. To become a Naga Sadhu, women must undergo a demanding initiation process. This includes observing strict celibacy for 10 to 15 years, convincing their guru of their devotion, and proving their ability to endure severe ascetic practices. A crucial part of the

initiation involves performing Pind Daan—a symbolic funeral rite—and shaving their heads as a gesture of renunciation. Unlike their male counterparts, who can remain Digambara (naked), female Naga Sadhus wear a single piece of unstitched saffron cloth, known as "Ganti," and are required to apply a Tilak on their foreheads. They are addressed as "Mai," "Avdhatani," or "Naagin" within their Akharas. However, female Naga Sadhus are not considered for leadership roles in the Akharas, reflecting traditional gender norms within the spiritual hierarchy.

## Akhilesh criticises UP Cabinet meet at Maha Kumbh mela

## Objectionable comments on Maha Kumbh spark outrage, two arrested

The police have arrested two individuals for making objectionable remarks about the Maha Kumbh and Hindu deities, triggering widespread anger among the Hindu community. The incidents, which surfaced on social media, have prompted the authorities to issue a strict alert for online content monitoring to prevent further provocation. The first incident occurred in the City Kotwali area, where a video of the Maha Kumbh bath was shared on social media with offensive comments. As the video went viral, it reached senior officials, leading to immediate intervention from the state administration. On Tuesday late night, the City Kotwali police arrested Kamran Alvi, a resident of Deva Road, Civil Lines. Kamran was charged under sections 67 and 299 of the newly implemented BNS Act for insulting religious



sentiments. Speaking about the case, City Inspector Alok Mani Tripathi said, "Such comments are not just offensive but are a deliberate attempt to vitiate the peaceful atmosphere of the city. The accused has been taken into custody and will be presented in court. We are also

investigating others who may have played a role in circulating the video." In a separate case, Abhishek Kumar, a resident of Boja village in Jaipur, was arrested for posting inflammatory remarks about Hindu deities and the Maha Kumbh. According to SHO Amit

Pratap Singh, "The accused was apprehended immediately after the comments came to light. We have registered a case, and further investigations are underway. We will not tolerate any attempts to disturb communal harmony." Members of Hindu

organizations have strongly condemned these incidents, labeling them as deliberate provocations to disrupt social harmony. At Patel Square, one of Barabanki's busiest locations, a large screen continuously displays a film highlighting the significance of the Maha Kumbh. Community members argue that the comments were intended to provoke anger and disrupt the otherwise peaceful atmosphere. "Hindu festivals like the Maha Kumbh symbolize unity, spirituality, and our cultural heritage," said Rajesh Sharma, a local member of a Hindu organization. "When someone mocks such events or our deities, it hurts the sentiments of millions and creates unnecessary tensions." Anita Tiwari, a devotee, echoed these sentiments, saying, "The Maha Kumbh is a sacred event that unites people from all walks of life. Such derogatory comments are not only disrespectful but

also an attack on our collective faith. Strict action must be taken to deter such behavior in the future." Authorities have issued an alert, urging people to be cautious while sharing or commenting on social media content related to religious events. "Social media is a powerful tool, but it must be used responsibly," said Alok Mani Tripathi. "We will monitor platforms closely and take strict action against any content aimed at disrupting peace." As the Maha Kumbh continues, the police have assured the public of heightened vigilance to maintain harmony. "We appeal to citizens to report such content immediately and refrain from spreading inflammatory messages," added SHO Singh. The arrests serve as a stark reminder of the consequences of using social media irresponsibly, especially in a country as diverse as India, where religious sentiments run

## Shri Ram Bank loans devotees the name of Lord Ram

Amidst the bustling Maha Kumbh Mela, there is a unique bank that does not deal in money but in faith. Shri Ram Bank, an institution with a 150-year-old legacy, offers "loans" to devotees in the form of "Ram Naam" (the name of Lord Ram). The bank encourages people to write the name of Lord Ram, and the response has been overwhelming, with millions of "Ram Naam" written and circulated so far. The bank's temporary branch was set up in Sector 6 of the Kumbh Mela on December 22. According to its custodian, Ashutosh Varshney, this bank operates just like any other—complete with loan disbursements, EMIs (equated monthly installments), and meticulous record-keeping. "The minimum loan is for writing 1.5 lakh 'Ram Naam,' but devotees can take more if they wish. The writing is done in



specially printed booklets provided for free, and every page records the number of 'Ram Naam' written," Varshney explained. **How the System Works** Devotees return the filled booklets to the bank, which are then used to grant loans to others. For instance, if a devotee takes a loan of 1.5 lakh "Ram Naam," they repay it by writing and submitting the

same number. To date, over 25 individuals have taken loans to write crores of "Ram Naam," with the final data expected to be released after the Maha Kumbh concludes. The bank accepts entries in multiple languages, including Hindi, English, Urdu, and Bengali. Anyone aged between six and 80 years can take a loan, but there are conditions—borrowers must abstain from

consuming meat, alcohol, garlic, and onions while fulfilling their loan. "The only requirement is a photograph for identification," said Rajkumar, a bank promoter at the Kumbh branch. The initiative has also drawn international devotees. Among them are Henk Kelman from the Netherlands, who now goes by the name Ramkrishna Das, and Sonal Singh, an Indian-origin resident of the U.S. Both have taken loans to write one crore "Ram Naam" each. **From Ledger Books to E-Ram** Tracing the bank's history, Ashutosh Varshney revealed, "I am the fifth generation in this tradition. It began with traders in the Chowk area who donated 10% of their earnings for social causes. Writing 'Ram Naam' emerged from this practice. Initially, it was recorded in ledger books, later in printed booklets, and now, we have introduced 'E-Ram' for digital transactions through social media platforms."



## ISRO unveils satellite images of Maha Kumbh

The Indian Space Research Organisation (ISRO) on Wednesday released before and after satellite images of the tent city here giving an insight into the grandeur of the Maha Kumbh which is drawing crores of people from across the world to take a holy dip at the Sangam.

Maha Kumbh, a mega-religious event organised every 12 years, is being held in Prayagraj from January 13 and will continue for 45 days till February 26. More than eight crore pilgrims have taken a holy dip at the Sangam so far. "Time series images (15 Sep 2023 & 29 Dec 2024) of EOS-04 (RISAT-1A) 'C' band microwave satellite, with its all-weather capability and fine resolution (FRS-1, 2.25m), provides unique insights on details of the Tent City (Layout of Structures and Roads) along with its network of pontoon bridges and supporting infrastructure, set up for the

Maha Kumbh Mela 2025," ISRO said in a statement. The time series images captured by the satellites show the construction of Shivalay Park, the India-shaped park in Prayagraj, spread across 12 acres of land and is designed to be a major attraction for the festival. The images taken on three separate dates capture the construction of the landmark. On the National Remote Sensing Centre's (NSRC) website, time series images of the Triveni Sangam were also shared, showing the difference via images captured in September 2023 and on December 29, 2024. Three time series images also captured the Prayagraj Sangam and the zoomed section of the River Ganges showing temporary pontoon bridges. Several time series images of the Parade Grounds also showed the transformation the location went through as the city geared up to welcome millions of worshippers and host one of the largest congregations on Earth.

## Defense Minister Rajnath Singh inaugurates Sainik school in Kerala

The Sainik School at Mavelikkara is a dream come true for Vidhyadhiraja Educational and Charitable Trust launched in 1978. The school is affiliated to the Sainik School, Government of India. Students who pass out from the fifth standard in other schools

are eligible to apply for admission to the sixth standard and the selection is based on an all India entrance examination. Jayaprakash Valliathan, a marine engineer-turned-educationist told The Pioneer that 60 per cent of the total seats are reserved for students from the Vidhyadhiraja Vidyapeetom Central School while the remaining seats are available for students from rest of the country. "The curriculum has been prepared as per the directives of CBSE New Delhi and Sainik School Society. The students in the Sainik School stream get a taste of life in the defense services with specially trained teachers imparting them training in physical education, sports and games,"

said Valliathan. Minister Rajnath Singh further stated that the last few years saw a jump in the number of Sainik Schools functioning in the country. "There were just 33 Sainik Schools in India but the number has gone up by manifolds because the nation is in need of youngsters with discipline, dedication and commitment to work not only in the armed forces and para military forces but in other areas too," said the minister. He pointed out that the Sainik Schools are the stepping stones to career in defense forces. "Since the Forces have started appointing girls too as officers, we need more trained professionals as well as Sainik Schools," he said.

With salary as the primary criterion, skilled Indian workers in high-demand sectors like technology, engineering and healthcare are likely to secure visas more easily. The streamlined process and in-country renewals will reduce uncertainties for professionals and their families. In 1780, James Augustus Hicky published India's first printed newspaper, 'Hicky's Bengal Gazette,' also known as the Calcutta General Adv, normative power of print media.

press—with publications in Hindi, English and regional languages—even stalwarts like Dainik Bhaskar and Malayala Manorama are grappling with reduced readership. Legacy newspapers such as Deepika, India's oldest surviving Malayalam publication, and Mumbai Samachar, the nation's longest-running newspaper, now struggle to adapt to the digital age. The shift is not merely technological but also cultural. The younger generation's preference for quick, digestible content over in-depth reporting signals a change in information consumption patterns. Traditional newspapers, with their rich investigative journalism and nuanced storytelling, are increasingly viewed as slow and outdated. The immediacy of apps like Daily Hunt and platforms offering free e-papers has made paying for physical newspapers seem redundant. This decline, however, should not overshadow the irreplaceable value of print media. Unlike digital platforms prone to misinformation and algorithmic biases, newspapers have long been trusted for their credibility and editorial rigour. They offer a depth of coverage that ensures stories are not just told but examined and contextualised. Newspapers are archives of history, recording

High literacy rates and a culture of respect for well-researched journalism have enabled newspapers to thrive even in a digital age. This example underscores the potential for print media to coexist with digital platforms when supported by an informed and engaged readership.

Indian Newspaper Day is a reminder to recognise and preserve this legacy. While print media must innovate to survive, readers, too, bear a responsibility to support credible journalism. The rise of e-papers and hybrid models—combining print and digital—offers hope for the industry's evolution rather than extinction. Newspapers continue to play a vital role in fostering democracy. They provide a platform for marginalised voices, hold power to account, and offer citizens the information they

need to make informed decisions. At a time when digital echo chambers threaten the very fabric of public discourse, newspapers serve as a counterbalance, offering diverse perspectives and challenging groupthink.

The theme of survival is intrinsic to the narrative of Indian newspapers. Just as Hicky's Bengal Gazette persevered despite colonial censorship and competition, today's publications must navigate the challenges of the digital age. The story of newspapers is one of resilience and adaptation. From the handwritten Acta Diurna of Julius Caesar's Rome to Gutenberg's printing revolution, and from Hickey's modest four-pager to modern broadsheets like The Times of India, the medium has continually evolved to meet the needs of its time. ## Breaking the cycle of violence: Lessons from personal trauma

Violence against the weak manifests in countless forms—child abuse, bullying, ragging, molestation and domestic violence—leaving deep and often irreparable scars

Violence against the weak is a timeless and universal phenomenon. Child abuse, bullying, ragging, eve-teasing, molestation and domestic violence are only a few that can result in irretrievable damage to the psyche or can even have tragic consequences. I joined the hostel for the first time as a 12-year-old adolescent. I was out in the world, away from the shelter of my parental love, trying to overcome my insecurities. One time a senior shouted at me to fetch a packet of cigarettes from the dormitory. I still remember my tears as I was roughly reprimanded for being tardy. I was scared of the hostel life. Three years later, I joined the college hostel. Ragging had not yet been banned and was openly indulged in by seniors. It was supposed to be a harmless fun activity to initiate the newly joined youngsters into college life. It had degenerated into something completely different. One Sunday, we were forced to sit above the wardrobe and hurl choice profanities at each other. I mouthed words



from my limited vocabulary. We were so traumatised that we started returning home over the weekends. When our parents questioned us, we started bicycling into the desert on the weekends when ragging was at its peak. We slept in remote towns before returning to the campus at the start of the week. We even spent a night in the waiting room of a railway station. We were particularly wary of one young man called the 'ragging king'. In time, after the freshers had been welcomed, I settled down. I forgot my earlier

trauma and looked forward to the next year when I would be bestowed the dreaded title by the new arrivals. One incident changed my outlook. I was ragging a fresher, who was terrified and not responding to my questions. Frustrated, I barked at him to jump into a nearby well. Much to our horror, he turned around and ran towards it. Momentarily stunned, I must have run the fastest race of my life and managed to stop him in the nick of time. I was a changed person. The government stepped in to ban the practice. Sadly, it continues. A recent news report mentioned ragging in several medical colleges where male seniors force fresh entrants to memorise and read aloud from booklets filled with profanities and promoting sexual violence against women, specifically against classmates and nurses. The booklet also teaches freshers to look at women of all ages, including those in the 0-15 years age bracket, as sex objects. Many of us may have been at the receiving end of the local or the school

bully. It exists even at the workplace, sometimes in the guise of the rude superior who would not think twice before throwing the file back at you, or the one preying upon the junior female colleague. Women do not have a pleasant experience travelling on public transport. They are afraid to step out after sunset. Every day we read of brutal assaults and deaths. The list is endless. Many are unable to bear the trauma and give up on life. I am not a psychologist. The reasons might be more complex than blaming it on not inculcating the right values in the children. But, that can be a starting point.

We can teach our young what English author Brian Jacques wrote in one of the Redwall series of fantasy novels for children, "Defend the weak, protect both young and old, never desert your friends. Give justice to all, be fearless in battle, and always ready to defend the right." Renuka Ji Dam: Addressing  
Delhi's water woes

Conceived over half a century ago on Giri River in Himachal Pradesh, the Renuka Ji Dam is finally set to redefine water and energy security across six Indian states



The visionary Renuka Ji Dam project, conceived 58 years ago on Himachal Pradesh's serene Giri River, is finally transcending decades of delays to emerge as a game-changer. This landmark initiative promises to alleviate Delhi's chronic water scarcity while energising Haryana, Rajasthan, Uttarakhand, Uttar Pradesh and Himachal Pradesh with sustainable power generation. Beyond its functional benefits, the dam exemplifies federal cooperation and political resolve. Prime Minister Narendra Modi virtually laid the foundation stone of this Rs 6,946-crore project on December 27, 2021. Now, with 95 per cent of procedural hurdles cleared, global tenders will soon be floated, paving the way for construction. Cost estimates have surged to Rs 8,262 crore, factoring a 5 per cent annual escalation. Targeted for completion by 2030, with operations commencing in 2032, this project's progress is critical for Delhi and beyond.

For Delhiites, the dam symbolises the realisation of a 58-year-old aspiration. The stored water will be routed to Delhi-NCR, Uttar Pradesh and Haryana through the Hathnikund Barrage, further reaching the Wazirabad and Okhla Barrages. Delhi's water demand exceeds 1,200 million gallons daily (MGD), with severe shortages during summer. The Renuka Ji Dam, promising 275 MGD, will bridge this deficit, bolstering domestic supply, industrial growth, and infrastructure development. Haryana leads with a 5.73 BCM share (47.82 per cent), contributing Rs 555.95 crore. Uttar Pradesh's 3.721 BCM (31.05 per cent) follows with Rs 361.04 crore. Rajasthan holds 1.119 BCM (9.34 per cent), contributing Rs108.58 crore. Himachal, Uttarakhand, and Delhi contribute Rs 36.67 crore, Rs 30.17 crore, and Rs 70.25 crore, respectively. Uttarakhand's share of water in the upper Yamuna basin is 0.311 BCM, which constitutes 2.60Rs30.17 crore of the total share. Together, the states allocate Rs 1,162.66 crore for this critical project.

Originally slated to showcase progress before Delhi's 2025 Assembly elections, the dam faced delays, pushing construction timelines by 5-6 months. Intervention by the Prime Minister's Office (PMO)

could expedite design approvals and tendering. Local tensions remain high. The Jan Sangharsh Samiti criticised project authorities for inadequate rehabilitation efforts, including compensation gaps for displaced families. Activists demand higher pay-outs aligned with Public Works Department estimates, claiming the current compensation is insufficient. Harikesh Meena, Managing Director of HP Power Corporation, refutes these allegations, stating Rs 1,573 crore has been disbursed, with 90 houseless families offered relocation options. Himachal Pradesh is set to gain 200 million units of electricity annually, worth Rs 66 crore. Delhi has already transferred Rs 270 crore, funding 90 per cent of the Rs 300-crore power machinery cost, underscoring the project's importance. Renuka ji, nestled in Himachal's Sirmaur district, is ideal for the dam due to its geographical and hydrological advantages. The Giri River, a Yamuna tributary, ensures a steady water flow.

The site also holds immense cultural significance. Named after Goddess Renuka, the mother of Parashurama (an avatar of Lord Vishnu), the area is steeped in mythology. Renuka Lake, India's largest natural lake, draws pilgrims year-round. Ancient temples dedicated to Goddess Renuka and Lord Parashurama further enhance its spiritual and historical value. The project blends technological ambition with religious reverence, ready to address Delhi's water woes and power needs for generations. The Rs 8,262.28-crore Renuka Ji Dam project, a 148-meter-high rock-filled structure, will transform water and power availability across six states. Submerging 1,508 hectares and displacing 7,000 residents, including 346 houseless families, the project spans 41 villages across 25 panchayats. Proposed in 1976, the dam faced decades of procedural hurdles. Initially estimated at Rs 4,596 crore

in 2015, costs have ballooned. A significant milestone was achieved in January 2019, when a MoU among the six beneficiary states, brokered by then Union Minister Nitin Gadkari, resolved water-sharing disputes. In 2022, the Cabinet Committee on Economic Affairs, chaired by PM Modi, approved financial support, pushing the project into execution mode.

Located near Dadahu village, the dam will store 498 million cubic meters of water, routed to Delhi-NCR, Uttar Pradesh, Haryana, and Rajasthan via key barrages. As part of the PM Krishi Sinchayee Yojana, it will deliver 23,000 litres per second to Delhi. Additionally, incidental hydroelectric power generation (40 MW) will earn Himachal Rs120 crore annually. Technical Experts predict a 110 per cent increase in the Giri River's flow, ensuring reliable water supplies during lean periods. Despite challenges faced by displaced communities, the Renuka Ji Dam promises long-term benefits: improved water security for Delhi, agricultural irrigation, and energy generation marking it a milestone in cooperative federalism and infrastructure development.

Despite its potential, the project's journey was fraught with challenges. Environmental concerns, inter-state disputes, land acquisition hurdles, and funding delays plagued progress. Securing environmental clearances was a monumental task. Forested landscapes raised alarms over wildlife displacement and green cover submergence. Years of negotiations and compensatory afforestation plans eventually paved the way. Inter-state discord over water-sharing ratios and financial contributions delayed progress. Himachal Pradesh had to acquire 1,477 hectares of land, including 909 hectares of forest. Protests and legal battles over compensation and rehabilitation compounded delays until enhanced packages and livelihood restoration initiatives placat-

ed affected communities. The project's escalating cost was another sticking point. Initially pegged at Rs 3,600 crore, delays ballooned the budget to Rs 6,946 crore by 2021. Financial deadlock broke when the central government agreed to fund 90 per cent of the cost under the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY). This eased the financial burden on states, with Delhi swiftly sanctioning Rs 1,066 crore as its share.

The central government played a crucial role in reviving the project. Integrating it into initiatives like the Jal Shakti Abhiyan and National Action Plan on Climate Change (NAPCC), underscored the dam's importance. Accelerated clearances, robust mediation, and funding commitments demonstrated political resolve. With construction set to commence by mid-2025 and completion targeted for 2032, strict oversight will ensure timely execution.

The Renuka Ji Dam epitomises cooperative federalism at its finest—where the centre and states unite to tackle shared challenges. For Himachal Pradesh, it heralds economic growth, energy self-sufficiency, and enhanced infrastructure. For Delhi, it is a lifeline, promising a reliable solution to its chronic water crisis. Beyond immediate benefits, the dam's capacity to regulate river flow and mitigate downstream flooding enhances its value as a climate-resilient infrastructure.

As a testament to sustainable development, the Renuka Ji Dam underscores the synergy of political will, inter-state collaboration, and community engagement in overcoming complex challenges. By transforming Himachal Pradesh into a green energy hub and securing Delhi's water needs, the project exemplifies inclusive growth and environmental stewardship.

## Empowering panchayats: The key to achieving Viksit Bharat 2047 through community actions

India must transition from top-down governance to a model where community leadership is the driving force behind sustainable development

India's development trajectory has been shaped by significant contributions from the office of Prime Minister (PM), Chief Minister (CM) and District Magistrate (DM). To achieve the vision of Viksit Bharat 2047 empowering Panchayat leadership, headed by Village Mukhiya (VM) is a critical strategy.

of allocated funds or prioritising local infrastructural projects decided by either the district or state. Addressing these challenges is crucial for India to meet its Sustainable Development Goals (SDGs) and improve its Human Development Index (HDI) ranking. It requires building

the capacity of GPs to adeptly identify, plan, and implement projects that align with the needs established through Gram Sabha.

The Panchayat Raj System established panchayats as the foundation of decentralised power, emphasising that sustainable development must begin with our smallest unit of democracy: the Panchayat, led by the VM (Sarpanch). Elevating the role of the VM akin to the PM and CM at the centre and state, supported by a strong administrative structure, can drive effective grassroots decision-making. The Ministry of Panchayati Raj has grouped the 17 SDGs into nine themes, demonstrating India's commitment to achieving these goals through the implementation of Localised

SDGs (SDGs) by Panchayats. GPs across India, are tasked with creating Gram Panchayat Development Plans (GPDs) that align with LSDG priorities. However, a survey of 800 panchayats revealed that only 7 per cent of Sarpanches independently chose their LSDG themes using the Gram Panchayat Planning Facilitation Tool (GPPFT), while 34 per cent of themes were decided by Block officials, 22 per cent by Sarpanches or Sachivs, and 16 per cent were directed by the state, reflecting a need for strengthening planning at the panchayat level.

To develop Viksit Panchayats, four key actions are proposed: **Support panchayat for last-mile convergence:** When a 13-year-old girl drops out of school, the responsibility



extends beyond the education department, requiring collaborative efforts across health, social welfare, and community development. A central coordinating body at the village level, led by the VM can drive such convergence. For instance, Anita Devi, Village Mukhiya of Bhetaura Panchayat in Gaya, Bihar has

embraced the 'Healthy Panchayat' LSDG theme. Collaborating with ASHAs, Anganwadi Didis, and Gandhi Fellows to achieve 'Zero Home Delivery' eventually boosting institutional delivery rates from 25 per cent to nearly 90 per cent in just one year. Replicating such successes requires empowering panchayat through convergence of funds, and functionary and administrative support.

**Reimagine development of Panchayat Leaders:** India has 2.6 lakh elected VMs, dedicated to strengthening panchayat governance. Prime Minister's call to bring 1 lakh youth into politics is a great encouragement for local youths. To unlock their full potential, we need to reimagine the institutional framework

that focuses on capacity building for elected 'VM and Ward Members'. For example, Jyoti Behar Devi, Mukhiya in Gumla, Jharkhand, banned alcohol in her panchayat, focused on livelihood opportunities and also started the "Siti Bajo aur School Aao" campaign to boost school attendance, effectively transforming her community. **Democratise data through Panchayat:** Village Mukhiyas, as key information providers of government schemes, need real-time access to comprehensive beneficiary data and scheme details. Implementing technology solutions that provide such access is paramount for informed decision-making and efficient governance. The Ministry of Panchayat Raj and the Ministry of Rural

Development has taken some initiatives which need further integration with planning and execution at the panchayat level.

**Revitalise Village Committees** Village-level committees such as School Management Committees, Village Health and Sanitation Committees, Jan Arogya Samitis, and Village Water and Sanitation Committees, play a pivotal role in fostering decentralised governance and community participation in development efforts. To achieve Viksit Bharat, these committees need to align to avoid duplication of efforts and promote community ownership.

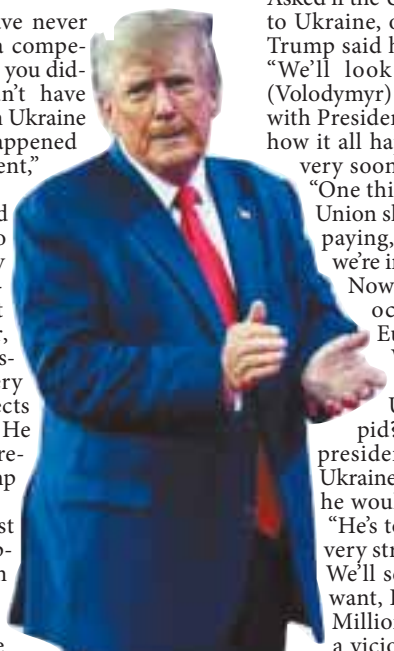

# Sanctions on Russia likely if Putin skips talks: Trump

US President Donald Trump on Tuesday said he is ready to meet his Russian counterpart Vladimir Putin anytime, but at the same time warned that he would likely impose sanctions on Russia if the latter does not come to the negotiations table on the issue of Ukraine. "It sounds likely," Trump told reporters when asked if the US will impose additional sanctions on Russia if Putin doesn't come to the negotiation table. "The war should have never started. If you had a competent President, which you didn't, the war wouldn't have happened. The war in Ukraine would have never happened if I were the president," Trump said. "Russia never would have gone into Ukraine. I had a very strong understanding with Putin. That would have never, ever happened. He disrespected Biden. Very simple. He disrespects people. He's smart. He understands. He disrespected Biden," Trump said. "Also, the Middle East would have never happened because Iran was broke," he added. Responding to a query, Trump said he



is ready to meet Putin anytime. "Anytime they want, I'll meet. Millions of people are being killed... It's a vicious situation and they're now largely soldiers. A lot of people have been killed and the cities look like demolition sites," he said. "The thing with Ukraine is that many more people died than what you're reporting. You're not reporting the real numbers, and I'm not blaming you for that. I'm blaming maybe our government for not wanting to release those numbers," Trump told reporters. Asked if the US will continue sending weapons to Ukraine, or will he turn off the tap soon, Trump said he is looking into the matter. "We'll look into that. We're talking to (Volodymyr) Zelenskyy. We're going to be talk with President Putin very soon, and we'll see how it all happens. We're going to look at it very soon," he said. "One thing I do feel is that the European Union should pay a lot more than they're paying, because under Biden, I mean, we're in there for USD 200 billion more. Now it affects them... We have an ocean in between, right? The European Union should equal us. We're in there for USD 200 billion more than the European Union. I mean, what are we, stupid? I guess the answer is yes," the president said. Trump also said that Ukraine President Zelenskyy told him that he would like to have peace. "He's told me that wants to have peace very strongly, but it takes two to tangle. We'll see what happens. Anytime they want, I'll meet. I'd like to see that end. Millions of people are being killed. It's a vicious situation," he said.

# Trump admn sends federal diversity staff on leave

Washington (PTI): President Donald Trump's administration is directing that all federal diversity, equity and inclusion staff be put on paid leave, and that agencies develop plans to lay them off, according to a memo Tuesday from the Office of Personnel Management. The memo follows an executive order Trump signed on his first day ordering a sweeping dismantling of the federal government's diversity and inclusion programs that could touch on everything from anti-bias training to funding for minority farmers and homeowners. The memo directs agencies to place DEI office staffers on paid leave by 5 p.m. Wednesday and take down all public DEI-focused webpages by the same deadline. Several federal departments had removed the webpages even before the memorandum. Agencies must also cancel any DEI-related trainings and end any related contracts, and federal workers are being asked to report to Trump's Office of Personnel Management if they suspect any DEI-related pro-

gram has been renamed to obfuscate its purpose within 10 days or face "adverse consequences." By Thursday, federal agencies are directed to compile a list of federal DEI offices and workers as of Election Day. By next Friday, they are expected to develop a list to execute a "reduction-in-force action" against those federal workers. The move comes after Monday's executive order accused former President Joe Biden of forcing "discrimination" programs into "virtually all aspects of the federal government" through "diversity, equity and inclusion" programs, known as DEI. That step is the first salvo in an aggressive campaign to upend DEI efforts nationwide, including leveraging the Justice Department and other agencies to investigate private companies pursuing training and hiring practices that conservative critics consider discriminatory against non-minority groups such as white men. The executive order picks up where Trump's first administration left off: One of Trump's final

acts during his first term was an executive order banning federal agency contractors and recipients of federal funding from conducting anti-bias training that addressed concepts like systemic racism. Biden promptly rescinded that order on his first day in office and issued a pair of executive orders — now rescinded — outlining a plan to promote DEI throughout the federal government. While many changes may take months or even years to implement, Trump's new anti-DEI agenda is more aggressive than his first and comes amid far more amenable terrain in the corporate world. Prominent companies from Walmart to Facebook have already scaled back or ended some of their diversity practices in response to Trump's election and conservative-backed lawsuits against them. Here's a look at some of the policies and programs that Trump will aim to dismantle: Trump's order will immediately gut Biden's wide-ranging effort to embed diversity and inclusion practices in the federal workforce, the nation's largest

at about 2.4 million people. Biden had mandated all agencies to develop a diversity plan, issue yearly progress reports, and contribute data for a government-wide dashboard to track demographic trends in hiring and promotions. The administration also set up a Chief Diversity Officers Council to oversee the implementation of the DEI plan. The government released its first DEI progress report in 2022 that included demographic data for the federal workforce, which is about 60% white and 55% male overall, and more than 75% white and more than 60% male at the senior executive level. Trump's executive order will toss out equity plans developed by federal agencies and terminate any roles or offices dedicated to promoting diversity. It will include eliminating initiatives such as DEI-related training or diversity goals in performance reviews. Trump's order paves the way for an aggressive but bureaucratically complicated overhaul of billions of dollars in federal spending that conservative activists

claim unfairly carve out preference for racial minorities and women. The order does not specify which programs it will target but mandates a government-wide review to ensure that contracts and grants are compliant with the Trump administration's anti-DEI stance. It also proposes that the federal government settle ongoing lawsuits against federal programs that benefit historically underserved communities, including some that date back decades. Trump's executive order is a "seismic shift and a complete change in the focus and direction of the federal government," said Dan Lennington, deputy council for the conservative Wisconsin Institute for Law & Liberty, which has pursued several lawsuits against federal programs. The institute recently released an influential report listing dozens of programs the Trump administration should consider dismantling, such as credits for minority farmers or emergency relief assistance for majority-Black neighbourhoods.

# Trump mulls 10% tariff on China starting Feb 1

Washington (PTI): US President Donald Trump on Tuesday said his team is discussing imposing a 10 per cent tariff on China starting February 1 based on the fact that the latter is sending fentanyl to Mexico and Canada. "We're talking about a tariff of 10 per cent on China based on the fact that they're sending fentanyl to Mexico and Canada," Trump told reporters at a joint news conference at the White House along with Oracle CTO Larry Ellison, Softbank CEO Masayoshi Son, and Open AI CEO Sam Altman. In response to a question, Trump said he is looking at February 1 as the date

for the tariffs. "For Mexico and China, we're talking about approximately 25 per cent (tariff)," the president said. Responding to another query, Trump said he did not "talk too much about tariffs" when he spoke with Chinese President Xi Jinping last week. When asked if he has asked Xi Jinping to intervene to stop the war in Ukraine, Trump said China has not done very much on that. "He's got a lot of power. I said you ought to get it settled. I had that talk with President Xi the other day too. I said we don't want that crap in our country. We've got to stop it. I would have stopped it."

# Trump announces \$500 bn AI initiative

Washington (pti): US President Donald Trump announced a USD 500 billion investment in AI infrastructure through a new company, which is being created in partnership with Oracle, SoftBank and Open AI. The venture, called Stargate, adds to tech companies' significant investments in US data centres, huge buildings full of servers that provide computing power. The three companies plan to contribute funds to the venture, which will be open to other investors and start with 10 data centres already under construction in Texas. "That's a massive group of talent and money. Together, these world-leading technology giants are announcing the formation of Stargate," Trump announced on Tuesday at a White House news conference along with Oracle Chief Technology Officer Larry Ellison, Softbank CEO Masayoshi Son and Open AI CEO Sam Altman. "So, put that name down in your books because I think you're going to hear a lot about it in the future, a new American company that will invest USD 500 billion at least in AI infrastructure in the United States and very, very quickly, moving very rapidly, creating over 100,000 American jobs almost immediately," said Trump.

# 'I like competent people coming to US'

US President Donald Trump has said he likes both sides of the argument on the H-1B foreign guest workers' visa, noting that the country needs "very competent" and "great" people which is possible through this visa programme. Trump also said that he has also used the H-1B visa programme. The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China. "I like both sides of the argument, but I also like very competent people coming into our country, even if that involves them training and helping other people who may not have the qualifications they do. But I don't want to stop — and I'm not just talking about engineers, I'm talking about people at all levels," Trump said on Tuesday. He made these remarks while talking to reporters at the White House during a joint news conference with Oracle CTO

Larry Ellison, Softbank CEO Masayoshi Son, and Open AI CEO Sam Altman. The president was responding to a question on the ongoing debate on H-1B visas within his support base. Indians are the main beneficiaries of the H-1B visas, which bring in the best of the talent and brains from across the world. Highly skilled professionals from India walk away with the overwhelming number of H-1B visas - which is Congressional mandated 65,000 every year and another 20,000 for those who received higher education from the US. While his close confidants like Elon Musk, the Tesla owner, support H-1B visas as they bring in qualified tech professionals, many of his supporters oppose it arguing that it takes away jobs from Americans. "We want competent people coming into our country. And H-1B, I know the programme very well. I use the programme. Maitre d, wine experts, even waiters, high-quality waiters — you've got to get the best people. People like Larry, he needs engineers, Masa also needs... they need engineers like nobody's ever needed them," Trump said.

"So, we have to have quality people coming in. Now by doing that, we're expanding businesses and that takes care of everybody. So I'm sort of on both sides of the argument, but what I really do feel is that we have to let really competent people, great people, come into our country. And we do that through the H-1B programme," Trump said. Since December, the debate on foreign guest workers visas for highly skilled professionals, the H-1B, has intensified which has literally created divisions in both the Democratic and the Republican parties. Such a backlash initially came from the supporters of Trump who argued that this is eating away at the jobs of Americans. Both Musk and Vivek Ramaswamy immediately weighed in and supported the H-1B visas. However, influential Democratic Senator Bernie Sanders asserted that the two close confidants of Trump are wrong. The debate appeared to originate from a suggestion last month from Sriram Krishnan, Trump's pick for White House policy adviser on artificial intelligence, that Musk examines removing caps on green cards for skilled immigrants.

# Aid flowing smoothly into Gaza: UN

United Nations (PTI): The United Nations humanitarian coordinator in Gaza said Tuesday trucks from the UN, aid groups, governments and the private sector are arriving and no major looting has been reported — just a few minor incidents. Nearly 900 trucks of aid entered Gaza on the third day of the ceasefire on Tuesday, the United Nations said. That's significantly higher than the 600 trucks called for in the deal. Muhannad Hadi, who returned to Jerusalem from Gaza on Tuesday afternoon, told UN reporters by video that it was one of the happiest days of his 35-year humanitarian career to see Palestinians in the streets looking ahead with hope, some heading home and some starting

to clean up the roads. In his talks with families at a communal kitchen run by the UN World Food Programme and elsewhere, he said, they all told him they need humanitarian assistance but want to go home, to work and earn money. "They don't like the fact that they have been depending on humanitarian aid," Hadi said. Palestinians talked about resuming education for their children and about the need for shelter, blankets and new clothes for women who have been wearing the same clothes for more than a year. He said a shipment of tents is expected in the coming days. Hadi, who is also the deputy UN coordinator for the Middle East peace process, said the UN hopes to start "early recovery"

programmes, beginning with cash-for-work removing the tons of rubble in Gaza. But he said the UN must make sure the banking system is operating and electricity is back, stressing the critical role of UN member states and the private sector in early recovery. Hadi said lawlessness and looting happen in any war situation but with the ceasefire in Gaza, the UN is hoping for a restoration of law and order, as he stressed that the minor incidents reported were not by organised criminals who looted UN convoys during the war. Since the ceasefire, he said some kids jumped on some trucks trying to take a food basket, and some other people tried to take bottled water.

# 'Key Justice Dept. officials reassigned'

Washington (PTI): The US Justice Department has reassigned key senior officials across multiple divisions as part of a leadership shakeup ahead of the expected confirmation of President Donald Trump's pick for attorney general, Pam Bondi, multiple people familiar with the matter said on Tuesday. Among those moved to other positions inside the department is Bruce Swartz, the long-time head of the Justice Department's office of international affairs, which handles extradition matters, according to two people who spoke to The Associated Press on condition of anonymity because they were not authorised to discuss personnel moves. As many as 20 or so officials in all have been reassigned. Another affected official is George Tosca, a veteran deputy assistant attorney general in the

department's national security division who, in addition to helping oversee major terrorism and espionage investigations, has also been a key supervisor in politically charged probes over the last decade, including into Hillary Clinton's handling of classified information and Trump's hoarding of classified documents at his Mar-a-Lago estate. A Justice Department spokesman did not immediately return a call seeking comment. The reasons for the moves were not immediately known. Though it is common for a new administration to appoint its own political hires at the top of the Justice Department, it is not standard for career lawyers to be reassigned. They serve the department across administrations and typically retain their positions even when control of the department changes hands.

# 'Canada will respond to US tariffs'

Toronto (PTI): Canada's outgoing prime minister and the leader of the country's oil rich province of Alberta are both confident that Canada can avoid the 25 per cent tariff US President Donald Trump says he will impose on February 1. Justin Trudeau and Danielle Smith will argue that Canada is the energy super power that has the oil and critical minerals that America needs to feed what Trump vows will be a "booming" US economy. But Doug Ford, the premier of Ontario, the manufacturing and automobile hub of Canada, said a trade war is 100 per cent coming. Trump "declared an economic war on Canada," Ford said in an interview with The Associated Press. "And we are going to use every tool in our tool box to defend our economy." Trudeau said Canada will retaliate if needed, but noted that Canada has been here before during the first Trump presidency when they successfully renegotiated the free trade deal. Ford said as soon as Trump applies tariffs, he will instruct Ontario's liquor control board to pull all American-made alcohol from the shelves. "We are the largest purchaser of alcohol in the world. And I'm going to encourage all the premiers to do the exact same," Ford said, adding that there will be a

dollar-for-dollar tariff retaliation on American goods entering the Canada. "We are going to target the Republican held areas as well. They are going to feel the pain. Canadians are going to feel the pain, but Americans will feel the pain as well," he said. "A message to the countries around the world: if he wants to use Canada as an example, you are up next. He's coming after you as well." Trump pledged in his inaugural address that tariffs would be coming in a speech in which he promised a golden era for America. He later said Canada and Mexico could be hit with the tariffs as soon as February 1, though he signed an executive order requesting a report coordinated by the secretary of commerce by April 1. Trump said Tuesday that the 25 per cent tariff that he intends to place on Canada and Mexico as soon as February 1 would have "nothing to do" with renegotiating the existing trade pact among the three countries. For him, the tariffs are all about stopping unauthorised migration and the flow of any illicit drugs. The US president told reporters at the White House that, in his opinion, the amount of fentanyl coming through Canada and Mexico is "massive".

US Customs agents seized just 43 pounds of fentanyl at the Canadian border last fiscal year, compared to 21,100 pounds at the Mexican border. About 60 per cent of US crude oil imports are from Canada. Despite Trump's claim that the US doesn't need Canada, nearly a quarter of the oil America consumes per day comes from Canada. America's northern neighbour also has 34 critical minerals and metals that the Pentagon is eager for and is also the largest foreign supplier of steel, aluminum and uranium to the US. Nearly USD 3.6 billion Canadian dollars (USD 2.7 billion) worth of goods and services cross the border each day. Canada is also the top export destination for 36 US states. "Trump wants to usher in a golden age for the US," Trudeau said at a Cabinet retreat in Quebec called to deal with Trump's threats. "If the American economy is going to see the boom that Donald Trump is predicting, they are going to need more energy, more steel and aluminum, more critical minerals, more of the things that Canada sells to the United States every single day." On Tuesday, Mexico President Claudia Sheinbaum stressed the need to keep "cool heads" and look at the wording of what Trump signed, rather than listen to the discourse surrounding it.

# Israel to maintain control of Gaza-Egypt crossing

Israel said it will maintain control of the Rafah border crossing between Egypt and the Gaza Strip during the first phase of the ceasefire with Hamas. A statement by Prime Minister Benjamin Netanyahu's office on Wednesday denied reports that the Palestinian Authority would control the crossing. It said local Palestinians not affiliated with Hamas who had been vetted by Israeli security would merely stamp passports at the crossing. It noted that, under international agreements, this stamp "is the only way Gazans may leave the Strip in order to enter, or be received in, other countries." The truce, now its fourth day, is supposed to bring calm to the war-battered Gaza for at least six weeks and see 33 Hamas-

held hostages released in return for hundreds of Palestinians imprisoned by Israel. The statement said European Union monitors would supervise the crossing, which will be surrounded by Israeli troops. Israel also will approve the movement of all people and goods. Israel captured the Gaza side of the Rafah crossing last May, forcing it to shut down. Egypt, a key mediator in more than a year of negotiations that led to the ceasefire, has demanded that Palestinians control the Gaza side. The war began when Hamas-led militants stormed into Israel on October 7, 2023, killing some 1,200 people, mostly civilians, and abducting around 250. Around 100 hostages still remain in Gaza, after the rest were released, rescued, or their bodies were recovered.

Additional District and Session Judge Court-2 of Cumilla Afroza Jesmin passed the order as there was no evidence against 79-year-old Zia, who is now undergoing treatment in London, the state-run BSS news agency reported.

Arch-rival Sheikh Hasina. Zia had been imprisoned for more than two years. On March 25, 2020, the Hasina government suspended her sentence and granted her conditional release through an executive order. Subsequently, the government extended her sentence suspension and release period every six months, upon application. # RBI Monetary Policy Committee member Nagesh Kumar advocates two inflation rates

RBI Monetary Policy Committee member Nagesh Kumar has suggested that there should be two inflation rates - one including food prices and the other without food prices - so that relevant rates could be taken into account for policy making.

Chief Economic Advisor V Anantha Nageswaran in the Economic Survey 2023-24 had pitched for excluding food inflation from the rate setting calls, saying that the monetary policy has no bearing on the prices of food items, which are dictated by supply side pressures.

"I think there is a healthy debate on what should be the target, whether overall headline inflation rate or inflation rate excluding the food products, which are, you know, very seriously affected by seasonal demand, supply mismatch," Kumar told PTI while responding to a question on suggestions made in the Economic Survey for excluding food inflation while setting benchmark interest rates.



The weightage of food in the overall consumer price inflation, which stands at 46 per cent, was done in 2011-12, and needs to be revisited.

"I think we should have two inflation rates, one including food inflation and one without food inflation... So the relevant rate could be considered for what, which particular policy

parameter one is looking at," he said.

India introduced the inflation-targeting framework in 2016 under which the Reserve Bank of India (RBI) is mandated to keep retail inflation at four per cent, with a margin of two per cent on either side.

The benchmark policy rates are decided bi-monthly by the

RBI on the basis of movement in consumer price index, which includes food, fuel, manufactured goods and select services.

Responding to a question on high food prices, Kumar said retail inflation slowed to a four-month low of 5.22 per cent in December.

"A large part of this 5.2 per

cent is because of the food prices inflation, and then also a seasonal mismatch of vegetable prices... And that corrects by itself, when more supplies come to the mandis, we should see inflation being restrained much more," Kumar added.

On India's current macroeconomic situation, he said slowdown in India's economic growth to a seven-quarter low of 5.4 per cent in the second quarter was a temporary, transient kind of slowdown.

According to Kumar, it reflected the lag effect of the very strong squeeze in capex of the government in the first quarter because of the election code of conduct, but the capex started to pick up in the second quarter.

"We expect a strong growth in the second half of the year, and overall, I think we should be making up somewhere around 6.5 per cent or 6.6 per cent," he said.

Responding to a question on outlook of the Indian economy in FY26, Kumar said the performance of the Indian economy will be slightly better next fiscal year than this year.

# Irregularities found in one rupee crop insurance scheme for farmers

Maharashtra Agriculture Minister Manikrao Kokate has admitted irregularities in the implementation of the one rupee crop insurance scheme for farmers, noting places of worship were shown as agricultural lands to claim benefits.

More than four lakh crop insurance applications, some filed even by those residing outside Maharashtra, have been rejected, Kokate on Tuesday said, adding a "bogus industry" has come to light which involves non-eligible people seeking benefits of the scheme.

The minister, however, asserted that no money has been actually lost as funds were not transferred by the government into the bank accounts linked to bogus applications.

Speaking to the media here, Kokate said instances of malpractice in the scheme have been identified in several aspects, including cases where mosques, temples and vacant lands were falsely declared as agricultural lands to claim benefits.

"I have instructed district collectors to take immediate action," he said.

The crop insurance scheme



was introduced in the 2023 budget by the then deputy chief minister and finance minister Devendra Fadnis. Under the scheme, farmers can get crop insurance for just Re one.

Before the scheme, farmers had to pay the company two per cent of the insurance premium. The agriculture department had received several complaints from farmers about the scheme's implementation, chiefly on grounds of non-payment of the insurance amount as well as mismatch of records.

Agriculture Secretary Vikaschandra Rastogi later headed a committee which compiled the complaints and conducted a probe into them.

Kokate said, "Over four lakh crop insurance applications were rejected across the state. Some of these applications

were filed by people from outside Maharashtra. We have taken significant steps to address the irregularities. Farmers will be issued unique ID cards linked to Aadhaar to ensure transparency."

An updated database of farmers is being prepared, the minister said, adding that significant reforms will be introduced in the scheme.

Asked how the large-scale bogus claims could be made, Kokate attributed much of the malpractice to certain Common Service Centres (CSCs), where people involved in data entry of details of farmers are paid Rs 40 per application.

"The operators of such centres filed bogus applications to earn more. We have ordered action against 96 such centres," he said.

# I like competent people coming to US: says President Trump

US President Donald Trump has said he likes both sides of the argument on the H-1B foreign guest workers' visa, noting that the country needs "very competent" and "great" people which is possible through this visa programme.

Trump also said that he has also used the H-1B visa programme.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality

occupations that require theoretical or technical expertise.

Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

"I like both sides of the argument, but I also like very competent people coming into our country, even if that involves them training and helping other people who may not have the qualifications they do. But I don't want to stop - and I'm not just talking about engineers, I'm talking

about people at all levels," Trump said on Tuesday.

He made these remarks while talking to reporters at the White House during a joint news conference with Oracle CTO Larry Ellison, Softbank CEO Masayoshi Son, and Open AI CEO Sam Altman.

The president was responding to a question on the ongoing debate on H-1B visas within his support base.

Indians are the main beneficiaries of the H-1B visas, which bring in the best of the talent and brains from across the world. Highly skilled professionals from India walk away with the overwhelming number of H-1B visas - which is Congressional mandated 65,000 every year and another 20,000 for those who received higher education from the US.

While his close confidants like Elon Musk, the Tesla owner, support H-1B visas as they bring in qualified tech professionals, many of his supporters oppose it arguing that it takes away jobs from

Americans.

"We want competent people coming into our country. And H-1B, I know the programme very well. I use the programme. Maitre d', wine experts, even waiters, high-quality waiters -- you've got to get the best people. People like Larry, he needs engineers, Masa also needs... They need engineers like nobody's ever needed them," Trump said.

"So, we have to have quality people coming in. Now by doing that, we're expanding businesses and that takes care of everybody. So I'm sort of on both sides of the argument, but what I really do feel is that we have to let really competent people, great people, come into our country. And we do that through the H-1B programme," Trump said.

Since December, the debate on foreign guest workers visas for highly skilled professionals, the H-1B, has intensified which has literally created divisions in both the Democratic and the Republican parties

# EPFO adds 14.63 lakh net members in November

Retirement fund body EPFO has added 14.63 lakh net members in November 2024, a growth of 4.88 per cent over the same month last year, according to the latest payroll data.

The growth in net member additions signifies increased employment opportunities and heightened awareness of employee benefits, bolstered by EPFO's effective outreach initiatives, a labour ministry statement said.

On a monthly basis, net member additions rose by 9.07 per cent over October 2024, the ministry said.

The EPFO enrolled around 8.74 lakh new members in November 2024, up by 18.80 per cent over the year-ago month and a 16.58 per cent rise against October 2024, the provisional data showed.

The ministry said a noticeable aspect of the data is the dominance of the 18-25 age group, with 4.81 lakh new members added in this age group constituting a significant 54.97 per cent of the total new members added



in November 2024.

Net member additions in the age group of 18-25 years are approximately 5.86 lakh for November 2024, reflecting an increase of 7.96 per cent compared to the previous month of October 2024.

This is in consonance with the earlier trend which indicates that most individuals joining the organised workforce are youth, primarily first-time job seekers, the ministry said.

The payroll data highlights that approximately 14.39 lakh members exited and subsequently rejoined EPFO. This figure represents an 11.47 per cent increase compared to the previous month of October 2024. It also depicts a significant year-

on-year growth of 34.75 per cent in November 2024.

These members switched their jobs and re-joined the establishments covered under the ambit of EPFO and opted to transfer their accumulations instead of applying for final settlement thus, safeguarding long-term financial well-being and extending their social security protection.

Gender-wise analysis of payroll data unveils that out of the new members added during the month, around 2.40 lakh new members are female, it said.

The comparison with the previous month of October 2024 shows an increase of 14.94 per cent.

# NSE adds one crore investors in five months

The National Stock Exchange (NSE) on Wednesday said its unique registered investors have crossed the 11 crore mark, with the latest one crore addition taking place in just five months, reflecting investor participation in the stock market through direct means.

Investor registrations at the NSE have experienced a remarkable acceleration in recent times, with a 3.6 times jump in the last five years.

It took 14 years since the NSE's commencement of operations in 1994 to reach one crore investors. The pace then quickened, with the next 1 crore registrations taking about seven years, followed by another 3.5 years for the next crore and the subsequent milestone of adding the fourth crore took just over a year.

"The rate of growth has since quickened significantly, with each additional one crore investors being added in roughly six-seven months, while the last one crore investors were added in just over five months, reflecting a shift in investor enthusiasm and participation in the stock market through direct means," NSE said in a statement.

In the last five months, daily new unique investor registrations have consistently ranged between 47,000 and 73,000. This growth has been driven by several key factors, including the rapid advancement of digitisation, heightened investor awareness, financial inclusion efforts, and strong market performance.

In 2024, the Nifty 50 index delivered a return of 8.8 per cent while the Nifty 500 index saw an impressive 15.2 per cent gain. Indian markets have had positive returns for the past nine consecutive years.

# Rupee rises 25 paise against US Dollar

The rupee appreciated 25 paise to close at 86.33 (provisional) against the US dollar on Wednesday, supported by positive domestic equities and soft US dollar index.

Forex traders said the rupee is likely to witness high volatility with a negative bias ahead of key events in the global and domestic economic landscape.

Moreover, the overall uncertainty about the global economy continued to weigh on both currencies and commodities, keeping investors on edge.

At the interbank foreign exchange, the rupee opened at 86.56 against the greenback. During the day, the local unit touched an intraday high of 86.30 and a low of 86.71.

It finally closed at 86.33 (provisional) against the US dollar, up 25 paise from its previous close.

On Tuesday, the rupee fell 13 paise to 86.58 against the US dollar.

"We expect the rupee to remain largely weak on underlying

strength in the US dollar and overall weakness in the domestic markets. Importer demand for dollars may also pressurise the rupee. However, any extended sell-off in crude oil may support the rupee at lower levels," Anuj Choudhary - Research Analyst at Mirae Asset Sharekhan, said.

Choudhary further noted that markets may see some volatility on incoming statements and announcements by the Trump administration. "USD-INR spot price is expected to trade in a range of 86.20 to 86.65," he added.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading down 0.15 per cent to 107.89 as traders pondered over the Trump Tariff Plan.

Brent crude, the global oil benchmark, rose 0.48 per cent to USD 79.67 per barrel in futures trade.

Crude oil prices had fallen due to fears of tough US policies and had touched USD 78 per barrel, a 4 per cent decline from recent highs following President Trump's mention of increasing US oil output.

In the domestic equity market, the 30-share BSE Sensex rose 566.63 points, or 0.75 per cent, to settle at 76,404.99 points, while the Nifty rose 130.70 points, or 0.57 per cent, to 23,155.35 points.

Foreign Institutional Investors (FIIs) remained net sellers in the capital markets on Tuesday, as they offloaded shares worth Rs 5,920.28 crore, according to exchange data.

# Sensex, Nifty rebound on buying in Infosys, HDFC Bank, firm global trends

Benchmark Sensex rebounded nearly 567 points and Nifty regained 23,150 level on Wednesday following gains in blue-chip stocks Infosys, HDFC Bank and Tata Consultancy Services, and firm global trends.

The 30-share BSE Sensex surged 566.63 points or 0.75 per cent to close at 76,404.99. During the day, the benchmark surged 624.77 points or 0.82 per cent to hit an intraday high of 76,463.13 on the BSE.

On similar lines, the broader NSE Nifty climbed 130.70 points or 0.57 per cent to settle at 23,155.35. In the intraday session, the Nifty rose 144.9 points or 0.63 per cent to



23,169.55 on the NSE.

Among Sensex shares, Infosys, Tata Consultancy Services, Tech Mahindra, Sun Pharmaceutical, Bajaj Finserv, HCL Technologies, Bajaj Finance, HDFC Bank, IndusInd Bank and Kotak

Mahindra Bank were among the gainers.

Tata Motors, PowerGrid, Axis Bank, State Bank of India, NTPC, Tata Steel and Adani Ports were the major laggards.

"The benchmark indices rebounded amidst heightened

volatility following better-than-expected results from a major private bank. The IT sector led gains, recovering from recent losses, while mid and small-cap stocks continued to underperform due to valuation concerns," Vinod Nair, Head of

Research, Geojit Financial Services said.

European markets were trading higher on Wednesday. In Asian markets, Tokyo and Seoul were settled on a positive note while Hong Kong and Shanghai closed in the negative territory. Wall Street had ended higher on Tuesday.

International oil benchmark Brent Crude was trading 0.49 per cent higher at USD 79.68 a barrel.

Foreign Institutional Investors (FIIs) offloaded shares worth Rs 5,920.28 crore on Tuesday.

The BSE Sensex plummeted 1,235.08 points to settle at 75,838.36 and the broader NSE Nifty plunged 320.10 points to close at 23,024.65 on Tuesday.

# Some equity research firms shutting shops after SEBI's new guidelines on research analysts

Markets regulator SEBI's new guidelines on research analysts (RAs) are forcing several equity research firms publicly announcing plans to shut down their shops due to heightened compliance and operational requirements.

The Securities and Exchange Board of India (Sebi), on January 8, came out with guidelines for Research Analysts in a bid to curb fraudulent stock recommendations and illegal practices in the securities market.

The new guidelines necessitate research firms to comply with stricter measures such as maintaining records of

client interactions, conducting compliance audits, and following Know-Your-Customer (KYC) procedures and these requirements have led to increased operational costs for smaller entities.

Consequently, a few firms including Sentinel Research, Stalwart Advisors, and Mystic Wealth have announced their plans of shutting their research services citing significant operational and compliance burden.

Market experts said that the new guidelines have notably lowered the threshold for individuals to register as RAs, making it easier for newcomers to enter the profession. However, for established RAs, these



guidelines have imposed heightened compliance and operational requirements.

They believe that the new regulations are too stringent and could undermine the quality of research in the market.

Sandeep Parekh, founder of Finsec Law Advisors, posted on microblogging site X that Sebi is "going way overboard in its regulations and shutting down competent and honest advisors and researchers from the

market".

"If it goes down this path, all that will remain will be incompetent and dishonest, or incompetent or dishonest advisors," he added.

Neeraj Marathe, who operates independent research firm Sentinel Research, also expressed his dismay on social media.

He had paused his research services last year when the draft RA regulations were first announced, hoping for more clarity and more balanced guidelines.

However, upon reviewing the final regulations, he stated that the rules were even more burdensome than expected.

"Last year, when the proposed RA regulations came, I had paused my

research services at sentinelresearch.in. The hope was that the actual regulations would be better in terms of conditions and compliance and I shall restart after getting clarity. Well, the actual regulations have turned out to be much worse! I too shall be discontinuing my research services portal," he added.

Stalwart Advisors, which has been operating its equity research service "Treasure Trove" for over a decade, announced it would be closing its operations.

The firm cited the increased operational and compliance requirements, including the rule that limits subscription fees to a quarterly payment model, as a key factor in its decision.



# Liverpool beats Lille to reach Champions League round of 16

Liverpool became the first team to guarantee a place in the last 16 of the new Champions League format by beating Lille 2-1 on Tuesday, while Barcelona fought back from two goals down to stun Benfica 5-4 in a thriller.

Harvey Elliott's bouncing, deflected shot gave Liverpool its seventh win from seven games, just after 10-man Lille had equalized following Mohamed Salah's opening goal.

Liverpool needed a point at Anfield to be sure of reaching the round of 16 as one of the top eight teams in the league stage, skipping the playoff round for teams ranked ninth to 24th.

Salah raced through in the 34th minute to sweep Liverpool ahead with his 22nd goal in all competitions this season. And when Lille's Aissa Mandi was sent off just before the hour mark, Liverpool looked certain to extend its 100% record in the league phase.

But Anfield was stunned when Canada striker Jonathan David converted from close range to level the score in the 62nd. It

didn't take long for Liverpool to regain the lead through Elliott's deflected effort five minutes later. "All my life I've dreamt of playing Champions League football, not only for my boyhood club but to play here at Anfield in front of our fans and especially to score, it's kind of a pinch-me moment," Elliott said.

Barcelona's comeback win It was a night of high drama in the Champions League with 33 goals scored across nine games. Nine of them came in Barcelona's battle with Benfica.

Raphinha scored in stoppage time to complete a rousing comeback as Barcelona won in Lisbon despite having been 4-2 down with less than a quarter of an hour remaining.

Benfica's Vangelis Pavlidis scored the third-fastest hat trick at the start of a Champions League game, with two of his goals coming after errors by Barcelona goalkeeper Wojciech Szczesny. Barcelona stays second with 18 points from seven games, and is now unbeaten in six games in all competitions since the new year.

"We came with the mindset that we could turn the game," Raphinha said. "We never gave up



and managed to grab a win." Robert Lewandowski scored two penalties for Barcelona to stay the Champions League's top scorer on

red card and went into half time 1-0 down to a Piero Hincapie header for Leverkusen.

Alvarez scored in the 52nd and had the momentum when Hincapie was sent off for a second yellow card, before Alvarez struck again to take the win and lift Atletico to third.

**Villa slides out of the top eight** With Prince William watching on, Aston Villa's hopes of automatic qualification for the round of 16 took a blow after a 1-0 loss to Monaco.

Villa led the standings early in the league phase of the competition after winning its first three games. But defeat to Monaco left the Premier League club eighth.

Wilfried Singo's goal at a corner in the eighth minute was enough to secure the win for ninth-place Monaco.

**Dortmund slump continues** Borussia Dortmund's 2-1 loss at Bologna increased the pressure on coach Nuri Sahin in Dortmund's fourth consecutive loss at the start of the new year in all competitions.

Serhou Guirassy gave Dortmund, last season's runner-up, the lead with a chipped penalty and ran to celebrate with Sahin.

It looked like the Champions League could provide a much-needed boost for a team floundering in the Bundesliga, but two goals in two minutes from Thijs Dallinga and Samuel Iling-Junior changed the game for previously winless Bologna. Results elsewhere meant Bologna will be heading out of the competition despite its win, since the Italian club can't finish in the top 24. Sturm Graz and Red Star Belgrade are also out after losing Tuesday.

Atalanta beat Graz 5-0, strengthening the Italian club's push to qualify directly for the round of 16. Atalanta finished the evening fourth.

PSV Eindhoven hung on for a 3-2 win at Red Star despite losing defender Flamingo to a red card just after halftime while leading 3-0. Stuttgart eased to a 3-1 win over Slovan Bratislava, which was already eliminated and has lost all seven of its games. Club Brugge and Juventus drew 0-0.

**Europa League** In the only Europa League game of the night, Galatasaray missed a chance to go third in the table, giving up a 3-1 lead to draw 3-3 with last-place Dynamo Kyiv.



## Australian Open: Ben Shelton criticises TV interviewers

American tennis player Ben Shelton criticized on Wednesday some of the questions and comments made by post-match TV interviewers at the Australian Open.

After Shelton reached the semifinals at the Grand Slam tournament, he followed his final answer at his news conference by saying: "One thing that I just want to say before we're done: I've been a little bit shocked this week with how players have been treated by the broadcasters." He began by referencing the flap over a television commentator's on-air insults about Novak Djokovic, which caused the 24-time Grand Slam champion to refuse to speak to the local broadcaster, Channel 9, after one match.

Djokovic eventually relented after receiving public apologies from the network and its employee, Tony Jones. "I don't think that was just a single event," Shelton said. "I've noticed it with different people, not just myself."

Shelton went on to mention the interview with 19-year-old American Learner Tien after his upset win over 2021 U.S. Open champion Daniil Medvedev ended at about 3 a.m. In the second round at Melbourne Park last week, calling it "embarrassing and disrespectful".

That awkward exchange included a series of statements to Tien, rather than questions, including observations by the interviewer that "19-year-

olds are not meant to be that good" and "I know where you live, by the way."

Shelton also noted two of his own on-court TV interviews. After the 22-year-old's win against 38-year-old French veteran Gael Monfils in the fourth round, interviewer Roger Rasheed, a former tennis coach, attempted to make a joke by saying, "He's almost your Dad."

Both Shelton and Monfils are Black. Shelton responded to Rasheed: "Was that a Black joke?" To which Rasheed replied, "I'm not sure."

Then, after Shelton's 6-4, 7-5, 4-6, 7-6 (4) victory over Lorenzo Sonego in the quarterfinals Wednesday, he was asked about facing either the defending champion, Jannik Sinner, or an Australian player, Alex de Minaur, next, with the interviewer pointing out that the spectators likely would be cheering against Shelton in the semifinals, either way.

Shelton answered: "I know I've got a few people out in the crowd who are going to be pulling for me, too."

At his news conference, Shelton said that what the interviewer said about the fans' support "may be true, but I just don't think the comment is respectful from a guy I've never met before in my life."

Shelton closed by saying: "I feel like broadcasters should be helping us grow our sport and help these athletes who just won matches on the biggest stage enjoy one of their biggest moments. I feel like there's just been a lot of negativity.

## 428 athletes from 19 teams to take part in KIWG 2025

The Khelo India Winter Games (KIWG) 2025 that starts on Thursday will feature 428 athletes from 19 competing teams.

Sports Minister Mansukh Mandaviya is set to declare the Games open in Leh on Thursday.

Nineteen teams, comprising states, Union Territories, and institutional outfits, will compete over five days across two events - ice hockey and ice skating - marking the first part of KIWG 2025.



A traditional Ladakhi-style opening ceremony has been planned to welcome 594 participants, including 428 athletes.

The second part, featuring snow games like skiing, will be hosted by Jammu and Kashmir from February 22 to 25.

"Sports Minister will attend the opening ceremony at the iconic Nawang Dorjay Stobdan Sports Complex in Leh on Thursday and will declare the games open," an official spokesperson said.

Mandaviya will be joined by a host of dignitaries, including the Lieutenant Governor of Ladakh, Brigadier Dr BD Mishra, and senior officials from the

Sports Authority of India and the Ladakh Autonomous Hill Development Council.

This will be the second time Ladakh hosts the Winter Games, now in its fifth edition, the spokesperson said.

"All teams have arrived in Leh, which is at an altitude of 11,562 feet. Himachal Pradesh has the largest contingent, comprising 78 athletes and support staff," he added.

Haryana (62), hosts Ladakh (52), and Maharashtra (48) will compete in the Ladakh edition. Uttarakhand, which will host the National Games later this

month, has the smallest team, comprising just one athlete.

The fifth edition of the Khelo India Winter Games will be held across two phases in Ladakh and Jammu & Kashmir, from January 23 to 27 and February 22 to 25, respectively, covering two ice and four snow disciplines, the spokesperson said.

Apart from identifying talent, the Khelo India Winter Games aim to showcase a region's art, culture, heritage, and promote tourism through sports. Several young skaters will compete at the Nawang Dorjay

## Borussia Dortmund fires coach Nuri Sahin

Borussia Dortmund fired coach Nuri Sahin on Wednesday, a day after its 2-1 loss to Bologna in the Champions League.

The loss extended Dortmund's losing streak to four games since the new year and dropped last season's Champions League runner-up to 13th in the standings. Dortmund is also struggling in the Bundesliga, where it's 10th.

"We really value Nuri Sahin and his work, we had wished for a long cooperation and until recently we hoped that we could manage to turn things around in sporting terms," sporting director Lars Ricken said in a statement.

"After four losses in a row, with just one win from the last nine games and currently being 10th in the Bundesliga, unfortunately we lost our faith in being able to achieve our sporting goals in the current configuration. This decision is personally painful for me too, but it was no longer avoidable after the game in Bologna."

There was no immediate word on a successor. Dortmund's next game is Saturday in the Bundesliga against Werder Bremen.

The 36-year-old Sahin had been Dortmund coach since June. He had been an assistant to Edin Terzic, who resigned following Dortmund's 2-0 loss to Real Madrid in the Champions League final, saying the club needed to enter a "new era" without him.

## Sindhu, Lakshya to lead team in Badminton Asia Mixed Championship

Double Olympic medallist PV Sindhu and World Championships bronze winner Lakshya Sen will lead a 14-member Indian team for the Badminton Asia Mixed Team Championship to be held in Qingdao, China from February 11-16.

India had clinched a bronze medal in the last edition of the competition in Dubai in 2023.

"The national selectors have given importance to the world rankings and current form of the players while selecting the squad that will have HS Prannoy and Malvika Bansod as the second men's and women's singles players respectively," the Badminton Association of India said in a release.

The strong Indian team will also have star doubles players Satwiksairaj Rankireddy and



Chirag Shetty. The women's doubles pairing could be either Gayatri Gopichand and Treesa Jolly or Ashwini Ponnappa and Tanisha Crasto. Tanisha will also pair up with Dhruv Kapila in mixed doubles while Sathish Kumar K and Adya Variyath will be the second combination.

BAI secretary general Sanjay Mishra said, "We did well by winning the bronze medal two years ago, but the target this year is to reach the finals, and then anything is possible, and we will go all out."

## Mainz signs US midfielder Lennard Maloney

German-born U.S. Midfielder Lennard Maloney has joined Mainz from Bundesliga rival Heidenheim, where he was dropped last month after expressing his wish to leave.

The 25-year-old Maloney, who had informed Heidenheim he was going to join Mainz when his contract expired at the end of the season, got his wish Tuesday when the clubs agreed on a deal.

"Maloney has been able to prove himself in the Bundesliga over the last year and a half," said Mainz sporting director Niko Bungert said. "His preferred position is as a number six and as a player, he's the perfect fit for Mainz 05. He brings a strong mentality, as well as a willingness to run hard, and is also strong at winning challenges and aerial duels. Lennard will find it easy to fit into our squad with his warm, open



personality."

Maloney signed a contract to 2028.

After 18 rounds of the league, Heidenheim is in the relegation playoff spot while sixth-place Mainz is on course for European qualification.

Heidenheim coach Frank Schmidt said in December he wasn't picking the defensive midfielder because he lacked commitment amid a series of

disappointing performances.

"I can only count on players in this phase who are 100% focused on the interests of Heidenheim," Schmidt said.

"From a coaching perspective I simply want another focus and another level of performance from my vice-captain."

The Berlin-born Maloney has made two appearances for the United States — both in 2023.

# Enrique must outwit Guardiola when PSG meets Manchester City

Luis Enrique credits Pep Guardiola with inventing arguably the "perfect model" of attacking soccer.

He must now outwit him when Paris Saint-Germain faces Manchester City in the Champions League on Wednesday, in a match both teams must win to avoid the prospect of early elimination in the new-look format.

"It's a special game. Not just for the two teams but because I will come across a friend who I shared many great moments with as a player and a person," Enrique said on Tuesday through a translator.

"What brings us closer is our vision of football: To try and be better than the opponent on the ball, to constantly press the opponent. We can fine-tune our game but we have a similar way of

seeing things."

Guardiola rose to fame as a coach during a glory era for Barcelona, winning the Champions League twice and multiple other trophies. Guardiola's sides hypnotized opponents with a pulsating brand of attacking soccer led by Lionel Messi that was the envy of Europe. Guardiola then turned City into a Premier League force.

"The 4-3-3 with Barcelona was almost the perfect model. He opened up a different way of playing in England and did so with success, he opened many doors for others," Enrique said.

"Pep has innovated throughout his career and is not scared to do so again."

Guardiola won the Champions League again with City in 2023, while Enrique's PSG reached the semifinals last season.

**Enrique and Guardiola have history**



They go back far. "We were mates in Barcelona and our families are really close friends," Guardiola said. "Our friendship will be eternal. They (Enrique's family) love us (and I

think we have an incredible connection." Enrique and Guardiola, who both are 54, played together in Barcelona's midfield from 1996-2001: Enrique the tireless dynamo who

scored 109 goals for the club; Guardiola the astute minesweeper protecting defense.

**As coaches, they are more similar.**

"If anything can define both Pep and I as coaches (it) is that we like to attack. We like to defend properly but we like to devise our game plan to be better than the opposition," said Enrique, who won the Champions League with Barca in 2015. "There are a lot of things I must think about when I have my cappuccino tomorrow morning."

**Namely that PSG is in danger of going out.**

So is City.

PSG is 25th out of 36 teams, and City is only one point ahead in 22nd. The bottom 12 are eliminated.

"Everyone has to be ready," Enrique said. "Man City do a lot of things tactically, they switch positions a lot. But we pose a lot

of problems. The team that is best prepared or best develops its ideas will win."

City is turning the corner after a slump that had Guardiola interrogating himself. City has rebounded with 22 goals in the past five games. Attacking midfielder Phil Foden is finding form and prolific striker Erling Haaland has signed a mega-contract until 2034.

"City are also very at ease with a transition game and have very dangerous players in attack," Enrique said. "We will see who makes the most of the possession. We want to keep the ball, it's when you retain possession that you have the most chance of winning."

**As long as you score.**

Wasteful PSG has netted just six goals in six games and was blanked by Bayern Munich and Arsenal.

"I hope for a horrible

performance from PSG tomorrow," Guardiola said, jokingly.

**Mbappe's shoes not filled** The void left by Kylian Mbappé since he joined Real Madrid is still felt. He scored a career-high 44 goals last season.

"We obviously had a player of reference who scored an immense amount of goals," Enrique said. "I don't think any one of our players previously showed they could score 25 goals in a season, so we have to resolve it through the team."

PSG's main scoring threat comes from winger Ousmane Dembélé, who has recovered from a heavy flu.

"I feel much better," he said on Tuesday. "I had five or six days when I wasn't feeling well."

Dembélé has 11 goals from 22 games and is well on course to beat his best of 14 with Barcelona in 2018-19.





# Australian Open: Swiatek will face Madison Keys in semifinals

Iga Swiatek is dominating her Australian Open opponents the way no one has at Melbourne Park since Maria Sharapova in 2013. Swiatek's latest lopsided win came via a 6-1, 6-2 score in the quarterfinals against No. 8 seed Emma Navarro on Wednesday. The No. 2-seeded Swiatek not only has not dropped a set so far in the tournament, but also has lost a grand total of only 14 games as she seeks her first title at Melbourne Park and sixth Grand Slam trophy overall. Sharapova was the last woman to reach the Australian Open semifinals having dropped fewer than 15 games. "She does everything with 100% conviction and intensity," Navarro said about Swiatek. "She has a different style of movement and play. It's tough to not be sort of affected by that and not feel like, OK, I have to do everything at the same speed that she's doing it. So that was something, for sure, I felt a little bit today." Swiatek will face No. 19 Madison Keys of the U.S. On Thursday night for a berth in the final. The other women's semifinalist is No. 1 Aryna Sabalenka, the two-time defending champion, against her good friend, No. 11 Paula Badosa. Keys, whose best showing at a major was getting to the title match at the 2017 U.S. Open, was a 3-6, 6-3, 6-4 winner against Elna Svitolina and is into her third semifinal in Australia. "Iga is tough to beat, because she has a lot of spin, kind of naturally, on both sides. She's a good server. She's a good returner. She moves

incredibly well," Keys said. "The biggest thing that makes her so difficult to beat is, because she moves so well, if you miss your spot just slightly, she has enough time to recover, and then the point goes back to neutral." There's an American in the men's semifinals, too: No. 21 Ben Shelton got that far in Melbourne for the first time with an entertaining 6-4, 7-5, 4-6, 7-6 (4) win over unseeded Lorenzo Sonego of Italy. Shelton was a semifinalist at the 2023 U.S. Open and now will meet No. 1 Jannik Sinner, the defending champion, or No. 8 Alex de Minaur in that round. Sinner faced de Minaur on Wednesday night. The other men's semifinal Friday is Novak Djokovic vs. Alexander Zverev. Against Navarro, Swiatek benefited from a no-call of a double bounce on a point she won in the second set. Because Navarro continued playing the point and did not immediately stop to ask for a video review, she wasn't allowed to have the sequence checked. Either way, Swiatek's dominance was pretty clear, even if she was modest about things afterward. "Well, I think it was much more tougher than the score says," said Swiatek, a 23-year-old from Poland. "Emma's a fighter... And I wanted to stay focused and keep my intensity." Swiatek has won four of five career matchups against Keys, 29. "Madison is a great player and experienced, so you never know," Swiatek said. "I'll be just focused on myself." Using a new racket this season, Keys is on a 10-match winning streak, including a

title at a hard-court tune-up event in Adelaide. Her run to the semifinals in Melbourne includes victories over two past runners-up at the Australian Open, Danielle Collins and Elina Rybakina. Keys' past losses in the semifinals in Melbourne came against eventual champions Serena Williams in 2015 and Ash Barty in 2022. "I think I play a little bit smarter for sure... Probably a little bit less fearless," Keys said. Svitolina, a three-time Slam semifinalist, was in control during the first set. But Keys made some tactical adjustments, including looking for more opportunities to get to the net. She won 23 of the 26 points when she moved forward and ended up with a total of 49 winners, 23 on her powerful forehand side. The one difficulty Keys had was getting going in her return games. But she finally converted her seventh break chance to lead 4-2 in the second set. "Getting to the point where I'm starting to appreciate my career for what it has been, and it doesn't have to have a Grand Slam in order for me to look at it and say, I've done a really good job, and I've really left everything out there." Now, while that's obviously still the goal, there have been periods of my career where it felt like if I didn't win one, then I hadn't done enough," Keys said. "That kind of took a lot of the fun out of the game, and there were times where it felt paralyzing out on the court because it felt as if I needed it to happen, instead of giving myself the opportunity to go out and potentially do it.



# There was a sense of fear during rehabilitation: Shami

Seasoned India pacer Mohammed Shami has revealed that he was gripped by a sense of fear when he began his rehabilitation after a long injury layoff, but managed to overcome that phase by training his mind to stay focussed on the national comeback. Shami was sidelined after the lost ODI World Cup final against Australia in November 2023 due to an ankle injury that required surgery. The recovery from that was followed by a swelling on his left knee during the domestic comeback some weeks back. Following his inclusion in India's Champions Trophy squad, his return has garnered national attention. He is also in the squad for the five-match T20I series against England beginning here later this evening. "I waited for an entire year and I worked very hard (to get back to full fitness). There was a sense of fear (of getting injured during rehabilitation) even while running," Shami said in a video posted by BCCI. "It is difficult for any player to get injured after being in full

flow, go the the NCA (National Cricket Academy) for rehabilitation and then make a comeback," he added. The cricketer, however, said an athlete is far more determined after deaking with an injury. "When you go through injuries, I feel you grow stronger as an athlete, this is what I feel. Because you have to repeat a lot of things while being mentally strong." Shami went through the domestic grind, representing his home state Bengal in the Ranji Trophy, Syed Mushtaq and Vijay Hazare but a swelling in his knee finally ruled him out of the five-match Border-Gavaskar Test series in Australia. On his competitive return in the Ranji Trophy, he guided Bengal to their first win of the season with a seven-wicket haul. He followed it up with impressive performances in the Syed Mushtaq Ali Trophy (11 wickets) and the Vijay Hazare Trophy (five wickets). Shami's T20I career has been sporadic, with just 23 appearances since his debut in 2014. His last outing in the format was against England in the 2022 T20 World Cup semifinal.

# India will adhere to dress code set by ICC at CT: BCCI

The Indian cricket team will adhere to the dress code set by the ICC during the upcoming Champions Trophy, BCCI secretary Devajit Saikia told PTI on Wednesday, rejecting speculation that the Board had objected to host Pakistan's name on the side's official jersey. The Champions Trophy will be held from February 19 and India will play its share of matches in Dubai after citing security concerns as the reason for refusing to travel to Pakistan. "BCCI will follow every uniform-related ICC rule during Champions Trophy," Saikia told PTI. "Whatever the other teams will do regarding the logo and dress code, we are going to follow in true letter and spirit," he added. However, Saikia said that whether national captain Rohit Sharma participates in the ICC's pre-tournament engagements, including a press conference and an official photo shoot in Lahore, is something that is still being discussed. "Whether Rohit Sharma travels to Pakistan for ICC media engagements is something that's still not decided," Saikia added. There were some unconfirmed media reports that the BCCI had objected to the host nation's name being embossed on their jersey, which is an established practice for all ICC events, owing to the tense political ties between the two countries.
