# 6 killed in stampede at Tirupati Heavy rush for tickets led to the tragedy at 'Vaikunta Dwara Darshanam'

The issuing of tokens for 'Vaikunta Dwara Darshanam' at Tirupati turned tragic with six people including five women getting killed in a stampede here on Wednesday.

The stampede took place when the gate was opened and thousands of people who were waiting to get a 'Vaikunta Dwara Darshan' ticket to have darshan of Lord Venkateswara at the Tirumala hill shrine on the auspicious Ekadasi Day rushed in. The Ekadasi Day falls on Friday.

Sources said that 20 injured people were admitted to the Ruia Hospital and nine were admitted to the SVIMS Hospital and are undergoing treatment. The stampede took place in the Bairagipatteda area when thousands of people rushed to get Vaikunta Dwara Darshan tokens when the gate was opened.

# United Breweries suspends beer supplies to TGBCL

United Breweries Limited (UBL), the makers of beer brands like Kingfisher and Heineken, has suspended supplies to the Telangana State Beverages Corporation Limited (TGBCL). The decision stems from TGBCL's failure to clear outstanding dues and the absence of price revision for beer after 2019.

This move by UBL is set to disrupt the availability of premium beer brands in Telangana, raising concerns among consumers and traders alike. The company stated that the absence of a price hike over the past four years and significant overdue payments have made operations in Telangana unsustainable.

In a statement, UBL expressed disappointment, pointing out that despite multiple representations to



the government through the Brewers Association of India (BAI), no solution could be achieved. The company emphasized that it is responsible to its stakeholders and can no longer operate with escalating losses.

The suspension also sparked debates about financial mismanagement in Telangana's excise sector. Industry insiders warn that without intervention from the government, the disruption could lead to short-

for setting up solar power plants. Coordination with banks for prioritised. The energy department, through TG REDCO, has invited tenders for the proiects, and these will soon be finalized. The Collectors were directed to speed up land acquisition and finalize eligible groups for the initiative.

The conference emphasized the benefits of solar energy, particularly for tribal areas, enabling farmers to adopt things like drip irrigation. This could lead to better yields and increased income for marginalized communities. Collectors were tasked with ensuring effective implementation, especially in tribal belts where land availability is higher.

The government also plans to integrate the PM-KUSUM scheme, enabling farmers to

produce up to two MW of solar power. Farmers have been encouraged to apply for this scheme via the TG REDCO portal, ensuring access to affordable and sustainable electricity.

Deputy Chief Minister Bhatt Vikramarka addressing Collectors emphasized that women's financial independence is key to their growth. The government has already finalised agreements between the energy and rural development departments to facilitate these solar power projects. Under the scheme, the government plans to provide interest-free loans and support self-help groups in using their resources effectively.

The Deputy Chief Minister also suggested using the rooftops of large buildings in urban areas like Hyderabad and Ranga Reddy districts for solar power generation. Protecting government land and promoting ecofriendly power generation were cited as added advantages of this initiative.

Pushkarini led to chaos. The crowd management arrangements reportedly failed to cope with the overwhelming number of attendees.

Devotees who came for tokens were kept at the Padmavathi Park near Byragipattedu to avoid crowding on the roads. However, when one of the staff members at the token issuance counter fell ill, the queue line gate was opened to shift him to hospital. Devotees, thinking that the counter had been opened for token issuance, devotees rushed forward. Witnesses report that a stampede occurred at this moment. Some have also alleged that proper security arrangements were not made at the queue lines. It is also said that the local staff did not inform the higher authorities about the alternative arrangements.

The decision to distribute tokens for darshan, while well-intentioned, was poorly executed. The absence of sufficient counters, a systematic queuing mechanism and clear communication exacerbated the situation. The lack of trained personnel to control the crowds and direct them safely contributed to the chaos.

tance, attracting devotees from across the country. The administration may have underestimated the turnout, especially after a period of pandemic-related restrictions. Devotees eager to attend after prior disruptions in temple activities likely contributed to the unusually high numbers.

Devotees reported confusion regarding the token distribution process which lacked clarity led to anxiety and crowding at specific counters. Inadequate use of technology, such as mobile apps or public announcements, to inform devotees about wait times or alternative

The token distribution centres were not equipped to handle large crowds, with narrow lanes and limited access points becoming choke points. The inability to regulate entry and exit flows likely contributed to crowd surges.

While administrative failures were a key factor, the combination of overwhelming turnout, logistical shortcomings, and human behavior created a tragic cascade of events.

For the first three days, January 10, 11, and 12, 1.20 lakh tokens were supposed to be issued on Thursday morning for Vaikunth Dwara darshan. For the remaining days, the tokens would be given at Vishnunivasa, Srinivasa, and Bhudevi complexes in Tirupati, as per TTD. However, due to the crowd of devotees, tokens have been issued from tonight, as informed by EO Shyamal Rao.



"We will consult irrigation engineers, revenue officials and technical experts from IIT, BITS Pilani and JNTU to scientifically determine the lake's FTL," he stated.

He added that NRSC imagery and village maps would be utilised in the process, with findings expected within two to three months.

The Commissioner acknowledged complaints about murky water entering the lake and stagnant drainage. Aditya Nagar residents living near the upper portion of the lake expressed portion of the lake expressed concerns, stating that the area did not have water-logging issues when they purchased their plots.

# hMPV: Govt hospitals arrange beds, testing tolls

On the ongoing reports about a surge in respiratory infections caused by Human Metapneumovirus (hMPV) from China, the Health Department of Telangana has advised the government hospitals to make arrangements to treat patients with influenza treatments in separate facilities and conduct every test; if then suspected the sample can be

sent for hMPV testing.
With this advise, Gandhi Hospital, Osmania General Hospital and Niloufer Hospital for now have arranged adequate oxygen beds and ventilators. However, the developments for testing have yet to be addressed whereas private laboratories, hospitals have the hMPV testing available in their panel.

Gandhi Hospital Deputy Superintendent Dr G K Sunil Kumar said no suspected cases

have been reported so far. "We have adequate oxygen beds, infrastructure and have set up 40 ventilator beds along with two isolation wards to treat patients," he said. In regard to testing, Dr

Sunil Kumar added that there are separate kits, with each kit we can do for 50 to 100 samples. The sample is a throat swab like Covid-19. He emphasised that while the virus is not a major threat, precautions should be taken to avoid its spread.

Osmania General Hospital Superintendent Dr Rakesh Sahay told The Pioneer, "The arrangement is made in the out-patient block of Emergency Ward. We have ten beds with ventilators. If and when required we will add depending on the suspected cases but nothing alarming for

In Niloufer Hospital the available Isolation Ward to look after cases of Covid-19 is to assist for influenza-like

symptom patients. "One of the wards with a capacity of 50 beds is available for patients."

The question of testing availability was not answerable because currently there is confusion whether RTPCR can detect the hMPV. If it can, then the government hospitals had the kits two months ago where they saw Covid-19 cases. However, private labs are boasting about availability of testing for hMPV.

Prabhu Challagali, President, Indian Medical Association, speaking to The Pioneer said, "The testing must be available in the panel list of government hospitals. Yes, we understand it is not alarming and it is a common virus but infrastructure is mandatory to any government hospital.

Single digit budgets would not work for Health department. The tertiary labs are informing the public about the testing availability for hMPV already."

The violation pertains to the failure to follow instructions outlined in C&IG Circular Memo No. G/257/2019, dated August 26, 2020, and December 29, 2020, which prohib-





7, 2025. These complaints alleged irregularities in the registration process and pointed out the registration of plots in unauthorised layouts by P Gopi. The District

Registrar of Nalgonda and the District Registrar (MV & Audit), Nalgonda, conducted thorough investigations and submitted their reports. The findings revealed that Gopi had registered 125 plots in violation of the prescribed rules. In accordance with the powers vested under Sub Rule (1) Rule 8 of TSCS (CC&A) Rules 1991, the Deputy Inspector General has placed P. Gopi under suspension with immediate effect.

The suspension aims to ensure the integrity of the registration process and uphold the legal guidelines established by the C&IG's office. Further investigations and actions are expected to follow.

## Concern over high fluorine levels in groundwater in Warangal dist

Recent tests conducted by geologists from Kakatiya University have revealed that the presence of fluoride in drinking water in undivided

Warangal district has surpassed the permissible levels, with concentrations reaching double the recommended limit. This issue has raised significant concern among officials and residents alike.

The study, led by Dr Bodige Satish and Dr Sai Krishna from the university's geology department, analysed water samples from 75 locations across the district. The findings indicate that the fluoride levels in the region exceed the World Health Organisation's (WHO) guidelines, which

stipulate that fluoride concentrations should be between 0.6 ppm and 1.5 ppm. Levels higher than 1.5 ppm increase the risk of fluorosis, a condition that can severely affect bone and dental health. The

research suggests that several factors contribute to the high fluoride content in the groundwater. These include the depletion of the groundwater table, the practice of sinking borewells deeper, and the excessive use of pesticides and fer-tilisers in agriculture. The study also

found other harmful substances, such as nitrates and sulphates, in excess. Areas such as Mallampally Mandal and Gundedu in Kamalapur Mandal recorded fluoride levels as high as 3 ppm, double the permissible limit, which is a cause for concern.

# Households in Bollaram, Ameenpur assured of piped, potable water

#### **Delhi's temperature** settles at 21.5 degrees C

elhi witnessed a sunny afternoon on Wednesday after several breezy cold days as the maximum temperature settled at 21.5 degrees Celsius, 2.5 notches warmer than the season's normal. #### **DU** professor accused of sexual offence resigns

professor at Delhi University's Ramjas College, who had been accused of sexual harassment, resigned on Wednesday following protests by students on campus over the alleged inaction by the adminstration on the issue. The alleged incident reportedly took place in December last year, when the professor, who also holds a prominent position in the university's student welfare cell, sexually harassed a minor female student. Students from various groups, including left-leaning organizations such as the All India Students Association (AISA) and the Students Federation of India (SFI), as well as the RSS-affiliated Akhil Bharatiya Vidyarthi Parishad (ABVP), held demonstrations on Wednesday demanding the professor's suspension. The protest turned violent when some unidentified individuals wielding sticks attacked students on campus, as seen in videos circulating on social media. While AISA and SFI alleged that the attackers were ABVP members, ABVP denied the allegations, claiming they were peacefully protesting.

# India, EU reaffirm commitment to democracy, rule of law

India and the European Union (EU) on Wednesday reaffirmed their commitment to principles and values of democracy, rule of law and human rights and agreed on the need to safeguard freedom and diversity of civil society actors.

The issues were extensively discussed at the 11th India-EU Human

Rights Dialogue held in Delhi.

The two sides discussed the issues related to civil and political rights, social, economic, and cultural rights, social, economic, and cultural rights. al rights, countering religious hatred, elimination of discrimination in all its manifestations, freedom of religion or belief, freedom of expression and opinion, both online and offline, a joint readout

While the EU reiterated its opposition to capital punishment, India reiterated its stand on recognition of the right to development as a "distinct, universal, inalienable and fundamental human right," it said.

India is among few countries that



still have death penalty. "During the dialogue, India and the EU reiterated their commitment to the shared principles and values of democracy, freedom, rule of law, and to the promotion and protection of all human rights," it said.

The two sides emphasised the "universality, indivisibility, interdependence and interrelatedness" of

all human rights, it added. "Reflecting their commitment

to upholding human rights, they both agreed on the need to safeguard the freedom, independence and diversity of civil society actors and organisations and other relevant stakeholders such as journalists, respecting freedom of association, expression and peaceful assembly," the readout said.

The two sides also delved into issues of the 'LGBTQI+' community, women empowerment and issues relating to technology and human

The two sides also exchanged views on the rights of migrants and business and human rights, accord-

ing to the readout. India and the EU recognised the importance of strengthening national and international human rights mechanisms for the protection and promotion of human rights," it said.

Both sides underlined the importance of enthancing cooperation in the multilateral fora particularly at the UN General Assembly and the UN Human Rights Council, it said.

"In this regard, they committed to closer cooperation and more regular exchanges between the Permanent Missions of India and the EU in Geneva, in order to identify further opportunities for joint action," the readout added.

When you talk of communication, I think the technology that we are focusing on is integrated satel-

**Clinical trials of** 

medicines often done

in poor countries: SC

Observing clinical trials of medicines and vaccines were often carried out in poor countries, the Supreme Court on Wednesday allowed a petitioner to file submissions and objections to the rules framed by the Centre on the issue. A bench comprising Justices Hrishikesh Roy and S V N Bhatti considered the submissions of Centre's additional solicitor general Archana Pathak Dave who said rules for new drugs and clinical trials were framed in 2019.

"We know that the clinical trials are conducted in poor countries," the bench said. Following the rules, Dave said New Drugs and Clinical Trials (Amendment) Rules were notified in 2024 to streamline the approval process for clinical trials and new drugs in India which aimed to improve patient safety protocols and ensure compliance with global standards.

# Despite law, Centre yet to rise from slumber

In a case over Mullaperiyar Dam, the Supreme Court on Wednesday expressed shock and said despite the Dam Safety Act by Parliament, the executive was yet to rise from its slumber. A bench of Justices Surya Kant, Dipankar Datta and Ujjal Bhuyan made the remarks after the Kerala government said the Centre enacted the Dam Safety Act in 2021 to stonewall proceedings, which were going on in court for the safe-ty of the 130-year-old dam and since

then nothing has been done. When the bench was informed the Centre was yet to constitute a national committee for the dam's safety prescribed under the law, it said, "We are aghast to know that despite enact-

ment of the Dam Safety Act by Parliament, the executive is yet to wake up from slumber." Senior advocate V Krishnamurthy, appearing for Tamil Nadu, said under the law, the Centre created a dam safety authority and an audit of the structure would be done. Petitioner Mathews J Nedumpara has sought review of apex court's orders over the safety of the dam on the ground that if water damages the dam, it would affect 50 to 60 lakh people living downstream.

The top court issued notice seeking the Centre's response and the assistance of the attorney general in the matter. The bench observed under Section 5(2) of the Dam Safety Act, a national committee comprising members prescribed under Section 5(1) was required to

be constituted within a period of 60 days from the date of the law's commencement, and it was required to be reconstituted every three years thereafter. "We are informed that no such national committee has been

constituted so far. Even the rules/regulations regarding the constitution, composition or functions of the said national committee have not been formulated," said the

The court noted Tamil Nadu government's submission on the Centre creating a new supervisory committee led by the chairperson of the national dam safety authority by an office memorandum of November 21, 2024, in supersession of the supervisory committee constituted by the top court in 2014. "It further appears there is no pro-

vision in the Dam Safety Act prescribing the constitution of a supervisory committee," the bench said, "and it further appears a supervisory committee was constituted by this court in an earlier round of litigation with respect to the Mullaperiyar Dam and the union of India has also conceptualised the constitution of the supervisory committee, maybe in terms of the judgment of this court."

was sought by the court over the constitution of the national committee and giving effect to other provisions of the Dam Safety Act. It directed the AG to take instructions from the national dam safety authority on its responsibility under the law. The bench, during the hearing, considered passing an order for a safety audit of the dam by an expert panel to allay any fears surrounding the British-era dam, which is situated in Kerala but controlled by Tamil Nadu.

The attorney general's assistance

Krishnamurthy submitted Tamil Nadu had formed an expert panel to assess the structural stability of the dam but required approval by the national authority on dam safety in the upcoming meeting on January 10.

# **Brace up for battle royal**

With polling scheduled for February 5, Delhi is poised for a fiercely contested three-way battle

s the Election Commission officially announced the schedule for Delhi's upcoming assembly elections, the stage is set for what promises to be a hard-fought, three-cornered contest. Polling for the 70 assembly seats in Delhi will take place on February 5, with the results to be declared on February 8. This election is poised to be a high-stakes battle between the incumbent Aam Aadmi Party (AAP), the Bharatiya Janata Party (BJP) and the Congress, each bringing its own strategies, narratives and issues to the forefront. Under the leadership of Arvind Kejriwal, AAP is looking to secure a third consecutive term in Delhi. The party, which has enjoyed overwhelming success in the last two elections, is fiercely campaigning for a 'hat-trick.' Kejriwal, whose party has transformed the political landscape of Delhi since its formation in 2012, is betting on his track record of governance and what he calls the 'politics of work.' AAP's focus remains on welfare programmes such as free electricity, water and healthcare, while



the party claims its tenure has been marked by development and transparency. With the slogan "Phir layenge Kejriwal," AAP has launched a campaign centred around a positive vision for the future, contrasting its achievements with the BJP's focus on divisive politics. However, AAP's victory is far from assured. Despite its dominance in the previous two elections, the party now faces mounting challenges. AAP has been dogged by corruption allegations, a point of attack that the BJP has effectively capitalised on.

For the BJP, this election is a do-or-die contest. The party, under the leadership of Prime Minister Narendra Modi, has mounted an aggressive campaign aimed

at ousting Kejriwal and the AAP from power. The BJP's central theme revolves around anti-incumbency, accusing AAP of corruption and failing to address the capital's development needs. Prime Minister Modi, at the forefront of the BJP's attack, has called the AAP government an 'AAP-da' (disaster) and criticised its inability to offer a vision for Delhi's growth. Modi's rhetoric positions the BJP as the party of national progress, while framing Kejriwal's leadership as an obstacle to Delhi's future. The BJP's strategy is twofold: discredit the AAP's governance while appealing to voters' desire for change. The Congress, once the dominant force in Delhi, is now a distant third. After losing power in the capital in 2013, the party has been trying to rebuild its political base, which has been severely eroded by both AAP and BJP. However, this time the party is determined to make its presence felt in the elections. Given the deepening polarisation, high stakes and aggressive strategies on all sides, the 2025 Delhi Assembly elections are shaping up to be a politically charged, hard-fought, and closely contested battle. Voters will have to choose between a legacy of governance under AAP, a vision for change from the BJP, and the prospect of stability from the Congress, making this election one of the most bitterly fought yet interesting to the core.

#### As President-elect Donald Trump prepares for his second term, the debate over H-1B visas for skilled foreign workers is heating up


s the US Presidentelect Donald Trump prepares to take office on January 20, Lhe faces a unique challenge. The issue of immigration and the H-1B visa has become a contentious point among the two key groups. He is trying to satisfy the conflicting interests of the billionaire tech community, who heavily fund his campaigns, and his 'America First' base.

Trump's recent favourable statements on H-1B visas for foreign skilled workers have sparked renewed discussions on the future of this critical programme. The New York Post quoted Trump, "I've always liked the visas, I have always been in favour of the visas.

That's why we have them." He added: "I have many H-1B visas on my properties. I've been a believer in H-1B visas. I have used it many times. It's a great program."

Trump admitted. Trump has backed Elon Musk and his other wealthy funders from Silicon Valley (South Africa-born Musk had an H1B visa himself). While tech leaders want a liberal H-1B visa regime, 'America First' hardliners wish for stricter restrictions on immigration at all levels.

In his first term, Trump prioritised protecting American citizens' interests, which had significant implications on the H-1B visas. 'America First' advocates argue that H-1B visas take jobs away from American workers. The looming question is, will the Trump's second term may prioritise American workers' jobs, or it could revert to the traditional Republican belief that immigration primarily benefits employers. # India's forests: Gains, gaps and the way forward



The report underscores the need for robust monitoring, effective execution of plantation drives and third-party certification of carbon stock to meet India's climate commitments



orest Survey of India has been releasing biannual reports on the status of Indian forests. The last report was released on December 31, 2021, and the current report which was due in December 2023, has been released after a year's delay. The highlight of the report is that total forest cover has been increased from 7,15,187 square km (2021 assessment) to 7, 15,343 square km (current assessment), which is now 21.76 per cent of the total geographical area of the country. Also, the tree cover, which comprises trees along the linear infrastructures and also in agricultural fields up to one hectare is increased by 1289 square km, which is 3.41 per cent of the total geographical area of the country. The net increase of forest cover and tree cover is 1445 square km in two years period till 2023.

The increase in forest cover is a meager 156 square km. Among the states that have gained maximum increase in forest cover are Uttar Pradesh, Rajasthan, Chhattisgarh and Odisha. A maximum decrease in forest cover has been noticed in Madhya Pradesh, Karnataka, Ladakh and Nagaland. Recorded Forest / Green Wash areas (RFA/GW) are the forests in control of the forest department. While Mizoram, Odisha, Karnataka, West Bengal and Jharkhand have added in RFA/GW areas and the forest cover has increased, Tripura, Telangana, Assam, Andhra Pradesh and Gujarat have lost. It indicates that states are losing their recorded forests. Villages on the fringes of the forests have been burning tree growth and occupying forest land with the support of local leaders and to claim it under the Forest Rights Act, of 2006. Improper implementation of the Forest Rights Act, of 2006 can be attributed to the reason for the loss of forests for agriculture. All the states have been taking up ambitious plantation programmes to increase forest cover and tree cover. The degraded forest areas are being planted regularly.

Taking a conservative estimate, a minimum of 18,000 square km area is being planted annually in the country; should THE NET

How can we justify a 7 square km increase in two years in RFA? It only indicates that deforestation and degradation are taking place at the same pace, we are planting the areas. Such an important report should contain an assessment of the success of plantations across the states. Forest cover outside RFA has increased in Gujarat, Bihar, Kerala, Uttar Pradesh and Assam, while it has been lost in Madhya Pradesh, Rajasthan, Arunachal Pradesh, Andhra Pradesh and Maharashtra. Loss of cover outside RFA is on account of the failure of the administration of the Revenue department of the state. States should put greater vigil

on such forests. These are the carbon sinks and in the era of a warming world, we cannot afford to plunder tree growth even outside RFA. The bright spot in the report is the success of the agroforestry programme. Most states have lost forest cover, but have gained in tree cover. This means that tree planting programmes on private lands/ community lands have been largely successful. Trees on government ands can be cut and destroyed, but the same cannot be done on private lands. In this period of two years, very dense forests increased by 3465.12 square km, while moderately dense forests and open forests have decreased by 1043.23 square km and 2480.11 square km respectively. Forest departments' efforts in taking up plantations in open and degraded areas appear to have shown some success. A large chunk of open and degraded areas has been re-stocked, which has pushed it into the very dense for-

est category.
But a simple arithmetic indicates that 58 square km of forests have been lost. Most probably, several small plots taken from forests on the fringes of the villages must

it not be reflected in this report? have been encroached on for agriculture and eventually community members had an intention to claim rights over it. Decadal changes in forest cover in Western Ghats eco-sensitive areas have also been brought out in the report. It is found that 58.22 square km of cover is lost in ten years. How can we forget the 30th July tragedy that struck Wayanad, Kerala? Nearly 500 humans were buried under landslide debris

when they were asleep.
It also damaged roads, bridges, buildings and human houses.
Landslides in portions of Karnataka and Maharashtra across the Western Ghats have disrupted lives and livelihoods. Losing 58 square km in ten years means losing nearly 6 square km annually. We need to mend our ways and cannot afford to lose any tree growth in such eco-sensitive areas. angroves in the country along the coastline protect against tsunamis, cyclones and Sea surges of any kind. The report indicates that out of 4991 square km of mangroves 7.5 square km is lost in two years. While Andhra Pradesh and Maharashtra together have added 25 square km of mangroves, Gujarat has lost 36 square km. On the western coast Gujarat is the most vulnerable state against frequent and destructive cyclones, how can it afford to lose such a big chunk of mangrove forests?

Other coastal states are reportedly expanding their mangroves by taking up large-scale planting, but the report does not show any increase. There has to be an enquiry as to why mangrove plantation programs are failing. Another highlight of the report is that the growing stock of carbon in the forests is 7285 Mt, and comparing it with the 2021 report there is an increase of 81.5 Mt in two years. Thus our forests are adding 40.75 Mt of carbon annually,

which is like 149 Mt of CO2 equivalent annually. Comparing it with the report of 2005, the growth in forests has created a carbon sink of 2.29 billion tons of CO2 equivalent compared to the 2005 level. To contain the average global rise in temperature within 1.50 Celsius, we have committed in our nationally determined contribution to achieve a carbon sink of 2.5 to 3.0 billion tons of CO2 equivalent by 2030 in response to the Paris Climate Accord of 2015. We are on course to achieve the target well before 2030. I suppose we need a third-party assessment for carbon stock in our forests. Carbon credit has been quite a contentious issue and in several annual climate conferences, UNFCCC has failed to find a resolution. However, for the first time at Baku CoP 29, a resolution has been achieved. It has allowed countries to trade carbon credits - certified reductions of carbon emissions at prices determined as a consequence of emission caps imposed. It has also been agreed that the

operations of the carbon market would be supervised by the UN body. Strict UN control is needed, as a project proponent in the developed nation can pay for an afforestation project to absorb 1000 tons of CO2 in a developing nation where trees fail to put in desired growth and are unable to sequester the entire quantity of carbon credited. Therefore, the carbon sink created by us through our interventions in forest growth needs certification from the UN body. The report in future should take into account the plantation programs each state is implementing and measure the change in the cover concerning the success/ failure of plantations.

On commissioning of all six units, the expected annual power generation will be 4,357 gigawatthours, the release said. Unit 1 and 2 of the 6x170 MW PHEP-II were synchronised on December 16 and 17, 2024,



#### Mouri Tech, Amanta **Healthcare scrap IPO plans**

solution provider Mouri Tech and Ahmedabad-based pharmaceutical company Amanta Healthcare have withdrawn their initial public offerings (IPOs). The companies had filed their Draft Red Herring Prospectus (DRHP) for the proposed IPO in September-October 2024 with the Securities and Exchange Board of India (Sebi). However, the draft offer documents for the IPOs were withdrawn in December last year and the reasons for the withdrawal have not been disclosed, an update with Sebi showed on Wednesday. Further, existing shareholder Sriniyasu Rao Sandaka intends to offload equity shares valued at Rs 129

hares of ONGC climbed 3 per cent on Wednesday, on a day when UK's BP Plc won a bid for ONGC's giant Mumbai High oil and gas field, offering to raise crude oil production by 44 per cent and natural gas by a staggering 89 per cent over a 10-year period. The stock went up by 2.94 per cent to settle at Rs 271.25 on the BSE. During the day, it rallied 3.77 per cent to Rs 273.45. At the NSE, shares of the firm jumped 3 per cent to Rs 271.50. The company's market valuation surged Rs 9,749.72 crore to Rs 3,41,240.07 crore. Oil and Natural Gas Corporation (ONGC) in a stock exchange filing said it has selected BP Exploration (Alpha) Ltd, a whollyowned step-down subsidiary of BP Plc, as the Technical Service Provider (TSP) for raising production in the field. ONGC had in June last year floated a tender seeking foreign partners to reverse declining output at its flagship Mumbai High fields, offering a share of revenue from incremental production plus a fixed fee but not any equity stake.

# India should build foundational models for AI: Nadella

#### Says investment is real entry barrier

PNS NEW DELHI

India must get into frontier work in artificial intelligence and build foundational models, but investment is a real entry barrier and just one mathematical breakthrough can change entire dynamics, Microsoft Chairman and CEO Satya Nadella said

Wednesday.

During his second day of Microsoft India AI Tour, Nadella said that India can do great work in the area of Indic languages and trans-

forming its industries using artificial intelligence. "There's no reason why

India can't do frontier work, but you can even define frontier pretty unique. So for example, I don't think the last known big breakthrough in AI frontier has happened. I always say we are one mathematical breakthrough away from that entire edifice being thrown out and being going after some-thing else," Nadella said.

He said academics in India, the research institutions, including Microsoft Research, are very fantastic math team and algorithms team.

"Let's not be bound, quite frankly, with what is considered frontier. So I would say India definitely should also do frontier work. Also use the frontier in order to, post training, to make it great for Indic languages, make it great for



Indian industry, and so on," Nadella said.

In response to a question by additional secretary in the IT ministry Abhishek Singh on whether India should build its own AI foundational model, Nadella said that India always has an option to do that but the real entry barrier in making foundational models is investment.

He said the other way to look at the investment barrier is to lower the cost with the help of research, which is always open for India.

# GDP growth likely to be 6.3 %, tad below govt estimates: Report

The GDP growth is expected to be about 6.3 per cent in the current fiscal year, a tad lower than the government's esti-mates of 6.4 per cent, owing to several factors such as weak demand, SBI research report

said on Wednesday.

According to the first advance estimates (FAE) of National Income for 2024-25 released by the National Statistics Office (NSO), released on Tuesday, India's economic growth rate is estimated to slip to a four-year low of 6.4 per cent in 2024-25, because of poor showing by the manufacturing and subdued

investments.

Historically, the difference between the estimates of the Reserve Bank of India (RBI) and the NSO is always in the range of 20-30 bps and hence the 6.4 per cent estimate for the 2024-25 fiscal year is along expected and reasonable lines, the SBI's research report 'Ecowrap' said.

"We, however, believe that GDP (gross domestic product) growth for FY25 could be around 6.3 per cent, with downward bias," it said. The report authored by

Soumya Kanti Ghosh, Group Chief Economic Adviser, State Bank of India (SBI), also said as per capita nominal GDP is expected to increase significantly in the current fiscal ending March 2025, by Rs

However, taking into account the revised GDP figures, if tax receipts grew by the BE, government expenditure lowered due to low CAPEX then fiscal deficit will be 4.9 per cent of the GDP in 2024-25,

SBI's research said. While, if government sticks to the fiscal deficit of Rs 16.1 lakh crore, then with the revised GDP numbers, the deficit as per cent of GDP would be at 5 per cent in 2024-

25, the report said.
In the Union Budget, the government projected to bring down the fiscal deficit to 4.9 per cent of the GDP in the current financial year.

# Budget should focus on tax reforms, reduction in personal I-T'

PNS NEW DELHI

The Budget is expected to focus on boosting private capex, tax simplification and reduction in personal income tax, particularly for the lowerincome groups, to stimulate demand, EY India said.

The Union Budget for 2025-26 is scheduled to be presented in Parliament on February

EY India, in its Budget expectation note, said with over Rs 31 lakh crore stuck in income tax disputes as of 2023-24, there is an urgent need to clear Commissioner of Income

Tax (Appeals) backlog and bolster alternate dispute resolution mechanisms like advance pricing agreements and safe harbours.

While a full comprehensive review of the direct tax code may take time, we might see some initial steps towards its implementation in this Budget. I also hope for a reduction in personal income tax, particularly for the lower-income groups, to provide relief and stimulate demand," said Sameer Gupta, National Tax Leader, EY India.

EY said the expectations from Budget are focused on a



set of strategic reforms that can propel the economy forward. With an emphasis on fiscal consolidation, tax system simplification, and investmentdriven growth, the Budget is

expected to lay a solid foundation for sustained economic development.

EY anticipates significant reforms to simplify the tax system and improve taxpayer ser-

vices, reduce litigation, and enhance tax compliance. The government is already

working on simplifying the Income Tax laws. It should follow a consultative approach and invite public comments on the draft proposals, EY said.
"Key areas of focus are like-

ly to include enhancing public spending, reducing the fiscal deficit, incentivising private sector investment, and introducing targeted tax reforms that foster business innovation," EY said.

In the last Budget, government had rationalised the capital gains structure in terms of

holding period of assets and tax rates. The government may further address some of the unintended anomalies to make the rationalisation of capital gains more complete, EY said.

For instance, the holding period for capital assets, such as business undertakings in slump sales may be reduced from 36 months to 24 months and unlisted shares in IPO offer for sale (OFS) from 2 years to 1 year, aligning them with listed securities.

Gupta further said for businesses, particularly SMEs, reducing the complexity of tax compliance is critical.

In an exclusive conversation, Dimple Ghadge, founder secretary of Palawi, shared the story behind this extraordinary endeavor. "In 2001, we found two abandoned girl children. When we took them to the hospital, they were diagnosed as HIV-positive. That moment changed everything for us. We

started working with people in red-light areas, and that's how Palawi was born," she recounted.

Today, they operate from three buildings, providing a safe haven for children of all age groups. Its logo—a growing sapling—symbolises the organisation's

Founded in 2001 by the determined mother-daughter duo Mangal Shah and Dimple Ghadge, Palawi has become a beacon of hope for HIV-positive children. In an exclusive chat with *The Pioneer*, Dimple takes us through their noble cause



mission to nurture these children and help

mission to nurture these children and help them thrive. However, the path to this success was fraught with challenges.

"People around us often asked, 'Why are you protecting such children who will die soon?" Dimple revealed. Yet, these questions only strengthened their resolve. Education became a critical focus area.

"Providing food and shelter was not enough Schools refused to admit HIVenough. Schools refused to admit HIV-positive children and even when one agreed, there was blatant discrimination. That's when we decided to start our own school, Gyaan Mandir, affiliated with the Maharashtra Board in 2013. We even opened its doors to underprivileged nonHIV students," she said.

Healthcare posed another significant challenge. To ensure the children received challenge. To ensure the children received adequate medical attention, Palawi established its own medical unit. The organization also goes beyond traditional care by emphasising skill development. "Once a child turns 14, they are encouraged to pursue arts or crafts like candle-making and stitching. The money they earn is saved for their future education," she explained, adding that creativity knows no boundaries or prejudices. One of their most heartwarming initiatives is the most heartwarming initiatives is the Palak-Balak program, where an older child takes responsibility for a younger one. "For

instance, a 15-year-old might take care of a 2-year-old, ensuring they're safe and happy. This builds a bond of love and responsibility. Every night, the elder child writes a note to the younger one, fostering a unique connection," she shared.

Funding, too, has seen an evolution. "Initially, we relied solely on individual contributions. As awareness about our work grew, we began receiving international funding from organisations like

tional funding from organisations like CAF America and explored crowdfunding avenues," she highlighted.

The success stories from Palawi are a

source of immense pride and inspiration. She shared one such story: "Two years ago, our students were barred from participat-

ing in a district-level sports competition. We pleaded for them to be allowed, even if they didn't win.

Out of 15 sports events, our children emerged victorious in 13. It was a proud moment that silenced many critics."

Palawi's story is a powerful reminder that love, determination and a belief in the fundamental rights of every individual can overcome even the harshest challenges. It overcome even the harshest challenges. It is not just an organisation; it is a family where children grow, thrive, and dream of a brighter future. As Dimple concluded, "We are here to give these children a life of dignity, and we will continue to fight for their right to live, grow, and succeed."


Getting into the physicality of a character helps tap into their mindset. I trained rigorously, and somewhere along the way, I even started enjoying it!" Since the character had no detailed

# Chronic acid reflux? Here's everything you need to know!

ERD or Gastroesophageal reflux disease is a chronic condition. It typically involves regurgitation of stomach acid and other contents into the esophagus, leading to symptoms such as heartburn, chest pain, difficulty swallowing and coughing. Treatment for GERD aims to alleviate symptoms, heal esophageal damage and prevent complications. Here are some common approaches:

Lifestyle modifications: Making changes to diet and lifestyle can often help manage GERD symptoms. This includes avoiding trigger foods, eating smaller meals, avoiding lying down or bending over after eating, losing weight if overweight and quitting smokina.

#### Medications

- Antacids: Over the counter antacids such as Gelusil, Mucaine gel or Ulgel can help neutralize stomach acid and provide temporary relief from
- H2-receptor antagonists (H2RAs): These medications, including ranitidine and famotidine, provide longer-lasting relief than antacids by reducing the production of stomach acid.
- Proton pump inhibitors (PPIs): Drugs like omeprazole, esomeprazole, rabeprazole and lansoprazole are more potent acid suppressors than H2RAs and are often prescribed for more severe cases of GERD or to heal esophageal damage.

 Prokinetic agents: These medications help strengthen the lower esophageal sphincter and improve esophageal motility, reducing the frequency of reflux episodes. Examples include metoclopramide and baclofen.

Surgery: For patients who do not respond to lifestyle changes and medications, surgical intervention may be necessary. Fundoplication is a common surgical procedure for GERD, that involves wrapping up the upper part of the stomach around the LES to strengthen it and prevent reflux.

**Endoscopic treatments:** Less invasive procedures such as endoscopic suturing or radiofrequency energy delivery can be used to tighten the LES and improve its function, reducing reflux symptoms.

Biologic therapies: In recent years, biologic therapies targeting specific pathways involved in GERD pathophysiology have emerged as potential treatments. These therapies aim to modulate acid production, improve esophageal function, or reduce

It's important for individuals with GERD to work closely with their healthcare providers to develop a customised comprehensive treatment plan catering to specific needs and preferences. Untreated GERD can lead to complications such as esophageal ulcers, strictures, a pre-cancerous condition called Barrett's esophagus, and esophageal cancer rarely. In summary, GERD is a chronic condition characterized by the regurgitation of stomach contents into the esophagus. The condition presents with symptoms such as heartburn and chest pain. Treatment options include lifestyle modifications, medications, surgery, endoscopic procedures and biologic therapies, with the goal of alleviating symptoms, healing esophageal damage, and preventing complications.








"Obviously he is world class and he took, what, 32 wickets in the series."


