US Army veteran who Adrove a pickup truck into a crowd of New Year's revellers in New Orleans, killing 15 people, had posted videos to social media hours before the carnage saying he was inspired by the Islamic State group and expressing a desire to kill, the president said.
The FBI said it was investigating

early Wednesday's attack in which the driver steered around a police blockade and slammed into revellers before being shot dead by police as a terrorist act and did not believe he acted alone.

Investigators found guns and what appeared to be an improvised explosive device in the vehicle - which bore the flag of the Islamic State group - along with other explosive devices elsewhere in the city's famed French Quarter.

President Joe Biden said Wednesday evening that the FBI found the videos the driver posted to social media. He called the attack a "despicable" and "heinous act."

The rampage turned festive Bourbon Street into a macabre scene of maimed victims, bloodied bodies and pedestrians fleeing for safety inside nightclubs and restaurants. In addition to the dead, dozens of people were hurt.

postponed until Thursday.

Zion Parsons, 18, of Gulfport, Mississippi, said he saw the truck "barreling through, throwing people like in a movie scene,

throwing people into the air."
"Bodies, bodies all up and down the street, everybody screaming and hollering," said Parsons,

Louisiana Gov Jeff Landry urged people to avoid the area, which remained an active crime scene. "We looked out of our front door and saw caution tape and dead silence and it's eerie," said Tessa Cundiff, an Indiana native who moved to the French Quarter a few years ago. "This is not what we fell in love with, it's sad."

Nearby, life went on as normal in the city known to some for a motto that translates to "let the good times roll." At a cafe a block from where the truck came to rest, people crowded in for breakfast as upbeat pop music played. Two blocks away, people drank at a bar, seemingly as if nothing happened. Biden, speaking from the presidential retreat at Camp David, addressed the victims and the people of New Orleans: "I want you to know I grieve with you. Our nation grieves with you as you mourn and as you heal."

"My heart goes out to the victims and their families who were simply trying to celebrate the holiday," Biden said in an earlier written statement. "There is no justification for violence of any

FBI officials have repeatedly warned about an elevated international terrorism threat due to the Israel-Hamas war. In the last year, the agency has disrupted other potential attacks, including in October when it arrested an Afghan man in Oklahoma for an alleged Election Day plot targeting large crowds.

farmers. Your government has stopped implementation of farmers-friendly central schemes. Your government is not sympathetic towards farmers. Today, farmers in Delhi are upset and worried," Chouhan said in the letter dated Ianuary 1.

to the Due nonimplementation of multiple central schemes, Delhi's farmers are being denied crucial benefits ranging from distribution to seed infrastructure development, he said. The Union minister said the absence of the Integrated Horticulture Development Mission has prevented farmers from accessing benefits for nursery establishment, tissue culture facilities, planting material procurement, and postharvest infrastructure.

The non-implementation of Rashtriya Krishi Vikas Yojana has further impacted farmers' access to agricultural mechanization, precision irrigation, soil health initiatives, crop insurance, and the Paramparagat Krishi Vikas Yojana, he added. Chouhan expressed concern over Delhi's failure to implement the Beej Gram programme, which offers benefits including seed distribution, testing facilities, laboratory infrastructure improvement, and assistance certification for seed

agencies.

Tnvestors' wealth surged Rs .52 lakh crore in two d market rally, with benchmark Sensex climbing nearly 2 per cent on Thursday alone. The 30-share BSÉ benchmark Sensex jumped 1,436.30 points or 1.83 per cent -- its best single-day gain in more than a month -- to settle at 79,943.71 on Thursday. During the day, it soared 1,525.46 points, or 1.94 per cent, to 80,032.87. On Wednesday, the benchmark gauge had climbed 368.40 points, or 0.47 per cent, to settle at 78,507.41.

The market capitalisation of BSE-listed firms surged Rs 8,52,239.27 crore to Rs 4,50,47,345.71 crore (USD 5.25 trillion) in two days.
"While markets failed to


deliver a Christmas rally over the past few weeks, the New Year has provided strong optimism in the first two days with Sensex touching the psychological 80,000-mark on the back of broad-based shortcovering.



Chess prodigy, Olympic shooter among Khel Ratna awardees

Double Olympic medallist shooter Manu Bhaker and chess prodigy D Gukesh were among the four athletes awarded the prestigious Major Dhyan Chand Khel Ratna award for 2024, announced by the Sports Ministry. The announcement also highlighted a remarkable inclusion of 17 para-athletes in the list of 32 Arjuna awardees, celebrating their outstanding achievements at the Paris Paralympics.

Joining Bhaker and Gukesh as Khel Ratna recipients were men's hockey captain Harmanpreet Singh and

para-athlete Praveen Kumar, both of whom have made significant contributions to Indian sports in the past year. The awards will be presented by President Droupadi Murmu at a ceremony in Rashtrapati Bhavan on January 17, 2025.

22 year old Manu Bhaker made history at the Tokyo Olympics by becoming the first Indian to win two medals in a single edition of the Games. She secured bronze medals in both the 10m air pistol individual event and the 10m air pistol mixed team event, further cementing her status as one of India's finest shooting



Interestingly, Bhaker's name for the Khel Ratna was the subject of recent controversy, as initial reports suggested she was overlooked due to a missed application deadline. Bhaker acknowledged a possible lapse on her part but, after procedural issues were resolved, was rightfully among included the honorees.

18-year-old chess sensation D Gukesh, another Khel Ratna recipient, became the youngest-ever World Chess Champion, achieving the title last year. His remarkable feat also contributed to India's historic gold medal victory in the Chess Olympiad. Harmanpreet Singh led the citation.

With the father of a mass murder accused still at large, police are perplexed as to why the accused did not end his own life after committing the horrific act if he was allegedly so disillusioned with life and societal pressures.

The arrested suspect, Mohammed Arshad, surrendered at the Loco police outpost under Husainganj police station on Wednesday. He confessed to killing five members of his family at a lodge in the Naka police station area on the night of December 31, 2024, alongside his father,

The victims were identified as Asma (mother) and four sisters: Aliya (9), Aksa (16), Alshifa (19), and Rahmeen

According to police, before murdering the women, Arshad and Badar consumed alcohol. They also forced Asma and Alshifa to drink beverages laced with sedatives, causing them to vomit. The three younger girls were given cold drinks mixed with intoxicants. Once all the victims were unconscious, they were killed.

Arshad confessed that he and his father committed the murders because they feared their enemies would exploit the women, possibly forcing them

into human trafficking. He claimed the family had faced threats and societal ostracisation after relocating from Delhi to Agra.

Badar, originally from Budaun, had previously worked in Delhi. He purchased a 100-square-yard plot in Agra but later sold half of it to a neighbour for Rs 7 lakh. Contrary to Arshad's claims, neighbours described the father-son duo as combative and overly suspicious. They allegedly kept the women confined to their home and were hostile to anyone who

approached them. Arshad told the police that after executing the murders, Badaruddin fled towards Charbagh railway station while he surrendered at the outpost.

However, the police suspect Arshad is withholding infor-mation and attempting to mislead the investigation. Arshad's statements have varied significantly during his interrogation. Initially, he claimed his father left to commit suicide, but later suggested he escorted him to the station to avoid arrest. These inconsistencies have led

Arshad's maternal uncle to take bodies to village

PNS LUCKNOW

The maternal uncle of the accused of mass murder reached Lucknow to take the bodies of the victims for burial at his native place.

Danish, the maternal uncle of murder accused Arshad, reached the post-mortem house on Thursday. He said that all the bodies would be taken to the village.

Police sent Arshad, who killed his mother and his four sisters in a lodge in the Naka area, to jail on Thursday. The search for his absconding father Mohammed Badar, who is the co-accused, has been intensified. The post-mortem of the five bodies was being conducted by a panel of doctors. After the autopsies, the bodies would be handed over to the family members.

On being informed by the police, Arshad's paternal and maternal uncles arrived in Lucknow on Thursday morning and went to the Naka police station. After informing them about the incident, the process of handing over the bodies was completed.

to Ajmer, where a video was recorded and shared online. In the video, Badar spoke about land disputes and threats from neighbours, while tension was visible on the faces of the women. On December 29, the family

arrived in Lucknow and checked into a hotel the following day. On the night of December 31, Arshad and his father executed their plan, killing the

murders and confessed to

Danish told newsmen that he would take all the bodies to his village Sambhal for the last rites there. Arshad's mother Asma was a resident of Sambhal.

Danish, who lives in Sambhal, said that on getting informa-tion about the incident, he left for Lucknow with the family on Wednesday night. He said the facts that Arshad was speaking about in the video that has gone viral, were never discussed in the family.

"Even information about the dispute with the neighbours was not given to us. The entire family is unable to understand why he took this step," he said. Police will seek remand of Arshad. The Naka police have filed an application in the court for his custody remand. Police said that the accused had to be interrogated regarding the incident.

Four police teams are raiding the possible hideouts in search of Badar. The help of surveil-lance and CCTV is being taken to trace his location.

Sources in the police said the investigators were mulling a narco test of Arshad. "His behaviour appears errat-

The chief minister has entrusted retired IAS and IPS officers, former vice-chancellors, educationists, and other senior citizens with the pivotal role of 'Nikshay Mitra'.

As 'Nikshay Mitras', they will play an active role in raising public awareness and supporting efforts to eradicate tuberculosis (TB).

On Thursday, CM Yogi convened a meeting with these individuals, emphasising the importance of their involvement in ensuring the success of the 'TB-Free Uttar Pradesh'

'The tiger is primarily moving in areas with dense tree canopies, making it difficult to track. Additionally, the animal is very clever and avoids open areas. It is nocturnal, typically moving in the forest after 4 pm. Even if it makes a kill, the tiger tends to drag its prey into dense bushes, which complicates efforts to dart and tranquillise it. Moreover, the cold weather forces the tiger to hide in well-concealed loca-

tions," he said. The tiger has been in Rehmankhera for over three to four weeks. "It has localised itself and is not moving out of this area," Pandey added. He also mentioned that the difficult terrain has contributed to delays in the capture. "Elephants cannot be brought here due to the challenging terrain," he noted.

Additionally, the IMD's Hindi newsletter 'KSHITIJ' and the Automatic Weather Observing System at CCS International Airport were unveiled. The event, which began with a

welcome address by Dr Manish R Ranalkar, head of the Meteorological Centre in Lucknow, featured chief guest Naveen Kumar, Secretary, Irrigation department, and guest of honour Sanjay Singh, Director General, Uttar Pradesh Council Agricultural Research.

Dr M Mohapatra, Director General of Meteorology, attended virtually. The work-shop included technical presentations from IMD officials, including Dr RK Jenamani, Scientist-G, and Dr SD Kotal, Scientist-F.

The event highlighted department's 150 years of meteorological service and gathered feedback from sectors such as agriculture, disaster management, for artisans released administration has released a guidebook on chikankari for artisans and stakeholders, developed under a memoramdum of understanding (MoU) signed with IIM-Indore.

Director of IIM-Indore, Himanshu Rai, emphasised that chikankari is an integral part of Lucknow's rich cultural heritage and craftsmanship. "The revival of chikankari was achieved through the oral and practical transmission of the craft by master artisans from recognised lineages in Lucknow. The IIM-Indore team has created a coffee-table book documenting the processes involved, which will help facilitate pre-production, production, marketing, and branding of chikankari for customers across India and around the world," he said.

Rai pointed out some challenges faced by the artisans, such as the lack of information on the designs preferred by customers, the absence of quality structure, and a lack of access to machinery.
"They were entirely depen-

dent on middlemen. In our initial report, we identified these problems and proposed solutions, the implementation of which has already led to an artisans. They then requested that a book be created to address these issues. My vision was to democratise this information so that artisans would no longer have to rely on middlemen," he added. Rai mentioned that the book

will be distributed to all artisans. He explained that the book covers various aspects, including steps for acquiring raw materials, focusing on quality, quantity, and price, as well as motifs for inspiration. It also provides guidance on preparing blocks, tracking trends for suitable motif creation, and detailing the intricacies involved in raw material

preparation. The guidebook further outlines the steps for preparing cloth for dyeing, embroidery, and washing, as well as standard operating procedures to be followed for readying the dress for sale. It also includes processes for packaging, inventory manage-ment, auditing, and sales and marketing strategies for chikankari branding.
"The overall goal is to support

artisans, common facilitation centres, and any organisations that assist chikankari artisans in connecting to remunerative markets," he added.

Mahakumbh Nagar (PNS): As preparations for a grand Maha Kumbh 2025 gain momentum, the Railways are gearing up to enhance the experience for devotees and visitors, ensuring the availability of clean and hygienic food to them.

The Prayagraj division has instructed all catering stall licence holders to adhere to the prescribed rates and maintain cleanliness and hygiene in food services. Additionally, all stalls have been directed to keep their goods systematically, ensure that employees wear proper uniforms and display name plates, and maintain polite behaviour towards the devotees. The Railways are also expanding the services continuously to accommodate the influx of devotees and tourists during the Maha Kumbh. Himanshu Shukla, Senior Divisional Commercial Manager (Coaching), stated that for Maha Kumbh 2025, crores of devotees from across

the country and abroad are expected to visit Prayagraj for darshan and bathing, with a significant number of them travelling by train.

He emphasised that it is the Railways' duty to offer the best services with dedication and assured full preparedness for the task. Shukla stated: "Regular and

surprise inspections of stalls and passenger facilities will be conducted. Besides, licence holders have been instructed to provide details of their base kitchens without delay. In addition, Shukla encouraged

the display of visitor books at the stalls inviting feedback from devotees and encouraging staff and licence holders to contribute suggestions for improving public facilities.

The senior divisional commercial manager (coaching) announced that over 13,000 trains will be operated for the convenience of devotees during Maha Kumbh. This includes more than 10,000 regular trains

and over 3,000 special trains. To manage the massive flow of passengers, a total of 560 ticketing points, including UTS, ATVM, MUTS, enquiry and PRS, will be set up across nine railway stations — Prayagraj Junction, Subedarganj, Naini, Prayagraj Chheoki, Prayag Junction, Phaphamau, Prayagraj Rambagh, Prayagraj Sangam, and Jhunsi, as well as in the fair area. Among these, 132 counters will be located at Prayagraj Junction, where approximately 10 lakh tickets can be distributed daily.

With emphasis on making passenger and freight traffic world-class and use of advanced technologies, the division has underlined its important role in the development of the country by extensively promoting economic development through infrastructure upgradation and capacity enhancement", said Srivastava. According to him, during the year 93.20 km rail tracks were renewed with new rail tracks (60 kg per metre weight as per international standards for medium and heavy locomotive movement), apart from 26.68 track km sleepers and 105 turnouts. "A total of 127.07 km doubling and third line works were completed, which include Chhapra-Gautam Sthan (8.85 km), Belthara Road-Kidiharapur

(13.85 km), Rasra-Indara (28.22 km), Khurhat-Sathiyawan (18.17 km) and Khorasan Road-Didarganj Road-Shahganj (23.65 km) and Chhapra Kachhari-Chhapra (3 km)", the DRM said, adding that in the same sequence, work of Ghazipur Ghat-Tadighat and Ghazipur City-Tadighat (16.79 km) new railne was completed

Besides, he said the work of automatic block signalling is being done at a fast pace. This year, so far about 29.37 km of automatic block signalling work has been completed in Varanasi division. With the completion of automatic block signalling work, operation of more trains has become possible and line capacity has also increased. "Keeping in mind Maha Kumbh-2025, road under bridge near Jhusi station vard, road under bridge between Jhunsi-Ramnathpur stations and expanded passenger facilities at Pravagrai Rambagh and Jhusi stations were expanded", he said.

The DRM said a total of 18 stations are being redeveloped in NER under Amrit Bharat Station Scheme (ABSS). Srivastava said that during Durga Puja/ Deepawali/ Chhath in 2024, 259 Puja special trains were run in 1,725 rounds from/through NER. Besides, he said that rail coach restaurants are being operated at Banaras and Varanasi City stations. Digital payment is being promoted through QR code at all 151 PRS and UTS counters on NER. used for allotment of berths to passengers in trains and for receiving digital payments and for paperless working, which has increased transparency in berth allotment. Under the new classification of railway stations on Indian Railways for the next five years, four stations of NER including Banaras, Chhapra and Mau, are classiadded.

Under the 'One Station One 31 personnel retire Product' (OSOP) scheme,the DRM said that 16 stalls/ 22 trolleys are being operated at 32 stations of NER. Due to availability of market for local products, employment opportunities have been provided to handicraftsmen/artisans. Will implement recommendations of panel on NEET-UG exam: Centre to SC

NEW DELHI

Centre on Thursday informed the Supreme Court that it would be implementing all the corrective measures suggested by its sevenmember expert panel on exam reforms after reviewing the National Testing Agency's functioning in holding NEET-UG last vear.

The top court on August 2, last year refused to annul the controversy-ridden NEET-UG of 2024, saying there was no sufficient material on record at present to indicate a systemic leak or malpractice compromising the integrity of the examination. It had also expanded the remit

panel, headed by former Indian Space Research Organisation (ISRO) chief K Radhakrishnan, to review the functioning of the National Testing Agency (NTA) and recommend exam reforms to make the NEET-UG (National Eligibility cum Entrance Test Undergraduate), transparent and free from malpractices.

On Thursday, Solicitor General Tushar Mehta, appearing for the Centre, apprised a bench comprising justices PS Narasimha and Manoj Misra that the Centre-appointed committee has filed its report and the government will be implementing all the recommendations.

"We are going to implement all

Report submitted in Sambhal's **Shahi Jama Masjid dispute**

 $T^{\text{he long-awaited survey}}_{\text{report of the Shahi Jama}}$ Masjid in Sambhal has been submitted in the Chandausi court, intensifying the debate surrounding the contentious site. Advocate Commissioner Ramesh Singh Raghav handed over the 40-page document on Thursday to Civil Division Judge Aditya Singh in a sealed envelope.

The contents of the report, compiled during surveys conducted on November 19 and 24 last year, remain undisclosed pending further orders from the Supreme Court.

Raghay, explaining the delay in submission, said, "The survey was thorough and based on photos and videos collected over two days. Due to my health issues, there was some delay, but the report has now been filed and will remain sealed until directed otherwise by the Supreme Court." The survey's second day, November 24, coincided with violent clashes that left five peo-



ple dead. Local residents recall the chaos vividly.

"The violence shook our entire community. People are still struggling to move past the events of that day," said Rajiv Kumar, a shopkeeper in the Kot Purvi area where the mosque

The dispute revolves around claims by the Hindu petitioners that the Shahi Jama Masjid was originally a Shri Harihar temple, demolished by Mughal emperor Babur in 1529. Maĥant Rishi Raj Giri of Kailadevi temple, one of the petitioners, said, "This place holds immense religious significance. It is believed to be the rophesied site for Lord . Visĥnu's Dashavatar Kalki.

origins as a temple." The petitioners, led by Supreme Court lawyer Harishankar Jain

and his son Vishnushankar Jain, have presented a 95-page document citing historical texts and archaeological findings to support their claim. Other petitioners include Mahant Dinanath and social workers Vedpal Singh, Madanpal, Rakesh Kumar, and Jeetpal Yadav.

The Advocate Commissioner confirmed that the next steps in the legal proceedings depend on potential appeals in the High Court. "For now, the court cannot open the report until a Supreme Court directive is issued. Even the judges have no access to the findings, Raghav added.

The submission of the report has heightened tensions in Sambhal. Many locals fear a resurgence of unrest. "We want peace and resolution, not more conflict," said Ayesha Begum, a resident living near the mosque. The case remains a sensitive issue, blending historical, legal, and communal aspects, as the nation awaits clarity on the court's next move.

NHRC seeks action report on stampede death at 'Pushpa 2' screening

NHRC has sought an action taken report within four weeks from the Hyderabad police chief on the death of a woman in a stampede at a theatre in the Telangana capital early December where 'Pushpa 2' movie was screened, according to the case's proceedings. The National Human Rights Commission (NHRC) has also said that the allegations in the stampede case be inquired by a senior rank police officer and sought "needful action" on it. The complaint was filed with the NHRC on December 5 and registered on December 17, as per the proceedings. The commission took action on January 1 and has sought a detailed action taken report 'within four weeks".

A 35-year-old woman died during the stampede at the Theatre in Hyderabad on December 4 where the Allu Arjun-starrer 2' movie was screened and her eight-yearold son was hospitalised. Following the incident, a case

Allu Arjun was arrested by the city police in connection with the death of the woman on December 13. SC orders copy of medical reports of Mukhtar Ansari be provided to son

The Supreme Court on Thursday directed the Uttar Pradesh authorities to provide medical and magisterial inquiry reports on the death of jailed gangster-politician Mukhtar Ansari on March 28, 2024. Umar said the medical and the judicial inquiry reports pertaining to his father's death were not furnished by the State Government.

Ansari, 63, a five-time MLA from Mau Sadar, died of cardiac arrest at a hospital in Banda in Uttar Pradesh on March 28, 2024. He was in jail since 2005, with over 60 criminal cases pending against him, and was convicted in the murder case of BJP MLA Krishnanand Rai. Prior to his death, the son moved the top court in December, 2023, seeking a direction to transfer his father to any prison outside held later.

Cyber fraud known as 'pig butchering scam' targetting youths, hosuwives, students: MHA report PIONEER NEWS SERVICE

Union Home Ministry in its latest report cautioned that a new cyber fraud known 'investment scam" has emerged, targeting unemployed youths, housewives, students, and needy people who are made to lose large sums of money daily. The report said that cybercriminals have also been using Google services platforms to initiate these crimes. "Google Advertisement plat-

form provides a convenient facility for targeted advertisement from across the border. This scam, known as 'Pig Butchering Scam' 'Investment Scam' is a global phenomenon and involves large-scale money laundering and even cyber slavery," it said. The pig butchering scam, which is believed to have started in China in 2016, targets gullible individuals with whom cyber criminals build trust over time, ultimately convincing them to invest in cryptocurrency or some other lucrative scheme when their money is stolen. The analogy to pig butchering comes from



the fattening of swine before their slaughter.

To curb the menace, the Home Ministry's Indian Cyber Crime Coordination Centre (I4C) has partnered with Google to share the threat intelligence for urgent action periodically.

The cybercriminals are using sponsored Facebook to launch illegal lending applications in India, the report said. "Such links are proactively identified and shared with Facebook, along with Facebook pages for necessary action," said the report by MHA.

WhatsApp remains the biggest social media platform that is possibly misused by cyber

criminals in India, the report said. The data published in the report on "cybercrime complaints where Big Tech platforms have been misused" shows that 14746 complaints were related to WhatsApp, 7651 against Telegram, 7152 against Instagram, 7051 against Facebook, and 1135 against YouTube till March

"Big techs play an important role in proactive identification and action on cyber criminals. I4C has partnered with Google and Facebook for sharing intelligence and signals for proactive actions," the report said.

I4C analyses the complaints reported on the portal and prepares analysis reports on the latest trends of cybercrime and misuse of services provided by service providers,

 $H^{\mathrm{igh\ nitrate\ levels\ have\ been}}_{\mathrm{found\ in\ groundwater\ of}}$ 440 districts across India, with 20 per cent of the samples collected exceeding the permissible nitrate concentration, the Central Ground Water Board (CGWB) has said in a report. Nitrate contamination is a significant environmental and health concern, particularly in agricultural regions using nitrogen-based fertilizers and animal waste. The "Annual Groundwater Quality Report -2024" also revealed that 9.04 per cent of samples had fluoride levels above the safe limit, while 3.55 per cent showed

A total of 15,259 monitoring locations were chosen nationwide to check groundwater quality in May 2023. Of these, 25 percent of wells (the most at Arunachal Pradesh, Assam, for drinking. Fifteen districts in

arsenic contamination.

risk per BIS 10500) were studied in detail. Groundwater was sampled at 4,982 trend stations before and after the monsoon to see how recharge affects

The report found that 20 per cent of water samples exceeded the nitrate limit of 45 milligrams per liter (mg/l), the threshold set by the World Health Organisation (WHO) and Bureau of Indian Standards (BIS) for drinking water.

Rajasthan, Karnataka, and Tamil Nadu had over 40 per cent of samples above the limit while there was high contamination in samples from --Maharashtra at 35.74 per cent, Telangana at 27.48 per cent, Andhra Pradesh at 23.5 per cent and Madhya Pradesh at 22.58 per cent.

Uttar Pradesh, Kerala, Jharkhand and Bihar reported percentages. In lower



Goa, Meghalaya, Mizoram and Nagaland, all samples were within safe limits.

In states like Rajasthan, Madhya Pradesh, and Gujarat, nitrate levels have remained stable since 2015. However, Uttar Pradesh, Tamil Nadu, Andhra Pradesh and Haryana showed increasing contamination from 2017 to 2023, the CGWB said.

High nitrate levels can cause health issues like blue baby syndrome in infants and are unsafe India have been identified as the most affected by high nitrate levels in groundwater including Barmer and Jodhpur Rajasthan; Wardha, Buldhana, Amravati, Nanded, Beed, Jalgaon, and Yavatmal in Maharashtra; Rangareddy,

Adilabad and Siddipet in Telangana; Villupuram in Tamil Nadu; Palnadu in Andhra Pradesh; and Bathinda in Punjab.

High nitrate levels in groundwater can be a result of excessive irrigation which can push nitrates from fertilizers deep into the soil, the report said. Poor management of animal waste in livestock farming adds to the problem, as it releases nitrates into the soil.

Urbanisation and population growth increase wastewater and sewage, which often contain high nitrate levels, while leaking septic systems and poor sewage disposal worsen contamination. The report further said fluoride concentrations exceeding the permissible limit are a major concern in Rajasthan, Haryana, Karnataka, Andhra Pradesh, and

Telangana. Elevated arsenic levels (more than 10 parts per billion) were found in several states, particularly in the floodplains of the Ganga and Brahmaputra rivers. This includes regions of West Bengal, Jharkhand, Bihar, Uttar Pradesh, Assam, and Manipur, as well as areas in Punjab and Rajnandgaon district in Chhattisgarh.

CISF records lowest number of suicides amongst its personnel in 2024

The Central Industrial ■ Security Force (CISF) on Thursday said it has recorded the lowest number of suicides amongst its personnel in 2024 -- at 15 -- over a six-year period due to some "creditable" steps taken to resolve the problems of its staffers.

As per official data, the force, which guards vital and sensitive installations in the aerospace, nuclear and government domain, saw 15 deaths last year due to suicide, which comes to 9.86 per lakh in an organisation that has an operational strength of over 1.51 lakh personnel. CISF has taken creditable steps in combating this challenge by implementing a series of proactive measures, which has led to substantial reduction in suicides of force members in 2024," said a CISF spokesper-

As per the National Crime Records Bureau (NCRB) data, due to suicide in the force over the spokesperson said that the the last five years stood at 25 national suicide rate stood at (2023), 26 (2022), 21 (2021), 18 12.4 per lakh in 2022.

Save Priya

Priya's story reveals a harrowing struggle. Efforts must intensify to stop her execution and ensure repatriation

he story of Nimisha Priya, a nurse from Kerala, currently on death row in Yemen, has sparked widespread debate and concern. With her death sentence sanctioned by Yemen's President Rashad al-Alimi, the clock is ticking on securing her release. Her story is not an isolated case but an ordeal that many workers face in the Gulf and many other countries. This case is not only about the fate of one individual but also raises critical questions about justice, diplomacy and human rights. Nimisha Priya, a trained nurse, moved to Yemen to work in private hospitals and make a career. In 2015, she partnered with Yemeni national Talal Abdo Mahdi to set up a clinic in Sana'a. Yemen's laws necessitate local sponsorship for businesses and Mahdi played that role for Priya. However, this professional relationship spiraled into a nightmare. Mahdi manipulated ownership documents of the clinic, claimed he was her husband using forged and morphed photographs and seized control of her finances. She was harassed mental-



ly and subjected to physical torture and imprisonment in her own home. In 2017, desperate to reclaim her passport and escape his clutches, Priya attempted to sedate Mahdi. Unfortunately, the sedatives proved fatal due to an overdose, leading to his death. The Yemeni judicial system found her guilty of murder, sentencing her a death sentene.

Efforts to appeal her conviction have been exhausted, with the Yemeni Supreme Court and President rejecting her pleas. While Mahdi's death is undeniably tragic, Priya only wanted to regain her life and runaway from coercion and cruelty. If she is executed than it would be travesty of justice and would mean

penalising a victim. Priya's actions, though legally punishable, occurred in a context of desperation and fear for her safety and freedom. The Government of India must assist Nimisha Priya and her family in securing her release and repatriation. Her release hinges on a complex process involving Yemen's tribal justice system and the payment of blood money to Mahdi's family must be paid by the accused to get a pardon. High-level diplomatic discussions with Yemeni authorities and tribal leaders are essential to secure a waiver of the death penalty. Besides, mobilising public support to raise blood money can be a way out. Employing a dedicated legal team with expertise in Yemeni law and tribal negotiations is crucial to ensuring fairness and efficiency in the process. Highlighting Priya's case on global platforms as a human rights issue may garner international support and pressure Yemen to reconsider her sentence. Priya's case underscores the plight of expatriates caught in abusive circumstances. Her actions, while grave, were not premeditated but driven by self-preservation against a backdrop of systemic exploitation. Repatriating Priya to India would allow her a better trial. The Indian government and civil society must step up efforts to secure her release and ensure she receives a fair chance to rebuild her life.

Winter session stalemate: Urgent need for reform

he Parliament's productivity in the Session was a record low, with only 52 per cent of scheduled work completed. Various factors, including disruptions and lack of quorum, contributed to the reduced output. The confrontation between the treasury benches and a belligerent Opposition continued throughout. The current performance highlights the challenges in maintaining productivity.

The Opposition, in particular, wanted to discuss the Adani issue. Leader of Opposition Rahul Gandhi has been raising the issue in public. It is a matter of significant public interest due to its implications. Also, the Opposition asked Union Home Minister Amit Shah to apologize for his comments about Dr BR Ambedkar, a highly respected figure in Indian history. The government was not willing to be flexible. With a productivity of merely 40.03 per cent during the Winter session.

Lok Sabha passed four of the

five bills it received. Rajya Sabha approved 3 bills. During this session, the Lok Sabha lost 65 hours and 15 minutes, the highest in 2024. Many requests for adjournment motions made in Lok Sabha and Rajya Sabha were not accepted. The 18th Lok Sabha is different in many respects. For the first time in a decade, we have a strong opposition with an official leader of Opposition (LOP). The bitterness between parties within and outside Parliament is increasing. Neither side is willing to accommodate. Discipline, decorum and dignity of Parliament are of paramount importance. The pressing need for parliamentary reforms is more evident than ever, and action is needed now. Over Rs 97.87.50.000 of taxpayers' money was spent during the Winter Session. The cost of running a Parliament session is over Rs 2.5 lakh per minute, a considerable burden on the exchequer, which should prompt reevaluating our parlia-



mentary practices. The Parliament's high cost and low productivity must be addressed sooner or later. House is often adjourned many times a day. In the last five decades, it has increased by over 100 times. This underlines the need to address the issue. For instance, Parliament saw protests from the ruling BJPled NDA and the aggressive Opposition INDIA Bloc. BJP MPs accused the Congress party of "insulting" Dr Babasaheb Ambedkar. Leader of Opposition Rahul Gandhi and INDIA Bloc MPs demanded the resignation of Union Home Minister Amit Shah over his comments about Ambedkar.

The escalating conflict over this issue resulted in two injuries and police involvement. Political parties should focus on honouring Ambedkar's legacy instead of blaming each other.Other bills include the Mussalman Wakf (Repeal) Bill, the Bharatiya Vidhevak. Scientists and innovators frequently find themselves facing competition for a diminishing pool of resources as budgets tighten and priorities shift in numerous regions of the globe.

A novel paradigm is emerging, one that is influenced by the digital economy: crowdfunding for research. Is it possible that this community-driven, decentralised approach could revolutionise the way we finance science? Government funding has been a cornerstone of scientific research across the globe, particularly in the domain of basic research. This funding plays a vital role in driving innovation, supporting the exploration of fundamental scientific principles, and fostering advancements that often serve as the foundation for applied research and technological development. Despite its critical importance, accessing government research grants presents sig-

tists and institutions, making it a complex and often timeconsuming endeavour.

The exhaustive application process is one of the foremost difficulties in securing government funding. As a result, projects that do not align with government priorities may struggle to find financial support, even if they hold substantial scientific or societal value. Moreover, the eligibility criteria for government funding further restrict access. Typically, government grants are available only to individuals holding doctoral degrees and those affiliated with recognised academic or research institutions, and some agencies restrict people from private institutions.

INDIA'S NEW TRADE PARADIGM WITH THE US

India faces new challenges from the Trump's tough stance, spurring urgent talks on tariffs and trade

he year gone by saw some crucial path-altering elections in nearly 70 of the most powerful democracies in the world. Some of the most populous countries led by India and including the US, Bangladesh, Indonesia etc. voted for a leadership of their choice in 2024. While the Indian electorate chose to renew another 5-year term for Prime Minister Modi (albeit with a less-than-expected mandate), Bangladesh too renewed its faith in Sheikh Hasina (who was accused of rigging the electoral process to retain power), which ultimately led to her been thrown out in a coup. In a highly polarised election ground, in the US, the incumbent President a front runner for the top job at the white house, pulled out near the finish line, leaving his second in command the Vice President to throw her hat in the ring against a mighty opponent Donald Trump. The US electorate gave a clear mandate for Donald Trump to lead the new global order for the US. Donald Trump's clear victory in the US elections, now potentially could lead to several multilateral, bilateral rejigs, around the globe. President-elect has already nominated several friends and allies from the past, in some of the top jobs.

He has threatened high tariffs for Canada and Mexico while joking that the former is another state of the US. He has strong views on India's trade surplus with the US which is already an issue of concern for Indian officials. Several Indian ministries were in a huddle in the last week of the year 2024, trying to assess the amount of exports from their respective sectors, while looking at the tariffs imposed on US imports. New Delhi-based policy research institute Research and Information System for Developing Countries (RIS) spent the last day of the year discussing 'Trade Tariff and Trump'. Several recommendations were made by the



A press release from the event highlighted in the first paragraph that "India should have comprehensive engagement with the US, as new administration led by President-elect Trump takes over. India should explore a comprehensive new institutional framework to address the multiple issues that arise from trade, investment, technology and finance linkages. India should urgently consider appointing a Task Force or create other institutional mechanisms that bring in domestic policy coherence on these lines." In an unrelated development, India's External Affairs Minister Jaishankar spent the last week of the year in the US, meeting key presidential nominees for the incoming Trump administration and also attending the last foreign affairs ministers meeting under President Biden, even though QUAD as the framework was empowered by Trump Presidency 1.0.

The policy research institute RIS has cautioned to not respond with any knee-jerk reactions, to possible volatile statements emerging from Washington, immediately after President Trump's swearing-in, instead, it suggests "India may need to plan first, plan hard, and yet plan fast." An agile, business approach may be the best way forward to dealing with the incoming administration.


It may also be worthwhile to note that the Indian government should reconsider some of the non-tariff barriers it imposes on imports in the form of regulatory compliances and compulsory testing etc. To avert losses, tie up with our US importers need to be strengthened so that they lobby for their own needs. However, low technology products have high US tariffs. We may be left with an avenue there to improve our participation in the value chains being built up in the US manufacturing sector. "A diversification of markets for Indian products may be needed, which could also have a sectoral focus. India can focus on exporting a certain bunch of products to say the Gulf Nations or the ASEAN group of countries depending on the price advantage. Some hedges need to be built to prevent any major hit of Trump tariffs.

en years ago, Prime Minister Narendra Modi set forth his vision of sushasan (good governance), calling it "the key to a nation's progress." He declared December 25, former PM Atal Bihari Vajpayee's birth anniversary, as Good Governance Day. Vajpayee had envisioned a "New India" where the government would embody the principles of democracy and development, emphasising citizen-centric decisionmaking, transparency, and

public participation. Put simply, good governance means that the day-to-day functioning of the government is effective, transparent, and accountable, which, in the modern age natural-

digital empowerment. In fact, in the context of a welfare government functioning in a vastly unequal society, good governance is fundamental for ensuring sustainable development, social justice, and the protection of human rights.

In 2019, India also adopted a metric called the Good Governance Index (GGI) to track and compare gover-

union territories across ten key sectors. The 11th Good Governance Day presents an apt moment to pause and reflect on the state of governance in one of the most critical sectors—education. Even though Human Resource Development, composed of indicators like 'quality of education" and 'elementary school retention rate," is one of the ten key sectors covered by the GGI, a close look at India's education governance reveals substantial room for improvement, particularly at the school level.

Vajpayee's commitment to education was evident during his tenure as Prime Minister—he pioneered the landmark Sarva Shiksha ly includes e-governance and nance among the states and Abhiyan (SSA) in 2002,

which emphasised universal school enrollment and went on to form the cornerstone of the Right to Education (RTE) Act, 2009. Building decisively on this foundation, Prime Minister Modi's leadership has elevated education to new heights through bold reforms. The introduction of the National Education Policy (NEP) 2020, along with the

NIPUN Bharat Mission, has revolutionised the approach to foundational learning. This shift is being carefully monitored through multiple assessment initiatives - states have implemented thirdparty evaluations, while programs like CBSE's SAFAL, the National Achievement Survey, and Gujarat's groundbreaking Vidya



Samiksha Kendra (VSK) use cutting-edge technology to track progress systematically. These assessment systems have revealed both progress and persistent challenges in our education sys-

The data highlights critical areas that need attention, particularly in learning outcomes. Various learning sur-

veys show that over 5 crore elementary-grade students lack foundational literacy and numeracy skills. Learning gaps for these children only keep widening as they progress through grades with a weak founda-tion. It is then unsurprising that almost 33 per cent of Grade VIII students are unable to read simple sentences or do basic arithmetic.

Recognising these challenges, PM Modi's administration has taken a step through the State School Standards Authority (SSSA), recommended in the NEP 2020, which emerges as a pivotal reform to enhance Îndia's school governance standards. The proposed SSSA would be an indepen-

dent quality regulator for all schools, both public and private. One of the key functions of the SA is to ensure public disclosure of school performance data for all schools through a digital portal.

With all schools being held to clear and uniform quality standards and policymakers being informed by datadriven insights, educational resources will be used more efficiently. The SA can create a culture of transparency where parents are active participants in their children's education.

With its emphasis on streamlining bureaucracy, focusing on outcomes rather than inputs, and integrating technology to reduce administrative burdens, not only

does it embody Prime Minister Modi's ideal of "minimum government, maximum governance". A pertinent example is the set of eight principles of good governance recommended by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP)participation, rule of law, transparency, accountability, equity, effectiveness, consensus, and responsiveness. As the nation observes Good Governance Day, the call to action is clear: states must embrace the SA to realise the shared vision of a "New India," where quality education is a right, not a privilege.

ICMR proposes new diagnostic tests in PHCs

Nine types of diagnostic tests, including those for diabetes, Malaria, TB, HIV and syphilis should be made available at the health centres in village-level health facilities, the Indian Council of Medical Research (ICMR) has proposed in a revised version of the National Essential Diagnostics List (NEDL).

The list enumerates the minimum number of tests that should be available at various levels of healthcare facilities in

the country. Ayushman Arogya Mandirs should have facilities for Hepatitis B tests available in addition to the nine diagnostics that are available at the village-level health centres, said the revised draft list which has been prepared incorporating inputs from relevant stakeholders and feedback from multiple con-

sultation meetings.
It builds upon the first list and provides recommendations for diagnostic tests across various levels of healthcare facilities, including village-level facilities, Ayushman ry.

Arogya Mandirs, primary health centre (PHCs), com-munity health centres (CHCs), sub district hospitals (SDHs) and district hospitals (DHs).

The draft of the second NEDL has been put up on the public domain for feedback and comments from various stakeholders.

The new set of guidelines states that tests for dengue and Japanese Encephalitis and other common illnesses must be accessible at the Primary Health Centres in addition to X-rays and ECG facilities.

The district-level hospitals must facilitate CT scan, MRI, mammography and echocardiography, according to the draft guidelines.
The ICMR released the first

NEDL in 2019 to make diagnostics an essential component of the health care system. In 2018, the World Health Organisation had recommended the development and implementation of an NEDL to facilitate the availability of in-vitro diagnostics across the various tiers of the healthcare pyramid, in facilities with or without an onsite laborato-

Munde refuses to resign amid sarpanch murder controversy

Maharashtra Minister and Nationalist Congress Party (AP) leader Dhananjay Munde -- who is in the eye of a controversy over the sensational murder of a Sarpanch in his home district of Beed – on Thursday refused to resign from his post, a couple days after prime accused in the murder case Walmik Karad surrendered to the police.

The development came a day after the Maharashtra government set up formed a Special Investigation Team (SIT) to investigate the murder of Massajog village Sarpanch, Santosh Pandit in the wake of Karad's surrender before surrendered to the CID Pune office on Tuesday.

Karad, who is allegedly linked to with Dhananjay Munde, is currently in 14 days' police custody. Karad is the key accused in the Rs two crore extortion case linked to the

Sarpanch Santosh Deshmukh (45) was allegedly killed for attempting to thwart the extortion bid on the windmill company. He was first abducted, brutally tortured and later killed in broad daylight near the windmill company office on the afternoon of December 9, 2024. Talking to media persons here, Munde wondered: "Why should I resign? I am in no way directly or indirectly involved (in the murder or extortion cases)...the police is probing the matter", Mundee, who is a close confidant of NCP President and Deputy Chief Minister Aiit Pawar, said that the state government had announced three probes - by Crime Investigation Department (CID), a Special Investigation Team (SIT) probe

and a judicial inquiry. "I want that the charge-sheet be filed at the earliest, the accused should be tried before a fast track court and those found guilty should be hanged,' Munde said.

Maharashtra chief minister Devendra Fadnavis, who holds the state home portfolio, had earlier said:"No one would be spared...we will not allow goonda raj in Maharashtra".

Four persons - Vishnu Chate, Jairam Chate, Mahesh Kedar and Pratik Ghule - hav so far been arrested in connection with the murder, while three others Sudarshan Ghule, Krushna Andhale and Sudhir Sangle wanted in the case are absconding.

AAP-BJP lock horns over farmers

⊤he Bharatiya Janata Party (BJP) and the Aam Aadmi Party (AAP) are locked in a letter war over the farmers issue. Senior BJP leader and Union agriculture minister Shivraj Singh Chouhan wrote a letter to Delhi chief minister Atishi and criticised the AAP government for not implementing several pro-farmer schemes of the Centre government in the national capital. In his letter written in Hindi, Chouhan said "political competition" should not become an obstacle to the welfare of farmers. Expressing concern over the condition of farmers, Chouhan told Atishi that Delhi government has no sympathy for farmers and it is very indifferent towards farmers, who are "upset and worried" due to the nonimplementation of many welfare schemes by AAP.

In a sharp response to Chouhan's letter, Atishi hit back accusing the BJP of hypocrisy regarding its stance on farmers and said the saffron party talking about them was like "Dawood (Ibrahim) giving a sermon on non-violence." Criticising the party for its treatment of the farming community, Atishi alleged that the situation of farmers under BJP rule was worse than ever before. "The hardships faced by farmers during the BJP's tenure have never been seen before," the Delhi CM said in her letter to

Meanwhile, AAP convener Arvind Kejriwal on Thursday said the BJP would be responsible "if something happens" to the protesting farmers in Punjab who are on an indefinite fast over a set of demands, including a legal guarantee on MSP. Responding to Atishi's allegations, Chouhan clarified

Omar defends statehood demand, cites legal and political necessity

Tewly elected Chief Minister of the Union Territory of Jammu and Kashmir Omar Abdullah Thursday reignited the debate surrounding the 'Kashmir issue' by claiming the issue still exists, whether on this side of the border or the other.

In his maiden interaction with the media in Srinagar, Omar also expressed hope that the biggest promise of the restora-tion of statehood would be ful-filled by the central government soon.

Before opening the floor for questioning Omar in his brief remarks observed, "It has been a little over two months since we came to power. It took us time to understand how the UT government works. We have been associated with the government earlier, but there is a vast difference between that form and the present form". I thought working in such circumstances would be difficult, but our start has been quite 'decent' and they "did not find

much difficulty" in it. However, reacting to a straight question on the permanent settlement of the Kashmir issue Omar Abdullah attempted to reignite the spark by claiming "Even if we accept that the status of Jammu and Kashmir has been permanently resolved, the fact remains that a part of Jammu and Kashmir lies on the other side of the border. When the BJP claims the Kashmir issue is resolved, does it mean they believe the issue on the other side of the border is also resolved? It hasn't. The Kashmir issue still exists, whether on this side of the border or the other, and that is something we can discuss." Commenting on the promises

made by the National

Conference in its election manifesto during the Assembly polls Omar, flanked by his cabinet colleagues in the SKICC, told the gathering of media persons, "Some issues were important to us and we fulfilled those including the resolution on the statehood, and the resolution on the special status".

"We the people are now expect-ing that the promises made with us will be fulfilled. The biggest promise is the restoration of statehood. The Supreme Court in its judgement had also stated that the statehood should be restored as soon as possible. One year has passed since and we think one year should be enough," he added. Abdullah said the sentiments of

the people should be respect-ed and their aspirations fulfilled.

When asked why his government went to New Delhi with the resolution on the restoration of J-K's statehood, instead of approaching courts, Abdullah said a legal fight on the matter should be the last option. He said no chief minister of a Union territory is as empowered as a chief minister of a state. "That is a fact. There is no point in living in denial. If I were an empowered CM, why would I ask for restoration of statehood."

Brushing aside speculation that the Centre was trying to destabilize his government and that NC was going to join the BJP-led National Democratic Alliance, Abdullah said, "There is no pressure from the PM, home minister or Rai Bhawan on us to change our ideology. I have been told by the PM and the home minister that your government will not be desta-bilised, and that we will give you the same cooperation as given to the LG.

Mamata accuses BSF of allowing infiltrators from Bangladesh to India

West Bengal Chief Minister Mamata Banerjee on Thursday accused the Border Security Force (BSF) of letting infiltrators from Bangladesh enter India and charged the BSF with trying to destabilise the state.

Stating that she could sense a "blueprint of the central government behind this attitude of the BSF", Banerjee also accused a section of District Magistrates and SPs of helping the border guards in their illegal act. Reacting to the

allegations, Union minister Sukanta Majumdar flayed the Chief Minister and said that said she has reached the "ultimate level of delusion". Majumdar alleged that according to Banerjee, the "incompetent" district magistrates and

superintendents of police under her administration are allowing foreign criminals to infiltrate the border to kill the elected

representatives of her party.
"Until now, she used to hold the opposition responsible for such incidents. But why this sudden shift in Mamata Banerjee's narrative? Is she trying to shield the misdeeds of her party's looter, criminal representatives by making such claims?" the member of Parliament from West Bengal's Balurghat asked. The Trinamool Congress supremo claimed that it was a conspiracy to blame the TMC for the infiltration issue. "If someone thinks of destabilising the state and blaming it on the Trinamool Congress, I would say that it is not done by TMC not know who all are coming,"



by the BSF and not by the TMC. Some media channels are trying to spread this for the sake of their TRP," she said. Baneriee also alleged that goons are entering the state from across the border, killing people and going back. "We have got information that the BSF is letting infiltrators

enter India through Islampur, Sitai, Chopra and several other bordering areas. The BSF is also torturing women and trying to destabilise the state," Banerjee said at an administrative review meeting at the state secretariat 'Nabanna'. "Border security is not our responsibility and BSF looks after this. Visa is not our matter but that of the central government. has been stopped. So, we do

"This is a deep-rooted conspiracy of the BSF and the central government has a blueprint for it. If there was no blueprint of the Centre, it would not have happened," she said. "There is no bad relationship between the two Bengals (West Bengal and Bangladesh). We speak the same language and we follow a similar way of lifestyle. People across the border can come here for treatment. But we should be informed," she stated.

The CM asserted that she had told the Centre several times that she would follow whatever decision it would take on the situation in Bangladesh. "But if I see that someone is helping terrorism to disturb my state, we will have to protest," Banerjee said adding that she would send a strongly worded letter to the Centre in this

(DM, SPs) protest this act of the BSF? I will ask DGP Rajeev Kumar to find out through which spots they had entered the state and where these people stay. The police get information of infiltrations. But (a section of) the DMs and SPs have not shared any information with us. They have not carried out their responsibility properly," Banerjee said. The Bengal CM directed the DGP to share a detailed report on the matter as she has planned to send a protest letter to the Centre.

According to Chouhan, Delhi farmers face additional burdens as agricultural equipment like tractors and harvesters are categorized as commercial vehicles, leading to higher purchase costs. Despite the AAP government's free electricity promises, farmers are being charged commercial rates for power, he said, adding that farmers along the Yamuna are struggling after their

irrigation equipment's power connections were disconnected. "Your government has been in power for the last ten years, and it appears former chief minister Arvind Kejriwal has betrayed farmers after making election promises," Chouhan said. The minister urged the Delhi government to implement central agricultural schemes immediately. stating that political competition should not hinder farmer welfare.

Referring to the ongoing hunger strike by farmers in Punjab, Atishi urged Chouhan to tell Prime Minister Narendra Modi to engage with the protestors and address their issues. She also asked the BJP to stop "politicising" the farmers' struggles and accused it of using "bullets and lathis" against farmers. "The condition of farmers has never been as bad as it is during the BJP rule. Farmers in Punjab are on hunger strike. Tell Modi ji to talk to them.

Stop playing politics with farmers. Bullets and lathis have been fired on farmers during the BJP rule," Atishi responded.

Kejriwal, in a post on X, also claimed that the Centre is preparing to implement the now-revoked three farm laws "through the backdoor" by calling it a "policy". He said copies of the new "policy" have been sent to all states for their views on it. Kejriwal posted on X that while the farmers were on a fast unto death in

Punjab, the BJP, due to its arrogance, was not talking to them. The AAP supremo charged that the BJP-led Centre accepted farmers' demands three years ago but is now reneged on it. "Why do the BJP have such arrogance that it does not even talk to anyone," Kejriwal asked. "May God keep the farmers who are on an indefinite protest safe, but if something happens to them, the BJP will be responsible for it," he said in a long post in Hindi.

UK upgrades law to crack down on 'vile' people smugglers

dhe UK on Thursday unveiled tougher laws including travel restrictions and a ban on phone usage to clamp down on "vile" people smugglers behind organised immigration crime networks.
The Home Office said new

interim orders will allow immediate action to disrupt and deter suspected serious criminality in a "major upgrade" to the country's Serious Crime Prevention

The changes form part of the Border Security, Asylum and Immigration Bill, with new powers mirroring those which are already used to disrupt other harmful criminality such as knife crime, slavery and trafficking.

"Dangerous criminal peoplesmugglers are profiting from undermining our border security and putting lives at risk. They cannot be allowed to get away with it," said UK Home Secretary Yvette Cooper.

"Stronger international col-laboration has already led to important arrests and action against dangerous gangs over the last few months. We will give law



enforcement stronger powers they need to pursue and stop more of these vile gang networks, Under the proposals, breach-

ing an interim order could lead to up to five years in prison. Restrictions to be imposed under such orders will vary on a caseby-case basis and could include: travel restrictions on suspects; ban on laptop or mobile phone usage; ban on accessing social media networks, including via a third party; restrictions on whom someone can associate with: restrictions on devices and communications with certain individuals: and restrictions on their finances, helping to prevent criminal proceeds from going under

The Home Office said that

currently securing a Serious Crime Prevention Order imposed on suspects, including people smugglers, can be a complex and lengthy process, restricting the use of this powerful tool.

Interim orders are intended to go further, speeding up the process for placing restrictions on people under investigation to prevent, deter and disrupt serious and organised crime, including people smuggling.

The new interim orders will allow the UK's National Crime Agency (NCA), the police and other law enforcement agencies to apply directly to the High Court to impose immediate restrictions while a full order is considered.

The UN children's fund urged governments on Thursday to prioritise the safety of migrant children after the latest Mediterranean shipwreck left about 20 people missing and added to a gruesome annu-

Among the seven survivors of the New Year's Eve wreck off the Sicilian island of Lampedusa was an 8-year-old girl whose mother is among the missing, UNICEF said.

The agency noted that last month, an 11-year-old girl found floating off Lampedusa was believed to be the lone survivor of a migrant boat that had left Sfax, Tunisia, with about 45 people on board.

According to the International Organisation of Migration's missing migrant tracker, 2,275 people were unaccounted for in the Mediterranean in 2024, bringing the total number of people missing since 2014 to 31,180. The vast majority — 24,466 — were believed to have died on the perilous central Mediterranean route, which is most often used by smugglers from Libya and Tunisia to ferry desperate people toward Italy.

These footprints offer an extraordinary window into the lives of dinosaurs, revealing details about

The dig, carried out at Dewars Farm Quarry in Oxfordshire, uncovered five extensive trackways with evidence of more in the surrounding area. The longest continuous trackway measured more

Four of the trackways were made by gigantic, long-necked, herbivorous dinosaurs called sauropods most likely to be Cetiosaurus, an up to 18-metrelong cousin of the well-known Diplodocus. The fifth trackway was made by the carnivorous

theropod dinosaur, Megalosaurus which had dis-

tinctive, large, three-toed feet with claws.

One area of the site shows the carnivore and herbivore tracks crossing over, raising questions about whether and how the two were interacting. Megalosaurus was the first dinosaur worldwide to be scientifically named and described in 1824 and kick-started the last 200 years of dinosaur sci-

Dr Emma Nicholls, Vertebrate Palaeontologist at OUMNH, explained: "Scientists have known about and been studying Megalosaurus for longer than any other dinosaur on Earth, and vet these recent discoveries prove there is still new evidence of these animals out there, waiting to be found." The footprints were buried under mud but came to light when quarry worker Gary Johnson felt 'unusual bumps' as he was stripping the clay back with his vehicle, in order to expose the quarry floor. At this point, the experts were called in. Working closely with Dewars Farm and Duns Tew Quarry Manager Mark Stanway, and his staff, the Universities of Oxford and Birmingham co-led a

Hundreds of different dinosaur footprints discovered in UK's Oxfordshire

 $R^{\rm esearchers}$ from the Universities of Oxford and Birmingham have uncovered a huge expanse of quarry floor filled with hundreds of different dinosaur footprints. In a stunning find, the teams uncovered multiple enormous trackways dating back to the Middle Jurassic Period (around 166

million years ago).
The trackways form part of a huge 'dinosaur highway' and include footprints from the nine-metre ferocious predator Megalosaurus, and herbivorous dinosaurs up to twice that size.

The excavation will be broadcast on BBC Two's Digging for Britain on January 8 and featured in a new public exhibition Breaking Ground at Oxford University Museum of Natural History

issued three separate notifications to discontinue multiple pensions, reducing both the first home take pension and also lowering the base for determining future increases in pensions, The Express Tribune newspaper reported. After debt servicing, defence and development, the pension is the fourth largest expenditure in the budget, the

paper said. According to the Ministry of Finance's notification, on the recommendations of the Pay and Pension Commission of 2020, "it has been decided that henceorth, in an event where a person becomes entitled to more than one pension, such person shall only be authorised to opt to draw one of the pensions". Instead of taking a pension on the basis of the last drawn salary, the new pensioner will get a pension based on the average salary of the last two years. The finance ministry stated that all the

existing instructions on multiple pensions should stand amended with immediate effect. The changes will not be applicable to

people who have already retired, except in cases where multiple pensions are

It also ended the annual compounding of the pension and any increase would be treated separately from the base pen-

After these changes, it is expected that in the next decade, the pension bill will significantly reduce and will become manageable. Apart from the new changes made in the pension system, the government already abolished the traditional pen-

sion scheme for the civilian employees hired from July 1, 2024. The scheme will also be applicable to employees of defence forces from July 1, 2025. Instead, the new employees have been

provided with a system of contributory pension based on the contribution made by them through salary.

New textbooks in Bangladesh to alter credit of declaration of independence: Report "exaggerated, imposed history".

 $B_{\text{textbooks}}^{\text{angladesh}} \text{ has introduced new} \\ \text{textbooks} \text{ that state that Ziaur}$ Rahman declared the country's independence in 1971, replacing the previous ones crediting founding father Bangabandhu Sheikh Mujibur Rahman with the declaration, according to a media report.

The new textbooks for primary and secondary students have several changes, The Daily Star newspaper said. The textbooks also removed the title "Father of the Nation" for Muiibur Rahman.

The new textbooks for the 2025 academic year will state that "on March 26, 1971, Ziaur Rahman declared the independence of Bangladesh, and on March 27, he made another declaration of independence on behalf of Bangabandhu," the paper quoted Prof AKM Reazul Hassan, chairman of the National Curriculum and Textbook Board, as saying. The information has been included in

the free textbooks where the matter of the declaration was mentioned, he added. According to the paper, writer and researcher Rakhal Raha, who was involved in the process of making changes in the textbooks, said they tried to free the textbooks from

Those who revised the textbooks found that it wasn't fact-based information that Sheikh Mujibur Rahman sent the wireless message [declaring independence] while being arrested by the Pakistani army, and so they decided to remove it." Earlier, in the textbooks of classes one

to 10, the information on who made the Declaration of Independence was changed according to the government in power, the paper said.
It is widely believed among support-

ers of Awami League that Muiibur Rahman had made the announcement and that Ziaur Rahman, who was an Army major and later a sector commander of the Liberation War, merely read out the declaration upon Muiib's instructions.

Earlier, Bangladesh decided to start the process of erasing the image of Sheikh Mujibur Rahman from its currency notes as it phases out the old notes. The move came after the ouster of his daughter Sheikh Hasina as prime minister on August 5. His statues and murals bearing his image were targeted as his daughter fled to India. The interim government also cancelled a national holiday on August 15, marking the assassination of Mujibur Rahman.

Israeli strikes kill at least 18 in Gaza

AP JERUSALEM

Tsraeli airstrikes killed at least 18 people in the Gaza Strip on Thursday, including three children and two high-ranking officers in the Hamas-run police force, according to Palestinian and hospital officials.

One strike early Thursday hit a tent in an Israeli-declared humanitarian zone known as Muwasi, where hundreds of thousands of displaced people are sheltering in tents during the cold and rainy

Another strike killed at least eight Palestinians in the central Gaza Strip. The dead were members of local committees that help secure aid convoys, according to Al-Aqsa Martyrs Hospital, which received the bodies. An Associated Press reporter at the hospital confirmed

There was no immediate comment from the Israeli military on the strikes.

The war was sparked by Hamasled militants' October 7, 2023 attack into Israel. They killed some 1,200 people, mostly civilians, and abducted around 250 that day. Around 100 hostages are still inside Gaza, at least a third of whom are believed to be dead. Israel's offensive has killed over

45,000 Palestinians in Gaza, according to local health officials, who say women and children make up more than half the fatalities. The officials do not distinguish between civilians and combatants in their tally.

Israel says it targeted Hamas official in a strike that killed 9 others: The Israeli military says it targeted a senior member of Hamas' internal security apparatus in a strike in the Gaza Strip that Palestinian officials say killed nine other people, including three chil-

The strike early Thursday hit a tent in an Israeli-declared humanitarian zone known as Muwasi, where hundreds of thousands of displaced people are sheltering in tents during the cold and rainy

The military said Hossam Shahwan, a senior officer in the Hamas-run police force in Gaza, was involved in gathering intelligence used by Hamas' armed wing in attacks on Israeli forces.

Maj Gen Mahmoud Salah, another senior police official, was also killed in the strike. The military says Hamas militants hide among civilians and blames the group for their deaths in the nearly 15-month war, which was ignited by Hamas' October 7, 2023 attack into Israel. The Hamas-run government had

a police force numbering in the tens of thousands that maintained a high degree of public security before the war while also violently suppressing dissent. The police have largely vanished

from the streets in many areas after being targeted by Israel, contributing to the breakdown of law and order that has hindered the delivery of desperately needed humanitarian aid.

"Growth of imports is observed majorly in Cotton Textiles mainly on account of import of long staple cotton fibre and such trends of import indicates an increase in production capacity of the country amidst rising consumption and selfreliance," the official statement said. During FY 2023-24, the import of textiles and apparel products by India stood at USD 8.94 billion, down by nearly 15 per cent in comparison to USD 10.48 billion in FY 2022-23. India was the sixth largest exporter of textiles and apparel in the world in 2023. The share of textile and apparel (T&A) including handicrafts in India's total exports stood at 8.21 per

cent in FY 2023-24. "Our country has a share of 3.9 per cent of the global trade in textiles and apparel. Major textile and apparel export destinations for India are USA and EU and with around 47 per cent share in total textile and apparel

"India is a major textile and apparel exporting country and enjoys trade surplus. Bulk of import takes place for re-export or for industry requirement of raw material," the Textile Ministry said.

It is noteworthy that export is a function of demand and supply and depends on factors such as global demand, internal consumption and demand, order flow, logistics etc. Exports in FY 2024 were initially low

At the interbank foreign exchange, the rupee opened on a weak note and witnessed an intra-day low of 85.79 and a high of 85.68 against the American currency. The local unit settled for the day at 85.73 (provisional), registering a fall of 9 paise over its previous close amid a sharp recovery in domestic equities. Wednesday, the rupee settled flat at 85.64 against the US

On December 27, the local strength against a basket of six currency touched its lifetime intra-day low of 85.80 against

the greenback. 'We expect the rupee to trade with a negative bias on strength in the US Dollar and dollar demand from importers. Sustained FII outflows may further pressure the rupee," said Anuj Choudhary -Research Analyst at Mirae

The two sides signed the Trade and Économic Partnership Agreement (TEPA) on March 10, 2024. Under the pact, India has received an investment commitment of USD 100 billion in 15 years from the grouping while allowing several products such as Swiss watches, chocolates and cut and polished diamonds at lower or zero duties. The European Free Trade

Association (EFTA) members are Iceland, Liechtenstein, Norway, and Switzerland. "Yes, EFTA is progressing very fast," Goyal told PTI when asked if the agreement would come into effect this

The minister said the Swiss Council of States has approved the agreement and now will go to their National Council for approval.

"So this overwhelming support in political circles in Switzerland for the TEPA with EFTA is truly a sign of the times to come... And in their statement also, it shows that that it has cleared an important hurdle and they are hoping to bring in entry to force by autumn of 2025, before the end of calendar year 2025," Goyal said. The bloc committed an



cricket. The game was introduced in Thalassery by *Sir Arthur Wellesley*, who led a military campaign to Malabar to defeat

challenged the East India Company (EIC) for imposing heavy taxes on the people.

Wellesley's mission was to subdue Pazhasi

Raja, who had incited the local population

to resist cooperation with the EIC and

To keep his soldiers engaged, Wellesley

introduced the game of cricket at the

military station. He also included players

from the local population to build trust.

Although cricket was considered a game of

royalty, Wellesley recruited washermen,

porters, rickshaw pullers, and others from

excelling in all aspects of the game.

Talented batsmen, bowlers, and fielders

emerged, and some quickly gained

prominence. Notable players like

Aboobaker, Ahmed and Kunjipakki became

batting style, which resembled *Geoffrey Anson's*, while *Kunjipakki* earned the title Sixer *Kunjipakki* for his crowd-pleasing sixes

Records of *Kunjipakki* and *Aboobaker's* performances, chronicled in scorebooks

imported from England, are preserved in the Arakkal Home, the ancestral house of the chieftain. This home, with its panoramic view of the maidan, houses a collection of cricket memorabilia from the late 18th and early 19th centuries. Ernest

Cowdrey, father of British cricketer Colin Cowdrey, regularly represented the English team at the Thalassery maidan. Old-timers fondly recall the golden era of cricket in Thalassery, when players' names became part of local folklore.

The tradition of naming players after cricketing icons persisted. At Sree Sankara College, Kalady, Ramakrishna Iyer, a wicketkeeper-batsman, was nicknamed Kirmani Ramakrishnan for emulating SMH Kirmani, India's renowned wicketkeeper. Kirmani was honoured with the Best Wicketkeeper in the World award after the 1983 World Cup, a recognition yet unmatched.

Despite his exceptional performance, *Kirmani* was often dropped from the national team for reasons known only to selectors. His eventful career, spanning nearly four decades, is documented in his memoir, *STUMPED*: *Life Behind and Beyond the Twenty-Two Yards*. Co-written with *Debashish Sengupta* and *Dakshesh Pathak*, the memoir includes articles by cricket writers and highlights *Kirmani's* contributions to the game.

Cricket, once a status symbol for the elite, became a sport for the masses with players like *Kirmani, Kapil Dev* and *Balwinder Singh Sandhu*. Before their rise, the game was dominated by royals like *M. A. K. Pataudi* and *Maharaja Ranjit Singh*. In the 1970s, cricket coaching was a privilege, but players like *Kirmani*, born into a lower-middle-class family, worked tirelessly to succeed. *Kirmani's* determination and resourcefulness, using bricks as wicketkeeper's gloves in his school days echo the humble beginnings of sports legends like Pele.

Kirmani's memoir recounts his inspiration from England's wicketkeeper Alan Knott and his experiences keeping wickets for unpredictable bowlers like Chandrasekhar, E. A. S. Prasanna and Bishan Singh Bedi. Despite his dedication, Kirmani was undervalued. While other players received ₹1 crore for benefit matches, Kirmani was allocated a mere ₹25 lakh, a glaring injustice.

Announcing his retirement from firstclass cricket with sorrow, *Kirmani* criticised the selectors' inability to appreciate talent. However, he remains a beloved figure in Indian cricket history, celebrated for popularising the game and his unparalleled skill as a wicketkeeper. The only drawback in STUMPED is the

occasional typos and grammatical errors, which detract from the reading experience. Penguin, the publishers, could have ensured a more polished presentation.

Lanka beats New Zealand 7 runs in the 3rd T20

Kusal Perera scored Sri Lanka's fastest Twenty20 International century — from 44 balls — on Thursday to spur his team to a consolation win over New Zealand by seven runs in the the final match of the three-match series.

Perera's career-best score in a century partnership with captain Charirth Asalanka lifted Sri Lanka to 218-5 — its second-highest T20 score, as it batted first for the first time in the series.

New Zealand held a winning 2-0 lead in the series after winning the first match by eight runs and the second by

New Zealand needed to achieve its highest run chase in T20s to complete a clean sweep of the series and was given a good start by Rachin Ravindra who made 69 from 39 balls. But it fell just short, held to 211-7.

The Black Caps began at a pace to match Sri Lanka, reaching 60-0 in the six-over power play. But Asalanka slammed the brakes on the New Zealand innings when he dismissed Ravindra, Mark Chapman (9) and Glenn Phillips (6) in quick succession.

Asalanka had figures of 3-25 after those dismissals but Daryl Mitchell hit four consecutive sixes from his final over to wreck his analysis and bat New Zealand back into the game.

Wanindu Hasaranga then dismissed Mitchell Hay (8)

and Michael Bracewell (1) in the 16th over to tip the match back in the visitors' favor. Asalanka took a superb diving catch to remove Bracewell and managed his bowlers well in a superb all-round performance. "I think it's a good win for us," Asalanka said. "I think throughout the series we've played good cricket but couldn't manage to get a win. Finally we got it. I hope this is a momentum shift for us. Adapting to these conditions has been a key for us."

New Zealand came to the last over, bowled by Binura Fernando, needing 22 to win. After taking six runs from the first three balls, one of which was a wide, Zak Foulkes hit the fourth ball for six, leaving New Zealand needing 10 from the last two balls.

It was too much and the New Zealand batters managed only three more runs.

The start of the match was delayed by 30 minutes by a wet outfield and when it began Sri Lanka lost the toss but had the chance to bat first on a good pitch at Saxton Oval.

The tourists lost both openers,

Pathum Nissanka and Kusal Mendis, inside the power play. But Perera powered up the Sri Lanka innings in an outstanding batting performance, hitting 13 fours and four sixes in his 101 from 46 balls

ll-rounder Beau Webster All-rounder Beau webster will replace an out-of-form Mitchell Marsh in Australia's squad for the fifth and final Test against India, home skipper Pat Cummins said here on Thursday.

The 33-year-old Marsh scored only 73 runs in seven innings across four Tests and Cummins cited this as the reason for his axing. He has bowled merely 33 overs in the series so far, claiming just three wickets.

We have one change in our side. Beau Webster comes in place of Mitch Marsh. Mitch knows that he hasn't scored enough runs," Cummins said at the pre-match press conference

"Mitchie obviously hasn't quite got the runs or perhaps wickets said he would have liked this series. So, it felt like it was time for a freshen up and Beau's been with the squad. He's been great. But I feel like now is a good week for Beau to get a chance." The 31-year-old Webster, who played against India A in

November, has scored 5247 runs and taken 148 wickets in first-class cricket. Webster has been in good form in the Sheffield Shield as well and averaged over 55 last season. "He's just been one of those star performers for Tasmania with the bat or ball, or in the field. He always seems to have a big impact, quite aggressive. (He) can change the game, like we've seen Mitch Marsh or Travis Head or Alex Carey do in that middle order."

Webster's crafty bowling played a role in the decision, That was definitely a factor. It's always nice to have a fifth bowler that bowls quite a lot for Tasmania. So if we need to call on that, we can.

"Firstly, if you're going to bat six, you picked for your batting, which he's shown in Shield over the last couple years when he takes the game on, and he's really changed some games for Tasmania. That pace bowling of Beau's going to be handy," said Cummins.

However, Cummins asserted that the Boxing Day match will not be Marsh's last Test for Australia. "Particularly here in Australia,

when a batter misses out or gets dropped it's always see as a big thing, but it's not the case. We love pulling a squad of players together who we can call on at different times, and we thought the time was right for Mitchy to have a freshen-up and miss this one. "But doesn't mean that he won't be back in the team at some point," the skipper said. Starc fit

Cummins also put to rest the speculation surrounding Mitchell Starc's fitness, saying the left-arm pacer will play the game.

He went for scans yesterday. But he got the all clear to play this match. He is good to go," Cummins said.
