Mid-week polls in Delhi on Feb 5

With an announcement of the 70 assembly seats in Delhi in a single phase on February 5 and the votes will be counted on February 8 by the Election Commission (EC), the stage is set for a fierce triangular contest between incumbent Aam Aadmi Party (AAP), the Bharatiya Janata Party (BJP), and the Congress. The battle lines are drawn between Prime Minister Narendra Modi's developmental model versus the 'freebies' model touted by the AAP chief and former Chief Minister Arvind Kejriwal, who is eyeing a hattrick, having swept the 2015 and 2020 elections with 67 and 62 seats, respectively. The AAP faces anti-

incumbency, corruption allegations and an aggressive BJP in its bid to assume power for a third successive term. The Congress will be keen to regain the national Capital. Although the Congress and the AAP contested the 2024 Lok Sabha elections together as part of the INDIA bloc, they will be competing separately in the upcoming Assembly polls. Announcing the dates for the

Assembly polls in Delhi, Chief Election Commissioner Rajiv Kumar said "It is a single-phase election... We have deliberately kept polling on a Wednesday so more people come out to vote... like we did in Maharashtra. The entire election process will be

India boosts surveillance for HMPV

A mid the detection of cases of human (HMPV) infection in Karnataka, Gujarat, Maharashtra and Tamil Nadu, the Centre has advised States to step up surveillance for respiratory illnesses including ILI and SARI to tackle any exigency, and create awareness about the prevention of transmission of the pathogen which is

fast spreading in China.
Union Health Secretary Punya Salila
Srivastava on Monday chaired a virtual
meeting with states and union territories to take stock of respiratory illnesses and HMPV cases in the country and public health measures for their management, a health ministry statement said. However, the Centre has not issued any advisory

The Union Health Secretary said that there is no cause of concern for the public as HMPV has been present



globally since 2001, the statement said, adding that States have been asked to strengthen and review the ILI/SARI surveillance. "The States have been advised to enhance information, education and communication (IEC) and awareness among people regarding the prevention of transmission of the virus with simple measures such as washing hands often with soap and water; not touching eyes, nose, or mouth with unwashed hands; avoiding close

contact with people exhibiting symptoms of the disease; and covering mouth and nose when coughing and sneezing," said the statement.

HMPV is a globally recognised respiratory virus. It is a viral pathogen that causes respiratory infections in people of all age groups.

During the meeting, it was noted that the IDSP data does not indicate any unusual rise in influenza-like illness (ILI) and severe acute respiratory illnesses (SARI) cases anywhere in the country. All the detected patients don't have any foreign travel history, suggesting that the virus is indigenous,

This is also corroborated by the ICMR sentinel surveillance data, it said. Srivastava reiterated that an increase in respiratory illnesses is usually seen during the winter months and that the country is well prepared for any potential surge in such cases, the statement said.

6.8-magnitude quake in Tibet kills 95 people with tremors felt in Nepal

A 6.8-magnitude earthquake struck near one of Tibet's holiest cities on Tuesday, killing at least 95 people and injuring 130 others with tremors also shaking buildings and forcing people to run to the streets in neighbouring

According to regional disaster relief headquarters, the quake jolted Dingri County in Xigaze in Tibet Autonomous Region in China at 9:05 am Tuesday (Beijing Time). The US Geological Service, however, put the quake's magnitude at 7.1.

PWD withdraws Atishi's bungalow allotment

In a twist to the ongoing row over Delhi chief minister's official residence at 6, Flag Staff Road at Civil Lines, the Public Works Department (PWD) has withdrawn its offer to allot the bungalow to Chief Minister Atishi, as she did not take "physical possession" of the house despite multiple requests from the department and issuance of "authority slip" last October. Countering her claim that she was evicted from her official residence for the second time in three months, PWD's sources have said that the question of eviction doesn't arise because she never took possession of the bungalow. The PWD has now offered two choices of accommodation to Atishi -

Bungalow 2 at 8 Raj Niwas and Bungalow 115 at Ansari Road Daryaganj - and asked her to submit her choice within eight days.

"A night before announcement of the election date, the BJP-led government at the Centre has thrown me out of the chief minister's residence for the second time in two months. I was sent a letter stating that the allotment had been did the same thing three months ago, when I became chief minister. My belongings and those of my family were thrown out of the house and on the road," the chief minister said in Hindi.

Atishi has not been evicted, as she never took possession of the bungalow that was allocated to her. Secondly, her official residence at 17 AB Mathura Road remains allocated to her, and she has been offered two other bungalows to choose from. The letter from the PWD also clarified that the withdrawal of the offer for the Flag Staff Road bungalow occurred for two main reasons: Atishi the allotment had been cancelled. India's GDP growth to be **slowest since Pandemic**

Tndia's economic growth rate is estimated to slip to a fourvear low of 6.4 per cent in 2024-25, mainly on account of poor showing by the manufacturing and services sector, according to government data released on Tuesday.

The gross domestic product (GDP) rate of 6.4 per cent will be the lowest since the Covid year (2020-21) when the country witnessed a negative growth of 5.8 per cent. It was 9.7 per cent in 2021-22; 7 per cent in 2022-23; and 8.2 per cent in the last fiscal ended March 2024.

The first advance estimates of National Income for 2024-25 released by the National Statistics Office (NSO) is lower than the 6.6 per cent projected by the Reserve Bank in December 2024. It is also a tad lower than the finance ministry's initial projection of 6.5-7 per cent. The advance estimates will be used in preparation for the Union Budget to be presented by Finance Minister Nirmala Sitharaman in the Lok Sabha on February 1. The manufacturing sector

HMPV scare: Health dept awaits Centre guidelines

The Health department is currently awaiting guidelines from the Central government regarding the HMPV (Human Metapneumovirus), which has been causing concern among some people. A senior official clarified that routine surveillance for respiratory illnesses is already being carried out, and further actions will be taken once the official guidelines from the Central

government are received. The official emphasised that HMPV is not a new virus but a routine one that has been circulating since 2001. Cases of HMPV are reported every year as part of the standard monitoring of respiratory viruses, and it is not considered fatal or

alarming.
There is no need for excessive concern as the virus typically results in mild respiratory issues, and it is routinely tested as part of the general surveillance for influenza-like illness

Dr İshwar Gilada, a medical expert, also downplayed the panic surrounding HMPV, explaining that it is a seasonal

regions and typically causes mild symptoms like a cold. A recent study in Gorakhpur in 2024 showed that around 4% of children tested positive for HMPV, but the virus did not lead to any severe outcomes, he noted. He also mentioned that testing for HMPV is expensive and not routinely conducted, as it is not necessary for such a non-fatal virus.

Dr Gilada further noted that individuals with weakened immune systems-such as children, the elderly, or those with chronic conditions like bronchitis or diabetes—should take precautions, but this is applicable for all respiratory viruses. He reassured the public that there is no need for panic, as HMPV does not require hospitalisation and has no specific treatment or vaccination, with subsequent infections typ-

ically being milder.
Meanwhile, Dr Surya Kant, head of the department of res-piratory medicine, KGMU, reassured the public that despite the scare, there is no reason for fear.

"While the scars of the COVID-19 pandemic are still

threat. HMPV, a respiratory virus first discovered in 2001, causes symptoms similar to a common cold or COVID-19, such as cough, fever, nasal congestion, and difficulty breathing. In severe cases, it can lead to bronchitis or pneumonia. The virus primarily affects children under 14, the elderly,

and pregnant women, with cases concentrated in China's

Guangdong province and

northern areas, resembling the

early stages of the COVID-19 pandemic," he explained. Dr Surya Kant said there is no specific vaccine or antiviral treatment for HMPV, but symptoms typically resolve within 2-5 days with rest and fever-reducing medications. Severe cases may require oxy-

gen support. He stressed the importance of vigilance, especially for those with weakened immunity or pre-existing health conditions. He urged the public to avoid spreading unverified information and advised preventive measures like wearing masks, frequent handwashing, and maintaining distance from infected individuals.

Petrol pump salesman abused, threatened

Unidentified youths riding an SUV allegedly threatened a petrol pump salesman with a knife, demanding free fuel, in the PGI police station area. The accused, later identified as Mohit Ranjan, the son of a policeman, has been arrested by the police.

The incident occurred around 10 pm on January 2 in Sector-6A, Vrindavan Yojana. According to Rajesh Kumar, the pump manager and complainant, the accused arrived in a Scorpio accompanied by a friend, Ashok Singh.

Mohit Ranjan allegedly demanded free diesel from the salesman on duty. When the salesman refused, the duo began hurling abuses and making threats from inside the car. Inspector, PGI police station, Ravishankar Tripathi confirmed the arrest, stating that the accused became aggressive when other pump staff intervened. Mohit reportedly parked his vehicle in front of the office, stepped out, and continued to abuse the staff. At one point, he allegedly threatened to slit the salesman's throat with a knife. The complainant also alleged

that the duo had caused trouble

at the petrol station on previous occasions, harassing staff and creating inconvenience for customers. Video footage of the incident has been provided to the police as evidence.

Meanwhile, thieves stole oil

and copper from a heavy transformer placed on a private plot near Bindra Plastic Factory on Kakori Road, under the jurisdiction of Samda police outpost in Kakori. On Tuesday morning, the thieves stole a 250 KVA transformer from a private site under the FCI power substation. The culprits cut the phase of the transformer, located near Mahendra City, and threw it down. After opening it, they made off with around 200 litres of transformer oil and 50 kg of copper. They left the transformer structure behind and fled. The theft was discovered at 7:30 am when consumers reported a power outage, and a lineman, who investigated the issue, confirmed the theft. Junior engineer Nitin Kumar filed a theft complaint.

Prashant Giri, subdivision officer of FCI substation, confirmed that the transformer was located near Rehmankhera feeder. Following the incident, power was restored using a trolley transformer.

Narrow escape for two in road mishap

Lucknow (PNS): Two individuals narrowly escaped injury when a speeding BMW, driven by a man allegedly talking on his mobile phone, rammed into their cars on the Gomti river bridge in Gomti Nagar on the morning of January 4.

The victims, identified as Vimlendra Mohan Mishra from Ayodhya and Mukesh Kumar from Unnao, were driving from Ambedkar Park to Hazratganj, heading towards the 1090 intersection.

While crossing the middle of the Gomti river bridge around 10:20 am, a white BMW car, coming at high speed from the opposite direction, swerved onto their side of the road and collided with both of their vehicles. The BMW first hit Vimlendra's car, causing heavy damage to its right side. Mukesh's car was then pushed forward, crashing into Vimlendra's car and blocking the left side door of Vimlendra's vehicle. The impact caused Vimlendra to become trapped in his car, and the police had to break the window to help him out. The driver of the BMW, later identified as Ratnesh Kumar Dubey, provided his mobile number when ques-tioned. However, he fled the scene shortly after the collision.

Forest officials minimise human interference in attempt to rescue tiger

The Forest department has adjusted its strategy in an effort to trap the tiger in Rehmankhera, which has been causing concern after it strayed from Lakhimpur Kheri into the area. On Tuesday, the department minimised human interference to allow the tiger to return to the carcass of the bait it had killed, which would provide an opportunity to tran-

auillise it. District Forest Officer (DFO), Awadh, Sitanshu Pandey said that the department had set up a watch on the carcass near the 'machans' (raised platforms), with one veterinarian stationed there to monitor the tiger's return. Two other veterinarians were combing the area using elephants, and the locations of the camera traps were adjusted to cover a larger area based on the latest information about the tiger's movements.

The Forest department is using a bait weighing around 80-90 kg, of which the tiger has consumed 3-4 kg. The team is awaiting the tiger's return so they can dart and tranquillise it. Starting the next day, they plan to use a recorded tigress' call to attract the animal's attention. The department believes the tiger may have been frightened off by the presence of elephants during the search, so they are minimis-

ing human interference in the area to create a calm environment for the tiger to return. Pandey noted that the tiger's presence has affected 11 nearby villages, and the police have already held meetings with village leaders to ensure safety measures are in place for the residents. Meanwhile, two additional teams continue tracking the tiger's movements within the forest.

New lease of life for patient with acute liver failure

Lucknow (PNS): Doctors at King George's Medical University (KGMU) saved the life of a 30-year-old male patient suffering from acute liver failure. The patient, who hails from Amethi, had been admitted to a private hospital in Lucknow for 1.5 months before being referred to KGMU due to severe complications.

Dr Zia Arshad, in-charge of KGMU's Trauma Ventilatory Unit (TVU), explained that the patient was dealing with multiple life-threatening issues including hepatic failure, altered consciousness, meningoencephalitis (brain swelling), thrombocytopenia (low platelets), and septic shock, which had led to low blood

pressure. The private hospital had given up on his treatment due to the complexity of his condition, recommending KGMU as the last hope. Upon arrival at KGMU, the patient's condition was critical, and he was admitted to the ICU for intensive

After thorough evaluation, effective treatment was administered, and the patient's condition has steadily improved. The patient is now off the ventilator, his liver function is improving, and his condition is stable.

Educationist alleges ₹1.6cr fraud by woman

Dr SP Singh, an educationist and manager of a chain of private schools, has accused a woman of defrauding him of Rs 1.6 crore in a land sale transaction meant for his school. The woman in question, Bhumika Kakkar, is the owner of a plot of land adjacent to Singh's school in Anand Nagar, located under the jurisdiction of the Alambagh police station. In his complaint, Singh stated that he has been running the school in Anand Nagar (Old Jail Road), Lucknow, since 1985, and has educated thousands of students over the years. The school currently operates across three separate buildings in the

area. Singh explained that a plot of land adjoining the primary branch of the school, measuring 289.219 square metres, was owned by Bhumika Kakkar and her uncle, Vinod Kumar Kakkar. Both individuals proposed to sell the land, and the deal was eventually finalised. On July 25, 2023, Singh made two payments: Rs 1.2 crore was transferred via RTGS to Bhumika Kakkar's account, while the same amount was sent to Vinod Kumar Kakkar. Both land transfers were officially registered on July 26, 2023. Singh further claimed that Bhumika Kakkar registered her portion of the land on July 26, 2023, after receiving an additional payment of Rs 40

lakh through RTGS. The remaining share was registered by Shilpi Kakkar, the second daughter of the late Harish Kakkar, on August 3, 2023, after receiving Rs 40 lakh via RTGS on August 4, 2023.

According to Singh, possession of both plots and the shops sold by Shilpi Kakkar was granted, but Bhumika Kakkar had given an affidavit seeking additional time—1 to 1.5 months—to vacate two shops located on the land. Later, Singh alleged that Bhumika Kakkar refused to vacate the shops, thereby committing fraud. Furthermore, Singh claimed that Bhumika Kakkar had failed to pay the property tax for the land, amounting to Rs 240,370,

which led to the plot being sealed by municipal corporation officials. The seal was only lifted after the school paid the

outstanding tax. Singh also alleged that Bhumika Kakkar had concealed this fact prior to the registration of the land transfer. The Milkipur assembly seat fell vacant following the resigna-tion of Awadhesh Prasad, who was elected MLA from the constituency during the 2022 Uttar Pradesh assembly elec-tions. In 2024, Samajwadi Party leader Akhilesh Yadav fielded Prasad as the Lok Sabha candidate from Faizabad (Ayodhya), where he defeated

BJP's Lallu Singh.
After securing his victory in the
Lok Sabha polls, Prasad
resigned from Milkipur, necessitating this by-election.

Earlier, by-elections to nine assembly seats were held in Uttar Pradesh, where the BJP secured victories on seven seats, while the SP won on two—Karhal and Sisamau. One of the most surprising out-

comes was the BJP's victory in Muslim-dominated Kundarki assembly seat, traditionally considered a stronghold of the Samajwadi Party. BJP candidate Ramveer Singh emerged victorious, breaking years of dominance by the opposition.

The Election Commission delayed the election for the Milkipur seat due to a writ petition filed by former MLA Gorakhnath Baba in the Allahabad High Court. The petition challenged Awadhesh Prasad's victory in the 2022 elections. However, the case has now been withdrawn, paving the way for the by-election.

Leader of the Opposition in the Uttar Pradesh Assembly, Mata Prasad Pandey, also presented a report on the Sambhal violence, alleging that tensions were deliberately escalated over a mosque survey. He accused the BJP of orchestrating the incident, stating that the survey team included BJP members and that the police used disproportionate force.

Instead of using tear gas, they opened fire, attempting to disrupt the communal harmony of the state," he said.

Pandey questioned the need for the survey, pointing to the Places of Worship Act, which prohibits such actions. "This entire incident was part of a government conspiracy," he claimed.

The violence in Sambhal had erupted on November 24 when a team of the Archaeological Survey of India (ASI) visited the Shahi Jama Masjid for the survey. The SP chief also targeted the BJP on issues of corruption and injustice, particularly against the PDA (backward, Dalit, and minority communities). "Even BJP members are accusing each other of corruption. There is internal conflict within their politics in Delhi and Lucknow," he claimed. Commenting on electoral mal-

practice, he alleged that the administration played a role in manipulating elections.
Referring to the by-elections for nine UP assembly seats, he said, "People were not allowed to

vote freely, with police officers stationed at places to stop peo-

Elderly man killed by three sons over property dispute

DDMA issues advisory for Maha Kumbh pilgrims, Kalpvasis

The District Disaster Management Authority (DDMA) has issued an advisory issued for pilgrims in view of Maha Kumbh to be organised in Prayagraj from January 14 to February, 26. During the Maha Kumbh Mela period, crores of devotees will gather in Prayagraj. During it the fair area which is spread over 4,000 hectares on the banks of the Ganga and Yamuna rivers, is sensitive to stampede, fire, drowning, health related problems etc.

In view of Maha Kumbh, an advisory has been prepared by the DDMA for pilgrims and Kalpvasis. According to it devotees and bathers have been asked to download the Maha Kumbh Mela-2025 mobile app and get information about the fair before reaching Prayagraj. They have also been suggested to ensure accommodation before the journey and keep warm and woollen clothes and food items according to the changing weather. For advance weather information, the website of the Meteorological

Department (IMD) should be checked. For early warning of disaster, download and check the Sachet mobile app. People above 60 years of age or with pre-existing diseases must get their health checked before travelling and travel only after consulting their doctors. People with pre-existing diseases should keep their doctors' prescriptions and contact numbers and the medicines prescribed by the doctord with them. People suffering from heart disease, respiratory disease, dia-betes, high blood pressure etc should take special precautions while traveling. If one is an Ayushman card holder, they should keep it with them so that in case of emergency they can get free treatment under the Ayushman scheme in gov-ernment and private hospitals. According to the advisory, one may have to walk to reach the Sangam area for bathing and darshan in the fair area. For this drinking water/ORS solution should be kept to maintain the level of water in the body. Pregnant women should take special precautions in view of the pos-

sibility of excessive crowd in the fair area. Besides, children, elderly and pregnant women should not be allowed to travel alone. Going into deep water should be avoided. Slippers and shoes are recommended for walking. One should not walk in muddy places. In case of headache, dizziness, ner-vousness, fast heartbeat, vomiting, blueness of hands, feet and lips, fatigue, breathlessness, cough or any other symptoms, one should immediately contact the nearest health centre established in the fair. The devotees have also been advised that those suffering from diabetes, heart disease, respiratory disease should take their medicines regularly on time. They should wash hands with soap before eating and after using the toilet. Besidesm they should take special care in the use of food items during the stay and avoid using contaminated food items in the open. They should not smoke and consume intoxicants. Although spraying and smoke is done to prevent mosquitoes in the fair area, still mosquito repellent should be kept.

Study paves way for developing resilient crop varieties

Tn a significant advancement for modern agriculture, Dr Prashant Singh and his research team have published a landmark study in the prestigious peer-reviewed journal Physiological and Molecular Plant Pathology (PMPP). The study showcases how drought priming (a technique involving controlled water stress) enhances wheat's resistance to spot blotch, a devastating disease caused by the fungus Bipolaris sorokiniana. This innovative approach offers a sustainable solution to some of agriculture's most pressing challenges.

Drought priming operates as an on-demand defense strategy, enabling plants to optimize resources by preparing for future stress while minimizing unnecessary metabolic costs. Notably, Dr Singh's team discovered that the protective establish drought-induced

benefits of drought priming can be passed to subsequent generations, making this technique particularly valuable for long-term crop protection. Progeny of drought-primed wheat exhibited enhanced defenses, including elevated antioxidant activity and increased production of defense enzymes, which were selectively activated during pathogen attacks without impairing normal growth.

Focusing on wheat (Triticum aestivum), the research demonstrated that drought-induced priming not only boosts resistance to Bipolaris sorokiniana, the pathogen responsible for spot blotch disease, but also transmits this resilience to the next generation (G1). This ground-breaking discovery highlights the potential of intergenerational priming as a transformative tool for sustainable agriculture. "Our findings intergenerational priming as a sustainable and chemical-free strategy to protect crops against diseases," Dr Singh explained, adding, "This approach could revolutionise disease management in agriculture, particularly in the face of global climate challenges."

The study paves the way for developing resilient crop varieties capable of thriving under changing environmental con-

ditions. By addressing critical gaps in understanding the metabolic adjustments and regulatory mechanisms underpinning drought priming, this research lays a robust foundation for future innovations in agricul-

tural sustainability.
This remarkable achievement underscores the pivotal role of cutting-edge research in shaping the future of agriculture while reflecting Dr Singh and his team's dedication to tackling global food security challenges.

Additional solicitor general Aishwarya Bhati, representing the Centre, said she would file the written submissions and the government would abide by the apex court's directions. The court underscored the need to pass an interim order in the

The 2021 surrogacy laws set age limits for intended parents and surrogate mothers. According to the law, the intended mother must be between 23 and 50 years of age, and the intended father must



be between 26 and 55 years of

Further, the surrogate mother must be married and between 25 and 35 years of age, having a biological child, and only act as a surrogate once in her lifetime. The laws also provide conditions to regulate surrogacy. The top court had outlined the

CEC defends recent amendment to election rules restricting CCTV footage of polling booths from public inspection allowed for public inspec-PIONEER NEWS SERVICE

Chief Election Commissioner Rajiv Kumar on Tuesday defended the recent amendment to election rules restricting CCTV footage of polling booths from public inspection, saying it is meant to protect voters' privacy and prevent use of data for creating fake narratives.
Based on Election

Commission's recommendation, the government had last month tweaked an election rule to prevent public inspection of certain electronic documents such as CCTV camera footage of polling stations to prevent misuse.

În his first remarks on tweak of Conduct of Election Rules, 1961, Kumar said only sharing of CCTV footage from inside and outside polling booths have been restricted.

Addressing a press conference here to announce the schedule for Delhi Assembly polls, he said such data or footage was banned for public inspection through EC's instructions in

He said certain other documents which are allowed under Rule 93 of the Conduct of Election Rules will continue to be available.

Some documents which are already restricted from sharing are forms filled by poll officials about the name of the voter and the identity shown by them before voting.

Kumar said rules were amended to "protect the identity of the voters as well as their profiling". He said if the footage is made public, the identity of those who voted and those who did not, would be revealed and was violative of privacy norms. If footage of 10.5 lakh polling

stations where suppose polling takes place for 10 hours is given out, it would mean data of one crore hours. "A person will need 3,600 years to go through the recordings if watched for eight hours daily," he said.



"Why does he want it? Let us ask this question from the person who wants it," Kumar said. He said the poll authority has examples to prove that the data would be used for machine learning and using AI to create narratives.

The CEC said even fact checkers would not be able to find out whether the AI-generated videos of polling stations are fake or genuine.

He said things which are to be restricted are yet to be defined or prescribed in the rules. The Union law ministry had amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to restrict the type of

"papers" or documents open to

public inspection. According to Rule 93, all 'papers" related to elections shall be open to public inspection. The amendment inserts "as specified in these rules" after

The law ministry and EC officials separately explained that behind the amendment.

While documents such as nomination forms, appointment of election agents, results and election account statements are mentioned in the Conduct of Election Rules, electronic documents such as CCTV camera footage, web-casting footage and video recording of candidates during the Model Code of Conduct period are not covered.

CCTV coverage, webcasting of polling stations are not carried out under Conduct of Election Rules but are the result of steps taken by the EC to ensure a level playing field," a former EC official explained.

An EC functionary said, There have been instances where such electronic records were sought, citing the rules. The amendment ensures that only papers mentioned in the rules are available for public inspection and any other document which has no reference in the rules is not

tion."

Candidates already have access to all documents and papers, and nothing has been amended in the rules in this regard, the functionary added.

The Punjab and Haryana High Court, in the recent Mahmoud Pracha vs EC case, had directed sharing all documents related to the Haryana Assembly elections, including treating CCTV camera footage as permissible under Rule 93(2), with

Trudeau steps down

Canadian Prime Minister Justin Trudeau resigns ahead of the upcoming elections

anadian Prime Minister Justin Trudeau's announcement of his resignation on January 6, 2025, marks a significant turning point in Canadian politics. Trudeau, who has served as Prime Minister since October 2015, made the decision amidst mounting pressure from his own party and growing challenges to his leadership. Trudeau's decision to step down comes against a backdrop of increasing discontent within the ruling Liberal Party. During his announcement outside Rideau Cottage in Ottawa, Trudeau acknowledged the internal discord that had hindered his leadership. In a strategic move, Trudeau met with Governor General Mary Simon to secure the prorogation of Parliament until March 24, effectively delaying the possibility of a no-confidence vote that was anticipated in the session scheduled to begin on January 27. This decision provides the Liberal Party with a window to elect a new leader and stabilise its position ahead of potential political upheaval. Trudeau's resignation reflects a culmination of political and person-



al challenges. The Liberal Party's diminishing unity became a significant obstacle for Trudeau's leadership. Discontent among MPs and party members had been growing, fueled by concerns over policy decisions, governance style, and declining public support.

After nearly a decade in office, Trudeau's administration faced criticism over issues such as economic management, healthcare and Canada's climate policy. These challenges eroded his public approval, making him a less viable candidate for the next election. By stepping down before the next election, Trudeau's resignation allows the Liberal Party to rejuvenate its leadership and present a fresh face to voters, potentially mitigating elec-

toral risks. Trudeau's departure will have significant political and national implications The resignation sets the stage for a competitive leadership race within the Liberal Party. The choice of the next leader will be critical in determining the party's future direction and its ability to retain power. Trudeau's resignation reshapes Canada's political dynamics. The opposition, particularly the Conservative Party, is likely to leverage this transition period to challenge the Liberals' governance record and push for early elections. Trudeau's tenure, marked by landmark achievements such as legalising cannabis, advancing gender equality, and climate initiatives, will now be evaluated in the context of his departure. His legacy will hinge on whether the Liberal Party can sustain these accomplishments under new leadership. Justin Trudeau's resignation underscores the complexities of long-term political leadership in a rapidly evolving landscape. While his decision to step down reflects personal and political pragmatism, it also signals a pivotal moment for Canadian democracy. The coming months will determine how effectively the Liberal Party navigates this transition and whether Canada's political institutions can maintain stability amid change. Trudeau's departure opens the door to new opportunities and challenges for Canada's political future.

India's Gorkha Brigade: A legacy at crossroads



The iconic Gorkha Brigade faces an uncertain future with the freeze on Nepal domiciled Gorkha recruitment under the Agnipath scheme

he press and media are flooded with stories Domiciled Gorkha soldiers and their imperiled future in the Indian Army under the Agnipath scheme. With the last NDG in India's Gorkha Brigade likely to retire around 2045-50, it is possible two Gorkha soldiers could confront each other in Doklam, or elsewhere along the LAC should NDGs start joining the PLA. Traditionally, they have joined the British Army since the early 19th century, later the Singapore Police and Brunei Army and still later, the French Foreign Legion and the Russian Army (around 15,000 according to Al Jazeera news). Soldiering is in their blood with the first choice always and every time, the British Army has pampered as well as exploited them. On 10 November 2024, Kathmandu Post carried a frontpage picture of impeccably smart Gorkhas at an attestation parade in the UK.

Three brothers in a Nepali family could still be in British, Indian and Nepalese armies in that order of preference. But Britain does not recruit Indian Domiciled Gorkhas. NDGs ceased joining the Indian Army for 5 years rendering hopelessly bleak the future of the Gorkha Brigade and a strategic glue that binds India and Nepal.Last year, in November and December, Indian and Nepalese Army Chiefs who became honorary Generals in each other's army spent a week in the other's country and were made much of. Last week, 1/11 Gorkha Rifles commanded by Col JP Singh went for joint training with the Sri Sri Jung battalion of the Nepal Army at Saljhandi near the border town of Butawal. (With PLA Nepal Army does only platoonlevel joint training restricted to Kathmandu Valley).

No weapons are carried by either contingent as the host country provides them. No two sovereign mies and their Chiefs have such unique rapport. Despite the shared history, geography and historic links between the two countries and their armies, recruitment of NDGs has been frozen since India took the unilateral decision in June 2022 to change



ical decision. QED It is his responsibility to raise the decision-making process to the next level as other Army Chiefs in the past have done in the national interest. During the economic blockade in 2015, Gen Dalbir Singh was able to persuade PM Narendra Modi and FM Sushma Swaraj that prolonging the blockade would adversely affect the livelihood of Indian Army Gorkha ex-servicemen and families of serving soldiers in Nepal which in turn would impact bilateral relations. The blockade was ended but bilateral ties were seriously disturbed. After King Gyanendra conducted the Palace coup in 2004. India decided to stop the supply of lethal armaments to the Nepal Army which was fighting the Maoists.

Then Army Chief, Gen JJ Singh, recommended against it. In a slanging match between MoD and EAM, Prime

Minister Manmohan Singh upheld the embargo. On the other hand, Siachen, Army Chiefs had prevailed in convincing Singh not to budge over any withdrawal from or concessions on Siachen.

In 1986, during the Gorkhaland movement in North Bengal, as a senior Gorkha officer who had been deployed there, I was invited to a meeting by Principal Secretary to PM, Sarla Grewal along with Deputy Chief of Army Staff, Lt Gen Rawat for discussion on the violence and our response.

In the higher direction of war in 1971, PM Indira Gandhi consulted Field Marshal Sam Manekshaw at every stage for planning and conduct of bat-tle. In 1975, then Army Chief, Gen Gopal Bewoor, 11 Gorkha Rifles convinced Mrs Gandhi of the negative impact of stopping the recruitment of NDGs. So this is not the first time that the absurd idea of ending NDG recruitment has come up. But this time government decided on NDGs that CDS accepted..Lt Gen Sanjeev Chauhan is the senior officer Brigade which meets annually in February in a unique assembly of seven Gorkha regiments to discuss professional matters. On recruitment of NDGs, they too are stuck at the Army Chief/CDS level. Two years ago, I wrote a letter

on strategic loss accruing from altered rules of NDG recruitment to the Principal Secretary to the PM, PK Mishra. No acknowledgement nor reply was received. Service Chiefs in the past have been willing and able to advise political authority on military matters. The consultative process has stopped with this government. On December 15, 2024, while inaugurating India's World magazine, Foreign Minister Jaishankar conspicuously omitted to mention national security or the military component of international relations as part of India's foreign policy vision. Answering a question last year on why no NDG recruitment he said foreign policy is determined by India's national interest and not that of any other country, implying Nepal. India's national interests in terms of defence and security are entwined with those of Nepal with whom New Delhi claims a special relationship which Kathmandu mildly reaffirms. It was Modi who said in Nepal's Parliament in 2014 that India has fought no war where Nepalese blood was not shed. and President Gorkha India-Nepal relations are written in blood

Digital shield: Safeguarding children from the digital trap

The Indian government has proposed the Digital Personal Data Protection Rules, 2025 to fortify children's online safety through robust data protection measures

⊣he digital revolution has profoundly trans-formed how we live, learn, and connect. While this transformation offers immense opportunities for growth and development, it also poses significant risks, especially for vulnerable populations such as children. The digital world is fraught with challenges, from exposure to inappropriate content to exploitation through targeted advertising. Recognising the urgent need for robust protections, the Indian government has introduced the Digital Personal Data Protection Rules, 2025, under the Digital Personal Data These rules, still in draft

Protection Act, 2023. form, have the potential to safeguard children from falling into digital traps by establishing a comprehensive framework for responsible data handling. A cornerstone of the draft rules is the requirement for verifiable parental consent before processing children's data. This mandate ensures that entities cannot collect or use data about minors without explicit authorisation from their parents or legal guardians. For

example, creating an account on a social media platform or an online gaming service requires parents to verify their identity and approve the

data processing activities. This provision is vital in reducing the risks posed by predatory targeting, identity theft, and unauthorised data collection. By putting parents in control, the rules prevent businesses from exploiting children's data for financial gain. This safeguard is particularly important in protecting children from behavioural profiling, which can have long-term implications on their psychological develop-

ment and privacy. Educational institutions play a critical role in a child's growth, but they, too, rely heavily on data collection. The draft rules explicitly

address this by restricting they underscore the impordata processing in schools and allied institutions to activities that are essential for educational purposes or the safety of students. For instance, tracking attendance, monitoring behaviour, and ensuring the security of transportation services are permissible, but excessive or irrelevant data collection is prohibited. These safeguards ensure that children's data is not misused or repurposed without clear justification.

The digital world can be a double-edged sword. While it offers educational resources and entertainment, it also exposes children to inappropriate or harmful content. The draft rules mandate that data fiduciaries implement measures to ensure that children cannot access content that negatively affects their well-being. This includes filtering out materials related to violence, explicit content, and other age-inappropriate mate-

Such provisions are critical in protecting the mental and emotional health of children, who are particularly susceptible to the influence of harmful digital stimuli. Moreover,

tance of collaboration between regulators and technology companies to create a safer online environment. Consent managers play a pivotal role in the new framework. As intermediaries, they enable data principals-in this case, parents or guardians—to give, manage, review, and withdraw consent for data processing activities. These managers must ensure that the process is transparent and user-friendly, empowering parents to monitor how their children's data is being

utilised. The draft rules also require consent managers to maintain detailed records of consent given, denied, or withdrawn, enhancing accountability across the board. While the draft rules represent a significant leap forward, their successful implementation hinges on overcoming several challenges. This calls for innovative solutions, such as integrating verified digital IDs like Aadhaar with consent management systems.

Farmers shunning use of nano-urea despite promotion



Despite a strong push from the government and ambitious targets for production and adoption, the fiscal year 2023-24 witnessed a sharp 43 per cent drop in nano-urea sales

ast year, around this time, the Union Minister for Chemicals and Fertilisers Mansukh Mandaviya had said "Consumption of urea this fiscal (read: FY 2023-24) is likely to be 8 percent less than in FY 2022-23 due to the use of its iquid nano variant. Because of this and higher domestic production, import of urea, the soil nutrient that accounts for 70 percent of the fertilizer subsidy bill, declined more than a fifth on year in 2023. Further spread of nano urea consumption and the start of a new large urea plant (Talcher in Odisha) by September 2023 would lead to elimination of imports in two-three years".

Nano-urea is urea in the form of a nanoparticle containing nitrogen particles of 20-50 nanometres (nm) in size. It provides nitrogen or 'N' to plants in liquid form as an alternative to conventional urea which is mostly supplied as prill (it is a small diameter, spherical white solid). The minister's statement pointed towards the commitment of the government to promote the use of nano-urea so that imports of conventional urea are brought down to elim-

However, according to data from the Fertiliser Association of India (FAI) – an umbrella body of the fertilizer industry – the sales of Nano urea plummeted by nearly 43 per cent during FY 2023-24 (this happened after growing by a significant 62 per cent during FY 2022-23). Meanwhile, the total production of Nano urea during FY 2023-24 was 81 per cent less than in the previ-

The manufacturers knew that there wouldn't be much demand for it; so they reduced the output even as its production capacity rose by 59 per cent. Why did the sales of Nano-urea decrease? But, before that, we need to understand why the government is so keen to promote its use.

The beauty of nano-urea lies in its ultra-small size and high surface area (10,000 times over 1 mm urea prill), which enable easy absorption by plant leaves. These particles enter the plant through cuticular pores, or stomata. and then penetrate the cell membranes through endocytosis. Once inside the cell, these release nutrients slowly and ensure full absorption by eliminating waste that normally happens with conventional means. The innovator namely Nano Biotechnology Research Centre (NBRC) of the Indian Farmers Fertiliser Cooperative Limited (IFFCO) claims its efficiency (a measure of how much of the 'N' supplied from it is absorbed by the plant) is over 80 per cent against around 40 per cent for the conventional stuff.

The use of nano-urea also results in higher crop yield by 3-16 per cent when compared to traditional urea. Moreover, unlike the latter which raises environmental concerns including nitrate leaching, global warming, ozone layer depletion, and groundwater pollution, the former causes less soil, water and air pollution. According to a study, two foliar sprays of nano-urea curtailed nitrogen load by 25 per cent, besides reducing the greenhouse gas (GHG) emission from 164.2 to 416.5 kg CO2-eq ha-1 under different crops.

A more startling claim made by IFFCO/NBRC is that a 500-ml bottle of nano-urea is equivalent to a 45-kg bag of conventional

The latter contains 46 percent N nutrient, or 20 kg (45×0.46). In contrast, the former contains 4 per cent N, or 20 grams (500x.04). The equivalence between the two means that urea in nano-form with a mere 20 grams can achieve what conventional urea does with 20 kg - a gap of 1000 times in efficiency.It is this monumental difference in efficiency that also enables the manufacturer to deliver a 500-ml bottle of nano-urea to farmers for Rs 240 without any subsidy sup-

In contrast, the cost of supplying equivalent conventional urea in a 45 kg bag, is over eleven times at around Rs 2650 (while, this figure is for imported urea, even for urea produced domestically, the cost is substantially higher and varies from unit to unit), the Government has to give a subsidy of Rs 2410 to make available to the farmer at the same price of Rs 240. There being 22.22 bags in a ton of urea (1000/45), the subsidy on the import of a ton of conventional urea comes to Rs 53,550 (2410×22.22).

If we were to replace one million tons of imported urea with nanourea which doesn't require any subsidy support, the government would save Rs 53,550 million or Rs 5355 crore. Mandaviya had kept a target of producing about 55 million bottles of nano-urea during FY 2023-24 which replaces 2.5 million tons of conventional urea. This would yield savings of around Rs 13,400 crore

in subsidy. Around 600 cubic metres of nat-

ural gas (NG) is needed to produce a ton of conventional urea. For generating the same effect through the nano-urea - given the efficiency difference of 1000 times, the requirement of NG would be a mere 0.6 cubic meters (600/1000). This would lead to huge savings in the import of gas (currently, India imports one-third of its requirement for domestic urea production). Drastic reduction in load on infrastructure will be a bonus. Imagine the impact of handling, moving, storing and delivering a 500 - ml bottle of nano-urea visà-vis a bag of conventional urea that there was unsold inventory containing 45,000 grams of the

material. The use of nano-urea thus offers unprecedented possibilities in terms of not just a substantial reduction in fertilizer subsidy but also trimming excess consumption of urea thereby reducing the imbalance in fertilizer use improving soil health, and helping achieve the environmentrelated goals. Additional benefits will accrue by way of savings in foreign exchange outgo, and a reduction in the current account deficit.

What explains the setback during FY 2023-24?Reportedly, the industry's argument that the fall in production and sales was due to the launch of new products such as Nano urea plus, with a higher concentration of nitrogen and reduction in sales of earlier variants of Nano urea that had lower nitrogen concentration' is untenable. This is because what-ever the level of 'N' concentration, fundamentally the product

Another explanation is that 'the drop in sales coubecausee fact that farmers had bought large quantities of Nano urea in the previous years' doesn't cut ice. Farmers generally are not prone to stocking fertilizer material as the majority of them just don't have the wherewithal to hold stocks.

A third possibility that lower domestic sales could be due to the export of nano-urea doesn't make sense. For a country that depends heavily on imports and even incurs huge subsidies, why would the government allow exports? The industry, however, concedes with dealers and that might have impacted sales during 2023-24. This shows that even during 2022-23, farmers didn't lift nanourea to the extent revealed by the sales figures of that year. One can't escape inferring that nanourea could be losing charm amongst farmers.

If it is due to factors like their being unable to cope with the rigours of the new technology (spraying it on leaves is more challenging than prill urea) or shortage of skilled labour etc, those can be overcome. But, if it is due to tall claims regarding efficiency or yield going haywire, it is a matter of concern. For instance, a study released by Punjab Agricultural University (PAU) in January 2024 says that the 'use of nano-urea led to decrease in the yield of wheat and rice by 21.6 per cper cent 13 per-cent respectively.

Prashant Kishor's Jansuraj: A new political force or BJP's strategic move in Bihar?

As the 2025 assembly elections approach, the big question remains: Can Kishor truly reshape Bihar's political future, or is his role simply to disrupt opposition unity?

rashant Kishor, a name synonymous with politrical strategy, has made his debut in Bihar politics with the launch of his party, Jansuraj. Drawing an analogy to a potter, Kishor likens his work to shaping the best clay into something meaningful, declaring, "We are bringing forward the best people of society. My role is to make this party win. I am in the role of a sutradhar (narrator); I have announced after the formation of the party that I will not run it. The party people will run the party."

This declaration, however, has done little to quell speculations about his aspirations. Rumors abound that Kishor is vying for the post of Chief Minister, a claim he repeatedly denies. "I am not contest-

Despite his assertions, Kishor's entry into Bihar politics has stirred discussions about the impact of Jansuraj on the state's political landscape, particularly in the context of the 2025 assembly elections.

Political analysts suggest that Kishor, with his background as a strategist for both Prime Minister Narendra Modi and Chief Minister Nitish Kumar, could be a disruptive force. Some even speculate that he might be a BJP-backed "pawn," designed to fragment opposi-tion votes, a claim fueled by his apparent inability to align with the Congress or RJD leadership.

Kishor's criticisms of Nitish Kumar's governance have been particularly sharp. He has lambasted Kumar's leadership style, though his past affiliations with the BJP have also fueled skepticism. Adding to the intrigue, JDU leaders have dismissed Kishor's efforts as insignifi-

JDU, meanwhile, continues to champion causes like the nationwide caste census and the "One Nation, One Election" policy. It also plans to hold a workers' meeting in Nalanda on January 20, 2025, to gauge its position before the elections. JDU's reliance on caste-based politics, particularly its focus on Mahadalits, underscores its strategy for retaining relevance. Recognizing the centrality of

caste and community dynamics in Bihar politics, Kishor has crafted his approach accordingly. His first major move was targeting the Muslim and backward caste vote banks, which collectively account for 53.8 per cent of the electorate. To solidify his position, he announced plans



to field more candidates from Muslim and extremely backward communities in the upcoming elections. The appointment of a Dalit as Jansuraj's first working president further underscored this strategy.

This decision, however, drew criticism, with some perceiving it as an overt counter to JDU's Mahadalit card. Kishor's

emphasis on Dalit representation, though a significant gesture, was met with resistance from sections of the political spectrum. Before launching Jansuraj, Kishor spent two years trav-

eling across Bihar, conducting a padayatra and engaging in public dialogues in villages and towns. His campaign drew heavily from the ideas of Mahatma Gandhi and Rabindranath Tagore, echoing a narrative of grassroots empowerment. However, his advocacy for ending Bihar's liquor prohibition—a policy closely associated with Nitish Kumar's governance—has sparked controversy. Critics argue that this stance contradicts Gandhian principles and exposes Kishor to allegations of opportunism.

Despite the criticisms, Kishor's efforts signal a genuine attempt to address Bihar's long-standing issues. Bihar has long grappled with challenges like unemployment, poor infrastructure, and rising crime. Kishor positions Jansuraj as a platform to tack-le these problems, but whether he can deliver remains to be seen.

Kishor's focus on margin-alised communities, grassroots dialogue, and inclusive leadership sets a distinct tone. However, his political credibility and ability to translate ideas into action will be closely scrutinized. As the assembly elections approach, the political battlefield in Bihar is becoming increasingly dynamic. JDU's focus on its traditional voter

base and initiatives like the caste census may clash directly with Jansuraj's appeal to similar demographics. Meanwhile, speculation about Kishor's BJP connections and his critique of Nitish Kumar suggest that his presence will influence alliances and electoral strategies across the board.

rashant Kishor's entry into Bihar politics marks a significant shift. By forming Jansuraj, he has sought to disrupt the status quo and present a new alternative. However, whether he can truly emerge as a transformative leader or will merely fragment votes remains the critical question.

South Korean agency receives new warrant to detain impeached President Yoon

South Korea's anti-corruption agency said it received a new court warrant on Tuesday to detain impeached President Yoon Suk Yeol after its previous attempt was blocked by the presidential security service last week.

The Corruption Investigation Office for High-Ranking Officials, which plans to question the embattled president on rebellion allegations over his short-lived martial law decree on Dec. 3, didn't immediately confirm how long the warrant would remain valid.

The agency's chief prosecutor, Oh Dong-woon, refused to answer when asked by lawmakers when the warrant would expire, saying such information is sensitive as the agency and execute it.

Detention warrants typically last seven days but can be extended to around 10 days. Oh didn't say when investigators planned to make their next attempt to detain Yoon. The Seoul Western District Court last week had initially issued a warrant to detain Yoon and a separate warrant to search his residence after he repeatedly defied authorities by refusing to appear for question-

ing.
About 150 anti-corruption agency investigators and police officers attempted to detain Yoon on Friday but retreated from his residence in Seoul after a tense standoff with the presidential security service that lasted more than five hours. The investigators did not

make another attempt to detain Yoon and the previous court warrants expired after a week on Monday.

If investigators manage to detain Yoon, they will likely ask a court for permission to make a formal arrest. Otherwise, he will be released after 48 hours. The anti-corruption agency and police have pledged to make a more forceful effort to detain Yoon, which could be a complicated process as long as he remains in his official residence.

The anti-corruption agency is leading a joint investigation with the police and military into Yoon's brief power grab, which included declaring martial law and dispatching troops to surround the National Assembly. Lawmakers who managed to get past the blockhours later.

Yoon's presidential powers were suspended after the oppositiondominated Assembly voted to impeach him on Dec. 14, accusing him of rebellion. The Constitutional Court has started deliberations on whether to formally remove Yoon from office or reinstate him. Members of the presidential security staff were seen

Police have said they are considering "all available options" to bring Yoon into custody and haven't publicly ruled out the possibility of deploying SWAT teams, although it's unclear whether investigators would risk escalating a confrontation with presidential security forces,

who are also armed. Park Jong-joon, chief of the presidential security service, has hit back against criticism that it has become Yoon's private army, saying it has legal obligations to protect the incumbent president. He and his deputy have so far defied summonses by police, who planned to question them over the suspected obstruction of official duty following Friday's events.

In a parliament hearing Tuesday, Oh criticized the country's acting leader,

Deputy Prime Minister Choi Sang-mok, for instructing police to oblige with the presidential security service's request to deploy personnel to Yoon's residence to beef up security ahead of Friday's detention attempt. The police did not carry out Choi's instruction, and Oh said the agency was reviewing whether Choi's actions constituted an obstruction of official duty. The agency has repeatedly called for Choi to instruct the presidential security service to comply with the execution of the detention warrant against Yoon. Choi hasn't commented. Yoon's lawyers argued the detention and search warrants against the president cannot be enforced at his res-

idence due to a law that pro-

search without the consent of the person in charge — which would be Yoon. They also argue the anti-corruption office lacks the legal authority to investigate rebellion charges and delegate police to

Trump renews offer of making Canada 51st state of US

Hours after the resignation of Canadian Prime Minister Justin Trudeau, US Presidentelect Donald Trump on Monday renewed his offer of making Canada the 51st state of the United States. Trudeau, 53, announced to resign Monday as he was forced by his ruling Liberal Party amidst his growing unpopularity. General elections are scheduled this year. The Canadian prime minister said that he would stay on as prime minister till the party elected a new leader. Trump, 78, who never had a good relationship with Trudeau even during his first term from 2017-2021, has been floating the idea of making Canada the 51st state of the United States ever since he met Trudeau after his November 5 electoral victory in Mar-a-Lago. Thereafter, he has been mentioning this on his social media

posts several times. Many people in Canada LOVE being the 51st State. The United States can no longer suffer the massive Trade Deficits and Subsidies that Canada needs to stav afloat. Justin Trudeau knew this, and resigned," Trump said on Truth Social.

"If Canada merged with the US, there would be no Tariffs, taxes would go way down, and they would be TOTALLY SECURE from the threat of the Russian and Chinese Ships that are constantly surrounding them. Together, what a great Nation it would be!!!" said the presidentelect after the resignation of Trudeau on Monday. There has not been much reac-

tion to Trump's proposal from the Canadian side. Trump has threatened to impose 25 per cent tariffs on Canadian imports if Toronto is not able top stop the flow of illicit drugs and illegal migrants from its southern border with the US. Biden 'doing everything possible' to make transition difficult: Trump

US President-elect Donald Trump has accused Joe Biden of making the presidential transition difficult, citing recent executive orders on climate and other official acts being taken by him in his last weeks as president.

Trump, 78, is slated to be sworn in as the 47th President of the United States on January 20. He replaces Biden as the new occupant of the White House, the official residence of the US President.

"Biden is doing everything possible to make the TRANSI-TION as difficult as possible, from Lawfare such as has never been seen before, to costly and ridiculous Executive Orders on the Green New Scam and other money wasting Hoaxes," Trump said in a post on Truth Social. "Fear not, these "Orders" will all be terminated shortly, and we will become a Nation of Common Sense and Strength. MAGA!!!" said the president-

Trump issued the statement shortly before Congress certified his victory in the Electoral College — and after Biden, 82, banned drilling for oil and nat-ural gas off most of America's coastline, with the total area covered by the order greater than the land of Alaska and Texas combined.

Biden announced earlier Monday he would block new drilling off the entire East Coast, as well as California, Oregon and Washington state, and block some drilling off Alaska's coast in portions of the Northern Bering Sea and in the eastern Gulf of Mexico.

Biden made the move just two weeks before Trump, who has promised to promote domestic energy production, is sworn in. Trump vowed to undo Biden's recent executive orders, though it's unclear if he would be able

to reverse the decision to block oil drilling, considering he was blocked in 2019 when he tried to reinstate drilling in areas blocked off by former President Barack Obama.

Despite Trump's assertion that Biden's White House has not been helpful during the transi-tion, his incoming chief of staff Susie Wiles has said otherwise. She told in an interview published Monday the White House has been helpful during the transition process.

White House chief of staff leff Zients has been very helpful. He has made great suggestions, helped make sure we stay on time with required functions, helped us navigate the labyrinth that is the Executive Office of the President, and been very professional," she said.

'He introduced me to the 'former chief of staff club' and even hosted a dinner (for Wiles and the former chiefs) at his beautiful home," Wiles added.

Trump Jr arrives in Greenland

The eldest son of US President-elect Donald Trump arrived in Greenland on Tuesday for a private visit that has heightened speculation that the incoming US administration could seek to take control of the Danish territory. Greenland's government said Trump Jr's visit would take place "as a private individual" and not as an official visit and that Greenlandic representatives would not meet with him. China shuts down Mt Everest scenic area after quake

China has closed for tourists the scenic areas of its side of Mt Everest, also known as Mount Qomolangma, follow-6.8-magnitude earth quake that jolted Dingri County in the Tibet Autonomous Region on Tuesday.

Dingri is home to the base camp of the world's highest peak.

According to local authorities, the staff and tourists were in safe condition after the quake, which hit the region at 9:05 am Tuesday (Beijing Time).

The hotel buildings and surrounding areas in the scenic area have remained intact, state-run Xinhua news agency reported, citing the Dingri Culture and Tourism Bureau. However, the Qomolangma Station for Atmospheric and Environmental Research of the Chinese Academy of Sciences, located in Dingri, is experiencing a power outage. Despite this, the facilities have remained in good condition. Located at the China-Nepal border, Mount Qomolangma reaches an altitude of more than 8,840 metres, with its northern section located in Tibet referred to as Xizang by

Singapore passes law to protect scam victims

Singapore on Tuesday passed a new law providing the police with powers to order banks to restrict the banking transactions of potential scam victims.

Singapore, said Minister of State for Home Affairs and Social and Family Development Sun Xueling as she tabled the Bill for a second reading in Parliament. "This Bill, passed unan-

imously, allows the police to act decisively and close a gap in our arsenal against scammers." Channel News Asia quoted the minister as saying in the

The Bill will allow specified officers, including those from the police and Commercial Affairs Department, to issue restriction orders to banks if there is reasonable belief that account holders will be making transfers to scammers. These restriction orders will suspend money transfers, the use of ATM facilities and all credit facilities, although individuals will still be provided access to their monies for daily living expenses. "The intent is to buy the police more time to engage and convince the individual that he is being scammed, including through enlisting the help of his family members," Sun

She added that the restriction orders

would involve the seven Domestic Systemically Important Banks (DSIBs) - DBS, OCBC, UOB, Citibank, HSBC, Maybank and Standard Chartered Bank — which account for the vast majority The Protection from Scams Bill comes of consumer bank accounts in as scams remain a "grave concern" in Singapore. The orders can also be

issued to non-DSIB banks if there is reason to believe that victims will make transfers to scammers. Sun said the Ministry of

Home Affairs (MHA) is "mindful of the need to strike a balance between protecting an individual from further harm and

not unduly inconveniencing him". Several safeguards are in place, such as requiring restriction orders be issued only "as a last resort if all other efforts to convince the individual have failed". Individuals can also appeal to the Commissioner of Police against the restriction orders - a process that MHA will ensure is expeditious, Sun added. The Bill will limit the duration of a restriction order to "a maximum of 30 days at the outset". Each order may be extended up to five times if the officer

deems it necessary.
After five extensions, the restriction order "must lapse ... even if the victim is still at risk of transferring more money to the scammer," said Sun.

Planned trip to Kyiv by Trump's Ukraine envoy unlikely

n upcoming trip to Kyiv by US President-elect An upcoming up to 15/10 of 2011 Russia has been cancelled but will be rescheduled, Ukrainian Foreign Minister Andrii Sybiha said Tuesday. The planned meetings between Keith Kellogg, a highly decorated retired three-star general who has long been Trump's top adviser on defence issues, and Ukrainian officials are "extremely important," Sybiha told reporters in the Ukrainian capital.

"I am confident that this meeting will take place in its own time," he said during a news conference with his visiting Icelandic counterpart. "We are in contact to clearly define the timeline for its organisation and to ensure that the meeting is as meaningful as possible."

Trump's arrival in the White House on January 20 injects another measure of uncertainty into how the almost 3-year-old war might unfold and whether it can end in the foreseeable future.

Ukraine, up against a larger enemy, Russia, relies on Western — and especially US — military backing to keep fighting. But Trump has criticised the billions of dollars the Biden administration has spent on Ukraine. He has also said he could end the war in 24 hours, though he hasn't elaborated on how he might do that. Ukrainian officials are eager to sway Trump on sticking with Ukraine. President Volodymyr Zelenskyy has praised Trump's "strength" and said the American president's "unpredictability" could work in Ukraine's fayour. Ukrainians have expressed hope tinged with pragmatism about Trump's election victory last November. The war is draining the resources of both sides, though military analysts say the conflict is less sustainable for smaller Ukraine, and the war's recent trajectory has not been in its favour.

Seattle police officer who fatally struck Jaahnavi Kandula sacked ing a sense of closure and jus-

In a significant development, a Seattle police officer who killed Indian student Jaahnavi Kandula in January 2023 when the patrol vehicle he was driving struck her, has been fired from the police department, officials said.

Kandula, 23, from Andhra Pradesh, was struck by a police vehicle driven by Officer Kevin Dave when she was crossing a street in Seattle on January 23, 2023. He was driving 74 mph (more than 119 km/h) on the way to a report of a drug overdose call.

Kandula was thrown 100 feet when she was struck by the speeding police patrol vehicle. According to a report in The Seattle Times on Monday, Interim Seattle Police Chief Sue Rahr said that she had fired Dave from the Seattle Police Department.

The report, citing an email sent by Rahr to employees, said she fired Dave on Monday after the Seattle Office of Police Accountability found he had violated four department poli-

"I believe the officer did not intend to hurt anyone that night and that he was trying to get to a possible overdose vic-



Rahr said

"However, I cannot accept the tragic consequences of his dan-gerous driving. His positive intent does not mitigate the poor decision that caused the loss of human life and brought discredit to the Seattle Police Department," according to the Seattle Times report.

It added that the policies Dave failed to follow "include using emergency lights for an emergency response and being responsible for safely operating a patrol vehicle", according to the copy of Rahr's email.

Jimmy Carter to be honoured in Washington, city where he remained outsider

Nearly 44 years after Jimmy Carter left the nation's capital in humbling defeat, the 39th president returns to Washington for three days of state funeral rites starting on Tuesday.

Carter's remains, which have been lying in repose at the Carter Presidential Centre since Saturday, will leave the Atlanta campus Tuesday morning, accompanied by his children and extended family. Special Air Mission 39 will depart Dobbins Air Reserve Base north of Atlanta and arrive at Joint Base Andrews in Maryland, with a motorcade into Washington and the Capitol, where members of Congress will pay their respects at an afternoon service.

Carter, who died December 29 at the age of 100, will then lie in state Tuesday night and again Wednesday. He then receives a state funeral Thursday at Washington National Cathedral. President Joe Biden will deliver a eulogy.

There will be the familiar rituals that follow a president's death — the Air Force ride back to the Beltway, a military honour guard carrying a flag-draped casket up the Capitol steps, the Lincoln catafalque in the Rotunda. There also will be symbolism unique to Carter: His hearse will stop at the US Navy Memorial, where his remains will be transferred to a horse-drawn caisson for rest of his trip to the Capitol.

The location nods to Carter's place as the lone US Naval Academy graduate to become commander in chief.

All of the pomp will carry some irony for the Democrat who went from his family peanut warehouse to the Governor's Mansion and eventually the White House. Carter won the presidency as the smiling Baptist and technocratic engineer

who promised to change the ways of Washington — and eschewed many of those unwritten rules ways when he got there.

"Jimmy Carter was always an outsider," said biographer Jonathan Alter, explaining how Carter capitalised on the fallout of the Vietnam War and Watergate scandal that toppled Richard Nixon. "The country was thirsting for moral renewal and for Carter, as this genuinely religious figure, to come in and clean things

From 1977 to 1981, Carter was the city's highest-ranking resident. But he never mastered it.

"He could be prickly and a not very appealing personality" in a town that thrives on relationships, Alter said, describing a president who struggled with schmoozing lawmakers and reporters.

The gatekeepers of Washington society never embraced Jimmy and Rosalynn Carter, either, not quite

Early in Carter's presidency, Washington Post society columnist Sally Quinn tagged the Carters and their West Wing as "an alien tribe," incapable of "playing the game." An elite Georgetown hostess herself, Quinn nodded to Washington's "frivolity" but nonetheless mocked "the Carter people" as "not, in fact, comfortable in limousines, yachts, or in elegant salons, in black tie" or with "place cards, servants, six courses, different forks, three wines ... and after-dinner mingling."

He endured a rocky four years that left him without enough friends in the town's power circles and, ultimately, across an electorate that delivered nearly 500 Electoral College votes to Ronald Reagan in the 1980 election.

Long after leaving office, Carter still bemoaned a political cartoon published around his inauguration that depicted his family approaching the White House with his mother, "Miss Lillian," chewing on a hayseed. Carter often flouted the ceremoni-

al trappings that have been on display in Georgia and will continue in Washington.

As president, he wanted to keep the Marine Band from playing "Hail to the Chief," thinking it elevated the president too much. His advisers convinced him to accept it as part of the job. And the song played Saturday as he arrived at his presidential centre after a motorcade through his hometown of Plains and

past his boyhood farm. He also never used his full name, James Earl Carter Jr, even taking the oath of office. His full name was printed on memorial cards given to all mourners who paid their respects in Atlanta.

He once addressed the nation from the White House residence wearing a cardigan, now on display at his museum and library. His remains now at rest in a wooden casket being carried and guarded by military pallbearers in their impeccable dress

uniforms.

"He was a simple man in so many ways," said Brad Webb, an Army veteran who came to honour the former president at his library, which is on the same campus as The Carter Centre, where the former president and first lady based their decades of advocacy for democracy, public health and human rights in the developing world.
"He was also a complicated man,

who took his defeat and did so much good in the world," said Webb, who voted for Republican Gerald Ford in 1976 and Reagan in 1980. "And, looking back, some of the things in his presidency — the inflation, the Iran hostages, the energy crisis — were really things that no president can actually control. We get to look back with some perspective and understand that he was an excellent former president but also had a presidency we can appreciate more than we did as it was happening."

Rupee falls seven paise against USD

The rupee fell 5 paise to **I** settle 85.73 at (provisional) against the US dollar on Tuesday, as higher crude oil prices and outflow of foreign funds continued to weigh on the local unit.

Forex traders said the rupee pared some of its intraday losses as the American currency retreated from its elevated levels. Moreover, the recovery in the domestic equity market also aided sentiments.

At the interbank foreign exchange, the rupee opened at 85.77, touched the day's peak of 85.65 and hit an intraday low of 85.80 against the greenback. The unit settled at 85.73 (provisional) against the dollar, registering a fall of 5 paise from its previous

On Monday, the rupee settled 11 paise higher at 85.68 against the dollar. During intraday, the unit had hit the lowest-ever level of 85.84 against the American currency.

"We expect the rupee to trade with a negative bias on FII outflows and underlying strength in the US dollar amid expectations of no rate cut by Fed in January. However, any extended recovery in the domestic markets may support rupee at lower levels.

"Traders may take cues from ISM services PMI, trade balance and IOLTS jobs data from the US. USD-INR spot price is expected to trade in a range of Rs 85.50 to Rs 85.90," Anuj Choudhary, Research Analyst at Mirae Asset Sharekhan, said.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.30 per cent lower at 107.92, amid disappointing US services PMI and factory orders data, while President-elect Donal Trump dismissed rumours over stringent trade tariffs.

Novak Djokovic said he still feels "a bit of trauma" when he travels to Australia, stemming from his deportation in 2022 because he was not vaccinated against COVID-19.

"The last couple of times that I landed in Australia, to go through passport control and immigration, I had a bit of trauma from three years ago," Djokovic said in an interview with Melbourne's Herald Sun newspaper published Monday, ahead of the Australian Open. "And some traces still stay there when I'm passing passport control, just checking out if someone from immigration zone approaching."

Djokovic, who has won 10 of his 24 Grand Slam Grand Slam championships at Melbourne Park, continued: "The person checking my passport — are to an immigration hotel. hey going to take me, detain A judge later reinstated the me again or let me go? I must visa and ordered Djokovic's



admit I have that feeling." Back in 2022, Djokovic sought, and initially obtained, an exemption that would allow him into the Australian Open — and the country — even though there were strict rules requiring shots to protect against the coronavirus. But after his flight landed, he was detained at the airport, his visa was canceled and he was sent

"I just hope to, before I retire, get at least one more title there," said the 37-year-old Djokovic, whose only triumph at a tournament in 2024 was his singles gold medal for Serbia at the Paris Olympics in

August.

Djokovic opened 2025 at the Brisbane International last week, losing in the quarterfinals to Reilly Opelka.

China's most successful club folds under weight of debts

¬uangzhou FC, the most Successful soccer club in Chinese history, disbanded on Monday due to crippling debts.

The club, formerly known as Guangzhou Evergrande, has been unable to meet the Chinese Football Association's financial entry requirements needed to compete in the 2025 domestic season.

"Due to heavy financial burdens resulted from previous seasons, the club could not pay off all the debt by the deadline," Guangzhou said in a statement. "We express our sincere apology to all the supporters from across the community and we appreciate the understanding and forgiveness of all the fans very much."

After being taken over by property developer Evergrande in 2010, the club started the spending spree in China that made headlines around the world.

Helped by players such as international



Paulinho and elite coaches such as Marcello Lippi of Italy and Brazil's Luiz Felipe Scolari, Guangzhou won eight Chinese Super League titles from 2011 to 2019. The team triumphed also won the Asian Champions League in 2013 and 2015.

Other clubs followed with world-famous stars such as Carlos Tevez, Nicolas Anelka, Oscar, Didier Drogba and others heading to China.

In 2021 however, Evergrande reported debts of over \$300 billion and, as key players left the club due to financial issues, it was relegated to China's

second tier in 2022. On the same day, Chinese Super League club Cangzhou Mighty Lions also announced its disbandment, as did third

tier club Hunan Billows. "Only by setting sights on the long term, keeping the financial operation in a healthy status and investing in youth with patience should clubs build a robust future," the Chinese Football Association said in a statement, adding that 49 teams had been deemed

Whitewash at home bigger failure than BGT loss: Yuvraj

World former Cup-winning W former all-rounder Yuvraj Singh has said that being whitewashed at home by New Zealand was a bigger low for Team India than the loss of Border-Gavaskar Trophy but refused to join the chorus of criticism against embattled veterans Rohit Sharma and Virat Kohli.

India have endured a difficult last few months in the fiveday format, going down 0-3 They are one of the greatest to an under-strength New cricketers of this time. Okay, Zealand at home, which was a first in the team's Test history. This was followed by a 1-3 drubbing by Australia in the away edition of the Border Gavaskar series.

Both the debacles have been largely attributed to the team's batting frailties, especially those of Rohit and Kohli.

"According to me, losing (to) New Zealand is more hurting (sic). Because they are losing 3-0 at home. You know, that is not acceptable. This (losing BGT) is still acceptable because you have won two times in Australia. And this time you lost," Yuvraj told 'PTI Videos' in an interview here.

"Australia has been a dominant side for the last so many years, that is my thought," the 43-year-old hero of India's 2011 World Cup triumph said.

While Kohli managed at least a hundred during the series despite continuing to be dismissed whenever he was

baited outside the off stump, Rohit was worse with a tally of just 31 runs and had to drop himself from the final

But Yuvraj said it is unfair to lambast the duo given their

past achievements.
"We are talking about our greats, Virat Kohli and Rohit Sharma, we are saying very bad things about them," he

Fiery South African pacer Kagiso Rabada, no stranger to beating Australia, believes the prospect of facing them in the World Test Championship final at Lord's in June has already sparked anticipation and motivation in his side

Reigning champions Australia secured their spot in the WTC final with a six-wicket victory over India in the fifth and final Test of the Border-

Gavaskar Trophy in Sydney, clinching the series 3-1.
South Africa were the first team to qualify after defeating Pakistan by 10 wickets in the Boxing Day Test.

"It's actually quite some distance away, but a big occasion like the World Test Championship final gets you up for it," Rabada said on up for it," Rabada said on SuperSport after taking a sixwicket haul in his side's 10-wicket, second-Test demolition of Pakistan that completed a 2-0 sweep.

Up against defending champions Australia, the Proteas will start as underdogs but Rabada,



who twice played a big part in winning winning series against Australia in 2016-17 and 2017-18, is confident of

pulling off an upset. "South Africa versus Australia has always been an intense rivalry, because we play cricket quite similar. We play hard -- and they're going to come hard at us, and we know that. But we also know how to beat them," he said.

Test match, possibly in the UK, against Ireland or Afghanistan, whoever is free. England urged to boycott Champions Trophy game against Afghanistan by UK politicians

AP LONDON

England should refuse to play the Champions Trophy cricket match against Afghanistan next month according to a letter signed by more than 160 U.K. Politicians.

The politicians want the England and Wales Cricket Board to take a stand against the Taliban regime's assault on women's rights and boycott the men's one-day international against Lahore, Afghanistan in Pakistan, on Feb. 26.

Female participation in sport has effectively been outlawed since the Taliban's return to power in 2021, a move that puts the Afghanistan Cricket Board in contravention of International Cricket Council rules.

Because Afghanistan's men are still allowed to compete by the ICC, a strongly worded letter has emerged from the U.K. Parliament pleading for the ECB to make its own moral objection.

Penned by Labour MP Tonia Antoniazzi and signed by a cross-party group from the House of Commons and House of Lords including Nigel Farage and Jeremy Corbyn, it raises the dystopia" "insiḋious unfolding in Afghanistan.

Gould issued a swift response, reaffirming ECB principles while suggesting it favoured a uniform approach from all member nations rather than acting alone.
"The ECB strongly condemns

the treatment of women and girls in Afghanistan under the Taliban regime," he said.
"The ICC constitution

mandates that all member nations are committed to the growth and development of women's cricket. In line with this commitment, the ECB has maintained its position of not scheduling any bilateral cricket matches against Afghanistan.

"A coordinated, ICC-wide approach would significantly more impactful than unilateral actions by individual members. "We understand the concerns

raised by those who believe that a boycott of men's cricket could inadvertently support the Taliban's efforts to suppress freedoms and isolate Afghan society. It's crucial to recognise the importance of cricket as a source of hope and positivity for many Afghans, including those displaced from the country."
