differences within the INDIA bloc, Jammu and Kashmir Chief Minister Omar Abdullah Thursday dropped clear hints suggesting he was also on the verge of splitting ties with the opposition plank. Omar also demanded the INDIA bloc should be disbanded as the opposition parties were not on the same page in the run-up to the Delhi polls. Acerbic observations made by

Omar, a close friend of Rahul Gandhi, have once again sparked speculation over the future of the Congress party in the INDIA bloc.
While both AAP and the

Congress are part of the INDIA bloc, the parties are contested the Delhi polls separately.

Mamta Baneriee-led Trinamool Congress along with Uddhav Thackeray's Shiv Sena (UBT) and Akhilesh Yadav's Samajwadi Party (SP) have already announced their support to the Aam Aadmi Party in the Delhi elections leaving Congress party stranded in the multicornered poll battle.

The subtle timing of Abdullah's remark, a day after Rashtriya Janata Dal (RJD) leader Tejashwi Yadav said the INDIA bloc had lost its significance and was formed specifically for the Lok Sabha polls, has also raised many evebrows in the power corridors.

"INDIA bloc was formed just for the Lok Sabha elections and to stop the victory march of the BJP. It has no significance now. The between the bickering



Congress and the AAP is not alliance was only for the unexpected," the former Bihar Deputy Chief Minister said. Reacting to Abdullah's remark, Congress MP Manickam Tagore said the opinion of INDIA bloc allies was not binding on the party. "INDIA bloc allies will not decide what the Congress wants to do in Delhi," he said. Abdullah, whose National Conference is part of the INDIA bloc, Thursday said "It

is unfortunate that no meeting of the INDIA bloc has taken place. Who will lead? What will be the agenda? How will the alliance move forward? There is no discussion on these issues. There is no clarity on whether we will remain united or not". "After the Assembly elections in Delhi, they (INDIA Bloc) should call all the alliance

## **Indian passport ranking slips**

Even as outbound travel from India continues to grow rapidly and a growing number of destinations try to Indian tourists. obtaining a visa for travel has become harder for Indian travelers, the global ranking of Indian passport dropped five spots to 85th in Henley Passport Index 2025 even as Singapore reclaimed the top spot and Japan takes the second position. According to

statement, as per the Henley Passport Index 2025, India Continued on page 8 has slipped from 80th rank in



2024 to 85th in 2025. An Indian national can travel to 57 visa-free destinations around the world, it adds. The index is considered the standard reference tool for global citizens and sovereign states when assessing where a passport ranks on the global mobility spectrum, the

Henley & Partners said. As per the index for 2025, India per the index for 2025, India stands at 85th while the ranking of Pakistan and Bangladesh stood at 103rd (101st in 2024) and 100th (97th in 2024), respectively. According to a data chart available on the firm's website for the range of years website, for the range of years from 2006-2025, India's rank was the lowest at 90th in 2021, while its best score was in 2006 when the country was ranked 71st.According to the passport index, the ranking of Pakistan and Bangladesh stood at 103rd (101st in 2024) and 100th (97th in 2024), respectively.

 $R^{ising \ air \ pollution \ level \ has}_{once \ again \ forced \ the}$  authorities to impose vehicle ban on BS 3 petrol and BS 4 diesel cars as the Commission for Air Quality Management (CAQM) for Delhi and its adjoining area has imposed the Stage-III ('Severe' Air Quality) measures under the Graded Response Action Plan (GRAP) for Delhi-NCR with immediate effect. The stage 3 also bans the entry of nonessential BS 4 diesel trucks into Delhi. The restrictions are not applicable for commercial vehicles involved in essential services "Persons with Disabilities shall be permitted to ply BS - III Petrol / BS - IV Diesel LMVs, provided that these are specifically adopted for them and are run only for their personal use," the CAQM said in a statement. GRAP Stage 3, which was revoked on Sunday, entails a ban on non-essential construction work.

#### Naidu visits Tirupati stampede victims

Andhra Pradesh Chief Minister N Chandrababu Naidu on Thursday visited the injured undergoing treatment in a hospital here following a stampede that left six people dead. Six devotees died and nearly 40 more were injured in the stampede at Bairagi Patteda near MGM School in Tirupati on Wednesday night as hundreds of them jostled for tickets for Vaikunta Dwara Darshanam at Lord Venkateswara Swamy temple on Tirumala Hills.

Hundreds of devotees turned up from across the country for the 10-day Vaikunta Dwara Darshanam commencing from January 10. Earlier, Naidu visited the accident site where the stampede claimed six lives

## Congress still relevant in Delhi: Sandeep Dikshit

ongress candidate from the New Delhi assembly constituency and two-time East Delhi MP, Sandeep Dikshit, has accused the AAP of siphoning off Congress votes in other states, at a time when the ruling party has serious allegation made against him and his party for being in cahoots with BJP while dismissing AAP's claim of Centre hindering the Delhi government

functioning.
The son of former Chief
Minister Sheila Dikshit is a widely known critique of AAP chief Arvind Kejriwal, one of the reasons he stated for pitting him against Kejriwal in the upcoming elections. While the AAP has made several allegations against Dikshit and Congress for being hands in gloves with the BJP, Dikshit, in an interview with The Pioneer, shrugged them off claiming that the BJP is picking his criticisms rather than the other way around.

"BJP is repeating what I am saying. They have never attacked Kejriwal on factual information. I have done that and I think it's good whoever is picking that up. Secondly, there is a critique and a criticism of AAP, which is not party-specific. Criticism is opposition-specific," he said.
"If Yamuna is dirty, do you



else about Yamuna and us to say something else? We are in the opposition, we will attack you for all the things that you have not done. When they were in the opposition, AAP and BJP both called us corrupt in 2012-13. We could very easily say that you are saying exactly what BJP was saying. The role of the opposition is to criticize the government wherever it finds valid criticism," he said.

He further raised questions on AAP fighting elections outside Delhi and claimed that they cut Congress votes to help the BJP. "They are really somebody who helps BJP win different elections and then they attack me," Dikshit alleged.

Claiming that the AAP is afraid of Congress fighting the elections, he asked why the AAP is scared of him or AICC treasurer Ajay Maken and injured many.

"If Yamuna is dirty, do you when they say that Congress is not relevant in Delhi.

"Their problem is that they are finding that the Congress is fighting full throttle and we are going to damage the prospects of both AAP and BJP very severely," Dikshit asserted.

The senior Congress leader also asked for evidence from the ruling party for their allegations against the Central government for stopping their work. Remembering his mother's time, he said that the delay is obvious in Delhi where files have to be delivered to the Lieutenant Governor (LG) first for approval. However, he said that it is a matter of delay rather than denial.

He claimed that the BJP has stopped the AAP from working where they believe they are indulging in corruption. "Otherwise, where is it that you've been stopped? Files will get delayed in Delhi because, unlike other states, where the Chief

Minister signs a file and it becomes policy, in Delhi's case, in many of the subjects, files have to go to the LG level," Dikshit added. While the AAP's narrative is

centered around 'Phir layenge Keiriwal' (We will bring Kejriwal again), Kejriwal's rival said that even if he becomes one he will be a Chief Minister 'who will be in jail, or he will 'not do any work' because of the conditions put by the Supreme Court on his bail. "In the remote chance that AAP wins Delhi again, and you get elected as their leader, even if you get sworn in as Chief Minister, you cannot perform. Not even for a single day. This promise of Rs 2,100 he made to the women. In reality, if he signs that file, he'll go to jail. He'll break his bail conditions," the leader said, adding that AAP Convenor resigned from his Chief Ministerial post not as a sacrifice but because he knew that he cannot perform its

duties. The Congress candidate also plans to remind people of the work his mother has done for Delhi and how Kejriwal has not been able to carry it on even in an 'average fashion'. Dikshit also claims that in case of any post-poll alliance, other parties will have to come to them and not the other way around as he is confident of a good performance by the Congress.

## CRPF launches online platform to adopt retired K9s for second life

 $T^{\text{he CRPF has launched a first-}}_{\text{ever online service that allows}}$ common people to adopt retired sniffer and assault dogs from the country's largest paramilitary force to give these four-legged soldiers a comfortable second life.

This is probably the first time that any security force has decided to offer their trained dogs for public adoption, as this move was always fraught with the dangers of misuse of these highly-skilled and motivated dogs by anti-national elements.

Till now, the central forces and state police were handing over their retired dogs to registered NGOs or reputed organisations for their care.

More than 30 canines from four combat streams such as explosive

breeds — Belgian Shepherd Malinois, German Shepherd, Labrador and the indigenous Mudhol Hound — can now be adopted through a rigorous process that will be monitored by the CRPF's specialised Dog Breeding and Training School

(DBTS) near Bengaluru.
These canines, aged 8-12 years, have undertaken hundreds of operations in the anti-Naxal, counter-insurgency and counterterrorism theatres across the country, saving lives of numerous troops from improvised explosive devices (IEDs) and deadly ambushes laid by Maoists or terrorists, a senior officer told PTI. Baloo, Sweety, Veeru, Moby, Coco, Stroll and their colleagues have been trained in various sniffer and detection and tracking, infantry

patrol and assault, etc. The officer said the adoption is free and the adopter can check the force's website to gather basic details and pictures of the dogs up for adoption, fill up a form stating their "motivation and intent" for adopting a retired police K9, and state how they plan to engage the canine -- like a companion, guard or a therapy dog — along with details of the proposed accommodation for the adopted

"A compatibility meeting between the adopter and the dog will be organised at a designated camp where the retired canine is housed. We have also got these selected canines groomed by dog behaviour experts so that they can adjust in a homely environment,"



the officer said. A brief profile, picture and citation of these "soldier buddies" have been hosted on the CRPF portal, making it clear that the adopter

shall take care of the "K9 hero with dignity, due diligence and compassion".

The force, as part of this adoption process, will sign a "legally-

binding" agreement with the adopter and will provide a KCI (Kennel Club of India) registration certificate, medical and vaccination records, and other vital documents of these canines. "Initiating public adoption of our retired dogs is an effort to ensure a happy second life for our canine soldiers," CRPF Deputy Inspector General Moses Dhinakaran told

It has been made clear in the terms and conditions of the adoption process that there shall be no abuse or ill-treatment" of the K9 and that they should not be sold, used for any purpose to earn money, or deployed against any

person. The guidelines state that CRPF adopted dogs, including regular communication with their handlers through short videos and live videoconferencing. "The adopter shall give emotional

support if the K9 is found in distress, and extend all therapeutic care as required for a geriatric dog," the guidelines state.

The force hopes that these brave loyal soldiers get a good home and family as it writes about Zina, a female Belgian Shepherd Malinois, how she is "loyal with a balanced temperament, making her an ideal companion for families looking for a protective yet gentle dog".



Ashiyana area of Lucknow allegedly died by suicide on Thursday morning, police said here. Identified as Upendra Kumar Singh (36), the constable was part of the 93rd Battalion of the CRPF.

According to Inspector, Ashiyana, Chhatrapal Singh, the incident occurred at around 8:45 am when Upendra shot himself in the head with his service rifle while on sentry duty at morcha (front) number eight. Colleagues rushed to the spot upon hearing the gun-shot and found him lying in a pool of blood. Upendra was initially taken to Lok Bandhu Hospital by CRPF personnel, where doctors referred him to the KGMU Trauma Centre. However, he succumbed to injuries.

Sources claimed that Upendra was on a video call with his wife, Ruby Singh, when the incident occurred. He had been transferred to Lucknow from the 36th Battalion in Arunachal Pradesh two years ago and had arrived at the 93rd Battalion's Alpha Unit in Para locality two days before the incident.

No suicide note was found at the scene. A forensic team conducted an inspection, and further investigations are underway. The police have informed Upendra's family, who hail from Lakhpurwa

Preliminary investigations suggest no immediate reason for the suicide. Police are awaiting statements from the family and colleagues to determine the

Upendra joined the CRPF in 2010 and was due for a promotion to head constable, with training scheduled in Ajmer. He is survived by wife Ruby and two sons, Rishikesh Kumar Singh (14) and Ujjwal Kumar Singh (11).

A police spokesperson confirmed the incident, stating: "At approximately 8:45 am on January 9, Constable Upendra Kumar Singh (36), posted with the 93rd Battalion CRPF in Ashiyana, shot himself with his service rifle. He was immediately rushed to Lok Bandhu Hospital and later referred to the KGMU Trauma Centre, where he died during treatment.

Senior officers, including the assistant police commissioner (Cantonment) and the Ashiyana station incharge, inspected the scene. The body has been sent for a postmortem and further investigations are underway.

**NSA AGAINST GAJANAND** 

Lucknow police on Wednesday invoked the National Security Act (NSA) 1980 against the main accused, Gajanand Dubey, in the kidnapping and murder case of e-commerce delivery executive Bharat Kumar, which occurred in September 2024.

A statement from the Lucknow police said the action was taken after sufficient evidence was found against Dubey following the filing of charges in court. 'The accused is currently lodged in Barabanki district

jail. In view of the severity of the incident, evidence indicating public order disruption was gathered, and Section 3(2) of the NSA 1980 was approved by the district magistrate of Lucknow. Gajanand was served the detention notice through the jail superintendent on January 8 (Wednesday)," Chinhat SHO Bharat Pathak said. "A copy of the NSA was provided to the jail superintendent," he added.

Adarsh Koshta, the head incharge of the e-commerce company on Satrikh Road, and Bharat's brother Prem Kumar filed a missing report on September 25, 2024 after Bharat disappeared. Investigations later revealed

that Gajanand had ordered mobile phones via the Flipkart app, which were delivered by Bharat to the location specified by the accused. Along with his accomplice, Dubey kidnapped the delivery boy with the intent to rob him, before brutally strangling him with a laptop charger wire in their rented house. Bharat's body was then stuffed into his own delivery bag and dumped in the Indira Canal. An FIR was filed under multiple sections, including kidnapping and murder. The first accused, Akash, was arrested within days of the crime.

## suspected case of **HMPV** in Lucknow

60-year-old woman Aadmitted to Balrampur Hospital on Thursday became the first suspected case of the Human Metapneumovirus (HMPV) in Lucknow.

Director of Balrampur Hospital, Dr Sushil Prakash, said that they have sent the woman's samples to King George's Medical University (KGMU) for testing, and any confirmation of whether the woman has contracted the HMPV virus can only be made once the test results are received. He stated that the woman has no travel history and is a resident of Rajendra Nagar, Mawaiya.

"She was brought to the emergency department of Balrampur Hospital because she was suffering from breath-lessness and also had a cold. She is suffering from diabetes, hypertension, hypothyroidism, kidney disease, and is a previ-ous patient of TB," Dr Prakash

He added that the woman has been admitted to the isolation ward of the hospital. They carried out testing for HMPV because the referral letter from Charak Hospital, from where the woman had been transferred, stated that she was HMPV positive.

the sample to KGMU for confirmation," he added.

KGMU spokesperson Dr Sudhir Singh said that they had received the samples of the woman in question, and the report would be processed within the next 24 hours.

Meanwhile, Chief Medical Officer, Lucknow, Dr NB Singh, said that there had been no reported case of HMPV in the Lucknow district until now.

"If the report from the woman admitted to Balrampur Hospital comes back positive, necessary steps will be taken," he said. He added that there was no need to panic and no need to pay attention to the rumours circulating on social media.

A senior health official mentioned that the director general of Medical Health had already given directions to allocate ten beds in government hospitals for HMPV patients, and all precautions typically followed for such viruses are to be implemented. Experts maintain that there is no need to panic, as the virus is not fatal. Sources, however, said that the case has raised concern, given the large congregation of people expected at Prayagraj for Maha Kumbh from January 13.

She pointed out that foggy conditions were hampering their efforts to rescue the tiger. "The fog persists until noon and is quite dense. With the thermal drones, we can sense human and tiger presence, but we are unable to pinpoint the location of the stray tiger," she said.

She said that the elephants were able to sense the presence of the tiger, and they were relying on them to locate it.

'At one point, we had localised the tiger, but when the elephants moved in so that the big cat could be darted, it was nowhere to be found. The tiger keeps changing its position, and sometimes the strategy we employ doesn't work," she added.

She said they needed to be patient, as in 2012, a tiger was trapped after three months. District Forest Officer (DFO), Awadh, Sitanshu Pandey, said: We are carrying out combing operations in the nearby villages from which we are receiving information. We want the human habitation so that the tiger does not approach these areas," he said.

He mentioned that they had constructed a pit, which is an old mechanism for trapping animals. "The trap was set in a location where frequent movement of the tiger has been detected through the camera

trap," he said. He added that over 50 staff members from the Forest department were working day and night to trap the tiger. He also mentioned that the recording of the sound of a tigress and the urine of a tigress would be used to attract the big cat.

"DFO, Sitapur, who was previously posted at the Pilibhit Tiger Reserve, has also arrived at the site to assist in rescuing the tiger," Pandey said.

## Lock-jawed for 14 years, teen back to normal after complex surgery

rare and complex surgical A procedure at Apollomedics Super Speciality Hospital here brought relief to a patient who had been unable to open his mouth for the past 14 years. Since the age of 5 or 6, Aditya, now 19, from Sant Kabir Nagar in Uttar Pradesh had been suffering from a locked jaw due to a childhood injury.

This condition prevented him from eating solid food or speaking for over a decade, severely affecting his growth and quality of life. Sources in the party disclosed that the RLD has demanded five seats from BJP for the Delhi assembly elections. "If the seats are granted under poll pact, the RLD will field its candidates in alliance. If this does not happen, the party may go solo in the elections. However, the party is thinking of fielding candidates only on some selected seats where its core Jat voters are dominant," the sources said.

RLD national general secretary Anupam Mishra said that the number of Jat voters in Delhi was quite large. "Delhi is a hub of Jat voters as it is close to west UP and they are residing there for decades. They play a decisive role in many assembly constituencies. There are also a lot of voters from UP and Punjab in Delhi. In such a situation, RLD's political reach and strength cannot be ignored. The party will play an

important role in wooing these voters in favour of BJP," Mishra said. Mishra said the RLD had a strong base of its core Jat and Gurjar voters in Delhi assembly constituencies bordering UP and stood a good chance there.

As per a rough estimate, there are 364 villages in Delhi and out of them 225 villages are Jat and Gurjar dominated. They are Mehrauli, Matiyala, Mundawar, Nazafgarh, Nangloi, Bijwasan and Rithala. Only in Najafgarh, the Jat domination is 30 per cent.

RLD national general secretary (organisation) Trilok Tyagi said that the party was planning to contest election in Delhi and the talks on this line were underway.

"Besides RLD, JDU and LJP (Ram Vilas) are also mulling to contest election in Delhi. Right now, it is yet to be decided if the BJP will share seats with us. After the denial for seats, the RLD will decide whether to go solo in Delhi. We have a party unit in Delhi and we have a strong presence of RLD voters in Delhi. Election preparations are being finalised with national and local leaders. It is expected that a positive decision will be taken on this soon," Tyagi said.

#### Cong demands tax relief in Union budget

Lucknow (PNS): Congress on Thursday asked the Central government to give tax relief and remove goods and services tax (GST) from essential household items and health insurance. Making this demand here during a press conference on Thursday afternoon, Congress national spokesperson and president of party's social media and digital platform, Supriya Shrinate, accused the BJP-led government at the Centre of imposing heavy taxes on the common people of the country and demanded relief to their suffering from "Gabbar Singh Tax" and removal of GST from essential household items and health insurance.

Shrinetra said that in a few days the government was going to present its budget, this budget would decide the future of the country.

She alleged that in this "suitboot government", income tax was much higher than corporate tax, meaning, big capitalists were paying less tax than common man.

She said that the Modi government had done this through "Gabbar Singh Tax" which should be equal for the richest and the poorest people of this country. "But this government has not only messed up the GST but the reality is that GST is being forcibly collected on flour, curd, medicine, education and even on selling popcorn and old car; today the tax on the common man is high and the tax on corporate industrialists is low," Shrinate said. She added that on an average, 64 per cent of the GST collection came from the bottom half of the country's population, that is, the bottom 50 per cent and only 3 per cent of GST cames from the top 10 per cent.

## 2 killed in road mishap

### INSV 'Tarini' with two women Navy officers crosses International Date Line

**T**ndian Naval Sailing Vessel (INSV) 'Tarini' carrying two women officers on Thursday crossed the International Date Line (IDL), achieving a significant milestone during the crew's global circumnavigation expedition, officials said.

"As the vessel sailed eastwards, the crew adjusted their clocks to account for the date change, symbolising the blending of two consecutive calendar days," a Navy spokesperson said.

"Tarini successfully crossed the International Date Line (IDL) today at approximately 1130 hours, Indian Standard Time (IST)," he said. This notable achievement marks a

crew's ongoing global circumnavigation expedition, the official added.

'Tarini' is undertaking the global circumnavigation journey under the Navika Śagar Parikrama II, an Indian Navy expedition attempting a double-handed circumnavigation of the earth via the three Great Capes. The boat was flagged off from Goa on October 2, 2024, by Navy chief Admiral Dinesh K Tripathi.

Carrying the two women officers, 'Tarini' had left the Lyttelton Port in New Zealand on Saturday for the longest and the most challenging leg of its expedition.

'Tarini' had reached Lyttelton on December 22, completing the second leg of significant milestone in the the historic circumnavigation

being undertaken by two Indian Navy officers -- Lt Cdr Dilna K and Lt Cdr Roopa A -- symbolising India's growing prowess of maritime explo-

The crew had left the Lyttelton Port for its onward passage -third leg of the expedition --to Port Stanley (Falkland Islands). This is the longest leg of the expedition with a distance of approximately 5,600 nautical miles (about 10,400 km), the official said.

During the stay at Lyttelton, the crew undertook repairs and maintenance of the vessel with particular focus on the next leg where it will cross the South Pacific, pass through the treacherous Drake Passage, before crossing Cape Horn to reach Port Stanley, the spokesperson earlier said.

## Kin of woman who died in child birth allege negligence by hospital

Afamily member of a woman who died on Sunday allegedly that she was expired at the Saksham Health Care hospital due to negligence of the hospital administration.

The deceased's family has also filed a complaint against the hospital administration at the Kherki Daula Police Station for further investigation.

According to police, the husband of the 30-year-old victim a resident of Manesar has alleged that his wife died due to medical negligence. Cops said on Thursday, they

have a received a complaint against Saksham Health Care hospital located in Sector-83 Manesar but they will forward the case for preliminary inquiry to the Gurugram health department to get a nod for going



ahead with their investigation (as is norm for cases against doctors).

According to the complaint, the deceased's woman husband Manoj Yadav admitted his wife Monika Yadav for delivery around 9 am on January 5. Doctor Shikha Parashar at Saksham Health Care hospital perform normal delivery around 2.20 pm. She delivered baby boy on January 5.

"After delivery she was responding well. The doctors suggested us to go home as the medical staff will take care of the patient. At around 6.40 pm, her condition detorated due to bleeding and the doctor failed to control her bleeding and later she died at the hospital," deceased husband Manoj told The Pioneer.

He alleged that the hospital

did not use blood unit despite arranged by the family. 'My wife was in immense pain

and was begging me to save her. I told doctors that she is in pain, but they said this was normal and she will recover soon. Soon after, she lost consciousness. Doctors then put her in an ambulance and asked me to rush to another hospital as the case was beyond their control," the complaint said.

She was expired at the hospital but despite this and to misguide us they shifted my wife to another private hospital, where the hospital management informed us that she was expired hours back," he alleged.

The Doctors had initially said the treatment would cost around Rs 80,000 and has charged Rs 50,000 after the delivery, he said.


Nandy died after a cardiac arrest at his home in south Mumbai. He was 73.

# Awas Yojana on Abbas Ansari's land in Lucknow

The Supreme Court on Thursday ordered status quo on the construction of housing units under the Pradhan Mantri Awas Yojana at a disputed site in Lucknow's Jiamau whose ownership is by the sons of gangster-turned-politician Mukhtar Ansari.

In 2020, the Lucknow Development Authority had bulldozed the bungalow that belonged to Ansari and his sons including Abbas Ansari. The government plans to build flats on the land under the PM Awas

An SC bench of Justices Surya Kant and N Kotiswar Singh took note of submission by senior advocate Kapil Sibaĺ, appearing for Abbas Ansari, that the plea regarding the possession of land was listed before the Division Bench of Allahabad High court repeatedly, but no interim stay was

On October 21 last year, the top court asked the High Court to take up the application for interim stay for hearing as early as possible. When the matter came up for hearing in the SC on Thursday, Sibal informed the bench that despite its order, the case has not been taken for hearing.
"Some High Courts, we don't



know what will happen. Allahabad High Court is one of the high courts which one should be worrisome about," the bench said.

While granting the status quo on construction, the top court bench directed the high court to hear the matter expedi-

"Since we have not issued notice and have also not obtained any report from Registry of the High Court, we are not inclined to express any opinion as to what were the circumstances in which the petitioner's writ petition could not be taken up for hearing by the bench, though it was listed from time to time," the bench observed.

It said that the petitioners have specifically stated that the

authorities have commenced construction at plot No 93 located in Village Jiamau, Lucknow, which they claim to be under their ownership.

If third party rights are created it is likely to cause irreversible loss to the petitioners, the court observed. "We dispose of this application with a direction to the authorities as well as to the petitioners to maintain status quo at the site till the matter is heard by the High Court," it said.

According to Abbas Ansari, his grandfather purchased a share in a plot in Jiamau and the deed was registered on March 9, 2004. The said property was allegedly gifted by him to his wife Rabia Begum, who then bequeathed the same through a registered will dated June 28,

2017 to the petitioner and his brother.

The plea said that the Sub-Divisional Magistrate, Dalibagh, Lucknow allegedly passed an ex parte (in their absence) order on August 14, 2020 declaring the plot a government property.

Thereafter, the petitioner and in August 2023.

Abbas Ansari then filed a petition in 2023 before the Lucknow bench of the Allahabad High Court. Some other co-owners of the plot, who were also affected by the SDMs order, also approached the High Court and the matter was listed before a division

When Abbas Ansari's writ petition came up for hearing before the single judge on January 8, 2024, he ordered it to be listed along with other matters so as to avoid conflicting orders. Abbas Ansari contended that

his writ petition has been listed before the division bench repeatedly, but no interim stay has been passed in their favour, as was done by the division bench in the case of other affected persons.

"Resultantly, the authorities, after taking physical possession of the petitioner's plot, have started construction of some dwelling units at the site under the Prima Minister Awas Yojna," the plea said.



## **Breaking ice**

The India-Afghanistan talks reflect India's shift from nonrecognition of the Taliban to a pragmatic approach to engagement

n a significant step towards recalibrating ties, India and the Taliban-led Afghan government held a high-level meeting in Dubai. The dialogue, attended by India's Foreign Secretary Vikram Misri and Afghanistan's Acting Foreign Minister Mawlawi Amir Khan Muttaqi, revolved around enhancing bilateral relations and addressing regional challenges. The talks, focusing on economic, humanitarian, and strategic cooperation, underscore India's pragmatic approach toward engaging with Afghanistan despite the complex political dynamics following the Taliban's return to power in 2021. India's relations with Afghanistan have been historically robust, characterised by cultural and economic collaboration. However, the Taliban's return disrupted bilateral ties, with India maintaining a cautious stance while continuing to provide humanitarian aid. The evolving geopolitical landscape, Pakistan's actions in the region, and Afghanistan's dire humanitarian crisis have necessitated a renewed engagement. The discussions also



gain relevance amidst regional tensions, notably Pakistan's airstrikes in Afghanistan, which New Delhi strongly condemned. This shared concern over Islamabad's destabilising actions further aligns Indian and Afghan interests, fostering mutual coop-

The Dubai meeting covered a wide range of topics. India reaffirmed its commitment to aiding Afghanistan's recovery. It pledged continued support in healthcare, food security, and disaster relief, building on its earlier contributions, such as 50,000 metric tonnes of wheat, medical supplies, and vaccines. Besides, both sides emphasised the strategic impor-

tance of Chabahar Port in Iran as a key trade and humanitarian supply route. The port offers Afghanistan access to global markets, bypassing Pakistan, and could serve as a stabilising economic lifeline for the war-torn country. India has expressed readiness to resume developmental activities, including infrastructure and capacity-building projects. This signals India's willingness to strengthen Afghanistan's socio-economic framework despite challenges posed by the Taliban's governance. The Afghan delegation addressed India's concerns about terrorism and regional stability, assuring cooperation to prevent Afghanistan from becoming a safe haven for anti-India activities. The talks indicate a shift in India's approach. This may encourage other nations to adopt a similar stance, recognising the necessity of dealing with the Afghan government. But the biggest takeaway from this meeting indeed was Strengthening India-Afghanistan ties to counter Pakistan's influence in the region. Islamabad's strained relations with Kabul, exacerbated by recent airstrikes, present an opportunity for New Delhi to assert its role as a reliable partner. Reviving trade and development projects through Chabahar Port could bolster Afghanistan's economy and offer India strategic leverage in Central

Navigating Trump redux: India's tightrope



While Trump's focus on countering China could strengthen Indo-US strategic ties, his erratic temperament and divisive policies present challenges


n India, there is a mix of excitement, tentativeness, and even concern, with the second coming of Donald Trump as the President of the United States. While Trump's excitable temperament is well known, he ought to be served better with hindsight of experience. But he may not. While India will remain resolutely relevant and critical in his foreign policy calculus, the handling of certain issues could test Indian reaction and patience. His inevitable fixation with managing China will necessitate nurturing the strategic 'pivot' of India as a counterbalance, Delhi's deep-rooted equations with countries like Russia or Iran, could earn his ire and vitriol

A lot will depend on 'Team Trump' who will aid and assist Trump as he attempts the shape his poll promises of MAGA i.e., Make America Great Again! However, unlike the first term when he did inherit and heed reputation and professionalism as the criteria for key jobs in the Trump administration (though subsequently, he developed a penchant for 'revolving door' ousters of many), this time the criteria only seem to be 'loyalty' to Trump, personally.

There is a disconcerting and contradictory logic to many recent appointments that begs the question if it indeed will be busiess as usual' – something Delhi had got used to, irrespective of the dispensation in Washington DC. Sadly, that vital presence of 'adults in the room' from the first Trump administration who were able to navigate and manage Trump out of his outlandish and fickle ideas, will not be present anymore. If anything, in a room filled with 'loyalists' (read, obsequious staff), chances that someone will play the 'adult in the room' anymore, will be starkly lesser than before, as there could be competitive grovelling to valourise Trump's ideas, whatever be the portent. How will Trump's purported 'non-interventionist' preferences sit with Sino-wary countries like India, Japan or Australia (the other three from QUAD framework) that are in the direct line of Chinese belligerence and expansionism? Will Trump's 'non-intervention-

ist' instinct embolden Beijing to finally bite the bullet on Taiwan and storm the same, knowing that beyond mouthing Washington DC will not intervene militarily? The picture emerging out of a beleaguered (and potentially isolated) Ukraine does not seem reassuring from a security angle, as the possibility of America pushing its 'allies' under the bus, seems very plausible. Even disconcerting memories of the Summer of 2020 when the Chinese aggression pushed through Indian frontiers, with a seemingly disinterested Trump offering to 'negotiate a deal' instead of adopting a more assertive stance, are still

Indeed, the Americans had expedited the exports of weaponry to Delhi, but all that made imminent commercial sense to the die-hard businessman in Trump. Just how ramrod and unfailing will the Trump support be in meeting any such exigency in the future, is worth considering. Even in bilateral relations, there is a fresh bunch of unrestrained radicals who make up the Trump redux cabinet They may or may not play by the traditional rulebook of diplomacy and could make comments that are unpalatable IN WASHINGTON DC to Indian sensibilities. Delhi will be under immense pres-



amongst this new Trump cabinet are trigger-happy interventionists (e.g., Secretary of State Marco Rubio, Elise Stefanik the Ambassador to UN etc.,) a la neoconservatives whom Trump rubbish repeatedly – how this contradiction will manifest will be interesting. Even on non-security issues like immigration, trade terms, or commitment towards the environmental issues, could be a very rocky ride for Delhi India has made ambitious commitments towards the

global environmental cause, whereas Trump's rhetoric has cockily been, "We're going to drill, baby, drill," and confirmed that, "I will terminate the green new scam". While India isn't on top of its target list on immigrant issues, it will only be a matter of time before the bogey "stealing your jobs" impacts India. Trump will be a mega populist who will dance to the 'redneck' wish list and this will impact relations with the world's largest democracy, a lot more gravely than

other countries. Trump has demonstrated a terrifying ability to shed responsibilities towards his allies (sovereign, coalition, and even personal) and also his moral responsibility by readily abandoning its vital geostrategic (remember stakes Afghanistan, and now Syria) with a thoughtless shrug of the shoulder and "not my problem" approach. This tests the will to invest in a transactional relationship like the one


offered by Trump, as no sup-

port can be construed for

Owing to his polarising politics of identity and blind support for the likes of Benjamin Netanyahu, the narrative emanating from the White House could jeopardise and harm the societal fabric of a diverse country like India that needs to maintain an inclusive outlook. America itself is in for a tumultuous time with the President-designate having promised to close the border with Mexico and launch the largest deportation exercise in US history within hours (not days) of taking over. While Donald Trump's rhetoric is usually more bark than bite, India may find it difficult to accommodate his provocative talk and tempera-

#### **INDIA'S GDP GAP WITH CHINA WIDENS** Madam — An analysis of the economies

done by a start-up highlights the pressing necessity to boost India's lacklustre growth. In 1980, India's Gross Domestic Product was \$186 billion, close to China's \$303 billion. But, by 2024, India's GDP had grown 21 times to \$3.93 trillion, while China's GDP had surged to \$18.5 trillion-61 times its 1980 level. To put it differently, China's GDP in 2004 was 2.82 times greater than India's. In 2014, it was 5.13 times greater and in 2024, 4.71 times greater. India's GDP surged 2.94 times from \$694 billion to \$2,043 billion between 2004 and 2014, while it grew merely 1.92 times, reaching \$3,930 billion between 2014 and 2024. Had the GDP growth in the decade starting in 2004 persisted in the decade beginning in 2014, the GDP disparity would have further decreased.

The decade before 2004 was a period of consolidation after structural reforms were initiated. India has to rejig its economic strategy to achieve a consistent 9-10 per cent rate of growth. India chose a mixed economic system, which combines the features of both socialist and freemarket economic systems. The recent push towards private investment in government-owned assets has served only as an easy route for crony capitalists to enrich themselves into billionaires. Democratic India can consider a new economic system aimed at fostering faster

However, growth in Southern India, which accounts for about 31 per cent of GDP, has thrived under the current system and can accelerate further with adequate support from the Centre. Northern India needs to explore strategies to bridge the gap with the South. And the ostrich-like attitude and constant denials hinder progress in addressing realities. The nation must embark on a rapid growth path that creates jobs, elevates the living standard of common man and reduces inequality.

#### **TRUMP 2.0: CHALLENGES AND OPPORTUNITIES FOR ASEAN**

With Trump's return, Southeast Asia finds itself bracing for another era of US ambiguity

Ith the return of Donald Trump to the US presidency, Southeast Asia braces for another era of unpredictability in American foreign policy. Southeast Asian nations, while expressing formal congratulations following Trump's victory, are now focusing on how his administration will impact their economies and strategic interests. As the region's governments gear up for a distinctly different governance style than the one under President Joe Biden, the potential for dramatic shifts in trade relations, diplomatic ties and regional stability is palpable. The ten members of the Association of Southeast Asian Nations (ASEAN)—spanning from Indonesia to Myanmar—are acutely aware that Southeast Asia may not be at the top of the new administration's

Trump is a known figure for his transactional and often unpredictable style of diplomacy. ASEAN countries, while understanding the volatility that a Trump administration can bring, remain cautiously optimistic that his return might lead to a return to serious trade talks. Many regional leaders believe that Trump's preference for direct, bilateral negotiations could lead to more favourable deals for specific countries, particularly those that are not bound by multilateral negotiations, like those seen under Biden's tenure. Yet, for many in Southeast Asia, the most pressing concern remains the US-China relationship. Since Trump's first term, ASEAN nations have had to balance their relationships with both China and the US, seeking to maintain economic growth and regional security without angering either side. The dynamic has changed considerably in the



post-pandemic era, as China and ASEAN emerged as each other's largest trade partners. The direction of US-China relations will have profound consequences for Southeast Asia's economic stability and security. Under Trump, this relationship was tense, marked by the trade war and military posturing, and the nomination of hardline China critics, such as Marco Rubio for Secretary of State and Mike Waltz as National Security Advisor, signals that the US will continue to confront China head-on in ways that could disrupt regional dynamics. While many ASEAN leaders are concerned about the economic impact of a hard-line US-China policy, there is also hope that Trump's presidency could bring muchneeded attention back to Southeast Asia's trade and strategic importance. This could be particularly appealing to resource-rich nations like Indonesia and the Philippines, which are in high demand for critical minerals used in electronics and green technologies. On the other hand, a significant worry for ASEAN countries is that they may become collateral damage in the US's efforts to reduce its trade deficit.

Despite these uncertainties, ASEAN's primary goal will remain stability and balance. ASEAN countries will push for steady relationships with both global powers, aiming to shield themselves from the worst effects of US-China tensions while seeking to expand their own economic and diplomatic space. To avoid being left behind, India is watching the space closely, as it is well aware that Trump will target Delhi soon.

Delhi is trying to rebuild bilateral relationships with several ASEAN groups of countries, even as it participates with full vigour on the multilateral platform. The chief guest for 2025 Republic Day would be the President of Indonesia, a key country in ASEAN. India's exports to the US could be hit due to Trump's overtures and it needs to find new markets for its products, while gently easing out domestic compliances and trade barriers. The region's future relationship with the US will depend not only on Trump's domestic agenda but also on how ASEAN and India navigate the delicate balance between American and Chinese influence in the years to come.

ecently, Prime Minister Narendra Modi has praised the film The Sabarmati Report produced by Ekta Kapoor and her Balaji Motion Pictures.
Before this also PM has been praised films - The Kashmir Files and The Kerala Story. ## What gaming regulation can learn from SEBI'S F&O regulations

India's gaming sector stands at a critical juncture. Thoughtful regulation can help it realise its immense potential while safeguarding consumers

wo seemingly disparate sectors—India's gaming industry and capital markets—are drawing significant attention in public policy discourse. Both sectors hold immense promise: gaming contributes to job creation, while capital markets foster capital formation. However, both also pose substantial challenges. Gaming can lead to habit formation and addiction, while the Futures and Options (F&O) segment of capital markets carries risks of speculative losses. Policymakers have tackled these challenges differently, with contrasting approaches in gaming and F&O regu-


on balanced regulation, particularly concerning gaming's habit-forming nature. Unfortunately, current proposals by the Ministry of Electronics and Information Technology (MeitY), the Advertising Standards Council of India (ASCI), and other stakeholders lean toward rigid, prescriptive measures, drawing inspiration from China's heavy-handed regulatory framework

Flaws in Current Gaming Regulation

1. Time and Age Restrictions Proposals to impose strict time limits and age restrictions on gaming apps are touted as innovative but raise significant concerns. Forcing intermediaries to monitor minors' activities infringes on privacy and contravenes the data minimisation principle of India's Digital Personal Data Protection Act (DPDPA). Such policies may inadvertently lead to surveillance overreach, compromising minors' online privacy. Parents, who have a far greater

vested interest in their children's wellbeing, are better positioned to manage their gaming habits. Handing this responsibility to unelected bureaucrats not only undermines parental discretion but also risks creating intrusive and overly broad policies.

2. Blanket Warnings and **Advertising Restrictions** The Ministry of Education's 2021 advisory linking online gaming to "gaming disorder" is an overgeneralisation. Such broad statements, without clinical substantiation, stigmatise



gaming and equate it with gambling. Similarly, ASCI's restrictions on advertisements portraying gaming as a viable career path stifle creativity. These measures lump educational and cerebral games with gambling-like activities, disincentivising developers from creating "good habit-forming" games. This could slow innovation and limit the gaming sector's growth potential.

Learning from SEBI's anced approach—relying on 2. Transparent Education Approach to F&O Regulation The Securities and Exchange Board of India (SEBI) faced a similar challenge with F&O trading, where explosive volumes exposed retail investors to speculative risks. Instead of resorting to outright bans. **Key Steps by SEBI:** 

**Increased Contract Sizes:** Raising the minimum investment size by 50 per cent reduced speculative trading

by retail investors. Disclosure Requirements: Brokers were mandated to display potential downsides prominently, promoting informed decision-making. Structural Adjustments: Limiting weekly expiries to one per exchange curbed excessive speculative activity.

These steps exemplify a bal-

nudges and incentives rather than bans. SEBI recognised that heavy-handed policies could undermine broader goals, such as increasing equity market participation.

India's gaming sector can benefit from SEBI's measured approach to F&O regulation. Policymakers must embrace strategies that balance innovation, consumer protection, and industry growth. Here are three actionable recom-

mendations: 1. Nudges and Incentives Over Mandates: Rather than micromanaging user behavior, regulators can incentivise responsible gaming through voluntary measures. For instance, gaming platforms could offer rewards for adhering to healthy gaming limits.

Over Stigma

Policymakers should prioritise honest disclosures about gaming's potential downsides instead of messaging that fosters shame. Clear and factual communication can empower gamers to make informed choices without demonising the industry.

Consideration of **Unintended Consequences:** A tunnel-vision approach risks stifling innovation and creating barriers to growth. Policymakers must evaluate how restrictive measures might deter investment, hinder creativity, or drive users to unregulated platforms.

#### Aaditya Thackeray urges Fadnavis to address housing issues for retired police

included water access for all and housing for retired police personnel, and a request that a policy for the reduction of premiums on the conversion of collector land to freehold land be brought in at the earliest. The Shiv Sena (UBT) leader

said that the water-for-all policy brought in by then chief minister Uddhav Thackeray during the MVA government had ensured that every house in Mumbai would get water, irrespective of their legal status, as a right.
"The earlier unconstitutional

regime of Eknath Shinde had given a 'stay' to this policy. We humbly requested that this policy be implemented again so that all Mumbaikars can benefit." Aaditya wrote.

"We also requested that the penalty for retired police families staying in police quarters be stayed or reduced, and permanent homes should be provided for retired police personnel in Mumbai

## **Supreme Court orders cancellation of** unclaimed Amrapali flats in Noida

Saying bookings will be cancelled and flats will be sold to other buyers, the Supreme Court on Thursday took a dim view on home buyers not turning up to take possession of flats in the Amrapali projects, being completed by the state-owned

A bench of Justices Bela M Trivedi and Satish Chandra Sharma asked attorney general R Venkataramani, who was appointed a court receiver in the case, to furnish the latest status report of unsold assets or where the home buyers did not turn up despite efforts to reach out to them.

We will request the court receiver to file a latest report where possession has not been taken over by the home buyers despite efforts by him

Senior advocate Ravinder Kumar, appearing for the Noida and Greater Noida authority informed the bench that Greater Noida authority had granted its approval for construction of additional flats in Gold Home Project and with regard to other five projects, there was need for some compliances to be made by the NBCC.

The bench noted the submission of senior advocate Siddharth Dave, appearing for the NBCC, saying the compliance was regarding uploading of the map in a portal, which was done for the four projects – Centurion Park, Leisure Valley, Leisure Park and Dream Valley.

The bench directed the Greater Noida authority to grant approval for remaining four projects.

## Two Nandu Gang members arrested in Bengaluru triple murder

Delhi Police's Special Cell has arrested two sharpshooters of the Kapil Sangwan alias Nandu Gang wanted in a triple murder case in Haryana's Panchkula and broad daylight murders in Tilak Nagar and Kakrola from Bengaluru in Karnataka.

According to an official on Thursday, the accused, has been identified as 27 year old Sahil alias Poli and 37 year old Vijay Gehlot alias Kalu, were arrested from Panchkula, Haryana," a senior police Bangalore on the intervening night

of Wednesday and Thursday. "Persevering effort and continuous ground work for several months by the team gave result on Thursday, wherein on the basis of a specific input above wanted criminals Sahil and Viajy Gahlot were apprehended in Bangalore, Karnataka after a chase of 5000 km. Both suspects were wanted for their involvement in multiple crimes, including daylight murders in Delhi and a high-profile triple murder case in officer said.

The officer further said that a team tracked the fugitives' movements, conducting multiple raids across Haryana, Uttar Pradesh, Himachal Pradesh, Punjab and Karnataka, before apprehending the suspects. Three mobile phones and Rs 2 lakh in cash were recovered from the suspects, he added. These items are being analysed for further evidence and connections to their criminal

network. Police said that Sahil was first arrested in 2018 for a robbery case in Najafgarh. While in custody, he became acquainted with Sachin Chhikara, a prominent member of the Nandu gang. Upon his release, Sahil committed further crimes under the gang's instructions, including the murder of Roshan alias Chhota in Najafgarh.

"Accused Sahil came in contact with Kapil Sangwan through one PK who is a close aide of Nandu gang. In 2018, accused Sahil was arrested in a robbery case of Police Station Najafgarh, Delhi where he met

gangster Sachin Chhikara who is a key member of Nandu gang. After coming out on bail, he along with shooters Vikas alias PK and Rohit Dagar shot their rival Roshan alias Chhota in Najafgarh on the instructions of Nandu. He was wanted in several heinous cases and was evading his arrest," a senior officer said.

Further, he added that the accused Vijay Gehlot is an active Bad Character (BC) of Dwarka North police station having involvement in several heinous criminal cases

#### Speeches of Umar, Sharjeel created fear: Delhi police to HC

Speeches by Umar Khalid, Sharjeel Imam and others created a sense of fear after a common reference to CAA-NRC, Babri mosque, triple talaq and Kashmir, police argued before the Delhi High Court on Thursday.

Opposing their bail pleas before Justices Navin Chawla and Shalinder Kaur, police made its submissions in the UAPA case related to the violence which took place in northeast Delhi in February 2020.

"Speeches by Meeran (Haider), Sharjeel Imam, Khalid Saifi and Umar Khalid show a common pattern.. All are on identical lines. They create a sense of fear in the people hearing them..(by talking about) CAA-NRC, Babri, triple talaq and Kashmir," said special public prosecutor Amit Prasad.

He said aside from the speeches, Umar Khalid gave an "objectionable speech in Amravati" which was made 'viral" at the relevant time. He accused Umar Khalid of

deliberately travelling outside

any responsibility. "There was a concerted plan to remain outside Delhi.. When

Delhi at the time when violence

erupted in the capital to evade

violence broke out, there was immediate reaction," he said. Khalid, Imam and others were booked under the Unlawful Activities (Prevention) Act (UAPA) and provisions of the IPC for allegedly being the "masterminds" of the violence, which left 53 people dead and over 700 injured.

The violence erupted during the protests against the CAA and NRC.

While challenging the trial court orders refusing bail, Khalid and others cited their long incarceration and parity with other co-accused who were granted bail.

SPP Prasad also referred to the statements of several protected witnesses to establish the accused persons were not "innocent bystanders" who merely organised protest sites, but planned to cause violence through WhatsApp groups, resulting in registration of 751 FIRs related to the riots.precedent.

The CAOM has confirmed that the actions under Stage-I and Stage-II of the revised GRAP will remain enforced. Singapore passport holders can currently travel visa-free to a total of 195 out of 227 destinations around the globe, giving its citizens more unrestricted travel access than anywhere else in the world. Close behind, runner-up Japan climbed from third to second place in the 2025 ranking. The Japanese passport unlocks visa-free access to 193 nations, a total that now includes China for the first time since Covid-19. Six countries - Finland, France, Germany, Italy, South Korea, and Spain - are tied for third place with visa-free access to 192 destinations globally. In fourth place, Austria, Denmark, Ireland, Luxembourg, Netherlands,

Norway, and Sweden are also in recent years, and is now tied, with their citizens ranked in fifth place. It has tied, with their citizens enjoying travel to 191 destinations without needing a visa.

The United Arab Emirates, in tenth place, remains the only Arab nation to have secured a spot in the top 10 ranking, meaning its passport holders can travel visa-free to 185 destinations worldwide. UAE passport holders have seen a major improvement in global mobility over the past decade, and have gained access to an additional 72 destinations since 2015. Meanwhile, the US passport, dropping from second place in 2015 to its current ranking in ninth place, has become less powerful over the past

been over a decade since the UK and the US jointly held first place on the index in 2014.

In 2025, Pakistan and Yemen shared the 103rd position on the Henley Passport Index, both with visa-free access to only 33 countries. They are followed by Iraq (31 countries), Syria and (27 countries) and Afghanistan (26 countries). Several EU member states,

France, Germany, Italy, and Spain, drop two places in the ranking to 3rd position, and are joined by Finland and South Korea, which each lost a place over the past 12 months and now have access decade. The British passport to 192 destinations with no has also diminished in power prior visa required.

The statement adds that a seven-nation EU cohort, all with visa-free access to 191 destinations, Austria, Denmark, Ireland, Luxembourg, Netherlands, Norway, and

Sweden, share 4th place, while five countries, Belgium, New Zealand, Portugal, Switzerland, and the UK, come in 5th with 190 visa-free destinations. The statement adds that on the other end of the mobility spectrum, Afghanistan, unsurprisingly, remains firmly entrenched at the bottom of the Henley Passport Index, having lost visa-free access to a further two destinations over the past year, creating the largest mobility gap in the index's 19history,

with

169 more destinations visafree than Afghan passport holders.

"The very notion of citizenship and its birthright lottery needs a fundamental rethink as temperatures rise, natural disasters become more frequent and severe, displacing communities and rendering their environments uninhabitable. Vanuatu is the third-biggest faller, losing six places from 48th to 54th position, followed by the British passport, which was top of the index in 2015 but now sits in 5th place.

Completing the Top 5 losers list is Canada, which dropped three ranks over the past decade from 4th to its current 7th place.

In contrast, China is among with visa-free access to 185 the biggest climbers over the

past decade, ascending from 94th place in 2015 to 60th in 2025, with its visa-free score increasing by 40 destinations in that time. And in terms of its openness to other nations. China has also risen on the Henley Openness Index, which ranks all 199 countries and territories worldwide according to the number of nationalities they permit entry to without a prior visa. China granted visa-free access

to a further 29 countries over the past year alone, and now sits in 80th position, granting visa-free entry to a total of 58 nations as the new year commences, compared to its rival America, which ranks 84th and allows just 46 other countries access without a

## Body of Israeli hostage found in Gaza, possibly alongside his son's remains

Tsraeli soldiers recovered the body of a 53-year-old hostage in an underground tunnel in southern Gaza, the military said Wednesday, and the army was determining if another set of remains belongs to the man's

The discovery of Yosef AlZayadni's body comes as Israel and Hamas are considering a ceasefire deal that would free the remaining hostages in Gaza and could halt the fighting. Israel has declared about a third of the 100 hostages dead, but believes as many as half could be alive.

Yosef and his son Hamzah AlZayadni were thought to still be alive before Wednesday's announcement, and news about their fate could ramp up pressure on Israel to move forward with a deal.

The military said it found evidence in the tunnel that raised

of Hamzah AlZayadni, 23, suggesting he may have died in captivity. Col. Nadav Shoshani, an Israeli military spokesperson, said the circumstances behind Yosef AlZayadni's death were being investigated.

AlZayadni and three of his children were among 250 hostages taken captive after Hamas-led militants stormed into southern Israel, killing 1,200 people. AlZayadni, who had 19 children, worked at the dairy farm at Kibbutz Holit for 17 years, said the Hostages Families Forum, a group representing the relatives of captives. AlZayadni's teenage children. Bilal and Aisha, were released along with about 100 hostages in a weeklong ceasefire deal in November 2023.

The family are members of the Bedouin community, part of Israel's Palestinian minority who have Israeli citizen-The traditionally

"serious concerns" for the life nomadic community is par-of Hamzah AlZayadni, 23, sug-ticularly impoverished in Israel and has suffered from neglect and marginalisation. cions. Yoon remained holed up at his official residence in the capital city of Seoul, where the presidential security service has fortified the grounds with barbed wire and rows of vehicles blocking the roads, anticipating another attempt by law enforcement to detain him after last week's failed effort.

## US 'notorious markets' report warns of risks from online pharmacies

**AP** BANGKOK

Nearly all of the world's 35,000 online pharmacies are being run illegally and consumers who use them risk getting ineffective or dangerous drugs, according to the US Trade Representative's annual report on "notorious markets." The report also singled out 19 countries over concerns about coun-

terfeit or pirated products. The report also named about three dozen online retailers, many of them in China or elsewhere in Asia that it said are allegedly engaged in selling counterfeit products or other illegal activities.

The report says 96 per cent of online pharmacies were found to be violating the law, many operating without a license and selling medicines without prescriptions and safety

warnings. Their websites often look like legitimate e-commerce platforms, often with false claims that they are approved by the Food and Drug Administration, said the report, released Wednesday. The FDA and Drug Enforcement Administration have both issued warnings about risks of buying prescription medicines from such

It cited a survey by the Alliance for Safe Online Pharmacies' Global Foundation that found nearly one in four Americans who have used online pharmacies reported having encountered substandard, fake or

harmful medicines. Last year, Federal prosecutors reported that a network of illegal drug sellers based in the US, the Dominican Republic and India had

packaged potentially deadly synthetic opioids into pills disguised as common prescription drugs and sold millions of them through fake online drugstores, federal prosecutors said Monday.

At least nine people died of narcotics poisoning between August 2023 and June 2024 after consuming the counterfeit pills, the indictment Apart from the risks of using drugs

that may contain inert ingredients

or those that could cause allergies, the medicines are sometimes made in unsanitary conditions, said the report, which did not give annual statistics for those who may have died or otherwise been harmed. The USTR's annual report cited examples from inside the United States, but and also mentioned risks of imported ingredients including



fentanyl from China. Many of the illicit online pharmacies are based outside the US.

The "Notorious Markets List" did laud progress in fighting counterfeit and pirated goods.

In one case, US authorities, industry groups and the police collaborated in shutting down a Hanoi, Vietnam-based piracy ring, Fmovies, and other related piracy sites, in July and August.
The report said the world's then-

largest pirated movies site had drawn more than 6.7 billion visits from January 2023 to June 2024. In another Vietnam-linked case, two people operating pirate television platform BestBuyIPTV were convicted and ordered to pay fines and forfeit property.

The report also cited crackdowns on online piracy in Brazil and the United Kingdom and busts of sellers of counterfeit purses, clothing and shoes in Kuwait.

But problems remain with cyberlockers that thwart efforts to restrict piracy of movies and other content

and of so-called "bulletproof" intermerce site, saying some countrynet service providers, or ISPs, that promise people using them leeway for using pirate sites, it said. One such ISP is Avito, a Russian-

Centre, a huge mall of about 2,000 stores, had actively cracked down on counterfeiting, though such products still can be found there.

The government is likely to provide a subsidy of Rs 35,000 crore to state-owned Indian Oil Corporation Ltd (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) to make up for losses they incurred on selling the fuel this

fiscal, sources said.
The three fuel retailers have kept the price of domestic LPG unchanged at Rs 803 per 14.2-kg cylinder since March 2024 despite a rise in input raw material cost. This led to under-recoveries on LPG sales, and the resultant drastic fall in their earnings in the April-September (first half of current 2024-25 fiscal year).

The total under-recovery on LPG sales for the industry in the current fiscal is estimated at about Rs 40,500 crore. Against this, the government is likely to provide Rs 35,000



crore in total spread over two financial years, two sources with knowledge of the matter

IOC, BPCL and HPCL are likely to get Rs 10,000 crore during the current 2024-25 fiscal and the remaining Rs 25,000 crore in the next, they said, adding that provision of the subsidy is likely to be made in the Union Budget for 2025-26 that Finance Minister Sitharaman Nirmala present on February 1. Sources said there is an under-

recovery (or loss) of about Rs 240 per 14.2-kg cylinder that the state-owned fuel retailers sell to domestic households at the current price of Rs 803.

Prices of domestic LPG are regulated by government to insulate domestic households from high market rates. Regulated prices are lower than the Saudi CP - the international benchmark used to price domestic LPG. This is domestic LPG because production is not sufficient to meet the local demand and the fuel has to be imported. This leads to under-recoveries and consequent losses to the fuel retailers.

Government from time to time compensates IOC, BPCL and HPCL for these losses. The three were previously paid Rs 22,000 crore compensation for 2021-22 and 2022-23 fiscal year. This was against Rs 28,249 crore of underrecovery. Of the Rs 40,500 crore under-recovery estimated for the current fiscal, IOC is likely to account for Rs 19,550 crore, HPCL Rs 10,570 crore and BPCL Rs 10,400 crore, according to sources.

Domestic LPG prices have remained unchanged since March 9, 2024, when they were cut by Rs 100 per 14.2-kg cylinder just before general elections were announced. Sources said international LPG

prices have moderately high in 2024, even during summers, leading to under-recoveries.

## I think he will be the next captain: Gavaskar on Jasprit Bumrah

The legendary Sunil Gavaskar is in awe of Jasprit Bumrah's leadership qualities and reckons the peerless fast bowler will succeed Rohit Sharma as the next captain of the Indian team following his extraordinary display in the Border-Gavaskar

Bumrah recently produced one of the best-ever bowling performances by an overseas pacer in Australia and picked 32 wickets over five Tests.

He was also captain during India's only victory in the series, helping the visitors to a convincing win at the Optus Stadium in Perth in the opener. "He could be the next man. I think he will be the next man. Because he leads from the front, he has got a very good air about him, the air of a leader but not somebody who is going to pressure on you," Gavaskar



aired his views on Channel 7. The batting great added, "Sometimes, you have captains who put a lot of pressure on vou. With Bumrah you can see

that, he expects the others to do what their job is, why they are in the national team, but it doesn't seem to pressurise anybody. Bumrah has

spearheading the Indian pace attack for some years now and his guidance has helped the likes of Mohammed Siraj to

grow as a fast bowler.
"With the fast bowlers, he has been absolutely brilliant, standing at mid-off, mid-on and every time just being at hand to tell them. I think he was absolutely brilliant and I won't be surprised if he takes over very soon.

Bumrah took his wickets at an incredible average of 13.06 and an even better strike rate of 28.37 before pulling up injured midway through Australia's first innings at the SCG in the final Test.

In Bumrah's absence, the home team chased down 162 on the third day to win the series 3-1. The lead pacer was handed the captaincy in the final Test after the out-of-form Rohit Sharma "opted out" but a back spasm prevented Bumrah from bowling on the crucial third

Bumrah destroyed Australia in Perth with eight wickets, grabbed six wickets in the first innings at the Gabba, and nearly turned the Boxing Day Test on its head with his exploits on the fourth afternoon at MCG.

In the series decider at SCG, Bumrah sent back Usman Khawaja and Marnus Labuschagne early in Australia's first innings but could only bowl one over after lunch on the second day when the game was evenly poised.



### McSweeney returns to Australia squad for Sri Lanka tour

## Australian Open 2025: Cases involving Jannik Sinner and Iga Swiatek make doping a top topic

It is a topic that shadowed tennis in 2024 and is still a talking point as the 2025 Grand Slam season opens at the Australian Open on Sunday (Saturday EST): doping and the cases involving Jannik Sinner which actually is still not fully resolved — and Iga Swiatek. Both spent much of last year at No. 1, and Sinner still will hold that spot in the ATP rankings when he steps on court at Melbourne Park to
