The issuing of tokens for 'Vaikunta Dwara Darshanam' at Tirupati turned tragic with six people including five women getting killed in a stampede here on Wednesday.

The stampede took place when the gate was opened and thousands of people who were waiting to get a 'Vaikunta Dwara Darshan' ticket to have darshan of Lord Venkateswara at the Tirumala hill shrine on the auspicious Ekadasi Day rushed in. The Ekadasi Day falls on Friday. Sources said that 20 injured people were admitted to the Ruia

'Came to seek blessings but my wife died'

The tragic stampede in Tirupati that claimed six lives and left many injured continues to draw emotional responses from victims' families and eyewitnesses, highlighting lapses in crowd management during the

distribution of darshan tokens. Krishnan, the husband of stampede victim Mallika, shared his heart-wrenching experience. "My wife and I arrived at the foot of Tirupati hill around 3 pm. We were told tokens would be distributed at 6 pm. While waiting, a sud-

den push in the crowd caused her to fall. She suffered a spinal injury and was unable to speak or breathe. Despite rushing her to the hospital, she was declared dead.

I am still in shock and unable to come to terms with the loss of my wife. We had come to Tirupati to offer prayers and seek the blessings of Lord Venkateswara, but instead, we faced this tragedy," he said, still in shock.

An eyewitness who was present at the scene described the events as chaotic and poorly managed.

Poor crowd management led to tragedy VIJAYAWADA: The tragic stampede in Tirupati that claimed six lives appears to have been primarily caused by inade-

quate crowd management, which points to administrative lapses. However, other contributing factors must also be considered to gain a full understanding of the incident. The Vaikunta Dwara Darshanam is a highly anticipated event that draws large crowds annually. The failure to anticipate the sheer number of devotees and prepare accordingly indicates a lapse in planning.

The Tirumala Tirupati Devasthanams (TTD) had set up approximately 90 ticket counters

across various locations in Tirupati, with tickets made available from 5 am on January 9. This announcement drew tens of thousands of devotees eager to participate in the sacred event, but the sheer volume of people at centres such as Vishnu Nivasam, Bairagipatteda, and Ramachandra Pushkarini led to chaos. The crowd management arrangements reportedly failed to cope with the overwhelming number of attendees. Devotees who came for tokens were kept at the Padmavathi Park near Byragipattedu to avoid crowding on the roads.

TTD apologises to devotees, Naidu to visit Tirupati

Tirumala Tirupati The Devasthanams (TTD) has apologised to devotees for the stampede at Tirupati, which claimed six lives and injured 40.

TTD Chairman BR Naidu termed the incident as unfortunate and said that, so far, only one victim has been identified while the identities of the others have not been confirmed.

He said that Chief Minister Chandrababu Naidu is taking the matter seriously and had expressed dissatisfaction with the officials' way of management during a teleconference. The Chief Minister warned that such incidents must not be repeated and is monitoring developments. He is scheduled to visit the families of the deceased on Friday at 11:45 am.

Chairman BR Naidu arrived at the Sri Venkateswara Ramnarain Ruia Government General Hospital in Tirupati where the injured are undergoing treatment and spoke to doctors. **Continued on Page 2**

Recommendation letters will also not be accepted during these days to allow more common devotees to have darshan through Vaikunta Dwaram, he stated.

"We have made better arrangements to avoid any traffic problems in Tirumala and Tirupati, and around 3,000 policemen have been deployed besides 1,550 TTD personnel for security arrangements. Arrangements have been made to distribute water and Annaprasadam to the devotees without interruption from 6 am to 12 midnight," he added.

The Chairman reiterated that only devotees with darshan tokens or tickets are allowed in the queues due to limited accommodation available

to come only on the allotted date and time on their token or tickets to avoid long waiting hours, he said.

The devotees were also requested to wear masks for their safety.

He appealed to Govindamala devo tees to come to Tirumala only with Time Slot Tokens. Later, the Additional EO said that unplanned darshan creates issues for the devotees as well as the administration. Hence devotees are requested to observe restraint and get the SSD tokens in Tirupati. They should come to Tirumala only on the allotted date and time on their tokens or tickets to avoid any sort of problems, he asserted.

space docking technology. ISRO had launched the two satellites -- SDX01 (Chaser) and SDX02 (Target) -- as part of the mission on December 30 with the help of PSLV C60 rocket from Satish Dhawan Space Centre in Sriharikota. The two small spacecraft weighing about 220 kg each were injected into a 475-km circular orbit as intended.

According to ISRO, SpaDeX mission is a cost-effective technology demonstrator mission for the demon-



stration of in-space docking using these two small spacecraft.

This technology is essential for India's space ambitions such as Indian on Moon, sample return from the Moon, the building and operation of Bharatiya Antariksh Station (BAS), etc.

The Space Docking Experiment (SPADEX) is a pivotal project, which is designed to develop and demonstrate the technology needed for spacecraft rendezvous, docking, and undocking using two small satellites, the space agency said.

They also visited the injured in hospitals. Three centres were opened to issue tokens at Srinivasam, Satyanarayanapuram and Bairagipatteda areas. TTD officials had announced that 1.20 lakh tokens would be issued to devotees for having darshan of Lord Venkateswara on January 10, 11 and 12. Meanwhile, officials identified two of the deceased as Mallika of Selam in Tamil Nadu and Naidu Babu of Narsipatnam town.

Sources said the police found a person suffering from breathless-ness. In order to help him, the police opened the gate but a large number of people rushed in leading to the stampede. They also said that adequate security arrangements were not made to regulate the crowd.

Chief Minister N. Chandrababu Naidu expressed deep shock at the deaths of six pilgrims in the stampede at Vishnu Nivasam in Tirupati rlier in the day. In a release on Wednesday, the Chief Minister said that he is deeply saddened by the ghastly incident in which six pilgrims lost their lives. The CM inquired with officials about the treatment being given to those who had suffered serious injuries in the incident. The Chief Minister is closely monitoring the treatment being given to the injured and other developments. The Chief Minister asked officials to visit the place and take all possible steps for providing relief to the devotees and ensure that effective medical treatment is provided to the injured. The Chief Minister held a teleconference with the Tirupati Collector, SP and the TTD Chairman and inquired about the injured. He also expressed anger over officials not making proper arrangements to regulate the crowds.

Protests overshadow PM Modi's visit to Visakhapatnam

Protesters seek assurance on protecting VSP from privatisation

PNS VISAKHAPATNAM

Prime Minister Narendra Modi's visit to Visakhapatnam on Wednesday, intended to highlight Rs 2 lakh crore worth of development pro-jects, was overshadowed by jects, was overshadowed by widespread protests demand-ing the protection of the Visakhapatnam Steel Plant (VSP) from privatisation. Activists of the CPM and the CPI spearheaded demon-strations across the city

strations across the city, demanding that the Prime Minister publicly guarantee that the VSP would remain a public sector undertaking. Protesters allege that the Central government, led by the BJP, has deliberately withheld the allocation of captive mines to the plant, contributing to its current financial struggles.

One of the most significant demonstrations took place at Maddilapalem Junction, where CPM, CPI members, and numerous women activists wearing black bands briefly disrupted traffic. The protesters staged a sit-in, chanting slogans and demanding immediate government action

Traffic management saw sig-

to safeguard the VSP. The situation escalated, prompting intervention from women police officers who detained the protesters and transported them in buses designated for attendees of the Prime Minister's public meeting. Even while detained on the buses, the protesters continued their demonstrations.

Authorities had taken preemptive measures to min-imise disruptions, placing leaders from various political parties who had pledged to oppose PM Modi's roadshow and public meeting under house arrest starting Tuesday evening. This move aimed to prevent them from participating in the planned protests.

The protests highlight the escalating public concern surrounding the potential privatisation of the VSP. The steel plant is considered a vital component of the region's economy and a symbol of local identity, making its future a highly sensitive issue. The demonstrations served as a stark reminder of the strong opposition the government faces regarding its plans for the



The administration may have underestimated the turnout, especially after a period of pandemic-related restrictions. Devotees eager to attend after prior disruptions in temple activities likely contributed to the unusually high numbers.



Preparations for cockfight arena at a brisk pace

Organisers ignore warnings from High Court, Collector and police

Despite clear bans and directives from the Andhra Pradesh High Court, the NTR District Collector Dr G Lakshmisha, and Police Commissioner SV Rajasekhar Babu, preparations for conducting cockfights during the upcoming Sankranti festival in the outskirts of Vijayawada continue unabated. Organizers, allegedly backed by influential TDP leaders and representatives, are reportedly arranging arenas for this illegal blood sport under the guise of Sankranti Sambaralu.

The Andhra Pradesh High Court has directed the police to take strict measures to prevent cockfights in the state, emphasising the ban under Section 10 of the Andhra Pradesh Gaming Act, 1974, and Section 34 of the Prevention of Cruelty to Animals Act, 1960. Special vigilance teams were formed by the district collector, involving officials from the Police, Revenue, and Animal Husbandry departments, to enforce the ban and raise pub-lic awareness, interestingly, these teams have not inspected these cockfight grounds preparation works.

Despite these measures, cockfight organisers, many linked to TDP leaders, have

The blatant disregard for legal and administrative orders raises questions about the effectiveness of enforcement and the influence of political leaders in perpetuating the illegal practice

New action plan prioritises tribal students' health

Stress on standardised policy, zero-tolerance approach to marijuana use near schools

The Integrated Tribal Development Authority (ITDA) Project Officer, V Abhishek, has emphasised the need to prioritise the health and wellbeing of tribal students. He highlighted the importance of consistency across schools and announced plans to implement a standardised policy along with an immediate 100day action plan targeting 10 students. In a meeting with Assistant Tribal

Welfare Officers, Ashram School Principals, and Gurukul School Principals, Abhishek outlined clear instructions regarding the students' health and safety. He mandated that Ashram School Principals submit monthly reports using Form 1, as required by the Tribal Welfare Department's Director. He also recommended setting up sick rooms in schools to assist students with health concerns and emphasised the importance of emergency procedures, including transport to hospitals and notifying parents and ATWs immediately.



Abhishek further directed that identity cards be issued to the parents and guardians of students, stating that only those with these cards would be allowed to collect students from school. He advised maintaining a visitor register at Ashram Schools, restricting visiting hours to Sundays from 10 AM to 4 PM. He also prohibited sending students home with unfamiliar individuals. The meeting also included the release of a five-day activity and

study plan for the ten students. Abhishek stressed the need for structured study hours in Ashram Schools, with a focus on supporting academically struggling students.

In response to the issue of marijuana use near schools, Abhishek declared a zero-tolerance policy. He ordered strict action if students were found using marijuana, including counselling and informing parents. People raise objections to APERC at public hearing

CPI State secretary demands immediate cancellation of agreement between SECI and Adani

The second day of the public hearing on the proposed annual revenue requirements and retail prices for the financial year 2025-26 under the auspices of the Andhra Pradesh Electricity Regulatory Commission (APERC) was held in person and through video conference at a private function hall in Vijayawada on Wednesday. APERC Chairman Thakur Ram Singh and member P Venkata Rama Reddy conducted the public hearing on electricity tariffs and other issues.

On the second day, 59 individuals registered to share their views: 14 participated in person, while 25 joined through video conference. On the first day, 27 people registered, with 11 attending in person and 10 participating via video conference. In total, 60 individuals provided their objections, opinions, and suggestions to APERC over the two days. Chairman Thakur Ram Singh stated that they would thoroughly review every issue raised by consumers, public associations, politicians, and industrialists and would communicate these concerns to the government

During the session, CPI State secretary K Ramakrishna expressed that the power sector in the State has deteriorated to



a point where it seems beyond improvement, stressing that the responsibility for safeguarding the sector lies with APERC. He noted that consumer trust in the Electricity Regulatory Commission is waning and argued that it is unjust to impose additional charges repeatedly. He called for a public hearing on the installation of smart meters and requested the immediate cancellation of the agreement between SECI and Adani.

The convener of the Electricity Consumers' United Forum, MÝ Anjaneyulu, stated that claims about the benefits of smart meter installation are misleading. He raised concerns about the high cost of coal purchased from abroad, which he believed would further burden consumers, and urged the government to shoulder the Fuel and Power Cost Adjustment (FPCA) charges.

P Koti Rao, spokesperson for the AP Chambers of Commerce and Industry Federation, advocated for promoting green power. He noted that electricity tariffs have increased every year, causing hardship for consumers due to additional charges. He expressed doubt about the commitment of top DISCOM officials to serve the public interest.

Rajesh Babu, an industrialist from Srikakulam district, called for subsidies on electricity bills for industries to encourage their establishment. He criticised lower-level staff for their indiscriminate actions and revealed that his industry has paid over Rs.3.5 crore in bills over three Besides, vears. Tata Subramaniam, Kumaraswamy, Tatineni Venkateswara Rao, I Sambasiva Rao, Jeeva, Ganesh, Hanumaiah, and others brought their concerns to the attention of the APERC Chairman.





Rs 22.38 crore loans extended to SCs during FY 2024-25: Collector

District Collector Chadalavada Nagarani has said that Rs 22.38 crore loans will be extended to the people of SC communities during the Financial Year 2024-25 and asked the bankers to reach the targets in extending loans through the SC and BC Corporations.

Collector Nagarani held a meeting with the bankers, SC & BC Corporation, LDM, DRDA, MEPMA and Industries department officials here on Wednesday and reviewed the loans granted to various communities by the SC and BC corporations.

Speaking on the occasion, Collector Nagarani said that the government decided to sanction various types of subsidized loans under self-employment and MSME schemes for the uplift of SC and BC communities. She highlighted that for the uplift of SC and BC communities and their financial stability, subsidized loans worth Rs 22.38 crore were being sanctioned to the SC communities to set up 714 units.

She revealed that 120 autos rickshaw being sanctioned through SERP while Rs 36.49 crore being sanctioned to 1,901 people under self-employment

Officials directed to collect all taxes through digital mode

Previously all the Gram Panchayats in East Godavari district had collected house taxes and water taxes through digital mode, UPI QR codes and POS machines, and henceforth, all the gram panchayats will have to collect every tax and non-tax revenue through digital mode, she instructed system. the officials.

The Collector said that there is already sufficient awareness in terms of digital cash payment collections among the people and the officials so that the Gram Panchayat needs to perform more efficiently in the utilization of funds.

Collector Prashanthi clarified that all the Panchayat Secretaries in the district should henceforth handle all types of transactions with transparency, and directed



still have death penalty. "During the dialogue, India and the EU reiterated their commitment to the shared principles and values of democracy, freedom, rule of law, and to the promotion and protection of all human rights," it said. The two sides emphasised the

"universality, indivisibility, interdependence and interrelatedness" of all human rights, it added.

"Reflecting their commitment

to upholding human rights, they both agreed on the need to safeguard the freedom, independence and diversity of civil society actors and organisations and other relevant stakeholders such as journalists, respecting freedom of association, expression and peaceful assembly," the readout said.

The two sides also delved into issues of the 'LGBTQI+' community, women empowerment and issues

relating to technology and human rights.

The two sides also exchanged views on the rights of migrants and business and human rights, according to the readout.

India and the EU recognised the importance of strengthening national and international human rights mechanisms for the protection and promotion of human rights," it said.

DU professor accused of sexual offence resigns

professor at Delhi University's Ramjas College, who had been accused of sexual harassment, resigned on Wednesday following protests by students on campus over the alleged inaction by the adminstration on the issue. Clinical trials of medicines often done in poor countries: SC

PNS NEW DELHI

Observing clinical trials of medicines and vaccines were often carried out in poor countries, the Supreme Court on Wednesday allowed a petitioner to file submissions and objections to the rules framed by the Centre on the issue. A bench comprising Justices Hrishikesh Roy and S V N Bhatti considered the submissions of Centre's additional solicitor general Archana Pathak Dave who said rules for new drugs and clinical trials were framed in 2019.

"We know that the clinical trials are conducted in poor countries," the bench said. Following the rules, Dave said New Drugs and Clinical Trials (Amendment) Rules were notified in 2024 to streamline the approval process for clinical trials and new drugs in India which aimed to improve patient safety protocols and ensure compliance with global standards.

Senior advocate Sanjay Parikh, appearing for NGO Swasthya Adhikar Manch, which filed a PIL in 2012 alleging large-scale clinical drug trials across the country by multinational pharmaceutical firms, said poor citizens were still being used as "guinea pigs" and not paid adequate compensation.

Showdown between AAP, BJP over 'Sheesh Mahal'

Despite law, Centre yet to rise from slumber

PNS NEW DELHI

In a case over Mullaperiyar Dam, the Supreme Court on Wednesday expressed shock and said despite the Dam Safety Act by Parliament, the executive was yet to rise from its slumber. A bench of Justices Surya Kant, Dipankar Datta and Ujjal Bhuyan made the remarks after the Kerala government said the Centre enacted the Dam Safety Act in 2021 to stonewall proceedings, which were going on in court for the safe-ty of the 130-year-old dam and since then nothing has been done.

When the bench was informed the Centre was yet to constitute a national committee for the dam's safety prescribed under the law, it said, "We are aghast to know that despite enact-

ment of the Dam Safety Act by Parliament, the executive is yet to wake up from slumber." Senior advocate V Krishnamurthy, appearing for Tamil Nadu, said under the law, the Centre created a dam safety authority and an audit of the structure would

be done. Petitioner Mathews J Nedumpara has sought review of apex court's orders over the safety of the dam on the ground that if water damages the dam, it would affect 50 to 60 lakh people living downstream.

The top court issued notice seeking the Centre's response and the assistance of the attorney general in the matter. The bench observed under Section 5(2) of the Dam Safety Act, a national committee comprising members prescribed under Section 5(1) was required to

be constituted within a period of 60 days from the date of the law's commencement, and it was required to be reconstituted every three years thereafter. "We are informed that no such national committee has been

constituted so far. Even the rules/regulations regarding the constitution, composition or functions of the said national committee have not been formulated," said the bench's order.

The court noted Tamil Nadu government's submission on the Centre creating a new supervisory committee led by the chairperson of the national dam safety authority by an office memorandum of November 21, 2024, in supersession of the supervisory committee constituted by the top court in 2014.

"It further appears there is no provision in the Dam Safety Act prescribing the constitution of a supervisory committee," the bench said, "and it further appears a supervisory committee was constituted by this court in an earlier round of litigation with respect to the Mullaperiyar Dam and the union of India has also conceptualised the constitution of the supervisory committee, maybe in terms of the judgment of this court."

The attorney general's assistance was sought by the court over the constitution of the national committee and giving effect to other provisions of the Dam Safety Act. It directed the AG to take instructions from the national dam safety authority on its responsibility under the law. The bench, during the hearing, considered passing an order for a safety audit of the dam by an expert panel to allay any fears surrounding the British-era dam, which is situated in Kerala but controlled by Tamil Nadu. Brace up for battle royal

With polling scheduled for February 5, Delhi is poised for a fiercely contested three-way battle

s the Election Commission officially announced the schedule for Delhi's upcoming assembly elections, the stage is set for what promises to be a hard-fought, Three-cornered contest. Polling for the 70 assembly seats in Delhi will take place on February 5, with the results to be declared on February 8. This election is poised to be a high-stakes battle between the incumbent Aam Aadmi Party (AAP), the Bharatiya Janata Party (BJP) and the Congress, each bringing its own strategies, narratives and issues to the forefront. Under the leadership of Arvind Kejriwal, AAP is looking to secure a third consecutive term in Delhi. The party, which has enjoyed overwhelming success in the last two elections, is fiercely campaigning for a 'hat-trick.' Kejriwal, whose party has transformed the political landscape of Delhi since its formation in 2012, is betting on his track record of governance and what he calls the 'politics of work.' AAP's focus remains on welfare programmes such as free electricity, water and healthcare, while



the party claims its tenure has been marked by development and transparency. With the slogan "Phir layenge Kejriwal," AAP has launched a campaign centred around a positive vision for the future, contrasting its achievements with the BJP's focus on divisive politics. However, AAP's victory is far from assured. Despite its dominance in the previous two elections, the party now faces mounting challenges. AAP has been dogged by corruption allegations, a point of attack that the BJP has effectively capitalised on. For the BJP, this election is a do-or-die contest. The

party, under the leadership of Prime Minister Narendra Modi, has mounted an aggressive campaign aimed

at ousting Kejriwal and the AAP from power. The BJP's central theme revolves around anti-incumbency, accusing AAP of corruption and failing to address the capital's development needs. Prime Minister Modi, at the forefront of the BJP's attack, has called the AAP government an 'AAP-da' (disaster) and criticised its inability to offer a vision for Delhi's growth. Modi's rhetoric positions the BJP as the party of national progress, while framing Kejriwal's leadership as an obstacle to Delhi's future. The BJP's strategy is twofold: discredit the AAP's governance while appealing to voters' desire for change. The Congress, once the dominant force in Delhi, is now a distant third. After losing power in the capital in 2013, the party has been trying to rebuild its political base, which has been severely eroded by both AAP and BJP. However, this time the party is determined to make its presence felt in the elections. Given the deepening polarisation, high stakes and aggressive strategies on all sides, the 2025 Delhi Assembly elections are shaping up to be a politically charged, hard-fought, and closely contested battle. Voters will have to choose between a legacy of governance under AAP, a vision for change from the BJP, and the prospect of stability from the Congress, making this election one of the most bitterly fought yet interesting to the core.

Donald Trump's H-1B dilemma

As President-elect Donald Trump prepares for his second term, the debate over H-1B visas for skilled foreign workers is heating up

s the US Presidentelect Donald Trump prepares to take office on January 20, he faces a unique challenge. The issue of immigration and the H-1B visa has become a contentious point among the two key groups. He is trying to satisfy the conflicting interests of the billionaire tech community, who heavily fund his campaigns, and his 'America First' base.

Trump's recent favourable statements on H-1B visas for foreign skilled workers have sparked renewed discussions on the future of this critical programme. The New York Post quoted Trump, "I've always liked the visas, I have always been in favour of the visas.

That's why we have them." He added: "I have many H-1B visas on my properties. I've been a believer in H-1B visas. I have used it many times. It's a great program."

Trump admitted. Trump has backed Elon Musk and his other wealthy funders from Silicon Valley (South Africa-born Musk had an H1B visa himself). While tech leaders want a liberal H-1B visa regime, 'America First' hardliners wish for stricter restrictions on immigration at all levels.

In his first term, Trump prioritised protecting American citizens' interests, which had significant implications on the H-1B visas. 'America First' advocates argue that H-1B visas take jobs away from American workers. The looming question is, will the Trump's second term may prioritise American workers' jobs, or it could revert to the traditional Republican belief that immigration primarily benefits employers. Debates arose over H-1B visas following Trump's appointment of India-born Sriram Krishnan as his advisor on artificial intelligence. It caused divisions within Trump's teampopents of the H-1B visa claim



marily beneficial for employers. Influential supporters like Elon Musk and Vivek Ramaswamy argue that H-1B visas are crucial for addressing the US engineers shortage. Musk, who built his empire, and Vicek Ramasawamy have strongly supported the pro-gram. Musk expressed his readiness to go to war over it. They highlight a significant skills gap in the US labour market, particularly in STEM

fields. What is an H-1B visa, and why is there such controversy surrounding it? Would India suffer if H-1B visas were eliminated? The visa system for skilled workers from other countries was introduced in 1990 by President Bush to work legally in the US. The visa is for three years. Applicants must have a job lined up with a US-based sponsoring company or institution. Since 2004, the United States has limited the number of new H-1B visas to 85,000 yearly.

Trump's recent statement about H-1B visas has given hope to many visa seekers, especially Indians. He stated that the US needs skilled and intelligent people and promised more job opportunities. It provides a positive outlook for H-1B visas.H-1B visa holders often complement, rather than compete with, US workers.

Now many H-1B visa seekers are hopeful after Trump has sided with Musk. He claimed that there was a need for skilled and intelligent workers. His promise of unprecedentapprovals, dropping from over 11,000 in 2023 to just above ed job opportunities offers a positive outlook for those positive outlook for those seeking H-1B visas. India's forests: Gains, gaps and the way forward

The report underscores the need for robust monitoring, effective execution of plantation drives and third-party certification of carbon stock to meet India's climate commitments



orest Survey of India has been releasing biannual reports on the status of Indian forests. The last report was released on December 31, 2021, and the current report which was due in December 2023, has been released after a year's delay. The highlight of the report is that total forest cover has been increased from 7,15,187 square km (2021 assessment) to 7, 15,343 square km (current assessment), which is now 21.76 per cent of the total geographical area of the country. Also, the tree cover, which comprises trees along the linear infrastructures and also in agricultural fields up to one hectare is increased by 1289 square km, which is 3.41 per cent of the total geographical area of the country. The net increase of forest cover and tree cover is 1445 square km in two years period till 2023.

The increase in forest cover is a meager 156 square km. Among the states that have gained maximum increase in forest cover are Uttar Pradesh, Rajasthan, Chhattisgarh and Odisha. A maximum decrease in forest cover has been noticed in Madhya Pradesh, Karnataka, Ladakh and Nagaland. Recorded Forest / Green Wash areas (RFA/GW) are the forests in control of the forest department. While Mizoram, Odisha, Karnataka, West Bengal and Jharkhand have added in RFA/GW areas and the forest cover has increased, Tripura, Telangana, Assam, Andhra Pradesh and Gujarat have lost. It indicates that states are losing their recorded forests. Villages on the fringes of the forests have been burning tree growth and occupying forest land with the support of local leaders and to claim it under the Forest Rights Act, of 2006. Improper implementation of the Forest Rights Act, of 2006 can be attributed to the reason for the loss of forests for agriculture. All the states have been taking up ambitious plantation programmes to increase forest cover and tree cover. The degraded forest areas are being planted regularly.

Decadal changes in forest cover in Western Ghats eco-sensitive areas have also been brought out in the report. It is found that 58.22 square km of cover is lost in ten years. How can we forget the 30th July tragedy that struck Wayanad, Kerala? Nearly 500 humans were buried under landslide debris when they were asleep.

It also damaged roads, bridges, buildings and human houses. Landslides in portions of Karnataka and Maharashtra across the Western Ghats have disrupted lives and livelihoods. Losing 58 square km in ten years means losing nearly 6 square km annually. We need to mend our ways and cannot afford to lose any tree growth in such eco-sensitive areas. naroves in the country along the coastline protect against tsunamis, cyclones and Sea surges of any kind. The report indicates that out of 4991 square km of mangroves 7.5 square km is lost in two years. While Andhra Pradesh and Maharashtra together have added 25 square km of mangroves, Gujarat has lost 36 square km. On the western coast Gujarat is the most vulnerable state against frequent and destructive cyclones, how can it afford to lose such a big chunk of mangrove forests? Other coastal states are reportedly expanding their mangroves by taking up large-scale planting, but the report does not show any increase. There has to be an enquiry as to why mangrove plantation programs are failing. Another highlight of the report is that the growing stock of carbon in the forests is 7285 Mt, and comparing it with the 2021 report there is an increase of 81.5 Mt in two years. Thus our forests are adding

which is like 149 Mt of CO2 equivalent annually. Comparing it with the report of 2005, the growth in forests has created a carbon sink of 2.29 billion tons of CO2 equivalent compared to the 2005 level. To contain the average global rise in temperature within 1.50 Celsius, we have committed in our nationally determined contribution to achieve a carbon sink of 2.5 to 3.0 billion tons of CO2 equivalent by 2030 in response to the Paris Climate Accord of 2015. We are on course to achieve the target well before 2030. I suppose we need a third-party assessment for carbon stock in our forests. Carbon credit has been quite a contentious issue and in several annual climate conferences, UNFCCC has failed to find a resolution. However, for the first time at Baku CoP 29, a resolution has been achieved. It has allowed countries to trade carbon credits – certified reductions of carbon emissions at prices determined as a consequence of emission caps imposed. It has also been agreed that the operations of the carbon market would be supervised by the UN body. Strict UN control is needed, as a project proponent in the developed nation can pay for an afforestation project to absorb 1000 tons of CO2 in a developing nation where trees fail to put in desired growth and are unable to sequester the entire quantity of carbon credited. Therefore, the carbon sink created by us through our interventions in forest growth needs certification from the UN body. The report in future should take into account the plantation programs each state is implementing and measure the change in the cover concerning the success/ failure of plantations.

Taking a conservative estimate, a minimum of 18,000 square km area is being planted annually in the country; should

Trees on government ands can be cut and destroyed, but the same cannot be done on private lands. In this period of two years, very dense forests increased by 3465.12 square km, while moderately dense forests and open forests have decreased by 1043.23 square km and 2480.11 square km respectively. Forest departments' efforts in taking up plantations in open and degraded areas appear to have shown some success. A large chunk of open and degraded areas has been re-stocked, which has pushed it into the very dense forest category. But a simple arithmetic indicates

that 58 square km of forests have been lost. Most probably, several small plots taken from forests on the fringes of the villages must 40.75 Mt of carbon annually,



BHEL commissions PHEP-2 project in Bhutan

Barat Heavy Electricals Limited has successfully Commissioned two units of the 6x170 MW Punatsangchhu-II Hydroelectric Project (PHEP-II) in Bhutan. Executed as part of a bilateral agreement between the Indian and Bhutanese governments, PHEP-II is a greenfield hydro project located in the Wangdue district of Western Bhutan, a BHEL press release said. Significantly, the Francis Turbine installed in the project is designed to operate at a rated head of 241 metres - the highest for any Francis Type Hydro Turbine in Bhutan. On commissioning of all six units, the expected annual power generation will be 4,357 gigawatthours, the release said. Unit 1 and 2 of the 6x170 MW PHEP-II were synchronised on December 16 and 17, 2024, respectively.



solution provider Mouri Tech and Ahmedabad-based pharmaceutical company Amanta Healthcare have withdrawn their initial public offerings (IPOs). The companies had filed their Draft Red Herring Prospectus (DRHP) for the proposed IPO in September-October 2024 with the Securities and Exchange Board of India (Sebi). According to the first advance estimates (FAE) of National Income for 2024-25 released by the National Statistics Office (NSO), released on Tuesday, India's economic growth rate is estimated to slip to a four-year low of 6.4 per cent in 2024-25, because of poor showing by the manufacturing and subdued investments. Historically, the difference

between the estimates of the Reserve Bank of India (RBI) and the NSO is always in the range of 20-30 bps and hence the 6.4 per cent estimate for the 2024-25 fiscal year is along expected and reasonable lines, the SBI's research report 'Ecowrap' said.

"We, however, believe that GDP (gross domestic product) growth for FY25 could be around 6.3 per cent, with downward bias," it said. The report authored by

Soumya Kanti Ghosh, Group Chief Economic Adviser, State Bank of India (SBI), also said as per capita nominal GDP is

expected to increase significantly in the current fiscal ending March 2025, by Rs 35,000 more than 2022-23, despite a slowdown in real GDP growth and nominal GDP growth remaining almost stagnant.

The FAE of the GDP in general shows a slowdown in aggregate demand in 2024-25, it said.

The heads that have positively contributed include government consumption with a growth of 8.5 per cent in nominal terms (4.1 per cent in real terms). Exports have also held the fort with positive growth of 8 per cent (5.9 per cent in real

terms). The worrying aspect of the demand is marked slowdown in gross capital formation, SBI's study said, adding that the capital formation nominal growth declined 270 bps to 7.2 per cent.

'...overall picture is that demand remains weak and sequential slowdown in FY25 at 6.4 per cent is an outer limit while the actual growth is def-initely below the estimated

figure," it said. The report further said that the fiscal deficit at the end of November 2024 stood at Rs 8.5 lakh crore, or 52.5 per cent of the Budget Estimates (BE).

However, taking into account the revised GDP figures, if tax receipts grew by the BE, government expenditure lowered due to low CAPEX then fiscal deficit will be 4.9 per cent of the GDP in 2024-25, SBI's research said.

While, if government sticks to the fiscal deficit of Rs 16.1 lakh crore, then with the revised GDP numbers, the deficit as per cent of GDP would be at 5 per cent in 2024-25, the report said. In the Union Budget, the

government projected to bring down the fiscal deficit to 4.9 per cent of the GDP in the current financial year.







Where love & care rewrite the lives of HIV+ve orphans

n a world that often dismisses the n a world that often dismisses the vulnerable, Palawi stands as a bea-con of hope and a testament to the transformative power of com-passion. Founded in 2001 by the dynamic mother-daughter duo Mangal Shah and Dimple Ghadge, this organisation has redefined the lives of HIV-positive children. What began as a modest effort in a small shed with just two abandoned girls has blossomed into a sanctuary for over 150 chil-dren. With its foundation rooted in love, they have touched the lives of more than 6,000 children, ensuring they receive shelter, education, healthcare and dignity.

and dignity. Their journey is not just about providing care—it's about defying societal prej-udices and rewriting the udices and rewriting the narrative for children who are often stigmatised. In an exclusive conversation, Dimple Ghadge, founder secretary of Palawi, shared the story behind this extraordinary endeavor. "In 2001, we found two abandoned girl children. When we took them to the hospital, they were diagnosed as HIV-positive. That moment changed everything for us. We started working with people in red-light areas, and that's how Palawi was born," she recounted.

Today, they operate from three buildings, providing a safe haven for children of all age groups. Its logo—a growing sapling—symbolises the organisation's

HIV students," she said. mission to nurture these children and help mission to nurture these children and help them thrive. However, the path to this suc-cess was fraught with challenges. "People around us often asked, 'Why are you protecting such children who will die soon?" Dimple revealed. Yet, these ques-tions only strengthened their resolve. Education became a critical focus area. "Providing food and shelter was not enough Schools refused to admit HIV-Healthcare posed another significant

challenge. To ensure the children received challenge. To ensure the children received adequate medical attention, Palawi estab-lished its own medical unit. The organi-zation also goes beyond traditional care by emphasising skill development. "Once a child turns 14, they are encouraged to pursue arts or crafts like candle-making and stitching. The money they earn is saved for their future education," she explained, adding that creativity knows no boundaries or prejudices. One of their most heartwarming initiatives is the most heartwarming initiatives is the Palak-Balak program, where an older child takes responsibility for a younger one. "For

instance, a 15-year-old might take care of a 2-year-old, ensuring they're safe and happy. This builds a bond of love and responsibility. Every night, the elder child writes a note to the younger one, foster-ing a unique connection," she shared. Funding, too, has seen an evolution. "Initially, we relied solely on individual contributions. As awareness about our work grew, we began receiving interna-tional funding from organisations like

tional funding from organisations like CAF America and explored crowdfund-ing avenues," she highlighted. The success stories from Palawi are a

source of immense pride and inspiration. She shared one such story: "Two years ago, our students were barred from participat-

students were barred from participat-ing in a district-level sports compe-tition. We pleaded for them to be allowed, even if they didn't win. Out of 15 sports events, our children emerged victorious in 13. It was a proud moment that silenced many critics."

Despite the obstacles, they have achieved a remarkable milestone: zero mortality under

the Prabha Hira Pratishthan ini-tiative. "Looking at the successful results of what you work hard for makes it feel worth it," she shared, her voice filled with pride. Palawi's story is a powerful reminder

Palawi's story is a powerful reminder that love, determination and a belief in the fundamental rights of every individual can overcome even the harshest challenges. It overcome even the harshest challenges. It is not just an organisation; it is a family where children grow, thrive, and dream of a brighter future. As Dimple concluded, "We are here to give these children a life of dignity, and we will continue to fight for their right to live, grow, and succeed." idhi Singh's journey from Allahabad to becoming one of the most versatile talents in the entertainment industry is a captivating story of resilience and passion. With each role she takes on, Nidhi has not only proven her ability to adapt and grow but also her commitment to delivering authentic and powerful performances. In her latest project, *Moonwalk*, she steps into a character that challenges her like never before — one that is unpredictable, complex and thrilling. In this in-depth conversation with The **Pioneer**, the Apharan fame shares her experiences, the preparation behind her role and what it truly means to be a part of a project that pushes her to explore new dimensions as an actor.

Reflecting on her journey in the industry, Nidhi says, "I honestly feel it's just begun. Every single project feels as new and exciting as the first time I faced the camera." For her, the thrill of acting lies in the constant evolution and the opportunities to work with creative minds. "It's really lovely when the people you're collaborating with—be it the writers, directors, producers, co-actors, or crew-are aware of what you've done. But I still approach every project as a clean canvas."

Despite her success, she remains grounded about the ups and downs of her career. "The journey is never all smooth; there are days when it gets frustrating. But you hold on, look ahead and keep moving. Being a part of this industry, which once seemed like a farfetched dream for someone from Allahabad like me, feels surreal."

Talking about her latest project Moonwalk, she shares how she was introduced to the script. "It was sheer luck. I had worked on a series, and through that, I was called in for a meeting. When they mentioned Moonwalk, I thought it might be something related to dance. I was thrilled initially, thinking I'd get to tap into my teenage love for dancing. But as I read the script, I realised it was a high-stakes comedy-drama, and I was hooked."

While Nidhi assumed she'd be auditioning for the character of Asma, she was pleasantly surprised when director Ajay Singh insisted she was perfect for the role of Chandni. "When he said Chandni, I couldn't believe it. I was sitting there in a casual T-shirt and pants, but he was convinced. Chronic acid reflux? Here's everything you need to know!

G ERD or Gastroesophageal reflux disease is a chronic condition. It typically involves regurgitation of stomach acid and other contents into the esophagus, leading to symptoms such as heartburn, chest pain, difficulty swallowing and coughing. It occurs when the lower esophageal sphincter (LES), a ring of muscle at the bottom of the esophagus, fails to close properly, leading to reverse flow of the stomach contents back up into the esophagus.

GERD can be caused by various factors including obesity, hiatal hernia, pregnancy, smoking and certain medications. Additionally, certain foods and beverages, such as citrus fruits, tomatoes, spicy foods, caffeine, alcohol and chocolate, can exacerbate symptoms.

Treatment for GERD aims to alleviate symptoms, heal esophageal damage and prevent complications. Here are some common approaches:

Lifestyle modifications: Making changes to diet and lifestyle can often help manage GERD symptoms. This includes avoiding trigger foods, eating smaller meals, avoiding lying down or bending over after eating, losing weight if overweight and quitting smokina.

Medication

• Antacids: Over the counter antacids such as Gelusil, Mucaine gel or Ulgel can help neutralize stomach acid and provide temporary relief from heartburn

• H2-receptor antagonists (H2RAs): These medications, including ranitidine and famotidine, provide longer-lasting relief than antacids by reducing the production of stomach acid.

• Proton pump inhibitors (PPIs): Drugs like omeprazole, esomeprazole, rabeprazole and lansoprazole are more potent acid suppressors than H2RAs and are often prescribed for more severe cases of GERD or to heal esophageal damage.

• Prokinetic agents: These medications help strengthen the lower esophageal sphincter and improve esophageal motility, reducing the frequency of reflux episodes. Examples include metoclopramide and baclofen.

Surgery: For patients who do not respond to lifestyle changes and medications, surgical intervention may be necessary. Fundoplication is a common surgical procedure for GERD, that involves wrapping up the upper part of the stomach around the LES to strengthen it and prevent reflux.

Endoscopic treatments: Less invasive procedures such as endoscopic suturing or radiofrequency energy delivery can be used to tighten the LES and improve its function, reducing reflux symptoms.

Biologic therapies: In recent years, biologic therapies targeting specific pathways involved in GERD pathophysiology have emerged as potential treatments. These therapies aim to modulate acid production, improve esophageal function, or reduce inflammation.

It's important for individuals with GERD to work closely with their healthcare providers to develop a customised comprehensive treatment plan catering to specific needs and preferences. Untreated GERD can lead to complications such as esophageal ulcers, strictures, a pre-cancerous condition called Barrett's esophagus, and esophageal cancer rarely. In summary, GERD is a chronic condition characterized by the regurgitation of stomach contents into the esophagus. The condition presents with symptoms such as heartburn and chest pain. Treatment options include lifestyle modifications, medications, surgery, endoscopic procedures and biologic therapies, with the goal of alleviating symptoms, healing esophageal damage, and preventing complications.

Bumrah continues to remain No. 1 in Test rankings

ndia's pace spearhead Jasprit Bumrah continued to reign supreme at the top of the bowlers' chart with a career-best rating of 908 in the latest ICC Test Rankings, released on Wednesday.

Bumrah, who made history ahead of the fifth and final Test against Australia by Test against Australia by recording the highest-ever ICC Rankings rating for an Indian bowler at 907 points, improved that tally by one point after taking two wickets in the first innings at the SCG. However, a back spasm ruled him out of bowling in the him out of bowling in the second innings, restricting his

second innings, restricting his role to just batting. Left-arm spinner Ravindra Jadeja, who climbed a spot to be joint-ninth, is the other Indian giving Bumrah company in the top-10. He shares the ninth spot with Australian pacer Scott Boland, who has made a remarkable leap of 29 places to break into the top 10.

Boland's stellar performance in the Sydney Test, where he



claimed a 10-wicket haul (4/31 and 6/45), proved too much for the Indian batters on a lively pitch.

His efforts were instrumental Australia's triumph, in ending a decade-long wait to reclaim the Border-Gavaskar Trophy.

Australia skipper Pat Cummins also made gains in the rankings, climbing to number two after picking up five wickets in the final match. South Africa's Kagiso Rabada rose a spot to occupy the third place while injured Josh Hazlewood moved down two places to be fourth. Rishabh Pant's blistering 33ball 61 in the second innings earned him a three-spot rise in the batting rankings, moving him to number nine while India opener Yashasvi Jaiswal retained his fourth spot.

South Africa captain Temba Bavuma extended his rich vein of form, scoring a vital century in the first innings to climb three spots to number six, also achieving a careerbest rating of 769.

The marquee five-match series ended 3-1 in favour of the hosts, who regained the Border Gavaskar Trophy after

a decade and also qualified for the World Test Championship final in June against South Africa. "The pitches at Perth Stadium Adelaide Oval Stadium, Adelaide Oval, Gabba and Melbourne Cricket Ground – the venues for the first four Tests - were

rated as 'very good," the ICC said in a statement.

"Meanwhile, the surface for the final Test in Sydney received a 'satisfactory', the second-highest rating on ICC's scale," it added. The traditionally batting-

friendly pitch at the Sydney Cricket Ground favoured bowlers this time. Batters from both the teams struggled for the majority of the Test which ended in two and half days.


