

War beyond language: Stalin insults Indian currency

he decision of the Tamil Nadu government to replace the universally recognised symbol of Indian currency ₹ with the Tamil letter

Ru has stirred a hornet's nest across the country if the initial reactions are any indication. But even DMK persons are of the view that Chief Minister MK Stalin's new found passion for Tamil language is to make the Centre to use Article 356 in order dismiss the democratically elected government so that the party could romp home with increased majority in the 2026 Assembly election based on the sympathy wave.

The move to change the symbol from ₹ to Ru (rubaai, Tamil for Rupee) was publicised by the DMK government through advertisements in the Stalin-family owned newspapers and news channels which are galore in the state. Thangam Thennarasu, the minister for finance is all set to present the 2025-2026 budget for Tamil Nadu on Friday.

Thennarasu is not known for his

prowess either in economy or education and is guided by a coterie of IAS officers, according to Prof C Murukadass, former head of the department of economics and who had been advisor to chief minister MG Ramachandran and J Javalalithaa

Edappadi Palaniswamy, former chief minister, termed the move as political stunt and one of the many gimmicks deployed by Stalin to tide over the financial ruin Tamil Nadu is undergoing. The economic survey presented by the government a la the Centre is also another ploy to cheat the general public, said Palaniswamy who took to social media.

K Annamalai, the state BJP chief, pointed out that Stalin has scored a self goal in his bid to emerge as the savior of Tamil. "It was Udhayakumar, a Tamil Nadu born youth who designed and developed the ₹ which was recognised and accepted by the then UPA Government headed by Manmohan Singh. The DMK was the second largest partner in that government and had supported the decision," said Annamalai

Udhayakumar is the son of Dharmalingam, a former DMK MLA who had represented Rishivandhyan constituency. "It is like humiliating the Tamil vouth who had the rare privilege to design the emblem of the national currency," said Prof Murukadass.

Stalin is engaged in a battle with the BJPled Center over the implementation of the three-language policy in school and college curriculum. He has convened a meeting of the non-BJP chief ministers to form a united front against the BJP-led NDA government's NEP 2025 and the alleged order to impose Hindi.

"Stalin or for that matter any other chief ministers in the country are incapable to replace the ₹ with the design or letter of their choice as this comes under the prerogative of the Centre. What the DMK government is doing is to divert the attention of the public from the failure of the Stalin government. The state is burdened with debt of ₹9.54 Lakh Crore and there is no money in the coffers for social welfare measures. Moreover, Stalin is facing indifferent health due to a series of ailments. His only mission is to facilitate the coronation of son Udhanidhi as the successor," said Prof Murugadass.

Political commentators in Chennai are of the view that Stalin's displeasure over the National education Policy and the campaign against it is much ado about nothing. "This is a move to grab national headlines and the people will forget the same after the initial excitement," said a senior commentator

Dr YR Johnson, former principal of

Navodaya Vidyalaya and a widely respected educationist is of the view that the State Government was violating the provision enshrined in Indian Constitution that guarantees the right to education. "You cannot deny the children their right to learn a language. Let the politicians have their fights in the public arena but not in schools or colleges. The Supreme Court and High Courts in the country have reiterated many times the right of children to learn the language of their choice and what the Tamil Nadu Government does is gross violation of court order," said Dr Johnson.

Adding to the woes of Stalin, a former ADGP Pon Manickavel said that Stalin has lost all capabilities to administer the State and he is led by a group of advisors who are working against the interest of the nation.

The Lok Sabha had witnessed Dhayanidhi Maran, Stalin's nephew questioning the propriety over the translation of Indian Constitution into Sanskrit, to which the Speaker gave the former some basic lessons.

ince time immemorial, the progress of civilization has been defined by its ability to Civilization has been defined by its asin connect-first through roads that linked villages and kingdoms, then through canals and boats that carried commerce and culture across waters, and later through airways that brought distant lands closer than ever before

These physical networks, however, have always been paralleled by intangible forces-shared beliefs, traditions, and above all, the financial systems that unify economies and enable prosperity. Since the dawn of our independence, the Indian rupee has been one such force binding together a nation of unparalleled diversity, where every region's traditions are

equally unique and equally important. It is within this context that the Tamil Nadu government's decision to replace the universally recognised rupee symbol (₹) with the Tamil letter 'Ru' in their budget document must be examined. This move appears to be less about cultural pride and more about political posturing, stoking regionalism at the cost of national unity, echoing past language-related controversies. Tamil Nadu, which adheres to a two-language policy (Tamil and English), has long opposed the three-language framework, branding it an imposition of Hindi. Yet, the National Education Policy (NEP) fosters multilingualism and grants states the autonomy to determine their linguistic preferences.

IT Guwahati Professor D Udaya Kumar, who had designed the Indian rupee symbol refused to be drawn into the controversy over language and said it is a mere coincidence that his father was a DMK MLA. "I don't have any reaction. It's the government which suddenly felt that there was a need for a change and they wanted to implement their own script. This is up to the state government. So, I don't have anything to say about that. It's entirely up to the government," said Kumar.

Kumar's father N Dharmalingam was an MLA from the Rishivandiyam constituency in 1971 from the DMK party, which is in power in Tamil Nadu presently. "My father was an MLA even

before I was born. Now, he is old and living in our village, leading his life peacefully. It just happened to be a coincidence, probably I could have been somebody else as well," the professo said.

Recollecting his experience while designing the Indian rupee symbol, Kumar said the design which he created was based on certain requirements that the government had asked for "It was a competition by the Government of India. I participated and my design got selected as the winner of the competition, and it was implemented then," said the IIT professor.

The Indian Rupee sign was adopted by the Government of India on July 15, 2010, Udaya Kumar is a post-graduate in Design from the Indian Institute of Technology Bombay.

It is not against the Constitution in any form," said Raja

DMK spokesperson Saravanan Annadurai meanwhile defended the state government's decision and was quoted, "The usage of Ru is to signify protest of the state against the policies of the government. The people of the state are aware of what the BJP is trying to do. Everybody across the country is aware of the nefarious designs of the BJP government."

President sanctions prosecution against Sisodia, Jain

Tn fresh trouble for the AAP former ministers Manish Sisodia and Satyendra Jain, President Droupadi Murmu has granted prosecution sanctions against them in the ₹1,300 Crore scam in construction of classrooms in Delhi government schools, during their tenure as ministers in the national Capital. In official communications to the office of Lieutenant Governor of the NCT of Delhi, the President through the Union Ministry of Home Affairs (MHA), said, the required permission to register an FIR and institute a probe against then education minister Manish Sisodia and then public works department (PWD) minister Satyendar Jain is granted. Under Section $\rm \widetilde{17}A$ of the Prevention of Corruption Act, 1988 (as amended in 2018) prosecution of former PWD minister, Satyendra Jain has been ordered. The file number 17A/4/DOV/2021 has been moved ahead as further action will it take it forward. The MHA's move comes after reviewing findings from the Department of Vigilance (DoV)'s investigation into alleged financial irregularities linked to them. In 2022, the Delhi government's vigilance directorate recommended a probe into the alleged scam and submitted a report to the chief secretary. The Central Vigilance Commission (CVC), in a report dated February 17, 2020, highlighted "glaring irregularities" in the construction of over 2,400 classrooms in Delhi government schools by the Public Works Department (PWD). It is alleged that a huge scam to the tune of over ₹2,000 Crore have been carried out in NCT of Delhi for the construction of School Rooms/Buildings at a highly inflated cost by the Govt, of NCT of Delhi. The scam involves construction of around 12,748 School Rooms at a very high and inflated construction cost. The total cost incurred for constructing the school rooms/buildings is around ₹2,892.65 Crore. The school rooms /buildings are being allegedly constructed at the rate of ₹8,800 Sqft whereas it is common knowledge that average construction cost (even for a builder of flats) is around ₹15,00 Sqft The lump sum cost for constructing a school room/building as per the tender awarded is around ₹24.86 Lakh per room, whereas such rooms are easily constructed at Delhi by/through any person at around ₹5 Lakh per room.

noting that 23 out of the 33 monitored sites, including six in the national capital, failed to meet primary water quality standards.

Having taken note of the presence of heavy metals like lead, copper, zink, nickel, cadmium and chromium in the riverbed of Yamuna which pose a serious threat to the heath and ecosystem of the river, the Committee recommended that the Department explore the possibility of controlled dredging. The Department has through their Action Taken Replies furnished the submissions of various Departments of the Yamuna basin States. However, the Delhi Jal Board has not furnished its reply.

The Yamuna flows through a 40 km stretch in Delhi, entering at Palla from Haryana and exiting at Asgarpur into Uttar Pradesh. The dissolved oxygen (DO) levels, which reflect the river's capacity to sustain life, were found to be almost non-existent in the Delhi stretch, the report said. It said the Yamuna has been categorised into three parts viz. the part from Yamunotri to HathniKund Barriage may be considered as unpolluted stretch, the part from HathniKund Barriage to Palla is moderately polluted. However, the part from Palla to Okhla, basically the Delhi stretch is severely polluted. Further, as per the Primary Water Quality Criteria for organised outdoor

specified as 5 mg/l or more, the Biochemical Oxygen Demand (BOD) is specified as 3 mg/l or less and Fecal Coliform (FC) is specified as less than 2500 MPN/100 ml.

The water quality data of monitored 33 locations during January, 2021 - May, 2023 was analysed for 4 parameters viz, Dissolved Oxygen (DO), pH, Biochemical Oxygen Demand (BOD) and Fecal Coliform (FC). The results were compared with the Primary Water Quality Criteria for Outdoor Bathing (PWQC) notified by Ministry of Environment, Forest & Climate Change under the Environment (Protection) Rules, 1986. The analysis revealed that: All the 04 monitored locations each in Uttarakhand and Himachal Pradesh are complying while all the 06 monitored locations are non-complying with the criteria in Haryana. All the 07 monitored locations in Delhi were non-complying with the criteria during 2021. 06 locations were non-complying except at Palla (entry point of Delhi) which is observed complying during 2022 & 2023. Out of 12 monitored locations in Uttar Pradesh, 11 are observed non complying during 2021-2023.

"Further, the National Mission for Clean Ganga (NMCG) in their reply has cited the observation of a Committee headed by Dr MA Chitale which in their

Committee reiterated that the Department may take pro-active steps at least for controlled dredging of the sludge which cannot be left to the vagaries of monsoon rains and whose continued presence may further decay the water quality of such an important river," the report said.

The report stated even if Delhi Jal Board (DJB) treats the entire sewage generated in Delhi upto Biochemical Oxygen Demand (BOD) of 10 mg/l desired water quality of BOD less than 3 mg/l & Dissolved Öxygen (DO) more than 5 mg/l may not be achieved in river Yamuna due to unavailability of fresh water in the river downstream of Wazirabad and importance of minium flow for sustenance of river ecosystem.

In its report the Committee warned that despite the construction and upgrade of sewage treatment plants (STPs) in Delhi and Uttar Pradesh, pollution levels remain alarmingly high. The Committee called for a coordinated response from all stakeholders to tackle pollution and restore the river's health. The panel raised particular concerns over encroachment along the Yamuna floodplains. While Delhi and Haryana provided information on encroachments, Uttar Pradesh and Uttarakhand are yet to furnish complete details.

Abandoned, blinded, maimed; each rescued camels breathes a story

anu was abandoned, blind, and helpless. Blackie was rescued from Kingglers. Rani spent years performing in a circus, while Martin, left lame from an injury, was no longer wanted. Each of them found safety and dignity at the Camel Rescue Centre (CRC) in Bassi, where, for the past 14 years, hundreds of camels have been treated and rehabilitated.

Established in 2011 by Help In Suffering (HIS) with support from the ELSU Foundation, the centre provides critical medical care for working camels-those used in transport, brick kilns, and tourism.

Located 30 km from Jaipur, it has become a sanctuary for camels suffering from injuries, malnutrition, and disease. With a full- time veterinary team, CRC

treats 250-350 camels every month, offering emergency care and long-term rehabilitation.

'The centre is part of HIS's camel welfare programme, running since 2001. Each year, 5,000-7,000 camels receive free veterinary care through mobile clinics, reaching remote areas where medical services are scarce. HIS also conducts annual treatment camps at major camel hubs like Pushkar, Jaisalmer, and Nagaur, treating thousands of camels during these events," said Timmie Kumar, Managing Trustee, HIS.

Beyond medical care, HIS has introduced humane welfare measures, such as replacing wooden nose pegs with gentler alternatives, fitting over 1,000 camel carts with reflectors to prevent accidents, and conducting regular deworming programmes for 2,000 camels annually.



For many families, camels are their livelihood, yet without proper veterinary care, these animals suffer from preventable illnesses and injuries. The Bassi

centre bridges this gap, ensuring camels receive treatment while also training owners in better welfare practices.

The centre was set up because there was

nowhere else for these camels to go, added Kumar. "We have treated, rescued, and rehabilitated thousands, but beyond the numbers, it's about relieving suffering and supporting the people who depend on them," he further said.

CRC veterinarians routinely treat camels for lameness, infections, digestive disorders, and respiratory diseases. Its mobile team reaches remote areas where veterinary care is often unavailable. "Every camel has a story," said Dr. Abhinav Swani, Veterinary Doctor at CRC, Bassi.

Many have worked in extreme conditions for years. Others are abandoned once they are no longer useful. The Camel Rescue Centre is one of several animal welfare initiatives by Help In Suffering (HIS), Jaipur, which continues to be a beacon of compassion for Rajasthan's gentle giants.

Special attention should also be given to the well-being of ele-phants residing in the state's forests. Proper arrangements for their food should be ensured by developing grasslands, preventing them from straying into populated areas in search of food. This initiative will help mitigate crop damage for farmers and foster coexistence between humans and elephants instead of conflict. Dr. Yadav gave these directives while presiding over the 15th general meeting of the Madhya Pradesh Tiger Foundation Committee at

To achieve this, the state should seek guidance from the Central Government, the Central Zoo Authority, and other wildlife institutions to establish a wildlife rescue center-cum-zoo with enhanced facilities. Observing wildlife in their natural habitat is always an attraction for tourists, and efforts should be directed toward enhancing wildlife tourism in the state. In such cases, if funds are not available from other sources, immediate financial aid of up to Rs 5 lakh per case will be provided. Additionally, if an air ambulance is required, the necessary amount will be covered from the Corpus Fund approved under wildlife protection schemes by the Madhya Pradesh Tiger Foundation Committee.

n a shocking incident from Rewa city, a stray dog was found carrying a dead newborn baby in its mouth, prompting the police to initiate a thorough investigation to identify those responsible for abandoning the infant. A disturbing video capturing

the dog wandering through narrow alleys at night with the infant's body clutched in its jaws has gone viral on social media, sparking public out-

The unsettling footage was reportedly recorded near Kabaddi Mohalla at Jaystambh Chowk, within the jurisdiction of the Civil Lines police station.

This incident marks the third case in Rewa within the past one-and-a-half months where a newborn has been found dis-



uring the proceedings of the Madhya Pradesh Legislative Assembly, Speaker Narendra Singh Tomar issued an important directive on Thursday regarding the language used by the esteemed members during debates.

The directive was given during the discussion on the motion of thanks to the Governor's address. The Speaker empha-sized the need to maintain decorum and avoid the use of unparliamentary language and personal accusations. Referring to certain unpleasant exchanges that occurred during the debate, he highlighted the dignified tradition of the Madhya Pradesh Assembly, which has earned it a distinguished reputation across the country. However, he expressed concern



over the increasing use of inappropriate language and stressed the collective responsibility of all members to uphold the

Assembly's dignity. House." In another significant matter, Speaker Narendra Singh Tomar advised the state government to formulate a comprehensive action plan to address the damage caused to crops by ghoda roj (wild horses) in several regions of Madhya Pradesh.

During the Question Hour on Thursday, Member Vipin Jain raised a query regarding the government's measures to prevent crop damage caused by ghoda roj and the steps being taken to curb the increasing road accidents resulting from their movement. Relentless heat wave grips MP, temperatures soar across the State

he mid-March heat wave has begun to create significant discomfort for residents across Madhya Pradesh, forcing people to adapt their daily routines to cope with the escalating temperatures. The relentless rise in mercury levels is not only affecting regular activities but is also exerting additional pressure on students appearing for their annual examinations. The sweltering conditions are making it increasingly challenging for them to maintain focus and perform well under the scorching heat.

Daytime temperatures soared above 36°C across most parts of the state, with the only respite being in Pachmarhi. The hill station, due to its higher elevation, remained relatively cooler compared to the rest of the region. The rising heat is not limited to the daytime. Night temperatures are also climbing steadily, making evenings warmer than usual. This persistent heat during both day and night is amplifying the discomfort felt by residents. With no immediate relief in sight, the oppressive heat is expected to intensify in the coming days. Meteorological experts have warned that the

bances could cause a temporary dip in temperatures in northern regions, but their influence on the central parts of the country remains minimal. In fact, the third week of March is likely to see a further increase in humidity levels across Madhya Pradesh, making the already harsh conditions feel even more oppressive.

The eastern regions of the state, including the Jabalpur, Rewa, Sagar, and Shahdol divisions, are expected to experience the full brunt of the heat wave starting March 14. Over the past 24 hours, the weather remained dry across all divisions of the state, with a sharp increase in tematures articularly noted in the Rewa division. In contrast, other divisions did not witness major fluctuations during the same period. In the Indore division, day temperatures have risen above normal levels, reflecting the broader warming trend across the state. Similar patterns have been observed in the Bhopal,

Narmadapuram, Ujjain, Rewa, Jabalpur, Shahdol, and Sagar divisions, where temperatures have climbed appreciably above seasonal norms. Meanwhile, the Gwalior division has experienced a particularly pronounced rise in daytime temperatures, making outdoor activities increasingly arduous.

Nighttime conditions across the state mirror the upward trajectory seen during the day. While most areas reported stable nighttime temperatures, the Bhopal, Ujjain, and Rewa divisions recorded above-average minimum temperatures. In the Indore and Gwalior divisions, the rise was even more significant, with night te increasing appreciably beyond the usual range. Other regions of the state, however, experienced night temperatures that remained within the normal range. The escalating heat is beginning to disrupt daily life, making routine tasks challenging for residents.

Dr. Bhavana Sharma, HOD Ophthalmology, informed that the week-long program includes a range of activities such as expert lectures by leading ophthalmologists, skits for public education, free glaucoma screening camps, and the dissemination of information through social media and news portals. She emphasized the need for

regular eye check-ups, particularly for individuals over 40

years of age and those with a family history of glaucoma. Diagnostic tests such as eye pressure measurement, visual field testing, and fundus examination are essential in early detection and treatment. Highlighting the significance of this initiative, AIIMS Bhopal Executive Director Prof Ajai Singh said: "Glaucoma is a serious public health concern that demands urgent atten-

tion. The lack of symptoms in the early stages often leads to late diagnosis, resulting in irreversible blindness. Through this initiative, AIIMS Bhopal aims to increase awareness, make screening accessible, and ensure that people at risk undergo timely examinations.

hief Minister Mohan Yadav, while delivering I the vote of thanks in the assembly on the Governor's address, stated that the Madhya Pradesh Assembly operates in adherence to democratic valuespresenting viewpoints, listening to opposition opinions, and providing appropriate responses. He expressed gratitude to the Speaker for introducing new traditions and systems in the assembly, emphasizing that in changing times, it is essential to adapt and evolve while recognizing the significance of time. Yadav stated that the Governor's speech serves as a roadmap for the bright future of our state, integrating new characteristics and strategies. He emphasized that the speech reflects the thoughts of great personalities of our time, incorporating the worldview of Mahatma Gandhi, the vision of Bharat Ratna Dr. Babasaheb Ambedkar, and the development-oriented approach of Prime Minister Narendra Modi Chief Minister Dr. Yadav stated that from 2003 to 2023, the

state's economy strengthened due to good governance, effective

policies, and development-oriented schemes. He highlighted that in 1960, Madhya Pradesh's per capita income was 80 percent of the national average. However, due to poor governance, weak policies, and economic mismanagement, it declined to just 60 percent by 2003. The state's economic growth rate, which was 4.43 percent until 2002-03, has now risen to 11.05 percent. Similarly, the state's GDP, which stood at Rs 71 thousand 594 crore in 2002-03, has now surged to Rs 15 lakh 03 thousand 395 crores. The per capita income, which was Rs 11,718 annually, has increased to Rs 1 lakh 52 thousand 615 per year. Madhya Pradesh is now among the fastest-growing states in the country, with the agriculture sector contributing 44 percent to its economy.

Ge stated that from 2017-18 to 2023-24, the labour force participation rate in Madhya Pradesh has increased from 59.3 percent to 72.7 percent, surpassing the national average. He attributed this growth to the state's effective labour policies.

Highlighting the state's financial progress, he noted that the bud-

get for 2002-03 was merely Rs 23,161 crore, whereas the government has now presented a budget of Rs 4 lakh 21 thousand 32 crore for 2025-26. He further expressed confidence that the state's budget will double in the next five years.

Yadav stated that, according to NITI Aayog's Fiscal Health Index, Madhya Pradesh ranks first in the country in terms of quality of expenditure, a matter of pride for all. He highlighted that against the budget estimate of Rs 3.14 lakh crore for 2023-24, the total expenditure by all departments reached Rs 3.04 lakh crore, achieving approximately 97 percent utilization. Furthermore, in the year 2024-25, 76 percent of the total budget has already been spent by various departments.

Chief Minister Dr. Yadav stated that the industrial growth rate of Madhya Pradesh, which was just 0.06 percent in 2002-03, has surged to 24 percent in 2024, marking an industrial revolution in the state over the past two decades. He highlighted that several major industries have

development. The state government is actively promoting industries at all levels, including through the start-up policy and MSME support. Chief Minister Dr. Yadav urged MLAs from both the ruling and opposition parties to work collaboratively to foster industrial growth in their respective regions. He also announced the decision to form development committees at the district level. Additionally, 54 services across 14 departments are now being provided to industrialists through a singlewindow system to streamline processes and enhance ease of doing business.

Chief Minister Dr. Yadav stated that under Sampada 2.0, a new system has been introduced for property registration through eregistration and e-stamping. To provide relief to the common man, the state has also launched the cyber tehsil system, which will save both time and money. He highlighted that over 80 lakh pending revenue cases have been resolved in three phases through the Revenue Maha

ership rights to 39 lakh people under the Svamitva Yojana. To improve public access to police services, the boundaries of 627 police stations have been redefined. Furthermore, an Administrative Unit Reorganization Commission has been established to reassess and re-determine the boundaries of districts, divisions, and tehsils for better governance. The Chief Minister stated that Tatya Tope University has been

Only surviving INA vetran celebrates 99th birthday

Madavan Pillai, one of the last surviving veterans of the INA, celebrat-Ked his 99th birthday on Thursday with a visit to the National War Memorial and had a special message for India's youth –embrace the unity, faith and sacrifice espoused by Netaji.

Several officials of the Indian Army were also present when Pillai arrived at the memorial in a wheelchair to pay homage to fallen heroes at the National War Memorial and to Subhas Chandra Bose at his statue at India Gate.

Holding a walking stick, he was helped by an Army official to the 'Amar Jawan Jyoti' to lay a ceremonial wreath and pay his tributes to the fallen bravehearts. Despite ageinduced infirmity, he looked up and saluted with pride writ large on his face. Bespectacled Pillai later also wrote his thoughts in a visitor's book. The ceremony, hosted by the Army, stood as a powerful reminder of India's enduring legacy of sacrifice and patriotism.

"Youth must work for the country and take the nation forward. Netaji taught us unity, faith and sacrifice, follow these three (values), then you can make a strong nation. Work by staying together ... Number one, even ahead of America, we (India) should be (in growth)," he said after paying tributes. "Lt R Madavan Pillai, born on March 13, 1926, in Swryan Township, Burma (now Myanmar), is one of the last surviving INA veterans. He belongs to a family originally from Tamil Nadu and joined the Indian Independence League as a civilian before enlisting in the Azad Hind Fauj (INA) on November 1, 1943," an official said.

The INA veteran commemorated his birth anniversary with the wreath-laying ceremony at the National War Memorial as

he entered the 100th year of his eventful life.

After laying a wreath at the solemn memorial, he paid tribute to Netaji at Bose's statue under the India Gate canopy. A wreath was placed next to the reflecting pool surrounding the canopy by the INA veteran. Serving as a recruiting officer and a fund-raiser, Pillai mobilised support for the INA across 32 locations in Burma (now Myanmar), including Hanthawaddy, Sawbwagale, Ywadanshe, Swryan, Yangon and Mayongone.

His active involvement in the freedom

struggle led to his imprisonment in a Rangoon (now Yangoon) jail from May to December 1945, officials said. "Later, he served in the Administrative Branch at the INA Headquarters in Rangoon under Major General K P Thimayya (elder brother of General K S Thimayya).

He was officially recognised as a freedom fighter by the government of India on August 1, 1980," a senior official said. In 2021, on the 125th birth anniversary of Netaji, he was awarded a silver medal for his role in the INA and India's Independence movement

On January 23, 2024, Prime Minister Narendra Modi felicitated him at the Parakram Diwas celebrations at the Red Fort, they said. Even at 99, the INA veteran remains an active advocate for keeping Netaji's and the INA's role alive.

The Azad Hind Fauj was first formed by Mohan Singh in 1942 and later revived by Netaji on October 21, 1943. United by the powerful war cry of 'Chalo Delhi', the INA aimed to secure India's complete independence from British rule, the officials said.

India announces \$1 Billion fund to boost creators' economy

\$1 Billion fund is being created to boost the India creators' econ-A omy, said Ashwini Vaishnaw Union Minister of Information and Broadcasting, Railways and MeitY at Global Media Dialogue ahead of the World Audio Visual and Entertainment Summit (WAVES) on Thursday. The function took place at Sushma Swaraj Bhawan, New Delhi, to encourage participation from various governments before the WAVES Declaration in Mumbai on May 2.

In his keynote speech, Minister Vaishnaw announced that a \$1 Billion fund will be created for the creators' economy. This fund will be dedicated to ensuring that the energetic creators, who are using the latest technologies today, will be able to access capital, hone their skills, upgrade their production levels, and reach the global market.

The Union Minister also clarified that the Global Media Dialogue will not focus on regulation but will serve as a platform for exchanging views and sharing perspectives.

Speaking on Cabinet approving the establishment of the Indian Institute of Creative Technologies (IICT), similar to IITs, IIMs, and AIIMS —Vaishnaw said that IICT will be established in Film City, Goregaon Mumbai, and to establish IICT, ₹391 Crore has already been sanctioned.

Vaishnaw shared that over 25 Lakh submissions were received, more than 80000 creators participated and out of which only 1000 will be selected. "...so, it is a democratic online process. The vision behind this initiative, as stated by the Prime Minister, is to bring together the creative world and modern technological usage to create unique content," he said.

The Minister also highlighted that over 100 countries are participating in it and it is a confluence of tech, media and entertainment. "Technology will serve as the base for this (WAVES) platform, bringing creators together from diverse fields," he added.

Committee suggests expanding health coverage

rationalised to 60 years and above irrespective of the people's socio-economic status in order to widen the coverage of the Ayushman Bharat health insurance scheme.

Keeping in view the huge expenditure on critical healthcare, the Departmentrelated Parliamentary Standing Committee on Health and Family Welfare in its 163rd report presented in Rajya Sabha on Wednesday also recommended revising healthcare coverage from the existing ₹5 Lakh per family per year to ₹10 Lakh per family per year.

It also pointed out that several highend interventions/procedures and even high-end diagnostics are not included in Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY).

The panel thus recommended that the number of packages, procedures covered under the Yojana should be reviewed and the fresh packages, procedures related to treatment of critical illness with high cost of treatment and expensive high-end investigations, diagnostics like radiological diagnostics (CT, MRI and imaging including nuclear imaging) be incorporated in AB-PMJAY instead

of leaving the same to be booked as addon packages.

The committee appreciated that the government has recently expanded the AB-PMJAY to cover six crore senior citizens of age 70 years and above belonging to 4.5 Crore families under the Vay Vandana scheme, irrespective of their socio-economic status.

An amount to the tune of ₹1,443 Crore has been earmarked for the treatment of senior citizens of the age of 70 years and above holding Ayushman Vay Vandana Cards. "The Committee is of the view that the age criteria of 70 years and above for Ayushman Vay Vandana Cards should be rationalised to 60 years and above irrespective of their socio-economic status for widening the coverage of the scheme in the better interest of common masses," the panel said in its report.

The committee, however, pointed out a persistent trend of underutilisation of allocated funds, particularly in the previous year as well as in the current financial year.

It stated that the AB-PMJAY is a pivotal and visionary health initiative aiming to provide financial protection and

like budget utilisation and state participation. The committee observed that in the FY 2023-24, ₹7,200 Crore was allocated as budget estimates (BE) 2023-24 which was reduced to ₹6,800 Crore at revised estimates (RE) stage, however, the actual expenditure was ₹6,670.47 Crore.

In 2024-25, ₹7,300 Crore was made in BE 2024-25 which was revised to ₹7,605.54 Crore at RE 2024-25, however, the actual expenditure was to the tune of ₹5,034.03 Crore till January 9.

In 2025-26, the enhanced amount of ₹9,406 Crore has been allocated as BE 2025-26.

This indicates potential inefficiencies in fund disbursement or implementation bottlenecks. The committee, therefore, recommended a thorough review of the fund release mechanisms to states and Union Territories (UTs). This review should focus on identifying and eliminating bottlenecks that contribute to underutilisation.

The department should implement a system of proactive monitoring of fund utilisation by states, coupled with targeted support to address any implementation challenges. Furthermore, the committee suggested that the release of funds be linked to the performance of states in terms of card creation, hospital admissions and beneficiary feedback, ensuring that funds are directed to areas of greatest need and impact.

Fire breaks out in Gurugram's KOD

Firefighters douse a fire which broke out in Kingdom of Dreams, in Gurugram, Thursday

major fire broke out in Gurugram's Kingdom of Dreams (KOD) in Sector-29 on Thursday morning.

Officials said that there were no casualties in the fire accident that took place around 11 am on Thursday. An electrical short circuit inside the KOD is suspected to be the cause of the fire. In July 2022, the Haryana Urban Development Authority (HUDA) sealed the KOD due to outstanding dues of crores of rupees. Since then, there have been no theatre shows or other entertainment and cultural programs in it, and it was closed for two years.

PT fighting operation went on for one and a half hours before the blaze was completely doused. According to the fire brigade officials, a security guard in the KOD reported the fire, but by the time the fire-fighters arrived at the spot, the blaze had engulfed the Cultural Lane inside the KOD. Investigations are underway to ascertain the losses and damage caused in the fire accident.

"When we reached the spot, they were engulfed in fire. Fire tenders were immediately called from different fire stations. As furniture was inside, the fire spread rapidl through the KOD," said a fire official. Gulshan Kalra, Deputy Director (Technical) of the Fire Department, said a short circuit is suspected to have caused the fire, the exact reason is yet to be ascertained.

CBI probes gold smuggling case involving Ranya Rao

he Central Bureau of Investigation (CBI)has launched a probe into the L alleged role of public servants in facilitating gold smuggling from Dubai following a complaint by the Directorate of Revenue Intelligence(DRI), which recently made two arrests, including that of actor Rabya Rao, from Bengaluru, officials said on Thursday.

The DRI arrested Ranya Rao from the Kempe Gowda International Airport in Bengaluru on March 3 for allegedly trying to smuggle over 14 kg of gold from Dubai.

The action was followed by the arrests of two foreigners (Omani and UAE nationals), also coming from Dubai, from the Chhatrapati Shivaji Maharaj International Airport in Mumbai while attempting to smuggle 21.28 kg of gold into India valued at Rs 18.92 crore on March 6. "These two foreign nationals previously arrived at the Mumbai airport multiple times," the DRI complaint to the CBI said.

Searches at Rao's residence led to the recovery of gold jewellery worth Rs 2.06 crore and Indian currency amounting to Rs 2.67 crore. She also made multiple international travels, including to and from Dubai, officials said.

These arrests in "quick succession" involving alleged smugglers with large quantities of gold coming from Dubai and the high frequency of these visits involving Indian and foreign nationals sent the alarm bells ringing about a "coordinated smuggling syndicate", possibly operating from Dubai, the officials said.

The DRI roped in the CBI because of the larger national and international ramifications.

96 districts hit by water contamination: Parliamentary panel PIONEER NEWS SERVICE New Delhi ing comprehensive solid and liquid waste

parliamentary panel has raised A concerns over water contamination issue in the country, highlighting that 11,348 habitations in 96 districts across seven states have not been provided with short-term measures for pollutants such as iron, nitrate, and heavy met-

In its report tabled in Parliament on Tuesday, the Standing Committee on Water Resources has urged the Centre to take swift action to ensure safe drinking water in these vulnerable regions.

The report further revealed that uranium contamination remains a pressing issue in Punjab, where 32 habitations across nine districts are affected.

Despite interim measures in 22 of these

areas, 10 habitations still await any mitigation efforts, it said. The committee has called for urgent and long-term interventions to safeguard public health.

"The Committee notes that all arsenic and fluoride affected habitations have been covered by community water purification plants as an interim measure. However, they (panel) further observe that there are 11,348 quality affected habitations (iron, salinity, nitrate, and heavy metals) spread over 96 districts of seven states where short-term measures have not been provided," the report said.

The government has also extended the Swachh Bharat Mission (Grameen) Phase II until 2025-26, maintaining an annual budget of ₹7,192 Crore.

This phase focuses on sustaining Open Defecation Free (ODF) status and achiev-

management (SLWM) in rural India, the panel said.

As of January 2025, 5.62 Lakh villages have declared themselves ODF Plus, with 4.21 Lakh achieving the advanced 'Model' category.

However, the committee raised concerns about underutilization of funds during the financial year 2024-25, where only 33 per cent of the revised budget was spent.

Delays in adopting the new 'just-intime' fund release system, integrated with the Reserve Bank of India's e-Kuber platform, have been cited as a major bottleneck, according to the report.

Rahul calls exam paper leaks a systematic failure

IIT-Guwahati unveils plan to prevent student suicides

ce-breaking sessions for freshers during their first week on campus, morning walks with faculty members, mandatory counselling sessions and comprehensive medical check-ups, and stress escape room workshops are part of IIT-Guwahati's plan to ensure students' mental wellbeing and prevent suicides.

The measures come after the institute faced massive protests last semester following back-to-back student suicides.

According to Indian Institute of Technology (IIT)-Guwahati Director Devendra Jalihal, the institute has chalked out a comprehensive plan to prevent suicides among students. "We have established a dedicated mental health and counselling system in the form of a Center for Holistic Wellbeing. SAATHI Counselling Club, a part of this centre consisting of student volunteers, sup-

ports fellow students in their mental and on campus, there will be no classes but overall wellbeing with the help of professional counsellors," he said.

We are exploring roping in retired army personnel as hostel special stewards who will routinely interact with the students to make them comfortable and share their observations with the counsellors. All of this will be done in a confidential manner and while ensuring that the students do not feel intimidated or there is no violation of their privacy," Jalihal said.

Nutritionists are also being hired to help the students with diets that can help address anxiety and stress, he added. Faced by suicides among students, several IITs are taking different measures to address concerns over their mental health.

Perumal Alagarsamy, the dean of student affairs at IIT-Guwahati, is spearheading the mental wellbeing initiatives on campus. "We have decided that for the first week, when the freshers arrive an acclimatisation programme so they do not feel out of place. The students will be invited for morning walks with faculty members so they are able to build a rapport with each other before entering the classroom," Alagarsamy said.

'The Peer Mentorship Programne aligns with this notion by assigning peer mentors to the new students. These mentors (will) play a pivotal role in providing relevant information, clearing doubts, and assisting with various challenges, serving as guiding lights for the newcomers when they feel lost," he added. As soon as the freshers arrive on campus, an ice-breaking session will be conducted to establish a warm and inclusive atmosphere and facilitate connections, Alagarsamy explained.

"These sessions aim to raise awareness about mental health and overall wellbeing while acquainting the students with the resources and the support available through the Counselling Cell and the

Center for Holistic Wellbeing," he said.

"These ice-breaking sessions will be conducted within each hostel to help expand the students' social networks, enabling them to connect with their peers through enjoyable games and activities," he added.

To help the students cope with the pressure of semester examinations, the SAATHI Counselling Club recently conducted a stress escape room workshop aimed at sharing knowledge on dealing with and manage stress and exploring entrepreneurship and career choices.

The institute has four full-time counsellors while Your Dost a start-up incubated at IIT-Guwahati has been roped in to provide round-the-clock access to the counsellors.

Mandatory interactions will be scheduled with the counsellors for all students so any early signs can be identified and mandatory comprehensive health checks conducted

UP gears up for Holi, Friday prayers amid tight security

s Uttar Pradesh prepares to celebrate Holi on Friday, which coincides with the holy month of Ramzan and the offering of Friday prayers (Jumma), the state administration is leaving no stone unturned to ensure communal harmony and peaceful celebrations.

To prevent any tension between the two communities, the government, in coordination with religious leaders, has made special arrangements, including altering the timing of Friday prayers and enhancing security across the state.

In a precautionary measure, the Uttar Pradesh Police have directed authorities to cover mosques with tarpaulin in most districts where Holi processions pass through sensitive areas. So far, 189 mosques have been covered with tarpaulin across UP. The move aims to prevent any untoward incident and maintain religious harmony during the festivities. In Sambhal district, where communal tension has flared up in the past, the administration has covered at least ten mosques with tarpaulin to avoid any damage during Holi processions. The district is considered sensitive due to its demographic composition and history of communal clashes.

Sambhal District Magistrate Rajendra Pensia emphasised that robust security arrangements are in place. Multiple peace committee meetings have been held, and 27 Quick Response Teams (QRTs) have been deployed in sensitive areas. The city has been divided into six zones and 29 sectors, each overseen by a magistrate and senior police officer. PAC (Provincial

Armed Constabulary) battalions have been stationed as part of a three-tier security plan. To enhance monitoring, 250 CCTV cameras have already been installed, with an additional 100-150 cameras set up for real-time surveillance. Drone technology is also being used to track movements in crowded areas. Similarly, in Shahjahanpur, mosques located on the routes of Holi processions have also been covered to prevent any provocative incidents.

To further ease the situation, the Shahi Imam of Lucknow's Eidgah, Maulana Khalid Rashid Farangi Mahali, announced that Friday prayers will be offered at 2 pm instead of the usual 12:45 pm. This decision has been welcomed by Muslim religious leaders across the state, including Ayodhya, where the chief cleric has also decided to conduct namaz after 2 pm.

The Uttar Pradesh Police have issued strict guidelines, urging citizens to celebrate Holi in a peaceful manner and avoid any new traditions that could spark tension. Additional police forces have been deployed in sensitive areas, and drone surveillance will be conducted in districts like Kanpur, Aligarh and Meerut to monitor crowd movement. Yogi Adityanath has appealed to people to respect each other's religious sentiments. "Holi comes once a year, but Friday prayers is held every week. Those who wish to avoid the festive chaos can offer pravers at home," he said

The administration is also keeping a close watch on social media platforms to prevent the spread of fake news and inflammatory content. With these proactive measures, the state hopes to celebrate Holi and Friday prayers in an atmosphere of peace and brotherhood.

ASI team inspects Jama Masjid in Sambhal

cting on the directives of the Allahabad High Court, the Archaeological Survey of India (ASI) team visited the historic Jama Masjid on Thursday to assess the site for whitewashing and decoration ahead of the holy month of Ramzan.

The court's intervention came after the Jama Masjid Committee filed a petition seeking permission for whitewashing and decoration, a tradition that has been followed every year during Ramzan. However, this year, the local administration denied the request, prompting the mosque committee to approach the High Court.

During the initial hearing, the High Court directed the ASI to conduct a site inspection and submit a report on the condition of the mosque. In its report, the ASI stated that there was no need for whitewashing, and only cleaning work could be done. However, after hearing the arguments presented by the mosque committee, the court ordered the whitewashing and decoration of the mosque, with the condition that the process would be carried out under the supervision of the Archaeological Survey of India.

On Thursday, the ASI team arrived at the mosque for measurements and assessment. Jama Masiid Committee office bearer, Advocate Zafar Ali, stated that the team will identify the specific areas where whitewashing is required. If the team provides instructions by today, the work will begin immediately. Otherwise, the whitewashing process will commence from Monday.

"After the whitewashing is done, the decoration work will also be carried out

as part of our tradition during Ramzan," said Zafar Ali. The mosque committee revealed that every year, the mosque is whitewashed and decorated before the holy month of Ramzan. However, this year, the local administration refused to grant permission for the same, leading to legal action.

The High Court, after reviewing the ASI report and hearing the arguments from the mosque committee, granted permission for the whitewashing and decoration of the mosque. However, the court instructed that the entire process

would be monitored by the ASI to ensure that no structural or historical damage is caused to the heritage site.

The ASI's role will be crucial in determining the extent of whitewashing and decoration. The team will assess the condition of the walls and other structures and specify the areas that can whitewashed. The mosque committee expressed satisfaction with the court's decision and assured full cooperation with the Archaeological Survey of India team.

This decision comes as a relief to the Muslim community, as the beautification of the mosque ahead of Ramzan holds great religious and cultural significance. The mosque committee hopes that the whitewashing and decoration will be completed before the start of the holy month.

Maharashtra's police to address each other without surnames

Dolice personnel in Maharashtra's Beed district will now put up their name plates without surnames, in an attempt to eliminate caste-based discrimination, an official said on Thursday. Nearly 100 such name plates have been distributed across police stations and other offices of the department in the central Maharashtra district, the official said. Earlier, Beed Superintendent of Police (SP) Navneet Kanwat in January directed the officials to address each other by their first name, and not surname, with an aim to curb the caste bias. Now, the SP's office has distributed name plates, for display on tables in the offices of the security personnel, which do not have a mention of their surname, the official said. The small name plates put up by police on their uniforms will have to be made individually without them displaying their surnames, the official said.

Kanwat was posted as the SP of Beed in December last year after the murder of Massajog village sarpanch Santosh Deshmukh, who was abducted, tortured and killed for trying to stop an extortion attempt against an energy firm operating a windmill project there.

Deshmukh's murder on December 9, 2024, had acquired a caste angle as the victim was a Maratha, while most of the accused are Vanjari, a dominant community in the Beed region.

17 Naxalites surrendered in Chhattisgarh

reventeen Naxalites, nine of them S collectively carrying cash rewards of ₹24 Lakh on their heads, surrendered in Chhattisgarh's Bijapur district on Thursday, a senior police official said. The cadres, including a couple, turned themselves in before senior police and Central Reserve Police Force (CRPF) officials here, he said.

The Naxalites cited disappointment with the "hollow" and "inhuman" Maoist ideology, exploitation of innocent tribals by senior cadres and increasing influence of security forces, Bijapur Senior Superintendent of Police Jitendra Kumar Yadav said. They were also impressed with the 'Niya Nellanar' (your good village) scheme under which security forces and administration have been striving to provide basic amenities and carry out development works in interior areas, he said.

All the surrendered Naxalites were active in different capacities in the Gangaloor area committee of the outlawed Maoist organisation, he said. Of them, Dinesh Modiam (36), a divisional committee member of Maoists, was wanted in 26 cases in Bijapur district and carried a reward of ₹8 Lakh, the senior police official said. Modiam's wife Jyoti Tati, alias Kala Modiam (32), and Dula Karam (32), both active as area committee members, carried a reward of ₹5 lakh each, he added.

ASI dies after scuffle in Bihar

n assistant sub-inspector (ASI) died after a scuffle between police personnel and a group of people broke out in Bihar's Araria district, a senior officer said on Thursday.

The incident occurred in Lakshmipur area under the jurisdiction of Phulkaha police station on Wednesday night when a police team went there to nab a person, and subsequently a brawl broke out between the personnel and those protesting the arrest, Araria Superintendent of Police Anjani Kumar said.

"The incident took place when the ASI along with other police personnel went to Lakshmipur to nab Anmol Yadav, wanted in a case. When the police team arrested Yadav, locals started protesting.

The accused was taken away by locals and the ASI fell unconscious during the scuffle," the SP said.

The ASI was immediately taken to the nearest hospital where he died during treatment, Kumar said. The deceased has been identified as Rajeev Ranjan.

The body of the ASI has been sent for post-mortem examination, the SP said.

"The body did not bear any external injury marks. Preliminary investigations have revealed that the ASI was not assaulted by the locals. Investigation is on...And the exact cause of death can only be known after the post-mortem report," he said.

A manhunt has been launched to nab Yadav, and efforts are on to identify those who forcibly freed him from the clutches of police, the SP added.

n a startling revelation, the drone empanelment process has been allegedly rigged by the Department of Agriculture, Andhra Pradesh and its Technical Team headed by Dr Sambiah Angirekula has allegedly favoured two local firms namely Drogo Drones Private Limited and Vihanga Technologies Private Limited in the process.

According to a complaint letter to the Principal Secretary, Department of Agriculture, AP, the Vihanga Technologies did not have the mandatory Type Certification even after the EOI submission deadline, however they were selected. The complaint mentioned, Drogo Drones lacked the mandatory technical specifications such as the 'Detect and

Avoid Capability' as per their certificate but was selected without any scrutiny. Vihanga Technologies is also acting as a Benami Company for Drogo with the sole intention to create an illusion of competition for the empanelment, alleged the letter. It alleged the trials conducted by Dr Sambiah and the technical team issued heavy restrictions on speed and battery recharging which was not mentioned in the EOI. This was followed with objective of disqualifying all companies except Vihanga and Drogo Drones that had a higher battery capacity, read the complaint a copy of which is with The Pioneer.

₹100 Crore scam: Drone empanelment rigged in Andhra

The other companies, as furnished in the complaint with more than 250 pages of annexure, were disqualified without any valid reasons stating that the drones suffered deviations from their Type Certification which is completely false. Moreover, the drones of Drogo in fact suffer significant gaps from the Type Certification as per the test reports they submitted. The battery capacity, life cycles are below the minimum requirements and their software is completely different from the certification approved by the DGCA, highlighted the complaint.

"All drone manufacturers except Drogo and Vihanga were subjected to intense scrutiny and were disqualified without valid reasons, whereas, the firms that did not have a type certification and mandatory technical features were selected and qualified through a biased process. The project is worth ₹100 Crore for supply of 875 drones which has been awarded through an unfair and rigged selection process," said an industry insider.

No pressure to withdraw CID probe into Ranya Rao case, says **Parameshwara**

arnataka Home Minister G Parameshwara on Thursday said There was no pressure on him to withdraw a CID probe into the gold smuggling by Kannada actress Ranya Rao.

Karnataka government withdrew its order for a CID investigation into the lapses and dereliction of duty by police personnel deployed at the Kempegowda International Airport (KIA) with regard to Ranya, within 24 hours after pronouncing it. The Minister said since the Department of Personnel and Administrative Reforms (DPAR) ordered appointing Additional Chief Secretary Gaurav Gupta to probe the possible role of Ranya's step father K Ramachandra Rao, a DGP rank officer, a parallel investigation was not needed.

He insisted that he was the one who immediately ordered CID investigation into the protocol lapses as soon as the mat-ter came to light. "In the meantime, the Chief Minister's Office also gave direction to the Department of Personnel and Administrative Reforms since he (Ramachandra Rao) is an IPS officer. So we decided not to order inquiry by our (police) department and let the DPAR probe it," Parameshwara told reporters here.

Hence, the DPAR order is retained. We withdrew because two separate investigations should not take place, he explained.

Editor's **Balochistan** on the Boil

The deadly train hijacking episode has brought the region's struggle to the fore

he recent hijacking of the Jaffar Express in Balochistan marks another deadly episode in the decades-long struggle for Baloch independence. The attack, orchestrated by the Balochistan Liberation Army (BLA), underscores the escalating insurgency in Pakistan's largest but most neglected province. The Pakistani military's swift operation to neutralise the hijackers may have ended the immediate crisis, but it has done little to address the underlying grievances that continue to fuel the Baloch nationalist movement.

On March 11, armed militants targeted the Jaffar Express, a passenger train traveling from Quetta to Peshawar. The BLA demanded the release of Baloch political prisoners and individuals allegedly abducted by Pakistani security forces. Pakistani military forces swiftly launched a rescue operation. The successful yet costly operation highlights the deteriorating security situation in Balochistan and the growing boldness of separatist groups.

The hijacking is not an isolated incident but rather a continuation of the Baloch people's longstanding quest for self-determination. Balochistan, rich in natural resources but historically marginalised, has seen multiple uprisings since Pakistan's creation in 1947. The roots of the conflict date back to what many Baloch consider a betrayal by Muhammad Ali Jinnah, Pakistan's founder. At the time of Partition, the princely state of Kalat, a major part of present-day Balochistan, opted for independence. However, in 1948, under pressure from Pakistan and with little international support, Kalat was forcibly annexed. This fueled deep resentment among the Baloch people and led to an armed insurgency that has resurfaced in different forms over the decades

Balochistan, despite being rich in resources such as gold, copper, and natural gas, remains the most impoverished province in Pakistan. Baloch nationalists argue that the region's wealth is exploited by the central government, with little benefit to the local population.

The China-Pakistan Economic Corridor (CPEC) has further intensified tensions, as Baloch rebels view Chinese investments and infrastructure projects as a means of increasing Pakistan's control over their land without addressing local grievances. Adding to the discontent are widespread allegations of human rights abuses, including enforced disappearances and extrajudicial killings of activists and civilians. The Pakistani state has often responded with heavy-handed military crackdowns, further deepening resentment

While the Baloch nationalist movement has waxed and waned over the years, recent developments suggest it is gaining momentum. The BLA and other militant groups, such as the Balochistan Liberation Front (BLF), have intensified their attacks on security forces, government infrastructure, and projects associated with CPEC. Targeted assaults on Chinese nationals working in Pakistan further indicate a strategy aimed at destabilising foreign investments and pressuring the Pakistani state. The hijacking of the Jaffar Express is a testament to the insurgents' evolving tactics and growing audacity. By targeting civilian infrastructure and taking hostages, the BLA has demonstrated its capability to conduct large-scale operations, signaling an emboldened separatist movement.

A military response alone will not quell the insurgency. Addressing the root causes-political disenfranchisement, economic marginalisation, and human rights violations-is crucial for any long-term resolution. The ongoing struggle in Balochistan is a reminder of the consequences of neglecting ethnic and regional grievances. Without meaningful dialogue and political solutions, Pakistan risks further destabilisation in its most resource-rich yet volatile province. The recent train hijacking may have been neutralised, but the broader Baloch insurgency remains far from over.

Towards a Fit and Trim India

Prime Minister Narendra Modi's latest initiative to combat obesity and curb excessive oil consumption is timely as obesity rates are rising sharply, underscoring urgent need for preventive healthcare and dietary reforms

rime Minister Narendra Modi's recent initiative to combat obesity and reduce excessive cooking oil consumption has ignited nationwide discussions on health and nutrition. The campaign underscores the importance of preventive healthcare and dietary changes in addressing India's growing obesity crisis. Given the alarming rise in obesity worldwide, this initiative is both timely and necessary and has received support from healthcare professionals, sportspersons, and the World Health Organisation.

India is witnessing a sharp increase in obesity, with the National Family Health Survey (NFHS-5) reporting that 23% of men and 24% of women are now overweight or obese. Urban areas show even higher numbers due to sedentary lifestyles and unhealthy diets. By now, we all know that obesity increases the risk of diabetes, heart disease, hypertension, and certain cancers, placing a heavy burden on India's healthcare system. The WHO has identified obesity as a major global health crisis, and India is rapidly catching up with Western countries in obesity rates.

However, while addressing obesity through lifestyle changes is essential, an even more pressing concern needs urgent attention-food adulteration. In 2018-19, the Food Safety and Standards Authority of India (FSSAI) found that almost one-third of food samples tested in India failed quality checks due to adulteration. Media reports highlight alarming instances of harmful substances being added to food, such as urea, starch, and detergent in milk; synthetic dyes and artificial ripening agents in fruits; chalk in common salt; artificial colors in spices; formalin in fish; iron filings or colored leaves in tea; synthetic whiteners, chalk powder, or soapstone in rice and wheat; and lead chromate in pulses. These adulterants pose serious health risks, including food poisoning, kidney damage, cancer, and neurological disorders.

Food adulteration is now so rampant that, at times, we don't even need food inspectors to detect it. Walk through any vegetable market, and you will see unnaturally shiny apples, bright green peas, pointed gourds, and glossy brinjals. These are not signs of freshness but of harmful chemicals like wax, artificial dyes, and pesticides. Soak vegetables in water, and you may see colors leaching out-clear evidence of adulteration.

While obesity can be managed by raising awareness about the dangers of consuming processed foods with unhealthy make matters worse, fake organic labels

ingredients or overconsuming edible oil and encouraging lifestyle changes, avoiding adulterated food is far more challengng. It is difficult to detect adulteration, and the issue is deeply rooted in systemic flaws in food production and regulation. Unless food adulteration is effectively tackled, even so-called "healthy" choices can be hazardous, exposing consumers to harmful substances despite their best efforts to maintain a nutritious diet. Due to the widespread issue of food

adulteration, many people have stopped eating fruits with their peels or raw salads, fearing pesticide residues and chemical coatings. This shift highlights how food adulteration forces people to compromise on natural and healthier eating habits, ultimately hindering efforts to promote a balanced diet and combat obesity.

With adulteration becoming so prevalent, it's no surprise that people are turning to organic food. The organic food market is expanding rapidly worldwide. In India, it was valued at around \$1.5 billion in 2023 and is projected to reach \$8.9 billion by 2032. However, organic food in India is much costlier than conventionally grown food, making it less accessible to middle-and lower-income groups. To

▲ he concept of a four-day workweek has taken the world by storm, promising enhanced work-life balance and efficiency. However, implementing such a model in a heterogeneous and populous nation like India-home to over 1.4 billion people-presents significant challenges.

India's labor market has distinct complexities, making a four-day workweek more of an aspiration

than an immediately achievable solution. The country's economy encompasses sprawling informal sectors alongside emerging knowledge industries, creating a stark divide in working styles and employment patterns.

The informal economy, which employs approximately 90% of India's workforce, operates beyond conventional employment paradigms. Agricultural laborers, small business owners, and daily wage earners typically work based on demand rather than a fixed schedule. For such workers, a four-day workweek may hold little relevance, as their earnings are directly tied to the number of hours worked.

Conversely, India's expanding service and technology sectors may be better positioned to experiment with compressed workweeks. Some e-commerce organisations have already tested four-day workweeks, reporting promising results in employee satisfaction and productivity. However, these



work schedule, the actual time available for leisure and personal activities might remain limited.

Despite these challenges, there are compelling reasons to explore pathways toward introducing a four-day workweek in India. Research suggests potential benefits, including reduced burnout, lower absenteeism, and improved mental health-factors that could address key workplace issues currently affecting Indian employers.

A sector-specific approach may offer the most viable path forward. Pilot programs in knowledge-intensive industries could serve as testing grounds, allowing successful models to be gradually expanded to other sectors. Additionally, government incentives for businesses willing to adopt such programs could accelerate broader acceptance.

The pandemic has already reshaped work arrangements worldwide, including in India. Remote and hybrid work

Rather than viewing the four-day workweek as a univer sal, short-term solution, India could integrate it into a broader movement toward more flexible, worker-oriented employment practices. While full-scale implementation across industries may be a distant goal, selective adoption in specific sectors could lay the groundwork for wider acceptance as the economy and infrastructure continue to evolve.

The journey toward workweek reform in India will be long, culturally complex, and closely tied to the nation's economic landscape. However, initiating the conversation is a crucial first step in the right direction.

The four-day workweek presents both opportunities and challenges for India. While its informal economy and cultural perceptions pose obstacles, the growing service and technology sectors offer a testing ground for its feasibility. Infrastructure limitations and deep-rooted work traditions may slow widespread adoption, but pilot programs and government incentives could drive gradual acceptance. The pandemic has already reshaped work models, highlighting flexibility's potential. Rather than an immediate, universal solution, a sector-specific approach could pave the way for broader implementation.

EUROPE FIGHTS TRUMP TARIFFS

Madam-The European Union announced on Wednesday, March 12, that it would impose retaliatory trade measures, introducing new duties on U.S. industrial and agricultural products. This decision came just hours after the Trump administration increased tariffs on all steel and aluminum imports to 25 percent. As the world's largest trading bloc, the EU had anticipated the U.S. tariffs and prepared accordingly. However, the measures still place significant strain on already tense transatlantic relations. Just last month, in February, Washington warned Europe that it would need to take responsibility for its own security in the future. The EU's retaliatory measures will initially target U.S. goods worth approximately 26 billion euros (USD 28 billion). These measures will not be limited to steel and aluminum products but will also affect textiles, home appliances, and agricultural goods. Additionally, items such as motorcycles, bourbon whiskey, peanut butter, and jeans will face renewed tariffs. With this, an open trade war has erupted between the European Union and the United States, which may escalate into a serious and dangerous situation in the coming days. The economic impact could extend beyond these regions, affecting countries like India, which may be particularly vulnerable due to its weaker economy. This escalating trade war between the EU and the US threatens global economic stability, with potential ripple effects on various nations.

TRUMP PUSHING INDIA INTO TRADE WAR

Madam - President Donald Trump, who champions the slogan "America First," has drawn India into his trade war. He has threatened that if India does not reduce import tariffs on American goods, the US will impose equivalent tariffs on Indian goods starting in April. This has placed India in a difficult position. Calling India the "Tariff King," Trump argues that the taxes India imposes on American goods are unfair. TRAIN HIJACKING IN BALOCHISTAN EXPOSES PAKISTAN'S FAULTLINES

he recent hijacking of the Jaffar Express in Balochistan has once again highlighted the deep-rooted insurgency in the region. The Balochistan Liberation Army (BLA) seized control of the train, which was carrying over 500 passengers, including 214 Pakistani soldiers.

The group issued a 48-hour ultimatum, demanding the release of Baloch prisoners and the withdrawal of Pakistani forces. In response, the Pakistani military launched a rescue operation, deploying Special Service Group (SSG) commandos Reports indicate that 104 hostages have been freed, while 16 militants were killed. However, several hostages also lost their lives during the operation, further escalating tensions.

The local population has long accused the government of exploiting their resources while denying them political and economic rights. This discontent has fueled multiple insurgencies over the decades, with separatist groups like the

BLA leading armed resistance against the state. The Pakistani military's heavyhanded response, including enforced disappearances and extrajudicial killings. has only intensified the unrest.

Carney: From Central Banker to Prime Minister

Mark Carney's rise from a globally respected central banker to Canada's Prime Minister signals a dramatic shift in the country's political landscape. Among his most urgent tasks is repairing Canada's strained relationship with India, a key economic and geopolitical partner

ark Carney's transition from a globally acclaimed central banker to Canada's Prime Minister marks a profound shift in leadership dynamics. Renowned for his crisis management at the helm of the Bank of Canada and the Bank of England, he now faces the uncharted terrain of political leadership. Taking charge of a deeply divided political landscape, he must navigate a strained Indo-Canadian relationship and the resurgence of protectionism in a Trump-led America.

From Central Banker to Political Leader

3. Reviving discussions on the stalled Canada-India Comprehensive Economic Partnership Agreement (CEPA).

4. Encouraging Canadian investments in India's technology and infrastructure sectors.

5. Attracting Indian investments into Canada's energy and AI industries.

6.Easing visa restrictions for Indian students and professionals to reinforce diaspora-driven relations.

Tackling Khalistani Extremism

Managing the presence of Khalistani elements in Canada remains a significant challenge. Trudeau's perceived leniency toward these extremists led to a diplo-



matic crisis, especially after the Nijjar controversy. If Carney aims to restore relations with India while maintaining domestic stability, he must strike a balance between national security and democratic free-

Carney must also distinguish between moderate Sikhs and extremist Khalistanis, ensuring that law enforcement targets violent elements rather than peaceful Sikh advocacy groups. His approach must be security-driven rather than politically motivatedunlike Trudeau's strategy of appeasement.

Balancing Indo-Canadian Relations and Domestic Politics

Restoring trust with India while managing domestic political sensitivities will require a delicate balancing act. Carney's lack of political baggage allows him to take a fresh approach, while his global reputation ensures India takes his diplomatic overtures serious-

ly. Leveraging economic incentives to reset relations with India could provide him with a major diplomatic victory early in his tenure. However, he will face opposition from pro-Khalistan groups in Canada, accusations of suppressing free speech and resistance from left-leaning Liberals who supported Trudeau's stance. If he implements a balanced policy-cracking down on extremists while protecting legitimate Sikh voices-he can repair Indo-Canadian ties without shaking domestic instability.

The Indian Diaspora's Influence

The Indian community in Canada, comprising approximately 1.86 million individuals according to the 2021 census, represents about 5.1 per cent of the national population. This demographic has significantly influenced Canada's multicultural landscape, particularly in urban centers such as Toronto, Vancouver, Calgary, Edmonton, and Montreal.

Notable political figures from this community include:

Jagmeet Singh: Leader of the New Democratic Party (NDP) since 2017 and the first person of Indian escent to lead a major federal party.

Harjit Singh Sajjan: MP for Vancouver South and former Minister of National Defense.

Anita Anand: Appointed Minister of National



Defense in 2021.

Bardish Chagger: Former Minister of Diversity and Inclusion and Youth.

Chandra Arya: MP for Nepean, Ontario, and advocate for economic development and immigrant integration.

Political Engagement and Diplomatic Tensions

The Indian community's active political participation underscores its commitment to Canada's democratic processes. However, relations between Canada and India deteriorated following the October 2024 murder of Sikh separatist Hardeep Singh Nijjar in British Columbia.

Trudeau accused the Indian government of orchestrating violence against dissidents in Canada, leading to reciprocal diplomatic expulsions and further straining bilateral ties. This crisis has raised concerns among the Indian diaspora, particularly regarding immigration, education, and economic exchanges. For Carney, engaging constructively with the Indian community is crucial. Addressing their concerns, fostering inclusive policies and working toward diplomatic reconciliation with India will be essential steps in strengthening Canada's social and economic fabric.

Domestic Political Challenges

Carney assumes office amid deepening political divides. The Liberal Party has suffered declining public confidence, particularly in Western Canada, where Trudeau's policies alienated oil-dependent provinces like Alberta and Saskatchewan. Meanwhile, right-wing populism has gained traction, mirroring global trends

While Carney's lack of electoral experience may be a vulnerability, his credibility as an economic strategist could help him regain voter trust.

Managing inflation, stabilising interest rates, and addressing affordability concerns will be immediate priorities. Gaining support from both progressive and conservative voters will be crucial for effective governance, while restoring confidence within his party and among centrist voters will determine his political longevity.

Conclusion

Carney's leadership will be defined by his ability to steer Canada through complex domestic and global challenges.

A strategic recalibration of ties with India could elevate his stature, but any misstep-particularly on the Khalistan issue-risks deepening tensions and undermining economic prospects in South Asia. India will also have to understand the priortise and compulsions of the new Canadian prime minister to reboot the relations

Ramzan and Navratri: A Shared Journey of Self-Restraint and Purity

India's fragile trade deal with the US



of all that is good, pure, and noble in the two religions: Islam and Hinduism. The common message for devotees of these respective religions is to achieve excellence in behavior through introspection and self-restraint.

The Father of the Nation, Mahatma Gandhi, once said, "There are limits to self-indulgence, none to self-restraint." Truly, self-restraint plays an important role in shaping human behavior in different societal and cultural settings. The entire concept of social control is based on the type, range, and depth of restraint exhibited in human behavior. More often than not, we see laws being violated, manipulated, and disobeyed because they are externally imposed. In contrast, by practicing selfrestraint, we become the masters of our actions and, in turn, our destiny.

Ramzan, the ninth lunar month in the Islamic calendar, is a period of spiritual reflection and piety, observed through fasting from dawn to sunset and increased charitable deeds by Muslims worldwide.

The objective behind this month-long exercise is to cultivate self-control and self-restraint through fasting, with the goal of achieving excellence in behavior and guarding against evil. According to the Quran (Verse 2:183):

"O you who believe, fasting is prescribed for you as it was prescribed to those before you so that you may become righteous."

Ramzan is seen as a time for introspection and strengthening one's connection with God. One night during Ramzan, known as Lavlat al-Oadr. is believed to be a night of exceptional blessings, during which the Quran was revealed to Prophet Muhammad. The first revelation of the Holy Quran took place on Laylat al-Qadr.

However, fasting does not mean abstaining only from food and water; it also necessarily includes refraining from all evil actions and thoughts. One must not indulge in falsehood, gossip, backbiting, or foul language while fasting.

Once, as Prophet Muhammad was passing through a street with his followers, he heard a woman shouting and abusing others. The Prophet asked, "Who is this woman? Is she a Muslim?" His followers replied, "She is a Muslim and is observing the fast." The Prophet then instructed his followers to offer dates to the woman to break her fast, explaining that by using vulgar language and expressing anger, she had rendered her fast meaningless.

In essence, a fasting person must exercise utmost control to eliminate even the slightest traces of waywardness in behavior and demeanor. The observer of a fast must ensure that their thoughts and deeds remain pure, noble, decent, and benevolent toward others, including all of humanity.

There are two types of sinners: Fasiq-ul-Amal - One who commits sin while knowing it is wrong.

2. Fasiq-ul-Aqeeda - One who commits sin and does not believe it is wrong.

Fasting can refine and purify those in the first category. During Ramzan, believers are given the opportunity for repentance and forgiveness. If a erson sincerely seeks pardon from the Lord for their misdeeds, the Lord listens to their prayers during this holy month.

The faithful are instructed to adopt taqua (refraining from sin and guarding against evil). If those observing the fast do not adhere to this principle, their fast will not be accepted by Allah. As ne Quran (79:40-41) states:

"As for him who fears to stand before his Lord and restrains himself from low desires, Paradise is surely the abode?

Fasting detoxifies the body when observed properly. Namaz (prayer), besides being an act of worship, is similar to yoga and meditation. Prophet

Muhammad's daughter, Hazrat Fatima Zehra, highlighted the benefits of fasting during Ramzan, stating that one of its purposes is to help the rich understand the pangs of hunger experienced by the poor. For this reason, Zakaat (charitable almsgiving) is prescribed during this period. The Quran states:

"And spend in the way of Allah and cast not yourself to perdition with your own hand." It further clarifies:

"He loves those who purify themselves." Someone once asked Hazrat Ali Ibn Abi Talib, the Caliph of Islam, "How do we know that Allah has accepted our prayers during Ramzan?"

Hazrat Ali replied, "If, between the sighting of the moon at the beginning of Ramzan and the sighting of the moon for Eid, you notice a positive change in your behavior, your prayers have been accepted."

Similarly, in Hinduism, Chaitra Navratri is observed between April 2-11, while Sharad Navratri is celebrated in the autumn season, around October-November. According to the Shastras, devotees observing Navratri fasts must practice Brahmacharya (celibacy), as it helps in reducing negative qualities such as anger, pride, deceit, and greed

It also aids in keeping and honoring different vows and commitments in life. Devotees observing the fast should also abstain from falsehood and refrain from using intoxicants like gutka, tobacco, and wine. Consumption of non-vegetarian meals is also prohibited during these periods.

Currently, the month-long Ramzan is being observed, and Chaitra Navratri will be celebrated from March 30 to April 7, 2025. From a cultural

ebration, as people from all corners of the country reside here.

The great Urdu poet, Mirza Ghalib, beautifully captured the fervor of the holy month of Ramzan in Delhi in a letter to his close friend, Mir Mehdi Husain 'Majroh':

"How did you presume that during the month of Ramzan, I would be staying in Rampur? Although Nawab Sahab insisted that I stay in Rampur, tempting me with mangoes, I left and, by 'Chand Raat' (the night before Ramzan), reached Delhi, for Delhi is a place where people feel the pulse of absolute bliss.

"In Delhi, during Ramzan, I have three commitments: At dawn, I go to Masjid Hamid Ali Khan, at Kashmiri Gate, to listen to the soulful recitation of the Holy Quran by Hazrat Qari Jafar Ali Jarchavi; in the evening, I break my fast at Mehtab Bagh, near Jama Masjid; and at night, I perform Namaze-Isha at Jama Masjid. How mirthfully life is passing here!'

Ramzan and Navratri, two sacred observances in Islam and Hinduism, exemplify the virtues of self-restraint, introspection, and spiritual elevation. Both are deeply rooted in religious traditions and serve as periods of reflection, discipline, and devotion, guiding individuals toward moral and ethical excellence.

Spiritual fasting

Ramzan, the ninth month of the Islamic calendar, is a time for fasting, prayer, and increased charitable acts. It is believed that during this holy month, the first revelation of the Quran was bestowed upon Prophet Mohammad on Laylat al-Qadr, a night of immense blessings.

Fasting during Ramzan is not merely about abstaining from food and drink but also about refraining from falsehood, anger, and immoral behavior. The objective is to cultivate 'taqwa'—a heightened sense of God-consciousness and righteousness. Acts of charity, such as 'Zakaat' (almsgiving), further strengthen the bond of empathy between the rich and the poor.

Similarly, Navratri, a Hindu festival observed twice a year, emphasises devotion, purity, and selfdiscipline. Devotees engage in fasting, prayer, and abstinence from material indulgences, aiming to purify the mind and body. Observing celibacy and refraining from falsehood, intoxicants, and nonregetarian food are integral to this practice.

In a culturally diverse city like Delhi, these spiritual occasions are observed with great fervor, reflecting the city's unique ethos of religious harmony. Ultimately, both Ramzan and Navratri remind us that true devotion lies in self-restraint, moral conduct, and a compassionate heart.

ndia is currently in a tight spot regarding its economic relations with the United States. In less L than two months since the new US President took office, high-level Indian officials, led by the Prime Minister himself, have visited Washington, D.C. Last week, India's Commerce Minister was in Washington for discussions with the newly appointed US Trade Representative and Commerce Secretary. According to news reports, Piyush Goyal is expected to return to Washington towards the end of March. The reason? President Trump's simultaneous announcement, during Goyal's visit, of imposing reciprocal tariffs on all countries with high import duties, including India.

President Trump has consistently targeted India as a high-tariff nation since taking office. His pub-

lic outbursts against various allies and friendly countries have become a nearconstant spectacle, akin to a reality show streaming across the globe. Several world leaders who managed early meetings with Trump were relieved that they were spared the harsh treatment that the Ukrainian President faced in the Oval Office. Trump's confrontational style is now well known, and global leaders fear reputational damage from their bilateral conversations with him. He employs his blunt, undiplomatic rhetoric to put foreign leaders in a difficult position, compelling them to

return with lucrative economic deals for the US

It was no surprise, then, that after meeting India's Commerce Minister, US Commerce Secretary Howard Lutnick stated, "We would like to focus on a bilateral conversation just between India and the United States-to bring down the tariff levels that India has, which protect some of its sectors." Following Prime Minister Narendra Modi's visit to the US last month, discussions on a bilateral trade agreement have been actively initiated, with expectations of finalisation by the end of the year. Intense consultations are underway in Delhi, with all relevant ministries contributing their recommendations.

One of India's key priorities is retaining control over the agricultural sector, which has significant domestic political implications. The US is pushing for greater access to the Indian agriculture market, while India seeks reciprocity without jeopardising its small farmers. American farmers, who are generally more prosperous and own larger farmlands, rely on advanced machinery to boost crop output. However, the US Commerce Secretary made it clear that access to India's agriculture market remains a top priority. He stated, "Maybe certain products have quotas. Maybe certain products have limits... And then we do the same thing on the other side and craft an agreement that makes sense for both of us. The Indian agriculture market has to open up. It can't just stay closed."

Meanwhile, back in India, the government is considering reducing import duties on certain products, including electronics. India currently imposes nearly 16.5 per cent import duties on several ICT hardware products, while the US maintains rates well below 1 per cent. Many experts believe that lowering duties on electronics could benefit India by encouraging US companies to shift their supply chains to the country. However, there seems to be some confusion over the definition of "US-manufactured" and "Made in the US" when determining tariff reductions. At present, many US technology companies do not manufacture in the US but operate their largest factories in China or Southeast Asia.

President Trump, meanwhile, is pressuring

American companies to relocate their manufacturing bases back to the US, threatening consequences if they fail to do so. This move could further complicate the already fragile global supply chain. India is closely monitoring these developments and must remain agile in its decision-making.

Conclusion

India and the United States have shared a complex yet evolving economic relationship, marked by cooperation and contention. Over the years, India

has worked towards strengthening trade ties with the US, which remains one of its largest trading partners. However, friction has persisted over issues such as tariffs, market access, and trade imbalances. Russia says it has retaken Kursk's biggest town from Ukraine

Russian forces have driven the Ukrainian army out of the biggest town in Russia's Kursk border region, officials claimed Thursday, as US officials so sought the Kremlin's response to a proposed 30-day ceasefire in the three-year war that Ukraine has endorsed.

The Russian Defence Ministry's claim that it recaptured the town of Sudzha, hours after President Vladimir Putin visited his commanders in Kursk and wore military fatigues, could not be independently verified. Ukrainian officials made no immediate comment on the claim.

The renewed Russian military push and Putin's high-profile visit to his troops came as US President Donald Trump presses for a diplomatic end to the war. The US Tuesday lifted its March 3 suspension of military aid for Kyiv after senior US and Ukrainian officials made progress on how to stop the fighting during talks held in Saudi Arabia. Trump said Wednesday that "it's up to Russia now" as his administration presses Moscow to agree to the ceasefire. The US president has made veiled threats to hit Russia with new sanctions if it won't engage with peace efforts.

Kremlin spokesman Dmitry Peskov said Thursday that US negotiators were on their way to Russia, but he wouldn't comment on Moscow's view of the ceasefire proposal.

"Before the talks start, and they haven't started yet, it would be wrong to talk about it in public," he told reporters.

Senior US officials say they hope to see Russia stop attacks on Ukraine within the next few days.

White House press secretary Karoline Leavitt told Fox News that national security adviser Mike Waltz spoke Wednesday with his Russian counterpart. She also confirmed that Trump's special envoy, Steve Witkoff, will head to Moscow for talks with Russian officials, possibly including Putin. By signaling its openness to a ceasefire, Ukraine has presented the Kremlin with a dilemma at a time when the Russian military has the upper hand in the war whether to accept a truce and abandon hopes of making new gains, or reject the offer and risk derailing a cautious rapprochement with Washington.

The Ukrainian army's foothold inside Russia has been under intense pressure for months from a renewed effort by Russian forces, backed by North Korean troops. Ukraine's daring incursion last August led to the first occupation of Russian soil by foreign troops since World War II and embarrassed the Kremlin.

Speaking to commanders Wednesday, Putin said he expected the military "to completely free the Kursk region from the enemy in the nearest future."

Putin added that in the future "it's necessary to think about creating a security zone alongside the state border," in a signal that Moscow could try to expand its territorial gains by capturing parts of Ukraine's neighboring Sumy region. That idea could complicate a ceasefire deal.

Ukraine launched the raid in a bid to

counter the unceasingly glum news from the front line, as well as draw Russian troops away from the battlefield inside Ukraine and gain a bargaining chip in any peace talks. But the incursion didn't significantly change the dynamic of the war.

The Institute for the Study of War, a Washington-based think tank, assessed late Wednesday that Russian forces were in control of Sudzha.

Ukraine's top military head, Gen. Oleksandr Syrskyi, said late Wednesday that Russian aviation had carried out an unprecedented number of strikes on Kursk and that as a result Sudzha had been almost completely destroyed. He did not comment on whether Ukraine still controlled the settlement but said it was "maneuvering (troops) to more advantageous lines."

Meanwhile, Major General Dmytro Krasylnykov, commander of Ukraine's Northern Operational Command, which includes the Kursk region, was dismissed from his post, he told Ukrainian media outlet Suspilne on Wednesday.

Imran Khan's party slammed for spreading 'fake narrative'

efence Minister Khawaja Asif on Thursday slammed jailed former premier Imran Khan's Pakistan Tehreek-e-Insaf party for spreading a "fake narrative" regarding the deadly terrorist attack on a train in Balochistan.

At least 21 passengers were killed in the attack by the Balochistan Liberation Army (BLA) terrorists on the Jaffar Express in Bolan areas of Balochistan on Tuesday. The stand-off with the militants ended after the security forces killed all 33 terrorists.

Speaking in the National Assembly, Asif accused PTI-affiliated social media accounts of misrepresenting the tragic incident and undermining national unity by promoting misinformation, instead of acknowledging the sacrifices made by the armed forces in the rescue operation.

"What's more upsetting is the way PTT's social media interpreted the situation," he said. "In yesterday's tweets, and otherwise as well, they target the armed forces. When the armed forces impose martial law, then they stand with them," Asif said, recalling that Khan supported Pervez Musharraf in his 2002 referendum.

Asif said Pakistan would emerge victorious in the war on terrorism with the nation's support for the armed forces.

"Our war against terrorism is a big milestone that the entire country can be proud of. If the entire nation stands proud like this with our armed forces, then there is no doubt we will be successful in our war (against terrorism)," the minister said.

The Parliament on Thursday unanimously passed a resolution to condemn the train attack and all acts of terrorism that endanger people and public order. Minister for Parliamentary Affairs Tariq Fazal Chaudhary moved the resolution that appreciated the armed forces for their unwavering commitment, brav-

ery and sacrifice in safeguarding the lives of the citizens and protecting the integrity of Pakistan.

The House expressed the "resolve to take every possible measure to eliminate terrorism from every corner of the country, affirming that no group, individual and ideology that seeks to undermine the nation's security, prosperity and sovereignty will be allowed to spread fear, hatred and violence within the territorial limits of the country".

It expressed the commitment to working relentlessly to root out terrorism in all its forms and manifestations.

The House called upon the people regardless of their ethnicity and religion to unite in the fight against terrorism and reject extremism, ensuring peace, safety and prosperity for future generations. Chairman Pakistan People's Party

Bilawal Bhutto Zardari strongly condemned the terrorist attack.

He said the terrorists, enjoying the backing of some foreign forces, only want to kill innocent people and impede the progress of Pakistan. He emphasized the need for unity in political ranks and consensus to once again defeat the terrorists.

Maintenance hole explosion at Texas Tech University causes fire

A n explosion inside a maintenance hole on the Texas Tech University campus in Lubbock set off fires and power outages, leading school officials to issue evacuation orders for several buildings and cancel classes for the rest of the week, university police said.

The explosion happened Wednesday night at the Engineering Key section of campus, which was evacuated.

Power was being shut down to the entire campus while repairs were underway, said Caitlynn Jeffries, a spokesper-

son for the university's police department. She asked that all public and unofficial personnel avoid campus.

"You can go ahead and go home for spring break. We are closing school down for the next couple days," Jeffries said at a news media briefing.

Firefighters responded to campus at about 7 p.M. For a possible gas leak, Lubbock Fire Rescue Capt. Jon Tunnell said at the briefing. They found "multiple manhole covers with active fire and smoke issuing from them," he said.

No injuries were reported, Tunnell said.

Musk, DOGE may get rid of programme that made tax filing free

time, using a free government tax filing programme that made it easy because it did most of the work for her.

Francis said it took 45 minutes to finish her taxes with the IRS Direct File programme, an electronic tax return filing system that the IRS made permanent last year and that has rolled out to 25 states.

Francis is expecting a \$530 refund. And because she saved cash by not using a commercial tax preparation company to file her taxes, "that money will go a long way," she said. She plans to use it for a trip to Amsterdam this year.

Despite its popularity with Francis and other members of the American public, the IRS Direct File's fate remains unclear as Elon Musk and the Department of Government Efficiency cleave their way through the federal bureaucracy.

So far, the programme is still available for use ahead of the April 15 tax filing deadline, and Treasury Secretary Scott Bessent committed during his January confirmation hearing to maintaining it, at least for this tax season.

Representatives from the Internal Revenue Service and DOGE did not respond to requests for comment from The Associated Press on their plans for Direct File. But one Republican tax expert says the IRS never got congressional authorization to create Direct File.

And Republican lawmakers and commercial tax preparation firms complain the programme is a waste of money because free filing programs already exist, although they are hard to use.

Direct File was rolled out as a pilot program in 2024 after the IRS was tasked with looking into how to create a "direct file" system as part of the money it received from the Inflation Reduction Act signed into law by President Joe Biden in 2022. Last May, the agency announced that the programme would be made permanent.

The IRS accepted 140,803 returns filed by taxpayers using Direct File in the 12 states where it was available last tax season. It's been expanded to include half the country this year. It is unclear how many taxpayers have used Direct File this year.

Merici Vinton, an original architect of Direct File from the US Digital Service, noted the ease and accessibility of the programme and called it "a great example of how people should interact with the government in the 21st century."

"We effectively launched a startup in

the IRS," she said. "It was built by an inhouse product team, in an iterative manner, and we ship updates to the software to improve user experience in real time based on feedback. If we continue to invest in it, both taxpayers and the IRS can benefit." Musk posted last month on his social media site that he had "deleted" 18F, a government agency that worked on technology projects such as the IRS' Direct File programme.

This led to some confusion about whether Direct File is still available to taxpayers. However, conversations inside the IRS indicate that no decision has been made on whether to cut the program, two people familiar with these conversations tell the AP.

Former IRS Commissioner Daniel Werfel, who oversaw the rollout of the programme, said Treasury officials considering the future of the program should take into account "the voice of the taxpayers."

"My reflection is that taxpayers are in very different situations and have very different preferences for how they want to file," he said. "Those whose preference is to file electronically direct with the IRS for free, it's a good option to have on the menu. But it should not replace other options."

Derrick Plummer, a spokesperson for Intuit, one of the country's largest commercial tax preparation firms, said free tax preparation had been available for years before Direct File came along.

"IRS Direct File is a solution in search of a problem, a waste of taxpayer dollars and a drain on critical IRS resources," he said. A June 2024 Treasury Inspector General for Tax Administration report estimates that the annual costs of Direct File may range from \$64 million to \$249 million.

"The IRS should focus on its core mission including data privacy and customer service while policymakers in Washington

n- focus on simplifying the tax code,"
 n- Plummer said.

However, other taxpayers, like 31 year-old Aquiel Warner in Austin, Texas, say they want to avoid using commercial tax preparation software.

Warner filed her taxes with Direct File in 10 minutes using her phone and a chatbot that the IRS provides. She likes the program's convenience, that it prepopulated her tax forms and that it allowed for free filing. Although she has some concerns about data privacy in the government — DOGE is reported to have access to some of the IRS' internal systems — she feels more secure going through the IRS than commercial tax preparation services.

"I don't want to be a product. I don't want my information sold when I file my taxes," she said. "I have to file my taxes, and I don't want to be put in a situation where, in order to file my taxes, I have to pay to get the help I need because I'm not a professional tax preparer."

Grover Norquist, president of Americans for Tax Reform, said the IRS never got explicit permission from Congress to create the Direct File system.

"It really doesn't matter if it's a good idea. It was done illegally," he said, calling on Congress and the Justice Department to look into what he says is unauthorized spending that went into the creation of Direct File.

Democratic lawmakers in January asked Bessent and IRS commissioner nominee Billy Long to preserve the program. They wrote in a letter that "ending Direct File would hurt everyday Americans." Long has not yet received a nomination hearing.

In the meantime, Musk and his cadre of computer programmers could decide to wield their tech skills to boost the programme — or use the very same digital savvy to delete it.

Pakistan Prime Minister Shehbaz Sharif on Thursday visited the restive Balochistan province to review the law and order situation and to express solidarity with the people there following the Jaffar Express hijacking incident in which 21 civilians and four soldiers were killed.

Sharif's visit comes a day after security forces killed all 33 Balochistan Liberation Army (BLA) militants who on Tuesday hijacked the Jaffar Express.

Sharif is accompanied by Deputy Prime Minister Muhammad Ishaq Dar, Federal Minister for Information and Broadcasting Attaullah Tarar, Federal Minister for Planning, Development Ahsan Iqbal, Federal Minister for Science and Technology Nawabzada Mir Khalid Magsi and others.

The incident occurred when the train, travelling from Quetta to Peshawar and carrying 440 passengers, was ambushed by BLA militants near the mountainous terrain of Gudalar and Piru Kunri in a tunnel. They opened fire

on the train and held the passengers hostage, prompting the security forces to initiate an operation that lasted two days. Announcing the completion of the operation, Director General Inter-Services Public Relations Lieutenant General Ahmed Sharif Chaudhry on Wednesday said the armed forces took part in the action against militants who "remained in contact with their facilitators and mastermind based in Afghanistan via satellite phone". Units from the Pakistan Air Force (PAF), Special Services Group (SSG), Army, and Frontier Corps (FC) took part in the operation, the army's spokesperson said.

Chaudhary said no one can be permitted to make innocent people of Pakistan the victim of their barbarism in the streets, trains, buses or markets because of their misleading ideas and instructions and facilitation of foreign masters.

"Whoever does this, let me say it very clearly, will be hunted down and brought to justice. Let me also say that this incident of Jaffar Express changes the rules of the game," he said. The bodies of those killed in the attack will be sent to their native areas after necessary administrative prerequisites. Defence Minister Khawaja Asif on Thursday lambasted former prime minister Imran Khan-led Pakistan Tehreeke-Insaf (PTI) for "politicising" the incident and misinterpreting the situation on social media.

"We need to rise above political interests and demonstrate national unity (on such occasions)," said Asif.

Asif slammed the former PTI-led government's decision to relocate thousands of fighters from the outlawed Tehreek-i-Taliban Pakistan (TTP) to the country.

On the Jaffar Express rescue operation, the minister said, "God forbids, there could have been a lot of casualties, but the security forces eliminated the terrorists.

"Our war against terrorism is a big milestone that the entire country can be proud of. If the entire nation stands proud like this with our armed forces, then there is no doubt we will be successful in our war (against terrorism)," the minister asserted.





Syria under Islamist group's rule

yria's interim president on Thursday signed a temporary constitution that leaves the country under Islamist rule for five years during a transitional phase.

The country's interim rulers have struggled to exert their authority across much of the country since the Islamist former insurgent group, Hayat Tahrir al-Sham, or HTS, led a lightning insurgency that overthrew former leader Bashar Assad in December.

Former HTS leader Ahmad Al-Sharaa is now the country's interim president a decision that was announced after a meeting of the armed groups that took part in the offensive against Assad. At the same meeting, the groups agreed to repeal the country's old constitution and said a new one would be drafted

While many were happy to see an end to the Assad family's dictatorial rule of over 50 years in the war-torn country, religious and ethnic minorities have been sceptical of the new Islamist leaders and reluctant to allow Damascus under its new authorities to assert control of their areas.

Abdulhamid Al-Awak, one of the seven members of the committee al-Sharaa tasked to draft the temporary constitution, told a press conference Thursday that it will maintain some provisions from the previous one, including the stipulation that the head of state has to be a Muslim, and Islamic law is the main source of jurisprudence.

However, Al-Awak, a constitutional law xpert who teaches at the Mardin Artuklu University in Turkey, also said the temporary constitution includes provisions that enshrine freedom of expression and the press. The constitution will "balance between social security and freedom" dur-

Al-Sharaa on Monday reached a landmark pact with the US-backed Kurdishled authorities in northeastern Syria, including a ceasefire and a merging of their armed forces with the central government's security agencies.

The deal came after government forces and allied groups crushed an insurgency launched last week by gunmen loyal to Assad. Rights groups say that hundreds of civilians - mostly from the Alawite minority sect to which Assad belongs were killed in retaliatory attacks by factions in the counter-offensive.

A key goal of the interim constitution was to give a timeline for the country's political transition out of its interim phase. In December, Al-Sharaa said it could take up to three years to rewrite Syria's constitution and up to five years to organise and hold elections.

Al-Sharaa appointed a committee to draft the new constitution after Svria held a national dialogue conference last month, which called for announcing a temporary constitution and holding interim parliamentary elections. Critics said the hastily-organised conference was not inclusive of Syria's different ethnic and sectarian groups or civil society.

The United States and Europe have been hesitant to lift harsh sanctions imposed on Syria during Assad's rule until they are convinced that the new leaders will create an inclusive political system and protect minorities. Al-Sharaa and regional governments have been urging them to reconsider, fearing that the country's crumbling economy could bring further instability.

UN secretarygeneral visitz Rohingya refugee camps, push for aid

N Secretary-General António Guterres arrived in Bangladesh on Thursday on a four-day visit to review the situation of more than 1 million Rohingya refugees amid the fear of aid cuts that could seriously affect them.

Bangladesh's foreign affairs adviser, Touhid Hossain, received Guterres at Dhaka's main airport.

Guterres's visit, which is his second to the country, is seen as crucial after the announcement of possible aid cuts by the World Food Programme, or WFP, and others following the decision by Washington to shut down USAID operations.

The interim government, which came to power in August after the ouster of former Prime Minister Sheikh Hasina in a mass uprising in Bangladesh, is hopeful that the visit will strengthen international efforts to mobilise aid for the Rohingya refugees and attract new global attention to the Rohingya crisis.

The WFP, the main UN food agency, said in a letter to the refugee authorities earlier this month that cuts to food rations could take effect from April 1 in Cox's Bazar, where dozens of camps are inhabited by Rohingya refugees

The agency said that the food rations could be half, or USD 6, from the existing USD 12.50 per month.

In a message to The Associated Press, the WFP said recently that whether the fund cuts would be effective from next month would depend on getting adequate funding that it requires to run their operations.

WFP spokesperson Kun Li said that they were "actively mobilising funds" to presecured, but USAID's payments system is still not functioning.

'We will just die in silence': US aid cuts hit Ethiopia's fragile Tigray region

As a result, a consortium of aid agencies in Tigray has had to stop distributions to the over 1 million people it has been responsible for feeding with US-provided grain. It has no money to pay for fuel, trucks and drivers to distribute existing food stockpiles.

That includes 5,000 metric tons of sorghum - enough to feed 300,000 people for a - stuck in a storage facility in Mekele that could rot before it reaches those in need.

"This is just one warehouse. There are several others across the region," said Teklewoini Assefa, head of the Relief Society of Tigray, part of the consortium. This will create malnutrition, disease. If this situation continues, what follows? Death?

He added: "Everything boils down to the payment system."

The effects of the aid cuts are widespread, with many USAID contracts terminated. Already, Ethiopia has been forced to lay off 5,000 local healthcare workers who were working on its HIV response.

Tigray relied heavily on US funds. More than two years after the war killed hundreds of thousands, full-scale recovery efforts are yet to start. The region's health system is in ruins and hundreds of schools remain closed.

In 2024, child malnutrition stood at 21% in some areas, according to a survey reviewed by The Associated Press far above the World Health Organization's threshold of 15% at which a situation is classified as an emergency. Now, aid workers say many programs to improve nutrition have halted. Projects to deliver medicines and vaccines have stopped. Dozens of camps for displaced people have had water handing out US grain. These have been sources cut off. "The impact has been

huge," said Ashenafi Asmelash, executive director of Mums for Mums, which has had two USAID- funded programs terminated. One helped build long-term resilience among farmers. The other helped improve the nutrition of children and new mothers.

Management Sciences for Health, another Tigray organization, has halted a project to combat tuberculosis and told its staff to expect mass layoffs in March, according to a senior executive, who spoke on condition of anonymity for fear of reprisals. Efforts to assist thousands of women who were raped during the war have been derailed, said Rigat Bishaw at Ayder Hospital, Tigray's biggest healthcare facility

This includes counselling and physiotherapy sessions for survivors run by the US-based Center for Victims of Torture, which received a stop-work order from the Trump administration in February and furloughed its staff.

CVT also halted a program to train health workers to recognize sexual abuse cases and refer survivors to appropriate health services. 'This sudden disruption is having a

huge impact on the healing of traumatized people," said Yohannes Fisseha, a CVT manager

Bangladesh extends military's magistracy power

Bangladesh's interim government led by Muhammad Yunus on Thursday extended the magistracy power of the military forces for 60 more days for the third time amid a nationwide law and order situation.

"Commissioned officers holding the rank of captain and above in the Bangladesh Armed Forces have been granted special executive magistrate powers across the country," a Public Administration Ministry statement said here.

According to the statement, navy and air force officers too would hold the authority of executive magistracy while performing duties in aid of civil administration, including the military and navy officers serving on deputation in paramilitary Bangladesh Coast Guard and Border Guard Bangladesh (BGB).

The renewal of the government order came as a nationwide operation called Operation Devil Hunt is underway as the country vandalism afresh since February 5.

Protestors that day first demolished the 32 Dhanmondi residence of Bangladesh's founding father Sheikh Mujibur Rahman using excavators coinciding with a scheduled virtual speech by his daughter and deposed prime minister Sheikh Hasina from India, where she fled last year after the students' massive protest that ousted her Awami League government. The protesters subsequently attacked

or set on fire the houses and business establishments of Awami League leaders and activists throughout the country. They were confronted while attacking a fugitive former minister's village home in suburban Gazipur on the outskirts of the capital.

Lebanon names new army chief, top security officials

ebanon appointed a new army chief and heads of three security agencies Jon Thursday as the government seeks to firm up state authority, especially in the country's south, following the militant Hezbollah group's devastating war with Israel.

The appointments also come after Lebanese political faction in January overcame a crippling, two-year deadlock, electing a president, Joseph Aoun, a former army chief, and forming a new government under Prime Minister Nawaf Salam.

A US-brokered ceasefire went into effect in late November, halting nearly 14 months of fighting between Hezbollah and Israel. The militants began firing rockets

of Hasina's Awami League regime in a student-led mass protests when police were in a dilapidated state as the main law enforcement agency.

A large number of policemen were lynched or critically wounded and police stations were attacked by protestors for their role in protecting the ousted regime while the government said the police was gradually regaining its morale with a massive restructuring exercise.

In line with the authority, the armed forces' officers could arrest or issue orders to arrest any crime suspect.

But army chief General Waker Uz Zaman last month said the military forces were eager to return to their barracks as soon as possible saying army troops were not trained for policing. Zaman also said that he ordered

troops to use minimal force in discharging policing duties as part of joint forces and stressed the need for reorganisation of police to take their original responsibilities in the quickest possible time.

Bangladesh, in the past two decades, has called out military troops in aid of civilian administrative authorities particularly to enforce vigil during national elections and handle law order situations but they were never granted magistracy power

The military, however, was given the magistracy authority in 2002 during former prime minister Khaleda Zia's Bangladesh Nationalist Party (BNP) government to carry out an anti-crime security clampdown called Operation Clean Heart when at least 40 people were killed in security custody.



India launches first exploration licence auction for minerals

nion Coal and Mines Minister G Kishan Reddy on Thursday launched nation's first-ever auction of Exploration Licences (ELs) for 13 exploration blocks for critical minerals.

Reddy launched the ELs in the presence of Goa Chief Minister Pramod Sawant in Dona Paula near here, a major reform aimed to unlock India's untapped critical and deep-seated mineral resources.

The licenses are for the exploration blocks for minerals like REE (rare earth elements), zinc, diamond, copper, PGE (platinum group minerals) and others.

The programme also featured a roadshow on the 5th Tranche of Critical Mineral Blocks and the launch of AI Hackathon 2025, a Mineral Exploration Hackathon focused on "Mineral Targeting

using AI" (Artificial Intelligence).

Addressing the gathering, Union minister Reddy said that in the last 10 years, India's mining sector has achieved many milestones and emerged as one of the fastest and most dynamic sectors of the country.

Today marks another milestone in the industry, he said.

"We are laying the foundation for new era in mineral exploration," he said adding that the era is faster, more technological ly-driven and globally competitive.

"We have established ourselves as a serious player in the global mineral landscape, it has also opened flood gates of opportunities for the private sector," he said.

Reddy said even greater milestones will be achieved in the coming years and it will pave the way for the rise of India as a global leader.

"Today we are launching 13 blocks for

various critical and deep-seated minerals," the minister said.

The exploration possibilities have been contemplated from multiple states like Andhra Pradesh, Gujarat, Jharkhand, Maharashtra, Uttar Pradesh, Chhattisgarh, Rajasthan and Karnataka, he said.

The exploration access would be granted exclusively, which would empower private companies to explore up to 1,000 square metres per licence, Reddy said.

This new framework will encourage transparency, efficiency, innovation, ensuring that only the most promising areas remain for a detailed exploration, he said.

"In the first 10 years (of Narendra Modi government), we increased the exploration activities manifold. The biggest reform is the introduction of a transparent auction regime and the involvement of private sector," Reddy said.

The minister said India's legal frame-

work for mining exploration was limited until now.

'There was a crucial gap. There was no structural mechanism for the private companies. Recognising this, the Government of India introduced amendment to the MMDR Act in 2023. This is a reform that will open doors for a systematic exploration of minerals," he said.

Addressing the gathering, CM Sawant thanked the Union Mines Ministry for choosing Goa for the roadshow and the launch of the ELs. Sawant said mining has always been integral part of the economy, contributing significantly for employment, industrial growth and development

"As we stand at the cusp of a new era of mineral exploration, this initiative reflects the government's firm commitment in self-

reliance in critical minerals," he said.

"These minerals are an integral part of

our electronic industry, green industry and others," Sawant said, adding that a lot of countries are yet to explore for the mineral availabilities.

The chief minister said there is a need to increase the pace of exploration in the country. The amendment in the Mines and Minerals (Development and Regulation) (MMDR) Act is a bold step which will help to tap the untapped mineral wealth of the country, he said.

Goa will immensely benefit from such an initiative, the CM said.

As India moves for a green energy future, securing the supplies of critical minerals will play a key role, he said.

Referring to the Hackathon 2025, Sawant said that Goa, with its mining legacy, stands to benefit from such technology advancement.



The Architect of India's Aspirations

he demise of an 87-year-old human being is neither shocking nor does it bring everlasting grief to the mind. If the deceased happens to be our father, mother, brother, or sister, we may be in a sense of bereavement for a couple of months. The general feeling among us is that each day that one gets after crossing the age of 60 is a bonus from Yama Raj. But there are certain persons for whom we pray to God Almighty to bless them with a much longer life. Ratan Tata, India's legendary industrialist topped the list of such people who made this world a much better place because of their presence.

The entire Indian society, barring a Malayalam satellite news channel, received the news of Ratan Tata's demise with a pang in their hearts. Born into a Zoroastrian family (popularly known as Parsees), Ratan Tata lived a life based exclusively on the essence of Zoroastrianism-Humata, Hukta, and Huvarsta (good thoughts, good words, and good deeds). For Ratan and the Tata Group, industry and business were means to serve humanity, either through philanthropy or social service. The catchphrase "We Also Make Steel" campaign launched by TISCO, the flagship company of the group, speaks volumes about the mission of this industrial conglomerate.

No doubt, the central government had honoured J.R.D. Tata and Ratan Tata with Bharat Ratna and Padma Vibhushan, respectively. But it is still doubtful whether the powers that be gave these great sons of India the honoursthey truly deserved. J.R.D. Tata, predecessor to Ratan Tata, did all he could to elevate the country economically and socially, despite the outdated socialist ideology that prevailed from 1947 to 1991. He had been pleading with the policymakers to loosen the government's shackles over the economy, which would have made India competitive in the global arena.

Ratan Tata: A Life authored by Thomas Mathew, a former IAS officer. I do not know whether there are any other books on Ratan Tata. The 666-page book is a moving tribute to

Ratan, who was once described as the Most Eligible Bachelor of India. Ratan reached the zenith of Indian industries not just because he was born with the surname



Tata but because he was destined to become the monarch

of everything he surveyed. Mathew has incorporated the reminiscences of Ratan

Tata's college mates, friends, relatives, and colleagues to portray the real Ratan, who was rather media-shy and always kept away from the glare of publicity. How Ratan, once voted as India's most perfect gentleman and seen as the apparent heir to J.R.D. made the Tata name a global brand is a corporate folklore of modern times.

But what makes Mathew's book unique is his description of the relationship between Ratan and Navajbai Tata (widow of Sir Ratan Tata, second son of group founder Jamsetji Tata). Navajbai adopted Naval Tata, father of Ratan Tata, from an orphanage. The latter treated her as his own grandmother. Navajbai ensured that Ratan was kept abreast of the history of the family, and she was a window to the world for the young boy. Till her last breath, Ratan was at her side, giving back

the love and affection she showered on him. This is an important part of this book and an eye-opener for modern-day parents, who deny their children the chance to interact with their grandparents.

Mathew's book may not rival Boswell's Life of Samuel Johnson, but the fact is that this bureaucrat has succeeded in telling us about a person who may be one of the last links between economic liberalisation and the license-permit era. This Tata was the real Ratan on the crown of Bharat Mata.



uditors most often cite the statement of B. R. Ambedkar that the **Comptroller and** Auditor General (CAG) of India is the most important official. Over the decades, the CAG emerged as India's highly respected institution. The people also look upon the CAG to keep a check on the executive by preparing no-holdsbarred reports. P. Sesh Kumar spent decades in the office of the CAG. Hailing from the Indian Audit and Accounts Service (IAAS), Kumar gained a ringside view of the functioning of the CAG. He, thus,

has expectations on him to reveal if the CAG is facing new challenges. The CAG made a comeback to

the popular discourse over tabling of reports in the Delhi Assembly Else, the CAG had almost faded from the popular discourse in the recent years. Kumar examines sharp reduction in number of reports of the CAG since 2011. He notes that the CAG reports peaked in 2015 when a total of 52 reports were submitted on Union government. Afterwards, reports turned to trickle, coming down to just 15 in 2018. Kumar after retirement has come out with an inside account of the functioning of the CAG. His book 'CAG Ensuring Ensuring Accountability Amidst Controversies: An Inside View deals with several turning points in the journey of the top auditor of India. The book also

dwells upon the tenure of Vinod Rai and takes a critical view of the famous "presumptive losses to the exchequer" shown in the reports during the last few years of the Manmohan Singh-led UPA government. Kumar indeed also cites the gains made by the government with the course corrections in policy making after the CAG reports were made public.

In 17 chapters, Kumar's book gives an exhaustive account of the history, current controversies, challenges, and also a reform roadmap. The book critically examines the tenures of Rajiv Mehrishi and GC Murmu as CAG. The author also brings out concerns in the IAAS cadre over the manner in which some of the CAG reports were handled. He details unhappiness in the cadre of auditors over the manner in which the report on the collections of tolls on national highways were handled by the CAG. Kumar stresses that the CAG report on the collections of tolls on national highways listed timely reform roadmap also for policy actions by the government.

But the people are genuinely concerned over the CAG not going public with its reports. Kumar answers the people's curiosity by examining in details the Supreme Court judgment that termed the CAG reports as "mere views" until they are tabled by Public Accounts Committee (PAC) of parliament or Assemblies. This explains why the CAG is not going public with reports after submitting them to parliament or Assemblies.

Taking a ringside view, the book argues that the CAG is not mandated to be a property of the PAC that its reports can wait endlessly to go public. The CAG is accountable to the people, and, therefore,

the top auditor should move to the Supreme Court to review the judgment. Kumar details that almost half the reports of the CAG are awaiting action on the parts of the PAC of parliament and Assemblies for the people to know about

them. If the CAG reports are not made public, the Constitution's arrangements of checks and balances for the healthy functioning of democracy too gets affected, suggests the book. It argues that the people need to know about the CAG reports to make informed decisions. Besides, Kumar also raises a

pertinent question on the appointment of the CAG. A Book: CAG single member CAG may be Author: P. SESH KUMAR susceptible to personal biases, Publisher: White Falcon Publishing he argues, while suggesting that a multi-member top auditor body should be constitut-

> ed. Kumar calls for Constitutional changes so that an appointment committee on the lines of the Election Commission and the Director of the CBI can also decide the members of the CAG. Kumar revisits some of the major controversies over the CAG reports. The CAG report on Bofors Scam in 1989 sets the backdrop for the political slugfest in the PAC in not recommending actions on the report to parliament. The book also exhaustively dwells upon the CAG reports on 2G spectrum allocations, Coal blocks, Rafale deal, and many others.

> Kumar's book, published by White Falcon Publishing, is a complete account of the functioning of the CAG, while also seeking space as a historical document. Until 1978, CAG was appointed from among IAS and IAAS, writes Kumar in the book, while making a case for reopening the post for non-IAS officials also. The book makes for an interesting read while also being an important document on the functioning of the CAG.



I am comfortable in top order, feels natural to me: KL Rahul

L Rahul has been performing consistently irrespective of his position in the batting order but given a choice, the stylish keep-er-batter would be "most comfortable" occupying one of the top-order slots.

Rahul, who usually bat No 5, was pushed down a position lower in the Champions Trophy, and made 174 runs in five innings in Dubai. Rahul's success was a reflection of his preparedness for this new challenge and dedication to keep working on his game.

"I have grown up playing in the top order. From my first competitive match in Mangalore at the age of 11 to my early days playing for India, and for most of my career, I have been a top-order batter. It is the position I am most comfortable in and the one that feels most natural to me," Rahul said

"That said, when you play a team sport, you don't always get to choose what you want. You have to be flexible and willing to adapt to the team's needs. Over the years, I've learned to embrace that and give

my best in whichever role I'm assigned," he added during an interaction with JioHotstar.

Rahul, who has led Punjab Kings and Lucknow Super Giants in the past, has reportedly turned down an opportunity to captain his new franchise Delhi Capitals in the upcoming IPL.

Speaking about the IPL auction, he said it can significantly impact a player's future in the game.

"Having been a captain for the last three seasons, I have been actively involved in the process of building a team. I understand the kind of pressure franchises face when assembling a squad.

"But from a player's perspective, it's even tougher because your career is at stake. The auction can shape a player's future or present unexpected challenges.

"I was definitely nervous, even a little anxious (during the last auction). But at the same time, I knew this was the right step for my career. There was excitement too, though it didn't last very long because reality sets in quickly."

If not Rahul then spin-bowling allrounder Axar Patel is the favourite to lead



DC this season. After a forgettable season at LSG last year, Rahul is looking for a fresh start at the Capitals.

"I'm really happy to be joining Delhi Capitals. Parth Jindal, the team's owner, is a close friend, and we have spent a lot of time outside of cricket discussing various things.

"I know how passionate he is about the sport, and I'm thrilled to be a part of this team. We have a strong squad, and I'm looking forward to the season ahead. This will be a new experience for me joining a new franchise, possibly my fourth or fifth team in the IPL. I feel both excited and a little nervous.

Sport ministry updates draft NCAAFS, invites suggestions from general public

niform penalties, amnesty scheme, and a whistle-blower mechanism are some of the key features of the Draft National Code Against Age Fraud in Sports (NCAAFS) which was released for public consultation by the Sports Ministry on Thursday. The Draft NCAAFS 2025, which is a significant update to the existing framework, invites suggestions and comments from the general public till March 31

"The Ministry of Youth Affairs and Sports has put in the public domain the Draft National Code Against Age Fraud in Sports (NCAAFS) 2025 for inviting comments/suggestions from the general public and stakeholders, as part of the consultation process," the ministry said in a statement. This addresses age fraud comprehensively, aiming to protect genuine ath-letes and uphold the integrity of sports competitions nationwide.

This revision has been undertaken almost after 15 years marking a significant update to the existing framework to ensure fair competition, ethical governance, and enhanced accountability in Indian sports." The Draft Bill has 10 salient features, including Mandatory Age Verification & Digital Locking, Medical Examination for Age Discrepancies, Two-Tier Appellate Mechanism, Dedicated National Database and QR-Enabled ID Cards.

According to Draft NCAAFS, "Athletes found guilty on the first violation will face a two-year ban from all competitions, along with forfeiture of any titles or medals won. "A second violation will result in a lifetime ban and initiation of legal proceedings under the penal code. Coaches and other officials found guilty will also face suspension and debarment from their roles," the statement said. As part of the amnesty scheme, a one-time amnesty window of six months will be provided, "allowing athletes to voluntarily declare their correct age without penalties."

"Athletes who participate in this amnesty program will undergo a performance review and subsequently be reassigned to the appropriate age group," the ministry said. There will also be a Whistleblower Mechanism where "a secure and confidential platform will be created for stakeholders to report cases of age fraud anonymously. Additionally, a reward system will be implemented to encourage and incentivise whistle-blowers to come forward with genuine reports."

There will also be a Two-tier Appellate Mechanism to "handle disputes related to age determination" and a "centralised digital portal linked with the National Sports Repository System (NSRS) will be established to securely store all age verification data of athletes."

The draft also says "athletes will receive ID cards embedded with QR codes" after verification. "These ID cards will be made accessible digitally through the DigiLocker platform and must be presented mandatorily for participation in all sporting events," the statement said.

"A robust monitoring framework will be established to ensure effective implementation of the Code." As per the draft Bill, "all athletes must submit three mandatory documents during the registration process. Upon verification, the athlete's age will be securely recorded in a centralised digital database, permanently locking their verified age to prevent any future manipulations." Also for cases involving age discrepancies, "medical examinations will utilise the TW3 method, MRI scans, and general physical and dental examination.

"Further, AI-based bone assessments to accurately determine an athlete's age will be done in pilot phase. Any disputes arising from these examinations may be appealed through designated appellate medical panel for further review.

elhi Capitals vice-captain Jemimah Rodrigues emphasised that the long gap between the last league match and the Women's Premier League final has revitalised the team, and said it will work to her side's "advantage" in the title clash.

"It's (the gap) actually working for our team. We've had a lot of team bonding sessions and at the same time, this WPL was a bit hectic for us. We did play back-to-back games, we traveled and we played too," Rodrigues said in a virtual press meet on Thursday. Rodrigues said the DC have had good training sessions in the last six days, and that will stand her team in good stead.

"I think getting this break is, honestly, how I look at it and I think how the team is looking at it, that it's working to our advantage," she said.

The Capitals will meet the winner of the Eliminator between Mumbai and Guiarat Giants in the title clash on March 15. "So I think sometimes it's nice

to have this break and yes, you know, we're ready for the finals. They are looking forward to it. We're prepared well. You know, like the other two years, this year has not been like the smoothest sailing for us.

"But like I said in one of the interviews that this team just doesn't know how to give up and we're going to come back stronger this year," she noted.

However, the WPL draw meant that the Capitals advanced to the final without having played a single league match at the Brabourne Stadium

Rodrigues did not read too much into that. "The thing is that everyone in our team has played on these pitches (in Mumbai). Everyone's pretty familiar with the conditions and the pitches.

"And like I said, we've been having good practice sessions on these off days, which is preparing us well enough to adjust to the conditions. "The Mumbai pitch is a batter's dream. The outfield's fast. So yeah, I mean, we are really looking forward to it and so are our bowlers. They've come up with their plans," she said.

Rodrigues said the experience of skipper Meg Lanning will help DC in landing their maiden WPL title after defeats in the last two editions.

"I think Meg is someone who wants to win, who wants to win every game. The thing I love about Meg, and this is something that I would like to add in myself also. She's calm but aggressive at the same time. And I think as a leader,

DC ready for WPL final, says Rodrigues that's a very, very crucial quality to have. "She told me last year that as a captain, it's very important that I set the tone for the team. If I stay calm and because everyone's looking up to me and if I am calm, I know the team is calm." Shafali Verma made a bright return to her run-making ways after a slew of disappointing moments last year, where she was also dropped from the Indian team.

Rodrigues patted the opener for keeping her composure during tough times.

"But to be dropped and to come back the way she did, I think hats off to her. I can't wait to see her. I'm sure she'll be back soon in the Indian team too," said Rodrigues. Veteran pacer Shikha Pandey has also contributed heavily to DC's win, taking 11 wickets from eight matches at an acceptable economy rate of 7.01.

In fact, she is currently holding the fifth place in the wicket-taker's list, and Rodrigues lauded Pandey for continuing to churn out impressive performances. 'She's always bowled those crucial overs, always nailed her vorkers, always been so crucial in DC winning. She wants the tougher overs.

Toto Wolff denies rumours of signing Verstappen for 2026

ercedes team principal and chief executive Toto Wolff has denied rumors on the eve of the Australian Grand Prix weekend that he's still seeking to sign reigning F1 world champion Max Verstappen for 2026.

Mercedes, which has a new driver lineup this year that sees rookie prospect Andrea Kimi Antonelli join George Russell, is hoping to emerge from its recent lean spell in F1 that has seen it score just five wins from the last three seasons, four of which came in 2024.

But while Verstappen was reportedly on Mercedes' shopping list last year as a top-gun replacement for its then-outgoing star Lewis Hamilton, Silver Arrows' team boss Wolff says extending Russell's contract beyond 2025 is the priority. "I think we've said it pretty clearly last year, and (Verstappen) said the same, we need to concentrate on our driver line-up, we need to do (the best with) that we have," Wolff said Thursday in Melbourne.

"I don't flirt outside if I'm in a good relationship, and that is true for this year, too. So, at the moment that is not on any, let's say, radar and I don't plan to shift my concentration away from these guys and make sure that George has a contract (extension) pretty soon and we agree on the final things.

Plenty of decisions to comeWolff's future driver lineup came into focus this week after McLaren extended its deal with Australian Oscar Piastri, which puts him out of reach during the sport's next big expected grid shuffle in 2027.

We have had a chat (with Russell) a few weeks ago about what the right timing would be to liaise, and I'm naively or not someone that sticks to what he says," Wolff said.

"These three (including reserve driver Valtteri Bottas) are the combination that I want to go forward with Mercedes, and I have no reasons to doubt that. We're going to find some time, I guess, before he summer."

Russell, a long-time Mercedes protégé who joined the works team in 2022 fresh from three years at Williams, is keen to stay in silver. "We've had such a long-term relation-

ship, and there's so much trust," Russell said. "We are focused on getting Mercedes back on top and trying to win races, and championships, and to be honest in this sport, the performance speaks.'

Hamilton: 'most exciting period of my life'Hamilton made it clear in Melbourne that he's moved on, following his recordbreaking stint with Mercedes, with the seven-time F1 world champion enjoying life at Ferrari as he prepares for his maiden start with the Scuderia.

Real Madrid thrashes Atletico Madrid in Champions League

eal Madrid beat Atletico Madrid in a Champions League penalty R shootout again to keep its title defense alive Wednesday and advance to the quarterfinals.

Defender Antonio Rüdiger scored the decisive spot-kick in a 4-2 shootout win after two Atletico players missed. Marco Llorente's shot struck the bar after Julián Álvarez's score despite slipping was disallowed on video review because he touched the ball twice.

Madrid also beat Atletico in a shootout to win the 2016 final part of a streak of eliminating its city rival in the knockout rounds for four straight years. That hardluck run started with the 2014 final when Atletico gave up an equalising goal in stoppage time.

Madrid moves on to the quarterfinals to face Arsenal, which also advanced Wednesday along with Aston Villa and Borussia Dortmund. The quarterfinals lineup was completed with Madrid's win in a tense derby that had ended 2-2 on aggregate score.

Atletico led 1-0 after 90 minutes and extra time in a typically tenacious performance at its Metropolitano Stadium to cancel out Madrid's 2-1 advantage from the first leg last week.

"When you get knocked out, it is not easy to digest," Atletico coach Diego Simeone said, "but I go out with a feeling of peace." Two key incidents defined reg-



ulation time. Atletico Madrid scored within 30 seconds and Real Madrid missed a penalty in the 70th minute.

Atletico took the lead with its first attack when England midfielder Conor Gallagher pounced on the ball from close range when a cross by Rodrigo De Paul was deflected into the goalmouth.

Madrid star Vinícius Júnior blazed a penalty kick high over the Atletico goal when he could have sent the 15-time champion through. He was substituted in extra time for his teenage fellow Brazilian, Endrick. Kylian Mbappé and Jude Bellingham stepped up to score Madrid's first two spot-kicks, and Fede Valverde also scored before Lucas Vazquez's kick was saved by Jan Oblak.

It was more relaxed in London, where Arsenal rested some regulars in a 2-2 draw with PSV Eindhoven to run up a 9-3 aggregate score.

Aston Villa also had a stress-free evening at home to ensure England has two teams in the quarterfinals, one night after Premier League leader Liverpool was beaten at Anfield by Paris Saint-Germain in a shootout. Villa won 3-0 against Club Brugge, which played with 10 men from the 17th, after a 3-1 win in Belgium last week. Brugge defender Kyriani Sabbe was sent off for pulling back Marcus Rashford when running clear on goal.

Substitute Marco Asensio, on loan at Villa from PSG, scored twice in the second half to ensure his temporary club will isfactory for both parties.

Borussia Dortmund rallied with two second-half goals to win 2-1 at Lille and advance 3-2 on aggregate. The beaten finalist last season now faces Barcelona.

England's unexpected challenge

There's only one former European champion from England left in the Champions League. Villa's unbeaten home record has driven its run to the quarterfinal, with wins against Bayern, Bologna, Celtic and now Brugge.

Liverpool's exit to PSG followed Manchester City being pushed out of the knockout playoffs last month by Real Madrid. Without the Champions League winners in 2019 and 2023, respectively, England's challenge halved to just two.

Villa's 1982 European Cup title is perhaps a less-remembered one in the competition's 70-year history. Arsenal's only time in the final was a loss to Barcelona in 2006.

Villa manager Unai Emery now goes back to Paris where his two seasons as coach there until 2018 seemed to be unsat-
