The meeting was attended by commission members Rapolu Jayaprakash, Tirumalagiri Surender, Balalakshmi Rangu and Commission Member Secretary Balamayadevi IAS.

The commission welcomed the Telangana Government's initiative to deploy enumerators for a 50-day caste census survey, followed by an additional window from February 16 to 28 for those who had not been registered earlier.

It expressed optimism that the findings of this caste survey would lead to an increase in BC reservations.

## Premier Energies moves unit from TG to AP

Premier Energies Limited has announced a major change in its operations by relocating its 4 GW Solar PV TOPCon Cell manufacturing unit from Telangana to Andhra Pradesh.

The decision, approved during a board meeting on March 3, comes as part of the company's backward integration strategy aimed at colocating its silicon ingot and wafer manufacturing facility with solar PV cell production.

The company had originally planned to set up the four GW Solar PV TOPCon Cell unit at the UDL-5 Part in the Industrial Park, Seetharampur, Ranga Reddy District, Telangana.

However, after a comprehensive market analysis, the board decided to shift this unit to the Industrial Park in Naidupeta Village in the Nellore District of Andhra Pradesh.

A high-level review meeting on the SLBC tunnel rescue operation was held on Wednesday by the Special Chief Secretary for Disaster Management, Arvind Kumar, along with Nagar Kurnool Collector Badavath Santosh and senior officials. The meeting assessed the progress of the rescue operations and analysed operations department-wise.

During the review meeting, Border Roads Organisation (BRO) Colonel Parikshit Mehra displayed a tunnel-boring machine model to explain the rescue attempt inside the tunnel.

Officials were told that debris removal from the tunnel boring machine's final section had been completed and that rescue teams were trying to clear the rubble.

Ground Penetrating Radar identified surface disturbances and excavation is being expedited in those areas, he said.



Officials reported that dewatering operations were progressing rapidly, and water jet technology was being used on the left side of the tunnel to remove sludge.

Rescue teams are intensifying their attempts using robotic services provided by the Hyderabad-based NV Robotics, while representatives from the Delhi-based National Centre for Seismology (NCS) also took part in the rescue ops.

The conveyor belt system had been restored, and commissioning work was underway to ensure seamless operations. Officials confirmed that challenges in the rescue process were being systematically addressed, speeding up the operation. Ventilation and lighting systems inside the tunnel had also been extended to facilitate the ongoing efforts.

The Rs 1,000 crore direct fund allocation on Women's Day reinforced the state's commitment to women-led enterprises. Subsidised e-autos costing Rs 3.5 lakh apiece will now get a Rs 1 lakh subsidy, encouraging women's participation in urban mobility.

acres at the new Andhra Pradesh site through the Andhra Pradesh Industrial Infrastructure Corporation. Of this, 169.71 acres have already been allotted, with an additional 100 acres granted in principle. The site will accommodate the relocated four GW Solar PV Cell TopCon unit along with a newly planned 5 GW silicon ingot and wafer manufactur-

The company has earmarked Rs 1,621 million for land acquisition, which will be financed using unutilized funds from the proceeds of its public offering. The total investment in the revised project remains unchanged, with the only variation being the reallocation of funds towards land procurement.

Company officials stated that the move will streamline operations by integrating the ingot and wafer production with PV cell manufacturing, enhancing efficiency and supply chain security. The relocation is subject to shareholder approval through postal ballot as per regulatory requirements.

The board also approved the reappointment of Uday Pilani Sudhir as an independent director for a second term of five years.



# **SHE Cyber Lab identifies** 185 leads in 13 states

One of the communication channels, Telegram, has become notorious for individuals sharing Child Sexual Abuse Material (CSAM). The investigation officers of SHE Cyber Lab used Open-Source Intelligence (OSINT) to join these Telegram channels. They engaged in conversations with individuals and traced the links back to the original senders.

It has identified 185 leads related to CSAM and shared 65 intelligence reports with police departments across 13 states in India.

Director General, Women Safety Wing Shikha Goel said that SHE Cyber Lab used advanced Open-Source Intelligence (OSINT) tools and intensified cyber patrolling to track and dismantle networks distributing CSAM. These efforts have resulted in 20 FIRs and the arrest of 23 individuals involved in child exploitation.

The crackdown on CSAM has been widespread, with the highest number of arrests in Telangana (14), followed by West Bengal (2), Rajasthan (2), Delhi (1), Maharashtra (1) and Tamil Nadu (1). The total number of accused arrested across different states stands at 23.

The Greater Hyderabad Municipal Corporation (GHMC) has issued a show cause notice to Praneeth Pranav Knightwoods (M/s Venkata Praneeth Developers) following allegations of unauthorised construction and land encroachment in Patancheru.

This action comes after multiple complaints from local farmers and landowners, who accused the developers of violating urban planning laws and illegally occupying buffer zones. Investigations revealed that the developers encroached 3



meters into the nala and 9 meters into the buffer zone, posing risks to public safety and

drainage infrastructure. The GHMC and the Irrigation department found that the developers had main-

from the nala instead of the legally required 24 meters.

The violations were documented under Sections 451(1) & 461(1) of the GHMC Act, 1955, impacting multiple survey numbers, including 351, tained only a 12-meter distance 347, 466/P, 346, 350, 352, 467,

348, 349, 145, 344/P, and 468. The developers failed to provide a satisfactory response. As a result, the GHMC issued a Speaking Order on March 1, 2025, reiterating the violations and the urgency of compliance.

**Water supply** disruption on Mar 8

The National Highways Authority of India (NHAI) is set to construct a flyover near the BHEL junction, necessitating the relocation of a PSC water pipeline by the Hyderabad Metropolitan Water Supply and Sewerage Board (HMWSSB). ## Three foreign nationals deported for visa violations

The Hyderabad City Police have deported three foreign nationals, two from Liberia and one from Uganda, for overstaying their visas and allegedly engaging in illegal activities. The Panjagutta Police, in coordination with the Foreigners Regional Registration Office (FRRO), apprehended the individuals and facilitated their deportation as per legal proce-

Karmo Martin P (Liberia) has arrived in India on a student visa in 2019 and completed his studies at Nizam College between 2020 and 2023. However, he continued extending his visa under false claims of having academic backlogs. Upon verification, he was found to be staying illegally and was detained at CCS Basheerbagh before being deported to

Liberia on February 26, 2025 P Kabatuku Mary (Uganda) entered India on December 17, 2024, on a medical visa for treatment at Apollo Hospital, Jubilee Hills. However, an investigation revealed that she had never visited the hospital and was residing illegally. She was also suspected of being involved in flesh trade. Following her detention at CCS Basheerbagh, she was deported to Uganda on March 4, 2025.

#### **Annual Amarnath Yatra to** start in J-K from July 3

he 38-day annual pilgrimage to 3,880 metres high holy cave shrine of Amarnath in south Kashmir will commence on July 3, an official spokesperson said on Wednesday. The decision to this effect was taken at the 48th board meeting of Shri Amarnath Ji Shrine Board (SASB) under the chairmanship of Lt Governor Manoj Sinha at Raj Bhawan, he said. #### Centre, Kerala govt clash over ASHA workers' funds

he Centre and the Kerala government on Tuesday continued to dispute claims over the provision of funds for disbursing incentives to ASHA workers in the state. While state Finance Minister K N Balagopal accused the Centre of not providing funds on time, Union Minister George Kurian refuted the claim, stating that those who hear such allegations will start respecting Narendra Modi once they properly investigate the matter. Talking to reporters in Kollam, Balagopal said that the Centre had yet to release Rs 100 crore in pending payments. He urged the Centre to increase the honoraria for scheme workers, including Accredited Social Health Activist workers. Balagopal said that Kerala had been raising this matter during the pre-budget meetings convened by the Union Finance Minister for the past two years. "In Jaisalmer, I also reiterated our demand that the rate of honoraria for Anganwadi workers, ASHA workers, and other scheme workers needs to be appropriately enhanced," the Kerala finance minister said Earlier, the office of State Health Minister Veena George stated that the claim that the Centre had allocated the full amount due to Kerala for centrally-sponsored health schemes in the last financial year was incorrect.

# Day not far when India will be **USD 5 trillion economy: PM**

#### Current multilateral system failing to mitigate climate change: India

PNS ■ NEW DELHI

India on Wednesday said the current multilateral system is failing to address global challenges like climate change and called for urgent reforms in global governance to ensure that equity, justice and action remain central to climate negotiations.

Addressing TERI's World Sustainable Development Summit, Union Environment Minister Bhupender Yadav said it is still technically possible to keep global warming within the 1.5-degree Celsius limit, but this would require developed countries to fulfil their commitments on financial and technological support.

"Global challenges demand global solutions. The current multilateral system is failing to address trans-boundary issues like climate change. We need urgent, structural reforms to global governance that put equity, justice and action at the core of climate negotiations," Yadav said.

He added that the proposed USD 300 billion per year under the New Collective Quantified Goal on Climate Finance (NCQG) by 2035 is far below the required USD 1.3 trillion, leaving developing countries underfunded in



their climate efforts.
Citing the 2024 UNEP Emissions Gap Report, he said: "It is still technically possible for us to stay on the 1.5degree Celsius pathway, with solar energy, wind power and forests offering tremendous potential for significant and rapid reductions in emissions.

"However, to fully unlock this potential, we must act with urgency and developed countries should honour and fulfil their obligations, in particular, on means of implementation," the minister said.

He stressed that countries must strengthen their climate action plans, known as Nationally Determined Contributions (NDCs), by including measures that maximise social, economic and environmental benefits, with stronger international cooperation as the foundation.

#### BJP questions the way Naxalites surrendered in Karnataka

He said 75 per cent of people buy two-wheelers on loan so that they can repay it slowly, but the financial crunch is so severe that as compared to last year, loans worth about Rs 2 lakh crore are still outstanding till September 2024, which has increased by Rs 40,000 crore in a year.

Two-wheeler sales have declined by 6 per cent in February 2025, Kharge added.

"Recession, financial crunch and reduction in spending capacity - this is the essence of the economy you run," Kharge said, hitting out at the prime

## TN CM Stalin moots Joint **Action Committee of MPs**

Stepping up the pressure on Centre, Tamil Nadu Chief Minister M K Stalin on Wednesday proposed that the 1971 Census be the basis for delimitation of Parliamentary constituencies for 30 years starting 2026 and favoured a Joint Action Committee (JAC) involving all southern states to press for related demands.

At an all-party meeting on delimitation here that was attended by main opposition AIADMK among others, Stalin, moving a resolution, said that in the event of increase in the number of seats in Parliament, the 1971 Census should be the basis for it and that appropriate Constitutional amendment should be done.

Also, the 1971 population data should be the basis for delimitation of LS seats for 30 years from 2026 and Prime Minister Narendra Modi should make an assurance in the Parliament, he asserted.

The JAC is to take forward such demands and create awareness among the people and the meet unanimously opposed delimitation exercise based on population, which will be a "threat to federalism and the rights of southern states to political representa-

Tamil Nadu's present representational percentage in Parliament, which is 7.18, should not be changed under any circumstances.

tion.'

Resolutions, supported by

parties including the Edappadi K Palaniswami-led AIADMK, were passed in the meeting to urge the Centre to accept the demands of Tamil Nadu on the issue. One of the key points underscored in the meeting was that there shall not be any reduction in the number of LS seats.

The meet underscored that Tamil Nadu is not against delimitation of Parliamentary constituencies. However, the proposed exercise must not become a punishment for implementing well the socioeconomic welfare measures during the past 50 years.

The Centre declined to heed to the voice of the state, which has 39 Lok Sabha MPs. In case this number was reduced, it would become a big injustice for the state.

The CM said that the allparty meeting is for under-standing that the state has been pushed to a corner on the issue of delimitation, thereby prompting it to take up a struggle movement to secure its rights. "The delimitation sword is hanging over the head of south India and Tamil Nadu will be severely affected," Stalin alleged.


Culture Ministry. It will be open to the public


What began as a threat by Trump is now a full blown trade war as Canada, China and Mexico retalliate the US tariffs

The trade war initiated by President Trump against China, Canada, and Mexico has set off a chain reaction of retaliatory measures, creating uncertainty in global markets and posing risks to economic posing risks to economic stability. While the administration aims to address specific national concerns through these tariffs, the broader implications suggest potential harm to both the US and global economies. As the situation evolves careful contion evolves, careful consideration of the long-term consequences is essential to mitigate adverse effects on world trade. As promised by him in his campaign President



promised by him in his campaign President
Donald Trump launched a bold series of tariffs aimed at imports from China, Canada, and Mexico, a move that significantly escalated global trade tensions and set off a swift chain reaction of retaliatory measures. The president signed executive orders that imposed a 25% tariff on all goods from Mexico and Canada, and a 10% tariff on Chinese imports,. The administration argued that these measures were necessary to tackle issues related to illegal immigration and drug trafficking to protect American industries. In an effort to minimize any disruptive effects, an additional 10% tariff was applied to Canadian energy exports, including electricity, natural gas, and oil.

The response from the targeted countries was swift and forceful. Beijing retaliated by announcing tariffs of up to 15% on key U.S. agricultural products such as chicken, pork, soy, and beef, while also expanding restrictions on U.S. businesses. In Canada, Prime Minister Justin Trudeau countered with 25% tariffs on \$155 billion worth of American goods. Similarly, Mexico's President Claudia Sheinbaum imposed retaliatory tariffs against the United States, criticizing the unilateral decision and warning of its adverse effects on both national and foreign companies operating in Mexico. Analysts have warned that the tariffs could significantly hinder economic growth, with projections suggesting a contraction of 2.8% in U.S. GDP. The increased tariffs were also expected to drive up consumer prices, adding to existing inflationary pressures and potentially prolonging periods of high interest rates. Global markets reacted negatively, with major U.S. stock indexes and shares in the automotive sector experiencing notable declines. Industries reliant on international supply chains, particularly the automotive sector, braced for production delays and increased costs as a result of these disruptions. #### **Textile industry needs support**

Madam — Apropos of the article 'Export Potentials of Punjab ...' (March 5), presents an interesting reading. But the trend in the country remains different. Only slogans galore and solutions are nil. The second largest provider of employment is the cotton industry in India. The direct employment it provides is around 40 million. Besides this, there are micro units and allied feeding industries providing employment to many more millions. The cotton business has been suffering for years due to various internal as well as external factors. In the same way, the spinning mills also feel suffocating due to various factors. Declining exports, unviable cotton prices, growing costs of manufacturing, and a number of such factors are quoted to be disturbing the functioning of mills. It is a pity that a good number of mills are closing their operations, throwing millions of workers out of their jobs, besides their due negative impacts on export earnings.

The industry, with debt-funded capex, finds it too difficult to manage the show anymore. Actually, in most of the mills, the number of permanent workers availing themselves of employee-related benefits is too low, and the vast section of the workforce is made up of contract, outsourced, casual, contingent, and barrack segments, who are paid too little and do not avail themselves of any benefits meant for permanent workers. In spite of such huge savings from the labour component, the mills are closing down due to various reasons that the governments

can alone resolve. For example, the cost of power is felt to be unviable. Export subsidies need to be provided. In the absence of required intervention from the state or the Union governments, a good number of mills are already closed, and many are nearing closure. It is said even banks are not inclined to advance these industries anymore. It is time to attend to this segment as a priority, as slogans are not a solution.

# A model of stability from China

While Western democracies struggle with internal gridlock, economic and stagnation, China's governance model continues to chart a course of long-term strategic vision



he Financial Times recently published an article on the question of who will succeed Xi Jinping. But perhaps the real question is not one of succession but of continuity—of how a governance model rooted in long-term vision, pragmatic adaptability, and national rejuvenation sustains itself beyond the tenure of any single leader. Unlike Western portrayals, often laden with exaggerated spectres from 'debt traps' to 'authoritarianism', there are profound lessons to be drawn from China's trajectory—especially as Western democracies now find themselves gasping for air in the suffocating embrace of their contradictions. "Democracy is a failed joke," Ai Weiwei, the Chinese contemporary artist, remarked in a recent interview with artist, remarked in a recent interview with The Independent—and perhaps never has this assertion been more starkly evident than in the shambolic decline of the liberal order. Governance, once regarded as the solemn responsibility of those entrusted with the future of their nations, has in the West deteriorated into little more than a revolving spectacle of populist theatre, corporate capture, and institutional paralysis. It is within this continuum that China now prepares to convene its most pivotal political gathering of the year—the Two Sessions. The third session of the 14th National

People's Congress (NPC) and the third session of the 14th National Committee of the Chinese People's Political Consultative Conference (CPPCC), scheduled to commence on 4 and 5 March respectively, are not mere ritualistic formalities but the very engine of governance in a system defined by strategic foresight rather than short-term electoral expedience. The Western world, entrapped in the myopia of its dysfunction, looks upon this grand assembly with bewilderment, unable to comprehend a system where efficiency supersedes obstruction and where governance is an instrument of civilisation rather than a battleground of per-

petual paralysis. petual paratysis.

As Beijing convenes these pivotal sessions, it does so with a purpose that far surpasses the partisan gridlock that has crippled Washington under Trump and reduced Brussels, under Ursula von der Leyen's leadership, to a stage of waning relevance. History does not bestow hegemony upon the indo-lent. It is earned through foresight, discipline, and a genuine commitment to civilisation's progress. The Western model, long heralded as the apex of governance, is now fraying



Socialism with Chinese Characteristics, marches forward with unparalleled

resolve. "The path of socialism with Chinese characteristics is the only correct path for building a modern socialist country," Xi Jinping declared in his report at the 19th National Congress of the Communist Party of China in October 2017. What have the last few decades illuminated since China's opening up? "Reform and opening up is the key

definitive proclamation for a new global par-adigm—one where dialogue supplants dis-cord and where stability is not held hostage

cord and where stability is not held hostage to the whims of declining empires. The very existence of Western diplomacy has been predicated upon coercion, economic subjugation, and military adventurism. China, by contrast, has demonstrated that genuine global leadership lies not in the proliferation of conflict, but in its resolution.

This year's Two Sessions will reaffirm Beijing's role as an indispensable mediator of international crises, bringing adversaries to the negotiating table in a manner that the West, mired in its moral hypocrisy, has repeatedly failed to achieve. Consider the diplomatic masterstroke that saw China facilitate a rapprochement between Iran and facilitate a rapprochement between Iran and Saudi Arabia—two historical adversaries long ensnared in the machinations of Western interventionism. This ethos extends to the Israeli-Palestinian crisis, where China,

to the Western penchant for war profiteering. While NATO expands its influence under the guise of security, China constructs bridges of diplomacy, demonstrating that true global leadership lies not in fuelling divisions but in fostering dialogue.But China's vision does not stop at terrestrial affairs. This year's Two Sessions will be held as the next frontier of human progress—space—becomes a new high-tech battlefield. While Western nations hoard technological advancements for geopolitical leverage.

Western nations hoard technological advancements for geopolitical leverage, China has advanced an inclusive vision of cosmic exploration. The construction of the Tiangong space station, the pioneering lunar projects, and the Mars exploration programme are not mere scientific endeavours; they are emblematic of a civilisation that aspires not merely for national greatness but for the collective progress of humanity for the collective progress of humanity.
The essence of the Two Sessions lies in the

The essence of the Iwo Sessions lies in the articulation of a governing philosophy rooted in long-term vision, adaptability, and the pursuit of collective progress. It is not governance dictated by ephemeral political cycles but by a civilisation's deeper consciousness—one that understands its historical responsibility not only to itself but to the broader trajectory of human development. In an era where artificial intelligence and artificial general intelligence are reshaping economies, governance, and even social structures, China does not see these advancements as instruments of control or geopolitical leverage but as elements of a broader mission: ensuring that technological evolution remains a force for human cohesion rather than fragmentation. What China has proven is that reform is not an event; it is the flow recognising history

potential. Simultaneously, the shifting currents of global trade, exacerbated by protectionist measures and economic fragmentation, have reinforced the necessity of an alternative economic logic—one not shackled to the fluctuations of political expediency but rooted in the principle of enduring equilibrium. True strength is not found in dominance, but in resilience—the ability to absorb, adapt, and outlast. This defines China's approach to trade tensions: rather than engaging in titfor-tat economic skirmishes, the focus is on structural reinforcement—building self-sufficiency in critical sectors while ensuring that economic interdependence remains a mechanism of stability rather than vulnerability.



He said other countries have used tariffs against the US for decades and now, it is "our turn" to start using them

against those nations.

"On average, the European Union, China, Brazil, India, Mexico and Canada -- have you heard of them? And countless other nations charge us tremendously higher tariffs than we charge them," Trump

He added: "It is very unfair. India charges us auto tariffs China's average tariff on our products is twice what we charge them. And South Korea's average tariff is four times higher.

India is confident of finding a solution, people familiar with the matter said while referring to the commitment expressed by Prime Minister Narendra Modi and Trump during their February 13 talks

## Meghalaya CM presents Rs 1,970 cr deficit budget

PNS SHILLONG

Meghalaya Chief Minister Conrad K Sangma on Wednesday tabled a Rs 1,970 crore deficit budget for the financial year 2025-26, announcing a Rs 6,000 scholarship for all postmatric students of the state.

The Rs 1,970 crore budget is around 2.96 per cent of the projected Rs 66,645 crore GSDP, in line with the targeted USD 10 billion economy by 2028.

According to the budget document, the total receipts for 2025-26 are estimated at Rs 30,415 crore, of which revenue receipts are Rs 25.591 crore and capital receipts Rs 14,324 crore. Excluding borrowings of Rs 24,788 crore, the total receipts are estimated to be 225,627 crore.

Estimating the total expenditure to be Rs 30,003 crore, Sangma said the rev-

enue expenditure is estimated to be Rs 20,556 crore and capital expenditure at Rs 9,447 crore. Excluding repayment of loans of Rs 2,406 crore, the estimated total expenditure is Rs 27,597 crore.

The interest payment for the current fiscal is estimated at Rs 1,347 crore and pension payments at Rs ,824 crore, he said.

"I am, therefore, presenting the budget for 2015-26 with a fiscal deficit of Rs 1,970 crore, which is around 2.96 per cent of the GSDP. I am delighted to highlight that the fiscal deficit has been maintained below the permissible limit of 3.5 per cent," the CM said, tabling the budget.

## How NGOs can drive lasting change in rural areas

few years ago, if you had walked into a Gram financial management. Sabha meeting in Rajpur block of Madhya Pradesh, you might have seen mostly empty rooms and a handful of Panchavat officials conducting the Gram Sabha. People—especially women—rarely participated in the Gram Sabhas and the idea of village development felt distant, controlled by Panchayat representatives and bureaucrats. But things changed over the years. Today, those same Gram Sabha meetings see more than 85% community participation and women's voices leading the discussions. Local women, once side-lined, are now Sarpanches and Ward Members, shaping the future of their villages through participatory and comprehensive Gram Panchayat Development Plans (GPDP). So, what sparked this transformation?

It wasn't just because of another external intervention. It was mostly due to a shift in approach - empowered communities driving their own development. In 2017. Transform Rural India (TRI) introduced the Localisation Model, a new way of doing rural development. The model created a locality compact -coordination mechanism between Panchayat, Community and local administration – to address the existing gaps in the community-led development approaches. Going beyond planning, the localization model created environment for local community to translate plans into reality, demand better services, and hold local leaders accountable. The Localisation Model approach in Rajpur - with improved governance and service delivery demonstrate the critical need to include design solutions and community-led development approach for real and lasting rural change.

#### **Role of NGOs in rural** transformation

The NGO sector in India has come a long way. In the post-independence era (1950s-70s), NGOs primarily acted as service providers, stepping in where government programs failed to reach. In the 1980s-90s, as rural India grappled with unemployment, social inequalities, and environmental issues, NGOs transitioned into community mobilizersorganizations like MYRADA and PRADAN pioneered Self-Help Groups (SHGs), microfinance and watershed programs, developing local leadership and accelerating economic gains. The 2000s saw NGOs partnering with the government on large-scale rural schemes like MGNREGS, NRHM and NRLM. However, with digital governance and CSR funding changing the landscape, the role of NGOs must now shift from implementers to enablers. To ensure sustainable rural transformation, NGOs must focus on strengthening local governance and developing community ownership. Instead of focusing on delivering services, they should empower rural communities to take ownership of their development, ensuring long-term, systemic change.

#### Power of design thinking in rural development

Rural development isn't just about building infrastructure or providing development services. More than funding or government schemes, rural India needs solutions that actually work for people. don't consider the real needs, behaviours and aspirations of rural communities. That's where design thinking comes in. Instead of imposing pre-decided solutions, design thinking encourages communities to co-create, prototype, and refine ideas that truly fit their context. It's about making development peoplecantered, practical and sustainable.

Design workshops have helped Self-Help Group (SHG) women, youth and local Panchayat representatives rethink solutions for economic growth, leading to initiatives like Mini Grameen Marts, high-value agriculture and digital tools for

Similarly, IDEO has also championed design thinking in rural development, particularly in Africa and Latin America. The "Human-Centered Design for Social Innovation" projects have effectively tackled issues like sanitation, financial inclusion and healthcare by working directly with communities to design and test solutions before scaling them up. This reinforces the importance of grassroots participation in designing solutions that truly work.

#### Importance of grassroots activism in sustaining change

Real change seldom comes from top-down policies or big budgets-it happens when people take charge of their own development. That's why grassroots activism is so important. When rural communities actively participate, they push for program implementation, demand accountability and make sure development efforts actually work for them. A strong grassroots movement creates local leaders who step up, solve problems and keep progress going long after NGOs or government programs leave.

As discussed above, the community-led development in Rajpur Block in Madhya Pradesh turned passive communities into active changemakers. In just a few years, Gram Sabha participation improved to 85%, 600+ SHG women contested elections, 531 got elected and 31 became Sarpanches. The model didn't just improve governance-it enhanced leadership skills among community, integrated community plans with Panchayat plans, and made sure public funds were used effectively. Grassroots activism is the backbone of sustainable rural development. The Localization Model in Rajpur provides evidence that when communities organize, demand, and participate in governance, development becomes more effective and sustainable. Therefore, NGOs today need to reposition from being direct implementers and instead invest in grassroots leadership, advocacy, and participatory governance.

#### Synergy between design & activism for lasting impact

Rural areas, with their intricate social, economic and environmental interdependencies, are dynamic and capable of evolving in response to internal and external stimuli. Therefore, NGOs looking to bring rural transformation need to bring design thinking and grassroots activism in their work. On their own, each has its strengths—design thinking brings structure, creativity and problem-solving methods, while grassroots activism mobilises people, builds momentum and ensures long-term accountability. But when we combine the two, we get something even more powerful: solutions that are not just welldesigned but also deeply rooted in community ownership. Design thinking gives NGOs the tools to build solutions that actually work. Instead of jumping to conclusions, it helps them break down problems, test ideas, and refine solutions based on real feedback. But even the best-designed solutions won't create change unless people actually use and sustain them. That's where grassroots activism comes in-it ensures that these solutions don't just remain ideas hut are scaled adonte championed by the community itself.

NGOs today can play a crucial role as bridgebuilders. They can connect design experts who understand problem-solving frameworks with local leaders who know the realities on the ground. This synergy is what makes models like the Localization Model in Rajpur and Prosperous Many model in Jonha successful. When NGOs empower communities with both the structured thinking of design knowledge and the mobilizing force of grassroots activism, we can truly think of rural transformation.

ustralia's stand-in Askipper Steve Smith on Wednesday announced his retirement from ODI cricket following his team's four-wicket loss to India in the Champions Trophy (CT) semifinal here but the star batter will continue to play Tests and T20 Internationals. The 35-year-old, who was leading the world champion side in the absence of an injured Pat Cummins, informed his teammates after the match that he would be stepping away from the 50-over format with immediate

Reflecting on his decision, Smith said it was the right time to step aside as Australia builds itself for the 2027 ODI World Cup.
"It has been a great ride, and I

have loved every minute of it," Smith said.

There have been so many amazing times and wonderful memories. Winning two World Cups was a great highlight along with the many fantastic team-mates who shared the journey," he added

in a media release shared by Cricket Australia.

A key member of Australia's victorious 2015 and 2023 ICC World Cup-winning teams, Smith was named Australia's men's ODI Player of the Year in 2015 and 2021 and earned a place in the ICC men's ODI Team of the Year in 2015.

He took over the ODI captaincy in 2015 and, fittingly, led the side one last time in his final match.

"Now is a great opportunity

for people to start preparing for the 2027 World Cup so it feels like the right time to make way," he said.

The veteran of 170 ODIs said Test cricket remains a priority and he is looking forward to the World Test Championship Final in June.

"I feel I still have a lot to contribute on that stage," he

"But everyone in the dressing room is staying out of the comfort zone be it the coaching staff, be it the players and hopefully we continue to do what is important for Indian cricket,"

Mohammad Shami, returning after a 14-month injury layoff, has once again emerged as India's leading wicket-taker in a world tournament, claiming eight wickets. He shares the top spot with New Zealand's Matt Henry, both having taken eight wickets.

Shami was the highest wicket-taker in the 2023 World Cup, with 24 wickets, where India finished as runners-up to Australia. That tournament

marked his last appearance before the injury layoff. "Shami 'one of the biggest fighters. I remember seeing him bowl at the nets. I used to tell him, 'Shami, you will go a long way', and I like it a lot because of the way he has upgraded himself.

## Trying to get my rhythm, says Shami

Mohammed Shami conceded that operating as India's lone front-line pacer after coming back from a lengthy injury layoff has been a heavy "responsibility" but a heavy "responsibility" but said he is trying to regain his "rhythm" to suit the team's needs in the ongoing Champions Trophy (CT).

Throughout the ICC showpiece here, Shami has shared the new ball duties with either Horshit Pane or

with either Harshit Rana or Hardik Pandya because of the injury-forced absence of Jasprit Bumrah.

Rana is still learning the ropes, while Pandya is an allrounder and delivering 10 overs in an ODI is not precisely his territory. Shami has so får picked eight wickets in the tournament.

"I am trying to get my rhythm back and contribute more for the team. It is a responsibility when there are no two proper fast bowlers and I have to shoulder more responsibility," Shami said in a mixed zone interaction after India's semifinal victory over Australia here on Tuesday night.

Shami said his workload is heavier without Bumrah steaming in at the other end but he is trying to give more than a 100 per cent to the role. "There is a load when you are the one main fast bowler and the other is an all-rounder. You have to pick wickets and lead from the front.

"I have become used to this load and am trying my best to make it easy for others and

give more than 100 per cent," he said. Shami was sidelined for over a year with an ankle injury that he picked durin the 2023 ODI World Cup. The veteran said he is now ready to shoulder the responsibility of bowling long spells.
"The trust debate ends when

you get selected in the team. I don't think that one should worry about his fitness too much. We just need to put in the effort and see how your body takes it. After all, we are labourers.

"I am now ready to bowl long spells. Short spells are anyways easy – 6 balls or 12 balls – and in limited-overs cricket it doesn't matter whether it's 10 or six overs," he noted.

The 34-year-old has bowled his full quota of 10 overs against Bangladesh and Australia, while he bowled just eight and four overs against Pakistan and New Zealand respectively in the earlier matches, primarily because spinners bowled nearly 35 overs in those games. Being at one venue helped me

Shami said it is an advantage for him that all of India's Champions Trophy matches are being played in Dubai.

"It has definitely helped us because we know the conditions and the behaviour of the pitch. It is a plus point that you are playing all the matches at one venue.

"The main thing is to gauge the conditions and know how the pitch behaves because you are playing at one venue and you can get to know it well,"

# You cannot build pressure on Kohli: Agar

Agar added that Kohli was the fulcrum around which the Indian team built the innings to overcome Australia.

"India batted around Virat

beautifully. The guys who came in kept pushing the rate and allowed Virat to do his thing, hit the odd boundary and just keep ticking over. I saw a stat that Virat has scored the most singles since the year 2000, which is phenomenal. It was a bit of a masterclass from him and all the batters contributed nicely.

Kohli's effort included 56 singles and four twos, indicating his exemplary fitness level. Former India cricketer

Sanjay Manjrekar added, the fact that Kohli is able to find the gaps despite five fielders inside the circle is a testament to his mastery over batting.

"Now you have five fielders inside the circle, so it's not easy as it used to be -- like during our times -- when you had four fielders. Very rarely has he hit the ball straight to the fielder and hasn't got a run," said Manjrekar.
